

## CM defends inquiry, says road project MP recommended does not exist

HT Bureau GUWAHATI, June 16: Rajya Sabha MP Ajit Kumar Bhuyan was questioned for over five hours on Monday by the Chief Minister's Special Vigilance Cell (SVC) in connection with alleged irregularities in the use of MPLADS (Member of Parliament Local Area Development Scheme) funds.

The veteran journalist-turnedpolitician expressed surprise over the summons and later accused the state government of using the vigilance unit as a tool for political harassment

Speaking to reporters after the interrogation, Bhuyan said he had faced close to 30 questions related to developmental projects under the scheme. "I had just one answer for all of them," he remarked. "I have always cooperated with the authorities, and I will continue to do so.' However, Bhuyan did not hold

Bhuyan, a vocal critic of the current state leadership, suggested that the probe was designed to discourage dissent and opposition unity. "Whenever opposition voices begin to align, investigations and harassment follow. This is nothing

but political vengeance," he asserted. Raising the issue of selective targeting, Bhuyan questioned the vigilance body's inaction in cases involving ruling party leaders.

"Why does CM Vigilance stay silent when BJP leaders face similar allegations? But when it's Ajit Bhuyan, they're suddenly wide awake," he said.

In a pointed conclusion, Bhuyan questioned the absence of scrutiny toward the state's top leadership.

"If corruption is truly being investigated, let's start at the top. What about the Chief Minister and his family? Why are they never probed? Why does the Vigilance Cell fall silent when real questions are raised?"

Reacting to the allegations, Chief Minister Himanta Biswa Sarma told reporters that he respects the MP, but defended the inquiry. (CONTD. ON PAGE-2)

# Land encroachment: 693 families evicted in 2 dists



GOALPARA, June 16: The Assam government on Monday launched eviction drives to evict 693 families, mostly belonging to

the migrant Bengali-speaking Muslim community, who allegedly encroached on vast tracts of land in the two districts of Goalpara and Bongaigaon, officials said. According to officials, 667 fam-

ilies were evicted from Hasilabeel village in Goalpara district, while another 29 families were removed from Bhandara in Bongaigaon dis-

The drive in Goalpara began at 7 am under tight security.

Deputy Commissioner Khanindra Chaudhary said, "There was no resistance from the encroachers, and no untoward incident was re-

ported during the day." The drive was stopped around 3 pm because of rain. It's likely to resume at 8 am on Tuesday, an official said

Almost 60 per cent of the encroached area has been cleared with concrete houses demolished, he added

The drive was carried out in over 45 per cent of 1,555 bighas in Hasilabeel under Balijana revenue

Chaudhary said the residents were served eviction notices in 2023 and 2024

"We served final notices on Friday, asking them to vacate their homes by Monday morning. Placards and posters were also put up at multiple locations as reminders, he said.

Chaudhary, along with Senior Superintendent of Police Navneet Mahanta, camped in the village since morning, while IGP (Law and Order) Akhilesh Kumar Singh arrived later to review the situation. Many residents left the village with their belongings, but those who remained requested that the district administration rehabilitate them.

'I was born here, and so was my father. My grandfather settled here when the Jogighopa bridge was being constructed. We are cooperating with the authorities but request them to provide us with an alternative place to stay', a local resident said

In Bongaigaon, the drive was carried out in Bhandara area after a notice was served to the encroachers last week, an official said.

The families had encroached 349 bighas of temple-sattra and built their homes, he added. There was no report of any untoward incidents with the families moving away with their belongings, and demolition of the houses was completed during the day. (PTI)

SIVASAGAR, June 16: Energy major ONGC on Monday said it has deployed the "most experienced" Crisis Management Team (CMT) to control the leakage of gas, which continued for the fifth day after a blowout at a crude oil well GUWAHATI, June 16: In a sigin Assam's Sivasagar district. nificant push to strengthen India's

The district administration said that air pollution is still within the acceptable limit and the local office of Pollution Control Board, Assam (PCBA) is closely monitoring the situation.

The blowout began on June 12 at Well No RDS 147 of Rig No SKP 135 of Rudrasagar oil field of ONGC at Barichuk of Bhatiapar. A private firm, SK Petro Services, was operating the well on behalf of the state-run Maharatna com-

"ONGC has deployed its most experienced Crisis Management Team (CMT), a team with a proven track record in managing complex well control operations, to contain the gas leakage at Well RDS#147. The operation is being closely and continuously monitored by ONGC's top management," the company said in a statement.

Geological challenges are inherent to oil and gas operations and the premier energy company follows stringent safety protocols, it added.

"ONGC is making all out efforts to bring the



gas leak under complete control at the earliest,' the company said.

The company, in coordination with the district administration, undertook the safe evacuation of affected families and has been providing them with shelter, food, drinking water and other essential daily supplies.

Because of the blowout, around 1,500 people have been affected and 70 families were shifted to a relief camp set up in nearby Bangaon, and all necessary arrangements are being made to ensure their welfare and well-being. "To safeguard public health, ONGC has established free round-the-clock medical camps staffed with doctors and equipped with essential trict medicines, as part of its comprehensive emergency response," the statement said.

The company said that it is maintaining continuous communication with all stakeholders, including the district and police administrations, media and local community leaders, to ensure transparency and swift action.

"ONGC is grateful to the government, the local residents and the media for their continuous support and seeks further cooperation from all stakeholders till this situation is normalised," it added.



NEW DELHI, June 16: Sixteen years after the last census in 2011, the government on Monday issued

a notification for conducting India's 16th census which will include caste enumeration in 2027. The census will be carried out

with a reference date of October 1. 2026 in the snow-bound areas like Ladakh and March 1, 2027 in the rest of the country, the notification said

"The reference date for the said census shall be 00.00 hours of the 1st day of March, 2027, except for the Union territory of Ladakh and snow-bound non-synchronous areas of the Union territory of Jammu and Kashmir and the States of Himachal Pradesh and Uttarakhand," it said.

In respect of Ladakh and snowbound non-synchronous areas of the Union Territory (UT) of Jammu and Kashmir and the states of Himachal Pradesh and Uttarakhand, the reference date shall be 00:00 hours of the first day of October, 2026, it said.

The massive exercise, which is expected to cost the government over ₹ 13,000 crore to give population-related data from across the country, will be conducted by about 34 lakh enumerators and supervisors and around 1.3 lakh census functionaries armed with digital devices.

Union Home Minister Amit Shah reviewed the preparation for the census with Union Home Secretary Govind Mohan, Registrar General and Census Commissioner of India Mritunjay Kumar Narayan, and other senior officials here on Sunday

This is the 16th census since the exercise started and the eighth after Independence, a government statement said.

According to Article 246 of the Constitution, the census is a subject listed at 69 in the Union List in the Seventh Schedule. The census is the primary source of data collection from every section of the society and a decennial activity.

In the upcoming census, caste enumeration will also be done, the first such exercise since Independence. The last comprehensive caste-based count was done by the Britishers between 1881 and 1931. Caste was excluded from all census operations conducted since Independence.

GUWAHATI, June 16: Chief Minister Himanta Biswa Sarma on Monday came down heavily on the Congress party, accusing it of resorting to "cheap thinking" and communal politicking in the wake of an alleged incident involving the desecration of a Hanuman temple in Dhubri district.

Speaking to the media, Sarma claimed that beef was intentionally thrown into the temple premises, sparking unrest in the area.

He stated that individuals arrested in connection with the case belong to the minority community.

"Look at the cheap thinking of Congress," Sarma said. "Beef was thrown into a Hanuman temple in Assam. The culprits are from the minority community, but Congress is blaming Hindus. This is the politics they play." Doubling down on his criticism, the Chief Minister accused the opposition party of longstanding "appeasement politics' and rejected suggestions that a Hindu could have been behind the alleged act. "Just imagine how narrow-minded one must be to think that a Hindu would desecrate a temple by placing beef there," he said. (CONTD. ON PAGE-2)

## Investigation in Raja Raghuvanshi murder case not just confined to love triangle: Meghalaya DGP

SHILLONG, June 16: Meghalaya DGP Idashisha Nongrang on Monday said the investigators probing the murder of Indore businessman Raja Raghuvanshi in Sohra were not treating the love triangle as the only motive, and they are looking into various other angles.

Raja was hacked to death on May 23 while honeymooning in the Northeastern state. His wife Sonam. her boyfriend Raj and three hitmen were arrested in connection with the murder on June 9.

"We are investigating whether there is anything more to this case. It is unusual that within a few days of marriage, she (Sonam) would develop so much animosity against her husband," Nongrang told PTI.

"We are exploring all possible angles for this murder to have taken place. We have enough evidence, and loose ends are being tied up. We have a solid case," she added.

Sonam (25) and Raja (29) got married in Indore on May 11 and reached Meghalaya via Guwahati in Assam on May 21 for their honeymoon. Both of them went "missing" on May 23 in Sohra in East Khasi Hills district, hours after checking out of a homestay at Nongriat village.

Raja's decomposed body was found in a gorge near Weisawdong Falls on June 2. A search continued for Sonam, who emerged in Uttar Pradesh's Ghazipur, around 1,200 km away, in the early hours of June 9 and surrendered as police arrested his boyfriend and the three hitmen. Sonam told the investigators that the Raja's jewellery that went missing was kept in a "particular place", the DGP said.

'We will be looking into that," she said.

All those arrested will be taken to Sohra around 12 pm on Tuesday for the reconstruction of the crime scene, police said. The hitmen, who were Raj's friends, had attacked Raja on the head with a machete in front of Sonam at the parking lot of the Weisawdong Falls. They then pushed the body into the gorge, according to the police. Sonam fled the state following the murder, taking taxis, buses, (CONTD. ON PAGE-2)

# Iran-Israel war: Govt to meet stakeholders this week to assess impact on India's trade

NEW DELHI, June 16: The government is closely monitoring the situation arising from the Iran-Israel conflict, and a meeting with shipping lines, container firms, and other stakeholders will be held this week to assess the impact on the country's overseas trade and address any issue, a top official said on Monday.

Commerce Secretary Sunil Barthwal said that the impact of the war on India's trade will depend on how the situation unfolds over a period of time. "We are watching the situation. We are also calling a meeting (this week) of all the shipping lines, the container organisations and the concerned departments, and stakeholders to understand from them that what are the kind of issues they are facing and how we can sort it out," he told reporters here.

Exporters have stated that the war, if escalated further, would impact world trade and push both air and sea freight rates.

They have expressed apprehensions that the conflict is expected to impact movement of merchant ships from the Strait of Hormuz and Red Sea. Nearly two-thirds of India's crude oil and half of its LNG imports pass through the Strait of Hormuz, which Iran has now threatened to close.

This narrow waterway, only 21 miles wide at its narrowest point, handles nearly a fifth of global oil trade and is indispensable to India. which depends on imports for over 80 per cent of its energy needs.

Airtel rolls out AI-based system to combat online fraud in Assam and NE

HT Bureau GUWAHATI, June 16: Bharti

Airtel has announced a major technological intervention to curb the growing menace of online fraud in Assam and the Northeast, revealing that its AI-powered fraud detection system has already shielded over 1.35 million users across the region within just 33 days of its launch

According to an official statement, the system, which has been automatically enabled for all Airtel mobile and broadband users, identifies and blocks malicious links shared via SMS, WhatsApp, Telegram, Facebook, Instagram, email, and web browsers in real time. The platform scans more than one billion URLs daily and is capable of blocking harmful sites in under 100 milliseconds. Citing an example, the statement said that if a user in Guwahati receives a message with a fraudulent delivery link-such as "Your package is deit here: layed. Track http://www.tracky0urparcell.com' —the system scans the link upon access. If deemed suspicious, it instantly blocks the site and redirects the user to a warning page that reads: "Blocked! Airtel found this site dangerous!" This real-time response mechanism has helped proect users from phishing fake

The present conflict that began with an attack on Is-rael on October 7, 2023 had brought cargo movement through Red Sea routes to a halt due to attacks by Houthi rebels on commercial shipping. After the US intervened with attacks on the rebels, the firing on commercial ships stopped.

Imports from Israel came down to USD 1.6 billion in the last fiscal from USD 2.0 billion in 2023-24. Similarly, exports to Iran of USD 1.4 billion, which were at the same level in 2024-25 as well as in 2023-24, could also suffer. "I respect him, but the road project that he had recommended does not exist," Sarma told reporters. "These people carry a very good face value in front of the public. In this case, only his statement was pending. After this, the report will be submitted to the court. Many ACS officers have already been terminated from service after being found guilty in the case," the CM said.

The investigation was initiated following media reports in February 2023, which alleged widespread corruption and misappropriation of MPLAD funds during 2021–22 and 2022–23. A regular inquiry was launched by the SVC. As a result, several Assam Civil Services (ACS) officers were suspended, and some were later dismissed for their involvement in the scandal. The Vigilance Cell has yet to issue a public statement on the questioning or the status of the case. (With inputs from PTI)

## ONGC gas leak enters day 5

The well has not caught fire yet and no one is injured in the incident, while all emergency services have been pressed in the area, a company official said. An ONGC official had earlier said that it was an old crude well without production and a perforation job was going on for zone transfer at the time of the blowout. "It is a kind of servicing of the well. The production was supposed to start from a new zone after the perforation job. At the time of the incident, the logging perforation operation was going on. Suddenly gas started coming out in an uncontrolled manner immediately after the perforation, leading to the blowout," he had added. (PTI)

### CEM inaugurates exhibition

Addressing the gathering, CEM Tuliram Ronghang described the BJP-led NDA government as pro-poor. He cited initiatives such as free distribution of rice under the NFSA, which provides 5 kg per person each month, and the Ayushman Bharat scheme that offers free treatment up to ₹5 lakh for economically disadvantaged individuals. Reflecting on the condition of the hill districts prior to 2014, Ronghang said that Karbi Anglong, West Karbi Anglong and Dima Hasao had been plagued by ethnic clashes, frequent bandhs, extremism, and developmental stagnation. Referring to the 1996 Charchim massacre where 41 innocent travellers were killed during a peak of insurgency, he said the situation has drastically changed under the Modi government.

Six extremist groups have since laid down arms and a tripartite peace accord was signed between the Centre, the Assam government and the militant organisations in recent years. He noted that the return of peace has paved the way for development in the region, with more progress expected in the next three years.

Ronghang further added that while the Congress government failed to allocate sufficient funds to KAAC, the BJP government has since doubled the financial outlay for the council. The Baithak was attended by Diphu MP Amarsing Tisso, MLA Rupsing Teron, KAAC Deputy Chairman Avijit Kro, President of BJP West Karbi Anglong District Committee Radip Ronghang, and other party functionaries.

Fairway maintenance works are already underway across NW-1, including the Varanasi-Ballia stretch, to ensure round-the-year navigability. A QPOM has been deployed at Nauranga in Ballia to address connectivity bottlenecks.

Fifteen community jetties are being developed in Uttar Pradesh, with onshore infrastructure already under construction at eight locations and two more under consideration. Two hybrid electric catamaran vessels have been deployed in Varanasi and Ayodhya, alongside a hydrogen-fuelled vessel and two Ro-Pax ferries for passenger cruise services. The operational Multi-Modal Terminal at Varanasi has positioned the state as a critical hub in the revitalised inland waterways ecosystem. A feasibility study is currently underway to replicate the Kochi Water Metro model in Varanasi, Ayodhya, and Prayagraj, subject to geographical suitability.

Speaking about the progress made in Uttar Pradesh, Sonowal said that the Jal Marg Vikas Project (JMVP) has made the state a major beneficiary of IWT revival on NW-1. The launch of MV Ganga Vilas-the world's longest river cruise—by Prime Minister Narendra Modi in 2023, which began its journey from Varanasi, has bolstered river cruise tourism in the state. The implementation of schemes like 'Jalvahak', offering incentives for cargo movement, and 'Harit Nauka', promoting low-emission vessels, has further advanced the state's leadership in sustainable river transport. In Bihar, the minister announced plans to explore a Water Metro project in Patna, inspired by the Kochi model, to provide clean and modern mobility across both banks of the Ganga. A new ship repair facility and the upgrading of the National Inland Navigation Institute (NINI) into a Centre of Excellence are also planned. Sixteen community jetties are being developed to enhance passenger connectivity, and Kalughat Terminal is being positioned to handle cargo bound for Nepal. Infrastructure plans include four QPOMs, two Ro-Pax terminals, and two hybrid electric catamaran vessels. The IWAI and the Bihar government signed an SSA to deepen collaboration on community jetties, cruise tourism, and QPOM operations.

In West Bengal, Sonowal noted that the Haldia terminal, already operational and integrated with Indo-Bangladesh Protocol routes, is establishing the state as a vital gateway for cross-border trade. The upcoming Coastal Shipping Bill, 2025, is expected to streamline cargo movement between inland and coastal waterways. West Bengal is also emerging as a key destination for river cruise tourism. Fifteen community jetties have already been commissioned, and work on seven more is in progress. Fairway maintenance is underway on important stretches including Farakka-Kahalgaon, and onshore facilities are being constructed at eight locations o support local logistics and passenger movement.

In Jharkhand, the Multi-Modal Terminal at Sahibganj is already operational and is significantly contributing to cargo movement along NW-1. Two community jetties are under development to improve local access. An integrated cluster-cum-logistics park is being planned at Sahibganj, with a memorandum of understanding signed between IWAI, NHLML, and RVNL. A traffic study is being conducted to support the project.

The Union Minister highlighted that the JMVP, launched in January 2018 at a cost of ₹5,061 crore, aims to develop a 1,390-km stretch of NW-1 from Haldia to Varanasi with assured depth and width for navigation. As of May 2025, the project is nearly 69% complete, with cargo traffic increasing from 5.05 million metric tonnes in 2014-15 to 16.38 MMT in 2024-25. The project includes community jetties, navigational locks to reduce transit time, cargo terminals, and various facilities to support both commercial and passenger traffic.

Since 2014, under the leadership of Prime Minister Narendra Modi, the inland waterways sector has seen a transformative shift. The number of operational national waterways has increased from three to 29, and cargo novement has grown more than seven-fold-from 18 million tonnes to over 145 million tonne vestments in the sector have crossed ₹6,300 crore. Today, 124 terminals are operational, including 27 permanent and 97 floating ones. A total of 111 waterways have been declared, spanning 23 states and four Union Territories, with a combined navigable length of over 20,000 km. In the financial year 2024–25, cargo movement on these waterways reached 145.84 MMT, with bulk commodities such as coal, iron ore, fly ash, cement, and vehicles forming 85% of the total.

GUWAHATI, June 16: Due recognition of work by a company always motivates its employees to perform better, builds trust and gives them a sense of belonging to the organisation, a study by two HR technology firms said.

Guwahati-based Vantage Circle and Mumbai's 'Great Place To Work India' have jointly published a research report, 'The Recognition Effect: A Leadership Blueprint for Emotionally Intelligent Workplaces', which uncovers how recognition of efforts, when done right, becomes a transformative force for workplace culture and performance.

"At the heart of the study lies a powerful finding: recognition isn't just about acknowledgement, it is a strategic lever for trust, agility, innovation and retention. Organisations that build high-recognition cultures outperform their peers across multiple dimensions of employee and business outcomes," the study mentioned. In such a scenario, 91 per cent of employees surveyed feel motivated, 94 per cent say their organisation is a great place to work, and an equally high percentage affirms that their companies deliver excellent customer services, it added. "Nearly all respondents in such environments also associate their organisation with innovation and express a strong intent to stay," the paper stated.

The research also brings to light how recognition of work is experienced across gender, generations, roles and tenure -- signalling the need for more inclusive approaches.

Commenting on the findings, Vantage Circle CEO and Co-founder Partha Neog said, "The true power of recognition and rewards lies not in what is given, but in what is genuinely felt. When done with intention, recognition becomes

more than a moment -- it becomes a cultural signal that shows people they matter."

Due recognition of an employee's work builds trust, pride and belonging for the organisation, he said.

"We believe that a culture of recognition develops engaged and loyal employees. When organisations make employee appreciation an intentional and integral part of workplace culture, they unlock the true potential of their people," Great Place To Work India Chief Executive Officer Balbir Singh said.

Recognition in the workplace helps employees see that their company values them and their contributions, fostering loyalty and engagement, he added. "Recognition programmes are a crucial part of the employee experience and a key driver of perceptions of fairness in the workforce, Singh said. (PTI)

At the heart of the discussion was the BTR government's decision to allot 3,400 bighas of land to APDCL, which would then lease it to the Adani Group for setting up a thermal power plant. The proposed project site lies in an area inhabited by Boro, Garo, and Rabha tribal communities, triggering widespread opposition and fear among locals over potential displacement and loss of agricultural land.

Recent tensions in the area, including scuffles between villagers and police during a boundary demarcation drive, have raised alarms, with opposition parties intensifying their campaigns against the land allotment.

Speaking to the media following the meeting, CEM Pramod Boro assured that no agricultural, revenue, or private land would be taken from villagers and that no

The strike followed months of rising tensions. Israeli officials cited intelligence that Iran had amassed enough enriched uranium to produce multiple nuclear weapons. A senior Israeli military official told Reuters that Iran could make up to 15 bombs within days. Israeli leadership framed the operation as a necessary step to counter an existential threat amid stalled diplomacy. Tehran denies seeking a nuclear weapon, but it stresses that it has a right to domestically enrich uranium - a process of altering the uranium atom to produce nuclear fuel. Earlier this week, Iran said it obtained a trove of secret documents on Israel's own undeclared nuclear arsenal. The immediate context includes not just military build-up but also failed diplomacy: US-Iran nuclear talks, scheduled for June 15 in Oman, were hanging by a thread before the airstrikes. It is now unclear whether they will go forward.

Just a day before the Israeli strikes, US President Donald Trump had issued two different sounding statements. As reported by Al Jazeera, within a day Trump had warned that there is a "chance of massive conflict" in the Middle East, confirming that an Israeli attack on Iran is "possible". Next, speaking to reporters on Thursday, Trump said he would "love to avoid the conflict" and suggested that the US would like Israel to hold off on plans to strike Iran's nuclear sites while Washington and Tehran continue their negotiations. Later on Thursday, the US president reiterated his commitments to diplomacy with Iran. "My entire Administration has been directed to negotiate with Iran," he wrote in a social media post. "They could be a Great Country, but they first must completely give up hopes of obtaining a Nuclear Weapon."

However, Washington's role goes beyond military posturing. While publicly disavowing military involvement, the US remains deeply invested in preventing Iran from developing nuclear weapons and in managing the broader fallout from Israeli actions. Its long-standing diplomatic support for Israel, layered sanctions on Iran, and simultaneous pursuit of backchannel diplomacy highlight Washington's complex and often contradictory position in the conflict. The Israel-Iran conflict is a decades-long power struggle rooted in ideology, security threats, and competing visions for the Middle East. Israel sees Iran as its most dangerous enemy, primarily due to Tehran's pursuit of nuclear capabilities, its calls for Israel's destruction, and its sustained support for groups like Hezbollah and Hamas. Israel believes that a nuclear-armed Iran would permanently alter the strategic balance in the region and pose an existential threat to the Jewish state

ary consciousness. His ancestors had been such legends as Haribilas Agarwala, who had brought the sacred Kirtan Puthi to the press, rescuing a valuable piece of Assamese heritage, and Chandrakumar Agarwala, the foundereditor of Jonaki, which had initiated an Assamese literary renaissance. Jyotiprasad grew up during an age of increased social ferment, when Assam, like the rest of India, was stirring to the vision of nationalism, reform, and modernity.

This was the time when Assam's increasing involvement in national political movements and cultural renaissance took place. The Assam Association, the forerunner of the Indian National Congress at the state level, started dreaming of Swaraj with the impact of all-India developments. The earliest indications of this cultural and political revival came with the creation in 1916 of the Assam Chhatra Sammilani and the Assam Sahitya Sabha in 1917. Jyotiprasad matured in the midst of this fresh ferment of intellectualism and rebellion, the Non-Cooperation Movement of 1921 being his first nationalist call to action when he was 18.

His involvement in the struggle for independence never deterred him from intellectual pursuits. After finishing his early studies in Tezpur, he moved to Calcutta and, in 1926, to England to pursue his studies further. Though he never held a formal degree, his time abroad was filled

nity. He learned filmmaking in Germany from the legendary Himangshu Rai with on-the-job training in direction, production, and editing. His wanderings around Europe, filled with all kinds of popular and high culture, gave him a cosmopolitan outlook that would later drive his art and activism back home.

In India, Jyotiprasad dove headfirst into the Civil Disobedience Movement in 1930. He not only joined but also spearheaded the movement along with leaders such as Hem Barua and Bishnuram Medhi. He organized Rayat Sabhas, speaking to lower-rung masses in an effort to organize them in the national movement. His fifteen-month prison term in 1932 was not just a time of atonement but of intense reflection and mental consolidation. As Dr. Hiren Gohain aptly

puts it, Jyotiprasad was among those visionaries who envisioned shattering the cultural lethargy

of Assam and placing it at the front rank of progressive nations by the power of creativity and self-sustaining effort. He was inspired by Gandhi's thought and envisioned national rebirth through indigenous cultural renaissance.

But what distinguished Jyotiprasad was the purity of his ideals and practice. He lived what he taught, and his political activism was inseparable from cultural reconstruction. He had respect for tradition but was never its captive. Transformation was the leitmotif of his intellect. He had firm conviction that cherishing rotten forms of the past could never lead to a living future. His work was not a paean to nostalgia but a call to go ahead with roots unbroken.

As a poet, Jyotiprasad altered the course of Assamese poetry. When his peers were mostly in romantic loss and personal longings, Jyotiprasad's poetry broadened the scope of emotion with collective longing and aesthetics of beauty, harmony, and social progress. His poems such as Sundar Konwar and Manimugdha did not provide merely lyrical beauty but depth of philosophy. He pioneered new rhythms and patterns in Assamese poetry by departing from the formality of earlier Vaishnava metres and be-

stowing Assamese verse with a contemporary voice without losing its cultural depth.

His role in contemporary Assamese music was just as revolutionary. When middle class Assamese aesthetic sense was being swamped by Bengali cultural overlordship, Jyotiprasad had the temerity to redefine Assamese musical identity. He took inspiration from traditional folk of the region-biya naam, bon geet, bihu—and blended it with a dash of Indian classical music and Western harmony to produce a new genre of modern Assamese songs. His song "Gache gache paati dile" was not only musical but symbolic, embodying a blend of indigenous traditions and modern movements. These songs, typically imparting patriotic and social messages, became instruments of cultural awaken-

ing and resistance.

Atulchandra Hazarika aptly explained how Jyotiprasad reshaped the cultural landscape of Assamese theatre. Shonit Kuwari was a watershed in terms of Assamese music and drama, raising fresh standards and expectations. He revived traditional folk customs and merged them with modern-day performance arts, thereby restoring them to their former place of pride in popular awareness

The passion for excellence that Jyotiprasad possessed was the stuff of legend. His enthusiasm was matched by his severity. The anecdote that Pushpalata Das has about him composing march tunes within a night and sternly training volunteers for a Rayat Sabha indicates his very deep commitment to the arts. For Jyotiprasad, every note, every step, and every word was necessarily in line with the ideals they represented. Art for him was no ornamentation-it was an austere act of nation-building.

This creative flame glowed even in children's literature. His poems such as Akamani Chowali and Bhut-Powali are still classics, cherished by generations for their lilting spirit, fantastical depth, and musicality of tone. His incomplete Jyoti Ramayana displays his capacity to embed

profound philosophical concepts in the simplicity of song and narrative, depicting nature as a symphony of music in which each component finds expression in movement and sound

But the most daring page in Jyotiprasad's professional career was that of a film maker. In 1935, he produced Joymoti, the first ever Assamese film, under the most unfavorable conditions. Without any infrastructure, without trained hands, without professional actors-women, most of all, since Assamese society was very orthodox at that time-Jyotiprasad produced a milestone film. He wrote the screenplay, created the music, directed the actors, handled photography and editing, and constructed an ad-hoc studio, Chitraban, on his family land. Making of Joymoti was a cultural revolution. Though commercially un-

successful, the artistic and historic significance of the film is unparalleled. His second film, Indramalati, produced under severe budget and time restrictions, was released in 1939 and brought him temporary financial relief.

His work did not stop in cinema. He constructed the Jonaki cinema hall at Tezpur in 1937the first cinema hall in Assamshowing his sense of aesthetics and vision of modernity. His architectural experiments, as through his model of Gauhati University, showed his faith that even buildings could be a symbol of cultural identity.

A philosopher and an artist, Jyotiprasad articulated his vision in speeches and essays. In books like The Artist's World, Worship of the New, and To the Light, he dealt with the philosophical basis of art and culture. Culture, for him, was not static-it was fluid, rooted in the people's life, developing along with the times. He believed that politics, economics, and social justice were all threads in the large cultural fabric. Art, thus, needed to confront society, speak the truth to power, and awaken the people. While escapism was the vogue in the art scene during those days, Jyotiprasad openly embraced the philosophy of responsibility of art—one that the country, the oppressed, and the future could gain from

be awakened to social crises Real art is, in his view, born of life itself-of struggle, suffering, hopes, and survival of common people. And yes, he may have developed a sympathy towards leftwing ideologies near the end of his life, but he could not confine his unrestrained spirit to any political party. He remained a voice of artistic uprising-a cultural revolutionary with his own moral sense

Jyotiprasad was also a builder of institutions. He was a zealous supporter of the establishment in Gauhati University and played a part in generating public opinion in its favor. He penned short stories, initiated biographies of Gandhi and Chandrakumar Agarwala, and penned plays in English-all left unfinished, but indicating his volatile creative energy. What is striking about his life is the range and the depth of his contributions-poetry, song, film, essays, drama, education, children's literature, activism, architecture. Every one of his works carries an imprimatur of originality, intent, and deep cultural engagement. His work never was superficial. It always was a creation of immense commitment, genuine introspection, and a burning ambition to serve Assam and India. As Dr. Hiren Gohain has put it, Jyotiprasad felt that artists-rather than politicians—can guide the people, not by slogans or creeds but by a higher degree of consciousness. He also realized that all art, in a society divided into classes, is complicitous, and the artist must stand with the oppressed at the end of the day, not by slogans but by lighting up minds, molding ideas, and creating hopes. Art was an expression of self-a medium to allow individuals and communities to discover their worth, restore their pride, and march towards liberty with hope, for Jyotiprasad. Rupkonwar Jyotiprasad Agarwala was not just a mastermind of creativity. He was the embodiment of modern Assam, whose vision, bravery, and dedication continue to inspire generations in succession. ## All eyes on what Iran does to oil traffic through Strait of Hormuz

**Desertification and Drought: A global** challenge requiring local solutions

- srael's strike against Iran has reignited a familiar tension in global energy markets, sending oil prices climbing into the mid-\$70 per barrel range. The impact is not just visible in the numbers, but in the broader nervousness sweeping across energy trading floors and geopolitical circles alike. At the heart of this movement lies the so-called "geopolitical risk premium"-the extra cost per barrel that markets price in when a key oil-producing region teeters on the brink of conflict. That premium has now risen to about \$8 a barrel, a level surpassing even the acute flashpoints of April and October 2024, when Israel and Iran directly exchanged strikes for the first time in decades.

This escalation has naturally drawn intense scrutiny, not only for the possibility of a broader military conflict but also for its potential to derail the delicate logistics of global oil supply. Among the many scenarios being modelled by analysts and strategists, one stands out as the most consequential: whether Iran will target the Strait of Hormuz. This narrow waterway, separating the Persian Gulf from the Gulf of Oman, has long been considered the most critical chokepoint in the global oil trade. Some 12 million barrels of crude pass through it daily-more than 20 percent of global consumption-with refined products pushing that number closer to 20 million barrels per day. Over 80 percent of this volume is Asia-bound, underscoring the strait's indispensable role in maintaining the energy lifelines of the region's largest economies, from India and China to Japan and South Korea.

As of now, market sentiment appears to be in a state of watchful hesitation. The price jump has been meaningful but not chaotic, largely because Iran's response remains undefined. If history is any guide, Iran may opt for a calibrated retaliation targeting Israeli military sites or regional proxies, thereby avoiding a broader confrontation. Such moves, while headlinegrabbing, typically result in only short-lived spikes in oil prices. The key here is the market's growing familiarity with these kinds of actions-they generate noise and some volatility, but unless they escalate further or disrupt infrastructure, their economic impact tends to be fleeting.

But this time, the calculus feels different. The rhetoric on both sides has been sharper, and the regional alignments more complex. Should Iran choose to escalate further—by, for instance, targeting oil infrastructure in Saudi Arabia or the UAE, harassing tankers,

or more provocatively, attempting to close or disrupt the Strait of Hormuz-then oil prices could enter a much more volatile phase. These are not theoretical risks. Iran has a long record of threatening to shut the Strait, and although it has never fully succeeded, its past actions-from missile launches to the seizure of oil tankers-have proven that it has the capacity to cause significant disruption and uncertainty.

What makes the current scenario more precarious is that the available alternatives to the Strait are limited and insufficient for maintaining full flow continuity. Saudi Arabia operates the East-West pipeline, which moves oil from the Eastern Province to the Red Sea, bypassing the Strait altogether. The UAE, similarly, utilizes the Habshan-Fujairah pipeline, allowing some oil to reach global markets without passing through Hormuz. However, these routes together only handle around 6 million barrels per day-barely half of the volume typically moving through the strait. Any prolonged disruption would thus create a substantial bottleneck, forcing refiners, traders, and governments to draw down on strategic reserves or scramble for alternative sources, both of which would drive prices sharply higher.

Moreover, the strategic geography of the Strait of Hormuz compounds the challenge. The narrowest point of the strait is only 21 miles wide, with shipping lanes just two miles wide in either direction. It is shared with Oman, but Iran's proximity and control over its northern shores allow it to exert considerable influence over the waters. Iran

GPS signals to misdirect tankers into its waters, as well as deploying fast boats to harass or seize vessels-moves that don't necessarily stop the flow of oil but make the journey riskier and more expensive. Insurance premiums on shipments rise, and so do charter rates and freight costs, all of which contribute to a rising cost base for global

Adding another layer of complexity is the presence of US naval forces in the region, tasked with securing free passage through the Strait. If Iran targets US military assets-either in the Persian Gulf or at bases across the Middle East-the conflict risks broadening dramatically. Such a scenario would likely see not just a spike but a sustained surge in oil prices, possibly well beyond the \$100 mark, as the market prices in a protracted disruption rather than a one-off skirmish.

In this sense, Iran's next move is not just a matter of military strategy-it's an economic pivot point. A restrained response could cap oil prices in the \$75-\$80 range, assuming no further escalation and a swift return to status quo. But any move to unsettle the energy infrastructure or shipping lanes in and around the Strait of Hormuz could catapult oil into the \$90s or beyond, with reverberations across inflation, interest rates, and global growth.

It's also important to consider the broader strategic environment in which this is unfolding. The global oil market has been gradually recovering from the shocks of the COVID era, with supply-demand balances tightening but still fragile. OPEC+ has been cautious with its output strategy, attempting to maintain price stability while managing spare capacity. Any geopolitical jolt that tightens supplies further could disrupt this balance, especially if it coincides with seasonal demand upticks in the northern hemiphere

China and India, the two largest consumers of Middle Eastern oil, are also watching the situation with growing unease. Both have been diversifying their oil imports and building up strategic reserves, but neither can easily replace the volumes that flow through Hormuz. The threat of prolonged disruption may prompt them to engage diplomatically behind the scenes, possibly leaning on Gulf allies or utilizing leverage with Tehran to de-escalate tensions. Globally, 23 per cent of the land is no longer productive. 75 per cent has been transformed from its natural state, mostly for agriculture. This transformation in land use is happening at a faster rate than at any other time in human history, and has accelerated over the last 50 years.

It is reported that over 70 per cent of natural ecosystems have been transformed. By 2050, this could hit 90 per cent. By 2030, food production will require an additional 300 million hectares of land and the fashion industry is predicted to use 35 per

pressures on land are huge and they are expected to keep on growing. More than 170 countries continue to be affected by desertification, land degradation and drought. Recurring and increasing threats of forest fires, heat waves, massive migration, sudden floods, rising sea levels, and food and water insecurity are more evident. By 2025, 1.8 billion people will experience absolute water scarcity. Also, two thirds of the world will be living under waterstressed conditions. By 2045, some 135 million people across the world may be displaced as a result of desertification. 2.6 billion people depend directly on

agriculture, but 52 per cent of the land used for agriculture is moderately or severely affected by soil degradation. The 2030 Agenda for Sustainable Development declares that "we are determined to protect the planet from degraincluding dation, through sustainable consumption and production, sustainably managing its natural resources and taking urgent action on climate change, so that it can support the needs of the present and future generations".

Due to drought and desertification, 12 million hectares are lost each year (23 hectares per minute). Within one year, 20 million tonnes of grain could have been grown. Currently, 13 million hectares

of forests are being lost every year, while the persistent degradation of drylands has led to the desertification of 3.6 billion hectares.

The World Day to Combat Desertification is a unique occasion to remind everybody that desertification can be effectively tackled, that solutions are possible, and that key tools to this aim lay in strengthened community participation and co-operation at all levels. Let us focus on inclusive cooperation amongst all stakeholders, ministries, agencies and sectors, to restore and rehabilitate degraded land and contribute towards achieving the overall Sustainable Development Goals. # Maleriraptor kuttyi: India's Triassic predator unearthed


The discovery of a new dinosaur species in India, named Maleriraptor kuttyi, has opened a fascinating chapter in the study of prehistoric life. This remarkable find, dating back approximately 220 million years to the Norian age of the Triassic period, has not only enriched our understanding of India's paleontological heritage but also provided critical insights into the survival and adaptation of early dinosaurs. Belonging to the Herrerasauria group, a lineage of small- to medium-sized carnivorous dinosaurs, Maleriraptor kuttyi represents a significant milestone in paleontology. Its discovery in India's Maleri Formation marks the first definitive evidence that herrerasaurs survived a major environmental upheaval in Gondwana that led to the extinction of an entire group of herbivorous dinosaurs. This article explores the significance of Maleriraptor kuttyi, its physical characteristics, the geological context of its discovery, and its broader implications for understanding dinosaur evolution and the ancient ecosystems of Gondwana.

The unearthing of Maleriraptor kuttyi in the Maleri Formation, a well-known geological site in India, underscores the region's importance in paleontological research. The Maleri Formation, located in central India, is one of the country's richest repositories of Triassic fossils, preserving a snapshot of life from a time when the supercontinent Pangea dominated Earth's geography. The name Maleriraptor is derived from the Maleri Formation, while kuttyi likely honors a researcher or local contributor involved in the discovery. The fossils of this dinosaur provide a rare glimpse into the diversity of life during the Norian age, a pivotal period in Earth's history marked by significant environmental and biological changes. The discovery of Maleriraptor kuttyi adds to the growing body of evidence that India was a critical region for early dinosaur evolution, challenging earlier assumptions that herrerasaurs were primarily confined to regions like South America.

Physically, Maleriraptor kuttyi was a small- to medium-sized carnivore, likely measuring between two to three meters in length. Its skeletal structure suggests it was a swift and agile predator, equipped with sharp teeth and claws that made it a formidable hunter in its ecosystem. The Herrerasauria group, to which Maleriraptor kuttyi belongs, is characterized by bipedal dinosaurs with lightweight, streamlined bodies, ideal for chasing prey. These features indicate that Maleriraptor kuttyi was well-adapted to its environment, capable of pursuing smaller animals or scavenging in a landscape where food resources may have been scarce. The study of its fossils reveals a body plan typical of early theropods, with strong hind limbs and a flexible neck, suggesting it was an efficient predator. Its discovery in India expands the known geographic range of herrerasaurs, previously documented primarily in South America, particularly in Argentina's Ischigualasto Formation.

The Triassic period, spanning roughly 252 to 201 million years ago, was a transformative era in Earth's history. It followed the catastrophic Permian-Triassic mass extinction, often referred to as the "Great Dying," which wiped out nearly 90% of life on Earth. The Triassic saw the rise of dinosaurs, which began as small, opportunistic creatures before evolving into the dominant terrestrial animals of the Mesozoic era. During the Norian age, around 227 to 208 million years ago, the supercontinent Pangea was beginning to show signs of rifting, with Gondwana forming its southern portion. Gondwana encompassed present-day India, South America, Africa, Australia, and Antarctica, and its ecosystems were shaped by dramatic climatic and geological changes. The discovery of Maleriraptor kuttyi is particularly significant because it provides evidence that herrerasaurs endured a major environmental upheaval in Gondwana during this period, which led to the extinction of a group of herbivorous dinosaurs

This upheaval, likely triggered by intense volcanic activity, climate shifts, or tectonic movements, reshaped the ecosystems of Gondwana. Herbivorous dinosaurs, which relied heavily on specific types of vegetation, were particularly vulnerable to these changes. The loss of plant life due to climatic shifts or volcanic ash likely decimated their populations, leading to the extinction of entire groups. In contrast, carnivorous dinosaurs like Maleriraptor kuttyi may have had an advantage due to their dietary flexibility. As predators, they could exploit a variety of prey, including smaller reptiles, early mammals, or even carrion, allowing them to survive in a changing environment. The agility and predatory efficiency of Maleriraptor kuttyi, as inferred from its skeletal structure, likely played a crucial role in its ability to adapt to these challenging conditions. This resilience highlights the adaptability of early carnivorous dinosaurs and sheds light on the factors that allowed certain



groups to thrive while others perished.

The Herrerasauria group holds a special place in the study of dinosaur evolution. These dinosaurs are considered some of the earliest known members of the dinosaur lineage, predating the split between the two major dinosaur groups: Saurischia (which includes theropods and sauropods) and Ornithischia. Herrerasaurs exhibit a mix of primitive and advanced traits, making them a critical link in understanding the evolutionary origins of dinosaurs. For instance, their skeletal structure shows similarities to later theropods, such as sharp, curved teeth and a bipedal stance, but they also retain some archaic features, such as a less specialized hip structure. The discovery of Maleriraptor kuttyi in India suggests that herrerasaurs were more widespread across Gondwana than previously thought, challenging earlier models that placed their primary distribution in South America. This finding prompts scientists to reconsider the migration patterns and evolutionary history of early dinosaurs, particularly in the context of Gondwana's interconnected landmasses.

The survival of Maleriraptor kuttyi through the environmental upheaval in Gondwana offers valuable insights into the resilience of early dinosaurs. Unlike herbivorous dinosaurs, which were heavily dependent on stable vegetation, carnivorous dinosaurs like Maleriraptor kuttyi could exploit a broader range of food sources. This dietary versatility likely allowed them to weather the ecological crises that decimated other species. The study of Maleriraptor kuttyi's fossils provides clues about its hunting strategies and ecological role. Its sharp teeth and claws suggest it was an active predator, possibly preying on smaller reptiles or early synapsids. Additionally, its lightweight build and strong limbs indicate it was capable of rapid movement, enabling it to chase down prey or escape larger predators. These adaptations underscore the evolutionary advantages that enabled herrerasaurs to persist in a volatile environment.

The discovery of Maleriraptor kuttyi also highlights the importance of India as a key region for paleontological research. The Maleri Formation, part of the Pranhita-Godavari Basin, has long been recognized as a treasure trove of Triassic fossils. Previous discoveries in the region include remains of early sauropodomorphs, rhynchosaurs, and other reptiles, but the identification of a herrerasaur adds a new dimension to the site's significance. The Maleri Formation's sedimentary layers, formed in ancient river systems and floodplains, provide an ideal environment for fossil preservation. The discovery of Maleriraptor kuttyi encourages further exploration of this region, as additional fossils could reveal more about the diversity and distribution of early dinosaurs in Gondwana. Collaborative efforts between Indian and international paleontologists are likely to intensify, with the goal of uncovering more evidence to piece together the puzzle of dinosaur evolution.

The broader implications of Maleriraptor kuttyi's discovery extend beyond paleontology to our understanding of Earth's ancient ecosystems. The survival of herrerasaurs through a period of significant environmental change suggests that carnivorous dinosaurs played a critical role in maintaining ecological balance during the Triassic. By preying on smaller animals and scavenging, they likely helped regulate populations and prevent overexploitation of resources. Furthermore, the presence of herrerasaurs in India indicates that Gondwana's ecosystems were highly interconnected, with similar species inhabiting diverse regions. This interconnectedness is a testament to the mobility of early dinosaurs, which were able to disperse across vast distances before the breakup of Pangea.

The discovery of Maleriraptor kuttyi opens new avenues for research. Paleontologists are likely to conduct comparative studies between the fossils of Maleriraptor kuttyi and those of other herrerasaurs, such as Herrerasaurus from Argentina, to better understand their evolutionary relationships. Advanced techniques, such as CT scanning and isotopic analysis, could provide further details about the dinosaur's biology, diet, and environment. Additionally, ongoing excavations in the Maleri Formation may uncover more fossils, potentially revealing new species or additional specimens of Maleriraptor kuttyi. These findings could help refine our understanding of the timing and causes of the environmental upheaval that affected Gondwana's ecosystems.

The discovery of Maleriraptor kuttyi is a landmark achievement in paleontology, offering a window into the ancient world of the Triassic period. This small but formidable carnivore, with its sharp teeth and agile build, survived a tumultuous period in Earth's history, demonstrating the resilience of early dinosaurs. Dermal fillers contain ingredients that add fullness to areas that have thinned due to aging. This thinning is common in the cheeks, lips, and around the mouth.

People should be aware of the costs

Botox may help to correct dynamic wrinkles, such as crow's feet around the eyes and horizontal lines on the forehead.

Botox is a purified form of the botulinum toxin that is obtained from bacteria. Though it is deadly in larger amounts, the tiny, regulated amount of Botox given to correct wrinkles has been used safely for decades.

Botox works by blocking nerve signals in the muscles where it is injected. When those nerve signals are interrupted, the affected muscle is temporarily paralyzed or frozen. Without movement of these selected muscles in the face, certain wrinkles may be softened, reduced, or even removed.

Botox and other treatments made with botulinum toxin are sometimes called neuromodulators or neurotoxins.

Treatments made with botulinum toxin are sold under the brand names Botox Cosmetic, Dysport, and Xeomin.

What can Botox correct?

Botox only works on wrinkles that are caused by muscle movement. These are known as dynamic wrinkles, and are often called "expression lines."

The most common dynamic wrinkles that Botox can treat are lines on the upper face, such as the "11" between the brows, horizontal lines on the forehead, and crow's feet around the eyes. These lines are caused by smiling, frowning, squinting, and other facial expressions.

Botox will not work on fine lines and wrinkles caused by sagging or loss of plumpness in the face. These are known as static wrinkles. Static wrinkles include lines in the cheeks, neck, and jowl areas.

Botox is not a permanent treatment. Repeated treatments are necessary for continued wrinkle-reducing effects. Most people find that the muscle-relaxing effect of Botox lasts for 3 to 4 months.

Botox side effects and considerations

The ASPS considers Botox to be safe, and 6.7 million procedures were performed in 2015. As Botox wears off over time, most side effects are only temporary. Possible side effects of Botox include: lon

• weakness or paralysis of nearby muscles

- headache
- dry mouth

• blurry vision or vision problems The treatment may also fail to work due to antibodies that fight the toxin. This happens in less than 1 percent of

people who have repeated Botox treatments, however.

The ASPS advise people not to rub or massage the area of the injection after having Botox treatment. This could spread the toxin to surrounding skin, causing muscle drooping and other problems.

The average cost of a Botox injection is \$385, according to 2016 statistics from the ASPS.

#### What are dermal fillers?

Dermal fillers, sometimes called soft tissue fillers, are substances designed to be injected beneath the surface of the skin to add volume and fullness.

Substances used in dermal fillers include:

• Calcium hydroxylapatite, which is a mineral-like compound found in bones.

• Hyaluronic acid, which is found in some fluids and tissues in the body that add plumpness to the skin.

• Polyalkylimide, a transparent gel that is compatible with the body.

Polylactic acid, which stimulates the skin to make more collagen.

 Polymethyl-methacrylate microspheres (PMMA), a semi-permanent

filler Each one of these is designed to treat different signs of aging or other cosmetic issues. The time they take to work, as well as how long they last,

also vary. Some fillers last 6 months,

in- while others last up to 2 years or longer.

People should discuss their individual needs and expectations with their doctor to determine what filler would be the best choice for them.

What can dermal fillers correct? Different types of dermal fillers are designed to treat varying signs of aging. Depending on the filler selected, they may:

plump up thinning lips
enhance or fill in shallow areas on the face

• decrease or remove the shadow or wrinkle under the eyes caused by the lower eyelid

• fill in or soften the look of recessed scars

• fill in or soften static wrinkles, especially on the lower face

Static wrinkles include those around the mouth and along the cheeks. These wrinkles are usually a result of a loss of collagen and elasticity in the skin.

Dermal filler risks and considerations

Dermal fillers are considered to be safe but side effects can occur. A licensed healthcare professional should perform all dermal filler procedures using only FDA-approved fillers injected with a syringe. The most common problems include:

• skin rash, itching, or pimple-like eruptions

• redness, bruising, bleeding, or swelling

• undesirable appearance, such as asymmetry, lumps, or overcorrection of wrinkles

• skin damage that causes a wound, infection, or scarring

• ability to feel the filler substance under the skin

blindness or other vision problems
death of skin cells due to loss of blood flow to the area

The cost of dermal filler treatments varies and depends on the provider performing it, the area being treated and the type of filler selected. The ASPS 2016 statistics list the following cost per syringe:

Dermal fillers: These use hyaluronic acid and similar substances to "fill in" or plump areas that have lost volume and smoothness. This includes wrinkles around the mouth, thin lips, and cheeks that have lost fullness. They may also be used on forehead wrinkles, scars, and other

areas that need extra volume for a smoother look. Botox results last 3 to 4 months. Dermal filler results vary, depending

on which filler is used. Because Botox and fillers are different substances designed for different uses, they can sometimes be combined in one treatment. For instance, someone may use Botox to correct lines between the eyes and a filler to correct smile lines around the

#### mouth. Takeaway

Millions of Botox and filler procedures are performed each year, and they have a good track record of safety.

A study in JAMA Dermatology found that Botox and filler procedures are very safe when performed by experienced board-certified dermatologists. Side effects occurred in less than 1 percent of recipients, and most

of these were minor. Though Botox and fillers are minimally invasive, they still carry some risks. An individual should be aware of all possible risks and benefits be-

fore having these treatments. Botox and fillers are not recommended for women who are pregnant or breastfeeding. People who have certain health conditions or who take any medications should discuss whether Botox

or fillers are safe for them. People should also discuss what Botox and fillers can realistically do for their appearance. Though they can enhance a more youthful look, the results are typically not as powerful as

having a surgical procedure, such as a facelift. Using a qualified medical provider, such as a board-certified dermatolo-

# Iran missile attacks on Israel kills 5, while Israel claims it now has air superiority over Tehran

**TEL AVIV, June 16:** Iran fired a new wave of missile attacks on Israel early Monday, killing at least five people, while Israel claimed in the fourth day of the conflict that it had now achieved "aerial superiority" over Tehran and could fly over the Iranian capital with impunity.

After days of attacks on Iranian air defences and missile systems, the Israeli military said its aircraft now control the skies from western Iran to Tehran and had destroyed more than 120 surface-to-surface missile launchers that had been firing at Israel in overnight missions.

'Now we can say that we have achieved full air supremacy in the Tehran airspace," said military spokesperson Brig Gen Effie Defrin. Iran, meantime, announced it had launched some 100 missiles and vowed further retaliation for Israel's sweeping attacks on its military and nuclear infrastructure, which have killed at least 224 people in the country since last Friday.

One missile fell near the American consulate in Tel Aviv, causing minor damage, US Ambassador Mike Huckabee said on X. There were no injuries to American personnel. Iran announced it had launched some 100 missiles and vowed further retaliation for Israel's sweeping attacks on its military and nuclear infrastructure, which have killed at least 224 people in the country since last Friday.

Israel said so far 24 people have been killed and more than 500 injured as Iran launched more than 370 missiles and hundreds of drones. In response the Israeli military said fighter jets had struck 10 command centres in Tehran belonging to Iran's Quds Force, an elite arm of its Revolutionary Guard that conducts military and intelligence operations outside Iran.

#### Explosions rock Tel Aviv and Petah Tikva

Powerful explosions, likely from Israel's defence systems intercepting Iranian missiles, rocked Tel Aviv shortly before dawn on Monday, sending plumes of black smoke into the sky over the coastal city. Authorities in the central Israeli city of Petah Tikva said that Iranian missiles had hit a residential building there, charring concrete walls, shattering windows and ripping the walls off multiple apartments

The Israeli Magen David Adom emergency service reported that two women and two men — all in their 70s — and one other person were killed in the wave of missile attacks that struck four sites in central Israel.

"We clearly see that our civilians are being targeted," said Israeli police spokesman Dean Elsdunne outside the bombed-out building in Petah Tikva. "And this is just one scene. We have other sites like this near the coast, in the south."

Petah Tikva resident Yoram Suki rushed with his family to a shelter after hearing an air raid alert, and



emerged after it was over to find his apartment destroyed. "Thank God we were OK," the 60-year-old said. Despite losing his home, he urged Israeli Prime Minister Benjamin Netanvahu to keep up the attacks on Iran. "It's totally worth it," he said. "This is for the sake of our

children and grandchildren." In addition to those killed, the MDA said paramedics had evacuated another 87 wounded people to hospitals, including a 30-year-old woman in serious condition, while rescuers were still searching for residents trapped beneath the rubble of their homes. LONDON, June 16: Prime Minister Keir Starmer has announced the "historic" appointment of Blaise Metreweli as the first female chief of the UK's Secret Intelligence Service, commonly known as MI6, in the 116-year history of the organisation.

Commonly referred to as 'C', the international spy agency's chief has operational responsibility for MI6 and is the only publicly named member of the organisation, accountable to Foreign Secretary David Lammy.

Metreweli, 47, has been promoted from current role as Director General, or 'Q', responsible for technology and innovation in MI6 and has previously held a director-level role at MI5 the UK's domestic security service.

"The historic appointment of Blaise Metreweli comes at a time when the work of our intelligence services has never been more vital," Starmer said on Sunday.

"The United Kingdom is facing threats on an unprecedented scale - be it aggressors who send their spy ships to our waters or hackers whose sophisticated cyber plots seek to disrupt our public services," he said.

Metreweli will succeed Sir Richard Moore, who leaves the service in the autumn later this year. "I'd like to thank Sir Richard Moore for his dedicated service, and I know Blaise will continue to provide the excellent leadership oss David Lammy. "At a time of global instability and emerging curity during that time and over his long ca-reer," said Wormald. ## UN rights chief decries 'horrifying' suffering in Gaza

GENEVA, June 16: The UN human rights chief said Israel's warfare in Gaza is inflicting "horrifying, unconscionable suffering" on Palestinians and urged government leaders on Monday to exert pressure on Israel's government and the militant group Hamas to end it.

Volker Turk made the comments at the opening of the latest Human Rights Council session on Monday, in a broad address that also raised concerns about escalating conflict between Iran and Israel, the fallout from US tariffs, and China's human rights record alongside wars and conflict in places like Sudan and Ukraine.

The United Nations High Commissioner for Human Rights, who has regularly spoken out about bloodshed in Gaza and called for the release of Israeli hostages held by armed Palestinian militants, used some of his most forceful words yet to highlight the Mideast violence.

"Israel's means and methods of warfare are inflicting horrifying, unconscionable suffering on Palestinians in Gaza," Turk told the 47member-country body, which Israeli authorities have regularly accused of anti-Israel bias.

The Trump administration has kept the United States, Israel's top ally, out of the council proceed-

Israel's military campaign has cording to Gaza's Health Ministry. It says that women and children make up most of the dead but it does not distinguish between civilians and combatants.

"The facts speak for themselves. Everyone in government needs to wake up to what is happening in Gaza," Turk said. "All those with influence must exert maximum pressure on Israel and Hamas, to put an end to this unbearable suffering." (AP)

The military has designated specific routes to access the food centres, and GHF has warned aid-seekers that leaving the roads is dangerous, but many do in an attempt to get to the food first. Israel and the United States say the new GHF system is needed to prevent Hamas from siphoning off aid. GHF says there has been no violence in or around the sites themselves. UN agencies and major aid groups, which have delivered humanitarian aid across Gaza since



# **PHE&WS** department undertakes swift restoration of water supply in Keyi Panyor

NAMSAI, June 16: In the wake of widespread damage inflicted on water supply infrastructure due to relentless rainfall and landslides from 28 to 31 May, the Public Health Engineering and Water Supply (PHE&WS) Department has mobilized extensive efforts to restore critical water services across the Keyi Panyor district. The natural calamity caused severe disruptions in multiple regions, leaving thousands of residents in over 30 villages without access to regular potable water.

Prior to the late-May catastrophe, the Dem water system had already sustained damage earlier on 24 April, creating early signs of strain on the area's water infrastructure. However, the situation deteriorated rapidly with the late-May weather events, which triggered massive landslides and flooding that crippled distribution pipelines and supply channels. The impact has been acutely felt in villages such as Neelam, Pania, Yazali, Deed, Talo, Yachuli town, and Upper Yachuli, including hamlets like Taba, Peet, and Tajgi.

In response to this crisis, the PHE&WS Department, in close

unteers stepped forward to offer manual labour and food support to departmental teams, substantially accelerating temporary repair work in many of the affected zones.

Thanks to this robust community-led support, temporary water restoration has already been achieved in multiple villages, including Yazali, Pitapool, Neelam, and Delipeji. These successful interventions reflect the coordinated ground-level action that continues to be the hallmark of the ongoing restoration initiative.

However, certain regions, particularly those more severely affected such as Upper Yachuli and sections of Yachuli town, continue to face major challenges. To address the immediate needs of these localities, the administration has made arrangements for private water tankers, ensuring that residents have at least a minimum supply of potable water while permanent repairs are underway.

# for Bangaldeshis in Kolkata



NEW DELHI, June 16: The Enforcement Directorate has filed a chargesheet under the anti-money laundering law against a Pakistani man, living as an Indian in Kolkata, after illegally procuring as many as five vital government IDs including Aadhaar, voter card and passport.

He was laundering funds by making "fake" Indian IDs for Bangladeshis who came here and through other illegal activities like hawala, the federal probe agency said in a statement on Monday.

The ED said it has submitted the prosecution complaint against the man named Ajad Mallik alias Ahammed Hossain Azad and Azad Hossain before a special Prevention of Money Laundering (PMLA) court in Kolkata on June 13. The court has taken cognisance against the "Pakistani national" and fixed a date for hearing, it said. The ED, which carried out raids

in this case in April, had then said in a press statement that Mallik was a Bangladeshi national. It arrested Mallik under the anti-money laundering law and the probe brought to light that he was indeed a Pakistani national.

The ED case stems from a West Bengal Police FIR against Mallik and unidentified others for violation of the Foreigners Act of 1946.

"Probe found that the man was a Pakistani national illegally living in India," the ED statement said.

"A Pakistani driving licence dating back to 1994 was recovered from his mobile phone bearing the name Azad Hossain and featuring the photograph of Ajad Mallik alias Ahammed Hossain Azad. It listed his father's name as Mumtaz-Ul-Haque and a permanent address in Pakistan," the ED said.

It said the driving licence recorded his date of birth as 14.08.1971 and it was issued by the Licensing Authority in Hyderabad, Pakistan.

In order to "conceal" his true identity, the ED said, the man

adopted the alias "Ajad Mallik" and procured multiple Indian identity documents like Aadhaar, PAN (permanent account number issued by the income-tax department) card, driving license, voter ID and passport by submitting "forged" and "fabricated" documents, as per

the ED. The agency found that the man operated a "hawala" network to facilitate illegal cross-border remitbetween India and tances Bangladesh, collecting payments in cash and UPI, before transferring equivalent amounts to Bangladesh using platforms like 'Bkash', an online financial trans-

action platform of Bangladesh. "He was also involved in illegal money transfers and document forgery and was actively involved in facilitating the preparation of visas and passports for Bangladeshi nationals seeking to travel to countries like Dubai, Cambodia and Malaysia," the ED said.

The Pakistani man collected payments in Bangladeshi Taka, US Dollar, and Indian Rupee and deposited these amounts into his own bank account or transferred them to the accounts of associates engaged in fraudulent visa or passport processing, the ED alleged.

He played a "significant" role in "fraudulent" activities carried out at certain forex changers (fullfledged money changers) based in Kolkata, in which "huge" cash deposits were declared as proceeds from legitimate foreign currency sales to customers but were actually "proceeds of crime" linked to "unlawful" activities including the creation of "fake" Indian identities for Bangladeshis to obtain passports, the ED said.

The ED had said in April that the man has two sons -- Osama Bin Azad and Omar Faruk -- and his wife Maymuna Akhter, residing in Bangladesh and are citizens of that country. It said the man "frequently" visited Bangladesh to meet his family. (PTI)

# ED files chargesheet against Pak man who made Indian govt IDs global leader in disaster management: Shah

NEW DELHI, June 16: Union Home Minister Amit Shah on Monday said India has become a global leader in the field of disaster management due to the excellent works carried out by the NDMA, NDRF and others.

Addressing a conference of the relief commissioners and disaster response forces of all states and Union Territories (UTs) here, Shah also said 10 years ago, the approach of the disaster mitigation organisations was for minimum casualties and after 10 years, the approach is to achieve the target of zero casualties

Whenever the history of India's disaster response will be written, the last 10 years of the Modi government will be recorded as a transformative decade. In these 10 years, we have made significant achievements in all four areas -capacity, efficiency, speed and accuracy," he said.

The home minister said the National Disaster Management Authority (NDMA) has effectively carried out policy, subject structure, research work, dissemination of various exercises to the public, development of several applications, and overall coordination and policy-related work.

In the last 10 years, NDMA, National Disaster Response Force (NDRF) and Coalition for Disaster Resilient Infrastructure (CDRI) have strongly positioned India to become a global leader in the field of disaster management, he said. Shah said in the last two years. work has been done to create a platform of ideas with a whole-ofgovernment approach by bringing together workshops and meetings of all the agencies related to relief and disaster management.

"When the heads of all the disaster relief teams discuss on a single platform, many shortcomings are removed and the country also benefits in being prepared to deal with a disaster," he said.

The home minister also suggested that every year, some districts and tehsils sensitive to disasters should be included in this conference so that the disaster management being considered at the national level gradually reaches the tehsil and district levels as well. All relief commissioners should prepare a district disaster management plan for every district in their state within 90 days, he said.

He also praised the role of NDMA, saying it has effectively carried out policy, subject structure, research work, dissemination of various exercises to the public, development of several applications and overall coordination and policy-related work

Shah said the NDRF has earned nationwide recognition, built a strong reputation and gained re-



spect while the State Disaster Response Force (SDRF) has also played a significant role in this structure. He said due to climate change and global warming, the entire world is grappling with disasters and there is a need to move forward with environmental conservation as a core component.

"In the coming days, while everyone is fully prepared to tackle disasters, there is also need to address their root causes," he said.

"Not only has our capacity to handle disasters been increased but it has also been enhanced and extended to the tehsil level. Attention has been given to speed, as saving lives during a disaster is of utmost importance," he said.

The home minister said efficiency has been improved through

the use of cutting-edge technology and the dedicated approach of disaster response forces.

Additionally, by providing accurate forecasting and early warnings, society has been made aware and successfully engaged in relief and rescue operations, he said. Shah said during the Modi gov-

ernment's tenure, there has been a significant shift in the approach related to disaster management. Earlier, the approach was relief-

centric, but now, the goal of "zero casualty" has been successfully achieved and the focus has shifted from relief-centric to a comprehensive and integrated approach, he said. He emphasised the importance of anticipating future disasters, conducting advanced research, compiling global ideas in

this field and adapting them to suit India's geographical conditions.

The home minister said in the last decade, India has made significant efforts for financial empowerment and greatly increased the government's budget.

"We have also pursued institutional empowerment deliberately and by design, along with structural empowerment. Combining all these, we have also adopted a multidimensional approach as a policy," he said.

Shah said from 2004 to 2014, the budget of the SDRF was ₹38,000 crore, which increased to ₹ 1.44 lakh crore from 2014 to 2024. Similarly, the budget of the NDRF was ₹ 28,000 crore from 2004 to 2014, which Prime Minister Narendra Modi increased to ₹ 84.000 crore.

"Overall, we have nearly tripled the total budget from ₹ 66,000 crore to  $\gtrless$  2 lakh crore," he said.

The home minister said the relief commissioners should prepare district disaster management plans for their respective districts within 90 days because until a district has its disaster management plan in place, it cannot respond swiftly in the face of a disaster.

He also said a lightning action plan needs to be formulated soon and noted that several states have yet to implement the incident response system. (PTI)

## Fresh caste survey in Karnataka: BJP says Cong always betrayed OBCs

NEW DELHI, June 16: The BJP on Monday accused the Congress of always deceiving and betraying the Other Backward Classes as it hit out at the party following the Karnataka government's decision to junk an earlier caste count and go for a fresh enumeration.

Union minister and BJP leader Bhupender Yadav asked for fixing accountability, noting that over Rs 165 crore of public money was spent in carrying out the earlier survey and claimed that the plank of social iustice is merely a show for the Congress to engage in social division for electoral purposes.

With the Congress asking the Centre to adopt the "Telangana model" for not just caste enumeration but also in bringing out detailed data on socio-economic parameters during the nationwide census, the key OBC face of the BJP questioned why the opposition party did not follow the same practice in Karnataka. Congress' inner contradictions have been exposed as the party has no real commitment to social justice and resorts to such political gimmicks for electoral purposes, he said.

At a press conference, Yadav also demanded an apology from RJD supremo and former Bihar chief minister Lalu Prasad Yadav after a political row erupted over the placement of a picture of Dalit icon Bhim Rao Ambedkar near his feet on his birthday.

"It shows his (Lalu's) arrogance. Most backward classes and Dalits faced most injustice during his government," he alleged.

Speaking to reporters, Yadav claimed that the Con-

gress has a history of betraying the OBC interests as he recalled that its governments at the Centre had ignored the Kaka Kalelkar Commission report on empowering the backward classes. The party also opposed the Mandal Commission recommendations, he said. He cited Karnataka Chief Minister Siddaramaiah's statement that the decision for a fresh caste enumeration was not his government's but the Congress leadership's, questioning the party's interference in the state government's decision-making.

Yadav compared it with the alleged interference from Sonia Gandhi-headed National Advisory Council during the UPA government.

The Congress has said that the fresh exercise has been announced to address the concerns of certain communities. Also, the earlier caste survey data was 10 years old and needed to be updated, it said.

It is the Modi government, Yadav said, which has worked for the socio-economic empowerment of the backward classes with its numerous schemes. It also accorded constitutional status on the National Commission for Backward Classes, he added.

He said the Karnataka government's decision not only highlights the internal contradictions of the Congress but also stressed that social justice is mere optics for the party which has "no commitment" to the idea The Congress, he alleged, resorts to electoral engineering, data manipulation and vote bank appeasement in the name of social justice, and invariably deceives the backward classes. (PTI)

What happens if the limit is crossed and will states be forced to deny employment despite demand, or will workers have to work without payment, he asked. Is it not true that according to a recent report, only 7 per cent of families have received the promised 100 days of work, Kharge further asked. (PTI)

## Govt's high-level committee should not 70% vaccines sourced by WHO, 14% generics supplant investigation by AAIB: CPI(M)

NEW DELHI, June 16: The CPI(M) on Monday questioned the setting up of a high-level committee by the Centre to look into the Ahmedabad crash, saying holding a "parallel" inquiry when India's Aircraft Accident Investigation Bureau (AAIB) is investigating the incident will lead to doubts about government interference.

Civil Aviation Minister K Rammohan Naidu on Saturday said while the AAIB investigation will handle the technical aspects, the high-level committee (HLC) will provide a holistic, policy-oriented roadmap for future safeguards.

In a statement issued here, the CPI(M) said the existing investigation should not be supplanted. The CPI(M) said as per international protocols and norms set by the International Civil Aviation Organization (ICAO), India's Aircraft Accident Investigation Bureau has commenced its independent investigation into the causes and circumstances surrounding the crash.

The Left party said the AAIB will take possession

of the "black boxes" of the aircraft and all other evidence, and complete its investigations in cooperation with international bodies, aircraft and engine manufacturers and other stakeholders

"Having a parallel high-powered governmental air crash investigation committee filled with bureaucrats will undermine the AAIB investigation and raise doubts about possible government interference," it said. The CPI (M) demanded that the terms of reference of the HLC be immediately revised to remove all overlaps with the AAIB investigation, especially as to the cause and circumstances of the crash of AI-171. "The accident investigation is better left to professionals and experts.

"The HLC should instead go into the Ahmedabad and other earlier crash investigation reports to formulate binding rules and mechanisms for strict implementation to prevent settlements and buildings coming up within prescribed distance and safety parameters in the proximity of airports," it said. Ahmedabad plane crash: 99 victims identified by DNA tests

AHMEDABAD, June 16: Four days after the horrific crash of an Air India plane claimed 270 lives, 99 victims have so far been identified through DNA matching and 64 bodies, including that of former Gujarat chief minister Vijay Rupani, were handed over to their families, officials said on Monday. Rupani was among the 242 passengers and crew members on board the London-bound Air India flight AI-171 that crashed in Ahmedabad on June 12. His mortal remains were handed over to his wife Anjali Rupani and other family members at the city civil hospital. Authorities are carrying out DNA tests to establish the identity of the victims as many bodies were charred beyond recognition or damaged. "Till now, 99 DNA samples have been matched, and 64 bodies have already been handed over to the respective families. These deceased were from different parts of Gujarat and Rajasthan," civil superintendent Dr

Rakesh Joshi told reporters. Addressing concerns of griefstricken kin, he appealed to them not to panic over the time-consuming process of matching DNA samples with mortal remains.

"We are trying our best to finish this process as soon as possible. Some are complaining that the results have not come even after 72 hours. I appeal to them not to panic, because this is a very important process with legal implications. We will call them as soon as results arrive," added Joshi.

Earlier on Sunday, Ahmedabad Civil Hospital authorities stated that samples of 250 victims, including persons on board the ill-fated flight as well as those killed on the ground, had been collected for identification. The Boeing 787-8 Dreamliner with 242 persons on board crashed into a medical college complex in Ahmedabad moments after taking off from the Sardar Vallabhbhai Patel International Airport at 1.39 pm on June 12. (PTI)

## In year of 'negative news', UN climate chief says 1.5 deg C goal still achievable Plea seeks review of SC verdict mandating

NEW DELHI, June 16: UN climate chief Simon Stiell on Monday said that despite a year dominated by negative headlines, many of the world's largest economies are showing encouraging signs of action on climate change and that keeping global warming within 1.5 degrees Celsius is still possible.

At the opening of the mid-year UN climate conference in Bonn, Germany, Stiell said worsening climate impacts in every country highlight the need for continued cooperation. "This year, beneath the noisier negative news, there are plenty of good reasons for optimism. We are seeing green lights for climate actions from many of the world's biggest economies, sending powerful demand signals to investors and doers," he said.

Stiell said countries must use the Bonn talks to finalise indicators for the Global Goal on Adaptation.

Negotiators in Bonn must "deep-dive" to create a roadmap for mobilising USD 1.3 trillion annually by 2035 to help developing



countries fight climate change, he said. At COP29 in Azerbaijan's Baku last November, countries agreed to triple climate finance to USD 300 billion a year by 2035, part of a broader goal to mobilise USD 1.3 trillion.

In Bonn, countries are expected to begin consultations on the "Baku to Belem Roadmap", which will guide the delivery of this goal. Stiell urged countries to ensure that the Mitigation Work Programme -- established at COP26 in

Glasgow to urgently scale up mitigation ambition -- builds momentum for "actionable solutions that respond to the urgency".

At COP28 in Dubai, countries completed the first Global Stocktake -- a two-year review of the collective global progress towards

achieving the Paris Agreement goals -- and decided to triple renewable energy capacity by 2030, double the global rate of energy efficiency improvements by 2030 and transition away from fossil fuels. Stiell said countries must also make progress on the outcomes of the first Global Stocktake at Bonn.

"None of these issues are easy. Disagreement is natural," Stiell said, adding that the progress made in the next 10 days will make a "very real" difference to billions of lives and livelihoods in every country. He said that recent COPs have all produced concrete, major global steps forward.

"Even if imperfect, even if no country gets everything it wants, this is human solidarity in action... Without UN-convened climate multilateralism, we would be headed for up to 5 degrees Celsius of global heating. Now it's around 3. A reminder that 1.5 and protecting all people continue to be both achievable over the course of time and utterly essential," the UN climate change chief said.

The mid-year UN climate meetings held annually in Bonn help countries work out technical details before the annual UN climate conferences known as COP. (PTI)

NEW DELHI, June 16: A plea filed in the Supreme Court has sought the review of its May 20 judgement barring fresh law graduates from appearing in entry level judicial services examination and fixed a three-year minimum law practice criteria.

The verdict of Chief Justice B R Gavai and Justices Augustine George Masih and K Vinod Chandran on May 20 mandated a minimum of three years of legal practice as a prerequisite for candidates aspiring to become civil judges (junior division).

The review plea, filed by recently-enrolled advocate Chandra Sen Yaday, argues the violation of fundamental rights under Articles 14 (right to equality) and 16 (equality of opportunity in matters of public employment for all citizens) of the Constitution of the aspiring law graduates.

The plea said the imposition of an uniform three-year practice requirement for all judicial service aspirants amounts to arbitrary and unjustified discrimination, depriv-

ing fresh law graduates of equal opportunity in public employment. The plea, in particular, challenges the direction asking high courts and the state governments to amend their service rules to enforce the new eligibility criterion.

# Council has 20 elected members and 4 nominated members BJP voted out of power in Mizoram's Chakma Council in no-confidence motion

AIZAWL, June 16: The BJP was voted out of power in Mizoram's Chakma Autonomous District Council (CADC) on Monday after its head, party leader Molin Kumar Chakma, was removed in a no-confidence motion, an official said.

The Zoram People's Movement (ZPM), the ruling party of the state, now has the maximum number of members in the council and it is likely to stake claim to form the next executive committee of the CADC.

The Molin Kumar Chakma-led executive committee, formed on February 4, was the first BJP-ruled one in the CADC since 1972.

A special session of the House was convened by CADC Chairman Lakkhan Chakma during which the BJP-led executive committee headed by Molin Kumar Chakma was voted out, the official said



The no-confidence motion was moved by Zoram People's Movement (ZPM) member Doymoy Daveng Chakma, claiming that Molin lost the confidence of the majority of members. Of the 17 elected members present, 15 voted in favour of Chakma's removal, and one against The lone MNF member Rasik Mohan

Chakma abstained from voting, the official said.

Twelve BJP members, including Lakkhan Chakma, recently quit the party and joined the ZPM. In the 20-member council, the ZPM now has 16 members, the BJP two and the MNF one. One seat is vacant due to the death of a BJP member in April.

The ZPM is yet to stake claim to form the next executive committee in the CADC, the official said.

The CADC was formed under the Sixth Schedule of the Constitution in 1972 for the welfare of the Chakma tribals of Mizoram.

It exercises legislative, executive and judiciary powers over allotted departments within the territory of CADC.

Its headquarters is Chawngte or Kamalangar in Lawngtlai district.

## Nagaland not frontrunner in GŠT collection, says official

DIMAPUR, June 16: Nagaland's commissioner of taxes Abhinav Shivam said the state is not a frontrunner in GST collection in average or per capital terms.

He noted that revenue leakages through evasion have severely affected the state share.

Addressing the inaugural programme of the five- day onsite training on GST for Nagaland state tax officers at the office of the commissioner of state taxes, Dimapur, Shivam said Nagaland has a unique and complex history.

"Our geography, remoteness, infrastructural challenges, and political complexities have led to a legacy of underdevelopment," he observed adding the state struggled to establish revenuegenerating industries and enterprises.

Pointing out that Nagaland relies heavily on tax revenues to meet its financial and developmental needs, he said optimising tax revenue is not merely an administrative objective but also a developmental imperative.

"Progress of our people, the services we dever the salaries we dispense the roads we

times, Nagaland has made modest headlines in terms of tax revenue recovery and compliance efforts. He said the state taxes department recovered over ₹ 10 crore in revenue arrears from February 2025 to May 2025.

Despite constraints, he said, the department is making steady, strategic progress.

He said the GST is dynamic and it demands that "we stay updated, trained, and alert to the nuances of reforms and policy changes that occur with remarkable frequency".

IMPHAL, June 16: Five members of the Meitei outfit Arambai Tenggol were arrested in connection with the alleged assault on two Manipur Police personnel in Bishnupur district and the kidnapping of a man in Imphal West, a senior officer said on Monday. Three members of the organisation were arrested on Sunday in connection with the kidnapping of Chesam Abdul Kadar of Paobitek Mayai Leikai area in Imphal West district, he said. The accused were produced before a court in the district and remanded to seven days of police custody, the officer said.

A search operation is underway to arrest others involved in the kidnapping of the person, he said. Another member of the Meitei outfit was

First group of 36 pilgrims for Kailash Manasarovar Yatra arrives in Sikkim

## Moves to 17 Mile

GANGTOK, June 16: The first group of 36 pilgrims for the Kailash Manasarovar Yatra has arrived in Sikkim's capital Gangtok after six years, and moved to the 17 Mile area on Monday for acclimatisation, officials said.

The 17 Mile area is around 27 kilometres from the state capital.

The pilgrims will proceed via the Nathu La pass in Sikkim and Tibet's Shigatse city before reaching Mount Kailash and Lake Manasarovar, they said.

On June 20, the pilgrims will cross the India-China border, an official said on Monday.

The group, also comprising two officials from the Ministry of External Affairs, reached Gangtok on Sunday evening, he said

Tourism and Civil Aviation Department Additional Chief Secretary C S Rao said the pilgrims landed at Bagdogra airport in West Bengal's Siliguri and reached Gangtok by road.

They were welcomed by officials of the

Tourism Development Corporation at a bungalow in Rhenock, he said.

This year, 750 Indian pilgrims have been selected for the yatra, with 500 travelling in 10 groups via the Nathu La route and 250 through the Lipulekh Pass in Uttarakhand.

"The first group of pilgrims stayed in Gangtok on Sunday night and proceeded with the yatra on Monday. They will halt at 17 Mile on June 16 for acclimatisation and then move to Serathang before cross-

ing the India-China border on June 20,' the official said.

"The Nathu La-Kailash Mansarovar Yatra is a government-to-government (Gto-G) based pilgrimage, and the Sikkim Tourism Development Corporation (STDC) will be responsible for the entire yatra," he said.

The STDC will take care of the pilgrims" journey from Gangtok to Mount Kailash and Lake Manasarovar and back, he added. (PTI)



# Wanted to create a compelling story about disparate worlds colliding: 'Stolen' director Karan Tejpal

**NEW DELHI, June 16:** Karan Tejpal had almost given up on his dream to become a director when he stumbled upon the idea of his critically-acclaimed film "Stolen", about two brothers who are forced to confront their privilege after they witness a baby being stolen from an impoverished tribal woman at a small town railway station.

The director, who worked as an assistant on films like "3 Idiots" and "Delhi 6", said he wrote "Stolen" after he came across a video where two businessmen lost their lives in a lynching because they were mistaken as baby snatchers by the crowd.

"Disparate worlds are always clashing and coming together and it's not something unique in itself in India. But the way we have sort of addressed it in 'Stolen' is to create a compelling story out of it, and to have that intersection kind of take our privileged characters to a place where they have a transformation," Tejpal told PTI in a virtual interview.

"We never set out with this idea that we are telling some really unique story about this intersection. But the idea was to tell an honest story about it, which compels you to think about these intersections."

After its premiere at the Venice Film Festival, "Stolen" travelled to many international festivals like BFI London, and the Indian Film Festival of Melbourne (IFFM)

Produced and co-written by Gaurav Dhingra of Jungle Book Studio, the film features Abhishek Banerjee and Shubham as two brothers and Mia Maelzer as the tribal woman. Harish Khanna and Sahidur Rahaman also star in key roles. The movie released on Prime Video earlier this month.

Tejpal said his personal motto while making a movie is to find the "heart of the story".

"If filmmakers do not find their heart within a story and they don't find that personal link to a story, then that story is never going to have any potency. For me, this project, or for any in the future, I think the hardest part is finding the heart of that story."

Banerjee, who plays sheltered rich brat Gautam Bansal in the movie, said his motivations to do the film were simple: he wanted to be part of an action drama.

"I really love the action genre and



just wanted to have fun on the set without thinking much... Both Karan and Gaurav had designed the film so well that you could see the film even when they were giving the narration," he said.

He, however, said being on the "Stolen" set felt like being in a proper acting college.

"This was the most planned film I've ever shot. Not a single minute was wasted. If we are on set, we are doing something productive. And if we are not on set, then still, we are doing something productive, either rehearsing or writing," he added.

Shubham, who graduated from the Film and Television Institute of India and co-wrote the critically-acclaimed "Eeb Allay Ooo!" with Prateek Vats, said he also loved that the movie was rooted in the action genre. Shubham's Raman is the empathetic brother who ropes in a reluctant Guatam to help the woman, Jhumpa Mahato, in her perilous journey into the heartland to find her missing baby.

The actor said he was initially worried about coming off as a boring character.

"I decided that instead of concentrating on the morality part of it, I would focus on my relationship with my brother? How are my decisions being taken because of my brother? Sometimes these are very complicated, detailed things like if he's saying tea, I will say coffee. It is just that toxic brother relationship, which sometimes leads to problems," he added.

Melzer said she wanted her portrayal of Jhumpa to be relevant to the real mothers. "At no point should it come across as if I am trying to enact it. This kind of pain cannot be acted on, that's what I feel. I tried to use my craft to go as close as possible to this feeling and maybe our film did justice to the story. The material, the films Karan gave me to watch and study and the research brought me closer to the role," she added.

Tejpal admitted that "Stolen" was a difficult film to make though it has found a lot of support from within the industry with filmmakers like Anurag Kashyap, Vikramaditya Motwane, Kiran Rao and Nikhil Advani boarding it as executive producers.

Dhingra said when Tejpal showed him the video, he felt scared and they decided to work on the movie together. Initially, he said, the director wanted to shoot the movie in Maharashtra but they eventually decided Pushkar in Rajasthan would be more suited.

"The pandemic delayed our film and many on the team fell sick during the shooting but once it was over and the film premiered in Venice, it was like a bullet train and there was no looking back," Dhingra said. (PTI)

# Paris Saint-Germain thumps Atlético Madrid 4-0 in an impressive Club World Cup opener



PASADENA (US), June 16: Fabián Ruiz and Vitinha scored in the first half, and Champions League winners Paris Saint-Germain opened Club World Cup play with a 4-0 victory over Atlético Madrid. PSG largely dominated Atlético at the Rose Bowl in its first match since trouncing Inter Milan 5-0 to win its first Champions League title on May 31.

Senny Mayulu and Lee Kang-in scored against 10-man Atlético in the second half of the European powers' meeting in front of 80,619 fans at the site of the 1994 World Cup final. The matchup was one of the highest-profile games in the group stage of the first 32-team edition of the Club World Cup and treble-winning PSG excelled under another spotlight.

Atlético's Clément Lenglet was sent off in the 78th minute with his second yellow card on a frustrating day that left Diego Simeone visibly furious at both the referees and his players' mistakes.

Ousmane Dembélé wasn't in uniform for PSG after reportedly

injuring a quadriceps while playing for France on June 6. Gonçalo Ramos replaced Dembélé in Luis Enrique's only change to the starting lineup from the Champions League final.

Enrique wore shorts and a training shirt on the sideline while coaching PSG in 88-degree midday California heat (31 Celsius). PSG controlled possession early, and Ruiz capitalized atop the penalty area in the 19th

minute. The Spanish midfielder long coveted by Atlético beat Jan Oblak with a clever strike into the far corner. Vitinha followed with a goal in injury time off Khvicha Kvaratskhelia's second assist of the first half.

Julián Alvarez appeared to answer for Atlético in the second half, but the goal was waved off after VAR determined Koke had fouled Désiré Doué in the buildup. Alexander Sørloth horrifically missed an open net in the 82nd minute for Atlético. Mayulu iced PSG's victory five minutes later, and Lee converted a penalty on the

inal kick of the match Atlético got a golden chance to tie it in first-half injury time, but Gianluigi Donnarumma swallowed up Thomas Griezmann's hard shot in the box. Moments later, Vitinha slipped through the Atlético defense and scored on the break. PSG looked remarkably sharp late in its taxing season, showing no sign of treating this tournament as an anticlimax. The champs are in good shape to advance from group play after winning their toughest group match on paper.

Atlético somehow looked more exhausted than its opponents, and it collected seven yellow cards that raise the danger of suspension down the road. Simeone's club will be favored in its next two matches, but will have less margin for error.

"I think that in this competition, we've set ourselves the goal to make history. We are entering a new chapter, and we need to show it's possible to reinvent ourselves. It's a good challenge. We need to keep fighting and working to win games. I was happy with the way we performed today." — Enrique

MONTREAL, June 16: George Russell won his first race of the Formula 1 season as the Mercedes driver held off defending race winner Max Verstappen at the Canadian Grand Prix. It was the fourth victory of Rus-

sell's career, and the race ended under yellow when McLaren teammates Oscar Piastri and Lando Norris staged a wheel-to-wheel late battle that ended with Norris hitting the wall. "It's amazing to be back on the

top step," Russell said. "I felt last year was a victory lost, so to get the victory and see

(teammate) Kimi (Antonelli) on the podium, too, is an amazing day for the team. I think it shows the strength of our cars in the cooler conditions, so let's see in the coming races.

Russell started on pole for the second consecutive year in Mon-treal and held the advantage for most of the race at Circuit Gilles Villeneuve. The British driver became the fourth race winner this year, joining points leader leader Piastri, Norris and Verstappen, the four-time reigning F1 champion.

Verstappen, who has one more race to go before points drop off his license and eliminate the possibility of a one-race suspension, was satisfied with his second-place finish. "Was quite a good race, even though in the first two stints we were struggling with the tires," the Dutchman said.

"We hung in there in the final stint. That was the maximum we could have achieved today." Mercedes rookie Antonelli finished third behind Verstappen for his first F1 podium. "A really good day. It was ab-

solutely victory on merit." Mercedes team principal Toto Wolff said. "We controlled the race all the way. George drove brilliantly and Kimi didn't crack under pressure, even with the McLaren right be-

hind him. "It's been a while since we've had two cars on the podium with a win and that's why everyone is delighted." The two McLarens came together when Norris, then in fifth, attempted to pass Piastri multiple times on the 67th lap out of 70. Norris ultimately ran into Piastri and bounced into the wall, drawing a safety car for the final laps.

"I was defending the inside, then I felt a small touch," Piastri said. "That's all I've got to go on at the moment. It's a shame for the team.' Norris received a 5-second penalty for contact with Piastri after the race and took responsibility. "I just went for it. I thought Oscar would move a bit more to the right, not leave a gap," Norris said. "I wasn't expecting anything easy from him. But in the end, it was all my mistake. I take full blame and I want to apologize to my whole team and to Oscar for attempting something like that."

Piastri finished fourth, ending an eight-race podium streak dating back to the second race of the season. McLaren as a team failed to reach the top three for the first time this year.

"We never want to see a McLaren car involved in an accident and definitely not contact between our two cars," team principal Andrea Stella said. "This is a situation we know is not acceptable. At the same time, we appreciate that Lando immediately owned it. (AP)

But that wasn't Sunday's takeaway. Rather, it was the 401.5 feet worth of putts the champion made over four days. And the fact that Spaun joined none other than Ben Hogan, Jack Nicklaus, Tom Watson and Jon Rahm as the fifth U.S. Open winner to finish birdiebirdie.

"I just felt like you keep putting yourself in these positions, like eventually you're going to tick one off," said Spaun, whose loss in a playoff to Rory McIlroy three

OAKMONT (US), June 16: No- months ago at The Players Championship was his third top-three finish of 2025.

But at the U.S. Open? In that kind of weather?

China finished on top of the standings with seven medals including four gold while Norway edged India to second on the basis of having won a silver with the same number of golds and medals as India.

A total of 11 nations including the individual neutral athletes group won medals in Munich. (PTI)

# German regulator pushes for more fan control of soccer clubs like Bayer Leverkusen

DUESSELDORF (GER-MANY), June 16: Top German soccer clubs including Bayer Leverkusen and Leipzig face the prospect of handing over more control to fans in future after a

regulator intervened. A statement Monday from Germany's antitrust regulator, the Federal Cartel Office, said it wants to see tighter enforcement of the rule known as 50-plus-1 which requires a soccer club's membership to have majority voting rights over how the team is

The regulator said recent European court rulings suggest permanent exemptions from 50-plus-1 for last year's champion Leverkusen and fellow top-tier club Wolfsburg seem "no longer possible.

It said efforts should be made in the future to ensure the club's professional soccer operations come under the control of membership organizations, but didn't



ensure the clubs it oversees "offer Leverkusen and Wolfsburg their fans the opportunity to bewere founded as workers' teams come a new full member with at major companies which own voting rights.'

That appears to affect Leipzig and its relationship with drinks giant Red Bull, though they weren't directly named by the regulator in Tuesday's statement.

clubs. It grants voting rights to far fewer people than most German clubs. Local media reported that only 23 members had the right to vote at Leipzig as of last year.

Leverkusen said in a statement that the Federal Cartel Office's new approach was a "remarkable change of course". The club added that it does not consider the regulator's reasoning to be "convincing" and that it will examine the ruling and reserve all legal options

Hans-Joachim Watzke, speaker of the league's executive board, said it stands behind 50-plus-1, which he called "an elementary component of German soccer." Fan control means outside in-

vestors can't buy up German clubs outright, like they can in the English Premier League and other competitions.

It's also one reason why Germany hasn't seen the sort of spending sprees and dramatic shifts in competitive balance

which followed takeovers at clubs like Manchester City, Chelsea or Paris Saint-Germain in the past. Fans often argue the rule keeps clubs rooted in their communities but still allows a limited role for investment.

Sportswear giant Adidas is among the minority shareholders who've helped member-run Bayern Munich win a string of titles, while Borussia Dortmund shares are traded on the stock market.

Fan power is a force in German soccer outside of the boardroom, too. Following protests, the league abandoned plans to sell a stake in its media rights income last year.

While the regulator's statement may eventually change how some top clubs are run, it could take a while. The regulator has been examining German men's soccer for around seven years now and has brought about limited changes before. (AP)

# England will hold the edge but India will push hard, feel former cricketers

NEW DELHL, June 16: Former Australia opener Matthew Hayden believes India will have a strong chance of winning the upcoming Test series against England if they can clinch the games in Leeds and Manchester, but South African pace great Dale Steyn has backed the hosts to triumph 3-2 in the fivematch contest.

India and England kick off their new World Test Championship cycle with the five-match series, starting with the first game in Leeds on Friday. Manchester will host the fourth Test from July 23.

"I don't think England bowlers are that good, they have got a number of injuries and a number of retirees as well, that will be the challenge," Hayden said on 'JioHotstar'.

"The northern Test matches when it's zipping around that will be key, win that one and it could well be a series that goes India's way," he added.

Since India's last red ball tour of England, the hosts' two most experienced bowlers --James Anderson and Stuart Broad -- have bid adieu to international cricket.

Additionally, England's bowling arsenal is also considerably depleted, with speedster Mark Wood ruled out of at least the first three Tests due to injury.

Fellow quick Jofra Archer will also miss the opening game, and Gus Atkinson is continuing to recover from a hamstring strain. India, meanwhile, will take the field under new captain Shubman Gill, ushering in a fresh era following the retirements of stal-

warts Rohit Sharma, Virat Kohli, and R Ashwin. With a youthful batting line-up and limited

red-ball exposure in recent months, the visitors will face a stern challenge.

Steyn didn't write India off but backed England to claim the trophy.

"It is a pretty young team. Probably going to say that England are going to win the series but it's not going to come without a fight. I feel like there are going to be one or two Tests that India will take themselves."



"All games will be close. But every game will have a result. I think it will be 3-2 in favour of England. But even that will be incredibly difficult.'

Former India cricketers Deep Dasgupta and Sanjay Manjrekar also backed England to clinch the rechristened Anderson-Tendulkar Trophy, but agreed the series would be a closely fought affair.

"It is a young team, it has a young captain.

The team is going through a transition so that will give England a slight advantage and they have the home advantage as well but it (the series) will be very close. I'd say 3-2 in favour of England," Dasgupta said.

Manjrekar echoed the sentiment: "I think England have an edge. They are playing at home and the Indian team is going through a transitional phase so I think England might just pull this off." (PTI)

## Women's ODI WC: India to face Pakistan on October 5 at Colombo

DUBAI, June 16: India's marquee women's ODI World Cup match against Pakistan will be held at the neutral venue of R Premadasa Stadium in Colombo on October 5, the ICC announced on Monday.

Colombo had to be added as a neutral venue according to the 'Hybrid Model' that was accepted for the men's Champions Trophy and beyond earlier this year after India refrained from travelling to Pakistan for the ICC event.

There were speculations whether ICC will slot an Indo-Pak round robin match, which is pretty much a feature in all global tournaments post terror attacks in Kashmir's Pahalgam where 26 Indian tourists were killed.

The military escalation from both sides had raised doubts about India facing arch-rivals even at world events but ICC has cleared all doubts after the release of schedule on Mon-

India will kick off their campaign against Sri Lanka at Bengaluru on September 30, and will also face Bangladesh on October 26 at the M Chinnaswamy Stadium, dispelling the rumours of the venue losing hosting rights of the matches after the recent stampede during the Royal Challengers Bengaluru victory celebrations. India's contest against the Lankans is also the opening match of the ICC showpiece.

India, who are seeking their maiden title triumph, will lock horns with South Africa on October 9 and will meet defending champions Australia on October 12, and both the matches are at Visakhapatnam.

From there, India will move to Indore to face England on October 19 and then will proceed to Guwahati for the match with New Zealand on October 23.

"With the eight best teams in the



alongside incredible venues and what promises to be record-breaking crowds, we are all looking forward to an unforgettable tournament," said Jay Shah, the ICC Chairman, in a release.

However, the BCCI is yet to form the Local Organising Committee (LOC) which will be in charge of the running of the tournament.

Australia will start their campaign against New Zealand on October 1 at Indore, while the high-profile match against England in a rematch of the previous edition's final is scheduled to be played on October 22 in Indore.

Meanwhile, Pakistan will play all their matches in Colombo as per the hvbrid model.

Apart from the match against India, they will also play against Bangladesh (October 2), Australia (October 8), England (October 15), New Zealand (October 18), South Africa (October21) and Sri Lanka (October 24) at the Premadasa Stadium.

The first semifinal is scheduled for October 29 either at Guwahati or Colombo depending on Pakistan's

progress in the tournament. The second semifinal will be held women's game descending on India, at Bengaluru on October 30, while the

final will be held at Bengaluru or Colombo on November 2 as per Pakistan's standing in the event.

India are hosting this global event for the first time since 2013, and all the eight teams will play each other in a round-robin format, with the top four entering the semifinals.

Apart from hosts India, the Aussies, England, New Zealand, South Africa and Sri Lanka achieved direct qualification to the World Cup while Pakistan and Bangladesh entered the tournament through the Qualifiers at Lahore earlier this year. Bangladesh qualified for the tournament at the expense of the West Indies.

NEW DELHI, June 16: In a significant move, the player undergoes a bone test in the 2025-26 season BCCI has decided to conduct an additional bone test at the age group level to ensure that no cricketer misses out on playing an extra season in the junior circuit due to arithmetical age.

As per the existing norms, a player undergoes a bone test for age determination via the TW3 method (test used for assessing bone age) and a +1 factor is added to determine his or her eligibility for the next season in the same age group.


## India eye stronger response against **Argentina**

LONDON, June 16: Having started their European leg with two narrow defeats, the Indian women's hockey team will be eager to bounce back when it takes on world No. 2 Argentina in back-to-back matches in the FIH Pro League.

Salima Tete and her side went down 1-2 and 2-3 to Australia over the weekend and will have little time to regroup before facing a formidable Argentine outfit that has won seven of its 12 league matches so far.

"Argentina is ranked No. 2 in the world and has won 7 of their 12 FIH Pro League matches so far. Coming into this leg of the league, we knew they would be one of the

I have looked up to Washington for inspiration: Sai Sudharsan

BECKENHAM (UK), June 16: Washington Sundar's meteoric rise from age-group to international cricket in a quick span of time was an inspiration for his younger state-mate B Sai Sudharsan, who is all set to make his Test debut against England at Leeds on June 20.

In 2016, Washington was playing more as a specialist batter for India U-19 in the junior World Cup and within a year and half, he was playing his first ODI as an 18-year-old. In 2021, he made his Test debut as a 20year-old and was one of the heroes of the Border-Gavaskar triumph.

Sai Sudharsan, who is two years junior to Washington, spoke about how his "senior's" journey goaded him to work harder in order to achieve his goal of donning India colours.

"I had played a few games against him (junior level). So, it's always special. We have looked up to him a lot and the way he went up and played for the country, it was real quick, I had that in my mind," Sai Sudharsan told BCCI.TV on sidelines of the intra-squad warm-up game with a beaming Washington by his side.

"He (Washington) did well in the IPL. Then he played for the country, so it was great motivation for me, that someone from Chennai (is playing for India). Knowing him and playing with him since we were young, it made me feel I also want to do it the same way. He was an inspiration," the stylish southpaw's admiration for Washington was there to be seen.

Washington, who has played 9 Tests, 23 ODIs and 54 T20Is for India, also spoke about the time when Sai Sudharsan was coming through the ranks as this talented cricketer from Chennai.

"Lot of my coaches and friends as well, constantly spoke about his (Sai Sudharsan's) growth in his cricketing career, always grown, only managed to get better," Washington said.

'Every time I watched him (Sudharsan) on TV, there was a lot to take from his skill-set, kind of work ethic, which definitely inspired a lot of kids," he said. (PTI)

Similarly, if a player's bone age is determined to be 15.5 years or higher, the bone age automatically increases to 16.5 years or higher, making him ineligible for the U-16 tournament, since 16.4 is the final cutoff.

"It's possible that this arithmetical calculation does not accurately reflect a player's actual age, which could cause them to lose out on a year of eligibility," the source added.

In the case of U-15 girls, if a player tests 13.9 years this season, she will be eligible for the same category the next season with a bone age of 14.9. However, if she tests at 14 or above this season, she

can play this season but not the next one with cut off being 14.9. (PTI)

## India should play both Kuldeep and Jadeja at Leeds: Harbhajan

NEW DELHI, June 16: Spin great Harbhajan Singh has thrown his weight behind wrist-spinner Kuldeep Yadav to start in India's playing XI for the first Test against England alongside Ravindra Jadeja.

The series opener begins at Leeds on June 20. Traditionally, the surface at Leeds aids the pacers more than the spinners.

"India should look to play Kuldeep Yadav. Of course, Jadeja will bowl with him. So, two spinners with three seamers would be the kind of perfect match for this game," Harbhajan told PTI Videos on Monday.

The turbanator termed the left-arm wrist spinner as a potential match-winner irrespective of the conditions.

"Let's see if conditions will change or favour the spinners. But even if it doesn't, I think these are two capable bowlers who can take wickets on any wicket," he said.

Drawing on his own experience, Harbhajan recalled India's bold decision to field two spinners at Headingley in 2002, when he and Anil Kumble bagged 11 wickets between them on a green top.

"That was a very unique decision at that point of time. The pitch was as green as we are standing on this grass ... But the management decided we'll go with two spinners and two fast bowlers and Sanjay Bangar will bowl as well.

"It's very unfortunate ... I was a bit shocked not seeing his name in the squad. I'm sure he will come back strong. He has got that will to make a comeback...All I can say is, don't be disheartened, you will get your due, if not today, then tomorrow... Look at Karun Nair.

"He scored 300 runs against England and then never got too many opportunities. Now he is back in England with the team," Harbhajan added. (PTI)
