Dhankhar said the words inserted in the Preamble in 1976 during the period of Emergency, were a "nasoor" (festering wound) and could cause upheaval. The changes signalled a betrayal of the "wisdom" of the framers of the Constitution, he added.

"It is nothing but belittling the civilisational wealth and knowledge of this country for thousands of years," the vice president said at a book launch event in Delhi

Dhankhar described the Preamble as a "seed" on which a Constitution grows. He also underlined that the preamble of no other Constitution has undergone a change except that of India. (CONTD. ON PAGE-2)

Sarma calls 'socialism' and 'secularism' Western impositions, seeks their removal from Constitution's Preamble CM for removing 'socialism, secularism' from Constitution

GUWAHATI, June 28: Chief Minister Himanta Biswa Sarma claimed on Saturday that 'socialism' and 'secularism' are "Western concepts", and these words should

be struck off the Constitution. He said these words were included in the Preamble of the Constitution by the then Prime Minister Indira Gandhi when the country was under Emergency rule, and these have no place in the Indian civilisation.

"How can I be secular? I am a hardcore Hindu. A Muslim person is a hardcore Muslim person. How can he be secular?" Sarma said.

He was speaking after launching a book titled 'The Emergency Diaries: Years That Forged a Leader' in Assam, which is based on firstperson anecdotes from associates who worked with Prime Minister Narendra Modi, then a young RSS pracharak, and used other archival material.

"Jai Ma Kamakhya. Let the blessings of Ma be endowed on everyone's families forever," Sarma posted on X after the 'darshan'. In another post on social media, he said, "We are feeling blessed after offering our prayers to the mother goddess after Ambubachi nibriti, along with my wife, son and daughter." "We prayed that the mother goddess keeps showering her blessings on all." Sarma added.

The chief minister and his family offered 'jal arpan' at the Saubhagya Kunda and completed 'parikrama' of the temple during the visit. The four-day Ambubach Mela had ended with the opening of temple doors on Thursday.

The mela is held for four days every year when the temple doors are closed, coinciding with the ritualistic menstrual cycle of Goddess Kamakhya. (PTI)

Assam journos protest minister's 'derogatory words' Govt reaffirms respect for journalists

GUWAHATI, June 28: Chief Minister Himanta Biswa Sarma on Saturday expressed regret over the remarks made by a cabinet colleague towards a journalist and reiterated his government's unwavering respect for the press and its role in a democratic society.

Addressing the issue after widespread protests by journalists across Assam over Housing and Urban Affairs Minister Jayanta Malla Baruah's comments, the Chief Minister said that if any derogatory statement had been made, it was deeply unfortunate and unacceptable.

"I apologise on behalf of my cabinet if any iournalist felt insulted. Though I haven't heard what was said, I will personally speak to the minister and ask him to apologise. Journalists

are not part of our political conflicts," Sarma

The controversy erupted on Friday during a press conference when Minister Baruah reportedly declined to answer a question posed by a reporter from a local satellite news channel, which has been critical of his alleged involvement in the allocation of government subsidies under a dairy promotion scheme. The minister had stated that he would respond only to the channel's owner and not to "low-class" individuals, a comment that drew sharp reactions from the media fraternity.

Unfair trade practices by Bangla suppliers forced India to restrict import of jute: Officials

NEW DELHI. June 28: India imposed restrictions on the import of jute and allied fibre products from Bangladesh in view of its "unfair trade" practices including circumvention of anti-dumping duty that harmed Indian farmers, people familiar with the matter said on Saturday.

The new restrictions will apply to imports into India of Bangladesh's jute and allied fibre products across all land and seaports, with the exception of the Nhava Sheva seaport in Maharashtra.

The punitive measures were announced on Friday and they came into effect immediately. There has been a sharp downturn in India-Bangladesh relations after deposed prime

Centre issues model rules to ease tree felling on agricultural land, boost agroforestry

Manipur civil society organisations to hold talks with Centre in Delhi on June 30

IMPHAL, June 28: A delegation of civil society organisations in Manipur will hold talks with the Ministry of Home Affairs in New Delhi on June 30 over the current situation in the ethnic strife-torn state, officials

A team of All Manipur United Clubs Organisation (AMUCO), Coordinating Committee on Manipur Integrity (COCOMI) and Federation of Civil Society Organisations (FOCS) will hold a discussion with officials of the Ministry of Home Affairs in the national capital on Monday, they

Addressing a press conference, COCOMI convenor Khuraijam Athouba said, "A delegation of AMUCO, COCOMI and FOCS will meet officials of the Ministry of Home Affairs on June 30. We will apprise them of the concerns and frustrations of the people.'

AMUCO senior member S Bhubon said the main priority is to ensure that the territorial boundary of Manipur is not affected. "We would highlight the short and long-term measures that need to be taken up to stop threats faced by farmers in the peripheral areas of the

Opening of highways to all is another serious issue, and the plight of internally displaced people and their resettlement will also be discussed,

NEW DELHI, June 28: The Centre has issued model rules for the felling of trees on agricultural land in a bid to promote agroforestry with the aim of doubling farmers' incomes, increasing tree cover outside forests and mitigating climate

In a letter sent to all state governments on June 19, the environment ministry said the objective of 'Model Rules for Felling of Trees in Agricultural Lands' is to enhance the ease of doing business in agroforestry and incentivise farmers to integrate trees into their farming systems without facing undue procedural hurdles.

The government has been promoting agroforestry to double farmers' income, enhance tree cover outside forests, mitigate climate change, reduce timber imports and ensure sustainable land use. It also supports India's climate goals under the Paris Agreement.

A key barrier is the lack of clear, harmonised rules for felling trees on agricultural land which affects



forestry produce, according to the ministry.

According to the model rules, the State Level Committee (SLC) already formed under the Wood-Based Industries (Establishment and Regulation) Guidelines, 2016 will also serve as the committee for these rules. It will now also include officials from revenue and agriculture departments. The committee will advise the state government on how to promote agroforestry and increase timber production from agricultural lands by simplifying rules for felling and transit of trees, especially species with commercial value.

It will empanel agencies for verification of applications and transit of timber from agricultural lands. Applicants must register their plantation land on the National Timber Management System (NTMS) portal. They have to enter

land ownership details and the location of their agricultural land. They must give basic plantation

details, including the number of saplings by species, planting date (month and year) and the average height of seedlings.

Applicants will also have to update this information as required by the SLC. For lands with more than 10 trees, the applicant must apply online through the NTMS, giving detailed information about the trees to be felled.

The verifying agency will do a field visit and prepare a report with details about the land, trees and the estimated quantity of timber. Based on this, a felling permit will be generated

For applications for the felling of up to 10 trees, applicants need to upload tree' photos to the NTMS. The system will estimate the tree size (girth, height), yield and species. Applicants also need to inform the planned filing date. After felling, they must upload

also send an officer to verify. In this case, the no objection certificate for felling will be issued automatically through the portal. Divisional forest officers will monitor how verifying agencies are functioning. They will submit a report every quarter to the SLC on the performance of these agencies.

Currently, most states have their own laws or rules that regulate the felling of trees on agricultural land. Some states have exempted certain tree species from requiring felling permission, while others require clearance even on private land depending on the species and location. The new mechanism aims to simplify the process of obtaining permission for tree felling on agricultural land and to transform agroforestry in India into a more organised and structured sector.

Currently, many farmers struggle to get fair market prices for timber because they lack verifiable proof that the wood is legally harvested and (CONTD. ON PAGE-2)

MCL to start operation in two new coal mines in Odisha's Talcher area by FY 2029-30

SAMBALPUR (Odisha), June 28: Mahanadi Coalfield Ltd (MCL), a subsidiary of Coal India Ltd (CIL) is going to start operation in two of its new mines having total coal reserve of 35 million tonnes (MT) in Talcher coalfield area of Odisha's Angul district, a senior company official said.

"We are going to start operation of the Subhadra coal mine having a reserve of 25 MT in Talcher area by the end of financial year 2025-26," chairman cum managing director (CMD) of MCL, Uday A Kaole, said during a media interaction here.

Similarly, the Balabhadra coal mine with a capacity of 10 MT will be made operational by the end of financial year 2029-30, he said.

At present, MCL is operating 18 coal mines in Angul, Sundargarh and Jharsuguda districts in Odisha of which three are underground mines and the remaining 15 are open-cast mines.

Among the coal mines, the public sector company has seven op-

Grand Continent to launch its first overseas hotel in Dubai

CHENNAI, June 28: Hospitality service provider Grand Continent Hotels and Resorts Ltd is set to make its first overseas expansion with the launch of a hotel in Dubai, a top official said here on Saturday.

The Bengaluru-headquartered company has drawn up plans to open 4 more hotels in the country as it targets to operate 5,000 hotels by 2028, Grand Continent Hotels and Resorts Chairman and Managing Director Ramesh Shiva said.

"It is a 125-room facility. It is our first international property. We will be launching it in three months in Dubai," he told reporters.

Shiva, a hospitality industry veteran, on Saturday inaugurated the 22nd property, a 72-room capacity hotel 'Grand Continent Premiere T Nagar' at Thirumalai Pillai Road in Chennai. Each room measuring 28 sq mts to 48 sq mts would be targeting travellers of both business and leisure. It is equipped with a rooftop swimming pool, multi-cuisine restaurant, unwind bar, state-ofthe-art boardroom among others. On the capital expenditure made for the new property, he said for a property like this T Nagar hotel, the investment would be around ₹7-8 lakh per room. "I would say about ₹ 5-6 crore will be the capital expenditure for this facility", he said.

Commenting about the future expansion plans, Shiva said they have planned to open a 42 room (42 room capacity hotel), a-82 room capacity hotel in Jaipur, Rajasthan, 92 rooms in Ayodhya, Uttar Pradesh and a 35 room facility in Gurgaon. The launch of these hotels would happen in 2025 and 2026, he said. To a query, he said the company would open hotels in Sri Lanka and Dubai. "Domestic market will be our strong market. We will also have properties in Sri Lanka and Dubai," he said.

In Dubai, initially it would be a property managed by Grand Continent Hotels and after three months it would become a 'leased property' in line with the company's strategy. Nearly 75 per cent of the customers come from the corporate segment while 20 per cent would be leisure and the remaining account for people going on pilgrimage to places like Tirupati or Ayodhya, he noted. CM for removing 'socialism,

"These concepts were never for India. Our economic principle is of sharing the riches... This socialism made us lose our competitiveness and capabilities, and we were left behind in the global race," Sarma said.

'The BJP didn't have to even demolish this concept of socialism. P V Narasimha Rao and Manmohan Singh demolished it and brought liberalisation," he added. He was referring to Prime Minister Rao and then Finance Minister Singh who were credited with bringing economic liberalisation in India in the early 1990s.

Sarma said the economic liberalisation was taken forward by the later BJP governments, and its benefits are now being made available to the marginalised and poor sections. Sarma said that the time is ripe to discuss the 'damage' caused by the Emergency to the nation, and start "erasing the Emergency legacy, just as colonial legacies are being erased". "We must not forget the Emergency as we cannot repeat the Emergency," he added. He claimed that Gandhi had brought in Emergency to save her own chair and there was no situation of unrest in the country to justify it.

The Emergency declared on June 25, 1975, by then Prime Minister Indira Gandhi lasted until March 21, 1977. It was marked by widespread press censorship, arrests without trial and the stifling of dissent in academia, politics and civil society. Sarma also questioned Gandhi's leadership, referring to the formation of Bangladesh.

"By winning the war against Pakistan, what did she do to help the Northeast? She could have redrawn the map for NE's straight access to the rest of the country and not remain dependent on the 'chicken neck' corridor. She could have asked Bangladesh to take back the illegal immigrants and they would have obliged," he claimed. "She was a powerful leader, but what is her contribution to the nation. Even Hitler was powerful but he damaged Germany," Sarma added. (PTI)

apology from the minister and seeking assurance against future instances of verbal abuse or disrespect by public representatives.

Chief Minister Sarma, in his response, urged for a clear distinction between media house owners and working ournalists. "Owners and journalists are not the same. Journalists are to be respected, regardless of who owns he platform. Our political criticism of media owners should not be viewed as an attack on journalists," he said.

Sarma also acknowledged the financial hardships faced by working journalists, especially those in rural areas. "Many journalists do not have houses of their own. When they or their family members fall ill, they often seek assistance from me. I am happy to help, but the media owners, who earn substantial profits, should also take responsibility and ensure their journalists are adequately paid," the Chief Minister said

He cited instances of rural correspondents being paid as little as Rs 100 per news item. "That is why I make it a point to give them a byte, so that their reports are used and they are paid. It is a matter of dignity," he added. Calling for structural reforms in the media sector, Sarma advocated for a fixed minimum wage and regulated eight-hour shifts for journalists to ensure their professional and personal well-being.

He reiterated his government's commitment to safeguarding press freedom and ensuring a respectful working environment for journalists. "We may disagree with media narratives at times, but there should be no room for disrespect," the Chief Minister said, reaffirming that any lapse in this regard would be addressed promptly and sensitively. Yojana, and other such welfare schemes, they signify the "sense of service" towards the last person in the social hierarchy, he said. All should walk together and grow together - this is the inspiration of Acharya Vidyanand Maharaj Ji, and "this is our resolve," PM Modi said. The event was held at the Vigyan Bhawan and hosted by the Ministry of Culture in collaboration with the Bhagwan Mahaveer Ahimsa Bharti Trust, Delhi, to honour the 100th birth anniversary of one of India's most revered Jain spiritual leaders, scholars, and social reformers. The revered saint was born on April 22, 1925 in Shedbal, Belagavi (now in Karnataka).

"He received his initiation at a young age and went on to become one of the most prolific Jain scholars of modern times, having memorised over 8,000 Jain Agamic verses," the ministry said.

He authored more than 50 works on Jain philosophy and ethics, including Jain Darshan, Anekantvad and Mokshmarg Darshan. Modi extolled Acharya Vidyanand Maharaj Ji's legacy and his contribution to revival of the Prakrit language, restoration of many old temples and his contribution in the fields of literature and music. His life was a unparalleled confluence of 'vidya' (knowledge) and 'anand' (bliss), the PM said. "Our India is the oldest living civilisation in the world, we are immortal for thousands of years, because our thoughts are immortal, our thinking is immortal, our philosophy is immortal," he said. And, the source of this philosophy is "our saints, seers, mahants and acharyas". He asserted that voices of Indian Tirthankars, saints and seers, their teachings, are equally contextual in different eras. Hailing the Jain seer being celebrated as a "Yug Purush" and "Yug Drashta", Modi underlined that through his literature and music, he had endeavoured to revive the ancient Prakrit language. Prakrit is one of the oldest languages of the world. It is the language of sermons of Bhagwan Mahaveer. Ancient texts of Jainism are scripted in this language, he said.

Because of those who "neglected their own culture", this language was going out of vogue, the PM said. 'We made his efforts, the effort of the government, and last year in October, our government accorded it the status of a Classical Language," he added. Prakrit, representing a spectrum of Middle Indo-Aryan languages, is integral to understanding India's rich linguistic and cultural heritage. "In our mission to digitise ancient manuscripts, a large section of it includes religious texts related to Jainism and manuscripts associated with acharyas," Modi said. "We want to go further on ths subject," he said, adding that mother tongues are being promoted in higher education as well

In his address, he again emphasised that his government has vowed to rid the country of "slavery mindset". He also reiterated his nine pledges and urged people to follow them. The pledges are: saving water, planting a tree in mother's memory, cleanliness, going 'vocal for local', travelling to explore different places in the country, adopting natural farming, having a healthy lifestyle, sports and yoga adoption, and helping the poor. Rashtrasant Paramparacharya Shri 108 Pragyasagar ji Muniraj and Union Culture Minister Gajendra Singh Shekhawat were also present on the dais at the event.

Under the provisions of SAFTA (South Asian Free Trade Area), jute from Bangladesh enjoys a duty free ac-

However, the Indian jute industry has, for long, suffered due to the adverse impact of dumped and subsidised imports of jute products, particularly yarn, fibre and bags'?from the neighbouring country, the people cited above said. There is credible evidence that Bangladeshi jute exports continue to benefit from state subsidies extended by the government of Bangladesh, they said. In response to these concerns, the Directorate General of Anti-Dumping and Allied Duties (DGAD) conducted detailed investigations and imposed anti-dumping duty (ADD) on jute and goods originating from Bangladesh, the people said. But, the imposition of ADD has not rielded a substantial reduction in imports, they said. Apart from various subsidies, common malpractices by Bangladeshi exporters include circumvention of anti-dumping duty through technical exemptions, mislabelling, exports through ADD exempted firms and "misdeclaration" to secure higher subsidies, the people said.

The restrictions are aimed to counter unfair trade practices, promote 'Atmanirbhar Bharat' (self-reliance), and protect rural livelihoods tied to India's domestic jute economy, the people cited above said. "To safeguard the interests of the domestic jute industry and to counter the unfair trade practices employed by the Bangladesh exporters acting in collusion with Bangladeshi establishment, it has been decided to restrict Bangladesh imports of jute and jute products to India through only from Nhava Sheva port," said one of the people.

The imposition is expected to streamline the quality checking, prevent misdeclaration and fraudulent labelling, thereby neutralising the malpractices that have plagued the industry for long," the person said. "The government is also taking steps to ensure that exporters in Bangladesh do not circumvent the aforesaid restrictions by routing their jute exports through third countries," he added. (PTI)

Congress MP alleges misuse of public funds, seeks PM's intervention over 'political favouritism' in dairy scheme

Gogoi writes to PM demanding inquiry into beneficiaries of dairy project

GUWAHATI, June 28: Assam Congress president and Lok Sabha MP Gaurav Gogoi on Saturday alleged that family members and associates of ministers and MLAs of the ruling dispensation were getting benefits of a government scheme, depriving genuine beneficiaries in the state.

He also criticised Chief Minister Himanta Biswa Sarma's role in it through endorsement of political favouritism" and attempting to justify the selection of such connected people as beneficiaries.

Gogoi, in a letter to Prime Minister Narendra Modi, requested a review of beneficiaries of the Assistance to Entrepreneur for Establishment of Commercial Dairy Farming (2022-23) in Assam.

The allegations by the Deputy Leader of the Congress in Lok Sabha came following reports of the inclusion of family members of ministers and MLAs in the list of beneficiaries under the dairy farming promotion scheme.

Gogoi noted that the scheme receives substantial financial support from the Assam government and each unit is eligible for up to ₹ 50 lakh in subsidy, with the objective to promote genuine entrepreneurship in the dairy sector.



"However, multiple reports and official documentation point to irregularities in the selection of beneficiaries. Several recipients of the scheme's benefits appear to be family members or associates of ministers and MLAs in the state government, while long-standing dairy farmers, particularly in districts like Bongaigaon, have reportedly been overlooked despite having applied multiple times and fulfilling the

eligibility requirements," he said in the let-

The exclusion of experienced dairy entrepreneurs raises concerns about the fairness and transparency of the selection process, he added.

"Equally alarming is the response from the chief minister of Assam, who chose to justify the inclusion of ministers' family members in the list of dairy scheme benestatement that the ministers' families will need a source of income when out of

He maintained that this "open endorsement of political favouritism" has fuelled public outrage for undermining the constitutional values of equality and justice.

It also reflects a breach of the oath of office, which obliges public representatives to act impartially and in the public interest,

Gogoi also mentioned the Gorukhuti agricultural project, funded through public money and intended for community benefit, which has also come under

Referring to the procurement of Gir cows for the project and allotment of several of these high-yield cattle to private parties, the Congress leader said, "Official records indicate that these were allocated to several elected representatives, including the firm owned by the wife of Jayanta Malla Baruah (cabinet minister and Nalbari MLA), Bhupen Pegu (Jonai MLA), Utpal Borah (Gohpur MLA), Diganta Kalita (Kamalpur MLA), and Dilip Saikia

Saikia is also the president of the state

Gogoi said that such actions go against the very principles of transparency, accountability and equitable access.

"If politically connected individuals are allowed to siphon off benefits meant for the poor, we risk alienating the very people these schemes are meant to uplift," he said, urging the PM to initiate an inquiry.

"I trust that this matter will be taken with the seriousness it deserves. I look forward to your prompt intervention on these issues," Gogoi added.

The state Congress president had earlier raised the matter on X and alleged that ₹50 lakh of taxpayers' money was handed to a minister for his private dairy farm.

He had hit out at the chief minister's response to the allegation by stating, "What will they do after losing power?" Gogoi had claimed that it was not the

first time those close to the BJP-led government have reaped "outsized benefits".

"This is not governance, but rather a betraval of the oath of office. Public money is misused to secure private futures, and power is treated as entitlement, not respon-

A China-led trilateral nexus as India's new challenge

ast week, China, Pakistan and Bangladesh held their first trilateral meeting in Kunming, China. The discussions focused on furthering cooperation and exploring the possibilities of deeper engagement. This meeting closely follows another trilateral meeting between China, Pakistan, and Afghanistan, held in May, with the aim of extending the China-Pakistan Economic Corridor and increasing cooperation. These trilaterals, led by China, come at a time of Pakistan's little relevance to the region, India's increasing relations with Afghanistan, and New Delhi's deteriorating ties with Bangladesh. The use of trilaterals underscores China's fresh attempts at making Pakistan a stakeholder in the region and keeping New Delhi preoccupied with immediate concerns.

A war that shaped alignments

The 1962 war between India and China has largely shaped regional alignments and geopolitics. Following the war, China found Pakistan to be an ally that could keep India engaged with immediate threats and limit it from challenging Beijing's interests, security, and status. On the other hand, Pakistan deemed China to be a country that would unquestionably offer economic and military assistance to support its aggression against India. To date, Pakistan is highly dependent on China for assistance, investments and infrastructure development. In fact, by the end of 2024, Pakistan had a loan of over \$29 billion from China. It is estimated that over 80% of Pakistan's arms imports are from China. In addition, China has also shielded Pakistan-backed terrorists at the United Nations Security Council and other multilateral platforms.

This camaraderie was largely visible during India's Operation Sindoor in May 2025. China termed India's retaliation to the Pakistan-sponsored attack in Pahalgam as "regrettable" and urged a political solution and dialogue. It backed Pakistan's stance of initiating an investigation into the Pahalgam terror attack in April 2025. The latest escalation also saw Pakistan deploying various Chinese-made hardware and weapons that ranged from surveillance radars, drones, missiles, guidance systems, and fighter jets. In the immediate aftermath of Operation Sindoor, Pakistan's Foreign Minister met his Chinese counterpart to reaffirm its "ironclad friendship." The trilateral with Afghanistan and other countries likely emerged from this meeting.

The resurfacing of an idea

This idea of China and Pakistan using plus one against India is not a new phenomenon. Even in 1965, Pakistan flirted with the idea of using East Pakistan, China and Nepal to cut off India from its strategic Siliguri corridor. This idea of using South Asian countries seems to have resurfaced as both China and Pakistan face a confident India. Pakistan-sponsored terror attacks in Uri (2016), Pulwama (2019), and Pahalgam have seen India retaliate in a befitting manner. It has shown that India will no longer tolerate Pakistan's nuclear blackmail. India has also used its diplomatic clout and growing economy to isolate Pakistan. India's suspension of the Indus Waters Treaty, halting trade, restricting port access, and targeting military installations — all as a part of its retaliatory measures against the Pahalgam attack - has damaged Pakistan military's operational capacities and confidence, highlighting Rawalpindi's limitations and weaknesses. India's military and diplomatic responses to Chinese border intrusions in Doklam and Galwan have also likely taken Beijing by surprise. New Delhi has also increased close cooperation with like-minded countries to limit Chinese aggressions.

At the same time, India's pragmatic engagement and domestic politics of the region have slowed down China's momentum in South Asia. In the Maldives, Beijing appears reluctant to trust President Mohamed Muizzu and the country's economy, despite his initial anti-India rhetoric. Mr. Muizzu has now turned to India to keep the country's economy afloat. In Nepal, despite signing the framework for Belt and Road Initiative (BRI) cooperation, major differences in funding remain unresolved and the progress of projects has been slow. In Sri Lanka, President Anura Kumara Dissanayake is developing close ties with India by respecting its redlines. Despite ideological and historical differences with Delhi, he visited India before China. In the case of Bangladesh, despite differences, India has not hindered the trilateral energy cooperation with Nepal.

These increasing anxieties are likely to have motivated China to push for trilaterals with Afghanistan and Bangladesh. Before their respective regime changes in 2021 and 2024, both countries were staunch supporters of India's fight against both Pakistan and its state-sponsored terrorism. With the change in regimes, however, Pakistan and China have attempted to draw both countries closer to their orbit. They remain cautious of pragmatic engagement between India and the Taliban, fearing that Pakistan would lose its leverage. At the same time, Pakistan has increased security, economic and political engagements with the new government in Bangladesh.

Historically, both Bangladesh and Afghanistan have enjoyed close ties with Pakistan and provide a fertile ground for crossborder terrorism. Pakistan's influence, supported by China and its economic clout, could thus create new terror and security-related challenges. This will help Pakistan become a relevant country in the region, create rifts between India and its neighbours, and keep Delhi preoccupied with immediate security and terrorrelated challenges, making way for Chinese BRI projects, interests and investments in the region.

China efforts and setbacks

The developments in the region demonstrate, once again, that China, and not Pakistan, is India's biggest challenge. With both Pakistan and China confronting a confident India, China sees an opportunity to challenge India through the trilateral nexus. At a time when India is seeking support from South Asian countries to fight terrorism. Chinese efforts will create new setbacks. South Asian countries will thus have to learn to balance between India and China, as Beijing uses Islamabad to create new complexities in the region. On its part, Delhi will have to continue to express redlines and convey the point that any misadventures by its neighbours could have severe economic, military, and political costs. (Courtesy: ORF)

SC ruling on maternity benefit as fundamental right is a big step

n May 23, while delivering a historic udgment in K Umadevi v. State of Tamil Nadu (2025), the Supreme Court unequivocally declared that 'leave and benefit due to maternity situation of a woman' are fundamental rights. The Court linked several previous cases, international conventions. treaties, and prevalent socio-economic reality of the nation to grant 'maternity leave as fundamental right under Art.21'. În Suchita Srivastava v. Chandigarh Administration (2009), it was noted that women's 'reproductive rights' was an integral part of personal liberty and hence fell within the ambit of Article 21.

In Umadevi, the Court added that 'international conventions', such as the Universal Declaration of Human Rights ('UNDHR'), the Convention on the Elimination of All Forms of Discrimination Against Women ('CEDAW'), the International Covenant on SEC Rights, and ILO basic framework on 'Maternity Protection' (2000) provide for a 'broad spectrum of reproductive rights includes maternity benefits.' As such, maternity leaves were integral to maternity benefit and hence formed an essential part of personal lib-

The Court enunciated that the global community "recognise maternity rights are at the intersection of several human rights and protected under human rights laws as well." In one stroke of the pen, the Court conferred status of fundamental right to maternity rights and benefits. It is an exquisitely written judgment. The assured and protected maternity sabbath is not merely a guarantee of constitutionalism but a mandate of a civilised society under international framework.

The most salient feature of the judgment is that the Court reminds the State its commitment to these international laws under Article 51(c) of the Constitution, especially regarding ILO's framework (2000) on 'maternity protection, right to proceed to freely, with dignity and assurance that right to return to same role, status and entitlements are in safe hands of employers and State'

The Court lauded the enactment of the Maternity Benefit Act, 1961 ('MB Act') and



urged the world of work to look for guidance under its provisions as a comprehensive legal framework. It does not bar any worker who is a mother from availing maternity benefits and leaves. The Court hailed the MB Act as 'North Star' as "it affords women much flexibility and enable to live an autonomous life as worker and mother.'

Now that maternity benefits have been recognised as a fundamental right, it shall dawn a new era in constellations of fundamental rights. The employers cannot evade or hide behind the ambiguity of maternity laws or resource crunch or simple ignorance.

There is also a procedural question involved in this new fundamental right of maternity benefit: Whether an aggrieved woman can directly approach directly either the Supreme Court or the High Court under the writ jurisdiction of Articles 32 and 226 of the Constitution, overriding the relief structure of the MB Act?

Similarly, another question that emerges is: whether, after the judicial acceptance of maternity right as a 'human right', the NHRC/SHRC shall exercise jurisdiction on these matters directly?

The MB Act provides 'an extraordinary relief mechanism' wherein a labour inspector is vested with power to issue 'orders'. This may lead to multiplicity of relief fora, hence causing confusion. The MB Act covers 'each

woman', whether permanent/regular/ FTE/contractual in any standard or non-standard forms of employment without any cap

The relief under the MB Act already suffers from, what I call, 'jurisdictional irony'. Just to briefly elaborate it, the Industrial Disputes Act, 1947 ('ID Act') also deals with employment disputes like non-payment of salary, termination of employment or unfair practice. But if such a dispute arises out of vindictive action of the management due to maternity conditions of women workers, it shall be dealt with under the MB Act. Now, the definition of 'appropriate government' is different in the ID Act and the MB Act. Hence most establishments that fall within one (Center/State) government for relief under the ID Act may not fall within the same jurisdiction under the

For example, ordinarily termination of a woman worker in a bank would come under the Central Government due to the ID Act. But if suddenly that woman claims that she was terminated due to maternity conditions, her petition shall now be heard in the labour department of the State Government. This multiplicity of fora already confuses a lot of aggrieved women workers and deprives them of appropriate relief due to 'irony of jurisdic-

The elephant in the room is 'informal

workers'. According to the Periodical Labour Force Survey, "over 70% of Indian employment is in the informal sector and the overwhelming majority of these informal workers are women (the Court itself records that "now women constitute a sizable portion of our workforce.". How are they going to be impacted by the Umadevi judgment?

Now if maternity rights are fundamental rights, it brings into its fold private employers of MSMEs for deliverance of this right. How will these MSMEs afford to finance the benefits, especially for those who are hired for 'fixed short term'?

It is high time due thought may be given to observe ILO Maternity Protection Convention 183 in law. The Court understood "concept of maternity leave is a matter of not just fair play and social justice but is also a constitutional guarantee to women whereof the State is bound to act." In this regard, 'universal maternity contributory corpus' may be formed. Field experiences in enforcement of maternity laws reveal that several social-factors like stigma, taboo, fear, insecurity or illiteracy impede women workers from placing claims for maternity benefits.

For employers, this benefit is the most unprovisioned for. This social attitude must also be re-vamped through accelerated awareness about the MB Act. The Court itself acknowledges this and calls upon 'to bridge the gap between society and law'.

With this judicial position that maternity benefits are fundamental rights, the Court has brought a nationwide attention to provisions of MB Act and accorded it due publicity and clarity in its implementation. But vesting women with maternity benefits in a patriarchal and lopsided labour market like India is not a question of legality. It is a mix factual matrix of socio-economic and political realities. It has to be addressed keeping in mind international best practices. Moreover as Andre Beteille, an eminent Indo-sociologist, remarked about India, 'Laws set the path, it is society that travels upon.' India has to traverse the path the Court has illustriously set for the cause of women at work. (IPA Service)

India-US trade talks reach crucial stage as US seeks larger access to farm goods sector

s has been agreed earlier, a trade team of India is currently visiting the United States to work out details of the agreement on commerce between the two countries before the deadline of July 9 when the so-called reciprocal tariffs come into force. Trump advisers however have indicated that the deadline may be extended by a few more days. While negotiations have progressed in wide areas, a few major differences have cropped up in sensitive areas, including trade in farm products.

In any trade talks, it is the farm sector which poses the biggest hurdle even though farming does not contribute an overwhelming proportion of national income. This is due to the fact that issues relating to the farm sector are most sensitive and politically extremely critical. In the talks between USA and India currently undergoing, it is the insistence of the USA for access to Indian markets for farm goods that is proving to be a stumbling point. USA is a huge producer of items like corn, sova, wheat and several other items. India is also a major producer and the domestic demand in India is massive.

There are two outstanding issues. First, United States subsidies its farm sector to an extent that is impossible to match in India. For example, US cotton growers, a small portion of US agriculture, were receiving as much as \$100 billion in subsidy. This had created a stalemate in WTO negotiations between the US and the African countries.

Billions of dollars are handed over to the farmers in the name of environmental protections and other practices which virtually result in price subsidisation. They could sell much cheaper than their cost of production to capture markets.

Secondly, the USA has a large variety of genetically modified crops — the ubiquitously described GM crops. Introduction of such crops and their leakage into general farming could play havoc with the indigenous crops. These could altogether wipe out the indigenous crops and their strains much to the loss of genetic varieties of a country.

Hence, proper caution has to be taken before introduction and consumption of such crops in a new environment. Therefore, a critical view would have to be taken to introduce protection measures.

These tend to prolong free trade negotiations between countries. For example, in case of free trade

negotiations with Japan, the Japanese had refused any concession on farm products which had nearly wrecked the negotiations altogether. The Japanese maintained that they eat only the Japanese variety of sticky rice which is not produced in India. Many other farm products had also posed problems for the negotiators. Many other points crop up before the trade negotiators as well. One of these is the point about domestic content. That is, in many cases, countries work as mere point for routing products of other countries. Chinese products enter India through the Nepal corridor as India and Nepal trade without any tariffs. However, in ordinary course these Chinese products would have attracted much higher tariffs to enter the Indian market.

Hence, the trade negotiators have to work out norms for "domestic content" in traded goods. These requirements vary from a high of 80% domestic content requirements to a low of 30%, depending on the choices of countries involved.

One of the major complaints of U.S. against Mexico, its southern neighbour, has been that Mexico had often been used as a transhipment point for pushing Chinese goods into USA without virtually any Mexican "domestic content" in these products. But the current round of trade negotiations to avert kicking in the reciprocal tariffs has been like negotiating with a gun pointed at your head. Many of these detailed and finer points about a trade deal are being ignored and that could create a serious breach later on.

However, for India, merchandise trade between India and USA is not large in volume compared with the overall economies of the two countries. Even though critical in certain sectors, the merchandise trade does not have much larger macro-economic implications for India as well as for USA.

Where Indo-US trade has huge significance for the former is the extent to which we can retain the overall framework for services trade. India's IT and IT enabled sectors have life threatening exposure to USA. Most of our IT and related service exports are to USA and any restrictions on that sphere could be debilitating for India.

It appears that the current round of trade talks concentrate principally on the merchandise trade segment and the other areas like services trade are not being much disturbed. For this reason India should now be much more careful in dealing with services

NATO summit at Hague shows once again Europe has surrendered to Trump

he Rambo of the global diplomacy Donald Trump joined the NATO summit at Hague on June 24-25 with a triumphant smile after organizing the ceasefire between Israel and Iran in their 12 day war and strongly imparting the signal that no one matters in the world affairs now excepting the U.S. President. The major European nations which were resorting to anti-Trump rhetoric in the last four months since the last February summit of NATO completely took an about turn and agreed to what Trump wanted. The NATO declaration issued on June 25 was a total vindication of Trump line on imposing 5 per cent of the members respective national incomes on defence spending gradually by 2035. Spain was the only dissenter but Trump threatened Spain and said that he would take

care of Prime Minister Pedro Sanchez later. Just remember what happened at the last meeting of NATO and later at the Munich Security Conference of European nations in February this year. US vice president J D Vance termed the European nations as freeloaders and said that USA would no longer carry the burden of defending Europe. French President Emanuel Macron as also Germany talked of independent defence arrangement without depending on USA. European Union members prepared

alternative plan for a European security system on its own strength. Only NATO Secretary General Mark Rutte, being a pragmatist remained silent. He knew how far the key powers of Europe could go with their plan without assistance from the USA.

So this time at the Hague summit, Rutte was ecstatic at the sight of Donald Trump. He presented the joint declaration as a victory of Trump. He sent a private message saying you will achieve something which no other American President, in decades, could have done. Rutte even said that Trump had done the right thing by persuading the Europeans to do what they did not do on their own.

After so much flattery and seeing the European leaders of NATO in bended knees, Trump was overwhelmed. "This was a tremendous summit, and I enjoyed it very much," he said at a news conference at the end of the meeting. He added that he understood the central role the United States plays in the defense of Europe. "They want to protect their country, and they need the United States and without the United States, it's not going to be the same," he said.

The NATO declaration made no mention of Ukraine's membership though that was at the agenda. That was done as per wishes of Trump that Ukraine need not be a member of NATO. Ukrainian President Volodymyr Zelensky had a

meeting with Trump at Hague but he did not come out of the meeting pleased though the NATO sources said that Ukraine will be getting arms and equipment from NATO member countries. At the G-7 meeting in Canada last week, Trump could not meet the Ukrainian President because he had to rush to Washington on account of Israel-Iran war by skipping the second day of the summit.

In the last two weeks since June 13 when Israel started the war against Iran, Trump did not allow any power to take any initiative to stop the war. France, Germany and Britain talked with Iran about a formula but Trump totally ignored that. President Putin wanted to mediate but Trump just told him you look after Ukraine and nothing more. China circulated a four point proposal but it was not discussed at any level. So all through it was Trump and Trump alone who dealt with the issues of negotiations projecting himself as the only world leader who matters in the year 2025 in global diplomacy.

Jyotiprasad's Joymoti: The Birth of Assamese Cinema

inema is not merely an art form; it is an embodiment of social aspirations, political consciousness, and cultural expressions. In this regard, Assamese cinema made its historic entry into the national film narrative through a cinematic creation that was much more than a film — it was an act of resistance, a cultural renaissance, and a call for identity. Joymoti, released in 1935, was not only the first Assamese film but also one of the earliest Indian films that broke away from the mythological and formulaic tropes of early Indian cinema. Directed and produced by Jyotiprasad Agarwala, the revered 'Rupkonwar' of Assam, Joymoti was not born out of commercial ambition but out of a deeper, more powerful desire the revival of Assamese identity and the assertion of regional culture through the most modern art form of the time. Jyotiprasad's Joymoti remains a watershed moment in the cultural history of Assam, and its significance lies not only in the fact that it was the first Assamese talkie but also in its bold ideological underpinnings, aesthetic innovation, and unwavering socio-political intent.

The 1930s was a turbulent decade, both for India and Assam. While the Indian national movement was at its peak, Assam was undergoing cultural erosion under colonial pressures and a struggle for linguistic and cultural recognition. Against this backdrop, Jy-

from Germany's UFA film studios and exposure to European art and cinema, envisioned a cinematic project that would be both a cultural milestone and a political instrument. He chose to adapt the historical figure of Joymoti Konwari, the Ahom princess who had embraced martyrdom rather than betray her husband Gadapani during the political conspiracies of the 17th century. But Jyotiprasad's interpretation of the tale was not just historical retelling; it was a cinematic reinterpretation designed to mirror the contemporary spirit of resistance against injustice and tyranny, both colonial and patriar-The making of Joymoti was in

itself a radical act. At a time when Assam had no cinematic infrastructure whatsoever - no studios, no trained technicians, no professional actors — Jyotiprasad created everything from scratch. He established the Chitraban Studio in the Bholaguri Tea Estate, constructed makeshift sets using traditional Assamese materials like japi, xorai, and local architecture, and trained local talents in acting and filmmaking. The lead role of Joymoti was played by Aideu Handique, who went on to become the first Assamese film actress and tragically faced lifelong social ostracisation simply because she addressed her on-screen husband as "bongohordeo" (husband). This tragic incident itself is a commentary on how deeply patriarchal norms were challenged by this film. Jyotiprasad's decision to cast otiprasad, armed with experience a woman in a lead role portraying



strength and sacrifice was a revolutionary departure from the trend of male-dominated narratives in Indian cinema of the time

Stylistically, Joymoti was far ahead of its time. Instead of relying on theatrical overacting and loud

film with cinematic realism in-spired by Soviet montage techniques, German expressionism, and Indian aesthetic sensibilities. The camera work, set design, costumes, and lighting all contributed to an immersive storytelling experience that focused on character development, emotional subtlety, and symbolic representation. Notably, he filmed mostly in natural light, as electricity was not available at the time, which gave the film a distinct organic visual tone. His innovation extended to sound design as well. Due to synchronization issues during post-production, Jyotiprasad invented a method of dubbing sound over the silent sequences, thus making Joymoti the first Indian film to introduce rerecording and post-synchronization a technical achievement often overlooked in mainstream histories of Indian cinema.

The narrative of Joymoti was itself a powerful political allegory. The torture and execution of Joymoti for refusing to betray her husband becomes symbolic of resistance against tyranny, echoing Gandhian ideals of non-violence and moral courage. Unlike other films of the era that placed women in ornamental or romanticised roles, Joymoti was portrayed as a figure of moral fortitude, agency, and sacrifice. She neither begged for mercy nor submitted to power, instead choosing to uphold her principles even at the cost of her life. In portraying Joymoti as a feminist icon and a political symbol, Jyotiprasad constructed a narrative that was radical in both content and form

However, the film's reception was not proportionate to its revolutionary value. It was not commercially successful, partly because of its unfamiliar cinematic grammar and partly due to the socio-political environment of the time. Audiences, more accustomed to melodrama and religious epics, found Joymoti's realism and political undertones difficult to digest. Additionally, the lack of a proper distribution network and publicity further impeded its reach. Yet, commercial failure could not dim the glow of its significance. The film became a cultural document, a symbol of Assamese pride, and an inspirational touchstone for generations of filmmakers and artists.

The tragedy of Joymoti did not end with its box-office failure. Over time, many reels of the original print were lost, and only partial versions could be restored later with painstaking effort. Efforts by Altaf Mazid and other film archivists have helped salvage what remains, and the film is now preserved and studied as a crucial artifact in Indian cinematic history. Despite its partial loss, its legacy continues to resonate through its ideological depth, artistic brilliance, and cultural audacity.

In understanding Joymoti, one must also understand Jyotiprasad Agarwala not just as a filmmaker, but as a visionary cultural leader. He was a poet, playwright, freedom fighter, and above all, a renaissance figure who sought to awaken Assamese society through literature, art, and cinema. He un-

derstood the transformative potential of cinema not as mere entertainment but as a potent vehicle for social reform, cultural preservation, and political awakening. Through Joymoti, he laid the foundation of a regional cinema that was not merely regional in content but global in vision and universal in spirit. The courage it took to embark on such a project, at a time when the medium was nascent and the environment hostile, cannot be overstated.

Today, when Assamese cinema has evolved into a robust medium with diverse voices and narratives, the contribution of Joymoti stands as a towering beacon. It reminds us of the roots from which this cinematic journey began — roots nourished by ideals of courage, identity, resistance, and artistic excellence. As we celebrate the milestones of Indian cinema, it is imperative to remember that the genesis of Assamese cinema was not in glamour or commerce, but in conviction, rebellion, and cul-

Jyotiprasad's Joymoti was not just a film. It was an awakening. It was a cinematic revolution born out of love for one's land, language, and people. It was a protest etched on celluloid, a poem visualised in frames, and a legacy that continues to inspire. In honouring Joymoti, we honour not only the birth of Assamese cinema but also the soul of a people who dared to dream through the eyes of their beloved Rupkonwar. Banu Mushtaq's Heart Lamp Lights the world stage

anu Mushtaq has etched her name B in literary history by becoming the first author writing in Kannada to win the prestigious International Booker Prize. Her winning work, Heart Lamp, a deeply evocative short story anthology translated into English by Deepa Bhasthi, is also the first collection of short stories ever to win this global recognition. The book paints powerful portraits of the lived experiences of Muslim women in southern India—portraits that judges described as "astonishing" in their depiction of survival and resilience.

Born and raised in a modest Muslim neighbourhood in a small town in Karnataka, Mushtaq's early life was shaped by the traditional religious education common among girls in her community. She studied the Quran in Urdu, the liturgical language of her faith, but her father envisioned a broader horizon for her. Defying prevailing norms, he enrolled her in a convent school where Kannada, the official language of Karnataka, was the medium of instruction. This decision laid the foundation for Mushtaq's literary journey, one that would eventually revolutionize Kannada literature.

Mushtaq embraced Kannada as her literary language with determination and passion. She began writing while still in

school, at a time when many of her peers were being encouraged to marry early and retreat into domestic life. She chose a different path, continuing her education and pursuing college, determined to carve a space for herself beyond the conof social expectations. However, life was far from easy. Her first pub-

lished story came only after years of perseverance and during one of the most challenging periods of her personal life.

At 26, she married a man of her choosing, a decision that was followed by a phase of intense personal conflict. She has spoken candidly in multiple interviews about the emotional and mental toll of these years. Once an aspiring writer with a passionate heart, she found herself suddenly reduced to a life of domestic drudgery, expected to wear a burqa and stay within the bounds of her home. At 29, after the birth of her child, she was consumed by postpartum depression. In a moment of overwhelming despair, she attempted self-immolation—an act averted only at the last minute by her husband. That moment, as she recounts, became a turning point.

Her stories in Heart Lamp embody this very spirit of silent yet fierce resistance. They do not offer loud proclamations or dramatic revolts, but rather depict women negotiating their survival with grit and grace. These are stories of quiet rebellion, of everyday courage, and of dignity in the face of stifling circumstances. In a literary landscape where Muslim women are often reduced to symbolic figures or tragic tropes, Mushtaq restores their complexity, agency, and humanity. Her characters endure injustices, challenge them when possible, and navigate their world with resilience that may not make headlines but is deeply transformative for their lives.

Her work reflects not just personal trials but also a broader political and social commentary. After a stint in journalism, where she worked with a local tabloid and participated in the Bandaya movement—a progressive literary and social movement focused on fighting injustice—Mushtaq turned to law to support her family. Yet, throughout these shifts in her career, writing remained her steadfast companion. She published six short story collections, a novel, and an essay collection, becoming a towering figure in contemporary Kannada literature.

Her frankness and fearlessness have also made her a target of religious conservatives. In 2000, after she publicly supported women's right to pray in mosques, she received threats, and a fatwa was issued against her. One man even attempted to attack her with a knife but was stopped by her husband. Yet, none of these threats silenced her. Mushtaq has continued to write with fierce honesty, taking on themes that challenge patriarchal interpretations of religion and

Her success with Heart Lamp has been monumental not just for herself, but for Kannada literature and for South Asian languages as a whole. Her translator, Deepa Bhasthi, who shares the £50,000 prize, is the first Indian translator to win the International Booker. Bhasthi expressed hope that this recognition will lead to greater interest in translating

works from and into Kannada and other relanguages, gional which are often overlooked in the global literary scene. In her acceptance speech, Mushtaq eloquently captured the soul of her literary philosophy. She reminded the world that "no story is ever small," and that literature remains one

of the last sacred spaces where human beings can inhabit each other's minds, even if just for a few pages. Her words, like her stories, spoke to the quiet power of empathy and the transformative potential of storytelling.

The impact of her work had already begun to ripple through literary circles even before the Booker win. In 2024, Haseena and Other Stories, an English translation of five of her earlier short story collections, won the PEN Translation Prize. Critics and readers alike have lauded her work for its authenticity, psychological depth, and socio-political in-Her writing demands attention—not through grand gestures but through careful, compassionate exploration of the margins of society.

Banu Mushtaq's life and work offer a masterclass in perseverance, truthtelling, and literary integrity. She has challenged restrictive traditions, spoken out against gendered oppression, and given voice to women whose stories might otherwise have been lost in silence. Through Heart Lamp, she has held up a mirror to society and, in doing so, illuminated the lived realities of countless women like herself-strong, complex, and unyielding. With this historic International Booker win, she not only secures her place in world literature but also opens the door wider for the stories that wait to be told from every corner of India and beyond. At least 60 people killed in Israeli strikes in Gaza as ceasefire prospects inch closer

DEIR AL-BALAH, June 28: At least 60 people were killed across Gaza by Israeli strikes, health workers said Saturday, as Palestinians face a growing humanitarian crisis in Gaza and ceasefire prospects inch closer.

The strikes began late Friday and continued into Saturday morning, among others killing 12 people near the Palestine Stadium in Gaza City, which was sheltering displaced people, and eight more living in apartments, according to staff at Shifa Hospital, where the bodies were brought.

More than 20 bodies were taken to Nasser Hospital, according to health officials. A strike midday Saturday killed 11 people on a street in eastern Gaza City, and their bodies were taken to Al-Ahli Hospital.

The strikes come as US President Donald Trump says there could be a ceasefire agreement within the next week. Taking ques-

Netanyahu denounces report that Pakistan welcomes Court of Arbitration's ruling on J&K hydroelectric projects

ISLAMABAD, June 28: Pakistan on Saturday welcomed the ruling by the Permanent Court of Arbitration in The Hague over two hydroelectric projects in Jammu and Kashmir and indicated its readiness for talks with India on issues relating to Indus Waters

The "high priority", at this point, is that "India and Pakistan find a way back to a meaningful dialogue, including on the application of the Indus Waters Treaty (IWT)," Pakistan said in a statement released early on Saturday.

India on Friday strongly rejected the ruling saying it has never recognised the so-called framework for dispute resolution with Pakistan. India rejects this socalled "supplemental award", the Ministry of External Affairs (MEA) said, referring to the ruling in the case related to Pakistan's objections to Kishenganga and Ratle hydropower projects.

In its ruling, the Court of Arbitration said India's decision in April to keep the Indus Waters Treaty in abeyance "does not limit" its competence over the dispute and that its ruling is binding on the parties.

However, India has never recognised the proceedings at the Permanent Court of Arbitration after Pakistan raised objections to certain design elements of the two projects under the provisions of the Indus Waters Treaty.

On the other hand, Pakistan called the ruling a "major legal win" emphasising that it is a "clear message that India cannot unilaterally suspend or sideline the treaty.'

The MEA called out Pakistan by saying that "this latest charade at Pakistan's behest is yet another desperate attempt by it to escape accountability for its role as the global epicentre of terrorism.'

"Pakistan's resort to this fabricated arbitration mechanism is consistent with its decades-long pattern of deception and manipulation of international forums," it said in a statement.

The illegal Court of Arbitration, purportedly constituted under the Indus Waters Treaty 1960, albeit in brazen violation of it, has issued

mental award' on its competence concerning the Kishenganga and Ratle hydroelectric projects in the Indian Union Territory of Jammu and Kashmir," the MEA said.

"India has never recognised the existence in law of this so-called Court of Arbitration," it said.

The MEA said India's position has all along been that the constitution of this so-called arbitral body is in itself a serious breach of the Indus Waters Treaty and consequently any proceedings before this forum and any award or decision taken by it are also illegal for that reason. A day after the April 22 Pahalgam terror attack, India took a series of punitive measures against Pakistan that included putting the Indus Waters Treaty of 1960 in "abeyance"

"Following the Pahalgam terrorist attack, India has in exercise of its rights as a sovereign nation under international law, placed the Indus Waters Treaty in abeyance, until Pakistan credibly and irrevocably abjures its support for cross-bordowntown Tehran on Saturday for the funeral of the head of the Revolutionary Guard and other top commanders and nuclear scientists killed during a 12-day war with Israel. The caskets of Guard's chief Gen. Hossein Salami, the head of the Guard's ballistic missile program, Gen Amir Ali Hajizadeh and others were driven on trucks along the capital's Azadi Street as people in the crowds chanted: "Death to America" and "Death to Israel."

Over $1\bar{2}$ days before a ceasefire Salami and Hajizadeh were both killed on the first day of the war, June 13, as Israel launched a war it said meant to destroy Iran's nuclear program, specifically targetmilitary commanders, scientists and nuclear facilities. There was no immediate sign of

Iran's Supreme Leader, Ayatollah Ali Khamenei, in the state broadcast of the funeral. Khamenei, who has not made a public appearance since before the outbreak of the war, has in past funerals held prayers for fallen commanders over their caskets before the open ceremonies, later aired on state television. MOSCOW, June 28: President Vladimir Putin has accused the Western nations of encouraging separatism in Russia. Putin's criticisms of the West came amid Russia's ongoing tensions with the Western nations over the conflict in Ukraine.

"No one has wished to pay attention to the Islamic State, as long as it operates against Russia. Explosions in Moscow, and all that. This is still happening today," Putin told journalists at the Belarus capital Minsk on Friday. "No one wants to pay attention to this. Everything is fine, as long as it is against Russia," he said on the sidelines of the summit of the Eurasian Economic Union (EAEU).

"The same happened when the collective West encouraged separatism in our country, and such an instrument of the fight against Russia as terrorism," the Russian president said. Russia Today, the staterun television, quoted Putin as saying that Moscow will no longer play "one-sided" games with the West."Western nations have repeatedly betrayed Russia by not fulfilling their promises related to NATO expansion and resolving the Ukraine con-

flict," he said. (PTI) Driven to starvation, Sudanese people eat weeds and plants to survive as war rages

CAIRO, June 28: With Sudan in the grips of war and millions struggling to find enough to eat, many are turning to weeds and wild plants to quiet their pangs of hunger. They boil the plants in water with salt because, simply, there is nothing else. Grateful for the lifeline it offered, a 60-year-old retired school teacher penned a love poem about a plant called Khadija Koro. It was "a balm for us that spread through the spaces of fear," he wrote, and kept him and many others from starving. A.H. who spoke on the condi-

tion his full name not be used, because he feared retribution from the warring parties for speaking to the press, is one of 24.6 million people in Sudan facing acute food insecurity —nearly half the population, according to the Integrated Food Security Phase Classification. Aid workers say the war spiked market prices, limited aid delivery, and shrunk agricultural lands in a country that was once a breadbasket of the world.

Sudan plunged into war in April 2023 when simmering tensions between the Sudanese army and its rival paramilitary the Rapid Support Forces escalated to fighting in the capital Khartoum and spread across the country, killing over 20,000 people, displacing nearly 13 million people, and pushing many to the brink of famine in what aid workers deemed the

world's largest hunger crisis. Food insecurity is especially bad in areas in the Kordofan region, the Nuba Mountains, and Darfur, where El Fasher and Zamzam camp are inaccessible to the Norwegian Refugee Council, said Mathilde Vu, an aid worker with the group based in Port Sudan. Some people survive on just one meal a day, which is mainly millet porridge. In North Darfur, some people even sucked on coal to ease their hunger. On Friday, UN Secretary-General Antonio Guterres called the Sudanese military leader Gen Abdel-Fattah Burhan and asked him for a week-long ceasefire in El Fasher to allow aid delivery. Burhan agreed to that request, according to an army statement, but it's unknown whether the RSF would agree to that truce.

A.H. said aid distribution often provided slight relief. His wife in children live in Obeid and also struggle to secure enough food due to high prices in the market. His poem continued: "You were

a world that sends love into the barren time. You were a woman woven from threads of the sun. You were the sandalwood and the jasmine and a revelation of green, glowing and longing.

worsening food insecurity Sudanese agricultural minister Abu Bakr al-Bashari told Al-Hadath news channel in April that there

conflicts: one between the Rapid Support Forces and the army, and another with the People's Liberation Movement-North, who are fighting against the army and have ties with the RSF, making it nearly impossible to access food, clean water, or medicine. He can't travel to Obeid in North Kordofan to be with his family, as the Rapid Support Forces blocked roads. Violence and looting have made travel unsafe, forcing residents to stay in their neighbourhoods, limiting their access to food, aid workers said. A.H. is supposed to get a retirement pension from the government, but the process is slow, so he doesn't have a steady income. He can only transfer around USD 35 weekly to his family out of temporary training jobs, which he says is not enough. Hassan, another South Kordofan resident in Kadugli said that the state has turned into a "large prison for innocent citizens" due to the lack of food, water, shelter, income, and primary health services caused by the RSF siege.

International and grassroots organisations in the area where he lives were banned by the local government, according to Hassan,

who asked to be identified only by his first name in fear of retribution for speaking publicly while being based in an area often engulfed with fighting. So residents ate the plants out of desperation. "You would groan to give life an antidote when darkness appeared to us through the window of fear.," A.H. wrote in his poem. "You were the light, and when our tears filled up our in the eyes, you were the nectar. Food affordability

Vu warned that food affordability is another ongoing challenge as prices rise in the markets. A physical cash shortage prompted the Norwegian Refugee Council to replace cash assistance with vouchers. Meanwhile, authorities monopolize some markets and essential foods such as corn, wheat flour, sugar and salt are only sold through security approvals, according to Hassan.

Meanwhile, in southwest Sudan, residents of Nyala, the capital of South Darfur, rely on growing crops, but agricultural lands are shrinking due to fighting and lack of farming resources. Hawaa Hussein, a woman who

has been displaced in El Serif camp since 2004, told the AP that they benefit from the rainy season but they're lacking essential farming resources such as seeds and tractors to grow beans, peanuts, sesame, wheat, and weika — dried powdered okra. Hussein, a grand-

mother living with eight family members, said her family receives a food parcel every two months, containing lentils, salt, oil, and biscuits. Sometimes she buys items from the market with the help of community leaders.

"There are many families in the

camp, mine alone has five chil-

dren, and so aid is not enough for everyone ... you also can't eat while your neighbour is hungry and in need," she said. El Serif camp is sheltering nearly 49,000 displaced people, the camp's civic leader Abdalrahman Idris told the AP. Since the war began in 2023, the camp has taken in over 5,000 new arrivals, with a recent surge coming from the greater Khartoum region, which is the Sudanese military said it took full control of in May.

"The food that reaches the camp makes up only 5 per cent of the total need. Some people need jobs and income. People now only eat two meals, and some people can't feed their children," he said. In North Darfur, south of El Fasher, lies Zamzam camp, one of the worst areas struck by famine and recent escalating violence. An aid worker with the Emergency Response Rooms previously based in the camp who asked not to be identified in fear of retribution for speaking with the press, told the AP that the recent wave of violence killed some and left others homeless. (AP)



Recognition brings long-overdue honour to Nocte leaders who led 19th-century resistance against British rule

Tirap recognises Nocte Chiefs as freedom fighters

HT Correspondent ITANAGAR, June 28: In a significant move to honour the indigenous resistance against British colonial rule, the office of the Deputy Commissioner, Tirap district, has formally recognised the contributions of two revered Nocte leaders—Wangto Lowang, the then Chief of Kheti village, and Wangmaan Lowangdong, the then Chief of Borduria village. According to an official state-

ment, both leaders played decisive roles in two separate uprisings during the 19th century that resisted British expansion into their territories, now part of modernday Arunachal Pradesh.

The statement documents the events of the Anglo-Nocte War of 1842, which was spearheaded by Wangto Lowang.

This armed resistance began on November 25, 1842, when Captain J Brodie, Sub-Assistant of Sibsagar, Assam, led a contingent of British forces toward Kheti in an attempt to assert colonial authority over Wangto's autonomous domain.

of detachments from the Assam Light Infantry Battalion, the 2nd Sebundies, and the Local Artillery Company, launched an attack on Kheti on December 23, 1842. Despite a fierce and courageous

British force eventually overpowered them. The villagers were forced to abandon Kheti, which was subse-

quently burned down. To reinforce British control and suppress further resistance, an

army outpost was established at the neighbouring village of Khela. The first Anglo-Nocte War thus concluded on December 29, 1842,

leaving behind a legacy of unyielding indigenous defiance. Equally significant was the Nocte resistance led by Wangmaan Lowangdong in 1875.

The conflict had its roots in August 1874, when Colonel R.H. Keatinge, the first Chief Commissioner of British Assam, issued a notice announcing the British intent to annex the tea gardens of Namsang and Hukanjuri, along with the land between them.

Lieutenant Holcombe, Assistant Commissioner of Jeypore, Assam, conveyed the notice to Wangmaan, warning him against retaliation and pointing out the vulnerability of Borduria village



Faced with the threat of British aggression but unwilling to expose his people to direct conflict, Wangmaan orchestrated a covert form of resistance.

All government departments and educational institutions in the district have been advised to actively participate in preserving and promoting this important chapter

of regional history. The acknowledgment stands as a tribute to indigenous valor and a step toward correcting historical omissions in the narrative of India's freedom struggle.

of India B R Gavai on Saturday said Dr B R Ambedkar envisioned one Constitution for the country to keep it united and never favoured the idea of a separate constitution for a state.

Speaking at the inauguration of the Constitution Preamble Park here, the CJI said the Supreme Court drew inspiration from Dr Ambedkar's vision of a united India under a single constitution while upholding the Centre's decision to abrogate Article 370 that granted special status to Jammu and Kashmir.

Gavai was part of a five-judge Constitution bench, headed by then Chief Justice DY Chandrachud, that unanimously upheld the Centre's decision to abrogate Article 370, which bestowed special status to the erstwhile state of Jammu and Kashmir.

"When Article 370 was challenged, it came before us, and when the hearing was underway, I recalled Dr Babasaheb's words that one Constitution is suited for a country... If we want to keep the



Constitution," he said, while addressing the gathering in Marathi.

On August 5, 2019, the Centre decided to strip Jammu and Kashmir of special status and divide it into two Union Territories.

Gavai said Dr Ambedkar had been criticised, saying the Constitution provides for too much fedcountry may not remain united.

Move to bring NRC through backdoor: TMC on EC's special intensive revision of electoral roll

NEW DELHI, June 28: The Election Commission's special intensive revision of the electoral roll is a "sinister move" to bring the National Register of Citizens (NRC) through the backdoor, Trinamool Congress leader Derek O'Brien claimed on Saturday and compared it to 'ancestor passes' in Nazi Germany

At a press conference here, he said the INDIA bloc parties were united on the issue and would take action soon. O'Brien also questioned the timing of the move, announced months ahead of Assembly elections in Bihar and set to be carried out in West Bengal before next year's polls. It is the BJP's "desperate attempt" to win in West Bengal, he claimed.

The Trinamool Congress' Rajya Sabha floor leader said, "It is a sinister move to bring NRC through the backdoor.

"In 1935, under the Nazis (in Germany), you were supposed to be given an ancestor pass... Is this the new version of that Nazi ancestor pass?" he posed.

"Why is this exercise being suddenly done right now? We have evidence as to why it is being done now. It is because the latest internal survey of the BJP for Bengal shows 46-49 seats for the party in the state's assembly polls (early next year). In their desperation to attempt to change things you do such

The Election Commission last Monday issued instructions to carry out a Special Intensive Revision in Bihar to weed out ineligible names and ensure all el-

igible citizens are included in the electoral roll, allowing them to exercise their franchise in the polls slated later this year.

A similar review of electoral rolls will be done by the end of this year in five states that are going to polls in 2026, which includes West Bengal

Trinamool's Rajya Sabha MP Sagarika Ghose claimed West Bengal was the "real target" of the exercise. "On June 26, the ECI announced that Special Intensive Revision will be conducted for Bihar Assembly polls, but the real target is Bengal.'

Her party colleague and another MP in the Upper House of Parliament, Saket Gokhale, expressed similar views. "The Modi government is taking away your right to vote and bringing in the NRC using the Election Commission. The purpose of this new exercise is to manipulate Bengal elections for the BJP and then replicate this model all over India," he alleged.

'The ECI must be forced to roll back and scrap this dangerous and sinister programme which will be used for deleting voters and even snatching their citizenship," Gokhale said.

O'Brien asserted the INDIA bloc parties will take up the issue both inside and outside Parliament. "We are all on the same page on this. We will not wait for Parliament to start. This cannot wait," he said.

EC begins intensive revision of Bihar voters list, says only Indian citizens can vote

NEW DELHI, June 28: The Election Commission on Saturday said the special intensive revision of electoral rolls in Bihar has begun and reminded of a constitutional provision that says only Indian citizens can vote. In a statement, the EC said, "The Constitution of India is supreme. All citizens, political parties and the Election Commission of India follow the Constitution." The statement comes as opposition parties questioned the intent behind the in

tensive revision. The poll authority reminded that Article 326 specifies eligibility to become an elector -- only Indian citizens, above 18 years and ordinary resident in that constituency are eligible to be on voters list.

Several opposition parties have said that the exercise carries the risk of willful exclusion of voters using the state machinery.

The poll authority is carrying out an intensive review of electoral rolls this year in six states beginning with Bihar to weed out foreign illegal migrants by checking their place of birth.

Bihar is going to polls this year while assembly polls in these five other states -- Assam, Kerala, Puducherry, Tamil Nadu and West Bengal -- are scheduled in 2026.

The move, which would be later expanded to other states, assumes significance in the wake of a crackdown in various states on illegal foreign migrants, including from Bangladesh and Myanmar. The EC said the special revision has already started successfully in Bihar for verifying the eligibility of each elector with "full participation" of all political parties.

The poll panel already has nearly 78,000 booth level officers (BLOs) and is appointing over 20,000 more for new polling stations, it said.

More than one lakh volunteers will be assisting genuine electors, particularly the old, sick, persons with disabilities, poor and other vulnerable groups during the special intensive revision. All recognised national and state political parties have already appointed 1,54,977 booth level agents (BLAs). They can still appoint more, it pointed out.

Resolve to make India a world leader in every sphere by 2047: Shah

GODHRA. June 28: Union Home Minister Amit Shah on Saturday called for the youth to resolve towards making India a world leader in every sphere by 2047, when it celebrates the centenary of its independence.

He also recalled the contributions of tribal leader Govind Guru in India's freedom struggle, saying he awakened the conscience of the people from the region during the British rule. Shah was addressing via video link a programme where development works worth Rs 125 crore for Shri Govind Guru University at Vinzol near Godhra in Gujarat's Panchmahal district were launched.

Describing Govind Guru a hero of India's freedom movement who fought against the British rulers, Shah said, "Around 1,512 tribal brothers and sisters were martyred in that struggle against the British, and Mangadh (in Gujarat) became an important place in the history of India's fight for independence.

Prime Minister Narendra Modi has taken forward the heroism of Govind Guru, and is determined to make India a great nation by 2047, he said. "It is a matter of importance for all of us. Our youth and children should make a resolution of creating an India where it attains the first position in every field in the world when the country celebrates the centenary of its independence," Shah added. The Union minister said the idea of setting up the Govind Guru University was conceived by Prime Minister Narendra Modi during his tenure as Gu-

Uneconomical, impractical: Experts on Railway decision to cap passenger waiting list at 25 pc

NEW DELHI, June 28: The Railway's decision to limit the passenger waiting list to 25 per cent of the capacity of each class has been flagged by reservation supervisors, ticket booking clerks and some senior commercial officers as uneconomical for the railways and inconvenient for travellers.

The ministry, however, has justified the decision, saying less than one-fourth of the total number of waiting passengers get confirmed berths on an average and the 25 per cent cap has been placed in view of

"The decision was made after meticulously studying the waiting list confirmation pattern," said Dilip Kumar the Executive Director of Information and Publicity, Railway Board.

He highlighted that earlier, there was an allegation that the Railways allowed a lot of passengers to book berths in the waiting category which led to crowding in trains. "It was also alleged that the Railways earned money on ticket cancellation.

Refuting the charge, Kumar stressed the Railways was more concerned about passenger comfort than monetary benefits.

The Centre for Railway Information Systems (CRIS) implemented the 25 per cent cap decision on June 16 for trains with reservation facilities. This come around two months after the ministry, through a circular, conveyed its decision on the matter to all principal chief commercial managers and the CRIS managing di-

The April 17 circular stated, "The matter has been reviewed and it has been decided that the maximum current waiting list limit will be revised to 25 per cent of the redefined capacity of each class available at originating as well as

roadside stations.' It added, "This logic will also be applicable for issuing of waitlisted tickets from remote locations as well as tickets booked under Tatkal scheme. This waiting list limit shall, however, not be applicable to the tickets issued on concessional fares, warrants etc.

The circular directed CRIS to "make necessary modifications in the software and inform the date of effect to all zonal Railways". Railway officials said such a cap

was in place earlier as well but more and more people were allowed to reserve seats/berths in the waiting category.

According to a 2013 circular, the waiting list cap on AC/EC and 2 AC classes was 30 and 100 respectively. Similarly, the first class, 3AC/Chair Car and sleeper class had 30, 300 and 400 waiting limits, respectively.

Over a week after the implementation of new waiting norms, a section of experts as well as reservation officials termed the decision "impractical".

"Waiting lists give a demand trend based on which we make decisions to run special trains. How will we do it now when the waiting lists of all trains will be capped at 25 per cent?" said a retired senior railway commercial officer who termed waiting lists valuable data to make future decisions.

Reservation supervisors said there have been cases in which due to bulk cancellations, trains departed with some available seats and despite giving confirmed berths to all waiting list passengers, some remained vacant causing a loss to the Railways.

"On one hand seats/berths remain vacant and on the other needy people are unable to travel," a supervisor said.

"Agents often do bulk booking on routes high on demand. They go for cancellations before 48 hours of a train's departure so that they have to pay just the nominal cancellation charges. In such cases, there is a high possibility that availability of seats/berths will be created before the train's departure," another reservation supervi-

He added, "This will create opportunities for brokers and touts operating at the current booking window at stations to mint money for passengers as they have prior information of berth positions due to their nexus with lower-level ticket booking staff." (PTI)

Decline in percentage of zero-dose children due to govt's proactive, inclusive approach: Health Ministry

NEW DELHI. June 28: India's percentage of zero-dose children to the total population has declined from 0.11 per cent in 2023 to 0.06 per cent in 2024, positioning it as a global exemplar in child health, as acknowledged by the UN Interagency Group for Child Mortality Estimation in its 2024 report, the Union Health Ministry said here.

According to WHO, zero-dose children are defined as those who lack access to or are never reached by routine immunisation services. They are operationally measured as those who did not receive their first dose of DTP (diphtheriatetanus-pertussis).

The ministry credited the decline in such children to its unwacommitment immunisation evident through its Universal Immunization Programme (UIP), which provides free vaccination services annually to 2.9 crore pregnant women and 2.6 crore infants (0'-1 year).

At the same time, it asserted that any comparison of India with any other countries with high burden zero dose children needs to take into consideration India's large population size and high vaccination coverage rate. Vaccination remains one of the

public health interventions, the ministry said in a statement, noting that the government has taken a proactive and inclusive approach to reach underserved populations. "Our healthcare workers ASHAs and ANMs conduct over 1.3 crore immunisation sessions

across the country," the statement

said. "As a result of the continued,

sustained efforts and intensified

most powerful and cost-effective

implementation of vaccination drives and campaign across the country, the percentage of zerodose children to the total population has declined from 0.11 per cent in 2023 to 0.06 per cent in 2024," it said

The approach remains progressive, and continuous efforts are being made in the current year to further reduce the burden of zerodose children in the country, it

These achievements have positioned India as a global exemplar in child health, as acknowledged by the UN Inter-agency Group for Child Mortality Estimation (UN IGME) in its 2024 report, it said.

The effect of the increased number of lifesaving vaccines in reducing mortality and morbidity in children due to diarrhoea, pneumonia, meningitis and encephalitis is also clearly observable, the statement said

According to the latest SRS (2020-22), the Maternal Mortality Ratio (MMR) in India has declined from 130/lakh live births in 2014-16 to 88/lakh live births in 2020-22. The United Nations Maternal Mortality Estimation Inter-Agency Group (UN-MMEIG 2000-2023) report says that the MMR in India stands at 80 per lakh live births, reflecting an 86 per cent decline relative to the global reduction of 48 per cent since 1990, it stated.

According to the United Nations Inter-Agency Group for Child Mortality Estimation (UNIGME 2024 Report), India achieved a 78 per cent decline in the Under-Five Mortality Rate (U5MR) surpassing the global reduction of 61 per cent and 70 per cent decline in the



Neonatal Mortality Rate (NMR) compared to 54 per cent globally during 1990 - 2023.

In addition to focused attention on increasing vaccination coverage, India's UIP embodies a comprehensive range of vaccines recommended by the World Health Organization (WHO). Till 2013, there were only six available vaccines in the programme.

Currently, India's UIP covers 12 vaccine-preventable diseases and has seen significant expansion, the statement said. With continued focus on improving vaccine coverage, India has taken a proactive and inclusive approach to reach underserved populations.

The Government of India in consultation with all states and UTs, has launched targeted campaigns to address challenges among zero-dose children, particularly in urban slums, peri-urban areas, migratory populations, hardto-reach regions, and communities affected by vaccine hesitancy.

"To amplify our reach, we are

leveraging technology and community engagement. The U-WIN platform tracks immunisation sta-

The comparative results of countries on zero dose children as a percentage of the total population shows that Yemen (1.68%), Sudan (1.45%), Angola Afghanistan (1.1%), Nigeria (0.98%), DR Congo (0.82%), Ethiopia (0.72%), Indonesia (0.23%), Pakistan (0.16%) have far more zero dose children as a percentage of their population compared to India's (0.11% during 2023 as per the last Wuneic report released.

Any comparison of India with any other countries with high burden zero dose children needs to take into consideration India's large population size and high vaccination coverage rate, the statement said. Therefore, any interpretation or analysis based on isolated factors does not lend credence to the country's progress on its immunization program, it emphasised. (PTI)


Efforts underway to form a popular government in Manipur: N Biren Singh

NEW DELHI. June 28: The completion of the 51.38-km Bairabi-Sairang rail line, which is set to connect Mizoram's capital Aizawl to the country's rail network, involved overcoming immense geographical and logistical challenges.

"The line is ready with the approval from the Commissioner of Railway Safety (CSR) and very soon, it will be inaugurated by Prime Minister Narendra Modi," a Northeast Frontier Railway (NFR) official said. Once operational, people can travel to

He added that the complete rail line was commissioned in four phases --Bairabi-Hortoki (16.72 km) commissioned in July 2024, Hortoki-Kawnpui (9.71 km) in June 2025, Kawnpui-Mualkhang (12.11 km) in June 2025 and Mualkhang-Sairang (12.84 km) in June 2025.

"The final stretch of the Bairabi-Sairang new line railway project, from Hortoki to Sairang, was thoroughly inspected by the CRS, Northeast Frontier Circle, between June 6 and June 10. This marks a significant milestone as it completes the entire 57.38-km rail line, paving the way for direct rail connectivity to Aizawl for the very first time," another official said.

The CRS authorised the operation of freight and passenger trains on the newlylaid broad gauge line between Bairabi and Hortoki on August 22, 2024.

"The revised sanctioned cost of the project is approximately ₹ 5,021.45 crore," the official said. (PTI)

TV ACTOR SHEFALI JARIWALA OF 'KAANTA LAGA' FAME DIES AT 42

MUMBAI, June 28: Popular TV actor Shefali Jariwala, who shot to fame with her breakout appearance in the remix track "Kaanta Laga" and also appeared on several reality shows, has died at the age of 42. Jariwala was rushed to Bellevue Multispeciality Hospital in suburban Mumbai by her husband, actor Parag Tyagi on Friday night. Her body later was taken to the Cooper hospital for postmortem.

"She was brought to the hospital around 11:15 pm. The on-duty doctor declared her dead on arrival," a hospital source said. Many media reports claim that she died due to a cardiac arrest, though the official cause of her death is yet to be ascertained. A host of celebrities, including playback singer Sunidhi Chauhan, Aarti Singh, Mahira Khan, Rashmi Desai and Vikas Gupta, arrived at her residence in suburban Andheri to offer their condolences to the family.

Her funeral was held at Oshiwara Hindu crematorium on Saturday evening. The last rites were performed by Jariwala's husband, father Satish Jariwala, and younger sister Shivani Jariwala.

Several friends from the industry, including Mika Singh, Vikas Gupta, Shehnaz Gill, Bhaktiyaar Irani, Aishwarya Sakhuja and Ashok Pandit, were present at the crema-

torium.

In the music video, directed by filmmaker duo Vijay Sapru and Radhika Rao, Zariwala showcased bold dance moves that became the defining visual of the remix era.

In a 2020 interview with The Times of India, Jariwala recalled that she was studying engineering at Sardar Patel Engineering College in Gujarat when filmmakers Radhika Rao and Vinay Sapru spotted her outside the campus and offered her the music video.

"I was in college then and I come from a family of academicians, so my parents told me to focus on my studies. But I wanted to do it because I was getting paid for it. I earned ₹ 7,000 from that song, and I wanted to see myself on TV," she said. She also revealed that her father was against the idea of her featuring in the music video.

"My father was completely against it. So first, I took my mom into confidence and then, we both convinced my father. And that song turned out to be such a hit that it was like a fairytale for me. It changed my life completely," she said.

After the success of the track, which also earned her the title of "Kaanta Laga girl", Jariwala had a cameo appearance in the 2004 hit romantic comedy "Mu-

In 2004, Jariwala married Harmeet Singh, one half of the musical duo Meet Brothers. Their marriage ended in 2009 after she allegedly accused him of domestic abuse. Jariwala and Tyagi, known for appearing in daily soaps like "Pavitra Rishta" and "Jodha Akbar", met in 2010 and dated for four years, before tying the knot in 2014. A week before her death, actor Jariwala shared a video of herself getting ready for a shoot, with the caption that read, "It's time for us to start living life. Like everything is working out in our favour."

The sudden demise of Jariwala has shocked many industry friends and colleagues, who expressed grief.

Singer Mika Singh said he is unable to fathom the news about the death of his dearest friend, Jariwala.

"I'm deeply shocked, saddened, and feeling a heavy heart... Our beloved star and my dearest friend @shefalijariwala has left us. Still can't believe it. You will always be remembered for your grace, smile, and spirit. Om Shanti," Singh wrote. "I can't get over this news...my heart is sinking. Shefali," actor Kamya Punjabi wrote.

Actor Divyanka Tripathi was shocked to learn about Shefali's demise.

"Still can't process the news about Shefali. Gone too soon. Deeply sad for her husband and the family," Tripathi said on X. Actor-comedian Kiku Sharda fondly recalled his experience of working with Jariwali, who he said was "full of life". "This is shocking!!!!!! worked with her on a couple of web shows, she was full of energy, full of life, always greeted all with a big, bright smile. Will miss you, Shefali, you were a beautiful soul. Rest in Peace. Om Shanti," Sharda said.

Actor Himanshi Khurana posted a photo with Jariwala and wrote, "Bigg Boss that place is cursed I think."

Actor Aly Goni wrote, "RIP Shefali." Actor Karanvir Bohra said, "Just heard the terrible news of #ShefaliJariwala passing away. My condolences to the family. #OmShanti."

ANNA WINTOUR IS SEEKING A NEW VOGUE EDITOR-IN-CHIEF BUT WILL MAINTAIN EDITORIAL CONTROL



NEW YORK, June 28: Anna Wintour is stepping down as Vogue editor-in-chief but will retain editorial control over the storied magazine.

The longtime Vogue powerhouse told staff Thursday she's seeking a head of editorial content to handle more of the day-to-day operations. But she's holding on to plenty of power to keep her a force at the magazine that built her reputation in fashion.

"And it goes without saying," she joked, "that I plan to remain Vogue's tennis and theater editor in perpetuity."

Wintour will remain chief content officer for Conde Nast and global editorial director of Vogue. The news shook the fashion world and Wintour-watchers on social media amid breathless headlines that she was "stepping down" from the magazine. The new lead will report directly to Wintour in her capacity as global editorial director, Vogue said in a statement posted to its website later Thursday.

"Anybody in a creative field knows how essential it is never to stop growing in one's work. When I became the editor of Vogue, I was eager to prove to all who might listen that there was a new, exciting way to imagine an American fashion magazine," Wintour told staff.

"Now, I find that my greatest pleasure is helping the next generation of impassioned editors storm the field with their own ideas, supported by a new, exciting view of what a major media company can be," she added.

As chief content officer, Wintour will continue to oversee every Conde Nast brand globally, including Vogue, Wired, Vanity Fair, GQ, AD, Conde Nast Traveler, Glamour, Bon Appetit, Tatler, World of In-

teriors, Allure and more, with the exception of The New Yorker.

"In effect, the addition of a new editorial lead for Vogue US will allow Wintour greater time and flexibility to support the other global markets that Conde Nast serves," the Vogue statement said.

Wintour also oversees the annual Met Gala, fashion's biggest night and a major fundraiser for the fashion wing of the Metropolitan Museum of Art. And she'll remain involved in Vogue World, a traveling fashion and cultural event the magazine began in 2022.

Four years ago, Conde Nast changed its editorial structure, bringing together editorial teams around the world for the first time. Every market where Conde Nast operates has a head of editorial content led by a global editorial director. The new role at American Vogue is part of that reorganization. The new structure has already been rolled out at other Vogue titles around the world.

The company will not seek an editor-inchief to replace Wintour at American Vogue, replacing that title with the new head of editorial content.

Wintour transformed Vogue during her decades at the magazine. She was named creative director in 1983, served as editorin-chief of British Vogue from 1985 to 1987 then rejoined the American title as editor-in-chief.

She modernized the magazine by featuring celebrities on its covers and mixing high fashion with more affordable street style. She championed emerging designers, including Marc Jacobs, Alexander McQueen and John Galliano, and broadened the brand's reach by adding new titles around the world. (AP)

Renuka Shahane on animated film 'Loop Line': Wanted to write about women who can't change their lives

NEW DELHI, 28: Most stories about women end with them taking a big or small step towards a solution but what about those who don't have the means to change their circumstances? This question inspired Renuka Shahane to explore one such life in her animated film "Loop Line".

Shahane, a known name in cinema and TV right from the Doordarshan days, said she kept thinking about many housewives stuck in an endless loop of emotional and verbal abuse.

"I had this idea in my mind that when we read women's stories, in the end, they take a big or small revolutionary step to solve their problems. But what about those who never take that step or have no way out? They are stuck in a loveless marriage where they don't get any respect for their work and the mental abuse is

normalised," the actorfilmmaker told PTI in an interview.

"Loop Line", an over eight-minute short, is about a middle-aged Mumbai housewife, who cooks, cleans and has no life outside the small flat that she shares with her emotionally abusive husband.

But her inner life is full of imagination that takes her places: be it romancing the screen hero that she is watching on TV or freely floating in a pond full of water lilies, a scene that instantly evokes the image of Claude Monet's famous painting.

There are moments of angst that also find a voice in her fantasies.

Shahane, who made her directorial debut with "Tribhanga" in 2021, said she initially wrote the story for the live-action format but she kept seeing the inner life of the character in animation.

"When I was writing this, I realised that the fantasies of the woman in this particular film, I could see only in animation. And then I realised that the combination of animation and live action doesn't seem right. So I decided to make a full animation

"I love animation. It is such a deep art form. And I have been fascinated with it since childhood. But I don't have any background in visual arts. So this was a big step for me," she said.

It was, in fact, a giant leap for Shahane as she made a mature story in animation, a format that is mostly associated with children's stories in India.

"There is no place or institution where we are showing mature-level animation films in India. So I knew this will be my passion project where I will invest money and I won't expect it to come back. I

was adamant that I want to do this content only in animation. My animators at Paperboard Design Studio were surprised when I approached them."

Shahane is happy that artists in India are waking up to the possibilities of the animation format beyond children's stories.

"It has not yet picked up in our country like it has in Japan or other countries... Even Disney films, though they are children's stories, are aimed at the adult audience as well. Any art form is dependent on money.'

"If it's not viable it's very difficult to make anything. Animation is a labour-intensive process. It takes a lot of time. So you need economically viable animation," she

said.
The film is titled "Loop Line" because Shahane could see the parallel between her character and Mumbai's local trains.

Both keep working without receiving any gratitude and are like lifelines to their family and the city.

Shahane said she wants to keep exploring stories where she has complete creative control like she had in "Loop Line".

"As an artist Lam

"As an artist, I am backing myself... Every artist should take that leap of faith. I am 58 years old and I have done a lot of work. During your struggle, you made compromises, but when you are comfortable, you should be committed to your art."

"Loop Line" features voices of actors Mitalee Jagtap and Anand Alkunte. The movie has been screened at film galas like 19th Tasveer South Asian Film Festival, Mumbai Short and Documentary Film Festival and New York Indian Film Festival.

It is produced by Shahane's Padachinha Production. (PTI)

India overcome Malaysia to regain team gold in Asian Snooker



COLOMBO, June 28: Multiple-time world champion Pankaj Advani and Brijesh Damani dug deep as India scored a fine 3-1 win over formidable Malaysia to regain the team gold in the ACBS Asian Snooker Championship here Saturday.

For India, who last won the gold two years ago in Iran, this was their fifth gold.

In the doubles, after letting Malaysia take an early 33-1 lead, Damani punished Thor Chuan's error with a brilliant frameclinching break of 60 to put India just a win away from the title.

Advani then kept the dangerous Thor Chuan on a tight leash with his stunning safety play en route to a decisive victory.

England's Lionesses face new challenges and 'noise' in Euro 2025 title defense

LONDON, June 28: England will look to eliminate the "noise" when it kicks off its campaign to retain the Women's European Championship crown.

The defending champions travel to Switzerland as one of the favorites at the 16-team tournament, despite recent upheaval in the squad, after winning last time and finishing runner-up to Spain in the 2023 World Cup.

Euro 2022 saw England triumph on home soil and secure the country's first senior title since the men's team won the World Cup in 1966. And, in a soccer-mad country, that success has ratcheted up

major tournament there's always noise," England coach Sarina Wiegman said. "So we expect noise until we go into the tournament, and it probably stays.

"The difference is that ... now, just the attention and the visibility

of the women's game has increased so much. So it sounds like that's more noise, but there's just more talk, more journalists here ... we just have to deal with it and move on and focus on football."

The 55-year-old Wiegman, who took charge of the Lionesses in September 2021, is bidding to make it a hat trick of European Championship titles, as she steered the Netherlands to the trophy in

Lower-order batters are putting in the work at nets: Prasidh Krishna

BIRMINGHAM, June 28: India's lower-order batters have left a lot to be desired with their failures in the first Test against England and seamer Prasidh Krishna says they are "putting in the work" at nets to come out better prepared for the second game here. India's lower order caved in without a fight in both innings which proved decisive in the final outcome.

The visitors lost their last seven wickets for 41 runs in the first innings to be bowled out for 471, and in the second essay, Mohammed Sirai, Jasprit Bumrah and Prasidh -- all fell for ducks -- as India lost their last six wickets for 32 runs.

"As the lower-order batsmen, we definitely are working on... If you look at our net sessions, we are putting in the work. "I think it is about putting your mind in there as well, making sure you trust yourself, trust the skill that you have and be there at the crease for a little longer. And then the numbers and the runs are going to show, and we are working towards it," Prasidh said during a press conference. (PTI)

I take complete responsibility, says Prasidh after leaking over 200 runs at Leeds

BIRMINGHAM, June 28: Beleaguered India seamer Prasidh Krishna has taken "complete responsibility" for his failure to hit the right lengths during a forgettable outing in the first Test against England, but said he was at all times trying to be parsimonious with his bowling.

Prasidh has been slammed by few former players after he leaked more than 200 runs in the series-opener at Leeds, which India lost by five wickets.

"If I look at the first innings, I was a little too short than where I wanted to be, 6-8 is ideal. Second innings it got slightly better, because again, the wicket was slightly slower. I had to pitch a few slightly behind 8, and go slightly fuller, when I am trying to get a wicket.

"I definitely did not bowl the lengths that I wanted to. It took me some time to get used to the slope on that side. No reasons, but I should be able to do it as a professional. I take complete responsibility about it, and maybe, do it better next time," Prasidh said at a press conference.

In the first innings, Prasidh gave away 128 runs in 20 overs at an economy of 6.40, one of the worst figures by an Indian bowler bowling a minimum of 20 overs in an innings. However, he got the wickets of Ollie Pope, Harry Brook, and Jamie Smith. In the second innings, Prasidh gave

India hope with the wickets of Zak Craw-

ley and Pope in quick succession but his

economy rate was again above six (6.10), conceding 92 runs in 15 overs. "Every time I come out to bowl, I was

definitely looking to bowl a maiden. I am not really trying to give away boundaries or anything. The outfield was fast. The lengths, lines that I bowled was not perfect, to be honest, at most times. And they took me on. Some of them were edges.

"Some of them, I tried bowling bouncers. But I ended up giving runs. But definitely, every time I come out to bowl, I was looking to keep the economy rate down and build the pressure up," Prasidh Wind was another big factor at Headin-

gley, and it was often extremely blustery and cold, making life difficult for the players in the middle. "You are trying to run in hard. The wind

sometimes is on and off. So, it is very im-

portant to understand what the pace of the run-up is "And I did have a chat with a couple of other guys as well, asking them what they did to be at the right pace, when they are

running in to bowl. So, that is about it."

The occasional rain and the drizzle also didn't help. "Every time the ball goes on the ground, it became wet. And when the ball becomes wet, it is going to get softer. The shine is not going to be around. So, I think that did



"If there are clouds, there is going to be swing. If there is sun, there is not going to be swing. So, that is what we are looking to do. make sure we bowl the right areas. The gripping, I wouldn't say it was a prob-

"It just got softer. And the moment it got softer, the seam got softer, the amount of purchase you get from the pitch differs."

The 29-year-old seamer said the Indian dressing room remains very positive despite losing a match they could have won.

"Yeah, the dressing room is still nice and happy and very, very motivated. Like I said, we came here knowing what this opportunity meant for all of us.

"And even in the game today, we might have looked quiet at some stages. But I think we still had a plan. We wanted to do something and we went about doing it. We got two wickets in a cluster twice, and that still kept the motivation.

He said India did not give up till the

"You know, as a bowling unit, we still ended up taking the new ball when they needed about 20 runs, with the same hope that something's going to happen.

"So, we were still there believing. We made sure till the last run is scored, we will be out there and making sure they work hard for it."

While he was criticised for his expensive figures by some former players, Prasidh received backing from head coach Gautam Gambhir.

"The culture we have created is we are learning off each other... no matter who is there, who is around, and Boom is around, he has been talking to us even before coming here. At least for me, I've been part of this team for few years now, so conversations are still going on," Prasidh said.

He added, "One thing you cannot get is experience, that you have to do it yourself and I think all of us are excited if you look at the team.

"It's my responsibility to get better and that's what I am trying, that's what I am working on, and I just want to make sure I put in the right kind of work, come back here, and put up better numbers." (PTI)
