# ELF big step forward towards national security: CM

GUWAHATI, June 29: Chief Minister Himanta Biswa Sarma on Sunday visited Jatiyani Village in Moran to inspect the ongoing construction of the Northeast's first Emergency Landing Facility (ELF)

on a national highway. The ELF is being developed on a 4.2-km stretch of the Moran Bypass under the Dibrugarh–Moran NH-2 project in coordination with the Indian Air Force and is expected to be operational by October this year.

Speaking to the media after the inspection, the chief minister said, "This will be the first emergency landing facility in the entire North East region. From civilian aircraft to advanced fighter jets like Sukhoi and Rafale, all will be able to land here. It's a big step forward in disaster preparedness and national se-

He added that he had reviewed the project with officials from the district administration, NHIDCL, and the Indian Air Force, and all minor issues had been resolved to

expedite the remaining work. "During the opening of this strip, I have requested the Indian Air Force to hold an air show and bring in some of their fighter jets,"

The ELF, once completed, will be capable of handling landings by defence aircraft including MIG, Tejas, Hercules, and AN-32.

The project, constructed with advanced specifications, is in-

tended to serve as a makeshift airstrip in times of war or natural

Located between Polo Club in Khatkhati and Rassipathar on the under-construction 11-km four-lane stretch of NH-2, the facility also includes temporary fencing to prevent intrusions during operations and an Air Traffic Control (ATC) tower for

flight management. The Chief Minister's Office, in by NHIDCL, this strategic project will enhance disaster response and national security readiness.

The road will be reserved exclusively for aircraft operations during emergencies and will otherwise

remain open to public transport. The ELF is a joint initiative between the National Highway Authority and the Indian Air Force's airfield construction division.

The Chief Minister remarked that the road from Moran Town to Tiloijan has already been opened to traffic since April 1 and is awaiting formal inauguration by Prime Minister Narendra Modi.

In addition to the Moran facility, the Chief Minister announced that the central government will develop two more ELF projects in the stateone between Tihu and Barama in western Assam and another between Nagaon and Lumding (Sankardev Nagar) in central Assam.

#### MDA urges centre to restore elected govt in Manipur

IMPHAL, June 29: The Manipur Democratic Alliance (MDA) has stepped up its pressure on the Centre to end President's Rule and reinstate a popular government.

At a press conference held Sunday at the MDA office in Babupara in Imphal, alliance convenor M Tombi Singh revealed that the group had submitted a detailed memorandum to key national figures including Union Home Minister Amit Shah, BJP president J P Nadda, and Rashtriya Swayamsevak Sangh (RSS) chief Mohan Bhagwat seeking intervention and restoration of democratic governance in the state.

"The President's Rule has not brought any progress or peace," Tombi said. "The people of Manipur are demanding the return of an elected government.'

Manipur has been under central rule since February 13, following the resignation of Chief Minister N. Biren Singh amid mounting political pressure and prolonged violence. (CONTD. ON PAGE-2)

NEW DELHI, June 29: Prime Minister of that crisis. How grave that crisis was.' His condemnation of the Congress for the Emergency-era excesses without naming the party or the then prime minister Indira Gandhi came amid an ongoing bitter war of words between the ruling BJP and opposition parties, which have claimed that an undeclared Emergency prevails under the Modi government.

He said, "I will play an audio for you. In this

In the audio, Morarji Desai, the prime minis-

ter after the Emergency, said the "oppression" of the Indira Gandhi regime was going on for several years but reached its peak in the last two years after the Emergency was imposed.

Desai said, "People's right to freedom was snatched away, newspapers were left without freedom. Courts were made completely powerless. And the way more than one lakh people were put in jail and then arbitrary rule continued, it is difficult to find its traces in the history of the world.

Modi said in the broadcast that people were tortured on a large scale during the Emergency for the 21-month period between 1975 and 1977. There are countless examples of atrocities on people that cannot be forgotten, he added.

He also played bits of speeches of former prime minister Atal Bihari Vajpayee, and former deputy PM Jagjivan Ram related to the period. George Fernandes was shackled, he noted and recalled that anyone could be arrested under

### NFR restores Lumding–Badarpur route in record time; train services resume smoothly

GUWAHATI, June 29: The Northeast Frontier Railway (NFR) has successfully restored train operations on the affected stretch between KM 108/6-8 in the Jatinga Lumpur-New Haflong section of the Lumding-Badarpur Hill Section, less than a week after it was severely impacted by landslides.

According to an official statement, limited train operations will resume from today, June 29, between 12:00 and 18:00 hours, while full-scale train services are scheduled to resume from Monday, June 30, 2025.

Train movement through the once-disrupted route has now resumed smoothly, with the first empty goods train marking the reopening by departing from New Harangajao at 10:21 hrs. The first passenger train to pass through the restored stretch was Train No. 13175 Sealdah–Silchar Kanchenjunga Express, which began its journey on June 28 and completed its run through



the section without any hindrance. It was promptly followed by Train No. 13174 Sabroom-Sealdah Kanchenjunga Express, which also operated without issue on its original route. Breakthrough at Penn State demonstrates potential of 2D materials to replace silicon and reshape future of electronics

# World's first computer devoid of silicon shows it is possible to replace it someday: Researchers

NEW DELHI, June 29: Researchers have built a computer from scratch without silicon, a "milestone" in showing that it is possible to one day replace the material that fuelled the bulk of technology advancements over the past half a century, by making devices smaller and faster.

Built at a nanofabrication unit at The Pennsylvania State University in the US, the research team has demonstrated the successful working of the world's first CMOS computer made using two-dimensional materials, which are paperthin, but at the nano-level. It is described in a paper in the journal Nature.

'Complementary Metal-Oxide-Semiconductor', or CMOS, is widely used in designing electronic circuits. It consumes low power and accommodates more components.

The development is acknowledged as pioneering and a starting point in creating not just alternatives to silicon, but a roadmap for a new generation of still smaller,

more flexible electronics. Saptarshi Das, professor of engineering science and mechanics at the The Pennsylvania State University (Penn State), and lead researcher on the paper, told PTI, "In the short term, you would like to augment silicon with these two-dimensional (2D) materials, because they offer new functionalities -- including in sensors and memory devices.

"This is why our paper is, I would say, a milestone, because it shows that it is possible in a way to replace silicon one day," Das said.

Silicon, whose conductivity can be manipulated for controlling electricity flow, has been foundational in advancing technology by helping electronics shrink in size. since 1947 when a transistor was first made using the material.

A transistor regulates electric signals and acts as a building block


for an electronic circuit. But now, nearly seven decades later, as electronic devices continue to become smaller, silicon may have hit a wall -- scientists say it may not be able to function as well, if devices are to get tinier. Das said, "The trajectory of sili-

con has stalled." Lead author Subir Ghosh, a doctoral student at Penn State, ex-"We have plains, molybdenum disulphide (MoS2) and tungsten diselenide (WSe2) -both quite common in the 2D materials community -- to make our

semiconductor devices." "Here at Penn State, you can grow this material over a large two-inch wafer. They are also scaleable, which means that the industry can also adopt these 2D material," Ghosh added.

The semiconductor industry is said to be governed by Moore's law, according to which the number of transistors in circulation double every 18 months (a year and a half).

However, transistors are no longer becoming smaller. This is because silicon is a bulky material -- like a brick -- which cannot be made any smaller owing to detri-



creased leakage current, power consumption and a reduced performance of the device, Das explained over a video call.

"Now, for example, if we need to construct a multi-storied building, we will use bricks. But now, what if I tell you that the best choice for this building is not tremely thin. You can then get back all the good qualities you need to make a device very small," Das

Research teams around the world, including China, are fiercely working for over a decade in developing 2D materials to initially support silicon in making

smaller devices, but eventually transition away from having to use the bulky material itself. Scientists at China's Fudan Uni-

versity have created a RISC-V microprocessor chip by assembling transistors made of 2D materials. The chip, described in a paper published in April in the journal Nature, also used a low power to

Mayank Shrivastava, professor at the division of electrical, electronics and computer sciences, In-Institute of Science, Bengaluru, and not involved in the study, told PTI, that a successful demonstration of the computer built using 2D materials is pioneering and "marks a watershed moment in the evolution semiconductor technology.'

"While we have seen individual devices and simple circuits from 2D materials before, building an actual computer, even one with a single instruction set, completely from 2D semiconductors is a bold leap," he said.

Shrivastava added that these developments are also a "wake-up call that the silicon race is maturing, and the next race, based on 2D materials, has already begun".

Das from Penn State explained that the 2D computer -- a primitive one that present day semiconductor foundries might be building in the 1960s -- was designed to perform a single instruction, which on repeat, can do all the basic functions of addition, subtraction and multiplication. Ghosh explained this single instruction, named 'reverse subtract, skip if borrow'

"In order to subtract, you have two numbers. But while subtracting a bigger number from a smaller one, we need to 'borrow'. So, when a 'borrow' is raised, our computer will skip that instruction and move on to the next," the lead author said. The computer achieved a high drive current, with a low leakage and power dissipation, enabling 2D-semiconductor circuits to operate below three volts and (CONTD. ON PAGE-2)





## Russia's Rosneft in early talks with Reliance to sell stake in India unit

oil giant PJSC Rosneft Oil Company is in early talks with Reliance Industries for sale of its 49.13 per cent stake in Nayara Energy, which operates a 20-million tonnes-ayear oil refinery and 6,750 petrol pumps in India, sources said.

Reliance has held preliminary talks for acquisition of Navara. which will help it overtake stateowned Indian Oil Corporation (IOC) to become India's No.1 oil refiner as well as give a meaningful presence in the fuel marketing space.

But the talks are at preliminary stage and there is no guarantee that they may lead to a definite deal as valuation remains a sticky ground, three sources with direct knowledge of the matter said.

Top Rosneft officials have visited India at least thrice in the last one year, including visits to Ahmedabad and Mumbai, for talks with potential investors.

For Rosneft, which is looking to exit from Navara due to western sanctions limiting its ability to repatriate full earnings from India operations, a potential buyer could be one who has substantial earnings overseas or is an international company - both of which could make quick overseas payouts for the stake. Being a large exporter of fuel, Reliance has substantial overseas income, the sources said.

While emails sent to Rosneft for comments remained unanswered, a Reliance spokesperson said, "As a policy, we do not comment on media speculation and rumours."

"Our company evaluates various opportunities on an ongoing basis," the spokesperson said. "We have made and will continue to make necessary disclosures in compliance with our obligations under Securities Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations 2015 and our agreements

The stake of Rosneft and UCP was offered to Reliance Industries. Adani Group, Saudi Aramco and state-owned ONGC/IOC combine lion valuation that Rosneft had put for Navara was considered too steep a price by almost every potential investor.

Adani Group politely declined

Nayara makes the most sense for Reliance, they said. Reliance operates twin refineries, with a combined capacity of 68.2 million tonnes per annum at Jamnagar in Gujarat. Its units are in the vicinity of Nayara's 20-million tonnes-ayear unit at Vadinar, Gujarat.

Nayara will help it cross IOC's 80.8-million tonnes-a-year capacity to become No.1 refiner in the country. But more importantly, the 6,750 petrol pumps of Nayara would help it gain a meaningful share in the fuel retailing business. Reliance has just 1,972 petrol pumps out of 97,366 outlets in the country. "Oil refining alone is not a profitable business. Unless you have marketing, you can never make money," an industry official explained.

Sources said for both Oil and Natural Gas Corporation (ONGC) and IOC, the valuation being sought by Rosneft is too high.

For them the value of petrol pumps should not be more than ₹ 3-3.5 crore per outlet. This gives a valuation of not more than USD 2.5-3 billion for the marketing network and similar value is what they see for the oil refinery, they said.

But for Reliance, the value of the marketing network is more, perhaps ₹ 7 crore per outlet (USD 5.5 billion). And given the synergies the combined operations of Jamnagar and Vadinar refineries can derive, the 20-million tonnes Nayara unit and its planned petchem unit could be worth another USD 5 billion, they said.

Sources said since the start of talks, Rosneft has brought down the valuation to USD 17 billion but that too is considered too high by companies such as Reliance.

However, no official deal has been confirmed, and Rosneft has not made a formal statement on the

## Signature Global to invest ₹ 2,200 cr on new housing project in Gurugram

**NEW DELHI, June 29:** Realty firm Signature Global will invest around ₹ 2,200 crore to develop a new housing project in Gurugram to expand business and achieve over 20 per cent growth in its pre-sales this fiscal year. The company has recently launched a premium residential project, 'Cloverdale', comprising 770 apartments, on Southern Peripheral Road (SPR), Sector 71, Gurugram. Signature Global emerged as the fifth largest listed real estate developer last fiscal in terms of sales bookings by achieving record pre-sales of ₹ 10,290 crore.

The Gurugram-based company has given a guidance of posting ₹ 12,500 crore worth pre-sales in the current fiscal. "We have launched a new housing project in Gurugram. Housing demand continues to be strong in this city, especially for reputed builders," Signature Global Chairman Pradeep Kumar Aggarwal

range of ₹4 crore to ₹7 crore in this project, which is spread over 8 acres and is part of an overall 22-acre development. The project is scheduled to be completed by 2031. Last month, Aggarwal said the company will invest around ₹ 4,000 crore this fiscal to acquire land parcels and carry out construction activities in its housing projects at Gurugram.

Signature Global had invested ₹ 1,070 crore last fiscal year to purchase 48 acres of land in Gurugram, Haryana. "Land is an important raw material for real estate developers. We will be investing around ₹1,200-1,500 crore on the acquisition of land parcels," he had said. Aggarwal said the investment in construction activities would be around ₹ 2,500 crore in 2025-26 against ₹ 1,900 crore in the preceding fiscal. (PTI)

On the sidelines of the visit, the Sivasagar Municipality Tax Payers' Association, led by president M K Borthakur and secretary Arabinda Baruah, submitted a memorandum to the Chief Minister. Their demands included the construction of a flyover from the ASTC point to Darikapar to ease congestion at Station Chariali and the replacement of the existing British-era iron bridge over the Dikhow River with a modern structure.

#### MDA urges centre to restore

The MDA leader pointed to the plight of thousands of internally displaced persons still stuck in relief camps more than a year after ethnic violence erupted on May 3, 2023. "Neither the ruling nor opposition legislators have been able to help these people return to their homes," he said. Tombi went further to blame the roots of the current crisis on the Congress government of 2005.

He alleged that bilateral talks initiated with Kuki militants based in Myanmar were the beginning of the trouble. By 2008, the talks became tripartite, and during that period, over 1,000 villages in hill areas were officially recognised, many of which, he alleged, were later settled by illegal immigrants who took up poppy cultivation. He defended the MDA's crackdown on illegal activities and drug trafficking, accusing the Congress of politicising the issue instead of accepting responsibility. "The Congress is blaming us now, but it was their policies that laid the foundation for this crisis," Tombi asserted. (NNN)

"The operating speed of 25 kiloHertz is still far behind silicon, while challenges remain in improving channel mobility, gate oxides, contacts, managing parasitics, reliability, ensuring yield, and achieving top-gate device integration or nanosheet devices for scale," he said.

"It is also vital to emphasise that while this milestone is academically significant, its commercial translation hinges on building infrastructure -- testbeds, fabrication capabilities, tool ecosystems, and skillsets -- that don't yet exist in many countries." Despite the limits, Shrivastava described the 2D computer as a "foundational milestone that, over time, have historically driven transformative changes." On Friday, India's electronics and IT Ministry was reported to consider funding research on 2D materials.

## Buridehing river floods devastate Kumchai Gaon Panchayat

MARGHERITA, June 29: Resi-

dents along the banks of the Buridehing River in Kumchai Gaon Panchayat, under the 83 No Margherita Constituency of Tinsukia district, are facing a grave crisis as floodwaters continue to submerge their agricultural fields and homes.

The situation has been further aggravated by severe riverbank erosion, leaving the affected communities in a state of despair.

Villages including 1 and 2 No. Toklong, Madhupur, and Amrit Gaon have borne the brunt of the disaster, with thousands of bighas of land reportedly lost to the advancing river.

The residents of these riverside areas, many of whom are indigenous people dependent on agricul-

ture, have been left without shelter or livelihood, and claim they have yet to receive any form of government relief or assistance.

In response to the crisis, a delegation from the All India Kisan Sabha and the All India Youth Federation visited Toklong No 2 on Saturday to assess the situation and interact with the affected residents.

The team included Ratul Gogoi, state executive member of the All India Youth Federation, Sanjeev Ganguly, assistant secretary of the All India Kisan Sabha, and Bijendra Gogoi and Hemanta Gogoi, president and secretary respectively of the All India Youth Federation Tinsukia district unit.

During a community meeting held at Toklong No 2 Primary School, the affected residents voiced their grievances and called for immediate intervention. They alleged that local authori-

ties, including the Margherita MLA, the Co-District administration, and relevant ministers and officials, have remained unresponsive to the crisis. The flood-hit villagers de-

manded a permanent solution to the recurring flood and erosion problem, stressing the urgent need for protective infrastructure and long-term planning.

The meeting concluded with a unanimous decision to form a committee that will soon submit a memorandum to the Assam government, urging concrete measures to address the growing challenges faced by the riverside

## Historic Wahab Bazar Mosque lost to Brahmaputra erosion in Dhubri

DHUBRI, June 29: The historic

Jame Masjid at Wahab Bazar in Fakirganj, located in Assam's Dhubri district, has been completely engulfed by the Brahmaputra River due to severe erosion, leaving no trace of the once-prominent religious and cultural land-

According to reports from the ground, the mosque had been under threat for weeks as the river's relentless currents gradually consumed the riverbank.

Eyewitnesses and local residents watched in despair as the final remnants of the mosque collapsed into the Brahmaputra, marking the end of a structure that had stood for generations.

The disappearance of the mosque was captured on camera, providing a haunting visual of the



river's power and the community's helplessness in the face of natural forces

The Jame Masjid at Wahab Bazar was not only a site of worship but also a heritage structure, holding deep cultural and spiritual

value for the residents of the area. Despite growing concern and the visibly precarious condition of

the mosque in recent weeks, efforts to protect it were ultimately overpowered by the rapid pace of erosion and shifting riverbanks.

This incident has intensified local fears over the growing threat of river erosion in the region. Community members are urging immediate intervention by the government to prevent further devastation.

The Wahab Bazar market, situated in close proximity to the site of the now-vanished mosque, is

also considered highly vulnerable. Prominent local figure Atikur Rahman has appealed to Chief Minister Himanta Biswa Sarma and Minister of Water Resources and Information & Public Relations Pijush Hazarika to take urgent steps to address the crisis.

### **EC** preparations for Bihar polls

expires on November 22, 2025. All political parties are preparing for the great electoral battle. Bihar has been a very high-stakes electoral battle for the PM Narendra Modi and the BJP, and this time it has already been reported that the party has planned 200 or more election rallies in Bihar. The Election Commission of India has no option but to take the Bihar election more seriously than any other elections in the last decade. It is in this general context, the Election Commission of India, has just given instruction to have a Special Intensive Revision (SIR) of Electoral Rolls, which will begin from July 1, 2025. The last intensive revision was conducted with January 1, 2003, as a qualifying date. It means the electoral roll will be prepared afresh, and to get one's name listed in the electoral roll, a citizen, especially those whose names were not in the voter list of 2023, will need to prove their citizenship. The ECI has said that all electors must submit an enumeration form, and those registered after 2003 have to additionally provide documents establishing their citizenship, as per the guidelines and schedule specified by the Commission. A new declaration form will be added which will require proof of citizenship. Earlier, ECI's Form 6, required a simple declaration by the applicant that they were citizen. The commission has also said that 'special intensive revision' of rolls, or SIR, will eventually cover all states and UTs. In Bihar, the final Revised Electoral Roll will be published on September 30, 2025.

This makes the decision of the ECI most controversial, since we have already seen in Assam, how difficult it was to prove citizenship not only for Bangladeshi infiltrators, but also for genuine Indian citizens. The draft National Register of Citizens (NRC) had excluded 40 lakh people, and the final list excluded 19 lakh, for they could not prove their citizenship, though 1971 was the cutoff year. The issue is still not resolved after the first list came out in 2018, and the final list published in 2019. This obviously is a reminder of the fact that lakhs of people would be deleted from the revised electoral roll of 2025, which is to be prepared just within a couple of months. ECI will give a limited time to the voter to prove his citizenship, which he can't, as the Assam experience has already shown. Additionally, it should be noted that all the persons born after 2023 in Bihar do not even have birth certificates. According to a Population Research Centre report, birth registration rate in Bihar reached only 80.3 per cent in 2018. It means lakhs of people are not even able to give their birth certificates, and therefore may suffer exclusion from the revised voter list.

ECI has clearly been influenced by the Union Government led by PM Narendra Modi, who has been playing the politics of NRC. "Proving the Citizenship" as a condition for allowing inclusion in the Revised Electoral Roll, is just an indirect implementation of NRC, in the name of Special Revision of Electoral Roll. Since proving citizenship is a controversial matter, ECI must not have put it as a condition, until the

# Democratic Party leaders have to learn right lessons from Zohran Mamdani's win

ohran Mamdani's spectacular success at the democratic primary for the New York mayoral election was symptomatic of the people's frustration over the establishment, the government, which failed to deliver. The PAC, called Fix The City, shattered all previous records, raising more than \$25 million to back Cuomo's attempt at a political comeback four years after he resigned over sexual misconduct allegations by at least 11 women who were former staffers. Yet he did not win.

Mark his words, this is what resonates with people. The Democratic Party needs to say boldly it cares for the middle classes and down trodden and say to money bags and the rich, we don't want your money, we need to take care of these people, opined Reich.

Well, we're the richest country in the world. We've never been richer. This is what Democrats have got to say. We pay for it by raising taxes on the wealthy. We

pay for it with a wealth tax. We pay for it the way in which Teddy Roosevelt – you don't even have to go back to Franklin D.

His fifth cousin, Teddy Roosevelt, in 1901 was contemplating and developing a sort of a wealth tax in terms of an estate tax. There are things that can be done and should be done, and Democrats cannot be afraid of sounding, what, socialist, radical? This is the time for sounding a little bit strong, Reich said.

# NATO is now a global alliance, not the original bloc of North Atlantic nations How the UN lost its bite

t the NATO summit in The Hague on June 24 and 25, heads of state and government decided on the most significant assault on the European welfare state since World War II. US President Donald Trump gives the orders, and Europe follows like lemmings. NATO plans to spend \$3 trillion on armaments equivalent to 5 per cent of GDP by 2035. That nearly doubles defence spending over the next decade, even though NATO already spends more than all other nations combined.

This massive militarisation will be paid for through cuts to pensions. healthcare, education, social services, and infrastructure. Massive debt programmes won't save future generations from ruin. The summit triggers the most profound social cuts in postwar European history.

NATO is a nostalgic, even romantic alliance — it dwells in past glories, as if time froze 50 years ago. The current arms build-up is often defended by citing similar defence-to-GDP ratios from the 1960s and '70s. But then, economic growth averaged 6.4 per cent yearly in West Germany, compared to -0.3 per cent in 2023, -0.2 per cent in 2024, and projected further decline in

Invoking the past thus distorts today's militarisation, which — like fascism — can end only in war and conquest. NATO is also outdated because the global South has shifted the world order: BRICS now account for 40 per cent of global GDP (with Indonesia just joining), while the G7 makes up only 29 per cent compared to two-thirds in 2006.

Efforts to cut BRICS off from key technologies through export controls (like the cold war's COCOM list) are doomed: China leads 37 of 44 critical tech fields. The strategy of hyper-armament is turning into a boomerang. NATO topples itself. The threat of overextension is palpable — especially as US allies are burdened to hold the global order together.

NATO aims to dictate to countries worldwide. Officials now celebrate Iran's lack of a nuclear programme even though Iran, as a Nuclear Non-Proliferation Treaty signatory, has every right to one. This is nothing but neocolonial domination.



Meanwhile, NATO unconditionally supports Israel — despite genocide and aggression toward Iran. Israel, unconstrained by the NPT and unsupervised by the IAEA, has acquired nuclear

weapons with no NATO sanctions. Yet even this neocolonial double standard is threatened by a changing world order. How long will countries tolerate NATO's bullving? Resistance grows, as all outdated powers collapse. As US dominance declines, some may resort to extreme measures to sustain the unsustainable.

NATO's massive rearmament is not about defence — it's war preparation. They aim to maintain global hegemony at any cost, extracting resources from allies to fund it. Their strategy? Be ready for global threefront warfare.

In Europe, Europeans themselves are meant to fight; Ukraine is meant to become NATO's proxy war. The goal remains crippling Russia. Europeans finance Ukraine's weapons, while the US secures the region's resources. In the Middle East. Israel acts as a floating aircraft carrier for NATO and the US. If Israel falters, the US intervenes. In the Indo-Pacific, it's China's turn an intricate web of US bases underwrites this. But does this global overreach deepen NATO's own crisis?

NATO claims US and Israeli attacks on Iran are "defence" — a stark perversion. The aggression during Yu-

goslavia and Libya proves it further. With recent escalations, NATO emerges as an alliance of rogue states

using terror as policy. Why call them rogue? They ignore or erode international law. They support Iranian regime change or Israel's genocide in Gaza. The alleged impending Russian attack on NATO within five years is yet another intelligencedriven fabrication — just like the leadup to Iraq and now the hysteria around Iran's nuclear ambitions, even when US services disagree.

Joining NATO means surrendering sovereignty. Previously, covert forces like Italy's Gladio or Turkey's Hezbollah shadowed left-wing critics. Today's summit leaves no room for independent fiscal, economic, or social policy poverty is pre-programmed. NATO's diplomacy increasingly re-

sembles crime syndicates. Europe is reduced to vassalage, slavishly implementing Washington's dictates. The North Atlantic leadership even adopted Trump's motto of "peace through strength." This gigantic rearmament doesn't make Europe stronger it makes it more submissive.

The NATO secretary-general's genuflection to Trump — ("Europe is going to pay in a BIG way as they should, and it will be your win") summarises it: European leaders fail to voice their own interests.

More European defence spending

doesn't mean more European influence – it serves US hegemony. The EU acts as a NATO subsidiary. There's no independent European foreign or security policy.

Countries resisting Washington are bullied into compliance — see Slovakia and Spain, which reluctantly signed off on the 5 per cent target. Any exceptions are temporary. NATO membership and political sovereignty are mutually exclusive. The US claims a de facto right to intervene in domestic politics if a country disobeys.

Today, only neutrality can protect democratic sovereignty. That is why NATO is courting neutral European countries like Switzerland and Austria. NATO expansion in Europe and Asia ongoing, aiming ever wider. Ukraine's president was invited to this summit to underscore expansion ambitions. The US frames the accession of neighbouring countries — and nearby missile deployments — as a cause for war, yet expects Russia and China to accept NATO's expansion without ob-

Since last year's Washington summit, NATO defines itself as a global alliance. This was reaffirmed in The Hague by inviting Australia's PM Anthony Albanese, Japan's Shigeru Ishiba, New Zealand's Christopher Luxon, and South Korea's Lee Jae Myung.

The idea that NATO is limited to the North Atlantic is now a romantic relic. Inspired by the James Bond classic, The World Is Not Enough, it serves US global dominance. That inevitably clashes with the BRICS, because NATO upholds a declining order. Proxy wars in Ukraine and the Middle East preserve resources — but how long can that succeed?

NATO's myth of being "the winner of history" falls flat after almost 40 years beyond the cold war. It now resembles an alliance of failed wars — Afghanistan, Ukraine. Domestically, it suppresses dissent via propaganda and institutional dominance. Why are there so few critical NATO scholars or books? Critics are labelled conspiracy theorists and silenced.

This is ideological totalitarianism shield preserving a dominant selfimage by marginalising critics. Meanwhile, those who echo NATO's official narrative earn positions on talk shows and at universities. (IPA Service)

# Fangs without venom:

hen the world burns, we need a platform that doesn't just appeal to douse the flames, but one that actually brings water. But in the third decade of the 21st century, every time the flames of war have risen, the United Nations has appeared merely scattering the ashes of statements and resolutions. Is this the same institution the world once looked up to in 1945 as a symbol of hope? Back then, the war-weary humanity, reeling under the devastation of the Second World War, laid the foundation of the United Nations to uphold global peace, protect human rights, and foster cooperation among nations. But today, when bombs fall in Gaza, tanks roll through Ukraine. civil war blazes in Sudan, and Haiti slips into governmental void one is compelled to ask: has the United Nations strayed from its purpose? Or has it become like a snake without fangs, without venom?

Looking at recent events, it certainly seems so.

The Israel-Palestine conflict, which reignited in 2023, has so far claimed more than 40,000 lives many of them women and children. The United Nations passed resolutions, announced humanitarian aid—but all efforts were nullified by the veto of countries like the USA. Similarly, the Russia-Ukraine war, which began in 2022, has entered its third year. Thousands have died, millions displaced. But in the Security Council, Russia's veto power has rendered the rest helpless. These are not solated cases.

From Armenia-Azerbaijan, Sudan, Mali, Somalia, Yemen, Congo-conflicts rage across the globe. Nations like Haiti are on the brink of lawlessness. Each time, the UN issues stern statements, passes resolutions, sends humanitarian aid—but fails to establish lasting peace.

The biggest reason for this failure lies in the structure of the Security Council. The five permanent members USA, Russia, China, France, and the UK can veto any proposal. Even if four nations agree to halt a war, one "No" nullifies the resolution. This structure is obsolete in today's multipolar world. Countries like India, Brazil, Germany, and Japan have long demanded permanent seats at the table. Yet, due to conflicting interests of the P5, the demand remains unfulfilled. Is it fair that India, with a population of 1.4 billion and the largest contributor to UN peacekeeping missions, is denied a seat at the decisionmaking table?

Today, power has become more valuable in the UN than humanity. Powerful countries place their national interests above

dying in Palestine or drone attacks on civilians in Ukraine—these tragedies have become nothing more than numbers in the game of geopolitics. Even if 150 nations in the UN General Assembly vote to stop a war, a single veto in the Security Council silences all. Peacekeeping forces are still deployed in several conflict zones, but they lack resources, autonomy, and teeth. In countries like Mali, Congo, and Lebanon, UN peacekeepers are helpless before armed local militias. After the U.S. withdrawal from Afghanistan, the UN was entirely ineffective in addressing the At the start of 2025, countries like

India, Brazil, and South Africa once again raised the demand for structural reform in the United Nations UN Secretary-General António Guterres himself said: "If we don't reform, history will not forgive us." The proposed reforms include the inclusion of new permanent members, limiting the veto power—especially in war-related resolutions, strengthening and empowering peacekeeping operations, and ensuring budgand administrative etary decentralization. A global IPSOS survey conducted in January 2025 reveals that 68% of people believe the UN is incapable of stopping wars, and 82% of youth demand radical reform. In countries like India, Nigeria, and Brazil, public disillusionment with the UN is particularly high. This is a clear signal—

lutions no longer satisfy the world. Today, as war flames spread and humanity groans, the UN must go beyond merely appearing 'united'-it must become genuinely sensitive. Its silence now is not just a sign of failure; it is increasingly seen as a complicity in crime. The current state of the United Nations echoes poet Ramdhari Singh Dinkar's timeless lines:

diplomatic jargon and ceremonial reso-

"Kshama shobhti uss bhujang ko, jiske pass garal ho.

Usko kya jo dantheen, visharahit, vinit, saral ho"

The UN today is like such a fangless, venomless snake—capable only of hissing, but powerless to act. It resembles that elderly member of a household whose words are heard with respect, but whose advice is ignored. If the UN truly wishes to become the platform for global peace, it must move beyond resolutions and take bold decisions—even if it means challenging the powerful. # Medical myths: All about weight loss

uring the holiday season, many people take on more calories than hey work off. Consequently, adding a little extra weight at this time of year is not unusual.

Classically, January is a time of change, and many people go on health kicks that include weight loss. With that in mind, we address some common mis-

1. Skipping breakfast aids weigh loss The common adage that breakfast is the most important meal of the day may or may not be true, but it seems unlikely that skipping the morning meal aids weight loss.

The rationale behind this strategy is that missing one meal a day leads to a lower overall intake of calories. However, the story is not so straightforward.

One study, published in 2010, analyzed food intake information from 2,184 people aged 9–15 years. Twenty years later, the researchers asked for the same information again.

They compared data from people who had skipped breakfast during childhood and adulthood with data from those who had never skipped breakfast or had done so only in adulthood.

Compared with the other groups, the participants who skipped breakfast during both childhood and adulthood tended to have larger waist circumferences, higher fasting insulin levels, and higher total cholesterol levels.

Sometimes, people who skip breakfast eat more during the rest of the day to counteract the deficit. But one 2013 study found that missing breakfast does not lead to eating more at lunch. The authors conclude that "Skipping breakfast may be an effective means to reduce daily energy intake in some adults."

However, these researchers only monitored the participants' food intake at lunch, not dinner. And the study only included 24 participants, so we should be wary of drawing solid conclusions from the findings.

A much larger 2007 study, which involved more than 25,000 adolescents, looked for links between skipping breakfast and having overweight. The researchers also assessed the roles of alcohol intake and levels of inactivity.

The scientists found that skipping breakfast had a stronger association with overweight than either alcohol consumption or levels of inactivity.

A 2020 systematic review and metaanalysis that appears in the journal Obesity Research & Clinical Practice concurs. After analyzing the results of 45

previous studies, the authors concluded: "Skipping breakfast is associated with overweight/obesity, and skipping breakfast increases the risk of overweight/obesity."

2. 'Fat-burning' foods can aid weight Certain foods are referred to as "fat-

burning." This sounds too good to be true, and it probably is. Some people claim that foods such ineapple, ginger, onions, avocados, asparagus, celery, chilies, broccoli, green tea, and garlic speed up the body's metabolism,

thereby helping the body burn fat. There is little scientific evidence, however, that these foods can help reduce

3. Weight loss supplements can help Proponents of certain supplements claim that they, too, help the body burn fat. In reality, these are generally ineffective, dangerous, or both.

The Food and Drug Administration (FDA) report that they have "found hundreds of products that are marketed as dietary supplements but actually contain hidden active ingredients [...] contained in prescription drugs, unsafe ingredients in drugs that have been removed from the market, or compounds that have not been adequately studied in humans."

"We've also found weight loss prod-

Jason Humbert, a senior regulatory manager at the FDA, adds:

In general, snacking is multifaceted it may support or hinder weight loss efforts, and in some cases it may have little

Older research, from 2007, investigated the role of snacking in weight loss. In the yearlong study, the researchers asked one group of participants to have three meals a day, without snacking. A second group was asked to have three meals and three snacks daily. Individuals in both groups consumed equivalent amounts of energy each day.

At the end of the study, the authors found no difference in weight loss between the two groups; snacking, it seems, neither helped nor hindered.

Another study, from 2011, investigated the "relationship between eating frequency and weight loss maintenance."



tain dangerous concoctions of hidden ingredients, including active ingredients contained in approved seizure medications, blood pressure medications, and antidepressants.'

4. Low fat foods aid weight loss Of course, reduced fat or low fat foods are likely to contain less fat. However, these products sometimes compensate with added sugar or salt. Checking labeling is key.

Also, it is worth noting that "reduced fat" does not necessarily mean "low fat," but simply that the fat content of a product is lower than the full-fat version.

5. Thou shalt not snack People may believe that snacking is a cardinal sin of dieting. In some cases, though, snacking can help people manage their caloric intake more effectively. It is not so much snacking itself, but what one snacks upon that that

Snacking may be more complex than it first appears. While some snack on celery and others on cookies, some people might snack because they are hungry and others because they are bored.

Having a piece of fruit or some low fat yogurt between meals, for instance, might reduce food cravings, keeping a person from overeating at mealtimes or resorting to more energy-dense snacks.

Some research has shown that people ith obesity are more likely to snack than people without the condition. In this case, switching from unhealthful to healthful snacks may aid in weight loss,

The researchers recruited participants who had previously had overweight or obesity but who had since maintained healthy weights.

They compared these individuals' eating patterns with those of people with obesity and people with healthy weights who had never had over-

The team found that participants with healthy weights ate more snacks than those who had lost weight — and that people with overweight ate the fewest

Overall, the authors concluded that "Eating frequency, particularly in regard to a pattern of three meals and two snacks per day, may be important in weight loss maintenance.' 6. No treats allowed

This follows on from the myth above. Of course, limiting sugary, high fat treats

is important, but cutting them out entirely is unnecessary and could be counterpro-As the British Heart Foundation ex-

"Depriving yourself of all the foods you enjoy won't work. You'll eventually give into temptation and abandon your efforts. There's no harm in allowing yourself a treat now and again."

7. Some sugars are worse than others There is a rumour that minimally rocessed sugars, such as those in maple syrup or honey, are more healthful than white sugar. In reality, our bodies process sugar in the same way regardless of its source. The gut reduces all sugars into monosaccharides.

Rather than looking at sugar processing, it is more important to note the amount of sugar in any food. All types of sugar provide around 4 calories per gram.

8. Cut out all sugar

Following on from the myth above, we know that all sugar is high in calories. However, a person looking to lose weight does not need to mercilessly cut sugar from their diet.

As with all things, moderation is key. It may instead be a good idea to avoid products with added sugar.

9. Artificial sweeteners are healthful To lower their sugar intakes, many

people opt for low- or no-calorie sweeteners, such as aspartame. This may reduce the number of calories consumed, but some studies have linked artificial, or nonnutritive, sweeteners to weight gain.

A systematic review and meta-analysis published in 2017 analyzed 37 existing studies involving a total of 406,910 participants to investigate the impact of sweeteners on cardiometabolic health.

According to the researchers, "Observational data suggest that routine intake of nonnutritive sweeteners may be associated with increased BMI [body mass index] and cardiometabolic risk.'

However, not all studies have reached this conclusion. Researchers and health experts continue to discuss the effects of nonnutritive sweeteners on weight loss and metabolic health.

10. You can target fat in specific areas Some people are particularly keen to lose fat from certain areas, such as the thighs or abdomen. In reality, this targeting is not possible. All bodies respond differently to weight loss, and we cannot choose which bits of fat will go first.

However, if weight loss is paired with exercises to tone a particular area, it can give the impression of more region-specific weight loss.

11. This fad diet is excellent

Vast legions of diets have become fashionable only to fade into obscurity, making room for more. As the Centers for Disease Control and Prevention (CDC) explain in a nutshell:

"[Fad] diets limit your nutritional intake, can be unhealthy, and tend to fail in

#### The take-home

Overall, losing weight can be challenging. Our bodies evolved during leaner times, so they are primed to take on energy and store it. However, many of us live in a world where calories are readily available, and our bodies still store this energy as if it's going out of

In general, reducing the caloric intake and exercising is the most reliable approach to weight loss. With that said, people with chronic diseases, including diabetes and obesity, should speak with their doctors before beginning a new weight loss regime.

It is also worth remembering that if anything seems too good to be true, it probably is — any "weight loss miracle" is unlikely to be miraculous. Most foods are not inherently unhealthful, but it is a good idea to consume high-sugar and high-fat foods sparingly. (Courtesy: Medical News Today)

ever 'surgery' is mentioned. Myth 2: Use of Mobiles cause brain tumours

Fact: After many years of research, there is no evidence that using a phone as per normal behaviour has a relationship with brain tumours; there are no links between normal usage unfounded research does exist that are based on alternate linking plans of granularity. Use of mobiles emit radiofrequency (RF) radiation which is non-ionizing radiation. Ionizing radiation, like xrays have enough radiation energy to cause DNA damage, RF radiation does not. Authorities, like the World Health Organization (WHO) and the American Cancer Society routinely monitor this, but science does not support the possibility of the 'myth'.

Myth 3: If you experience headaches, you certainly have a brain tumour

#### Myth 4: Brain Tumours Are Always Fatal

Fact: This is simply not the case. A large percentage of people diagnosed with brain tumours, both benign and malignant, live long, meaningful lives. This is yet again attributable to advanced techniques in neurosurgery, radiation, chemotherapy, precision medicine, and many other emerging fields of medicine, along with the type, grade, location, and size of the tumour, as well as the patient's overall health.

#### Myth 5: Brain Tumours are **Only Affecting the Elderly**

Fact: Brain tumours can occur in people of any age, even in children and young adults. In fact, brain tumours are one of the more common solid tumours in children. Only age does not determine risk.

#### **Myth 6: Brain Tumours Are** Hereditary

Fact: Most brain tumours are not inherited. While some rare genetic conditions like neurofibromatosis or Li-Fraumeni syndrome may increase the risk, the vast majority of brain tumours occur sporadically, without a hereditary factor. ## The silent heart attack, often missed but deadly

eart attacks have long been associated with dramatic chest pain and older age. But in recent years, a silent and deeply concerning trend has emerged as young adults in their 20s, 30s, and early 40s are increasingly falling victim to heart attacks, and in many cases, without any warning signs at all. These are called silent heart attacks, and they can be just as dangerous, if not more than the typical ones.

What Is a Silent Heart Attack? A silent heart attack, or silent myocardial infarction, occurs when the blood supply to a part of the heart is blocked, but the person feels little to no symptoms. # Russia launches biggest aerial attack since start of war: Ukraine

KYIV, June 29: Russia launched its biggest aerial attack against Ukraine overnight, a Ukrainian official said Sunday, part of an escalating bombing campaign that has further dashed hopes for a breakthrough in efforts to end the 3year-old war.

Russia fired a total of 537 aerial weapons at Ukraine, including 477 drones and decoys and 60 missiles, Ukraine's air force said. Of these, 249 were shot down and 226 were lost, likely having been electronically jammed.

The onslaught was "the most massive airstrike" on the country since the beginning of Russia's full-scale invasion in February 2022, taking into account both drones and various types of missiles, Yuriy Ihnat, head of communications for Ukraine's air force, told The Associated Press. The attack targeted several regions, including western Ukraine, far from the front line. Poland and allied countries scrambled aircraft to ensure the safety of Polish airspace, the country's air force said.

One person died in a drone strike in the Kherson region, Gov. Oleksandr Prokudin said, while another was killed when a drone hit a car in the Kharkiv region, according to its Gov. Oleh Syniehubov. Six people were wounded in Cherkasy, including a child, according to regional Gov. Ihor



large fire broke out at an industrial facility in the city of Drohobych following a drone attack that also cut electricity to parts of the city.

Ukraine's air force said one of its F-16 warplanes supplied by its Western partners crashed after sustaining damage while shooting down air targets. The pilot died.

Attacks continued during the day. Dnipropetrovsk Gov. Šerhii Lysak said a 72-year-old man was killed when a drone hit his car.

Russian troops reportedly advance in Donetsk

Russia's Defence Ministry said it had shot down three Ukrainian drones overnight. Two people were wounded in another Ukrainian drone attack on the city of Bryansk in western Russia, regional Gov. Alexander Bogomaz said Sunday morning, adding that seven more Ukrainian drones had been shot down over the region.

Meanwhile, Russia claimed Sunday that it had taken control of the village of Novoukrainka in the Russian-occupied Donetsk region.

Russian forces have been slowly grinding forward at some points on the roughly 1,000-kilometre front line, though their incremental gains have been costly in terms of troop casualties and damaged armour.

In other developments, Russia's foreign intelligence chief, Sergei Naryshkin, said he had spoken on the phone with his US counterpart, CIA Director John Ratcliffe. "I had

counterpart and we reserved for each other the possibility to call at any time and discuss issues of interest to us," Naryshkin said in remarks to state TV reporter Pavel Zarubin, who posted them on his Telegram channel on Sunday.

Sunday's attacks follow Russian President Vladimir Putin's comments two days ago that Moscow is ready for a fresh round of direct peace talks in Istanbul. Two recent rounds of talks between Russian and Ukrainian delegations in Istanbul were brief and yielded no progress on reaching a settlement. Zelenskyy withdraws Ukraine from an anti-land mine pact

Ukrainian President Volodymyr Zelenskyy signed a decree to withdraw Ukraine from the Ottawa Convention banning antipersonnel land mines, a Ukrainian lawmaker said Sunday. The move follows similar recent steps by the Baltic states and Poland.

The 1997 treaty prohibits the use, production, stockpiling and transfer of antipersonnel land mines in an effort to protect civilians from explosives that can maim or kill long after fighting ends. "This is a step that the reality of war has long demanded," said Roman Kostenko, secretary of the Ukrainian parliamentary committee on national security, defence and intelligence. He noted that Russia is not a party to the convention "and is massively using mines against our military

# Trump calls for deal on war in Gaza as signs of progress emerge

TEL AVIV (Israel), June 29: US President Donald Trump on Sunday pleaded for progress in ceasefire talks in the war in Gaza, calling for a deal that would halt the fighting in the 20-month-long conflict as Israel and Hamas appeared to be inching closer to an agreement. A top adviser to Prime Minister Benjamin Netanyahu, Cabinet Minister Ron Dermer, was set to travel to Washington this week for talks on a ceasefire, an Israeli official said.

The official said plans also were being made for Netanyahu to travel to Washington in the coming weeks, a sign there may be movement on a new deal. The official declined to discuss the focus of the visit and spoke on condition of anonymity to discuss plans that had not yet been finalised.

"MAKE THE DEAL IN GAZA. GET THE HOSTAGES BACK!!!" Trump wrote on his social media platform Truth Social early Sunday between posts about a Senate vote on his tax and spending cuts bill. Trump raised expectations Friday for a deal, saying there could be a ceasefire agreement within the next week. Taking questions from reporters, he said, "We're working on Gaza and trying to get it taken care of."

Trump has repeatedly called for Israel and Hamas to end the war in Gaza. Despite an eight-week ceasefire reached just as Trump took office earlier this year, attempts since then to bring the sides toward a new agreement have failed.

Trump post slams Netanyahu corruption trial The Gaza message wasn't the only Middle East-related post by Trump. On Saturday evening, he doubled down on his criticism of the legal proceedings against Netanyahu, who is on trial for alleged corruption, calling it "a POLITICAL WITCH HUNT, very similar to the Witch Hunt that I was forced to endure"

In the post on Truth Social, he said the trial interfered with talks on a Gaza ceasefire.

"(Netanyahu) is right now in the process of negotiating a Deal with Hamas, which will include getting the Hostages back. How is it possible that the Prime Minister of Israel can be forced to sit in a Courtroom

all day long, over NOTHING," Trump wrote.

The post echoed similar remarks Trump made last week when he called for the trial to be cancelled. It was a dramatic interference by an international ally in the domestic affairs of a sovereign state. And it unnerved many in Israel, despite Trump's popularity in the country

The trial has repeatedly been postponed at the request of Netanyahu, citing security and diplomatic developments. On Sunday, the court agreed to call off two more days of testimony by Netanyahu scheduled

A sticking point over how the war ends

Talks between Israel and Hamas have repeatedly faltered over one major sticking point, whether the war should end as part of any ceasefire agreement.

Hamas official Mahmoud Merdawi accused Netanyahu of stalling progress on a deal, saying in remarks on the Telegram messaging app that the Israeli leader insists on a temporary agreement that would free just 10 of the hostages.

Netanyahu spokesperson Omer Dostri said "Hamas was the only obstacle to ending the war", without ad-

#### Senate Republicans advance Trump's tax and spending cuts bill after dramatic late-night vote

WASHINGTON, June 29: Senate Republicans voting in a dramatic late Saturday session narrowly cleared a key procedural step as they race to advance President Donald Trump's package of tax breaks, spending cuts and bolstered deportation funds by his July

The tally, 51-49, came after a tumultuous night with Vice President JD Vance at the Capitol to break a potential tie. Tense scenes played out in the chamber as voting came to a standstill, dragging for more than three hours as holdout senators huddled for negotiations, and took private meetings off the floor. In the end, two Republicans opposed the motion to proceed, joining all Democrats.

There's still a long weekend of work to come. Republicans are using their majorities in Congress to push aside Democratic opposition, but they have run into a series of political and policy setbacks. Not all GOP lawmakers are on board with proposals to reduce spending on Medicaid, food stamps and other programs as a way to help cover the cost of extending some USD3.8 trillion in Trump tax breaks.

"It's time to get this legislation across the finish line," said Senate Majority Leader John Thune. R-S.D.

Ahead of roll call, the White House released a statement of administrative policy saying it "strongly supports passage" of the bill. Trump himself was at his golf course in Virginia on Saturday with GOP senators posting about the visit on social media.

But by nightfall, Trump was lashing out against holdouts, threatening to campaign against one Republican, Sen Thom Tillis of North Carolina, who had announced he could not support the bill because of grave Medicaid cuts that he worried would leave many without health care in his state. Tillis and Sen Rand Paul of Kentucky voted against. The president was working the phones from the Oval Office late Saturday night, according to a person familiar with the discussions who was not authorized to speak publicly and spoke on condition of anonymity.

Pressure was mounting from all sides billionaire Elon Musk criticised the package as "utterly insane and destructive."

The 940-page "One Big Beautiful Bill Act was released shortly before midnight Friday, and senators are expected to grind through all-night debate and amendments in the days ahead. If the Senate is able to pass it, the bill would go back to the House for a final round of votes before it could reach the White House. With the narrow Republican majorities in the House and Senate, leaders need almost every lawmaker on board. A new analysis from the nonpartisan Congressional

Senate Democratic leader Chuck Schumer of New York said Republicans unveiled the bill "in the dead of night" and are rushing to finish the bill before the public fully knows what's in it. He immediately forced a full reading of the text late Saturday in the Senate, which would take hours.

Make-or-break moment for GOP

The weekend session could be a make-orbreak moment for Trump's party, which has invested much of its political capital on his signature domestic policy plan. Trump is pushing Congress to wrap it up and has admonished the "grandstanders" among GOP

holdouts to fall in line. The legislation is an ambitious but complicated series of GOP priorities. At its core, it would make permanent many of the tax breaks from Trump's first term that would otherwise expire by year's end if Congress fails to act, resulting in a potential tax increase on Americans. The bill would add new breaks, including no taxes on tips, and commit USD350 billion to national security, in-

cluding for Trump's mass deportation agenda. But the cutbacks to Medicaid, food stamps and green energy investments, which a top Democrat, Sen Ron Wyden of Oregon said would be a "death sentence" for America's wind and solar industries, are also causing dissent within GOP ranks. The Republicans are relying on the reductions to offset the lost tax revenues but some lawmakers say the cuts go too far, particularly for people receiving health care through Medicaid. Meanwhile, conservatives, worried about the nation's debt, are pushing for steeper cuts.

#### Iran's judiciary says at least 71 killed in Israel's attack on Tehran's notorious Evin prison

**DUBAI, June 29:** At least 71 people were killed in Israel's attack on Tehran's Evin prison, a notorious facility where many political prisoners and dissidents have been held, Iran's judiciary said on Sunday.

Judiciary spokesperson Asghar Jahangir posted on the office's official Mizan news agency website that those killed on Monday included staff, soldiers, prisoners and members of visiting families. It was not possible to independently verify the claim.

The June 23 attack, the day before the ceasefire between Israel and Iran took hold, hit several prison buildings and prompted concerns from rights groups about the safety of the inmates.

Jahangir did not break down the casualty figures but said the attack had hit the prison's infirmary, engineering building, judicial affairs and visitation hall, where visiting family members were killed and

On the day of the attack, New Yorkbased Centre for Human Rights in Iran criticised Israel for striking the prison, seen as a symbol of the Iranian regime's



repression of any opposition, saying it violated the principle of distinction between civilian and military targets.

At the same time, the group said Iran was legally obligated to protect the prisoners held in Evin, and slammed authorities in Tehran for their "failure to evacuate, provide medical assistance or inform families" following the attack. Jahangir said some of those injured were treated on site, while others were

sent to hospitals. Iran had not previously announced any death figures, though on Saturday confirmed that top prosecutor Ali Ghanaatkar — whose prosecution of dissidents, including Nobel Peace Prize winner Narges Mohammadi, led to widespread criticism by human rights groups — had been killed in the attack. He was one of about 60 people for whom a massive public funeral procession was held on Saturday in Tehran, and he was to be buried at a shrine in Qom on Sunday

Israel attacked Iran on June 13 in a bid to destroy the country's nuclear program.

Over 12 days before a ceasefire was declared, Israel claimed it killed around 30 Iranian commanders and 11 nuclear scientists, while hitting eight nuclear-related facilities and more than 720 military infrastructure sites. More than 1,000 people were killed, including at least 417 civilians, according to the Washingtonbased Human Rights Activists group. In retaliation, Iran fired more than 550 ballistic missiles at Israel, most of which were intercepted, but those that got through caused damage in many areas and killed 28 people. (AP)

#### China's humanoid robots generate more soccer excitement than human counterparts and navigate the field with

BEIJING, June 29: While China's men's soccer team hasn't generated much excitement in recent years, humanoid robot teams have won over fans in Beijing based more on the AI technology involved than any athletic prowess shown.

Four teams of humanoid robots faced off in fully autonomous 3-on-3 soccer matches powered entirely by artificial intelligence on Saturday night in China's capital in what was touted as a first in China and a preview for the upcoming World Humanoid Robot Games, set to take place in Beijing.

According to the organisers, a key aspect of the match was that all the participating robots operated fully autonomously using AI-driven strategies without any human intervention or supervision. Equipped with advanced

visual sensors, the robots were able to identify the ball arrange for robots to play

They were also designed to stand up on their own after falling. However, during the match several still had to be carried off the field on stretchers by staff, adding to the realism of the experience.

China is stepping up efforts to develop AI-powered humanoid robots, using sports competitions like marathons. boxing, and football as a realworld proving ground.

Cheng Hao, founder and CEO of Booster Robotics, the company that supplied the robot players, said sports competitions offer the ideal testing ground for humanoid robots, helping to accelerate the development of both algorithms and integrated hardware-software systems. He also emphasised safety

as a core concern in the application of humanoid robots.

"In the future, we may



football with humans. That means we must ensure the robots are completely safe," Cheng said. "For example, a robot and a human could play a match where winning doesn't matter, but real offensive and defensive interactions take place. That would help audiences build trust and understand that robots are safe."

# 5.3 magnitude quake hits Pakistan; 5 people injured

KARACHI, June 29: At least five people were injured when a 5.3 magnitude earthquake shook Pakistan's Balochistan province on Sunday. The earthquake, with an epicentre near Barkan town, struck around 3.30 am local time, according to paramilitary Levies official Tauqeer Shah.

"We have reports of at least five people being injured including a couple whose house roof collapsed in the Rara Shaim area near Barkan," Shah said.

The United States Geological Survey put the epicentre of the quake around 60 kilometres from Barkan town.

Shah said the tremors were felt in many areas near Barkan including Rara Shaim, Kingri and Wastu. According to initial reports, around a dozen houses were damaged during the tremors while cracks appeared in many resi-

dences in the affected areas. Some media reports stated that the earthquake measured 5.5 on the Richter scale.

In 2021, an earthquake in the Harnai town of the province left 20 people dead and scores injured, while in October 2005, a 7.6 magnitude earthquake in the northern areas of Pakistan killed more than 73,000 people and left about 3.5 million people homeless. In June, Pakistan's largest city, Karachi also experienced around a dozen earthquake tremors between magnitudes 2.2 and 3.5, but no casualties or damage were reported. (PTI)

## Severe heat waves hit Southern Europe as local authorities warn against wildfire risks

waves across Southern Europe have pushed temperatures above 40 C (104 F) in countries including Italy, Spain and Greece, as local authorities issued fresh warnings against the risk of wildfires.

Experts link the rising frequency and intensity of these heatwaves to climate change, warning that such extreme weather events are becoming increasingly common across Europe's southern region.

Severe heat waves were recorded in Italy, Greece, Spain and Portugal before the weekend. with locals and tourists alike taking shelter from the sweltering

Two-thirds of Portugal were on high alert on Sunday for extreme heat and wildfires, with temperatures expected to top 42 C (107 F) in Lisbon

Tuscany, Calabria, Puglia and Umbria — were planning to ban some outdoor work activities during the hottest hours of the day in response to the record-high temperatures. Italian trade unions pushed the government to expand such measures at a national level.

On Sunday, the Italian Health Ministry placed 21 out of 27 monitored cities under its highest heat alert, including top holiday destinations like Rome, Milan and

In Rome, tourists tried to seek shade near popular spots like the Colosseum and the Trevi Fountain, using umbrellas and drinking from public water fountains to stay cool.

Similar scenes were reported in Milan and Naples, where street vendors sold lemonade to tourists and residents to offer some refresh-



ment from the heat. Greece was again on high wildfire alert because of extreme weather, with the first summer heat wave expected to continue

throughout the weekend. A large wildfire broke out south of Athens on Thursday, forcing

Greek authorities deployed 130 firefighters, 12 planes and 12 helicopters to battle the blaze, while police evacuated 40 people, with five areas under evacuation orders.

In Spain, locals and tourists were desperately trying to keep cool this weekend, as the country sizzled in temperatures as high as 42 C (107 F) in the southern city of Seville along with other locations in southern and central parts

of the country. Southern regions of Spain recorded temperatures above seasonal averages, prompting health alerts and safety recommendations from authorities. The country's national meteorological service Aemet has said that June is set to break yet another record, becomrecords started. Experts warned that intense heat

can affect daily life, especially for vulnerable populations such as the elderly and children. Local authorities advised against

physical activity during the hottest hours of the day, and recommended drinking plenty of fluids. A Lancet Public Health study

published last year highlighted the increasing risk of heat-related deaths because of climate change. The study predicted that heat-related deaths could more than quadruple by mid-century under current climate policies. While more people currently die from cold than heat, the study stressed that rising temperatures will offset the benefits of milder winters, leading to a significant net increase in heat-related mortality. #### INDIA bloc may knock door of judiciary against SIR: Digvijaya



PATNA, June 29: Senior Con gress leader Digvijaya Singh on Sunday said all constituents of INDIA bloc may knock the door of judiciary against the ongoing Special Intensive Revision (SIR) of electoral roll in Bihar if the Election Commission does not accept opposition parties objections about

Singh accused the NDA government at the Centre of trying to erase the names of poor and marginalised voters from the electoral rolls through SIR ahead of the assembly polls in the state.

"The SIR drive of the EC is a deliberate attempt to disenfranchise poor, tribal, young, flood-affected, and migrant voters in the upcoming Bihar Assembly elections. All constituents of INDIA bloc may knock the door of judiciary against the ongoing SIR of the electoral roll in Bihar if the EC does not accept the opposition's objections about the drive.

"I met RJD supremo Lalu Prasad ji here on Saturday and requested him to speak to our party president Mallikarjun Kharge over the issue," Singh told reporters

Is it possible to conduct houseto-house verification of around eight crore voters within 25 days by the ECI in Bihar, he asked.

"I once again repeat that the drive is an attempt to snatch the voting rights of people of Bihar in big numbers, especially poor, farmers, labourers, socially marginalised and oppressed classes by making them ineligible to vote. It will be a sheer injustice to the majority of the voters of Bihar. This will adversely affect BJP also," he

The SIR drive has been launched just a few months before the state polls, he said, adding, "The EC should have taken the opinion of all political parties before launching this drive."

Criticising the NDA government in the state, Singh said, "The state of education is in a very pathetic condition in Bihar. The NDA government has ruined the education system in Bihar...the state has the worst dropout rates in the country. A large number of government schools in the state are running without electricity, teachers, com puters, or libraries."

He alleged that around 2.637 government schools in the state operate with only one teacher, while 2.91 lakh students are enrolled in these schools and 117 schools have no students at all, yet 544 teachers are still posted there.

"Bihar has the lowest number of higher educational institutions per lakh population in the country. According to data provided by the authorities concerned, there are just 37 universities, 1.092 colleges, and 315 standalone institutes, totaling 1,387 institutions. That means the state has only seven colleges per lakh population, compared to the national average of 30 — the low-

#### Monsoon covers entire country

#### 2 dead in Uttarakhand cloudburst; IMD sounds red alert in several states

NEW DELHI/SHIMLA/UTTARKASHI, June 29: A cloudburst in Uttarakhand's Uttarkashi district early Sunday left two construction workers dead and seven missing as monsoon covered the entire country almost a week early than usual, bringing rain in national capital and other northern states and triggering landslides in several hilly areas.

The India Meteorological Department (IMD) has issued a red alert for heavy rainfall on June 29 and 30 in various districts of Uttarakhand, including Uttarkashi, Rudraprayag, Dehradun, Tehri, Pauri, Haridwar and Nainital. Authorities have put the Chardham yatra on hold for a day for the safety of pilgrims.

A similar red alert of heavy to very heavy rain has been issued for 12 districts in Himachal Pradesh, where rain-related incidents have claimed 17 lives since the onset of monsoon in the state on June 20.

In Uttarakhand, a landslide triggered by a cloudburst destroyed the shelters of workers engaged in the construction of a hotel along the Yamunotri National Highway in Uttarkashi district, officials said.

There were 29 labourers at the campsite when the landslide occurred washing away around 10 metres of the highway. Twenty of them were evacuated to safety while nine went missing, the district emergency oper-

from the banks of the Yamuna River near Tiladi Shaheed Smarak, about 18 km from the place where the landslide occurred, police said. The labourers are said to be of Nepalese origin.

NDRF, SDRF and police personnel are carrying out search and rescue operations at the site, District Magistrate Prashant Arya said. The highway is blocked by landslide debris, he said, adding pilgrims returning from Yamunotri have been asked to stay at safe locations due to the blocked highway, he said.

The Chardham Yatra has been postponed for a day as a precautionary step and a decision on further travel will be taken after reviewing the weather conditions along the routes on Monday, Garhwal Commissioner Vinay Shankar Pandey said.

In Himachal Pradesh, services on the Shimla-Kalka rail line -- a UNESCO world heritage -- were suspended on Sunday after boulders and trees fell on the tracks following overnight rains in Solan district. A bridge in Solan's Barotiwala industrial area was also washed away. A landslide near Koti on the Shimla-Kalka National Highway (NH-5), connecting Shimla and Chandigarh, damaged some stretches of the road, resulting in a two to three-km-long traffic iam for hours. ### 3 killed, 50 injured in stampede near Gundicha Temple in Odisha's Puri

PURI, June 29: At least three persons, including two women, were killed and around 50 others injured in a stampede near Shree Gundicha Temple in Odisha's Puri on Sunday morning, officials said.

The incident took place around 4 am when thousands of devotees gathered near the temple to witness Rath Yatra festivities, they said.

The injured have been admitted to a nearby hospital, and the condition of six people is stated to be critical. "Out of the 50 injured, six are still unconscious and their condition is very serious," an official of the medical facility, where they are undergoing treatment, said.

Chaos ensued after two trucks carrying materials for rituals reportedly entered the crowded spot near the chariots of Lord Jagannath and his sibling deities.

Devotees in large numbers had assembled outside the temple since the early hours to catch a glimpse of the deities when the 'Pahuda' (cloth) covering their faces was to be removed, as part of the rituals,

The deceased were identified as Basanti Sahu (36) from Bolagarh, and Premakant Mohanty (80) and Pravati Das (42) from Balipatna.

Their bodies have been handed over to family members, and the cremation will take place at 'Swargadwar' in Puri.

In a punitive measure following the stampede, Chief Minister Mohan Majhi ordered the transfer of District Collector Siddharth Shankar Swain and SP Vineet Agrawal. Majhi also announced the suspension of two police officers - DCP Bishnu Pati and Commandant Ajay Padhi - an official

He ordered an administrative inquiry into the matter to be carried out under the supervision of the development commissioner.

The Odisha government will provide financial assistance of Rs 25 lakh each to the next of kin of the deceased, the release added.

Another notification issued by the General Administration Department stated that senior bureaucrat Aravind Agarwal has been appointed as in-charge of the overall supervision of Rath Yatra.

Earlier in a post on X, Majhi sought forgiveness from devotees of Lord Jagannath for the stampede, and tendered an apology on behalf of his government for the ncident.

"Due to intense eagerness among devotees to have a glimpse of Mahaprabhu... an unfortunate incident occurred because of the resulting jostling and chaos. I and my government seek forgiveness from all Jagannath devotees. We express our condolences to the families of devotees who lost their lives... pray to Mahaprabhu Jagannath to grant them the strength to bear this profound sorrow," Majhi said. He also said that security lapses behind the incident would be probed and those found guilty will face stringent action.

Odisha Law Minister Prithviraj Harichandan said that the situation is now normal at the Shree Gundicha Temple, where devotees are offering prayers to the deities on chariots.

Puri's titular king, Gajapati Maharaja Divyasingha Deb, expressed shock over the incident, and appealed to the state government to carry out a comprehensive inquiry into the matter.

The titular king, who is also the chairman of the Shree Jagannath Temple Managing Committee (SJTMC), also urged the Odisha government to take proper and immediate steps to prevent the recurrence of any such incident.

Health department sources said among those critically injured, one has been shifted to the SCB Medical College and Hospital in Cuttack, while five others are in ICU.

A host of political leaders, including Congress president Mallikarjun Kharge, Rahul Gandhi and BJD chief Naveen Patnaik condoled the deaths, with many criticising the state government over arrangements for the Rath Yatra. (PTI)

## EC to soon upload 2003 Bihar voters list on website; 4.96 crore electors need not give documents

NEW DELHI, June 29: The Election Commission will soon upload the 2003 Bihar electoral roll on its website to facilitate the nearly 4.96 crore voters whose names figure on it extract the relevant portion to be attached with the enumeration form for the special intensive revision of the voters'

According to the instructions issued by the poll authority to its Bihar poll machinery, the 4.96 crore voters -- 60 per cent of the total electors -- who were listed in the 2003 special intensive revision need not submit any supporting document to establish their date or place or birth except the relevant portion of the electoral roll brought out after the revision

The other three crore -- nearly 40 per cent -- will have to provide one of the 11 listed documents to establish their place or date of

"The basic exercise is to identify each and every individual of the remaining three crore voters before their names are included in the list," a functionary explained. The special intensive revision

will ensure that no eligible elector

is left out of the electoral rolls and

no ineligible one is part of it, Chief

Election Commissioner Gyanesh Kumar told PTI on Sunday.

Bihar, as of now, has more than 7.89 crore voters spread across 243 assembly seats. Polls in the state are due later this year

According to EC instructions, the electoral registration officer (ERO) of each assembly constituency will be responsible for ensuring that "no eligible citizen is left out and no ineligible person is included in the electoral roll" while carrying out the revision.

The EROs will satisfy themselves regarding the eligibility of every person before entering their name in the electoral roll. The EC said every existing elector, as on the date, will be provided

available an enumeration form through a booth level officer (BLO). The elector can download the enumeration form from a dedicated website. The BLO will collect a copy of the enumeration form and sign the acknowledgement of receipt on the

As part of the intense revision, poll officials will carry out houseto-house verification to ensure an error-free voters' list.

The terms of the legislative assemblies of Assam, Kerala, Puducherry, Tamil Nadu and West Bengal are ending in May-June next year, and an intensive revision of the electoral rolls in these states will commence by the end of the year, officials said.

However, since assembly polls in Bihar are due later this year, the EC decided to conduct the revision

Amid allegations by opposition parties that the EC has fudged voter data to help the BJP, the poll panel has taken additional steps in the intensive revision to ensure illegal migrants do not get enrolled in the voters' list.

An additional 'declaration form' has been introduced for a category of applicants seeking to become electors or shifting from outside the state. They will have to undertake that they were born in India before July 1, 1987, and provide any document establishing the date of birth and/or place of birth.

One of the options listed in the declaration form is that they were born in India between July 1, 1987, and December 2, 2004.

They will also have to submit documents about the date and place of birth of their parents.

The last intensive revision for Bihar was conducted in 2003. The EC said multiple reasons,

such as rapid urbanisation, frequent migration, young citizens becoming eligible to vote, non-reporting of deaths and inclusion of the names of foreign illegal immigrants have necessitated the conduct of the exercise to ensure integrity and preparation of errorfree electoral rolls. (PTI)

# Manipur sees drop in violence, rise in drug seizures under President's rule: Officials

IMPHAL, June 29: Manipur has witnessed a significant decline in violence, with a sharp drop in civilian deaths and injuries and a marked increase in drug seizures since the imposition of President's rule in February, officials said here on Sunday.

Besides, Manipur Police, Assam Rifles and other paramilitary forces are also working tirelessly to recover thousands of weapons looted from police armouries following the outbreak of violence in May 2023, they said.

Despite the relative calm, challenges remain for the security forces to recover thousands of lost arms and addressing the activities of the banned valley-based terrorist groups involved in extortion and petty crimes, they added.

The recent crackdown on cadres of Meitei outfit Arambai Tenggol, accused of allegedly engineering violence against the Kuki people and indulging in largescale violence within the valley, has also been helpful in bringing a sense of peace in certain parts of the state, officials said

Recently, a dismissed police head con-

stable of Manipur Police and a prominent Arambai Tenggol leader Asem Kanan Singh and four associates were arrested in a joint operation of Manipur Police and the

Singh was wanted for many cases including an alleged attack on Additional Superintendent of Manipur police last

After the arrest of Singh, the outfit announced distancing itself from any violent activities being done on the streets in its

During the period of central rule beginning February 13, only one protest-related fatality has been reported, a stark contrast to the 260 fatalities documented from May 3, 2023, until the enforcement of President's rule, they said.

Injuries have also seen a significant drop, with just 29 new cases reported in the last four months compared to a total of ,776 since May 2023.

From February 13 to June 26, the region saw no incidents of arson or vandalism. while cumulative incidents of such nature crossed 17,000 before the imposition of



In the fight against drug abuse, Manipur Police, Assam Rifles and paramilitary forces have stepped up their operations, resulting in the arrest of 84 people under the Narcotic Drugs and Psychotropic Substances (NDPS) Act during the central rule

The security forces have seized 24.4 kg

of heroin, 25.7 kg of brown sugar, 31.8 kg of opium, and over 379 kg of 'Ganja', contributing to a stabilisation of the drug issue in the region, officials said.

However, the issue of unrecovered firearms continues to pose a significant challenge for the security agencies.

Since the imposition of central rule, no new arms have been reported lost from pofirearms lost, many are understood to have been recovered or surrendered

In the last four months alone, 2,390 weapons were seized out of which many were looted weapons.

Moreover, security forces have recently demolished 63 illegal bunkers, adding to the total of 548 that had been dismantled since May 2023.

While arrests related to extortion continue, with 336 people apprehended in the last four months out of a total of 601, experts are voicing concerns over the resurgence of banned terror groups, including the United National Liberation Front (UNLF), People's Liberation Army (PLA), Kanglei Yawol Kanba Lup (KYKL), and People's Revolutionary Party of Kangleipak (PREPAK).

Officials alleged that these groups are running extortion rackets besides indulging in out of court settlements in cases related to matrimonial and property disputes. Manipur Police recently cracked down on such a gang and arrested some people, they added. (PTI)

#### Three Manipur civil groups head to Delhi for crucial third round of talks with MHA

Delegation to press for displaced persons' return, border security, and peace roadmap

IMPHAL, June 29: Three key civil society organisations from Manipur have left Imphal for New Delhi today for a third round of talks with officials from the Ministry of Home Affairs (MHA), hoping to find a breakthrough in the ongoing conflict in Manipur that has gripped the state since May

A joint delegation of 19 members, including seven representatives from the Coordinating Committee on Manipur Integrity (COCOMI), seven from All Manipur United Clubs' Organisation (AMUCO) and five from Federation of Civil Society Organisations (FOCS) will participate in the meeting scheduled for June 30.

The violence between the Meitei and Kuki communities that began on May 3, 2023 has resulted in the deaths of around 250 people and displaced more than 60,000.

In response, civil society groups have been engaging with the central government in a series of talks, though previous meetings have yet to produce concrete results.

The first round of discussions was held on April 5 in New Delhi, where representatives from the Meitei and Kuki-Zo communities met MHA officials separately.

AMUCO and FOCS represented the Meitei side, while the Kuki-Zo delegation included members from Manipur, Zomi Council, United Zou Organisation, and Hmar Inpi.



The second round of talks took place on May 27, attended by CO-COMI and FOCS. AMUCO did not participate in that meeting, and it concluded without any resolu-

On Saturday, the three Meitei civil groups had held a joint meeting in Imphal and agreed to attend the third round together.

Speaking to the media at the Manipur Press Club, COCOMI convenor Khuraijam Athouba said the delegation would focus on key issues such as the return of internally displaced persons to their original homes, ensuring proper security for farmers in sensitive border areas, and restoring free the Kuki-Zo Council, Kuki Inpi movement along all major highways in the state.

NEW DELHI, June 29: Bollywood actor Varun Dhawan slammed the insensitive media coverage following the death of Shefali Jariwala.


Dhawan penned a note on his Instagram handle on Sunday, questioning the need for covering 'someone's grief". The 38-yearold actor didn't specify any name in the post.

### Sinner won't say why he fired two team members right before Wimbledon

LONDON, June 29: Jannik Sinner confirmed that he recently fired two members of his team fitness coach Marco Panichi and physiotherapist Ulises Badio, who themselves were replacements for people involved in the player's doping case — but declined Saturday to explain the reason for the change ahead of Wimbledon. Sinner, who has been ranked

No. 1 for more than a year, said that he decided shortly after losing in the second round of the grasscourt tournament in Halle, Germany, this month to make the change. Sinner has not yet found substitutes for Panichi and Badio, who both used to work with Novak Djokovic. "Nothing seriously bad happened. They did great work for (the past) three months. Sometimes, things happen," Sinner said at his pre-tournament news conference. "The timing obviously isn't the best, but having done a lot of work (together) before, it won't affect this Grand Slam a lot. I feel well physically and mentally and ready to compete.'

Play begins Monday at the All England Club, where Sinner was a quarterfinalist in 2024. He will play Luca Nardi in an all-Italian matchup on Tuesday. Last year, Sinner tested positive twice for a trace amount of an anabolic steroid in March; the case wasn't made public until August, shortly before the U.S. Open, which he ended up winning for the second of his three Grand Slam titles. He initially was completely cleared, based on the defense that he accidentally was exposed to the banned substance, Clostebol, via a massage from his then-physiotherapist, Giacomo Naldi. (AP)

#### Saudi Arabia has never beaten yellow cards after the two ex-Mexico in international play, with Coco Gauff says criticism of Aryna Sabalenka's French Open comments went 'too far'

LONDON, June 29: It didn't take long for Coco Gauff and Aryna Sabalenka to patch up their relationship after this month's French Open final.

Now as Wimbledon is about to start, Gauff is hoping everyone else can also forget what the topranked Sabalenka said in the wake of her loss to the American at Roland-Garros.

A day after dancing together on Wimbledon's Centre Court in a TikTok video, the two tennis players faced more questions on Saturday about the aftermath of Sabalenka's comments right after the final, when she said her loss had more to do with her own mistakes than Gauff's performance.

The Belarusian later wrote to apologize to Gauff and said her but not before she faced some major backlash from fans and pundits — especially in the United States.

Gauff is trying to make sure the criticism stops.

"I'm not the person that will fuel hate in the world," said Gauff, who opens her Wimbledon campaign against Dayana Yastremska on Tuesday. "I think people were taking it too far. ... It was just really targeting and saying a lot of things that I felt were not nice. I didn't want to fuel that

Sabalenka, who faces Carson Branstine on No. 1 Court on Monday, said she hopes the Tik-Tok video shows that all is well

"We are good, we are friends," the three-time major winner said. "I hope the U.S. media can be easy on me right now."

Sabalenka reiterated that she never meant to offend Gauff. "I was just completely upset

with myself, and emotions got over me," she said. "I just completely lost it.' Gauff did acknowledge that she

was initially tempted to hit back publicly at Sabalenka, who said the American "won the match not because she played incredible; just because I made all of those mistakes from ... easy balls."

Gauff also said she was slightly surprised that it took a while for Sabalenka to reach out to apologize. But once that happened, the American was quick to bury any other." (AP)

# A ton in T20Is is pretty special because it's not one of my natural formats: Mandhana

NOTTINGHAM, June 29: Smashing a maiden T20I century against England was "pretty special" as the shortest format is "not one of my strengths", said India stand-in skipper Šmriti Mandhana after powering her side to a 97run victory in the opening match here. Mandhana struck her first T20I ton in her 149th game, a 62ball 112 studded with 15 fours and three sixes, to help the visitors to 210 runs before dismissing

the hosts for 113 in 14.5 overs. "It's a nice feeling because this format is something which, for me as a batter, I need to keep pushing and keep improving. It's not a very natural format for me," Mandhana said during the postmatch press conference on Saturday. "I like to time the ball; (I'm) not a big hitter of the ball and, for the last six years, it's always (been) a work in progress and it's still a work in progress.

"So, to actually get a hundred in this format, getting it before in Test cricket and one-day cricket which are more suited to my batting, but getting it in this format is pretty special because it's not one of my strengths," she said.

Mandhana added that she had been working on her power hitting. "The improvement... and I'm trying to work a lot on my power hitting and to see that come through, which is a really nice feeling," she said.

The left-handed opener, who had topped the batting charts last year with 763 runs in 23 T20Is, including eight fifties, said her celebration after scoring the ton was directed at teammate Radha

"That's actually a funny story. I think three days back, me and Radha Yadav were having a conversation that, (and) you know all these girls are really hard on me sometimes, they keep telling me (and) she was telling me that it's high time you get a century in T20s," Mandhana said.

"You keep getting out in 70s, 80s and you're not doing justice to your talent' and all of that stuff. I was like, 'okay Radha, I will see now'. This time, I'll try and get (it) in one of the matches in the

"I did not think that it would come in the first match. The finger was towards her that 'see, I got it today'. It's pretty frustrating to get out in the 70s and 80s over the last 10 years," she added.

Mandhana heaped praise on India bowlers, especially 20-yearold debutant Shree Charani, who bagged four wickets.

The way the bowlers bowled and executed the plans was just amazing. That makes our job very, very easy when they bowl like that," Mandhana said.

"They all were really focused. They knew their plans, especially (for) Shree to come in the first match and bowl (like that)... we saw what she could do in WPL a little bit. She was always looking really like a good bowler. But today, the way she actually bowled was amazing," Mandhana said. "(For) all the bowlers, the plans were pretty clear. Even when we were inside and there were a few wickets fell and Nat (Sciver-Brunt) was on one end. The plan was pretty clear to try and execute your best ball to Nat and give a single to her, which they did brilliantly throughout."

Mandhana said a big knock from opener Shafali Verma was also round the corner.

"I've seen Shafali bat last 7-8 days amazingly well in the nets, so I don't see a big knock too far because the way she's been hitting the ball." (PTI)



## India is too much dependent on Bumrah, should play Kuldeep: Azharuddin



HYDERABAD, June 29: Former captain Mohammad Azharuddin said India should play left-arm wrist spinner Kuldeep Yadav in the Edgbaston Test against England to add more experience to their bowling attack and reduce the burden on pace talisman Jasprit

Across the first Test at Leeds, which India lost by five wickets, the visitors were relying heavily on Bumrah for wickets and cutting the flow of runs.

"They are too much dependent on Bumrah. It's not easy because you need more experienced bowlers, and they should play Kuldeep Yadav,"

India will face England in the second Test at Birmingham from July 2, and the pitch, which is expected to be dry, could offer

some assistance to Kuldeep. India made a good first innings total of 471 with skipper Shubman Gill, Yashasvi Jaiswal and

Rishabh Pant making hundreds. They had a reasonable second innings total of 364 with KL Rahul and Pant scoring centuries, but middle and late order collapse in both digs meant that the visitors could not raise stronger totals or a target.

Azharuddin called for keeping the team combination right to take the team out of the Leeds

"We lost because of batting collapse, but anyways now they have to pick the right players and bowling has to be perfect," he

The 62-year-old defended new Test captain Gill, saying he should be given enough time to prove his mettle.

"This is his just first match as a captain, you just can't talk about captaincy. It's too early to talk about captaincy," he re-

"We should give him a fair chance and he has just taken over. So, you should give him a lot of time and support. We cannot just complain and criticise players like that," said Azharuddin, who led India to 14 wins in 47 Tests as captain. (PTI)

# T20 World Cup Triumph: Rohit recalls emotional build-up to final, Surya's catch, and Kohli's knock

NEW DELHI, June 29: Revisiting India's T20 World Cup triumph under his captaincy, Rohit Sharma has revealed he was a bundle of nerves, didn't sleep the whole night, and "couldn't feel my legs" before the big final against South Africa.

Sunday marked the first anniversary of the memorable win in Barbados that broke 13 years of World Cup title drought for India.

"Thirteen years is a long time. Most people don't even have a 13-year career. So, to wait that long to win a World Cup... the last one I won was in 2007. For me, it couldn't have gotten any bigger than this. I didn't sleep the whole night. I was only thinking about the World Cup. I was nervous. I couldn't feel my legs," Rohit reminisced while speaking to JioHotstar.

"Did I feel nerves? Of course. I just don't show it — but inside, it was a lot. We were supposed to leave around 8:30 or 9 in the morning. But I woke up at 7. From my room, I could see the ground and just kept watching it.

"I remember thinking — 'In two hours, I'll be there. And in four hours, the result will be out. Either the Cup will be here or it

The skipper described the nimble-footed Suryakumar Yadav's catch to dismiss David Miller in the last over as the defining moment of the final

"Even after (the catch), the umpires sent it up to the third umpire and it was being checked whether Surya caught the ball or not, and everyone's hearts were in their

"I thought it was gone, and it was a six because I was on the long off. I was standing right opposite Surya," Rohit said of the thrilling game.

Suryakumar showed great presence of mind to pull off a stunning catch at long-off to dismiss the dangerous looking Miller, which eventually sealed a seven-run win for

Detailing the catch, the then India captain



added, "I saw this and thought 'Oh shit', (they now need) 10 (runs) off five balls. But then I saw that the ball is coming into Surva's hands.

"It would have taken a blinder to take that catch. It would have taken a lot of effort to take that catch because when it was in the air it looked like it would cross the rope easily. Maybe the wind pulled the ball a bit into the

"I was standing with Surya. When the umpires were checking the catch and I said 'Surya, tell me. You tell me. I don't want to look there (at big screen). And he said I have

"Surya is honestly one of the safest catchers in the team — without a doubt. I haven't seen him drop many catches. He's got incredibly safe hands.

South Africa needed 16 in the last over

lift India to 176 for seven. "Not many people are talking about (Axar's) knock, but that knock was a gamechanger. To get 47 off 31 in that time was

very, very crucial. "And then we needed one guy to stick around and Virat did that job perfectly. Batted throughout the entire innings, which was good. Because then Shivam, Axar, Hardik -- they can come in and play their role," Rohit

Kohli, who had until then struggled to get going, fired when it mattered -- the big final and was the Player of the Match.

"You know, the experience of playing for India for so long, being there, it really helps. You can control your emotions, you can control your thoughts and be in the

#### Wanted to finish Test quickly as Bumrah could have been brought in with second new ball: Smith

LONDON, June 29: England batters' decision to go after Ravindra Jadeja in the 82nd over and complete the task of winning the first Test in a hurry was borne out of the thinking that India could bring in their strike bowler Jasprit Bumrah in a desperate attempt to take some late wickets.

With Joe Root and keeper-batter Jamie Smith batting comfortably and the winning target of 371 within sniffing distance, the latter finished off the contest by smashing Jadeia for two sixes and a boundary to guide the hosts to a memorable five-wicket win.

"The runs at that point (when Smith decided to go after Jadeja) were not too many, so I wasn't expecting him (Bumrah) to come on and bowl (with the new ball), but you're just never quite sure, especially in cricket," Smith was quoted as saying by ESPNCricinfo.

England's thinking was that had Shubman Gill pressed Bumrah into service when the hosts were 355/5 after the 81st over and the Indian quick had struck a couple of blows,

things could have become slightly difficult for Ben Stokes' side.

"You don't know what will happen. I always back our tail but there could be a couple of decent balls and suddenly you're eight-down and the pressure's back on you again. It was nice to just get it done and move on.'

"I knew there was a new ball coming and it looks as though I'd exposed Chris Woakes (at No. 8) but, at that point, if I'd hit another couple of sixes in that over, you're taking all the momentum into the new ball," said Smith.

He added, "The second new ball can bring wickets but it can increase the scoring rate as well. There's always a little bit of calculated thinking behind it."

Smith said India "kept trying all day" on the final day but England's philosophy of keeping it simple in good batting conditions helped the hosts get over the line.

Chasing 371, England won in the final hour with Ben Duckett (149), Zak Crawley (65), Root (53 not out) and Smith (44 not out) delivering throughout the five days." (PTI)

"It was simple in that you knew you had to chase the runs and we weren't going to block out for the draw," Smith said.

"We were always going to be positive and try to get the runs. It was a rapid outfield and as good a batting conditions as you could have on day five."

"It (wicket) wasn't misbehaving too much as the Test went on, so you always felt as though you could keep it simple, you didn't have to do things too out the box to get the runs which is very help-

Smith said he did not read much into the talk about the inexperience in the Indian side.

"When they're trying to get 10 wickets and you're chasing 370, it's not everyday that gets done. There could have been some head-downs at the end but they kept trying all day," he said.
"I see a lot of chat about maybe

some inexperience on their part but I thought they were fantastic

# Pant's first question to his surgeon after accident: Am I ever going to be able to play again?

LONDON, June 29: When India wicketkeeper-batter Rishabh Pant was brought into a hospital in Mumbai following grievous injuries suffered in a car crash in December 2022, the first question he asked the attending doctor was "will I be able to play again?" recalled renowned orthopaedic surgeon, Dr Dinshaw Pardiwala, who treated the superstar cricketer following the horrific incident. Pant, while driving from Delhi to his hometown, Roorkee, on December 30, 2022 lost control of his car which crashed into a divider and caused him severe injuries.

He was pulled out of the mangled mass, and Pardiwala said, "Rishabh Pant was extremely lucky to be alive - extremely lucky."

"When he first came in, he had a dislocated right knee. He also had an injury to his right ankle, lots of other minor injuries all over. He had a lot of skin loss, so his entire skin from the nape of the neck down to his knees was completely scraped off in the process of that accident," Pardiwala told The Telegraph, recalling the brutal impact of the crash on Pant's body.

"Then getting out of the car - that broken glass scraped off a lot of the skin and the flesh from his

The fighter in Pant endured 635 days of recovery, rehabilitation, multiple surgeries and extensive physiotherapy to make a triumphant return to professional cricket, a fight-back which has become one of the most heartwarming stories in sports.

"To be in an accident like this, where the car actually overturns and blows up, the risk of death is extremely high," said Pardiwala, days after seeing his patient in full flow, smashing the ball effortlessly and playing audacious strokes on way to scoring back-toback centuries in the opening Test against England at Headingley. Pardiwala said that Pant was extremely lucky to not lose blood supply in his right leg given the severity of the injuries, as it could have led to serious complications including amputation.

"When your knee dislocates, and all the ligaments break, there's a high possibility of the nerve or the



main blood vessel also being injured. If the blood vessel gets injured, you typically have about four to six

hours to restore the blood supply "Otherwise, there's a risk of losing your limb. The fact that his blood vessel wasn't injured despite having a severe high-velocity knee dislocation was extremely lucky," said Pardiwala.

Pardiwala recalled the day Pant was brought into his hospital in Mumbai, his first question was, "Am I ever going to be able to play again?"

His mother, though, was more practical, asking the surgeon: "Is he ever going to be able to walk again?" Pardiwala said the injuries were so bad that Pant needed a complete reconstruction of his knee.

"We had a lengthy discussion about the fact that these are grievous injuries - we would need to reconstruct the entire knee. Once we reconstruct the entire knee, we're going to have to then work through a whole process of letting it heal, letting it recover, then get back the basic functions – the range, the strength and the stability.

The orthopaedic surgeon performed a four-hour

surgery on January 6, 2023 on Pant's right knee, reconstructing three ligaments and repairing tendons and meniscus. Pardiwala recalled that for several weeks after the surgery, the young cricketer couldn't

"He lost a lot of skin, and so he couldn't really move his hands. They were completely swollen. He couldn't really move either of his hands initially." Gradually he started to drink water without assis-

tance and then managed to walk without crutches after

four months. But the surgeon was sceptical about Pant being able to play cricket professionally again. 'Typically, when we reconstruct these patients they are happy just to get back to normal life. If they can

walk and do some minimal amount of recreational

sports, they're happy.' "I said: 'We can certainly make sure that he walks again. I'm going to try my best to make sure that we can get him back to playing again.' We didn't really want to offer him too much initially, but we did want to give him hope. So I said: 'We'll break it down into

steps.' Step one, of course, has to be the surgery. "When we discussed it just after the surgery, the way I told him is the fact you're alive, the fact that your limbs survived - that's two miracles down. If we get you back to competitive cricket, that's going to be a third miracle. Let's just hope for everything, and then take it a step at a time.'

But Pant was determined to get back onto the field and started setting timelines for himself.

"His question then was: 'OK, assuming that we do manage to get there, how long is it going to be?' I said: 'Probably looking at 18 months to get back to competitive cricket." He moved to National Cricket Academy in Bangalore and remained there for most of 2023.

"His whole aim was 'Get me back to normalcy as fast as possible'. And we were trying to make sure that we were doing just the optimum, not too little, but not too much. His recovery was much faster than we had anticipated. He was like: 'Nothing is too much.' He pushed harder than normal people." (PTI)
