DIBRUGARH, June 15: Chief Minister Himanta Biswa Sarma on Sunday defended the shoot-at-sight order issued in Dhubri, claiming that a "huge conspiracy" has been going on against the state since independence and it will take time to eliminate such ploys.

Opposition parties, including the Congress, have criticised the government for issuing the order to control communal tension in

Speaking to reporters after an official function, Sarma said police have arrested the person accused of writing objectionable content on walls in Dhubri town, and that interrogation is currently underway.

"We have already taken action. Assam is a critical state. People won't stop indulging in anti-national activities just because I issued a warning. This is part of a larger conspiracy that has roots

Five nabbed for throwing beef near temple: CM

GUWAHATI, June 15: Five people have been arrested in Assam's Goalpara district for allegedly throwing beef near a temple during the recent Eid festival, Chief Minister Himanta Biswa Sarma said on Sunday.

"Lakhipur Police of Goalpara district has arrested the... individuals for allegedly throwing beef near a temple in a deliberate attempt to incite communal tension post Eid-ul-Zuha," Sarma said in a post on X. Ahmedabad plane crash

Rupani's mortal remains identified, probe gathers pace



AHMEDABAD, June 15: The mortal remains of former Gujarat chief minister Vijay Rupani have been identified through DNA test, officials said on Sunday, as investigations into the June 12 Air India plane crash in Ahmedabad intensified. Various central and state government agencies, led by the Aircraft Accident Investigation Bureau (AAIB), were at the crash site here for a probe into the causes of the country's worst air disaster in three decades.

So far, 32 victims have been identified and the mortal remains of 14 handed over to the relatives, additional civil superintendent Dr Rajnish Patel told reporters, as the process to identify the deceased through DNA tests gained pace three days after the tragedy.

Rupani was among the 241 passengers killed in the horrific crash. One out of the 242 persons on board miraculously survived.

"The DNA sample of former Gujarat chief minister Vijay Rupani matched (with that of his family members) today morning at gar area of Ahmedabad and going

Chopper crashes near Kedarnath, all seven on board killed

11.10 am," Gujarat Minister of State for Home Harsh Sanghavi told reporters in Gandhinagar.

Chief Minister Bhupendra Patel met the family members of Rupani and informed them about the DNA match, state Health Minister Rushikesh Patel said. "Thirty two DNA samples have matched till now, and 14 bodies have already been handed over to the respective families. These deceased were from Udaipur, Vadodara, Kheda, Mehsana, Ahmedabad and Botad districts," said Rajnish Patel, professor of surgery at the government-run B J Medical College. All but one of the 242 passengers and crew on board the Boeing 787-8(AI171) and another 29 persons, including five MBBS students, on the ground were killed in the plane crash on Thursday.

The London-bound aircraft came down moments after taking off from the Sardar Vallabhbhai Patel International Airport before falling inside the nearby campus of the medical college in Meghaninaleading the investigations and they are here for the last three days, a senior state police official said.

Various central agencies and the state police are assisting in the probe into the horrific tragedy.

Ahmedabad Municipal Corporation (AMC) Commissioner Banchha Nidhi Pani said the black box recovery was a very important part of the investigation process.

"When the investigation started, the black box had to be recovered. The black box is either in the front or in the back. In this case, the tail end was not destroyed and it was stuck in the first building (of BJ Medical College hostel)," the official said. "The AAIB requested us that cranes, labourers and engineers be provided. The AMC immediately acted and the black box was also recovered," Pani said.

City Police Commissioner G S Malik also reached the accident site on Sunday morning.

"Around 270 bodies have been brought to the Ahmedabad Civil Hospital so far from the plane crash site," BJ Medical College's junior doctors association president, Dr Dhaval Gameti, told PTI.

The central government on Saturday set up a high-level multi-disciplinary panel to ascertain the "root cause" of the plane crash and assess any contributing factors, including mechanical failure, human error and regulatory compliances.

The panel, headed by Union Home Secretary Govind Mohan, was mandated to give its report in three months. As many as 230 teams were formed to coordinate with the victims' families, officials earlier said. (PTI)

RUDRAPRAYAG (UTTARAK-HAND), June 15: A helicopter carrying pilgrims from the Kedarnath shrine crashed early Sunday in the forests of Gaurikund amid poor visibility, killing all seven people on board, the fifth helicopter accident on the Chardham Yatra route since the pilgrimage started on April 30.

The Civil Aviation Ministry suspended the operations of the helicopter operator and issued a slew of safety directions after the tragedy, which came just days after one of the deadliest air disasters where an Air India flight to London crashed in Ahmedabad just after take-off, killing 241 people on board and several others on the

The seven people on board the Bell 407 helicopter, operated by private firm Arvan Aviation Pvt

Ltd, included a two-year-old child and the pilot. They hailed from Maharashtra, Rajasthan, Uttarakhand and Uttar Pradesh.

The Civil Aviation Ministry said it has suspended the operations of Arvan Aviation for the Char Dham Yatra and has directed the Directorate General of Civil Aviation (DGCA) to immediately post officers from airworthiness, safety and operations to actively oversee all helicopter activity in the Kedarnath Valley.

Preliminary indications suggest that the probable cause may be Controlled Flight into Terrain (CFIT), with the helicopter reportedly airborne despite poor visibility and extensive clouding at the valley entry area, the ministry said in a statement.

The exact cause will be determined through a detailed investiga-

tion by the Aircraft Accident Investigation Bureau (AAIB), it added. CFIT occurs when an airworthy aircraft under the complete control of the pilot is inadvertently flown into terrain, water or an obstacle.

Uttarakhand Chief Minister Pushkar Singh Dhami also ordered a high-level inquiry and suspension of helicopter operations on the Chardham Yatra route for two days. Rudraprayag District Disaster Management Officer Nandan Singh Rajwar told PTI that zero visibility caused by bad weather apparently led the helicopter to crash between Gaurikund and Trijuginarayan in Kedarghati and catch fire.

"There were five passengers, one infant and one crew member on board. The helicopter took off from Guptakashi at 05:10 hrs and landed at Shri Kedarnath ji Helipad at 05:18 hrs. The helicopter took off again at 05:19 hrs for Guptkanshi and crashed near Gaurikund,' an official statement said

Among the victims was a member of the Badrinath-Kedarnath Temple Committee Vikram Singh Rawat. Rajveer Singh Chauhan, the pilot of the helicopter, had served in the Indian Army for over 15 years and had vast experience of flying missions over different terrains. A resident of Shastri Nagar in Jaipur, Chauhan had been working as a pilot with Aryan Aviation Private (CONTD. ON PAGE-2)

Gas leak continues at **ONGC** well after three days of blowout. 70 families shifted

SIVASAGAR, June 15: Leakage of gas continued for the fourth day at a well of energy major ONGC in Assam's Sivasagar district, where 70 families have been shifted to a relief camp, officials said on Sunday.

A team led by ONGC Director (Technology & Field Services) Vikram Saxena on Saturday took over the operational control of Well No RDS 147, where the blowout took place, they said. "The well killing process is going on, and we have mobilised all necessary equipment for the same. The Crisis Management Team (CMT) is working on war-footing to control the leakage," an official told PTI.

The well has not caught fire yet, and no one is injured in the incident, he said. The blowout took place on June 12 at Well No RDS 147A of Rig No SKP 135 of Rudrasagar oil field of ONGC at Barichuk in Bhatiapar. A private firm, SK Petro Services, was operating the well on behalf of the state-run 'Maharatna' company.

A senior official of the district administration said that around 1,500 people have been affected by the incident. (CONTD. ON PAGE-2)

'Out-of-school model estimates assume stable patterns of school-age population progression through the education system'

Over 272 million children out-of-school across the globe: GEM report

NEW DELHI, June 15: The global out-of-school population is now estimated to be 272 million, over 21 million more than the last estimate, according to UNESCO's Global Education Monitoring Team (GEM).

The team, in its latest report, has pointed out that by 2025, countries will be off-track by 75 million relative to their national targets.

"Two reasons explain this upward adjustment. First, new enrolment and attendance data account for eight million, or 38 pc, of the increase. The ban on girls attending secondary school age in Afghanistan in 2021 also contributes to this increase," the report said.

"Second, updated UN population estimates account for 13 million, or the remaining 62 pc, of the increase. Compared to the esti-



mates last used in the out-of-school model, the 2024 World Population Prospects estimate that the number of 6- to 17-year-olds in 2025 (a proxy of the school-age population) is higher by 49 million (or by

3.1 pc)," it added.

The report also noted that the impact of conflicts on out-ofschool populations which can be underestimated as conflicts hamper data collection.

lation estimates impacts out-ofschool rate and population estimates, but the magnitude of that impact depends on the source of data on enrolment and attendance. "If the source is administrative data, then the full increase of the population is passed on to the out-of-school population because there is no fresh information on enrolment. "But if the source is survey data.

then the increase of population is passed on to the in-school and outof-school populations proportionately. As the model relies on survey data for many countries with large out-of-school populations, only part of the increased school-age population is estimated to be out of school," it said. Adani's Haifa port unaffected by Iranian missile strikes, operations normal: Sources

billionaire Gautam Adani-led group's Haifa port in Israel was unharmed by the Iranian ballistic missile attack, with cargo operations progressing unhampered, sources said.

Late on Saturday night, Iran targeted Israel's Haifa port and a nearby oil refinery in response to Tel Avi's attack on Iranian nuclear and other targets earlier this week.

Sharpnels fell in the chemical terminal at the port and some other projectiles fell at the oil refinery, two sources aware of the matter said. They claimed there were no

Adani's port, however, was not impacted by the strike.

A piece of interceptor shrapnel was also found at the Kishan West (Haifa port) but there were no iniuries, they said

Cargo operations at the Adanioperated port were unhampered. 'There are eight ships in the port now, cargo operations are normal," a source said

DLF to invest ₹ 5500cr to build new luxury housing project in Gurugram

New Delhi, June 15: Realty major DLF Ltd will invest around ₹ 5,500 crore to develop a luxury housing project in Gurugram, as it seeks to achieve record sales bookings this fiscal on high demand.

According to sources, the company will soon launch an 18-acre project 'DLF Privana North' in Sector 76/77 Gurugram, comprising more than 1,150 apartments.

The estimated cost to develop this project is around ₹ 5,500 crore, they added. This upcoming project is part of its 116-acre township 'DLF Privana'. In this township, the company had last year launched and completely sold out two projects -- 'DLF Privana West' and 'DLF Privana South' -- for

around ₹ 12.800 crore. In May 2024, DLF sold all 795 apartments for ₹ 5,590 crore within three days of the launch of its 12.57-acre project 'Privana West'.

Before that, in January 2024, the company had sold 1,113 luxury apartments in Gurugram for ₹ 7,200 crore within three days of the launch of its project 'DLF Privana South', which is spread over 25acre. The new project will be the third one in this large township.

DLF, the country's largest real estate firm in terms of market capitalisation, reported record sales bookings of ₹ 21,223 crore in 2024-25, an increase of 44 per cent from ₹ 14,778 crore in the preceding financial year.

DLF's MD Ashok Tyagi recently gave sales bookings guidance for the current fiscal at ₹ 20,000-22,000 crore, almost in the same range as last financial year.

To achieve this target, DLF plans to launch housing properties worth more than ₹ 17,000 crore this fiscal year amid strong demand for luxury homes. (PTI)

Grainspan invests ₹ 520cr on grain-based ethanol plants, benefits from Centre's interest subsidy

AHMEDABAD, June 15: Encouraged by the Union Food Ministry's interest subsidy scheme, Grainspan Nutrients has invested ₹ 520 crore to set up two grainbased ethanol plants in Ahmedabad and is supplying green fuel for blending with petrol.

The two plants, which use maize and rice as feedstock, have a total installed capacity of 350 kilolitres per day. Grainspan's first grain-based ethanol plant, located at Bhamsara Village in Ahmedabad district, became operational in May 2023 with a capacity of 110 kilolitres per day. This plant was Gujarat's first grainbased ethanol facility.

Enthused by the success, the company last month commissioned its second facility, which has been built at a cost of ₹360 crore with an installed capacity of 240 kilolitres per day at the same location.

The company supplies ethanol to Oil Marketing Companies (OMCs) under the Ethanol Blending Pro-

"There are three grain-based ethanol plants in Guarat, of which two facilities are being operated by us. We were the first to set up such a plant in the state, thanks to the central government subsidy," Grainspan Nutrients Pvt Ltd CEO Manoj Khandelwal said here.

He said there is an immense growth potential in ethanol production in India, not only to meet domestic demand but exports also.

Grainspan, which has been into manufacturing of food ingredients since 2014, forayed into ethanol a few years back to diversify its business taking advantage of interest subsidy.

The decision has helped the company increase its turnover which touched ₹ 760 crore last fiscal. Grainspan Ingredients Pvt Ltd CFO Pankit Shah said the company has invested a total of ₹ 520 crore in these two plants, which are fully operational.

"The first plant has been set up with the help of Central Government interest subsidy. We have taken a loan of ₹ 120 crore for the first plant," he said, adding that there is no interest subsidy on the second plant.

In the 2024-25 Ethanol Supply Year (ESY) that runs from November to October, Grainspan Nutrients will supply around 8 crore litre to OMCs at a fixed rate of nearly ₹ 72 per litre.

In the next ESY, the figure will reach 12 crore litres generating a topline of more than ₹800 crore. Apart from grain-based, Gujarat has 13 sugarcane-

based distilleries. Till June 8 of the current ESY, the ethanol blending has reached 18.9 per cent in the state with the supply

The Centre has notified various ethanol interest subvention schemes from 2018 to 2022 (in 2021 ethanol production from grain was also included under these schemes) to encourage sugar mills and distilleries to enhance their ethanol production capacities. Under all these subvention schemes, the government is facilitating project proponents to avail loans from banks/financial institutions. It provides interest subvention at 6 per cent or 50 per cent of the interest, whichever is lower, for a period of five years including one-year

A new interest subvention scheme for cooperative sugar mills has also been notified in March 2025 for conversion of their existing sugarcane-based plants into multi-feed-based ethanol plants.

Grainspan CFO said that the company's turnover rose 20 per cent to ₹ 758 crore last fiscal, of which ₹ 416 crore came from the food business and ₹ 342 crore from ethanol.

Pan-India, many companies and cooperatives have taken advantage of the interest subsidy incentive to set up new or expand ethanol-making capacities with sugarcane and grain (maize and rice) as feedstock. As a result, India's total ethanol-making capacity has jumped over four times in the last 11 years of the

current government. Till year 2013, ethanol distillation capacity in the country was 421 crore litres.

At present, the ethanol production capacity in the country has reached 1,810 crore litres, which includes 816 crore litres of molasses-based capacity, 136 crore litres of dual feed capacity and 858 crore litres of grain-based capacity.

Additional capacity has led to an increase in percentage of ethanol blending with petrol.

Till year 2013, supply of ethanol to OMCs was only 38 crore litres with blending levels of only 1.53 per Production of fuel-grade ethanol and its supply to

OMCs has increased by more than 18 times from ESY 2013-14 to ESY 2023-24. In ESY 2023-24, about 707 crore litres of ethanol has been blended by OMCs thereby achieving a

blending of 14.60 per cent. In the current ESY 2024-25 till May 25, about 548 crore litres of ethanol has been blended by achieving

a blending of 18.74 per cent. The government has set a target of 20 per cent blending by 2025-26. (PTI)

Segregating dreams from scrap: Seelampur's e-waste economy moves to shadows but doesn't stop

NEW DELHI, June 15: In the winding, congested alleyways of New Seelampur, a 500-foot stretch tucked deep inside east Delhi, life hums with the quiet rustle of wires, metal scraps, and fraving hopes.

Every household here seems tied to the business of e-waste -- a world where old computers, phones, fridges, and their innards are torn down, stripped, sorted, and sold. But the story is no longer what it once was.

As India's e-waste policy evolves and the gaze of enforcement agencies intensifies, the epicentre of one of the world's largest informal e-waste markets has quietly dispersed, not collapsed, but fragmented and slipped into the shadows.

The business hasn't ended, it has just moved -- to Loni, Muradabad, Meerut and smaller towns where it thrives away from the eyes of the regulators, the media, and digital scrutiny.

"The volumes have not really reduced. The business is still alive, but just not visible in Delhi anymore," says Vinod, programme officer at Toxics Link, an environmental NGO.

"Two things are happening -- the market is moving out, and formal recyclers are taking some share, but the informal chain still dominates," he adds. During a recent visit to the New Seelampur

slum, PTI witnessed how this once-bustling hub has morphed into a quieter but deeply embedded network. As the reporter walked through the slum's narrow lanes, nearly every doorway opened into a home where families were engaged in e-waste segregation.

In a dimly-lit 6x6 feet room, 50-year-old Saleema sat hunched over a knee-high mound of cables. Her fingers, bent with arthritis, sort wires from morning to night, guided only by a low-watt bulb dangling from the tin roof. For 10 kg of wires, she earns ₹ 50 -- slightly

more if she finds slivers of copper.

A single mother -- her alcoholic husband vanished into irrelevance years ago -- Saleema supports her three children. Her eldest son has been



lodged in Tihar Jail for over a year on theft charges, still awaiting trial.

"I have been doing this for over 30 years. This is the only life I've known," she says. Next door, 19-year-old Shahheda sits outside her one-room home, her hands still hennaed

from her wedding barely a month ago. Married into this community from Muradabad, she's no stranger to the trade. After making breakfast for her family, she joins her

husband and in-laws, segregating wires. "Copper dekh rahe hain'... If we get a good amount, it helps us with daily expenses. It's lit-

tle, but it adds up," she says. Nearby, Sajid Khan's family of five is also neck-deep in dismantling old electronics.

"Pehle se kaam bahut kam ho gaya hai'. The buyers are there, but GST and high costs have driven things outside. It's formalised now," he says. His daughter attends school in the morning and returns to help in the evening -- a pattern repeated in many homes here.

Twelve-year-old Sharmila (name changed) wants to become a doctor – and not just any doctor, but one who treats her neighbours, many of whom suffer from chronic ailments linked to toxic exposure. "After school, I help my father," she says

shyly, as she picks apart an old mobile charger. Her father, who did not wish to be named, is saving every rupee in the hope of breaking the cycle. "We want to leave this behind," he says. On any given day, one might see an array of tasks being carried out here -- circuit boards being pried open, mobile phones separated into batteries, cases, and chips.

For ₹80, a technician will strip an old phone into saleable pieces. In the makeshift shanties, traders examine CRTs from old monitors, polishing the glass to resell in rural markets. Impure copper sells for ₹ 600 per kg; pure fetches

Each house is a microcosm of labour -- families bent over wires, children washing dismantled parts, mothers selling components to traders who come knocking. Yet, the total daily income rarely crosses ₹ 500- ₹ 1,000 per household.

"e-waste is processed in phases -- from collection to dismantling to material recovery -and each stage generates economic value," explains Vinod from Toxics Link.

"That's why it survives. Every actor in the

chain makes something, even if it's meagre." India's E-Waste (Management) Rules, 2022, was designed to tighten controls, making producers more responsible through extended producer responsibility (EPR). But the system still falls short. "How laws are made is not very important but how implementation takes place is the key, and that is where the gap is between implementation and the role of the informal sector -- these are two serious gaps," says Satish Sinha, associate director, Toxics Link, which

works closely in the sector. "The Delhi market might have shrunk in size and moved to somewhere else, the volumes, to my understanding, haven't really reduced.

'Many formal recyclers have entered the market, whose numbers have grown. So a lot of products could be going to the formal market directly, and that is why there could be a reduction of the informal market," Sinha says.

Only about 500,000 tonnes of e-waste were formally collected in 2021-22 -- out of more than 3 million tonnes generated.

And even though companies are mandated to send waste to the authorised recyclers, loopholes abound, says public policy analyst Dharmesh Shah. (PTI)

He alleged that the order was selectively targeted at one particular community. "The order is not at all justified. There are other means to control the situation. It seems the order was issued only to target one community," he claimed. Raijor Dal working president Bhasco De Saikia said the state government failed to prevent communal tension in Dhubri and also to identify the real culprits. "The shoot-at-sight order is communal in nature aiming to polarise society. It was issued to divide people and trigger riots. We strongly oppose it," he added.

Tear gas shells were fired to disperse the agitators and restrictions on public movement were imposed. To prevent further flare-up of "communal tension, riot risk or violent protests", the district administration next day clamped restrictions under section 163 of BNSS and ordered all shops and markets establishments in the town to remain closed. It was withdrawn a day later. "Accordingly, the licenses of both pilots have been suspended for six months," the ministry said. Chief Minister Dhami chaired an emergency meeting with senior officials soon after the crash and ordered a high-level inquiry into it. "Heli services will remain suspended on Sunday and Monday as the weather is bad and the safety passengers is the state government's top priority." he said. Those responsible for negligence should be identified and punitive action should be ensured against them, he said. He also told officials at the meeting to issue a strict SOP for heli operations in the state and set up a control and command centre in Dehradun to monitor heli operations in the state. Helicopter crashes or emergency landings are occurring at an alarming frequency on the Chardham yatra route in Uttarakhand. The Chardham yatra involves Kedarnath, Badrinath, Yamunotri and Gangotri shrines. On May 8, a helicopter going to Gangotri Dham crashed in Uttarkashi district in which six people were killed. On June 7, a helicopter going to Kedarnath had to make an emergency landing on the road due to a technical fault soon after take-off in which the pilot was injured but the five devotees on board were rescued safely. On May 12, a helicopter returning from Badrinath to Sersi with pilgrims on board had to make an emergency landing in a school playground in Ukhimath due to poor visibility. All pilgrims were safe.

The helicopter took off again after about an hour when the weather improved. On May 17, a heli ambulance from AIIMS Rishikesh crash-landed near the Kedarnath helipad in Uttarakhand due to damage to its rear part. Fortunately, all three occupants on board – a doctor, a pilot, and a medical staff member – escaped unharmed.

The chief minister said on Sunday that a strict SOP (Standard Operating Procedure) with priority to public safety should be prepared for the operation of heli services in the state, in which a complete check of the technical condition of the helicopter should be made mandatory. Weather status should also be checked before heli operations, he said at the meeting. It was decided at the emergency meeting to set up a common "Command and Coordination Center" in Dehradun for better coordination and safe operation of helicopters, Dhami said. "There should not be any laxity regarding compliance with DGCA norms in helicopter operations in the state. It should also be ensured that the pilots flying in the upper Himalayan region are experienced," he said. (PTI)

Gas leak continues at ONGC

"They are getting the smell of gas and are not able to light their stoves or burn anything. We are providing them with cooked food and constantly monitoring the situation." she said. From the area of the blowout, 70 families have been shifted to a relief camp set up in nearby Bangaon, and all necessary arrangements are being made to ensure their welfare and well-being, the district administration said in a post on Facebook.

"There are currently doctors from the Health Department and the Animal Husbandry Department at the scene. They are examining the health conditions of both people and their domestic animals," it added. An official of ONGC had earlier said that it was an old crude well without production, and a perforation job was going on for zone transfer at the time of the blowout. "It is a kind of servicing of the well. The production was supposed to start from a new zone after the perforation job. At the time of the incident, the logging perforation operation was going on. Suddenly, gas started coming out in an uncontrolled manner immediately after the perforation, leading to the blowout," he said. (PTI)

Tensions in Dhubri escalated on June 8 and 9 after suspected cattle remains were found in a temple, triggering unrest. Police have registered five FIRs relating to three separate incidents, including the alleged cow slaughter, rioting, and the spread of misinformation. Twenty-two people had initially been arrested in the aftermath.

The FIRs cite violations under the Assam Cattle Preservation Act and several sections of the Bharatiya Nyaya Sanhita, including those dealing with defiling places of worship, promoting enmity between groups, criminal conspiracy, and acts intended to

outrage religious sentiments. Authorities have intensified surveillance and law enforcement measures in the region to prevent

Assam logs 3 new COVID-19 cases, one recovery

GUWAHATI, June 15: Assam reported three fresh COVID-19 cases in the last 24 hours, according to official data released on Sunday.

According to the Union Ministry of Health and Family Welfare website, there are 29 active cases in Assam, of which three were detected since Saturday. Since January this year, Assam has seen 14 people recovering from COVID-19, including one in the last 24 hours, it said. There are 7,383 active COVID-19 cases in India at present, and 10 more deaths have been reported in the last 24 hours, it added.

Official sources have maintained that most cases are mild and managed under home care. (PTI)

Efforts on as ONGC struggles to cap Bhatiapar Gas Well

SIVASAGAR, June 15: The deafening roar of an uncontrolled natural gas blowout from Well RDS 147 in Barichuk, Bhatiapar, just 8 km from Sivasagar town, continues to send waves of panic through the local population for the fourth consecutive day. Over 700 residents have been affected as efforts by a 20-member Crisis Management Team (CMT) to cap the well head remain unsuccessful.

The well, operated by SK Petrochemicals 135 VI, a private rig contractor for ONGC, suffered the blowout during a work-over operation earlier this week. ONGC officials on-site stated that efforts are underway to contain the gas flow and expressed hope of plugging the well soon, but admitted that no expert can give a definitive timeframe for full con-

An ONGC officer, speaking on condition of anonymity, revealed that the team's initial attempt to cap the well using the conventional Heavy Mud Injection method failed. The team is now employing the Junk Shot technique, a high-risk emergency measure that involves injecting shredded rubber, golf balls, and similar materials into the well to disrupt and stop the gas flow. Vikram Saxena, Director (Technical and Field Services), is personally monitoring the operation.

In a significant development, Sivasagar MLA and Raijor Dal leader Akhil Gogoi visited the site today. After speaking with ONGC's CMT leader Sri Hari, Gogoi disclosed that the blowout may have inadvertently revealed a rich natural gas reservoir in the region.

Meanwhile, the Sivasagar district administration has shifted affected residents to Bogaon High School, where two medical camps are operational. Security forces have been deployed, and the Water Resources Department is assisting by lifting water from the Dikhow River to cool the well head and prevent ignition. Oil India Ltd has also sent logistical support to aid the operation.

Fears among villagers are growing, drawing comparisons to the Baghjan blowout of 2020. Dhan Chutia and his wife said they have been forced to leave their home after 4 p.m. daily due to the intense pressure and noise. "Our poultry and animals are suffering in the heat," they said.

Anjumoni Phukan, wife of Dayananda Chutia, tearfully expressed her dread, saying, "I'm praying every minute that this doesn't become another Baghjan." Several residents also accused ONGC of indifference to their suffering and lack of basic support, especially amid the scorching

Diphu Municipal Board declares weekly market days at Lorulangso Market

Myth, reality, universal concerns headline Rashmi Narzary's 'The Lost Soul of the Joukhoorei'

GUWAHATI, June 15: Bringing together a blend of myth and reality, award-winning author Rashmi Narzary's says her latest book -'The Lost Soul of the Joukhoorei' underscores universal concerns along with the "joys of befriending and the pains of letting go".

Narzary, who hails from the Bodo community, has narrated many a story of yore of the land with creative sensibility and her recent book, too, brings to the fore myths, folklore and legends drawn from lost and forgotten tales.

The only Assamese writer to be invited by the Sahitya Akademi as a house guest recently to the Rashtrapati Bhawan, Narzary, told PTI that 'The Lost Soul of the Joukhoorei' was born out of her 'crazy imagination and I dole out magic and suspense, too, along with legends of the land'.

Eminent lyricist and poet Gulzar has mentioned in the book's blurb, "If there is a Cosmos within Cosmos, a Universe within a Universe, it's in the storytelling by Rashmi Narzary. She takes you across infinite time. The book ends. The story

does not." Narzary said the story of her new book "begins with an ancient feel about it, that would flow through realms, space and species, human, animals, birds and insects, all speaking the same language, and being bound by elements of love and compassion".

The 'Joukhoorei', the title derived from the Bodo words 'jou' meaning wine and 'khoorei' signifying bowl, is the dry shell of a gourd with its insides scooped out to hold liquid. The book tells the story of 'having and losing, of uprooting and settling, of the joys of befriending and the pains of then letting go - It is a tale of a soul not lost forever but a soul which had only lost its way", she said.

It is redolent with the legends of "our land, but is imbued with universal concerns where the lines between myth and reality blur, and every choice carries the weight of destiny". Narzary said.

"A visit to the serene 'gompas' (monasteries) in the high altitudes of Sikkim and Bhutan refused to leave my thoughts, and I set this tale in the mountains, which are generally thought to be home to spirits, mysteries and mythical songs," she said. The author has woven the tale around 'Bathou' (as Lord Shiva is referred to among the Bodos) and the Buddha, but she points out that they are essentially separate and have distinct identities, though they are manifestations of the same belief.

"The connect with the Buddha and the Jataka era in the book was incorporated for a feel of ancientness and mythical allure, as well as to add a bridge between the very distant, enchanted past and the present," she said. Her books may be works of fiction, but Narzary maintains that a lot of research goes into her writings as she "observes people, situations, objects, and anything around me".

"I listen to people talk and at times, I get old people in our villages to speak of days of yore, of unchronicled incidents, of lost customs which were bound with lost clans. I also read a lot of academic papers, old news archives and even consultation with former army personnel like in 'An Unfinished Search' are involved," she said.(PTI)

Tribute on Death Anniversary

Anandaram Dhekial Phukan: Guardian of Assam's tongue and soul

nandaram Dhekial Phukan, a towering personality in the history of Assam, played a crucial role in the revival and preservation of Assamese culture and language during a period of cultural and political turmoil. His vision, dedication, and efforts left a lasting impact on the linguistic, educational, and social landscape of Assam. Often referred to as the "Raja Ram Mohan Roy of Assam," Phukan's intellectual endeavors focused on the revitalization of Assamese identity, especially through the promotion of the Assamese language and vernacular education. He was the torchbearer of Assam's renaissance, continuing the work initiated by his father, Haliram Dhekial Phukan, who had planted the seeds of Assam's cultural revival through his historical work Assam Buranji and his advocacy for women's education.

This article delves into Anandaram Dhekial Phukan's profound contributions to Assamese society, particularly in the fields of education and language, his struggle to establish the Assamese language as distinct from Bengali, and his philosophical outlook on the importance of cultural and linguistic identity.

Early Life and Influence of Haliram Dhekial Phukan: Anandaram Dhekial Phukan was born into a family committed to social and cultural reform. His father, Haliram Dhekial Phukan, was a distinguished historian who authored Assam Buranji, one of the first comprehensive historical accounts of Assam. More than just a historian, Haliram was a visionary who saw education as the foundation for societal progress, and he was particularly supportive of women's education, a cause not commonly advocated during his time. These influences shaped Anandaram's worldview and set him on the path of enlightenment, making him a pivotal figure in Assam's renaissance.

Anandaram was deeply committed to the cause of education, and his central belief was that no society could progress without education in its mother tongue. He understood that the key to a people's advancement was through language—the language of their land, their heritage, and

Advocate of Vernacular Education and Assam's Cultural Revival: In the era of colonial India, education was largely imparted in foreign languages like English and Bengali. Anandaram Dhekial Phukan recognized that while learning foreign languages such as English and Bengali was necessary for global communication and competitive growth, neglecting one's mother tongue would ultimately erode the cultural foundation of society. He strongly advocated for the introduction of vernacular education in Assamese, emphasizing that learning in one's native language would enhance the understanding of concepts and real-life situations among the masses. Phukan argued that true education could not take root unless it was in a language that the people could fully un-

derstand and engage with. Phukan's resistance to the use of Bengali as the medium of instruction in Assam's primary schools was particularly significant. In his seminal work Observations, he argued that primary education should be imparted in the mother tongue. He pointed out that Bengali, being a foreign language in Assam, created significant obstacles in education, as neither the teachers nor the students were proficient in it. The result was a gross misunderstanding of concepts, with students unable to grasp the full meaning of the subjects being taught. Furthermore, Phukan criticized the educational system

for using textbooks in **DEGREE OF THOUGHT** Bengali, which were inaccessible to most of Assam's population.

Anandaram Dhekial Phukan also recognized the importance of using Assamese in courts and administrative matters. He strongly objected to the imposition of Bengali as the court language, emphasizing that it violated the rights of the Assamese people. Phukan believed that the legal and judicial system should be accessible to the common people, and this could only be achieved by using the native language. His fight to restore Assamese as the language of the courts was ultimately successful, marking a significant victory for the Assamese people.

Struggle Against the Imposition of Bengali: The imposition of Bengali in Assam had its roots in colonial administrative policies. British officers, who lacked the initiative to learn Assamese, mistakenly regarded Assamese as a mere dialect of Bengali. This misconception, combined with the shared alphabet of Assamese and Bengali, led to the erroneous belief that the two languages were essentially the same. Bengali was adopted as the official language in Assam's courts and schools, leading to widespread discontent among the Assamese populace.

Anandaram Dhekial Phukan was at the forefront of the movement to dispel this misconception. He believed that the imposition of Bengali threatened to erase Assamese cultural identity. Phukan meticulously documented the differences between the two languages, proving that Assamese was a distinct language with its own grammar, syntax, and vocabulary. In his work A Few Remarks on the Assamese Language and on Vernacular Education in Assam, Phukan provided concrete examples to illustrate the linguistic differences between Assamese and Bengali. Through comparative analyses of everyday words, literary passages, and even Sanskrit texts, Phukan demonstrated that Assamese was not a mere variant of Bengali but a unique and independent lan-

Phukan's comparison of Assamese and Bengali went beyond vocabulary. He argued that while Assamese and Bengali shared certain commonalities due to their Sanskritic origins, this did not make them the same language. His meticulous research and clear arguments helped establish Assamese as a language in its own right, distinct from Bengali. This intellectual defense of Assamese laid the foundation for the eventual restoration of Assamese as the official

language of Assam. The Restoration of Assamese as the Court Language: One

Dhekial Anandaram Phukan's most significant achievements was the restoration of Assamese as the language of the courts. For many years, Bengali had been imposed as the court language in Assam, creating a barrier between the legal system and the Assamese people. Phukan's tireless efforts to replace Bengali with Assamese culminated in the successful reintroduction of Assamese in Assam's judicial system.

Phukan argued that the use of Bengali in the courts was not only impractical but also unjust. He pointed out that most Assamese judges and court officials were more comfortable with Assamese than Bengali, and the imposition of Bengali created unnecessary communication gaps. Furthermore, the general populace found it difficult to understand legal proceedings conducted in a foreign language, which undermined their access to justice.

Drawing on the provisions of the Act XXIX of 1837, which had abolished Persian as the court language in Bengal and Hindustan and replaced it with local languages, Phukan argued that the same logic should apply to Assam. If Persian could be replaced by Bengali and Hindustani in other regions, then Bengali could similarly be replaced by Assamese in Assam. Phukan's arguments were compelling, and after years of advocacy, Assamese was finally restored as the court language in Assam, a victory that was

warmly welcomed by the Assamese peo-

Philosophical Vision - Language as the Soul of a Nation: Anandaram Dhekial Phukan's fight for the Assamese language was not just a linguistic battle—it was a philosophical and cultural one. Phukan understood that language was more than just a means of communication: it was the soul of a people, the vessel of their culture, history, and identity. He believed that the survival of Assamese culture depended on the preservation and promotion of the Assamese language. Without a strong linguistic foundation, Phukan argued, the Assamese people would lose their unique identity and be subsumed by larger, more dominant cultures.

Phukan's philosophical outlook aligned with the ideas of other great thinkers of his time, such as Raja Ram Mohan Roy and Mahatma Gandhi, who also recognized the importance of cultural and linguistic identity in the process of nation-building. Like these luminaries, Phukan believed that true progress could only be achieved through a synthesis of tradition and modernity. While he advocated for the learning of foreign languages like English and Bengali for practical purposes, he insisted that Assamese must remain at the heart of Assam's educational and administrative

A Lasting Legacy: Anandaram Dhekial Phukan's life was tragically short, but his legacy endures. His tireless efforts to restore the dignity and prominence of the Assamese language laid the groundwork for future generations of Assamese scholars, writers, and activists. His work ensured that Assamese would not be relegated to the status of a "mere dialect" but would be recognized as a distinct and vibrant language with its own literature, history, and intellectual traditions.


Anandaram Dhekial Phukan: A visionary who awakened Assam's soul

The journey of Assam through the corridors of the 19th century was one fraught with the burdens of political transition, cultural insecurity, and linguistic erosion. As the region came under British colonial administration, it was not only its sovereignty that was challenged but also its unique identity. Assamese language, literature, and cultural expressions faced a systemic marginalization, particularly due to the imposition of Bengali as the language of administration and education. In such a time of peril, when the native spirit risked being silenced under the weight of foreign dominance and internal confusion, there arose a luminous figure who not only understood the depth of the crisis but also possessed the intellectual courage to challenge it. Anandaram Dhekial Phukan emerged as the most compelling voice of that era—an enlightened mind, a dedicated reformer, and a visionary whose ideas heralded the dawn of the Assamese renaissance. Though his life spanned a mere twenty-nine years, its impact has endured for generations. He was more than a reformer—he was a symbol of resistance, a harbinger of progress, and a prophet who foresaw the emergence of a modern Assamese identity built on the solid foundation of language, education, and cultural pride. Born on 22nd September 1829 in Guwahati,

Anandaram came from a family rooted in aristocratic legacy and cultural erudition. His father, Holiram Dhekial Phukan, had held a prominent position during the Ahom rule and later served under the British regime, producing scholarly works in Sanskrit and Bengali. This familial heritage sowed the seeds of intellectual curiosity in young Anandaram, although his early years were shadowed by personal loss. The death of his father when he was just two years old placed him under the nurturing care of his mother, Kameshwari, who raised him with quiet strength. His initiation into traditional education began at the Sanskrit Tol of Umananda, which grounded him in classical learning. However, it was his transition to English education—despite opposition from traditionalist family members—that marked a profound turn in his intellectual journey. Enrolling in Guwahati's first English school in 1837 under the mentorship of James Matthew and Jenkins, he imbibed the modern liberal arts spirit. Recognizing his exceptional promise, the British administration sponsored his education in Calcutta, where he joined Hindu College in 1841. Though he returned prematurely in 1844 due to familial obligations, his thirst for learning never waned. He continued to educate himself in English, Urdu, and Persian, making him a rare polyglot of his time. This eclectic scholarship became the bedrock of his reformist zeal and his lifelong mission of cultural preservation and societal modernization.

The defining cause of Anandaram Dhekial Phukan's life was his unwavering commitment to the Assamese language at a time when it



teetered on the brink of extinction in formal domains. The British colonial administration, driven by expediency and influenced by Bengali officials, had supplanted Assamese with Bengali as the language of instruction and governance in Assam. For Anandaram, this was not a mere administrative change—it was an assault on the cultural and intellectual integrity of his people. He saw language as the carrier of a civilization's consciousness, a repository of its history, values, and aspirations. His fight to restore Assamese was not driven by narrow linguistic sentiment but by a profound understanding of identity politics. When British Governor A. J. Moffatt Mills visited Assam in 1853, Anandaram presented an erudite and persuasive memorandum advocating for the reinstatement of Assamese in schools. His arguments were so cogent and well-articulated that Mills supported the proposal, setting in motion a policy reversal that would have long-term implications. It was a turning point in Assam's modern history. Anandaram's intervention restored not just a language but revived a collective confidence among the Assamese people in

their cultural legitimacy. His landmark work A Few Remarks on the Assamese Language, and on Vernacular Education in Assam, published in 1855, stands as a monumental intellectual contribution to the cause of linguistic identity. Distributed among administrative circles across India, the book provided rigorous evidence that Assamese was not a derivative of Bengali but a distinct language with its own grammar, syntax, and literary lineage. This assertion, supported by his multilingual erudition, challenged the dominant colonial narrative and reshaped official policy. More importantly, it gave Assamese speakers a renewed sense of pride in their mother tongue. His scholarship became a cornerstone of the intellectual movement that reclaimed Assamese as a legitimate and independent language. Through this work, Anandaram not only countered colonial assumptions but also dismantled the regional hegemonies that sought to undermine Assamese linguistic sovereignty. In a deeply divided and colonially orchestrated cultural

milieu, this was an act of intellectual defiance and self-assertion.

Education, for Anandaram, was the most potent instrument for social transformation. He time. In a society where women's education believed that a nation could progress only when its youth were equipped with knowledge. He viewed modern education not merely as a means of individual advancement but as a pathway to collective liberation. His textbook Assamese Larar Mitra played a vital role in the revival of Assamese as a medium of instruction. It served as an educational bridge, reconnecting young minds with their linguistic roots while simultaneously steering them towards rationality and enlightenment. He implored the youth to seek knowledge fearlessly, exhorting them to overcome social prohibitions and conservative resistance. His appeal to students to unite in the pursuit of education was revolutionary for its time and reflected his radical belief in intellectual empowerment. Anandaram was not just a reformer; he was a dreamer who saw a future Assamese society that was literate, thoughtful, and capable of steering its own des-

However, Anandaram's vision was not confined to education and language. He had a comprehensive understanding of modernity, encompassing economic, social, and moral dimensions. At a time when commerce was still viewed with suspicion in Assamese society, Anandaram championed trade as the cornerstone of national development. He explicitly linked prosperity to commerce, arguing that without economic engagement, Assam would remain impoverished and marginalized. His call to embrace trade was not just practical advice—it was a visionary forecast of a self-reliant Assam integrated into the global economy. His critique of Assamese indifference towards economic matters demonstrated a rare insight into the nexus between cultural pride and material progress. He recognized that cultural revival had to be backed by economic strength for it to be sustainable.

Anandaram's ideas on social reform were equally progressive. In his writings and personal conduct, he consistently demonstrated a vision of a civilized, egalitarian society. His famous prayer for a transformed Assam—one that would witness steamships instead of boats, brick houses instead of bamboo huts, schools in every village, and mutual love replacing hatred—was a dream rooted in rational optimism. It captured not just his aspirations but also offered a blueprint for Assam's future. He envisioned a soiety where modern infrastructure would blend with moral values, and where development would be inclusive and humane. His prayer reveals a desire for comprehensive progress-material, intellectual, and ethical-and underscores his spiritual humanism. He dreamt of an Assam where modernity did not mean abandoning tradition but rather evolving tradition into a higher, more inclusive form.

In his personal life too, Anandaram broke

conventions. His decision to educate his wife, Mahendri Devi, was a quiet yet profound act of rebellion against the patriarchal norms of his was nearly unheard of, his insistence on making his wife literate spoke volumes about his commitment to social equality. He balanced his responsibilities as a husband and father with his public duties, never allowing personal grief or societal constraints to deter him from his mission. The death of his first child, Raseshwari, was a personal tragedy, but he continued to devote himself to public causes with unflag-

ging zeal. Professionally, Anandaram served in various administrative positions including as Jemadar, Munsif, Dewan of Bijni Raj Estate, and Deputy Commissioner of Nagaon. His tenure in the colonial bureaucracy was marked by efficiency, fairness, and a deep sense of duty. But even as he carried out his official responsibilities, he remained intellectually active and socially engaged. His books on legal and administrative matters such as Englandor Buranji, Estate Administration, Sadarer Mamalar Nispati, and Dewani Mamalar Nispati show the breadth of his knowledge and his desire to democratize access to institutional knowledge. He sought to bridge the gap between the ruling system and the common people, believing that awareness and information were key to empowerment. Through his professional and literary contributions, he exemplified the ideal of the civil servant-scholar—one who serves not only the administration but also society.

Tragically, Anandaram's promising life was cut short when he passed away on 16th June 1859, merely five days after falling ill. His death at the age of twenty-nine robbed Assam of a torchbearer in its time of awakening. Yet, his ideas continue to resonate. His belief in language as identity, education as liberation, commerce as progress, and unity as strength remains profoundly relevant. Today, as Assam faces new cultural, linguistic, and socio-economic challenges, the legacy of Anandaram Dhekial Phukan offers both inspiration and guidance. He remains a shining example of how vision, courage, and intellectual clarity can spark the renaissance of an entire civilization.

The story of Anandaram Dhekial Phukan is not simply the biography of an individual—it is the narrative of a people reclaiming their voice, their dignity, and their place in the world. His life reminds us that the future of a community lies not in passive adaptation but in proactive transformation. He taught Assam to look within for strength and to look ahead for progress. In honoring his memory, especially on his death anniversary on 16th June, we do not merely pay tribute to a historical figure—we reaffirm our commitment to the ideals he stood for. His life remains a testament to the fact that even in a short span, a resolute soul can leave behind a legacy that shapes the destiny of generations. Right from 1923 Tezpur Litchi has brick by brick made its place in the hearts of the people and in 2015 it received the coveted GI tag which cements its place as not only Tezpur's but the nation's wonder fruit. But this fruit has not yet made it big in the world scenario even though it is exported to some foreign countries, the main reason behind this is very limited production which barely serves the nation let alone the world demand. I urge the State Department of Agriculture and Horticulture to press the centre for a Litchi Board in Tezpur like the Makhana Board the centre approved last year for Bihar. This will give fresh energy to the horticultural potential of Litchi and will also open other avenues related to Litchi which will bring in good revenue for Assam and the country as a whole.

What to know about prediabetes

Prediabetes, also known as borderline diabetes, is where a person's blood sugar levels are higher than usual but not yet high enough for a diagnosis of type 2 diabetes.

Prediabetes is a condition that can progress to type 2 diabetes. Doctors may also refer to prediabetes as impaired glucose tolerance or impaired fasting glucose.

Research suggests that this progression occurs in about 25% of people with prediabetes within 3 to 5 years. Overall, up to 70% of people with prediabetes will develop diabetes at some point in their life.

Symptoms of prediabetes

Prediabetes does not always have symptoms. Many people may not know they have it until a doctor determines they have high blood sugar based on a blood test or a complication occurs.

If symptoms do occur, they may in-

- unexplained weight changes
- increased appetite
- · weakness
- fatigue • blurry vision
- sweating
- · recurring gum bleeding or skin in-

fections

• slow wound healing However, most people will not know they have prediabetes until they un-

Causes and risk factors for predia-

According to the National Institute of Diabetes and Digestive and Kidney Diseases, various other conditions and factors can increase the risk of prediabetes, including:

- overweight or obesity
- metabolic syndrome
- low levels of physical activity • high blood pressure
- a history of stroke or heart disease • polycystic ovary syndrome (PCOS)

Regularly consuming sugary drinks may also increase the risk. A 2021 review associates drinks with added sugar, including soda, juices, and sweetened tea or coffee, with a higher risk of

Anyone with any of these risk factors may benefit from a prediabetes screening to check whether they have the con-

Diagnosing prediabetes

A doctor may use the following blood tests to diagnose or screen for predia-

☐ Glucose tolerance test: A glucose tolerance test measures how quickly the body can process the sugar in the blood in a 2-hour period.

☐ Fasting blood test: A fasting blood test measures blood sugar levels after a person has not eaten for a specific pe-

☐ Hemoglobin A1C test: An A1C test measures the average blood sugar levels over 2 or 3 months. People do not need to fast or take any special liquids or medications for the A1C test, and it

gives reliable results. ☐ Random plasma blood test: This measures a person's blood sugar levels at any time.

The American Diabetes Association states that a doctor will diagnose prediabetes when test results show the following measurements:

☐ fasting blood sugar levels of 100 to 125 milligrams per deciliter (mg/dl) • glucose tolerance levels of 140 to 200 mg/dl

• an A1C test result of 5.7% to 6.4% A doctor may also re-test these levels to confirm that the readings are not due to one-off spikes in blood sugar.

Who should undergo screening for prediabetes?

Healthcare professionals may recommend that people start to undergo screening for prediabetes between the ages of 30 and 45, repeating the screening every 3 years.

People with risk factors may need to start screening earlier and get followups more often than this.

The Centers for Disease Control and Prevention (CDC) offers an online test to assess people's risk of prediabetes. Anyone who is concerned they may have prediabetes should also visit a doctor for testing and a diagnosis.

Prediabetes treatment

Prediabetes is reversible. Lifestyle changes and weight management are the first-line treatment option.

Healthcare professionals may suggest a person work toward a goal of exercising for 30 minutes per day and switch to a low fat diet, with the aim of reducing their weight by 7%

If someone has a high risk of type 2 diabetes or cannot make the necessary lifestyle changes, doctors may suggest management with medication. Medications may include metformin (Glucophage) and acarbose (Prandase)

Managing prediabetes may also involve continual monitoring of the risk factors and regular testing of blood sugar levels.

The CDC leads a program called the National Diabetes Prevention Program, which aims to help people with prediabetes lower their risk of type 2 diabetes

Prediabetes progression

Around 70% of people with prediabetes progress to a diagnosis of diabetes. However, the rate of progression may vary from person to person, and not all people with prediabetes will progress to diabetes.

People may be able to prevent this progression if they make appropriate lifestyle changes. It is important for people with prediabetes to work with a healthcare professional to lower their risk of progression and complications.

Frequently asked questions

What foods should someone with prediabetes eat?

Healthcare professionals may recommend that people with prediabetes eat a balanced diet with plenty of fiber. Fiberrich foods include whole grains, beans, and leafy green vegetables.

People may also benefit from limiting simple carbs, salt, and added sugar.

What are the complications of predi-

Even if it does not progress to type 2 diabetes, prediabetes can lead to complications such as stroke, kidney failure, and heart disease.

Can children have prediabetes?

In a 2019 study involving 5,786 people, 18% of the 2,606 adolescent participants — ages 12 to 18 years — had prediabetes. Among the 3,180 young adults, the prevalence was 24%

Many children who develop type 2 diabetes do not receive a diagnosis until adolescence. This is, in part, because puberty hormones can make it harder for the body to regulate insulin.

Parents and caregivers can help prevent diabetes in children by encouraging them to eat a balanced diet and engage in plenty of physical activity. Can prediabetes progress to type 1 di-

Prediabetes refers to a metabolic state that is a precursor to type 2 diabetes. It

cannot evolve into type 1 diabetes. However, there is research on a parallel disease called pre-type 1 diabetes, in which a person's immune system displays certain characteristics that indicate progression to type 1 diabetes.

How long does it take to reverse prediabetes?

With a well-balanced diet, regular exercise, and prescribed medical interventions, a person may be able to reverse prediabetes in about 3 years.

Summary

Prediabetes is the stage before type 2 diabetes develops. It does not usually cause active symptoms, and most people will not be aware that they have the condition until it progresses to diabetes and starts causing health problems.

Anyone who is at risk of developing diabetes should have regular screening. Risk factors include high blood pressure, low levels of physical activity, and overweight or obesity.

ent types of strokes, ischemic stroke is by far the most common accounting for nearly 87% of all stroke cases globally. An ischemic stroke occurs when a blood clot blocks or narrows an artery leading to the brain, cutting off the oxygen supply. Within minutes, brain cells begin to die. Because the brain is extremely sensitive to lack of blood flow, timely treatment is critical. The faster a patient receives medical attention, the better the chances of minimizing long-term disability or even preventing death.

Early detection of an ischemic stroke is the most important factor that influences outcomes. Unfortunately, many people fail to recogthe symptoms or underestimate their seriousness, delaying medical intervention. In stroke care, time is brain every second counts, and a fast response can dramatically change the course

of recovery. The hallmark symptoms of an ischemic stroke tend to appear suddenly. One of the earliest and most visible signs is facial drooping. This typically manifests as one side of the face appearing uneven or numb, and the person may be unable to smile symmetrically. Arm weakness is another red flag: if the person cannot raise both arms or if one arm drifts downward, it is a strong warning sign. Speech difficulties follow ranging from slurred speech to trouble understanding or forming sentences. Other potential signs include sudden blurred or double vision, unsteadiness, dizziness, lack of coordination, or a thunderclap headache with no apparent cause.

To simplify the identification of stroke symptoms, the American Heart Association recommends the

acronym FAST: • F (?) Face Drooping: Does one side of the face sag or feel numb? • A (?) Arm Weakness: Is one

arm weak or numb? Can the person raise both arms? • S (?) Slurred Speech: Is the speech slurred or incoherent?

 T (?) Time to Call Emergency Services: If any of these signs are observed, seek immediate medical

with each passing hour.

While rapid response is essential during a stroke, prevention is the ultimate key to reducing the burden of the disease. Controlling high blood pressure the most significant risk factor can significantly cut down the chances of stroke. Similarly, people living with diabetes should manage their blood sugar levels diligently, as fluctuating glucose levels can damage blood vessels and raise stroke risk. High cholesterol also contributes to the narrowing of arteries, and reducing LDL levels through diet, exercise, or medica-

tion can offer protection. Smoking is a well-established cause of blood vessel damage and clot formation, and quitting can greatly reduce the risk. Excessive alcohol intake should be avoided, as it can increase blood pressure and atrial fibrillation both risk factors for stroke. Maintaining a healthy body weight through regular physical activity and a balanced diet rich in fruits, vegetables, grains, and proteins also supports cardiovascular and brain health

Ischemic stroke is a serious but largely preventable condition. Raising awareness about its warning signs and risk factors is crucial. If someone around you displays even one symptom from the FAST checklist, act quickly and call emergency services. Timely intervention can mean the difference between full recovery and lifelong disability or even death. Likewise, by adopting a healthier lifestyle and managing chronic conditions, we can significantly reduce the risk of ever having a stroke in the first place.

Understanding heart failure and treatment

What are the main treat-

eart failure may sound frightening, but advances in medical science have made it a highly manageable condition. Awareness, early intervention, and adherence to medical guidance are your best tools for living well with heart failure. Here are some general questions about heart failure which every patient wants to know.

What is heart failure? Heart failure, also known as congestive heart failure, is a condition where the heart is un-

it's functioning less efficiently than normal. What causes heart failure? There are several causes. The most common include coronary artery disease, high blood pressure, previous heart attacks, heart valve diseases, and certain

Common symptoms include shortness of breath, fatigue, swelling in the legs or ankles, rapid heartbeat, persistent coughing, and difficulty lying flat due to breathlessness. These symptoms often worsen over time if left untreated.

How is heart failure diagnosed?

We start with a physical exam and medical history, followed by tests like ECG (electrocardiogram), echocardiogram, chest X-ray, blood tests (including BNP), and sometimes cardiac MRI or stress tests. These help us assess heart function and determine the type and severity of heart failure.

Can heart failure be cured?

While heart failure often can-



DUBAI, June 15: Israel unleashed airstrikes across Iran for a third day on Sunday and threatened even greater force as some Iranian missiles evaded Israeli air defences to strike buildings in the heart of the country

Planned talks on Iran's nuclear programme, which could provide an off-ramp, were cancelled.

The region braced for a protracted conflict after Israel's surprise bombardment of Iran's nuclear and military sites on Friday killed several top generals and nuclear scientists, and neither side showed any sign of backing down.

Iran said Israel struck two oil refineries, raising the prospect of a broader assault on Iran's heavily sanctioned energy industry that could affect global markets.

The Israeli military, in a social media post, warned Iranians to evacuate arms factories, signalling what could be a further widening of the campaign. Around noon local time, explosions were heard again in the Iranian capital, Tehran.

US President Donald Trump has expressed full support for Israel's actions while warning Iran that it can only avoid further destruction by agreeing to a new nuclear deal.

Iranian Foreign Minister Abbas Araghchi said on Sunday that if the Israeli strikes on Iran stop, then "our responses will also stop". He said the United States "is a partner in these attacks and must take responsibility"

Israel, the sole though undeclared nuclear-armed state in the Middle East — said it launched the attack to prevent Iran from developing a nuclear weapon. The two countries have been regional adversaries for decades.

Iran has always said its nuclear program was peaceful, and the US and others have assessed it has not pursued a weapon since 2003. But it has enriched ever larger stockpiles of uranium to near weaponsgrade levels in recent years and was believed to have been able to develop multiple weapons within months if it chose to do so.

The UN's atomic watchdog censured Iran last week for not complying with its obligations.

Araghchi, Iran's top diplomat, said Israel had targeted an oil refinery near Tehran and another in the country's Bushehr province on the Persian Gulf. He said Iran had also targeted "economic" sites in Israel, without elaborating.

Araghchi was speaking to diplomats in his first public appearance since the initial Israeli strikes.

Semiofficial Iranian news agencies reported that an Israeli drone strike had caused a "strong explosion" at an Iranian natural-gas processing plant. Israel's military did not immediately comment. The extent of damage at the South Pars natural gas field was not immediately clear. Such sites have air defence systems around them, which Israel has been targeting.

Iran calls nuclear talks unjus-

The Arab Gulf country of Oman, which has been mediating indirect talks between the US and Iran over Tehran's nuclear programme, said a sixth round planned for Sunday would not take place.

"We remain committed to talks and hope the Iranians will come to the table soon," a senior US official said on condition of anonymity to discuss the sensitive talks.

Araghchi, Iran's foreign minister, said Saturday that the nuclear talks were "unjustifiable" after Israel's strikes, which he said were the "result of the direct support by Washington". In a post on his Truth Social account early Sunday, Trump reiterated that the US was not involved in the attacks on Iran and warned that any retaliation directed against it would bring an American response "at levels never seen before".

G7 leaders gather in Canada for summit overshadowed by Middle East crisis, Trump's tariffs



BANFF (CANADA), June 15: Leaders of some of the world's biggest economic powers will arrive in the Canadian Rockies on Sunday for a Group of Seven summit overshadowed by a widening war across the Middle East and US President Donald Trump's unresolved trade war with allies and rivals alike.

Israel's strikes on Iran and Tehran's retaliation, which appeared to catch many world leaders unawares, is the latest sign of a more volatile world as Trump seeks to withdraw the US from its role as world policeman.

Speaking on a flight to Canada to attend the summit, British Prime Minister Keir Starmer said he had discussed efforts to de-escalate the situation with Trump and Israeli Prime Minister Benjamin Netanyahu, as well as other world leaders.

Britain is sending Royal Air Force jets and other military reinforcements to the Middle East.

'We do have longstanding concerns about the nuclear program Iran has. We do recognise Israel's right to self-defense, but I'm absolutely clear that this needs to de-escalate. There is a huge risk of escalation for the region and more widely," Starmer said, adding he expected "intense discussions" would continue at the summit.

Trump is summit's wild card

As summit host, Canadian Prime Minister Mark Carney has decided to abandon the annual practice of issuing a joint statement, or communique, at the end of the meeting.

 $\bar{\mbox{W}}\mbox{ith}$ other leaders wanting to talk to Trump in an effort to talk him out of imposing tariffs, the summit risks being a series of bilateral conversations rather than a show of unity.

Trump is the summit wild card. Looming over the meeting are Trump's inflammatory threats to make Canada the 51st state and take over Greenland. French President Emmanuel Macron is making a highly symbolic stop in Greenland on his way to Canada, meeting the Arctic territory's

leader and Denmark's prime minister aboard a Danish helicopter carrier. Macron, who is one of the very few leaders to have known Trump during his first term, was the first European leader to visit the White House after Trump took office, emerging unscathed from the Oval Office encounter. But despite the two leaders' sporadic bromance, Macron's approach to Trump has failed to bear major results, with France caught up in the president's planned tariffs on the European Union.

Nor did it bring any US security guarantees for Ukraine despite Macron's efforts, together with Starmer, to build a coalition of nations that could deploy forces after any ceasefire with Russia, with the hope it would convince the Trump administration to provide backup.

Trump is scheduled to arrive late Sunday in Kananaskis, Alberta. Biident Christodoulides and address lateral meetings between other leaders are possible Sunday, but the sumbusiness leaders at Limassol, it mit program does not get underway until Monday. said. From Cyprus, he will head to

Peter Boehm, Canada's sherpa of the 2018 G7 summit in Quebec and veteran of six G7 summits, expects the heads of state to pivot discussion to devote more time to the war. "Leaders can accommodate a discussion, perhaps even a statement," Boehm said. "The foreign policy agenda has become much larger with this.

Leaders who are not part of the G7 but have been invited to the summit by Carney include the heads of state of India, Ukraine, Brazil, South Africa, South Korea, Australia, Mexico and the UAE, Avoiding tariffs will continue to be top of mind.

"Leaders, and there are some new ones coming, will want to meet Donald Trump," Boehm said. "Trump doesn't like the big round table as much he likes the one-on-one." Bilateral meetings with the American president can be fraught as Trump has used them to try to intimidate the leaders of Ukraine and South Africa.

Former Canadian Prime Minister Jean Chrétien told a panel this week that if Trump does act out, leaders should ignore him and remain calm like Carney did in his recent Oval Office meeting.

"He tends to be a bully," Chrétien said. "If Trump has decided to make a show to be in the news, he will do something crazy. Let him do it and keep talking normally." Starmer had a warm Oval Office meeting with the president in February, wooing Trump with an invitation for a state visit from King Charles III. Trump has praised the British prime minister, despite their political differences.

Zelenskyy expected to meet Trump

Last month Britain and the US announced they had struck a trade deal that will slash American tariffs on UK autos, steel and aluminum. It has yet to take effect, however, though British officials say they are not concerned the Trump administration might go back on its word.

Starmer's attempts to woo Trump have left him in an awkward position with Canada, the UK's former colony, close ally and fellow Commonwealth member. Starmer has also drawn criticism — especially from Canadians — for failing to address Trump's stated desire to make Canada Asked if he has told Trump to stop the 51st state threats, Starmer told

The Associated Press: "I'm not going to get into the precise conversations I've had, but let me be absolutely clear: Canada is an independent, sovereign country and a much-valued member of the Commonwealth.'

The war in Ukraine will be on the agenda. President Volodymyr Zelenskyy is due to attend the summit and is expected to meet with Trump, a reunion coming just months after their bruising Oval Office encounter which laid bare the risks of having a meeting with the U.S. president.

Starmer met with Carney in Ottawa before the summit for talks focused on security and trade, in the first visit to Canada by a British prime minister for eight years.

German officials were keen to counter the suggestion that the summit would be a "six against one" event, noting that the G7 countries have plenty of differences of emphasis among themselves on various issues.

Jaipur Literature Festival London commemorates Ahmedabad plane crash victims

LONDON, June 15: The annual Jaipur Literature Festival (JLF) London opened on a sombre note in solidarity with all those impacted by the Air India Ahmedabad-London plane crash, with senior Congress MP Shashi Tharoor leading a moment's silence at

the British Library. A planned light-hearted inaugural session involving Indian High Commissioner to the UK Vikram Doraiswami was modified to a conversation around the 'Power of Words', with Tharoor and UKbased historian-author Shrabani Basu reflecting upon the inadequacy of words when coping with grief at such an enormous scale.

It came as the death toll in the tragic crash involving a plane that was due to land at London Gatwick Airport on Thursday evening hit 270, including 53 British nationals.

"The language of pain is not words but silence," said Tharoor, as he shared with the audience how he had been airborne on another Air India flight to London at the time of the disaster.

"In many ways, the language of

grief, of suffering, loss is a landscape of shadows. It's so often inadequate to the profound desolation that human beings feel and that language attempts, I think inadequately, to articulate," he said. Basu, the author of 'Spy Princess: The Life of Noor Inayat Khan' and 'Victoria & Abdul: The True Story of the Queen's Closest Confidant', added: "I hope today we can fill this room with the power of words, words to unite us, to console us, to remember those who lost their lives widely and also the love that they carried in their hearts, which we all share with them.'

JLF London, one of the international off-shoots of the main literature festival held in Jaipur and running until Sunday, brought together speakers and writers from around the world to discuss everything from art to literature, history to science, food to film, international politics to sustainability.

"Creativity is and continues to be at the center of everything that we do," said JLF producer Sanjoy Roy, managing director of Teamwork Arts. "This weekend we will be celebrating books and ideas and music and so much more. And this, in many ways, again, is a bridge between India and the UK. Do we need bridges? You bet we do... The easiest thing to do is to hate. Much more difficult is to love and respect each other, and books and ideas are one way to be able to push back on that idea of ignorance," he said.

This year's programme included sessions with International Booker Prize-winning Kannada author of 'Heart Lamp' Banu Mushtaq, lyricist and poet Javed Akhtar, novelist Shobhaa De, playwrights Hanif Kureishi and David Hare, JLF co-directors William Dalrymple and Namita Gokhale, among others. (PTI)

Political violence threaded through recent US history; Motives, justifications vary grim history of political violence, more on detaining people who are

WASHINGTON, June 15: The of New York City late last year, the assassination of one Democratic Minnesota state lawmaker and her husband, and the shooting of another lawmaker and his wife at their homes, is just the latest addition to a long and unsettling roll call of political violence in the United States.

The list, in the past two months alone: the killing of two Israeli embassy staffers in Washington, DC. The firebombing of a Colorado

march calling for the release of Israeli hostages, and the firebombing of the official residence of Pennsylvania's governor — on a Jewish holiday while he and his family were inside.

And here's just a sampling of some other disturbing attacks before that — the assassination of a health care executive on the streets attempted assassination of Donald Trump in small-town Pennsylvania during his presidential campaign last year, the 2022 attack on the husband of former House Speaker Nancy Pelosi by a believer in right-wing conspiracy theories, and the 2017 shooting by a liberal gunman at a GOP practice for the congressional softball game.

"We've entered into this especially scary time in the country where it feels the sort of norms and rhetoric and rules that would tamp down on violence have been lifted," said Matt Dallek, a political scientist at Georgetown University who studies extremism. "A lot of people are receiving signals

from the culture." Politics behind both individual shootings and massacres

Politics have also driven largescale massacres. Gunmen who killed 11 worshippers at a synagogue in Pittsburgh in 2018, 23 shoppers at a heavily Latino Walmart in El Paso in 2019 and 10 Black people at a Buffalo grocery store in 2022 each cited the conspiracy theory that a secret cabal of Jews were trying to replace white people with people of colour.

That has become a staple on parts of the right that support Trump's push to limit immigration.

The Anti-Defamation League found that from 2022 through 2024, all of the 61 political killings in the United States were committed by right-wing extremists. That changed on the first day of 2025, when a Texas man flying the flag of the Islamic State group killed 14 people by driving his truck through



a crowded New Orleans street before being fatally shot by police. "You're seeing acts of violence from all different ideologies," said Jacob Ware, a fellow at the Council on Foreign Relations who researches terrorism. "It feels more random and chaotic and more fre-

The United States has a long and

from presidential assassinations dating back to the killing of President Abraham Lincoln to lynchings and violence aimed at Black people in the South to the 1954 shooting inside Congress by four Puerto Rican nationalists. Experts say the past few years, however, have likely reached a level not seen since the tumultuous days of the 1960s and 1970s, when icons like Martin Luther King, Jr., John F. Kennedy, Malcolm X and Robert F. Kennedy were assassi-

Ware noted that the most recent surge comes after the new Trump administration has shuttered units that focus on investigating white supremacist extremism and pushed federal law enforcement to spend less time on anti-terrorism and

in the country illegally.

"We're at the point, after these six weeks, where we have to ask about how effectively the Trump administration is combating terrorism." Ware said.

Of course, one of Trump's first acts in office was to pardon those involved in the largest act of domestic political violence this century — the January 6, 2021 assault on the US Capitol, intended to prevent Congress from certifying Trump's 2020 election loss.

Those pardons broadcast a signal to would-be extremists on either side of the political debate, Dallek said: "They sent a very strong message that violence, as long as you're a Trump supporter, will be permitted and may be rewarded." (AP)

She claimed that former Delhi Chief Minister Arvind Kejriwal, who is the AAP's national convener, had made "tall promises" to the people of Delhi as well as Punjab but now stood exposed.

"Those who ran away from Delhi after making tall promises are now sitting in Punjab... I want to ask them 'kya hua tera vaada' (what about your promises)," asked Gupta. "Kejriwal should answer what happened to those promises. I will not ask Bhagwant Mann because he is only a "mukhota" (mask), the government here is being run by their leaders from Delhi who have been rejected by the people there," she said. Gupta asked the AAP what is the fate of their promises to improve health infrastructure and schools.

"What about your promise to end drug problem in Punjab? What have you done for these years?...People have died due to consumption of spurious liquor in Punjab, what are you doing? With builder mafia, you are snatching land of poor farmers. In every street, outside every school 'chitta" is sold. Punjab has been converted into a "Chitta Express","

Gupta accused Kejriwal of displaying "false Punjabiyat today". 'When you were in power in Delhi for a decade, not even one minister in Kejriwal's Cabinet was from the Sikh community. Did you not find them able? While in power in Delhi, you never did anything for the Sikhs," she said.

Gupta said the process of delivering justice to the 1984 anti-Sikh riot victims truly began after Prime Minister Narendra Modi came to power. She also said that her government recently handed over job appointment letters to the families of 1984 anti-Sikh riot victims.

In present BJP government in Delhi, you will see a minister from the Sikh community, from the Punjabi community, she added.

Escalating her attack, Gupta said

"The chief minister is seen only in the advertisements, what have you left him with. Entire administration in Punjab is being run by the rejected AAP leaders of Delhi. Be it (Manish) Sisodia, Satyendar Jain, Bibhav Kumar, Raghav Chadha. Who among them is of Punjab origin? Who among these knows the problems of Punjab? They are only power hungry. They lost power in Delhi and quickly de-

scended on Punjab," she claimed.

Gupta said the AAP had made promise to give ₹ 1,000 per month to every woman in Punjab during the 2022 state assembly polls. 'Three-and-a-half years have passed, have they given a rupee. Kejriwal should answer. They had promised MSP to farmers. Did they give?" asked the chief minister. "When the AAP came to power, they said they will end the VIP culture, they were here for change and not for power, they had said such things," said Gupta.

"But now entire previous Cabinet of Kejriwal is now sitting in Punjab. They are using Punjab's resources, for what, to enjoy the VIP culture. They are using the hard earned money of people," she

Gupta said after Kejriwal's party lost power in Delhi earlier this year and the BJP formed the government, the AAP supremo forgot the people of the national capital.

The AAP has fielded Rajya Sabha member Sanjeev Arora for the Ludhiana West bypoll. Gupta said that Kejriwal by fielding Arora in the bypoll wants to clear his route to enter the Rajya Sabha.

The Ludhiana West assembly seat fell vacant following the death of AAP MLA Gurpreet Bassi Gogi earlier in January.

Further attacking the AAP, she said, "In Punjab, they are indulging in politics of corruption. The state is under debt of ₹4 lakh debt due to the AAP's wrong policies and people have to bear the burnt."

"I have come to expose the tall promises they made in Delhi too They said they will make Delhi like London and Paris. But they pushed the national capital backward during their rule. They did not carry even a single development work, only corruption, advertisements and publicity," she added. Gupta said when the AAP was in power in Delhi, their schemes were such where nothing was spend on the ground, but ten times expenses were incurred in advertising those schemes.

"They talked about a liquid solution, which they claimed will check practice of stubble burning and to publicise it they spend ₹ 80 crore...I want to ask the people of Punjab, did you get any liquid solution which they claimed was to check for stubble management," she added. Gupta also cornered the former Kejriwal government in Delhi with regard to implementa-

MEA must move beyond passive advisories, establish coordinated evacuation for Indian students in Iran: Cong

NEW DELHI, June 15: The Congress on Sunday claimed that more than 1,500 Indian students are left in a state of uncertainty in Iran and asked the Ministry of External Affairs to move beyond passive advisories to immediately establish a coordinated evacuation mechanism. The Congress' assertion came after Indians in Iran were on Sunday asked not to panic, exercise due caution and maintain contact with the Embassy of India in Tehran through its social media accounts in view of the current situation in the country following the launch of strikes by Israel.

Congress' media and publicity department head Pawan Khera alleged that while Indian students in Iran are calling for help, the government remains largely unresponsive, even as missiles rain from the sky.

"With flights suspended, airspace over Tehran closed, and internet access disrupted, more than 1500 Indian students are left in a state of precarity and uncertainty - with no information about evacuation or safe zones," Khera said in a post on X.

The Indian Embassy has issued a generic advisory urging the students to "remain vigilant, avoid all unnecessary movements, follow the Embassy's Social Media accounts and observe safety protocols as advised by local authorities", he said. "Meanwhile, students remain trapped in distress as the Indian Embassy in Iran remains unresponsive: 'We are traumatized after last night's attack There has been no response from the Indian Embassy. Our families are panicking'," Khera said. He claimed this is not the first time Indian citizens have been left pleading for help during foreign crises. "Whether it was Sudan, Ukraine, or now Iran, Modi's government has turned evacuations into propaganda opportunities -- stepping in late, speaking too much and doing too little, too slowly, Khera alleged. "The MEA must move beyond passive advisories and immediately establish a coordinated evacuation mechanism -- complete with emergency response teams, real-time communication channels and logistic support -- before the window for safe exit narrows any further," he said.

In an advisory, the Indian embassy in Iran asked all Indian nationals and Persons of Indian Origin to remain vigilant, avoid all unnecessary movements, follow the embassy's social media accounts and observe safety protocols as advised by local authorities.

The embassy provided a Google form on its X account and asked the Indian citizens to fill it out to provide their details. "Please remember, it is important not to panic, exercise due caution and maintain contact with the Embassy of India in Tehran," it said.

It also provided a Telegram Link and asked the Indian citizen to join it to receive updates on the situation from the mission. "Kindly note that this Telegram Link is ONLY for those Indian Nationals who are currently in Iran," the embassy posted on X. It also provided emergency contact details. The Congress on Sunday unequivocally condemned Israel's recent "bombings and targeted assassinations" on Iranian soil and said this attack on Iran's sovereignty and encroachment of its rights only deepens instability as well as sows the seeds of further conflict. 

SIBLAC warned that any expedition involving summiting Kanchenjunga, particularly from Nepal, could be perceived as a serious cultural violation, and called for the mountain to be treated with spiritual reverence rather than as a site for adventure

SIBLAC had earlier urged the Sikkim government to enforce the standing prohibition on climbing Mt Kanchenjunga, citing the sacred status of the mountain and the legal protections already in place. It had condemned the summit attempt by a group of mountaineers in May. (PTI)

Asked what all he has experi-



The Club World Cup is finally up and running and soccer may never be the same

MIAMI GARDENS (USA), June 15: After more than a year of uncertainty and criticism, the Club World Cup kicked off in Miami on Saturday and soccer may never be the same.

At least that's what FIFA president Gianni Infantino has been telling anyone who would listen.

"This tournament will be the start of something historic that will change our sport for the better," he said this week as part of an exhausting schedule of public engagements to drum up interest in the month-long event staged across 11 cities in the United

Soccer's newest tournament is what the sport has been waiting for, Infantino says, and on Saturday, despite considerable pushback and obstacles, he turned his personal passion project into a re-

The Swiss lawyer, who holds one of the most powerful positions in the world as head of soccer's governing body, was on hand at a largely full Hard Rock Stadium to watch Lionel Messi's Inter Miami draw 0-0 with Egyptian team Al Ahly in the opening game of his super-sized Club World Cup.

The match may have been underwhelming, but the occasion kicked off with a lavish opening ceremony featuring music, dance routines and fireworks — was a moment of immense pride for Infantino and conclusive proof of his influence over the most popular sport on the planet. LONDON, June 15: Someone who never dreamt of leading the national cricket team, India's new Test skipper Shubman Gill has set himself the goal of creating a team culture where every player is "secure and happy.'

A transitional India will search for their maiden Test series victory in England since 2007, and the first match is scheduled to take place at Leeds on June

"It was like, not even in my dreams, I thought I wanted to be the captain of the Indian cricket team. So, apart from all the silverware and trophies aside, I really would like to build a team culture where everyone is very secure and happy," Gill told Skysports.

But Gill knew that the task was easier said than done.

"I know it can be a very difficult environment, especially with all the competition and the number of matches that we play, different squads coming in. But if I'm able to do that, I think that would be my goal," he added.

"So, keeping a secure environment and making the player feel secure in his abilities and his capabilities I feel is one of the most important things that a leader

Gill acknowledged that Rohit Sharma,

who retired from Test cricket on May 7, had laid out a clear path for him.

"It can seem like he is not aggressive, but Rohit is very aggressive in terms of his tactics. He is someone who is very clear with his communication prior to the matches, during the series and even after the series, what he wants from the play-

Gill said he wanted to follow the path of his predecessor Rohit, who had always put the team ahead of individuals.

"The kind of environment Rohit bhai kept, even if Rohit bhai is swearing at you, you would not take it to your heart. That's just kind of his personality. I think that's a great trait to have.

"He's firm, but even if he's being hard on you, you know that it's not coming from his heart. It's coming from a team perspective," added Gill.

The 25-year-old said he had a conversation with Rohit on the road ahead for

"This is a conversation that I've had with Rohit bhai a couple of times that ideally in the next 5, 7 or 10 or 15 years, where would we want the Indian cricket team culture to be?"

Gill also said he learned so much from the "proactive" leadership of Virat Kohli. "When I played under Virat, I think his



proactiveness in Test matches with the field or with the ideas or with his thinking was something that I liked and that I picked up. If he thinks that, okay, this plan is not working, he would immediately have another plan, communicate to the bowler what he wants from them." he

Gill also provided a gist of his conversation with head coach Gautam Gambhir and chief selector Ajit Agarkar before taking up the leadership role.

"They just want me to be able to express myself as a leader. I mean, that's what they have told me, there are no expectations. They are not expecting me to, he would want the players to have.

you know, to do something that I'm not capable of.

"But you definitely have some kind of expectations from yourself as a leader and as a player. So those are the expectations that I have from myself," he added. Gill also revealed that he hid all the captaincy talk even from his father, his

biggest source of support in his career. "I don't even think he (father) dreamt of me being the Indian Test captain, like even myself as well. All I remember when I was young, all my dreams were to play for India and win matches.

"So yeah, he called me when the news broke out, I think a couple of days before. But I knew sometime before (the news flashed), but I didn't tell him because I wanted to tell him when it's official. But we had a very heartfelt conversation once he got to know that I've been named the captain," he said.

Gill already has a taste of Gambhir's style of coaching from his days at the Kolkata Knight Riders in the IPL, but he was confident of adjusting to him in the national environment.

"Gautam bhai is very determined, very committed. And he's also very clear with his communication, what he wants from the players and what kind of mindset that

"Gautam bhai focuses more on the kind of attitude or the mindset that he re-

guires from the team or the players. Gill's crisis management ability will be put to test when he will have to decide on the workload of premier pacer Jasprit

Bumrah. Chief selector Agarkar had already made it clear that it's highly unlikely that India will have the services of Bumrah

throughout the series. "It's more based on match to match and see how much workload there has been on him. That's what we are trying to look at. You need to see how much

workload he had in this particular match. "We don't want to have a predetermined mindset. Okay, these are the matches that he would want to play because there are so many factors that can not go in your favour in determining whether he is going to play the next match or not," he explained.

Gill said he has not decided upon any plan to counter England's 'Bazball' method of cricket in the series.

"I don't want to have a preconceived notion of how I would want to go about things. There might be a case, you know, they can come out playing aggressive cricket and can lose a few wickets," he

BCCI trims daily allowances for staff, streamlines travel policy

NEW DELHI, June 15: The daily allowances of the BCCI staff across departments, which have not been paid since January, will finally be released following the streamlining of the domestic 'tournament allowance policy' by the board's top brass.

As per the existing BCCI travel policy, the employees are paid per diem of ₹ 15,000 for short-term travel (up to four days) and ₹ 10,000 for long travel usually relating to the Indian Premier League (IPL). Women's Premier League (WPL) and ICC events hosted by India. A one-time incidental allowance during the travel is ₹ 7500. According to the revised policy, the incidental allowance component has been removed and employees will now be paid a flat ₹ 10,000 per day for their time on the road. The IPL window is slightly longer than two months while ICC events also last at least a month.

A BCCI source told PTI that after tax deduction at source, the per day allowance comes to ₹ 6500.

As the policy was going to be revised, the BCCI staff including the finance, operations and media department have not been paid their daily allowances for USD 1000 on foreign tours. (PTI)

mulated, their dues should be cleared soon. "A clear cut policy was needed in terms of allowances as some employees were claiming allowances even when they were operating out of the Mumbai headquarters during tournaments. Now that it has been devised, the dues will be cleared soon," added the source.

For more clarity, an employee who is travelling for the whole of 70-day IPL would be eligible for a daily allowance of ₹ 10,000 with the total claiming amounting to ₹7 lakh.

For someone who has limited travel during the IPL would be eligible to claim only 60 percent of the 70day allowance and someone who is not travelling at all can claim 40 percent of the amount accrued for 70 days. As far as foreign travel is concerned, most BCCI employees are paid USD 300 per day.

On the other hand, the honorary office-bearers including president, secretary, treasurer, vice-president and joint secretary, are entitled to a daily allowance of
