30 bighas of land allotted to IHM in Sonapur area, informs minister

IHM campus demolished to free Silsako

GUWAHATI, July 21: The Institute of Hotel Management (IHM) was demolished on Monday to free Silsako Beel (lake) in Guwahati city, officials said.

The administration is eyeing to clear the natural waterbody from various structures, both private and government, to mitigate flood problems in the state capital, said Housing and Urban Affairs Minister Jayanta Malla Baruah.

"This is a difficult yet necessary decision. While IHM has served the city in the education sector, the pressing need to safeguard Guwahati from devastating floods demands urgent action. We are acting for the greater good of the city's future," he told reporters here.

The IHM, a central government institute and spread over 15 bighas (almost five acres), is being relocated to a temporary building on GS Road, Baruah said.

'We have allotted 30 bighas (almost 10 acres) to IHM in Sonapur

area. We will construct their infrastructure and hand it over to the institute," he added

Baruah said that eviction and clearance work at IHM marks an important development in making the 800-bigha reservoir project at Silsakoo, envisioned to address the city's chronic urban flooding.

Demolition of the IHM campus started with classroom blocks. Hostel structures and other ancillary facilities will be dismantled in the coming days, he added.

"This is the largest single institutional demolition within the reservoir zone. We aim to complete the process within 15 days, carry-

multaneously," he said.

Earlier, the government had evicted the Omeo Kumar Das Institute of Social Change and Development (OKDISCD) and Institute of Cooperative Management (ICM) from Silsako Beel.

"The remaining two facilities -one tennis court and Ginger hotel -- will also be evicted from the location. We are in discussion with them right now," the minister said.

He said the reservoir site, spread across approximately 800 bighas (over 264 acres), is expected to be excavated during the upcoming dry

The government in 2008 had declared Silsako Beel, surrounded by Chachal, Hengerabari, Pathar Quarry and Satgaon areas, a protected waterbody in Guwahati through an Act and prohibited any construction or settlement in around 1,800 bighas (over 595

Bangladesh training aircraft tragedy claims 20

171 more injured as plan crashes into school building

DHAKA, July 21: A Bangladesh Air Force training fighter jet crashed into a school building in Dhaka shortly after takeoff on Monday, killing at least 20 people, mostly children, and injuring 171, in one of the deadliest aviation accidents in the country's re-

The F-7 BGI aircraft, a training fighter jet manufactured in China, crashed into the two-storey building of Milestone School and College at Diabari in Dhaka's Uttara area. The pilot, Flight Lieutenant Mohammad Towkir Islam, was killed in the crash.

According to an updated statement from the Inter-Services Public Relations Directorate (ISPR), 20 people, including the pilot, have died and 171 others injured. The pilot attempted to steer the aircraft away from densely populated areas. However, despite his efforts, the aircraft tragically crashed into the two-storey building of the school, said the ISPR - the media wing of the military.

"All injured individuals are being promptly transported to the Combined Military Hospital (CMH) and nearby hospitals for necessary treatment, with assistance from Air Force helicopters and ambu-



The aircraft crashed due to a mechanical fault (the details of which will be informed after investigation) after taking off from the Bangladesh Air Force Base AK Khandaker in Kurmitola at 01:06 pm as part of a regular training, the statement said. It said that the chief of army staff and senior military officers rushed to the crash site where rescuers, including firefighters, army troops, police and elite Rapid Action Battalion (RAB), (CONTD. Himanta not worried of China dam on Brahmaputra

'Centre is a better judge on this topic and it will take a call on this

GUWAHATI, July 21: Chief Minister Himanta Biswa Sarma on Monday tried to alleviate fears on China's move to construct the world's largest dam on Brahmaputra and said he does not foresee any immediate cause of worry as the river gets most of its waters from Bhutan and Arunachal Pradesh. Speaking to reporters on the sidelines of a function

here, Sarma said the exact impact of the massive dam, the construction of which began last week, is not properly known as different theories are being floated, and he hoped that the Centre must be in touch with China on the matter.

China on Saturday formally started the construction of a USD 167.8 billion dam over the Brahmaputra River in Tibet, close to the border with India in Arunachal Pradesh.

"I am not immediately worried because Brahmaputra is a mighty river and it is not dependent on a single source (of water)," Sarma told reporters here.



When asked about the possible downstream impact of the dam on Assam, he said it is not yet known whether it will be good or bad.

"Brahmaputra gets most of its waters from Bhutan, Arunachal Pradesh, and the rainwater and other forms of water from our state itself," he added.

The CM further said that there are two scientific views floated regarding the dam by China.

"First -- if Brahmaputra's flow is disturbed by China, then there may be less water and consequently biodiversity will be affected. But there is also a counter view that if less water comes, it will also act as a flood cushioning. So, I don't know which one is correct," he added. Sarma opined that the Centre is a better judge on this topic, and it will take a call on this.

"I am sure that they (Centre) must already be having a discussion with China or will have a discussion with the neighbouring country," he added.

The dam is being built at a massive gorge in the Himalayan reaches, where the Brahmaputra makes a huge U-turn to flow into Arunachal Pradesh, and then to Assam and Bangladesh.

According to reports, the size of the project would dwarf any other single infrastructure project on the planet, including China's (CONTD. ON PAGE-2)

India becomes Malaysia's top oil palm seed buyer as domestic cultivation expands

KUALA LUMPUR, July 21: The country currently has about ply and keep cooking oil prices af-India has emerged as Malaysia's 370,000 hectares under palm oil fordable for consumers. largest importer of germinated oil palm seeds, with demand surging as the country accelerates efforts to boost domestic palm oil production and reduce import depend-

India imported 3.03 million tonnes of palm oil from Malaysia in 2024, representing 17.9 per cent of Malaysia's total palm oil exports and making it the top destination for Malaysian palm oil.

"There has been a noticeable increase in demand for Malaysian oil palm seeds, particularly from İndia," Malaysian Palm Oil Board Director General Ahmad Parveez Ghulam Kadir told PTI, citing India's push to expand domestic production.

India aims to rapidly expand palm oil cultivation to 1 million hectares by 2025-26 and achieve nearly 2.8 million tonnes of crude palm oil production by 2029-30 under its National Mission on Edible Oils-Oil Palm scheme.

The seed trade, however, remains largely informal, with supolies conducted on an ad hoc basis through one-off consignments without formal contracts or longterm agreements, Kadir noted.

Most transactions happen through business-to-business arrangements where Malaysian exporters provide quality planting materials and technical expertise.

"Malaysia welcomes this development as it reflects confidence in the quality of our seeds and our longstanding partnership with India," he said.

The development comes even as Malaysia's palm oil exports to India have moderated following New Delhi's recent reduction in tariffs on crude palm oil.

Kadir said India's tariff adjustments are part of broader policy measures to manage domestic sup-

While Malaysia has seen some moderation in export volumes to India, we remain a key and reliable supplier, and the Indian market continues to be a priority," he said.

Malaysia is engaging stakeholders to strengthen its position in food manufacturing and hospitality segments where demand remains strong, while promoting sustainable palm oil certified under the Malaysian Sustainable Palm Oil

The Malaysian Palm Oil Board has developed new high-yield varieties through breeding programs that can potentially produce over 30 tonnes of fresh fruit bunches per hectare annually, nearly double Malaysia's national average of 15.47-16.73 tonnes recorded between 2020-2023. The improved varieties also have slower height growth, extending economic lifespan from 25 years to over 30 years while facilitating harvesting operations.(CONTD. ON PAGE-2)

The project was set up after a massive eviction drive was carried out in 2021 to clear 77,420 bighas (25,500 acres) of land from alleged encroachers, mostly Bengalispeaking Muslims, in which two persons, including a 12-year-old boy, were killed in police firing.

"The successful eviction drive here emboldened us and made us

nd Paikan. We Batadrava, Chap have cleared 1.29 lakh bighas (nearly 43,000 acres) in four years, and this land is being used for the public good now." Sarma said.

He said plantations were being done in the cleared land and in forest areas which have been freed from encroachers, and animals such as elephants, rhinos and tigers are returning to their natural habitats. "We have taken the pledge to

clear every inch of land from en-Bangladeshis... 29 lakh bighas (10 lakh acres) are still encroached by illegal Bangladeshis and doubtful citizens," the chief minister said.

The government cleared only a small portion, Sarma said, adding that he is confident that he will be able to make other land encroachment-free, as the Assamese people have rediscovered the zeal within them. "If someone thinks that we will stop after two to three eviction drives, fear their red eyes and bow

PM underscores unity, military strength, and India's transformation from conflict to progress

NEW DELHI, July 21: Prime Minister Narendra Modi on Monday set the ruling alliance's tone for an expected discussion in Parliament's Monsoon session on Operation Sindoor, describing this sitting of parliamentarians as a "Vijay Utsay" and expressing confidence that MPs will articulate this sentiment in one voice.

In his customary remarks in Parliament complex before the session's start, Modi lauded a number of positive developments for the country and asserted that the Constitution is prevailing over bombs

As naxalism's footprint shrinks fast, red zone is turning into green growth zone, he added.

"This Monsoon session is a very proud session for the country. It is like a 'Vijay Utsav' (celebration of victory) for the nation. The world witnessed the capability of armed forces. They achieved their targets

100 per cent," he said. He also noted that the Indian flag was unfurled recently at the International Space Station, a reference to Shubhanshu Shukla becoming the first Indian to set foot

The prime minister said economy was getting a boost from bountiful rains, while peace and progress have marked this decade amid low inflation and high growth. The water reservoir level has tripled compared to the past ten years, which will significantly benefit economy, he added.

ing naxalism, security forces are moving ahead with a new enthusiasm," he said.

"I can say with pride that in the country, numerous districts have come out of the grip of naxalism and are breathing freely. Our Constitution is winning," Modi said.

He also hailed the economic transformation in the last 11 years, saying that when his government took office India was part of the fragile five but was now moving forward towards becoming the third biggest global economy.

Peace and development have moved ahead shoulder to shoulder in the last decade, Modi said.

Before 2014, the prime minister said India grappled with doubledigit inflation. The inflation rate is now hovering around 2 per cent, and citizens are experiencing relief and improved ease of living.

TEZPUR, July 21: Seven people were arrested after arms and ammunition were recovered from their possession during an operation to thwart an attempt to form a criminal gang for carrying out illegal activities in Assam's Sonitpur district on Monday, a top police of-

A camp of the criminals at Tharaibil on the foothills bordering Arunachal Pradesh was also destroved, he said.

Sonitpur Senior Superintendent of Police Barun Purkayastha said that the operation was conducted by a special team led by the Dhekiajuli police.

"It was a crackdown on the criminals who were trying to form themselves into a gang to carry out activities such as dacoity and extortion," he said.

He said raids were conducted at two places since Sunday night, leading to the recovery of a cache of arms and ammunition, including two 7.65 mm pistols, 16 rounds of live ammunition, two countrymade rifles and two 'khukris'

(knives). While five people were apprehended in the raids, two others who had escaped were arrested during the day with the help of police from neighbouring districts, the SSP said. (PTI)

Par panel for tax exemptions on anonymous donations to NPOs, TDS refund without penalty

tary panel, headed by BJP leader Baijayant Panda, has favoured continuing tax exemption on anonymous donations made to religious-cum-charitable trusts in the new Income Tax Bill, saying any removal would have an adverse impact on not-for-profit organisations.

The 31-member Select Committee of the Lok Sabha that examined the new Income Tax Bill, 2025, also suggested allowing taxpayers to claim TDS refund even after the ITR filing due date without paying any penal charges. The Committee has recommended changes in the Income Tax Bill, 2025, which will replace the sixdecade-old Income Tax Act, 1961.

The 4,575 page report, which was tabled in the Lok Sabha on Monday, also made suggestions for sweeping changes in the way the new Income Tax bill, 2025, was to treat income of non-profit organisations (NPOs), while commending tax department's move of replacing the dual concepts of "previous year" and "assessment year" with a single, unified term: "tax year"

"The adoption of a single, consistent 'tax year' streamlines tax period references throughout the legislation, making the law more accessible and easier to understand," the report said.

With regard to NPOs, the government in the new bill has exempted from tax anonymous donations received by purely religious trusts. However, such donations received by a religious trust that may also have other charitable functions, like running hospitals, and educational institutions, will be taxed as per law. Clause 337 of the Income Tax Bill, 2025, proposed a flat 30 per cent tax on anonymous do-

"The committee strongly urge the reintroduction of a provision analogous to the explanation found in Section 115BBC of the 1961 Act," the report said.

While the Bill's stated aim is textual simplification, the committee observe a critical omission concerning religious-cum-charitable trusts, which could have substantial adverse impacts

"In such scenarios, the law should not compel a return merely to avoid penal provisions for non-filing. The committee, therefore, recommend to remove sub-clause (1)(ix) from Clause 263 to provide flexibility for allowing refund claims in cases where the return is not filed in due time," it noted.

The Committee has made 32 important recommendations on the I-T Bill, as per a statement issued by the panel. Parliamentary committee reports are recommendatory in nature and the government may choose to accept them in part or in full. Commenting on the report, BDO India Partner, Tax and Regulatory Services, Preeti Sharma said the report suggests a total of 566 observations / recommendations for change. Now the Lok Sabha has to debate the recommendations and identify the changes that are required in the current Bill to make it futuristic and relevant for common taxpayers.

Nangia Andersen LLP, M&A Tax Partner, Sandeep Jhunjhunwala said the Committee has suggested modernising definitions such as "capital asset" and "infrastructure capital company", clarifying property-related deductions, and reinforcing the "actual payment" rule for business expenses. It has also recommended procedural safeguards such as making penalties for non-maintenance of books discretionary and permitting refund claims even where returns are not filed on

HDFC Bank posts 12.2% rise in Q1 net profit, PAT at ₹181.6 billion

HT Bureau GUWAHATI, July 21: HDFC Bank Limited recently announced its financial results for the quarter ended June 30, 2025, reporting a 12.2% year-on-year growth in profit after tax (PAT) to ₹181.6 billion. The bank's profit before tax (PBT) for the quarter stood at ₹212.9 billion.

According to an official statement, the total balance sheet size as of June 30, 2025, reached ₹39,541 billion, compared to ₹35,672 billion on the same date last year. The average deposits for the quarter were ₹26,576 billion, registering a 16.4% increase from ₹22,831 billion in the June 2024 quarter and a 5.1% rise from ₹25,280 billion in the March 2025 quarter. HDFC Bank's net revenue during the quarter was ₹531.7 billion. This includes transaction gains of ₹91.3 billion from a partial divestment through an offer for sale in the recent IPO of its subsidiary, HDB Financial Services Ltd.

Bangladesh training aircraft

continued their rescue operations. A high-level investigation committee has been formed by the Bangladesh Air Force to determine the cause of the accident, the statement added. Brigadier General Zahed Kamal, Director General of Fire Service and Civil Defence, earlier told reporters that the crash and the subsequent fire killed 19 people. At least 50 others were critically injured, he added. He said that rescuers recovered 19 bodies from the school compound alone while the rescue operation was underway.

Earlier, Md Sayedur Rahman, the special assistant to Chief Adviser Muhammad Yunus for the Health Ministry, said that injured people, mostly students, were being treated at the Combined Military Hospital (CMH), Dhaka Medical College Hospital, and the National Institute of Burn and Plastic Surgery (NIBPS). According to doctors, eight of the injured were in critical condition. 'The number of injured people being brought to our facility is rising," a doctor at NIBPS told reporters. Fire service officials earlier said the jet crashed atop a four-storey building of the school with a big bang and immediately caught fire.

According to police, firefighting units, ambulances, and air force helicopters rushed to the scene soon after the crash. A teacher of the school, who spoke on condition of anonymity, said that security personnel were putting bodies in body bags to be taken to Dhaka's combined military hospital from the damaged building, which housed classes from one to seven.

"Dozens of ambulances were carrying the wounded to nearby hospitals," she said. The National Burn Institute in the capital said they were treating 18 people, mostly students, some with critical conditions. The interim government has declared a one-day state mourning on July 22 when the national flag will be flown at half-mast across Bangladesh and its missions abroad. Chief Adviser Professor Muhammad Yunus expressed shock and sorrow over the casualties caused by the crash.

"I am deeply saddened by the casualties caused by the heartbreaking accident involving a Bangladesh Air Force jet at the Milestone School and College campus," he said in a statement. Fahim Hossain, an eleventh-grade student, said that the jet crashed right in front of his eyes -

"It hit the ground floor of a two-storey building around 1:15 pm, where classes for the primary section were taking place," Fahim told The Daily Star.

The plane crashed in front of the classrooms used by class 3 and class 4 students. Recounting the experience, a teacher who was injured in the incident said students were lining up to leave the school just as the final bell rang when the flames erupted.

There was no warning. Before we even understood what was happening, there were flames all around. Visibility dropped instantly. All I could see was fire, then smoke," the teacher said. "Both of my hands were burnt. I'm also experiencing breathing difficulties, and my face and ears are scorched."

Witnesses said many wounded people were carried away by spontaneous volunteers and army troops from the crash site, even in rickshaws and tricycle vans.

"We transported some of the injured with burns onto rickshaws and vans. Their clothes were ripped apart, torn, and some even were walking towards rescue vehicles with burn injuries on their bodies," said Nuruzzaman Mridha, a teacher of the school.

The crash was one of the deadliest aviation accidents in Bangladesh in several decades, Bangla-language daily Prothom Alo reported.

Law, Justice and Parliamentary Affairs Adviser Asif Nazrul said that today's crash was "a great tragedy in our national life on an unprecedented scale".

Three platoons of Border Guard Bangladesh (BGB) have been deployed at the crash site to assist the law enforcement and rescue operations, according to a BGB press release. (PTI)

His appointment is expected to add further impetus to the administration of justice in the region.

own Three Gorges Dam, regarded as the largest in the world so far. The mammoth dam will be built in one of the rainiest parts and the project site is located along a tectonic plate boundary where earthquakes occur. Brahmaputra flows across the Tibetan plateau, carving out the deepest canyon on Earth.

The Tibetan plateau, regarded as the roof of the world, frequently experiences earthquakes as it is located over the tectonic plates. The hydropower project, regarded as the biggest infrastructure project in the world, raised concerns in the lower riparian countries -- India and Bangladesh.

The dam, besides empowering China to control the water flow, could also enable Beijing to release large amounts of water, flooding border areas in times of hostilities. India, too, is building a dam over the Brahmaputra in Arunachal Pradesh.

On July 19, Chinese Premier Li Qiang announced the start of the construction of the dam at a groundbreaking ceremony in the lower reaches of the Brahmaputra River, locally known as Yarlung Zangbo, at Nyingchi City.

The project will consist of five cascade hydropower stations, with a total investment estimated at around 1.2 trillion Yuan (about USD 167.8 billion). According to a 2023 report, the hydropower station is expected to generate more than 300 billion kWh of electricity each year, enough to meet the annual needs of over 300 million people. India and China established the Expert Level Mechanism (ELM) in 2006 to discuss various issues related to trans-border rivers, under which China provides India with hydrological information on the Brahmaputra and Sutlej rivers during

Data sharing of trans-border rivers figured in the talks between Indian and Chinese Special Representatives (SRs) for the border question -- NSA Ajit Doval and Chinese Foreign Minister Wang Yi, respectively -- held here on December 18 last year. (PTI)

India becomes Malaysia's

Current Malaysian commercial seeds are suitable for cultivation in India with proper farming practices and adequate irrigation, Kadir said, noting the materials have performed well under tropical conditions similar to many Indian regions with sufficient rainfall.

Research efforts are underway to develop climate-resilient varieties with improved drought tolerance, though none have been commercially released yet, he added. (PTI)

Sarma maintained that the Gorukhuti eviction was an important one, which even led to "international pressure" on the government to stop such drives. "But our people were not dissuaded. Sarma maintained that the Gorukhuti project is not about profit or loss, but it is about reclaiming the land for the indigenous people.

Highlighting the progress of the project, Sarma said it has generated approximately Rs 5.05 crore in revenue in its fourth year and currently holds deposits of around Rs 7.64 crore.

He described it as laying the foundation for a new model of self-sufficiency, built on cattle and pig farming, handloom production, and other activities. He added that the government is considering the establishment of an agricultural science institute at Gorukhuti to equip the youth with training in modern organic farming techniques.

He announced that under the Pradhan Mantri Matsya Sampada Yojana, the Department of Fisheries has launched a scheme to develop an integrated aqua park in the project area. He also said that the monthly honorarium paid to the Krishi Sainiks involved in the project will be increased by ₹ 2000 per month. (PTI)

"The secretary general will take the necessary steps in this direction," the Rajya Sabha Chairman announced.

The Act states that no inquiry committee shall be constituted unless the motion has been admitted in both Houses.

The committee comprising a senior judge of the Supreme Court, a sitting chief justice of a high court and a distinguished jurist will then probe the charges levelled against Justice Varma. It will be asked to come out with a report in three months.

The inquiry report will be tabled in Parliament, followed by a discussion in both Houses after which there will be voting on the motion for the removal of Justice Varma. Though Justice Varma has denied any wrongdoing, the inquiry panel constituted by the then Chief Justice of India Sanjiv Khanna concluded that the judge and his family members had covert or active control over the storeroom where the cash was found, proving his misconduct serious enough to seek his removal. fostering community harmony. Railway Board official inspects Kamakhya Depot and BOOT

GUWAHATI, July 21: Manu Goel, Additional Member (Environment and Housekeeping Management), Railway Board, conducted a comprehensive inspection of key infrastructure and service facilities under the Northeast Frontier Railway on July 17.

The visit was aimed at reviewing housekeeping standards, waste management systems, and passenger service delivery mechanisms, as per an official statement.

Accompanied by Ajay Nandan, Principal Chief Mechanical Engineer of NF Railway, Goel began the inspection at the Kamakhya Depot, where he reviewed the integrated cleaning and maintenance contract for the Brahmaputra Mail.

This initiative, the first of its kind, includes coach maintenance, bedroll distribution, onboard housekeeping services (OBHS), and minor enroute repairs. According to the statement, the initiative

has led to a 25% reduction in passenger complaints on the Rail Madad portal. Goel also appreciated efforts such as grav-

ity cock solutions for leaky taps and enhanced supervisor training for pipeline isolation.



The inspection also covered the AMI generation and testing facility that supplies over 1.45 lakh litres of bacteria used for bio-toilet maintenance in trains operating from depots including Agartala, Katihar, New Jalpaiguri, Dibrugarh, Naharlagun, and New Bongaigaon.

Innovations showcased during the visit included pre-cooling of AC coaches prior to platform placement, resulting in fewer passenger complaints and reduced platform detention, a dedicated UIC testing model to minimise cable faults, and saltwater resistive load testing for power cars to ensure generator ef-

Goel also visited the Rail Madad War Room at Kamakhya, where 24x7 monitoring of OBHS activities and passenger complaints is carried out.

Key features such as real-time cleaning res-

olution, bedroll tracking through IRCTC charts, biometric attendance of OBHS staff, and monitoring of train cleanliness were re-

He praised the integration of digital systems and interdepartmental coordination for improving passenger services. At the BOOT Laundry facility in New

Guwahati, Shri Goel inspected modern equipment including a multi-stage tunnel washer, ironers, folders, and high-capacity boilers used for cleaning bedrolls and blankets. The facility currently handles around

13,365 bedroll packets daily for Guwahati and Kamakhya-based trains. Quality checks using whiteness meters were also highlighted. The official statement further noted that the inspection reflects the Railway Board's commitment to improving environmental sustain-

ability, operational cleanliness, and service quality. Future developments under the NF Railway include the introduction of Vande Bharat and Amrit Bharat trains, installation of a tandem wheel lathe, provision of Overhead Equipment (OHE) over pit lines, and development of a new coaching complex at New Guwahati.

India's fintech revolution

ndia has long been celebrated as a global trailblazer in financial inclusion. From biometric identity systems to mobile-enabled dig-Lital payments, we've built infrastructure at a scale and speed that few countries can rival. According to the World Bank's Global Findex Database 2021, 78 percent of Indian adults now own a formal financial account—up from just 35 percent in 2011. It's a statistic that looks impressive, and it is. But the real story lies in what these accounts are—or are not—doing. A third of them, according to the same Findex report, are inactive. Millions of Indians hold accounts they don't use. This sobering fact signals a harsh truth: we may have solved for access, but we've barely begun to solve for inclusion. The Jan Dhan-Aadhaar-Mobile (JAM) trinity gave financial accounts to the masses. It was an unprecedented push to formalize the economy and improve the delivery of government benefits. But over the years, the focus has become narrowly administrative—opening accounts, linking them to Aadhaar, transferring funds—without attending to the deeper challenge of making financial services meaningful, especially for the poor and the marginalised. If inclusion is only measured by the number of accounts opened, we are mistaking a means for an end. A dormant account is not a tool for savings, credit, or security. It is, at best, a conduit for a government subsidy—and often, just another number on a dashboard.

Yes, the gender gap in account ownership has narrowed—from 20 percentage points in 2014 to just 6 in 2021. That's commendable progress. But ownership alone does not ensure agency. In practice, many women in rural India depend on male relatives or banking agents to access their accounts. This undermines privacy and autonomy, and in some cases, increases vulnerability to exploitation. A study cited by the World Bank showed that when women in a government workfare program were paid into their own accounts, rather than their husband's, they were more likely to seek employment and exercise control over household finances. The lesson is clear: financial infrastructure must empower women, not just enroll them. India's digital payment ecosystem—fueled by UPI, mobile wallets, and QR codes—is often held up as a model. During the pandemic, over 80 million Indians made their first digital merchant payment. Yet beneath this boom is a digital divide that mirrors our socio-economic

More than half a billion Indians with accounts did not make a single digital payment in the year preceding the 2021 survey. Why? Many lack smartphones or affordable data. Others face language barriers or interface complexity. For the elderly, the illiterate, and the digitally uninitiated, even basic navigation can be daunting. And let's not forget: digital fraud and unauthorized deductions are growing concerns, especially for low-income users. Simply put, digital access without digital literacy breeds new forms of exclusion. Many of those who do receive wages or benefits digitally still report frustration. According to the World Bank, one in five wage recipients in India paid unexpected or hidden fees to access their own money. Others cited distance, poor connectivity, or lack of understanding as reasons for not using their accounts.

The declaration of TRF as a terrorist organisation – A big victory

Then innocent lives were cent terrorist attack in Pahalgam, it sent shockwaves across India and the world. The cries of victims once again reminded us that terrorism still thrives—nourished by political patronage, ideological extremism, and cross-border sup-

port. In a transformative move, the United States has officially designated The Resistance Front (TRF)—a proxy of Pakistanbased Lashkar-e-Taiba (LeT)—as a global terrorist organisation. This action is not just symbolic; it marks a strategic global shift against the proxy war machinery that has long used Kashmir as a battle-

This US action is being hailed as a significant diplomatic success for India, reflecting the persistent efforts of Prime Minister Narendra Modi and External Affairs Minister S. Jaishankar to internationalise the issue of Pakistan-sponsored terrorism. It validates India's long-standing claim that Pakistan continues to harbour, protect, and export terrorism under various facades. Though TRF attempts to appear as a local Kashmiri resistance group, it is merely the rebranded face and extended arm of Lashkar-e-Taiba and Hafiz Saeed's terror network Formed after the abrogation of Article 370 in 2019, its mission has been to orchestrate attacks in India under the guise of "indigenous rebellion."

TRF employed social media, digital platforms, and diplomatic jargon to mislead international opinion, falsely positioning itself as a grassroots Kashmiri movement. In reality, its strings are pulled directly from Rawalpindi and Pakistan's ISI.

Pakistan has long attempted to disguise itself as a victim of terrorism, while actively cultivating and exporting extremism. The global community has, over time, recognised this hypocrisy, prompting Pakistan to rename and rebrand its terror groups. TRF is a prime example of this strategy. The Pahalgam attack was an assault not just on lives but on India's vision for peace and progress in Kashmir, especially through tourism and infrastructure development. Whenever peace returns to the Valley, terror outfits respond with bloodshed.

The designation of TRF as a global terrorist entity sends a clear global message—that terrorism cannot be hidden behind new names. Using terror as an instrument of foreign policy must face universal condemnation and consequence. India's success is rooted in its strategic outreach. Delegations were



sent to 32 nations, including the US, to present concrete evidence proving that TRF is merely a front for Lashkar-e-Taiba. These efforts bore fruit in the form of the US declaration

Despite supporting India on paper, the US and international bodies continue financial engagement with Pakistan, often through loans and aid from the World Bank and IMF. This duality must stop. Supporting a terror-breeding nation contradicts the very principles of counter-terrorism. The United Nations Security Council (UNSC) has often shown indecisiveness in terrorism matters. Similarly, the FATF's reluctance to move Pakistan into its grey list, despite ample evidence, raises serious questions. If Pakistan is openly backing TRF, why is it still escaping stringent sanctions?

India must not rest on symbolic victories alone. The following steps are essential: Strengthen crossborder counter-terror strikes including surgical and drone operations. Demand international economic sanctions on nations or entities funding terrorism. Enhance domestic intelligence and cyber surveillance capabilities. Keep exposing Pakistan's terror nexus at FATF, UN, and G20 platforms.

A united front of democratic, peace-loving nations must adopt a Zero Tolerance Policy against terrorism. No country-directly or indirectly-should be allowed to provide safe haven to terrorists. The declaration of TRF as a terrorist organisation is just the first step. The real challenge lies in eliminating its financial, logistical, and ideological roots. The unholy nexus between Pakistan's government, military, and terrorist outfits must be broken. The Pahalgam attack is a reminder that terrorism is not merely a security threat—it is an insult to humanity, civilisation, and peace.

India must now act with resolve and readiness, not just reaction. We owe it to future generations to build an India where Kashmir is known for its beauty—not its bloodshed. The campaign to globally isolate TRF and similar outfits must continue

Trump had targeted Brazil with new trade penalties, announcing a 50 percent tariff on imports beginning in August over what he described as "unfair" trade practices. This follows his earlier July 6 declaration of a 10 percent tariff on any nation aligning with the BRICS group.

BRICS Over the Years The BRICS group, origi-

nally formed in 2009, is a coalition of emerging economies comprising Brazil, Russia, India, China, and South Africa (which joined in 2010). In 2024-25, the bloc expanded to include Egypt, Ethiopia, Indonesia, Iran, Saudi Arabia, and the United Arab Emirates, bringing the total number of member countries to 11.

BRICS was established with the goal of promoting peace, development, and a more balanced global order by strengthening economic cooperation among developing nations. Over the years, it has positioned itself as a counterweight to Western-led institutions like the G7 and the IMF, advocating for a multipolar world and reforms in global governance systems. The bloc also promotes the use of local currencies in trade.

But what defines BRICS today is a subtler, more strategic ambition: to insulate themselves from Washington's gravitational pull while cooperating to build a joint hi-tech industrial base. There are things that the BRICS get right. Finan-

Overall, the future of BRICS might be shaped less by external threats and more by its ability to reconcile internal contradictions and articulate a coherent vision for global governance. For now, the coalition is more a reflection of the shifting geopolitics of the Global South than a monolithic challenger to the West. The embryonic nature of its de-dollarisation efforts and the moderating influence of India and Brazil suggest that the group's challenge is more latent than explicit. Nevertheless, as Western institutions continue to grapple with questions of legitimacy and representativeness, the mere existence of BRICS, with all its contradictions, signals a world in flux – and an invitation to rethink the foundations of international order.

reaucratic Governance: Capunism is a bureaucratic system that merges the best aspects of market forces and public service. It offers a framework where market forces and bureaucratic structures work together for mutual benefit. Singapore stand as a stellar example of this system, demonstrating how a well-designed bureaucratic structure can lead to remarkable socio-economic development and public service efficiency. Singapore is a British colony that bears much resemblance to the Indian and British administrative system. But In 1995, the Singapore government launched the Public Service for 21st Century initiative (PS21), which focuses on institutional ethos such as innovation, quality, customer service and staff well-being. Singapore's government recognizes the importance of decentralization and the distribution of decision-making powers. Each department operates with clear missions and objectives, and teams have specific, measurable targets. Decentralization empowers subordinates to complete complex tasks effectively, fostering a culture of accountability and innovation, while rewarding high performers. To attract and retain the best talent, Singapore invests heavily in education and offers competitive compensation for public servants. Bureaucrats' salaries are aligned with private sector standards. This ensures that decisions are made based on expertise and the public good rather than personal gain. This technocratic approach ensures that merit-based appointments and promotions are given. Only competent and

hardworking individuals are rewarded, thus reducing corruption and inefficiency. India can learn from Singapore's example, by embracing meritocracy, decentralization, investment in talent, continuous improvement and anti-corruption measures. This approach can transform India's bureaucratic system into an engine of innovation and efficiency, making it more accountable, transparent and responsive to citizens' needs. This will prevent the pitfalls of rigid bureaucracy as seen in India's case. Rather than the system itself picking the winning and loser, the role of the system will become that of a facilitator. which will create a level playing field for all participants. The winners and losers are decided by performance, not by allegiance to authority. More importantly, the state of a country's economy will always be a reflection of what its system promotes. The American system promotes innovation (innovative economy); the Chinese promotes scale (export-oriented

economy); while the Indian system promotes inefficiency and sycophancy. Despite missions like Mission Karmayogi and Digital India, many bureaucrats resist change due to: * Job security through permanency * Aversion to transparency * Lack of training in tech or modern governance models This represents a cultural lag, where institutional culture fails to adapt to modern technological and participatory needs, a key change.



What India needs is not just efficient administrators but ethical public servants - who see their power not as entitlement but as responsibility. Unless we redirect the narrative from valorisation to accountability, India's steel frame risks becoming a rusted relic of unfulfilled democratic

The "ghosts" haunting India's bureaucracy aren't just inefficiencies they are deep sociological relics of colonialism, elitism, and institutional decay. Understanding them requires more than administrative reforms; it demands a sociological lens that examines structures, cultures, and power dynamics. Only then can India hope to build a bureaucracy that is truly transparent, accountable, and citizen-

was 33 years old when I joined the Department of East ▲ Asian Studies at the University of Delhi as a master's student. The average age in my class was around 24. Therefore, there would be a natural curiosity among my batchmates to know my age and the year I was born. I never revealed my birth year. But there was no reluctance in me telling them my age, nor in their accepting me into their circle. These students came from varied backgrounds, from chemistry to physics, from computer engineering to life sciences. As they got used to the course syllabus, an area-specific study of International Relations, they arrived at a very critical year: 1989, the year I was born. Since then, the reaction was always more than polite interest. It carried a strange weight for me to explain and for them to understand the meaning of the period. In a field shaped by political fault lines, revolutions, and ideological moves, 1989 was a tectonic shift. The world, in many ways, was reborn that year. Every time there would be a mention of this particular year by the Professors, glances would be passed. A child born in 2002 feels both uneasy and amazed to be with someone from that era. But here's the thing I've been thinking about lately: how long will that memory last? Not the textbook version of 1989, but the emotional, lived memory of it as a universal watershed year. I believe it will remain significant for exactly one

nary rolls around, the world will turn around to take one last meaningful look. After that, I believe there would be a dynamic shift, and not just 1989, but the whole 20th century will likely slip into the background of public consciousness. Its urgency, its symbolism, its power—all will begin to fade. This isn't about nostalgia. It's about how time works on memory. I believe history tends to give its most serious attention at the 100-year mark. Think about it for a moment. The First World War's centenary in 2014 brought back a moment of global reflection. 2039 will do the same for World War II. These anniversaries aren't just calendar events; they're moments where cultures attempt closure. They teach. They mourn. They remind. And then they start to move on. Because after a certain time, memory changes. No living witnesses remain. No oral history. The relevance begins to flatten into commemoration. The other key component is how humanity made a big leap in not only technology but also overall growth as we progressed from the 1980s to the 1990s and finally to the Y2K crisis. That's why I believe 2089 will be the last moment when 1989 feels alive in public conversation. Not just because of the numbers lining up, but because the world that remembers 1989 those who protested, those who ruled, those who sang, wrote, photographed, and were shaped by that year—will largely be gone. I will be gone. What will remain is context, not connection. And yet, for one last time, the world will look back at the whole century that was defined by the events that marked 1989.

The case for 1989 being a turning point isn't a stretch, but it's the closest thing we have to a universally acknowledged shift in the late 20th century. The Berlin Wall fell, and with it, a Cold War symbol cracked open in real time. East and West Germany would soon reunite. Across Eastern Europe, communist regimes unravelled with a speed no one had thought before. In Poland, Czechoslovakia, Hungary, and Romania, governments that had ruled for decades crumbled in months. A great example is Nicolae Ceauşescu, the Romanian dictator, who bore witness to his entire empire crumbling down in front of his eyes on a single day. The next day, 25th December, he was assassinated by the very guards who once swore to protect him. Take China. Students filled

and poems and an impossible hope, bringing democracy and freedom of the press and speech. What followed was state violence on an unimaginable scale. Yet the world took note of it. And so did China's leaders, who would choose, after that moment, to keep the political iron-grip tight while letting the economy accelerate. No one could deny that the hybrid model of authoritarian capitalism took wings in the shadow of Tiananmen. Outside of the usual Cold War zones, the changes were no less signifi-The Soviets left Afghanistan. Civil war tightened its grip on Sri Lanka. The Kash-

mir insurgency picked up. In driven by a different kind of fire South Korea, democratic consolidation was underway.

In India, 1989 marked a major political shift. The Congress party lost its dominance in the general elections, and the rise of coalition parties began to reshape India's political landscape. The Mandal Commission's implementation was about to drop in. Ayodhya politics were heating up. Identity, caste, and communal lines were being redrawn, not with borders, but with ballots. street protests, and violence. And then there's Assam, grappling with its own set of problems. The state had been a ticking time bomb for over a decade, its fuse lit by the unrest of the Assam Movement, protesting illegal immigration and demanding protection for Assamese identity. Though the Assam Accord was signed in 1985, by 1989, the promises had been diluted. Tensions simmered. Insurgent groups, most notably ULFA, started gaining strength. One of the most tragic flashpoints that year was the Gohpur Massacre, where 535 people were killed in a brutal episode of ethnic violence. The scale of savagery was such that the state suffered immediate political implications. The Election Commission cancelled voting across Assam for the 1989 general elections, citing security reasons. While India held its breath and watched the fall of one-party dominance, Assam was denied even the basic

act of casting a vote. So while the world watched walls fall in Europe, young men to save one's culture, linguistic, and political dynamics. It was a reminder that the idea of "transition" wasn't always peaceful and the same everywhere, and that for some parts of the world, 1989 was less about liberation and more about deepening unrest.

It wasn't just borders and ideologies that shifted in 1989. The culture changed, too. If the political world was falling apart and rearranging itself, the cultural world was capturing that uncertainty, bottling it into music, film, and literature. The year saw many incredible stars take their final breath. Start with music. Freddie Mercury, the iconic frontman of Queen, recorded his final song as his health deteriorated due to AIDS. The band released The Miracle, an album marked by unity, reflection, and a kind of quiet farewell. Mercury would not publicly recognise his sickness until just before he died in 1991, but by 1989, his public appearances had become rare. It felt as if a generation's defining voice was gradually dissolving into quietness. And it wasn't just him. The AIDS crisis was altering the music industry as a whole, forcing people to confront stigma, loss, and action.

One of India's most prominent cultural voices was silenced on the first day of the year. Safdar Hashmi, a writer, activist, and co-founder of Jana Natya Manch, was viciously attacked while performing a street play in Ghaziabad. He died the following day. His death not just stunned the nation, but it also sparked a movepolitical intervention rather than scattered history. It's a shared a mere performance. His murder provided an impetus for artists, intellectuals, and workers alike to bind together into a cohesive force. Even today, his name remains at the crossroads of art and resistance, reminding us that freedom of expression in India has always been both powerful and equally fragile.

In Japan, the death of Emperor Hirohito marked the end of an era in a very literal sense. He had ruled for over 60 years and oversaw Japan's militaristic expansion, rapidly consuming parts of Asia and its devastating defeat at the end of World War II. Though postwar Japan had recast him as a symbolic figurehead, his presence remained a living link to the trauma. His death in January 1989 ended the Showa era and ushered in the Heisei period. 1989 also saw the passing of two other global icons: Samuel Beckett and Salvador Dalí. Both men had shaped postwar modernism in radically different ways. Their deaths marked the slow retreat of a cultural generation that had emerged from war and depression, and had now given way to a digitized, fragmented, and globalized culture. Meanwhile, in a quiet lab at CERN, Tim Berners-Lee proposed the World Wide Web. Not a flashy product launch. Just a technical document: a successful communication between the Hypertext Transfer Protocol (HTTP) and a server with the help of the Internet. From then on, things didn't change in bits and pieces; the in-

year the world rearranged itself. And if 2089 is the last time we truly look back at it, I hope we can do so with the full weight of ternet revolutionised mankind. what was won, what was lost,

1989 different from most other years. A common link, a certain thread, could be found linking them all. 1989 shows how humanity prepared to move itself into a new century by shedding its old skin. But here's the hard truth about time: its meaning and value erode gradually. Slowly, memory detaches from emotion. That's why I believe 2089 will be the final year when 1989 will be remembered with a feeling, and not simply because it's a historical checkpoint. The people who tore down walls, who protested in the square, who performed in the streets and faced tanks, or who simply held on as the world changed around them, will no longer be able to bear testimony. Only their memory will be passed down, not felt directly. Where there is no digital space, oral memory will stand guard as long as it can. Think of 2045, when the world will likely look back at the end of World War II with one final global pause. After that, the emotional charge will taper off. The same will happen with 1989. It will get its centennial. And then, like all things, it will settle into silence. This is how remembrance works. We honour, we reflect, and then we move on. But I was born in 1989. I don't

take that lightly. To me, this isn't

just the year I arrived, but it's the

Udayaditya Bharali: The progressive flame of Assam's intellectual conscience

Professor Udayaditya Bharali, one of Assam's most luminous minds and steadfast voices of reason, passed away on July 6, 2025, bringing to a close an era in the state's socio-intellectual history. His death, following a long and courageous battle with multiple health afflictions that began with cancer surgery five years ago, leaves behind an irreplaceable void. More than just a historian or an academic, Bharali was the rare embodiment of an extraordinary teacher, a prolific writer, a political thinker, a humanist, and a radical social democrat. He stood as a towering public intellectual, deeply rooted in the ethos of equity, justice, and unwavering moral

Born on September 1, 1947, in Moran—a part of the undivided Sibsagar district—Bharali's formative years were shaped by movement. As the son of Umakanta Bharali, a police officer posted across Assam, young Udayaditya attended schools in Mazbat, Mangaldai, Udalguri, Dhekiajuli, Gohpur, Sivasagar, Guwahati, Barama, and Nalbari, finally completing his matriculation from Barpeta Vidvapeeth in 1962. This itinerant schooling exposed him to Assam's richly diverse social fabric, allowing him to engage with communities across linguistic, ethnic, and cultural lines. It was here, amid the mosaic of people and ideas, that he absorbed the liberal, inclusive worldview that would come

to define his life's work. Bharali graduated from Cotton College in 1966 and topped the MA in History from Gauhati University in 1967, earning the prestigious university gold medal. The following year, on November 14, 1968, he returned to Cotton College as a lecturer in the History Department. Over the next four decades, Bharali emerged as a towering figure in Assam's intellectual community, serving not only as a beloved teacher but as an institution builder, culminating in his appointment as Principal of Cotton College in 2003, a post he held until his retirement in 2006.

As a pedagogue, Bharali was unconventional yet magnetic. He addressed his students with the informal 'toi' instead of the formal 'tumi,' signaling camaraderie and openness. He taught history not as a rigid timeline of facts, but as a vibrant and contested arena of ideas, drawing parallels from daily life and social experiences to unravel complex concepts. His classroom was a democratic space—one of dissent, discussion, and discovery. His influence extended beyond his discipline. Students from various streams-sciences, humanities, and commerce—attended his lectures, drawn by his charisma and the rare clarity of thought that only a few teachers ever truly command. His bond with students was deep and personal; one of them, Uttam Barthakur, would later serve as his dora-dhora (best man) during his marriage to Asomi Bhar-

Bharali's engagement with students wasn't confined to the classroom. In 1991, he spearheaded the formation of the Cotton College Study Circle—a student-led intellectual forum that sparked serious dialogue on contemporary events. Its first discussion was on the Iraq-Kuwait War, followed by guest lectures from leaders like Dr. Jayanta Rongpi and Holiram Terang on autonomy and identity. The forum later birthed the publication Chatra Barta, an academic magazine that sustained conversations around social justice and democracy. Under Bharali's guidance, similar study circles began sprouting in other colleges across Assam, reflecting his unwavering commit-

ment to nurturing young, critical minds. Parallel to his academic life, Bharali was a



in Assam's radical democratic movements. His politics were shaped by a commitment to inclusive nationalism—one that sought to bridge caste, ethnic, and linguistic divides. His seminal 1981 work Jati Samashyar Prosnat questioned narrow ethnonationalist constructs and offered an alternative vision of Assamese identity rooted in progressive values and equal rights. These ideas resonated powerfully with marginalised groups, including the All Bodo Students' Union, Takam Mising Porin Kebang, Autonomous State Demand Committee, All Assam Tea Tribe Students' Association, and All Tai Ahom Students' Association, During the 1980s and '90s, he was a revered presence at tribal conventions and student meetings, his words received with rare attention and respect.

Professor Bharali's reach extended to multiple spheres of Assamese public life. In the realm of literature and journalism, he was a respected columnist for Sadin, Asom Bani, and Asomiya Pratidin. His writings were rigorous, contextual, and laced with the insight of a historian. His short story collection Beimanor Thikona Handhan—a powerful literary rendering of moral ambiguity and social decay—earned him the Bishnu Rabha Award from the Asam Sahitya Sabha in 1996. As an editor, he contributed to The Political History of Assam (Volume I) under the leadership of H.K. Barpujari. Another landmark contribution was his co-authorship of Hundred Years' History of Cotton College: 1901–2001, which remains an invaluable resource for students of institutional history.

His creativity also found expression in sport-themed stories such as Beimanor Thikona Handhan and Hengaror Hipare, which revolved around football and cricket. But these were not just tales of the gamethey were social commentaries layered in allegory. Bharali was also a sports administrator of note. He helped draft the constitution of the Guwahati Sports Association and contributed to organising major events under the Assam Cricket Association. He combined a passion for sports with a commitment to transparency, often highlighting how athletic participation

could become a means of social mobility. Professor Bharali's life was also steeped in activism. A tireless campaigner against human rights violations, he stood at the forefront of civil liberties movements in Assam. He was a vocal critic of the Citizenship Amendment Act (CAA), deeming it a divisive and dangerous project. In rallies and debates, he warned that the Act threatened to fragment Assam's multi-

committed left intellectual deeply embedded ethnic society and corrode the inclusive ideals of the Constitution. True to his values, he remained steadfastly aligned with causes that uplifted the marginalised—Dalits, Adivasis, religious minorities, and the working poor. His activism never courted populism; instead, it was grounded in democratic reason, historical awareness, and unvielding empathy.

An exceptional organiser, Bharali had the rare ability to translate vision into action. He played a key role in orchestrating the centenary celebrations of Assamese icons such as Jyoti Prasad Agarwala, Bhimbor Deori, Bishnu Prasad Rabha, and Hemanga Biswas. These were not mere commemorations: they were platforms to reignite public dialogue on art, politics, and identity in Assam. Bharali's leadership infused these events with a sense of purpose and intellectual integrity that is often lacking in today's personality-driven

Yet beyond his many accolades and public roles, what truly defined Udayaditya Bharali was his enduring belief in progress—through knowledge, solidarity, and justice. He imagined an Assam where every citizen, regardless of caste, creed, or ethnicity, could live in peace, dignity, and harmony. That dream informed every facet of his life: in the way he taught, wrote, organised, protested, and built institutions. He saw education not as a transactional activity, but as a means to liberate human potential. He viewed history not merely as a record of past events, but as a lens to interrogate power and understand social

Bharali was not merely a scholar or a teacher. He was a builder of democratic culture—one that valued truth, empathy, dissent, and collective well-being. In the age of performative politics and fleeting digital fads, his life reminds us of the slow, rigorous work needed to shape thoughtful citizens and just societies. His passing has left a cavernous void in Assam's intellectual and moral ecosys-

Iran will hold nuclear talks with European nations in Turkey

Monday it would hold renewed talks this week with European nations over the country's nuclear programme, with discussions to be hosted by Turkey.

The talks, to be held in Istanbul on Friday, will be the first since a ceasefire was reached after a 12day war waged by Israel against Iran in June, which also saw the United States strike nuclear-related facilities in the Islamic Republic. A similar meeting had been held in the Turkish city in May.

The discussions will bring Iranian officials together with officials from Britain, France and Germany - known as the E3 nations — and will include the European Union's foreign policy chief, Kaja Kallas.

"The topic of the talks is clear, lifting sanctions and issues related to the peaceful nuclear programme of Iran," Iranian Foreign Ministry spokesman Esmail Baghaei said in his weekly briefing. He said the meeting will be held at the deputy ministerial level.

Under a 2015 deal designed to cap Iran's nuclear activities, Iran agreed to tough restrictions on its international programme in ex-

change for an easing of sanctions. The deal began to unravel in 2018, when the United States pulled out of it and began to reimpose certain sanctions. European countries have recently threatened to trigger the 2015 deal's "snapback" mechanism, which would allow sanctions to be reimposed in the case of non-compliance by

Ishiba's coalition loses majority in Japan's upper house election

TOKYO, July 21: Japanese Prime Minister Shigeru Ishiba 's ruling coalition failed Monday to secure a majority in the 248-seat upper house in a crucial parliamentary election, further shaking the stability of his government as Japan faces challenges such as rising prices and high US tariffs.

Ishiba's Liberal Democratic Party and its junior coalition partner Komeito, which needed to win 50 seats on top of the 75 seats they already have to retain their majority, won 47 seats. It was three seats short of a majority and a retreat of 19 seats from before the vote.

The loss is another blow to Ishiba's coalition, making it a minority in both houses following its October defeat in the lower house election, and worsening Japan's political instability. It was the first time the LDP has lost a majority in both houses of parliament since the party's formation in 1955.

Despite the loss, Ishiba expressed determination to stay on and not create a political vacuum to tackle challenges such as U.S. tariff threats, but he could face calls from within his party to step down or find another coalition partner. "I will fulfil my responsibility as head of the No. 1 party and work for the country," he said.

Ishiba hoped for a simple majority but came up short' Ishiba had set the bar low, wanting a simple majority of 125 seats, which means his LDP and its Buddhist-backed junior coalition partner Komeito needed to win 50 seats.

Exit poll results released seconds after the ballots closed Sunday night mostly showed a major setback for Ishiba's coalition. The LDP alone won 39 seats, better than most exit poll projections of 32, and still the No. 1 party in the parliament, known as the Diet. But Ishiba said the coalition's poor showing was because his government's measures to combat price increases had yet to reach many people.

"It's a tough situation. I take it humbly and sincerely," Ishiba told a live interview with NHK. The poor performance in the election will not immediately trigger a change of government because the upper house lacks the power to file a no-confidence motion against a leader, but it will certainly deepen uncertainty over his fate and Japan's political stability. Ishiba could face calls from within the LDP party to step down or find another coalition partner.

Economic worries frustrate voters

Soaring prices, lagging incomes and burdensome social security payments are the top issues for frustrated, cashstrapped voters. Stricter measures targeting foreign residents and visitors also emerged as a key issue, with a surging right-wing populist party leading the campaign.

TRF deserves designation as foreign terrorist organisation: US

NEW YORK/WASHINGTON, July 21: The US House Committee on Foreign Affairs has welcomed the designation of The Resistance Front, a proxy of the Pakistan-based Lashkar-e-Taiba, as a global terrorist outfit over the Pahalgam attack, saying anyone who "butchers" civilians doesn't

Last week, the US designated The Resistance Front (TRF) as a designated Foreign Terrorist Organisation (FTO) and Specially Designated Global Terrorist (SDGT).

"President (Donald) Trump calls it like it is. The Resistance Front is a foreign terrorist organisation and deserves the designation," the committee, chaired by Representative Brian Mast, said in a post on X Saturday. "When you butcher civilians, you don't get a pass—you get Justice. It was a terrorist attack—simple and straightforward," the committee said.

It also cited its post on X dated April 22, when the committee had slammed a report by the New York Times on the Pahalgam attack titled "At Least 24 Tourists Gunned Down by Militants in Kashmir" The House Foreign Affairs Committee Majority had said, "Hey, @ny-

Japan's Ishiba says he'll stay in office to tackle inflation

TOKYO, July 21: Japanese Prime Minister Shigeru Ishiba said Monday he will stay in office to tackle challenges such as rising prices and high US tariffs after a weekend election defeat left his coalition with a minority in both parliamentary chambers and triggered calls for his resignation.

Ishiba's ruling Liberal Democratic Party and its junior coalition partner Komeito were short three seats to maintain a majority in the 248-seat upper house in Sunday's vote. Though the LDP is still the leading party, its ruling coalition is now a minority in both houses of the Diet, or parliament, which makes it difficult for the coalition to pass any legislation.

The loss of a majority in Sunday's election does not immediately lead to a change of government because the upper house lacks power to file a no-confidence motion against a leader. With opposition too fractured to form a united front powerful enough to topple the ruling coalition, Ishiba is under more pressure to step down from ultraconservative rivals in his own party. Ishiba said he takes the result seriously but that his priority is to avoid creating a political vacuum and to tackle impending challenges, including the Aug 1 deadline for a tariff deal with the US.

"While I painfully feel my serious responsibility over the election results, I believe I must also fulfil my responsibility I bear

for the country and the people so as not to cause politics to stall or go adrift," Ishiba said. "Challenges such as global situation and natural disaster won't wait for a better political situation."

His chief tariff negotiator, Economic Minister Ryosei Akazawa, is heading to Washington for his eighth round of talks. The prime minister hopes to reach a mutually beneficial deal and meet with US President Donald Trump "as soon as possible," he said. Sunday's vote comes after Ishiba's coalition lost a majority in the October lower house election, stung by past corruption scandals, and his unpopular government has since been forced into making concessions to the opposition to get legislation through parliament. It has been unable to quickly deliver effective measures to mitigate rising prices, including Japan's traditional staple of rice, and dwindling wages.

Trump has added to the pressure, complaining about a lack of progress in trade negotiations and the lack of sales of US autos and American-grown rice to Japan despite a shortfall in domestic stocks of the grain. A 25% tariff due to take effect Aug 1 has been another blow for Ishiba.

At a news conference Monday, Ishiba said his LDP and the Komeito have agreed to stick with their coalition while seeking further cooperation from opposition parties.

Bees have some ways to cope with warming Earth, but researchers fear for their future

WILLIAMSPORT (US), July 21: Sweat covers Isaac Barnes's face under his beekeeper's veil as he hauls boxes of honeycomb from his hives to his truck. It's a workout in what feels like a sauna as the late-morning June temperatures

Though Barnes was hot, his bees were even hotter. Their body temperatures can be up to 27 degrees Fahrenheit (about 15 Celsius) higher than the air around them. As global temperatures rise under climate change, scientists are trying to better understand the effects on managed and wild bees as they pollinate crops, gather nectar,

make honey and reproduce. They noticed flying bees gathering nectar avoided overheating on the hottest days by using fewer but harder wingbeats to keep their body temperature below dangerous levels, according to a study published last year. Scientists also say that bees - like people may also cope by retreating to a cooler environment such as the shade or their nest.

"Just like we go into the shade, or we sweat or we might work less hard, bees actually do the exact same thing so they can avoid the heat," said Jon Harrison, an environmental physiologist at Arizona State University and one of the study's authors.

But that means the bees aren't able to do what they normally do, said Kevin McCluney, a biology professor at Bowling Green State University.

"They're not going out and getting more nectar. They're not mating. They're not doing the things that bees would otherwise do," McCluney said.

Heat is just one challenge for

critical pollinator Generally, most bees are heattolerant, but as the climate warms, some experts think their ability to fend off disease and gather food might become harder. And habitat loss, increased use of pesticides, diseases and lack of forage for both managed and wild bees are all listed as potential contributors to the global decline of bees and

other pollinators.

"If you're not well-fed, and your body is intoxicated with pesticides and you have lots of diseases in your body, you're going to be less heat-tolerant than if you were healthy," said Margarita López-Uribe, a pollinator health expert at Pennsylvania State University.

Earlier this year, preliminary results from the annual US Beekeeping Survey found that beekeepers lost almost 56% of their managed colonies, the highest loss since the survey started in 2010.

Almost all of the managed honeybee colonies in the US are used to pollinate agricultural crops such as almonds, apples, cherries and blueberries. Fewer pollinators can lead to less pollination and potentially lower yields.

"It's a very fragile system if you think about it," López-Uribe said. "Because if something goes wrong, you have these super highvalue crops that won't get enough bees for pollination."

Losing hives at Honeyrun Farms

Back at Barnes' hives in Ohio,

eyrun Farm with his wife, Jayne, one of the challenges heat can pose to his 500 honeybee hives is fending off parasitic mites that threaten the bees. If temperatures get too hot, he can't apply formic acid, an organic chemical that kills the mites. If it's applied when it's too hot, the bees could die.

Last year they lost almost a third of the 400 hives they sent to California to help pollinate commercial almond groves. Barnes thinks those hives may have been in poor health ahead of pollination because they were unable to ward off mites when it was hot months earlier.

"Dead hives aren't pollinating the almonds," he said. "It's a real ripple effect that stems back from the heat in the summertime."

Sometimes the heat helps. Here in Ohio, Barnes' hives last summer produced a bumper crop of honey as they feasted on nearby soybean nectar as the plants bloomed in the heat. Still, the lack of diverse plants for bees to forage in an area dominated by corn and soybean fields isn't ideal

And even the native blooms are appearing erratically, Barnes said. In autumn, his bees search for food on goldenrod, but those blooms are appearing later. And even then, he has supplemented his hive with additional food to keep them healthy

into the winter. "Every single plant that blooms is something that the bee can use," Barnes said. "And every single plant is affected by climate change.

Research that may aid bees is in

It's only in the last decade that people have become aware of the magnitude of the pollinator decline globally, said Harrison, of Arizona State University. Data is limited on

how much climate change and heat stress is contributing to pollinator decline.

"It's a relatively new focus for biology," he said. "I think it's super important, but it's not being studied a ton.'

The Trump administration's proposed budget would eliminate the research program that funds the USGS Bee Lab, which supports the inventory, monitoring and natural history of the nation's wild bees. Other grants for bee research are also in jeopardy.

US Sen Jeff Merkley of Oregon said America's pollinators are in 'grave danger," and he'll fight for the federal funding. Pollinators contribute to the health of the planet, the crops we grow and the food we eat, he said.

"Rather than taking bold action to protect them, the Trump administration has proposed a reckless budget that would zero out funding for critical research aimed at saving important pollinators," he said in a statement to The Associated Press. (AP)

The proposal was presented on Monday during a meeting between a YMCR delegation led by chairman S D Loda and Chief Minister Pema Khandu at the state secretariat, here. Citing growing concerns over illegal

riverbed extraction, pollution, and disrupted natural flow patterns, YMCR stressed the need for comprehensive legal

The group, working for river protection and conservation, proposed that the new legislation should clearly define community responsibilities and enforcement mechanisms, drawing inspiration from successful models implemented in other

As part of its recommendations, YMCR called for the creation of a dedicated department or cell under the environment or water resources department to monitor river health, ensure enforcement of regulations, coordinate restoration efforts, and conduct sustained public education initia-

tives. The organisation suggested that this new body could complement the recently passed Arunachal Pradesh Flood Plain Zoning Act, 2025.

To build public awareness and mobilise wider engagement, the delegation also proposed the institution of an annual Arunachal River Day' and a dedicated state-level conclave on environmental

after seven train blasts here killed more than 180 persons, the Bombay High Court on Monday acquitted all the 12 accused, saying the prosecution "utterly failed" to prove the case and it was "hard to believe the accused committed the

The judgement comes as a major embarrassment to the Maharashtra Anti-Terrorism Squad (ATS) which probed the case. The agency had claimed that the accused were members of the banned outfit Students' Islamic Movement of India (SIMI) and had hatched the conspiracy with Pakistani members of terror group Lashkar-e-Taiba (LeT).

In a damning indictment of the prosecution's case, the high court declared all confessional statements of the accused as inadmissible suggesting "copying".

Further eroding the credibility of the confessions, the court said the accused had successfully established that torture was inflicted upon them to extort these confessional statements.

A special bench of Justices Anil Kilor and Shyam Chandak said the prosecution has failed to even bring on record the type of bombs used in the crime and that the evidence relied on by it was not con-

clusive to convict the accused.

"Punishing the actual perpetrator of a crime is a concrete and essential step toward curbing criminal activities, upholding the rule of law, and ensuring the safety and security of citizens," HC said in its 671-page judgment.

But creating a false appearance of having solved a case by presenting that the accused have been brought to justice gives a misleading sense of resolution, it

"This deceptive closure undermines public trust and falsely reassures society, while in reality, the true threat remains at large. Essentially, this is what the case at hand conveys," the bench said.

The death row convicts were Kamal Ansari (now dead), Mohammad Faisal Ataur Rahman Shaikh, Ehtesham Qutubuddin Siddiqui, Naveed Hussain Khan and Asif Khan. The special court had found them guilty of planting bombs and several other charges.

It had imposed life imprisonment on Tanveer Ahmed Mohammed Ibrahim Ansari, Mohammed Majid Mohammed Shafi, Shaikh Mohammed Ali Alam Shaikh, Mohammed Sajid Margub Muzammil Ataur Rahman Shaikh, Suhail Mehmood Shaikh and



Zameer Ahmed Rehman Shaikh.

The witness statements and alleged recoveries made from the accused have no evidentiary value, the HC said while quashing the conviction of the 12 persons. Five had been sentenced to death and seven to life imprisonment by a special court. One of the death row convicts died in 2021.

Seven blasts ripped through Mumbai local trains at various locations on the western line on July 11, 2006, killing more than 180 persons and injuring several others.

"The prosecution has utterly failed to prove the case against the accused. It is hard to believe that the accused committed the crime. Hence their conviction is quashed and set aside," the HC said.

The HC said the accused shall be released from jail forthwith if not wanted in any other case. After pronouncing the verdict, the judges said they had done their duty as per the responsibility cast upon them. (PTI)

The prosecution's evidence, witness

statements and alleged recoveries made from the accused persons have no evidentiary value and hence cannot be held as conclusive for conviction, the HC

The bench also drew an adverse inference on the prosecution for failing to examine important witnesses in the case and also for poor and improper sealing and maintenance of the recovered items explosives and circuit boxes allegedly used to assemble the bombs.

"The prosecution has failed to even bring on record the type of bombs used in the alleged crime. Hence, the evidence of recovery is not sufficient to prove the offence against the accused," it said.

Discarding the confessional statements, HC said they seem to have been taken after torture was inflicted upon them and were "incomplete and not truthful". The high court also pulled up the investigating agency for not providing legal assistance to the accused persons before and while recording their confessional statement.

The bench said the confessional statements are vague on several aspects like planning of the conspiracy, in what containers the bombs were packed, how they were detonated, what device was used to

trigger the bombs and so on.

'It is well known that, in most cases, police are in the habit of extorting confessions by illegal and improper means, including torture," HC said.

The HC also held as "incredible and non-trustworthy" the evidence given by witnesses, including taxi drivers who drove the accused to the train station, those who saw the accused plant the bombs, those who were witness to bombs being assembled and those who were witness to the alleged conspiracy.

The court also noted that the provisions of the Maharashtra Control of Organised Crime Syndicate (MCOCA) would not apply to this case and that sanction for the same was granted in a "mechanical manner without application of mind".

Maharashtra revenue minister and senior BJP leader Chandrashekhar Bawankule said the state government will assess the merits of the HC order, before deciding on whether to challenge it in the Supreme Court.

KOLKATA, July 21: Sharpening her 'Bengali asmita' pitch ahead of the 2026 polls, West Bengal Chief Minister Mamata Banerjee on Monday accused the BJP of unleashing "linguistic terrorism" on Bengalis, asserting that the fight for identity and language will continue until the saffron party is de-

Addressing a massive Martyrs' Day rally in Kolkata, Banerjee gave a clarion call to defeat the BJP in the 2026 assembly elections and eventually oust it from power at the Centre, declaring, "If this linguistic profiling doesn't stop, our resistance movement will reach New Delhi.

"If needed, there will be another language movement against the BJP's terrorism on the Bengali language... From July 27, a movement will start in Bengal in protest against the attack on Bengalis, Bengali language and 'Bhasha santras' (linguistic terrorism)," she announced, positioning the campaign as a mass resistance to the alleged marginalisation of Bengali identity.

"We must win more seats in the 2026 assembly polls and then march to Delhi to defeat the BJP,"

Accusing the BJP of harassing Bengalis in states ruled by it, Banerjee alleged attempts to erase the identity of the community from NRC notices to exclusion of

detention camps.

"In 2019, they vandalised the of Ishwar Chandra statue Vidyasagar. They saw the results of that audacious act of insulting Bengali icons. Now, they have issued notifications to delete Bengali names from voter lists. In BJPruled states, Bengalis are being harassed and put in detention camps," she said.

"I challenge the BJP – let me see how many people they will put in Baneriee also launched a frontal

SILIGURI (WB), July 21: Leader of the Opposition in West Bengal Assembly, Suvendu Adhikari, on Monday demanded that special intensive revision (SIR) of electoral rolls be conducted in the state as is being done in Bihar for removing illegal voters from the

He maintained that those Hindus who have come to India from Bangladesh due to religious persecution need not be afraid.

'They are refugees in the eyes of Prime Minister Narendra Modi," Adhikari said, addressing a rally here after leading a march to Uttarkanya, the north Bengal branch of the state secretariat here, to protest atrocities on women in the state.

"Indian Muslims need not worry," Adhikari said to reassure ruling TMC is claiming are being targeted by the saffron brigade, if an SIR is held in the state.

Maintaining that the BJP stands firm with them, he said, "No Rohingya or Bangladeshi Muslim illegal immigrant, however, will be allowed to have their names in the electoral rolls in the state.'

The SIR of electoral rolls has triggered a major political controversy in Bihar, where elections are due later this year, with the opposition INDIA bloc alleging that it was designed to "benefit the ruling NDA", a charge denied by the EC that is carrying out the

hatna were protesting against minister Kokate after a viral video showed him purportedly playing a game of rummy on his mobile phone during the recently concluded monsoon session of the state legislature

After NCP (SP) MLA Rohit Pawar shared Kokate's video clip, the latter clarified he was merely skipping a downloaded game that flashed on the screen of his mobile phone in the legislative council.

Referring to the scuffle in Latur, Sapkal claimed activists from the Chhava organisation had peacefully protested by handing over a pack of playing cards to NCP state president Sunil Tatkare. They were then assaulted by workers of the Ajit Pawar-led NCP, he alleged.

"This is not democracy, it's mob rule. Not just MLAs, but even ministers and office-bearers have bearrogant," claimed."The chief minister must show the courage to take action," he added. The Congress leader also accused Chief Minister Devendra Fadnavis of misleading the legislative assembly over alleged honeytrap incidents involving state ministers and bureaucrats. (PTI)

In a recently held meeting, Chief Minister Sawant and state Information Technology Minister Rohan Khaunte appealed to stakeholders to work towards drafting the AI Mission 2027, aligning with Prime Minister Narendra Modi's

Nearly 350 Information Technology companies and startups are operating in Goa, as per data from the IT department.

Goa Information and Technology Director Kabir Shirgaonkar told PTI Videos that the state government's AI mission is derived from the Centre's ambitious India AI Mission

"We intend to meet various ob-



jectives through this mission, and one of them is create an inclusive and future-friendly AI ecosystem to empower citizens, enhance governance and support innovation across sectors," he said.

The government's predominant focus under the Goa AI Mission 2027 would be on setting up Graphic Processing Units (GPUs) to increase compute capacity, Shir-

"There's also the concept of an AI Coach. When talking about AI, datasets are very important. The Government of Goa will play an active role in preparing datasets, as you all know, the government pos-

sesses a vast amount of data, and these datasets will be critical when working with AI," he said.

Shirgaonkar said the ethical use of AI will also be a major focus area as the Goa government moves forward.

'Some of the major highlights of the Goa AI Mission include the formulation of a Goa AI Policy,' he said, adding the AI Advisory Council has already been formu-

"The AI Advisory Council, a multi-stakeholder body, aims to provide strategic direction and ensure consistent implementation across domains. So, the first step is

the formation of the council, followed by drafting of the Goa AI Policy," he explained.

Shirgaonkar further said the focus will also include AI education, the setting up of Goa AI Labs. and the development of a Konkani Large Language Model (LLM).

"As you know, language models are essential, and developing a Konkani LLM will be one of our key priorities. We aim to use AI to preserve and promote Goa's cultural and linguistic heritage through this locally built LLM in Konkani," he said.

Specifically, the Goa AI Mission will rest on four core pillars -skilling, startups and companies, capital, and government and infrastructure, the official said.

"Under the 'skilling' pillar, we will target colleges and schools to ensure that AI education is integrated at all levels so that our fuure generation is AI-ready," he

Amarsh Chaturvedi, co-founder of Neural Private Ltd in Panaji, said his is an AI first startup, working with enterprises to help scale their AI initiators with ease and

"We are also glad to be a part of the AI state mission in Goa, which is one of the pioneering initiatives

in the country," he added. Goa is one of the "very, very few states in the country" which is looking at AI and making the state ready for the future in technology, Chaturvedi said. He said the Goa AI Mission 2027 also aims at bringing together academia, industry, startups and the government to fulfil multiple objectives.

"The first one being making the population of Goa AI ready, and this also entails skilling and reskilling people to work with AI, not just as users, but also creators. he said.

The mission also includes building the core infrastructure to carry out foundational research, not just physical infrastructure, but digital infrastructure that could entail collaboration of academia in Goa with universities elsewhere in the

world, Chaturvedi said. "So, from a holistic perspective, the intent is right and the steps that are being planned to undertake and fulfil the objectives of this mission are also in the right place," he added. (PTI)



Mizoram: 0ver 10,100 meth tablets seized, 2 arrested

AIZAWL, July 21: Over 10,100 methamphetamine tablets have been seized and two persons arrested in Mizoram's Champhai district, an official of the state Excise and Narcotics Department said on Monday.

The tablets, weighing around 10.1 kg, were seized during an operation on Saturday, the department's spokesperson Peter Zohmingthanga said.

One person, identified as Lunminlalzo (34), a resident of Manipur's Churachandpur town, was arrested on Saturday.

"Based on inputs provided by him, a woman, identified as Christy Hmingthanzami (19), a resident of Champhai's Vengthar locality, was nabbed from Maubawk village in the district on Sunday," he said.

"A car used for transporting the contraband was also seized," he

He said that the seized methamphetamine tablets were being

smuggled outside Mizoram. The two accused have been booked under sections of the Narcotic Drugs and Psychotropic Substances Act, Zohmingthanga said.

According to the official, the department has intensified its anti-drug campaign and is rounding up drug addicts in Aizawl and other district headquarters.

Several addicts have been counseled and sent to rehabilitation centers with the consent of their parents, while others have been engaged in community work as per court directives, Zohmingthanga added. (PTI)

Three militants among six held in Manipur

IMPHAL, July 21: Security forces have arrested three militants belonging to two banned organisations from Manipur's Imphal East and Kakching districts, police said in a statement on Monday.

Three others were also apprehended from Imphal West district for allegedly being involved in the trading of ammunition, it said.

A self-styled sergeant major of the banned Prepak was arrested from his residence at Kontha Ahallup in Imphal East district on Saturday, the police said, adding that he had received basic military training at Tanal in Myanmar and had recruited a cadre in October last year for the outfit.

More than 100 ammunition items were recovered from their possession, the police said.

Security forces have been conducting search operations in Manipur since ethnic violence broke out two years ago.

More than 260 people have been killed and thousands rendered homeless in ethnic violence between Meiteis and Kuki-Zo groups since May 2023.

The Centre had on February 13 imposed the President's rule in Manipur after Chief Minister N Biren Singh resigned.

India to host chess World Cup in October-November

NEW DELHI, July 21: India will host this year's chess World Cup from October 30 to November 27 with a host city for the event to be named in "due course", the sport's global governing body FIDE announced on Monday.

The tournament that will see 206 players battling for the coveted title and qualification spots in the 2026 FIDE Candidates Tournament. India last hosted the event in 2002 in Hyderabad where Viswanathan Anand won the title.

The players will compete in a knockout format, where the losing player in each round is eliminated.

The event has used several formats over the years, but since 2021, it has followed a singleelimination format. Each round spans three days: two classical games on the first two days, followed by tie-breaks on the third day, if necessary," FIDE stated.

In the first round, the top 50 players receive byes, while players seeded from 51 to 206 compete, with pairings based on the principle of the top half versus the reversed lower half.

"The top three finishers of the 2025 World Cup will earn direct qualification for the 2026 Candidates Tournament, which determines the challenger for the World Chess Championship," FIDE said.

Reigning world champion D Gukesh, R Praggnanandhaa, the runner-up of the 2023 World Cup, and Arjun Erigaisi, currently ranked world number five, are among the stars who would be seen in action. World number one Magnus Carlsen has also qualified to compete in the biennial event that he won in 2023.

India has recently hosted major events, including the 2022 Chess Olympiad, Tata Steel Chess India, the 2024 World Junior U20 Championships 2024, and the 5th leg of the FIDE Women's Grand Prix in April this year.

'We are thrilled to bring the FIDE World Cup 2025 to India, a country with a deep-rooted passion and support for chess. Indian chess fans' enthusiasm has always been remarkable, and we anticipate great interest in the event among local chess lovers, both on-site and online," FIDE CEO Emil Sutovsky said in a press re-

India came into the second game with their nose ahead and were expected to grab the series due to their all-round strength and form of some big players.

However, poor shot selection and an inability to adapt to the conditions spoiled their plans as they struggled to 143 for eight batting first in a 29-overs-a-side contest

The bowlers, too, failed as England's top-order batters completed an easy chase with plenty f overs to spare.

Now, coming into the decider, India suddenly have a lot to pon-

Except for vice-captain Smriti Mandhana and Deepti Sharma, their batters were found wanting against the likes of Sophie Ecclestone, Em Arlott and Linsey Smith at Lord's and the bowling also failed to live up to the expectations. With the accurate Ecclestone leading the way, the India batters struggled against the spinners especially, and they will certainly hope for a much better outing against the slow bowlers at Chester-le-Street.

India bat long but for the visi-

ple of players from among Mandhana, skipper Harmanpreet Kaur, Jemimah Rodrigues, Pratika Rawal, and Harleen Deol to play big knocks with Richa Ghosh and Deepti providing them support lower down the order.

The team will be looking for early breakthroughs from the pacers before the spinners get into the act.

As far as England are concerned, they are in a much better space then they were after the series-opener and the likes of Ecclestone and Arlott would look to do an encore with the ball.

McIlroy falls short in bid to crown British Open homecoming with the claret jug

PORTRUSH (NORTHERN career Grand Slam. Fans came in IRELAND), July 21: Scottie Scheffler was walking down the first fairway at Royal Portrush when a shout came from outside the ropes: "Go Rory!"

They were all over the Dunluce Links again Sunday, those passionate supporters of Rory McIlroy cheering on their favorite son in the final act of his homecoming whether they were watching him or not. The big disappointment for McIlroy was that he couldn't deliver what they craved.

"It's been an awesome week," McIlroy said after shooting 2-under 69 to tie for seventh at the

British Open. "I've gotten everything I wanted out of this week apart from a claret jug, and that's just because one person was just a little bit better than the rest of

That might be an understatement.

Scheffler, the world No. 1, won by four shots to was seven strokes clear of McIlroy and playing on a different level in this pretty corner of Northern Ire-

McIlroy even acknowledged as much. "He's an incredible player," he said of Scheffler. "He's been dominant this week. Honestly, he's been dominant for the last couple years. He is the bar that we're all trying to get to.'

As for Scheffler, he could only apologize for spoiling the McIlroy party. "I know I wasn't the fan favorite today," he said, grinning, in his post-round speech on No. 18, "but I did hear a lot of USA and Dallas, Texas chants,'

Scheffler might have won two majors this year and asserted himself as the game's dominant player. Yet, for many, 2025 still belongs to McIlroy after his dramatic win at the Masters in April to complete the (AP)

droves this week to celebrate McIlrov's achievements, and produced some of the loudest roars he has ever heard on a golf course.

If McIlroy didn't quite deliver, then Royal Portrush — where he shot 61 as a 16-year-old for the course record — certainly did, gaining widespread rave reviews.

When the Open returned to Portrush in 2019 for the first time in 68 years, McIlroy was so emotional he hit his opening drive out-ofbounds, shot 79 and missed the cut. He made amends six years later.

"I feel so thankful and just so lucky that I get to do this in front of this crowd," McIlroy said. "Hope-

fully I'll have one or two Opens left here, if the R&A decide to keep coming back probably one while I'm still competitive and another one while I'm more gray than I already am.

McIlroy started Sunday capture his fourth major title. He six strokes back from Scheffler after a wild third-round 66, and needed a minor miracle to catch his big rival.

He got up-and-down for birdie at the par-5 second hole but couldn't make a fast enough start. A bogey at No. 4, after missing the green with his approach, was a mistake he couldn't afford and he suddenly was eight shots adrift of Scheffler, who played as steady as ever.

A double at No. 10 ended his

McIlroy couldn't reproduce his Saturday charge but at least played all four days this time.

"I tried as best as I could to keep my emotions in check, especially walking up the last there and that reception," McIlroy said.

"It's just been incredible to come back here and to play and at least feel like I had a chance today going out there. Just an awesome week.

Italy one win away from women's Euro final, 3 years after players were permitted to turn pro

ROME, July 21: Italy is one win away from reaching the final of the Women's European Championship, but just three years ago its players couldn't even get professional con-

tracts in their own country. Little wonder veteran captain Cristiana Girelli was in tears after her two goals inspired Italy to a 2-1 victory over Norway last week, and a first semifinal appearance at the tournament in 28 years.

The Azzurre next plays defending champion England on Tuesday

"It's a great joy to be among the top four in Europe and it is a happiness that we want to share because we know how important it is to bring home the results in Italy and especially for the new generations," Girelli said, after again wiping the

tears from her eves. "Because obviously we do this for our glory but there is a much deeper meaning, which we certainly want to bring, which is that in Italy women can play soccer too."

Of course they can, although they couldn't hope to make a lot of money for it until 2022 after years of amateur-only status.

It was in April of that year that the executive board of the sport's national federation approved new regulations to open the way for a women's professional era starting July 1 — in time for the following Serie A season.

A 1981 Italian law had limited female players to amateur status, meaning they couldn't earn more than 30,000 euros (\$32,000) per year before taxes.

Benefits such as social security contributions, an end-of-career fund, pension, medical protection for injuries and maternity leave were a distant dream.

The 35-year-old Girelli and many of her national teammates have experienced the change firsthand, with several of them having had to do hospitality jobs to support their soccer careers.

"There were difficult years where



we really suffered a lot," Girelli said. The push to make the women's game professional in Italy followed the national team's surprise run to the quarterfinals of the 2019 Women's World Cup.

It was also helped by the big clubs — Juventus, AC Milan, Inter Milan, Roma and Lazio — starting to invest more in their women's

Progress has been slower than in the countries of its traditional soccer rivals — such as England, France and Spain — but Italy is showing signs that it is catching up on the international stage.

Under coach Andrea Soncin, Italy is proving it can go toe-to-toe with the top teams, culminating in its first semifinal match at the European tournament since a run to the

1997 final.

"It's something magical," Girelli said. "But to tell you the truth I have felt something special in the air since I arrived in Switzerland, since the coach took charge of this team I felt something special.

"And you know, women are never wrong with their feelings," she continued with a wry smile.

While it hasn't quite reached fever pitch back home, 2.4 million television viewers in Italy — a 16.2% audience share — watched the team's match against Norway and that's likely to be even more for the semifinals

"We hope this love, this affection, this atmosphere that's coming to us from Italy doesn't disappear," Girelli said. "I really hope that with all my heart because we struggled to get here.


"We've reached something amazing, something extraordinary, and however it goes, I really hope it continues to feed this passion, this love for us." (AP)

Scottie Scheffler dominates in British Open victory for his 2nd major title this year

PORTRUSH (NORTHERN IRELAND), July 21: The enormous yellow scoreboard above the 18th green at Royal Portrush perfectly illustrated the state of golf these days. Scottie Scheffler's name was at the top. No one was close.

That's how it was in the British Open on Sunday, when Scheffler never gave anyone a chance from the time his 9-iron settled a foot away for birdie on the first hole until he tapped in for a 3-under 68 and a four-shot victory over Harris English. That's how it is in the sport, a level of dominance not seen since Tiger Woods.

"He is the bar that we're all trying to get to," Masters champion Rory McIlroy said. "In a historical context, you could argue that there's only maybe two or three players in the history of the game that have been on a run the one that Scottie's been on here for the last 24 to 36 months. Incredibly impres-



second major this year — and fourth in the last three years — he captured the third leg of the career Grand Slam, now missing only the U.S. Open.

He became the first player in more than a century to win his first fourth major title by at least three

shots, and if not for his lone blunder from a bunker on the eighth hole when he had a seven-shot lead, he would have played bogey-free on the weekend.

"Being able to walk up 18 with the tournament in hand is a really tough thing to describe. It's a really cool feeling. I have a lot of grati-

tude towards being able to accomplish something like this," Scheffler said, the silver claret jug on the table next to him.

"It's taken a lot of work — not only a lot of work, but it takes a lot of patience," he said. "It's a high level of focus over 72 holes of a tournament. This was, I felt like, one of my best performances men-

The emotions he showed were

telling. Until he had his name etched on golf's oldest trophy, Scheffler had a week marked by his extraordinary insight on how he views winning. He said celebrations last only a few minutes. He has wondered, "What's

the point? He loves the work required to be the best. He thrives on competition. But in terms of fulfillment, he often questions why he wants to win so badly when the thrill of winning is fleeting.

LONDON, July 21: An eightmember working group, headed by ICC's new chief executive officer Sanjog Gupta, has been formed by the game's global governing body to explore the possibility of restructuring Test cricket into a two-tier system. The committee was set up during ICC's annual general meeting in Singapore under the all-Indian leadership of the chair, Jay Shah and Gupta, who was appointed as CEO earlier this month.

Other members of the panel include England and Wales Cricket Board (ECB) chief executive Richard Gould and the Cricket Australia (CA) chief executive Todd Greenberg, according to a report in 'The Guardian'.

"Any changes would be introduced for the next cycle of the World Test Championship, due to run from 2027 to 2029, and involve an expansion from the current nineteam format to two divisions of six," the report read.

The working party has been asked to submit its recommendations to the board by the end of the year. The presence of Gould and Greenberg indicate that there is strong possibility of the new twotier system being introduced as CA and ECB have been major advocates of it.

Currently, nine teams compete in the World Test Championship, but if the proposed two-tier system is implemented, the structure would shift to two divisions of six teams each, featuring a promotion and rel-

With Asia Cup uncertain, PCB's revenue could take massive hit

KARACHI, July 21: With the future of this year's Asia Cup T20 tournament mired in uncertainty, the Pakistan Cricket Board is bracing for a severe hit to its revenue. The Pakistan Cricket Board is expecting to earn an estimated 8.8 billion rupees this year from its share of the revenue from the International Cricket Council (ICC) and the

According to details coming from a reliable Board source, the PCB has outlined an amount of USD 25.9 million (approximately 7.7 billion rupees) during this fiscal year as its share from the ICC. The Board is hoping to earn another 1.16 billion rupees from the Asia Cup and 7.77 million rupees through other international cricket events.

"The revenues from these two major sources (ICC and Asia Cup) is very important for the financial health of Pakistan cricket," one well-informed insider said.

He said the uncertainty over the schedule and venue for the Asia Cup has increased as PCB Chairman Mohsin Naqvi did not travel to Singapore for the ICC meetings last weekend. Naqvi, who is also the federal interior minister, instead took part in the AGM virtually.

According to the insider, PCB CEO Sumair Ahmed, who had gone for the ICC meeting, "didn't get positive responses" from either the BCCI or the boards of Sri Lanka, and Afghanistan over attending the ACC meeting called on July 24 in Dhaka to finalise the Asia Cup arrangements. (PTI)

KINGSTON (JAMAICA), July 21: Mitchell Owen marked his in ternational debut with a half-century and a wicket to help Australia to a three-wicket win in the Twenty20 cricket series opener against West Indies.

Owen shared an 80-run fifthwicket stand off 40 deliveries with Cameron Green, who scored 51 off 26 balls, to put Australia on course to reach the victory target of 190 with seven balls to spare on Sun-

After being sent in to bat and making a flying start, West Indies was restricted to 189-8 after losing four wickets for five runs off the last nine balls.

Australian fast bowler Ben Dwarshuis returned a career-best 4-36, taking three wickets in four deliveries — Jason Holder blocked a hat-trick ball but was out next delivery — in the next-to-last over of the West Indies innings.

The top four West Indies batters all got starts, with Roston Chase plundering 60 from 32 deliveries before he was caught in the deep off Dwarshuis' bowling to end a 91-run second-wicket partnership with Shai Hope (55) in the 13th

Six Indian badminton players barred from World

NEW DELHI, July 21: The Indian badminton squad that won the mixed team bronze medal at the ongoing World University Games in Rhine-Ruhr, Germany has been hit by a controversy over selection after six of the 12 chosen players were barred from participating due to an alleged administrative

Twelve players were selected and sent to represent India, but only six were allowed to compete as officials failed to submit all names correctly during the managers' meeting on July 16.

"This is not just mismanagement – it's career sabotage. We demand answers, accountability, and that our voices be heard. We didn't lose a match – we lost our right to even participate," wrote Alisha Khan, one of the players left out, on Instagram.

"This isn't just a mistake. It's career sabotage by AIU and our team officials. We demand justice."

According to sources, BV Rao and Ajit Mohan were the Association of Indian Universities (AIU) officials who attended the meeting. The AIU, which is the nodal body for university-level sports in the country, acknowledged the incident.

"We have been informed about this and the matter is being investigated," AIU Secretary Dr Pankaj Mittal told PTI while refusing to comment any further. According to a source, the issue was not

just an error but stemmed from "systematic irregularities" starting from the selection trials held at Kalinga Institute of Industrial Technology (KIIT), Bhubaneswar. "During the managers' meeting, officials

were given a letter listing all 12 players from India. It was their responsibility to read it carefully, check for missing or injured players, and confirm or adjust the names accord-
