GUWAHATI, July 10: Chief Minister Himanta Biswa Sarma on Thursday interacted with Headmasters of Tea Garden Model Schools and Adarsha Vidyalayas at a programme held at the GMCH Auditorium, where he unveiled a series of key policy decisions aimed at improving infrastructure, academic quality, and student wel-

fare in these institutions. The interaction was part of a broader initiative by the state government to transform education in remote and underprivileged areas, particularly among tea garden communities

According to an official statement, Sarma announced that the Assam government will operationalise 80 more Tea Garden Model Schools in January 2026. This will be in addition to the 118 schools that were inaugurated following the laying of foundation stones in November 2022.

The Chief Minister stated that the expansion is a result of the positive outcomes observed in existing model schools, which have played a crucial role in delivering quality education to children in tea garden areas. The Tea Garden Model School initiative was launched with the goal of establishing 200 schools across 800 tea gardens in the state, providing accessible and holistic education to one of in regions with limited public Assam's most underserved com- transport. munities. "Our objective is not just to open schools, but to enhance the academic and infrastructural standards so that students receive the best possible environment to learn and

grow," said Sarma. Highlighting further reforms, the Chief Minister said the government is actively considering the introduction of a mid-day meal programme for students of Class IX and X, expanding on the existing programme for students up to Class VIII.

He noted that this would help reduce dropout rates and incentivise older students to stay in school.

Additionally, the government is also exploring the launch of a School Breakfast Programme along with mandatory health check-ups to promote students' physical well-being and attendance.

He added that efforts are underway to equip schools with smart classrooms and interactive boards, particularly in model schools, to bring digital learning to rural students.

To address mobility issues faced by children in remote tea garden areas, bicycles will be distributed to students from Class VI onwards, Sarma announced. This is expected to help students travel longer distances to reach schools, especially

Govt approves ₹1,066 cr to 6 disaster-hit states: Shah

NEW DELHI, July 10: The Centre has approved ₹1,066.80 crore for flood and landslide affected states of Assam, Manipur, Meghalaya, Mizoram, Kerala and Uttarakhand as part of the central share under the State Disaster Response Fund (SDRF), Union Home Minister Amit Shah said on Thursday

Shah also said that the Narendra Modi government stands resolutely beside the states in all situations like flood, landslide and cloudburst.

"Today the central government has approved ₹ 1,066.80 crore for flood and landslide affected states of Assam, Manipur, Meghalaya, Mizoram, Kerala and Uttarakhand as part of the central share under SDRF," he wrote on 'X'.

The home minister said apart from the financial aid, providing all logistic assistance, including deployment of requisite National Disaster Response Force, Army and Air Force, has been the priority of the government.

Among the six flood affected states, Assam received ₹ 375.60 crore, ₹ 29.20 crore was given to Manipur, ₹ 30.40 crore to Meghalaya, ₹ 22.80 crore to Mizoram, ₹ 153.20 crore to Kerala and (CONTD. ON PAGE-2)

Cabinet okays SOPs aimed at curbing unethical conduct by private hospitals and nursing homes

HT Bureau GUWAHATI, July 10: The Assam Cabinet, in a meeting chaired by Chief Minister Himanta Biswa Sarma on Thursday, approved a series of decisions aimed at strengthening public welfare, education, traditional institutions, and healthcare accountability in the state.

According to an official statement, the Cabinet gave its nod to the implementation of the Gaja Mitra Scheme in eight districts identified as highly prone to human-elephant conflict-Goalpara, Udalguri, Nagaon, Baksa, Sonitpur, Golaghat, Jorhat, and Biswanath.

As part of the scheme, community-based voluntary monitoring and rapid response teams will be formed in 80 locations.

Each team will comprise eight members drawn from local communities and operate for a six-month period, coinciding with the peak human-elephant conflict season, which aligns with the paddy cultivation cycle.

Army constable among three held for running opium racket

In another administrative decision, the Cabinet de-notified two villages-Mornoi Bebejia and Bebejia-from the Subansiri

Tribal Block under Subansiri Revenue Circle in Lakhimpur district, citing that the population of protected persons in these villages was below five percent.

In a move to support spiritual and cultural institutions, the Cabinet decided to offer a monthly stipend of ₹1,500 to celibate monks (Udasin Bhakats) residing in Satras across Assam. The financial assistance is intended as both a gesture of respect and a means to support the wellbeing of these traditional custodians.

To address concerns over coercive practices in private healthcare, the Cabinet approved a draft (CONTD. ON PAGE-2)

enhance the monthly remuneration of Gaon Pradhans from the existing ₹9,000 to ₹14,000 with effect from October 1, 2025.

This increase, aligned with the state's 2025–26 budget announcement, will also extend to Gaon Pradhans in forest villages.

NEW DELHI, July 10: An army constable, his girlfriend and an accomplice of his were arrested in Delhi's Kalindi Kunj area for smuggling opium worth ₹ 1 crore in an SUV on Thursday, an official said.

The arrested constable, Godhu Ram (31), had allegedly been on the run from the Indian Army for the past nine months and had been using his leave period to facilitate the smuggling of opium from Manipur to Rajasthan and Delhi-NCR, he said.

The trio was arrested near Kalindi Kunj area on July 7 when they were intercepted in the SUV car, Deputy Commissioner of Police (Special Cell) Aalap Patel said, adding that a concealed consignment of 18 kg opium was recovered from their possession. "The gang had modified the vehicle by creating secret compartments beneath the floor mats to discreetly transport the contraband," Patel added.

During the search, the police team also recovered a licensed pistol of 0.32 bore along with six live cartridges from the vehicle. The SUV and the weapon were registered in Ram's name, he said.

The arrests were made on a tip-off received by Delhi Police's Special Cell (Southern Range). Acting on the information, a trap was laid near Agra Canal Road in the Kalindi Kunj area on July 7.

"On spotting the vehicle, the team swiftly



cordoned it off and apprehended all three occupants. Upon checking, 18 packets of high-grade opium were recovered, hidden beneath the floor mats of the car," the DCP added

A case under relevant sections of the Narcotic Drugs and Psychotropic Substances (NDPS) Act was registered at the Special Cell Police Station, New Delhi.

According to investigators, the seized consignment was procured from a supplier based in Manipur and was intended for distribution across Delhi-NCR, Haryana, and Rajasthan.

Initial interrogation revealed that the accused had been part of a well-organised supply chain and used the cover of personal travel to avoid detection. Police said that none of the three accused have any prior criminal records. Further investigation is underway to identify the larger network and the source of procurement. (PTI)

Indian Army activates relief

corridors for elephant movement.

GUWAHATI, July 10: The Indian Army has launched extensive humanitarian assistance and disaster relief operations (HADR), following heavy rain and flood in several states of North East, according to an official release issued on Thursday.

The army has so far deployed 40 relief columns across the region and rescued a total of 3,820 people, it said. The military force has launched the exercise under Operation Jal Rahat-2 with coordinated deployment across Nagaland, Assam and Manipur,

"These efforts are being led by Headquarters Inspector General Assam Rifles (North) in collaboration with local civil administration," the statement said.

The army has also distributed 1,361 food packets, supplied 15,421 water bottles and provided medical aid to 2,095 people, it said.

In Assam, the Indian Army activated its HADR operations in the upper districts with the Dhansiri river in Golaghat breaching the danger levels.

"Although water levels are now receding, the Indian Army continues to monitor the situation closely and is ready to intervene, should the need arise," it added.

Talking about Nagaland, it said that the deputy commissioner of Dimapur on Thursday requisitioned assistance from the Indian Army to provide immediate flood relief in Singrijan Colony, one of the worst-hit areas. "The army swiftly responded with the deployment of

an Engineer Task Force (ETF) team. While a verbal derequisition was received later in the day, the army remains on standby with (CONTD. ON PAGE-2)

Two arrested in Jorhat for

JORHAT, July 10: Police in Jorhat on Thursday arrested two individuals for allegedly practising medicine without the requisite qualifications or registration, following a complaint filed by the Assam Council of Medical Registration.

The arrests were made in two separate cases under relevant sections of the Bharatiya Nyaya Sanhita (BNS).

The accused, Ashok Kumar Gogoi (46), a resident of Jail Road, Samannay Path, and Amar Jyoti Nath (38) of Bahona Tiniali, were booked under Sections 319(2), 316(2), 336(2), 125, and 271 of the BNS.

The cases have been registered as Jorhat Police Station case numbers 345/2025 and 346/2025.

Jorhat Additional Superintendent of Police (Headquarters) Luna Sonowal informed reporters that the arrests followed a complaint submitted to the Criminal Investigation Department (CID) by Dr Abhijit Neog, Nodal Officer of the Anti-Quackery Cell, Assam

Council of Medical Registration. The complaint alleged that the two individuals had

been impersonating qualified medical practitioners. Preliminary investigation revealed that Gogoi had been running a practice from his chamber on Old Circuit House Road for the past eight years, while Nath was operating from Khojuriguri, Borigaon for the last three years.

During questioning, Gogoi claimed to have undertaken a course in homeopathy, and Nath claimed to

Flood risk in 21 locations; 4 sites under severe condition, says govt water body

NEW DELHI, July 10: The Central Water Commission (CWC) flagged flood concerns in 21 river monitoring sites across India, including four under severe flood conditions, according to its daily flood bulletin issued Thursday.

While no rivers have breached their highest flood levels (HFL), so far, four locations in Assam and Bihar are witnessing water levels that have crossed the danger mark.

The Dhansiri River in Assam's Golaghat district, and the Bagmati and Gandak Rivers in Bihar are among the key rivers where levels remain critical, with rising or steady trends.

Seventeen additional sites are experiencing "above normal" flood situations, with water levels hovering between the warning and danger thresholds. These include

river stretches across Assam, Bihar, Odisha, Uttar Pradesh, and West Bengal.

The situation in Assam remains a cause for concern, as the Barak, Kushiyara, and Katakhal rivers are showing rising trends in the Cachar, Karimganj, and Hailakandi districts, respectively. Meanwhile, in Bihar, the Bagmati River at Runisaidpur and the Kosi

River at Basua are also rising, though still below danger levels. In Uttar Pradesh, multiple Ganga monitoring stations, includ-

ing Fatehgarh, Garhmukteshwar, and Kachhla Bridge, reported levels above warning thresholds. The Ghagra River at Elginbridge and the Gandak at Khadda are also under close watch. The bulletin also said that 25 reservoir sites across 13 states (CONTD. ON PAGE-2)

ITANAGAR, July 10: Altogether 89 bird species were documented during a two-day survey at a lake in Arunachal Pradesh's Namsai district, officials said on Thursday. The survey was carried out at the Nongsaya Lake in Jona, around 9

km from Namsai town, by the Arunachal Pradesh Birding Club (APBC) in collaboration with the Public Works Department, conservationist Koj Mama said. "The survey was undertaken

recognising the critical ecological role the lake plays," he said.

Key bird species spotted during the survey included oriental darter, lesser adjutant, pale-chinned blue flycatcher, blossom-headed parakeet, yellow-bellied warbler and chestnut-capped babbler.

"The lake and its surrounding forested environment offer rich



biodiversity, with immense poten- tion. In addition to acting as a nattial for bird and butterfly conservaural habitat, the area could serve as

an ideal location for environmental education and recreational activities," Mama said.

Highlighting the ecological significance of the lake, he stated that the area could contribute meaningfully to sustainable development and community engagement in ecosystem protection.

The team also recorded several butterfly species, including the rare Assam Pasa, underlining the area's ecological richness, he said.

With its lush green forest cover and potential as a sanctuary for migratory water birds, Nongsaya Lake holds promise as a future global bird-watching destination, the conservationist said.

Mama stressed that the creation of suitable infrastructure, particularly carefully designed trekking routes that avoid disturbing

wildlife, could open the area to responsible ecotourism.

He emphasised that the lake's ecosystem plays a crucial role in preserving major watersheds and

"With a proper development strategy, the lake can serve multiple purposes, such as conservation, sustainable fishing, recreation, and as a sanctuary for migratory birds," Mama added.

Markets wilt under selling pressure; Sensex drops 345 points on weakness in IT stocks

MUMBAI, July 10: Benchmark indices Sensex and Nifty buckled under selling pressure on Thursday due to weakness in IT and telecom stocks as investors turned cautious ahead of the start of earnings season, with tech major TCS scheduled to announce its Q1 numbers later in the day.

Tariff-related uncertainty also dampened investor sentiment in the market, traders said.

Sliding for the second straight session, the 30-share BSE Sensex dropped 345.80 points or 0.41 per cent to settle at 83,190.28. During the day, it declined 401.11 points or 0.48 per cent to 83,134.97.

As many as 2,064 stocks declined, while 1,959 advanced and 138 remained unchanged on the BSE. On similar lines, the 50-share NSE Nifty declined 120.85 points or 0.47 per cent to 25,355.25.

A positive momentum in global equities, however, restricted the loss in the domestic markets.

"Indian equities concluded the day in the red, weighed down by weakness in IT stocks ahead of TCS' Q1 results. Investor sentiment remains cautious ahead of the Q1 results in anticipation of a muted start to the season from the IT and finance sectors. However, the recent consolidation in the IT stocks largely factors in the muted outlook, limiting further worries,"



Vinod Nair, Head of Research, Geojit Investments Limited, said. From the Sensex pack, Bharti Airtel, Asian Paints, Infosys, Bharat Electronics, Tech Mahindra and Eternal were major laggards. However, Maruti, Tata Steel, Bajaj Finance, Bajaj Finserv, Trent and Tata Consultancy Services were among the gainers.

"Dalal Street ended in the red on Thursday, as investors remained cautious ahead of two key events -- US President Donald Trump's upcoming tariff announcement and the start of India's Q1FY26 earnings season, with TCS scheduled to report results post market hours," Gaurav Garg, Analyst, Lemonn Markets Desk, said.

The BSE midcap gauge dipped 0.28 per cent while the smallcap index inched higher by 0.12 per cent. Among BSE sectoral indices, teck dropped 1.17 per cent, telecommunication (1.11 per cent), BSE Focused IT (0.77 per cent), IT (0.71 per cent) and consumer

IT (0.71 per cent) and consumer durables (0.44 per cent). Realty, metal, oil & gas and utilities were the gainers. "On the sectoral front, profit

booking in IT majors ahead of TCS results weighed on the index, followed closely by weakness in FMCG and pharma stocks. However, the realty and metal sectors bucked the trend and closed in the green. The broader indices also ended with modest losses, continuing their profit-taking phase," Ajit Mishra – SVP, Research, Religare Broking Ltd, said.

An Indian commerce ministry team will soon visit Washington for another round of talks on the proposed trade agreement with the US to iron out differences in sectors, like agriculture and automobiles, a government official said on Thursday.

This visit is significant as the US has further extended the imposition of additional import duties (in the case of India, it is 26 per cent) till August 1. India is seeking the removal of this additional tariff.

In Asian markets, South Korea's Kospi, Shanghai's SSE Composite Index and Hong Kong's Hang Seng settled higher, while Japan's Nikkei 225 index ended lower. European markets were trading

mostly higher. The US markets ended in positive territory on Wednesday.

Foreign Institutional Investors (FIIs) bought equities worth Rs 77 crore on Wednesday, according to exchange data. Global oil benchmark Brent crude dipped 0.27 per cent to USD 70 a barrel.

On Wednesday, the 30-share BSE Sensex fell by 176.43 points or 0.21 per cent to settle at 83,536.08. The Nifty declined 46.40 points or 0.18 per cent to end at 25,476.10. (PTI)

India now makes faster payments than any other country, courtesy UPI: IMF note

NEW DELHI, July 10: India now makes faster payments than any other country with the quick growth of UPI, and the usage of other instruments, including debit and credit cards, is on the decline, according to an IMF note. Unified Payments Interface is an instant and real-time payment system developed by NPCI to facilitate inter-bank transactions through mobile phones. IMF's Fintech Note titled 'Growing Retail Digital Payments: The Value of Interoperability' said that since its launch in 2016, UPI has grown quickly, while some proxies for cash usage have begun to decline.

UPI now processes more than 18 billion transactions per month and dominates other electronic retail payments in India. "India now makes faster payments than any other country. At the same time, proxies for cash usage have fallen," the note said.

The note presents evidence consistent with this framework using granular data covering the universe of transactions on India's UPI, an interoperable platform that has become the world's largest retail fast payment system by volume.

"Since its launch in 2016, UPI has grown quickly, while some proxies for cash usage have begun to decline. UPI now processes more than 18 billion transactions per month and dominates other electronic retail payments in India," the fintech note said.

Fintech Notes offer practical advice from IMF staff members to policymakers on important issues.

It said that interoperable payment systems, such as UPI, are alternatives to closed-loop systems that could also foster the adoption of digital payments. Such systems allow for seamless payments between users of different payment providers. "Importantly, total digital payments also rise relative to a proxy for cash usage," it said. The note further said that estimating cash usage is difficult because cash transactions can occur anonymously and may not be recorded in any ledger, especially in the informal sector. (PTI)

Small tea growers urges Centre for fair price discovery mechanism

KOLKATA, July 10: Small tea growers, who contribute more than 50 per cent to the crop production of the country, have urged the Centre to set up a fair and transparent price discovery mechanism so that they can realise a proper value by selling leaves to factories. In a letter to Commerce Minister Piyush Goyal, the Confederation of Indian Small Growers Associations (CISTA) suggested a price protection scheme modelled on the lines of the minimum support price (MSP). It said the Tea Board should undertake a detailed study to determine an equitable pricesharing ratio between small growers and factories. Small growers are facing the persistent challenge of poor price realisation, which is undermining the sector's sustainability, CISTA president Bijoy Gopal Chakraborty said. Small growers contribute more than 52 per cent to the country's tea production, and a proper price realisation mechanism should be identified so that livelihoods are sustained, he said.(PTI)

HT Bureau GUWAHATI, July 10: Nearly half of India's small businesses now operate primarily online, using websites, social media, and marketplaces to drive customer engagement and sales, according to the GoDaddy 2025 Global Entrepreneurship Survey.

gain knowledge about running a business, with 62 percent turning to social media for insights, ahead of books and blogs, and even artificial intelligence tools

These difficulties point to a growing need for practical, time-saving tools that can help entrepreneurs bridge the gap between visibility and actual revenue.

As small business owners move deeper into the digital space, many are seeking support that can streamline their online marketing efforts.

Sixty-three percent said they want more effective ways to target the right audience, while nearly half are looking for simpler tools to create and schedule content.

Artificial intelligence is beginning to play a more significant role in addressing these needs.

The survey shows that AI users are more likely to want performance insights and content templates compared to non-users, indicating a growing demand for focused and result-driven solutions.

Apurva Palnitkar, Senior Director of Marketing at GoDaddy India, stated that Indian entrepreneurs are becoming increasingly tech-savvy.

Govt approves `1,066 cr to 6

₹ 455.60 crore to Uttarakhand as the central share from SDRF, according to a statement issued by the Ministry of Home Affairs. These states have been affected due to extremely heavy rainfall, floods and landslides during the southwest monsoon this year.

The Modi government has provided more than \mathbb{R} 8,000 crore from SDRF/National Disaster Response Fund to various states this year, the statement said. It has already released \mathbb{R} 6,166.00 crore from the SDRF to 14 states and \mathbb{R} 1,988.91 crore from the NDRF to 12 states.

In addition, ₹ 726.20 crore was released from the State Disaster Mitigation Fund to five states and ₹ 17.55 crore from the National Disaster Mitigation Fund was also released to two states, the statement said. During the ongoing monsoon, 104 teams of the NDRF were deployed in 21 states/UTs for rescue and relief operations. (PTI)

Gaja Mitra scheme sealed

Standard Operating Procedure (SOP) and regulatory guidelines aimed at curbing unethical conduct by private hospitals and nursing homes. Key provisions of the guidelines include mandatory handover of deceased patients within two hours of death certification, irrespective of payment status, with violations attracting penal action.

All such incidents must be reported to the police and district health authority within four hours. A 24x7 tollfree government helpline (104) will be set up for families to report coercive practices, with mandated escalation to relevant authorities. Immediate action will be taken to release wrongfully withheld bodies and initiate legal proceedings. Penalties for offending hospitals may include license suspension, monetary fines up to ₹5 lakh, blacklisting, or permanent deregistration for repeat offences.

Further, the Cabinet approved the "Assam Goods and Services Tax (Reimbursement for Indigenous Bell Metal Industries) Scheme, 2025," which aims to reimburse State GST paid by bell metal manufacturers.

The scheme is designed to ease the financial burden on traditional artisans and support the survival of the indigenous craft. In the education sector, the Cabinet greenlit the "Prerona Aasoni" scheme, which will provide financial assistance of ₹300 per month to all Class X students studying in schools affiliated with the Assam State Secondary Education Board (ASSEB Div-I) and appearing in the HSLC Examination 2026.

The scheme will be implemented from November 1, 2025, and funds will be transferred via Direct Benefit Transfer (DBT). Additionally, the Cabinet approved an increase in state incentives for Anganwadi Workers and Helpers by ₹1,500 and ₹750 respectively, effective from October 1, 2025. Following this revision, Anganwadi Workers will receive a total monthly remuneration of ₹8,000 and Helpers will receive ₹4,000. Lastly, the Cabinet approved the proposal to change the name of Rabindranath Tagore University to Rabindranath Thakur Vishwavidyalaya.

AIUDF leaders detained amid protests over eviction drive in Dhubri; released later

HT Bureau GUWAHATI, July 10: Tensions flared in Assam's Dhubri district on Thursday as the All India United Democratic Front (AIUDF) staged widespread protests against an ongoing eviction drive that has displaced over a thousand families in the Chapar revenue circle.

The demonstrations, held in villages such as Charuwa Bakra, Santoshpur, and Chirakuti Part I and II, were led by senior AIUDF leaders, including nine sitting MLAs. Among them were Mankachar MLA Aminul Islam and Karimganj South MLA Karim Uddin Barbhuyan. The protestors blocked National Highway 17, disrupting traffic and daily life in the region.

The police detained several AIUDF leaders and party workers at Bilasipara, taking them to Chapar Police Station, from where they were released later in the day. Security has since been tightened in the affected areas.

Tea Garden workers stage dharna across 38 estates in Margherita

MARGHERITA, July 10: In response to a call by the Central Executive Committee of the Assam Chah Mazdoor Sangha (ACMS), the Margherita branch of the organisation staged demonstrations on Wednesday across multiple tea gardens in the region.

Tea garden workers held dharnas in front of the managers' offices at 38 tea estates under the Margherita branch of the ACMS, pressing for a series of demands aimed at improving their working and living conditions.

Key demands included raising the daily wages of workers in large tea estates to ₹351 and increasing the minimum daily wages of workers in small tea gardens to ₹250, as per existing government notifications.

Other demands included revision of salaries for sub-

staff, enhancement of leave and travel allowances, amendment of the Tea Garden Labour Act to eliminate anti-worker provisions, a halt to arbitrary uprooting of tea bushes and sale of tea garden land for industrial purposes, and ensuring that if the 15 tea estates owned by Andrew Yule Tea Company in Assam are to be sold, they be handed over only to reputed tea compa-

Has GST achieved its goals?

ST was launched on July 1, 2017 with the promise that it would transform the Indian economy. It was characterized as a second freedom since it would unify the nation. Eight years later, it is time to assess its performance. While the Prime Minister has lauded the tax, the Leader of Opposition in the Lok Sabha Rahul Gandhi, has criticised it since it marginalises the marginals. GST supposedly subsumed seventeen different taxes, thereby simplifying indirect taxation. Further, with a common tax rate applicable across the country, India was to become one unified market, leading to ease of doing business. The cascading effect of taxes was expected to be eliminated, resulting in lower incidence of taxes and reducing inflation. Black income generation was expected to decline, leading to additional tax collection which could help social development. So, growth was expected to accelerate leading to creation of more jobs. It was slated to reduce inequality by benefiting the poorer states. GST is collected at the last point of sale even though it is applicable at every stage of production and distribution. The consumer pays the entire amount when the final sale occurs. Since the poorer states produce proportionately less than the better off states, their share of consumption in their state GDP ('GSDP') is higher, so they were expected to collect proportionately more of GST, thereby causing inter-state disparities to decline.

This expected benefit to the consuming states became a stumbling block for introduction of GST. The producing states, like Gujarat and Tamil Nadu, feared losing tax revenue and opposed GST. To bring them on board, they were promised a 14 percent increase in tax revenue over the base year, 2015-16. Further, the cash cows of petroleum goods and liquor for human consumption were kept out of GST to allow flexibility to the States. The Centre and the States could levy their own excise on these items and collect extra taxes as per their needs. This came in handy during the pandemic when tax collections plummeted. In brief, the promise was that GDP would rise, inflation would decline, black economy would be checked, inter-state inequality would decline and social sector spending would rise thereby benefitting the marginalised sections. It seemed like a win-win. Did it turn out as promised? Going by official data, did growth accelerate? Three complications arise in assessing this. First, the pandemic changed the basic parameters of the economy as it experienced its biggest downturn in 2020-21, three years after GST's introduction. In 2021-22, the economy started recovering but it has remained below the level it should have achieved if the pandemic had not stuck. Second, GST was initiated 7 months after demonetisation which had damaged the economy.

So, the GDP base was already low. Third, the three years of prepandemic functioning of GST can be termed as transitional for such a complex tax. Similarly, the three post pandemic years are also transitional. So, given these and other complications, both global and local, is it fair to assess the impact of GST on GDP?

sraeli Prime Minister Benjamin Netanvahu and President Donald Trump were closer together on key issues more than ever at their White House meeting on Gaza this Monday, as the Israeli warmaker nominated the American warmaker for the Nobel Peace Prize

After the meeting, they discussed how, among other things, there were talks going on that could result in the removal of Palestinians from Gaza to surrounding countries. "The Palestinian people should have a choice," Netanyahu declared, "about whether to stay or to move out." Not included in the choice he or Trump is offering them, of course, was the right to form an independent Palestinian state and remain in what has been their homeland for thousands of years.

No credible journalists or lawmakers anywhere in the world report even a scintilla of evidence that other countries in the region are even willing to take in Palestinians. The choice Trump and Netanyahu, his accomplice in war crimes in the region, are offering Palestinians is to either stay in a devastated country facing starvation and death at the hands of military occupiers or a massive transfer of an entire people out to surrounding countries that have no interest in taking them in.

In explaining his call for Trump to be nominated for the Nobel Peace Prize, Netanyahu cited the "unmitigated success" of the recent ioint U.S.-Israeli strikes on Iran's nuclear facilities. The two leaders sat down with their top aides for a dinner in the White House Blue Room to mark the Iran operation and allegedly to discuss efforts to push forward with a 60-day ceasefire proposal to pause the 21month conflict in Gaza.

"He's forging peace as we speak, one country and one region after the other," Netanyahu said as he presented Trump with a nominating letter he said he sent to the

Nobel committee. In a move that, instead, endangered peace in the region and the world, Trump ordered U.S. forces to drop "bunker-buster" bombs and fire a barrage of Tomahawk missiles on three key Iranian nuclear sites.

"Coming from you in particular, this is very meaningful," Trump told Netanyahu as the prime minister handed him the nomination letter for the peace prize.

Other than being a meeting enabling Netanyahu and Trump to celebrate a supposed "victory" this week, the session at the White House yielded nothing when it comes to concrete plans for Israel to end its genocidal war against Palestinians. It also left the widespread perception around the world that Trump is not at all seriously pushing for an end to the conflict but instead orchestrating, from behind the scenes, its continuation. Nothing was done to change the fact, for example, that continued pumping in of armaments to Israel by Washington en-

ables the war against the Palestinians to continue. Trump is also claiming that

Iranian officials have reached out to the U.S. to schedule talks about Iran's nuclear program. Negotiations had started in April but were scuttled after Israel and then the U.S. began bombings last month.

Contrary to Trump's assurances, Tehran has yet to confirm that it has agreed to restart talks with the U.S. But Iran's President Masoud Pezeshkian, in an interview published Monday, said the U.S. airstrikes so badly damaged his country's nuclear facilities that Iranian authorities still have not been able to access them to survey the destruction.

Pezeshkian added in the interview with right-wing journalist Tucker Carlson that Iran would be willing to resume cooperation with the U.N. nuclear watchdog but cannot vet commit to allowing its inspectors unfettered access to monitor the sites. (IPA Service)

The BTR Communication Bridge is a groundbreaking publication that marks a new chapter in the journey of unity and inclusion in the Bodoland Territorial Region (BTR). This landmark volume presents 1001 essential English words and 1001 commonly used English sentences, translated into 18 regional languages spoken across BTR: Bodo, Assamese, Bengali, Hindi, Rabha, Garo, Hajong, Rajbanshi, Madahi, Mundari, Kurukh, Khorta, Deshi, Nepali, Sadhri, Barman Kachari, Odia, and Santali, Some of these languages are spoken by small and scattered communities and are considered endangered or vulnerable. By including them alongside more dominant tongues, the book not only promotes practical communication but also contributes to the preservation and revival of precious linguistic traditions that are at risk of being lost.

What sets BTR Communication Bridge apart is its scale, intent, and inclusivity. To our knowledge, no other government, autonomous council, or literary organisation in the country has undertaken such a comprehensive multilingual initiative. While searching, we did not come across any publication of this kind—information compiled in one volume by any government, autonomous council, or literary organisation in the country. This makes the book not only a first of its kind in BTR, but also a rare and pioneering effort where language becomes both a medium and a message for unity.

Credit for this historic accomplishment goes to the visionary leadership of BTC Chief Executive Member Shri Pramod Boro, whose firm belief in unity through cultural respect and communication laid the foundation for this remarkable work. His commitment to inclusive governance and community empowerment finds powerful expression in this book. Sincere gratitude is due to him for imagining and enabling an initiative that no one else in the country had dared to pursue. The book has been compiled and

edited by Zahid Ahmed Tapadar, a seasoned author, compiler and editor with earlier experience of bringing out a multilingual word book in Dima Hasao, Building on that foundation, he led the current effort with unmatched dedication-compiling the English content, translating it into Bengali, and guiding a team of 51 language experts who worked tirelessly to transcreate the words and sentences into their respective languages. The entire projectfrom concept to print-was executed in just 40 days, an achievement that speaks of remarkable teamwork, vision, and efficiency.

The content is contextually relevant and also deeply rooted in everyday life-covering common situations in homes, markets, schools, hospitals, offices, and public spaces.

Equally praiseworthy is the book's design and production quality. The layout is clear and userfriendly. The cover design is visually compelling and symbolically powerful. The print is of high quality, and the aesthetic appeal of the book reflects both professionalism and cultural sensitivity. Many readers have noted that this is perhaps the most finely produced book ever published in BTR in terms of both content and appearance.

But the BTR Communication Bridge goes far beyond being a language tool. It begins with a wellwritten introduction to the Bodoland Territorial Region, followed by a brief account of its historical and political evolution. It



offers insights into the etymology and identity of Bodoland, provides a concise overview of the Bodoland Peace Accord and its resolution model, and reflects on the languages, traditions, and communities that make the region unique. It also includes glimpses of BTR's heritage, culture, and tourism potential, making the book informative, engaging, and meaningful beyond its immediate purpose.

This is not merely a guide to languages-it is a reflection of Bodoland's transformation from conflict to peace, from isolation to connection, and from aspiration to action. It stands as a powerful symbol of what is possible when leadership, language, and collective goodwill come together.

In every respect, BTR Communication Bridge is a landmark achievement. It sets a new benchmark for multilingual inclusion, community engagement, and cultural preservation in the country. More importantly, it gives voice to the many tongues of Bodoland-reminding us that when we speak to each other with respect, we build more than just communication. We build understanding. We build peace. We build a future, together.

The Cost of Industrial Agriculture Industrial agriculture, with its reliance

on intensive tillage, monocultures, synthetic fertilisers, and pesticides, has contributed significantly to the climate crisis by degrading soils and releasing vast stores of carbon.

The Food and Agriculture Organisation (FAO) estimates that agriculture, forestry, and other land use changes contribute about a third of global greenhouse gas emissions.

This damage is not theoretical: vast areas of fertile land have been stripped of organic matter, leading to erosion, desertification, and falling yields. In many regions, farmers are caught in a cycle of declining soil fertility and rising input costs, pushing them further into poverty.

How Regenerative Practices Work In contrast, regenerative farming practices aim to heal the soil and break this destructive cycle. Techniques include cover cropping, no-till or reducedtill farming, composting, crop rotation, agroforestry, and managed grazing.

increase organic matter in the soil, boost biodiversity, improve water retention, and strengthen the resilience of farms to droughts and floods. For example, cover crops prevent erosion and add biomass to the soil, while agroforestry integrates trees into farmland, providing shade, windbreaks, and additional income sources.

A Lifeline for Small Farmers

Beyond its environmental benefits, regenerative agriculture is vital for social and economic reasons.

Smallholder farmers, who produce a large share of the world's food, are on the frontlines of climate change. They face increasing uncertainty due to erratic rainfall, shifting growing seasons, and extreme weather events.

Regenerative practices can help these farmers build resilience by reducing dependence on expensive inputs and by improving yields over time.

Healthier soils retain more water and nutrients, offering protection against both drought and flooding.

Empowerment Through the Soil

Equity is at the heart of regenerative agriculture's promise. By valuing local knowledge and traditional practices, it empowers farming communities-especially women and indigenous people who often play central roles in land stewardship but are marginalised in decision-making and markets. Restoring degraded lands can create opportunities for local employment, support food security, and enhance livelihoods.

The shift to regenerative models also recognises the need for fair access to land, finance, and markets so that all farmers, not just large corporate operations, can participate in the transition to a more sustainable food system.

A Global Climate Imperative

There is also an urgent global imperative to scale up regenerative practices. According to the InterGovernmental Panel on Climate Change (IPCC), landbased solutions, including soil carbon sequestration, could sequester up to 23 gigatons of CO2 by 2050.

This is not a silver bullet that replaces cutting fossil fuel emissions, but it is an essential part of a comprehensive climate strategy. The world cannot meet the Paris Agreement goal of limiting warming to 1.5°C without transforming agriculture and land use.

Momentum and the Risk of Co-option

Many Governments, businesses, and civil society groups are recognising this

Each of these methods is designed to potential. Large and beverage industry have begun investing in regenerative supply chains. Initiatives such as the OP2B coalition have mobilised billions of dollars to promote regenerative practices among farmers.

> Monitoring and verification technologies are improving, enabling better measurement of carbon sequestration and other ecosystem services on farms. Financial incentives, certification schemes, and policy support can help make regenerative farming economically viable at scale.

Yet these efforts must be carefully designed to avoid repeating the mistakes of the past. A just transition to regenerative agriculture must prioritise the needs and rights of farmers, especially smallholders. Solutions must be adapted to local contexts rather than imposed from above.

Land rights, tenure security, and inclusive decision-making are essential to ensure that the benefits of regenerative agriculture are widely shared. Without this focus on equity, the promise of regenerative agriculture risks being coopted or limited to wealthy markets.

India's Regenerative Opportunity

India, with its vast and diverse agricultural landscape, is particularly well placed to champion regenerative agriculture. Many traditional farming systems in India already embody regenerative principles, such as mixed cropping, composting, and agroforestry.

Revitalising and modernising these practices can help address soil degradation, water scarcity, and rural poverty while contributing to India's climate goals. Government support, research institutions, civil society, and farmer producer organisations can all play critical roles in scaling these solutions.

A New Carbon Story

Ultimately, regenerative agriculture offers not only a response to the carbon and climate crisis but a vision for a healthier, fairer, and more resilient world. It reframes carbon from a pollutant to be feared into a vital building block to be stewarded with care. By working with nature rather than against it, we can repair broken ecosystems, secure livelihoods, and leave a more hopeful legacy for future generations. In a time when climate news often feels overwhelming and despairing, regenerative agriculture stands out as a genuine source of optimism-a practical, sciencebacked pathway to resilience, equity, and hope. Rubio says US and Russia have exchanged new ideas for Ukraine peace talks

KUALA LUMPUR, July 10: US Secretary of State Marco Rubio said Thursday that the US and Russia have exchanged new ideas for Ukraine peace talks after he met with his Russian counterpart in Malaysia Thursday.

"I think it's a new and a different approach," Rubio told reporters after talks with Russian Foreign Minister Sergey Lavrov. "I wouldn't characterise it as something that guarantees a peace, but it's a concept that, you know, that I'll take back to the president." He didn't elaborate. Rubio added that President Donald Trump has been "disappointed and frustrated that there's not been more flexibility on the Russian side" to bring about an end to the conflict. "We need to see a roadmap moving forward about how this conflict can conclude. And then we shared some ideas about what that might look like," he said of the 50-minute meeting. "We're going to continue to stay involved where we see opportunities to make a difference."

The two men held talks in Kuala Lumpur on the sidelines of the annual Association of Southeast Asian Nations Regional Forum, which brings together 10 ASEAN members and their most important diplomatic partners including Russia, China, Japan, South Korea, European nations and the US.

The meeting was their second encounter since Rubio took office, although they have spoken by phone several times. Their first meeting took place in February in Riyadh, Saudi Arabia, as the Trump administration sought to test Russia and Ukraine on their



willingness to make peace. Thursday's meeting occurred shortly after the US resumed some shipments of defensive weapons to Ukraine following a pause, ostensibly for the Pentagon to review domestic munitions stocks, that was cheered in Moscow.

The resumption comes as Russia fires escalating air attacks on Ukraine and as Trump has become increasingly frustrated with Russian President Vladimir Putin.

US diplomatic push could be overshadowed by tariff threats Rubio was also seeing other foreign ministers, including many whose countries face tariffs set to be imposed August 1.

Rubio sought to assuage concerns as he held group talks with ASEAN foreign ministers.

"The Indo Pacific, the region, remains a focal point of US foreign policy," he told them. "When I hear in the news that perhaps the United States or the world might be distracted by events in other

parts of the planet, I would say distraction is impossible, because it is our strong view and the reality that this century and the story of next 50 years will largely be written here in this region.

"These are relationships and partnerships that we intend to continue to build on without seeking the approval or the permission of any other actor in the region of the world," Rubio said in an apparent reference to China. Trump notified several countries on Monday and Wednesday that they will face higher tariffs if they don't make trade deals with the US. Among them are eight of ASEAN's 10

members. US State Department officials said tariffs and trade won't be Rubio's focus during the meetings, which Trump's Republican administration hopes will prioritise maritime safety and security in the South China Sea, where China has become increasingly aggressive toward its small neighbours, as well

as combating transnational crime. But Rubio may be hard-pressed to avoid the tariff issue that has vexed some of Washington's closest allies and partners in Asia, including Japan and South Korea and most members of ASEAN, which Trump says would face 25 per cent tariffs if there is no deal. Rubio met earlier Thurday with Malaysian Prime Minister Anwar Ibrahim, who has warned global trade is being weaponised to coerce weaker nations. Anwar urged the bloc Wednesday to strengthen regional trade and reduce reliance on external powers.

Rubio's "talking points on the China threat will not resonate with officials whose industries are being battered by 30-40 per cent tariffs,' said Danny Russel, vice president of the Asia Society Policy Institute and a former assistant secretary of state for East Asia and the Pacific during the Obama administration.

When Anwar said "ASEAN will approach challenges as a united bloc' he wasn't talking about Chinese coercion but about US tariffs." Russel noted

Majority of ASEAN members face major tariff hikes

Among ASEAN states, Trump has announced tariffs on almost all of the bloc's 10 members. Trump sent tariff letters to two more ASEAN members Wednesday: Brunei, whose imports would be taxed at 25 per cent, and the Philippines at 20 per cent. Others hit this week include Cambodia at 36 per cent, Indonesia at 32 per cent, Laos at 40 per cent, Malaysia at 25 per cent, Myanmar at 40 per cent and Thailand at 36 per cent. (AP)

Bangladesh's tribunal indicts deposed PM Hasina over killing of protesters

DHAKA, July 10: A special tribunal in Bangladesh on Thursday indicted deposed premier Sheikh Hasina in absentia on charges of crimes against humanity in connection with a deadly crackdown on protesters during the July-August uprising last year.

The International Crimes Tribunal of Bangladesh (ICT-BD) has set August 3 as the date for the trial.

The tribunal has "framed the charge against her (Hasina) alongside the home minister of her regime Asaduzzaman Khan Kamal and (the then) inspector general of police Chowdhury Abdullah Al Mamun,' prosecution lawyer told reporters.

The ICT bench, headed by Justice Md Golam Mortuza Mozumder, passed the order after rejecting a defence plea to dismiss the charges. The other two members of the tribunal are Justices Md Shofiul Alam Mahmood and Md Mohitul Haq Enam Chowdhury.

The prosecutors said Hasina along with the co-accused was indicted on five charges, including mass killings, murder, and torture to tame the protestors during last year's July-August uprising.

If proven guilty, the accused could face the death penalty

According to a UN rights office report, up to 1,400 people were killed between July 15 and August 15 last year as Hasina's government ordered a security crackdown on protesters.

With Thursday's order, the formal trial against 72year-old Hasina and other defendants in the case for crimes against humanity has begun for the first time.

Hasina's Awami League condemned the indictment against her and other leaders by, what it called, "kangaroo court" and said this step "marks another testament to the ongoing witch hunt against our party and weponssation of judiciary by Yunus regime'

"In eleven months, people have lost their faith over the judicial system as Yunus regime has reduced this key state organ into a means to prosecute dissenters," the party said in a statement on X.

'While we reiterate our commitment for a fair trial for July august victims, we repeatedly express no confidence on the current trial process," it added.

Hasina faces multiple cases in Bangladesh after being ousted on August 5 last year following a mass student-led agitation in the country, which forced her to flee Dhaka



Mamun, the only accused appearing in person, pleaded uilty when produced before the tribunal from custody, prosecutors added.

During the indictment hearing, the former police chief expressed his willingness to make a statement in the prosecution's favour at a later stage. The presiding judge said the tribunal would later decide whether to treat him as an "approver".

Mamun's lawyer told journalists that the ex-police chief agreed to become a state witness, confessing his role during the violent movement.

The ICT-BD's investigation agency on May 12 filed its report in the case, bringing five charges against the trio. The prosecution said the charges include the delivery of a provocative speech by Hasina at a press briefing on July 14, 2024, issuing a directive to eliminate the July Movement protesters with the use of helicopters, drones, and lethal weapons by law enforcement agencies.

The three were also accused of issuing directives to law enforcers, collaborating with the Awami League and plotting to kill innocent students and people on August 5 last year in Dhaka's Chankharpul and Ashulia areas as part of a broader plan to eliminate the protesters to suppress the movement.

The ICT-BD was originally formed during the Awami League regime in 2010 to try the hardened collaborators of Pakistani troops during Bangladesh's 1971 Liberation War on charges of crimes against humanity. Muhammad Yunus' interim government decided to try Hasina in the same court on identical charges. (PTI)

Bangladesh witnessed 2,442 communal Ship attacked by Yemen's Houthi rebels sinks in Red Sea, six of 25 aboard rescued violence incidents in 330 days: Minority body

DHAKA, July 10: Bangladesh witnessed 2,442 incidents of communal violence over a span of 330 days from August 4 last year, when political unrest peaked, leading to the ouster of prime minister Sheikh Hasina's Awami League government, a minority advocacy group in the country said on Thursday.

"Most of these violent incidents happened between August 4 and August 20 last year," the Bangladesh Hindu Buddhist Christian Unity Council said in a statement released at a press conference at the National Press Club here.

The minority communities faced 2,442 incidents of communal violence over a span of 330 days from August 4, 2024, it said.

The nature of violence ranged from murders and sexual assaults, including gang rapes, to attacks on places of worship, seizing homes and businesses, arrests on charges of alleged defamation of religion, and forced removals of minorities from organisations, the statement said.

cents belonging to minority groups.

The perpetrators have largely evaded justice, with the interim government "refusing to acknowledge" the incidents and "dismissing them as politically motivated," the statement said.

A senior Council leader, Narmal Rosario, said the ongoing reform initiatives by the interim government have repeatedly excluded minority communities, "which is the most frustrating factor for us".

"We want to walk together with all," he emphasised.

Another leader, Nimchandra Bhoumik, said, "The division (within the society) was not a pleasant matter for anyone."

"The government, in fact, ignores the incidents of repression of minorities. We demand proper justice," acting general secretary of the council, Manindra Kumar Nath, said.

As per the 2022 census, Hindus are the largest minority community in Bangladesh at 7.95% of the total population, followed by atement said. Buddhists (0.61%), Christians (0.30%), and others (0.12%). (PTI)

DUBAI, July 10: A Liberian-flagged cargo ship attacked by Yemen's Houthi rebels sank on Wednesday in the Red Sea, and a European naval force in the Mideast said only six of the 25 people who were on board have been rescued.

The attack on the Eternity C, which also killed at least three of the crew, represents the most serious assault carried out by the Houthis in the crucial maritime trade route where USD 1 trillion in cargo once passed through annually.

From November 2023 to December 2024, the Houthis targeted more than 100 ships with missiles and drones in a campaign the rebels describe as supporting Palestinians in the Gaza Strip during the Israel-Hamas war. The Iranianbacked rebels stopped their attacks during a brief ceasefire in the war. They later became the target of an intense weekslong campaign of airstrikes ordered by US President Donald Trump.

The attack on the Eternity C, as well

Three people also were killed during the hourslong attack on the ship, the EU force said, and their nationalities were not immediately known.

The armed rebels had attacked the ship with rocket-propelled grenades and small arms, later using two drones and two drone boats carrying bombs to strike the vessel, the EU force said. The Eternity C sank at 7.50 am on Wednesday, it added

The ship, flagged out of Liberia but owned by a Greek firm, likely had been targeted like the Magic Seas over its firm doing business with Israel. Neither vessel apparently requested an escort from the EU force.

The US military has two aircraft carriers in the Mideast, the USS Nimitz and the USS Carl Vinson, but both likely are in the Arabian Sea, far from the site of the attacks. There are two American destroyers believed to be operating in the Red Sea. However, the ships attacked

In the Philippines, Migrant Workers Secretary Hans Cacdac said he has been leading an effort to reach out to the families of the missing Filipino sailors to update them on the search and rescue

efforts "It's human nature that one should be terribly worried and distraught about the situation," Cacdac told The Associated Press by telephone. "It's our role in government to be there for them in their utmost hour of need to ensure that not just government services but throughout this hand-holding process, we will provide the necessary support.'

The attacks on the ships drew international condemnation.

"These attacks demonstrate the ongoing threat that Iran-backed Houthi rebels pose to freedom of navigation and to regional economic and maritime security," US State Department spokesperson Tammy Bruce said. "The United States has been clear: We will continue to take necessary action to protect freedom of navigation and commercial shipping from Houthi terrorist attacks.' The EU force earlier said one of the wounded crew lost his leg. Grundberg, the UN envoy, also decried the targeting of civilian infrastructure after Israel bombed three Houthi-controlled ports in Yemen over the weekend and hit a power station.

Student pilot from India among two killed in mid-air crash in Canada

OTTAWA, July 10: An Indian student pilot was killed in a midair crash in Manitoba province of Canada, according to the Consulate General of India in Toronto.

The Indian pilot, identified as Sreehari Sukesh, was killed when his single-engine plane collided mid-air with another similar aircraft piloted by a Canadian youth, who was also killed in the accident on Tuesday.

The Consulate General of India on Wednesday said it was "in contact with the bereaved family, the pilot training school and local police to provide all necessary assistance." "The bodies of the two student pilots were recovered in the wreckage of their single-engine planes after both crashed mid-air on Tuesday morning near Steinbach, roughly 50 kilometres southeast of Winnipeg," a Canadian Broadcasting Corporation (CBC) news report said. The students collided when approaching a landing strip while practising takeoffs and landings, the CBC report said, quoting Adam Penner, president of Harv's Air, the flying school where both pilots had been training. The Transportation Safety Board, the agency responsible for investigating aviation incidents in Canada, said it is gathering information and assessing the fatal crash. Sreehari Sukesh's age was not mentioned. The CBC said the Canadian victim was 20-year-old Savanna May Royes, who, it said, "had always dreamed of becoming a pilot, following in the footsteps of her father." A Royal Canadian Mounted Police (RCMP) statement said after its Steinbach unit was notified of the mid-air collision, the personnel from the RCMP, fire department and Emergency medical services attended and located the wreckage of two small, single-engine aircraft, south of Steinbach. TikTok faces fresh European privacy investigation over China data transfers LONDON, July 10: TikTok is facing a fresh European Union privacy investigation into user data sent to China, regulators said Thursday.

The Data Protection Commission opened the inquiry as a follow up to a previous investigation that ended earlier this year with a 530 million Euro (USD 620 million) fine after it found the video sharing app put users at risk of spying by allowing remote access their data from China

The Irish national watchdog serves as TikTok's lead data privacy regulator in the 27-nation EU because the company's European headquarters is based in Dublin.

During an earlier investigation, TikTok initially told the regulator it didn't store European user data in China, and that data was only accessed remotely by staff in China. However, it later backtracked and said that some data had in fact been stored on Chinese servers. The watchdog responded at the time by saying it would consider further regulatory action. (AP)

Six of 25 on board have been rescued A statement from the European Union naval mission in the Red Sea said the crew of the ship included 22 sailors, among them 21 Filipinos and one Russian, as well as a three-member security team. Those rescued were five Filipinos and one Indian.

Tanks were also dispatched to one of Taiwan's international airports in the centre of the capital Taipei to guard against an imaginary Chinese air landing operation. In its unusual fashion, Beijing has derided the war exercises as a farce that will have no effect on its determination to take over the island, whose population overwhelmingly rejects unification with China. Taiwan earlier in the week accused China's coast guard and maritime militia of harassing Taiwanese boats near Taiwan-held islands off the Chinese coast and on Wednesday sanctioned eight Taiwanese companies it said were aiding Taiwan's defence industry. UN says if US funding for HIV programmes not replaced, millions more will die by 2029

LONDON, July 10: Years of American-led investment into AIDS programmes has reduced the number of people killed by the disease to the lowest levels seen in more than three decades, and provided life-saving medicines for some of the world's most vulnerable.

But in the last six months, the sudden withdrawal of US money has caused a "systemic shock," UN officials warned, adding that if the funding isn't replaced, it could lead to more than 4 million AIDS-related deaths and 6 million more HIV infections by 2029.

"The current wave of funding losses has already destabilised supply chains, led to the closure of health facilities. left thousands of health clinics without staff, set back prevention programmes, disrupted HIV testing efforts and forced many community organisations to reduce or halt their HIV activities," UNAIDS said in a report released Thursday. UNAIDS also said that it feared other major donors might also scale back their support, reversing decades of progress against AIDS worldwide — and that the strong multilateral cooperation is in jeopardy because of wars, geopolitical shifts and climate change.

The USD 4 billion that the United States pledged for the global HIV response for 2025 disappeared virtually overnight in January when US President Donald Trump ordered that all foreign aid be suspended and later moved to shutter the US AID agency.

Andrew Hill, an HIV expert at the University of Liverpool who is not connected to the United Nations, said that while Trump is entitled to spend US money as he sees fit, "any responsible government would have given advance warning so countries could plan," instead of stranding patients in



Africa when clinics were closed overnight.

The US President's Emergency Plan for AIDS Relief, or PEPFAR, was launched in 2003 by US President George W Bush, the biggest-ever commitment by any country focused on a single disease. UNAIDS called the programme a "lifeline" for countries with high HIV rates, and said that it supported testing for 84.1 million people, treatment for 20.6 million, among other initiatives. According to data from Nigeria, PEPFAR also funded 99.9 per cent of the country's budget for medicines taken to prevent HIV. In 2024, there were about 6,30,000 AIDS-related deaths worldwide, per a UNAIDS estimate — the figure has remained about the same since 2022 after peaking at about 2 million deaths in 2004. Even before the US funding cuts, progress against curbing HIV was uneven. UNAIDS said that half of all new infections are in sub-Saharan Africa.

Tom Ellman, of the charity Doctors Without Borders, said that while some poorer countries were now moving to fund more of their own HIV programmes, it would be impossible to fill the gap left by the US. "There's nothing we can do that will protect these countries from the sudden, vicious withdrawal of support from the US," said Ellman, director of Doctors Without Borders' South Africa Medical Unit.

Experts also fear another loss: data. The US paid for most HIV surveillance in African countries, including hospital, patient and electronic records, all of which has now abruptly ceased, according to Dr Chris Beyrer, director of the Global Health Institute at Duke University.

"Without reliable data about how HIV is spreading, it will be incredibly hard to stop it," he said.

The uncertainty comes as a twice-yearly injectable could end HIV, as studies published last year showed that the drug from pharmaceutical maker Gilead was 100 per cent effective in preventing the virus. At a launch event Thursday, South Africa's health minister Aaron Motsoaledi said the country would "move mountains and rivers to make sure every adolescent girl who needs it will get it," saying that the continent's past dependence upon US aid was "scary." Last month, the US Food and Drug Administration approved the drug, called Yeztugo, a move that should have been a "threshold moment" for stopping the AIDS epidemic, said Peter Maybarduk of the advocacy group Public Citizen. But activists like Maybarduk said Gilead's pricing will put it out of reach of many countries that need it. Gilead has agreed to sell generic versions of the drug in 120 poor countries with high HIV rates but has excluded nearly all of Latin America, where rates are far lower but increasing. (AP)

Hindi has been in the school curriculum ever since education came to Arunachal Pradesh and there is no problem in learning it, Khandu told PTI Videos in an interview.

There is so much diversity in Arunachal Pradesh that 26 major tribes and over 100 subtribes speak their own languages and dialects, the chief minister said.

"If I speak in my own dialect, my own language, people from another tribe will not understand. That's why everyone speaks Hindi. There will certainly be grammatical mistakes... but even if you go to a village, all the villagers will understand and speak Hindi. We speak Hindi in election campaigns and even in the Assembly

"So definitely, Hindi is a binding language. There's no problem in learning it. It should be learnt," the BJP leader said in comments that come amidst the ongoing row over Hindi in

Maharashtra and some southern states.

He said Arunachal Pradesh is a strategic location where security force personnel come from different states and most speak in Hindi. "There is also the Border Roads Organisa-

tion. So there are various other mediums through which we picked up Hindi quickly," he said.

that the next Dalai Lama would not be from China and could be from somewhere else, Khandu said, "Yes, definitely not from China because there is no democracy there." "So wherever there is democracy... it can be anywhere in the

world where there is democracy," he said.

When pointed out that Tibet is also under Chinese rule, the chief minister responded, "That is why, I am not saying specifically it would be from this country or that coun-

try." "It would be a bit immature for us to say this right now. But this much is certain... where there is democracy, where people have their freedom, can express their views. I think there is clarity on that," he said.

The chief minister said the Gaden Phodrang Trust will carry out the search for the next Dalai Lama.

"The search for the 15th Dalai Lama... the entire process will begin only after the present Dalai Lama passes away. So there is no hurry in this," he said.

On China's objection to the Dalai Lama's succession issue, Khandu said, "I don't know why China is objecting to it. They must have their own policy. There is no Dalai Lama institution in China. The Dalai Lama institution is recognised mainly in the Himalavan belt and by the Tibetan Buddhists. China has no role in it.

The chief minister said the Dalai Lama institution has been continuing for over 600 years, from the first Dalai Lama to the current 14th. He said there was speculation about whether the Dalai Lama institution would continue and if the

next Dalai Lama could be a woman. "Before the 90th birthday of the 14th Dalai Lama, all heads of Buddhist traditions met and confirmed the institution will continue," he said. (PTI)

Deputy Chairperson of the council, Neelam Gorhe, later announced that the remarks made by the two leaders would be expunged from the official records. During the Question Hour, Milind Narvekar of the

Shiv Sena (UBT) asked a question that a social organisation has demanded 50 per cent of the housing units in the city be reserved for Marathi people.

He also sought to know if the present government has taken any decision about it.

In a written response, Deputy Chief Minister Eknath Shinde, who is also the Housing Minister, said the department has not received any such letter from the organisation

BJP leader Chitra Wagh, a nominated member of the House, said it was appropriate to reserve 50 per cent houses for Marathi people. She asked whether there was any such proposal when Uddhav Thackeray was the chief minister.

To this, minister Desai, who was replying on behalf of Shinde, said there was no such proposal when the Thackeray-led Maha Vikas Aghadi (MVA) government was in power. "No one has the right to deny Marathi manoos a house in Mumbai, its suburbs or Maharashtra. If any builder does this, the government will take strict action," he said.

Shiv Sena leader Hemant Patil, in an apparent dig at Thackeray, said when people are in power, they have an opportunity to do some positive things for the Marathi manoos, but Chaturvedis are sent to the Rajya Sabha instead of Narvekars.

His remark was apparently aimed at Shiv Sena (UBT) Rajya Sabha member Priyanka Chaturvedi.

Sena (UBT) MLC Parab said he had brought a private member's bill in the House to reserve 50 per cent of the houses in redeveloped buildings for Marathispeaking people. He also asked if the state government would bring such a law.

But Desai said when the MVA was in power during 2019-2022, it did not bring any such law.

"You did not do that and this has come on record.

A furious Desai strongly objected to Parab's remark, and challenged him for a confrontation outside the House.

As tempers ran high, Gorhe adjourned the House for 10 minutes. Later, she said the remarks made by Desai and Parab will not be part of the House's record. After the proceedings of the House resumed, Desai said the government will do whatever was required to give priority to Marathi manoos in housing schemes. Earlier, Sachin Ahir of Sena (UBT) said if MHADA, a government body that builds affordable houses, has a clause of 15 year domicile certificate, then the government has a scope to look into it.

"(BJP MP Nishikant) Dubey has a flat in Khar. He doesn't stay here but has rented it out. So Marathi manoos has no house but outsiders buy houses here as an investment," he said.

Dubey triggered a controversy recently for his "patak patak ke marenge" (will thrash you) remark targeting MNS chief Raj Thackeray and his cousin Uddhav amid incidents of violence against Hindi-

speaking people in Maharashtra. Later, talking to reporters on the Vidhan Bhavan premises, Desai, who handles the tourism, mining and ex-servicemen welfare portfolios, said the wars of words between him and Parab took place during a debate over protection for native Maharashtrians in housing projects in Mumbai and its surrounding region. "The discussion was about legal provisions to ensure housing for Marathi people. BJP MLC Chitra

Wagh asked whether the MVA government had made any such legal provision. I replied that no such step had been taken by that government," he said. The minister said his reply appeared to have provoked Parab. "Parab called me a 'gaddar' (traitor). I responded in a similar language, and it led to a heated exchange," Desai said.

CM Patel, who handles the roads and buildings department, had asked experts to prepare a report on the repairs, inspections and quality checks conducted at the bridge, and the decision to suspend the four engineers was taken on the basis of this report, a government release said. NEW DELHI, July 10: The Supreme Court on Thursday asked the Election Commission to consider Aadhaar, Voter ID and ration cards as valid documents during its ongoing Special Intensive Revision (SIR) of electoral rolls in Bihar, set to go to polls later this year.

Calling SIR a "constitutional mandate", Justices Sudhanshu Dhulia and Joymalya Bagchi considered the submissions of senior advocate Rakesh Dwivedi, appearing for EC, and permitted the poll panel to continue with the exercise in Bihar with over 7 crore voters.

Terming the right to vote as an important right in a democratic country, it said, "We cannot stop a constitutional body from doing what it is supposed to do. Simultaneously, we will not let them do what they are not supposed to do."

The bench in its order further noted, "After

is up to you to consider. We are saying it looks that way. They are genuine. If you have a good reason to discard then discard it. But

It also cited Section 21(3) of the RP Act, which permits the poll panel to carry out a special revision "in such manner as it may think fit", reinforcing the panel's discretionary power.

Senior advocates Kapil Sibal, Abhishek Manu Singhvi, Shadan Farasat, Vrinda Grover, and others termed the approach of the poll panel as exclusionary and disproportionate affecting the poor.

Sibal cited Bihar government data indicating that only a small fraction of the population possesses the documents deemed acceptable by the poll panel, with just 2.5 per cent holding passports and under 15 per cent having matriculation certificates. Grover said the process was "exclusionary rather than inclusionary" whereas Singhvi emphasised that disenfranchising even a single eligible voter undermined democratic integrity and violates the basic structure of the Constitution.

"Even the documents you are accepting," the bench told the ECI, "are ultimately based on Aadhaar... The contradiction in excluding a document which is deeply embedded in other accepted forms of identity.

Dwivedi maintained that Aadhaar could not be accepted as proof of citizenship and verifying one's credentials was the poll panel's responsibility under Article 326 of the Constitution. (PTI)

First indigenously made diving support vessel 'Nistar' to be inducted into Navy on July 18

indigenously constructed diving support vessel that can undertake deep-sea diving and rescue operations, is set to be inducted into the Indian Navy on July 18, officials said on Thursday.

The ship will be commissioned at a ceremony to be held at the Naval Dockyard, Visakhapatnam, in the presence of Defence Minister Rajnath Singh, they said.

'Nistar', designed and constructed by Hindustan Shipyard Limited, Visakhapatnam, was delivered to the Indian Navy on July 8 at Visakhapatnam.

The ship will also serve as the 'Mother Ship' for Deep Submergence Rescue Vessel (DSRV) to rescue and evacuate personnel in case of an emergency in a submarine underwater, a Navy spokesperson said on Wednesday. On commissioning, 'Nistar' will join the Eastern Naval Command to support deep-sea diving and submarine rescue operations.

The ship is highly specialised and can

NEW DELHI, July 10: 'Nistar', the first undertake deep-sea diving and rescue operations -- a capability with select navies across the globe, the Navy official earlier said. With a length of approximately 120 metres and a tonnage of nearly 10,000 tonnes, the DSV has the capacity to maintain its position with extreme accuracy, using dynamic positioning system, the officials said.

> "The expansive diving complex onboard, which consists of both air and saturation diving systems, along with underwater Remotely Operated Vehicles (ROVs) and side scan sonar, substantially enhances the operational envelope of the vessel," the Navy spokesperson said on Thursday. As the 'Mother Ship' for the DSRV, the induction of this platform would provide a "major capability enhancement" to Indian Navy's submarine rescue preparedness.

The ship is also outfitted with an operation theatre, an intensive care unit, eightbed hospital and hyperbaric medical facilities which are critical towards meeting her operational roles, the spokesperson said. With an endurance of "over 60 days at sea, capacity to undertake stage through helicopter operations and a 15tonne sub-sea crane make the ship a very versatile platform," he said.

The ship is a testament to the government's focus on nation-building through self-reliance in defence production and unwavering focus on 'Aatmanirbharta'. A total of 120 MSMEs have participated in the construction of this ambitious, unique and state-of-the-art vessel, achieving more than 80 per cent indigenous content, the officials said. The project is a step towards realising the Indian Navy's vision of designing and constructing complex indigenous platforms.

SHILLONG, July 10: In a major push towards governance reform, judicial efficiency, and cultural promotion, the Meghalaya Cabinet on Wednesday approved three proposals.

Those include a set of criminal justice rules under the new national criminal laws, the Meghalaya Film Tourism Policy 2025, and the discontinuation of interviews for Group D posts in state recruitment.

The key decisions were made during the Cabinet meeting chaired by Chief Minister Conrad K Sangma.

Government spokesperson Paul Lyngdoh said three new criminal justice rules are aimed at aligning the state's legal procedures with the Bharatiya Nyaya Sanhita, Bharatiya Nagariksuraksha Sanhita, and Bharatiya Sakshya Adhiniyam.

The Meghalaya e-Shaksha Management Rules 2025 will enable secure, tamper-proof storage of electronic evidence' such as videos and photographs' through the mobile application e-Shaksha, which integrates with the Crime and Criminal Tracking Network and Systems (CCTNS) and Inter-Operable Criminal

Justice System (ICJS) systems. Each piece of evidence will be digitally secured and assigned a unique ID, ensuring accessibility to courts and prosecutors during trial.

It also includes the Meghalaya Electronic Processes Issuance Service and Execution Rules 2025, which will allow for the digital issuance of summons, warrants, and other legal processes.

Meghalaya Cabinet approves criminal justice reforms, scraps interviews for recruiting Group D staff

These e-documents will be generated via a centralised case information system, replacing paper-based formats and improving efficiency in court proceed-

The Meghalaya Guidelines for Community Services 2025 introduce community service as an alternative form of punishment for individuals convicted of petty offences.

Courts can now sentence such offenders to socially constructive activities including assisting in hospital maintenance, organising books in government libraries, cleaning classrooms in public schools, supporting municipal cleaning efforts, or participating in tree planting and weed removal in forest department programmes.

"These reforms modernise our criminal justice system and introduce a more rehabilitative approach, in full conformity with the new national laws. The rules were approved after due consultation with the Meghalaya High Court," Home Commissioner & Secretary Cyril Diengdoh Diengdoh elaborated

The Cabinet also approved the Meghalaya Film Tourism Policy 2025, aimed at positioning the state as a prime filmmaking destination in the northeast. The policy will attract national and international productions, while providing incentives for local filmmakers and strengthening infrastructure, Tourism Minister Paul Lyngdoh said.

The policy, released three months ago and finalised after integrating over 200 suggestions from industry stakeholders, includes subsidy support of up to 1 crore or 25 per cent of the total production cost for films made in major national and international languages, provided 75 per cent of the shoot takes place outdoors in Meghalaya.

Local films in Khasi, Pnar, and Garo will receive a 50 lakh subsidy, which can be availed of once every two years.

Further support is extended to the production of TV serials, web series, and original shows for the state-run Hello Meghalaya App, the only governmentfunded OTT platform in India. Grants will also be available for documentaries and short films, alongside the establishment of a much-anticipated state-run film studio.

A dedicated film facilitation cell will be created to coordinate with various departments, including Tourism, Arts & Culture, and the Department of Information and Public Relations (DIPR), to streamline implementation.

"This is a milestone initiative to promote our landscapes, create job opportunities, and support homegrown content,' Lyngdoh said

In another key governance reform, the Cabinet approved the discontinuation of interviews for Group D posts in state recruitment processes.

This move, in line with guidelines from the Department of Personnel & Training (DoPT), Ministry of Personnel, Public Grievances & Pensions, aims to ensure greater transparency, fairness, and merit-based selection. (PTI)

Cong alleges no tender for prefab homes, seeks probe

IMPHAL, July 10: The opposition Congress in Manipur on Thursday demanded an investigation into the construction of pre-fabricated houses for displaced people, claiming that no tender was floated for the work. State Congress president Keisham Meghachandra said during a visit to two sites of pre-fabricated houses in Bishnupur district on Wednesday, he learnt constructions were underway without a work order or any tender.

"The constructions were not being done officially. We are demanding a thorough investigation into how pre-fabricated houses were being constructed without floating tenders. This strongly indicates a possible loot of hundreds of crores of rupees," he alleged.

"The government, both in the state and at the Centre, must ensure direct transfer of all the financial benefits meant for the displaced persons to their individual bank accounts, instead of transacting through middlemen," he added.

Meghachandra, the MLA of Wangkhem, said the government must also ensure a fixed timeline for the return of the displaced people to their original homes.

He submitted a memorandum to Governor Ajay Kumar Bhalla regarding this. (PTI)

CYMA provides aid assistance to Myanmar refugees, victims of rain

AIZAWL, July 10: The central committee of Young Mizo Association (CYMA), Mizoram's largest and most influential civil society organisation, on Thursday extended financial aid of over ₹ 19 lakh to support refugees from Myanmar and locals affected by rains.

According to a press statement issued by the organisation, ₹ 6 lakh was disbursed to YMA branches in East Mizoram's Champhai district to support refugees from Myanmar, who recently fled to the state due to armed conflict between ethnic Chin militias in the Chin hills. Of the amount, ₹3 lakh was provided to the Zokhawthar branch, ₹ 2 lakh to the Vaphai

branch and ₹ 1 lakh was provided to Champhai YMA sub-quarters. The CYMA's statement also said that over ₹ 13 lakh was disbursed on Thursday to aid people affected by natural

people from Myanmar had fled to Mizoram and took shelter in Zokhawthar and Vaphai villages in Champhai district due to the recent gunfights between two anti-junta forces - Chin National Defence Force (CNDF) and Chinland Defence Force (CDF).

Some refugees were sheltered by their relatives, while others lodged at community halls, and they were provided food by village authorities and NGOs, they said.

According to the State Emergency Operations Centre (SEOC) of Mizoram's Disaster Management and Rehabilitation department, a staggering 846 landslides have been reported across the state between May 24 and July 9, severely disrupting infrastructure, mobility, and daily life.

Wanted to make sure I'm not stepping on any toes: Nagesh Kukunoor on new series 'The Hunt'

NEW DELHI, July 10: As a filmmaker, anything remotely political is a no-go zone for Nagesh Kukunoor but he says what drew him to "The Hunt - The Rajiv Gandhi Assassination Case" was that it came across as a true crime thriller.

The series, which debuted last week on streaming service SonyLIV and has garnered good reviews, delves into the aftermath of one of India's most tragic historical events -- the assassination of former prime minister Rajiv Gandhi on the night of May 21, 1991, at a poll rally in Tamil Nadu's Sriperumbudur.

Adapted from author Anirudhya Mitra's 2022 book "Ninety Days: The True Story of the Hunt for Rajiv Gandhi's Assassins", the show follows the Special Investigation Team of the CBI that cracked the assassination plot, identified the assassins and chased the mastermind, Sivarasan, to his final hideout

"I had never ventured into the true crime space ever, so it was exciting to actually adapt a book. I had done a little bit of adapting, but it was more articles for 'Modern Love Hyderabad'. But this was a completely different format ... an event has happened and you are actually going to now dramatise it," Kukunoor told PTI in an interview.

"The thing that always makes something like this more challenging is because it's a sensitive topic, you want to make sure that you're not stepping on any toes. You're trying to do right by all while telling and engaging in dramatic stories," he added.

The project was brought to Kukunoor, a director who created a space for himself with deeply personal stories like "Hyderabad Blues", "Rockford", "Iqbal" and "Dor", by Sameer Nair, the CEO of production banner Applause Entertainment. "Sameer and I are good friends. He

pitched this book to me because this is anything but political. This is a true crime thriller. It begins with the day of the assassination and then just tells you what happened over the next 90 days, and that's what attracted me to it.

"He already knew my rules. That I don't do anything political or religious. Nothing with those overtones... I was not going to attempt any real life politics because you don't know who can be offended," he said. If he has to tackle anything political, then he will do it in the fictional space, Kukunoor added, giving the example of his JioHotstar show "City of Dreams".

"When I write something, I want to give equal weight to both parties. I don't mean parties in the political sense. I mean characters. And when you're doing anything political that usually doesn't find favour because someone always takes a side and the other side is going to be offended. So it's like 'Why wade into that?' Even in this, there is no taking sides of anyone. Nothing political happens. It's just the way the events unfolded and they're laid out.'

Kukunoor said he doesn't care to be in the public eye despite being a known figure in the world of movies. "I don't have any presence on social media. Someone just told me that my last post was in June of 2019 when I wished Keerthy Suresh on her birthday apparently.

"I have a lot to say in the material that I write because it's the kind of person I am... I don't need to stand on a box and I don't need to spout things and wade into controversies and stuff like that. Not the kind of person I am. The ones who have the interest to do that, by all means they should.'

Kukunoor said he handled the story of "The Hunt: The Rajiv Gandhi Assassination Case" with utmost care. "A lot of the special investigation team members are still alive today. So I want to make sure that I did right by them," he added.

Adapting a book is a very subjective yet cumbersome process, said the filmmaker, who collaborated with Rohit G Banawlikar and Sriram Rajan on the project. "It's just subjective and me as a director, I have to just take a call on which incidents I feel can propel the story forward better because the book is always dense with details. You can't take every single one and turn it into a scene.

And at the same time, sometimes you'll just take two lines of a book and you feel that that could give a huge, powerful scene.

Asked what were his memories of the time when the incident took place, Kukunoor said he was in the US where he was studying for his master's degree in environmental engineering at Georgia Institute of Technology.

"I had just finished getting my master's and obviously the event shocked me. India women register maiden T20 series win against England



MANCHESTER, July 10: India scripted a landmark victory, clinching their first-ever Women's T20I series win against England with a dominant six-wicket triumph in the fourth match, led by a stellar performance from their spinners.

With this win, India took an unassailable 3-1 lead in the five-match series, with the final game scheduled to be played in Birmingham on Saturday. India had beaten England

in a lone T20I match played in Derby in 2006. Since then, the 'Women in Blue' have fallen short in every women's T20I series against England, both at home and away. Spin played a starring role in

India's dominant win on Wednesday as Radha Yadav (2/15), 20-year-old Shree Charani (2/30), and Deepti Sharma (1/29) combined to claim five wickets, restricting the hosts to a modest 126 for 7.

Openers Shafali Verma (32) and Smriti Mandhana (31) then chased with flair, putting on a 56-run stand that laid the foundation for the win. The visitors overhauled the target with 18 balls to spare, capping off a memorable evening.

The victory comes as a timely boost for India, helping them acclimatise to English conditions ahead of the ICC Women's T20 World Cup scheduled to be held here next year.

"We are really grateful that we were able to do this (series win). I'm really proud of my team the way we played this series. It was really important to get that momentum and I'm really happy the way we all contributed," India skipper Harmanpreet Kaur said at the post-match presentation. "We had very good camps back home before coming here. We worked on all our plans, accordingly we have executed

everything here. Everybody knew their role and accordingly we all played," she added.

Kaur and Co. have been in redhot form, having handed England a record-shattering 97-run defeat in the series-opener before sealing a 24-run win in Bristol, England women's first-ever T20I loss at the venue. They lost the third T20I by five runs. Electing to bat first, England found themselves under early pressure as Indian spinners Radha and Deepti struck within the powerplay, removing both the openers.

Stand-in captain Tammy Beaumont, leading in the absence of the injured Nat Sciver-Brunt, briefly counterattacked with a 16-ball 20 that included three boundaries. But her stay was cut short by Radha, and five balls later, Charani trapped Alice Capsey leg-before, leaving England wobbling at 93 for 5. India's bowlers were backed by a sharp fielding effort that squeezed England during the middle overs, keeping the hosts to a sub-par total. With the bat, Shafali came out

swinging, taking on the short-ball ploy with confidence and cracking six boundaries. Mandhana too joined the charge, striking five fours of her own. Though both openers fell in quick succession, the platform was well set. Jemimah Rodrigues (24 not out) and Harmanpreet Kaur (26) steered India home through a boundary-less phase between overs 8 to 14 to eventually take India to the win. (PTI)

Djokovic reaches a record 14th

Wimbledon semifinal and faces

No. 1 Jannik Sinner next

LONDON, July 10: At least Novak Djokovic could laugh about it immediately afterward.

Yes, he took what he called a "nasty" and "awkward" fall on his second match point at Wimbledon on Wednesday. Yes, he slid into the splits and ended up face-down on the Centre Court grass. And, yes, those sorts of things aren't ideal for a 38-year-old seeking an unprecedented 25th Grand Slam title.

Still, Diokovic dusted himself off and took the next two points, reaching the semifinals at the All England Club for a men's-record 14th time with a 6-7 (6), 6-2, 7-5, 6-4 victory over No. 22 seed Flavio Cobolli to set up a showdown against No. 1 Jannik Sinner.

"Obviously, (my) body is not the same today like it was before," Djokovic said at his news conference, "so I guess the real impact or effect of what happened, I will feel tomorrow. So let's see. I'm hoping in the next 24, 48 hours, that the severity of ... what happened is not too bad, that I'll be able to play at my best and free of pain in two days." That's when he will take on three-time major champion Sinner, who didn't play like someone dealing with an injured right elbow while using terrific serving and his usual booming forehand to beat 10th-seeded Ben Shelton 7-6 (2), 6-4. 6-4.

"It's going to take the best of me at the moment to beat Jannik. I mean, I know that," said Djokovic, who has lost his last four meetings with Sinner, including in the French Open semifinals last month Djokovic is 2-0 against Sinner at

Wimbledon, eliminating him in the 2023 semifinals and 2022 quarter-



late-match tumble was not the only thing that was far from smooth for Djokovic. He served for the opening set at 5-3 but got broken at love. He later was a point from owning that set before first-time major quarterfinalist Cobolli came through.

Djokovic did stretches and breathing exercises at changeovers. He whacked his shoe with his racket after one miss in the fourth set. He seemed bothered at times by the bright sun above Centre Court.

He also showed off all of his considerable skills, accumulating 13 aces, holding in 19 of 21 service games, using a drop-shot-lob-dropshot combination to take one point and limiting his unforced errors to 22 — half as many as Cobolli.

On Friday, Djokovic will try to reach his seventh consecutive final at the All England Club and get closer to equaling Roger Federer's men's mark of eight trophies there. The other men's semifinal is twotime defending champion Carlos Alcaraz, who defeated Djokovic in the 2023 and 2024 finals, against Taylor Fritz.

The women's semifinals Thursday are Aryna Sabalenka vs. Amanda Anisimova, and Iga Swiatek vs. Belinda Bencic.

Against Shelton at No. 1 Court, Sinner wore a white sleeve on his right arm with strips of tape visible underneath — one above the elbow, one below it — after he was hurt when he fell in the opening game of his fourth-round match against Grigor Dimitrov on Monday. (AP)

EAST RUTHERFORD (USA), July 10: Wearing their blue, red and white jerseys, Paris Saint-Germain supporters were surrounded by white shirts.

Real Madrid fans were 95% of the crowd at MetLife Stadium for Wednesday's Club World Cup semifinal, the shirts of Los Blancos radiant in the harsh summer sun. Yet, it was PSG fans in a couple sections behind one goal who cheered virtually from start to finish as their team moved within one win of a historic quadruple.

A 4-0 rout of Real Madrid in a Club World Cup semifinal following a 5-0 wipeout of Inter Milan in the Champions League final reinforced that PSG may be the dominant soccer team of the mid-2020s. "We have always said that the collective work by the players is what's helping us," said Fabián Ruiz, who scored twice as PSG built a three-goal lead in the first 24 minutes. "We are a great group, a young group that is working well."

PSG moved on to Sunday's final against Chelsea in the first expanded Club World Cup with a chance to win its fourth major title of the season exactly 100 days after it clinched Ligue 1 on April 5. It added the Coupe de France by beating Reims 3-0 on May 24, then romped over Inter seven days later.

PSG's blue, red and white jerseys don't have glamorous names pressed across the back, and they may not be as ubiquitous as the the red shirts of Manchester United, Liverpool and Arsenal, Manchester City's light blue or Chelsea's royal blue, but the team is filling up the trophy display at Parc des Princes, its cramped, outdated stadium not far from Roland-Garros and the Bois de Boulogne. On May 31 at Munich, Achraf Hakimi got the first goal 12 minutes in, Désiré Doué scored the next two and Khvicha Kvaratskhelia and Senny Mayulu

added one goal each.

This time, Ruiz scored in the sixth minute and Ousmane Dembélé in the ninth following glaring mistakes by defenders Raúl Asencio and Antonio Rüdiger, and Ruiz made it 3-0 to cap a counter. Gonçalo Ramos added a goal in the 87th. Dembélé, this year's Ligue 1 Golden Boot winner with 21 goals, started for the first time since straining his left quadriceps with France on June 5. He missed the Club World Cup group stage and was a substitute in PSG's first two knockout matches, scoring in second-half injury time during Saturday's 2-0 quarterfinal win

over Bayern Munich. "This is the first match in this World Cup that we can use Usman as a normal player," PSG coach Luis Enrique said. "I think he is the best player this season by a long term and I think he deserves to win everything because he gave everything to the team and the team is going to achieve trophies, which is the most impor-

tant thing for a club.' Real Madrid has 15 European and five world titles, a modern global superpower brand established two decades ago in the Galacticos era of David Beckham, Zinedine Zidane and Luis

Figo, then lifted loftier by Cristiano Ronaldo from 2009-18 and the rise of social media.

PSG hadn't won a Ligue 1 title since 1995 when Qatar Sports Investments took over in 2011. Paris has won 11 of 13 French championships since 2013 but until May failed to become Europe's best, despite emulating Madrid's star collection when its lineup included Lionel Messi and Kylian Mbappé.

A group achieved more than the star system.

Netherlands 4-0 to revive Euro title defense

ZURICH, July 10: A "proper" England performance saw the Lionesses get the defense of their Women's European Championship title firmly back on track with a 4-0 win over the Netherlands on Wednesday, thanks to a Lauren James double.

James showed precisely why she had been selected despite not having played for more than two months when the squad was announced in June because of injury. The Chelsea forward was at the heart of England's attacks and scored a sumptuous opener in the 22nd minute before netting her side's third on the hour mark.

James has been directly involved in 16 goals in her last 13 starts for England, with eight goals and eight assists. Georgia Stanway doubled Eng-

land's lead on the stroke of halftime and Ella Toone wrapped up the result in the 67th as the Lionesses, watched by Prince William, gave the perfect response to their 2-1 defeat to France.

"This is about showing who we are," Stanway told the BBC. "We want to go back to proper England. LJ (Lauren James) set the tone with that goal and we all just followed."

Player-of-the-match Alessia Russo elaborated.

"I think proper English to us just means we'll work hard, we'll work until we can't run anymore, we stick together," she said. "That's our standard and our DNA as a team and we definitely saw that today from the first minute right until the end.

"(We) probably could have scored even more as well ... it was definitely something that we wanted to return to and we know that we're capable of performances like that.'

It was a far more positive performance from England than against France, when it became the first titleholder to lose its opening match at a women's Euros. The manner of that defeat was as disappointing as the result, which left England facing possible elimination if it lost to the Netherlands and France avoided a shock defeat against Wales later Wednesday.

France ultimately defeated Wales 4-1 to take charge of Group D with six points from two games, three more than England and the Netherlands.

England plays Wales in their final group match on Sunday, when the Netherlands faces France.

"We have to believe in our chances." Netherlands coach Andries Jonker said. "If not it's better not to show up.³

The Netherlands, which beat Wales 3-0 in their opener, had never previously lost a match at a major tournament by more than a single goal — apart from the 2019 World Cup final.

"It is a heavy defeat and we didn't see it coming," Jonker said. "We thought we would be able to compete.

"We wanted to win, we wanted to qualify directly for the quarterfinals. But I really don't care this is the heaviest defeat ever." The Dutch appeared timid and toothless against a rampant England side. Sarina Wiegman's team dominated from the start against her native Netherlands and had two good chances in the opening 10 minutes with James and Russo both heading narrowly wide.

England took a deserved lead in stunning fashion.

Russo ran onto a long kick from goalkeeper Hannah Hampton and surged forward before cutting it back to James, who carved out some space on the edge of the area before lashing a fierce strike into the top right corner. It was only James' third appearance since injuring her hamstring in April and the 23year-old was again involved when England doubled its lead in the second minute of first-half stoppage time. (AP)

Human rights court rules Olympic champion Semenya did not get fair hearing in sex eligibility case

GENEVA, July 10: Two-time Olympic champion runner Caster Semenya won a partial victory at the European Court of Human Rights on Thursday in her sevenyear legal fight against track and field's sex eligibility rules.

The court's 17-judge highest chamber said in a 15-2 vote that Semenya had some of her rights to a fair hearing violated at Switzerland's Supreme Court, where she had appealed against a ruling by the Court of Arbitration for Sport in favor of track's World Athletics. Her case should now go back to the Swiss federal court in Lausanne — to be watched closely by other sports which have passed or are reviewing their own rules on eligibility in

women's events. The original case between Semenya and track's governing body based in Monaco was about whether athletes like her — who have specific medical conditions, a typical male chromosome pat-



tern and naturally high testosterone levels — should be allowed to compete freely in women's sports.

Europe's top human rights court in Strasbourg, France, dismissed other aspects of the appeal filed by Semenya, who was in court Thursday to hear the judgment read. It awarded her 80,000 euros (\$94,000) "in respect of costs and expenses."

cial review" that was required because Semenya had no choice but to pursue her case through the CAS's "mandatory and exclusive jurisdiction." the Strasbourg judges ruled.

Governing bodies of sports oblige athletes and national federations to take their disputes to the sports court in the International Olympic Committee's home city Lausanne. "The court considered, however, that the Federal Supreme Court's review had fallen short of that requirement," it said in a statement.

In dismissing other elements of the South African runner's case, the court judged she "did not fall within Switzerland's jurisdiction in respect of those complaints."

World Athletics, led by its pressince emerging on the global ident Sebastian Coe, has said its rules maintain fairness because Semenya has an unfair, male-like athletic advantage from her higher testosterone. Semenya argues her testosterone is a genetic

World Athletics and the IOC did not immediately respond to the ruling

Second legal lap at StrasbourgThursday's win followed a legal victory from the same court two years ago for Semenya.

That judgment which said she had faced discrimination opened a way for the Swiss supreme court to reconsider its decision to dismiss her appeal against the CAS verdict in favor of World Athletics.

At CAS in 2019, three judges ruled 2-1 that discrimination against Semenya was "necessary, reasonable and proportionate" to maintain fairness in women's track events.

World Athletics drew up its rules in 2018 forcing Semenya and other female athletes with Differences in Sex Development to suppress their testosterone to be eligible for international women's events. (AP)

Tendulkar was quoted as saying, "It's a huge honour. In 1983, when India won the World Cup, it was my first introduction to Lord's."

"I saw our captain, Kapil Dev, lift the trophy. That moment sparked my cricketing journey. Today, with my portrait going up inside the Pavilion, feels like it's come full circle. When I reflect on my career, it brings a smile to my face. This is truly special.

"Unlike the previous paintings, which were

full-length, the portrait of Tendulkar is a largerthan-life image of his head and shoulders," the release added.

"The Lord's Portrait Programme has been running in its current form for three decades, but MCC has been collecting art and artefacts since the Victorian period, opening a dedicated museum in the 1950s making it the oldest sporting museum in Europe.

"The Long Room Gallery is the oldest and most iconic gallery in sport. The Club currently houses around 3,000 pictures, nearly 300 of which are portraits.

Pearson Wright said: "It was clear that MCC

didn't want this portrait to be in the same format as the previous Indian cricket portraits I made, so a fresh approach was taken with this one.

"I decided on a composition which focused more on Sachin's head and also using a heroic larger-than-lifesize scale to give the painting a sense of gravitas and power.

"I have often painted a portrait with an abstract background, often a plain colour, rather than paint a rendition of an interior or exterior space. This is largely to give focus to the subject's features and to minimise a context which might define the subject in some way." (PTI)
