SHILLONG, July 19: Meghalaya Deputy Chief Minister Prestone Tynsong has said the state government will press for the retransfer of block I and II from Assam's Karbi Anglong district, asserting that the long-pending boundary issue remains a top priority.

Tynsong, who also chairs the regional committee on the matter, said the government is awaiting a response from his Assam counterpart to schedule a joint inspection of the disputed areas. Before the creation of Meghalaya, both these blocks were part of the United Khasi Jaintia Hills district of Assam. In the 1950s, the then governor transferred the blocks to Karbi Anglong for ease of administration.

"I am yet to get the date from my counterpart because in Ri Bhoi district, we have more than one chairman from the Assam side, whereas from our side, I am the only chair-

biggest dam over Brahmaputra in Tibet BEIJING, July 19: China on Saturday formally started the construction of a USD 167.8 billion dam over the Brahmaputra River in Tibet, close to the Indian border

in Arunachal Pradesh. Chinese Premier Li Qiang announced the start of the construction of the dam at a groundbreaking ceremony in the lower reaches of the Brahmaputra River, locally known as Yarlung Zangbo, at Nyingchi City, official media reported.

The groundbreaking ceremony took place at the dam site of Nyingchi's Mainling hydropower station in Tibet Autonomous Region, state-run Xinhua news agency reported.

The hydropower project, regarded as the biggest infrastructure project in the world, raised concerns in the lower riparian countries, India and Bangladesh.

The project will consist of five cascade hydropower stations, with a total investment estimated at around 1.2 trillion Yuan (about USD 167.8 billion), the report said.

According to a 2023 report, the hydropower station is expected to generate more than 300 billion kWh of electricity each year – enough to meet the annual needs of over 300 million people.

Representatives from various organisations, including the National Development and Reform Commission and the Power Construction Corporation of China and locals attended the ceremony, the report said. The project was approved in December last year.

According to earlier reports, the size of the project would dwarf any other single infrastructure project on the planet, including China's own Three Gorges dam, regarded

as the largest in the world. China has already operationalised the USD 1.5 billion Zam Hydropower Station, the largest in Tibet, in 2015, which raised concerns in India.

Concerns arose in India as the dam besides empowering China to control the water flow, the size and scale of it could also enable Beijing to release large amounts of water flooding border areas in times of hostilities. India too is building a dam over Brahmaputra

in Arunachal Pradesh. India and China established the Expert Level Mechanism (ELM) in 2006 to discuss various issues related to trans-border rivers under which China provides India with hydrological information on the Brahmaputra river and Sutlej river

during the flood seasons. Data sharing of trans-border

rivers figured in the talks between India, China Special Representatives (SRs) for border question, NSA Ajit Doval and Chinese Foreign Minister Wang Yi, held here

on December 18 last year. The Brahmaputra Dam presents enormous engineering challenges as the project site is located along a tectonic plate boundary where earthquakes occur.

The Tibetan plateau, regarded as the roof of the world, frequently experiences earthquakes as it is located over the tectonic plates.

But an official statement in December last year sought to allay concerns about earthquakes, saying that the hydropower project is safe and prioritises ecological protection.

Through extensive geological explorations and technical advancements, a solid foundation has been laid for the science-based, secure, and high-quality development of the project, it said

NEW DELHI, July 19: India and the US teams have concluded the fifth round of talks for the proposed bilateral trade agreement (BTA) in Washington on July 17, an official said. The negotiations were held for four days (July 14-17) in Washington.

'The Indian team is coming back," the official said. India's chief negotiator and special secretary in the Department of Commerce Rajesh Agrawal led the team for negotiations.

These deliberations are important as both sides are looking at finalising an interim trade deal before August 1, which marks the end of the suspension period of Trump tariffs imposed on dozens of countries, in-

ocal tarifis. The implementation of high tarifis was immediately suspended for 90 days till July 9 and later until August 1, as America is negotiating trade deals with various countries.

Issues related to agriculture and automobiles are learnt to have figured during the fifth round of negotiations. Matters related to ways to deal with non-market economies, and SCOMET (Special Chemicals, Organisms, Materials, Equipment, and Technologies) also came up for discussion.

On the possibility for an interim trade agreement before August 1, an official has recently stated, "We are not differentiating between an interim or the first phase of the bilateral trade agreement. We are negotiating a complete deal. Whatever will be finished (agreed upon), we can package it as an interim deal and for the rest, talks will continue' India has hardened its position on the US demand

for duty concessions on agri and dairy products. New Delhi has, so far, not given any duty concessions to any of its trading partners in a free trade agreement in the dairy sector. fairs Minister said he has not come across a single case where a member of the minority community is willing to migrate out of India because of being deprived of anything in the country.

He accused "the Left ecosystem backed by the Congress party" of running a relentless campaign that minorities are being "tortured, butchered, lynched and killed, and are not safe in India".

Rijiju said such narratives were not helping the country. Asked about his predecessor Mukhtar Abbas Naqvi's statement when he was the minister that India is heaven for minorities, Rijiju said India is a country where "people are law abiding, we are secular, we have a Constitution", and so, whether in majority or minority, everybody is the same. Whether one belongs to a minority or a majority community, everybody is equal before the law, he asserted.

"Now, having said that I can clearly make this statement that whatever the majority community gets, the minority communities also get that but there are certain things which minorities get but the majority community do not get," Rijiju told PTI on Friday at the news agency's headquarters here.

"If you see the history in brief, there were some

problems in Tibet due to the Chinese occupation and the Tibetans came to India. There were some democratic movements and problems in Myanmar and the democratic activists came to India. There were some problems in Sri Lanka, the Lankan Tamils came to India. There was persecution of minorities in Bangladesh, they all came to India. From Pakistan, Afghanistan (many came to India)," the senior BJP leader said.

"Ultimately, they all desire to take shelter in India because they have the confidence in the Constitution of India and the people of India. That is why they come here," he said. (CONTD. ON PAGE-2)

While one accident happened in Hojai district, the other was reported from Dhubri, they said. A speeding vehicle hit the railing

In the Golakgunj area of Dhubri, a car skidded off the road and hit trees. A woman and a 10-monthold child was killed on the spot.

Police and locals rescued three others, including a 1.5-month-old child, from the car and rushed them to a local hospital. The infant succumbed in the hospital, police said. The two others injured in the accident are undergoing treatment, they said. (PTI)

18 killed in UP, rain havoc in Rajasthan, alert in U'khand, Bengal, HP

NEW DELHI, July 19: Uttar Pradesh bore the brunt of monsoon fury as rain-related incidents claimed 18 lives, with the IMD on Saturday issuing alerts for heavy rain in Uttarakhand. Himachal Pradesh, West Bengal and Kerala. While torrential rain caused a flood-like situation in parts of Rajasthan; heavy rainfall and landslides in some areas of Arunachal Pradesh and Sikkim affected normal life and disrupted traffic movement

In Uttar Pradesh, 18 people died in a period of over 24 hours ending at 8 pm on July 18. Of the total. eight died of drowning following excessive rain, while two were a result of snakebites.

In Chitrakoot, two deaths due to drowning were reported on July 17 and 18, three in Moradabad on July 17, and one drowned in Ghazipur on July 18, according to an official statement.

Rain-related incidents after downpour claimed three lives in Banda and two each in Mahoba and Chitrakoot, and one in Lalitpur



on July 18, the statement said.

In Rajasthan, heavy rainfall over the past 24 hours has resulted in flood-like conditions in several cities, including Ajmer, Pushkar,

Bundi, Sawai Madhopur, and Pali. Many villages have been cut off as rivers, drains, and dams overflowed due to the intense rain. On Friday night, 17 people got stranded in the Banas River near Golera village in the Todaraisingh

area of Tonk, but they were later rescued by the SDRF.

In Ajmer's Dargah area, several people were swept away by the strong water flow, prompting locals to intervene and rescue them. Ajmer's Ana Sagar lake is overflowing as a result of the persistent

rain, with locals using sandbags to try to control the flow. The highest rainfall recorded was 234.0 mm in Nainwa of Bundi district, followed by 230 mm in Merta City of Nagaur, 190 mm in Mangliawas of Ajmer, 180 mm in Nasirabad of Ajmer, and 160 mm in Pratapgarh.

Heavy to very heavy rain is expected in the Jodhpur division on Saturday, with moderate to heavy rain anticipated in some areas of the Ajmer and Udaipur divisions. The likelihood of reduced heavy rain activity in the Bharatpur, Jaipur, Kota, and Bikaner divisions from Saturday is also strong, Jaipur MeT department director Radhey Shyam Sharma said.

A rapid decline in rain activities across the state is likely from Sunday onward, he said, adding that a new wave of heavy rain could potentially return to eastern Raiasthan around July 27-28.

In Uttarakhand, a 'red alert' for heavy rainfall on Sunday in parts of the Kumaon region has been issued by the meteorological department. Nainital, Champawat and Udham Singh Nagar in the Kumaon region are likely to be pounded (CONTD. ON PAGE-2)

Indian electronics exports hit USD 40 bn: Vaishnaw

HYDERABAD, July 19: India's electronics exports have soared past USD 40 billion, marking an eight-fold growth during the last 11 years, Union Minister Ashwini Vaishnaw said on Saturday.

He also highlighted that the domestic electronics production has gone up by six times.

Addressing the 14th Convocation of IIT Hyderabad, near here, Vaishnaw also emphasised the rapid progress of India's first bullet train project, which is expected to become operational by August or September 2027.

Looking ahead, Vaishnaw said the first Made in India semiconductor chip, on a commercial scale, will be manufactured this year. He expressed confidence that India is on track to become one of the top five semiconductor nations in the world in the coming years, citing its increasing focus on capital equipment and the materials required for semiconductors.

Trump's tariff threat pushes Lula's popularity, worsens legal troubles for Brazil's ex-leader

SAO PAULO, July 19: US President Donald Trump may have thought that pressuring Brazil with higher tariffs would help his ally, the country's former President Jair Bolsonaro, but the move apparently backfired.

Last week, Trump sent a letter to Brazilian President Luiz Inácio Lula da Silva threatening a 50 per cent import tax and directly linking the decision to Bolsonaro's trial, which he called a "witch hunt".

"This trial should end immediately!" Trump wrote Thursday evening in a second letter, this one addressed to Bolsonaro. He added that he had "strongly voiced" his disapproval through his tariff policy. Rather than backing down, Brazil's Supreme Court escalated the case, worsening Bolsonaro's legal troubles. On Friday morning, federal police raided Bolsonaro's home and political office. The former president was ordered to wear an ankle monitor, banned from using social media, and hit with other restrictions.

Meanwhile, President Lula — who was facing higher unpopularity, growing opposition in Congress and increasing risks to his likely reelection bid seems to have gained politically from the situation.

Now the 79-year-old leftist Lula, in office for the third non-consecutive term of his long political career, is seeing renewed acceptance, congressional support against Trump and pleas to run one last time to defend Brazil's sovereignty.

Back in the game

Lula has appeared more energized in public since Trump's announcement. At a national students assembly Thursday, he wore a blue cap reading "Sovereign Brazil Unites Us" — a contrast to MAGA's red cap.

"A gringo will not give orders to this president," he told the crowd, and called the tariff hike "unacceptable blackmail." The impact on Lula is not a first. Trump's actions targeting other countries have boosted ideological rivals in Canada and Australia instead of strengthening his allies at a local level.

Private pollster Atlas said Tuesday that Lula's unpopularity had reversed course after his spat with Trump. Lula's job approval went from at 47.3 per cent in June to 49.7 per cent since the tariffs battle began.

The poll of more than 2,800 people was conducted July 11-13, with a margin of error of 2 percentage The study also said 62.2 per cent of Brazilian

Trump's move as undue interference in Brazil's politics, though he said he agreed the trial against the farright leader is biased against him.

Social media analytics firm Palver analyzed 20,000 messages about Trump on WhatsApp, Brazil's most widely used communication platform, a day after Trump's announcement. Its analysis said right-wing users dominated viral content, but spontaneous conversations leaned left, mocking Bolsonaro as submissive and defending Brazil's sovereignty.

"Trump has put Lula back in the game," said Thomas Traumann, an independent political consultant and former spokesman for the Brazilian presidency who only weeks ago argued that Lula had lost his front-runner status in the presidential race as he struggled to deliver on his promises on the economy.

"Trump handed it to Lula on a silver platter," Traumann said. Business leaders who until recently sided with Bolsonaro are having to court Lula to negotiate with Trump. Agribusiness, Brazil's largest economic sector and a traditional right-wing stronghold, united to criticise the US president's move. Industry groups were quick to denounce the tariffs as politically motivated and lacking any commercial justification. National outrage

"In general, with the major exception of a more radical conservative wing, (Trump's move) generated national outrage for violating Brazil's sovereignty,' lawmaker Arnaldo Jardim, a member of the congressional agricultural caucus, told The Associated Press. Jardim, who pushed for the approval of a reciprocity bill that could be used by Lula if there's no agreement until the Aug. 1 deadline, hardly sides with the president. "Even among sectors that initially thought this could benefit Bolsonaro, many had to reconsider their positions," he said.

Top congressional leaders who recently helped nix a Lula decree to raise a transactions tax were moving toward a head-on collision with him. After Trump's announcement, they signed a joint statement agreeing with Lula's promise to use the reciprocity law against the US.

In another change, Brazil's Congress decided to start moving on Lula's plan to give an income tax break to millions of poorer Brazilians. in February 2024, and the design, drawing and report received final approval from the competent authority in March 2025. Geotechnical investigations for the substructure and superstructure have been completed. An EPC (Engineering, Procurement and Construction) tender has been floated for the construction of the bridge, including approach roads, rail viaducts, earthwork and ancillary works.

Construction will commence immediately after the tender is awarded. The project will cover a 7.062 km stretch from Agthori to Kamakhya and includes a 1.3 km steel composite girder bridge over the Brahmaputra. The double-deck structure will feature a double-line railway track on the lower deck and a three-lane roadway with footpaths on the upper deck.

The north-end approach of 2.694 km will connect to Agthori station, while the 3.07 km south-end approach will link to Kamakhya station.

Once operational, the bridge will boost line capacity and connectivity in the region, which is poised for industrial development. The project is also expected to generate significant employment opportunities for skilled and unskilled workers in the surrounding areas.

"When we rise to defend our land, culture, and identity, you choose to politicise it," he wrote in a direct mes-sage to Banerjee, alleging she had "compromised Bengal's future" for vote bank politics. Defending Assam's pluralistic ethos, Sarma stated that Assamese, Bengali, Bodo, and Hindi-speaking communities have long coexisted peacefully in the state.

However, he asserted that no civilization can sustain itself without protecting its borders and cultural foundations. "Assam will continue to fight to preserve its heritage and dignity with constitutional clarity," he said. The remarks came shortly after Mamata Banerjee launched her own attack on the BJP-led Assam government, accusing it of discrimination against Bengali-speaking citizens.

In a post earlier on Saturday, Banerjee said, "Bangla, the second most spoken language in India, is also the second most spoken in Assam. To threaten citizens for upholding their mother tongue is both discriminatory and unconstitutional." She condemned what she described as the BJP's "divisive agenda" in Assam, asserting that such politics had crossed all limits.

"I stand with every fearless citizen fighting for the dignity of their language, identity, and democratic rights," she added. The escalating exchange underscores deepening political tensions between the BJP in Assam and the Trinamool Congress in Bengal, with both states now at odds over sensitive issues ranging from linguistic rights and cultural identity to migration and national security.

The country is also seeking duty concessions for labour-intensive sectors, such as textiles, gems and jewellery, leather goods, garments, plastics, chemicals, shrimp, oil seeds, grapes, and bananas, in the proposed trade pact. The two countries are looking to conclude talks for the first tranche of the proposed bilateral trade agreement (BTA) by fall (September-October) this year. Before that, they are looking for an interim trade pact. India's merchandise exports to the US rose 22.8 per cent to USD 25.51 billion in the April-June quarter this fiscal year,

He said barring isolated incidents and the riots when the Congress was in power, generally, "minorities are safest in India". Despite that, for the last 11 years, there has been a constant campaign that the minorities are not safe in India, Rijiju said and wondered how that is helping India.

What is India as a country gaining from this, he asked.

"I belong to a minority community. I must openly make this admission that the majority Hindus which are around 78 to 79 per cent as per the old old census. If you see the new census later on when it comes out, this percentage may be reduced but I don't know right now. But because of the Hindu majority, all the minorities are enjoying the absolute freedom and protection in this country," Rijiju said.

"Imagine if I was in Pakistan. Imagine if we were made part of Bangladesh during the partition. We would have been refugees today. Today, every tribal community, every minority community is safe and secure in his or her own homeland because the majority Hindu community is secular by character and tolerant by nature." the minister asserted. That is why India is a preferred place for every minority community, he said and added that this must be appreciated. "If you don't appreciate the reality, then you are doing the greatest disservice to the country," he said.

On whether the Muslims also feel as safe in India, Rijiju said, "I saw some of the Hindus are saying that they feel threatened by some Muslim majority pockets within the country. Maybe there are some individual incidents, maybe some Hindus are saying that there is a Muslim majority (in the area) so we feel threatened. But I feel that nobody should feel threatened and if anybody is threatening the other community then the state government must take action." He asserted that everybody is equal and everybody is safe in India.

Anybody who is saying that they are unsafe in India are doing the greatest disservice to India as a nation, the minister said. He pointed out that under the ministry of minority affairs, all the schemes of the government of India are applicable in every part of the country for everyone. "The ministry of minority affairs implements policies and skills only for minority communities. The minority communities are not deprived of any possibility of getting the benefits from anywhere. It's the same for everyone," he said. The minority affairs ministry provides enough support system as gap funding to all the six notified minority communities in India, he said.

Earlier this month, Rijiju was involved in a war of words with AIMIM president Asaduddin Owaisi, who had slammed the BJP leader over his statement that India is the only country where the minorities get more benefits and protection than the majority community. The Hyderabad MP, in a post on X, had said, "You are a Minister of the Indian Republic, not a monarch. @KirenRijiju You hold a constitutional post, not a throne. Mi-nority rights are fundamental rights, not charity." "India's minorities are not even second-class citizens anymore.

18 killed in UP, rain havoc

by heavy rainfall on Sunday. The department has also issued an 'orange alert' for heavy to very heavy rainfall at a few places in Dehradun, Tehri and Pauri districts in the Garhwal region as well as Bageshwar and Pithoragarh districts of Kumaon. In view of the rain alerts, the district administrations have been asked to take precautions, including controlling the movement of people. Disaster-related equipment and wireless sets should be kept ready at every police station and outposts, said a letter issued by Deputy Secretary, State Emergency Operation Centre, Shivshankar Mishra, to the district magistrates. Tourists in the upper reaches of the Himalayas should not be allowed to travel amid unusual weather or heavy rain, the letter said.

In Himachal Pradesh, the India Meteorological Department (IMD) has issued an 'orange alert' for downpour on Monday and Tuesday in nine districts in Una, Bilaspur, Hamirpur, Kangra, Kullu, Mandi, Shimla, Solan and Sirmaur. Hamirpur received 13.5 mm of rain since Friday night, followed by Karsog 8.1 mm, Kasauli 5 mm, Jubbarhatti 4.8 mm, Kothi 4 mm, Slapper 3.9 mm and Shimla 3.6 mm, Ghaghas 3.4 and Kufri 3 mm.

A total of 141 roads are still closed in the state, while 58 water supply schemes and 28 power distribution transformers were affected as of Saturday evening, according to the State Emergency Operation Centre (SEOC). In the disaster-hit Mandi district, 94 roads were closed and 33 in Kullu district.

In Kerala, the IMD has issued a 'red alert' for downpour five northern districts -- Malappuram, Kozhikode, Wayanad, Kannur, and Kasaragod -- where incessant rains lashed several towns and high-range areas, causing inundation and traffic snarls. Districts including Ernakulam, Idukki, Thrissur, and Palakkad were placed under an 'orange alert' for heavy rainfall. In light of the rain alerts, the Kerala State Disaster Management Authority (KSDMA) has also issued guidelines on precautions to be taken during emergencies. Both Wayanad and Kozhikode experienced intense rainfall throughout Friday night, although there was a slight respite on Saturday morning. District authorities in Kozhikode are closely monitoring the situation and are prepared to evacuate people living in high-altitude areas and those near water bodies to safer locations if necessary. In Arunachal Pradesh, surface communication at various places in Lower Siang district has been snapped due to continuous rains over the past couple of days.

Incessant rains have snapped the Aalo-Likabali road in several locations since Saturday morning, Likabali Additional Deputy Commissioner Mokar Riba said. The road, a lifeline for several districts including West Siang, Leparada, Shi-Yomi, and Upper Subansiri, has been blocked by landslide debris in Siji, Yate and near Garu village, he said, adding that the National Highways and Infrastructure Development Corporation Ltd (NHIDCL) has been directed to clear the road. "Though the NHIDCL has engaged men and machinery, they are facing problems in clearing the road due to continuous downpour," Riba said.

Vehicular movement on a stretch of National Highway-10 connecting Sevoke in West Bengal and Sikkim's Rangpo has been temporarily halted due to landslides and rockfall, officials said on Saturday.

Clearance activities are underway on the stretch following landslides at Birik Dara in Kalimpong district of West Bengal, they said, adding that it is expected to reopen within 24 hours. Meanwhile, in Delhi, the IMD has forecast thunderstorms with showers during the day. The city recorded a minimum temperature of 25.2 degrees

ICICI Bank Q1 net profit jumps 15.9 pc; sees margin contraction ahead clear that it is comfortable with the quality of

MUMBAI, July 19: ICICI Bank on Saturday posted a 15.9 per cent jump in its consolidated net profit for the June quarter to ₹ 13,558 crore compared to ₹ 11,696 crore in the year-ago period.

On a standalone basis, the country's secondlargest private sector lender reported a net profit of ₹ 12,768 crore for the quarter, up 15.5 per cent from ₹ 11,059 crore a year ago.

Its core net interest income increased 10.6 per cent to ₹ 21,635 crore on the back of a 12 per cent domestic loan growth, but was restricted by a narrowing of the net interest margin to 4.34 per cent from 4.41 per cent in the quarter-ago period.

The bank's executive director Sandeep Batra pointed to some more pain in the offing on the NIMs front, especially with the RBI's rate cut cycle still on.

"We do expect the NIMs to sort of compress a little more in the next quarter," he told reporters, adding that the future trajectory will be decided by the RBI's actions and the overall liquidity in the system.

The other income, excluding treasury operations, recorded a 13.7 per cent jump to ₹7,264 crore. From an asset growth perspective, the bank slowed down growth in the riskier credit



card and personal loans segment to over 1 per cent each after multiple quarters of maintaining it at over 20 per cent.

Batra said there is no specific reason for the slowdown, but pointed out that the number is influenced by the demand factor as well.

When asked about the slower growth in retail assets, he said the bank does recalibrations to its credit norms and added that there is an overall slowdown in the market as well.

The corporate loans grew more slowly than expected because of competitive pricing options available to borrowers.

From an asset quality perspective, the fresh slippages came at a slightly higher level of ₹ 6,245 crore, but the bank management made it

The overall provisions, excluding the ones for taxes, stood at ₹ 1,815 crore compared to ₹ 1,332 crore in the year-ago period, the bank said. The gross non-performing assets ratio improved to 1.67 per cent as of June 30 from 2.15

per cent in the year-ago period. Batra said the bank expects the economy to fare better in the second half of the fiscal year, and the banking system will be a beneficiary of this as credit demand increases.

The overall deposit growth came at 12.8 per cent for the reporting quarter, the bank said, adding that it added 83 branches to take its overall network to 7,066 branches as of June 30.

ICICI Bank's overall capital adequacy stood at 16.97 per cent, with the core buffer level at over 16 per cent. Batra said the bank does not foresee any immediate need for a capital raising exercise.

Among its subsidiaries, the life insurance arm delivered a PAT increase to ₹ 302 crore in Q1 against ₹ 225 crore in the year-ago period, the general insurance arm's PAT jumped by nearly 29 per cent to ₹747 crore, while ICICI Securities' net profit declined to ₹ 391 crore from ₹ 527 crore. (PTI)

lllegal teak wood worth of 10 lakh seized in Srirampur, 2 Arrested

KOKRAJHAR, July 19: In a significant move to secure land rights and

HT Correspondent GOSSAIGAON, July 19: In a significant crackdown on timber smuggling, a team of police personnel from Srirampur police outpost under the Gossaigaon subdivision seized a large consignment of illegal teak wood during a special operation based on a tip-off.

The seized timber, estimated to be valued at over 10 lakh, was being transported secretly in a six-wheeler truck. The truck, bearing registration number KA-50-A-3595, was heading towards West Bengal from Silchar. The illegal teak logs were cleverly hidden beneath household items to avoid detection.

Acting on specific intelligence, Srirampur police intercepted the vehicle along National Highway 27 and conducted a thorough search, uncovering the hidden timber consignment. During the operation, police arrested the truck driver and his assistant. The arrested individuals have been identified as Krishna Babu and Raju Bhai. According to officials, the timber consignment was being transported without any valid permits or documentation.

Police have launched a detailed investigation and are actively working to trace the broader network involved in the illegal timber trade. Further arrests are expected as the probe continues.

Teacher-Student Relationship

Transfer policy stuck in files: Teachers are waiting with bated breath

'The characters change, the story remains the same: The Transfer Saga'

Reachers in Haryana are once again caught in confusion, rumours and incomplete information. Every morning in schools begins with tea and a discussion in the staffroom - "When will the transfers take place?" No one has an answer to this question, but everyone has a guess. Some say in August, some say after the cabinet, some believe v that the se ion is in the middle the ment will not do anything. Everything seems to be stagnant, blurred and hanging in the balance. The results of the examination conducted for teacher deployment in Model Sanskriti Vidvalavas and schools selected under the Pradhan Mantri Shri Yojana are ready. But the announcement is not being made because the Common Transfer Policy 2025 has not yet received cabinet approval. Here the question becomes imperative that before conducting the examination, was it not ensured that the policy has been made or what will be the time limit for its approval? If the result of the examination depends on the policy, then why was it taken earlier? Is this an administrative lapse or political delay? Another argument being given for not declaring the results is that they are kept in sealed envelopes which no one has seen, so that no interference is possible. This tradition of "sealed honesty" on one hand shows that the department is pretending to be transparent and on the other hand it also makes it clear that the department itself is afraid of some possible 'game' with the results. What makes this situation even more ridiculous is the department's double standards - when it creates a structure like SMC (School Management Committee) and then dissolves it within a month. This is the same department that has been talking about transfers since December and did not take any concrete steps until July. Every week a new order comes and the next week some other officer cancels it. This makes it clear that there is a complete lack of coordination in the department. Everyone is ready to take a "decision" at their own level, but there is no one to give direction to the education system. The teachers have become mentally exhausted due to this confusion and opaqueness. In every school, the discussion revolves around this one issue - someone is getting the transfer file prepared, someone is getting the CCL form filled, someone is waiting for the result, and someone is trying to gather information from his contacts. There is a kind of mental tension and instability which is affecting the work of the teachers. In such a situation, it is worth thinking that the system on which the future generation is dependent has itself become unstable and confusing. The reason behind this is not only the indecisiveness of the administration but also the neglect of political priorities. Governments are busy with elections, announcements and showy schemes but there is no clarity on basic needs like the teacher transfer policy. When teachers are mentally unstable, how will the education of children remain stable? In many districts of Haryana, the same teacher is teaching in two schools, some schools do not have subject experts, and on the other hand, those who should be transferred are stuck at the same place for vears. There was talk of an online transfer system based on MIS (Management Information System). But due to the lack of a policy, this system is also not able to be updated. Claims were made to make the processes transparent in the name of technology, but



until the policy is made, everything is just a click away. This is a digital dream that has not yet come true.

Teachers were promoted, many positions became vacant. Now the question is whether transfers will happen after promotion? If yes, then how many more promotions are pending? There is no answer to these questions on the departmental website, there are only rumours in the WhatsApp groups of teachers' organizations. Not only this, according to an official of the department itself, the cabinet meeting is proposed in August. This means that the policy will come by the last week of August, by then the middle of the session will come. And then the same argument will be given that transfers should be postponed till the next session so that the studies of the children are not interrupted.

This cycle is repeated every year. The policy is not made, then it is said that the session is in between. Teachers are not able to plan themselves. Neither can they take CCL, nor can they prepare mentally whether they will get a transfer or not. The department is in a serious crisis – where files are moving but no decision is being taken.

Students suffer the most due to this confusion. When a teacher is waiting for a transfer for two years, his attention naturally shifts from teaching. There are many teachers who are working hundreds of kilometres away from home and are mentally disturbed due to family responsibilities. Will they be able to educate children with this mindset?

It is also true that politics has been going on in the name of transfers in Haryana for years. Sometimes there is nepotism in the transfer list, sometimes transfers are stopped before panchayat elections, sometimes names are added or removed at the behest of some leader. Transparency is talked about only in policy papers, there is no sign of it on the ground.

If the government and the department really want to take education reform seriously, they will have to take concrete steps to improve this situation. Firstly - a clear timeline should be given as to when the transfer policy will come. Second - confusion should not be spread about exam results until the policy comes. Third - departmental coordination should be increased so that after an order is issued. no other officer can cancel it. And most important every process should be made trackable online.

Transfer is not a favour, it is the teacher's right. Presenting it as a "favour" is a derogatory attitude. Teachers are neither political workers nor part of any group. They are the foundation stones on which the future of society stands. And if the foundation itself is kept in uncertainty, how can the peak be strong?

This article is a request to the education department and the government to come out of this confusion, indecisiveness and administrative cowardice. Instead of keeping the transfer policy confined to files and lockers, it should be implemented on the ground. Because the teacher is tired now. And when the teacher is tired, the whole society becomes lethargic.

The Historic Nagshankar Temple and Conservation of Rare Turtles

The Shri Shri Nagshankar Temple, located in Biswanath district, is an ancient Shiva pilgrimage site that has held a special place in the hearts of devotees and tourists for centuries. This temple is not only a sacred spiritual center but also gains a unique identity due to the presence of rare species of turtles residing in the large pond within its premises. Through the conservation of these turtles, the Nagshankar Temple has already played a pioneering role in both religious significance and biodiversity preservation. The temple is situated approximately 30 kilometers from Tezpur, the headquarters of Sonitpur district. Positioned almost midway between Tezpur and Biswanath Chariali, in the heart of the erstwhile undivided Sonitpur district, between Jamugurihat and Chatiya, the temple is located just one kilometer south of National Highway 15. The connectivity to this temple is highly convenient. Due to its accessible location, devotees and tourists visit the site every day of the year. The entire region has come to be known as Nagshankar, named after the temple.

The large pond within the temple premises adds a new dimension to the scenic beauty of this place. The tranquil waters of the pond and the surrounding lush greenery evoke a sense of peace in the minds of visitors. The long-lived, large turtles residing in this pond are an integral part of the temple's religious and touristic significance. According to local beliefs, these turtles are considered companions of Lord Shiva, referred to as 'Mohan.' It is believed that after the puja, these 'Mohan-like' turtles accept the offerings from devotees, signaling the success or failure of the worship. The rare species of "Bormuria turtles" in this pond attract numerous domestic and international tourists and researchers annually. Every day, the temple's prasad and offerings are dedicated to these turtles, a practice rooted in ancient tradition. Visitors also participate in this tradition by offering prasad to the turtles, reflecting a unique cultural aspect tied to the temple's religious identity. When called by the name 'Mohan,' the turtles come to the pond's edge, appearing before visitors and accepting prasad or food from their hands. The temple's spiritual significance, the pond's beauty, and the presence of the turtles have made Nagshankar Temple a distinguished tourist destination. The influx of tourists and researchers from across the country and abroad has increased its global recognition. The temple management committee, along with local MLA Padma Hazarika, has taken various steps to enhance the beauty of this place. These efforts have strengthened both the temple's spiritual importance and its tourism potential. The mythological stories associated with the origin of the Nagshankar Temple lend



it profound religious significance. According to legend, when Sati immolated herself in Daksha's yajna after Shiva's insult, a grief-stricken Shiva began the Tandava dance, carrying her body on his shoulder, threatening the destruction of the world. To prevent this catastrophe, Lord Vishnu used his Sudarshan Chakra to dismember Sati's body, and its parts fell at various places across India. It is believed that Sati's navel fell at this site, leading to the establishment of a Shiva Linga and the construction of the temple. This legend has established Nagshankar Temple as a significant Shakti Peeth. Another tale suggests that Bana Raja, a devoted follower of Lord Shiva, learned of the plan to establish a 'second Kashi' in Biswanath. Overjoyed, Lord Shiva came to visit 'Kashi.' However, due to Narada Muni hiding one of the required one crore Shiva Lingas, the establishment of Kashi in Biswanath could not be completed, and the region is still known as 'Gupta Kashi' (Hidden Kashi). In his sorrow, Lord Shiva lay down, with his head in Biswanath, navel in Nagshankar, and feet in Rudrapada. As Lord Shiva's navel touched this land, the place was named 'Navishankar' in the Yogini Tantra. The Gopini Kirtan mentions, "With his head in Biswanath, navel in Nagshankar, and feet in Rudrapada, he rests." Over time, Navishankar became Nagshankar. Later, the sage Dhaumya Muni worshipped Shiva at this site, marked by the navel, and it became known as Dhaumya's Ashram. However, when Dhaumya Muni had to leave as the royal priest of the Pandavas, the site turned into a forest. These legends and folklore have added a profound dimension to the temple's religious importance. Devotees firmly believe that worshipping at this temple fulfills their desires, enhancing its spiritual allure and securing a special place in their hearts. The depth and significance of these mythological stories have given Nagshankar Temple a unique position among Assam's Shaiva Peeths.

It is also popularly believed that the Nagshankar Temple was built in the 4th century by a king named Nagshankar or Nagaksha from the Lohitya dynasty. Nagshankar ruled eastern Kamrup (ancient Assam) in 378 CE. He was a great king and sent emissaries to the contemporary Maurya emperor, Ashoka. King Nagshankar or Nagaksha ensured regular worship at the temple, and its name became associated with him. After his death, the temple's religious activities ceased for some time. Another belief attributes the temple's construction to King Arimatta. Later, during the reign of Ahom king Swargadeo Shivsagar Singha, Shalal Bargohain, appointed as the governor of the region from Biswanath to the Bharali River, learned of the dilapidated state of this Shaiva Peeth and informed Shivsagar Singha. In 1480 CE, Shivsagar Singha rebuilt the temple, appointed Ramananda Barua as the chief priest, and assigned 12 families as 'Paiks' to manage the worship. Since then, the worship of Lord Shiva has continued uninterrupted. Shivsagar Singha donated 833 bighas of land as 'Devottar' (temple land), a significant contribution at the time, strengthening the temple's economic foundation and reviving its religious activities. The sanctum sanctorum houses a Shiva Linga, a Vishnu idol, a Yoni Kunda, and a Shaligram idol. The presence of these idols reflects the temple's religious diversity, making it a confluence of Shaiva and Vaishnava traditions. This historical background has given Nagshankar Temple a prominent place among Assam's ancient Shaiva Peeths, further clarifying its religious and cultural significance. This historical context provides a profound foundation for the temple's religious importance, establishing it as an integral part of Assam's heritage.

Every year, grand fairs are held at Nagshankar Temple during Shivaratri and Bohag Bihu, vibrant expressions of local culture and tradition. These festivals attract large gatherings of devotees, creating a festive atmosphere. Devotees strongly believe that worshipping at Nagshankar Temple grants their wishes, further enhancing its religious significance. The temple management committee has taken various steps to develop the site as a tourism hub, increasing its environmental beauty and appeal.

As mentioned earlier, one of the unique features of Nagshankar Temple is the rare species of turtles residing in its pond. The temple management committee has taken special measures for their conservation, enabling around 300 turtles to thrive in the pond. The Nagshankar Turtle Conservation Project currently nurtures 13 turtle species, including the Black Softshell (Nilssonia nigricans), Indian Softshell (Nilssonia gangetica), Peacock Softshell (Nilssonia hurum), Narrow-headed Softshell (Chitra indica), Indian Flapshell (Lisemmysys punctata), Spotted Pond (Geoclemys hamiltonii), Assam Roofed (Pangshura sylhetensis), Indian Tent (Pangshura tentoria), Indian Roofed (Pangshura tecta), Brown Roof (Pangshura smithii), Assam Leaf (Cyclemys gemeli), Tricarinate Hill (Melanochelys tricarinata), and Indian Black (Melanochelys trijuga). Of these, the Black Softshell and Common Softshell are critically endangered, six species are endangered, two are vulnerable, and the rest are listed as threatened or least concern by the IUCN. The temple management committee, in collaboration with organizations like the Northeast TSA Foundation India, has been working on artificial breeding to increase the turtle population, providing a strong foundation for their long-term survival. The committee has also raised awareness about the turtles' diet. Previously, visitors offered biscuits and puffed rice, which were unsuitable for the turtles' health. Now, scientifically appropriate food, such as dried fish, is provided. These measures demonstrate the temple's commitment to the turtles' health. This initiative has established Nagshankar Temple as both a religious site and a model for environmental conservation. Assam's Chief Minister, Dr. Himanta Biswa Sarma, recently praised these efforts, noting that Nagshankar Temple is an exemplary symbol of biodiversity conservation within a religious site. This recognition has further highlighted the temple's environmental importance on a global stage, establishing its conservation efforts at an international level.

In conclusion, the beauty and significance of Nagshankar Temple are not limited to its religious and historical background. Through the conservation of the turtles in its pond, the temple has already gained recognition both nationally and globally. The synergy of religious faith and turtle conservation has made Nagshankar Temple a model center for preserving rare biodiversity. If the temple's heritage and environmental conservation efforts continue in the future, it will remain a shining symbol of Assam's heritage and pride.

KOLKATA, July 19: At least five people have been arrested from New Town near Kolkata in connection with the murder of gangster Chandan Mishra in a Patna hospital, police said on Saturday.

However, the prime suspects, who were allegedly hiding in the city managed to flee, prompting police to launch a renewed search operation, a senior officer claimed.

The five arrested, who were apprehended from a housing complex in the satellite township of the metropolis following raids conducted jointly by the Bihar Police and the West Bengal Special Task Force (STF) in the early hours of Saturday, were "providing logistics" to the five main accused who killed Mishra, an officer said.

According to CCTV camera footage, the prime suspects escaped the city in a white vehicle, which was spotted passing through Basanti Highway near here, the of-

NEW DELHI, July 19: After US President Donald Trump's remark that "five jets were shot down' during the conflict between India and Pakistan, Congress leader Rahul Gandhi on Saturday asked Prime Minister Narendra Modi to clarify and asserted that the country has the right to know the truth.

Questioning the prime minister's "silence", the Congress also demanded that PM Modi give a "clear and categorical" statement in Parliament on the US leader's claims on the India-Pakistan conflict over the last 70 days.

The opposition party's assertion came after Trump said "five jets were shot down" during the conflict between India and Pakistan in May, while repeating his assertion that the fighting ended following his intervention.

The US president did not specify whether the jets were lost by either of the two countries or if he was referring to combined losses.

In a post in Hindi on X, Gandhi said, "Modiji, what is the truth about the five jets? The country has a right to know!'

Congress general secretary incharge (Communications) Jairam Ramesh said just two days before the Monsoon Session of Parliament begins, "the Trump missile gets fired" for the 24th time with the same two messages.

He pointed out that Trump has again stated that the US stopped the war between India and Pakistan, two countries that have nuclear weapons. The US President also reiterated his remarks that there would be no trade deal if the war continued, he said.

Trump said that if India and Pakistan want a trade agreement with the US, they have to agree to an immediate ceasefire, Ramesh pointed out.

"The sensational new revelation by President Trump this time around is that five jets may have

been downed," Ramesh said. 'The prime minister, who has had years of friendship and huglomacy with President Trump going back to 'Howdy Modi' in September 2019 and 'Namaste Trump' in February 2020, has to now himself make a clear and categorical statement in Parliament on what Presi-

In a nearly 35-minute phone call with Trump last month, Modi firmly said that India does not and will "never accept" mediation and that the discussions between Indian and Pakistani militaries on cessation of military actions were initiated at Islamabad's request.

India launched Operation Sindoor on May 7, targeting terror infrastructure in Pakistan and Pakistan-occupied Kashmir in retaliation against the Pahalgam attack that killed 26 civilians

HT Correspondent KOLORIANG, July 19: Deputy Commissioner of Kurung Kumey, Cheechung Chukhu, recently urged all departmental heads, officers, and field-level officials to remain proactive and responsive during the monsoon season in order to effectively assist people affected by natural disasters.

He was addressing the second district-level review meeting on disaster preparedness, held under the aegis of the District Disaster Management Authority (DDMA) at Koloriang.

According to an official statement, the meeting also marked the formal release of the District Disaster Management Plan (DDMP) for the 2025-26 session.

Chairing the session in his capacity as Chairman of DDMA, the Deputy Commissioner called for enhanced coordination among departments and directed that timely and effective support be extended to those in distress during monsoon-related emergencies.

Speaking on the occasion, incharge District Disaster Management Officer (DDMO) K Kholie highlighted the aims and objectives of the review session.

He elaborated on the importance of the DDMP document, stating that it would serve as a crucial tool to guide preparedness and ensure a structured response to any disaster events in the dis-



He added that the plan would significantly improve resilience and public safety through systematic, proactive planning. During his address, DC Chukhu reminded all departments of their responsibility to not only respond to disasters but also raise

awareness among citizens about disaster preparedness. He said loss of lives and damage to property could be minimised if people are well-informed and authorities act in a coordinated manner He further directed the formation of ADC-level Disaster Management Committees and Circle-level Disaster Management Committees to ensure hyper-local planning and pre-

paredness. These committees have been tasked with conducting monsoon preparedness meetings, preparing reports on losses and damages, and forwarding them to the District Executive Committee for the final disbursement of relief compensation.

The Deputy Commissioner also asked all administrative officers to identify vulnerable areas prone to landslides and ensure that essential commodities such as food, medicines, first aid kits, and fuel are stocked in adequate quantities well in advance.

He underscored the importance of early planning to avoid crises arising from road blockages or isolation of remote pockets during heavy rainfall.

In its public advisory, the DDMA has asked residents to avoid landslide-prone areas during the rainy season and remain in close touch with authorities in the event of any disaster.

The meeting concluded with a renewed call for institutional preparedness, inter-departmental coordination, and public cooperation to ensure that the district remains resilient and responsive during the monsoon season.

Landslides disrupt road network in Arunachal's Lower Siang district

ITANAGAR, July 19: Surface communication at various places in Arunachal Pradesh's Lower Siang district has been snapped due to continuous rains over the past couple of days, officials said.

Incessant rains have snapped the Aalo-Likabali road in several locations since Saturday morning, Likabali additional deputy commissioner Mokar Riba said.

The road, a lifeline for several districts including West Siang, Leparada, Shi-Yomi, and Upper Subansiri, has been blocked by landslide debris in Siji, Yate and near Garu village, he said.

The official said he has directed the National Highways and Infrastructure Development Corporation Ltd (NHIDCL) to clear the road.

"Though the NHIDCL has engaged men and machinery, but they are facing problems in clearing the road due to continuous downpour," Riba said.

The official has appealed to the public to avoid travelling during night hours in view of landslides.

Several parts of the state have been severely affected by the monsoon rains



since May. At least 14 people have lost their lives due to landslides and floods triggered by rains this year, besides affecting 36,751 people across 26 districts.

Meanwhile, state Health and Family Welfare Minister Biyuram Wahge on Saturday visited the flood-hit areas at Seijosa in Pakke Kessang district, to assess the damage caused by the recent rains.

"Accompanied by deputy commissioner, department heads, and panchayat

members, we reviewed the situation on the ground, including blocked roads, damaged bridges, disrupted water supply, and affected households," Wahge, who represents the district, said in a social media

"Directed the district administration and departments concerned to take swift action to restore connectivity, repair water reservoirs, and ensure timely relief reaches all those in need," he added. (PTI)

GILL'S REAL TEST STARTS NOW WITH INDIA TRAILING 1-2, SAYS CHAPPELL

NEW DELHL, July 19: Former Australia captain Greg Chappell believes Shubman Gill has displayed greatness with the bat and shown glimpses of his potential as a young captain, but said his real test begins now with India trailing 1-2 in the five-match Test series against England.

India lost the third Test against England at Lord's by 22 runs to go 1-2 down in the series.

The two teams will face off in the fourth Test of the Anderson-Tendulkar Trophy at Manchester starting July 23.

"As India prepare for the final two Tests of their series in England, the spotlight now shines firmly on their 25-year-old captain Shubman Gill. A bright young talent, he has shown greatness with the bat and glimpses of leadership potential, but this moment will define his trajectory as a Test captain.

"It's not an easy environment in which to grow, but it's the one he's in - and the stakes couldn't be higher," Chappell wrote in his column in ESPNcricinfo.com.

Chappell wants Gill to set the tone for the side with his actions.

"Gill must define what sort of team he wants India to be. The captain sets the tone - not just with words, but with actions, clarity of purpose, and visible standards.

That means demanding discipline in the field. India cannot af-



ford to slip back into being a poor fielding side. The best teams are superb in the field. They don't give easy runs. They don't drop chances," he wrote.

Chappell wants Gill to be firm in picking the side he feels can win a match for him.

"The selectors and Gill must pick and stick. He must identify the core group of players he trusts, lay out a clear game plan, and commu-

nicate individual roles within it. Every player should know what is expected of them and where they fit in. "Too often, in teams that struggle, players are left to work it out for themselves. That can't be left to chance at this level," the

Australian great wrote. Chappell said a captain should be a good communicator and its high time Gill should adopt that

communicators. Gill must become one - and quickly. Whether it's at training, in the middle or in the dressing room during a break clear, calm communication is essential

"His bat can't always do the talking. He must learn to speak in a way that aligns the group, encourages belief, and creates trust," he said. "He also needs to enunciate quality. "Great captains are great the right approach. Batters must be

told to play positively and bat in partnerships. If a batter gets a start, it is critical to go on and get a big score. Collapses come when players who are set decide that they don't want to keep working that hard.'

Chappell said creating pressure through consistent bowling is as important as taking wickets.

"Bowlers must know that it's not just about taking wickets but about building pressure: bowling good balls, good overs, and good spells. Pressure creates mistakes. It's not magic, it's method," he wrote.

Čhappell said it is time for Gill to stamp his authority as a leader and not just as a batter, as India look to bounce back in the series with two matches remaining.

"If Gill wants to become a great Test captain, this is his moment to stamp his authority. Not just with the bat, but with his leadership. Set the standard. Demand it of others. Pick your team. Back them. And make sure every man knows what is expected and hold them to it," he wrote. "Because in the end, cricket isn't about heroes. It's about partnerships. It's about teams. And it's about captains who bring the best out of those around them.

"If Gill can lead with clarity of thought and strength of purpose, he won't just shape this series, he'll shape the future of Indian cricket," Chappell added. (PTI)

The list, released by the Cricket Association of Bengal, also includes pacer Akash Deep and topbatter Abhimanyu order Easwaran, who are both currently touring England with the Indian team.

But Shami was below par in the IPL where he turned out for his new franchise Sunrisers Hyderabad and managed just six wickets in nine innings at an economy rate of 11.23.

He had earlier returned to international cricket in the T20I series at home against England in January this year, having last played in the ODI World Cup final in November 2023.

Shami had made domestic comeback with Bengal in the last season where he played across all formats, but was not picked for the tour of Australia. Bengal's probables

Current IOA President P T Usha has even gone to the extent of suggesting that India would run the risk of being suspended by the International Olympic Committee for government interference.

However, Mandaviya has asserted that the IOC has been consulted while drafting the proposed legislation. Having the IOC on board is crucial as India is bidding to become an Olympic host in 2036.

Rijiju, who batted for autonomy of sports administrators but with greater accountability during his tenure in the sports ministry, said he is confident of its smooth passage in the Parliament.

"There are two (other) things -the Khelo Bharat Niti and the antidoping amendment bill. These two bills (anti-doping and sports governance) are to be combined and we will discuss in the Parliament and I am sure the members will take part," he said.

"Once the new sports bill is passed, it will usher in a new sporting culture in the country. Khelo India has already promoted sports culture in the country," he added.

The anti-doping act was originally passed in 2022 but its implementation had to be put on hold due to objections raised by the World Anti-Doping Agency (WADA).

The world body objected to the institution of a National Board for Anti-Doping in Sports, which was empowered to make recommendations to the government on anti-doping regulations.

The Board, which was to comprise a Chairperson and two members appointed by the central government, was also authorised to oversee the National Anti-Doping Agency (NADA) and even issue directions to it.

WADA rejected this provision as government interference in an autonomous body. The amended bill has therefore deleted this provision to be WADA-compliant. (PTI)

Will IPL money via The Hundred route rescue financially struggling county cricket clubs?

MANCHESTER, July 19: Will the in- first-class counties to look to the future from The Hundred money, then I think vestment by IPL owners in The Hundred competition ease the financial struggles of the majority of 18 county clubs in England? It is a "make or break" question facing the struggling clubs in the county circuit right now.

According to the recently-released Leonard Curtis Cricket Finance Report, the gap between the top clubs and the smaller ones is widening with the big three -- Surrey, Lancashire and Warwickshire -- generating 44 per cent of the total revenue of all 18 first-class counties in 2023. The smaller clubs like Northamptonshire, Leicestershire and Derbyshire are hugely reliant on the funding from the parent body -- the England and Wales Cricket Board (ECB).

The sale of equity in the eight franchises of The Hundred is expected to raise approximately 520 million pounds, a part of which would be shared with the county clubs. The ECB decided to sell stakes of the eight franchises ahead of The Hundred's fifth season that begins on August 5, day after the conclusion of the Test series between India and England.

Four out of the eight teams have attracted investments from IPL franchise owners connected to Mumbai Indians (49 per cent of Oval Invincibles), Sunrisers Hyderabad (100 per cent of Northern Supercharges), Delhi Capitals (49 per cent of Southern Brave) and Lucknow Super Giants (70 per cent of Manchester Originals). The other four teams -- Welsh Fire, Birmingham Phoenix, London Spirit, Trent Rockets -- have drawn huge sums from American investors.

The eight counties hosting The Hundred teams, including the hosts of Test matches in the summer, are sitting pretty but the majority of the remaining 12 face an existential threat.

"The Hundred money allows the 18

rather than simply survive from one summer to the next," said former England captain Michael Vaughan in the report.

"I would like to see counties being transparent with each other and sharing knowledge about what works for them. Sometimes petty rivalries prevent that from happening and divisions between the Test host counties and the others develop." In a separate interaction with PTI, Vaughan said the fresh investments into The Hundred would help England produce better cricketers.

"There is an expectation that it's (Hundred investments) going to help County cricket. What it does do is help England produce better players because some of our players go to the IPL and mix with some of the legends of the game and coaches and they come back better players. "The IPL is not going to move and it's not going to get any smaller, so the game is going to accelerate," he said, referring to the money pumped in by the IPL teams. Stuart Cain, CEO of Warwickshire County Cricket Club, believes the fresh influx of cash in English cricket will help

all 18 counties but in the long run they need to develop multiple revenue streams.

"In its most simplest form, that money will help red-ball cricket and T20 cricket thrive in all the counties, not just the eight franchises where there are teams.

"So, if you're a Worcestershire or Northamptonshire or Leicestershire where you don't have a Hundred team, but you have that money, you can build better stadiums, which will attract more fans, give them a better experience. So, they want to come back again," Cain told PTI.

"It allows you then to create more money, which you can invest in the squad, which means that you can employ better red-ball players. If we can make it even more attractive through the investment

that the 18 counties will all benefit and the game in general will benefit."

Cain said there is also plenty to learn on the operation front from the IPL biggies besides stressing on the important of creating different revenue streams for clubs that don't have teams in The Hundred.

"What's great with The Hundred is four of the teams have got IPL investment and four have got predominantly American US investment. So there's a nice mix here. We can learn a lot from the IPL

"So, the investors are operating in those global franchise environments can help us build The Hundred competition. We've got a strong T20 tournament already in the Blast. So what we need to do is make sure that it stays really strong and healthy and that The Hundred stays different," Cain said. "Being straight, county cricket doesn't make money. So what we have to make sure is that through The Hundred money, the venues that aren't playing Hundred cricket can take the Hundred money and invest it in their stadiums.

For example, Cain is building a new onsite hotel at Edgbaston for an additional revenue stream through the year.

"All those things will then drive more money into the pockets of the county to then invest back into county cricket and to the Blast," said Cain.

Because of the financial crunch, the quality of cricket in county circuit has been impacted. With more cash in hand, the clubs would be able to attract better players and improve the standard of red ball game, said former India stumper and Lancashire great Farokh Engineer.

"It'll help the counties hugely. So, IPL have actually come to the rescue of certain dwindling counties. The county cricket's standard has fallen down. In my time, there was myself and Clive Lloyd playing for Lancashire." (PTI)

HI names 40-member core group for senior women's national camp

BENGALURU, July 19: Hockey India on Saturday announced a 40-member core probable group for the upcoming senior women's national coaching camp, which will be held at the Sports Authority of India (SAI) Centre here from July 21 to August 29. The camp holds significance as the Indian women's hockey team gears up for the women's Asia Cup, set to begin on September 5 in Hangzhou. China. The tournament will serve as a direct qualification pathway for the 2026 FIH Women's World Cup, with only the champion earning a guaranteed spot.

All players from the previous camp have been retained, reflecting a continued emphasis on stability and long-term development under the current coaching setup. "This camp comes at a very critical juncture for us. The Asia Cup is not just a prestigious continental tournament, but also a direct route to the 2026 World Cup. We are treating this camp with utmost in-

tensity and focus to ensure we arrive in Hangzhou as a mentally and physically prepared unit," Indian women's hockey team chief coach Harendra Singh said in a release.

"We have retained the core from the last camp to maintain consistency in our approach, while also allowing the younger players more time to integrate into the senior structure. After a tough Pro League campaign in Europe, where we couldn't produce the results we wanted, this camp also gives us a chance to reset, refocus, and bounce back stronger. Moreover, we have identified critical angles in penalty corner defence, which was a key area of concern during the Pro League.

The goalkeeping unit features experienced stalwarts Savita, Bichu Devi Kharibam, Bansari Solanki, and Madhuri Kindo, along with rising talent Samiksha Saxena from Assam Hockey, who impressed selectors with her performances at the National Championships earlier this year. The defence line-up comprises seasoned names such as Nikki Pradhan, Sushila Chanu Pukhrambam, Udita, and Mahima Chaudhary, bolstered by emerging players like Ishika Chaudhary, Jyoti Chhatri, Anjna Dungdung, Akshata Abaso Dhekale, and Suman Devi Thoudam. In midfield, the group continues to rely on the experience of Neha, Salima Tete, Vaishnavi Vitthal Phalke. Manisha Chauhan, and Sharmila Devi, while also nurturing young talents like Sujata Kujur, Mahima Tete, Albela Rani Toppo, and Pooja Yadav.
