# Day of 'surprise' events capped by Dhankhar's abrupt resignation

President on Monday night has triggered a firestorm of speculation on whether there was more to it than "to prioritise health care", as his sudden move had capped a day of events in Rajya Sabha on his watch which took the government by surprise and put it in a damage-con-

The usual effusive praise that is showered on an occupant of a high office on his departure was missing from the ruling alliance's side, an indication that the government was probably happy to see him go. It was the Opposition, which had signed a notice to impeach him last year for his alleged biases, that had nice words for him.

Dhankhar had informed the House on Monday that he had received a notice for a motion to remove Justice Yashwant Varma, who is embroiled in a suspected corruption case, from 63 opposition MPs. The Vice President is ex-officio chairman of the Rajya Sabha.

Congress leader and Rajya Sabha MP Jairam Ramesh speculated in a post on X that something serious clearly occurred between 1 PM and 4.30 PM, which prompted Nadda and Rijiju to skip the BAC "deliberately". This naturally did not go well with Dhankhar, he

Nadda told reporters that both of them were busy in official work and had informed the Rajya Sabha Chairman's office about it.

A few BJP members were also critical of Dhankhar's decision to allow the Leader of Opposition in Rajya Sabha, Mallikarjun Kharge, to launch a sharp attack on the government over Operation Sindoor during the Zero Hour when the ruling alliance had already expressed

At 9.25 PM on Monday, Dhankhar (74) announced his resignation "to prioritise health care and abide by medical

Barring Prime Minister Narendra Modi, who put out a brief post, most of the leading government figures refrained from offering any comment.

Modi said on X, "Shri Jagdeep Dhankhar Ji has got many opportunities to serve our country in various capacities, including as the Vice President of India. Wishing him good health."

Opposition MP Kapil Sibal, long a bitter critic of Dhankhar, lauded him as a nationalist and patriot.

He wanted the opposition and the government to work together to enhance India's standing in the world, the senior

lawyer said. Many leaders are of the view that the ties between Dhankhar and the govern-

ment might have got strained over a period of time, but there is little clarity on the reasons for these differences. (PTI)

The publication marks a key step in the run-up to the elections for the 40 constituencies under the

According to an official statement from the Assam State Election Commission, the draft roll includes a total of 2,669,396 voters, comprising 13,29,742 male and 13,39,637 female electors. The roll will cover 3,277 polling

# Naga organisations in Manipur urge PM,

IMPHAL, July 22: Several Naga organisations in Manipur on Tuesday urged Prime Minister Narendra Modi and Home Minister Amit Shah to immediately halt the fencing of India-Myanmar border and to restore the Free Movement Regime (FMR) within 20 days.

The Naga organisations, which included the United Naga Council, All Naga Students' Association, Manipur, Naga Women's Union and Naga Peoples Movement for Human Rights South submitted the petition through Manipur Governor Ajay Kumar Bhalla.

The Raj Bhavan in an official statement said that representatives of UNC, ANSAM, NWU, and NPMHR-S met Governor Bhalla on Tuesday.

"During the meeting, the representatives expressed concerns over



ongoing developments impacting the hill areas, particularly in relation to the Free Movement Regime and border fencing," it said, adding that the "governor acknowledged the grievances raised and said that the matter would be looked into.'

# **Grounded British**

THIRUVANANTHAPURAM, **July 22:** The British F-35B fighter iet flew back on Tuesday after completing maintenance, more than a month after it made an emergency landing at the international airport here, and remained parked since

The jet, which took off at 10.50 am, flew to Darwin in Australia, airport sources said

"A UK F-35B aircraft, which landed following an emergency diversion on June 14, departed today from Thiruvananthapuram International Airport. A UK engineering team, deployed since July 06 completed the repairs and safety checks, allowing the aircraft to resume active service," a British High Commission spokesperson said.

In a statement, the spokesperson said the UK remains very grateful for the support and collaboration of the Indian authorities and airport teams throughout the repair and re-

While the airport sources confirmed that landing charges, daily rent, and parking fees amounting to ₹5 - ₹6 lakh had been paid, there was no confirmation regarding any payment made to Air India.

## 'Aadhaar, voter, ration cards considered only One dead, 12 injured in two fighter jet flies back for identification': EC justifies SIR in Bihar

**NEW DELHI, July 22:** The Election Commission of India has justified its ongoing Special Intensive Revision (SIR) of electoral rolls in Bihar saying it adds to the purity of the election by "weeding out ineligible persons" from the electoral rolls.

The affidavit filed by the poll panel in a plea challenging June 24 order directing SIR of electoral roll pan-India starting from Bihar said despite legal concerns, Aadhaar, voter card and ration card were already being considered by the commission for the limited purpose of identity during the SIR-2025 exer-

"The SIR exercise adds to the purity of elections by weeding out ineligible persons from the electoral roll. The entitlement to vote flows from Article 326 read with Sections 16 and 19 of the RP Act 1950 and Section 62 of the RP Act 1951 which contains certain qualifications with respect to citizenship, age, and ordinary residency. An ineligible person has no right to vote, and thus, cannot claim a violation of Articles 19 and 21 in this regard," the poll panel said in a detailed affidavit.

It referred to the July 17 order of the top court asking the ECI to consider Aadhaar, voter and ration cards for the purpose of SIR-2025.

"In addition to the legal concerns already articulated hereinabove, these documents are, in fact, already being considered by the Commission for the limited purpose of identity, during the SIR process," it said.

The ECI continued, "A bare perusal of the enumeration form issued under the SIR Order reveals that the Aadhaar number may be voluntarily furnished by a person furnishing the enumeration form. Such information is utilised for the purpose of identification, in accordance with Section 23(4) of the Representation of the People Act, 1950, and Section 9 of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016.'

Section 23(4) of the Representation of the People Act, 1950 stipulates the "electoral registration officer may for the purpose of establishing the identity of any person require that such person may furnish the Aadhaar number given by the Unique Identification Authority of India as per the provisions of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016"

On the other hand, Section 9 of the 2016 Act says Aadhaar number is not evidence of citizenship or domicile, etc. The poll panel said each and every existing elector,

# separate road accidents

**22:** One person was killed and 12 others were injured in two separate road accidents in Assam on Tuesday, officials said.

In a chain accident involving six vehicles in Chirang district, one person was killed and five others were injured, while seven more people sustained injuries in Sonitpur district in a head-on collision between an oil tanker and an SUV.

A senior official of the Chirang district administration told PTI that multiple vehicles collided on National Highway-27 at Kashikotra, resulting in massive road blockage that affected traffic for several hours on Tuesday.

"A car stopped seeing a big snake crossing the highway. Several other vehicles also stopped. However, a speeding gas tanker could not stop and rammed all the vehicles in front of it." she added.

## India records nearly fourfold rise in annual organ transplants since 2013: Govt

NEW DELHI, July 22: The total number of organ transplants performed annually in the country has increased from 4,990 in 2013 to 18,910 in 2024 due to consistent efforts over the years, Minister of State for Health Prataprao Jadhav informed the Rajya Sabha on Tues-

In a written reply, Jadhav said the number of deceased donor organ transplants has risen from 837 in 2013 to 3,403 in 2024, while the organ donation rate (deceased donors per million population) has improved from 0.27 to 0.81 during the same period.

The number of deceased organ donors has grown from 340 in 2013 to 1.128 in 2024, he said.

"India currently ranks third globally in total organ transplants and stands first in living donor organ transplants," Jadhav stated.

To strengthen the organ trans-



plantation ecosystem, states are encouraged to identify gaps and take proactive measures. They can seek assistance from the Centre through the National Organ Transplant Programme (NOTP), he said.

Under NOTP, financial grants are provided to states based on proposals received for establishing Regional Organ and Tissue Transplant Organisations (ROTTOs) and State Organ and Tissue Transplant Organisations (SOTTOs). The programme also supports infrastructure development in public sector facilities for setting up transplant or retrieval centres and tissue banks.

Funding is also extended for hiring transplant coordinators in government (CONTD.ON PAGE-2)

## Ebix Tech secures ₹140 crore contract from Maharashtra Transport Corp

MUMBAI, July 22: Ebix Technologies, Indian subsidiary of Eraaya Lifespaces, on Tuesday announced securing a ₹ 140 crore contract from Maharashtra State Road Transport Corporation for the first statewide rollout of the National Common Mobility Card for concessionaires in India.

"Once fully operational, the project is expected to clock transactional volumes to the tune of ₹ 2,000 crore annually, boosting the entity's digital transaction ecosystem and passenger convenience, Ebix Technologies Limited, earlier known as EbixCash," said in a statement.

In November 2022, the company was awarded a contract to supply and maintain 38,622 Androidbased Electronic Ticketing Machines (ETMs) integrated with an online reservation system.

This mandate has successfully facilitated the issuance of approximately 220 crore passenger tickets in the past two years, Ebix Technologies said, adding



that this network spans MSRTC's fleet of over 16,000 buses, serving more than 13 crore passengers monthly across urban and rural Maharashtra.

"The newly-awarded National Common Mobility Card (NCMC) programme expands this partnership with a focus on smart and interoperable payments that will revolutionise how millions travel daily," it said. "Spearheaded by the National Payments Corporation of India (NPCI) in collaboration with the Ministry of Housing and Urban Affairs, the initiative enables passengers to use a single smartcard across multiple transport modes, creating a truly integrated mobility ecosystem," Ebix said.

"With the NCMC rollout, we are not just introducing another payment method. We are fundamentally reimagining how citizens experience everyday travel across Maharashtra," a company spokesperson said

The project includes mandatory adoption of the NCMC smartcard for all concessional passengers and pass holders on MSRTC buses, with optional availability for regular passengers, a minimum business assurance of 70 lakh NCMC cards to be sold in the first year alone, scaling to over 2 crore cards issued statewide through a network of 3,000 dedicated retail outlets established by Ebix Technologies, among others. #### 'PM Modi's short, focussed visit shows India invested in UK ties'

Modi's short but focussed visit to the UK highlights his commitment to this partnership and his willingness to keep it thriving as it is taken to the next level with a Free Trade Agreement, India's High Commissioner Vikram Doraiswami said on Tuesday.

Speaking to PTI at India House in London on the eve of the PM's visit, Doraiswami said an extremely "detailed and ambitious" FTA document is in the final legal scrubbing phase to ensure it reflects the substance of what was agreed when negotiations concluded on May 6. All eyes will be on the FTA, which aims to double bilateral trade to USD 120 billion by 2030 and is expected to be formally signed off during Modi's meeting with British Prime Minister Keir Starmer on Thursday.

"We are working to finalise it; the objective is to have the Free Trade Agreement land," said Doraiswami.

"It is, of course, a detailed and ambitious document, which is probably our most ambitious Free Trade Agreement to date. So, there is effort that is required to make sure it's all accurate and covers everything that the two sides have actually agreed and reflects the substance of what people are expecting, as and when it lands. It will have a very important impact upon both economies and help drive growth in both countries," he said.

The envoy pointed out that the FTA, once signed and ratified by the UK Parliament, will give businesses a more predictable framework and stressed that it is not just about "tariff reductions" but also about improving the terms

And, of course, there is a huge and very important set of areas covered under services, which is a significant segment of both the

British and the Indian economy," he shared. Regarding the extremely truncated UK visit before the Prime Minister heads to the Maldives, Doraiswami admitted that the High Commission and the 1.8-million-strong diaspora would have liked all the "bells and whistles" of a longer tour, but reiterated that it suggests a great willingness to keep the India-UK partnership "thriving"

The fact that he's so committed to this relationship should give our diaspora friends confidence here that the UK is such an important partner for us that the Prime Minister is willing to fly across all of this distance just to push the relationship forward, for a mere 24 hours. I think that's pretty incredible," said the

"The Prime Minister has consistently held the view that we must build ties with traditional and important partners. His willingness to travel a considerable distance for a short period of time, even when Parliament is in session... making a short but really focussed trip suggests to us that the Prime Minister places great emphasis on getting this relationship not just to maintain its current trajectory but to lift

it to its next level," he said. The Prime Minister, who will be accompanied by a business delegation, is also scheduled for an audience with King Charles III at one of the royal estates. During his visit to the UK in 2018, Modi and the then Prince of Wales had jointly launched an Ayurvedic Centre of Excellence. (PTI)

### Grounded British fighter jet

remained grounded at the international airport here since June 14 after it developed a technical snag. The aircraft, which took off from HMS Prince of Wales on June 14, was unable to return to the carrier due to adverse weather conditions.

Prioritising safety, it diverted to Thiruvananthapuram International Airport, where it landed safely. Subsequently, the aircraft developed an engineering issue whilst on the ground, which temporarily delayed its return to the Carrier Strike Group. Engineers from HMS Prince of Wales assessed the aircraft and determined that the support of a UK-based engineering team was required.

The UK accepted India's offer to move the aircraft to the Maintenance, Repair and Overhaul (MRO) facility. To ensure minimal disruption to regular airport operations, it was decided that the aircraft would be moved once the UK engineering teams arrived with specialist equipment.

The emergency landing by the British Royal Navy fighter jet at Thiruvananthapuram International Airport became the subject of countless memes, and even turned into a marketing opportunity for A poster shared by Kerala Tourism on its official 'X' handle went viral on social media.

It featured a stylised image of the fighter jet parked against a dreamy Kerala backdrop -- coconut trees and lush greenery. A playful caption read: "Kerala is such an amazing place, I don't want to leave. Definitely recommend." The quote was humorously attributed to "UK F-35B." (PTI)



#### Death of a **Communist stalwart**

he life of VS Achuthanandan who passed away at the age of 101 on Monday is a remarkable chapter in the history of Kerala in general and the revolutionary movement here in particular. VS Achuthanandan was a symbol of a brilliant tradition of struggle, extraordinary determination and uncompromising fighting stance. His century-long life, which took on the problems of the people and stood with the people, is inextricably intertwined with the modern history of Kerala. VS's contributions, which led the Kerala government, the CPI(M), the Left Democratic Front and the opposition at various stages, are unparalleled. History will record that they are part of Kerala's political legacy. The demise of VS marks the end of an era. This has caused a heavy loss to the party, the revolutionary movement and the entire democratic progressive movement. The party can only make up for that loss through collective leadership. This is a time when many memories of working together for a long time come flooding back. VS had an eventful life marked by extraordinary energy and survival power in the revolutionary movement. The life of VS is a struggle-filled chapter in the history of Kerala and the Communist Party.

When the Communist Party split in 1964, the last remaining link among the 32 people who left the National Council was severed with the demise of VS. A valuable political presence that had kept the national freedom struggle in sync with contemporary politics had disappeared. As a communist leader, as a member of the Legislative Assembly, as the Leader of the Opposition and as the Chief Minister, VS has made many contributions. From a worker, VS rose very quickly to become a powerful leader of the working class movement. The party developed VS and the VS Party. In 1940, at the age of 17, he became a member of the Communist Party and remained a member of the party for a long time, 85 years. Comrade VS, who went to Kuttanad, led the struggle to end the wage slavery and caste slavery faced by the agricultural workers. He walked around the villages of Kuttanad and convened meetings of agricultural workers and developed them into an organized force. He did this by challenging the landlords and the police.

VS played an irreplaceable role in the formation of the 'Travancore Agricultural Workers Union' and later in its development into one of the largest labour movements in Kerala, the 'Kerala State Agricultural Workers Union'. The countless struggles led by VS changed the social history of Kuttanad. He was at the forefront of the struggles for better wages, the abolition of the chappa system, job stability, and the seizure of surplus land. His efforts to instill confidence and team spirit in the workers, walking for kilometers along the ridges of the fields and visiting their huts, attracted them all to the movement. The demise of VS has created an irreparable loss for the party and the country.

Unexpected Exit: Jagdeep Dhankhar resigns as Vice President of India

n a surprising move, Jagdeep Dhankhar resigned from the post of ■ Vice President of India on July 21, 2025. He submitted his resignation to President Droupadi Murmu, stating health reasons as the cause. The announcement came as a shock to political circles and the general public, as Dhankhar's term was set to run until August 2027. His resignation took effect immediately after the President accepted it.

Dhankhar, who also served as the exofficio Chairman of the Rajya Sabha, cited medical advice for his decision to step down. He is 74 years old and had been undergoing treatment in recent months. While his official reason was health-related, the timing of the resignation—just as the Monsoon Session of Parliament began—sparked speculation about possible political tensions behind

Reports indicate that Dhankhar accepted an Opposition-backed motion in the Rajya Sabha related to the removal of a judge. This decision, said to be controversial within the ruling alliance, may have led to friction. According to some sources, there was a heated exchange between Dhankhar and

central leadership officials following the acceptance of the motion. Congress leader Jairam

Ramesh openly questioned the timing, suggesting that more had happened behind closed doors. He pointed to a critical time window on the day of resignation and linked it to the absence of key ministers from a meeting chaired by Dhankhar.

With his resignation, the office of the Vice President is now vacant. According to the Indian Constitution, the Deputy Chairman of the Rajya Sabha will perform the Vice President's duties until a new election is held. A fresh election must be conducted within six months. All Members of Parliament, from both the Lok Sabha and Rajya Sabha, will vote to elect the next Vice President. The government, led by the NDA, has already started internal discussions about potential candidates for the role. Names such as Harivansh, the current Deputy Chairman of the Rajya Sabha, and Haribhau Bagade, a senior BJP leader tion seeking the removal of a sitting



from Maharashtra, are among those reportedly being considered.

Jagdeep Dhankhar had a long and eventful career in public service. Born in 1951 in Rajasthan, he studied science and law and began his professional life as a lawyer. He was elected as a Member of Parliament in 1989 and served as Minister of State for Parliamentary Af-

sembly. His political journey took a major turn in 2019 when he was appointed Governor of West Bengal. During his tenure as Governor, he was known for his frequent disagreements with the state government.

In August 2022, Dhankhar was elected as the Vice President of India, defeating Opposition candidate Margaret Alva with a strong majority. He assumed office on August 11, 2022. As Chairman of the Rajya Sabha, he was known for his firm conduct of proceedings. He often urged members to uphold decorum and made headlines for his no-nonsense approach. He also took a proactive role during key legislative moments, including the Nari Shakti Vandan Bill debates, during which he reorganized the panel of Vice-Chairpersons to include more women parliamentarians.

However, his decision to accept a mo-

judge—an unusual step—appears to have led to discomfort in some quarters of the government. This incident, coupled with his resignation just hours later, has led many observers to wonder whether there was pressure or disagreement behind his departure. While BJP leaders have reiterated that Dhankhar resigned purely for health reasons, Opposition voices continue to point toward political friction.

With the Vice President's seat now vacant, the focus shifts to the upcoming election. According to constitutional provisions, a new Vice President must be elected within six months. Until then, the Deputy Chairman of the Rajya Sabha will take charge of proceedings in the Upper House. Political observers believe that the government may choose a consensus candidate to avoid further contro-

Dhankhar's resignation is one of the rare instances of a Vice President stepping down before completing the full five-year term. Despite the abrupt end, his time in office was marked by active participation in parliamentary affairs, assertive decisions, and a legal background that influenced his approach to legislative conduct. ## VP Jagdeep Dhankhar's resignation has a political context

ealth issue is the officially stated reason for the Vice President of India Jagdeep Dhankhar's resignation, but it has a political context. It was only in December 2024, Dhankhar had rebuked its own government led by PM Narendra Modi over not talking to agitating farmers of Punjab. He had said that a nation that tested the patience of farmers paid a "heavy price". Now his resignation is seen as the "heavy price" he had to pay for going

against his own government. The Vice President Dhankhar had sought to know on stage in a Mumbai event from the Union Minister of Agriculture Shivraj Singh Chouhan preset there as the why the Centre was not holding a dialogue with the protesting farmers. Dhankhar had said 'every moment is critical for you. I urge you, and as the person holding the secondhighest constitutional position in India, I request you to please tell me, was any promise made to the farmer, and why has it not been fulfilled? What are we doing to fulfil the promise? There was an agitation last year, and there is one this year as well, and time is passing, but we are doing nothing." It was a direct indictment of the PM Narendra Modi led Centre, that has not yet accepted the farmers' demand for the legal guarantee for MSP for their crops.

Dhankhar took over as Vice President of on August 11, 2022 and resigned on July 21, 2025. He is the third Vice President of India after VV Giri and R Venkataraman to resign before completing his term, with only difference that Giri and Venkataraman had stepped down to contest presidential election, but Dhankhar has resigned stating "health concerns and the need to follow medical advice" and his intent to "prioritise health care".

In the power corridor in New Delhi, people believe that "health issues" may be only one of the reasons, that too a superficial one, behind his resignation. He was seen in good health and vigour on the first day of the Monsoon session of the Parliament. He presided over the proceedings of the Rajya Sabha and addressed the issues relating to the opposition motions and opposition's demand for a statement of Prime Minister and discussion on Pahalgam terror attack, Operation Sindoor, and ensuing events including Trump's claims.

Dhankhar had convened the meeting of the Business Advisory Committee of the Rajya Sabha at 12:30 PM, which was also attended by Union Ministers J P Nadda and Kiren Rijiju. However, discussions remained incomplete which made him reconvene the meeting at 4:30 PM. Nadda and Rijiju were absent, and the government was represented by the Union Minister L Murugan. It was the first time Dhankhar was seen visibly unhappy, and then he rescheduled the meeting for July 22 at 1 PM. Within hours in the late evening the sud-

den and most unexpected move of resignation came, which surprised most of the leaders including from the BJP, perhaps excepting the political leadership of the ruling establishment in the help of affair. What upset Dhankhar so much prompting him to resign? It remains the matter of speculation. Heath was not immediate concern, but has been a long-term concern for him since March 2025, when he was hospitalized for certain heart problem and was discharged after a few days with advice for rest.

Opposition has linked Dhankhar's resignation to his being humiliated by the BJP leaders, on at least two occasions in the day. Congress leader Jairam Ramesh has said that at 4:30 PM BAC awaited Nadda and Riiiiu, who never came. Dhankhar was not personally informed that the two senior Ministers were not attending. He said that something very serious happened yesterday between 1 PM and 4:30 PM to account for the deliberate absence of the ministers. Jairam Ramesh also recalled how Dhankhar fearlessly referred to "ahankara" in public

It has been noted by many and highlighted by Congress that JP Nadda had said during the opposition's protest in the Rajya Sabha, "Nothing will go on record, only what I say will go on record". There is a speculation that this might have hurt Dhankhar and he was presiding over the Rajya Sabha at that time.

JP Nadda has defended himself and said, "As for what I said in the Rajya Sabha, that whatever I say will go on record, it was directed at the interrupting Opposition MPs, not at the Chair". On his and Rijiju's absence, he said, "Kiren Rijiju and I did not attend the meeting called by the Vice President at 4:30 PM because we were occupied with other important parliamentary work, and prior intimation was given to the office of the Honourable Vice President.'

There is another speculation which is related to the opposition's impeachment motion against Justice Yashwant Varma. There are reports suggesting that there the government was not happy with the way Dhankhar was handling the impeachment motion. Another speculation is about disagreement on the issue of justice S K Yadav's impeachment whose pro-Hindutva statement made in a VHP event had created great controversy in the past.

The political context, timing, and the way Dhankhar's resignation has come, are suggestive of some serious differences between the Vice President and the Union government on various issues, and the absolute political control of PM Narendra Modi. Criticising or differing with him will have to be paid by a "heavy price" though officially stated reasons may by different. (IPA Service)

# After first six months of Trump 2.0, Americans are still confused on gains or losses

President Donald J Trump completed 180 days in his 2nd presidency on Sunday that was marked by a high-octane governance full of confrontations, chaos, and calculated populism. Trump is parrelling into his seventh month in office with the throttle wide open-and the brakes seem-

Commerce Secretary Howard Lutnick's Sunday remarks promised a "record-breaking" fortnight ahead as Trump's White House pushes for last-minute tariff deals with over two dozen trade partners. But beneath the noise of impending mega-deals and tariff threats lies a swirling mix of global tensions, unfinished diplomacy, immigration crackdowns, citizenship upheavals, and a crypto-fuelled shadow economy that increasingly defines the Trump Doctrine 2.0.

Trump has fired off formal tariff threats to 25 countries marking this week, including top trading allies like Canada, Mexico, and the European Union. Come August 1, steep new tariffs—ranging from 10% for smaller economies to a punishing 35% for larger players—will take effect unless they capitulate to U.S. demands.

The 27-nation EU block which accounts for near \$ one trillion trade is defying solution and a mega beautiful trade deal with India is still elusive as that country is driving a hard bargain on agricultural imports from U.S., while willing to concede lower tariffs on a variety of goods from America including automobiles, whiskey and some manufactured goods on a lower tariff

"The next two weeks will be for the record books," Commerce Secretary Lutnick declared on Face the Nation, echoing the administration's belief that pressure equals progress. The message? Comply or pay.

At the heart of this strategy lies a high-stakes standoff with the EU. Last year alone, trade between the U.S. and the 27-nation bloc crossed \$975 billion. Trump has now threatened to slap a 30% tariff on European exports if a deal isn't struck, escalating from April's already controversial 20% hike. That means a whopping 50% tariffs totally unacceptable to EU.

Brussels has responded in kind, warning of retaliatory tariffs targeting American agriculture, tech, and autos-effectively reviving fears of a 21st-century transatlantic trade war.

Meanwhile, Mexico and Canada-still reeling from the fentanyl crisis accusations and Trump's immigration-linked tariff policies face their own ultimatums. Starting next month, tariffs on their exports to the U.S. will spike to 30% and 35%, respectively, from the 1st batch of 25% announced, unless new agreements are finalized. Trump has tied their compliance not just to trade, but to drug interdiction and border enforcement-an audacious linkage of com-

While Trump announced in April the framework for what he called a "big beautiful trade deal" with Prime Minister Narendra Modi, little has been finalized. Behind the scenes, thorny issues remain: tariffs on U.S. dairy and medical devices, e-commerce restrictions, digital data localization, and disputes over defence offsets.

Trump famously called his 2nd buddy Modi 'tough but fair," but, White House sources suggest frustration is growing. With some states elections looming in India in 2026, New Delhi is wary of appearing overly compliant to Washington's muscle-flexing. That said, backdoor crypto cooperation—especially regarding American blockchain firms operating in India-

has seen quiet progress. Arguably the most bizarre yet effective fundraising mechanism in modern American politics, Trump's re-election campaign and MAGA media empire have been boosted by the unofficial "TrumpCoin"—a meme-based cryptocurrency surging among his supporters and alt-finance fans.

While not formally endorsed, TrumpCoin has become de facto campaign cash, accepted at MAGA rallies, stores, and even some conservative media paywalls. More controversially, insiders allege that Trump's sons, Don Jr. and Eric, are leveraging offshore partnerships—particularly through Dubai-based World Liberty Financial and its Abu Dhabi-linked promoters—to

float crypto assets with limited oversight. A \$2 billion deal has been clinched with Abu Dhabi financiers that endorses Trumps meme USD1 in an exchange called binance for trad-

The diaphragm is a small, flexible cup made of silicone. A person inserts the diaphragm into their vagina to cover the

According to Planned Parenthood, the diaphragm is 94% effective if used correctly every single time.

However, the real-life accuracy rate is around 83%, which means about 17 people out of 100 will still get pregnant using the diaphragm.

Diaphragms should be used along with spermicide. It can be applied to the diaphragm and around the edges before insertion. Spermicide comes in creams and gels. It destroys sperm and reduces the chances of pregnancy.

Doctors prescribe and fit most diaphragms. These birth control options are effective immediately. A person can use reusable devices for up to 2 years. If inserted correctly, neither partner should feel it during sex

Diaphragms are most often prescribed and fitted by a healthcare professional. However, one-size diaphragms that fit most people are also available.

Diaphragms remain in place for 6 hours after sex, but not for more than 24 hours. If a person has sex again during the 24 hours, they should reapply spermicide and then wait another 6 hours before removing the diaphragm.

A diaphragm does not protect against sexually transmitted infections (STIs), and individuals cannot use them during

The cervical cap is a small silicone cup that a person inserts into their vagina, fitting over the cervix. It is similar to the diaphragm but smaller. The only cervical cap available in the United States is available under the brand name, FemCap, which comes in three sizes.

According to Planned Parenthood, the failure rate for the FemCap is roughly 14% for people who have never given birth and 29% for those who have had a

The cervical cap does not contain hormones and can be inserted before sex. A person can use the same cap for up to 2 years. People should always use spermicidal gel with the cervical cap to ensure its protective qualities. Much like the diaphragm, it requires a prescription, a doctor must fit it, and it is not suitable for use during periods.

As with the diaphragm, the cervical cap should be left in place for 6 hours after sex. Unlike the diaphragm, the cervical cap can stay in longer, up to 48 hours total. A person does not need to reapply spermicide again if they have sex more than once during this timeframe. **Spermicides** 

Spermicides are placed in the vagina before sexual intercourse to stop sperm from entering the uterus. They are available in creams, gels, and suppositories.

Spermicides have a failure rate of 21% Trusted Source with typical use, according to the Centers for Disease Control and Prevention (CDC). However, effectiveness increases when used with other methods, such as the diaphragm or cervical cap.

This method is easy to use, does not require a prescription, and is inexpensive. Some people might experience side effects, such as irritation and allergic reac-

#### External condoms

The external, or male, condom is an effective way to guard against STIs.

It is also effective in preventing pregnancy by keeping semen from entering the vagina.

According to the World Health Organization (WHO)Trusted Source, when people use male condoms correctly, they are 98% effective in preventing preg-

The external condom is simple to use and safe. It is also convenient, inexpensive, easy to source, and does not require a prescription.

Condoms are not as effective as some other methods of birth control, and people need to use them every single time they have sex.

Some individuals are allergic to latex, and some people find condoms make sex less enjoyable by limiting sensation or re-



quiring more lubricant. When people are using a lubricant with condoms, they should choose a watersoluble or silicone variety, as oil-based lubricants can break down latex con-

#### **Internal condom**

The internal, or female condom, is a strong, thin protective covering with a ring on each side to hold it in place. It can protect against pregnancy and STIs.

According to the WHOTrusted Source, when people use the female condom correctly, it is 95% effective in protecting against pregnancy.

The internal condom contains no hormones, is available without a prescription, and is inexpensive. They are latex-free, they can increase sexual pleasure, and they can give a person control over the use of birth control and condoms with a sexual partner.

However, the outer rings of the female condom may cause irritation, and many people feel it reduces feeling. Female condoms usually cost twice as much as male condoms.

#### The sponge

The sponge is made of plastic foam and contains spermicide. A person inserts it into their vagina before sexual intercourse. It has a nylon loop for easy removal afterward. It is available at most drugstores and does not require a pre-

The sponge prevents pregnancy by covering the cervix so that sperm cannot enter. It also releases spermicide to immobilize sperm. According to Planned Parenthood, the

birth control sponge is least effective in people who have previously been preg-

In people who have never been pregnant, the failure rate is 9% when used correctly each time, and 14% with regular use. For people who have been pregnant before, the failure rate is 20% with

ideal use and 22% with regular use. The sponge carries an increased risk of yeast infection and toxic shock syndrome and should not be left in the vagina for more than 30 hours total. Vaginal dryness and allergic reactions are common side

#### Phexxi

A newer nonhormonal birth control method is a prescription vaginal gel sold under the brand name Phexxi.

Phexxi is put into the vagina up to an hourTrusted Source before having sex using a prefilled applicator. It starts working immediately and is effective for up to 1 hour. It is not effective if a person uses it after having sex.

Phexxi prevents pregnancy by lowering the pH level in the vagina. This makes it difficult for sperm to move, decreasing the chance for sperm to meet the egg.

Planned Parenthood states that with perfect use, Phexxi is 93% effective. However, it is 86% effective with typical use. A person should make sure to follow the instructions closely. Phexxi is suitable for use with some other birth control methods, such as condoms or a diaphragm.

It is important to note that this method does not protect against STDs. However, it is safe to use while nursing.

#### There are some side effects associ-

- ated with Phexxi, including: Bacterial vaginosis
- Vaginal burning, irritation, or itching Yeast infections
- Urinary tract infections (UTIs)
- Vaginal discharge
- Allergic reaction A person should speak with a healthcare professional for further information.

There are some long-term and permanent nonhormonal options that are safe and effective for most people. Paragard

Long-term and permanent solutions

In the United States, this nonhormonal intrauterine device (IUD) is available under the brand name Paragard. According to the Food and Drug Administration (FDA), less than 1 out of 100 people using Paragard get pregnant each year.

Paragard is hormone-free and prevents pregnancy for up to 10 years. It takes only a few minutes for a doctor to insert the device into the uterus. Once in place, the thin copper IUD causes an inflammatory reaction inside the uterus that prevents sperm from reaching the egg.

Paragard can be a good option for people who do not want to worry about daily or weekly birth control reminders or who do not want to use hormonal birth control. This method is completely reversible. A healthcare professional can remove Paragard at any time if a person decides they want to get pregnant or do not want to use it anymore.

Paragard does not protect against STIs. **Side effects include:** 

- Cramping
- · Heavy periods
- Spotting between periods Sterilization

For people who want a permanent birth control method, sterilization may be an option. The procedure involves surgery that is difficult to reverse, and it will

not protect against STIs. For females, the surgical procedure is called tubal ligation, and for males, vasectomy surgery provides permanent

When done correctly, these methods are highly effective in preventing preg-

Another method of sterilization was available in the United States under the brand name Essure. It is a uterine device that does not require surgery, is hormonefree, and is fitted in a doctor's office without general anesthesia.

The Essure device is a tiny spring-like device that a doctor inserts through the vagina to each fallopian tube. The mesh substance of Essure inflames the fallopian tubes, causing permanent scarring and blockage of the tubes over time.

According to the FDATrusted Source. as of December 2019, Essure is no longer available for implantation in the United States. However, people who have been using the device as birth control successfully can continue to do so.

#### Other methods

While barrier methods and long-term birth control are popular options in the United States, some people prefer alternative hormone-free birth control.

#### Withdrawal method

The withdrawal method is the oldest form of birth control, but it is not the most effective. Withdrawal involves a person pulling their penis out of the vagina before ejaculation.

According to Planned Parenthood, with perfect use, the method is 96% effective. However, this is a difficult method to use perfectly. Typical use is 78% effective. This means a little over 1 in 5 people who use this method will become pregnant.

#### Natural family planning

Some people may wish to try natural family planning or fertility awareness methods. It involves tracking the menstrual cycle to work out when a person is ovulating. While a person is ovulating, they should use barrier methods if they wish to prevent pregnancy.

#### According to Planned Parenthood, there are three main methods:

• Temperature: A person takes their temperature every morning.

· Cervical mucus: A person checks their vaginal discharge every day.

• Calendar: A person records their menstrual cycle on a calendar.

A person can use one or more of these methods — a combination of all three is the most effective. Failure rates are between 12 and 24% depending on which method a person uses. Success rates are higher if a person uses a combination.

Natural Cycles, an app that is used for fertility awareness, has FDA approval.

However, it is important to note that natural family planning can be difficult, and a person may wish to consider a more effective method.

#### How to choose a nonhormonal birth control method

A person may wish to consider the following when choosing a nonhormonal birth control method:

- How much does it cost?
- How long does it last? • Does it require a prescription?
- How effective is it?
- Does it protect against STIs? How much do efficacy rates vary between perfect and typical use?
- Are there any side effects? • Is it easy to use long term? **Summary**

Deciding on a birth control method is a personal choice.

Each person should consider how birth control fits into their lifestyle and pick a method that is effective, safe, and convenient. It is also important to consider that some methods reduce the risk of STIs, and others do not.

# Why education must lead to employment for women in India

espite notable progress in female literacy and higher education, women's participation alarmingly low. According to the Women Empowerment Principles (WEP), female literacy in India has crossed 77 per cent, and women now account for 48 per cent of higher education enrollment. Yet, the Female Labour Force Participation Rate (FLFPR) stood at just 41.7 per cent in 2023-24 — significantly below the global average. This stark disparity reveals a troubling disconnect between educational attainment and actual em-

ployment outcomes. The real issue lies in what happens after women complete their education. While colleges and universities proudly highlight rising female enrollment, few track or support how many of these women transition into formal iobs, entrepreneurship, or leadership roles. This oversight undermines the productive potential of nearly half the country's population.

According to WEP data, only 20 per cent of academically strong female graduates enter the formal workforce or launch businesses. Clearly, qualifications alone are not enough — there is a pressing need for a more support- and do not guarantee financial inde-

ive ecosystem to help women take the next step in their professional journey. One practical and impactful solution

is to include a "conversion rate" — the

Her latest report, "From Economy of Occupation to Economy of Genocide," submitted to the UN Human Rights Council last week, marks a seismic intervention. It unflinchingly names and implicates companies that have not only allowed Israel to sustain its war and genocide against Palestinians, but also confronts those

demic exercise or a mere moral statement in a world whose collective conscience is being brutally tested in Gaza. The report is significant for multiple interlocking reasons. Crucially, it offers practical pathways to accountability that transcend diplomatic and legal rhetoric. It also presents a novel approach to international law, positioning it not as a delicate political balancing act, but as a potent tool to confront complicity in war crimes and expose the profound failures of the existing international mechanisms in Gaza. There is vital context that is necessary to understand the significance of this report, which is considered a searing indictment of direct corporate involvement, not only in the ongoing Israeli genocide in Gaza but Israel's overall settler-colonial project. In February 2020, following years of delay, the UN Human Rights Council released a database that listed 112 companies involved in business activities within illegal Israeli settlements in the Oc-

cupied Territories. The database exposed several corporate giants for helping Israel maintain its military occupation and apartheid. This was particularly earth-shattering considering the UN's consistent failure to rein in Israel or hold accountable those who sustain its war crimes in Palestine. The publication of the database was an important step that allowed civil societies to mobilize around a specific set of priorities, thus pressuring corporations and individual governments to take morally guided positions. The effectiveness of that strategy was clearly detected through the exaggerated and angry reactions of the US and Israel.

of all existing UN mechanisms to achieve even the most modest expectations of feeding a starving population during a time of genocide. In the report, the categories of complicity in the genocide are divided into arms manufacturers, tech firms, building and construction companies, extractive and service industries, banks, pension funds, insurers, universities, and charities.

Their collective technological know-how, machinery and data collection has allowed Israel to kill, to date, more than 57,000 and wound 134,000 in Gaza, while also maintaining its apartheid regime in the West Bank. What Albanese's report tries to do is not merely name and shame Israel's genocide partners, but to tell us, as civil society, that we now have a comprehensive frame of reference that allows us to make responsible decisions and pressure and hold accountable these corporate giants.

A drone hit a gas station in the town of Putyvl, wounding four people, including a 5-yearold boy, it said. A second drone strike hit the same location less than two hours later, wounding seven other people.

After dark, two powerful Russian glide bombs were dropped on Sumy city, wounding 13 people, including a 6-year-old boy. According to regional authorities, five apartment buildings, two private homes and a shopping mall were damaged in the attack. The blasts shattered windows and destroyed balconies in residential buildings, acting Mayor Artem Kobzar said.

Russia's Defence Ministry, meanwhile, said Tuesday that air defences downed 35 Ukrainian long-range drones over several regions overnight, including three over the Moscow region. (AP)

#### Australian Parliament resumes after Labor's

landslide election victory MELBOURNE, July 22: Australia's Parliament resumed Tuesday for the first time since the centre-left Labor Party won one of the nation's largest-ever majorities in the May elections.

Prime Minister Anthony Albanese thanked the traditional owners of the national capital Canberra at a Welcome to Country ceremony in Parliament House. He noted that such ceremonies performed by Indigenous people to welcome visitors to their traditional land at the start of a new parliament had been introduced by a Labor government in 2007. "In the 48th Parliament, we write the next chapter. Let us do it with the same sense of grace and courage that First Nations people show us with their leadership," Albanese said.

The government has said the first legislation will be a bill to reduce student loan debt by 20 per cent. The measure to be introduced Wednesday will benefit 3 million Australians with student loan debts and cost the government 16 billion Australian dollars (\$10 billion).

The government also plans to introduce laws that would cut funding to child care providers who fail to meet quality standards and that would provide legal protections for some wage rates.

Labor won 94 seats in the 150seat House of Representatives where governments are formed. Labor's majority is the largest since Prime Minister John Howard's conservative coalition won 94 seats in 1996, when the lower chamber had only 148 seats.

Howard stayed in power almost 12 years, and Albanese is the first prime minister since then to lead a party to consecutive election victories, following an extraordinary era of political instability.

The main opposition Liberal Party has elected its first woman leader, Sussan Ley, after one of the party's worst election results on record. (AP)

# Arunachal to get India's first fully indigenous 50-kw geothermal power plant

'Project is expected to be completed in three years'



ITANAGAR, July 22: India's first fully indigenous geothermal power plant will be developed in Arunachal Pradesh, officials said on Tuesday.

The 50-kw plant will be developed at a record low of 68 degrees Celsius, they said.

In this regard, the Centre for Earth Sciences and Himalayan Studies (CESHS) and Shriram Institute for Industrial Research have inked a memorandum of un-

derstanding CESHS geoscience chief Rupankar Rajkhowa said the project

will come up in Tawang district. "We have already identified three places -- Mago, Thingbu and Damteng, and the research and structural mapping has been done," he said, adding that the project will cater to a population

Rajkhowa said the project is expected to be completed in three

of over 5,000.

Maintaining that it's a first-ofits-kind in the Himalayan region, he said the project will be completed at a cost of over Rs 10 crore, funded by the Ministry of New and Renewable Energy.

A team of scientists from CESHS, led by its director Tana Tage, recently visited the demonstration site of an indigenously developed 20-kw geothermal power plant at SIIR.

SIIR's geothermal project manager Bhupesh Sharma said multiple trials have been conducted using a smaller 5-kw labscale model to better understand the operational challenges of indigenous bipolar process technology, particularly at a lower temperature of just 68 degrees

Chief Minister Pema Khandu said, "Arunachal Pradesh & CESHS take a visionary step by signing an MoU to develop India's first fully indigenous 50kw geothermal power plant at a record low of 68 degrees C. Harnessing Earth's energy, driving innovation, and leading India's clean energy revolution from the Himalayas!

"It will be a milestone in clean energy and geothermal research,"

# **APYO** demands immediate action against substandard flyover work in Naharlagun

ITANAGAR, July 22: The
Arunachal Pradesh Youth Organisation (APYO) has demanded immediate corrective action against alleged substandard construction work being carried out on the under-construction flyovers under Package-B of National Highway 415 in Naharlagun.

The organisation has also threatened to launch a democratic movement if the authorities fail to address the issue within a stipulated time.

In an official statement issued following a press conference at the Arunachal Press Club on Tuesday afternoon, APYO president Kipa Kanam expressed serious concern over the quality of work being executed by the construction firm M/S Woodhill Shivam and supervised by the monitoring agency AECOM JV.

He alleged that materials not conforming to the prescribed guidelines of flyover construction were being used, raising fears of structural instability and potential loss of life and property.

"We are not against the development work being undertaken. However, we are deeply concerned that if the flyovers are not con-

tional standards, they could pose a serious threat in the future. In case of a structural collapse, who will be held responsible?" Kanam questioned.

The youth body specifically pointed out that 18 pillars in the middle of Naharlagun township have allegedly been constructed in violation of laid down specifications, raising doubts over their structural integrity.

"The presence of these 18 pillars, which appear to be poorly constructed, has led us to question the overall durability and quality of the entire Package-B stretch," the APYO statement read. The organisation confirmed that

We insist that the 18 pillars be reconstructed using proper materials within 15 days. If this demand is not fulfilled, we will be compelled to launch a democratic agitation," the organisation stated.

DIBRUGARH, July 22: An Inte-

grated Water Treatment Plant at Medo in Arunachal Pradesh's Namsai district is providing free drinking water to 10 villages under the Chongkham block, benefiting a population of around 22,000.

Implemented by the Public Health and Engineering Department (PHED), Namsai Division, the facility is supplying water to 1,285 households across 10 habitations.

Built with an outlay of ₹32 crore, the plant has a treatment capacity of 2.70 million litres per day (MLD).

It sources water from a jack well constructed in a riverbed and is powered by both solar energy and conventional supply, with generator backup during outages.

"The project was established about five years ago. Now, around 22,000 residents are receiving clean water daily," said an official of the water treatment plant

Local residents had donated ap-

proximately 3.3 acres of land to facilitate the construction of the plant. The facility has also emerged as a tourist destination, with visitors from Assam and neighbouring regions frequenting the site to enjoy

"The revenue generated from tourism is used for the plant's maintenance," said Haage Guro, Junior Engineer, PHED.

British F-35B fighter jet flew back on Tuesday after completing maintenance, more than a month after it made an emergency landing at the international airport here, and remained parked since

The jet, which took off at 10.50 am, flew to Darwin in Australia, airport sources said.

"A UK F-35B aircraft, which landed following an emergency diversion on June 14, departed today from Thiruvananthapuram International Airport. A UK engineering team, deployed since July 06 completed the repairs and safety checks, allowing the aircraft to resume active service," a British High Commission spokesperson said.

In a statement, the spokesperson said the UK remains very grateful for the support and collab-

throughout the repair and recovery process.

'We look forward to continuing to strengthen our defence partnership with India," the statement

The jet was brought out of the hangar and kept

at the airport bay on Monday. Sources said a 14-member team of engineers from the UK, who carried out repairs on the fighter jet, will depart on Wednesday aboard a special aircraft, the Globemaster.

They said the British jet was kept at the Air India hangar throughout its stay.

The British Royal Navy F-35B Lightning fighter jet is part of the UK's most advanced stealth fleet.

Known to be one of the most advanced fighter aircraft in the world and worth over USD 110 million, the jet remained grounded at the international airport here since June 14 after it developed a technical snag

The aircraft, which took off from HMS Prince of Wales on June 14, was unable to return to the carrier due to adverse weather conditions.

Prioritising safety, it diverted to Thiruvananthapuram International Airport, where it landed safely. Subsequently, the aircraft developed an ing to Rs 5 - Rs 6 lakh had been paid, there was engineering issue whilst on the ground, which temporarily delayed its return to the Carrier Strike

Engineers from HMS Prince of Wales assessed the aircraft and determined that the support of a UK-based engineering team was required.

The UK accepted India's offer to move the aircraft to the Maintenance, Repair and Overhaul

To ensure minimal disruption to regular airport operations, it was decided that the aircraft would be moved once the UK engineering teams arrived with specialist equipment.

The emergency landing by the British Royal Navy fighter jet at Thiruvananthapuram International Airport became the subject of countless memes, and even turned into a marketing opportunity for Kerala Tourism.

#### Govt slams 'double standards'

# LS adjourned for day as opposition protests demanding debate on SIR

NEW DELHI, July 22: The Lok Sabha was adjourned for the day on Tuesday due to protests by the opposition demanding a discussion on the ongoing voter roll revision in Bihar. even as the government accused them of practising "double standards" by asking for a debate on one hand and disrupting the House on the

Opposition members trooped to the Well of the Lok Sabha when the House reconvened at 2 pm after two earlier adjournments on the second day of the Monsoon session of Parliament demanding a discussion and roll back of the Special Intensive Revision (SIR) exercise initiated by the Election Commission in Bihar ahead of assembly polls scheduled for later this

Dilip Saikia, who was on the chair, made repeated requests to opposition MPs to go back to their places and allow the House to function.

As the protests continued, Parliamentary Affairs Minister Kiren Rijiju got up and condemned the opposition behaviour. He said it was agreed at the Business Advi-

sory Committee meeting on Monday that first Operation Sindoor will be taken up for discussion and the time for it had also been fixed. "Only the rule under which discussion will

take place will be decided. They come here carrying placards and violate the rules, I condemn this," Rijiju said. "They are asking for a debate and we are

ready for a debate but they are not allowing the House to function," he said, slamming the op-

These "double standards are wrong, on one hand they ask for debate and then create a

Rijiju said the government is ready but the opposition was wasting the time of Parliament. He condemned the behaviour of the Congress



Earlier, when the House re-convened at 12 noon, BJP member Jagdambika Pal, who was in the chair, urged the floor leaders of the opposition parties to ask their members to return

to their seats and allow the House to function. "The government is ready to discuss any issue which the Speaker allows as per the rules. I appeal to you to go back to your seats," Arjun Ram Meghwal, Minister of State for Parliamen-

Pal also urged opposition members not to show placards and instead give in writing their demands at the meetings of the Business Advisory Committee.

As ruckus continued, Pal adjourned proceedings till 2 PM.

When the House met at 11 am, opposition MPs, including Congress, were on their feet, demanding discussion on the revision of electoral rolls in Bihar and Operation Sindoor.

Agriculture Minister Shivraj Singh Chouhan appealed to the opposition members to go back to their seats so that the House can take up questions related to farmers during the designated time of Ouestion Hour.

Speaker Om Birla intervened and told the opposition MPs that sloganeering and showing placards lowered the dignity of the House. He ater adjourned the House till 12 noon.

The House could not function on the first day of the session on Monday due to repeated adjournments following opposition protests over the demand of discussion on Operation Sindoor. Under Operation Sindoor, armed forces at-

tacked Pakistani terror sites and defence installations for three days beginning May 7 following the Pahalgam terror attack on April 22 in which 26 people were killed. (PTI)

## Pahalgam massacre: With attackers at large, security concerns rise

#### Demand to fix accountability gains traction

PAHALGAM, July 22: Three months after the brutal terror attack in Pahalgam that left many tourists dead, the perpetrators are still at large, raising concerns over security lapses in the region and sparking growing calls for fixing accountability.

While the National Investigation Agency (NIA) has made two arrests in connection with the April 22 incident, those nabbed are believed to be the ones who provided logistical support, while the actual terrorists responsible for the ghastly crime have evaded security

The security vacuum has prompted Lt Governor Manoj Sinha, who will complete his five-year term next month, to take full responsibility for what he acknowledged as a "security failure"

This admission was appreciated by Chief Minister Omar Abdullah, who nonetheless called for accountability. "I appreciate the statement of the Lt Governor but an admission of failure must be followed by action," he had told PTI here recently.

"Heads must roll when such a grave mistake leads to the loss of precious lives. The people of Kashmir deserve to know what went wrong and who will be held accountable," the chief minister had said.

On April 22, a meticulously planned terror strike hit holiday-makers in Pahalgam meadows, killing 26 people -- 25 tourists and one local pony rider -- a huge setback for the counter-insurgency campaign of the

The strike was characteristic of careful planning and the terrorists' successful escape indicated a high level of training and local support.

The officials said that intelligence agencies had been alerted about the possibility of a terror attack, but the inputs were utilised at another place, some 90 kilometres away from the site where the attack took place, resulting in a key security lapse.

The NIA has been mandated to conduct the investigation and, so far, it has arrested two suspects who were suspected to have given shelter and food to the

The two men - Parvaiz Ahmad Jothar from Batkote, Pahalgam and Bashir Ahmad Jothar of Hill Park, Pahalgam – were arrested by NIA on June 22.

The NIA had said the arrested accused, who are presently on remand, have disclosed the identities of the three armed terrorists involved in the attack, and have also confirmed that they were Pakistani nationals affiliated to the proscribed The Resistance Front (TRF), a proxy of Pakistan-based terror outfit Lashkar-e-Taiba (LeT).

Parvaiz and Bashir had knowingly harboured the three armed terrorists at a seasonal dhok (hut) at Hill Park before the attack, according to NIA investiga-

The two men had provided food, shelter and logistical support to the terrorists, who had, on the fateful afternoon, selectively killed the tourists on the basis of their religious identity, making it one of the most gruesome terrorist attacks ever, the agency said.

CM Abdullah's demand for accountability of top officials is symptomatic of the public pressure building up to fix responsibility for security failure.

The incident has highlighted doubts over the efficiency of the security system in Kashmir and will probably be at the centre of public debate in the

Security officials said the terrorists, members of a TRF unit known as the "Falcon Squad," breached the Pahalgam area wearing military camouflage and equipped with military-grade firearms and modern communication equipment, including a camera-fitted

The attack was reportedly planned by Saifullah Kasuri alias Khalid, a top LeT commander and personal assistant of internationally designated terrorist Hafiz Saeed, they added. They indicated that the online trail of the attackers originated from safe houses along the border in Karachi and Muzaffarabad, which implied extensive logistical integration with the LeT network

They said that targeting tourists in Pahalgam represents a possible change in the operational policy of Kashmiri terror groups, indicating that the group is ready to target not only government staff and settlers but also civilian visitors under an overall strategy to destabilise the region, discourage tourists, and polarise

#### 'Prima facie' case of money laundering in Chanda Pahalgam's soul yearns for return of tourists Kochhar-Videocon case; ED order upheld

**NEW DELHI, July 22:** An appellate tribunal has said there was a "prima facie" case of money laundering against former ICICI Bank CEO and MD Chanda Kochhar and her husband in a corruption case involving the Videocon Group, as it upheld a 2020 ED order attaching a Mumbai flat of the couple worth crores of rupees. The tribunal, in an order issued on July 3, said it finds "substance" in the "quid pro quo" allegation made by the Enforcement Directorate against Chanda Kochhar for sanction of a loan of Rs 300 crore to Videocon International Electronics Ltd (VIEL), as post this disbursal, a sum of Rs 64 crore was transferred by the Videocon Group to NRPL, a company of her husband Deepak Kochhar.

The said loan was approved by a sanctioning committee of the ICICI Bank between June 2009 and October 2011, and Chanda Kochhar was a member of this panel, apart from being the MD and CEO of the private lending company.

The ED case, based on a CBI FIR, claimed that Chanda Kochhar hatched a "criminal conspiracy" to cheat ICICI Bank by "abusing" her official position while sanctioning this amount.

Chanda Kochhar, as per the probe agencies, got illegal gratification/undue benefit through her husband from VIL or Videocon Group promoter V N Dhoot. The ED had in January 2020 provisionally attached

Churchgate in Mumbai, a property of NRPL, apart from Rs 10.5 lakh in cash, seized by the agency during searches on another company of Deepak Kochhar.

The Adjudicating Authority of the Prevention of Money Laundering Act (PMLA) had in November 2020 refused to confirm the ED attachment, and consequently, the federal probe agency appealed before the appellate tribunal.

"It may be true that the issue will be determined by the Trial Court but we find a prima facie case against the respondents for commission of the offence of money laundering and, therefore, the Provisional Attachment Order (of the ED) is justified," the Tribunal said. It said there was "total inter-fixing of the work of the industries floated by Deepak Kochhar and even by the Videocon Group of Industries."

The tribunal rejected Chanda Kchhar's argument that she was "not knowing the business affairs of her husband" and had pleaded ignorance in her submission. The respondent (Chanda Kochhar) was expected to conduct herself as per the rules and policy of the bank and could not have pleaded ignorance about the association and affairs of the husband, it said in an 82page order. "...the sanction of a loan of ₹ 300 crore by ICICI Bank to the Videocon Group of Industries, where Chanda Kochhar remained part of the committee, was against the rules and policy of the bank," it

He said he hoped to see other nearby destinations,

but they remain closed as a precautionary measure. "I have been able to only visit Betab valley," he said, adding that the decision to visit this place was taken after he saw pictures of Chief Minister Omar Abdullah cycling on the roads of this town.

Pahalgam MLA Altaf Kaloo has been holding daily meetings with delegations associated with the tourism industry. "Rates have been brought down to ensure more tourists come back," he said.

"The government and the people, they're still trying to come out of the big shock. People are still wondering how and why it happened. Locals are in deep

shock. How it happened...," the MLA said on the April 22 massacre.

Terrorists had attacked holiday-makers in Pahalgam meadows, killing 26 people -- 25 tourists and one local pony rider. The horrific incident left the country shocked and outraged and triggered an India-Pakistan military conflict.

The collective trauma of the people was still felt in Kaloo's voice, but he quickly regained his composure and added, "All these delegations came to us. Tourists are very comfortable. We are keeping a bird's eye on the security of our guests and ensuring no stone is left unturned to keep them safe." He said this year, after a meeting with the Lt Governor Manoj Sinha and the chief minister, locals and tourists were allowed to come to Pahalgam. "This has helped a lot."

Asif Burza, Managing Director of Ahad Hotels and Resorts, says the revival has already started and visitors have started arriving. "There has been a big push from the government, and also the chief minister leading from the front has played a major role in the revival story. "There has also been a push from the Government of India with Union Tourism Minister Gajendra Shekhawat's help, and they are planning big events in the near future," Burza said.

Umesh Talashi, a minority community member staying in this area, said the April 22 attack left a scar on the heart of every peace loving citizen. (PTI)

#### NFR commissions **Automatic Block** Signalling between Aluabari and Panjipara HT Bureau GUWAHATI, July 22: In a signif-

icant step towards digital modernisation, the Northeast Frontier Railway (NFR) has commissioned Automatic Block Signalling (ABS) across a 22.9-km stretch between Aluabari, Gaisal, and Panjipara on This move is aimed at improv-

ing operational efficiency, reducing headway, and enhancing line

According to an official statement from NFR, the newly commissioned section comprises three stations—Aluabari Road, Gaisal, and Panjipara—along with three Auto Huts and 14 level crossing

As part of the upgrade, seven existing engineering level crossing gates have been interlocked with automatic signals, thereby boosting safety at crossings.

With this commissioning, NFR has now completed 87.57 route kilometres of ABS coverage from Ambari Falakata to Panjipara under its ongoing signalling modernisation programme.

The total sanctioned ABS project spans 702 km from Old Malda to Guwahati.

Earlier, the Aluabari-Ambari Falakata section (66 km) had been completed.

Upcoming phases include Panji-Malda, Ambari para–Old Falakata-Jalpaiguri, and New Coochbehar-Jorai, all targeted for execution during the 2025-26 fis-

Other segments are under active implementation.

The first train to operate on the newly signalled section was the 22301 UP Howrah–New Jalpaiguri Vande Bharat Express, which passed Panjipara at 13:40 hrs and Gaisal at 13:53 hrs.

This was followed by the 20503 DN Rajdhani Express, which crossed Aluabari at 14:05 hrs under the new signalling system.

NFR officials stated that the automation marks a major leap toward creating a safer, more efficient, and technologically advanced railway network across the region.

Artists find inspiration in S H Raza to turn scrap into sculptures duce local artists to new ways of creating art.

MANDLA (MP), July 22: All creation begins from a dot, a "bindu", a philosophy that is reflected in artist S H Raza's most famous artworks and has now become an inspiration for sculptor Narendra Kumar Dewangan who works with scrap metal to create sculptures.

"When you put a tack to connect two metal parts it is a point only that starts the creation of something new. So in a way, all our works are inspired by Raza," Dewangan told PTI as he welded another piece of metal to his work, titled "Environment Balancer".

The metallic sculpture, made with scrap of cars, bikes, and construction material, is one of the four being made here as part of Raza Smriti, a five-day multidisciplinary art camp organised by the Raza Foundation.

Raza, who died on July 23, 2016, was born in Mandla district of Madhya Pradesh in 1922. After spending his initial years in Mandla, he moved to different parts of the state with his father, a deputy forest ranger. Dewangan, a sculptor from Chhattisgarh, has created a city of metal that has at its centre a large tree to physically balance the tilted sculpture.

"I am showing a city that is both inside and outside the earth and there is a tree at the centre of it to balance it out. The tree is a symbol of how to balance the environment and at the same time how to find a way to coexist with nature," he said. Another artist from Chhattisgarh, Jee-



tendra Sahu, has also looked to nature for inspiration. His vision has come to reality in the shape of MP's state bird Dudhraj, or Indian paradise flycatcher.

With the petrol tank of a bike as the bird's body and metal sheets for its long tail, the sculpture is a tribute to the state that is known for its natural beauty and the many forest reserves.

"I like to do realistic works more. I saw Dudhraj here and found it to be too attractive, so I felt that with this I can represent the whole state," Sahu said. To match the bird's form, Sahu has used rebars, chain sprockets, paddings, chains, and different types of gears.

Speaking about the sculptors finding their expression through scrap material, Ashok Vajpeyi, poet and managing trustee of the Raza Founda-

"They have all collected these pieces which are picked up from shops here and they have been given the freedom to imagine what they would like to do so there are different kinds of things all of them are doing," Vajpeyi said.

"And what is interesting is in a manner of speaking the function of art is gathering up what is also broken down. The things here are broken down and not useful in the conventional sense but they can still be used in creating art, so there is this excitement of imagination getting embodied in material which never had been used for that purpose and was not intended to be used for that purpose," he added.

Amit Kumar Sinha, a sculptor from Jabalpur, has followed the inspiration of J Swaminathan and Raza in his work, combining elements of both the stalwarts - bindu from Raza, bird and mountain from Swaminathan.

"Swaminathan worked a lot with Gond artists to promote their art. And even though Raza spent very little time here, as he was settled in France, his journey of art in India is internationally renowned," he said. He added that since every art starts from a dot, the five circles in his work represent five dots.

The five-day event, which started on July 19, will come to an end on Wednesday. The completed sculptures will be placed at the Raza Art tion, said the objective of the camp is to intro-Gallery in Mandla. (PTI)

# Eviction drive carried out in Shillong in compliance with Meghalaya HC orders

Vendors with valid COVs can operate



SHILLONG, July 22: Shillong Municipal Board authorities on Tuesday carried out an eviction drive in the Khyndailad area here in compliance with the Meghalaya High Court's orders.

During the drive, the authorities confiscated goods and dismantled stalls of street vendors who were operating without valid certificates of vending (COV).

Acting on a state government directive that set a deadline (July 22) for all unauthorised vendors to vacate the area, the Shillong Municipal Board (SMB) officials had been verifying vending permits for the past few days.

Only those vendors who were able to produce valid COVs were allowed to continue operating. The rest had their stalls removed and materials seized," an SMB official at the site told PTI.

The action follows directions from the Meghalaya High Court, which had pulled up the state government and municipal authorities for failing to regulate street vending, especially in congested commercial zones such as the Khyndailad area, the city centre.

As part of its continuing oversight, the high court also appointed a special officer to monitor compliance and implementation of vend-

state-run university, Captain Williamson Sangma State University (CWSSU), has invited applications for postgraduate programmes for the academic session 2025-26, officials said on Tuesday. Various courses are being offered in the varsity's Tura and Shillong campuses, the University's Registrar, A Ch Marak, told PTI.

In the Tura campus, postgraduate programmes are available in Anthropology, Economics, Education, Environmental Science, Garo, Geography, History, Philosophy, Political Science and Sociology.

"The Shillong campus will offer postgraduate (PG) courses in Commerce, English, Khasi and Social Work, which are also simultaneously available at the Tura campus," he said. Established in 2011 through an Act of the

state government, CWSSU operates from its permanent campus in Tura.

The campus was constructed under Special Plan Assistance with an allocation of ₹



16.96 crore and completed in December 2022. With academic blocks, hostels, and administrative facilities, the campus has an The University Grants Commission

The university is recognised under Section 2(f) of the UGC Act, 1956, and is empowered to award degrees independently.

(UGC) formally approved its degree-awarding status in December 2024. The institution began academic operations this year, with the Shillong campus set to open shortly.

Admissions to CWSSU's PG programmes do not require the Common University Entrance Test (CUET), making the university an attractive option for students

At least 11 colleges from across the state have been granted affiliation with the University. These colleges also admit students without CUET, unlike those under NEHU, which are bound by the CUET requirement as per NEP 2020.

According to official sources, admissions to the PG courses will remain open for at least two to three weeks, and the application procedures and course details are available on the university's website.

CWSSU's launch is seen as a significant milestone in Meghalaya's higher education sector, enhancing access and offering flexible admission pathways for students. (PTI)

## MNF MLA Lalrintluanga Sailo's body brought Meghalaya minister asks MLAs, MPs to Aizawl from Delhi, last rites tomorrow

AIZAWL, July 22: The mortal remains of Mizo National Front (MNF) MLA Lalrintluanga Sailo, who died at a hospital in Delhi, were brought to Aizawl on Tuesday afternoon.

"The body of the two-time legislator from Dampa arrived at the Lengpui airport around 1.30 pm, and will reach his home at Luangmual neighbourhood in the western part of Aizawl in the evening," they said.

His funeral will be held on Wednesday, leaders of the Luangmual unit of Young Mizo Association (YMA) said.

Sailo, whose performance as opposition member in the assembly was praised by many, died at Max Superspeciality Hospital in Delhi around 9 pm on Monday after battling with complicated ailments, including scrub typhus and pneumonia, for nearly a month. The 65-year-old MNF leader was flown to Delhi on June 29 following a fever.

Although he initially showed signs of improvement, his condition deteriorated a few days ago and became worse on Sunday, following which he was put on ventilator support, family sources said. Born in 1960, Sailo joined MNF and went underground when he was only 16.

He actively took part in the secessionist movement, spearheaded by the MNF led by late Laldenga, for 20 years till the underground group signed the historic Mizo peace accord with the Centre in

He contested the assembly polls in 2018 and got elected from Dampa in Mamit district, defeating his nearest opponent, Congress nominee Lalrobiaka, by a margin of 1,657 votes.

He was re-elected from the same constituency in the last assembly polls, held in November

Sailo held many important posts in the MNF and was a member of the national core committee of the party till his last breath.

The MNF described Sailo's death as 'the collapse of one of the big pillars of the party'

Governor VK Singh, Chief Minister Lalduhoma and state Congress president Lal Thanzara mourned his death.

SHILLONG, July 22: With the Meghalaya government launching a massive drive to upgrade school infrastructure, Education Minister Rakkam A Sangma on Tuesday said that the state-run efforts alone are not enough and urged all 60 MLAs and two MPs to contribute to the endeav-

Leading by example, Sangma claimed he had renovated 45 schools in his Rongara-Siju constituency in South Garo Hills district, using ₹ 2 lakh per school from MLA scheme

"If each MLA takes care of 50 schools per year, we can make real change in infrastructure," he said, urging other public representatives, including members of district councils, to work towards meaningful de-

f pointing fingers, let's come together and build," he added. Each legislator in Meghalaya receives an annual allocation of ₹ 2.5 crore under the MLA Local Area Development Scheme (MLA-LADS), meant for infrastructure and development work within their constituencies, officials said. "These discretionary funds can be utilised for a wide range of purposes, including school repairs, water supply, rural roads, and health infrastructure," they said.

Notably, the state government, under its Mission Education programme, has launched a large-scale initiative to repair and upgrade over 2,000 government schools within the next two years. This includes lower and upper primary, secondary, and higher secondary institutions.

"In the current year alone, an amount of ₹ 100 crore has been sanctioned for upgrading 200 government lower primary (LP) schools, with an additional 300 such institutes identified for future improvements," the officials said. "Nearly 90 per cent of these schools have already undergone or are un-

dergoing renovation, with around 100-200 still pending sanction", they

In total, 1,608 schools have been taken up under the programme, with most nearing completion, one of the officials said.

"However, there are some schools in Mawsynram, Mylliem, and Khliehriat areas, which are still awaiting implementation," he said.

Funding sources for the renovations include Sama government allocations, and contributions from the development funds of MLAs, MPs, and MDCs.

"Recently, ₹ 33.80 crore was sanctioned for the construction and renovation of 19 upper primary and secondary schools to improve classrooms, sanitation facilities, electrification and quarters," another official said. Sangma's appeal for shared responsibility is being viewed as a push for a collaborative approach to strengthen Meghalaya's school infrastructure and ensure a better learning environment for students across the state. (PTI)

## Naga bodies' ultimatum

IMPHAL, July 22: The United Naga Council (UNC), the Naga Women Union (NWU), the All Naga Students' Association, Manipur (ANSAM) and the Naga People's Movement for Human Rights-South (NPMHR-S) have served a 20-day ultimatum jointly to the central government today in connection with the the abrogation of Free Movement Regime (FMR) and the ongoing border fencing construction in 'Naga ancestral homeland'. The ultimatum gave 20 days' time to the central government to address the issues. These Naga organisations have been stiffly opposing the scrapping of the FMR and the border fencing construction in 'Naga homeland'.

"Should the demands remain unaddressed from the date of this ultimatum, we shall be compelled to resume our protest movement in stronger measure across all the Naga hill districts," it cautioned. The joint ultimatum of these Naga bodies addressed to Prime Minister Narendra Modi, Union Home minister Amit Shah, External Affairs minister S. Jaishankarand and Union Defence minister Rajnath Singh was submitted through the Governor of Manipur today.

The joint ultimatum of these Naga organisations said, "We submit this ultimatum with deep concern and anguish, expressing our strong resentment against abrogation of the Free Movement Regime (FMR) along the imaginary Indo-Myanmar border and the accelerated ongoing border fencing construction across the ancestral Naga homeland without due consultation with the affected indigenous communities and violating the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP) particularly Articles 8, 26, and 36 thereof, endorsed by India".

They also placed on record that considerable numbers of press statements have been issued, picketing of government offices in 'Naga areas' have been undertaken, public demonstration of protest and rallies were held in Naga hill districts and memoranda submitted to register our stiff opposition to the abrogation of the FMR and construction of the border fencing across the Naga ancestral homeland. One of the references includes a memorandum submitted to the Union Home Minister. Government of India, on January 19, 2024 through the Deputy Commissioner, Senapati district by the UNC. Another reference is a memorandum submitted to the Union Home Minister of India through the Governor of Manipur on February 1, 2025 by the ANSAM. A rally at Chandel district was held and a memorandum submitted to the Prime Minister of India on February 12, 2025 through the Deputy Commissioner by Chandel Naga People's Organization (CNPO), NSUC and Naga Chief Association, Chandel. A rally at Kamjong was also held and a memorandum submitted to the Governor of Manipur on February 21, 2025 by the Tangkhul Naga Zingsho Longphang.

"All associate professors and statutory posts officers will be brought under the biometric attendance system from October 31, while the professors will be included later," it said.

"All concerned are requested to register their personal details, including

mobile number and Aadhaar, on the portal by themselves or to contact the nodal officer, Tripura University, for onboarding," it reads. "The biometric attendance for non-teaching staff (Group B&C) was introduced earlier, and now this will be done for teaching staff and other

"You guys are the loudest," he had told the audience that night, but it now appears that the sentiment was more than a polite compliment. The British artist's affection for the city did not end with the performance.


Shillong featured prominently in his music video for the chart-topping single 'Sapphire',



Roshan, who is the father of Bollywood superstar Hrithik Roshan, said above the age of 45, everyone should get regular scans such as a heart CT and a carotid brain artery sonography which are "often ignored completely"

He was imprisoned three years ago and went on a hunger strike. Despite obstacles, Panahi has continued to make films be it "This Is Not a Film", which he made in his living room while under house arrest or "Taxi", which was set in a car. "As a towering figure in Iranian cinema, the director has explored the existence and freedom of individuals living amid censorship and political repression. Capturing the political and social contradictions of Iranian society from a countercultural perspective, he has continued to create films in secret, courageously submit-

ting them to international film festivals despite repeated arrests, custody, detention, travel bans, and a stated-imposed filmmaking ban," BIFF said in their release

"At a time when making films in my country becomes more difficult every day, this recognition reminds me that cinema can still connect us beyond borders, languages, and limitations. I not only accept this award in my own name, but also on behalf of all those who, in silence, in exile, or under pressure, continue to create," Panahi said in his statement to the festi-

The filmmaker's "It was Just an Accident" won the top prize at the Cannes Film Festival in May this year. Panahi won Venice festival's Golden Lion for "The Circle" in 2002 and the Golden Bear at the Berlin film festival for "Taxi" in 2015.

The filmmaker's accomplishments also include Locarno's Golden Leopard for "The Mirror" in 1997 and Cannes' screenplay prize for "3 Faces" in 2018.

Panahi will be receiving the award at the festival's opening ceremony, scheduled on September 17. The festival will run till September



# DURAND CUP KICKS OFF AMID UNCERTAINTY IN INDIAN FOOTBAI

edition of Durand Cup kicks off here Wednesday with East Bengal facing South United FC amid a cloud of uncertainty surrounding the upcoming top-tier domestic football season. In the midst of this impasse, the Durand Cup has retained its significance as the traditional curtain-raiser for Indian football.

The competition continues to draw a full roster of 24 teams despite only six ISL clubs confirming participation this year.

The spotlight on Wednesday will

Determined to turn around their fortunes after a forgettable 2024-25 campaign, where they finished ninth in the ISL, made an early Super Cup exit, and bowed out of the AFC Challenge League in the quarterfinals, the Kolkata giants have rung in major changes under Spanish coach Oscar Bruzon.

Key signings include Brazilian midfielder Miguel Figueira, Argentine defender Kevin Sibille, and Palestinian international Mohammed Rashid.

They join full-back Jay Gupta, who completed a multi-year move from FC Goa after a successful stint

## Four days to departure, wrestlers yet to get appointment for visas ahead of U17 World C'ship

"The Federation had to seek intervention of the MEA and the Home Ministry after its numerous requests did not receive a positive response from the Greece embassy," WFI President Sanjay Singh told PTI.

"The tickets have been booked and the players are ready. The exposure for young athletes is paramount for their growth. They must not miss the World Championship. It's Tuesday today, let's hope we get a response now," he added.

"In the past we have got visas from the Greece embassy in a matter of four days but this time there is an inexplicable delay."

Even the world governing body United World Wrestling (UWW) President Nenad Lalovic has shot a missive to the Hellenic Olympic Committee, requesting urgent intervention in the matter.

"Unfortunately, some of the qualified and registered teams including the Iranian and Indian delegations — have encountered difficulties and delays in obtaining their Schengen visas," Lalovic

"Despite having followed the application procedures correctly, these teams have not yet received their visas. I would therefore be most grateful for your support in facilitating this process with the relevant authorities, to ensure that all participating athletes and officials are able to obtain their visas in time," the letter read.

A note on the Greece embassy website reads: "Kindly be informed that due to the current situation the processing time of the visa applications is 15 working days, as per instructions of the Greek Embassy in New Delhi, and may be extended."

Explaining the visa procedure further, the website mentions that it may take more than 15 days to process the visa applications.

# We are not going to take a backward step and let opposition be confrontational: Stokes

MANCHESTER, July 22: England captain Ben Stokes on Tuesday asserted that his team will respond in kind to any aggression from Indian players in the fourth Test starting here from Wednesday, indicating no cessation to the verbal volleys in an intensely fought

England lead the five-match series 2-1, but players such India skipper Shubman Gill, Mohammed Siraj, Zak Crawley, Ben Duckett, Stokes and Harry Brook were not averse to having some animated conversations with the opposition players.

"I don't think it's one of those things where we're going to necessarily just go out and start at (sledging). I don't think either team's really looked to do that. I think there's always going to be a moment in a Test series where something does heat up. It's a massive series and there's a lot of pressure on both teams to perform," Stokes said on the eve of the match at Old Trafford.

It might have been an organic reaction to a particular situation, but Stokes hinted clearly that aggression from the rival camp will not be taken lightly.

"As I said, it's not something that we're going to purposely go out and look to start because then that will take our focus off what we actually need to do out in the middle. But by no means, we're not going to take a backward step and let any opposition try to be confrontational towards us.

"And not try to give a bit back. I think that goes for most teams, to be honest anyway. So, it's not like we're the only team who does that. But the series has been great to play. It has been great to watch. All five days, all three Tests so far. Quality of cricket has been outstanding," he added.

The proceedings heated up during the third day of the third Test at the Lord's when Crawley and Duckett successfully employed some delaying tactics, inviting angry reactions from Siraj and Gill.

Gill had pointed his fingers at Duckett, which resulted in a similar reaction from the England opener. Stokes vindicated the whole episode. "Obviously, that night (at the

Lord's) when Zak and Ben had to go out just started it off. We had the advantage of bowling last in the Test match to win." "We just threw everything that

we possibly could at India, not only with our skills, but also with their energy in the field as well," he Stokes admitted that the aggres-

sion from the Indian players added some adrenalin into his side. "Harry Brooks said, Brendan McCullum said, you guys have

been too nice. Do you agree? Yeah, I think potentially. I guess it was a really nice moment, I think, as a team when you speak about something like that and everyone buys into that (replying to aggressive tactics by the opposition)," said the premier all-rounder.

While India are in a must-win situation, England are in the driver's seat having taken the series lead at Lord's, and they will be keen to claim the rubber at a venue where the Indian team hasn't played a Test since 2014.

"Good win for us at Lord's. Nice break. Hope we continue the momentum and put in the same effort and energy," Stokes said.

MANCHESTER, July 22: An injuryplagued India could be forced to depart from its preferred template when it takes on a reinvigorated England in the fourth Test starting here on Wednesday, hoping to end a winless record at the storied Old Trafford and draw level in what has been a compelling series so far.

Following the first Test in Leeds, India had found a settled line-up by fielding three all-rounders in the playing eleven including Nitish Reddy, who has now been ruled of the series due to a knee in-

With Ravindra Jadeja and Washington Sundar being the two spin bowling allrounders, India had the cushion of batting till number eight but that may not be the case in Manchester, where the visitors are yet to win in nine attempts including four losses and five draws. England are leading 2-1 going into the penultimate game

Shardul Thakur, who played the seriesopener, would be the direct replacement for Reddy in the playing eleven but he doesn't provide the same batting quality. If selected, he would have to up his game with the ball too as Reddy had produced timely wickets in the third Test at Lord's. Considering the options available, India could also go back to the combination they played at Leeds where they had only one spinner in Jadeja and there were specialist batters till number six with both Karun Nair and Sai Sudharsan in the playing eleven.

Also in the mix are uncapped pacer Anshul Kamboj and Prasidh Krishna. Either of them can come in for Akash Deep if he is not able to recover fully from his

Like Akash Deep, Kamboj can generate plenty of seam movement and he also looked in good shape in the first outdoor training session ahead of the high-stakes contest. He was also a part of India A's shadow tour of England

Pace spearhead Jasprit Bumrah and workhorse Mohammed Siraj are two certain starters in the playing eleven.

Lord's was the first time in the series that Indian batters faltered and the Shubman Gill-led line-up would be looking to course correct with all to play for.

Despite low returns in the third Test, Gill has aggregated more than 600 runs in the series and from the team's point of



view, he would need to return to his heavy scoring ways.

Jofra Archer got the better of Yashasvi Jaiswal twice in his successful return to Test cricket and the young Indian lefthander would be better prepared to deal with the extra pace of the England fast

Gill has been the team's leading run

assured in the middle across six innings is K L Rahul, having provided a batting masterclass in English conditions at the top of the order.

Considering the training session 48 hours before the game, Rishabh Pant appears to have fully recovered from his finger injury and would be performing his dual duties as usual.

## Shastri backs Washington as India's next long-term all-rounder Governance Bill: Sports Ministry source



MANCHESTER, July 22: Former head coach Ravi Shastri believes Washington Sundar has all the attributes to become India's next "genuine" Test all-rounder, as he is lethal with the ball in home conditions and is also a naturally gifted batter.

The 25-year-old off-spinner, who made a memorable Test debut at the Gabba in 2021, has since had limited red-ball opportunities. In 11 Tests, Washington has amassed 545 runs and taken 30 wickets.

"I always loved Washington. When I saw him on day one, I said he's the man. And he can be a genuine all-rounder for many, many years for India," Shastri said on The ICC Review.

Shastri feels Washington's redball appearances should have been more, especially given his proven ability on turning tracks

"He again is just 25 years of age. I think he should have played a lot more Test cricket. Can be lethal in India on tracks where the ball is turning, as New Zealand found out when they played against India. He out-bowled some of the senior spinners. He bowled that well and

Washington was the joint highest wicket-taker in the 2024 home Test series against New Zealand, finishing with 16 wickets in four innings.

Shastri, who oversaw Washington's Test debut, also heaped praise on his batting ability, suggesting the Tamil Nadu player was good enough to be promoted up the

"He's a naturally talented batsman. He's no number 8. He can go at 6 very soon in the batting lineup.

In the ongoing England series, Washington has made key contributions with both bat and ball. At Lord's, his 4/22 in the second innings, including the prized scalps of Joe Root, Ben Stokes and Jamie Smith, had swung the match in India's favour.

Shastri added that Washington's technical attributes make him an asset even in overseas conditions.

"And once he gains confidence, I think he'll get better and better because even overseas he's got the drift, he's got the pace, he's got the strength in his fingers and the fitness. You know, do both long spells and do the controlling job when needed." (PTI)

NEW DELHI, July 22: The BCCI will come under the purview of the National Sports Governance Bill that is set to be introduced in Parliament on Wednesday and will be required to take recognition from the proposed National Sports Board even though it is not reliant on government funding.

This was revealed by a top Sports Ministry source on Tuesday.

"Like all National Sports federations (NSFs), the BCCI will have to comply with the law of the land once this Bill becomes an Act. They don't take ministry funding but an Act of Parliament applies to them," the source said.

"They will remain an autonomous body like all other NSFs but their disputes, if any, will also come to the proposed National Sports Tribunal which will become the dispute resolution body for sports matter ranging from elections to selection," the source added.

"However, this Bill does not mean government control on any NSF. Government will be a facilitator in ensuring good governance, not an enforcer. The BCCI has become a part of

the Olympic movement after cricket was included in the 2028 Los Angeles Games where it will be played in the T20 format. The long-awaited Sports Gover-

nance Bill seeks to institutionalise a strong framework for timely elections, administrative accountability, athlete welfare and reduction in litigation through a slew of measures.

The National Sports Board (NSB), appointed entirely by the central government, will have sweeping powers to grant and even suspend recognition of federations based on complaints or "its own motion" for violations ranging from

electoral irregularities to financial misappropriation.

The Bill makes some concessions on the thorny issue of age cap of administrators by allowing those in the bracket of 70 to 75 to contest elections if the concerned international bodies do not object. In electoral matters, the Bill will accept the "supremacy" of the Olympic Charter and the statutes of the International Federations.

The proposed NSB will comprise a chairperson, and its members will be appointed by the central government from "amongst persons of ability, integrity and standing."

The appointments would be done based on the recommendations of a search-cum-selection committee. according to the Bill that has been finalised after extensive consultations with stake-holders and public

The selection committee would be made up of the Cabinet Secretary or Secretary Sports as chairperson, the Director General of the Sports Authority of India, two sports administrators who have each served as the President or Secretary General or Treasurer of a National Sports Body and one eminent sportsperson who is a Dronacharya, or Khel Ratna or Arjuna awardee.

'This is an athlete-centric Bill which will ensure stable administration, fair selection, safe sports and grievance redressal, NSF audits, proper accounting and better fund management," the ministry source asserted.

'The National Sports Tribunal will ensure that there is no career damage to athletes due to delayed court cases. Even now 350 different court cases are in progress where the ministry is a party, this needs to end," he added.

As was mentioned in the draft released last year, the Board will have the power to grant recognition to NSFs and even constitute ad-hoc panels to run individual sports in case an NSF is suspended.

It would also be mandated to "collaborate" with the International Sports Bodies for welfare of athletes in India and to issue guidelines to NSFs for ensuring compliance with international standards.

All these duties have so far been the domain of the IOA, which acted as the nodal body for NSF-related

"I absolutely adore Jasprit Bumrah, I absolutely love his skills. He is outstanding. However, I believe that when you play for India, you have to give it

spell, when Root comes, you are not bowling the sixth over. You have to give it all. Either you give everything or you rest properly," Pathan said on his Youtube channel.
