

Cabinet approves ₹1.07 lakh cr Employment Linked Incentive scheme 3.5 cr jobs to be created in two years

government on Tuesday approved an Employment Linked Incentive scheme with an outlay of ₹ 1.07 lakh crore to create 3.5 crore jobs over the next two years through social security schemes run by the retirement fund body EPFO.

The ELI scheme to support job generation, enhance employability and social security across all sectors, with special focus on the manufacturing sector, was approved by the Union Cabinet in a meeting, chaired by Prime Minister Narendra Modi, Information & Broad-Minister Ashwini casting Vaishnaw said.

The scheme aims to incentivise the creation of more than 3.5 crore jobs in the country over two years, an official statement said.

The scheme will provide incentives to employees as well as employers to boost job creation.

Under the scheme, while the first-time employees will get one month's wage (up to ₹15,000), the employers will be given incentives

133 arrested for illegal cattle slaughter, selling beef

Drive aimed at stopping violation of the Assam Cattle Preservation Act: Assam Police

GUWAHATI, July 1: At least 133 people were apprehended on Tuesday for their role in alleged violation of the Assam Cattle Preservation Act and over one tonne of suspected beef were seized across the state, a senior police officer said.

According to Inspector General Police (Law and Order) Akhilesh Kumar Singh, a suo-motu drive was initiated across the state to check reported incidents of illegal cattle slaughter and selling of beef in restaurants unauthorisedly.

Consumption of beef is not illegal in Assam, but The Assam Cattle Preservation Act, 2021, bans slaughter and sale of beef in areas where Hindus, Jains and Sikhs are in majority and in areas which fall within a five-km radius of a temple or satra (Vaishnavite monastery).

'The main intention of the drive is to stop violation of The Assam Cattle Preservation Act. We raided hotels and restaurants, registered dozens of cases at many police stations (CONTD. ON PAGE-2)

The ELI scheme aims to incentivise the creation of more than 3.5 crore jobs in the country over a period of 2 years, it stated. Out of these, 1.92 crore benefi-

The benefits of the five schemes to facilitate employscheme would be applicable to jobs created between August 1, ties for 4.1 crore youth with a total 2025, and July 31, 2027. The plan consists of two parts,

with Part A focused on first timers (employees) and Part B focused on employers.

Targeting first-time employees registered with EPFO, this Part A will offer a one-month wage up to ₹15,000 in two instalments. Émployees with salaries up to ₹ 1 lakh will be eligible. The first instalment will be payable after 6 months of service, and the second instalment after 12 months of service and completion of a financial literacy programme by the employee.

"To encourage the habit of saving, a portion of the incentive will be kept in a savings instrument or deposit account for a fixed period and can be withdrawn by the employee at a later date. Part A will benefit around 1.92 crore first-time employees," the statement said. Part B of the scheme will cover

the generation of additional employment in all sectors, with a special focus on the manufacturing sector. The employers will get incentives with respect to employees with salaries up to ₹ 1 lakh.

The government will incentivise employers, up to ₹ 3,000 per month, for two years, for each additional employee with sustained employment for at least six months. For the manufacturing sector, incentives will be extended to the 3rd and 4th years as well.

Establishments, which are registered with EPFO, will be required to hire at least two additional employees (for employers with less than 50 employees) or five additional employees (for employers with 50 or more employees) on a sustained basis for at least six months.

The benefit to the employer (per additional employment per month) will be up to ₹ 1,000 for employees with a monthly wage of ₹10,000, while this will be ₹ 2,000 for employees with wages of more than ₹ 10,000 and up to ₹ 20,000. Employees with wages up to ₹ 10,000 will get a proportional incentive. The benefit will be ₹ 3,000 per month to the employers for employees (CONTD. ON PAGE-2)

Himanta claims record paddy

GUWAHATI, July 1: Chief Minister Himanta Biswa Sarma on Tuesday said the state has recorded the highest-ever paddy procurement by purchasing nearly seven lakh metric tonnes of the foodgrain, more than twofold jump as compared to the previous season.

"We are proud to announce the successful conclusion of Kharif Marketing Season (KMS) 2024-25 with a record paddy procurement of 6.97 lakh MT -- the highest ever!" Sarma said in a post on X.

The state had procured just 3.14 lakh MT during the 2023-24 KMS, he added.

In KMS 2022-23, the paddy procurement had stood at 5.92 lakh MT, the CM said.

"This remarkable achievement reflects our commitment to ensuring that our farmers are connected to markets and the Minimum Support Price (MSP) they rightfully deserve," Sarma said.

Last month, the chief minister said the state had set a target of procuring 5,85,500 MT of paddy during the 2024-25 KMS.

Sarma also said that Assam's agricultural products are catering to the global market due to their high quality and nutrient-rich content.

"Recently, farmers from Majuli expanded their reach to Middle East and EU markets as they exported 267 MT of Red Rice -- earning higher profits & establishing Brand Assam," he said in a separate post.

The red rice was produced originally in over 1,000 hectares of land in Majuli, the world's largest river island and located in the Brahmaputra, the CM said. (PTI)

DIPHU, July 1: Executive Member of the Karbi Anglong Autonomous Council (KAAC), in charge of Animal Husbandry and Veterinary Department, D Uphing Maslai visited the border villages of Tapat and Khanduli in West Karbi Anglong on Tuesday, following an incident in which a mob allegedly entered from Meghalaya and uprooted saplings and dismantled protective wooden structures erected for plantation work in Tapat.

The incident occurred on June 25 and has since triggered tension along the inter-state border area.

In response, the KAAC EM undertook a field visit to assess the situation, meet with local residents, and appeal for calm.

During his visit, Maslai interacted with village headmen and residents of the affected areas and assured them of continued support from the KAAC.

"As people were tense, I made up my mind to visit the affected places at Tapat and Khanduli, which is the most extreme village of West der. There was a plantation in Tapat and on June 25, a mob from Meghalaya entered and uprooted the plants. Following the incident, tension has mounted in the area," he said.

To provide immediate relief to the residents, rice was distributed among the villagers. Additionally, torchlights were handed over

Reassuring the communities of Tapat, Khanduli and Langkeroi, the EM informed them that Chief Executive Member of KAAC. Maslai was accompanied by Chairman of the Border Development Board, Augustin Hanse, and other officials during the visit. The KAAC leadership reiterated its appeal

for peace and cooperation among communities while urging authorities to maintain vigilance along the sensitive border belt.

NEW DELHI, July 1: Hectic negotiations between India and the US will enter the sixth day on Tuesday in Washington, with the talks reaching a crucial stage and New Delhi demanding greater market access for its labour-intensive goods, an official said.

The Indian team, headed by special secretary in the Department of Commerce Rajesh Agrawal, is in Washington for negotiations on an interim trade agreement with the US.

The stay of the Indian officials has been extended. Initially, the delegation was scheduled to stay for two days, with the talks having commenced on June 26.

These talks are also important as the suspension date of Trump's reciprocal tariffs is approaching. It will end on July 9. The two sides are looking at finalising the talks before that, the official said.

India has hardened its position on giving duty concessions to American farm products. It is seeking duty concessions

for its labour-intensive goods such as textiles, engineering, leather, gems and jewellery. "If the proposed trade talks fail, the 26 per cent tariffs will come into force again," the official added.

On April 2, the US imposed an additional 26 per cent reciprocal tariff on Indian goods but suspended it for 90 days. However, the 10 per cent baseline tariff imposed by America remains in place. India is seeking full exemption from the additional 26 per cent tariff.

The US is demanding duty concessions in both the agriculture and dairy sectors. But these segments are difficult and challenging areas for India to give duty concessions to the US as Indian farmers are into sustenance farming and have small land holdings.

Therefore, these sectors are politically very sensitive. India has not opened up the dairy sector for any of its trading partners in free trade pacts the country has signed so far. (CONTD. ON PAGE-2)

CEM Ronghang reviews ration card distribution plans

DIPHU, July 1: A key review meeting on the constituency-wise launch of Ration Card distribution was held on Tuesday at the conference hall of the Arboretum Centre in Diphu.

NEW YORK, July 1: External Affairs Minister S Jaishankar has said

relationship is defined by its stance on China. "I think it's a very gross oversimplification to make India-US about China. In fact, it's not just an oversimplification. I think it's even misleading at times," Jaishankar said on Monday during a conversation with Newsweek CEO Dev Pragad at the publication's headquarters at One World Trade Centre near the 9/11 Memorial in Manhattan.

He said that the India-US relationship is about "so many other things," noting the large Indian community, which contributes significantly to the US. "I think it's been a game-changer. It has got nothing to do with China," he said.

He stressed that Washington and Delhi have a very strong economic connect. "Look at our trade numbers and look at the relevance of that trade to our respective economies. Look at our technology connect," he said, adding that there is a tendency to point even the defence or security cooperation towards China, but "I ask you to look at the other coast. We work to keep the Arabian Sea safe for global shipping.

"This is (an) age of oversimplification. I urge you not to fall into that. I think the world is much more nuanced. It's much more multi-causal. We have many more interests than just one country. I would certainly like to believe that the relationship is going well because there is great merit in me," Jaishankar said. He added that there are certain realities of the landscape, and one of them is that the relationship between the US and China is not what it used to be, it has acquired a much sharper competitive edge. "Frankly, where we are concerned, we look at these two countries, and each one of them has made up its mind (CONTD. ON PAGE-2)

NEW DELHI, July 1: Gross GST collections increased by 6.2 per cent to over ₹ 1.84 lakh crore in June but slipped below the \mathbf{E} lakh crore mark recorded in the previous two months.

Gross GST collections stood at ₹1,73,813 crore a year ago, as per government data released on Tuesday. In May, the Goods and Services Tax (GST) collection was ₹ 2.01 lakh crore. It touched a record high of ₹ 2.37 lakh crore in April this year.

In June, gross revenues from domestic transactions rose 4.6 per cent to about ₹ 1.38 lakh crore, while GST revenue from imports grew 11.4 per cent to ₹ 45,690 crore. The gross Central GST revenues stood at ₹ 34,558 crore, State GST revenues at ₹ 43,268 crore and Integrated GST at about ₹ 93,280 lakh crore in June. Revenues from Cess were ₹ 13,491 crore.

NEW DELHI, July 1: Tractors and Farm Equipment Ltd (TAFE) and AGCO Corporation on Tuesday announced a comprehensive out-of-court settlement of all outstanding disputes, with the Indian firm agreeing to buy out the US-based firm's shareholding in it for USD 260 million (nearly ₹2,225 crore).

In separate statements, the two companies said they have settled all matters relating to the Massey Ferguson brand, commercial issues and shareholding, thus ending their corporate feud.

Under the settlement, ownership of the Massey Ferguson brand will rest with TAFE as the sole and exclusive owner for India, Nepal and Bhutan. TAFE said it will hold all rights, title and interest in "Massey Ferguson" and related trademarks and all goodwill assoiated therewith.

Besides, TAFE will buy back AGCO's shares in itself, which amounts to 20.7 per cent of the domestic tractor maker's equity, for a consideration of USD 260 million, making TAFE a wholly-owned subsidiary of the Amalgamations Group, a diversified industrial conglomerate, headquartered in Chennai, it added.

TAFE will also retain its shareholding in AGCO at an ownership level of 16.3 per cent and not exceed it, while participating in AGCO's future buyback programs to maintain its proportionate ownership subject to certain exceptions, it stated.

As part of the settlement, TAFE will support AGCO by voting its shares in favour of all the recommendations of AGCO's Board of Directors at shareholder meetings, subject to certain exemptions, the Chennaibased firm said.

Besides, TAFE will remain a long-term investor in AGCO, it added. While all commercial agreements between TAFE and AGCO will be mutually terminated, TAFE will honour outstanding supply orders and continue to supply parts for all markets on agreed terms, it stated. AGCO, in its statement, said, "Parties have agreed to mutual non-disparagement and TAFE not engaging in public activism.

TAFE will no longer be entitled to nominate a representative to the AGCO Board of Directors and AGCO's Director on TAFE's Board will step down." The two companies said their agreements will become effective upon the completion by AGCO and TAFE of certain governmental and other processes in India relating to the repurchase of the shares held by AGCO in TAFE.

"As we step into a new era in TAFE's growth story, we recognise and cherish the long partnership we've had with AGCO, and continue to support AGCO as an engaged shareholder," TAFE Chairman & Managing Director Mallika Srinivasan said.

Stating that TAFE and Massey Ferguson have been synonymous in the minds of the Indian customers for over 65 years, she said, "We re-dedicate our commitment to transformation of Indian agriculture through our innovative products, solutions and service to the farming community in India." AGCO Chairman, President and CEO Eric Hansotia welcomed the reaching of an amicable resolution with TAFE on all outstanding commercial, governance and shareholding mat-

"We appreciate the TAFE relationship for its years as a commercial partner and continued support as a shareholder. AGCO's Board and management team are fully focused on our Farmer-First strategy, which we believe will improve outcomes for farmers, drive operational success for our company and deliver strong returns for shareholders," Hansotia said.

AGCO said it will file the agreements with the US Securities and Exchange Commission.

Last year in September, AGCO Corporation terminated multiple agreements with TAFE, including the Massey Ferguson brand license agreement, a distributor agreement for India, Nepal, and Bhutan.

Subsequently, a legal battle followed with TAFE taking the matter to the Madras High Court. (PTI)

Talks on India-US trade pact

The US wants duty concessions on certain industrial goods, automobiles, especially electric vehicles, wines, petrochemical products, dairy, and agricultural items like apples, tree nuts, and genetically modified crops.

India is seeking duty concessions for labour-intensive sectors like textiles, gems and jewellery, leather goods, garments, plastics, chemicals, shrimp, oil seeds, grapes, and bananas in the proposed trade pact.

The two countries are also looking to conclude talks for the first tranche of the proposed bilateral trade agreement (BTA) by fall (September-October) this year. The pact is aimed at more than doubling bilateral trade to USD 500 billion by 2030 from the current USD 191 billion.

Before the first tranche, they are trying for an interim trade pact. The US team was here from June 5 to June 11 for the talks. The negotiations will continue both virtually and physically in the days to come

India's merchandise exports to the US rose by 21.78 per cent to USD 17.25 billion in April-May this fiscal, while imports rose by 25.8 per cent to USD 8.87 billion. (PTI)

CCI orders probe into market abuse charges against Asian Paints

Ather's foray into the family

NEW DELHI, July 1: The Competition Commission of India (CCI) on Tuesday ordered an investigation against Asian Paints for allegedly abusing its dominant position in the market for manufacturing and sale of decorative paints.

The direction follows a complaint filed by Grasim Industries (Birla Paints Division), which accused Asian Paints of engaging in exclusionary practices aimed at stifling its entry and growth in the Indian decorative paints segment.

"The Commission is of the opinion that a prima facie case of contravention of the provisions of section 4(2)(a)(i), 4(2)(c) and 4(2)(d) of the Act by the OP (Asian Paints) is made out in the present matter," CCI said in the order.

Section 4 of the Competition Act, 2002, prohibits abuse of dominant position.

Accordingly, the fair trade regulator directed the Director General to cause an investigation to be made into the matter and submit an investigation report within a period of 90 days. Grasim, a part of the Aditya Birla Group, forayed into the decorative paints segment under the 'Birla Opus Paints' brand in February last year. Asian



Paints is a market leader and manufactures paints for both decorative and industrial use. The competition regulator observed that OP (Asian Paints), by way of restraining its dealers from dealing with the OP's competitors like the informant (Grasim Industries Ltd) by enforcing exclusivity upon such dealers, is imposing unfair conditions upon them, which is found to be in the nature of exploitative conduct.

Further, by restraining suppliers of essential raw materials from providing goods and services to the OP's competitors like the informant, as well as by coercing landlords, C&F agents and transporters to refrain from engaging

with competitors like Grasim, Asian Paints seems to be prima

facie creating barriers to new entrants in the market as well as partially foreclosing competition in the market, it said. Thus, the conduct of Asian Paints seems to be prima facie causing an appreciable adverse effect on competition in India, the regulator added.

The complainant further alleged that Asian Paints coerced dealers into returning or refusing to install Grasim's tinting machines, which the complainant claimed were technologically superior.

In its response, Asian Paints argued that the Indian decorative paints market is highly competitive with low entry barriers and presence of several regional and multinational players.

It (Asian Paints) also highlighted Grasim's rapid growth

achieved a high single-digit market share and established a vast network of over 50,000 dealers. However, the CCI noted that the material placed by Grasim indicated potential abuse of market power by Asian Paints. The Com-

mission said such conduct by a dominant enterprise could restrict competition and innovation, and hinder consumer choice.

However, the regulator clarified that observations made were not a final view on the case merits and directed the DG to conduct the probe without being swayed in any manner whatsoever by the observations made herein.

In September 2022, CCI dismissed a complaint filed by JSW Paints alleging unfair business practices against Asian Paints with regard to the latter misusing its dominant position and further denying access to the market. JSW Paints had alleged that after they launched their decorative paints segment, Asian Paints began to pressurise and target the dealers who had agreed to stock and display their decorative paints manufactured by the company. Demonstrations held in Nagaon and Dhubri; BJP leaders demand apology from Congress, accuse party of promoting political hooliganism

BJP stages statewide protests over alleged attack on CM's convoy

HT Bureau GUWAHATI, July 1: The Bharatiya Janata Party (BJP) on Tuesday staged statewide protests in Assam, including major demonstrations in Nagaon and Dhubri, to condemn the alleged attack on Chief Minister Himanta Biswa Sarma's convoy during a Congress-led protest in Golaghat on June 30.

In Nagaon, a massive demonstration was organised by the district BJP unit near Shahid Bhawan, drawing participation from over 400 party workers and senior leaders.

According to an official statement, Assam Labour Minister Rupesh Gowala, Nagaon Sadar MLA Rupak Sharma, and district BJP president Ranjit Bordoloi were among those who led the protest.

Addressing the gathering, MLA Rupak Sharma said the Chief Minister represents the people of Assam, not just the BJP.

"If the Congress can dare to attack the Chief Minister today, it raises serious concerns about the safety of ordinary citizens if such



a party returns to power," he said. Sharma called for protests to remain democratic and peaceful, accusing the Congress of displaying desperation through violent conduct.

Minister Rupesh Gowala echoed similar sentiments, describing the incident as "clear proof" of the Congress party's disregard for democratic values.

"This attack exposes the deep frustration within the Congress party, stemming from its repeated

political failures," Gowala re-

marked. Meanwhile, in Dhubri, a parallel protest was staged at Punch More, led by Assam Cabinet Minister Ranjit Kumar Dass.

BJP workers and supporters from across the district took part in the protest, raising slogans such as "Down with Gaurav Gogoi" and

"Congress's goondaism won't work," in reference to the Congress MP whom they blamed for the incident.

Addressing the gathering, Minister Dass demanded a public apology from Gaurav Gogoi, calling the alleged attack "an insult not just to the Chief Minister but to the entire democratic ethos of Assam.' Dass declared that until Gogoi publicly apologises, the BJP in Dhubri would not allow him to enter the district.

Both protests concluded peacefully under tight security arrangements.

The BJP's district units in Nagaon and Dhubri termed these demonstrations as the beginning of a wider campaign demanding accountability, civility, and respect in political conduct.

The party also reiterated its commitment to upholding law and order, warning that any attack on constitutional authorities would not be tolerated.

Similar demonstrations are being planned in other districts as part of a coordinated response to what the party described as "Congress's growing culture of political hooliganism.'

HT Correspondent KHERONI, July 1: Despite receiving official approval from the Union Ministry of Railways, the proposed stoppage of the 12423/12424 New Delhi-Dibrugarh Town Rajdhani Express (Daily) at Diphu Railway Station in Karbi Anglong remains unimplemented, drawing criticism from local residents and public representatives.

Amarsing Tisso, Member of Parliament from the Diphu Lok Sabha constituency, had formally requested the railway ministry to introduce a halt at Diphu, citing the town's importance as a key administrative and commercial centre in the region

The request was submitted through a letter dated July 20, 2024, addressed to Ashwini Vaishnaw, Union Minister for Railways, Communications, Electronics & Information Technology.

Responding favourably to the proposal, the Union Minister extended his support in a letter (No. 2025/CHG/13/NFR/07/Part-1) dated May 28, 2025, addressed to MP Tisso.

HT Bureau GUWAHATI, July 1: In a concerted effort to safeguard vulnerable passengers and combat human trafficking, the Railway Protection Force (RPF) of Northeast Frontier Railway (NFR) has achieved a significant breakthrough, rescuing 27 individuals-including 22 minors-during operations conducted between June 25 and June 29, 2025.

The information was provided in an official statement issued by NFR on Tuesday.

According to the statement, RPF teams stationed across key railway stations within the NFR zone acted swiftly and decisively in multiple rescue operations over the five-day period. The rescued individuals included 22 minors,

three men, and two women. All were safely handed over to Child Line authorities, non-governmental organisations, parents, or local police authorities for further action and support. The rescue operations commenced on June 25 and 26, when RPF teams based in Katihar, Kishanganj, and Samsi successfully rescued five runaway minor boys during coordinated efforts.

The minors were subsequently handed over to Child Line representatives after preliminary inquiry and counselling.

Continuing the momentum, the RPF team at Kamakhya Railway Station conducted a rescue operation on June 27, during which one runaway minor boy was found and immediately

Field programme blends scientific study with indigenous knowledge to promote biodiversity conservation

GUWAHATI, July 1: In a unique initiative aimed at promoting awareness and understanding of herpetofauna, leading biodiversity conservation organisation Aaranyak organised a 'Herping' session in Phumen Engti village of Karbi Anglong district, Assam.

Held on June 29, this marked the first such field programme of the year and was conducted with the active participation of students from various academic institutions.

According to an official statement, a total of 12 undergraduate and postgraduate students from the Zoology departments of Debraj Roy College in Golaghat, International School in Guwahati, and Arya Vidyapeeth College in Guwahati participated in the hands-on session.

The programme was designed to provide practical exposure to the study of reptiles and amphibians, while also fostering an understanding of the ecological and cultural context of biodiversity conservation in the region.

The session commenced with a classroom-style theoretical demonstration at the Aaranyak field station.

Dr Jayanta Kumar Roy, a herpetologist associated with Aaranyak, introduced the students to the basics of amphibians and reptiles, including their key identifying features and behavioural traits.



This was followed by an overview of field study methods and frog call identification techniques, conducted by Sourav Gupta, also from Aaranyak.

Following the instructional session, participants embarked on a guided field exercise that began from Phumen Engti village and stretched along the Langkiri River into the community forests of the Karbi Hills, covering approximately five kilometres.

As per the official statement, the students were able to appreciate the rich natural biodiversity of the area while also observing local practices such as jhum cultivation — a traditional form of agriculture practiced by the Karbi community.

They were also introduced to sev-

eral wild edible plants, many of which are known for their medicinal properties.

The session continued into the evening with a night walk focused on amphibian and reptile observation. Guided by local community experts Sanjib Bey and Bidyaram Tokbi, participants explored forest trails and riverine habitats near the village.

They observed and identified several species including the Red-eyed Frog (Ronga chakua beng), Indian Skipping Frog (Pani beng), Cricket Frog (Uisiringa beng), Assamese Cascade Frog (Axomiya nijora beng), as well as various reptiles such as benttoed geckos, garden lizards, and skinks (Monikira).

The field walk provided students

safeguarding biodiversity. According to the statement, the initiative was aimed at fostering a holistic understanding of biodiversity that integrates both scientific inquiry and cultural perspectives.

Aaranyak expressed that such fieldbased educational activities play a vital role in building environmental consciousness among the youth while also empowering local communities through recognition of their traditional knowledge systems.

The programme is part of Aaranyak's larger commitment to biodiversity conservation, ecosystem protection, and support for indigenous communities in the Kaziranga-Karbi Anglong and Manas landscapes.

These initiatives are supported by the International Union for Conservation of Nature (IUCN) - KfW and the US Fish and Wildlife Service.

New Manipur govt before Aug 12?

There is no let-up in ministry-making efforts on the part of BJP MLAs, who by themselves have a comfortable majority in the 60-member Manipur Assembly. Senior BJP MLAs, such as, Govindas and Biswajit are holding parleys with their supporters and other stakeholders. Speaker Satyabrata Singh is reportedly active behind the scene. BJP MLA Kh Ibomcha recently went on record saying that Manipur should have a popular ministry before long. More meetings of BJP MLAs, excepting seven who belong to the Kuki-Zo tribes, are likely. While these are informal efforts at the level of BJP leaders, serious attempts are being made by the Union ministry of home affairs (MHA) to work out a truce between the warring sides, the Meiteis of the Valley and Kuki-Zos of the Hills, before a popular ministry assumes office. Manipur was placed under President's rule on February 13 after former chief minister Biren Singh was left with no option but to resign on February 9 in the face of stiff opposition of the Kuki-Zo political outfits and their civil society organizations to his continuation in office. President's rule is always initially for six months, which period is to end on August 12. Inquiries by IPA from informed quarters suggest that MHA is keen on seeing that the trouble-torn state has a popular ministry before August 12 and thereby avoiding extension of president's rule for another six months.

Moreover, budget-related legislative steps too have to be initiated so that the state has the authority which derives from a regular budget for a full fiscal year. Union finance minister Nirmala Sitharaman followed the usual vote-on-account route for the initial spell of six months of President's rule. This issue has assumed urgency as requirements of additional funds have gone up substantially because of additional expenditure on the large security apparatus and large expenses that have to be incurred for arranging return to the original dwelling places of the 60,000 plus internally displaced persons. A K Mishra advisor (north-east) in MHA, is scheduled to hold soon the second round of talks with what has come to be known as the Suspension of Operations (SoO) groups to straighten out matters relating to the number and location of camps for Kuki-Zo militants coming under the purview of the SoO arrangement.

It is not an easy job for the BJP central leadership to identify a face who will be acceptable as chief minister also to the Kuki-Zo communities. The domination of the Meiteis in the administration and the resultant conspicuous under-representation in governance of the Kuki-Zo personnel has remained a sore point with them for a long time. They hold Biren Singh responsible for manoeuvering an overwhelming role in the administration of the majoritarian Meitei community. Also, the immediate past chief minister has been scathing in his attack against the Kuki-Zos about whom his position is that a large number of them are illegal immigrants from Myanmar and Bangladesh and that they have been regularly indulging in clandestine activity. A date for Modi's visit will hinge on when a ministry is sworn in before the conclusion of six months of President's rule on August 12.

Discord at Qingdao Terror, oil, and Taiwan strain China's regional diplomacy

The recently concluded Defence Ministers' meeting of the Shanghai Cooperation Organisation (SCO) in Qingdao, China, on June 26, 2025, revealed the growing fissures in the delicate architecture of regional diplomacy under Beijing's watch. India's Defence Minister Rajnath Singh's decision to withhold endorsement of the draft joint statement over its omission of the Pahalgam terror attack marked a diplomatic snub with far-reaching implications. The fallout: no joint declaration was issued, an unusual and embarrassing outcome for a multilateral platform focused primarily on security cooperation.

According to the Indian Ministry of Defence, Singh also held a bilateral meeting with his Chinese counterpart, General Dong Jun. During this discussion, Singh stressed the need for a "structured roadmap of permanent engagement and de-escalation" to resolve the lingering tensions between the two Asian giants. However, tellingly, there was no mention of a permanent resolution to the border dispute, a conspicuous omission that underscores the current diplomatic impasse following the deadly 2020 standoff along the Line of Actual Control (LAC).

Singh's address at the SCO wasn't merely procedural. He launched a thinly veiled attack on Pakistan, urging the SCO to un-

equivocally condemn cross-border terrorism and the sheltering of terrorists. Without naming Islamabad directly, he pointed to "countries using terrorism as an instrument of state policy," clearly referencing India's longstanding grievances against Pakistan's role in exporting terrorism, most recently manifested in the Pahalgam attack that killed several Indian security personnel. The absence of any SCO consensus on this issue highlights the deep-rooted geopolitical fault lines within the grouping.

Pakistan, a full SCO member since 2017, enjoys unwavering support from China in international forums. Their so-called "ironclad" friendship has repeatedly frustrated India's attempts to build an anti-terrorism consensus within multilateral bodies like the SCO. Moreover, the presence of Russia, another key SCO member and India's traditional strategic partner, complicates matters further. Moscow's growing proximity to Beijing, especially after the West's sanctions over Ukraine, has made Russia less willing to align with India against Pakistan. Iran and the Central Asian republics, each with their own economic and security relationships with China,

further add to the complexity. Iran's presence at the Qingdao meeting was equally significant. Defence Minister Aziz Nasirzadeh's appearance marked his first for-



Israel conflict. His expression of gratitude towards China was a subtle diplomatic message to the West. Iran hopes that Beijing, with its significant stake in Middle Eastern energy flows, will take a more proactive role in deescalating regional



to adopt a more visible role in ensuring regional security.

This request comes against the backdrop of growing Western anxiety over Iran's threat to close the Strait of Hormuz—one of the world's most critical maritime choke points for oil exports. Roughly 20% of global oil passes through this narrow waterway. The US Secretary of State, Marco Rubio, in a recent statement, indirectly called on Beijing to rein in Tehran's aggressive posturing. Rubio pointedly reminded China that its economic health is intimately tied to the uninterrupted flow of oil through the Hormuz Strait.

China's engagement with Iran has long been defined by energy dependence. Beijing buys nearly 90% of Iran's oil exports, making Tehran one of its top suppliers. Much of this trade continues despite US-led sanctions, facilitated by China's network of small, private "teapot refineries." These independent refineries help Beijing skirt Western scrutiny while keeping its energy lifelines open. However, despite this economic interdependence, China's security footprint in the Middle East remains limited. Its responses to regional flare-ups have so far been confined to generic calls for restraint and dialogue, a policy line that Iran now seems eager to see revised.

that Iran now seems eager to see revised.Amid these high-stakes diplomatic exchanges, President Xi Jinping's announced

absence from the upcoming BRICS summit in Rio de Janeiro adds another layer of intrigue. The South China Morning Post reported that this would be Xi's first-ever absence from the BRICS summit since he became president in 2013. Officially, the reason cited is a scheduling conflict, and Premier Li Qiang is expected to represent China at the summit.

However, informed diplomatic speculation suggests that Xi's decision may also be linked to Brazil's invitation to Indian Prime Minister Narendra Modi for a state dinner after the summit. The optics of Xi attending a summit where Modi would likely be the central guest of honour may have influenced the Chinese leader's calculus. Given the ongoing border tensions and diplomatic irritants, Beijing seems eager to avoid scenarios where India's international stature appears to rise at China's perceived expense.

BRICS, since its founding in 2009, has served as a platform for emerging economies to push for a multipolar global order, challenging the dominance of US-led international institutions. Its membership has recently expanded to include Iran, the UAE, Saudi Arabia, Egypt, Ethiopia, and Indonesia, signalling a clear tilt towards Global South solidarity. China has been widely seen as the driving force behind this expansion, aimed at building a counterweight to Western geopolitical dominance. However, China's assertive diplomatic moves and simultaneous disputes with several BRICS members-particularly India-highlight the internal contradictions within this coalition

Another diplomatic flashpoint complicating China's regional position is Taiwan. In a speech series titled "10 Talks on the Country," Taiwanese President Lai Ching-te unequivocally asserted that Taiwan is "of course a country," challenging Beijing's long-standing claim that the island is an inseparable part of China. Lai's remarks drew an immediate and sharp rebuke from the Chinese Foreign Ministry, which denounced his statements as a "Taiwan independence manifesto." Beijing reiterated its position that Taiwan's future is a decision to be made by the "1.4 billion Chinese people, including compatriots in Taiwan."

This rhetorical escalation comes at a time when public sentiment in Taiwan continues to diverge from Beijing's narrative. Recent surveys show that most Taiwanese now identify themselves as Taiwanese rather than Chinese. Since 2016, the Democratic Progressive Party (DPP), known for its pro-independence stance, has won three successive national elections, though it returned with a minority government in 2024.

Taiwanese domestic politics now stand at a critical juncture. In less than a month, several recall polls will take place, targeting nearly a quarter of the opposition Kuomintang's (KMT) parliamentary seats. Historically, the KMT's leaders fled to Taiwan after losing the Chinese Civil War to Mao's Communists in 1949. Yet today, the KMT is perceived as more conciliatory towards Beijing compared to the DPP. The DPP, sensing an opportunity, has already launched an aggressive campaign portraying the recall vote as a referendum on resisting Beijing's influence. In a recent video, the DPP urged voters to "oppose the communists," signalling that the coming weeks could see a further hardening of positions on both sides of the Taiwan Strait.

In sum, the Qingdao SCO summit unfolded under the shadow of multiple regional tensions—India's post-Pahalgam diplomatic push, Iran's call for greater Chinese involvement in Middle Eastern security, Xi Jinping's sudden withdrawal from the BRICS summit, and the volatile cross-Strait rhetoric over Taiwan's sovereignty. China finds itself simultaneously navigating contradictory roles: as a regional hegemon, a global economic powerhouse, and a diplomatic interlocutor with competing interests across its vast sphere of influence.

With the SCO leaders' summit scheduled later this year in Tianjin, all eyes will remain on how Beijing recalibrates its diplomatic approach. Will China manage to balance its growing global ambitions with the conflicting interests of its regional partners? Or will the fractures seen at Qingdao widen further, complicating Beijing's quest for regional leadership? The coming months will offer critical answers. The Amarnath Ji Yatra is a significant Hindu pilgrimage to the Amarnath Temple in Jammu and Kashmir. For 2025, the Shri Amarnath Ji Shrine Board (SASB) has announced that the Yatra will take place from July 3 to August 9, 2025. The Amarnath Ji Yatra is a test of faith, endurance, and devotion. It is more than a trek and a religious journey that tests your faith, your health, and your patience. The Amarnath Ji Yatra is considered a sacred journey, offering devotees an opportunity for spiritual growth, self-reflection, and connection with the divine. Every year 'Amarnath Ji Yatra' is marked by 'Pratham Pujan' which is said to summon the blessings of Baba Amarnath and attracts a large number of devotees from all over the world. The Amarnath Ji Yatra is a revered pilgrimage that showcases the devotion and resilience of millions of pilgrims.

Every year, thousands of pilgrims from every corner of the nation travel to the holy cave of Amarnath Ji in Jammu and Kashmir. His riding friend - Nandi, the bull - was left at Pahalgam, the moon atop his head at Chandanwari, the snake around his neck at Lake Sheshnag, the 5 basic essentials of life that he carried at Panchtarini and even his son Lord Ganesha himself at Mahaguna top.

The 38-day annual pilgrimage is scheduled to start from the twin routes — the traditional 48-km Pahalgam route in Anantnag district and the shorter but steeper 14-km Baltal route in Ganderbal district - leading to the 3,880-metre-high Amarnath cave shrine. The decision to shorten the pilgrimage period was made before the recent terrorist attack in Pahalgam that killed 26 people, mostly tourists, and is unrelated to any immediate security threat. Security arrangements for the Amarnath Ji Yatra are comprehensive and multi-layered. Despite recent incidents, including a terror attack near Pahalgam, pilgrims stood firm in their resolve to undertake the sacred journey. It is nice that security forces have carried out an extensive joint mock drill along the Jammu-Srinagar National Highway, as part of final preparations ahead of the annual Yatra. Over 180 companies of paramilitary forces have been deployed in the Jammu region, and CCTV surveillance has been increased at multiple points along the yatra route. Jammu police has also set up several checkpoints across the city to bolster security arrangements and carry out daily anti-sabotage checks ahead of the Amarnath Ji Yatra.

The Amarnath Ji yatra is an important part of Indian cultural heritage, showcasing the country's rich spiritual traditions and diversity. The journey offers an opportunity for personal growth, self-reflection, and spiritual rejuvenation, attracting millions of devotees each year. Best possible facilities are made available for the devotees with the efforts of the Indian Army, Central Government and State Government Police Forces along with NGOs and government provided services. To ensure a safe and successful yatra, pilgrims must ensure to adhere to security guidelines, including prescribed cut-off timings and restricted areas and stay away from isolated areas and avoid taking alternative routes suggested by drivers or local transporters. Minister Dr. S. Jaishankar embarked on a three-day visit to the United States on June 30, 2025, marking a significant moment in India's foreign policy engagements. The visit centers around his participation in the Quadrilateral Security Dialogue (Quad) Foreign Ministers' meeting in Washington, D.C., on July 1, hosted by U.S. Secretary of State Marco Rubio. Additionally, Jaishankar will inaugurate an exhibition at the United Nations headquarters in New York titled "The Human Cost of Terrorism," a poignant initiative to highlight the global impact of terror attacks. This visit, occurring against the backdrop of complex geopolitical dynamics, holds immense importance for India and the Indo-Pacific region. The Quad meeting, in particular, is expected to address critical issues such as regional security, counterterrorism, economic cooperation, and technological advancements, while reinforcing the strategic partnership among

India, the United States, Japan, and Australia. This article explores the expectations from the Quad talks, their significance, and the broader implications of Jaishankar's visit. The Quad, comprising India,

the U.S., Japan, and Australia, was first conceptualized in 2007 but gained renewed momentum in 2017 as a counterbalance to China's growing influence in the Indo-Pacific region. The group's primary objective is to ensure a free, open, and rules-based order in the Indo-Pacific, safeguarding the sovereignty and territorial integrity of nations. The timing of this meeting is crucial, as the region faces multifaceted challenges, including China's aggressive maritime activities in the South China Sea, territorial disputes, and increasing militarization. The Quad has evolved from a dialogue platform to a robust framework for cooperation, encompassing joint military exercises like Malabar, intelligence areas such as semiconductors, clean energy, and infrastructure development. For India, the Quad serves as a vital mechanism to strengthen its strategic autonomy while addressing regional security concerns

The Foreign Ministers' meeting on July 1 is expected to build on discussions from the previous Quad summit held in Washington on January 21, 2025. The agenda will likely focus on reviewing the progress of ongoing Quad initiatives and charting new strategies to address emerging challenges. Key areas of discussion will include enhancing maritime security, countering terrorism, and fostering economic resilience through diversified supply chains. The recent terrorist attack in Paharganj, which claimed 26 lives, has underscored the urgency of global cooperation in combating terrorism. India, which has long advocated for a zero-tolerance policy toward terrorism, is likely to emphasize this issue during the talks. The Quad nations are expected to explore ways to strengthen intelligencesharing mechanisms and coordinate efforts to disrupt terror financing and networks, particularly in light of India's recent counterterrorism operations. such as "Operation Sindoor" in Pakistan and Pakistan-occupied Jammu and Kashmir.

Jaishankar's visit to New York to inaugurate the UN exhibition on the human cost of terrorism further amplifies India's commitment to raising global awareness about the devastating impact of terror attacks. Scheduled a day before Pakistan assumes the rotating presidency of the UN Security Council, the exhibition is a strategic move to highlight India's concerns about statesponsored terrorism, particularly from Pakistan. The event will showcase the human toll of terrorism worldwide, drawing attention to the need for a unified international response. India's consistent efforts to push for the Comprehensive Convention on International Terrorism at the UN

Beyond security, the Quad meeting will likely delve into economic and technological cooperation, areas where the group has made significant strides. For India, these initiatives are crucial for reducing dependence on China-dominated supply chains and enhancing its technological capabilities. The Ouad's focus on climate change, healthcare, and humanitarian assistance also aligns with India's priorities, as it seeks to position itself as a leader in sustainable development and global health. The discussions are expected to pave the way for new agreements and partnerships, particularly in emerging technologies like artificial intelligence and quantum computing, which are vital for the region's economic resilience.

The strategic significance of Jaishankar's visit extends beyond the Quad framework. His bilateral meeting with Australian Foreign Minister Penny Wong on the sidelines of the Quad talks is expected to further strengthen India-Australia ties, particularly in trade, defense, and education. The Comprehensive Economic Cooperation Agreement (CECA) between the two nations, which is under negotiation, could receive a boost, fostering deeper economic integration. Additionally, India's engagement with the U.S. under the new administration will be closely watched, as it seeks to navigate the evolving dynamics of U.S. foreign policy in the Indo-Pacific. The Quad remains a cornerstone of the U.S.'s strategy to counter China, and India's role as a reliable partner in this framework enhances its geopolitical influence.

The broader geopolitical context adds weight to the Quad talks. While global attention has been focused on conflicts in the



Middle East and Ukraine, the Indo-Pacific remains a critical theater for global power dynamics. China's assertive actions, including its claims in the South China Sea and its growing naval presence, pose a direct challenge to the Quad's vision of a free and open Indo-Pacific. The group's ability to present a united front will be crucial in deterring aggression and ensuring regional stability. For India, the Quad provides a platform to balance its strategic interests while maintaining its policy of non-alignment. By engaging with like-minded democracies, India can address security threats without compromising its autonomy. The Ouad's evolution into a more action-oriented alliance is evident in its recent initiatives, such as the Indo-Pacific Partnership for Maritime Domain Awareness, which monitors illegal activities in the region's waters. The group's commitment to providing public goods, such as vaccines and disaster relief, has also strengthened its legitimacy as a force for global good. For India, participation in the Quad enhances its global standing, positioning it as a key player in shaping the rules-based international order. The upcoming Quad Leaders' Summit, to be hosted by India later in 2025, will build on the outcomes of this Foreign Ministers' meeting, making Jaishankar's visit a critical preparatory step.

Jaishankar's visit also underscores India's proactive foreign

policy under Prime Minister Narendra Modi's leadership. By engaging with global powers and multilateral platforms like the Quad, India is asserting its role as a responsible stakeholder in international affairs. The visit comes at a time when India is navigating domestic and regional challenges, including the aftermath of the Paharganj attack and tensions along its borders. The Quad's support in these areas, particularly in intelligence sharing and defense cooperation, will bolster India's efforts to address these challenges effectively.

Dr. S. Jaishankar's three-day visit to the United States and the Ouad Foreign Ministers' meeting represent a pivotal moment for India's foreign policy. The discussions are expected to yield concrete outcomes in areas such as counterterrorism, maritime security, and economic cooperation, reinforcing the Quad's role as a stabilizing force in the Indo-Pacific. The inauguration of the UN exhibition on terrorism highlights India's leadership in addressing global challenges, while its bilateral engagements, particularly with Australia, will deepen strategic partnerships. Women in the marketplace: Integration, spatial justice, and right to the city

The increasing representation of women in India's economic data and

on e-commerce platforms highlights the success of policies supporting women entrepreneurs through credit, skilling, and formalisation. However, it also reveals a persistent policy vacuum that hinders women's empowerment and integration into the country's workforce. Does an increase in the Female Labour Force Participation Rate (FLFPR) signal a corresponding rise in ownership rights and empowerment for women entrepreneurs? Has India's traditional urban planmodel—and the newer ning technological push for 'smart cities'democratised access to economic spaces and enabled meaningful market integration for women entrepreneurs?

This article argues that FLFPR must be re-envisioned to ensure women have an equal stake in spatial justice—including ownership and co-governance of economic spaces, access to trade licences, physical markets, and procurement systems across the business supply chain.

Easing Entry, Not Equity

The Union Budget 2025-26 allocated over INR 3 lakh crore for self-employment, skilling, and credit access for women entrepreneurs. This financial impetus aims to strengthen schemes, such as the Prime Minister's Employment Generation Programme (PMEGP), the Pradhan Mantri MUDRA Yojana (PMMY), Stand-Up India, Deen Dayal Upadhyay Antyodaya Yojana-National Urban Livelihoods Mission (DAY-NULM), PM Street Vendor's AtmaNirbharNidhi (PM SVANidhi), and Startup India—initiatives that promote inclusion and ease of doing business for women.

India's Periodic Labour Force Surveys show a consistent rise in women's labour force participation, with urban FLFPR (for women aged 15 years and above, either employed or seeking employment) increasing from 15.9 percent in 2017–18 to 22.3 percent in 2023-24.

For example, PMEGP, which offers credit-linked subsidies to new micro-enterprises, supported 89,118 enterprises in 2023-24. PMMY, with its three-tier lending model (Shishu, Kishor, Tarun), has expanded access to micro-credit for small businesses and microenterprises. As of December 2024, women had registered 2,20,73,675 MSMEs and micro enter-

prises on the Udvam Registration Portal (URP) and Udyam Assist Platform (UAP). Over 80 schemes exist across ministries, financial institutions, and startup missions.

Still, most of these schemes focus on entry-prioritising access to credit and skills—without addressing the structural barriers and gendered disparities in India's market economy. Women often operate in markets planned and designed by men without formal structures, or on the urban periphery, lacking any negotiating or co-governing stake. Markets seldom offer gender-inclusive amenities such as toilets, feeding rooms, or daycare, which undermines spatial justice. Furthermore, these schemes overlook women's structural exclusion from economic negotiations and legal and regulatory frameworks-conditions critical for equitable participation. These gaps signal a clarion call to develop integrated policies that consider procurement pipelines and co-governance, and reimagine 'inclusion' from visibility to active stakeholder participation.

Illusion of Inclusion

India's Periodic Labour Force Surveys show a consistent rise in women's labour force participation, with urban FLFPR (for women aged 15 years and above, either employed or seeking employment) increasing from 15.9 percent in 2017-18 to 22.3 percent in 2023–24. In the same period, the worker population ratio (actual number of employed women among the population) rose from 14.2 percent to 20.7 percent.

Yet, despite these gains, women's work and entrepreneurship largely remain informal. India continues to lag globally on FLFPR. In the World Economic Forum's Global Gender Gap Index 2024, India slipped two ranks from 2023, scoring 0.641—below the global average of 0.685. On the Economic Participation and Opportunity sub-index, India ranked 142 out of 146 countries, scoring 39.8 percent compared to the global average of 60.5 percent.

Furthermore, PLFS data from 2017–18 to 2023-24 also show that self-employment among urban women rose from 34.7 percent to 42.3 percent, while regular wage/salaried employment declined from 52.1 percent to 49.4 percent. Consequently, their unemployment rate fell from 10.8 to 7.1 percent. In contrast, the Annual Survey of Unincorporated Sector

Enterprises (ASUSE) 2023-24 found that 26.2 percent of proprietary enterprisesmostly home-based, unregistered, and informal micro units-are owned by women. Yet they lack safety nets, scaling support or infrastructural access.

Therefore, to gauge women's empowerment in India meaningfully and accurately, a critical examination of the types of jobs, their work conditions, and the broader social and economic context in which they operate must be readily sought. Limited access to secure formal employment, care burdens, and exclusion from institutional networks often sequester women into self-employmentnot as a choice, but a necessity.

In many cases, businesses are registered in women's names to gain tax exemptions, subsidies, or scheme benefits, while male relatives retain control over purchasing, pricing, and market expansion. This 'disguised ownership' inflates women's entrepreneurship data, masking the true extent of their participation and control-up to 30 percent, according to a multi-state survey. A 2022 NITI Aayog report expressed a similar concern.

Access to Supply Chains and Procurement

While the Government e-Marketplace (GeM) aims to digitise and democratise procurement, its stringent documentation and compliance requirements—including proof of turnover, experience, and original equipment manufacturer (OEM) certifications-render it inaccessible to many women-led microenterprises. The mandatory vendor assessment process adds further hurdles, widening exclusion due to infrastructure gaps, digital illiteracy, and lack of procedural support. For instance, GeM's 'Womaniya' initiative mandates a 3 percent procurement quota for women-led micro and small enterprises (MSEs) and reduces transaction charges. Nonetheless, women constitute only 8 percent of the seller base. Even exemption clauses require formal documentation, placing the burden of proof on women who often lack institutional recognition. In 2024-25, women-led MSEs generated INR 46,615 crore—less than 1 percent of GeM's gross merchandise value of INR 4 lakh crore.

Spatial Dynamics of Urban Markets Beyond economic parameters, zoning laws, trade networks, market associations, and formal/informal gatekeeping all shape physical markets. Existing pa-



triarchal market biases inhibit women from having equal negotiation power, making it challenging for them to establish, run, and or scale businesses in such a complex, multi-layered market ecosystem.

The digital interventions under India's Smart Cities Mission (SCM) focus primarily on beautification, surveillance, and mobility rather than gender-inclusive infrastructure. For instance, authorities evicted female vendors in Mumbai's Dadar Market during a road widening project without providing permanent vending zones or vendor association membership. In May 2025, despite being SVANidhi beneficiaries, street vendors in New Delhi were evicted as part of a citywide Safai Abhiyan (Cleanup Drive).

Digital Markets: Opportunity or **Isolation**?

E-commerce platforms and digital marketplaces have created numerous avenues for self-employment without obligations to comply with stringent regulations and informal gatekeeping in physical markets. However, they also digitise precarity. Many women selling on platforms such as Instagram or Meesho operate informally. They also lack logistics support or Goods and Serv-

ices Tax (GST) registration, making them ineligible for public tenders and restricting their ability to scale or access credit.

The 2025-26 Union Budget acknowledged the vulnerabilities of platform workers and launched the e-Shram portal, introducing digital ID cards. It has also extended the Pradhan Mantri Jan Arogya Yojana (PM-Jay) health coverage to registered gig workers. However, these measures fail to address deeper structural issues-including skewed contracts, lack of social security portability, and exclusion from formal procurement and vendor networks.

Towards an Inclusive Urban Economy

An inclusive economy must reimagine cities not merely as growth engines but also as spaces fostering equal access. Beyond participation, policies must uphold women's rights to co-own, shape, and govern economic spaces by:

· Reforming municipal laws and reconfiguring market redevelopment under SCM beyond mere cosmetic upgrades.

· Mandating participatory market planning with compulsory representation of women vendors in official vending committees.

• Ensuring women's representation in

market associations that decide working hours, space usage, rent, and infrastruc-

· Reforming licensing and ensuring tenure security, while expanding GeM's eligibility criteria for recognition.

• Building gender-sensitive access to gender-inclusive infrastructure, including toilets and daycare facilities

• Creating a Women's Market Integration Index to periodically track ownership, procurement, access, licensing, and representation in decision-making bodies.

The question of women's entrepreneurship is ultimately about urban equity and spatial justice-about how women move beyond mere 'access' to ownership and co-governance of the spaces they sustain. Despite their visibility as street vendors, retail shop owners, or digital sellers, the absence of spatial justice stakeholder participation and right to the city limits their power to influence how markets are planned, designed, and governed. Budgetary and policy interventions must encourage and prioritise a participatory vision of the city-one that considers women's aspirations, imaginations, and sense of belonging. (Courtesy: ORF)

ementia is a collective term that describes various symptoms of cognitive decline, such as forgetfulness, confusion, and changes in behavior. It is not a specific disease but a group of conditions characterized by impairment of at least two brain functions such a memory loss and judg-

spotlighting a harrowing crisis of child sexual abuse that often begins early in life.

The research, conducted by the Institute for Health Metrics and Evaluation at the University of Washington, analysed data spanning 204 countries over three decades, from 1990 to 2023. Data from the Global Burden of Diseases, Injuries, and Risk Factors study was used to calculate the prevalence of sexual violence against children (SVAC).

The study estimated that 30.8 per cent of Indian women and 13.5 per cent of Indian men experienced sexual violence during their childhood, placing India among the countries with the highest prevalence rates for women. For young Indian adults aged 20-24, the numbers remain stark: 26.9 per cent of women and 9.4 per cent of men reported having experienced sexual violence as children.

Globally, the figures are no less grim. The paper found that 18.9 per cent of women and 14.8 per cent of men worldwide have been victims of child sexual abuse. Of those aged 13-24 who reported ever experiencing sexual violence, twothirds of girls and nearly three-quarters of boys said it happened before they turned 18. The findings reveal that SVAC is not only pervasive but alarmingly persistent over time, showing little change since 1990. India, alongside countries such as Costa Rica. Chile and the Solomon Islands. recorded among the highest prevalence for women, underlining that the crisis is global, not regional.

The research showed that the vast majority of sexual abuse begins before adulthood. Childhood and adolescence are not just vulnerable years, they are the primary years of risk. Across the global sample, 67.3 per cent of female survivors and 71.9 per cent of male survivors said their first encounter with sexual violence happened during childhood

The researchers argued that these early windows must be the focus of future prevention efforts through safe schooling environments, better social support systems and the dismantling of patriarchal norms that enable secrecy and shame.

The true scale of the problem may be even greater, the research cautioned. The study adjusted for underreporting linked to how surveys were conducted. For instance, face-to-face interviews often yield lower disclosures than anonymous methods.

In fact, 63 countries had no publicly available data on sexual abuse against children and even among countries with data, most had only one year of usable information, making it difficult to track trends or

study also finds that boys are significantly affected, sometimes more than girls.

In countries like Bangladesh and Haiti, the prevalence of child sexual abuse is higher among boys than girls, challenging entrenched assumptions and calling for a more inclusive approach to child protec-

For Indian boys, the rate (13.5 per cent) is just below the global average (14.8 per cent) but still deeply concerning.

Entrenched notions of masculinity and stigma around male victimhood contribute to silence and underreporting, the authors of the paper said.

The study revealed several global "hotspots" where children are disproportionately affected. Among women, the highest age-standardised prevalence of childhood sexual violence in 2023 was found in Solomon Islands (42.6 per cent), Ivory Coast (32.4 per cent), Chile (31.4 per cent), Costa Rica (30.9 per cent) and India (30.8 per cent).

For men, the highest rates were reported in Ivory Coast (28.3 per cent), Bangladesh (27.7 per cent), Haiti (26 per cent), Botswana (27.1 per cent) and Nigeria (24.2 per cent). Looking at the regionwise numbers, in South Asia, India recorded the highest female prevalence at 30.8 per cent, while Bangladesh topped the male rates at 27.7 per cent, over twice the global average for boys.

In sub-Saharan Africa, Ivory Coast reported the highest rates for both girls (32.4 per cent) and boys (28.3 per cent), making it one of the few countries where male prevalence nearly equals female. Chile (31.4 per cent) and Haiti (26.0 per cent) led in Latin America and the Caribbean for girls and boys, respectively.

The Solomon Islands recorded the world's highest female prevalence at 42.6 per cent, while Laos had the highest male rate (22.4 per cent) in Southeast Asia, East Asia, and Oceania.

In Central Europe, Eastern Europe, and Central Asia, Bosnia and Herzegovina stood out with 14.7 per cent among women and a reversed pattern, 21.0 per cent among men, highlighting the male burden.

Among high-income countries, New Zealand reported the highest rates for both girls (28.8 per cent) and boys (22.8 per cent). In nearly every region, young adults aged 20-24 reported SVAC rates matching or exceeding past averages.

The authors of the study stressed the need for multisectoral responses, including strengthening child protection laws, investing in survivor support services and ensuring education systems are safe and responsive. (Courtesy: Down to Earth)

Dementia is more common in females than males. Potential factors contributing to the differences between genders are longevity, hormones, and genetic predispositions, but the definitive reason is unknown.

However, despite these differences, the signs and symptoms of dementia in women are generally the same as those in other genders. Early signs of dementia in women may include memory loss, difficulty with problem-solving, and changes in behavior and personality.

A note about sex and gender

Sex and gender exist on spectrums. This article will use the terms "male," "female," or both to refer to sex assigned at birth.

Early signs of dementia in women

In the early stages of dementia, people may still maintain a degree of independence. They may continue to drive, work, and participate in social activities. However, they may notice subtle memory lapses and cognitive difficulties impacting their daily lives.

It might only be those close to the individual who notice the subtle differences or through diagnostic evaluations by healthcare professionals.

Common early signs of dementia include:

· Memory lapses: Forgetting familiar words or the location of everyday objects.

• Difficulty with names: Struggling to remember names when meeting new people.

• Task performance issues: Finding it challenging to perform tasks in social or work settings

• Forgetting recent information: Losing track of material that was just read.

• Misplacing valuables: Frequently losing or misplacing valuable objects.

• Trouble planning or organizing: Increased difficulty with planning or organizing activities.

What is dementia?

Dementia is not a single disease but a collection of symptoms characterized by a decline in cognitive function severe enough to interfere with daily life. It damages brain cells, affecting their communication ability and impairing thinking, behavior, and feelings.

Several diseases can cause dementia, with Alzheimer's disease being the most common. Other types include:

- Vascular dementia
- Frontotemporal dementia
- Lewy body dementia

Early diagnosis and intervention can help manage symptoms and improve quality of life, although no cure exists.

Overall signs of dementia

Dementia symptoms progress over time, becoming more pronounced and impacting various aspects of an individual's life. The progression divides into early, middle, and late stages.

· Confusion: A person may have difficulty recalling personal information like addresses, telephone numbers, and educational background.

· Disorientation: A person may experience confusion about location or time.

· Decision-making: Individuals need help choosing appropriate clothing for the season or occasion. Bladder and bowel control: This includes trou-

ble controlling the bladder and bowels. • Sleep disturbances: Changes in sleep patterns

can happen, such as sleeping during the day and being restless at night.

• Wandering: An increased tendency to wander may happen.

• Behavioral changes: This includes personality and behavioral shifts such as suspiciousness, delusions, or compulsive behaviors like hand-wringing or tissue shredding. In the final stage of dementia, symptoms become severe, and individuals require extensive care.

• Dependence: When a person needs around-theclock assistance with daily personal care.

· Memory loss: When there is a loss of awareness of recent experiences and surroundings.

Physical decline: A person may experience a decline in physical abilities, including walking, sitting, and swallowing.

· Communication difficulties: They may have difficulty communicating, though they may still say words or phrases.

• Infection vulnerability: They may have an increased susceptibility to infections, particularly pneumonia.

When to contact a doctor

If someone has problems remembering recent events or feels confused, they should talk with a health professional. Likewise, if a friend or family member notices these issues, they should seek medical advice.

A doctor may ask the individual questions and perform various tests to determine the cause of the symptoms. They may also refer the person to a specialist, such as a neurologist, for further assessment. Causes

Dementia arises from damage to brain cells, disrupting their communication abilities. This interferes with a person's thinking, behavior, and emotions.

Each brain region handles specific functions such as memory, judgment, and movement. When cells in a particular region become damaged, that area cannot perform its tasks effectively.

Different types of dementia are linked to specific brain cell damage in particular regions. For example, Alzheimer's disease involves high levels of certain proteins inside and outside brain cells, making it difficult for these cells to remain healthy and communicate.

The hippocampus, responsible for learning and memory, is one of the first areas affected, leading to early memory loss.

Several risk factors can contribute to the devel-

Diagnosing dementia involves several steps:

· Medical history review: This usually includes evaluating symptoms and family history.

 Physical examination: This includes checking overall health and identifying potential causes for symptoms

• Cognitive and neuropsychological tests: These include assessing memory, problem-solving, and language skills.

• Imaging tests: MRI or CT scans are used to look for brain abnormalities.

• Laboratory tests: Blood tests are used to rule out other conditions

Treatment

While there is no cure for dementia, various treatments can help manage symptoms:

 Medications: Medications such as cholinesterase inhibitors and memantine are approved for treating dementia and may help slow progression.

· Therapy: Cognitive stimulation and occupational therapy can improve function.

• Lifestyle changes: Regular exercise, a healthy diet, and mental stimulation can support brain health

Outlook

The outlook for individuals with dementia depends on the type and stage of the disease. While dementia is progressive and currently has no cure, early intervention can improve quality of life and slow symptom progression.

People with dementia can live for many years after diagnosis. Treatments and lifestyle changes help manage symptoms and maintain daily functioning. On average, individuals with Alzheimer's disease live about 4 to 8 years after symptoms become noticeable.

Prevention

While dementia is not always preventable, certain lifestyle choices may help reduce the risk:

• Maintain a healthy diet rich in fruits, vegetables, and whole grains.

• Engage in regular physical activity.

· Keep the mind active through learning and social activities.

• Manage general health by controlling weight, blood pressure, cholesterol, and diabetes and treating hearing problems.

· Stay mentally active and remain connected with family and friends.

• Take care of mental and physical health, and try to get good sleep

• Drink less alcohol and stop tobacco use. Summary

Pahalgam attack was act of economic warfare: EAM Jaishankar

NEW YORK, July 1: The Pahalgam terror attack was an act of economic warfare meant to destroy tourism in Kashmir, External Affairs Minister S Jaishankar said, asserting that India has made it clear that it will not allow nuclear blackmail to prevent it from responding to terror emanating from Pakistan.

India has had a string of terrorist attacks over the years emanating from Pakistan and in the wake of the April 22 Pahalgam terror attack, there was a sentiment in the country that "enough is enough," Jaishankar said on Monday.

His remarks came during a conversation with Newsweek CEO Dev Pragad hosted at the publication's headquarters at One World Trade Centre near the 9/11 Memorial in Manhattan.

Jaishankar said that the Pahalgam attack "was an act of economic warfare. It was meant to destroy tourism in Kashmir, which was the mainstay of the economy. It was also meant to provoke religious violence because people were asked to identify their faith before they were killed."

"So we decided that we cannot let terrorists function with impunity. The idea that they are on that side of the border, and that, therefore, sort of prevents retribution, I think, that's a proposition that needs to be challenged and that is what we did," he said.

Jaishankar is on an official visit to the US and will travel to Washington DC to participate in the Quad Foreign Ministers' Meeting on Tuesday.

He commenced his visit by inaugurating an exhibition in the UN Headquarters titled 'The Human Cost of Terrorism', organised by the Permanent Mission of India to the UN

"And in this particular case, I can tell you that I was in the room when Vice President (JD) Vance spoke to Prime Minister (Narendra) Modi on the night of May 9, saying that the Pakistanis would launch a very massive assault on India if we did not accept certain things.

"And the Prime Minister was impervious to what the Pakistanis were threatening to do. On the contrary, he indicated that there would be a response from us. This was the night before and the Pakistanis did attack us massively that night, we responded very quickly thereafter," Jaishankar said.

"And the next morning, Mr (Secretary of State Marco) Rubio called me up and said the Pakistanis were ready to talk. So I can only tell you from my personal experience what happened. The rest I leave to you," he said. (PTI)

He said throughout July and August, the celebration would revive every day of the last year for which the young students, commoners, rickshaw pullers, and workers were martyred and injured. "We will do this every year so that dictatorship cannot raise its head again in any way," Yunus said.

The movement started in July last year under a platform called Students against Discrimination (SAD), demanding reforms in a controversial quota system for government jobs, but turned violent, resulting in the ouster of the government on August 5, 2024. when Hasina left the country for India on a military aircraft.

Yunus flew from Paris three days later to take charge as the interim government's Chief Adviser as the SAD nominee. He subsequently disbanded Awami League and its students' front, saying the ban would remain enforced until their leaders were tried.

Most leaders of the Awami League and ministers of the past regime, including several officials, were arrested or were on the run at home and abroad as the government initiated their trial for brutal actions to tame the uprising, leaving several hundred people, including students, dead. Hasina and her regime leaders are being prosecuted in Bangladesh's International Crimes Tribunal (ICT-BD), formed in 2010 for trying hardened collaborators of Pakistani troops during the 1971 Liberation War on charges like crimes against humanity.

According to a UN rights office report, some 1,400 were killed between July 15 and August 15, 2024, as retaliatory violence continued even after the fall of the past regime. (PTI)

"If this insane spending bill passes, the America Party will be formed the next day," he wrote. "Our country needs an alternative to the Democrat-Republican uniparty so that the people actually have a VOICE."

Musk's post about the America Party was viewed 32 million times on X.

NEW DELHI, July 1: Chief Election Commissioner Gyanesh Kumar on Tuesday asserted that eligible citizens should register themselves as voters only in constituencies of which they are ordinary residents and not the place where they own a house.

His remarks come as the poll machinery in Bihar undertakes a special intensive review (SIR) of the voters list of the state, which is going to the polls later this year. One of the key objectives of the drive is to identify "many persons" who have, knowingly or unknowingly, managed to retain multiple voter cards of different constituencies.

Addressing a group of boothlevel officers here, the CEC said, "As per the Representation of the People Act, you are entitled to vote only in the assembly constituency where you are an ordinary resident. For example, if you ordinarily reside in Delhi but own a house in Patna, your vote should be regis-

Cabinet nod for ₹ one lakh crore scheme to spur private investments in R&D

NEW DELHI, July 1: The Union Cabinet on Tuesday approved the Research Development and Innovation Scheme with a corpus of Rs one lakh crore to spur private sector investment in research.

The scheme, approved by the Cabinet at a meeting chaired by Prime Minister Narendra Modi, aims to encourage the private sector to scale up research, development and innovation in sunrise domains and in other sectors relevant for economic security, strategic purpose, and self-reliance.

The initiative will also finance transformative projects at higher technology readiness levels, support acquisition of technologies which are critical or of high strategic importance, and facilitate setting up of a deep-tech fund of funds.

Digital India completing 10 years Unfulfilled promises, digital exclusion of marginalised: Cong

NEW DELHI, July 1: With the Modi government hailing Digital India as a people's movement that democratised technology in 10 years, the Congress on Tuesday claimed the fine print of its "lofty claims" is marred by unfulfilled promises, digital exclusion of the marginalised, hurting privacy and weakening transparency.

Digital India is a flagship programme of the government launched on July 1, 2015, by Prime Minister Shri Narendra Modi with the vision to transform India into a digitally empowered society and knowledge economy. Questioning the government's

claims of the success of the initiative that completed 10 years, Congress president Mallikarjun Kharge cited data like villages and schools that are yet to get broadband connectivity, the rising debt of state-owned telecom companies MTNL and BSNL and a surge in cyber crimes.

At the same time, the opposition party sought to take credit for laying the foundation of several pathbreaking initiatives like Aadhaar and UPI during its rule.

"The fine print of Modi Govt's lofty claims of 'Digital India' is marred by unfulfilled promises and

false claims," Kharge said in a post on X.

As of 26th June 2025, under the BharatNet project, a total of 6.55 lakh villages were supposed to be targeted for broadband connectivity, but out of these, 4.53 lakh villages, i.e. 65 per cent of them are yet to be covered, he claimed.

"The project's deadline has been revised at least 8 times in 11 years. A meagre 0.73% (766) Gram Panchayats currently have active Wi-Fi services. When the private players are opting for 5G, BSNL has not yet completed its target of deploying 1 lakh 4G towers. Onethird towers left to be installed," the Congress chief said.

Even after receiving three revival packages worth over $\gtrless 3$ lakh crore -- \gtrless 69,000 crore in 2019, \gtrless 1.64 lakh crore in 2022, and ₹ 89,047 crore in 2023 -- it still lags behind private players, Kharge said

He pointed out that BSNL's debt rose by 291.7 per cent, from ₹ 5,948 crore in March 2014 to ₹ 23,297 crore in March 2024.

"MTNL's debt increased by 136.2%, from ₹ 14,210 crore to ₹

Cybersecurity incidents rose by about 76.25% from 2020 to 2024. These cases increased from 11.58 lakh in 2020 to over 20.41 lakh in 2024," Kharge claimed, citing CERT-In data.

Between 2022 and 2024, digital arrest scams and related cybercrimes in India nearly tripled, and the money lost rose 21 times, he said, citing replies to questions in the Rajya Sabha.

"We were told that demonetisation will reduce cash transactions, but cash in circulation has risen, even in the last year," Kharge said.



Three militants arrested in Manipur

IMPHAL, July 1: Security forces arrested three militants of various proscribed outfits in Manipur for allegedly being involved in extortion activities in Imphal East and Thoubal districts, police said on Tuesday. One active cadre of the banned United National Liberation Front (P) was apprehended from the Khurai Kongpal area in Imphal East district on Monday, a senior officer said.

"The militant was accused of illegally settling issues through kangaroo courts in matters related to land disputes, crimes against women, and recovery of loan money in valley areas," he said.

An active cadre of the proscribed Kangleipak Communist Party (PWG) was also arrested from the Leirongthel Pitra area in Thoubal district on Sunday, the officer said.

The militant was allegedly involved in extortion activities, kidnapping and recruiting new cadres for the outfit, he said.

One active cadre of the outlawed Prepak (Pro) was apprehended from the Charangpat Mamang Leikai area in Thoubal district on Monday. He was also accused of being involved in extortion, threatening people and kidnapping in Thoubal.

Security forces have been conducting search operations in Manipur since ethnic violence broke out two years ago.

AGARTALA, July 1: On the eve of National Doctors' Day, Tripura Chief Minister and Health Minister Manik Saha announced the successful completion of the state's third kidney transplant, marking another milestone in the state's advancing healthcare sector.

The transplant was carried out by a team of doctors at Agartala Government Medical College (AGMC) and GB Pant Hospital, in collaboration with experts from Shija Hospitals and Research Institute, Manipur.

Expressing his pride, Saha said, "As we prepare to celebrate Doctors' Day tomorrow, I'm delighted to share that our doctors have successfully performed the state's third kidney transplant. Both the donor and recipient are currently stable."

Saha hailed the accomplishment as a testament to the medical team's skill and relentless commitment, adding that it reflects the growing capabilities of Tripura's healthcare system. Tripura entered the field of organ transplantation less than a year ago, performing its first kidney transplant at AGMC & GBP Hospital in July 2024.

Drugs Control Administration (SDCA) cancelled the licenses of 15 pharmacies under Niuland district in Nagaland for not complying with regulatory requirements.

In an effort to regulate pharmacies in the state as per the Drugs and Cosmetic Act, 1940 and Rules 1945A, a joint team of the Niuland district administration, police and Dimapur chief medical officer's office, led by assistant drugs controller Martemjen Longkumer and drugs control ofState Drugs Control Administration, the licenses of the 15 pharmacies were cancelled during the joint enforcement drive for noncompliance with the show cause notices issued to them for violating Rule 65(2) of the Drugs and Cosmetics Rules 1945 and Section 42 of the Pharmacy Act 1948.

Nagaland health and family welfare minister P Paiwang Konyak earlier directed the State Drug Control Administration to immediately shut down all pharmacies found operating without registration, licence or operated

In April, in a major three-day crackdown on pharmacies operating without licensed personnel, the licenses of 54 pharmacies in Mokokchung town were can-

celled by the authorities. Drugs licenses of 24 retail pharmacies in Dimapur and Chümoukedima districts were cancelled in February due to non-compliance with Rule 65 of the Drugs and Cosmetics Rules, 1945.

The move followed repeated notices and extended deadlines to the pharmacies for employing registered pharmacists, which were not complied.

Tripura introduces e-attendance with shared location in govt schools: Official

KAILASHAHAR (**TRIPURA**), **July 1:** The Tripura government has asked all government school teachers across the state to share their locations after reaching their respective schools, an official said on Tuesday. Around 25,000 teachers, who are engaged in 4.912 schools in the northeastern state. have been asked to share their locations from June, the official said

The government had earlier introduced eattendance for the teachers. Since June, the state government has asked them to share their locations along with the e-attendance. the official explained

"E-attendance with shared location has been introduced in all the government schools. Earlier only the e-attendance system was implemented in schools. But one more feature - share location of teachers has been inserted from June," Unakoti district's

education officer, Prasant Killikdar told PTI. According to him, a teacher will have to click the "share location" option on the digital device only after entering school premises. Otherwise, it will not work.



"Once the process is done, the headmaster or headmistress will upload the presence of teachers of a particular school on the school management system, a digital platform. After doing this, the entire e-attendance with the location of teachers all over the state will

be accessible from the chief minister to the secretary and director on a real-time basis," Killikdar, who is the joint director of the department said.

Terming the introduction of e-attendance along with sharing location a good develop-

ment to ensure the presence of teachers in their respective schools, he said the system for recording the departure time of the teachers has not been implemented yet.

For the students, the class teachers are uploading the attendance during school days, he said.

Killikdar said the department has already constituted two inter-district committees for each district for conducting surprise visits to the schools.

"The teams conduct surprise visits to schools on a regular interval and submit their reports to the district education offices for forwarding them to the Director for taking necessary steps to ensure quality education,' he said.

All these initiatives have been taken to ensure transparency in teachers' attendance in schools for better results, he said.

Due to the constant efforts, the performance of the state government's Vidyajyoti (CBSE) schools not only in Unakoti district but also across the state has improved this year compared to 2024, he added. (PTI)

Acting on a tip-off, the paramilitary force, in collaboration with the Mizoram Police, set up a check post at Zokhawthar village in the district on June 29, and the team, while conducting a thorough search of a suspected individual, recovered 20,200 Methamphetamine tablets weighing 2.22 kg, it said. The seized tablets from the peddler are valued at over ₹ 6.67 crore, it said.

Methamphetamine tablets are a highly addictive stimulant that affects the central nervous system, and these are banned in India.

The accused is a Myanmar national and the recovered Meth tablets were handed over to Mizoram Police at Zokhawthar for further investigation and legal proceedings, the statement added. (PTI)

Man kills girlfriend by slitting her throat, held in Meghalaya

MAIRANG (MEGHALAYA), July 1: A 25-year-old man was arrested for allegedly killing his girlfriend by slitting her throat in front of her father in Meghalaya's Eastern West Khasi Hills district, police said on Tuesday.

The incident took place on Monday evening when the woman, along with his father, went to a market in Mairang Pyndengumiong village to sell their farm produce, a senior officer said.

The deceased was identified as Phyrnailin Kharsyntiew, a resident of Mawkhap village.

According to the police officer, eyewitnesses said the accused approached them and got engaged in an argument with the woman.

"All of a sudden, the man slit the throat of her girlfriend. The woman was immediately taken to Mairang Civil Hospital, where doctors declared her dead," the officer said.

Locals managed to apprehend the accused as he tried to flee the spot, and he was subsequently handed over to the police.

The police have registered a case, and the investigation is underway, the officer said.

"The motive behind the murder seems to be a personal dispute, but all angles are being looked into," he said.

The woman's father said the man vented his anger by killing his daughter, as she did not want to continue the relationship.

The incident has triggered outrage in the district as locals demanded justice for the woman. (PTI)

I'm not a horror film aficionado: Kajol on latest movie 'Maa'

NEW DELHI, July 1: (PTI) Actor Kajol says she isn't a fan of horror films and will be watching "Maa", her own entry in the genre,

solely for professional reasons. "Maa", directed by Vishal Furia, is the first horror project of Kajol's career of over 30 years. The movie shares the same universe with the 2023 movie "Shaitaan", which featured her actor-husband Ajay Devgn.

"I don't watch horror films. I have watched a lot of big films. I'm not a horror film aficionado at all. "I hored bareador of the set

"I haven't watched 'Maa' yet. Only in parts with lots of green screens behind me so that I don't get scared, and no background music, or anything like that. (But) I really have to watch it, for professional reasons," the 50-year-old actor told PTI in an interview here.

As an actor, Kajol had initially assumed working on a horror film would be no different from any other genre. "It was a very interesting

experience, actually, it was not something that I had done before. I always assumed working on the horror genre was the same as working in any other film, and I was completely wrong.

"Horror has a pitch when you are acting, and the pitch is completely different from regular movies. It's not a romcom, it's not a love story, or it's not a drama. Vishal and I used to have long conversations where we were like, 'no, this is not the pitch. You have to keep it at this pitch.' And that was really emotionally draining... to keep it at that pitch constantly,"

she added. "Maa" features Kajol as Ambika, a woman leading a happy life with her husband, and daughter Shweta. When the mother-daughter pair travel to Chandrapur in West Bengal to sell the ancestral bungalow, they confront the eerie traditions and tightly held secrets of the village and are drawn into a chilling web of fear, superstition, and something even darker, according to the official plotline.

Kajol said the movie was initially conceptualised as a tight thriller but during the development process, the makers realised the need to add a horror element to it.

"We didn't start out to do a horror film... but by the time the script came out, we realised that the characters and situations had become so big, that we needed a bigger platform to do justice to them, and to climax for them. "As it was, the audience would not


"As it was, the audience would not have been satisfied if we had come out with a very simplistic ending... it just didn't leave you that satisfied. So, that's why we had to attach the horror tag to give it that kind of staging," she said. Kajol said her character of Ambika deals with the "basic notion of the parent", which is to protect her child. "...and she wants to do everything that she can to protect her child from physical harm," she said.

At the end, the film turned out to be a learning experience for the actor. "From doing action, to working with VFX, all of it, and even the dramatic scenes... I love the music of the film, so it all came together really nicely,"

she said. Although Kajol has done a significant number of projects on OTT, including legal drama series "The Trial: Pyaar Kaanoon Dhokha" and suspense thriller "Do Patti", the actor said nothing beats the charm of watching movies in theatres.

"Cinemas still have magic, somewhere down the line... You just don't have that same vibe or feel when you're watching a movie at home. It's something that only a cinema theatre can give you," she said.

Jury returns to deliberate for a second day

NEW YORK, July 1: A jury returns to deliberate for a second day Tuesday at the sex trafficking trial of music mogul Sean "Diddy" Combs.

۲

On Monday, jurors deliberated over five hours without reaching a verdict after receiving instructions on the law from the trial judge, Arun Subramanian.

They are deciding whether prosecutors have proven racketeering conspiracy and sex trafficking charges during a trial that began in early May.

Prosecutors say Combs for two decades used his fame, fortune and a roster of employees and associates to help him coerce and force two different girlfriends to repeatedly perform sexually with male sex workers for days at a time while he watched and sometimes filmed the drug-fueled events.

Defense lawyers say prosecutors are unjustly basing federal crimes on what Combs did in the bedroom with his girlfriends as they participated in the swinger lifestyle and on acts of domestic violence involving their client.

Combs, 55, could face 15 years in prison to life behind bars if he is convicted of all charges. After pleading not guilty, Combs

chose not to testify as his lawyers

built their arguments for acquittal mostly through lengthy cross examinations of dozens of witnesses called by prosecutors, including some of Combs' former employees who took the witness stand reluctantly only after being granted immunity.

When jurors first left the room to begin deliberating on Monday, Combs sat for a while slumped in his chair at the defense table before standing and turning toward three rows of spectators packed with his family and friends.

Those supporters held hands and lowered their heads in prayer, as did Combs, who was several feet from them in the well of the courtroom. After they finished, they together applauded, and so did Combs, still clapping as he turned back toward the front of the room.

Combs also showed off two books he's reading: "The Power of Positive Thinking" by Norman Vincent Peale and "The Happiness Advantage" by Shawn Achor.

Barely an hour into deliberations, the jury foreperson sent a note to the judge, complaining that there was one juror "who we are concerned cannot follow your Honour's instructions. Alcaraz needs 5 sets to beat Fabio Fognini in the 1st round

locked in a five-set struggle at Centre Court, looked toward his coach Monday and shouted something about how Fabio Fognini - 38 years old, retiring after this season, winless in 2025 — looked as if he could keep playing until he's 50.

"I don't know why it's his last Wimbledon," Alcaraz said later, "because the level he has shown, he can still play three or four more years. Unbelievable.'

Such behavior wasn't displayed Monday. And when Alcaraz pushed a forehand long to cede the fourth set, Fognini nodded toward his guest box, where a member of his entourage stood to snap a photo with a cellphone. 

GEORGE'S (GRENADA), July 1: Australian spin great Nathan Lyon has no immediate plans of Test retirement as he yearns for one final away series win in India before calling time on his illus-

"I've always said I want to win away in India. I want to win away in England," Lyon was quoted as saying by cricket.com.au. "We've got that opportunity in a couple of years' time, but we've also got to take it Test by Test and make sure that we're doing everything here in West Indies right.

"Then we've got a massive summer at home with the Ashes. But another World Test Championship final would be on my cards for sure," he added.

India face selection conundrum in bid for comeback against England

BIRMINGHAM, July 1: India will need to shed their conservative selection approach and give themselves the best chance to take 20 wickets on what is expected to be another batting surface in the second Test against England, beginning here on Wednesday.

By the team management's own admission, India missed a specialist bowler at Leeds, Kuldeep Yadav to be specific, as England comfortably chased down a record 371 on day five of a game that the visitors should have won.

In the words of assistant coach Ryan ten Doeschate, India are grappling to find a team combination that doesn't compromise on batting depth and yet has the bowlers to take 20 wickets.

"In terms of managing the strategy there, we're looking at each bowler individually, feeling what we feel they can get wickets-wise. And then it's just trying to balance up and trying to calculate as best you can what the best chance of getting into the Test match.

"But you need 20 wickets. So the attacking party is obviously finding someone who can get wickets as well. And we are grappling with that. We don't stop talking about that. We're trying to figure it out." Doeschate admitted.

The weather has been rather hot in Birmingham and the surface, bound by a decent covering of grass, is dry under-

neath. On this very ground three years ago, England had gunned down a daunting 378 with ridiculous ease to draw the series. Of late, the same 22 yards have offered plenty of runs to the batters in county cricket.

The spinners will eventually come into the game and India need to decide whether they want someone like Washington Sundar who can assist Ravindra Jadeja or get Kuldeep, who is a much better wicket-taking option. What is confirmed is that India will go in with two spinners.

Shardul Thakur was the fast bowling all-rounder at Leeds but there is a strong possibility that batting all-rounder Nitish Reddy starts on Wednesday.

Thakur did not have the best of outings but dropping him after one opportunity would be borderline harsh on him.

The question mark ahead of the game is over Jasprit Bumrah's availability. If he doesn't play the second of his decided quota of three Tests, the pace line-up is expected to be Mohammed Siraj, Akash Deep and Prasidh Krishna.

With Bumrah hard to handle at the other end, the pacers did not have the required consistency in their lengths to test England batters. They would be wiser after that experience and if Bumrah doesn't play, will have a lot to prove.

Jadeja, who could not get much out of a turning pitch on day five at Headingley, would be eager to make an impact too.



India's catching would have to be a lot better after the horror show at Leeds, costing Yashasvi Jaiswal his spot in the slip cordon.

The batting department has a settled look though India would be desperate to add runs late in the innings after two lower-order collapses that cost them dearly.

The likes of K L Rahul, Jaiswal, Rishabh Pant and captain Shubman Gill

would be aiming to build on the gains made in the series opener.

Rookie Sai Sudharsan and comeback

man Karun Nair are certain to get another opportunity after an underwhelming start to the series.

England, on the other hand, seem to have added a method to their madness with a refined 'Bazball' approach that gives due respect to the conditions and the bowler.

Expected to make a comeback, Jofra Archer has pulled out of the match due to a family emergency but the Chris Woakesled pace attack would be high on confidence, having cleaned up India's tail twice and allowing the hosts to make a comeback in the contest.

Being a home hero, Woakes would be expected to provide the breakthroughs with the new ball after low returns in Leeds. Josh Tongue would be sniffing blood against India's fragile lower-order. Brydon Carse also improved as the game progressed while skipper Ben Stokes, by far, got the most out of the conditions.

Stokes dismisses Bumrah factor; declares himself massive fan of Pant

BIRMINGHAM, July 1: England captain Ben Stokes on Tuesday dismissed the chatter surrounding Jasprit Bumrah's availability for only three Tests out of five as "India's problem" and said he is expecting the "passionate" visitors to ight hard in the second Test irrespective of the team composition.

Bumrah was by far the best Indian bowler on show at Leeds, where the Shubman Gill-led side lost from a position of strength. The likes of Prasidh Krishna, Mohammed Siraj and Shardul Thakur were not consistent enough with their lengths to test the England batters. India have not decided which three Tests Bumrah will be a part of over the course of the English summer. He has played one, leaving him to feature in two out of the next four games.

However, Stokes and Co are not bothered about Bumrah's availability and are focusing on extending their series lead.

"That's India's problem. They will deal with it. I am captain of England," that is how Stokes handled the query on Bumrah.

Having said that, Stokes gave due respect to the opposition.

'Good team. They always fight hard, come hard. Very passionate team," he said when asked about the trailing Indian team.

"It's pretty clear that there's always pressure on shoulders of international sportsmen, but playing for India, especially in cricket, there's probably a bit more on any other nation. So, yeah, a very proud nation. Don't take anything for granted from last week. We start at 0-0 again.

England had chased down 371 on day five at Leeds to complete their second highest successful chase in Test cricket. The highest chase, 378, too came against India here at Edgbaston three years ago.

Stokes and Pant had a moment at Headingley as the latter charged down the ground against the England captain early in his innings. Stokes reacted to Pant's ploy with a hearty laugh.

What was all that about?

"Even though he's in opposition, I absolutely love watching Rishabh play cricket. I love the way he takes it on in all formats of the game. He's got a bit of stickiness in his time, but that type of talent, when you let that type of talent be free, that's what can happen in the last week," said Stokes. Pant became the first Indian wicketkeeper batter to smash two hundreds in a Test match, drawing praise from the world cricket fraternity.

DUBAI, July 1: India vicecaptain Smriti Mandhana on Tuesday moved up one spot to be ranked third in the ICC rankings for batters in women's T20 Internationals.

Mandhana, who is already world No. 1 in ODIs, made the leap after her maiden century in the opening T20I of the fivematch series against England last week in which she also stood-in for injured skipper Harmanpreet Kaur.

Mandhana smacked 15 fours and three sixes to make 112 off 62 balls to power India to a 97run victory against England at Nottingham, which was also the biggest defeat in terms of runs for the hosts in the shortest format. The left-handed Indian opener now has a career-high of 771 rating points and is ranked third, behind West Indies' Hayley Matthews, who is second with 774 points, and Australia's Beth Mooney at the top with 794 points.

"We have used the experience of the last 10 years and the new policy will work towards improvement of sports. Major objective is to make India a top-five sporting nation by 2047. That's the overall objective," Information and Broadcasting Minister Ashwini Vaishnaw told reporters while unveiling the policy and other cabinet decisions.

"The PM has given a different kind of emphasis to sports, especially

"It's a well thought through policy which addresses all matters related to sports. It also includes the framework for sports governance," he added.

India is bidding to host the 2036 Olympic Games for which there has been a massive push to create infrastructure and bring events of interna-

A statement from the Press Information Bureau described the new policy as an outcome of "extensive consultations" involving central ministries, NITI Aayog, state governments, National Sports Federations (NSFs), athletes, domain experts, and public stakeholders.

It seeks to link sports with tourism and economic development. "So many people travel to watch an IPL, a football game. So that boosts tourism and economic development," Vaishnaw said.

The document also seeks to align with the National Education Policy by making sports an integral part of school curriculum. It states that the objective is to equip educators and physical education teachers with specialised training to promote sports education. (PTI)

Prima facie RCB is responsible for the gathering: CAT blames IPL team for June 4 stampede

BENGALURU, July 1: The Central Administrative Tribunal (CAT) on Tuesday observed that the Royal Challengers Bengaluru are "prima facie responsible" for the stampede outside Chinnaswamy Stadium on June 4, which led to the death of 11 people.

Nearly 2.5 lakh fans thronged the MG Road and Cubbon Road areas near the stadium after RCB announced a victory parade from the Vidhana Soudha and a fan engagement programme at the stadium to celebrate the team's maiden IPL triumph.

"...therefore, prima facie it appears that the RCB is responsible for the gathering of about three to five lakh people. The RCB did not take the appropriate permission or consent from the Police," the CAT noted.

"Suddenly, they posted on social media platforms and as a result of aforesaid information the public were gathered," added the CAT in its observation.

The RCB had posted in its social media handles about the parade and the fan engagement on the morning of June 4, and the Tribunal noted that the police department did not have sufficient time in its hands to manage such a large gathering at such short notice. "Because of shortage of time on 04.06.2026, the Police was unable to do the appropriate arrangements. Sufficient time was not given to the Police. Suddenly, the RCB created the aforesaid type of nuisance without any prior permission. (PTI)

In that case Kuldeep Yadav and Washington (whose batting skills match Jadeja's) can play since it would be difficult to stop rampaging English batters on a good batting surface without a wrist spinner.

If one takes a cursory look at Jadeja's track record in Test matches in England, it is pretty deflating. Just 28 wickets in 13 Tests and not a single fifer. His strikerate is a dismal 102.6 which is more than 17 overs for one wicket. In the second innings. Ducket attempted more than 30 reverse sweeps with fair degree of success and it can be attributed to the natural speed of Jadeja's deliveries.

If one looks at classical left-arm Test spinners from India - from legendary Bishan Singh Bedi to the talented duo of Maninder Singh and Murali Kartik, all of them gave more revolutions to the ball and imparted a lot of side-spin while DREAM

bowling in England or while playing in English County cricket or league cricket. In case of Jadeja his natural speed while landing the ball on the rough is becoming a problem, feels a lot of analysts. "If a batter is intent on playing reverse

sweep, he always likes pace on the deliveries. It then becomes easy to execute when those deliveries land on the rough outside the left-handed batter's off-stump," a former left-arm spinner, who has extensive knowledge of English conditions but did not wish to be named, told PTI.

"If you observe minutely, deliveries bowled with a certain speed on the rough won't turn. That was specifically what happened with Jadeja. He never reduced the pace on deliveries."

Why Bishan Bedi or even Maninder Singh were successful at Leeds on the 1986 tour? Maninder had figures of 4/26 in little over 16 overs on a damp fourth morning. The reason was that their natural speed was on the slower side.

That allowed them to put more revs on the ball, keep it hanging in the air to cre-

ate deception. To execute reverse sweep the batter had to fetch the ball. If the pace is slow, the ball will jump and turn after hitting the rough, denying the batter any chance to use the pace.


In case of Jadeja, the problem is his muscle memory. He is so used to hitting the same area with more or less identical speeds, slowing it down considerably can lead to losing the length and bowling more hittable balls. His arm speed needs to remain same as slowing the arm speed will also lead to slower release which isn't permissable. On rank turners, a bowler just needs to land the ball in one

spot on the stump channel and let the pitch do the rest. Even Jadeja won't be able to tell which ball would come in with angle, and which one would turn away (from right handers) and which one would go straight.

During the 2013 Australia series then skipper Mahendra Singh Dhoni wanted spinners to take lead from first hour. The whole pitch, not just sides becomes scuffed up and Jadeja became unplayable. But in England, one needs to extract turn and not have set plans as conditions change so rapidly over five days.

Edgbaston will be a different challenge and Jadeja knows it too well as in 2022, Jonny Bairstow and Joe Root flaved him in the second innings where he went for 62 in 18.4 wicket-less overs. Edgbaston is primarily a good batting strip and this is one ground where the team management might think twice before playing Jadeja. Lord's brings with itself, a different set of

challenges due to the famous slope on the Nursery end. (PTI)
