Eviction drive launched to clear encroached village in Nalbari dist



NALBARI, June 30: The Assam government launched an eviction drive on Monday morning to clear encroachments from 82 bighas of village grazing reserve (VGR) land in Assam's Nalbari district, offi-

The eviction drive began at

Bakrikuchi village under Borkhetry revenue circle early in the morning amid tight security.

No untoward incidents have been reported so far, District Commissioner Nibedan Das Patowary told reporters here. Through a notice, the circle of-

fice on June 3 asked the encroachers at VGR to clear the land but the residents approached the Gauhati High Court which ruled that all VGR lands across the state must be

VGR land is designated for the specific purpose of cattle grazing in villages.

"The people residing on the encroached land cooperated with the district administration and over 70 per cent of them had moved out with their belongings," Patowary said. Around 300 families had settled on the VGR and they are cooperating with the administration,

Around 500 security personnel have been deployed in the area and more have been kept on standby to prevent any untoward incidents, IGP (Law and Order) Akhilesh Kumar Singh, who is also camping at the site, said. "The eviction has been peaceful so far and we have not faced (CONTD. ON PAGE-2)

State tightens Aadhaar rules to curb illegal infiltration

GUWAHATI, June 30: In a significant move to strengthen identity verification, the Assam government on Monday announced stricter measures to prevent the alleged misuse of Aadhaar cards by illegal immigrants.

Chief Minister Himanta Biswa Sarma said the state will soon implement a district administrationled process for issuing Aadhaar cards to adults to curb fraudulent enrollments

"Time's up for fake Aadhaar cards in Assam!" Sarma posted on X. "We are making the process stricter to ensure no infiltrator secures the document illegally and disrupts national harmony.

Under the new policy, only Deputy Commissioners (DCs) will be authorized to issue Aadhaar cards to adults, replacing the cur-



rent system to eliminate loopholes. The CM said the move aligns with Assam's broader goal of becoming "Infiltrator Mukt" (free of illegal immigrants), vowing, "We will not

stop until this is achieved.' The decision follows rising concerns over fake Aadhaar cards being used to access government

registration, which officials say threatens national security and demographic balance.

A senior official stated that fraudulent documents have enabled illegal residents to avail benskewing distribution.

"Assam is now the first state to centralize Aadhaar issuance for adults under district magistrates, adding an extra layer of scrutiny. The move is expected to intensify verification, especially in border areas and regions with sensitive demographics," he added.

Authorities have urged citizens to report suspected cases of fake Aadhaar usage, emphasizing that the crackdown is crucial to maintaining law and order while ensuring rightful access to state resources. The new system is likely to be rolled out in the coming days

CM reviews Bio-Ethanol Project at NRL, inaugurates Dhansiri Nagar Township

PM to dedicate India's first bamboobased bio-refinery on September 8

GUWAHATI, June 30: Chief Minister Himanta Biswa Sarma on Monday visited the Numaligarh Refinery Limited (NRL) in Golaghat district to review the ongoing construction of India's first bamboo-based bio-refinery and assess the overall progress of the refinery's expansion projects.

The Chief Minister's visit comes in the lead-up to Prime Minister Narendra Modi's scheduled tour of Assam on September 8, during which he is expected to inaugurate the bio-refinery and dedicate the facility to the nation. According to an official statement, chief minister

Sarma chaired a high-level review meeting with senior NRL officials, state ministers, Members of Parliament, and local MLAs to evaluate the pace and quality of work underway at the site.

The bamboo-based ethanol plant, currently under construction with an investment of ₹4,000 crore, will mark a milestone as the country's first dedicated bamboo bio-refinery.

During the meeting, the Chief Minister examined key progress indicators related to the plant's construction, technological installations, supply chain systems for bamboo procurement, and readiness for

Following Raja Raghuvanshi's murder, tourists visiting Meghalaya must hire guides



SHILLONG, June 30: In a move aimed at enhancing the safety of tourists, the authorities in Meghalaya have made it compulsory for visitors to hire guides while participating in outdoor activities within the East Khasi Hills district, officials said on

The orders came a month after Indore businessman Raja Raghuvanshi's murder, planned by his

"In view of safety reasons, it is now mandatory for all tourists to take the services of a registered tourist guide while undertaking treks (and outdoor activities) in the area," East Khasi Hills Deputy Commissioner Rosetta M Kurbah said in an order.

the Sohra region of the state.

Mandatory guide services will not only ensure better safety for visitors but also help prevent intaining injuries, or being vulnerable to criminal activities in isolated areas, she said.

Kurbah who is also the Chairperson of the District Tourism Promotion Society (DTPS) cited safety and security concerns following the Raja Raghuvanshi murder case that shook the state which also led to the arrest of eight people from Indore.

Tourism officials said the order would be strictly enforced, and violators may face penalties or be denied access to trekking routes.

The administration also plans to deploy more trained guides and work with local communities to implement the directive effectively. The East Khasi Hills District has popular trekking destinations such as the doubledecker living root bridge, waterfalls and meadows. The tourism department has emphasised the need for better safety measures to protect the region's reputation as a safe and serene tourist destina-

Trade talks with US enters crucial phase

India toughens stance on agri issues

NEW DELHI, June 30: India has hardened its position on issues related to agriculture as negotiations with the US team in Washington have entered a crucial stage, an official said on Monday. The official also said that the stay of the Indian team, headed by special secretary in the department of commerce Rajesh Agrawal, is expected to be extended further.

The team is in Washington for negotiations on an interim trade agreement with the US. Both sides are rushing to close a deal ahead of the July 9 deadline for the full implementation of a 26 per cent reciprocal tariff which has been suspended since April.

"If the proposed trade talks fail, the 26 per cent tariffs will come into force again," the official added. The stay of the Indian officials has already been extended for three days until June 30. Initially, the delegation was scheduled to stay for two days with the talks having commenced on June 26.

Another official said that the commerce ministry has informed domestic exporters and industry that the talks are on for the first phase of the proposed bilateral trade agreement. There would be more phases.

These talks are significant as both countries are engaged in negotiations for an interim trade deal and are trying to finalise the pact before



pensions of reciprocal tariffs imposed by the Oonald Trump administration on April 2.

On April 2, the US imposed an additional 26 per cent reciprocal tariff on Indian goods but suspended it for 90 days. However, the 10 per cent baseline tariff imposed by America remains in place. India is seeking full exemption from the additional 26 per cent tariff.

The US is demanding duty concessions in both agriculture and dairy sectors.

But these segments are difficult and challenging areas for India to give duty concessions to the US as Indian farmers are into sustenance farming and have small land holdings. Therefore, these sectors are politically very sensitive. India has not opened up dairy sectors for any of its trading partners in any free trade pacts the

1,500 cows sacrificed in **Dhubri during Eid: Himanta**

GUWAHATI, June 30: Chief

Minister Himanta Biswa Sarma on Monday alleged that approximately 1,500 cows were sacrificed during Eid al-Adha celebrations in Dhubri district, expressing dismay over what he called a lack of media and public attention to the incident.

"I have received reports that around 1,450 cows were slaughtered in Dhubri in the name of Qurbani (ritual sacrifice). This is deeply painful and unacceptable. What's more concerning is that this mass sacrifice went largely unreported," Sarma told journalists.

BRICS summit expected to denounce Pahalgam terror attack; Animals are 'jeevan dhan', term 'pashu' inappropriate: Murmu call for fight against terrorism

NEW DELHI, June 30: The BRICS leaders' declaration to be unveiled at the grouping's annual summit in Rio de Janeiro is set to forcefully denounce the Pahalgam terror attack and call for a firm approach to unitedly confront terrorism in line with India's expectation.

Prime Minister Narendra Modi will attend the summit in the Brazilian city on July 6 and 7. India will be the grouping's chair for the next year. The prime minister is travelling to Brazil as part of his five-nation tour from July 2 to 9. The other countries that the prime minister is visiting are Ghana, Trinidad and Tobago, Argentina and Namibia.

Dammu Ravi, secretary (economic relations) in the external affairs ministry, told a media briefing that Modi's participation in the summit will be an expression of India's solidarity with the bloc and it will be a great opportunity for him to connect with the leaders of the Global South. Ravi suggested that the BRICS leaders' declaration will have reference

to the challenge of terrorism that will be much to the satisfaction of India. "There is no contradiction in the way the members have come out with their understanding, sympathy and solidarity with India on Pahalgam I think this has been very well captured in the (leaders) declaration and all

the members are very sensitive to this matter," he said. "There is also a broader understanding on how to deal with this menace of terrorism and no one should be spared in dealing with it. I think that is very well captured." "When you get the declaration, you will see the language is much to our satisfaction," Ravi added. BRICS brings together 11 major emerging economies of the world, representing around 49.5 per cent of the global population, around 40 per cent of the global GDP and around 26 per cent of the global trade. President Murmu highlights animal welfare, biodiversity loss, and the cultural bond between humans and animals

BAREILLY, June 30: President Droupadi Murmu on Monday said she feels that using the word 'pashu' for animals was "inappropriate" and referred to them as

jeevan dhan' or wealth of life. Speaking at the 11th convocation ceremony of the Indian Veterinary Research Institute (IVRI), Murmu said life without animals cannot be imagined.

ICAR-IVRI in Izatnagar is dedicated to research and development in the field of veterinary and animal sciences.

"When you work as a (veterinary) doctor, you should always have the welfare of animals in mind. The environment that I come from is close to nature. Humans have a relationship with forests and wild animals," Murmu said.

"Today, we have technology, but in the past, they (animals) were our 'saadhan' (for transportation) and 'bal' (strength) for the farmers. Hence, I do not find the word 'pashu' appropriate for animals as they are 'jeevan dhan'. We cannot



added.

She said in the Indian culture, the presence of God is seen in all creatures. "The belief that our Gods and sages communicated with animals is also based on the

same philosophy," she said. Murmu noted that several species of animals have either be-

come extinct or are on the verge of extinction and emphasised that their conservation is crucial for biodiversity and the health of the Earth. She said the power of thinking and understanding that God has given to humans should be used for the welfare of all living beings.

Citing an example, Murmu said during her childhood days, vul-

tures were a common sight, but that is not the case today.

The chemical drugs used in veterinary medicines could be behind the dwindling numbers of some species of the bird. Banning such drugs is a commendable step towards the conservation of vultures, she said.

"The Covid pandemic warned us that a culture based on consumption can cause unimaginable damage not only to mankind but also to other living beings and the environment," she asserted.

She also appealed to the IVRI and other institutes to play a leading role in increasing biodiversity, prevention and control of zoonotic diseases, and finding indigenous and low-cost treatments and nutrition for animals.

The President lauded the stucareer that involves treating animals and urged them to establish start-ups in various fields of animal science so that they can generate employment and contribute to the country's economy

Murmu pointed out that the concept of 'one health' -- that humans, domestic and wild animals, flora and the wider environment are all interdependent -- is gaining importance across the world.

The President said technology, like other fields, has the potential to bring revolutionary changes in veterinary medicine and care. The use of technologies like genome editing, embryo transfer technologies, artificial intelligence, and big data analytics can bring revolutionary changes in this field, she said.

Murmu arrived in Bareilly earlier in the day and was welcomed by Uttar Pradesh Chief Minister Yogi Adityanath and Governor Anandiben Patel.

Industrial output growth slows to 9-month low of 1.2 pc in May

NEW DELHI, June 30: India's industrial production growth slowed to a nine-month low of 1.2 per cent in May 2025 due to poor performance of manufacturing, mining and power sectors caused by the early onset of Monsoon, according to official data released on

The factory output, measured in terms of the Index of Industrial Production (IIP), had expanded by 6.3 per cent in May 2024.

The National Statistics Office also revised downward the industrial production growth for April to 2.6 per cent from the earlier estimate of 2.7 per cent reeased last month

The previous low was observed in August 2024 when IÎP remained unchanged.

The NSO data showed that the manufacturing sector's output growth decelerated to 2.6 per cent in May 2025 from 5.1 per cent in the year-ago month.

against a growth of 6.6 per cent a year ago. Power production declined by 5.8 per cent in May 2025 against 13.7 per cent growth in the year-ago period.

During the April-May period of FY26, industrial production grew by 1.8 per cent compared to 5.7 per

Mining production contracted by 0.1 per cent

Aditi Nayar Chief Economist, Head - Research & Outreach, ICRA said, "The early onset of the monsoon doused activity in mining and the demand for electricity, with both these sub-sectors of the IIP reporting a contraction in May 2025, amidst an anaemic growth of manufacturing.

Moreover, the underlying trends were uneven, with three of the use-based categories displaying a contraction, amidst a continued high 14.1 per cent expansion in capital goods, boosted by a low base, Nayar said.

Tepid industrial volume growth in the first two months of the quarter does not augur well for industrial GVA (gross value added) growth in Q1 FY2026,

As per use-based classification, the capital goods segment growth accelerated to 14.1 per cent in May 2025 from 2.6 per cent in the year-ago period. Consumer durables (or white goods production) contracted by 0.7 per cent during the reporting month against a growth of 12.6 per cent in May 2024.

In May 2025, consumer non-durables output contracted 2.4 per cent compared to a growth of 2.8 per cent a year ago. (PTI)

any resistance. A total of 452 bighas have been encroached. But people have built houses only on 82 bighas. They use the remaining area for fisheries and agriculture. A report is being prepared and action will be taken accordingly, a circle official said. There are also schools, mosques and Anganwadi centres in the village.

Altogether 12 bulldozers have been pressed into service to demolish the unauthorised structures. Many of the encroachers were seen camping with their belongings on the main road leading to the village and they demanded that they should be adequately rehabilitated. This is the second eviction drive in June. The earlier drive was carried out on June 15 and 16, when 667 families in Hasilabeel village in Goalpara district were evicted.

Chief Minister Himanta Biswa Sarma had recently said that eviction drives to clear encroached land will continue. Many eviction drives have been carried out over the last four years, and his government has ensured that the cleared land is not encroached upon again, Sarma said. "We have conducted at least one eviction drive in each district, and our biggest achievement is that now people are afraid to settle on encroached land," Sarma

CM reviews Bio-Ethanol Project

The chief minister stressed the strategic importance of the project, both in terms of India's push toward green energy and for the economic upliftment of bamboo farmers across the Northeast. Sarma also reviewed preparations for Prime Minister Modi's proposed visit to the refinery site in September.

He emphasised that the Prime Minister's inauguration of the ethanol facility would be a landmark moment for Assam and the country's renewable energy journey.

In addition to the review, the Chief Minister formally inaugurated the Dhansiri Nagar Township, a newly developed residential complex built to accommodate refinery staff and their families. The township is equipped with modern amenities, designed to provide a comfortable and efficient living environment for NRL employees. Ministers present during the visit included Agriculture Minister Atul Bora, Finance Minister Ajanta Neog, Public Health Engineering Minister Jayanta Mallabaruah, and Minister for Tea Tribes and Adivasi Welfare Ru-

MP Kamakhya Prasad Tasa, MLAs Bhabendra Nath Bharali, Mrinal Saikia, and Biswajit Phukan also participated in the deliberations alongside senior officials from the state government and NRL. Meanwhile, the chief minister visited Bokakhat Circuit House later in the day to meet security personnel injured in the recent grenade blast incident at Bokakhat.

He enquired about the medical condition of the injured personnel—Siddhartha Borbora, Sushil Bhowmick, and Mintu Hazarika—and conveyed his wishes for their speedy recovery. The visit underscored the government's focus on industrial development, sustainable energy, and the welfare of both frontline workers and the refinery's workforce, as per the official statement.

Trade talks with US enters

The pact is aimed at more than doubling bilateral trade to USD 500 billion by 2030 from the current USD 191 billion. Before the first tranche, they are trying for an interim trade pact.

The US team was here from June 5 to June 11 for the talks. The negotiations will continue both virtually and physically in the days to come. India's merchandise exports to the US rose by 21.78 per cent to USD 17.25 billion in April-May this fiscal, while imports rose by 25.8 per cent to USD 8.87 billion. (PTI)

Two arrested for running fake lottery scam in Jorhat

with assistance from Nagaon police, arrested two individuals from Kochuwa in Nagaon district for allegedly defrauding people through a fake lottery scheme.

The accused have been identified as Ashikur Rahman (19) and Elias Ahmed (20).

In a statement issued on Sunday, Jorhat Superintendent of Police Shwetank Mishra informed that the duo had circulated social media posts featuring photographs of lottery tickets and images of fourwheeler vehicles as prizes, falsely claiming that a lottery would be held at Harimandir in Duliagaon, Jorhat.

However, during the enquiry, police found that no such Harimandir exists in Jorhat, and uncovered a larger scam where people were lured into paying ₹ 200 per ticket under the pretext of winning prizes through the non-existent lot-

Based on the findings, Jorhat Police registered a case under Jorhat Police Station Case No. 319/2025.

297(2)/316(2)/318(4)/61(2) of the Bharatiya Nyaya Sanhita (BNS), 2023, read with Section 7(3) of the Lotteries (Regulation) Act, 1998.

During the investigation, police seized two mobile phones from the accused containing several images of lottery tickets and recovered ₹ 70,000 in cash. Further investigation is underway to trace the full extent of the scam.

China's Tsangpo dam poses major risk to Assam, warns expert at Dibrugarh lecture

HT Correspondent DIBRUGARH, June 30: As part of its

Golden Jubilee celebrations, the Dibrugarh Press Club on Monday organised a lecture under its "Aamar Alohi" series at Jagriti Hall on the topic "Mega Dam on Yarlung Tsangpo and Its Possible Impact: From Dibrugarh to Guwahati and Bangladesh.

Delivering the lecture, eminent geologist and retired Dibrugarh University professor Dr Jogendranath Sharma warned that China's proposed Medog Hydropower Project could trigger severe natural disasters downstream in Assam. Approved in December 2024, the 60,000-MW project—60 times larger than India's biggest dams—is being constructed in the seismically active and ecologically sensitive Medog

Dr Sharma highlighted threats such as erosion from "hungry water," groundwater disruption, altered monsoon patterns, and risks to biodiversity and the livelihoods of over two million



He called for a joint Indo-China Environmental Impact Assessment and cautioned that a dam collapse during an

earthquake could lead to devastation akin to the 1950 Assam earthquake. While noting that the Yarlung Tsangpo contributes only around five percent of the Brahmaputra's flow in

Bangladesh, Sharma emphasised that the potential risks of the dam remain significant. He also referred to India's proposed

11,000-MW Siang project as a possible countermeasure, though it too raises environmental concerns.

A delegation from the Siang Indige-Farmers Forum (SIFF), Arunachal Pradesh, also participated in the programme and voiced their opposition to the Siang Upper Multi-Purpose Project, to be implemented by NHPC on the Siang river. The event was anchored by Dibru-

Chirag Paswan stuns Nitish

The political activity in Bihar is intensifying due to Lok Janshakti Party boss Chirag Paswan's decision to contest the Bihar election this year, despite already being an MP and a union minister. However, this move does not seem to have gone down well with Janata Dal United. An anxious Nitish recently interacted with Chirag during the Prime Minister's Bihar visit and asked him: "Why do you want to contest the Bihar Assembly election? You are young and presently a Union Minister after winning three consecutive Lok Sabha elections. What is the need for you to contest an Assembly election when you are enjoying vour stint as a Union Minister?" Chirag reportedly told Nitish that 'Bihar is calling him'. His party has, therefore, decided that he should contest the Assembly elections. On the other hand, Union Minister Chirag Paswan's party MP and brother-in-law, Arun Bharti, has hit out at the caste survey, which was conducted by the Nitish Kumar-led Mahagathbandhan government in Bihar in 2023, calling it a fraud and conspiracy against the marginalised sections of the society, including the Dalits and Adivasis. However, Paswan's planned Bahujan Bhim Sankalp rally on 29 June -- a show of his party's strength in Nitish Kumar's home district -- has also triggered alarm bells within the JD(U).

According to NDA sources, the JD(U) is expected to get more seats than the BJP. As Chirag Paswan's party had 100 percent strike rate in Lok Sabha polls, winning all five seats, it may ask for nearly 30 to 35 seats. The final seat-sharing formula is likely to be announced by August, while the candidate selection will follow soon to allow contestants to rally support ahead of the polls. The BJP's intention to give Nitish Kumar a marginal edge in terms of seats allocated might be a tactic to pacify the JDU leader ahead of this election, given Chirag Paswan's presence. Publicly, the BJP has backed Nitish Kumar to remain as Chief Minister, but sources say some within it lean in favour of Chirag Paswan, setting up a possible face-off. As the high-stakes fight for Bihar inches closer, Leader of the Opposition Tejashwi Yadav made an appeal to the youth of Bihar to give him a time of 20 months to change the face of the state, citing Chief Minister Nitish Kumar's example, whom they had given some 20 years.

Addressing the 'Chhatra Yuva Sansad' organised by the Rashtriya Janata Dal (RJD) at Patna's Bapu Sabhagar, Yadav announced his plans if elected, his government would create jobs and establish a Youth Commission, make forms for competitive examinations free of cost, provide home tutors to academically weaker students, and ensure free transportation to examination centres. Tejashwi also assured the audience that, if voted to power, his concern would remain on governance rather than blaming the past. Meanwhile, amid protests by opposition parties, the Election Commission has said the special intensive revision is needed as the electoral roll keeps changing due to a variety of reasons and the Constitution mandates it to ensure that only eligible citizens are part of the voters' list and those not, do not get to vote

ndia marks National Doctor's Day on July 1st each year, a solemn occasion to honor the tireless dedication, compassion, and sacrifice of its medical professionals. His tenure as the second Chief Minister of West

Iran's Supremo Ayatollah Khamenei challenges Trump's exaggerated claims

ith Donald Trump at the helm of the United States, wars have become a joke. They finish quickly as lightning. India's war with Pakistan lasted all of 4 days. The Iran-Israel war was over in 12 days. Gaza is a different take. But in India-Pakistan and Iran-Israel, a third country forced its views in with the President of that country causing confusion – US President Donald Trump.

Last Friday, Trump repeated that it was he who stopped the India-Pakistan war from going nuclear and that he did this by ordering his administration to "cancel all deals" with the two countries. Earlier, he had claimed that he offered them mouthwatering "sweetened trade deals" in lieu of war. Problem is, Trump is always talking 19 to the dozen and he marks shifts with gay abandon. "We did some great work. India and Pakistan. That was going to be maybe nuclear. We did that. We did a lot of work. I don't know if there's ever been a president that's done much more," Trump said on Friday.

Trump was in an expansive mood. The US Supreme Court had just then limited the power of lower courts in a birthright citizenship case and President Trump couldn't have asked for more. Without preamble, Trump repeated that he stopped a nuclear war by threatening that "Washington will stop trade" with Delhi and Islamabad.

"Serbia, Kosovo is going to go at it, going to be a big war. I said, 'You go at it, there's no trade with the United States.... That's what happened with India and Pakistan. I was negotiating with both of them and I said...cancel all deals with India and Pakistan. They're not trading with us because they're in a war," Trump said.

Who is lying, Prime Minister Narendra Modi or President Trump? India's Foreign Secretary Vikram Misri vouched for Prime Minister Narendra Modi. Nobody so far, anybody from the Trump administration, has vouched for President Trump. Neither Vice President JD Vance nor Secretary of State Marco Rubio or Defence Secretary Pete Hegseth.

The "ceasefire" between India and Pakistan was on the urgent request of Pakistan's DGMO. Trump claims 'the two countries called back'. I said, "Look, you want to have trade with the United States. It's great, but you want to go and start using nuclear weapons...we're not going to allow that. And they both agreed, both have great leaders...So we did a lot," President Trump said. India still hasn't succumbed to Trump's delu-

sion. India also doesn't call it a "ceasefire". As far as India is concerned, it's an "understanding" worked out on May 10 by the DGMOs of India and Pakistan. Also, as far as India is concerned, 'Operation Sindoor' hasn't been called off, yet. If Pakistan enacts another instance of cross-border terrorism, all bets are off.

President Trump wants the Nobel Peace Prize and the USA is banking on wars to land President Trump the 'Nobel Peace Prize'. Trump is desper-

ate for a ceasefire. It didn't happen with Russia-Ukraine and Trump made sure India and Pakistan went after each other for Trump to claim credit for a "ceasefire".

It is another matter that India does not and will "never accept" mediation on Kashmir. Now, in the latest, President Trump says that but for him, Iran's "Supreme Leader Ayatollah Ali Khamenei", wouldn't have been around. "I saved him from an ugly and ignominious death," Trump said and Iran's Foreign Minister Abbas Araghchi asked Trump to watch his "tone".

While delivering a victory speech, Khamenei had said that the US President had "exaggerated events in unusual ways" the previous day. "If President Trump truly wishes to reach an agreement, he should set aside his disrespectful and unacceptable tone towards the Iranian Supreme leader, Grand Ayatollah Khamenei, and stop hurting his millions of sincere supporters," Araghchi posted to X.

Araghchi also said that the Israeli regime "had NO CHOICE but to RUN to Daddy" to avoid being "flattened by our Missiles", adding that Iranians valued their independence and did not take kindly to "threats and insults".

Khamenei said the US President needed the "exaggeration" and that "the Islamic republic won", delivering "a severe slap to the face of America", to which Trump shot back, "I saved Khamenei from an ugly death", questioning Khamenei's declaration of victory in the war against Israel, asking why the Supreme Leader had "blatantly and foolishly" claimed victory "when he knows his statement is a lie, it is not so. As a man of great faith, he is not supposed to lie," Trump said.

Trump spoke the truth when he said Iran had been "decimated", and that Iran's three "evil nuclear sites" had also been "obliterated". Trump also claimed he knew "exactly" where Khamenei was sheltered and that he had not allowed Israel and the US armed forces to take Khamenei's life.

The fact is, despite these "facts" and clarifications, Trump still does not have a "ceasefire" to flaunt with and get a Nobel in return. Also, far less influential global leaders are holding the most-powerful man on the planet to ransom, putting a question mark on whether it is unilateralism or multilateralism that rules the world.

The US President said that he was "was working on possible removal of sanctions against Iran" and this would have given Iran a much better chance "at a full, fast, and complete recovery", but had "dropped all work on sanction relief" after being "hit" by Khamenei's statement of "anger, hatred, and disgust."

Trump predicted bad things ahead for Iran. "They are always so angry, hostile, and unhappy, and look at what it has gotten them - A burned out, blown up Country, with no future, a decimated Military, a horrible Economy, and DEATH all around them." The only problem is, such a dark prognosis will not fetch a Nobel Peace Prize for President Trump! (IPA Service)

India's diplomatic isolation was firmly evident at the SCO meet in Qingdao in China

India's total diplomatic isolation was in show in the Shanghai Cooperation Organisation (SCO)'s defence ministers meet in Qingdao city in China on June 25 and 26 when a joint statement was prepared calling upon the members to jointly fight terror but there was no mention of Pahalgam killings on April 22 while taking note of attacks in Balochistan.

The joint statement was prepared after discussions among the members including India and Pakistan at the meet presided over by China, the host nation for 2025 summit. Indian defence minister Rajnath Singh strongly spoke against terror during the deliberations focusing on the Pahalgam massacre and the consequent action of India to dismantle the terror camps in Pakistan through Operation Sindoor. But the joint statement on the final day did not incorporate Indian point on Pahalgam terror while the Pakistani point on Balochistan was included.

Naturally, Singh did not sign this one sided declaration. The norm in SCO is that every resolution will have to be on the basis of consensus. So as a result of India's objection, the joint statement could not be issued. Pakistan is happy that India was alone in not signing. So it was a diplomatic victory for Islamabad which is engaged with India in a perception battle after Pahalgam killings and Operation Sindoor, to influence the global opinion.

SCO has presently ten members- China, Russia, India, Pakistan, Iran, Belarus, Kazakhstan, Kyrgyzstan, Tajikistan and Uzbekistan. Indian officials claimed that the statement was tuned in favour of Pakistan by China. Fine enough. It might be true. But then what about the other seven members including Russia? It was a sheer failure of our foreign office that all the central Asian member states of the SCO did not come in support of India. Even Russia did not intervene to amend the statement to incorporate Indian view. In all in SCO, out of ten members, excepting India, no other country was against the statement. It was a clear 9-1 in favour of Pakistan.

The SCO summit of head of states will be held later this year in Tianjin in China. Prime Minister Narendra Modi will be attending the SCO summit, it is stated. He will be meeting there the Chinese President Xi Jinping, Russian President Vladimir Putin, Pakistan Prime Minister Shehbaz Sharif as also the other leaders. The issue of fighting terror will also figure at that summit like the latest meeting of defence ministers. What is Prime Minister of India going to do to ensure that the summit declaration finally contains the Indian viewpoint.?

Even before that SCO summit later this year, BRICS summit will be held in Brazil on July 6 and 7. Indian PM will be attending that. At that meeting also, the fight against terror issue will come up. Pakistan is not a member of BRICS. That way that pressure from Islamabad which was there on the Qingdao meeting, will not be there in Brazil summit. But every country has taken some position and that does not change suddenly. It requires constant persuasion and presentation of facts. Rajnath Singh and his team totally failed at Qingdao meeting to convince the members of the SCO. That should not be repeated at the Brazil summit. Only few days are left for the BRICS summit. In these eight days, Indian diplomats have to make all efforts to meet the member countries and convince them of Indian position with full facts about the involvement of Pakistan with terror attacks against India. China says Sino-India border dispute complicated, takes time; Ready to discuss delimitation



BEIJING, June 30: China on Monday said that the boundary dispute with India is complicated and will take time to settle but at the same time, it expressed its readiness to hold discussions on the delimitation of the border

Defence Minister Rajnath Singh in his meeting with Chinese counterpart Dong Jun in Qingdao on June 26 proposed that India and China should solve the "complex issues" under a structured roadmap comprising steps to de-escalate tensions along the frontiers and rejuvenate the existing mechanism to demarcate the borders.

Singh and Dong held bilateral talks on the sidelines of a conclave of the Shanghai Cooperation Organisation (SCO) in the Chinese port city of Qingdao, with a focus on maintaining peace and tranquillity along the Line of Actual Control (LAC).

Asked for China's reaction to Singh's remarks, Foreign Ministry spokesperson Mao Ning said. What I can tell you is that China and India have established the Special Representatives (SRs) mechanism on the boundary question and reached the Agreement on the Political Parameters and Guiding Principles for the Settlement of the China-India Boundary Question".

The two sides have diplomatic and military communication mechanisms at various levels, she said.

China stands ready to maintain communication with India on issues including delimitation negotiation and border management, jointly keep the border areas peaceful and tranquil, and promote cross-border exchange

and cooperation, she said. Questioned about the prolonged delay in resolving the border issue despite 23 rounds of the SR-level talks, Mao said, The boundary question is complicated, and it takes time to settle it.

The positive side is that the two countries have already established mechanisms at various levels for thorough communication. We hope that India will work with China in the same direction, continue to stay in communication on relevant issue and jointly keep the border areas peaceful and tranquil, she

The 23rd round of the meeting of the SRs, National Security Advisor Ajit Doval and Chinese Foreign Minister Wang Yi, was held here in December last year. It was the first meeting of the SRs since frictions had emerged in the Western Sector of the India-China border areas in 2020.

The SRs in their meeting positively affirmed the implementation of the latest dis-

In his meeting with Dong, Singh had emphasised the need to create "good neighbourly conditions" to achieve the best mutual benefits and called for "taking action on the ground" to bridge the "trust deficit" resulting from the 2020 eastern Ladakh bor-

der standoff, according to an Indian readout. Singh also briefed Dong on the Pahalgam terror attack targeting innocent civilians, and India's Operation Sindoor to dismantle the terrorist networks in Pakistan.

The Singh-Dong meeting came amid efforts by both New Delhi and Beijing to reset their ties following an understanding last October to end the military standoff along the Line of Actual Control (LAC) in eastern Ladakh. (PTI)

2 killed, 1 wounded in sniper ambush as Idaho firefighters come under siege from rifle fire

BOISE, June 30: Two firefighters were killed Sunday and another was wounded when they were ambushed by sniper fire while responding to a blaze in a northern Idaho mountain community. as crews endured a barrage of gunfire over several hours that the governor called a "heinous" assault.

A shelter-in-place order was lifted Sunday night after a tactical response team discovered the body of a man with a firearm nearby, the Kootenai County Sheriff's Office said. Officials did not release his name, nor did they say what kind of gun was found.

Authorities planned a news conference later Sunday to provide more information

Sheriff's officials said crews responded to a fire at Canfield Mountain just north of Coeur d'Alene around 1:30 pm, and gunshots were reported about a half hour later.

Sheriff Bob Norris earlier said officials weren't immediately sure how many people were shot and deputies were "actively taking sniper fire as we speak.'

victims brought to Kootenai Health, said hospital spokesperson Kim Anderson. Two were dead on arrival and the third was being treated for injuries, Anderson said. The wounded firefighter's condition wasn't known.

An alert by the Kootenai County Emergency Management Office asked people to avoid the area around Canfield Mountain Trailhead and Nettleton Gulch Road, about 6.5 km north of downtown Coeur d'Alene. Though the shelter-in-place order was lifted, the sheriff's office cautioned residents to be prepared because the fire

was still burning. The FBI responded to the scene with technical teams and tactical support, Deputy Director Dan Bongino said.

The Idaho House Republican Leadership said in a statement: "We are horrified by the murder of two firefighters in Coeur d'Alene, and shocked by such a vicious attack on our first responders. We are praying for them, the injured, their families and their colleagues."

Coeur d'Alene is a city of

55,000 residents near the border with Washington. Canfield Mountain is a popular hiking and biking area on the city's outskirts, covered with trees and heav brush and crisscrossed with trails that lead into a national forest. Fire is always a big concern for the region, said Bruce Deming, whose property abuts the trail system. When he noticed smoke on the ridge Sunday afternoon, he wondered why no firefighting helicopters were responding. (AP)

Death toll in rain related incidents rises to 45 in Pak

ISLAMABAD, June 30: Another seven people were killed in the past 24 hours in rain related incidents in Pakistan, bringing the death toll to 45, according to official data released

on Monday. The National Disaster Management Authority (NDMA) in its latest update said seven more people died, including four in Balochistan, two in Khyber-Pakhtunkhwa, and one in Punjab.

It said 68 people have been injured since the pre-monsoon spell of rains began on June 26.

Khyber Pakhtunkhwa province in northwest Pakistan was the worst hit with 21 casualties, according to the NDMA website.

It said another 13 people were killed in Punjab, seven in Sindh, and four died in Balochistan province.

At least 39 people have been injured in Punjab, 16 in Sindh, 11 in Khyber Pakhtunkhwa, and two in Balochistan, it said.

As many as 50 houses have been fully damaged and 39 partially damaged while 55 animals killed as rains wreak havoc in different parts of the

Scorching temperatures grip Europe, putting regions on high alert

ANKARA (Turkiye), June **30:** Forest fires fanned by high winds and hot, dry weather damaged some holiday homes in Turkiye as a lingering heat wave that has cooked much of Europe led authorities to raise warnings and tourists to find ways to beat the heat on Monday.

A heat dome hovered over an arc from France, Portugal and Spain to Turkiye, while data from European forecasters suggested other countries were set to broil further in coming days. New highs are expected on Wednesday before rain is forecast to bring respite to some areas later this week.

"Extreme heat is no longer a rare event — it has become the new normal," tweeted UN Secretary-General Antonio Guterres from Seville, Spain, where temperatures were expected to hit 42 Celsius (nearly 108 Fahrenheit) on Monday afternoon. Reiterating his frequent calls for action to fight climate change, Guterres added: "The planet is getting hotter and more dangerous — no country is immune.

In France, which was almost entirely sweltering in the heatwave on Monday and where air conditioning remains relatively rare, local and national authorities were taking extra effort to care for homeless and elderly people and people working outside. Some tourists were putting off plans for some rigorous



outdoor activities.

"We were going to do a bike tour today actually, but we decided because it was gonna be so warm not to do the bike tour," said Andrea Tyson, 46, who was visiting Paris from New Philadelphia, Ohio.

Authorities in Portugal issued a red heat warning for seven of 18 districts as temperatures were forecast to hit 43 degrees Celsius, a day after logging a record June temperature of 46.6 degrees C. Almost all inland areas were at high risk of wildfires.

In Turkiye, forest fires fanned by strong winds damaged some holiday homes in Izmir's Doganbey region and forced the temporary closure of the airport in Izmir, the staterun Anadolu Agency reported Authorities evacuated four villages as a precaution, the Forestry Ministry said.

In Italy, the Health Ministry put 21 cities under its level three "red" alert, which indicates "emergency conditions with possible negative effects" on healthy, active people as well as at-risk old people, children and chronically ill people.







Tribals in Great Nicobar not against development but lack info about infra project: NCST member

communities in Great Nicobar are not opposed to development but lack sufficient information about a proposed mega infrastructure project on the island, National Commission for Scheduled Tribes (NCST) member Asha Lakra has

The project, titled Holistic Development of Great Nicobar, involves the construction of a transshipment port, an international airport, a township and a power plant over more than 160 square km of land. This includes around 130 square km of pristine forest inhabited by the Nicobarese, a Scheduled Tribe (ST), and the Shompens, a Particularly Vulnerable Tribal Group (PVTG), whose population is estimated to be between 200 and 300.

In an interview with PTI, Lakra said she led an NCST team to the Andaman and Nicobar Islands from June 5 to 7 to review the issues faced by the tribal communities. She said the commission held a detailed meeting with representatives of all tribal groups, including the Great Andamanese, Jarawa, Nicobarese and Shompens.

12 dead, 34 injured in blast in pharma plant near Hyderabad

SANGAREDDY (TELANGANA), June 30: Twelve people were killed and 34 others suffered injuries in a blast in a pharma plant in Telangana's Sangareddy district, about 50 km away from Hyderabad, on Mon-

About 90 people were working at around 9.30 AM in the plant of Sigachi Industries at Pashamylaram when the tragedy occurred, state Health Minister C Damodar Rajanarasimha, who visited the accident site

along with Labour Minister G Vivek Venkatswamy, told reporters. The cause of the mishap would be known after examination by the

technical experts, he said. Venkatswamy said 12 of the 34 injured people were critical and put on ventilator support in the hospitals. Because of the burns, their respiratory

system was under stress, he said. The government is hopeful that the remaining 22 people who received

burns recover soon, he said. Prime Minister Narendra Modi expressed grief over the fire tragedy and conveyed condolences to those who lost their loved ones in the incident. He wished an early recovery to the injured.

In a post on 'X', he announced an ex-gratia of Rs 2 lakh from the Prime Minister's National Relief Fund for the next of kin of the deceased and Rs 50,000 for the injured.

Chief Minister A Revanth Reddy expressed anguish over the incident and directed officials to take all steps to save the trapped workers and provide them advanced medical care, an official release said.

The company said it deeply mourns the loss of lives and extends heartfelt condolences to the families of the deceased. The firm is extending all possible support to those affected, it added. Y Nagi Reddy, Director General of the Telangana State Disaster Response and Fire Services, said a blast was being suspected in the drying unit of a plant.

"Industrial experts are saying that during the drying process, or a handling process the pressure could have built up followed by the blasting of the material which led to the blasting of the entire handling unit as well as the industrial building," Reddy told reporters.

He said the removal of debris was still ongoing at the blast site and that search was on for any people trapped in the collapsed three-storeyed

NEW DELHI, June 30: The BJP on Monday accused opposition parties of seeking to turn the Constitution into a "sharia script" and using the garb of "samajwaad" (socialism) to hide its "namazwaad", as it slammed RJD leader Tejashwi Yadav for asserting that his bloc, if elected to power in Bihar, will throw the amended Waqf Act in dustbin.

BJP national spokesperson Sudhanshu Trivedi said the ÎNDIA bloc of the RJD-Congress-Left in Bihar has shown its disrespect for the Constitution, as the Act was passed by Parliament and is being adjudicated in the Supreme Court. They respect neither Parliament nor the judiciary, he said.

Addressing a press conference, he rejected opposition parties' criticism of the Election Commission's special intensive review of electoral rolls, which has started from the poll-bound Bihar, to weed out ineligible voters, as born out of their "defeatist mindset" in the face of their inevitable loss.

These parties want fake voters, while it is imperative to ensure that only eligible Indian citizens get to elect the government of their choice, he said. The EC has said the exercise, a regular mechanism, is aimed at including only eligible voters in the elec-

Opposition parties have claimed that it can exclude eligible voters willfully, an allegation that is an extension of their attack

on the poll watchdog for working to benefit the ruling alliance. Assembly polls in Bihar are expected to be held in October-November. Targeting opposition leaders for their strident criticism of the Waqf (Amendment) Act at the Patna rally, Trivedi said their alliance is driven by vote bank politics, a euphemism for its outreach to Muslim voters over the opposition to the Act from a large number of them. He alleged that the INDIA bloc wants to enforce Sharia provisions through the back door. States like Telangana and Karnataka are giving reservations to Muslims at the cost of quotas for Hindu OBCs, SCs and STs, and West Bengal is

also trying to do it, he said. He underlined the BJP-led NDA's commitment to the values of the Constitution drafted by B R Ambedkar. He said, 'Samvidhan bachao' is merely a facade of these parties as their true face is 'sharia lao' If they are in power, they will add 'namazwaad' to the Constitution's preamble. They want to turn the Constitution into a Sharia script, but we will not allow it."

RJD's Tejashwi Yadav on Sunday claimed that the ruling NDA in Bihar was "on its way out", and the new government in the state led by the opposition alliance will "consign to the dustbin" the Waqf Act brought by the Narendra Modi dispensation at the Centre. (PTI)

Raj Narain said that with the help of the Government, Indira Gandhi won the election and appointed a gazetted officer as her election agent. Based on these two matters, Justice Jagmohan Lal Sinha on 12th June 1972 declared the election as null and void," said Saha.

He informed that the then

Prime Minister Indira Gandhi knocked on the door of the Supreme Court, and there Justice Krishna Iyer said that she could remain Prime Minister but couldn't vote or hold any government "Later, the then Chief Minister

of West Bengal, Siddhartha Shankar Ray, was summoned—he was a renowned barrister-and Indira Gandhi discussed the matter with him. Then pressure was

mounted on President Fakhruddin Ali Ahmed and Emergency was declared in 1975, which is a black day," said Saha.

He said that this is why the Mock Parliament was arrangedto make the upcoming generations aware of this black day and to discuss it. Later, they will convey it to the people as well.

"It was a direct attack on the Indian Constitution. We have seen how democracy was killed during the Congress regime. In Tripura, the then Chief Minister was Sukhamoy Sengupta and we saw how they used the Maintenance of Internal Security Act (MISA) in a wrongful way and arrested many people, starting from journalists. We saw what kind of situation was created. Many houses were vandalised. Those who protested against Emergency were arrested, and even the press was attacked. Sikkim MP submits representation to Parl panel seeking restoration of flight services



Movies reflect the phase you are in: 'Metro... In Dino' director Anurag Basu

MUMBAI, June 30: Filmmaker Anurag Basu says his growth as a storyteller mirrors the evolution he has witnessed in his personal life where women have been a major source of inspiration.

Over a career spanning more than two decades, Basu has established himself as a versatile director, exploring various genres ranging from the erotic thriller "Murder" and the romantic crime drama "Gangster" to deeply moving stories like "Barfi!" and "Kites", and even ensemble anthologies such as "Life in a... Metro" and "Ludo".

"Movies reflect the phase you are going through in your life. Initially, my films were a little erotic when I was young. After that, I grew older, had a family, matured, and then began to understand the depth of relationships in a much better way. Those depths then began to be reflected in films," Basu told PTI in an interview. "I seek inspiration from everybody, from all the women in my life, like the women who raised me, who loved me, and those who outsmarted me. So, all the stories came from there," he said.

Basu received critical acclaim for his 2007 movie "Life in a... Metro", an anthology exploring stories of love, ambition, and heartbreak in the fast-paced urban landscape of Mumbai.

He is now coming out with the movie's follow-up "Metro...In Dino", which follows the bittersweet relationships of four couples in four different cities.

The director said when he made "Life in a...

Metro", he thought of it as a standalone movie as he had no storyline for a follow-up.

"While making 'Ludo', this idea came to me. Before that, I attempted once or twice to write the film, but it didn't happen. But this time, it came along," he said. "Metro...In Dino" is part of Basu's hyperlink trilogy, which began with "Life in a...Metro" in 2007 and continued with "Ludo" in 2020. All three movies weave together interrelated tales that encapsulate the diversity of love.

"Now the trilogy is complete, and I don't want to do it again. I don't want to do a hyperlink film. I don't want to do it for the next 2-3 films," the 55-year-old director explained.

While writing interlinked stories is a big challenge, shooting the movie was a lot of fun, Basu added. "We have to write four stories, which is equal to writing four films. The audience will see it from the perspective of four stories. For me, it's a movie, and it should have a graph of up and down and everything. In

'Ludo', you felt like you were watching one movie. "It was the same case with the old 'Metro' film. So, achieving that ease is a little difficult. You don't want to get lost in four stories, and wanting to root for all the characters and be invested in all the characters at the same time is a very tough job," he said.

"Metro...In Dino" features a star-studded cast of Anupam Kher, Neena Gupta, Pankaj Tripathi, Konkana Sen Sharma, Ali Fazal, Fatima Sana Shaikh, Aditya Roy Kapur, and Sara Ali Khan.

For Basu, he "hit the jackpot" with the star cast of this film. "All my first choices said yes. I was lucky because there was no option B. They trusted me. So, it was a dream cast. If it wasn't there, I don't know what I would have done. Now, when I see the film, I can't see anybody else playing their character as they have played," he added

Basu has already begun work on his next, a musical romantic drama that was initially titled "Aashiqui 3". The film, which features Kartik Aaryan and South sensation Sreeleela, is poised for its theatrical release on Diwali.

"I don't know if it's going to be called 'Aashiqui 3'. There was a story which I was making, and I didn't write a story for 'Aashiqui 3'. I was going to make this film, no matter what the title was. As of now, I don't know what the title will be. It would be right to say untitled now," the director said.

Basu is equally thrilled about his long-cherished project: a biopic on the legendary Kishore Kumar, which he had announced over a decade ago. Reports have claimed that superstar Aamir Khan will feature in the movie but Basu refused to comment on the speculation. "I've started work on it at full speed. I'll start it (filming) soon. The writing work and all is done, everything is done," Basu said.

MIAMI GARDENS (USA), June 30: Harry Kane scored twice and Bayern Munich capitalized on a quick start to beat Flamengo 4-2 in the Club World Cup round of 16 on Sunday.

Germany's premier soccer club regrouped quickly from its only loss of the tournament last week against Benfica, jumping out to a 2-0 lead and then holding off Flamengo's comeback attempts to advance to the quarterfinals.

Bayern Munich will face Champions League winner Paris Saint-Germain on Saturday in Atlanta after PSG routed Lionel Messi and Inter Miami 4-0 earlier Sunday. Kane's first goal was a deflected strike nine minutes into the match that put Bayern up by a pair of goals, and the prolific goal scorer found the back of the net again on a feed from Joshua Kimmich that he whipped past goalie

Agustín Rossi. The Bundesliga champion struck early when Flamengo star Erick Pulgar headed the ball into his own net off Kimmich's corner in the sixth.

Even though Flamengo had plenty of opportunities, the Brazilian club failed to capitalize on enough of them and never got closer than a goal

Luiz Araújo had Flamengo's best chance of the first half with a left-footed shot toward the back post, but Manuel Neuer slid over and knocked the ball away for a

Gerson finally put Flamengo on the board when he beat Neuer in the 32nd to cut the 2-0 deficit in half before Leon Goretzka restored Bayern's two-goal lead.

Flamengo pulled within a goal again in the second half when Jorginho converted a penalty. Then came Kane again, finishing in the 73rd with his third goal of the tournament.

The 65,000-seat Hard Rock Stadium — home of the NFL's Miami Dolphins — has been one of the more well-attended venues of the tournament and was almost completely full Sunday, with many attendees wearing Fla-

PARIS, June 30: American businesswoman Michele Kang has taken over as president of seventime French champion Lyon after John Textor resigned following the club's relegation over financial irregularities.

The South Korea-born Kang is also majority owner of the Lyon's women's team — OL Lyonnes and has been on Lyon's board of directors since 2023.

Lyon said in a statement that Kang will play an "active role" in leading the club's appeal against the relegation handed down last Tuesday by the French league's soccer watchdog, known as DNCG. The case is expected to be heard within the next week.

That ruling could also decide whether Crystal Palace will be allowed to play in next season's Europa League, which Lyon also qualified for. Textor also held a 43% stake in Palace — which he has agreed to sell to New York

Jets owner Woody Johnson and UEFA has rules against clubs with the same owner playing the

same competition. Lyon added that Textor has also resigned from the board of directors. He became Lyon president three years ago, taking over from longstanding incumbent Jean-Michel Aulas, who sold to Textor's Eagle Football Holdings.

The 66-year-old Kang will be supported in her role by Michael Gerlinger, the general manager of Eagle Football Holdings.

"A highly respected figure in European football administration, Michael brings over two decades of experience in governance, regulatory affairs and sports operations," Lyon said in its statement.

Lyon's run of Ligue 1 titles from 2001-08 made it the powerhouse of French soccer. Since Paris Saint-Germain took over at the top, fortunes have steadily dipped for Lyon. (AP)

French soccer union blasts Club World Cup over 'massacre' of player welfare

PARIS, June 30: France's union of professional soccer players launched a scathing attack on the Club World Cup on Sunday, saying it is "urgent to stop this massacre" amid ongoing concerns about extreme player workloads.

The UNFP also accused FIFA president Gianni Infantino of living "in an ivory tower" by ignoring the impact congested calendars have on players worldwide.

"The incongruity of the situation is not lost on anyone, except, of course, Gianni Infantino and his flatterers. From the height of his ivory tower, which he parades around the world, the FIFA president is not bothered by the fate that the international calendar reserves for the game's leading players," the UNFP said in a statement early Sunday morning. "His (Infantino's) Club World Cup proves, to the point of absurdity, that it is urgent to stop this massacre game. He

flouts the physical and mental health of players for a few more dollars." The UNFP statement said the Club World Cup comes at the end of an already exhausting season, and thereby ignores "collecbargaining agreements (which) almost everywhere, provide for an incompressible period of three weeks of rest for footballers between two seasons.'

FIFA was approached for comment by The Associated Press.

Days before the start of the month-long Club World Cup, which ends on July 13, soccer chiefs faced renewed calls to safeguard players over growing fears of injuries and burnout.

The newly expanded tournament involving 32 of the world's best teams has faced pushback since FIFA announced it would be added to an already saturated calendar. The tournament will be played every four years, sandwiched in



between the men's World Cup, European Championship and Copa America. It went ahead against the backdrop of legal challenges in Europe, strike threats and repeated concerns over players' mental and physical welfare due to too many games. "The UNFP, like FIFPRO and FIFPRO Europe, has been protesting for years against the drastic increase in workloads," The UNFP added. The sevenround shootout was a fitting end to a fast-paced and feisty contest that went down as one of the best of this biennial tournament for North America, Central America and the Caribbean. Confident India hope for Mandhana encore, Harmanpreet availability in 2nd T20I against England

BRISTOL, June 30: A confident India will aim to capitalise on opener Smriti Mandhana's sublime form and hope for skipper Harmanpreet Kaur's availability to achieve another big win when the second Women's T20I against England is played here on Tuesday.

Mandhana's maiden T20I century in the opening game at Nottingham guided India to a massive 97-run win, and the likely presence of skipper Harmanpreet -- who was rested for the first game as a precautionary measure following a head injury sustained during a warm-up match -- for the second game would only add to the hosts' worries.

Lack of variety in India's bowling attack is concerning: Chappell



LONDON, June 30: Australia batting legend Greg Chappell believes India paid the price for a lack of variety in their bowling attack during the first Test against England and has called for the inclusion of Arshdeep Singh and Kuldeep Yadav, whom he hails as the "best wrist-spinner since Shane Warne", in the

India lost the opening Test of the five-match series by five wickets at Headingley, where they were also guilty of dropping as many as eight catches.

"As disappointing as the fielding in Headingley was, it was not the main reason India lost the Test. Most of India's problems were self-inflicted. Perhaps the most expensive error was the no-ball that gave Harry Brook an early life in the second innings," Chappell wrote in his column for 'ESPNCricinfo'.

However, the former Australian skipper felt that the sameness of India's right-arm seamers -- Mohammed Siraj, Prasidh Krishna, and Shardul Thakur -- posed a bigger tactical problem that the fielding issue.

"More concerning to me, though, is the lack of variety in the bowling attack. Apart from Jasprit Bumrah, India's seamers are too similar - all right-arm, medium fast, operating at comparable angles.

medium-fast, operating at comparable angles.

"There is a reason why wickets often fall after a

change of bowling. It forces the batter to recalibrate. That variability isn't available to Shubman Gill with his current crop." The 76-year-old former India coach called for the inclusion of left-arm seamer Arshdeep and wrist-spinner Kuldeep to add much-needed contract to the attack.

trast to the attack.

"Without Bumrah, I'd like to see left-armer Arshdeep Singh added to the mix and Kuldeep Yadav, possibly the best wrist spinner since Shane Warne, in-

cluded in the attack."

At Headingley, pace spearhead Jasprit Bumrah returned match figures of 5/140 from 43.4 overs. In contrast, Thakur and Krishna ended with 2/89 from 16 overs and 5/220 from 35 overs respectively.

"Even with Bumrah in the mix, the rest of the attack has to be more disciplined. I didn't see two consecutive balls land in a dangerous place. They were either too full, too short or too wide. Bowlers have to work in partnerships as much as batters.

"All England have to do at present is to see off Bumrah and they know the pressure will go with him," Chappell wrote. Chappell also criticised the Indian team management's preference for batting depth over a balanced bowling attack.

"I don't agree that an extra batter who bowls should be selected as insurance against top-order collapses. The top six must be trusted to deliver the runs and that the best combination to secure the requisite 20 wickets is available to the captain," he said. India opted to go with all-rounder Ravindra Jadeja as the lone spinner at Leeds. "Jadeja is not a front-line spinner in English conditions. If his batting is considered good enough, he can be a support spinner; otherwise a rethink is necessary. If India are to reverse their fortunes in this series then a better balanced team is required.

"The selectors are the ones under pressure now. If batters and bowlers have to be prepared to take risks to score runs and take wickets, they too have to have the courage to take bold decisions." (PTI)

Azhar Mahmood appointed Pakistan's acting red-ball head coach



LAHORE, June 30: Former all-rounder Azhar Mahmood was on Monday elevated to the post of Pakistan's acting redball head coach until the conclusion of his current contract, which runs until April next

Mahmood had signed a twoyear contract with the Pakistan Cricket Board in April last year as assistant coach across formats along with Australia's Jason Gillespie (Tests) and South Africa's Gary Kirsten (limited overs), who have both moved on.

"The Pakistan Cricket Board today announces Azhar Mahmood as the acting red-ball head coach of the Pakistan men's team. Azhar will serve in this role until the conclusion of his current contract," the PCB said in a statement.

"A seasoned cricketing mind, Azhar Mahmood steps into the role with an impressive portfolio of experience. Having served as the assistant head coach of the national side, Azhar has long been a pivotal part of the team's strategic core.

"His deep knowledge of the game, combined with handson international exposure and proven success in the English county circuit, make him exceptionally well-suited for this position," the PCB added.

PCB highlighted Mahmood's achievements in winning County Championship titles for Surrey as their assistant coach.

"His red-ball pedigree is underscored by two County Championship titles — an achievement that speaks volumes about his leadership, tactical acumen and unwavering commitment to excellence," it

"The PCB is confident that under Azhar's guidance, the red-ball squad will continue to grow in strength, discipline and performance on the global stage," the board added.

The 50-year-old Mahmood played 21 Tests and 143 ODIs for Pakistan between 1996 and 2007. (PTI)

Ayush clinches maiden BWF World Tour title at US Open; Tanvi finishes runner-up

IOWA (US), June 30: Rising shuttler Ayush Shetty notched up his first BWF World Tour title with a commanding straight-games victory over Canada's Brian Yang in the men's singles final of the US Open Super 300, ending India's

Steve Smith trained in a baseball cage for Australia's Caribbean test

ST GEORGE'S (GRENADA), June 30: Charismatic Australian batter Steve Smith's quick recovery from a "compound dislocation" in the little finger of his right hand, and his sooner-than-expected return to the squad for the second Test against West Indies has a baseball twist to it. Smith has suffered an injury to his right little finger while trying to take a difficult catch off South African captain Temba Bavuma at first slip during the World Test Championship final at Lord's earlier this month.

The 36-year-old former Australian skipper immediately left London after his wound was cleaned, stitched and his finger placed in a splint. Instead of waiting for the injury to heal by itself, he decided to hit the "baseball cage" in New York, where he owns an apartment.

The injury forced him to miss the opening game of the three-Test series against the Caribbean in Barbados from June 25 to 27, which Australia won by 159 runs. In New York, he began by facing tennis balls and other soft balls in the nets before facing the hard cricket ball.

"My mate actually told me about it, which was ideal because it was pretty warm there (in New York)," Smith was quoted as saying in ESP-Nericinfo.

"Underneath this bridge there was a batting cage, and he was able to throw me a few balls there, so it was good to be in the shade, it was pretty hot there," he said.

A baseball cage is a netted enclosure, quite similar to the cricket nets, used by baseball players to practice hitting. It provides a contained area where batters can safely swing and hit baseballs, without the risk of stray balls leaving the hitting area.

Smith sent the footage of his batting to the Australian medical staff in the Caribbean, who were happy with his progress.

The report added that Smith had his stitches removed on Sunday and

The report added that Smith had his stitches removed on Sunday and his finger now only has a thinner splint as he gears up for his return for the second Test at St George's from July 3.

"For me, it'll just feel like training as normal, I think. I don't really feel any pain or anything. (I'm) just getting used to the splint on and the slight limited movement.

"It's not too had. I've got a lot of movement there now, so that feels

"It's not too bad, I've got a lot of movement there now, so that feels good. Hitting the ball felt completely fine," said Smith

"Fielding some balls in front of the wicket will probably be the strangest thing for me, I don't think I've ever done that in a Test match. Fielding at either probably mid-on or mid-off or fine leg, is a bit different to standing at the second or first slip," he added. (PTI)

Real tournament will start from quarterfinals: Sreejesh

BENGALURU, June 30: India coach PR Sreejesh says competing in the FIH Junior World Cup in a new format will be exciting and reckons that the real tournament will begin from the quarterfinals.

India will host the quadrennial event in the cities of Chennai and Madurai from November 28 till December 10, this year.

For the first time, 24 teams will compete in the World Cup which was initially a 12-team tournament. From the 2001 edition onwards it became a 16-team tournament.

Under the new format, teams will be divided into six pools (A-F) with four teams in each pool. The six group winners and two best-placed second place teams will qualify for the quarterfinals.

India are placed in Pool B alongside arch-rivals Pakistan, Chile and Switzerland.

"We will take each game as it comes, one step at a time and grab as many points as we can to secure the best spot in the quarterfinals," Sreejesh said in a Hockey India release.

"This is the first time the FIH Hockey Men's Junior World Cup, 2025 has been expanded to 24 teams, and we're planning our preparations accordingly. Playing in this new format will be very exciting," the former India goal-keeper said. (PTI)

Pataudi medal was an afterthought, ECB should have done better: Farokh Engineer

BIRMINGHAM, June 30: A close friend of the late Mansur Ali Khan Pataudi, Farokh Engineer says the ECB erred in handling the renaming of the India-England Test series trophy and its decision to introduce the winning captain's medal after his former teammate's family name was clearly an afterthought to "appease" supporters like him.

The ECB had instituted the Pataudi Trophy for the India-England series in 2007 until renaming it to the Anderson-Tendulkar trophy before the start of the ongoing five-match series. The decision was criticised by the likes of Sunil Gavaskar.

Engineer too was left disappointed.

Engineer too was left disappointed but at the same time, he felt the achievements of Sachin Tendulkar and James Anderson were unquestionable. Tendulkar approached the ECB which led to the home board introducing a winning captain's medal after the Pataudi family.

"Well Tiger Pataudi was a great friend of mine. Great colleague of mine. We played a lot of Test cricket. Great heritage, great family. I was most happy when the trophy was named after him back in 2007," the Manchester-based Engineer told PTI.

"On one hand I was very disappointed

that the Pataudi name was removed, I would love Tiger's name to go on but instead powers that be decided with Anderson and Sachin who are legends of the game.

"The whole issue is debatable but they have kept the name. I hope they invite Sharmila Tagore (Mansur's wife) and his son Saif Ali Khan to present the medal. Last series they didn't do that. Fingers were pointed at ECB for that. Hopefully they give them due credit."
