HT Bureau GUWAHATI, July 3: Chief Minister Himanta Biswa Sarma on Thursday undertook a detailed review of the progress and implementation of several key government welfare schemes in Udalguri district and directed officials to ensure their speedy execution and wider public outreach.

According to an official statement, the Chief Minister chaired a review meeting at the District Commissioner's office and assessed the implementation status of flagship initiatives including 'Orunodoi 3.0', 'Mukhya Mantrir Mahila Udvamita Abhijan'. 'Mukhya Mantrir Atmanirbhar Asom Abhijan', and 'Eti Koli Duti

Addressing the 'Eti Koli Duti Paat scheme', launched to coincide with the bicentennial celebrations of Assam's tea industry, Sarma said that the government will provide a one-time payment of ₹ 5,000 to all permanent and temporary Class III and IV workers of tea gardens.

He instructed the DČ to prepare a comprehensive database of tea garden workers in the district and to oversee the proportional distribution of beneficiaries across Udalguri, Bhergaon, Tangla, and Majbat subdivisions.

He also reviewed the functioning of the district-level implementation committee to ensure effective execution.

The meeting was attended by several senior leaders and officials,

including Speaker of the Assam Legislative Assembly Biswajit Daimary, Minister for Water Resources Pijush Hazarika, Mangaldoi MP Dilip Saikia, Deputy CEM of BTC Gobindo Basumatary, Udalguri MLA Charan Boro, and Principal Secretary of BTR Akashdeep.

Later in the day, the Chief Minister also met with representatives of various organisations, including the All Koch Rajbongshi Students' Union (AKRSU), All Assam Koch Rajbongshi Sanmilani, All Bathou Mahasabha, All Adivasi Students' Association, and the Assam Rabha Students' Union at the Circuit House in Udalguri.

Eviction drive launched to clear 78 acres of public land



NORTH LAKHIMPUR, July 3: Around 220 families have been affected in an eviction drive, which was carried out in Lakhimpur district of Assam on Thursday to clear 235 bighas (almost 78 acres) of land from alleged encroachment, officials said.

Lakhimpur District Commissioner Pronab Jit Kakoty said the administration is carrying out the eviction drive at four locations, including three Village Grazing Reserve (VGR), since morning after following due protocol. Traders from Bihar shoot and injure **Assam youth**

TEZPUR, July 3: A person was injured in a firing by two traders, who hailed from Bihar and were on a business tour, in Biswanath district of Assam, officials said on Thursday.

The incident took place in the Joypur area of Gohpur on Wednesday night, according to Biswanath Additional Superintendent of Police Amit Kumar Hojai.

"As per information, two traders from Bihar had come here for business purposes. They had an argument over some issues in the market and then fired," he added. One person, who is a local chilly

trader, sustained a bullet injury in the incident and has been admitted to a hospital, Hojai said.

The locals immediately captured one person, while the other fled from the scene. They handed him over to the police later.

"The investigation is on to nab the other person. We are also trying to find other possible angles in the case," the ASP said. (PTI)

72-yr-old woman murdered by caretaker, wife

GUWAHATI, July 3: City police has arrested a man and his wife for allegedly killing a 72-year-old woman here, officials said on Thursday.

Addressing a press conference, Guwahati Police DCP (Central) Amitabh Basumatary said the incident took place on Wednesday in Kharghuli area, where the deceased used to stay along with the caretaker's family.

"During investigation, we found the involvement of the caretaker and his wife in the murder. We apprehended both of them, who stay in the same campus," he added.

The deceased has been identified as Bandana Das, who was staying alone after the demise of her husband. Her brother's family stays nearby

Basumatary said following intense interrogation, the caretaker confessed to the crime in collusion

Man stabs wife to death in front of children

RANGIA, July 3: A man allegedly stabbed his wife to death in front of their children in Assam's Kamrup district on Thursday, a police officer said.

The accused, a station master of Northeast Frontier Railway, fled after the incident that took place in Rangia town.

According to Rangia Police Station Officer-in-Charge Nabajyoti Nath, neighbours informed the force of the incident.

"The deceased has been identified as Anjali Singh, wife of Rahul Kumar Singh, who is the station master of Kendukona Railway Station. They have two children. They told us that their father stabbed mother," he added.

The police have launched a manhunt to nab the accused, the OC said. (CONTD. ON PAGE-2)

Tripura no longer 'safe zone' for infiltrators: CM Manik Saha

AGARTALA, July 3: Tripura Chief Minister Manik Saha on Thursday said the northeastern state is no longer a "safe zone" for infiltrators because of proactive action taken by security agencies.

His remark comes in the wake of the BJP's ally, the Tipra Motha Party (TMP), launching a widespread anti-infiltration campaign across the state.

"The day Bangladesh Prime Minister Sheikh Hasina left her country following the student uprising and violence, I met security agencies and instructed them to prevent any infiltration across the border," Saha told reporters at the Raj Bhavan.

He added, "Tripura is no longer a 'safe zone' for infiltrators. The security agencies have carried out extensive operations against infiltration. A strong message has already been sent to Bangladesh — it is not possible to enter Tripura and stay back using forged Aadhaar cards."

Responding to TMP's campaign, the CM said the state government is already taking action to curb infiltration. "If they (TMP) still have concerns, we

are open to sitting together and discussing them," he said. Asked about a viral video in which a cabinet minister from Tipra Motha Party was allegedly heard urging party workers

to "drive away infiltrators by caning," Saha responded, "The truth is the truth... no one can twist the truth. At a party programme in Sabroom, South Tripura, Forest Minister Animesh Debbarma was heard telling party workers

to "drive away Bangladeshis back to their

country by caning.'

Meanwhile, another TMP legislator, Ranjit Debbarma, has written to Union Home Minister Amit Shah, seeking the Centre's intervention to identify and deport illegal infiltrators from the state. (PTI)

CM pins graft charges at Gorukhuti Project

Congress asked to speak against 'qurbani' of cows by Muslims

UDALGURI, July 3: Chief Minister Himanta Biswa Sarma on Thursday took a dig at opposition Congress, accusing it of lacking the courage to speak out against the slaughter of cows by Muslims during 'qurbani' and the alleged throwing of beef near religious places.

Speaking on the sidelines of a meeting, Sarma said the BJP is the only party that can request the Muslim community to perform 'qurbani' with animals other than "I can challenge the Congress that they

don't have the courage to speak on 'qurbani'. BJP can openly say that Islam does not recognise 'qurbani' of cows. 'Ourbani' can be of any animal. BJP has the courage to request the public not to carry out 'qurbani' of cows next time, but to do it with goats," Sarma said.

"Can Congress do it? They will have to



who is the well-wisher of cows?" the CM asked. He further questioned whether the Congress ever protested the selling of beef openly in shops and throwing of meat in front of Namghar.

"Has the Congress condemned the Dhubri incident? Or will they condemn the Hajo case, in which beef was found today? Should they not speak about dead

cows to find out who killed them? The Congress operates in reverse order. Where it should play, it is silent, and it is silent where it should raise its voice," he said.

According to police, around 80 people have been arrested across Dhubri, Hojai, Goalpara, and Lakhimpur districts for allegedly throwing beef parts during Eid celebrations last month. On Thursday, parts of meat suspected to be beef were also found in Hajo in Kamrup district.

"Opposition parties don't raise their voice where they should. Thousands of cows are killed for 'qurbani' in Assam. Should we raise our voices for living cows or the dead ones?" Sarma questioned.

Sarma also slammed the Congress and other opposition parties for repeatedly raising allegations of corruption regarding the Gorukhuti Multipurpose Agriculture Project in Sipajhar, (CONTD. ON PAGE-2)

Bairabi-Sairang line: Railways Dalai Lama's reincarnation to follow Police attempt to rescue sourced construction material, workforce from across country



AIZAWL, July 3: To connect Mizoram's capital Aizawl to the railway network, the Northeast Frontier Railway (NFR) sourced construction material and labour

force from across the country. The 52-km Bairabi-Sairang (near Aizawl) rail line, built at a cost of approximately ₹ 8,000 crore, is ready and will soon be inaugurated by Prime Minister Narendra Modi

Vinod Kumar, chief engineer of the project, said his team ordered almost all construction material from other states.

"Crushed stones were brought from Assam, West Bengal and Jharkhand. We purchased sand from Silchar and Guwahati. We sourced reinforcement rods from Kolkata and bent them near the highway as carrying them to the construction site was not possible due to their length. Then, we straightened them for use at the site," he said.

"Small vehicles cannot carry 12ft-long rods and big vehicles cannot ply on these roads," he added.

According to Kumar, steel girders used for the project were manin Raipur in ufactured Chhattisgarh, Kolkata in West Bengal, and Wardha and Ahmed-

nagar in Maharashtra. NFR officials said that carrying girders to the construction site posed a huge logistical challenge

and several special arrangements

had to be made. "There are two approach roads to Guwahati from Aizawl and both often get closed due to landslides or poor conditions. So, we carried the girders up to Bairabi using the rail network and then took them to the site by making special transportation arrangements," Kumar elaborated.

"Cranes were dismantled to take them to the site to place these girders on the bridge. A day's work took more than a month to complete due to all these reasons," he said. Both skilled and unskilled labourers who worked on the project were from West Bengal Assam, Uttar Pradesh, Bihar and Jharkhand, he added.

According to the officials, with the completion of the Bairabi-Sairang line, Mizoram will be the fourth northeastern state to have its capital city linked to the national railway network

According to the NFR, the line has 48 tunnels covering a distance of 12.853 km, 55 major and 87 minor bridges, five road overbridges and nine road underbridges. One of the bridges, numbered 196, stands 104 metres tall -- 42 metres taller than the Qutub Minar. The railway line was commissioned in four phases --Bairabi-Hortoki (16.72 km) commissioned (CONTD. tradition, not China's wish: Rijiju

NEW DELHI, July 3: In a snub to China, Minority Affairs Minister Kiren Rijiju on Thursday asserted that the decision on the Incarnation of the Dalai Lama would be taken by the established institution and the leader of Tibetan Buddhist himself and no one else.

This is the first reaction by a senior government functionary on the comments of the Dalai Lama on his successor. On Wednesday, Tibetan spiritual leader Dalai Lama said that the institution of the Dalai Lama will continue and only the Gaden Phodrang Trust will have the authority to recognise his future reincarnation.

Talking to reporters here, Rijiju said the Dalai Lama is the "most important and defining institution' for the Buddhists.

"And all those who follow the Dalai Lama feel that the Incarna-



tion is to be decided by the established convention and as per the wish of the Dalai Lama himself. Nobody else has the right to decide it except him and the conventions in place," Rijiju said.

The minister's remarks came after China rejected the Nobel Peace laureate's succession plan, insisting that any future heir must receive its seal of approval. Rijiju, a practising Buddhist, and Rajiv Ranjan Singh, a fellow Union minister, are (CONTD. ON PAGE-2)

couple held captive in Assam, face mob attack

NORTH LAKHIMPUR, July 3: At least four people were injured in Lakhimpur district of Assam on Thursday when a police team went to rescue a couple, who were held captive by a mob for allegedly being in an illicit relationship, an officer said.

Of the injured people, four are police personnel.

According to Ghilamora Police Station Officer-in-Charge Gakul Chetia, information was received that a couple was held captive by vilagers of Baliyani Kumbang after they returned from outside the state.

The woman is already married, and she is alleged to be in a relationship with the man. They had fled from here and were staying outside Assam. When they returned, the villagers kept them captive," he added. Once police reached the spot and rescued the couple, the villagers got unruly and pulled them out of the vehicle and started to thrash them,

"When our team members tried to free the two, the mob attacked them also. In the process, one lady constable sustained injuries and started bleeding. Another constable was also injured," he added. The mob tore the clothes of the woman of the couple and badly hit the man.

"After a lot of effort, our team could rescue both of them and reach the police station. We have taken them for medical treatment and they are out of danger," Chetia said. (CONTD. ON PAGE-2)

ISRO has a flourishing repository of R&D in space technologies

ISRO transfers 10 technologies to industry to boost self reliance

NEW DELHI, July 3: The ISRO transferred 10 technologies, including two inertial sensors to reduce import dependence, to six Indian industries for commercial use in space and other sectors, India's space sector promoter said on Thursday. The transfer of technology was

facilitated by the Indian National Space Promotion and Authorization Centre (IN-SPACe). Technologies of two advanced

inertial sensors - the Laser Gyroscope and the Ceramic Servo Accelerometer – developed by the ISRO's Inertial Systems Unit were transferred to Hyderabad-based Zetatek Technologies Pvt. Ltd, making it the first company to get the niche technology.

Zetatek, a company with over 25 years of expertise in Inertial Navigation System (INS) testing, calibration and QA/QT equipment, will manufacture the sensors in the country which may help reduce import dependence.

"The transfer of these technolo-



step towards empowering the private sector to harness and commercialize space technologies," IN-SPACe Chairman Pawan Goenka said in a statement.

In the midstream segment, three technologies related to ground station operations – S/X/Ka tri-band dual circular polarised monopulse feed, tri-axis antenna control servo system, and Ku/C/L and S Band

Cassegrain feed – developed by the ISRO – have been transferred to Avantel and Jisnu Communications, both Hyderabad-based firms specialising in end-to-end communications solutions for space and defence platforms.

These technologies, currently sourced from foreign vendors, will enable self-reliance in critical ground station infrastructure.

The technology transfers aim to

to access the developed technologies available with the ISRO, enabling them to use space-related technology for commercial applications in space as well as other sectors, a statement from IN-SPACe said. The tripartite Technology Trans-

fer Agreements (TTAs) were signed between NewSpace India Limited (NSIL), the recipient industries, and IN-SPACe at the IN-SPACe headquarters Ahmedabad.

"ISRO has a flourishing repository of R&D in space technologies and it is time we leverage that to the optimum to strengthen India's space industrial ecosystem, and in that, industry-led innovation will play a key role," Goenka said.

"These technologies are vital and currently sourced from foreign suppliers. With this transfer, we are taking a pivotal step toward building indigenous capabilities within India," said Rajeev Jyoti, Director, Technical (CONTD. ON PAGE-2)

Stock markets decline on fag-end selling

MUMBAI, July 3: Benchmark stock indices Sensex and Nifty pared intra-day gains to close lower on Thursday due to last-hour selling in financial and metal

The 30-share BSE Sensex dropped by 170.22 points or 0.20 per cent to settle at 83,239.47. The index opened higher and rose further by 440.4 points or 0.52 per cent to hit a high of 83,850.09. However, profit taking emerged in the last hour of trade dragging the barometer to a low of 83,186.74 in the pre-close session.

The 50-share NSE Nifty declined by 48.10 points or 0.19 per cent to 25,405.30.

Among the Sensex firms, Kotak Mahindra Bank, Bajaj Finserv, Bajaj Finance, Adani Ports, Trent, State Bank of India, Titan and Tata Consultancy Services were the laggards.

However, Maruti, Infosys, NTPC, Asian Paints, Eternal and Hindustan Unilever were among the biggest gainers.

Tata Trusts launches campaign to reframe menstruation as a marker of health

GUWAHATI, July 3: In a bold move to challenge deep-rooted social taboos and reframe entrenched perceptions, Tata Trusts has launched a powerful new campaign aimed at shifting how menstruation is understood across India.

According to an official statement, the campaign encourages families and communities to view menstruation not as a symbol of fertility or sexual maturity, but as a normal and healthy biological function.

The initiative comes in response to the ongoing silence and stigma surrounding menstruation in Indian society, where nearly 355 million individuals menstruate each month.

Despite the scale, a large number of adolescent girls remain unprepared for their first period.

Studies cited in the campaign show that around 71% of girls in India are unaware of menstruation until they experience it themselves.

The campaign draws from extensive ethnographic research conducted in rural areas of Jharkhand, Uttar Pradesh, and Gujarat.

It combines Social and Behaviour Change Communication (SBCC) strategies with on-ground development interventions across seven states.

Its goal is to break societal silence, replace shame with understanding, and empower girls to embrace their periods without fear or embarrassment.

At the core of the campaign is a series of short films and a catchy jingle titled "Maheena Aa Gaya" (translated as "I've got my periods"), which seeks to normalize everyday experiences associated with menstruation. The films portray real-life, emotionally resonant scenarios in which parents, husbands, and mothers-in-law support women during their menstrual cycle with empathy and practical care.

These stories aim to make conversations about menstruation feel natural and accepted within the household. The campaign also highlights how menstruation is often misunderstood as a marker of readiness for marriage.

Mothers and frontline workers, such as Anganwadi workers and ASHAs, often avoid the topic out of fear that young girls will be perceived as eligible for mar-

The new narrative encourages communities to shift away from these outdated beliefs and instead see periods as a vital sign of health.

Divyang Waghela, Head of Water, Sanitation and Hygiene (WASH) at Tata Trusts, emphasized the broader systemic issues that complicate menstrual hy-

"The lack of access to clean water, privacy, and safe disposal options for menstrual products severely hampers girls' ability to manage their periods with dig-Waghela said. "Through this campaign, we aim to tackle these infrastructural and societal barriers simultaneously, so that menstruation is recognized as a normal part of growing up.'

Deepshikha Surendran, Head of Brand and Marketing Communications at Tata Trusts, noted that the campaign is rooted in realism, not radicalism.

"We are not asking people to completely change their beliefs overnight. Instead, we are asking them to see menstruation as a health issue-nothing more, nothing less," she said. "'Maheena aa gaya' is more than just a phrase—it's a cultural signal inviting families to replace fear with familiarity and myths with science." To deepen its outreach, the campaign also includes content specifically designed for ASHAs and Anganwadi workers, who serve as a vital bridge between communities and healthcare systems.

These films are intended to help health workers communicate more openly and effectively about menstrual health and hygiene.

Creative Director Keigan Pinto, who helped shape the campaign's messaging, said the goal was to spark an emotional and cultural shift.

"We wanted to create something that felt real, intimate, and instantly relatable. So we filmed in people's homes, capturing everyday conversations, using a memorable song that sticks and speaks to India's cultural memory," he said.

According to Tata Trusts, the campaign is part of its wider commitment to addressing menstruation-related stigma through education, infrastructure, and community engagement. The organization hopes that its approach grounded in behavioural science, empathy, and communication—will inspire a generational shift in how India understands and supports menstruation.

Vacancy rates dropped sharply to 33.5 per cent, the lowest since H2 2019, while new supply remains limited – 0.2 million sq ft expected by year-end. Rentals also saw a rise of 10 per cent during the period under review.

Dhubri's Alomganj residents vow to resist eviction of Patta Land

DHUBRI, July 3: Thousands of families in Dhubri's Alomganj area are gripped by a deep sense of despair following the impending news of a massive eviction drive, reportedly targeting approximately 4,000 bighas

While a significant portion, an estimated 2,200 bighas, is designated as "khas land" (government land), reports also indicate that around 900 bighas of patta land (privately owned land with title deeds) are also slated for acquisition.

In response to the administration's move, the district committee of the Garia Maria Desi Jatiya Parishad convened a meeting on Thursday at Chitalkatti in Alomganj.

During this crucial gathering, a firm decision was made, "The land of all the sons of the soil and pattadars will never be given up.

Afzalur Rahman, Dhubri District President of the Garia Maria Desi Jatiya Parishad, stated, "We don't mind evicting people living on government land, taking away the khas land. But villages in Panbari and Alomganj areas of the indigenous Deshi communities will not be allowed to be wiped out."

The Dhubri district administration, represented by the District Commissioner, Additional Commissioner, and Gauripur Circle Officer, held discussions with Alomganj pattadars on Wednesday regarding the acquisition of vast tracts of land for projects under "Advantage Assam 2.0."

However, a division among the pattadars them-

Trump's birthright citizenship

S President Donald Trump first wanted to end birthright citizenship with an executive order issued on January 20, 2025. the day he assumed office for his 2nd non-consecutive term as president. Again on June 20, 2025, he issued an EO for the Department of Justice (DOJ) to issue an edict for denaturalization of citizens in certain categories such as crime and illegal means of obtaining nationality. While birthright citizenship issue is not yet settled in courts, the Supreme Court has only blocked injunctions from lesser courts against a president's Executive Order, but not yet decided the constitutionality of such a matter, which is sought to be questioned under various articles of the 14th amendment, which grants citizenship to anyone born in the USA irrespective of the status of the parents. Both the writer of the judgement Associate Justice Amy Cony Barrett, a Trump appointee, and Bret Kavanaugh, another appointee of Trump, had clearly stated that their order is limited in scope to the injunctions being issued by lower courts on the president's EO on the matter – that is leaving the main subject matter of ending birthright citizenship open or further litigation through class action lawsuits for those who moved the petitions to seek relief. There are some 28 states which have seen courts flooded with petitions questioning the president's EO on ending birthright citizenship as being violative of the four articles enunciated in the 14th amendment which was brought by the congress to grant citizenship to freed American slaves from Africa. Soon after the Supreme Court order, groups such as ACLU moved in New Hampshire and Maryland for relief.

The clauses in question are Citizenship clause, Immunities and Privileges, Due Process and Equal protection. All these provisions make it amply clear that citizenship ensures civic rights, the explanation of the privileges of citizenship and immunities that goes along with it and the due process of law to enforce it against challenges and equal protection to the new class of citizens sought to be naturalized along with the same protection already accorded to already naturalized citizens. Trump's EO goes into effect in some 28 states immediately where the injunctions have been removed and also to various other EOs of the president which have been blocked in courts for him to have a free ride with his legislation. Associated with the EO on ending birthright citizenship is the question of the constitutional validity of the 14th amendment along with its four clauses, mentioned before, that are being sought to be questioned some 240 years later in a divided America along strictly ethnic lines – an extension of the Make America Great Again -MAGA - into a MAKE AMERICA WHITE AGAIN, because the 14th amendment was virtually enacted after the then Republican president Abraham Lincoln fought a civil war and freed the African slaves and gave them liberty and the right to vote. Trump, according to his critics, is seeking to subvert the constitution by creating a class of two categories of citizens – those born in the USA and those who came in as immigrants, there was a first wave, a second wave, a third wave, a fourth wave and so on since the 16th century, when America was first discovered by Columbus.

How the Musk-Trump feud threatens to rewire American Politics

hat began as one of the most unlikely yet powerful alliances in recent American political history has now degenerated into an epic and highly consequential battle for ideological supremacy within the Republican Party. Once united by their disdain for government bureaucracy and love for deregulation, Elon Musk and Donald Trump now find themselves on opposite ends of an escalating political war that threatens not just their personal legacies but the structural coherence of the American two-party system itself.

At the heart of this rupture lies the controversial and aggressively expansive "One Big Beautiful Bill"—a legislative behemoth championed by Trump as the defining achievement of his second presidential term. Originally designed to combine sweeping tax cuts with enormous infrastructure and defense spending, the bill has drawn sharp criticism for ballooning the federal deficit and stripping funding from renewable energy sectors, including federal subsidies for electric vehicles. The projected \$4–5 trillion debt-ceiling hike embedded within the bill has left fiscal conservatives uneasy, but none have been as vocally, consistently, and theatrically opposed as Elon Musk.

For Musk, the ideological breach is both personal and philosophical. Once a loyal Trump ally who briefly served as head of the Department of Government Efficiency (ironically abbreviated as DOGE) and donated hundreds of millions to pro-Trump political action committees, Musk has now weaponized his sprawling media platform, X (formerly Twitter), to wage an unrelenting campaign against the bill and, by extension, the president himself. With over 220 million followers hanging on his every word, Musk's posts have framed the bill as nothing short of a betrayal of conservative economic principles—an orgy of pork-barrel spending, crony capitalism, and reckless debt accumu-

Musk's fury reached a crescendo



when details emerged that the bill would phase out federal tax incentives for electric vehicles, a move that poses a direct threat to Tesla's market standing just as the global EV industry approaches a tipping point. But Musk insists that his crusade is not driven by self-interest. In post after post, he has declared that his stand is about "preserving the integrity of

American capitalism" and resisting what he describes as a "cartel of government handouts and corporate

capture.' In a move that few expected but many now fear, Musk has vowed to form a new political entity—the socalled "America Party"—if the bill passes. Promising to represent what he terms "the 80% in the middle," Musk envisions the America Party as a centrist alternative that blends fiscal responsibility with entrepreneurial innovation and transparent governance. His X polls, reaching millions within hours, show overwhelming support for such a thirdparty option—at least within his digital ecosystem.

The idea of launching a viable third party in America is notoriously difficult, fraught with legal, logistical, and political challenges. Gaining ballot access in all 50 states, building a candidate pipeline, and competing against the entrenched political machinery of Democrats and Republicans is no small feat. Yet if anyone has the financial resources, technological infrastructure, and media dominance to attempt it, it's Elon Musk. His existing network of PACs, political operatives, and Silicon Valley loyalists makes the threat of a Muskled insurgency far more plausible than similar third-party dreams of Trump, true to form, hasn't taken

of counterattacks via Truth Social. His posts were laced with sarcasm, personal insults, and what some see as veiled threats. In one widely circulated statement, Trump mocked Musk's reliance on federal subsidies, accusing him of hypocrisy and claiming, "Elon may get more subsidy than any human being in history, by far, and without subsidies, Elon would probably have to close up shop and head back home to

Trump even suggested that DOGE—the very agency Musk once headed—should investigate Tesla, SpaceX, and Neuralink for alleged misuse of government funds. While it remains unclear whether this was rhetorical bluster or a signal of real legal action, civil liberty watchdogs swiftly condemned the comments, warning that Trump was dangerously close to weaponizing state power against a private citizen and former ally for

from a public confrontation, rewith characteristic bravado. In all-caps posts that quickly went viral, he declared: "I AM LITERALLY SAYING CUT IT ALL. NOW," doubling down on his pledge to dismantle corporate welfare-including subsidies that benefit his own companies. Musk positioned himself as the rare billionaire willing to bite the hand that feeds him, presenting himself as the only public figure serious enough to dismantle what he calls Washington's "culture of corrupt handouts."

The political tremors from this feud are already rippling across the Republican landscape. The GOP is now visibly splintering along three emerging fault lines: Trumpian populists loyal to the former president's brand of nationalism and spending-heavy populism; traditional fiscal conservatives alarmed by the soaring deficit; and a rising bloc of technocratic, libertarianleaning voters—many of them younger, urban, and digitally active-who view Musk as a new kind of political champion.

Musk's public threats to fund primary challengers against incumbent Republicans who vote for the bill have thrown House and Senate GOP leadership into crisis mode. Even high-profile Republicans like Speaker Mike Johnson have been singled out by Musk for their support of what he calls the "porkstuffed monstrosity." Meanwhile, Musk has lavished praise on Senate fiscal hawks like Rand Paul and Thomas Massie, holding them up as of examples "conservative courage" in an otherwise compromised Washington.

Democrats, for the most part, are watching the chaos with quiet amusement and strategic calculation. For them, a divided Republican Party improves their own electoral prospects heading into the 2026 midterms. Yet some centrist Democrats have started to take Musk's broader critiques of government inefficiency seriously, wary of losing disaffected independent voters to a potential Musk-led centrist

movement. Beyond the immediate legislative battle, the longer-term implications of this Musk-Trump clash could be transformational for American politics. Musk, unlike traditional corporate titans, is not content to operate from the shadows via lobbyists and backroom deals. He prefers to dominate the conversation directly, mobilizing millions through social media, challenging political orthodoxy, and pushing the boundaries of billionaire activism in ways that make previous political donors look quaint by comparison.

For the tech community, this moment signals the arrival of an overt technocracy in American politics, where CEOs and innovators no longer limit themselves to policy advocacy but openly seek to shape the political narrative and electoral outcomes. Musk's war with Trump is not just a feud between two egos; it is a referendum on the future relationship between technology, governance, and populism in the United States.

As the Senate vote on the "One Big Beautiful Bill" looms near, with July 4 set as a symbolic deadline, the stakes could not be higher. Should the bill pass, the formation of the America Party will move from rhetorical threat to political reality, unleashing a disruptive force that could fracture the GOP, energize disillusioned centrists, and potentially redraw America's political

The next chapter of this saga will determine whether Musk's unique combination of wealth, reach, and ideological fervor can overcome the systemic barriers that have crushed previous third-party efforts. Regardless of the outcome, the Musk-Trump war has already begun reshaping the contours of American political discourse, proving once again that in the 21st century, politics and technology are more intertwined—and combustible—than ever before. Communist Party's Jeannette Jara is the presidential nominee of Chile's ruling coalition for November polls

Joters in the presidential primary of the Unity for Chile (Unidadpor Chile) coalition have selected the Communist Party's Jeannette Jara as their candidate to face off against the right-wing candidates José Antonio Kast and Evelyn Matthei in November's general election in Chile. Presently Gabriel Boric is the President of the country representing this ruling coalition.

Jara scored a stunning 60% total in a four-candidate race on Sunday. Her next closest challenger was Carolina Tohá of the Democratic Socialism party, who took 27.7% of the ballots. The parties in the Unity for Chile coalition pledged to support whichever candidate won the primary, however, so all the left and progressive forces in the country are now rallying behind

"Today begins a new path that we will walk together, with the conviction to build a fairer and more democratic Chile," Jara declared on social media after the Electoral Service announced her win. "In the face of the threat from the far right, we respond with unity, dialogue, and hope.'

At a rally with supporters Sunday, she urged her compatriots to "hold on to each other and not let go, so we can face Chile's far right with the broadest possible front.'

She was immediately congratulated by President Gabriel Boric, who is barred from running for re-election due to constitutional limits on presidents serving consecutive terms.

"Jeannette Jara immediately steps up to lead the forces of progressivism toward the future," Boric said Sunday evening. "What lies ahead will not be easy, but Jeannette knows about tough battles. Now, let's all work together for unity to rally the majority of our compatriots to continue building a fairer, safer, and happier

Jara, 51, is one of the most prominent political leaders in the country. Before stepping down to run for president, she served as Minister of Labour in the Boric government. In that position, she spearheaded successful efforts to reduce Chile's workweek from 45 to 40 hours and raise the minimum wage.

Kast, her main opponent in the general election, is making his third try for the presidency. Last time around, he lost to Boric, capturing 44% in the second round after having led in first-round balloting.

· Kast is part of the right-wing royalty of the Chilean ruling class. His parents were German immigrants who arrived in Chile in the early 1950s. His father, Michael Kast Shindele, was a member of the Hitler's Nazi Party and a lieutenant in the military of the Third Reich.

He escaped from U.S. custody and then fled the de-Nazification campaign in Germany after World War II. He settled in Chile, where, together with other relatives, he set up a sausage factory that made the family one of the richest

The fascist politics brought over from Europe were passed down through the generations. One of Kast's brothers, Miguel, was a "Chicago Boy" economist and labour minister for the former Chilean dictator, Augusto Pinochet. He helped impose neoliberal policies that crushed the Chilean working class, with an emphasis on privatization, deregulation, and attacks on

As a politician, Kast has consistently pushed a reactionary platform premised on giving free rein to big business and handing over control of social policy to ultra-conservative forces. He advocates major tax cuts on the wealthy, a rollback of labour and other progressive legislation, a halt to immigration, and bans on things like emer-

gency birth control and same-sex marriage. His frequent praise for the years of the Pinochet dictatorship have generated controversy but also endeared him to leading capitalists, the military, and the religious base of voters who all fondly remember the years of tyranny that saw tens of thousands of trade unionists, students, Communists, socialists, democracy ac-

tivists, and indigenous people murdered. In 2021, running against Boric, Kast framed the election as "a choice between freedom and communism." With an actual Communist as his main opponent this time, the red-baiting is expected to reach new extremes.

Also in the race is right-wing candidate Evelyn Matthei of the Independent Democratic Union, who has earned the endorsement of some sections of the capitalist class and the foreign business press. The Economist magazine in 2024 proclaimed her "The woman who will lead Chile's counter-revolution."

She served in the government of former President Sebastián Piñera, is a consistent defender of the Pinochet dictatorship, and also comes from a fascist pedigree. Her father, Fernando Matthei Aubel, was the son of a German military officer and was trained by the U.S. Air Force in

After the Pinochet coup in 1973, he returned to Chile and was promoted to the rank of general. During the dictatorship, he served as a government minister and was implicated in campaigns of political repression and trafficking of bacteriological weapons, which were tested on political prisoners.

In the last years of the dictatorship, Evelyn Matthei was head of a government body tasked with privatizing Chile's pension system. During the struggles to democratize the country's political system and overturn military rule in the late 1980s, she was the leader of the campaign that sought to continue the dictatorship and was elected to parliament as a pro-Pinochet deputy.

The latest opinion surveys have her in third place, at 10% support.

The platform of the Unity for Chile coalition has put the issues clearly on the table for voters. It declares: "Chile must decide where to go in the coming years: Deepen the path of change or enter an authoritarian drift.'

Jara and the coalition make the case that the far-right is seeking to "roll back our rights" and promotes an "exhausted free market model that makes life precarious." The alternative, they argue, is a coalition of "those who have historically fought for profound social change: the communities, unions, feminists, youth, indigenous peoples, socio-environmental movements, and cultural figures."

It recalls the Popular Unity coalition that elected socialist Salvador Allende to the presidency in 1970, who was killed during the 1973 U.S.-backed Pinochet coup, but the left program seeks to go beyond the past to build an even stronger progressive front to address the economic challenges of today.

Iran is not Syria, nor like any other country in Middle East

The question of regime change in Iran has recently resurfaced after the killing of Iran's top military commanders following the Israeli airstrikes. It is not the first time that for-

eign powers have imagined Iran as a crumbling house, one that only needs a gentle push, or a series of airstrikes, before it falls into new hands. This was the fantasy in 1953, when the CIA and the British intelligence Mohammad overthrew Mossadegh, Iran's prime minister, who had nationalized the country's oil, and pushed Iran into Mohammad Reza Pahlavi's autocratic rule. And this was also the dream in the 1980s, when Saddam Hussein invaded Iran with military and economic support from the United States, the United Kingdom, France, and Israel, who believed the newly revolutionary Iran would collapse in months. Founded in 1979 after the Iranian Revolution, the Islamic Republic of Iran has democratic, theocratic, and authoritarian elements in its governance system, which makes it a hybrid. The founding figure of the Islamic Republic, Ayatollah Ruhollah Khomeini, envisioned a state run by Islamic clerics and jurists who ensured all policies adhered to Islamic law.

As Iran was a constitutional monarchy before the revolution, theocratic elements were effectively grafted on top of the existing republican ones, such as the parliament, executive, and judiciary. Iran has a unicameral legislature (one house of parliament), called the Majles, and a president. There are regular elections for both. But, while there are democratic elements within this system, in practice, it is a "closed loop" that keeps the clerical elite in power and prevents challenges to the supreme leader. There is a clear hierarchy, with the supreme leader at the top. This complex system of governance makes the Iranian regime a unique one in the Middle East. Iran is not Syria, Libya, or Iraq, where, in movement rooted in the princi-

the recent past, regime change has been achieved. United States policy makers often underestimate the strength of the Iranian state, which is structured for survival. The following features and dynamics make the Iranian regime hard to replace.

The Iranian military has a around 420,000 men across ground, naval, air, and air-defence troops, and the Islamic Revolutionary Guard Corps (IRGC), an elite, ideologically driven military with roughly 190,000 personnel across ground, naval, and air branches. Beyond them is the Basij, a vast paramilitary network with hundreds of thousands of members embedded in every corner of Iranian society—in the streets, in neighbourhoods, in schools. and mosques. They aren't just loyalists of the Ayatollah but woven into a deeper idea of the state and committed to the core ideology of the Islamic Repub-

Despite Israel's extensive and quite successful campaign of assassinations targeting senior IRGC commanders, the core of this group has not been hollowed out but hardened. A younger generation of more ideologically rigid commanders has emerged. This new generation of Iranian military commanders has also been battle-hardened in close-quarter conflict in Syria and understands how wars of state collapse can unfold. Bombing and Air campaigns could significantly destroy military and civilian infrastructure in Iran. but to replace the Iranian regime, President Trump must be prepared to fight not just a standing army but a system with decades of experience in asymmetric warfare.

Iran is not governed by a single man or clique that can be decapitated. The Iranian state is a competitive authoritarian system with institutions that have evolved over a century. Even amid a crisis, the system generates new leaders, factions, and power centres. Even the deaths of some influential figures would not bring the system down: it would renew it. Iran is not merely a conventional state; it is built upon a revolutionary, theocratic ideology. The current structure is more than a government; it is part of an ideological

ples of revolution and resistance. It is naive to think that any external military attack or intervention could destroy this structure. Historically, when Iran faces external threats, its citizens unite under nationalist sentiment, thereby strengthening the ruling regime.

More than 46 years after the Iranian Revolution, there is still talk among Iranians, both those living in the country and among the diaspora, that the end of the regime is nearing. Unless and until large factions of the regime's military, police, and intelligence forces begin defecting, it will be hard for the people of Iran to overthrow the regime. And unfortunately, in every protest movement in Iran since the 1979 revolution, that hasn't happened. The protesters haven't convinced significant individuals within the regime to step away and join them. Yes, there is discontent among the Iranian people, especially regarding women's rights, economic crises, and political freedoms.

However, this dissatisfaction has not yet transformed into a well-organized movement. A significant number of Iranian citizens are voicing their dissatisfaction with the Iranian regime over issues of human rights abuses, the absolute authority of the Supreme Leader, the declining economy of the country, and the lack of freedoms of speech, assembly, and thought. From the 2009 Green Movement to the 2017-2019 economic protests and the 2022 "Women, Life, Freedom" uprising, Iranians have demonstrated extraordinary courage in confronting state violence. But these uprisings have not translated into regime collapse.

Iranian opposition groups may be getting western media attention, but the hard reality is that they have no ground presence inside Iran. The impact of illegal drugs on young society Half

ne of the biggest revolutions of the 21st century is the increase in women's participation. Yet, when the World Economic Forum released the Global Gender Gap Index 2025, India's 131st position indicates that despite all claims of development, women empowerment has remained confined to slogans only. There has been a slight improvement in the field of education and health, but India's situation in political representation and economic participation is worrying.

The Global Gender Gap Index is released every year by the World Economic Forum and evaluates gender equality in four key areas: economic participation and opportunity, educational achievements, health and life expectancy, and political empowerment. In the 2025 report, India is ranked 131st out of 146 countries, while in 2024 it was ranked 129th. That is, we have fallen two more places.

India has certainly made some progress in the field of education. The enrollment rate of girls at the primary level has almost equalized, but participation in higher education is still unequal. The school drop-out rate is higher among girls in rural areas, especially after adolescence. Education is not limited to just going to school, it also provides opportunities, self-reliance and decision-making ability - which is still not available to the majority of girls.

The picture is even more worrying in terms of economic participation. The female labour force participation rate in India is only around 25%, while the global average is 47%. Despite India's large population, the limited economic contribution of women hinders the country's productivity and inclusive growth. Women do not get equal pay for equal work. They work in the informal sector where they do not get any facilities like pension, maternity benefit or social security.

India's position is even weaker in the field of political representation. This is the reason why India has received the lowest marks in political empowerment in the Global Index. The number of women MPs in Parliament is still less than 15%. The picture of state assemblies is no different. Even though there is 33% reservation at the Panchayat level, there too the name of women is mentioned, but the power is in the hands of their husband or father-in-law - that is, words like "Sarpanch pati" have now become a part of our political culture.

India's position becomes even more worrying when we compare it with our neighbouring countries. Countries like Bangladesh (99th), Nepal (117th), and Sri Lanka (123rd) are ahead of India, while Pakistan (148th) is at the bottom. Bangladesh has strengthened women's leadership politically and has also improved women's labour participation. This shows that willpower and change in social thinking is more important than resources.

Politics is not just a centre of power, but a platform for guiding social discourse. Only when there are women in Parliament, Assembly and Cabinet, will their issues—women's safety, maternal health, education, gender justice—become a real priority. But, in India, the mindset of considering women leaders as "someone's wife" or "someone's daughter" still prevails. Lineage and male patrons are seen more than the quality of leadership.

The real situation of women in villages and small towns is even more complex. Even today, incidents like child marriage, dowry, domestic violence and honour killing are a blot on women empowerment. There are so many women who do not know about bank accounts, property rights or legal protection. Government schemes like Ujjwala or Beti Bachao-Beti Padhao are visible, but their ground impact is not visible in the statistics.

However, there are some rays of light amidst all this darkness. Through campaigns like Startup India and Digital India, many women have started small online businesses. Many women are making India proud on international platforms in the field of sports, science, and technology. Names like PV Sindhu, Avani Lekhara, and ISRO's female scientist Ritu Karidhal are examples that if given opportunity and confidence, women can change not just their homes but the world.

Now the question is—what to do next? First of all, a law to provide 33% reservation to women in Parliament and Assembly should be passed as soon as possible. This is not just a question of representation, but a question related to the soul of democracy. Flexible work policies like maternity leave, crèche facility, and gender safety at workplace are necessary to increase women's labor participation. There should be special scholarships, hostels and security arrangements for higher education of girls. And most importantly, society will have to change its thinking. Daughters will have to be considered an opportunity, not a burden.

India dreams of becoming a global power in the 21st century, but this dream is incomplete by marginalizing half of the population. Women need not just corrective policies but a mental revolution based on equality. The Global Gender Gap Index is not a foreign conspiracy but a mirror that shows us our reality. NEW YORK/WASHINGTON, July 3: Operation Sindoor conveyed to the world with great clarity that India will act against terrorism, External Affairs Minister S Jaishankar said in a statement in line with the UN Security Council calling for those responsible for the Pahalgam attacks to be brought

to justice. 'What is important for us in the Quad statement, as also the statement that the Security Council had issued on April 25, is that the perpetrators of terrorism must be held accountable. They must be brought to justice," Jaishankar said during a press conference in Washington on Wednesday.

"And that's important because we then have to communicate to the world what we did. On May 7, the objective of Operation Sindoor is that if there are terrorist attacks, we will act against the perpetrators, the supporters, the financiers, and the enablers. So that message, I think, was conveyed with great clarity," he said.

A joint statement issued by Quad Foreign Ministers -- Jaishankar, US Secretary of State Marco Rubio, Foreign Minister of Australia Penny Wong, and Japanese Foreign Minister Takeshi Iwaya -- unequivocally condemned all acts of terrorism and violent extremism in all their forms and manterrorism.

The Quad foreign ministers condemned in the "strongest terms" the April 22 terrorist attack in Pahalgam, Jammu and Kashmir, which left 26 people dead.

"We call for the perpetrators, organisers, and financiers of this reprehensible act to be brought to justice without any delay and urge all UN member states, in accordance with their obligations under international law and relevant UN-SCRs (UN Security Council resolutions), to cooperate actively with all relevant authorities in this re-

gard," the joint statement said. The UN Security Council press statement condemned the Pahalgam attack, with members of the Security Council underlining the need to hold perpetrators, organisers, financiers and sponsors of this reprehensible act of terrorism accountable

House GOP clears key

night, House Republicans voted before dawn on Thursday to advance President Donald Trump's tax and spending cuts package after GOP leaders worked almost around the clock trying to persuade sceptical holdouts as they race to send the bill to his desk by the Fourth of July deadline.

A roll call that started late Wednesday finally closed almost six hours later, a highly unusual stall on a procedural step.

Trump, who had hosted lawmakers at the White House earlier, lashed out at the delay. Once the gavel struck, 219-213, the bill advanced to a last round of debates toward a final vote, which is expected later Thursday morning.

"Our way is to plow through and get it done," House Speaker Mike Johnson said, emerging in the middle of the night from a series of closed-door meetings. "We will meet our July 4th deadline."

The idea of quickly convening to for a vote on the more than 800page bill after it passed the day before in the Senate was a risky gambit, one designed to meet Trump's demand for a holiday finish. Republicans have struggled mightily with the bill nearly every step of the way, often succeeding one vote. Their slim 220-212 majority leaves little room for defec-

Several Republicans are balking at being asked to rubber-stamp the Senate version less than 24 hours after passage. A number of moderate Republicans from competitive districts have objected to the Senate bill's cuts to Medicaid, while conservatives have lambasted the legislation as straying from their fiscal goals. "What are the Republicans waiting for??? What are you trying to prove???" Trump railed in a post-midnight vote. He also warned starkly of political fallout from the delay "COSTING YOU

VOTES!!!" It fell to Johnson and his team to convince them that the time for negotiations is over. They needed assistance from Trump to close the deal, and lawmakers headed to the White House for a two-hour session Wednesday to talk to the president about their concerns. Trump also worked the phones. "The president's message was, We're on a roll," said Rep. Ralph Norman, R-SC "He wants to see this."

Republicans are relying on their majority hold of Congress to push the package over a wall of unified Democratic opposition. No Democrats voted for bill in the Senate and none were expected to do so in the House. "Hell no!" said House Democratic Leader Hakeem Jeffries, flanked by fellow Democrats outside the Capitol.

In an early warning sign of Republican resistance, during a first procedural vote that also stalled out as GOP leadership waited for lawmakers who were delayed coming back to Washington and conducted closed-door negotiations with holdouts.

By nightfall, as pizzas and other dinners were arriving at the Capitol, the next steps were uncertain. Trump pushes Republicans to do

the right thing The bill would extend and make permanent various individual and business tax breaks from Trump's first term, plus temporarily add new ones he promised during the 2024 campaign. This includes allowing workers to deduct tips and pay, and a USD 6.000 deduction for most older adults earning less than USD 75,000 a year.

In all, the legislation contains about USD 4.5 trillion in tax cuts over 10 years. The bill also provides about USD 350 billion for defense and Trump's immigration

Republicans partially pay for it all through less spending on Medicaid and food assistance. The Congressional Budget Office projects the bill will add about USD 3.3 trillion to the federal debt over the coming decade.

The House passed its version of the bill in May by a single vote, despite worries about spending cuts and the overall price tag. Now it's being asked to give final passage to a version that, in many respects, exacerbates those concerns. The Senate bill's projected impact on the nation's debt, for example, is significantly higher. (AP)

US employers added surprising 147,000 jobs last month despite uncertainty over economic policy

WASHINGTON, July 3: US employers added 147,000 jobs in June as the American labour market continues to show surprising resilience despite uncertainty over President Donald Trump's economic policies.

The unemployment rate ticked down 4.1 per cent from 4.2 per cent in May, the Labour Department said Thursday. Hiring rose modestly from a revised 144,000 in May and beat economists expectations of fewer than 118,000 new jobs and a rise in the unemployment rate.

The US job market has cooled considerably from red-hot days of 2021-2023 when the economy bounced back with unexpected strength from COVID-19 lockdowns and companies were desperate for workers. So far this year employers have added an average 124,000 jobs a month, down from 168,000 in 2024 and an average 400,000 from 2021 through 2023.

Hiring decelerated after the Federal Reserve raised its benchmark interest rate 11 times in 2022 and 2023. But the economy did not collapse, defying widespread predictions that the higher borrowing costs would cause a recession. Companies kept hiring, just at a more But the job market increasingly looks under

strain. A survey released Wednesday by the pay-



roll processor ADP found that private companies cut 33,000 jobs last month. "Though layoffs continue to be rare, a hesitancy to hire and a reluctance to replace departing workers led to job losses last month," said ADP chief economist Nela Richardson. (The ADP numbers frequently differ from the Labor Department's official job count.)

Employers are now contending with fallout from Trump's policies, especially his aggressive use of import taxes - tariffs.

Mainstream economists say that tariffs raise prices for businesses and consumers alike and make the economy less efficient by reducing competition. They also invite retaliatory tariffs a half. (AP)

from other countries, hurting US exporters. The erratic way that Trump has rolled out his tariffs - announcing and then suspending them, then coming up with new ones — has left businesses bewildered.

Manufacturers responding to a survey released this week by the Institute for Supply Management complained that they and their customers were reluctant to make decisions until they understood where Trump's tariffs would end up. "That whiplash has to stop and it has to stay stopped," said Susan Spence, chair of the ISM's manufacturing survey committee.

Trump's assault on the federal bureaucracy could also show up in June's job report. Nancy Vanden Houten, lead US economist at Oxford Economics, expects federal jobs dropped by 20,000 last month, "reflecting a hiring freeze, voluntary quits and retirements.' For now, she wrote in a commentary Wednesday, court rulings "have put massive federal layoffs on hold."

The president's deportations — and the threat of them — also are likely to start having an impact on the job market by driving immigrants out of the job market. In May, the US labour force — those working and looking for work fell by 625,000, the biggest drop in a year and

94 Palestinians killed in Gaza, including 45 people waiting for aid: Authorities

TEL AVIV, July 3: Airstrikes and shootings killed 94 Palestinians in Gaza overnight, including 45 who were attempting to get much-needed humanitarian aid, ospitals and the Health Ministry said on Thursday.

Israel's military did not immediately comment on the strikes. Five people were killed while outside sites associated with the Gaza Humanitarian Foundation, the newly-created, secretive

American organisation backed by Israel to feed the Gaza Strip's population, while 40 others were killed waiting for aid in other locations across the Gaza Strip.

Dozens of people were killed in airstrikes that pounded the Strip Wednesday night and Thursday morning, including 15 people killed in strikes that hit tents in the sprawling Muwasi zone, where many displaced Palestinians are

A separate strike on a school in Gaza City sheltering displaced people also killed 15 people.

Gaza's Health Ministry said the number of Palestinians killed in Gaza has passed 57,000, including 223 missing people who have been declared dead, since the war began on October 7, 2023.

CAIRO, July 3: Amnesty International accused a controversial Israeli- and US-backed system to distribute aid in Gaza of using starvation tactics against Palestinians to continue to commit genocide in the Gaza Strip during Israel's war

The UK-based human rights group released a report Thursday condemning Israel and the Gaza Humanitarian Foundation, which the US and Israel have backed to take over aid distribution in Gaza from a network led by the United Nations.

Gaza's Health Ministry says more than 500 Palestinians have been killed at or near GHF distribution centres over the past month. The centres are guarded by private security contractors and located near Israeli military positions. Palestinian officials and witnesses have accused Israeli forces of opening fire at crowds of people

moving near the sites. The Amnesty report said Israel has "turned aid-seeking into a booby trap for desperate starved Palestinians" through GHF's militarised hubs. The conditions have created "a deadly mix of hunger and disease pushing the population

past breaking point. "This devastating daily loss of life as desperate Palestinians try to collect aid is the consequence of their deliberate targeting by Israeli forces and the foreseeable consequence of irresponsible and lethal methods of distribution," said Agnès Callamard, Amnesty's secretary general.

Israel denies accusations Israel's foreign minister denounced the Amnesty report, saying the organization has "joined forces with Hamas and fully

adopted all of its propaganda lies.' The Israeli army says it has fired warning shots to control crowds and only fires at people it says are

acting suspiciously. The Foreign Ministry and COGAT, the Israeli defense body in charge of coordinating aid to Gaza, said Israel has facilitated the entry of over 3,000 aid trucks into the Gaza Strip since May 19 and GHF has delivered boxes of food with the equivalent of 56 million

Humanitarian organizations say that amount is not nearly enough to meet overwhelming need in



Gaza. GHF did not immediately return requests for comment.

The World Food Programme says despite the new Israel-backed initiative, food consumption reached a critical low last month, with food diversity reaching its worst level since the conflict began. "The continued closure of crossings, intensified violence since March, soaring food prices. and extremely limited humanitarian and commercial supplies have severely restricted access to even basic food items," the WFP said in a June report.

GHF hubs are close to Israeli military positions

Amnesty's report follows a statement earlier this week from more than 165 major international charities and non-governmental organizations calling for an immediate end to the foundation. They say the new mechanism allows Israel to use food as a weapon, violates humanitarian principles and is in-

It's the latest sign of trouble for the GHF, a secretive initiative headed by an evangelical leader

Donald Trump. Last month, the US government pledged USD 30 million for the group to continue operation, the first known US donation to the group, whose other funding sources remain opaque.

GHF started distributing aid May 26 following a nearly threemonth Israeli blockade that pushed Gaza's population of more than 2 million to the brink of famine.

Palestinian witnesses have describe scenes of chaos around the distribution sites, and two contractors in the operation have told The Associated Press that colleagues fired live ammunition and stun grenades toward crowds of people. Palestinians often must travel long distances to reach the sites.

In a statement Tuesday, GHF rejected criticism of its operations and claimed it has delivered more than 52 million meals to hungry Palestinians.

"Instead of bickering and throwing insults from the sidelines, we would welcome other humanitarian groups to join us and feed the people in Gaza," GHF said.



NEW DELHI, July 3: Union Minister Jitendra Singh on Thursday said Jammu and Kashmir will emerge as a key growth engine in India's journey.

Highlighting Jammu and Kashmir's continued importance in national priorities, he said the recent milestone projects like the Chenab bridge, the Lithium discovery and the purple revolution of lavender farming is empowering youth entrepreneurs in the region.

"J&K will emerge as a key growth engine in India's journey from the 4th largest to the 1st largest global economy," said Singh, the Minister of State for Personnel.

His remark came during an informal luncheon hosted here for Delhi-based Indian Administrative Service (IAS), Indian Police Service (IPS) and Indian Forest Service (IFoS) officers of the erstwhile Jammu and Kashmir cadre, now merged with Arunachal Pradesh-Goa-Mizoram and Union Territory cadre (AGMUT).

He also recalled the turbulent times of peak militancy in the 1990s and early 2000s, acknowledging the courage of officers, who served in extremely challenging circumstances.

The minister encouraged officers to break rigid hierarchies, sharing that he maintains personal contact with many officers and often reaches out directly. "It saves

time and gets the job done faster, especially when the outcome affects people's welfare," he said. The gathering saw officers from diverse batches and services reminiscing about their days of service in Jammu and Kashmir and appreciating the opportunity to reconnect.

Singh, in his address, reflected on the careers of several officers from their first postings in Jammu and Kashmir to their rise through the ranks into senior lead-

Minor rape survivor agrees to continue with pregnancy post AIIMS opinion in HC

NEW DELHI, July 3: A minor rape survivor, who sought termination of her 27-week foetus, on Thursday agreed to continue with her pregnancy after AIIMS doctors opined in the Delhi High Court that aborting the pregnancy at this stage would amount to foeticide

The doctors, who were part of the medical board of All India Institute of Medical Sciences (AIIMS) which examined the minor, stressed that it would be in the best interest of the child to be born and his mother if the pregnancy is continued for another 4-6 weeks.

A bench of Chief Justice D K Upadhyaya and Justice Anish Dayal then modified a single judge's order, which allowed the 16-year-old girl to terminate the pregnancy, considering the medical board's opinion. The court told the counsel appearing for the survivor and her mother to make them understand that it

would be in the interest of the survivor and her child to continue with the pregnancy and after the delivery if they wish, the infant could be given for adoption. Post discussions with the survivor and her mother,

the counsel informed the bench that the survivor had

agreed to continue with the pregnancy. The bench termed the situation to be "very unfortunate, unpleasant and precarious" in which the court had to ensure the welfare of both the minor girl and

Two doctors comprising the medical board appeared before the court and said if the procedure was performed right now, it would be a pre-term delivery with the child being alive and not the termination of

The doctor said it would amount to foeticide which was only permissible in case of medical issues.

Terminating the pregnancy would hamper her future reproductive health and it would be much safer to perform the procedure at 34 weeks gestation period, she added. The doctor said if this pregnancy was allowed to be terminated, it would open floodgates and others who did not want to continue with the pregnancy would demand termination.

The bench then said, "It will be a foeticide which is only permissible in cases with medical issues. It amounts to an offence under the criminal law and please don't ask us to be party to that."

The court while modifying the single judge's June 30 order said the girl should remain admitted to AIIMS for the entire gestation period and till her de-

She should also be allowed to stay in AIIMS till she

feels fit after delivering the child, it added. The court directed AIIMS to provide free medical treatment to the girl and the child for the next five

"The facts and circumstances of this case presents a very unfortunate, unpleasant and precarious situation where this court has to ensure the welfare of both the minor girl as well as the child to be born," the court The bench continued, "The care of both these lives

does not merely require medical attention but also

having regard to the socio-economic cultural situation of our society, they will constantly be needing other forms of support such as psychiatric or psychological treatment or counselling and some financial support The court asked the Delhi government's Depart-

ment of Women and Child Development to file an affidavit giving details of the mode of help to the girl and the child and posted the matter on October 15.

In the day earlier, the court said that "advising a rape victim to prolong her pregnancy will entail anxiety" which could have a grave impact on her mental

Mamata writes to Shah, seeks action against provocative social media content, cybercrime

KOLKATA, July 3: Expressing concern over the rising impact of provocative social media content and cybercrime, West Bengal Chief Minister Mamata Banerjee on Thursday wrote to Union Home Minister Amit Shah and stressed the need for stringent legislative and policy interventions.

The two-page letter refers to recent "incendiary narratives, misleading stories and fake videos" on social

media, which have "significantly contributed to aggravation of criminal tendencies among certain sections of society". "Such content not only spreads

misinformation but also has the potential to inflame communal sentiincite violence, disrupt societal harmony and indulge in crime against women," Banerjee wrote and added, "The instantaneous and wide-reaching nature of misuse of digital platforms amplifies these effects manifold." In April this year, the Muslim-ma-

jority district of Murshidabad witnessed large-scale violence, which began as a protest against the passed Waqf (Amendment) Act and quickly spiralled out of control into communal riots, resulting in multiple deaths and widespread damage to public and private property.

More recently, in June, violence of communal nature broke out at Maheshtala under the Diamond Harbour police district in the outskirts of Kolkata. The clashes left about a dozen police personnel, including the deputy commissioner of the Port area, injured.

The state has also witnessed communal violence in districts like Howrah and Hooghly in the recent past

In the aftermath of almost all these incidents, Banerjee has remained vocal about the spread of lies and misinformation on social media which, she maintained, added fuel to the fire.

In her letter to the Union home minister, Banerjee also highlighted the menace of an alarming surge in cybercrime which, she said, is "growing both in complexity and in its detrimental impact".

"From financial frauds and identity theft to online harassment and defamation, cybercrimes are exacting a severe toll on individuals and institutions alike," the chief minister Observing that both provocative

social media posts and cybercrimes disproportionately affect vulnerable sections of society - women, children, the elderly and the economically weak - Banerjee urged the introduction of stringent legislative measures to serve as an effective deterrent to the two crime formats. "The current legal framework and

its enforcement require further strengthening to keep pace with the rapidly evolving digital ecosystem and the sophisticated methods employed by malicious actors," she said. The chief minister also urged the home minister on the necessity to launch large-scale awareness campaigns to promote responsible digital behaviour alongside sensitisation programmes, digital literacy campaigns and community engagement initiatives.

"This is a collective challenge requiring urgent and coordinated action to safeguard public order, national unity, and the integrity of our democracy," the Trinamool Congress posted on X, quoting Banerjee's letter. (PTI)

Reduce disruptions in House: LS Speaker Birla

GURUGRAM, July 3: Ahead of the Monsoon Session of Parliament, Lok Sabha Speaker Om Birla on Thursday urged all political parties to reduce disruptions in House proceedings and asserted it is time to change past practices.

Addressing the national level conference of Urban Local Bodies here, Birla said that people would teach a lesson to political parties that resort to disruption of the House proceedings.

Birla said there has been some reduction in disruption of the House proceedings in the 18th Lok Sabha, which had its first sitting in June last year.

"It is time for change. If we have to strengthen democracy and hold democratic institutions accountable, we have to ensure that the Houses function in a proper manner," he added.

The speaker said all political parties should make efforts to reduce disruptions in proceedings of the House. Parliament's Monsoon Session is scheduled to begin on July 21 and continue till August 21, a week longer than the original plan to conclude on August 12.

Birla said that he had been wi nessing the Lok Sabha proceedings since 2014 when he was elected as a member for the first time.

"The members used to get placards to disrupt the proceedings of the House. The 17th Lok Sabha (2019-2024) was no different, but change was visible in the 18th Lok Sabha," he said.

Birla said the political parties and members started thinking that the House should be allowed to function so that issues faced by people could be raised effectively.

"All political parties made efforts to ensure that the House functions properly," he said. Birla also wanted the Urban Local Bodies to adopt similar practices as the Lok Sabha and state assemblies of having the Ouestion Hour and Zero Hour in their functioning.

"Why can't we make efforts to have day-long sittings of ULBs? Let the meeting continue for eight hours. It can have Ouestion Hour. Zero Hour. Issues can be discussed and accountability can be fixed to ensure transparency," the speaker

CISF trains 380 firefighters across 150 cities in national fire safety initiative

GUWAHATI, July 3: In a significant national initiative aimed at enhancing fire safety and disaster response, the Central Industrial Security Force (CISF) has successfully trained 380 fire service personnel from 150 cities across 22 States and Union Territories.

According to an official statement issued by the force, the CISF, India's only Central Armed Police Force (CAPF) with a dedicated fire wing, has been at the forefront of implementing a specialised training programme following a directive issued by the Union Home Minister during the CISF Raising Day in 2023.

The minister had tasked the force with upskilling firefighters from 100 Indian cities to strengthen national fire safety ca-

pabilities. In response, the CISF's Fire Service Training Institute (FSTI) in Hyderabad developed a tailormade curriculum focused on modern firefighting techniques, rescue operations, and disaster manage-

ment strategies. The institute conducted 11 training batches during the 2023–24 period, training 274 firefighters from 113 cities.

Building on this momentum, the CISF continued the initiative in 2025, adding five more training batches. Four of these have already concluded, benefiting 106 participants from 46 cities across 10 states. The fifth batch is scheduled to begin on August 25, 2025.

The CISF has indicated its readiness to organise additional training sessions during the current calendar year if states continue to nom-

The curriculum has been specially designed to tackle the challenges posed by densely populated urban areas and hazardous industrial zones.

Trainees are instructed in advanced firefighting technologies and protocols, as well as in responding to Chemical, Biological, Radiological, and Nuclear (CBRN) emergencies and potential chemical warfare scenarios.

A CISF spokesperson underlined the importance of the programme, stating that as the only CAPF with a dedicated fire service, the force is committed to enhancing the technical skills of fire personnel and fostering a proactive culture of fire safety and disaster preparedness.

The training modules are routinely updated to reflect advancements in fire science and to ensure readiness for both emergency response and preventive action.

The Fire Service Training Institute in Hyderabad, a state-of-theart centre of excellence, plays a central role in this effort.

It not only caters to CISF personnel but also extends training services to members of other national and international organisations, reinforcing India's capacity in fire and disaster management.

As the initiative continues through 2025, the CISF aims to deepen its collaboration with state fire services, contributing to the broader vision of a disaster-resilient India. The training drive stands as a testament to the CISF's enduring commitment to protecting lives, infrastructure, and property across the nation.

Party loyalist with RSS roots, Samik Bhattacharya picked to revive Bengal BJP ahead of 2026 polls

KOLKATA, July 3: A dyed-in-the-wool party loyalist and articulate communicator with deep roots in the RSS. Samik Bhattacharva's election as the West Bengal BJP president signals the central leadership's calibrated move to steer the state unit through internal churn and retool it into a winning machine ahead of the 2026 assembly elections.

At 61, Bhattacharya's rise to the state's top organisational post is being seen as a reward for decades of silent perseverance, ideological fidelity, and personal discipline, traits that have kept him at the core of the party machinery even when he wasn't in the limelight.

A Rajya Sabha MP, he was elected unopposed as the new president of the Bengal unit. A bachelor, Bhattacharya's political journey began in the mid-1970s when, as a schoolboy, he first attended RSS shakhas in Howrah's Mandirtala area

Immersed early in Sangh values, he joined the Akhil Bharatiya Vidyarthi Parishad (ABVP), which marked the beginning of his full-time political life as a foot soldier of the Sangh Parivar. He has been part of BJP since its marginal

years in West Bengal, staying committed even when the party had little organisational presence or electoral relevance, long before its breakthrough post-2018.

Gradually, he rose through the ranks: from ABVP to BJYM during Tapan Sikdar era in the 1990s, and over the next three decades held every major organisational post: state general

secretary, vice-president, and chief spokesperson, except the presidency.

It was during his days in BJYM that he forged a camaraderie with his contemporary Rahul Sinha, who would later head the state BJP in 2009. His prominence grew under Tathagata Roy's presidency, when he was appointed state general secretary. Though he did not wield much organisational power under Dilip Ghosh, he was made chief spokesperson—a position that showcased his clarity, calmness, and com-

Despite serving under nine state presidents, Bhattacharya remained a go-to man within the organisation, trusted for ideological clarity and internal coordination, even as others leapfrogged into power or drifted away. (PTI)

Doubling of Aluabari Road—Thakurganj rail section sanctioned under NFR

aimed at enhancing rail infrastructure in Eastern India, the Ministry of Railways has sanctioned the doubling of the Aluabari Road-Thakurganj railway section under the Northeast Frontier Railway

According to an official statement issued by the NFR, the sanctioned project covers a total length of 19.95 kilometres and will be implemented at an estimated cost of approximately ₹326.67 crore.

The work falls under the broader railway initiative for multi-tracking and flyover or bypass development, aimed at capacity augmentation during the financial year 2024-25.

According to the statement, the doubling of this section will deliver significant benefits to the

people of Eastern Bihar and North Bengal. The enhanced rail infrastructure is expected to improve regional mobility, reduce travel time, and increase the punctuality of passenger trains.

Furthermore, it will streamline the movement of freight trains carrying agricultural produce, consumer goods, and essential commodities. This, in turn, will bolster local

economies by ensuring better market access for farmers, small traders, and transport-dependent industries. The Aluabari Road-Thakurganj

route lies on a High-Density Net-

work (HDN) corridor connecting

Aluabari to New Jalpaiguri. The current utilisation rate of this section is already 94 percent, and projections estimate that it could reach as high as 200 percent



for rail services on the rise, the doubling project is seen as a crucial intervention to boost line capacity, reduce train detention, and offer improved operational flexibility. The strategic importance of the section is further underscored by its integration with other infrastructure works in the region.

Once completed, the line will complement parallel initiatives such as the proposed new railway link between Araria and Galgalia,

When asked about the stalemate in the election of the state party president, the chief minister said the BJP, being a disciplined party, will take a final call in an appropriate manner and at an appropriate time.

Barman thanked Prime Minister Narendra Modi, Union Home Minister Amit Shah, BJP general secretary B L Santosh and Chief Minister Manik Saha for making him a cabinet minister of the northeastern state.

"I had no discussion with the chief minister regarding my portfolio. Being a disciplined karyakarta (worker), I had done whatever task was given to me by the party and will continue to so," Barman, who had spent a considerable time in West Bengal for boosting the party organisation, told reporters.

Barman returned to Tripura in 2021 and was appointed the party's state general secretary. He fought the assembly elections in 2023 and won by a comprehensive margin from Nalchar assembly constituency in Sepahijala district. (PTI)

"On average, one person dies

every 3.5 minutes in road accidents in India. In Tripura, two people died every three days last year. This year, it has imoccurring every four days," Anurag said. "Thanks to a focused road safety drive, Tripura's performance is now better than the national average." He informed that the police and traffic units are adopting the "4E" approach— Education, Engineering, Enforcement, and Emergency Services—to enhance road safety. Multiple departments in the state are collaborating under



this strategy. Highlighting progress, the DGP said that road traffic accident (RTA) deaths in Tripura were 13% lower in 2023 compared to the previous year. In the current year, up to June, RTA deaths have declined by 30%, and total accidents have dropped by 10%. "Over-speeding is the main cause of road accidents. While it accounts for 71% of accidents nationwide, in Tripura, it contributes to 90% of the cases. Other contributing factors include driving under the influence, poor vehicle maintenance, and violation of

tal deaths significantly outnumber those caused by crime,' Anurag pointed out.

The DGP stressed the impor-

tance of public cooperation in adhering to traffic rules to reduce fatalities and injuries. He noted E-Tender Notice No. CON/2025/ with concern that 66% of accident victims are youth between 18 and 45 years of age. "Last year Tripura recorded 226 deaths from road accidents, while 116 people were murdered. Clearly, acciden-

The event marked a significant step toward enhancing emergency response capabilities in the state, with authorities reaffirming their commitment to curbing road fatalities through stricter enforcement and awareness.

Pochettino says pro-visitor crowd in St. Louis was 'like to play in Guatemala

ST LOUIS (USA), July 3: Mauricio Pochettino got a feel for what the U.S. men's national team still faces at times during home games: a crowd rooting for the opposition.

"It was like to play in Guatemala," the coach said after his team got two early goals from Diego Luna and hung on for a 2-1 win Wednesday night that advanced the Americans to the CONCACAF Gold Cup final. "That was good for our players because it was an atmosphere that we didn't expect."

The U.S. will play Mexico or Honduras on Sunday in Houston, the Americans' last competitive match before next year's World Cup.

A sellout crowd of 22,423 at Energizer Park energized Los Chapines, who outshot the U.S. 20-12 and got an 80th-minute goal from Olger Escobar.

"That is football." Pochettino said. "When we say the connection in between the fans and the team, that is the connection that we'd like to see in the World Cup. That connection that makes you fly, because (of) the energy that translates.'

U.S. players are used to some home matches where the support is overwhelmingly for the oppo-

"We're a country full of immigrants, so it was kind of expected for tonight," defender Chris Richards said. "It was good for some of the younger guys to kind of experience that tonight, but for us experienced guys, we went through World Cup qualifiers with the exact same stuff, so I think that was a good lesson that the team needed to learn."

An Argentine who played for his nation 20 times, Pochettino comes from a culture where soccer dominates life.

"I saw player of the Guatemala crying," he said. That is the way that we need to feel, and our fans need to feel the same. It's not to come here and to enjoy f the spectacle and you lose, nothing happens. Yes, it happens a lot. Things happen because you play for your pride, you play for many, many things that I think I cannot tell you tonight. But I think it's good for our players I came from Argentina and in Argentina it's not the same win or lose. The consequences are massive."

"The rest of the opponents and the different countries," he added, "you play for survival, you play for food, you play for pride, you play for many things. It's not to go and enjoy and go

home and laugh and that's it." Luna has showed the hunger Pochettino wants. The 21-yearold impressed the coach when he continued playing with a broken nose during a January friendly against Costa Rica in which the Americans used a B team after training sessions with mostly Major League Soccer players that some fans nicknamed Camp Cupcake. He's become a regular in the Gold Cup and has three goals in his last two games. "Diego was the example from January, how he is desperate to play for this shirt, for the national team and that is why now he is in the level that he showed," Pochettino said.

Striker Patrick Agyemang also has emerged from January camp to gain a starting berth at the Gold Cup, where many regulars

'Frustrated' Woakes rues missed chances as close calls go India's way on day 1



BIRMINGHAM, July 3: Seasoned England pacer Chris Woakes admitted to feeling "frustrated" after a couple of tight umpiring calls went in India's favour against his bowling on the opening day of the second Test here.

Woakes, with his immaculate line and length, turned out to be the standout bowler for the hosts as he ended day one with figures of 2 for 59 from 18 overs.

However, two key reviews off his bowling -- both ruled umpire's call -- did not go England's way.

"It was a pretty frustrating morning, really," Woakes told reporters after stumps on the opening day on Wednesday.

"Obviously emotions run high when you are desperate to do well for the team, do well for yourself and it would have been nice... had those decisions gone our way, the day looks completely different, but that is Test cricket and we move on," he added. Both decisions involved India's top order.

The first came in the seventh over, with India at 14 without loss, when Yashasvi Jaiswal was struck on the pads. The second was in the 11th over, with India 21 for one, and Karun Nair survived a similar review. On both occasions, DRS showed the delivery clipping the stumps, but not enough to overturn the not out on-field call by Bangladeshi umpire Sharfuddoula.

"We could have easily had them

"He's always on my mind, that's for sure. There are moments where you certainly think about him. He loved his cricket; he would've loved this week," he said. (PTI)

Starting as the second-seeded player in Group B of the Under-12 Girls category, Pratitee remained unbeaten throughout the group stage, scoring an impressive 6.5/7, defeating the top-

Nigeria, along with players from India, Russia, Georgia, and Mongolia.

LONDON, July 3: When Naomi Osaka opened up about her anxiety and depression at the 2021 French Open, it sparked a conversation in sports — and society at large — about mental health and the importance of addressing such issues.

In the time since, more and more players have spoken about the topic and seeking help, and whatever taboos there were seem to have faded. Still, the way three-time Grand Slam finalist Alexander Zverev discussed his state of mind after a first-round exit at Wimbledon this week revived the conversation. "I feel very alone out there at times. I struggle mentally. ... I'm trying to find ways to kind of get out of this hole. I keep kind of finding myself back in it in a way," said Zverev, who was the runner-up at the Australian Open in January but then went through a rough stretch of results this season when he had a chance to overtake Jannik Sinner at No. 1 in the rankings.

Alexander Zverev says at Wimbledon he feels quite alone

"I feel, generally speaking, quite alone in life at the moment, which is a feeling that is not very nice," Zverev said. "It's not a feeling on a tennis court, it's just a life feeling in general.'

Players at the All England Club were asked Wednesday about Zverev's words.

They could empathize, some said. Amanda Anisimova was a French Open semifinalist as a teen in 2019, then announced two years ago she was taking time off because of burnout. She's been back for a while now and reached the third round at Wimbledon with a victory Wednesday.

"It's definitely tricky. Each and every one of us goes through something at some point in our lives. We have our bouts of negative times.'

"It honestly takes some selfreflecting, figuring out what's going wrong or how can I create a lifestyle that I enjoy. I feel like there are so many factors. For me, personally, it was finding people that I could confide in and I trusted. People that I could talk to," Anisimova said.

"What Alex said about feeling lonely ... a lot of people struggle with being lonely, especially on the pro circuit," she said, adding that taking a break from tour life "really helped me and I'm happy I did that, because I came back with a new perspective, felt refreshed, and I feel like I learned a lot about myself."

Wimbledon athletes talk about turning to therapy for help



Top-ranked Aryna Sabalenka, who owns three major trophies, said that she worked with a therapist for five years.

"It's really important to talk openly about whatever you're dealing with. ... It's really important to be open and to talk about what are you experiencing, because if you're going to keep it inside, it's just going to destroy you. I think that's kind of like something happening to him," Sabalenka said. "I think (Zverev) just needs to open up to whoever is close to him."

At the Australian Open, title winner Madison Keys addressed

her reliance on therapy and the ways in which it both allowed her to be happier, in general, and more successful at tennis — a sport in which losses are frequent and expectations can be a

On-court losses in tennis can affect off-court identities

"Our identity becomes very wrapped up in being a tennis player. That's great, but when you have the tough kind of weeks, months, years on tour, that can really take a toll on how you think about yourself as a person," Keys, a 30-year-old

American, said Wednesday. "So being able to kind of dive into that and figure out how to separate the two and know that you're not just a tennis player, you're a full person that has all of these other really great attributes and other interests and just different things in your life.'

When a reporter asked the No. 3-seeded Zverev after his loss to unseeded Arthur Rinderknech on Tuesday whether he might consider trying therapy, the 28-yearold German replied: "For the first time in my life, I'll probably

This is how he described his current mindset: "I've never felt this empty before. Just lacking joy, just lacking joy in everything that I do. It's not necessarily about tennis. Just lacking joy outside of tennis, as well."

Andrey Rublev, a 10-time Slam quarterfinalist from Russia who is seeded 14th at Wimbledon, said after his win Wednesday that life on tour, in and of itself, is not the problem for someone like Zverev.

"Tennis is just the trigger point," Rublev said. "It's something inside of you that you need

U19 ODI: Record-breaking Suryavanshi helps India colts beat England by 4 wkts

NORTHAMPTON, July 3: Teenage sensation Vaibhav Suryavanshi continued his rich vein of form by smashing a record nine sixes as India defeated England by four wickets in the rain-truncated third U19 Youth ODI to take a 2-1 lead in the fivematch series here.

The 14-year-old Suryavanshi, who had come close to striking half-centuries in the previous two games before getting dismissed in his 40s, finally made his innings count as he clobbered the home team bowling on way to 86 off just 31 deliveries as India chased England's 268/6 in 34.3 overs on Wednesday.

Suryavanshi's knock was studded with six boundaries and nine maximums.

In fact, nine sixes by Suryavanshi is the highest number of maximums hit by an Indian batter in an U-19 ODI eclipsing the previous record of eight sixes by Mandeep

India suffered a slump in the middle overs with the team reduced to 199 for 6 in the 24th over.

But bowling all-rounder Kanishk Chouhan (3/30), who had taken three England wickets earlier, hit an unbeaten 43 (42 balls) and shared an unbroken 75-run stand with RS Ambrish (31 not out) to guide the team to victory.

Suryavanshi ravaged every single bowler that bowled to him and made his intentions clear when he smacked right-arm pacer Se-



bastian Morgan for two consecutive sixes in the third over.

Morgan came in for some harsh punishment again in his subsequent over when he was hit for two more sixes and a boundary by the 14-year-old batting sensation, who has been on a roll since showing his precocious talent in the IPL for Rajasthan Roy-

England left-arm pacer James Minto bore the brunt of Suryavanshi's fury in the sixth over, going for 23 runs, which included three sixes and a boundary.

Dawkins, a right-handed batter, following two successive below-par scores, gave England the start they needed after they were put in to bat by the visitors on an overcast

Dawkins and his left-handed opening partner Isaac Mohammed (41 off 43 balls) displayed immense calm playing the moving ball as they stitched together a 78-run partnership at the top to give the hosts the start they needed.

Isaac's dismissal did not slow the flow of runs as the next batter in Ben Mayes played an almost run-a-ball innings scoring 31 (32) to guide England to 133/2 by the 22nd over.

The 55-run partnership for the second wicket between Dawkins and Mayes really gave the home team the momentum, which was later capitalised by skipper Rew as he launched into the Indian bowling attack by playing some cracking shots that left the visitors searching for ideas.

Pakistan gets government nod to be in India for hockey's Asia Cup and Junior World Cup



NEW DELHI, July 3:Pakistan's hockey teams will not be stopped from competing in next month's Asia Cup and the subsequent junior World Cup in India as any move to block the arch-foes from multi-lateral competitions in the country would be a violation of the Olympic Charter, a sports ministry source said on Thursday.

While the Asia Cup is scheduled to be held in Rajgir, Bihar from August 27 to September 7, the junior World Cup will be organised in Chennai and Madurai from November 28 to December 10.

"We are not against any team competing in India in a multi-national competition. If we try to stop Pakistan it would be seen as a violation of the Olympic Charter. Likewise, we will also show up for any multi-national event that features Pakistan. But bilateral is different and there will be no relaxation on that front," the source said.

The ministry's decision also clears the decks for Pakistani participation in the junior World Cup of shooting, scheduled here in September, and the World Para-Athletics Championships, also in the national capital in September-October

The Charter is akin to the constitution of the Olympic movement and stresses on sport as a tool for promoting international peace and cooperation.

As a result, any attempt to block a rival country from a multi-national event adversely impacts the host country's prospects of getting future hosting rights.

When asked whether this means India will be allowed to play against Pakistan in the Asia Cup of

cricket in September, the source said, "The BCCI is yet to reach out to the ministry on this. We will address this query when they approach us.

Speculation is rife that India and Pakistan will play each other in a round robin match during the continental tournament, which is set to be held in the UAE or Sri Lanka even though the original host is

India and Pakistan have been avoiding bilateral sporting engagements after the 2008 Mumbai terror attacks but even multi-lateral face-offs were in doubt after the Pahalgam terror attack in which 26 tourists were gunned down in April.

In May, India retaliated with Operation Sindoor, targeting terrorist infrastructure in Pakistan, leading to a tense military showdown that de-escalated on Pakistan's request for a ceasefire.

"International sports demands that we cannot back out from competing in multi-national competitions. Take for instance, Russia and Ukraine, they are at war but they show up at multinational events and compete as well. That's the norm and we are respecting these norms," the source said.

"We have informed Hockey India about this decision," he added.

Hockey India (HI) welcomed the ministry's call.

"We welcome government's decision. Our stance from the beginning was that whatever the government decides, we will abide by that. There is no other argument in that," HI secretary general Bhola Nath Singh said. (PTI)

cumbent Afghanistan coach heaped

praise on the Indian skipper, who held the innings together on a tricky opening day wherein England threatened to cause more damage than they did. "What also stood out was his body language and the way he scored his runs. His control against the English

bowlers sent a message to the dressing

room that he was taking charge (and) leading from the front," Trott said in "His intent was clear: "I'll be there, I'll be not out, and I'll resume tomorrow. I'll make sure we get into a winning position'. (It was) very impressive from such a young man — a world-

class player with a bright future." "Having the confidence to execute a plan that's not necessarily textbook, but gives you an edge over the opposition, is remarkable. As captain, that has a significant impact not just out in the middle, but also for those watching from

Trott pointed out the difference in Gill's approach while facing England

While Gill crossed the triple-figure mark, opener Yashasvi Jaiswal missed his second hundred when he fell for 87 but his performances in England so far have impressed the former batter.

"There was a bit of a contrast some play and misses, but also some exquisite cricket shots. We've spoken about how he tends to chase the ball outside off at times, but when he plays straight, he times the ball so well.

"He doesn't need to over-hit. We've seen him dismantle bowling attacks before, and he's shown he can hit sixes almost at will. But across these three innings in England, he seems to be in much better control."

Trott added, "He has developed a game plan; he knows where and when to score. England will try to challenge that with tricky field placements, testing his patience and ego. But overall, (he is) very impressive. He is a fantastic player for India." (PTI)
