95 pc people leave Paikan forest ahead of eviction drive: Govt



GOALPARA, July 11: A day before a scheduled eviction drive to clear encroachment on 1,040 bighas of land in the Paikan Reserve Forest in Assam's Goalpara district, about 95 per cent of alleged illegal settlers have already moved out from there, an official said on Friday.

The district administration is

geared up to lend its support to the forest department for a smooth anti-encroachment operation, he said. The eviction drive, which was scheduled to be carried out on Friday, was postponed by a day, keeping in mind the Friday prayer in the Muslim-majority area, Chief Minister Himanta Biswa Sarma had said.

"The district administration will look after ensuring the law and order situation, and we have completed preparations for it," Goalpara district commissioner (DC) Khanindra Choudhury told PTI.

He also said, "Around 90-95 per cent of the illegal settlers have already moved out from the site, dismantling their establishments and carrying away their belongings."

Only the brick structures or structures which cannot be moved are still there, he said.

"Security and other arrangements from our end have been completed to ensure smooth operation," the DC added.

Goalpara Divisional Forest Officer (DFO) Tejas Mariswamy had said earlier that the eviction drive would clear encroachment on around 1,040 bighas of land in the Paikan Reserve Forest of Krishnai Forest Range. "There are 1,080 families (CONTD. ON PAGE-2)

Governor wraps up two-day Karbi Anglong visit Acharya satisfied with KA's law and order scene

GUWAHATI, July 11: Governor Laxman Prasad Acharya concluded his two-day visit to Karbi Anglong on Friday, expressing satisfaction over the pace of development in the region and underlining the economic potential of local sectors such as dairy and coffee.

According to an official statement, the Governor interacted with beneficiaries of welfare schemes, inspected infrastructure projects, and held reviews with officials during the tour, which he described as a testimony to the progress made possible by peace and coordination in the council areas.

During his visit to a milk processing plant in Manja, the Governor emphasised the need for coordinated efforts between the farming community and government agencies to harness the dairy sector's potential as a pillar of the local economy.



He said the Manja plant could significantly enhance household incomes and help achieve economic self-reliance for rural and semi-urban populations in the district.

Highlighting the importance of public service delivery, the Governor also visited a Jal Jeevan Mis-

sion project site at Longnit.

He reviewed the grievance redressal mechanisms in place, including the maintenance of beneficiary registers, and interacted with locals to check their access to central welfare schemes such as the Pradhan Mantri Awas Yojana (PMAY) and PM-Kisan.

The Governor reiterated the importance of ensuring efficient and transparent delivery of all government schemes at the grassroots.

In the health sector, Acharya visited the Mohongdijua Subsidiary Health Centre, where he held interactions with doctors, nurses, and ASHA workers to understand the nature and reach of health services being provided, particularly to women, children and the elderly.

He stressed the need for every eligible citizen to be issued an Ayushman Bharat health card and took stock of staffing levels, medicine availability, and infrastructural bottlenecks at the facility.

The Governor also met with PMAY beneficiaries to assess the ground-level impact of the housing scheme and later visited the Regional Coffee Research Centre at 5th Mile. In his discussions with officials there, he encouraged a focus on (CONTD. ON PAGE-2)

India test fires Astra beyond visual missile

NEW DELHI, July 11: India on Friday successfully test fired Astra beyond visual air-to-air missile from Su-30 Mk-1 aircraft off the coast of Odisha, demonstrating its indigenous defence capabilities.

The missile has a range exceeding 100 km and is equipped with state-of-the-art guidance and navigation system, officials said.

"The Defence Research and Development Organisation (DRDO) and the Indian Air Force (IAF) successfully conducted the flight-test of indigenous beyond visual range air-to-air missile 'Astra' equipped with indigenous radio frequency seeker from Su-30 Mk-1 platform," the defence ministry said.

During the tests, two launches were carried out against high-speed unmanned aerial targets at different ranges, target aspects and launch platform conditions, it said. "In both the cases, the missiles destroyed the targets with pinpoint accuracy," the ministry said in a statement.

It said all subsystems performed

as per expectations including the radio frequency seeker which has been indigenously designed and developed by the DRDO.

"The flawless performance of the Astra weapon system was validated through flight data captured by range tracking instruments deployed by Integrated Test Range, Chandipur," it added.

These successful flight tests have re-established the accuracy and reliable performance of Astra weapon system with indigenous seeker, the ministry said. In addition to various laboratories of DRDO, more than 50 public and private industries including Hindustan Aeronautics Limited have contributed towards development of the weapon system.

Defence Minister Rajnath Singh complimented the DRDO, the IAF and industry partners involved in the design and development of the radio frequency seeker.

The successful testing of the missile with indigenous seeker is a major milestone in critical defence technology, he said. (PTI)

FM Sitharaman praises Meghalaya's progress, full utilisation of ₹ 5,400 crore SAsCI funds

SHILLONG, July 11: Union Finance Minister Nirmala Sitharaman on Friday praised Meghalaya's progress under Chief Minister Conrad K. Sangma, calling the state a model of effective and purposeful development.

She highlighted the state's exemplary utilisation of its entire allocation of ₹ 5,400 crore under the Special Assistance to States for Capital Investment (SAsCI), setting an example for other states to follow.

Speaking at a programme, Sitharaman said, "While some states are unable to fully utilise their shares, Meghalaya has effectively used its entire allocation to build capital assets. I will put on record my appreciation of Meghalaya's efforts."

She reaffirmed the Centre's commitment to the Northeastern region, adding, "The government looks at the region as one to empower, act, strengthen and transform."

The FM also pointed out key development achievements in the

state, including the construction of over 540 km of roads and a five-fold increase in optical fibre coverage since 2014.

She praised the state's performance in centrally sponsored schemes such as the Jal Jeevan Mission, PM Awas Yojana, PM Jeevan Jyoti Bima Yojana, and the Swachh Bharat Mission.

CM Sangma, while addressing the gathering, said the state government follows a model of purpose-based, target-based, and result-based governance.

He reaffirmed the government's ambition of making Meghalaya one of the top 10 states in India by 2032 and informed her that the state was now on the verge of becoming a \$6-billion economy, with a growth rate nearing 15 per cent, significantly higher than the national average.

The CM also highlighted how the state leveraged a large number of schemes and projects through Externally Aided Projects (EAPs), which have served as a key source of funding for smaller states.

The total funding through EAPs is nearing ₹ 12,000 crore, supporting a wide range of development initiatives across Meghalaya, he said.

A series of important projects were launched during Sitharaman's visit.

Among them was the initiative to establish digital libraries in remote areas of the state, with a total budget of ₹ 162 crore under SAsCI.

Implemented by the State Rural Employment Society, the project aims to set up 750 digital libraries across rural areas, connecting youth to the National Digital Library and fostering a reading culture.

The redevelopment of Uman Lake was another key project inaugurated with a funding of Rs 120.81 crore under SAsCI.

The initiative aims to transform the waterbody into a world-class eco-tourism hub, expected to attract over 1.27 lakh tourists annually and create nearly 4,000 jobs.

Himanta discusses issues raised by Karbi conglomerate

GUWAHATI, July 11: The Assam government will press for a tripartite meeting involving the Centre and a conglomerate of 21 organisations of Karbi Anglong for resolving their demands, Chief Minister Himanta Biswa Sarma said on Friday.

Sarma met with representatives of the Forum for Hills Autonomous State Movement (FHASM) Alliance here to discuss the issues raised by it.

The alliance, involving political as well as apolitical organisations, has been pressing for a "state within state" for Karbi Anglong district, among other demands.

"Our tribal sisters and brothers are an intrinsic part of Assam's social fabric. We are committed to empower them and protect their unique heritage," Sarma said in a post on X after the meeting.

The Chief Minister's Office (CMO), in another post, said Sarma discussed the ongoing concerns and aspirations of the forum during the meeting.



"The meeting focused on mutual respect, safeguarding unique identity, inclusive development and adherence to constitutional processes to address the forum's aspirations," it said.

The chief minister stated that "he would impress upon for a tripartite meeting involving the Central Government, State Government and FHASM to find an amicable resolution to their demands," the CMO said.

Sarma also reviewed the implementation of the 2021 Karbi Accord provisions, and reiterated the importance of peaceful engagement and tangible solutions in the interest of the people, it added. (PTI)

Assam and Bihar face severe inundation: CWC

NEW DELHI, July 11: Twenty river sites across India remain under flood risk, with one location in Assam and two in Bihar experiencing severe flood conditions, the Central Water Commission (CWC) said in its daily flood bulletin issued Friday.

The sites under severe flood conditions are located along the Brahmaputra and its tributaries in Assam's Golaghat, and Ganga's tributaries of Bagmati and Gandak in Muzaffarpur and Gopalganj respectively.

Water levels at these sites have crossed the danger mark, the bulletin noted.

Overall, the CWC has flagged flood concerns in 20 locations, primarily in Assam, Bihar, Odisha, Uttar Pradesh, and West Bengal.

Tourists, commuters advised to avoid travel to Dawki via Pynursla due to landslide risks

SHILLONG, July 11: Tourists and commuters have been advised to avoid travelling to Dawki via Pynursla due to the high risk of landslides along the Shillong-Dawki road in Meghalaya, which is currently under construction, officials said on Friday.

Dawki, located along the India-Bangladesh border, is one of Meghalaya's most popular tourist destinations, known for the crystal-clear waters of the Umngot River.

Thousands of tourists visit the area annually for boat rides, kayaking, cliff jumping, and to witness the picturesque views of the river and surrounding hills.

The Additional Deputy Commissioner of East Khasi Hills district in charge of Pynursla Civil Sub-Division said that the road stretch be-



tween Laitlyngkot and Lyngkyrdem and the overall Shillong-Dawki route remains highly vulnerable to landslides owing to incessant rainfall.

Authorities have urged the public to refrain from unnecessary travel

along the route in the coming days as a precautionary measure.

The Shillong-Dawki road project, spanning around 85 km, is being implemented by the National Highways and Infrastructure Development (CONTD. ON PAGE-2)

India presents candidature for Int'l Maritime Organisation Council

LONDON, July 11: India has presented its candidature for re-election to the International Maritime Organisation (IMO) Council at the organisation's 134th session in London, where the Ministry of Ports, Shipping and Waterways highlighted key aspects of maritime safety and gender inclusivity.

At a special India-themed reception at the IMO Headquarters on Thursday evening, Ministry Secretary T K Ramachandran and Indian High Commissioner to the UK Vikram Doraiswami announced the decision to seek re-election in Category B of the Council.

The election for the 2025-26 biennium will take place at the organisation's Assembly later this year and follows India's re-election with the highest tally back in De-

cember 2023.

"India embraces the philosophy of One Earth, One Family, One Future, and we bring this vision to life through fostering robust and collaborative maritime efforts," said Ramachandran in his address at the reception.

"Under our Vision 2047, we see maritime growth as a corner of global progress, and we deeply value a growing engagement with the IMO and its member states... we have several pillars, including shipbuilding, ship recycling, ship financing, ship ownership and ship flagging, the entire ecosystem," he said.

The senior official highlighted the ministry's plans to invest USD 1 trillion in the sector over the next 25 years as he invited representa-

tives from around the world to "partner with India in this quest for us to become one of the leading maritime nations in the world, and I trust that we will continue to receive your support as we seek re-election to the IMO Council".

India's candidature falls under the Category of 10 states with "the largest interest in international seaborne trade", alongside Australia, Brazil, Canada, France, Germany, the Netherlands, Spain, Sweden and the United Arab Emirates (UAE).

"I do want to emphasise how much we value the partnerships that we have forged with many delegations here, across the years, and our effort to see the IMO as a central pillar of the international order in the (CONTD. ON PAGE-2)

'Need to stop oscillating between fears of overpopulation and population collapse'

India's population at crossroads, not a crisis: Population Foundation of India

NEW DELHI, July 11: An NGO, Population Foundation of India, has urged a shift away from fear-driven debates on overpopulation or fertility decline, calling instead for policies that centre on dignity, rights, and opportunities, particularly for women, youth, and the elderly.

The NGO, in a statement on World Population Day 2025 on Friday, asserted that India's population challenges are not about numbers but about justice, equity, and investment in human potential.

"India's population story is not a crisis, it's a crossroads," Poonam Muttreja, Executive Director of the Population Foundation of India, said during a function marking the occasion.

World Population Day is being observed under the global theme: 'empowering young people to create the



families they want in a fair and hopeful world".

The NGO asserted that India's pop-

ulation challenges are not about numbers but about justice, equity, and investment in human potential.

"We must stop oscillating between fears of 'overpopulation' and 'population collapse,' and instead focus on what really matters, gender equality, reproductive autonomy, and inclusive public investment," she added.

The foundation's statement focused on three key areas for policymakers.

The first is realising the gender dividend; family planning must move beyond female sterilisation to a range of contraceptives, with both men and women sharing responsibility.

"We need men to be part of the solution as active participants, not merely as supporters. It's men's onus to ensure women's safety at home as well as at the workplace," Muttreja said.

"Family planning has long been seen as a woman's responsibility, but reproductive health is a shared responsibility," she added. (CONTD. ON PAGE-2)

Byrnihat most polluted city in India in first half of 2025: Analysis

NEW DELHI, July 11: Byrnihat, located on the Assam-Meghalaya border, ranked as the most polluted city in India in the first half of 2025 while Delhi stood a distant second, according to a new analysis.

According to the analysis by independent research organisation Centre for Research on Energy and Clean Air (CREA), Byrnihat recorded an average PM2.5 concentration of 133 micrograms per cubic metre, while Delhi's PM2.5 levels reached twice the national ambient air quality standard at 87 micrograms per cubic metre.

Hajipur (Bihar), Ghaziabad, Gurugram, Sasaram (Bihar), Patna, Talcher (Odisha), Rourkela (Odisha) and Rajgir (Bihar) were the other cities in the top 10 most polluted list.

Aizawl in Mizoram was the cleanest city in the country in the first half of the year.

From January to June, CREA said, particulate matter data was available for over 80 per cent of the days in 239 out of 293 cities with continuous ambient air quality monitoring stations (CAAQMS).

Among the 239 cities, 122 exceeded the annual National Ambient Air Quality Standard (NAAQS) of 40 micrograms per cubic metre, while 117 cities remained below the annual

limit.

CREA said that while the introduction of vehicle restrictions, such as the end-of-life ban in Delhi, is an important component of air quality management, focusing solely on vehicular emissions risks overlooking other critical year-round sources of pollution.

According to source apportionment studies from the Portal for Regulation of Air Pollution in Non-Attainment Cities (PRANA) and IIT Delhi, in addition to transport (17 per cent-28 per cent) and dust (17 per cent-38 per cent), several other sectors contribute significantly to PM levels, including residential combustion (8 per cent-10 per cent), agricultural burning (4 per cent-7 per cent) and industrial activities and power plants (22 per cent-30 per cent).

These studies consistently show that Delhi-NCR's air quality crisis is not solely due to vehicles or seasonal biomass burning, but is also driven by continuous emissions from multiple sources across sectors.

For example, despite clear Supreme Court directives, critical pollution control technologies such as flue gas desulfurisation (FGD) systems are still absent in most thermal power plants near Delhi, CREA's (CONTD. ON PAGE-2)

UK joins capital boost in Eutelsat, total investment rises to €1.5 billion

GUWAHATI, July 11: The United Kingdom has announced its decision to participate in the planned capital increase of global satellite communications provider Eutelsat, joining other key investors including France and Bharti Space Limited.

The move pushes the total expected investment to €1.5 billion. The development was confirmed in an official statement issued by Eutelsat on Friday, which said that His Majesty's Government, through the UK Secretary of State for Science, Innovation and Technology, has committed €163.3 million to the total.

This includes participation in both the Reserved Capital Increase and the subsequent Rights Issue, in proportion to its post-transaction shareholding.

The French State, represented

via Agence des Participations de l'État (APE), remains the lead investor, subscribing €551 million to the Reserved Capital Increase.

Bharti Space Limited has committed €30 million, His Majesty's Government €90 million, CMA CGM €100 million, and FSP €57 million.

The total amount for this tranche stands at €828 million, while the planned Rights Issue will raise an additional €672 million.

All commitments are subject to shareholder approval at an extraordinary general meeting expected around the end of Q3 2025, along with regulatory clearances and the finalisation of a revised non-concurring shareholders' agreement reflecting the post-investment ownership structure.

Eutelsat said that following completion of the two transactions—expected by the end of 2025—the

French State would hold 29.65% of the share capital and voting rights. Bharti Space Limited, the UK Government, CMA CGM and FSP would respectively hold 17.88%, 10.89%, 7.46% and 4.99%.

The investors involved in the capital increase would not be in a position to launch a public takeover, the statement clarified.

UK Science, Innovation and Technology Secretary Peter Kyle said the investment affirms the country's commitment to securing critical satellite infrastructure.

"As our adversaries increasingly use space technologies to harm us, resilient satellite connectivity has become essential to our continent's national security," he said.

Bharti Group founder Sunil Bharti Mittal welcomed the UK's participation and said Eutelsat was positioned to meet growing sover-

eign and commercial connectivity needs.

"This new capital injection will allow Eutelsat to go further and faster in developing innovative technologies and services," he said.

Eutelsat CEO Jean-Francois Fal-lacher thanked the UK Government for its continued support and called space a strategic asset.

"We remain committed to the UK, which we consider one of our home markets, and to supporting the development of OneWeb to address the needs of all our sovereign and commercial stakeholders," he said.

French President Emmanuel Macron had earlier called for countries such as India, Canada and Brazil to partner with France in investing in Eutelsat, describing the initiative as a collective strategic effort to support global space capabilities.

Visitor registration opens for SEMICON India 2025 in New Delhi

GUWAHATI, July 11: SEMI and the India Semiconductor Mission (ISM) have officially opened visitor registrations for SEMICON India 2025, scheduled to be held from September 2 to 4 at Yashobhoomi, the India International Convention and Expo Centre in New Delhi.

According to an official statement, the event is being organised in collaboration with industry partners under the theme "Building the Next Semiconductor Powerhouse" and will highlight India's expanding role in the global microelectronics and semiconductor landscape.

Held under the aegis of the India Semiconductor Mission of the Ministry of Electronics and Information Technology (MeitY), SEMICON India 2025 builds on the success of last year's edition and aims to provide a high-impact platform that brings together key stakeholders from the policy, industry, academic, and investor communities.

SEMICON India is one of eight global SEMICON events hosted annually by SEMI, each designed to convene leaders and innovators from across the semiconductor design and manufacturing ecosystem.

The 2025 edition is expected to see participation from over 300 exhibiting companies representing 18 countries and regions.

It will feature a three-day conference with global CXOs and industry experts, as well as international and state government pavilions.

Special focus areas will include a workforce development pavilion, startup pavilion, international roundtables, B2B forums, and training and upskilling programmes aimed at supporting India's growing talent pool in semiconductor manufacturing and design.

SEMI President and CEO Ajit Manocha said the event underscores India's strategic importance in the global chip industry at a time when supply chain resilience and engineering talent are of paramount importance.

who have encroached on forest land, and we had asked them to vacate the area in November-December last year. We again served them notices last month to leave the area by July 10," he added. Since 2023, the administration has cleared encroachments on 650 hectares of land across four forest ranges.

"Of this area, human habitation was in 200 hectares and farming was done in the remaining 450 hectares," Mariswamy had said. Notably, encroachments on about 3,500 bighas of land (around 1,160 acres), affecting around 1,100 families, in Charuwa Bakra, Chirakuta and Santoshpur villages under the Chapar circle in neighbouring Dhubri district were cleared during a drive on Tuesday.

The anti-encroachment exercise was undertaken to hand over land to Adani group to set up a power plant.

Alleged encroachers had damaged excavators and tried to attack police personnel during the eviction drive, prompting security forces to resort to a baton charge to disperse the mob. Last month, Sarma had visited the site for the proposed power plant, and announced that a 3,400 MW thermal power plant would be established there. Sarma, at a press conference in Guwahati on Thursday, had asserted that eviction drives would continue in the state with over 25,000 acres of land having been cleared of encroachment in the last four years.

The CM said that he would hold another press meeting next week and furnish all data related to eviction drives since he became the CM in May 2021.

"We will have another eviction drive on Saturday in Goalpara. The Gauhati High Court has asked us to clear forest land. It only said that we should provide drinking water and other essential items to the evicted people," he added. The Congress, however, has criticised the eviction drives and promised that all Indian citizens, who have been evicted from land during the BJP rule, will be compensated if the opposition party comes to power in the state. (PTI)

the development of MICE (Meetings, Incentives, Conferences, and Exhibitions) and tourism infrastructure at Mawkhanu, with a total investment of Rs 103 crore. Spread across 106 acres, the project includes a Meghalayan Experience Theme Park, an open-air amphitheatre, and festival zones designed to boost tourism beyond Shillong. A major highlight of the announcements was the proposed ₹ 732-crore Mawkhanu Football Stadium, a state-of-the-art complex with a residential football academy developed in partnership with NorthEast United FC. The project reinforces Meghalaya's reputation as the football capital of India.

The FM also launched a project to construct working women's hostels with a total investment of Rs 132 crore under SASCI. These hostels will provide safe and affordable accommodation, with 400 beds in Shillong and 200 beds each in Jowai, Byrnihat, and Tura.

In addition, the Union minister inaugurated the office-cum-residential complex for the Central Board of Indirect Taxes and Customs (CBIC) at New Shillong, with a budget of Rs 256.23 crore, to strengthen administrative operations in the state. Another significant project was the launch of the Northeast Regional Campus of the Indian Institute of Corporate Affairs (IICA) at Mawkhanu.

The ₹ 100.95 crore campus, funded under the Prime Minister's Development Initiative for North East Region (PM-DevINE), will serve as a premier centre for corporate governance, economic research, and capacity-building. This marks the first time that the IICA is establishing a presence outside Delhi.

A cheque distribution ceremony was also held, where beneficiaries of schemes such as PM MUDRA, PM SVANidhi, PMEGP, and NPS Vatsalya received financial support.

In a significant boost to Meghalaya's organic farming sector, Sitharaman also flagged off a two-metric-tonne consignment of premium organic pineapples to LULU Retail in Dubai. This consignment, under the IFAD-supported Megha-LAMP initiative, was sourced from farmers of the Jirang Organics Farmer Producer Company in Ri-Bhoi. The IMO is the premier body that oversees the maritime sector, which in turn underpins international trade, transport and all maritime activities. The Council is the executive organ of IMO and is responsible, under the Assembly, for supervising the work of the organisation. The Assembly normally meets once every two years in a regular session. It is responsible for approving the work programme, voting the budget and determining the financial arrangements of the organisation. It also elects the organisation's 40-Member Council at these meetings for the next two-year period. The delegation led by Ramachandran reaffirmed India's continued support to IMO's efforts towards maritime safety, environmental protection, and inclusive development of the global maritime community during the IMO Council session in London.

Earlier in the week, the team jointly hosted an 'India Maritime Investment Meet' with the High Commission of India in London to showcase the country as a fast-growing maritime economy and invite representatives from the UK's shipping industries to India Maritime Week 2025 in Mumbai, scheduled for October. (PTI)

The second is harnessing the demographic dividend, with over 250 million young people. India has a unique opportunity to drive inclusive growth by investing in education, skill development, reproductive health, and mental well-being, especially for adolescent girls. The third is to prepare for the silver dividend, noting that by 2050, nearly one in five Indians will be over 60, the foundation called for immediate investments in elder care, pensions, healthcare, and age-friendly infrastructure and see older adults as vital contributors and not as dependents. India, now the world's most populous country, reflects the full range of demographic experiences, from high fertility and unmet reproductive needs in states like Bihar and Uttar Pradesh to ageing populations and below-replacement fertility in Kerala and Tamil Nadu, the statement added.

While India's Total Fertility Rate (TFR) stands at 2.0, more than 24 million married women still lack access to contraceptives and early marriages and unsafe abortions further restrict reproductive choices.

The foundation urged policymakers to abandon fear-based narratives and called for strengthened care systems and a rights-based approach to the population. "If we centre people, especially women, youngsters, and the elderly in our policies, population trends will not be a crisis, but a path to a more just and resilient future," the statement concluded. (PTI)

Markets extend losses for 3rd session; Sensex tanks 690 points on selling in IT, auto stocks



MUMBAI, July 11: Equity benchmark indices Sensex and Nifty declined for the third session in a row on Friday, dropping nearly 1 per cent, dragged by heavy selling in IT, auto and energy stocks amid a muted start of the earnings season.

Tariff-related uncertainties and mixed global market trends also added to the pressure, analysts said.

The 30-share BSE Sensex tanked 689.81 points or 0.83 per cent to settle at 82,500.47. During the day, it fell 748.03 points or 0.89 per cent to 82,442.25.

As many as 2,450 stocks declined while 1,557 advanced and 158 remained unchanged on the BSE.

Similarly, the 50-share NSE Nifty dropped 205.40 points or 0.81 per cent to 25,149.85.

On the weekly front, the BSE benchmark dropped 932.42 points or 1.11 per cent, and the Nifty tanked 311.15 points or 1.22 per cent.

"While weak European market cues and negative US Dow Futures weighed on sentiment, the disappointing start to earnings season by software major TCS cautioned investors about the sluggish global demand scenario that led to heavy selling in IT, telecom, auto, realty and oil & gas stocks," Prashanth Tapse, Senior VP (Research), Mehta Equities Ltd, said.

From the Sensex firms, Tata Consultancy Services declined 3.46 per cent after reporting its June quarter earnings.

The country's largest IT services company on Thursday reported a 6 per cent growth in June quarter net profit at ₹ 12,760 crore, helped by a jump in non-core income even as revenues grew at a tepid pace.

The rupee revenue grew 1.3 per cent to ₹ 63,437 crore during the quarter. Still, it was down by over 3 per cent on a constant currency basis, as the company faced headwinds in its major markets amid a winding down of the BSNL deal, which helped it in recent quarters.

Mahindra & Mahindra, Bharti Airtel, Tata Motors, Titan, HCL Tech, Bajaj Finance, Reliance Industries, Trent, Infosys and HDFC Bank were among the other major laggards

from the pack.

"Markets traded under pressure on Friday and lost over half a per cent, dragged down by weak cues. The session began on a negative note following disappointing results from IT major TCS, which further worsened due to profit-taking in heavyweight stocks across other sectors. Sentiment remained subdued due to ongoing uncertainty around tariff-related issues and a weak start to the earnings season," Ajit Mishra - SVP, Research, Religare Broking Ltd, said.

Meanwhile, shares of Hindustan Unilever Ltd (HUL) surged 4.61 per cent following the announcement that Priya Nair will become the first woman CEO and MD of the firm, effective August 1, 2025.

Axis Bank, NTPC, Eternal and State Bank of India were also among the gainers.

"The domestic market experienced a negative close due to a sober start to Q1 earnings season and a ramp-up in the tariff threat by the US to impose a 35 per cent tariff on Canada. Investors may continue to be focused on quarterly earnings for a buy-on-dips strategy. However, in the near term, the current premium valuation and the global headwinds like low spending and tariff uncertainties may restrain new inflows.

"The IT index underperformed due to deferment in orders and new investments, which may impact FY26 earnings estimates," Vinod Nair, Head of Research, Geojit Investments Limited, said.

The BSE smallcap gauge declined 0.70 per cent, and the midcap index dropped 0.65 per cent.

On BSE sectoral indicators, tech tumbled 1.85 per cent, BSE Focused IT tanked 1.77 per cent, IT (1.65 per cent), auto (1.72 per cent), oil & gas (1.28 per cent), consumer discretionary (1.23 per cent), and telecommunication (1.22 per cent).

In contrast, healthcare and FMCG were the gainers.

In Asian markets, South Korea's Kospi, Japan's Nikkei 225 index settled lower, while Shanghai's SSE Composite index and Hong Kong's Hang Seng ended higher.

European markets were trading lower in mid-session trade.

The US markets ended in positive territory on Thursday.

Global oil benchmark Brent crude climbed 0.31 per cent to USD 68.85 a barrel.

Foreign Institutional Investors (FIIs) bought equities worth ₹ 221.06 crore on Thursday, according to exchange data.

On Thursday, the Sensex dropped 345.80 points or 0.41 per cent to settle at 83,190.28. On similar lines, the Nifty declined 120.85 points or 0.47 per cent to 25,355.25. (PTI)

He highlighted that defeating TB is essential for India to achieve its Sustainable Development Goal (SDG) targets, particularly the aim of ending TB by 2025.

Key resource persons at the programme included Dr Mridul Bharati Nath, District TB Officer, Kamrup Metro, and K Maipak

Singha, State Programme Officer for PMTBMB-A-Nikshay Mitra, State TB Cell, Assam.

They delivered talks on the objectives of the Pradhan Mantri TB Mukti Bharat Abhiyan and focused on the importance of community participation in the national movement.

The speakers also discussed the Nikshay Poshan Abhiyan, which provides nutritional support to TB patients, and urged attendees to enrol as Nikshay Mitras—volunteers who adopt TB patients and support their recovery.

The awareness campaign was attended by around 150 participants, including members of the GU academic fraternity, NSS volunteers, and students from affiliated colleges.

Ceremonial Mega Oil Palm Plantation Drive held at Rongjangmi in WKA

DONGKAMUKAM, July 11: A Ceremonial Mega Oil Palm Plantation Drive cum awareness and distribution programme was held on Friday at Rongjangmi, a remote village near Kuthepi in West Karbi Anglong district.

The event was organised by the Department of Agriculture, Hamren, in collaboration with Godrej Agrovet Ltd, Silchar, with the aim of promoting oil palm cultivation among local farmers.

According to officials, the programme drew active participation from farmers and was attended by key officials including District Agriculture Officer (DAO) Gunjon Dutta, State Nodal Head of Godrej Agrovet Ltd Anand Pandey, District Nodal Officer Mirjeng Terang, Agricultural Development Officer (ADO) of Dongkamukam Circle Olivina Katharpi, and District Incharge of West Karbi Anglong and Sribhumi (Karingangi) Shyam Shekhar Singha.

Addressing the gathering, DAO Gunjon Dutta informed the farmers that oil palm cultivation could yield substantial returns, with an estimated income ranging between ₹40,000 to ₹70,000 per bigha starting from the fourth year of plantation.

He added that while oil palm cultivation had already begun in Karbi Anglong through initiatives sponsored by Patanjali, in West Karbi Anglong, 50 saplings have been provided by Godrej Agrovet Ltd as part of a pilot project to be implemented over 500 hectares this year.

Although government agencies are in-



directly involved, the initiative is being executed in close coordination with private sector stakeholders.

Dutta further stated that Goalpara district was the first in Assam to implement oil palm cultivation successfully, while Karbi Anglong and West Karbi Anglong experienced a delay of nearly three years due to unavoidable circumstances.

He assured that a farmers' delegation would be taken to Mizoram to gain practical exposure to the cultivation practices already being followed there.

As part of the initiative, interested farmers were assured of various financial

supports, including ₹3,000 per hectare for land clearing, ₹6,250 per hectare for intercropping, ₹4,000 per hectare for bio-fencing, ₹15,000 per unit for vermicomposting, and ₹10,000 for cattle farming. Encouraging youth participation, Dutta urged local farmers not to seek employment outside the state in places like Kerala, Tamil Nadu, Andhra Pradesh, or Maharashtra.

He expressed confidence that, if successful, oil palm cultivation could lead to the establishment of a processing industry in the district, creating local employment and economic development opportunities.

Farmer drowns

NAGAON, July 11: A 50-year-old farmer, identified as Balbir Singh, died in a drowning incident at Borkola village in Nagaon district on Friday, triggering a wave of grief in the local community.

According to sources, Singh had gone to the Shingimari Jan, a water body located near the Borkola-Fulguri road, to graze his cattle in the morning.

While at the site, he reportedly slipped and fell into a deep pit formed after excavation by a JCB machine.

He drowned before help could arrive.

Local residents recovered the body later in the evening.

The sudden demise of Singh, who was the sole breadwinner for his family, has left his wife, two sons, and a daughter in deep mourning.

GUJARAT BRIDGE COLLAPSE

Death toll rises to 19 as injured man dies in hospital; search operation on

VADODARA, July 11: The death toll in the Mahisagar river bridge collapse in Gujarat's Vadodara district climbed to 19 on Friday after one of the injured persons succumbed to injuries at a hospital, officials said. The search for the two missing persons is still underway, they said.

Several vehicles plunged into the river after a segment of the four-decade-old bridge, connecting Anand and Vadodara districts, collapsed near Gambhira village close to Padra town on Wednesday morning.

"Forty five-year-old Narendrasinh Parmar, a resident of Dahevan, who was one of the five injured persons undergoing treatment at the SSG Hospital died on Friday," an official said.

Eighteen bodies were recovered till Thursday night, and the operation resumed on the third day with efforts being made by the teams engaged at the site to trace two more persons, who are missing, Vadodara Collector Anil Dhameliya said.

On Thursday, Gujarat Chief Minister Bhupendra Patel suspended four engineers of the state's Roads and Buildings Department in connection with



the bridge collapse.

State minister Rushikesh Patel visited the site of the tragedy and informed the media that action has been taken on the basis of a preliminary report submitted by a committee set up by Chief Minister Bhupendra Patel.

A high-level probe committee of the state's roads and buildings department will submit a detailed report in 30 days, he said.

Out of the 7,000 bridges in the state that have been surveyed, the government has identified those that need repairs or require construction of a new one. Action is taken on them accordingly, he said after

the visit.

"As per the preliminary report of this investigation committee, it has been recorded that the bridge collapsed due to pedestal and articulation crushing. A detailed report will be given by this committee of the Roads and Buildings Department within 30 days," he said.

The investigation report with its technical and administrative reasons will be submitted to the CM and other decisions will be taken on the basis of it, he added. "The state government placed four roads and buildings department officials under suspension," said Patel who also later visited the injured persons at the SSG Hospital and en-

quired about their health.

Collector Dhameliya earlier told the media that the primary objective of the ongoing search and rescue operation was to recover a body trapped under a slab in the river, and trace the missing driver of a truck stuck in the water.

A list of eight missing persons was compiled on Thursday, and the bodies of six of them were recovered, he said.

The operation is being carried out by the National Disaster Response Force (NDRF), State Disaster Response Force (SDRF) and other agencies, with locals joining the efforts.

Dhameliya said the rescue teams continue to work amid challenges, including muddy terrain, release of soda ash in water and a tanker filled with a highly corrosive substance.

A tanker that fell into the river was carrying sulphuric acid, and care is being taken to ensure that it does not leak, he said. There is a presence of soda ash in the water, which is causing irritation and itching for the rescuers, he said.

Earlier in the day, some trucks and two-wheelers were pulled out of water during the operation. (PTI)

Gurugram tennis player murder: Uncle says victim's mother on same floor when shooting happened

GURUGRAM, July 11: Police here on Friday said they were investigating all possible angles in the murder of former tennis player Radhika Yadav, including what her mother was doing when the incident occurred. According to an FIR registered based on the complaint of the deceased's uncle, Kuldeep Yadav, Radhika's mother Manju Yadav was present on the first floor of the house when the shooting took place.

The 25-year-old former player was shot dead by her father at the family's double-storey home in the upscale Sushant Lok area of Gurugram on Thursday. Deepak Yadav (49) later confessed to killing his daughter and was arrested.

Radhika Yadav featured in a music video last year alongside an independent artist. With many claiming that the music video might have triggered tensions at home, police said all angles were being looked into. According to officials, Deepak Yadav confessed that he shot at Radhika because he was often taunted for living off her income. Police, in a statement, claimed that the tennis academy Radhika ran was the bone of contention between the father and the daughter. "Her father was not happy with it," Gurugram police spokesperson Sandeep Singh said,

adding that Deepak has disclosed that his objection was to her daughter running the tennis academy, over which there had been altercations between the two. "On many occasions, he had told her to shut it, but she did not agree. Angered, he shot her thrice," the spokesperson added. The accused felt that he was financially well off and also earned from rental income, so there was no need for his daughter to run an academy, the police claimed. A court here on Friday sent Deepak Yadav to police custody for a day. Outside the court, a police official told reporters that they had sought a two-day remand of the accused. "We have to recover the ammunition of his licensed revolver (used in the crime). We have to verify how much ammunition he had procured," he said.

Asked from where the recovery has to be made, the official said, "The accused owns land in Kasam village near Rewari. We have to get the ammunition from there." The 49-year-old accused, wearing a T-shirt and trousers, had his head covered with a towel as he stepped out of the vehicle near the court complex under police escort for a court appearance.

He faced a volley of questions from a battery of mediapersons, wanting to know why he killed his daughter. However, he

was quickly taken inside the court premises. When he came out of court after the hearing, the towel was off. He faced the same question, and again, he was quickly escorted by the police to the vehicle.

In the FIR, Kuldeep Yadav said Deepak, his wife Manju and daughter Radhika lived on the first floor of the house in Sector 57 while he lived on the ground floor along with his family.

On Thursday, around 10.30 am, he suddenly heard a "loud explosion" and rushed to the first floor, the FIR stated.

"I saw my niece Radhika lying in a pool of blood in the kitchen, and the revolver was found in the drawing room. My son, Piyush Yadav, also rushed to the first floor. Both of us picked up Radhika and rushed her in our car to Asia Maringo Hospital in Sector 56, where doctors declared her dead," the uncle said in his statement.

Earlier, police said the incident occurred around 2 pm when Radhika was on the first floor, cooking food in the kitchen.

Kuldeep Yadav said only Deepak, his wife and daughter were on the first floor of the house when the incident occurred. Their son Dheeraj was not present there at the time of the incident, the deceased's uncle told the police, which was recorded in the FIR. (PTI)

No stay asked for by petitioners, SC order to save Bihar voters from disenfranchisement: Cong

NEW DELHI, July 11: The Congress on Friday said the Supreme Court order on pleas challenging the Election Commission's special intensive revision of electoral rolls in Bihar makes it clear that "no stay was asked for by any of the petitioners", and hoped the ruling will save a vast majority of voters from being disenfranchised.

The Supreme Court on Thursday asked the Election Commission to consider Aadhaar, voter ID and ration cards as valid documents during its ongoing Special Intensive Revision (SIR) of electoral rolls in Bihar, set to go to polls later this year.

Calling SIR a "constitutional mandate", Justices Sudhanshu Dhulia and Joydip Bagchi considered the submissions of senior advocate Rakesh Dwivedi, appearing for the EC, and permitted the poll panel to continue with the exercise in Bihar with over 7 crore voters.

In a post on X, Congress general secretary in-charge communications Jairam Ramesh said, "Following the Honble Supreme Court's order that has just come out officially, the Election Commission

now has to include the EPIC, Aadhar cards, and Ration Cards in the Special Intensive Revision of the electoral rolls in Bihar. This will save a vast majority of voters from being disenfranchised," Ramesh said on X.

"Moreover the EC's spin on the no stay being given has been clearly exposed. Page 7 of the order makes it clear that no stay was asked for by any of the petitioners yesterday. Such deliberately misleading headline management does not baffle a Constitutional authority," he said.

Hitting back at Ramesh, the BJP accused him of misinterpreting the Supreme Court observations.

"Stop misinterpreting the Supreme Court. The Court has not mandated the acceptance of any additional documents—it has merely said it may consider them. Justice Dhulia clearly stated that the Election Commission of India (ECI) is free to record valid reasons for excluding any document. The discretion lies with the ECI," BJP's IT department head Amit Malviya said in his post on X.

"Deliberately misrepresenting court observations is dangerous -- you could be held in contempt for attributing to the Court what it never said. Just ask Rahul Gandhi, who faced the consequences for a similar offence not long ago," he said.

Ramesh also tagged screenshots of the court order with his post.

"Since these cases will come up before the appropriate Court prior to August 1, 2025 which is the scheduled date for notification of Draft Electoral Rolls there is no occasion presently to pass any order on the ad interim stay applications, and the petitioners in any case do not press for a stay at this stage," the order said.

Depending on the reply of the Election Commission the petitioners would always be at liberty to press their plea for stay on the next date of listing, it said.

Terming the right to vote as an important right in a democratic country, the bench said, "We cannot stop a constitutional body from doing what it is supposed to do. Simultaneously, we will not let them do what they are not supposed to do." (PTI)

Nitish disburses first instalment of hiked pension amount to over 1 crore beneficiaries

PATNA, July 11: Bihar Chief Minister Nitish Kumar on Friday disbursed the first instalment of the hiked pension amount of ₹ 1,100 per month to the bank accounts of 1.11 crore beneficiaries, including senior citizens, widows and people with disabilities. Over ₹ 1,227 crore was credited under six different pension schemes during a function here, officials said.

The Bihar government had on June 24 increased the pension amount from ₹ 400 per month to ₹ 1,100.

"The elderly are an important part of society and ensuring a dignified life for them is top priority of our government. It will continue to make efforts in this direction. We will ensure that this amount is disbursed on the 10th of every month," Kumar said on the occasion.

The Bihar government is also committed to the overall development of women in the state, he said. "Our government has been consistently working towards the empowerment and welfare of women. We have set an example in terms

of women's empowerment by prioritising their education, security and employment. Before 2005, the earlier dispensation did nothing for women. It was only after we assumed office that the real change started," the CM asserted. Noting that he had "made mistakes" in the past by joining hands with the opposition in Bihar, Kumar added: "I strayed 'idhar udhar' (here and there) twice. But now, I am with the NDA and will remain with the alliance forever, and work for the development of the state." (PTI)

We hit 9 terror targets in Pak with precision in Operation Sindoor, missed none: NSA Ajit Doval

CHENNAI, July 11: India hit nine terror targets crisscrossing Pakistan with precision and missed none of them during Operation Sindoor, National Security Advisor Ajit Doval said on Friday, taking pride in India's capability and technological prowess in neutralising the threats from across the border.

The precision was to the point where India knew who was where, and the entire operation lasted hardly 23 minutes past 1 am on May 7, he said.

"Thereafter, they said Pakistan did this and so on. Can you tell me of one image or photograph that shows any damage to India," Doval asked while speaking at the 62nd convocation ceremony of IIT, Madras.

India launched Operation Sindoor on terror targets in Pakistan and Pakistan Occupied Kashmir, post the April 22 Pahalgaon terror attack in which 26 persons, mostly tourists, were killed.

Addressing the students, Doval also said the link between technology and warfare was very important, and that the country should develop indigenous technology to meet its requirements.

Referring to the earlier speaker, Padma Subrahmanyam—Padma Vibhushan awardee and legendary danseuse—congratulating him for the success of Operation Sindoor and evoking thunderous



applause from the students and graduates, the NSA said, "I am really proud of it (Operation Sindoor). Much of it was driven by indigenous content."

"We are proud of it—that some of our best systems worked, whether it was BrahMos (missiles), the integrated air control and command system, or battlefield surveillance. We decided on nine terrorist targets, not in the border areas but in the crisscross of Pakistan, and we missed none."

No unintended site was struck, and the strike was precise to the point where "we knew who was where. And the entire operation lasted for 23 minutes," he said.

In a subtle rebuttal to international

media coverage questioning the operation's effectiveness, the NSA said, "They wrote what they wanted. But satellite images tell the real story—that 13 Pakistan airbases, before and after May 10, show exactly what happened."

Earlier, speaking at the convocation, Padma Subrahmanyam said the historic victory of Operation Sindoor was a manifestation of adherence to the valour that the Bhagavad Gita preaches.

"As a proud Indian, I have always offered my salutations to our jawans, who are our national guardian angels," she said, congratulating Doval for his role in the operation.

At the event, Doval said the country could not afford to lose the technology battle and remain behind or fall decades behind others.

He acknowledged the role of IIT, Madras and the private sector in developing 5G in two-and-a-half years' time, whereas the Chinese took over 12 years and spent 300 billion dollars to develop 5G technology.

"Even a screw that deals with anything related to data or security protection must come from a trusted source. It is either made in India or by somebody who is very close to India," he added, emphasising the need to totally insulate our system from the enemy. (PTI)

DADAM, July 11: A three-day programme titled "Inauguration of the Women Technology Park (WTP) Millet Processing Unit and Workshop cum Hands-on Training on Millet Processing and Value Addition" was held successfully from July 9 to 11 at Dadam village in Arunachal Pradesh's Tirap district.

Annual Smoke Offering Ceremony reaffirms sacred traditions in Arunachal's Gelling village

Ceremony at Kepangla Pass blends faith, ecology, and cultural resilience in remote Himalayan village

GELLING, July 11: The serene frontier village of Gelling in Arunachal Pradesh

came alive with spiritual fervour as members of the Memba Buddhist community gathered at the sacred Kepangla Pass for

the annual Smoke Offering Ceremony, known traditionally as Riwo Sangchö. The event, observed on the 15th day of the 5th month of the Tibetan lunar calendar, drew monks, lay practitioners, local officials, and community members in a collective expression of devotion and cultural continuity.

According to an official statement, the ceremony was conducted with solemnity and celebration, reflecting the enduring bond of the Memba people with their ancestral faith and Himalayan homeland. Participants assembled at the revered Kepangla Stupa, where aromatic herbal substances were offered in sacred fires. As smoke spiralled into the mountain air, Buddhist chants filled the valley, imbuing the landscape with a deep spiritual resonance.

The rising smoke was offered to guardian deities, enlightened beings, and all sentient life. It symbolised the purification of the environment, protection of the borderlands, and the invocation of

blessings for universal well-being. The ritual, considered one of the most profound in the Himalayan Buddhist tradition, embodies a spiritual call for the removal of obstacles, negative energies, and karmic afflictions.

The event, steeped in centuries-old custom, has continued to serve as a powerful symbol of cultural resilience for the Memba community, who have preserved their traditions across generations. The annual observance is not only a spiritual practice but also a reaffirmation of identity and harmonious coexistence with nature.

The official statement noted that the ceremony is increasingly drawing wider attention for its potential to inspire models of spiritual ecology among remote Himalayan communities. The presence of scholars, local administrators, and well-wishers at this year's observance underlined a collective commitment to safeguarding and promoting such vital indigenous traditions.

Indian women eye strong finish after sealing maiden T20I series win over England

BIRMINGHAM, July 11: With the series already in bag, a confident India will look to further assert their dominance and end the five-match women's T20I rubber on a high when they face England in the inconsequential fifth and final game here on Saturday.

While the bat and ball did the talking in the initial games, it was India's electric fielding that stood out in the fourth T20I, helping them seal a historic maiden series win over England in the shortest format.

Arundhati Reddy's three sharp catches in the deep and Radha Yadav's brilliance in the field helped India restrict England to 126 for 7, setting up a six-wicket win and a decisive 3-1 lead.

The victory not only marked India's first T20I series triumph over England but also provided a morale-boosting edge ahead of the upcoming three-match ODI series.

A win in the final game would give Harmanpreet Kaur and Co. a commanding 4-1 result and dent England's confidence going forward. The Indian men's team had produced a memorable victory at Edgbaston last week in the second Test, and the women's side will be keen to keep the winning momentum going at the same venue.

India's bowling attack, built around four spinners and two



seamers, has paid rich dividends as the England batters have visibly struggled against spin, losing 22 wickets to spinners so far in the series.

While Radha Yadav emerged as the Player of the Match for her two wickets and fielding exploits, it is young N Shree Charani who emerged as the leading wicket-taker after making her T20I debut at the start of this series.

With the most successful spinner in women's T20Is Deepti Sharma

anchoring the attack, India's spin dominance has been hard to counter.

In the batting department, Smriti Mandhana has been the top scorer, while Shafali Verma's aggressive approach has given India rapid starts.

Her 19-ball 31 in the fourth T20I set the tone for the chase and helped her earn a recall to the ODI squad for India A's tour of Australia.

Shafali, however, will be eager

to convert her starts into more substantial contributions.

Jemimah Rodrigues, with 107 runs in the series, has been a steady presence in the middle order and hit the winning runs in the previous match.

Harmanpreet, despite a 48-run stand with Rodrigues, looked short of her best and will aim to fine-tune her game before the ODI leg. For England, the absence of skipper Nat Sciver-Brunt, ruled out with a left groin injury after the second T20I, has hurt their bal-

ance.

Their batting has lacked direction, with Sophia Dunkley the only batter showing any consistency.

Openers Dunkley and Danni Wyatt-Hodge have failed to provide solid starts, and the middle-order has not stepped up either. A total of 126 was never going to trouble India's powerful batting unit. In the bowling department, pacer Lauren Bell has stood out with six wickets, but apart from her, no other bowler has been able to stop the Indian batting line-up, with the next best being Sophie Ecclestone and Lauren Filer with just three wickets each.

India should persist with Nitish, avoid temptation to chop and change: Kumble

LONDON, July 11: Former India captain Anil Kumble says all-rounder Nitish Kumar Reddy should be a regular fixture in the national Test team as he has proved himself to be a fine mix of discipline and talent.

Reddy, playing his second game in the ongoing tour of England, was the most successful Indian bowler, picking up two wickets, on the opening day of the third Test here on Thursday.

"I was surprised at how well Nitish Kumar Reddy bowled. He consistently hit the right areas. That short ball down leg side was a gift, but otherwise, he was disciplined," Kumble said of the seven-Test-old player on JioStar's 'Match Centre Live'. "I thought he did quite well in Australia - got a hundred with the bat and bowled decently even if he didn't take many wickets. What you need from someone like him is to break partnerships and give the fast bowlers a breather while still maintaining control. "He bowled nearly 14 overs in a spell - that shows fitness and control. He's young, he's a capable batter with a century under his belt, and he's a sharp fielder. India should persist with him and avoid the temptation to chop and change," added the leg-spin great.

Kumble said the Lord's pitch was evidently tough for the batters as England were forced to abandon their aggressive style for a more reserved approach which yielded 251/4 on the opening day.

"It was evident right from the start that it was going to be a grind for the batters. The openers struggled to score off the new ball, and this was the kind of pitch where you had to work hard for your runs," Kumble said.

"I thought the Indian bowlers bowled really good areas consistently and that's one of the reasons India managed to restrict England to 251. England will be fairly satisfied with just four wickets down. "India will probably reflect tonight and feel that one or two more wickets could have put the match firmly in their favour. As it stands, it's evenly poised," he added. Former England player Jonathan Trott also noted the home team's change in strategy. "It was an interesting day, starting right from the toss. England took a different approach compared to the first two Tests. I thought Ollie Pope (44) came out in typical 'Bazball' style -- attacking early -- but quickly realised that this wasn't that kind of pitch. Credit to him for adjusting his game. (PTI)

AIFF charts roadmap for Indian women's national team after Asian Cup qualification

NEW DELHI, July 11: All India Football Federation (AIFF) president Kalyan Chaubey on Friday held discussions with his colleagues to chart a roadmap for the national women's team's preparation plans for next year's AFC Asian Cup in Australia.

It was decided to organise the 2025-26 Indian Women's League season, featuring eight teams playing 14 matches each, from September 2025 to January 2026.

The Indian U20 women's team will also participate in the IWL. The AIFF said the earlier than usual scheduling would allow for ample preparation time in the lead-up to the Women's Asian Cup, scheduled from March 1 to



21. In addition, the Blue Tigresses will undergo 83 days of preparatory camps, conducted in three phases. This will include 10-12 international friendlies and five to seven matches with domestic teams.

To effectively manage this calendar, the AIFF said it will engage

with all IWL club owners to seek their support and cooperation in releasing players for the camps and when required for the national interest. With this plan, the AIFF said each player is projected to play at least 30 matches between August and February, combining both club and international commitments.

To facilitate uninterrupted national team preparation in the lead-up to the Asian Cup, it was also suggested that the senior women's national football championship for the Rajmata Jijabai Trophy 2025-26 be scheduled after the conclusion of the continental tournament.

India secured a memorable

qualification in the continental tournament finals with a thrilling 2-1 victory over hosts Thailand last Friday.

The win helped India top Group B of the Qualifiers with a perfect record — four wins from four matches. For the first time the Blue Tigresses have booked a ticket to the continental championship through the qualification route. Chaubey convened a meeting with the AIFF's deputy secretary general, M. Satyanarayan, technical director Syed Sabir Pasha, director of national teams Subrata Paul, Indian women's national team head coach Crispin Chettri and assistant coach Priya PV. (PTI)

Wasn't the surface to come out swinging; Indian attack made it hard to score: Pope

LONDON, July 11: "This wasn't a surface where you could come out swinging," said Ollie Pope as he defended England abandoning 'Bazball' for a more conservative style of batting on the opening day of the third Test against India here.

England were 251/4 at stumps on Thursday after an uncharacteristically defensive performance that required plenty of patience, a far cry from their usually aggressive rate of scoring in the format.

"This wasn't a surface where you could come out swinging. The Indian attack held their lengths and made it hard to score," Pope said at the post-play press conference, referring to the tight spells bowled by the Indian attack that was bolstered by the return of pace spearhead Jasprit Bumrah (1/35). Nitish Kumar Reddy (2/46) was most successful while

Akash Deep and Mohammed Siraj did their bit to maintain a tight grip on the scoring rate. "...not necessarily the way we're used to kind of going about, putting together a first innings, but I think 250 for four is a pretty, pretty good score...obviously would have liked some more runs..." Pope, who made a dogged 104-ball 44 before falling to Ravindra Jadeja, said. "...but I think the the nature of the surface and I think the way the Indian attack bowled as well was pretty good throughout," he added.

Pope said the opening day's play was all about respecting the conditions and adapting to the needs of the team. "I think it's a day that we'll take, obviously we've had to adapt...I think for us, yeah, it's just about getting better as a team and reading situations.

"...sometimes it might be that you

see some more aggressive shots on a pitch that's really moving around and nipping around.

"(That's) because that's your best way of putting some pressure back on the bowlers and trying to get them to sort of stop doing what they want to do," he explained.

Talking about his own batting, Pope said building an innings was his priority. "...it's something that we're trying to get better and better as a team and obviously (it's) a Test against India. They're always going to test you in in those kind of situations. So yeah, it's just trying to adapt," asserted.

Pope, who is the vice captain of the team, was also quizzed about skipper Ben Stokes, who was unbeaten on 39 along side Joe Root (99) but left the side concerned with a groin niggle during his 102-ball stay. (PTI)

FC Goa, captain Odei Ona India part ways

PANAJI, July 11: FC Goa and their captain Odei Ona India have parted ways after a fruitful partnership, the Indian Super League (ISL) club announced on Friday.

The 35-year-old Spanish centre-back has appeared in the vast majority of the club's ISL matches in 2024/2025.

Known for his exceptional ability to read the game and composure under pressure, Ona India joined the Gaur ahead of the 2023-24 season, reuniting with head coach Manolo

Marquez, under whom he previously played at Hyderabad FC.

"Our Captain gave everything, every tackle, every drop of sweat for our badge. He wore the orange with pride, played with heart, and led us to glory," FC Goa said on X.

I have identified a problem area and working on it: Neeraj Chopra

GURUGRAM, July 11: India's star javelin thrower Neeraj Chopra on Friday said he has identified a problem in his game and is looking to address it at the earliest, as he seeks to win a second world championship gold medal later this year.

Chopra, who is the strongest Indian medal hope in the September 13-21 showpiece in Tokyo, will be training in Prague and Nymburk in the Czech Republic for 57 days.

He will be heading out with his physio Ishan Marwah tonight and be based in the European country till September 5 at a total cost of Rs 19 lakh.

"I have already identified the areas I need to work on. While throwing the spear I tend to fall too much on my left side. We need to work on that. In training I don't do that, but in competition, it happens because of the extra effort I put in," Chopra said. The double Olympic medalist said he also needs to work on his consistency to hit the 90-mark more often.

"I have achieved 90m this year. But I need to be more consistent to achieve it more often. I am continuously around 88-89m, and my coach said he is happy, but I need to be more consistent," Chopra said during the launch of Under Armour store here. Needless to say, his next big target is to finish on top of the podium at the World Athletics Championships. (PTI)

I have learned to handle pressure from MS Dhoni sir: Deepti Sharma

BIRMINGHAM, July 11: Seasoned India Women all-rounder Deepti Sharma says she has learned to stay unruffled in the most difficult of circumstances by religiously watching video clips of MS Dhoni, one of the best in the business when it came to handling pressure. The 27-year-old Deepti recently joined the legendary Jhulan Goswami in the coveted 300-wicket club in international cricket, and while she has sizzled with her off-spin bowling and lower-order batting, what sets her apart is her ability to deliver under pressure.

"I have learnt to handle pressure from MS Dhoni sir. I used to be glued to the TV whenever there was a match featuring him and watch them," Deepti told BCCI TV on Friday.

"It never seemed like he (Dhoni) was under pressure at any moment, he would calmly handle the situation and finish the game at last. That is exactly what I have also developed in my game," she added.

Deepti has been one of the team's most consistent performers over the past



few years and is often called upon to get a breakthrough with the ball or bail the team out of a tricky situation with the bat. "I keep things simple, for example in every match when I get the chance to bowl, be it in the powerplay or slog overs, I handle that task very calmly.

"I love challenges, and whenever a tough situation arises, the team management feels that we have Deepti in our ranks and she can get the job done."

Deepti's wicket of Alice Capsey in the 4th T20 International against England brought up her 300th international wicket across formats.

"Obviously feeling great, and it's a very proud moment for me as well as my family. The team has also praised me a lot for this achievement.

"When I started playing cricket, I did not think on these lines. The only goal was to find a way to play for India.

Practice accordingly, with hard work and dedication.

"I was not thinking about records etc. It was never in the back of my mind but it feels good when we reach a milestone."

She added, "When I picked my first wicket, I mean I got two wickets in that match, I was feeling very good about it, my maiden wickets. I have had some good memories, right from my first wickets, including the encouragement and high fives from my teammates."

Deepti made her international debut for India's Women's team in an ODI against South Africa in November 2014, and she was just 17 at the time.

"I have not set any targets, like I want to take these many wickets or score these many runs.

"What matters to me is in how many matches can I contribute to the team as an all-rounder and help them win matches. How much impact can I make and how can I take the team out of difficult situations... that is more important to me, and not milestones." (PTI)
