

Air India crash report hints at cockpit confusion

Preliminary probe finds no aircraft fault • Pilots heard questioning each other as Dreamliner lost thrust

NEW DELHI, July 12: Seconds before Air India flight 171 crashed while ascending from Ahmedabad, the fuel control switches of both its engines were cut off, a preliminary investigation report said on Saturday, suggesting a catastrophic pilot error in the cockpit of the Boeing 787 Dreamliner.

The Airlines Pilots Association of India disagreed with the report, saying the investigation is "shrouded in secrecy," appears to be biased against the pilot and has come to a conclusion hastily.

A 15-page preliminary investigation report into the disaster revealed fuel-control switches of the two engines moved from the "run" to the "cutoff" position, within the space of one second, leading to immediate loss of altitude.

In the cockpit voice recording, one pilot is heard asking the other why he cut off the fuel. The other denied having done so

The report by Aircraft Accident Investigation Bureau (AIIB), released early on Saturday, neither concluded any reason for the switches moving nor apportioned explicit blame for the crash.

It also did not identify the pilots in the voice recording. But it also said no fault was found in the aircraft, leaving only the possibility of pilot error as the cause.

At the controls was First Officer Clive Kunder, 32, while Sumeet Sabharwal, a veteran with 30 years of experience at Air India, was the senior cockpit occupant in command monitoring the flight.

The report, however, referenced a 2018 airworthiness bulletin by the US Federal Aviation Administration that said fuel switches had been installed on Boeing 737s, a smaller model, "with the locking feature disengaged".

The locking mechanism was similar on various Boeing aero-



plane models, including certain 787s, it said. Air India did not carry out inspections recommended in the 2018 FAA advisory on fuel control switch safety, as the bulletin was classified as "nonmandatory", the report said.

It wasn't immediately clear if this had any link to the accident.

The report provided the first detailed account of the fateful 32 seconds between takeoff in Ahmedabad and the crash into a medical college hostel just outside the airport perimeter, killing all but one of the 242 onboard and another 19 on the ground in the deadliest aviation accident in a decade.

The report did not provide any clues to why and by whom the two fuel switches were moved to a cutoff position as the plane nosed into the air, starving the two engines of the thrust needed for the lift. It ruled out any bird hit or fuel contamination.

According to a chronology laid out in the report, both fuel cutoff switches moved from RUN to CUTOFF, one second apart, almost immediately after takeoff. Ram Air Turbine (RAT) pump was deployed to supply hydraulic power as both engines fell below the minimum idle rate.

About 10 seconds later, Engine 1 fuel cutoff switch moved to its so-called RUN position, followed by Engine 2 four seconds later. The pilots managed to relight both engines, but only Engine 1 recovered while Engine 2 failed to build up enough power again to reverse deceleration. (CONTD. ON PAGE-2)

Centre eases SO2 emission norms, exempts large number of coal plants

NEW DELHI, July 12: The central government has once again extended the deadline for coal-based thermal power plants to comply with sulphur dioxide emission norms and has fully exempted those located away from critically polluted areas or cities with a population of over one million.

In a notification dated July 11, the environment ministry said the compliance deadline for Category A plants, located within a 10-km radius of the National Capital Region or cities with a population of over one million, has been extended from December 2024 to December 2027

Category B plants, situated within a 10-km radius of critically polluted areas or non-attainment cities, will now be assessed on a case-by-case basis instead of adhering to the earlier 2025 deadline. Category C plants -- all others not falling under Category A or B -- have been completely exempted from the sulphur dioxide norms, provided they meet the prescribed stack height criteria. These plants were earlier required to comply by December 2026.

Flue gas desulphurization units are installed in coal-fired power plants to control sulphur dioxide emissions, a major air pollutant. SO2 converts into fine particulate matter (PM2.5), which can penetrate deep into the lungs and cause a range of diseases, leading to millions of deaths each year.

The ministry said it had received numerous representations seeking exemption or relaxation in the timelines of the emission standards due to factors such as the "limited availability of technology providers, its techno-economic feasibility, negative impact of the Covid (CONTD. ON PAGE-2)

SHILLONG, July 12: Union Finance Minister Nirmala Sitharaman on Saturday underscored the need to balance ecological preservation with the aspirations of development, particularly in regions like Meghalaya.

BENGALURU, July 12: ISRO on Saturday said it has successfully completed the development of Service Module Propulsion System (SMPS) for Gaganyaan Mission with the completion of the qualification test programme.

A full duration hot test of SMPS for 350 seconds was conducted to validate the integrated performance of the SMPS for flight off-nominal mission profile of the Service Module based mission abort on Friday.

Gaganyaan mission is India's first human spaceflight mission in the making. "The overall performance of the propulsion system during the hot test was normal as per pre-test predictions," ISRO said in a statement.

According to the space agency, "The Service Module (SM) of Gaganyaan is a regulated bi-propellant based propulsion system that caters to the requirements of the Orbital Module for orbit circularisation, on-orbit control, de-boost manoeuvring and Service Module based abort during the ascent phase.'

The Liquid Apogee Motor (LAM) engines provide the main propulsive force during the orbit circularisation and de-boost phases, while the Reaction Control System (RCS) thrusters ensures precise attitude control, it added

"A System Demonstration Model (SDM) test bed was realised emulating the fluid circuit of the SMPS, encompassing the propellant tank feed system, helium pressurisation system. flight-qualified thrusters, and control components," ISRO said.

It added that the SDM for SMPS has undergone 25 tests under nominal and off-nominal conditions for a cumulative duration of 14,331s for various Gaganyaan mission scenarios and human rating requirements. The space agency said the Gaganyaan Service Module Propulsion System is designed, developed, and realised by Liquid Propulsion Systems Centre (LPSC) and the tests were carried out at ISRO Propulsion Complex (IPRC), Mahendragiri in Tamil Nadu. GOALPARA, July 12: An eviction drive to clear encroachment of around 135 hectares of land in the Paikan Reserve Forest in Assam's Goalpara district was conducted smoothly on Saturday, an official said.

Goalpara District Commissioner (DC) Khanindra Choudhury told PTI that the operation concluded peacefully. "The structures were dismantled. It went off peacefully," he said. As many as 40 excavators were pressed into action, along with heavy security deployment to ensure peaceful eviction operation.

A forest department officer said, "Our target was to recover the forest area under encroachment and we have done it." "Our first step was to clear the encroachment. Now, we will go to the plantation to recover the land," he said.

Police officers said "preventive measures" were taken for peaceful conduct of the eviction operation and it went off smoothly.

Local reports claimed that an affected person allegedly tried to commit suicide but was saved with swift medical assistance.

The Goalpara DC had said on Friday that about 95 per cent of alleged illegal settlers have already moved out from the area, dismantling their establishments.

The eviction drive, which was scheduled to be carried out on Friday, was postponed by a day, keeping in mind the Friday prayers in the Muslim-majority area, Chief Minister Himanta Biswa Sarma had said. Goalpara Divisional Forest Officer (DFO) Tejas Mariswamy had said earlier that the eviction drive

would clear encroachment on around 135 hectares in the Paikan Reserve Forest of the Krishnai Range.

"There are 1,080 families who have encroached on forest land, and we had asked them to vacate the area in November-December last year. We again served them notices last month to vacate the area by July 10," he had said.

Since 2023, the administration has cleared encroachments on 650 hectares of land across four forest ranges. "Of this, human habitation was in 200 hectares and farming was done in the remaining 450 hectares," Mariswamy had said.

Encroachments on nearly 1,160 acres, affecting close to 1,100 families, in Charuwa Bakra, Chirakuta and Santoshpur villages under the Chapar circle in neighbouring Dhubri district were cleared during a drive on Tuesday. (CONTD. ON PAGE-2)

HT Bureau GUWAHATI, July 12: Prime Minister Narendra Modi on Saturdav addressed the Rozgar Mela via videoconferencing and distributed more than 51,000 appointment letters to newly recruited youth in various government departments and organisations.

The Prime Minister congratulated the appointees and described their induction as the beginning of a journey of national service under the guiding principle of "Citizen First.

The event was joined from Guwahati by Union Minister of Ports, Shipping & Waterways Sarbananda Sonowal, who also handed over appointment letters to select candidates from Assam.

According to an official statement, the Prime Minister underlined that the Rozgar Mela was part of the government's broader effort to provide meaningful employment and that lakhs of youth had already received appointments through such events.

Highlighting India's strengths, he said the world acknowledges the country's two great assets demography and democracy --with the largest youth population and the largest democratic system in the world.

He emphasised that these are key to India's future, and that converting youth potential into productive national capital is a top priority for the government.

The Prime Minister cited his recent visit to five countries and said that India's youth power was a strong and recurring theme across discussions. He pointed out that

agreements signed during the tour, covering sectors like defence, digital technology, energy, and pharmaceuticals, would create long-term opportunities for Indian youth both at home and abroad.

One of the pilots issued a "Mayday, Mayday, Mayday" distress call, but before air traffic controllers could get a response about what had gone wrong, the plane crashed just outside the Ahmedabad airport boundary having grazed some trees before plunging into a hostel packed with students.

The time between the takeoff and the crash was only 32 seconds. The preliminary report recommended no action for now for the operators of Boeing 787-8 planes. In a statement, Air India said that it "stands in solidarity with the families and those affected" and "[continues] to mourn the loss" of those killed in the accident. Air India said it was "working closely with stakeholders, including regulators" and "continue to fully cooperate with the AAIB and other authorities as their investigation progresses." On its part, Boeing said: "Our thoughts remain with the loved ones of the passengers and crew on board Air India Flight 171, as well as everyone affected on the ground in Ahmedabad. We continue to support the investigation and our customers.

The US National Transportation Safety Board noted that there were no recommended actions in the report aimed at operators of Boeing 787 jets or the GE engines. The ill-fated flight was commanded by Sumeet Sabharwal, 56, a veteran with 30 years of experience at Air India. He had logged 15,638 flying hours, including 8,596 on the Boeing 787. He was also an Air India instructor. His co-pilot was Clive Kunder, 32, who had 3,403 hours of total experience, with 1,128 hours on the Dreamliner. Kunder was the pilot flying, while Sabharwal was the pilot monitoring. The crew had passed pre-flight breathalyser tests and were seen at the gate on CCTV before they took off, the report adds. The June 12 accident was India's worst aviation disaster in almost three decades and the industry's deadliest in 11 years, as well as the first fatal accident involving a Boeing Dreamliner. The investigation was conducted with assistance from the UK's Air Accident Investigation Branch and the US National Transportation Safety Board.

Aviation experts have said it is difficult for pilots to inadvertently move the fuel switches, as there is a little mechanical gate built into the switch. Switches need to be lifted up over this little gate to shut off supply. They also asked why the report made no reference to cockpit camera footage. Fuel switches are devices that regulate the flow of fuel into the engine of an aeroplane. Pilots use them to start or shut down engines on the ground or during a flight in case of an engine failure. They are spring-loaded to remain in position. To change fuel supply, a pilot has to first pull the switch up and then move it from RUN to CUTOFF or vice versa.

'The aircraft achieved the maximum recorded airspeed of 180 Knots IAS at about 08:08:42 UTC (13.38 IST) and immediately thereafter, the Engine 1 and Engine 2 fuel cutoff switches transitioned from RUN to CUTOFF position one after another with a time gap of 01 sec," the report said. (PTI)

It added that it had also received an "explicit recommendation" from the Ministry of Power in this regard.

According to the notification, several studies were conducted by research institutions regarding the effectiveness and rationale behind the SO2 standards and their role in the overall ambient air pollution of the region. The ministry said consultations were held with the industry, the Ministry of Power, the Central Pollution Control Board (CPCB), scientific institutions and other stakeholders regarding the emission standards and their timeline. It added that a committee was constituted in the CPCB to "examine the issue in totality, assess the available study reports, other relevant materials and other related factors and make a recommendation on applicability of these standards and its timeline".

The CPCB, after detailed analysis, submitted its recommendation based on its study on the National Ambient Air Quality Standards of SO2 across most regions of the country; resource conservation in terms of avoiding additional consumption of water, auxiliary power and limestone; and the increase in carbon footprint or carbon dioxide emissions due to operation of the deployed control measures and mining and transportation of limestone required for these measures.

The anti-encroachment exercise was undertaken to hand over land to the Adani Group for setting up a power plant. Crackdown on illegal vehicle modifications in Cachar intensifies

GUWAHATI, July 12: In a coordinated effort to reinforce road safety and enforce vehicular compliance, the Cachar District Administration, in collaboration with the District Transport Office and Assam Police, has intensified its ongoing crackdown on unauthorised vehicle modifications.

Launched in May, the enforcement drive has gained significant momentum, with officials warning that the campaign will continue through the end of July 2025.

According to an official statement, the initiative is aimed at curbing a growing trend of illegal alterations to vehicles-modifications that violate legal provisions and pose serious risks to public District Commissioner safety. Mridul Yadav, who is leading the campaign from the front, has underscored the administration's zero-tolerance stance.

"Public safety is paramount," Yadav said, adding that such modifications are not only unlawful but endanger the lives of drivers, passengers, and pedestrians alike.

District Transport Officer (DTO) of Cachar, Ramesh Shyam, is overseeing the enforcement operations on the ground. As per the latest figures shared in the official release, at least 30 vehicles have been penalised for violations so far, with echallans issued and fines totalling

₹1.50.000 collected. "Our teams are vigilant," DTO Shyam stated, "and we are committed to ensuring that vehicle owners comply with all prescribed norms.

These illegal alterations may appear trivial to some, but they represent serious safety hazards.

The joint enforcement squads have been conducting rigorous checks across the district-from busy market zones to interior rural roads.

Vehicles found with structural changes, unauthorised lighting systems, pressure horns, or exhaust modifications have been pulled over, and their owners warned or penalised under relevant provisions of the Motor Vehicles Act.

Officials have clarified that the campaign is not intended to inconvenience the public but to instil a culture of lawful and responsible vehicle usage

"The drive is preventive, not just punitive," DTO Shyam reiterated. "Our goal is to protect lives, and we urge all vehicle owners to follow the rules to avoid facing stricter penalties." The administration has also appealed to the public for cooperation, noting that community support is essential to building a safer road environment. As the campaign enters its final

fortnight, authorities have affirmed that surveillance and enforcement will continue with full intensity. The message from Cachar's lead-

ership is unequivocal: the district's roads will not be allowed to devolve into zones of indiscipline. With sustained vigilance and a firm administrative resolve, the

crackdown aims to restore order, reduce accidents, and ensure that every road user adheres to the rule of law.

In an official statement issued later in the day, ONGC clarified that the incident involved a minor leak of effluent water containing traces of floating oil.

The seepage was observed at Nagar, Rudrasagar, Jonaki Sivasagar, specifically in the area between Group Gathering Station 2 (GGS-2) and Group Gathering Station 3 (GGS-3).

The ONGC team promptly isolated the leak upon arrival and initiated repair work. According to the statement, the

area has been secured and all standard safety protocols have been implemented on site.

Malala Yousafzai celebrates the Power of Pen

Tirginia Woolf famously wrote, "As a woman, I have no country. As a woman, I want no country. As a woman, my country is the whole world," highlighting her feminist perspective. Today when we celebrate the birthday of Malala Yousafzai as a global voice for a generation struggling for women education, we may apply Virginia Woolf's words for her. In her Nobel Peace Prize speech, Malala Yousafzai made it clear that the award is not just for her,. It is for those forgotten children who want education. It is for those frightened children who want peace. It is for those voiceless children who want change.I am here to stand up for their rights, to raise their voice... it is not time to pity them. It is not time to pity them. It is time to take action so it becomes the last time, the last time, so it becomes the last time that we see a child deprived of education.'

The campaign "I am Malala" was launched to promote her cause. On Malala's 16th birthday, 12 July 2013, she addressed the UN, which responded by naming the day "Malala Day". Yousafzai spoke before the UN on July 12, 2013, her 16th birthday, to promote universal access to education. With an audience of more than 500 young education advocates from around the world, it was her first speech in front of a crowd since the attack. She said, "Malala Day is not my day. Today is the day of every woman, every boy and every girl who has raised their voice for their rights."Malala Yousafzai is a Pakistani activist for female education and she gained international prominence after surviving an assassination attempt by the Taliban in 2012. Malala advocates for girls' right to education and continues to work towards improving access to education for children worldwide. Her courage and activism have made her a global symbol of education and empowerment. The world now recognizes more realistically the meaning of the age old proverb. "Pens are mightier than weapon. In her Nobel Peace Prize speech, she asserts boldly, "Dear brothers and sisters, I was named after the inspirational Malalai of Maiwand who is the Pashtun Joan of Arc. The word Malala means grief stricken", sad", but in order to lend some happiness to it, my grandfather would always call me Malala - The happiest girl in the world" and today I am very happy that we are together fighting for an important cause."Aged just 17, Malala is the youngest ever Nobel Prize laureate. We all celebrate 12 July globally as the 'Malala Day'.though she herself says, Malala has become the very symbol of girls' right to education. At the age of 11 she became known for her blog on the BBC's Urdu service and attracted international media attention. The world was appalled by the attempt to assassinate her in 2012, but Malala recovered and forgave her attacker. Political leaders and celebrities have paid tribute to the Pakistani schoolgirl and have endorsed her message that every child is entitled to go to school. "The extremists are afraid of books and pens. The power of education frightens them."said Malala Yousafzai who is today the loudest global voice for women.Born in Mingora Pakistan on 12 July 1997 Malala Yousafzai jointly awarded the Nobel Peace Prize with Kailash Satyarthi on October 10 2014 for her struggle against the suppression of children and young people and for the right of all children to education. Malala Day is an annual observance on July 12th that honours the advocacy and resilience of Malala Yousafzai in promoting girls' education. It raises awareness about the importance of education and the ongoing fight for equal educational opportunities for all children worldwide. The Nobel Peace Prize was awarded to Malala and Kailash Satyarthi for their work in promoting children's rights, specifically the right to education. Malala's activism, particularly her blogging and public speaking against the Taliban's ban on girls' education in Pakistan, brought global attention to the issue and made her a target of the Taliban. She was shot in the head by the Taliban in 2012 for her activism. Malala continued her advocacy through the Malala Fund, an organization she co-founded to support girls' education worldwide. She also continues to speak out on the importance of education and women's rights on global platforms. In her Nobel Peace Prize lecture Malala said, "Some people call me the girl who was shot by the Taliban. And some, the girl who fought for her rights". Some even call her a Nobel Laureate now. But she concludes her speech by confidently asserting, "However, my brothers still call me that annoving bossy sister. As far as I know, I am just a committed and even stubborn person who wants to see every child getting quality education, who wants to see women having equal rights and who wants peace in every corner of the world. Malala Yousafzai comes from the Swat Valley in Pakistan. In 2009 the Taliban decreed that all girls' schools should be closed or there would be consequences. Malala continued to go to school. She started to blog about girls' right to education, and became known as one who defied the school ban. On 9 October 2012 she was shot by the Taliban, but survived. She has not allowed threats to silence her and is a global voice as she continues to campaign for the right of girls to education. The Malala Fund helps to provide schooling for girls in Pakistan, Nigeria, Jordan and Kenya. Her message has been that children's right to education is the foundation for peace, and an important measure in the fight against extremism. The Norwegian Nobel Committee has decided that the Nobel Peace Prize for 2014 is to be awarded to Kailash Satyarthi and Malala Yousafzai for their struggle against the suppression of children and young people and for the right of all children to education. "Education is education. We should learn everything and then choose which path to follow. Education is neither Eastern nor Western, it is human."Articles 28 and 29 of the UN Convention on the Rights of the Child state that all children are entitled to an education. Education should aim to develop the child's personality, talents, physical and mental capacities and be of good quality. UNESCO says that, worldwide, 57 million children do not go to school, over half of them girls. As many as 130 million children spend years at school without ever learning to read or write. Education helps to reduce child mortality, improves health, increases an understanding of democracy, results in higher wages and promotes economic growth. Despite her youth, Malala Yousafzai has already fought for several years for the right of girls to education, and has shown by example that children and young people, too, can contribute to improving their own situations. This she has done under the most dangerous circumstances. Through her heroic struggle she has become a leading spokesperson for girls' rights to education.'

The Contradiction at the Heart of American Democracy

he United States of America has long positioned itself as the vanguard of democracy — the shining city upon a hill, a moral compass for the modern world. Yet, as the republic commemorates 250 years since its founding, this selfimage is crumbling under the weight of its contradictions. The story of American democracy, once packaged as a noble experiment in liberty and self-rule, now increasingly resembles an elaborate illusion - one engineered to conceal the architecture of racial domination, settler-colonial expansion, and global empire. What the world has been sold as democracy is not a universal ideal, but a selective ideology - invoked when useful, discarded when obstructive. It is time to interrogate this myth, not to destroy hope, but to ground our understanding in historical

and political truth We are told that American democracy was born in a moment of virtuous restraint ---when George Washington re-Colonel jected

Lewis Nicola's DEGREE OF THOUGHT proposal to crown him king. This tale has been exalted

in civic education as the foundational moral choice of the republic: a soldier-turned-statesman declining monarchy to champion liberty. But this moment, like much of the origin story of the United States, is a polished fable. The reality is that the new republic was neither egalitarian nor just; it was an elite project, forged by white, land-owning men who enslaved others, exterminated Indigenous peoples, and consolidated power under the guise of constitutional order.

The Declaration of Independence, often celebrated as a beacon of freedom, was authored by men who owned slaves. Thomas Jefferson, its principal writer, not only enslaved over 600 people in his lifetime but fathered children with one of them, Sally Hemings, while she remained legally his property. Thus, while the document proclaimed that "all men are created equal," its authors actively denied that equality to millions — not merely by omission, but through systematic and legislated violence. The very wealth that funded the new nation was extracted from the blood, sweat, and bodies of enslaved Africans, whose suffering became the economic foundation of America's ascent. In parallel, the genocide of Indigenous nations was not an

The later establishment of Indian Boarding Schools, which functioned until the late 20th century, continued the assault by severing children from their families, erasing languages, banning spiritual practices, and subjecting the youth to systemic abuse — cultural genocide masked as assimilation.

Slavery's formal abolition in 1865 was not a moment of pure redemption. The 13th Amendment outlawed slavery except as punishment for crime, a legal loophole that would birth the American prison-industrial complex. In the post-Reconstruction South, Black life was criminalised to supply labour to private industry through convict leasing. This system evolved into Jim Crow laws and eventually into the modern regime of mass incarceration. Today, the United States holds over two million people behind bars - disproportionately Black and Brown — in conditions that continue to echo slavery. The rhetoric of freedom rings hollow when liberty is so unequally rationed.

Even now, the violence persists. On 22 June 2025, the US launched airstrikes on alleged Iranian nuclear sites — without Senate approval, without a UN mandate, without presenting evidence of imminent threat. It was another act of premeditated agversities and tech industries to attract global talent brain-draining the best minds from poorer countries. At the same time, it offers haven to corrupt elites and their looted wealth. This dual strategy consolidates American power while weakening potential rivals. Those who benefit are often silenced by privilege, reluctant to criticise the very system that rewards them. Silence, in such cases, becomes a survival strategy — the price of assimilation into the imperial order.

Yet, American diplomats continue to sermonise about corruption, democracy, and human rights - often while standing on the very soil that has been devastated by their policies. The dissonance is staggering. To speak of justice in Iraq, after launching an llegal war there in 2003, is not just hypocrisy — it is an insult to history. That war, based on fabricated intelligence, killed hundreds of thousands, dismembered Iraqi society, and unleashed chaos across the Middle East. It was not a mistake. It was a calculated crime, designed to secure oil and power under the pretext of liberation.

As the United States crosses the threshold of 250 years, it is not an enlightened democracy but a decaying empire grappling with its contradictions. It preaches rule of law while withdrawing from international treaties. It champions human rights while funding apartheid and authoritarian regimes. It speaks of peace while waging perpetual war. Its democracy is neither universal nor moral — it is a brand, a mythology, a geopolitical weapon.

To participate in this mythology - to recite its founding fables without critique — is to become complicit. To worship the Constitution without interrogating the violence it enabled is to enshrine injustice in civic religion. True democracy must be built not on myth but on accountability. It must emerge from a reckoning with history, a dismantling of empire, and a commitment to justice - not just for Americans, but for all.

Until that reckoning occurs, the American project will remain what it has long been: a paradox wrapped in a flag, promising liberty while dealing in domination. Its democracy, such as it is, must not be preserved as sacred scripture — it must be reimagined as a living contradiction in need of radical transformation. (the

'Bhanubhakta's Ramayan': Its Impact on Gorkhali community

The Ramayana is considered as an epic in Sanskrit verse tradition. The origin of Ramayana is very ancient. In encient Indian religious and literary texts such as Vedas, Puranas, Brahman, Aranyak and Upanishads one finds ample reference to the stories of Ram. The legend of Ram existed much before Valmiki wrote his Ramayana. Valmiki took the legend and treated it in the genre of epic verse. He composed the Ramayana in 'Loukik Sanskrit and therefore he is regarded as Adi Kabi.

The Ramayana has been translated and rewritten in many languages of the Sanskrit origin. Vyas Risshi's "Adhyatma Ramayana", and others Yog Basista, Ananda Ramayana, Mantra Ramayana and Bhusundi Ramayana etc. are all written in Sanskrit language. The Ramayana has also been written in regional languages such as Kamba Ramayana in Tamil, Kumudendu Ramayana in Kannad, Sapta Kanda Ramayana in Assamese, Kritivas Ramayana in Bengali and several other translations in different languages of India. Likewise, in Nepali language, bhanubhakta Acharya wrote his 'Bhanubhaktako Ramayana' in 19th century. It was tanslated from Vyas Rishi's Adhyatma Ramayana written in Sanskrit language.

Bhanubhakta's biographer Motiram Bhatta opines that the great poet was inspired by a grass cutter in his literary journey. The grass-cutter is said to have saved some money in order to dig a well so that the people of his village could have free access to drinking water also Thus he felt he would leave behind his name for posterity. Bhanubhakta was amazed at the grass-cutters outlook. This incident instilled in him an urge to do something for his people, for his community.

He thus writes-

"Bharajanma gharesatira mandi dhana kamayo Naam kei rahos pachi bhanera kuwa khanayo...

. Tes ghansi le kasari aja diyecha arti

Dhikkar ho makana basnu narakhi kirti."

Thus, Bhanubhakta started his exemplary work of writing the Ramayana in Nepali. Bhanubhakta was born in Tanahu in Nepal in the year 1814. He had his basic education at his own home, his tutor being his grandfather Sri Krishna Acharya. Thereafter he acquired the knowledge of Sanskrit and astrology while he was in Banaras with his grandfather .Bhanubhakta is taken to be the most representative poet of the early Nepali literature. Besides Ramayana, his other well known works are Bhaktamala, Prashnauttarmala, Badhusiksha, Ramgita and lots of other poems to his credit.

Writers before Bhanubhakta in Nepali literature mainly dealt with mythical heroes and superheroes in their writings. Bhanubhakta was the first Nepali poet to write about common people, the everyday people that one encounters in daily lives. He talks about grass cutters, a common folk

like Giridhari Bhatt, wife of Gajadhar Soti, young maidens of Kantipur and the likes. His themes and characters attracted the readers of his contemporary society because they could find a reflection of their own lives in his writings. Thus his writings were more extensively read than any other writers of his age.

The Ramayana has manifold influence in the lives of Nepali speaking people the world over. Apart from being a cult literary text it is also a historical text, a social treatise and a favorite read. It instills the values of love, tolerance and Vasudeaiba Kutumbakam (the world is one family) in its readers. It would be near to impossible for any other text to come closer to the Ramayana's appeal in the minds and hearts of the Nepali speaking people. Infact, his Ramayana proved to be healing source to the Gorkhali people also after the Sugauli Treaty.

Bhanubhakta is also known as Adikabi. Though the history of Nepali literature goes much beyond Bhanubhakta but modern Nepali literature begins with Bhanubhakta's Ramayana. He writes for the masses and as Motiram Bhatta, his biographer opines, Bhanubhakta is one of the first Nepali poet to talk about the people and for the people. He brought literature to the homes of common people, entertaining them and giving them a respite from their hard life. As Rahul Sankrityayan puts the popularity of a work of art is its acceptance by the common people. Though Raghunath Bhatta had written the Ramayana in the Nepali language before Bhanubhakta but Bhanubhakta's Ramavana is considered to be the cult text because of its proximity to the social and cultural milieu around him. Many people don't even know about the existence of Raghunath Bhatta's Ramayana. But Bhanubhakta's Ramayana has a special place in the hearts of all Nepali and Gorkhali people

Bhanubhakta's Ramayana was also a means of entertainment for people of all caste and class. Because of its colloquial style even common illiterate people like cowherds farmers and grass-cutters could reproduce the slokas and sing them while working. The slokas charmed them so much so that they started learning the alphabets so that they could read the written text. The slokas were sung at weddings, get togethers and any other social events. . Even today there is a tradition of orally reciting the Ramayana. Recitation competitions are also held every year on Bhanu Jayanti which falls on 13th July.

The tradition of orally reciting Bhanubhakta's Ramayana

Since many years the tradition of reciting Bhanubhakta's Ramayana has a great importance in rural life of Nepali and Gorkhali people. People often recite-

to get relief from the tiredness of the day's hard work. The Ramayana was recited in village gatherings by simple village folks. Rama's character, his love and respect for his parents, his family values, Rama's love for Sita, Hanuman's devotion for Rama inspired the people and provided them entertainment and much needed respite from their day to day hardships and turmoils. The common people could find shades of their own lives and personalities in the characters of the Ramayana besides their interest in the spiritual values . People read Bhanubhakta's Ramayana with a great devotion. The Ramayana's influence on the Nepali community is so immense that it cannot be summarized in a few words.

Bhanubhakta's Ramayana has the same kind of impact and influence on the Nepali speaking community people as Madhab Kandali's Ramayana has on the Axomiya people, Kritibas Ramayana on the Bengali people and Tulsidas's Ramavana on the people of North-India. It is not only a religious text but a literary creation of the highest order. It helped in standardizing the Nepali language, unifying the Nepali speaking people and instilling a sense of pride and oneness in the people.

In conclusion there is a fear that if we the Nepali speaking people let forget the creator of such a magnanimous cultural text then we may lose our identity. Therefore, I believe that interest, discussions and research on this topic by the new generation will help in maintaining the importance of this magnum opus of Nepali literature.

The Heritage and Culture of Jamugurihat

The very word "Jamuguri-hat" refers to a vast region encompassing the three mauzas of Barabhagia, Chilabandha, and Murhadol, located in the historically renowned, fertile land along the Jiyabharali River, rich with the treasures of education, literature, and culture. The history of this region, its historical landmarks, various institutions and organizations established in different villages, the intermingling of languages and cultures of diverse communities, culinary traditions, and religious customs have consistently occupied a significant place in various spheres of the state. In reality, every region has its past, with roads, educational institutions, hospitals, temples, mosques, churches, and their histories. In the fields of art, culture, literature, and education, there are always a few individuals who lead and shape the region's identity. These are the lifeblood of a region, its defining characteristics and uniqueness. With this perspective in mind, this article attempts to present a comprehensive discussion of the Jamugurihat region.

The name "Jamugurihat" is not profoundly ancient. The region derives its name from a marketplace or "hat" that was held under a massive jamun (Indian blackberry) tree situated in the heart of the area. Al-

The story of King Arimatta's atonement for patricide, associated with landmarks like the Pithaguri Doul and Shukna Pukhuri in Kusumtola, keeps the region vibrant with historical significance. Similarly, the Kachari Pukhuri in Nandikeshwar testifies to the Kachari rule, while the Hukai Pukhuri in Pachigao bears witness to the reign of Hukai Bhuyan of the Bhuyan dynasty. Although various dynasties ruled at different times, the six-century-long Ahom era holds the most significant historical value and importance for the region. The "Chamdhara Garh," constructed along the eastern bank of the Bharali River at the western boundary of Jamugurihat, enhances the region's historical significance. Built around 1635 during the reign of Swargadeo Pratap Singha, this garh (fort) stretched from the Brahmaputra River to the foothills of Dafla and was used as a military outpost and fortress to counter frequent Mughal invasions. Thus, Chamdhara served as a primary military base and residential area for officers and dignitaries. Additionally, the Gohai Kamal Ali, constructed under the orders of Koch King Naranarayan by Gohai Kamal, son of Chilarai, from Koch Bihar to Narayanpur, passes through the heart of Jamugurihat and is locally referred to as "Kabirar Ali" (the poet's road). The presence of douls (temples), thansatras (Vaishnavite monasteries), temples, numerous large royal ponds, and the Kusumtola Bori collectively underscore the region's profound historical importance. Jamugurihat's role in India's

independence movement was no less significant. With the mantra "Do or Die," people from all sections of society in the region actively participated in every phase of the independence struggle. In response to

hatma Gandhi's individual satyagraha against World War II was conducted in Jamugurihat as well. Madan Shaikia was the region's first satyagrahi. The satyagraha, launched nationwide with the mantra "Do not aid the British with money or men," opposed the British government's attempt to involve India as a cooperative nation in the war. In 1942, Jamugurihat set a remarkable precedent during the Quit India Movement. Men, women, students-everyone left their homes to participate in rallies and processions. Many were imprisoned, faced heavy fines, and endured police atrocities. Thus, Jamugurihat made an immense contribution to India's freedom struggle.

It is heartening to note that from the late 19th century through the period of the independence movement, several schools were established in var-

Russia warns US, South Korea, Japan against forming security alliance targeting North Korea SEOUL, July 12: Russia's for-eign minister on Saturday warned Jaishankar to visit China to attend SCO FMs meeting

eign minister on Saturday warned the US, South Korea and Japan against forming a security partnership targeting North Korea as he visited his country's ally for talks on further solidifying their booming military and other cooperation. Russian Foreign Minister

Sergey Lavrov spoke at North Korea's eastern Wonsan city, where he met the country's leader, Kim Jong Un, and conveyed greetings from President Vladimir Putin.

Relations between Russia and North Korea have been flourishing in recent years, with North Korea supplying troops and ammunition to support Russia's war against Ukraine in return for military and economic assistance. That has raised concerns among South Korea, the US and others that Russia might also transfer to North Korea sensitive technologies that can increase the danger of its nuclear and missile programmes.

Speaking with reporters after a meeting with his North Korean counterpart Choe Son Hui, Lavrov accused the US, South Korea and Japan of what he called their military buildups around North Korea.

Pak, Russia sign agreement to revive Pak Steel Mills project ISLAMABAD, July 12: Pakistan and Russia have signed an agreement to restore and modernise the Pakistan Steel Mills project, marking a new chapter in cooperation between the two countries, according to media reports.

China was also in the race for getting the contract for the Pakistan Steel Mills (PSM) project that was originally built with Soviet assistance. The agreement to revive the PSM in Karachi was signed at the Pakistan Embassy in Moscow on Friday, state-run Associated Press of Pakistan (APP) reported.

The project aims to restart and expand steel production, marking a new chapter in bilateral cooperation, the APP said.

Special Assistant to Prime Minister Haroon Akhtar Khan, who is currently on a visit to Russia, said, "Reviving the PSM with Russia's support reflects our shared history and commitment to a stronger industrial future." The PSM was originally built with assistance from the former Soviet Union in 1971, and had remained a lasting symbol of Pakistan-Russia ties, a statement issued by Press Information Department said.

BEIJING, July 12: External Affairs Minister S Jaishankar will travel to China to participate in the foreign ministers' meeting of the SCO bloc in the Chinese city of Tianjin next week, an official announcement here said on Saturday.

The Meeting of the Council of the Ministers of Foreign Affairs of the SCO will be held in Tianjin on July 15, a statement by a spokesperson of the Chinese Foreign Ministry here said on Saturday.

In addition to attending the SCO meeting, Jaishankar will also pay a visit to China, the spokesperson said, without specifying it.

At the invitation of the member of the Political Bureau of the Communist Party of China and Foreign Minister Wang Yi, foreign ministers of other SCO member states and heads of the bloc's permanent bodies will attend the meeting, the statement said.

The ministers will exchange views on SCO cooperation in various fields and major international and regional issues, it said.

The SCO comprises 10 member states - China, Russia, India, Iran, Kazakhstan, Kyrgyzstan, Pakistan, Tajikistan, Uzbekistan and Belarus.

A host of issues between the two countries, including the current normalisation process between the two countries. China's stoppage of the key rare earth metals required to manufacture a host of products, including automobiles, are expected to figure in the talks. Earlier, reports said that Jaishankar will visit Bei-

jing on July 13 for talks with Wang. Jaishankar's visit follows the recent visits of De-

fence Minister Rajnath Singh and National Security Advisor Aiit Doval to China.

It would be Jaishankar's first visit to China after the ties between the two countries came under severe strain following the 2020 military standoff along the Line of Actual Control (LAC) in eastern Ladakh.

Wang may also visit India this month to hold a fresh round of talks with NSA Doval under the framework of Special Representatives (SR) dialogue on the boundary dispute, it is learnt. Both Wang and Doval are the designated SRs of the boundary mechanism.

Both countries held 23 rounds of talks under the SRs mechanism to resolve the vexed boundary dispute spanning 3,488 km, but without success.

Defence Minister Singh travelled to the Chinese port city of Qingdao last month to participate in the SCO defence ministers' conference.

China is the current chair of the SCO, and it is hosting the meetings of the grouping in that capacity.

During his talks with Chinese Defence Minister Gen Dong Jun on June 26, Singh proposed that India



and China should solve the "complex issues" under a structured roadmap comprising steps to de-escalate tensions along the frontiers and rejuvenate the existing mechanism to demarcate the borders.

Singh and Dong held bilateral talks on the sidelines of a conclave of the Shanghai Cooperation Organisation (SCO) with a focus on maintaining peace and tranquillity along the Line of Actual Control (LAC). Singh had also emphasised the need to create "good neighbourly conditions" to achieve the best mutual benefits and called for "taking action on the ground" to bridge the "trust deficit" resulting from the 2020 eastern Ladakh border standoff, according to an Indian readout on the meeting on June 27.

Reacting to Singh's statement, Chinese foreign ministry spokesperson Mao Ning had said the boundary question is complicated, and it takes time to settle it". The military standoff between China and India in eastern Ladakh began in May 2020, and a deadly clash

at the Galwan Valley in June that year resulted in a severe strain in ties between the two neighbours. The face-off effectively ended following comple-

tion of the disengagement process from the last two friction points of Demchok and Depsang under an agreement finalised on October 21.

China and India are currently in the process of normalising relations.

The decision to revive the SR mechanism and other such dialogue formats was taken at a meeting between Prime Minister Narendra Modi and Chinese President Xi Jinping in Kazan, Russia, on October 23.

The Modi-Xi meeting came two days after India and China firmed up a disengagement pact for Depsang and Demchok.

In the last few months, India and China have initiated a number of measures to repair the bilateral ties. Recently, the two sides resumed the Kailash Manasarovar Yatra after a gap of nearly five years. (PTI)

UK's oldest man and WWII veteran, Donald Rose, dies at 110

LONDON, July 12: Britain's oldest World War II veteran, Donald Rose, has died at the age of 110. Rose participated in the D-Day landings on June 6, 1944, and was part of the division that liberated the Bergen-Belsen concentration camp in northern Germany.

Judge orders Trump administration

LOS ANGELES, July 12: A federal judge on Friday ordered the Trump administration to halt indiscriminate immigration stops and arrests in seven California counties, including Los Angeles.

Immigrant advocacy groups filed the lawsuit last week accusing President Donald Trump's administration of systematically targeting brown-skinned people in Southern California during its ongoing immigration crackdown. The plaintiffs include three detained immigrants and two U.S. citizens,

CAMARILLO (US), July 12: Federal immigration authorities said Friday they arrested about 200 immigrants suspected of being in the country illegally in raids a day earlier on two California cannabis farm sites. Protesters engaged in a tense standoff with authorities during an operation at one of the farms.

The Department of Homeland Security said in a statement that authorities executed criminal search warrants in Carpinteria and Camarillo, California, on Thursday. They arrested immigrants suspected of being in the country illegally, and there were also at least 10 immigrant children on site, the statement said.

Four U.S. citizens were arrested for "assaulting or resisting officers," the department said. Authorities were offering a \$50,000 reward for information leading to the arrest of one person suspected of firing a gun at federal agents. One worker who called family to say he was hiding from authorities was on life support after falling and suffering significant injuries.

During the raid, crowds of people gathered outside Glass House Farms in Camarillo to seek information about their relatives and protest immigration enforcement. Authorities clad in military-style helmets and uniforms faced off with the demonstrators. Acrid green and white billowing smoke then forced community members to retreat.

Glass House, a licensed California cannabis grower, said in a statement that immigration agents had valid warrants. The company said workers were detained, and it is helping provide them with legal representation. The farm also grows tomatoes and cucumbers.

"Glass House has never knowingly violated applicable hiring practices and does not and has never employed minors," the statement said. It is legal to grow and sell cannabis in California with proper licensing.

The state's Department of Cannabis Control said they "observed no minors on the premises" during a site visit to the farm in May 2025. After receiving another



complaint, the department opened an active investigation, according to a department spokesperson. Worker gravely injured

At least 12 people were injured during the raid and protest, said Andrew Dowd, a spokesperson for the Ventura County Fire Department. Eight were taken to St. John's Regional Medical Center and the Ventura County Medical Center, and four were treated at the

scene and released. Dowd said he did not have information on the extent of the injuries of those hospitalized. On Friday, about two dozen people waited outside the farm to retrieve the cars of loved ones and speak to managers. Relatives of Jaime Alanis, who has picked tomatoes at the farm for 10 years, said he called his wife in Mexico during the raid to tell her immigration agents had arrived and that he was hiding with others inside the farm.

"The next thing we heard was that he was in the hospital with broken hands, ribs and a broken neck," Juan Duran, Alanis brother-in-law, said in Spanish. It was not immediately clear

how Alanis was injured. A doctor at Ventura County Medical Center told the family that those who brought Alanis to the hospital said he had fallen from the roof of a building.

Alanis had a broken neck, fractured skull and a rupture in an artery that pumps blood to the brain, said his niece Yesenia, who didn't want to share her last name for fear of reprisal. He is on life support, she said

"They told us he won't make it and to say goodbye," Yesenia said, crying. The hospital did not immediately respond to requests for comment.

Confrontation with authorities Relatives and advocates headed to the farm about 50 miles (80 kilometers) northwest of downtown Los Angeles to try to find out what was going on, and began protesting outside.

Federal authorities formed a line blocking the road leading through farm fields to the company's greenhouses. Protesters were seen shouting at agents wearing camouflage gear, helmets and gas masks.

The billowing smoke drove protesters to retreat. It wasn't clear why authorities threw the canisters or if they released chemicals such as tear gas.

Ventura County fire authorities responding to a 911 call of people having trouble breathing said three people were taken to nearby hospitals. At the farm, agents arrested workers and removed them by bus. Others, including U.S. citizens, were detained at the site for hours while agents investigated.

The incident came as federal immigration agents have ramped up arrests in Southern California at car washes, farms and Home Depot parking lots, stoking widespread fear among immigrant communities.

Federal investigations

The Department of Homeland Security said in a statement Friday that the investigation into immigration and potential child labor violations at the farm is ongoing. No further details of the allegations were provided.

The agency said hundreds of demonstrators attempted to disrupt

the operations, leading to the arrest of four Americans.

"We will prosecute to the fullest extent of the law anyone who assaults or doxes federal law enforcement," Assistant Secretary Tricia McLaughlin said in a statement.

The project, with an estimated installed capacity of 11,000 MW, has been facing opposition from local communities, since the proposal first came up in 2017, due to concerns about displacement, livelihood loss, and environmental impacts.

Till recently, people were against the PFR survey. Now the state government has taken another route - engage in dialogue - highlighting the project's benefit and promise to hear the concerns of the people affected by the project.

The Siang Indigenous Farmers Forum, which is leading the movement against the dam project, claimed that it is meaningless, as people from 27 affected villages are "against" the project.

"Only 25 per cent of Riga is affected", SIFF president Lamok Padun said

He accused the state government of pushing for the project by forcing BJP workers from Riga village to agree to sign for the MoU. Padun disclosed that SIFF will hold a rally in protest against the development at Geku in Upper Siang district on July 14. (PTI)

Migrant youth lynched for sexually assaulting girls, curfew imposed in Roing



ITANAGAR, July 12: Curfew was imposed in Roing town in Arunachal Pradesh's Lower Dibang Valley district as tensions flared after a migrant youth from neighbouring Assam was lynched by a mob for allegedly sexually assaulting several girls, police said

The 19-year-old man, identified as Riaz-Ul Kurim from Bongaigaon, was taken into police custody on Friday after it came to light that he had allegedly sexually assaulted several girls of a school.

The parents of the girls, who filed a complaint with the school authorities, had nabbed the youth and thrashed him before police rescued him and took him into custody.

However, a mob barged into the police station, dragged the youth outside and beat him up. As he was rescued and taken to the hospital, they followed him and thrashed him again, ultimately leading to his death.

The youth used to work at a construction site near the school, police said.

So far, eight minor girls -- aged between six and nine -- have undergone medical examinations.

Lower Dibang Valley Superintendent of Police Ringu Ngupok said the boarders of a hostel of the school were allegedly sexually assaulted over the course of a week by the youth

The hostel lacked basic safety infrastructure as there were no grills on the windows and no functional locks on the sliding doors, leaving the children exposed and vulnerable, another senior police officer involved in the investigation said.

The accused had unhindered access to the hostel premises. The absence of secure barriers and proper oversight made it easy for him to approach the girls at night, he added

"A parent-teacher meeting was convened around 6.30 pm on Thursday, Around 8.30 pm, we received information that the parents and relatives of the victims had begun assaulting all the labourers working at the construction site. As tensions escalated, Kurim fled the scene and went missing. We rescued all 17 labourers and later

released them after recording their statements," the SP said. On Friday, Kurim was traced to

parents and local youths. He was thrashed before the police intervened and took him into custody, he said.

However, the mob followed, barged into the police station, forcibly removed the youth from custody, and assaulted him -- ignoring repeated appeals for calm from the police and even the local MLA, the SP said.

He was rushed to the hospital in a critical condition, but the mob followed again and beat him up. He succumbed to his injuries shortly thereafter.

A post-mortem examination was also conducted in front of a judicial magistrate at Roing district hospital.

Police have registered multiple cases related to child sexual abuse, and mob lynching, among others. Investigations are also underway against the school and hostel management for gross negligence and failure to ensure the safety of the children

A curfew has also been imposed in Roing town and additional security forces have been deployed to maintain law and order.

"The situation in Roing remains tense but is under control. The school's hostel has been shut down indefinitely by the district administration and parents have been instructed to withdraw their children and enrol them in nearby government or recognised private schools," the SP said.

A team from the Arunachal Pradesh State Commission for Protection of Child Rights (AP-SCPCR), led by chairperson Ratan Anya and member Nguarang Achung, is also currently in Roing to conduct an independent inquiry into the matter. (PTI)

Indian legal system facing unique challenges, says CJI Gavai

SUNDAY, JULY 13, 2025

HYDERABAD, July 12: The Indian legal system has been facing unique challenges and delays in trials can sometimes go on for decades, Chief Justice of India BR Gavai said on Saturday.

Delivering the convocation address at Nalsar University of Law, Hyderabad near here. Justice Gavai advised students to go abroad for studies on scholarships and not put pressure on family finances.

"Our country and legal system are facing unique challenges. Delays in trials can sometimes go for decades. We have seen cases where someone has been found innocent after spending years in jail as an undertrial. Our best talent can help us resolve the problems that we are facing," he said. The Chief Justice quoted Jed S Rakoff, a senior federal district judge in the United States in this connection. The American judge in his book, "Why the Innocent Plead Guilty and the Guilty Go Free: And Other Para-



doxes of Our Broken Legal System," had made the following remark. "Even though I conclude that our legal system is in bad need of fixing, I remain cautiously optimistic that my fellow (citizens) will rise to the challenge." This comment of the American judge was quoted by CJI Gavai.

Further, the Chief Justice advised the passing out graduates to seek mentors for the sake of integrity and

not for their power. On the "pressure to pursue a master's degree abroad", Justice Gavai said: "A foreign degree alone is not a stamp of your worth. Don't take this decision in the reflex of thought or under your peer pressure. What happens next? Years of debt, anxiety, career decisions made under financial burden.

He cited examples of some young graduates or lawyers taking loans of as much as ₹ 50-70 lakh for foreign education. In fact, a small portion of a big amount like ₹ 50-₹ 70 lakh can be used as an investment to start independent practice or build an office chamber. The young lawyers can go abroad for studies at a later stage in life when they are stable, he said.

The growing trend of going abroad also reflects a structural issue, signalling a lack of confidence in the state of postgraduate legal education and research in our country, Justice Gavai said.

Many who study abroad come back with renewed passion and fresh perspectives, but when they return, they often find institutions unwelcoming, under-resourced or close to new ideas. There are few structured pathways for postdoctoral research, limited funding for early career scholars and opaque hiring processes that discourage even the most committed

"This must change if we want to keep our best minds or bring them back. We must build nurturing academic environments, offer transparent and merit-based opportunities, and most importantly, restore dignity and purpose to legal research and training in India," he said.

On issues of mental pressure faced by legal professionals, he said the working hours are long, expectations are high and the culture sometimes is "ruthless"

'You will feel pressure, not just to succeed but also to appear to be successful. Many hide their struggles. I urge not to," he said.

It is not just enough to celebrate India's legal legacy; its future should be taken care of. The future depends on how researchers, young faculty and lawyers and scholars are treated.

6 dead, 8 injured in building collapse in Delhi; rescue operation underway

NEW DELHI, July 12: Six people, including a two-year-old girl, died and eight sustained injuries when a four-storey building collapsed in the Welcome area of northeast Delhi on Saturday morning, an official said. The bodies of the owner of the building, his wife, two sons and two others were retrieved from the debris and sent to GTB Hospital, he said.

Eight people have been hospitalised, while attempts are underway to rescue those still trapped under the rubble. Multiple agencies, including the NDRF, have been deployed for rescue operations, the official said.

A senior police officer said, "Around 7.04 am on Saturday, we received information regarding the collapse of a four-storey building near Idgah, Welcome. When the police team reached the spot, they found that three storeys of the building had collapsed.'

"So far, eight injured persons have been rescued -- seven have been shifted to JPC Hospital and one to GTB Hospital for treatment. All the listed missing persons have been rescued; howowner of the building, Matloob, lived in the building with his family members. The ground floor and first floor were unoccupied. The building opposite also sustained damage."

Matloob, 50, his wife Rabia, 46, and two sons -- Javed, 23, and Abdulla, 15 -- died in the incident. Two more, including Zubia, 27, and her two-year-old daughter Fozia, also perished.

The injured included Matloob's two other sons -- Parvez, 32, his wife Siza, and their oneyear-old son Ahmad, 21, and Naved, 19.

Govind, 60, his brother Ravi Kashyap, 27, and their wives Deepa, 56, and Jyoti, 27, who lived in the opposite building, were also hospitalised with injuries. Anees Ahmad Ansari, another person from the opposite building, said he too sustained minor injuries in the incident.

On Friday, the World Heritage Committee (WHC) at its 47th session held in Paris, inscribed India's serial nomination consisting of 12 forts, representing extraordinary fortification and military system

on the coveted list. While the journey from the nomination to the inscription wasn't easy for Team India, sustained efforts led to a crowning triumph at UNESCO.

Ambassador and Permanent Representative of India to UN-ESCO, Vishal V Sharma, delivered the statement on New Delhi's behalf after the inscription was announced.

"This is a historic day, not only for India, but especially for Marathi people all over the world. The rich cultural heritage of the Marathas has been honoured by the recognition of its Outstanding Universal Value by the international community," he said.



In a telephonic interview with PTI shortly after delivering the remarks at the UNESCO Headquarters in Paris. Sharma shared India's success story and what it took to earn the prestigious recognition.

"It was excellent teamwork, but it was not very easy to get the Maratha Military Landscapes inscribed," he recalled.

"I thank the government of Maharashtra, the Indian Culture Ministry, the Archaeological Survey of India (ASI), and the Ministry of External Affairs. We had to do coordination with 20 different countries, and it's an excellent example of teamwork," Sharma told PTI

over the phone.

Sharma said the Indian nomination had received a "deferral recommendation" by the advisory body, ICOMOS. A deferral recommendation means the advisory body does not want it to be inscribed.

The Paris-based International Council on Monuments and Sites (ICOMOS) is one of the key advisory bodies to UNESCO, and its experts visit the nominated sites. He said Team India "pointed out the mistakes, factual errors from the advisory body's side".

The nomination for the UN-ESCO tag was for the 2024-25 cycle.

The 'Maratha Military Landscapes' was developed between the 17th and 19th centuries.

The 12 components of the inscribed property are - Salher Fort, Shivneri Fort, Lohgad, Khanderi Fort, Raigad, Rajgad, Pratapgad, Suvarnadurg, Panhala Fort, Vijay Durg, Sindhudurg in Maharashtra and Gingee Fort in Tamil Nadu.

These components, distributed across diverse geographical and physiographic regions, showcase the strategic military powers of the Maratha rule, the Indian officials

There are more than 390 forts in Maharashtra, out of which only 12 forts were selected under the Maratha Military Landscapes of India; of these, eight forts are protected by the Archaeological Survey of India (ASI), the ministry earlier said.

Sharma said the advisory body was "primarily concerned" as to what the criteria for selection were, and why not more forts.

"Then we had to justify that there was a hierarchy of system, primary, secondary and tertiary forts. And, these 12 were the main ones, and then we explained to various other Member States,' he said.

The Indian envoy to UNESCO also said, "There isn't much awareness" about the forts in western and southern parts of India vis-a-vis those in Rajasthan. "So, we took this opportunity to promote Maharashtra and Maharashtra tourism also", among the international community.

And, Chhatrapati Shivaji Maharaj's royal seal 'Raj Mudra' was circulated to explain to them the philosophy of the Marathas --- the well-being of the people, h e added. (PTI)

Six Bangladesh nationals, two Underground cadre arrested **Indian touts arrested in Tripura**

Bangladeshi nationals and two Indian touts have been arrested in Tripura for crossing over the international border illegally, police said on Saturday.

BSF personnel who were conducting routine checking in North Tripura's Inter-state bus terminal at Dharmanagar on Friday evening detained four suspected Bangladesh nationals and two Indian citizens who guided them to reach Dharmanagar.

All six persons were handed over to the police authority by the BSF for taking necessary legal action.

"During preliminary interrogation, it was revealed that out of six persons, four are Bangladesh citizens. Two others who allegedly guided the Bangladesh citizens to initiated. (PTI)

Tripura exported 73.15 MT pineapple to Gulf nations in last seven years: Agriculture Minister

HT Correspondent AGARTALA, July 12: Tripura's Agriculture and Farmers' Welfare Minister Ratan Lal Nath on Saturday informed that to boost the income of pineapple cultivators, the department is planning to set up a new fruit processing centre under the PPP model in Nalkata under North District of the state which shares interstate border with Assam.

He also stated that in the last seven years, the department has exported 73.15 metric tonnes (MT) of pineapple to Dubai, Oman, and Qatar.

Minister Nath said this while addressing the Pineapple Festival at Geetanjali Auditorium in Kumarghat of Unakoti District.

The Minister also informed that the state government is working to obtain the GI tag for Sidol Shutki (fermented fish), Sabri banana, and several other products.

"After our government came, we declared Queen pineapple as the state fruit. Queen pineapple already has a GI tag nobody can copy it. Our main aim is to ex-



pand the production and market of pineapple. We need to produce it more, and for that, such events are being organised. We have also organised buyers and sellers meet on organic products, which was held for the first time for various items like pineapple, bird's eye chilli, and ginger all of which are organic," he said.

The Minister stated that in the state, 3.65 lakh kani of land is used for fruit cultivation, of which 74,000 kani is used for ineapple.

"Of this, Kew variety is cultivated in 53,700 kani of land in Dhalai, Unakoti, and North Districts, while Queen variety

is cultivated in 22,000 kani. After our government came to power in 2018, the price of pineapple was around \gtrless 8 to \gtrless 9. Now. it has increased to around Rs 40 or more. Our main aim is to help farmers and increase their income. The Union DoNER Ministry is working to make Queen pineapple a global brand. We have held meetings with Union Minister Jyotiraditya Scindia twice and are planning to undertake a scheme worth ₹ 132 crore," said the minister.

The Agriculture Minister also informed that from 2018 to 2025, a total of 73.15 MT of pineapple was exported to Dubai, Oman, and Qatar.

In addition 4.40 MT of jackfruit were exported to America, and 30 MT of ginger and 17 MT of betel leaf were exported to Bangladesh.

"Our main aim is to strengthen the farmers so that the economy of our state grows," he added.

"We are also going to take a decision to set up a fruit processing factory under the PPP model in Nalkata," he informed.

I thought we'll be lucky to have her in 'Heads of State': Ilya Naishuller on Priyanka Chopra Jonas



NEW DELHI, July 12: Priyanka Chopra Jonas was a joy to work with and the only choice for the female lead in "Heads of State", says filmmaker Ilya Naishuller about his latest action-comedy, which features the Indian actor with John Cena and Idris Elba. The Russiaborn musician-filmmaker, best known for directing Bob Odenkirk in action thriller "Nobody" as well as sci-fi film "Hardcore Henry", said as soon as they thought about approaching Priyanka for the role of Noel Bisset, an MI6 agent, everything "made total sense". "She's the only actress I talked to for this movie, I'll be honest. I was just like, 'If the call goes, we'll be lucky to have her'. And I remember she charmed me in about 45 seconds flat over a Zoom call.

"She's wearing a big, homely sweater and just chilling on her couch. And we started talking, and I immediately understood we have quite a bit in common," Naishuller told PTI in an interview. The director said he could see parallels between his journey in Hollywood with the way Priyanka, an already established star in India, made a space for herself in the US.

"She went from being so big in India to being like, 'You know what? I want to risk it and see what happens. I want to go out there and be ambitious and try to crack America'. It is a very difficult thing to do. It always is, no matter how big you are at home, and the fact that she went there and started that path, I was like, I deeply respect that and I admire that. It's courage," he said. Naishuller said while he felt good about their shared "commonalities", he realised that he was

charmed by her presence. "I just realised either she is playing the charm or she is that charming and that's her. And both things work, because one proves that she's a great actress, as I already knew, or she can be a great fun person to hang around with... And when we got to work, I was like, 'That was her.' She is that charming, fantastically warm person." The filmmaker said Priyanka was always prepared and curious throughout the shooting of the movie that revolves around a newly-elected US President (Cena) and his more seasoned British counterpart, played by Elba. They don't get along well but have to unite to fight a common enemy that wants to derail an important

summit. They find an ally in Priyanka's Bisset. "Every time we finish a scene and there's a relight, she'd pull up an apple box, sit right and be like, 'How's it going? What are you guys doing?' And that's the kind of vibe I really enjoy. So to balance out Idris Elba and John Cena, she had to be there. She was always like, 'Well, I'm a little bit of a third wheel'. I'm like 'It's a tricycle'." Naishuller said grew up on Jackie Chan

Natshuffer said grew up on Jackie Chan movies and wanted to bring the same energy to "Heads of State", currently streaming on Prime Video. "If you surround violence with comedy, the violence becomes punchier and you don't need to do that much to elicit a good chuckle. And it's the first time I've been trying to go for a movie that is outright trying to make you laugh because 'Nobody' was very reserved.

"There's a lot of chaos in this movie... I'm just trying to understand how to fit all that together...This is the first movie where I had to cut jokes. We had too many good jokes... When the bullets are flying, our guys are terrified, and that's actually funnier than them taking bullets over here and just saying wise lines. It's a ridiculous movie, but I wanted a grounded ridiculous movie, if that makes sense." (PTI) Will not blame anybody, need to solve it together: Ajay Devgn on Diljit Dosanjh controversy

MUMBAI, July 12: When there are two differing points of view, you need to sit down and resolve issues through conversation, actor Ajay Devgn said on Friday while responding to the controversy surrounding Diljit Dosanjh's film "Sardaar Ji 3", which has drawn criticism for featuring Pakistani star Hania Aamir.

The Punjabi film courted a huge controversy last month after Dosanjh shared the trailer of "Sardaar Ji 3", which made its debut in overseas territories on June 27 and skipped release in India.

Many social media users have called for a ban on Dosanjh, while politicians and trade unions like the All Indian Cine Workers Association (AICWA) and the Federation of Western India Cine Employees (FWICE) have criticised the Punjabi actor-musician for collaborating with Aamir in the wake of the Pahalgam terror attack.

"I don't know where the trolling comes from (or) what is right and what is wrong. I'm not in his shoes to comment on that. He would've had his problems, and people are thinking from their point of view. "So, when you've two different points of view, then you can sit and solve it out together. I'll not blame anybody or say that, this is right or wrong; they need a conversation, Devgn told reporters at the trailer launch press conference of "Son of Sardaar 2". At the event, Devgn was also

asked about the ongoing language row in Maharashtra. The controversy started after the Maharashtra government made it compulsory for state-run primary schools to teach Hindi as a third language, apart from English and Marathi.

"The only answer I'll give you about the language thing which is going on is 'Aata Maaji Satakli'," Devgn said, referring to the popular dialogue from his hit "Singham" franchise.

The "Raid 2" actor said he is thrilled about returning to the comedy genre after six years with "Son of Sardaar 2".

Venice Film Festival to screen 4K restored version of Bimal Roy's 'Do Bigha Zamin'

MUMBAI, July 12: The 2025 edition of the Venice Film Festival is set to showcase a 4K restored version of "Do Bigha Zamin", the 1953 classic directed by acclaimed filmmaker Bimal Roy. The announcement coincides with the legendary filmmaker's 116th birth anniversary.

Presented under the Venice Classics section, "Do Bigha Zamin", titled "Two Acres of Land" in English, has been selected among a distinguished lineup of restored cinematic masterpieces, which also includes "Matador" by Pedro Almodovar, "Roma Ore 11" by Giuseppe De Santis, "Przypadek" by Krzysztof Kieslowski and "Lolita" by Stanley Kubrick.

The screening will be presented by Roy's children --Rinki Roy Bhattacharya, Aparajita Roy Sinha, and Joy Bimal Roy -- along with Shivendra Singh Dungarpur, director of the Film Heritage Foundation.

The restoration is a collaborative effort between the Film Heritage Foundation, The Criterion Collection, and Janus Films.

Acclaimed lyricist and filmmaker Gulzar welcomed the announcement, calling the film "historic." "It's amazing that 'Do Bigha Zamin' is restored and will be shown in Venice. This film is historic as it changed the way films were made in India. After Chetan Anand's 'Neecha Nagar' which won an award at the Cannes Film Festival, this was the second Indian film to win at the Cannes Film Festival and receive international recognition. "The most important element is that all his films right from the Bengali ones which he made and

the Hindi films which he made, all these films were based on literature. Not many people know that 'Do Bigha Zamin' is from a poem by Rabindranath Tagore, which was also called 'Do Bigha Zamin'. The script was done by Salil Choudhury," Gulzar said, recalling the time when he started working with Roy's 1961 production "Kabuliwala".

The cinema icon said he has fond memories of the time. "People would say that Bimal-da was like a married print. In those days, the picture and sound negatives were separate and when they were brought together optically to make the release print, it would be called a married print. Bimal-da would shoot two shifts in a day -7 am to 2 pm and 2 pm to 10 pm and would then sit in the editing room working till late night at Mohan Studios. People would say that he is married to films. Bimal Roy was the coolest director I have ever seen. I learnt not only filmmaking from him, but the art of patience and stamina," he added.

Starring Balraj Sahni and Nirupa Roy, "Do Bigha Zamin" is considered an important film in the early parallel cinema of India.

The film, which captured the plight of a poor farmer struggling with industrialisation, was based on Rabindranath Tagore's Bengali poem "Dui Bigha Jomi" and "Rickshawalla", a short story written by composer Salil Chowdhury.

Dungarpur said he was introduced to the works of Bimal Roy when he was working under Gulzar. "When I was working as an assistant to Gulzarsaheb, he would often speak about his guru Bimal Roy. This spurred me to watch all his films right from the time he was a cameraman on P C Barua's 'Devdas' to his first Bengali film as a director 'Udayer Pathey' to 'Do Bigha Zamin'.

"In his films I was struck by the poetic visuals, the silences, the deep humanism and compassion that he showed in the social themes of his films that highlighted the plight of the marginalized, the issues of migrant labour, and the urban-rural divide that are still so relevant today. For me 'Do Bigha Zamin' changed the face of Indian cinema that brought filmmakers out of the studio to begin shooting on the streets," he said.

Dungarpur said he is glad to collaborate with The Criterion Collection and Janus Films to restore other classics of Bimal Roy such as "Devdas", "Madhumati" and "Bandini".

The family of Bimal Roy said the premiere of "Do Bigha Zamin" at the Venice Film Festival is a "dream come true for us".

"This would not have been possible without the tireless efforts of Shivendra Singh Dungarpur of Film Heritage Foundation and Fumiko Takagi of the Criterion Collection. Our heartfelt thanks to both of them for their unwavering dedication to restoring and celebrating cinema. 'Do Bigha Zamin' is especially fitting for this prestigious platform, as it holds a unique connection with Italian cinema," Rinki Roy Bhattacharya, Aparajita Roy Sinha, and Joy Bimal Roy said in a joint statement. Crystal Palace demoted by UEFA from Europa League

GENEVA, July 12: Crystal Palace chairman Steve Parish says the decision to cut the club from the Europa League is "a bad day for football" and "a ter-

rible injustice." UEFA demoted Crystal Palace to the third-tier Confer-ence League on Friday because of the English cup winner's ownership ties to French club Lyon through American busi-nessman John Textor.

Textor's 43% minority stake in Palace — even though he had limited decision-making influence there — while he owned Lyon outright, conflicted with UEFA rules on multi-club ownership designed to protect the integrity of its competitions.

"We're devastated," Parish told Sky Sports. "It's a bad day for football. It's a terrible injustice. We've been locked out of a European competition on the most ridiculous technicality. Supporters of all clubs should be devastated for us.

"Everyone knows we're not part of a multi-club setup. We don't share any staff. I think we've shown John had no influence over our club. This is a lu-dicrous decision. We will ask the appeal court to listen to our argument." UEFA said its club finance panel accepted Lyon's entry into the second-tier Europa League instead. Lyon qualified on merit by placing sixth in Ligue 1 this season but its entry was in jeopardy because of persistent financial turmoil.

The decision follows the financially troubled club being reprieved this week from demotion to Ligue 2.

UEFA's decision came after several weeks of uncertainty for the south London club which has taken the shine off the first qualification for European competitions in its history. Palace beat Manchester City in the FA Cup final in May.

Palace said it will challenge the UEFA ruling at the Court of Arbitration for Sport. A fasttrack case would need to be held within about one month before Conference League qualifying playoffs. Textor has been an increasingly controversial figure in global soccer, also owning Brazilian club Botafogo and Belgium's Molenbeek while being linked with a failed bid to buy Everton.

Spain levelled within four minutes, led from the 49th, and added Esther González's tournament-leading fourth goal in stoppage time.

Still, Spain had enough problems in defense handling the Italians, who had 13 attempts on goal, to give host Switzerland

some hope for their quarterfinal in one week.

Italy finished runner-up to Spain in the group because Portugal, which was third in the standings at the start of play, lost to Belgium 2-1 when needing a lopsided win.

Norway awaits Italy in the first quarterfinal on Wednesday in Geneva, and it will be Spain-Switzerland two days later in Bern.

NEW YORK, July 12: Spanish league president Javier Tebas rejected Real Madrid goalkeeper Thibaut Courtois' plea to postpone the team's 2025-26 opener to give players time to rest following the expanded Club World Cup.

Real Madrid was eliminated with a 4-0 semifinal loss to Paris Saint-Germain on Wednesday and will have a 41-day offseason before their La Liga opener against Osasuna on Aug. 19.

Tebas said the decision not to move the opener was made by the Spanish Football Federation and La Liga agreed with it. He said players were to have 21 days off and 21 days of preseason training.

"I believe that they will have 20 days to rest instead of 21 and no other leagues like the Premier League for Chelsea or the French Ligue 1 for PSG are changing the games," he said through a translator during a Friday interview with The Associated Press.

"So I don't believe that we should change the calendar for that reason, especially thinking that it's a matter of one day. Real Madrid played 68 competitive matches in a season that started Aug. 18: 38 in the league, 14 in the Champions League, six each in the Copa del Rey and the Club World Cup, two in the Spanish Super Cup and one apiece in the European Super Cup and Intercontinental Cup. Djokovic says he definitely plans to play at Wimbledon at least one more time

LONDON, July 12: Novak Djokovic wanted to make this much clear after losing to Jannik Sinner in the Wimbledon semifinals Friday: This was not a farewell performance. Djokovic intends to compete again at the All England Club.

"I'm not planning to finish my Wimbledon career today," the 38year-old Djokovic said. "I'm planning to come back definitely — at least one more time.

His 6-3, 6-3, 6-4 defeat at Centre Court against the No. 1-ranked Sinner put an end to Djokovic's latest attempt to tie Roger Federer's men's record of eight championships at Wimbledon and to claim an unprecedented 25th Grand Slam title overall.

Djokovic was not fully able to compete at his best level, two days after taking what he described as a "nasty" and "awkward" fall in the last game of his quarterfinal victory.

"I don't want to talk in details about my injury and just whine about not managing to play my best," Djokovic said Friday. "I do feel disappointed that I just wasn't able to move as well as I thought or hoped that I would."

He was visited by a trainer before the third set for treatment on his upper left leg, won the next three games and was a point from a 4-0 lead, but lost six of the last seven games. "We all saw, especially in the third set, that he was a bit injured," said Sinner, who will meet No. 2 Carlos Alcaraz in Sunday's final. "He's been in a very difficult situation.

Italy and Burns find new identity

In the group stage, the team was clubbed with France, Isle of Man, Luxembourg and Turkey.

It was a massive dream for a team that played its maiden T20 International in 2019 against Germany. Clearly, there was a lack of pedigree and resources but they dared to dream.

They made an early charge with a 77-run win over Luxembourg in Rome and followed that up with a five-wicket victory over France and a seven-wicket drubbing of Isle of Man.

The nine-wicket win over Turkey propelled them to the final against Romania which they won by a massive 160-run margin in June 2024

Alcaraz will face Jannik Sinner at Wimbledon in a rematch of the French Open final



LONDON, July 12: First, Carlos Alcaraz did his part to set up The Grand Slam Rematch The Tennis World Wanted, barely averting a fifth set and getting past Taylor Fritz 6-4, 5-7, 6-3, 7-6 (6) in the semifinals Friday to move within a victory of a third consecutive Wimbledon championship.

Then it was Jannik Sinner's turn keep up his end of the bargain, and he overwhelmed a not-fully-fit Novak Djokovic 6-3, 6-3, 6-4 to get to the final at the All England Club for the first time.

So get ready for Sunday: No. 1 Sinner vs. No. 2 Alcaraz for the title on the grass courts of Wimbledon, exactly five weeks after their riveting and remarkable final on the red clay of the French Open.

Sinner grabbed a two-set lead in that one, then held a trio of match points, before Alcaraz came all the way back to win after 5 hours, 29 minutes filled with brilliance from both

Asked to reflect on what happened in Paris, Alcaraz began by saying, "Probably the best," then cut himself off.

"I mean, probably,' no. It was the best match that I have ever played so far. I'm not surprised he just pushed me to the limit. I expect that on Sunday — just to be in the limit, to be on the line. Just going to be a great day, a great final. I'm just excited about it," Alcaraz said, speaking for anybody who might have paid any attention to that classic at Roland-Garros.

"I just hope not to be 5 1/2 hours on court again," he added with a smile. "If I have to, I will. But I think it's going to be great." Who wouldn't expect this one to

be?

"Hopefully it's going to be a good match, like the last one," Sinner said. "I don't know if it'll get better, because I don't think it's possible.

India lost Yashasvi Jaiswal (13), Karun Nair (40) and skipper Shubman Gill (16) on day 2 to be 145/3 and trailing the hosts by 242 runs in the first innings.

"It was fantastic, a typical KL Rahul innings where he had to grind it out. It was a fiery spell from Jofra Archer — especially that first spell where he clocked over 150 kmph, with steep bounce and a bit of swing early on," Kumble said on JioHotstar. "KL countered all of that brilliantly. He was clinical in his approach and looked in control. It was a very disciplined and mature knock, and I'm sure he'll be satisfied with how he played."

Third-year Major League Cricket league hopes to keep growing the sport in US

OAKLAND (USA), July 12: Australian cricket legend Adam Gilchrist had barely made it inside the Coliseum entrance when dozens of fans swarmed him, and he obliged every request for photos and autographs.

Major League Cricket's week-long stop in the Bay Area last month had top officials in the sport thrilled with how the old Oakland Coliseum provides an ideal spot for the sport to thrive --- even for major international competitions like World Cup and exhibition matches ahead of the 2028 Los Angeles Olympics, when the sport makes its return for the first time in 100 years.

"I've been really pleased with the way it's been received," Gilchrist said. "Clearly, the South Asian community up to India, Pakistan, Sri Lanka, that region, it's a religion there. And given the diaspora here and the number of South Asians in the community, I figured that they would have a keen following. It's great to see new faces to cricket."

Attendance for the opening weekend totaled more than 25,000 as the third-year, six-team league kicked off its season with great support in the Bay Area. Then, cricket scored another major victory June 29 in Dallas when the Texas Super Kings against MI New York drew a sellout of more than 6,100 with a standing-room the largest regular-season attendance at that venue. It was the second-highest total for the sport at that venue behind the 2023 Championship Final.

growing cricket in the U.S. just a few months into his tenure, which has included a move from Antigua in the West Indies to Dallas. He dreams of the day when all ages and skill sets are involved.

Curtly Ambrose, who retired 25 years ago, coaches at the highest levels at home in Antigua. He is hopeful cricket will catch on as a popular sport in the U.S. — and is encouraged by the support in the San Francisco area.

"Very, very unique because where I come from there are always traditional cricket stadiums. This is different, baseball stadium, drop-in surfaces. That is something that doesn't happen in cricket normally but the support is good and I have a feeling that this will get bigger and better.'

In a city that has lost its three major professional sports teams over the past

five years, cricket's Oakland stop certainly brought a festival-like atmosphere to the Coliseum — devoid of baseball for the first time since 1968 after the Athletics relocated to West Sacramento ahead of a planned move to Las Vegas. The dual-sport Coliseum — where the

Oakland Roots soccer team now plays — is already a planned site for training and exhibitions ahead of the Olympics for nations looking to practice and get acclimated on U.S. soil.

"It's probably really the best cricket facility almost in the Americas because it's so iconic, so historic and so well located in terms of the wider Bay Area where there are all these cricket fans," said Grave, who had initially hoped to bring cricket to the venue several years ago but couldn't make it work with the A's. bowl full quota of overs on all five days of Tests LONDON, July 12: After seeing just 75 overs being bowled on day 2 of the third Test between Ben Stokes' side and India at Lord's an exasperated former England captain Michael Vaughan wanted teams to mandatorily bowl full quota of 90 overs on all five days

of a match. India bowled 83 overs on day 1 of the Test, while less than 75 overs could be squeezed in on day 2, leaving a combined shortfall of nearly 23 overs over two days.

Vaughan said penalising the teams for slow over-rate was not good enough as the players were 'quite rich" and won't be affected by the fines imposed on them. "I don't' think fines work.

think these lads (cricketers) are quite rich. I don't think the cash is going to affect them," opined Vaughan, who played 82 Tests and scored more than 7.500 runs across formats, on BBC Sport.

He was at a loss to understand how teams were unable to complete the full quota of overs on the first four days when they managed all 90 overs on the fifth and final day

"(It's) been a problem for Test match cricket for a while. I know it's hot. I know we've had a few injuries. But when we get to the fifth day, we have to bowl the 90 overs. I've no idea why on day one, two, three and four we can see the game played at a snail's pace," he said. (PTI)
