Himanta, Army deny connections with air strike along India–Myanmar border

HT Correspondent DIBRUGARH/GUWAHATI, July 13: A senior commander of the banned United Liberation Front of Assam (Independent), ULFA(I), was reportedly killed along with two brigadiers and at least 19 others injured in a suspected aerial strike along the India-Myanmar border in the early hours of Sunday, triggering denials from both the Assam government and the Indian Army.

In a press release issued on Sunday, ULFA(I) claimed that the attack began between 2:00 AM and 4:00 AM and targeted several of its mobile camps spread across the Nagaland–Myanmar and Arunachal-Myanmar international borders.

The group alleged that over 150 drones-allegedly of Israeli and French origin—were deployed in the offensive, which it termed a surprise aerial strike. The outfit

HT Correspondent JORHAT, July 13: A retired District Agriculture Officer (DAO), Dr Nitumoni Gogoi, has lodged a formal complaint with the Jorhat Police, alleging that forged appointment letters bearing his name and signature have been circulated for posts in the Agriculture Department and Assam Agricultural Uni-

versity (AAU). According to the FIR filed at Jorhat Police Station, the fraudulent documents, dated July 12, 2025, falsely list Dr Gogoi as the issuing authority in his former capacity as DAO. Jorhat.

Dr Gogoi clarified that he retired as DAO, Golaghat on December 31, 2024, and had only briefly held the post in Jorhat earlier.

Speaking to this newspaper, Dr Gogoi said he became aware of the fake appointment letters through a reliable source, who shared copies with him.

The documents allegedly appointed three individuals to posts at AAU and the District Agriculture Office in Nalbari.

The positions listed were Assistant Laboratory Bearer at DAO, Nalbari; Junior Soil Tester, Soil

Department, AAU, Jorhat; and Executive Soil Ranger Assistant, Soil

Department, AAU, Jorhat. Dr Gogoi pointed out several discrepancies in the forged documents, including the incorrect usage of "District Agricultural Officer" instead of the official desig-

nation "District Agriculture Officer" and the unauthorized use of a DAO's authority to issue government appointments.

He also questioned how a state Agriculture Department official could appoint staff to a university like AAU, which follows an entirely separate recruitment procedure.

"A serving DAO doesn't have the authority to appoint anyone, let alone issue appointments for a university. Moreover, I am retired. This is clearly a case of forgery, and I hope a proper investigation will uncover those behind this racket," Dr Gogoi stated.

The appointment letters reportedly list candidates from Tezpur, Golaghat, and Sivasagar. Police are expected to launch an

inquiry into the matter based on Dr Gogoi's FIR.

challenging conditions: AI Pilots' grouping ICPA MUMBAI, July 13: The Indian Commercial Pilots<sup>3</sup> Association (ICPA) on Sunday said the crew of the AI

171 flight that crashed last month acted in line with their training and responsibilities under challenging conditions, and the pilots should not be vilified based on conjecture.

Strongly rejecting insinuations in some quarters about pilot suicide, the association representing narrow-body pilots of Air India stressed that until the official investigation is concluded and the final report is published, any speculation is unacceptable and must be condemned

It may be noted here that the Airline Pilots' Association of India also had on Saturday demanded a fair and fact-based probe into the Air India plane crash as it claimed that the tone and direction of the investigation into the Air India plane crash suggests a bias towards pilot error.

ICPÅ is the narrow-body fleet pilots' body at Tata Group-owned Air India.

The Aircraft Accident Investigation Bureau (AAIB) has released its preliminary report into the fatal Boeing 787-8 plane crash on June 12 that killed 260 people. The report has found that the fuel supply to both engines of Air India flight AI171 was cut off within a second of each other, causing confusion in the cockpit and the airplane plummeting back to the ground almost immediately after taking off.

The 15-page report says that in the cockpit voice recording, one unidentified pilot asked the other why he had cut off the fuel, which the other denied.

In its preliminary report on the crash of Air India's



AI 171 flight from Ahmedabad to London Gatwick on June 12 that killed 260 people, the Aircraft Accident Investigation Bureau (AAIB) on Saturday said the fuel switches of the Boeing 787-8 aircraft were cut off soon after takeoff.

"In the cockpit voice recording, one of the pilots is heard asking the other why did he cutoff. The other pilot responded that he did not do some," the report said. ICPA on Sunday said it is deeply disturbed by speculative narratives emerging in sections of the media and public discourse-particularly the reckless and unfounded insinuation of pilot suicide.

"There is absolutely no basis for such a claim at this stage, and invoking such a serious allegation based on incomplete or preliminary information is not only irresponsible -- it is deeply insensitive to the individuals and families involved," (CONTD. ON PAGE-2)

Saha said the Ministry of Tourism has sanctioned Rs 98 crore for developing a world-class spiritual spot at Bandower.

According to the plan, idols of 51-Shakti Peethas will be installed at the site, spreading over 15 acres of land, he said.

The spiritual site will have an interpretation centre, the biggest idol of Nataraj in the world, a cafeteria, a sky bridge and cottages for accommodation. The proposed facilities will have a capacity of managing 7000 pilgrims at a time, he said.

Hoping that the proposed replica of the 51-Shakti Peethas will be an important spiritual spot in the country, the chief minister said a person can't visit all the Shakti Peethas, spreading across the Indian sub-continent- Nepal, Sri Lanka, Pakistan and Bangladesh. Saha added that the prime min-

ister will be invited to consecrate the 51-Shakti Peethas, which is scheduled to be ready in the next one and a half years.

He said the Asian Development Bank (ADB) has already sanctioned Rs 18 crore to develop Kasbewari Kali Bari in Sepahaijala and the ADB is likely to fund a facelift project for Chaturdash Devta temple in West Tripura.

Asserting that tourism plays a significant role in boosting the state's gross domestic product, the chief minister said the proposed replica of 51-Shakti Peethas will not only promote spiritual tourism but also strengthen Tripura's growth engine.

The chief minister said the government will provide security to tourists and is set to appoint over 6.000 special executives to assist the state force in maintaining law and order. (PTI)

Phase-3 dengue vaccine trial enrolment to end by October: ICMR Currently, there is no antiviral ment of about 10,500 participants treatment or licensed vaccine against dengue in India.

The results of the Phase-1/2 trial has shown no safety concerns for the one-shot vaccine, NIE Director Dr Manoj Murhekar said.

"The participants enrolled in the Phase- III trial will be followed up for two-years. This trial will evaluate the efficacy of this tetravalent dengue vaccine," Dr Murhekar said

The multi-centre, double-blind, randomised, placebo-controlled phase-III trial was launched in August last year to evaluate the jab's efficacy, safety and, long-term immunogenicity.

The first participant in this trial was vaccinated at the Pandit Bhagwat Dayal Sharma Post Graduate Institute of Medical Sciences

(PGIMS), Rohtak last year. The development of an effective vaccine is complex due to the need to achieve good efficacy for all four serotypes. The dengue virus

has four serotypes, 1-4, with low cross-protection against each other, meaning individuals can experience repeated infections, Dr Murhekar said

In India, all four serotypes of dengue virus are known to circulate or co-circulate in many re-

gions The Union Health Ministry in a statement earlier had said that the tetravalent dengue vaccine strain (TV003/TV005), originally developed by the National Institutes of Health (NIH), USA, has shown promising results in clinical trials in Brazil.

Dengue is a major public health concern in India, ranking among

the top 30 countries with the highest incidence of the disease.

The global incidence of dengue has been steadily increasing over the past two decades, with more than 129 countries reporting dengue viral disease by the end of 2023, according to the World Health Organisation (WHO). In India, approximately 75-80 per cent of infections are asympto-

matic, yet these individuals can still transmit the infection through the bite of Aedes mosquitoes.

Among the 20-25 per cent of cases where symptoms are clinically apparent, children are at a significantly higher risk of hospitalisation and mortality. In adults, the disease can escalate into severe conditions like dengue hemorrhagic fever and dengue shock syndrome. (CONTD. ON PAGE-2)

# **Polish major among 6 firms in fray for Deocha Pachami coal mining contract: WBPDCL**

KOLKATA, July 13: The West Bengal Power Development Corporation Ltd (WBPDCL) is hopeful of finalising the appointment of a mine developer and operator (MDO) soon for underground mining at the mega Deocha Pachami coal block in Birbhum district, with six companies, including one from Poland, already expressing interest through a global tender process, a senior official said.

The world's second-largest coal mining project is expected to attract an investment of Rs 35,000 crore over its project period, according to state government estimates.

"The global expression of interest (EoI) process for underground coal mining has commenced, with six participants expressing interest, including one from Poland. We are working closely and expect to complete the process soon," WBPDCL Chairman and Managing Director P B Salim told PTI.

WBPDCL Director (Mining) Chanchal Goswami said the EoI was part of the broader global tender floated on December 20, 2024, along with the geological report and draft notice inviting tender (NIT).

"We are working with these six bidders to take forward the tendering process, with India's leading underground mining firms, and a Polish major, participating," he



said The list of bidders who have shown initial interest includes JMS Mining Pvt Ltd, Gainwell Commosales Pvt Ltd, Minop Innovative Technologies Pvt Ltd, Minsol Ltd, Maheshwari Mining Pvt Ltd, and JSW SA, the largest underground coal mining company in Poland.

"In parallel, we are also awaiting the expert study report from the National Institute of Rock Mechanics (NIRM), Bengaluru, given prepare a parallel detailed project the complex geological challenges at Deocha Pachami. Despite market scepticism over The Deocha Pachami coal private sector participation in un-

lerground mining due to high technical risks and capital requirements, WBPDCL's recent pilot project for basalt rock removal has attracted strong interest.

"Basalt rock extraction has already begun. The government started bidding with a 15 per cent revenue share, but it went up to 71.5 per cent -- this was unimaginable," the official said.

The pilot project commenced after a ceremonial 'bhoomi puja' in February 2025. It spans an initial 12 acres, with plans to expand to 326 acres

Meanwhile, the tender process has attracted scrutiny, with the CPI(M) demanding a judicial probe into the ballast mining contracts, citing concerns over trans-

Separately, the state government is exploring underground coal gasification for around 30 per cent of the block where conventional mining may not be feasible. The remaining 70 per cent is planned to be developed through a mix of underground and opencast mining, wherever possible.

The success of the basalt extraction has provided fresh momentum for advancing Deocha Pachami's underground coal development. which is seen as crucial to West Bengal's future energy security and industrial growth, officials said. (PTI)

## **Titagarh Rail acquires 40 acres** of land in Bengal for expansion

KOLKATA, July 13: Titagarh Rail Systems Ltd has acquired around 40 acres of land on lease for ₹126 crore from the West Bengal government, a move that will help the company ramp up production of Vande Bharat coaches and metro cars at its Uttarpara facility in Hooghly district, an official said.

The land parcel spread across

contiguous to Titagarh's existing 34-acre plant at Uttarpara, making it a critical addition to the company's expansion plans, he said.

The 99-year lease agreement, signed on July 12, 2025, with the state, involves a consideration of ₹ 126.63 crore, he said.

"The additional land will enable us to establish extra production infrastructure and dedicated areas for forming, testing, and commission-

ing of metro coaches and Vande Bharat trains," the company said in a regulatory filing on Saturday.

A test track of adequate length will also be set up to ensure comprehensive performance and safety validation before delivery, it said.

The expansion will support Titagarh's plan to scale up its production capacity from 300 cars per year to around 850 annually by FY'28. (PTI)

## Vedanta's donations to BJP nearly quadruples to ₹ 97 cr in FY25: Annual Report

NEW DELHI, July 13: Billionaire Anil Agarwal's mining conglomerate Vedanta Ltd nearly quadrupled its donations to the ruling Bharatiya Janata Party (BJP), contributing ₹ 97 crore in the fiscal year ending March 2025, according to its latest annual report.

Under "Miscellaneous Expenses', Vedanta detailed the political donations as well as the management and brand fee expenses it paid to its parent, London-listed Vedanta Resources Plc. Political donations totalled ₹ 157 crore in 2024-25, up from ₹ 97 crore in the previous financial year.

While donations to the BJP soared, those to the opposition Congress were cut to just ₹ 10 crore.

The donations in fiscal year April 2024 to March 2025 (FY25) included "contributions to Bharatiya Janata Party of ₹ 97 crore (₹ 26 crore in fiscal year ended March 31, 2024), Biju Janata Dal of R₹ 25 crore (March 31, 2024: ₹15 crore), Jharkhand Mukti Morcha of ₹ 20 crore (March 31, 2024: ₹ 5 crore) and All India Congress Committee of ₹ 10 crore (March 31, 2024: ₹ 49 crore)," according to the annual report for 2024-25 Vedanta has been one of the biggest donors

to political parties.

"During the year ended March 31, 2024, VRL assigned the agreement, including a sublicensing agreement, to its wholly-owned subsidiary, VRIL, whereby the Group will fulfil its obligations under the agreement via VRIL with effect from April 1, 2024," the annual report said. ### NFR records 9.6% surge in freight loading in June <u>HT Bureau</u>

GUWAHATI, July 13: The Northeast Frontier

Railway (NFR) has registered a consistent surge in freight loading, underscoring the zone's growing role in supporting economic activity across the region. According to an official statement, NFR loaded 0.968 million tonnes (MT) of freight in June 2025 - a 9.6% increase over the corresponding period last year. This growth was primarily fuelled by a substantial increase in the movement of key commodities. Cement loading saw a sharp rise of 53.1%, while coal grew by 37.5%, and petroleum, oil and lubricants (POL) by 41.7%. Fertilizer loading increased by 9.1%, container traffic by 11.1%, and other miscellaneous goods by 36.2%. A standout figure was recorded in the loading of stone chips, which rose by an impressive 275% compared to June of the previous financial year, indicating heightened construction activity and infrastructure demand in the region. Officials attributed this consistent growth to improved logistical coordination, efficient use of railway assets, and growing industrial and infrastructural activity across the northeastern states. "NFR is working round the clock to serve its customers and ensure the timely delivery of essential commodities to end users," the statement said. ## **Decline in purchasing** power of commoners

T ndustrial growth, the stock market and the rupee have already been sinking. Now more and more reports show a constant fall L in Indian households' rapidly shrinking expenditure capacity. According to the latest data released by the National Accounts Statistics. Indians have significantly reduced their spending on clothing and footwear over the past three years. Clothing and footwear are essential items for any household. A continued decline in expenditure on these items for last three years means that the crisis has started turning endemic in nature. The data shows that the consumer expenditure on clothing and footwear stood at Rs 4.52 trillion in the financial year 2023-24, marking a seven percent decline from Rs 4.94 trillion in 2021-22. This dip shows a growing trend of cautious spending among Indian consumers. Such a situation arises when there is a definite fall in the purchasing power of the people. A deeper look into the data reveals that the during this period the footwear consumption remained largely stagnant, with a marginal slip from Rs 1 trillion in FY21 to Rs 99,000 crore in FY24, while the clothing segment faced a steeper decline, falling from Rs 3.93 trillion in FY22 to Rs 3.53 trillion in FY24. The downward trend in Indian consumers' ability to spend money on clothing and footwear began in 2020-21 fiscal, the year which was marked by the COVID-19 pandemic. That year the spending on clothing and footwear dropped by 15 percent in comparison to the level of expenditure Indian consumers had shown on these items in the financial year 2019-

Recent figures from the Ministry of Statistics signals that the fall in Indians' capacity to spend on items of daily use is acquiring deeper roots in the economy. They also highlight the desperate need for policy support to boost income growth and restore consumer confidence. However, such a transformation would require massive efforts to reverse the trend of fall in the employment generation in the country. This in turn would require a complete policy overhaul. This seems an impossible proposition given the way the unemployment, falling expenditure capacity, rising inflation and almost stagnant economy have become the defining feature of the Narendra Modi government. Only in February this year, a study by venture capital firm "Blume Ventures" found that Nearly 100 crore Indians, 90 percent of the country's population, lack discretionary spending power to purchase goods or services. The report stated that the intensification in the decline of the consumption pattern is driven not only by a decline in purchasing power of ninety percent of the population in India but also by a sharp drop in financial savings and a surge in mass indebtedness.

The study, titled "Indus Valley Annual Report 2025" clearly stated that only the top 10 percent of India's population have shown a significant hike in their consumption expenditure. It, therefore, called this small group of Indians as "the primary driver of consumption and economic growth". The report, however, noted that this "consuming class" in Asia's third-largest economy is not expanding in size but rather becoming wealthier, meaning the rich are getting richer while the overall number of wealthy individuals remains stagnant.

n an era where climate commitments are shaping geopolitical alignments Land economic strategies, the European Union's Carbon Border Adjustment Mechanism (CBAM) has emerged as a lightning rod of controversy. Pitched by the EU as a bold instrument to curb global emissions and prevent "carbon leakage," the CBAM aims to impose import duties on goods produced in countries with lower environmental standards than those upheld within the Union. However, what Brussels touts as climate-conscious innovation, a growing coalition of developing nations — notably the BRICS bloc — decries as protectionist overreach.

The BRICS group, comprising Brazil, Russia, India, China, South Africa, and newly joined members including Egypt and the United Arab Emirates, issued a pointed denunciation of CBAM during their July 2025 summit in Rio de Janeiro. Their statement condemned "unilateral, punitive and discriminatory, protectionist measures" enacted under the guise of environmental concern, explicitly rejecting carbon border adjustment mechanisms like the EU's. This rare consensus underscores the building frustration among large developing economies, who view CBAM as a neo-colonial tool that shifts the burden of climate action onto their shoulders while securing the competitive edge of Western industries.

At its heart, CBAM is meant to prevent what the EU calls "carbon leakage" — the tendency of industries to relocate manufacturing to countries with lax emissions norms, thus undercutting the Union's own climate goals. In theory, taxing carbon-intensive imports such as steel, cement, fertilisers, aluminium, and electricity generated by fossil fuels levels the playing field. European industries pay for their emissions under the EU's Emissions Trading System (ETS), and CBAM ensures that imports don't enjoy an unfair cost advantage simply because they were manufactured in jurisdictions with looser climate regulations.

But the devil, as always, lies in the detail — and in the power dynamics of global trade. Developing economies argue that CBAM is a disguised form of green protectionism. It penalises their industries for lacking the resources and infrastructure to rapidly decarbonise — even as they struggle to lift millions out of poverty. The European Commission maintains that CBAM is compliant with World Trade Organization (WTO) rules, promising that any carbon taxes already paid in the country of production will be deducted from the EU import duty. Yet for countries like India, the concern is less about formal compliance and more about systemic injustice.

The EU, however, appears unmoved. CBAM entered its transitional phase in October 2023, with full implementation slated for 2026. While it currently applies to a limited set of products, Brussels has made it clear that more goods will be added in future phases. Given that the EU represents approximately 15% of global imports, the implications are immense. Countries heavily reliant on export-led growth - like India, whose manufacturing sectors supply steel, aluminium, cement, and fertilisers to Europe - will bear the brunt of these tariffs.

The worry extends beyond just Europe. Other advanced economies are watching closely. The United Kingdom and Canada have reportedly considered implementing similar carbon tariffs, and the United States' Inflation Reduction Act (IRA), signed into law in 2022, already incentivises domestic production of clean energy technologies - indirectly disadvantaging foreign manufacturers. While the IRA does not formally include a CBAM-like provision, its subsidy-

heavy structure for American green industries acts as a non-tariff barrier that reshapes global trade flows under the pretense of climate action.

Moreover, the global race for energy transition is being coloured by strategic anxieties. China's dominance in clean tech - solar panels, wind turbines, battery technology, and critical minerals has triggered an economic nationalism in the West cloaked in environmental rhetoric. As the fossil fuel era gives way to a new energy order, countries like India are wary of being boxed out by policies designed more to contain China or protect Western interests than to actually reduce global emissions.

Ironically, policies like CBAM may do little to slow climate change in the long term. By diverting production to regions with better emissions records rather than helping high-emission sectors decarbonise, CBAM risks being a tactical fix rather than a transformative solution. Worse, it could fracture the fragile international consensus on climate cooperation. Developing countries might see little incentive to commit to deep decarbonisation if their efforts are met not with financial sup-

Developed countries should prioritise assisting developing economies in greening their industries through financial aid, concessional loans, joint R&D, and preferential access to green technologies. Trade tools like CBAM should be part of a broader framework that includes equity-based climate finance and capacity-building measures, not standalone instruments that penalise the poor while protecting the rich. As BRICS and the BASIC group continue to challenge CBAM and similar climate trade policies, the debate is no longer just about trade or emissions — it's about climate justice. The challenge is to ensure that the transition to a greener planet does not become another theatre for old economic hierarchies and new forms of coercion.

The 2025 Rio declaration is therefore not merely a statement of protest — it is a call to reimagine climate action through the lens of equity. It asks a fundamental question that the world cannot afford to ignore: Will the fight against climate change be a collective, cooperative endeavour - or another tool of global division?

## ECI has to follow the procedure, cannot have intent to exclude electors

The crux of the observations and suggestions sion of India, but by the Ministry of Home Affairs. made by the Supreme Court of India in the matter of Special Intensive Revision of Electoral Roll in Bihar is that the Election Commission of India (ECI) has to follow the well laid procedure under the law, and cannot have intent to exclude electors from the voter list. The deadline of submission of documents by the electors is July 25, and the Supreme Court will be hearing the case next on July 28. By that time many things will be known, such as how the ECI has been going ahead with its constitutional responsibility of revision of the electoral roll, and how far people would be able to meet the deadline for submission of documents that the ECI has given them. While allowing the SIR, the Bench of the Supreme Court comprised of Justice Sudhanshu Dhulia and Justice Joymalya Bagchi had actually made significant observations and suggestions while hearing the bunch of petitions on July 10, 2025 challenging the ECI's order of June 24 for SIR of Electoral Roll of Bihar. The petitioners had alleged that the exercise was intended to delete large number of electors from the voter list. Senior Advocate Rakesh Dwivedi appearing on behalf of the ECI, had submitted, "Election Commission is one constitutional body which is in direct relationship with the elector. It cannot and does not have any intent whatsoever to exclude anybody from the voter list unless and until the hands of the Commission are compelled by the provision of law itself."

mmediately after the war when capitalism had faced a serious existential crisis, it L had adopted a dual strategy to cope with it. First, it whipped up the "red scare" which was absolutely without any justification, in order to terrorise the domestic working class into acquiescing with the system. Second it was forced to make adjustments in its modus operandi, of which four in particular deserve attention, namely, formal political decolonisation, the introduction of democratic governance based on universal adult franchise, the acceptance of Keynesian "demand management" to eliminate mass unemployment, and the adoption of welfare state measures everywhere, especially in Western Europe. These changes were so significant that an impression got around that "capitalism had changed", that it was no longer the old predatory capitalism which prevailed but a new welfare capitalism" With finance capital gathering strength during the long post-war boom that followed, and with this finance capital going global, which paved the way for an attenuation of the autonomy of the nation-state and the imposition of a neoliberal regime everywhere, these post-war measures were getting reversed anyway; but this reversal has now acquired an unprecedented momentum. The open genocide being perpetrated against the Palestinians with the support of metropolitan capitalism has a brutality equalling if not exceeding that of colonial times; the upsurge of neo-fascism and of bourgeois authoritarianism has attenuated the democratic space available to people: the economic crisis of world capitalism can no longer be treated through Keynesian "demand management" because of the hegemony of globalised finance; and now there is also a concerted effort to roll back welfare spending everywhere, and to devote the resources released from it for making financial transfers to capitalists and for raising military expenditure. Donald Trump's "big beautiful bill" which got passed by both houses in the US and has now become law, is a massive assault on welfare spending. According to the Congressional Budget Office which makes estimates independent of the US government, this bill will give tax concessions whose cumulative value over the next ten years is \$4.5 trillion; and the main beneficiaries of the tax concessions will be the rich. In addition, military expenditure will rise cumulatively by \$150 billion and "border security" (that is, expenditure incurred for keeping out immigrants) by \$129 billion. All these outgoings are financed through a cut in Medicaid by \$ 930 billion, in Green Energy by \$ 488 billion and in Food Benefit by \$287 billion. Medicaid is the programme that is meant to help the most vulnerable sections of American society, such as the old, the poor and the disabled; and curtailing it as the bill does, is to hit at the most helpless segments of this society. Trump's "big beautiful bill" is a brazen transfer of ben-

spending is about 2 per cent of GDP and in many countries not even that. NATO countries, especially those in Europe, in other words are planning to raise their military spending from 2 per cent to 5 per cent of GDP in a decade's time.

Now, the currencies of the other NATO countries are not comparable to the American dollar, which is why they cannot raise their fiscal deficits relative to GDP in defiance of the wishes of globalised finance capital. Besides, most European NATO countries, being members of the European Union, are statutorily constrained not to raise their fiscal deficits above 3 per cent of their GDP, which is more or less the level where it currently is anyway. Since taxing the rich is out, again in deference to the wishes of finance capital, it follows that the rise in military expenditure will have to be effected at the expense of the working people in these countries, which can take the form either of higher taxation imposed on the workers or of cuts in welfare expenditure. Of the two alternative ways of raising the burden on the workers, cuts in welfare spending are obviously more easily achieved. though it matters little which way is adopted. for both ways entail a decline in the living standard of the workers. The imposition of an additional burden of 3 per cent of GDP on the workers is an immense imposition. The NATO countries in short have given clear notice that even officially the days of so-called "welfare capitalism" are over, that the world is back to the days of "predatory capitalism". Why have NATO countries decided to raise their military spending? There is of course the standard invoking of a Russian threat to Western Europe. But even in the heyday of the so-called Soviet threat that was invoked to justify the Cold War, such high levels of military expenditure had never been witnessed. Besides, even today the annual military expenditure of Russia is less than a third of the total annual military expenditure of the European NATO countries alone, even if we leave aside the USA. So, the "Russian threat" is just a camouflage. The significantly higher military expenditure to which the NATO countries have committed themselves is motivated by a desire to protect a crumbling Western imperialist order by using force against all countries that are seen as possible challengers to this order. The bombing of Iran was motivated by this desire; and the coming vears are likely to see several such instances of aggression. It is to prepare for such aggression that the workers of the advanced countries are being made to sacrifice whatever welfare measures they had enjoyed till now. A crumbling imperialism however is dangerous in the extreme. for it is perfectly capable of pushing the world to a catastrophe. The recklessness involved in bombing Iran's nuclear sites testifies to this. Raising the awareness of people all over the world to resist this imperialist recklessness thus becomes absolutely necessary. (IPA Service)

On the ECI's submission Justice Dhulia had concluded the hearing with his remark, "We have serious doubt on whether you can follow this timeline. Remember, you have to follow the procedure. It is something that is not practical."

Additionally, the Bench also asked the ECI to consider Aadhaar card, voter ID card, and ration card as acceptable documents for inclusion of names in the voter list. It is a significant suggestion because a large number of people in Bihar do not have any of the 11 documents that the ECI has declared acceptable.

The Supreme Court has asked three pertinent questions to the ECI: one, about the EC's very authority to conduct a "special intensive revision"; two, about the valid procedure, including what it can ask for; and then the timing of the exercise, just months ahead of the assembly polls. The ECI is supposed to answer these questions by the next hearing.Most haunting issue for the electors of Bihar at this point of time is that if they will not be able to provide documents within the deadline given to them which will end on July 25, their name will be deleted not only from the voter list but they might be treated as not a citizen of India or even as infiltrators from other countries.

Senior Advocate Kapil Sibal appearing for a petitioner RJD MP Manoj Jha said, "The burden is not on me to prove citizenship. Before they remove me from electoral roll, they have to show that they have some document in their possession that proves that I am not a citizen."

Justice Bagchi questioned the ECI's exclusion of Aadhaar, and said "Even these other documents by themselves don't prove citizenship." ECI's order has made it mandatory for the electors of Bihar whose name was not in the Electoral Roll of 2003 to prove their citizenship, and also of their parents. The order effectively requires a person born after 1987 to prove their own citizenship along with the citizenship of their parents to get his or her name included in the revised in the electoral roll.

Senior advocate Gopal Sankaran Narayan appearing on behalf of one of the petitioners pointed out that Aadhaar is an acceptable document as per the Representation of Peoples Act, but the ECI is not considering it a valid document for Bihar SIR of Electoral Rolls.

The bench then asked the ECI why? Senior Advocate Rakesh Dwivedi appearing on behalf of the ECI has simply said, "Aadhaar Card cannot be used as proof of citizenship." On which Justice Bagchi said, "That (citizenship determination) is a different issue and the prerogative of Home Ministry.'

Justice Sudhanshu Dhulia remarked: "... citizenship is an issue to be determined not by the Election Commission of India, but by the Union Ministry of Home Affairs." On this ECI's lawyer said that the poll panel has the powers to check for citizenship for voting rights, under the Article 326 of the Constitution of India. He also said that the ECI has role as the Representation of People Act, 1950 mandate that one must be a citizen to vote.

The issue of proof of citizenship and the jurisdiction of ECI will come up in the future hearings, since it is still a matter that is haunting the electors of Bihar. Even Justice Dhulia has found that the issue of determination of citizenship can't be settled within the deadline.

"Isn't it too late now for that?, asked Justice Dhulia to ECI, adding, "Your decision, let us say to disenfranchise the person who is already there on the electoral roll of 2025, would compel this individual to appeal against the decision and go through this entire rigmarole and thereby be denied of his right to vote in the ensuing election." He also said, "They are saying that you are asking people for documents suddenly which they don't have.

Then the issue of giving reasonable time also came for argument since the ECI had given a deadline of only 30 days to submit documents. Justice Bagchi questioned the practicality of ECI, "This timeline ... why just 30 days? The census will take a year.'

On this ECI's lawyer assured the court that all eligible voters would be included and that hearings would be held in case of objections, adding, "Let the revision exercise be completed. And then your lordship can look at the entire picture.

Supreme Court then allowed the SIR exercise, with caution. However, the larger questions will come in the future hearing, including whether the ECI's order is arbitrary and unconstitutional violating fundamental rights, or violates the principle of due process and natural justice? (IPA Service)

efits from the poorest to the richest.

Of course the tax concessions are far larger than even the curtailment in expenditures mentioned above: as a result, the fiscal deficit in the US is slated to increase cumulatively over the next decade by \$3.4 trillion. Its impact by way of stimulating the economy will be trivial; it amounts only to a gratuitous addition to the wealth of the rich.

A question will arise here. A larger fiscal deficit is disliked by finance capital. Even when the larger fiscal deficit is incurred for financing transfers to the rich, finance capital still does not like it. In fact this is what Liz Truss, a former British prime minister had tried to do; but so great was the objection of finance to her programme that the poundsterling fell in value and Liz Truss had to resign. She became in the process the shortest-serving prime minister in the entire history of Britain, with a tenure of no more than 50 days. How then has finance capital allowed Donald Trump to undertake larger borrowings for making larger transfers to the rich?

It is still not clear if Trump has got away with a larger fiscal deficit; that is, whether finance capital will not force him to curtail the fiscal deficit further, not necessarily by reducing transfers to the rich but by cutting down welfare expenditures even further. But Trump does have some leeway because of the fact that the American dollar has a status today that is quite different from that of the British pound sterling. The world's wealth-holders still regard the dollar to be almost "as good as gold", and would be unlikely to move out of it even in the face of Trump's enlarged fiscal deficit. This leeway was not available to Liz Truss when she embarked on her infamous plan to make deficit-financed transfers to the British rich.

The curtailment in welfare spending that is occurring in the US at present is soon going to be followed by a similar curtailment all over the metropolitan capitalist world. At a NATO summit held on June 24-25 in the Hague, a decision was taken to raise military spending in all member countries of NATO to 5 per cent of GDP by 2035. The current

# **Impact of Brain Drain on Assam's Future**

ssam today finds itself at a crucial juncture, where The aspirations of its younger generation are increasingly charting paths away from their home state. This ongoing departure of talent-students, professionals, researchers, and skilled workers—has emerged as a defining concern for its longterm developmental trajectory. Often termed as "brain drain", this silent migration of human capital presents a complex paradox: while it speaks to the excellence of Assamese individuals who are able to secure opportunities beyond the region, it simultaneously underlines the lack of adequate systems, infrastructure, and promise within the state that can accommodate and retain its best minds. The long-term impact of this outflow cannot be dismissed as mere numbers on a graph—it directly affects the socioeconomic, educational, and cultural future of Assam.

The forces propelling brain drain from Assam are deeply rooted in longstanding structural deficiencies. Higher education institutions within the state, though improving, often fall short of national standards in terms of faculty strength, research capabilities, global exposure, and modern pedagogical practices.

Many students, after completing their higher secondary education, prefer to move to institutions in other states for undergraduate and postgraduate studies, particularly in disciplines like engineering, medicine, law, management, and pure sciences. This migration for academic excellence becomes a natural precursor to permanent settlement outside Assam, especially when metropolitan cities offer abundant employment options and higher salaries. The result is a widening intellectual gap within Assam's own institutions and professional sectors.

Urban India and foreign countries appear to promise greater rewards-economic, social, and professional. Assam, despite its natural beauty and rich cultural identity, struggles to offer comparative returns. The state's economy is still heavily reliant on agriculture and tea, with limited diversification into modern sectors such as information technology, biotechnology, research, and advanced manufacturing. Start-up ecosystems, which have become accelerators of growth in cities like Bengaluru and Hyderabad, remain underdeveloped in Assam. This unevenness not only disincentivizes return migration but actively fuels permanent resettlement elsewhere. As a consequence, the state is not just losing young minds-it is also losing potential entrepreneurs, iob creators, and thought leaders who could have played pivotal roles in transforming Assam's economy and governance.

Beyond employment, social and infrastructural gaps exacerbate the sense of alienation among the youth. Issues like intermittent electricity, poor internet connectivity in rural and semi-urban areas, limited healthcare services, bureaucratic delays, and lack of cultural spaces dampen the desire of returnees or aspiring professionals to invest their energy in Assam. Many of them find that the pace of change back home does not match the momentum of their aspirations. As time passes, their connections to the homeland weaken and are replaced by attachments to new places that offer stability, efficiency, and recognition.

The brain drain also carries deep implications for Assam's intellectual and cultural landscape. The state has a rich legacy of literature, music, theatre, indigenous knowledge systems, and language diversity. When talented individuals migrate, they carry with them the stories, traditions, and memories of their homeland, but the active process of nurturing and transmitting these to the next generation back home is disrupted. Cultural institutions find it difficult

to attract young leadership. Aca-

demic institutions miss out on dynamic researchers and thinkers who can revitalize the curriculum and bridge global and local knowledge. Art spaces, rural innovation hubs, and community organizations struggle to find the next generation of passionate stewards

ens the urban-rural divide within the state. Most often, it is the rural and semi-urban youth who migrate, leaving behind an ageing population in their native villages. The result is a weakening of local economies, decline in agricultural productivity, erosion of traditional farming knowledge, and collapse of rural cooperatives. Women and elderly residents are frequently left to shoulder the burdens of households and farmlands in the ab-

sence of male members. Though remittances sent back home offer temporary relief, they rarely translate into sustainable investments that can rebuild local economies or create employment for others. The long-term demographic

implications are no less alarming. A continuous outflow of the educated class creates a void in leadership, innovation, and governance. Institutions such as schools, rural health centres, panchayats, and local industries suffer from a shortage of qualified professionals. Policymaking and administrative execution at the grassroots level become subpar due to lack of young, driven individuals. In turn, this leads to a vicious cycle-poor services push more people to leave, further weakening the system. This cycle must be broken if Assam aspires to a future of inclusive development and regional strength. Economic growth remains stunted when it fails to integrate its youth force into its development plans. Assam's over-reliance on a few traditional sectors, and lack of investment in contemporary industries, discourages skilled youth from staying.

The tea industry, which once provided employment and identity, is no longer sufficient to meet the economic ambitions of a digitally connected generation. Even sectors such as tourism and culture, which hold enormous potential, suffer from lack of organized infrastructure and innovation-driven marketing. The absence of high-growth indusand foremost. tries results in limited high-paying jobs and professional fulfillment, which are critical for retaining young talent.

While the negative impacts of brain drain are obvious, it is important to acknowledge that not all migration is inherently harmful. Many Assamese individuals who leave the state go on to achieve great success, often becoming ambassadors of Assam's culture, values, and ethos on national and global platforms. This diaspora, if engaged meaningfully, can be a valuable resource for the state's growth. Countries across the world, including India at a national level, have begun to tap into their diaspora for investment, policy guidance, mentorship, and technology transfer. Assam too must actively develop mechanisms to maintain longterm relationships with its diaspora, encourage knowledge exchange, and create avenues for return. Reversing brain drain or transforming it into brain gain, however, is not a spontaneous process. It demands a visionary approach by the government, educational institutions, industry bodies, and civil society. First

in revamping its education system. Universities and colleges should be equipped with modern facilities, updated syllabi, industry linkages, research grants, and international collaboration. Faculty development programs and research fellowships can help retain and attract academic talent. Special focus should be given to STEM education. vocational training, and entrepreneurial

studies Parallel to education reform, the state must create an enabling environment for start-ups and small businesses. Young entrepreneurs need access to seed capital, incubation centres, legal support, and mentorship networks. By facilitating a local entrepreneurial ecosystem, Assam can not only prevent the outflow of business-minded youth but also become a hub of innovation in the northeast. Integration of rural products with global markets through e-commerce, crafts innovation, and sustainable tourism can provide meaningful

livelihoods to young people within the state. Digital infrastructure is another area that demands urgent attention. High-speed internet, reliable electricity, and accessible transport can revolutionize the way people work and learn, especially in remote areas. The postpandemic world has normalized remote work. Assam has a golden opportunity to create work-from-home job clusters, especially in areas like digital marketing, content creation, data analytics, and customer service, thereby retaining its youth who

would otherwise migrate to cities for such opportunities. Emotional belonging is another factor that influences migration choices. A youth who feels disconnected from the state's vision is less likely to return. Therefore, the government and civil society must also promote a strong cultural and civic identity among the young generation. Celebrating Assamese festivals, supporting regional literature, encouraging local cin-

ema, and reviving indigenous traditions through youth participation can rekindle a sense of pride and ownership in the homeland. Cultural exchange programs, heritage education, and creative fellowships will go a long way in nurturing this connection.

Diaspora engagement must be institutionalized through the creation of a dedicated Assam Global Network that can regularly interact with overseas Assamese professionals, provide investment platforms, and recognize their contributions. Return migration policies such as simplified registration, job matching, real estate incentives, and social security support can further encourage professionals to come back and contribute to Assam's development.

For any of these strategies to work, there must be political will, policy continuity, and participatory governance. Youth-led organizations should be given voice in state planning and innovation councils. Research institutions must be supported to study migration patterns and create region-specific solutions. Transparency, accountability, and a merit-based public system are essential to inspire confidence among the youth that Assam is indeed a place worth building their future in.

The story of brain drain in Assam is not just a statistical concern-it is a mirror reflecting the hopes, disappointments, and decisions of an entire generation. If this trend continues unchecked, the state risks becoming a land of lost opportunities, governed by memories rather than momentum. But with the right vision and collective effort, Assam can reverse the tide. It can become a state where the best minds stay not out of compulsion, but out of conviction- a state that not only remembers its children but also gives them reasons to return, to stay, and to lead. Assam's future depends not just on development, but on where its dreams decide to live.

However, in recent years, there has been a worrying increase in cancers of the digestive system known as gastrointestinal or GI cancers — in people under the age of 50, and experts have yet to identify a reason.

A new analysis of studies notes that between 2010 and 2019 early-onset colorectal cancers increased by 14.8% in the United States, and rates are increasing worldwide.

The comprehensive review. which is published in The British Journal of Surgery, suggests that, while the exact cause is unknown, environmental factors, diet and lifestyle, may be responsible for the increase.

Anton Bilchik, MD, PhD, surgical oncologist, chief of medicine and Director of the Gastrointestinal and Hepatobiliary Program at Providence Saint John's Cancer Institute in Santa Monica, CA, not involved in the review, suggested some possible reasons for the rise in early-onset GI cancers.

"While the increase in obesity is associated with a major increase in early-onset colorectal cancer, the majority of patients are not obese, do not have a family history or any other obvious risk factors," Bilchik told Medical News Today.

"This suggests that other factors such as the environment, lifestyle, diet (processed food and red meat), lack of exercise and stress may all negatively affect the trillions of bacteria in our bodies (the microbiome) as well as our immune system creating a proinflammatory response which has been linked to the development of early onset cancers." - Anton Bilchik, MD, PhD

Greatest rises in colon and rectal cancers

The researchers note that earlyonset cancers of the colon and rectum had increased the most. People born in 1990 are more than twice as likely to develop colon cancer, and more than four times as likely to develop cancer of the rectum than those born in 1950.

They identified global increases in colorectal cancers. A study of

20 European countries showed that between 2004 and 2016, coltold MNT.

orectal cancers had increased by almost 8% for those aged 20-29, almost 5% for people aged 30-39, and by 1.6% in the 40-49 age

Even more shocking are figures from the Centers for Disease Control and Prevention (CDC) Wonder database in the U.S., which identified a 333% increase in the incidence of colorectal cancers among 15-19 year olds and a 185% increase among people aged between 20 and 24.

Despite these apparently huge percentage increases, the authors emphasize that the absolute numbers of cancer diagnoses are still very much lower in those under 50 than in older people.

However, the researchers on this study highlight the need for targeted awareness and interventions, particularly among younger age groups

#### Bilchik concurred, commenting that:

'Public awareness that GI cancer is now the leading causeTrusted Source of [cancerrelated] deaths in males under age 50 and the second leading cause in women is essential. The US Preventative Task Force has already reduced the screening age to 45. Given the disproportionate increase in blacks and Hispanics compared with non-Hispanic whites, the screening age may need to be further reduced to 40."

Can experts explain the increase in colorectal cancers?

"Though the rates of colorectal cancer are rising fastest in the youngest age groups — ages 15-24 — the absolute number of cases in this age group is relatively low compared to those aged 40-49, which makes it challenging to isolate risk factors specific to this younger group," joint first author of the review Sara K. Char, MD, Clinical Oncology Fellow at

"Several factors, including obesity, excessive alcohol intake, intake of a Western-pattern diet, sedentary lifestyle, and consuming sugar-sweetened beverages have been associated with increased risk of early-onset colorectal cancer," Char suggested. "Other factors, such as exposure to microplastics and changes in the gut microbiome have also been implicated," she told us. "However, we know that not all patients with early-onset colorectal cancer have these risk factors. Ongoing research efforts are needed to better understand these rising trends."

Gastric cancers preventable by stopping bacterial infection

Another recent study, led by researchers from the International Agency for Research on Cancer of the World Health Organization (WHO) in Lyon, France, and published in Nature MedicineTrusted Sourcearound the same time as the comprehensive review, found a link between gastric cancers and infections with a common bacterium.

The study was concerned with preventable gastric cancers, and it analyzed data from participant cohorts across 185 countries, focusing on individuals born in 2008-2017 The researchers concluded that

an estimated 15.6 million gastric cancer cases are likely to develop among people from these birth cohorts

Of these cases, a staggering 76% are attributable to infections with the bacterium Helicobacter pylori, which are very common but also preventable. This, according to the study au-

thors, highlights the need of implementing education and preventive strategies addressing this cause for gastric cancer worldwide.

Early examples of potent global soft-power health activities include the US-led medical civic action programme during the Vietnam war, and the medical diplomacy of China and Cuba in 1960s Africa and Latin America.

More recently, the UN embedded health in its sustainable development goals, and the high profile of health at the G7 and G20 reflect how health influences global policy. There is a moral argument for global aid to advance health as a global public good. But there are other advantages to global health diplomacy, including the promotion of national interests and foreign policy goals, and raising a country's international status.

#### Continuing threats to health security

Aside from common health challenges, governments around the world must address novel infectious diseases, bioterrorism, and accidental biological incidents. Tackling such challenges requires concerted global action involving multiple stakeholders, under the aegis of multilateral organisations.

The Covid-19 pandemic highlighted how advancing health policies for the global public good requires coordinated international efforts. For example, collaboration between Oxford University. AstraZeneca, and the Serum Institute of India produced the Covishield vaccine.

COVAX was a novel partnership between the WHO, UNICEF, and the Coalition for Epidemic Preparedness Innovations. The partnership distributed Covid-19 vaccines, under a licensing and technology transfer agreement, to meet global immunisations demands. The sharing of biological information across borders remains critical to global health security, and promotes innovation in medical research and development.

Despite these notable partnerships, geopolitical vitamin D deficiency, and staying rivalry, vaccine nationalism, and the hoarding of medical supplies marred global pandemic management. The crisis damaged public trust in the WHO, weakening its soft power. There were delays in declaring Covid-19 a Public Health Emergency of International Concern (PHEIC), and uncertainty over the pandemic's origin. This demonstrates the urgent need for transparency and enhanced accountability in the WHO, and, ultimately, for its structural reform.

Several WHO member states, most recently the US, are calling for distinct guidelines on when to declare a PHEIC, greater accountability over financing, and measures to ensure the global health workforce is protected.

#### Rethinking global health

Negotiations over a pandemic treaty alleviated some of these concerns. Despite the US' absence, the Pandemic Agreement treaty was adopted last month. Yet glaring caveats remain. Negotiations over a Pathogen Access Benefit Sharing (PABS) mechanism, for example, have yet to take place. And any effective agreement will take years to enforce, during which time another pandemic might well occur.

Global health diplomacy remains crucial for navigating the shifting geopolitical landscape. Repercussions from the US' withdrawal from the WHO, the dismantling of USAID, and proposed US funding cuts to GAVI, the Vaccine Alliance, all call for urgent change. A resurgence in military conflicts, and increased military spending by the US, China, Russia, Germany, and India, has reduced global health funding. Finally, global health security remains much weaker without technical assistance and data-sharing with the US.

To raise their standing on the world stage, China and India continue to influence health activities in Africa, Latin America, and South Asia. India, in particular, is avidly pursuing a permanent seat on the United Nations Security Council.

India is the leading vaccine manufacturer by volume, with vibrant biotechnology and pharmaceutical industries. The country now has a remarkable opportunity to assert its voice in global health. China, meanwhile, has pledged to supplement its mandatory WHO contribution with an additional \$500 million over the next five years. Concerns remain, however, over how other countries will be able to interact with China under such multilateral fora

Global health is undergoing seismic shifts, and biological threats will not diminish. The US departure from health activities leaves a power vacuum, and signals the pressing need for a restructuring of the global health landscape. India and China are poised to address these challenges. Before they can do so, however, both rising powers must address systemic problems that continue to mar global health governance. ## **Environment group appeals to J-K govt to** protect 252-million-year-old fossil site

SRINAGAR, July 13: The Environmental Policy Group (EPG) has appealed to the state government to take steps for protecting the 252-million-year-old Guryul Ravine Fossil Park located in Khonmoh, Jammu and Kashmir. The EPG, in a statement issued on Saturday, expressed concern over the establishment of a large illegal garbage dumping yard near the fossil park. "The act not only constitutes a

grave ecological violation but also endangers a globally significant geo-heritage site that dates back 252 million years," the EPG said.

They highlighted that the site is critically important, as it is the only known geological formation that preserves definitive evidence of the world's first recorded tsunami, embedded within its ancient sedimentary layers.



"The Guryul Ravine is globally acknowledged by geologists, palaeontologists, and climate scientists as one of the most important Permian-Triassic boundary sites in the world. The fossil record at Guryul Ravine offers a rare glimpse into the ecological collapse and recovery phases that followed the extinction. It serves as a natural laboratory for studying Earth's climate history, mass extinctions, tectonic activity, and evolutionary processes," the group said.

Shedding light on what made the Guryul Ravine unique, the EPG mentioned it was due to the

presence of tsunami-generated sedimentary structures, identified and documented by geoscientists. that confirm the earliest evidence of a massive oceanic disturbance triggered during the Permian-Triassic transition.

These findings have been cited in international scientific journals and attract global research interest, making the site not only a national but also a world heritage

"The establishment of a waste dumping ground in such close proximity to this ecologically and scientifically sensitive area is a shocking act of environmental vandalism. It directly violates several key environmental protection laws, including the Environment (Protection) Act, 1986, the Wildlife (Protection) Act, 1972, and the Solid Waste Management Rules. 2016," the EPG said.

The group warned that the illegal dumping poses an immediate risk to the fossil beds, fragile sedimentary layers, and the overall ecological balance of the region. They cautioned that if this negligence is not addressed, it could destroy one of the few accessible records of the Earth's most "dramatic evolutionary moment"

The EPG appealed to Lieutenant Governor Manoj Sinha, Chief Minister Omar Abdullah and the chief secretary to intervene at the highest level and issue immediate directions for corrective action.

They also called for the park and its surrounding buffer zone to be officially declared as a nodumping zone and designated as an eco-sensitive area under relevant provisions of the environmental and heritage protection law. (PTI)

## Seized weapons show Manipur insurgent groups modifying some looted arms into sniper rifles

Improvised sniper rifles and cannons emerge as ethnic groups weaponise looted arms, scrap metal in Manipur



NEW DELHI/IMPHAL, July 13: Manipur's ethnic insurgent groups from both the Meitei and Kuki communities are modifying weapons, many of them looted from police armouries in 2023, and converting them into makeshift sniper rifles to increase their range and lethality, officials said on Sunday

They said the weapons have been converted into makeshift sniper rifles to target opposing communities. Among over 6,000 weapons looted from police armouries were .303 rifles, AK assault rifles and INSAS rifles and carbines.

The standard .303 rifle has an effective kill range of about 500 metres, the officials said, adding that after modifying the butt of the gun and placing a specialised telescope with other specifications, the round from the same rifle can travel much further, with more accuracy and lethality

The AK-47 is most effective within 300-400 metres only.

These modifications suggest that the groups wanted to engage in long-distance combat, but before they could pose a new challenge to security forces, the police along with the Assam Rifles and other paramilitary forces confiscated these weapons from various districts of the Imphal valley and hills.

In June, Manipur Police and other security forces recovered 328 weapons during simultaneous operations across five districts of the Imphal Valley on the intervening night of June 13 and 14 from Meitei dominated insurgent groups and 203 arms in first week of July from four districts in the hill areas where Kuki insurgent groups have an upper hand.

The weapons recovered from these two raids included INSAS rifles, AK series rifles, Self Loading Rifle, modified sniper rifles, grenade launchers, pistols and

country-made 0.22 rifle. Immediately after clashes broke out in 2023 between the two communities that have claimed 260 lives so far, security agencies had seized guns fabricated from parts of uprooted electric poles or galvanised iron (GI) pipes.

After the clashes turned bloodier in June 2023, the people of the hill district, who are traditionally hunters and have the ability to improvise and make deadly weapons, uprooted some electric poles and water pipes.

This community traditionally used swords, spears, bows and arrows. Later, they started using muzzle guns and bullets also known as 'Thihnang'. The uprooted electric poles were

used to manufacture indigenous cannon, also known as 'pumpi' or 'bampi', filled with scrap iron and other metallic items which act as bullets or pellets.

These are manufactured by village blacksmiths, also known as 'Thih-Kheng Pa' who often render free service to defend their community, the officials said.

The hill community is also known for its techniques in guerrilla warfare and often defends itself by carrying out sudden attacks on approaching people or ambushing them by rolling down huge stones in steep areas.

The electric pole converted 'bampi' is given an electric charge and is operated from a distance as the possibility of the pipe or the electric pole bursting in the middle cannot be ruled out, the officials said. (PTI)

Additional funds will be allocated if required, he said.

The official said offline mode may also be required as many refugees live in remote areas with poor inter-

Usha had also met World Boxing President Boris van der Vorst in Lausanne last month.

The tenure of the previous BFI office-bearers ended on February 2. Elections were initially scheduled for March 28, but the process has since been stalled due to legal wrangling, including multiple appeals and counter-appeals.

To ensure administrative continuity and oversight of domestic and international competitions, World Boxing set up a six-member Interim Committee, headed by Ajay Singh on April 7, with a 90day mandate.

Last week, it extended the committee's tenure and urged the panel to complete the election process by August 31. Interestingly, while Usha has announced the fact-finding panel, she has vet to nominate the final member of the BFI Interim

Committee. "Everything is out in the open, the delay is due to legal complica-

The BFI has been plagued by internal strife and factionalism in the run-up to the elections. The Returning Officer, former Delhi High Court judge RK Gauba, had also resigned from his post, alleging a smear campaign against him. Former Sports Minister Anurag Thakur is set to contest the elections against the incumbent BFI President Ajay Singh. (PTI)
