Trump's 50 pc tariff on Indian goods from today

Export sectors such as shrimp, apparel, leather, gems & jewellery to be impacted



NEW DELHI, Aug 26: The steep 50 per cent tariff on Indian goods entering the United States will take effect from August 27, severely impacting several labour-intensive export sectors such as shrimp, apparel, leather and gems & jewellery.

The high additional import duties would affect more than half of the USD 86 billion Indian exports to America, while the remaining items, including pharmaceuticals, electronics, and petroleum products, will continue to be exempt from the levy.

According to a US notification, "the duties... are effective with respect to products of India that are entered for consumption, or withdrawn from warehouse for consumption, on or after 12:01 am Eastern

Daylight Time on August 27, 2025" (or 9:31 AM IST August 27).

At present, a 25 per cent additional duty is already in place on Indian goods entering the US market. Another 25 per cent will be slapped as a penalty for purchasing Russian crude oil and military equipment. According to exporters, this "prohibitive" duty will drive out a number of Indian goods from the US market, as major competing countries like Bangladesh, Vietnam, Sri Lanka, Cambodia, and Indonesia have much lower duty on their goods.

Certain firms are front-loading the consignments to America before the increased tariffs take effect. This was reflected in July's trade data. India's goods exports to the US rose 19.94 per cent to USD 8.01 billion in July, while imports increased 13.78 per cent to about USD 4.55 billion during the month.

During April-July, the country's exports to the US increased 21.64 per cent to USD 33.53 billion, while imports rose 12.33 per cent to USD 17.41 billion.

An industry official from the leather and footwear sector said that companies would now be compelled to reduce staff and halt production until there is clarity on the proposed bilateral trade agreement (BTA) between the two countries. It aims to double the bilateral trade in goods and services to USD 500 billion, from the current USD 191 billion. Sharing

GUWAHATI, Aug 26: Assam Chief Minister Himanta Biswa Sarma on Tuesday said that a section of people who have been evicted during the recent anti-encroachment drives were living on acres of forest land, which had created resentment among the indigenous population

Speaking to reporters on the sidelines of a programme in Kokrajhar, Sarma said that seeing the size of the land some of those evicted possessed had made his

"Some of them had occupied 200 to 300 bighas (8 to 9 acres) of land individually. Why will this not make anyone angry?" he asked.

"The situation in Uriamghat made me think of living in a farmhouse there and giving up being a chief minister," he said.

Sarma said that if poor people had settled on small plots, it would not have angered people, but occupying such large tracts of forest

GUWAHATI, Aug 26: Elections to the 40-member Bodoland Territorial Council (BTC) in Assam will be held on September 22, State Election Commissioner Ranjan Sarma announced on Tuesday.

The last date for the filing of nominations is September 2, while the scrutiny of the nominations will be held on September 4, he

The last date for withdrawal of nominations is September 6, he

The counting of votes will be held on September 26, and the entire election process will be completed by September 28.

The polling will be held from 7.30 am to 4 pm on September 22. The counting of votes will begin at 8 am on September 26, Sarma said.

The model code of conduct will come into force with immediate effect in the entire Bodoland Territorial Region (BTR), comprising Kokrajhar, Chirang, Baksa, Udalguri and Tamulpur districts of the

A total of 26,57,937 people will be eligible to vote in this election, an increase of 11.35 per cent since the last polls in 2020. Among the eligible voters are 13,23,399 males, 13,34,521 females and 17 persons of other genders.

The total number of polling stations in BTC has increased to 3,359 from 3,146 in 2020, a rise of 6.77 per cent, Sarma said.

Among the 40 seats in the BTC, 30 seats are reserved for Scheduled Tribe (ST) candidates, five for non-STs and the remaining five are open to both ST and non-ST candidates

A candidate can spend a maximum of ₹ 10 lakh for the campaign.

A coalition of the United Peoples' Party Liberal (UPPL), the BJP and the Gana Suraksha Party (GSP) is in power in the council

₹5.8 crore worth drugs seized, 3 arrested

GUWAHATI, Aug 26: Three persons have been arrested and ₹ 5.8 crore worth of drugs have been seized from Cachar and Sribhumi districts in Assam's Barak Valley region, Chief Minister Himanta

Biswa Sarma said on Tuesday. Based on specific information, an anti-narcotics operation was launched by the police in the Lakhipur area of Cachar district on Tuesday, Sarma said in a post on X.

Sensex tumbles 849 pts amid widespread selloff; ends below 81K ahead of additional 25 pc US tariffs

MUMBAI, Aug 26: Benchmark BSE Sensex tumbled 849 points to close below the 81,000 level on Tuesday due to widespread selling pressure after the US issued a draft notice on the implementation of an additional 25 per cent tariff on Indian products. The 30-share BSE Sensex tumbled 849.37 points, or 1.04 per cent, to close at 80,786.54 with 25 of its constituents ending lower and five with gains. During the day, the index nosedived 949.93 points, or 1.16 per cent, to hit a low of 80,685.98.

The 50-share NSE Nifty dropped 255.70 points, or 1.02 per cent, to finish at 24,712.05. In the intra-day session, it dived 278.15 points, or 1.11 per cent, to hit a low of 24,689.60.

Persistent foreign fund outflows and losses in global equities following US President Donald Trump's firing of a Fed governor also dampened investor sentiment, analysts said.

Realty, pharma, banking and metal stocks bore the brunt of the selling, while FMCG shares displayed relative resilience with marginal gains.

Sun Pharmaceutical was the biggest laggard among Sensex firms, declining by 3.40 per cent following reports that Donald Trump had suggested a cut in drug prices of between 1,400 per cent and 1,500 per cent.

Trump's latest remarks came as his administration adopts an aggressive stance on pharmaceutical pricing and plans to impose higher tariffs on imported medicines.

Tata Steel, Trent, Bajai Finance, Mahindra & Mahindra, Bajaj Fin-



Bank, Tech Mahindra, Adani Ports, Titan, BEL, and Larsen & Toubro were also among the losers.

has the right to occupy forest lands. Let me remind you, this law was enacted by the Congress," Sarma said. He said that along with minorities, people of other communities were also evicted during the drive in Uriamghat. "It is, however, only the Miyas who protest and do not want to follow the law. This cannot be allowed as India is a country based on laws," he said. "What we are doing today is constructive. It will help those who truly believe in justice, but those who choose to listen to the members of Assam Nagarik Samaj (organisers of the meeting attended by Prashant Bhushan and Sayeeda Hamid) will ultimately be misled," he said. But, the additional burden of another 25 per cent... has effectively driven the Indian apparel industry out of the US market as the gap of 30-31 per cent tariff disadvantage vis-a-vis major competing countries like Bangladesh, Vietnam, Sri Lanka, Cambodia and Indonesia is wellnigh impossible to bridge," he said. Economic think tank GTRI said that US tariffs will impact 66 per cent of India's USD 86.5 billion exports to America. It said that USD 60.2 billion worth of goods will face 50 per cent duties from August 27, including textiles, gems, and shrimp.

'The United States' new tariff regime, effective August 27, 2025, marks one of the most severe trade shocks India has faced in recent years. With over two-thirds of India's USD 86.5 billion exports to the US now subject to prohibitive 25-50 per cent duties, critical labour-intensive sectors such as textiles, gems and ewellery, shrimp, carpets, and furniture face sharp declines in competitiveness and employment," GTRI Founder Ajay Srivastava said. He said India's exports to the US are expected to decline steeply to approx-

imately USD 49.6 billion in FY2026 due to Washington's new tariff regime. (PTI) Shoot-at-sight order

SC order on stray dog

The Supreme Court has modified its dog-order of August 11 and "dog-lovers" are beyond relief, except that the order doesn't meet everybody's expectations. The best thing about the order is that dog-lovers have been told not to feed strays on the streets and roads, in the vicinity of schools and at the entrances to gated communities. Food is not always a distraction but dogs might take exception to a stray child or elderly man invading the public feeding areas randomly selected by the compassionate dog-lovers. The problem is every dog-lover who feed stray dogs selects his or her feeding place. The dog-lover is as territorial as the dog! The Supreme Court's modified order says the strays should be captured, sterilized and immunized and then released back into the human population. And because the stray dogs have been vaccinated against Rabies, children wouldn't be in danger. The most that will happen will be fear of dogs instilled in the child, a fear that will stay for the rest of his/her lifetime. Fear of stray dogs is an international phenomenon. In Netherlands, it led to strong measures taken and today Netherlands is beyond the ken of stray dogs. But India being 'Sanatani', Indians are default animal-lovers, not just dog-lovers. The Supreme Court directed the Municipal Corporation of Delhi to release sterilised and vaccinated stray dogs back into their localities but not before the dogs are tested and declared rabies-free. Stray dogs betraying aggressive behaviour must be kept separate from the rest of the freely roaming stray dogs.

Is the MCD capable of carrying out this task? As it is, doglovers have been questioning the commitment of the inept MCD. The feeling drummed into the average Indian that our justices are a notch above common mortals. The stoppage of public feeding of stray dogs is a great relief to people who use roads for a smooth travel from 'Point A' to 'Point B'. Stray dogs often take a liking for unprotected ankles and calves. yanmar today is not a single, unified entity but a complex mosaic of competing forces. The military junta, or the State Administration Council (SAC), is losing its grip on the couna determined resistance movement composed of People's Defence Forces (PDFs) and powerful ethnic armed organizations (EAOs). For India, particularly its northeastern states, this unfolding crisis is not just international news; it is a matter of immediate and vital concern, impacting security, trade, and regional stability. This article examines the current state of the conflict, the rise of the Arakan Army, and the delicate geopolitical dance involving India and China, with a specific focus on the strategic importance of the India-Myanmar-Thailand (IMT) Trilateral Highway.

The Unravelling of the Junta and the Humanitarian Crisis

Since the February 2021 coup, Myanmar has been in a state of escalating civil war. The military, known as the Tatmadaw, has faced unprecedented resistance, suffering its worst losses in history. Its forces have been routed from numerous towns and military outposts, particularly in the northern and western parts of the country. A key turning point was Operation 1027, a sweeping offensive launched in late 2023 by the Brotherhood Alliance that demonstrated the military's vulnerability and inspired resistance forces nationwide. The junta has since resorted to brutal tactics, including indiscriminate airstrikes and forced conscription, which have only fuelled popular opposition.

The humanitarian situation is dire. As of late 2025, over 3.5 million people are internally displaced, and a staggering 19.9 million are in need of humanitarian assistance. Public services have collapsed, and the economy is in a state of freefall, with widespread poverty and food insecurity. The country was also hit by a major earthquake in March 2025, adding another layer of devastation to the already worsening crisis.

The Arakan Army's Ascendancy and its Strategic Implica-

For India and Bangladesh, the most consequential development is the rapid rise of the Arakan Army (AA) in Rakhine State. The AA has seized control of a majority of the townships in the state, including the entire 271-kilometer border with Bangladesh. They are now a de facto governing body in much of the re-

trolling trade. The AA's ultimate goal, rooted in their ethno-nationalist ideology, is to restore the sovereignty of the ancient Kingdom of Arakan, which they believe was a distinct entity from the rest of

ical puzzle. The AA's territorial gains put them in control of critical infrastructure projects that are central to the strategic interests of both India and China.

India's Kaladan Multi-Modal Transit Transport Project: This project, a cornerstone of India's "Act East Policy," is designed to provide a sea-river-road route from Kolkata to the northeastern states via the Sittwe Port in Rakhine. With the AA now controlling this region, the project's success is entirely contingent on their cooperation.

China's Belt and Road Initiative (BRI): Similarly, the deep-sea port and oil and gas pipelines in Kyaukphyu are central to China's BRI. While Beijing has reportedly intensified its backing of the junta, it also appears to be preparing for a scenario where the AA controls the facility, given the group's stated commitment to protecting foreign

The Chittagong-Rohingya connection further complicates the situation. The AA's territorial ambitions have raised concerns in Dhaka. while its shifting stance on the Rohingya-caught between a history of ethnic tensions and recent exploitation by the junta—adds a delicate layer to the crisis for both Bangladesh and the international

The IMT Trilateral Highway: A **Stalled Dream**

Crucially, the conflict has directly impacted the India-Myanmar-Thailand (IMT) Trilateral Highway, a project of immense strategic and economic importance to India. This ,360 km road network, connecting Moreh in India to Mae Sot in Thailand, is envisioned as the physical embodiment of India's "Act East

For Northeast India, the highway carries transformative potential: it would transform the landlocked region into a gateway for trade with Southeast Asia, significantly reducing logistics costs and creating a new economic corridor. It is a key enabler for India to strengthen its economic and diplomatic presence in the ASEAN region and a crucial counter to China's growing influence.

However, despite its immense promise, the project is decades behind schedule. While the sections in

Security Challenges: The highway passes through active conflict zones, creating an extremely dangerous environment for construction workers. such as the 1 Kalewa-Yagyi road and the Tamu-Kyigone-Kalewa bridge projects, have faced repeated delays due to the violence.

The highway's fate will depend on New Delhi's ability to navigate the complex and dangerous landscape of a civil war in its own backvard. Recent high-level visits by Indian officials to Myanmar highlight a continued commitment to the project despite the immense challenges.

TAIWAN'S PATH TO TRUE ENERGY RESILIENCE

aiwan is at a critical point in terms of its energy security: despite its global importance in semiconductor manufacturing, the island is highly vulnerable due to its heavy reliance on energy imports and centralized grid infrastructure. In short, Taiwan's current energy set-up exposes it to significant risks, both from potential external coercion and from natural phenomena.

In this context, some have argued that Taiwan should resume production of nuclear energy to ensure a secure power supply. While the reactivation of nuclear power plants may provide a stable energy base, it carries unacceptable risks and offers limited strategic advantage in the face of Taiwan's challenges. Instead, shifting to decentralized microgrids powered by diverse renewable energy sources and supported by a robust energy storage represents the most viable path to ensuring Taiwan's energy security and national resilience.

It is important to understand that a robust and decentralized energy infrastructure constitutes a strategic deterrent for the country. If Taiwan is perceived as capable of withstanding a prolonged blockade due to its energy resilience, the perceived effectiveness of such a blockade as a coercive tool is diminished. This perception plays a crucial role in the cost-benefit analysis of initiating a conflict, as it turns energy resilience into a component of "asymmetric defense" and "deterrence by denial" - making Taiwan a harder target and increasing the risks for any potential aggressor.


The Energy Achilles' Heel

Taiwan's current energy landscape is defined by an overwhelming dependence on imports, with the island importing around 96 percent of its total energy supply. Fossil fuels dominate the electricity generation matrix, accounting for approximately 80 percent of the total electricity produced in 2024. Of this share, natural gas makes up 42.4 percent, while coal contributes 39.3 percent.

Taiwan holds a critical position as the world's sixth-largest importer of liquefied natural gas (LNG), as of 2025. This heavy reliance is further exacerbated by a strategic energy reserve estimated to last only 11 to 14 days under normal consumption conditions. Such vulnerability exposes the island to sharp fluctuations in global energy prices, as seen in 2022 when fuel costs surged due

In a scenario marked by geopolitical tension this energy dependency becomes Taiwan's "Achilles" heel," posing an existential risk to the island's security. Defense and security experts have pointed out that a maritime blockade would likely be among the People's Liberation Army (PLA)'s strategies in a conflict over Taiwan, directly targeting these supply lines and potentially crippling Taiwan's energy infrastructure within weeks. Therefore, moving away from imported fossil fuels toward domestically sourced energy is not merely an environmental priority, but a matter of national security.

In addition, Taiwan's historically centralized electrical grid presents another major challenge to its resilience. With power generation largely concentrated in the center and south and heavy consumption in the northern urban centers, the centralized transmission system creates vulnerable chokepoints. This means that isolated failures can rapidly cascade into widespread blackouts across the island, as demonstrated by incidents like the major "303 blackout" in 2022 which was triggered by an equipment malfunction at the Hsinta Power Plant in Kaohsiung, where a switchyard failure caused a sudden imbalance in the southern grid. That fault tripped an ultra-high-voltage substation, triggering cascading shutdowns that left over



island-wide.

Distributed Resilience

A key shift in Taiwan's path to energy resilience is the adoption of distributed power systems, particularly microgrids, as an alternative to centralized energy infrastructure. These systems integrate local power generation, battery energy storage, and smart controls, allowing for autonomous operation when disconnected from the main grid. Microgrids are designed to function modularly, with automatic and seamless "islanding" capabilities, enabling them to continue supplying electricity during disruptions.

Battery storage lies at the heart of this architecture, playing a vital role in stabilizing intermittent renewable inputs, absorbing excess energy, and redistributing it during peak demand. It also enhances system reliability during grid failures. The strategic benefits of combining decentralized energy with storage include not only greater efficiency, sustainability, and cost savings, but also critical backup capacity for essential infrastructure - such as hospitals, data centers, and military fa-

The very features that protect against typhoons, such as distributed energy and islanding capabilities, are precisely those needed to withstand military threats, whether conventional, cyber, or electromagnetic pulse (EMP) attacks. This "dualuse" nature makes the microgrid strategy inherently robust and politically justifiable across multiple threat vectors. In this way, the energy transition is framed not only as an environmental initiative or disaster preparedness effort, but as an integral part of Taiwan's broader national defense

Recognizing these advantages, Taiwan's government has already pledged to invest NT\$564.5 billion (\$19.2 billion) in grid modernization, with emphasis on decentralization, energy storage, and system redundancy. These efforts have been shaped by previous crises, such as Typhoon Danas and major blackout events, which exposed vulnerabilities in the traditional grid model.

As part of its push toward a more resilient and flexible energy system, Taiwan is actively developing its battery storage infrastructure. The government has set a target of reaching around 590 megawatts (MW) of installed battery storage by 2025, combining efforts from both public initia-

atively small in scale compared to Taiwan's overall electricity demand, this capacity would play a crucial role in managing fluctuations from renewable sources and ensuring backup power during emergencies.

Looking further ahead, Taiwan plans to expand its energy storage capacity significantly, aiming for up to 20 gigawatt-hours (GWh) by 2030. This long-term goal reflects the country's commitment to integrating distributed storage into its broader strategy for energy security and national preparedness. Complementing these developments is Taiwan's considerable potential in renewable energy, particularly in solar and offshore wind. Geothermal energy also offers significant promise, though it remains largely untapped due to location constraints, regulatory complexity, and land use con-

Considering the national needs, the government has set ambitious renewable energy targets: 20 percent renewables by 2025 (up from 5 percent in 2020), including 5.7 GW of offshore wind power and 20 GW of solar capacity by 2025. By the end of 2024, Taiwan's total installed renewable energy capacity reached 21,067 MW, led by solar photovoltaic with 14,281 MW and wind energy with

Despite Taiwan's remarkable potential and its ambitious goals, the rollout of solar and wind projects has so far fallen short of expectations. This is not a matter of technology or resources. Rather, issues such as corruption scandals and local opposition have hindered progress, and for Taiwan's renewable-centered energy resilience strategy to succeed, these internal barriers must be addressed and overcome. This will require strong political will and effective public engagement.

What About Nuclear Energy?

Taiwan's nuclear energy policy has been politically contentious for decades, culminating in the decommissioning of its last reactor in May 2025, as part of its ambition to become a "nuclear-free homeland." However, the more vulnerable the population feels, the more divided public opinion has become regarding nuclear power in the country. The 2011 Fukushima nuclear accident in Japan deeply impacted public perceptions of nuclear safety in Taiwan. In its aftermath, widespread protests broke out across the island, reflecting

into strong majority support for phasing out nuclear energy, leading the government to suspend work on the almost-finished Lungmen (Fourth) Nuclear Power Plant.

Another key factor contributing to public opposition is the historical mishandling of nuclear waste, particularly the storage of low-level waste on Orchid Island (Lanyu) without fully informing the indigenous Tao people. This event left a deep trauma and fostered structural distrust in government assurances regarding nuclear safety and waste management. As a result, reaching public consensus for reactivation is extremely difficult, regardless of technical arguments.

Amid the shutdown of nuclear facilities, the debate has resurfaced due to rising energy demand driven by the semiconductor and AI industries, blackout concerns, financial losses at Taipower due to fuel costs, and the broader global narrative of a "nuclear renaissance." Pro-nuclear groups advocate for its stability and potential benefits to national security. However, even if nuclear energy were technically feasible or strategically appealing, the social cost and political capital required to overcome this deeply rooted distrust could prove prohibitive, diverting valuable resources and attention away from more effective resilience strategies.

Reactivating nuclear power plants in Taiwan would be a strategic miscalculation – one that both fails to address the nation's core vulnerabilities and also introduces new, unacceptable risks that

further compromise its resilience. The Limits of Nuclear Energy

China's "joint blockade campaign" is a central strategy of the PLA in a Taiwan contingency. This approach seeks to integrate military, cyber, space, and economic measures to isolate Taiwan and compel its surrender without the need for a fullscale invasion. A key component of this strategy is "network-centric coercion," which aims to sever Taiwan's connections with the outside world.

Closely related to a blockade is the possibility of a "quarantine," a gray zone operation led by China's coast guard and other law enforcement forces rather than the PLA. This type of operation offers China several strategic advantages: it is more politically reversible, not immediately considered an act of war, and could still compel foreign companies and governments to comply with their demands.

From an energy resilience standpoint, however, the differences between a blockade and a quarantine are subtle. A well-enforced quarantine could still heavily disrupt Taiwan's access to international shipping routes, including those necessary for importing fuel, uranium, and maintenance components essential to nuclear power plants.

Simultaneously, the economic and logistical uncertainty caused by such operations would suppress industrial activity, which accounts for over 50 percent of Taiwan's total power use, leading to a steep decline in overall energy demand. Under these reduced-demand conditions, existing coal plants, combined with an expanding portfolio of renewable energy sources, could sustain the island's electricity needs for over a year. This directly challenges the argument that nuclear baseload energy would be "essential" for survival in such a situation.

Furthermore, one of China's key strategic objectives in implementing a blockade or quarantine would be to avoid provoking a direct military response from the United States and its allies. To achieve this, China would aim to force the Taiwanese government to surrender – or at least lose its capacity to resist – as quickly as possible, ideally before any external intervention becomes fealeft over 2025, combining efforts from both public initia- growing anxiety about the risks of nuclear power. sible. In this context, Taiwan's ability to sustain itself energetically, especially through independent and resilient systems, becomes a critical deterrent. The longer Taiwan can endure without external support, the more time it buys for its defense forces to mobilize and for potential allies to intervene, undermining China's initial objective of a swift and contained campaign.

Nuclear Energy as a Dangerous Liability in an Open Conflict

In the event of a military conflict, China may prioritize seizing control of Taiwan's critical infrastructure – particularly its nuclear power plants - rather than destroying them outright. Direct strikes on these facilities could risk a catastrophic radiological disaster, rendering parts of the island uninhabitable. However, nuclear plants remain highly vulnerable in wartime. Even if not deliberately targeted, they can suffer collateral damage, accidental hits, or be used as strategic leverage during a struggle for control.

The case of Ukraine's Zaporizhzhia Nuclear Power Plant, captured by Russian forces in March 2022, underscores this risk. Since its occupation, the site has faced repeated shelling and drone strikes, sparking global concern over nuclear safety. Similarly, Chinese military exercises have included simulated attacks on Taiwan's energy infrastructure, suggesting that such facilities are seen as viable targets for disruption, if not total de-

The inherent risks of operating nuclear facilities in a seismically active, densely populated, and geopolitically volatile region are significantly magnified in wartime. During such periods, safety protocols may be compromised, and external power supplies may be disrupted. The possibility of a nuclear incident whether due to direct attack, collateral damage, or loss of control, is so catastrophic that it transforms nuclear energy into a dangerous liability in a warzone, regardless of China's initial intentions. The risk-reward analysis for Taiwan strongly favors avoiding such a potential disaster. The consequences of even a minor failure are so severe that the risk becomes simply unacceptable. Therefore, it becomes evident that the issue is not merely that nuclear power is unnecessary or dangerous in isolation, but rather that it fails to address the root causes of Taiwan's energy vulnerability, and introduces new, uncontrollable risks in the process.

Charting a Truly Resilient Future for Taiwan In light of the multiple challenges Taiwan faces, it is clear that energy resilience is a strategic imperative for national survival. In this context, the most realistic, secure, and effective solution does not lie in reactivating highly centralized and politically divisive nuclear power plants. Instead, it lies in building a decentralized energy system based on microgrids supported by energy storage. This approach enables the continuous, localized supply of electricity and dramatically reduces exploitable vulnerabilities for hostile actors.

Moreover, by being powered through renewable sources, these microgrids would enhance the island's self-sufficiency, gradually eliminating its reliance on imported fossil fuels. The integration of battery storage ensures grid stability and reliability, transforming the intermittency of renewables into a strategic advantage.

Therefore, if Taiwan truly seeks to ensure its energy security, protect its population, and preserve its sovereignty in the face of current and future threats, the most coherent response would be to invest in decentralization, storage, and renewable energy. This is the architecture of a truly resilient

Strengthening India's green shield for climate and disaster resilience

ndia is currently facing a rise in disasters. The recordbreaking heatwaves of 2024, with temperatures in parts of Rajasthan exceeding 50 °C, served as a stark warning of the extremes ahead. Cyclones Asna and Fengal caused widespread damage along the coasts, while Hiendured malavan states snowstorms, flash floods, landslides, and the looming threat of glacial lake outbursts.

The year 2025 has proven to be equally harsh. Uttarakhand and Himachal Pradesh have experienced unexpected cloudbursts, slope failures, and swiftly retreating glaciers that continue to destabilise fragile mountain ecosystems. Himachal Pradesh, specifically, faced repeated cloudbursts and flash floods that ravaged communities. At the beginning of August, the Himalayan village of Dharali was ravaged by a devastating flood, believed to have been caused by a glacial lake outburst.

Just weeks later, a sudden cloudburst in Kishtwar, Jammu and Kashmir, unleashed torrents of water that devastated houses. livelihoods, and lives.

These calamities are no longer isolated shocks but part of a systemic crisis. They are driven by a changing climate, reckless development in vulnerable areas. and most significantly, the degradation of natural buffers. Among the strongest of these natural buffers are forests — living systems that regulate rainfall, stabilise slopes, store carbon, and shield vulnerable communities from the worst impacts of climate extremes.

Forests: Nature's Climate Regulators

Forests are not merely scenic landscapes; they function as dynamic, self-supporting ecosystems that regulate climate and risks. They capture rainwater and slow its runoff, reducing flood peaks. Their root structures stabilise soils and slopes, reducing the risk of landslides. Coastal mangroves absorb the energy of storm surges, while in arid areas, shelterbelts protect farmlands from dust storms. In cities, tree cover lowers surface temperatures and reduces flash flooding by absorbing rainwater.

The India State of Forest Report 2023 reveals that forests and tree cover now extend over 25.17 per cent of the country's geographical area — 827,357 square kilometres — marking a modest but significant increase from 2021. The estimated total carbon stock in the nation's forests is 7,285.5 million tonnes. The carbon stock of the country has risen by 81.5 million tonnes in comparison to the previous assessment. Regarding status on achievement of target under Nationally Determined Contribution (NDC) related to carbon sequestration, the current assessment shows that India's carbon stock has reached 30.43 billion tonnes of CO2 equivalent; which indicates that as compared to the base year of 2005, India has already reached 2.29 billion tonnes of additional carbon sink as against the target of 2.5 to 3.0 billion tonnes by 2030.

Forestry Throughout the **Disaster Cycle**

Forests play a clear role throughout the entire disaster management cycle. During the prevention and mitigation phase, forests serve as buffers by managing water flow, minimising erosion, and reinforcing terrain stability. Coastal plantations protect inland regions from cyclonic winds and tidal waves, whereas inland forests lessen the intensity of droughts and sandstorms.

Preparedness also benefits from forestry. In Uttarakhand, forest watchtowers linked to satellite telemetry have been integrated into wildfire early warnsponses and timely evacuation. Forest departments regularly provide training to communities in fire management, enhancing their capacity to deal with disaster risks. When disaster strikes, forests

become a critical lifeline. Bamboo and wood serve as materials for temporary shelters, fodder supports livestock, and non-timber products offer food and medicine when supply chains fail. Forests also speed up recovery. Following Cyclone Fani, the restoration of mangroves in Odisha improved coastal defence while also rejuvenating livelihoods via fisheries and activities related to forests. In Bundelkhand, reforestation of watersheds enhanced groundwater recharge, turning drought-stricken villages into more resilient agricultural communities. In the Himalayas, focused reforestation has secured slopes and revived essential water regulation services.

Perspectives from India and Other Regions

India's forest programs illustrate how effectively focused actions can mitigate hazard risks. The restoration of mangroves in Odisha has shielded against cyclones. In the Kendrapara district of the state, villages shielded by mangroves suffered far less damage during the 1999 super cyclone and Cyclone Phailin (2013) than areas where mangroves had vanished. Uttarakhand's reforestation efforts in delicate catchments have minimised erosion and decreased flooding. In Rajasthan, establishing shelterbelts of resilient local species has safeguarded agricultural areas from desert winds and enhanced local microclimates.

In Himachal Pradesh's Shiwalik hills, afforestation and watershed programs have reduced soil erosion and landslides, protecting slopes and water resources. In cities like Delhi and Hyderabad,



urban forests and green belts have lowered temperatures by 2-

3°C and reduced flood risks. These lessons resonate globally. Japan has historically preserved coastal forests as a form of green infrastructure to reduce the effects of tsunamis. Chile incorporates forestry into its climate and disaster strategies. These instances emphasise a significant reality: forests represent more than biodiversity; they embody survival and resilience.

A Centre of Excellence in

Forestry To effectively realise the potential of forestry in enhancing resilience, India should pursue well-planned and forward-looking measures. At the core of this transformation lies the vision to

establish a Centre of Excellence in Forestry for Climate and Disaster Resilience (CEF-CDR) at the Indira Gandhi National Forest Academy — on the lines of the Centre for Disaster Management at the Lal Bahadur Shastri National Academy of Administration, Mussoorie — positioning it as a leading centre for forestrybased knowledge, innovation, and leadership in resilience building.

Designed as a centre for knowledge, innovation, and application, its mission would be: to utilise forestry as a primary defence against climate change and disasters, integrating science, technology, and local wisdom."

This centre could promote specialised training, facilitate ap-

plied research, encourage technology adoption, and foster international partnerships — making sure forestry stays integral to India's resilience framework. This must be complemented by better incorporation of forestry into national and state climate and disaster resilience plans, regarding forests as essential infrastructure for resilience rather than an afterthought. Requiring Disaster Impact Assessments in addition to Environmental Impact Assessments for all significant projects will enhance the protection of vital forests from immediate economic compro-

The capacity of institutions also needs to be enhanced.

The Cost-Benefit Advantage

forestry is as strong as the environmental one. Strategies for disaster risk reduction based on ecosystems provide benefits that far exceed their expenses. The contrast between natural and artificial defences is educational. Constructing seawalls along a coastline is highly costly, whereas rehabilitating mangroves provides similar or superior protection at a reduced price, along with additional advantages for fisheries, biodiversity, and carbon sequestration. Thus, investing in forests, therefore, is both a climate and financial strat-

From Silent Guardians to **Strategic Shields**

India today faces a dual challenge: accelerating climate change and escalating disaster risks. Forests, known for their capacity to cool the environment, stabilise slopes, shield coasts, reduce floods, and support livelihoods, represent some of the nation's most valuable yet underutilised resources.

To harness their full potential, India needs to alter its perception and management of forests. They should no longer be viewed merely as passive biodiversity reserves but as proactive, strategic shields-green infrastructure vital to national resilience. Accomplishing this necessitates courageous policies, more robust institutions, scientific innovations, and community involvement. It requires the incorporation of environmental protections at each phase of development planning and disaster

The way is evident. By treating forests as vital resources and investing in them with the seriousness they deserve, India can turn its "silent guardians" into active frontline defences — securing lives, livelihoods, and sustainable growth in an unpredictable climate. (Courtesy: The Poincer)



Tom Barrack made his comments in Beirut after trips to Israel and Syria where he discussed with officials there the ongoing situation in Lebanon following this month's decision by the Lebanese government to disarm Hezbollah by the end of the year. Hezbollah's leader rejected the government's plan, vowing to keep the weapons.

An alert to Australians in Iran noted the embassy's closure and urged them to "strongly consider leaving as soon as possible, if it is safe to do so."

"Foreigners in Iran, including Australians and dual Australian-Iranian nationals, are at a high risk of arbitrary detention or arrest," the warning read.

Australia updated its warning to travellers to its highest level: "Do not travel" to Iran.

Iran has a long history of detaining Westerners or those with ties abroad to use as bargaining chips in negotiations.

Foreign Minister Penny Wong said that Canberra would keep some diplomatic lines open to Tehran to advance Australia's interests. She added that it was the first time Australia has expelled an ambassador since World War II. Albanese aims to declare

Protesters in Israel demand release of hostages as Gaza strikes kill 16, hospitals say

LOD (ISRAEL), Aug 26: Protesters in Israel on Tuesday torched tires, blocked highways and clamoured for a ceasefire that would free hostages still in Gaza, as Israeli leaders pressed ahead with plans for an offensive which they argue is needed to crush

The disruption came as Palestinians in Gaza braced for the expanded offensive against a backdrop of displacement, destruction and parts of the territory plung-It also came a day after deadly strikes against

Gaza's main hospital killed 20 people including medics and journalists, among them Mariam Dagga, a journalist who worked for The Associated Press. Prime Minister Benjamin Netanyahu is expected to

hold a security cabinet meeting later Tuesday, but it's unclear if he will discuss ceasefire efforts. He has said that Israel will launch an expanded offensive in Gaza City while simultaneously pursuing a ceasefire, though Israel has yet to send a negotiating team to discuss a proposal on the table.

Netanyahu has said the offensive is the best way to weaken Hamas and return hostages, but hostage families and their supporters have pushed back.

"Go back to the negotiation table. There's a good deal on the table. It's something we can work with,"

said Ruby Chen, the father of 21-year-old Itay Chen, a dual Israeli-American citizen whose body is being held in Gaza. "We could get a deal done to bring all the hostages back.' Hamas captured 251 hostages on Oct 7, 2023. The

vast majority have been released during ceasefires. Is-

rael has only rescued eight hostages alive. Fifty hostages remain in Gaza, and around 20 of them are believed by Israel to still be living. Responding to a call from Israel's Hostages and Missing Families Forum for a "National Day of Strug-

gle," protesters waved banners that read "Hostage Deal Now" The relatives of hostages said they hope steady pressure can push Netanyahu and his security cabinet

to commit to ceasefire talks. But far-right members of his coalition have repeatedly threatened to bolt if Israel agrees to a truce and have dismissed the protesters' demands.

"We could have ended the war a year ago and brought all the hostages and soldiers home. We could have saved hostages and soldiers, but the prime minister chose, again and again, to sacrifice civilians for the sake of his rule," said Einav Zangauker, whose 25year-old son Matan was abducted from one of Israel's hardest hit kibbutzim on Oct 7. Trump fires Fed Governor Lisa Cook, opening new front in fight for control over central bank

WASHINGTON, Aug 26: US President Donald Trump fired Federal Reserve Governor Lisa Cook late Monday, a sharp escalation in his battle to exert greater control over what has long been considered an institution independent from day-to-day politics.

Trump said in a letter posted on his Truth Social platform that he is firing Cook because of allegations that she committed mortgage fraud. Bill Pulte, a Trump appointee to the agency that regulates mortgage giants Fannie Mae and Freddie Mac, made the accusations last week.

Pulte alleged that Cook had claimed two primary residences -- in Ann Arbor, Michigan and Atlanta -- in 2021 to get better mortgage terms. Mortgage rates are often higher on second homes or those purchased to rent. The announcement came days after Cook said she wouldn't leave her post despite Trump previously calling for her to resign. The Fed's board has seven members, meaning Trump's move could have deep economic and political ramifications.

Trump said in announcing the move that he had the constitutional authority to remove Cook, but doing so wll raise questions about control of the Fed as an independent entity. The firing is likely to touch off a legal battle and Cook could be allowed to remain in her seat while the case plays out. Cook would have to fight the legal battle herself, as the injured party, rather than the Fed. (AP)

Nearly 2 lakh people evacuated across Pak's Punjab amid rising water levels in eastern rivers

LAHORE, Aug 26: Nearly two lakh people were evacuated from flood-prone areas to safer places across Pakistan's Punjab province till Tuesday as authorities issued warnings and alerts regarding rising water levels in almost all eastern rivers.

"Indus, Chenab, Ravi and Sutlej rivers are experiencing low to high flooding owing to torrential monsoon rains in the catchment areas, and more rain is expected over the next 48 hours," Punjab Emergency Services Rescue 1122 spokesperson Farooq Ahmad said in a statement. He said the evacuation operation is being conducted in Kasur, Okara, Pakpattan, Bahawalnagar, Vehari, and Narowal, with 25,000 people relocated to tem-

porary residences from these flood-hit areas. A senior official of Punjab Emergency Services told PTI on Tuesday that nearly 200,000 people have been evacuated from Kasur, Okara, Pakpattan, Bahawalnagar, Vehari, Layyah, Bhakkar and Narowal.



"Over 175,000 people left their houses on their own, while 25,000 people, who were stuck in flood-hit areas, have been rescued through boats by the government rescue agencies," the official said.

Hundreds of houses have been damaged by the floods, Ahmad added.

"A high alert has been issued in Kasur,

Okara, Pakpattan, Bahawalnagar, Vehari and Narowal in light of a flood alert by India," he

According to the Provincial Disaster Management Authority (PDMA), there has been a high flood alert in Punjab because of heavy

"There is a risk of high to very high flooding in the Chenab, Ravi and Sutlej rivers, whereas urban flooding is also expected in the Rawalpindi, Lahore, and Gujranwala divisions," it said.

It added that a high-level flooding warning has been issued at the Harike location of the

"However, there is a low flood situation at Kalabagh and Chashma in the Indus River, while the water flow is at a normal level at Tarbela and Taunsa. There is a high flood situation at Ganda Singh Wala in the Sutlej River and a medium flood at Sulemanki. There is a medium flood situation at Marala

and Khanki on the Chenab River," the PDMA said. On Sunday, India communicated flood warnings to Pakistan through diplomatic channels on "humanitarian grounds". It was the first known official contact between India and Pakistan since a four-day conflict between the two sides in May.

A day after the Pahalgam terror attack on April 22, India took a series of punitive measures against Pakistan that included putting the Indus Waters Treaty of 1960 in "abevance". Usually, flood alerts are shared through the Indus Water Commission.

An alert by the Punjab PDMA on Monday reported "high flood level" in the Sutlej River. The Pakistan Meteorological Department (PMD) also issued a flood warning for the Chenab River and Ravi River on Monday.

The National Disaster Management Authority (NDMA) has warned of heavy rains across most parts of Pakistan until August

Urban Affairs Minister Balo Raja joins virtual meet on Swachhata Hi Seva 2025 rollout

The second is the Safai Mitra Suraksha Shivirs, under which single-window camps will be organised to provide preventive health check-ups and welfare support to sanitation workers.

Arunachal to get city gas distribution network BPCL, OIL sign agreement to set up JV



ITANAGAR, Aug 26: Arunachal Pradesh is set to get a city gas distribution network with Bharat Petroleum Corp Ltd (BPCL) and Oil India Ltd (OIL) signing an agreement on Tuesday to set up a joint venture company to implement the project.

As a part of the project, Compressed Natural Gas (CNG) stations will be set up and Piped Natural Gas (PNG) will be supplied to households, commercial units, and industries in the state, a statement

The initiative is aimed at expanding clean energy access and contributing to the socioeconomic development of the northeastern state, in line with the government's gas-based economy vision, it said.

The agreement was signed at BPCL's corporate office in Mumbai in the presence of its CMD Sanjay Khanna and

OIL's CMD Ranjit Rath. "This joint venture reaffirms BPCL's commitment to expanding clean energy access

across India, with special focus on the North-East. Together with OIL, we will build a strong city gas distribution network to serve households, industries, and transport," Khanna said.

"Arunachal Pradesh holds great potential, and through this initiative, we aim to drive sustainable growth, improve quality of life, and support India's vision of a gas-based economy," he added.

Rath said the establishment of the gas distribution will be a significant step for OIL to realise its vision of bringing clean and reliable energy to the re-

"OIL has a long-standing legacy of hydrocarbon production in the state and with the commissioning of the Kumchai-Kusijan gas pipeline last year, we successfully reinforced our role as an anchor in advancing the Centre's hydrocarbon vision for the Northeast," he added. (PTI)

India expects condemnation of cross-border terrorism by upcoming SCO summit in China

NEW DELHI, Aug 26: India on Tuesday said it expects the Shanghai Cooperation Organisation (SCO) to strongly condemn crossborder terrorism at its annual summit in the Chinese city of Tianjin next week, comments that came ahead of Prime Minister Narendra Modi's visit to China

Modi will begin a four-day visit to Japan and China from August 29 to September 1.

In the first leg of his trip, he will travel to Tokyo to hold the annual India-Japan summit with Prime Minister Shigeru Ishiba. The two prime ministers will also meet outside Tokyo as well.

After concluding his trip to Japan, Modi will visit Tianjin to participate in the SCO summit on August 31 and September 1.

At a joint media briefing with

Foreign Secretary Vikram Misri, Secretary (West) in the external affairs ministry, Tanmaya Lal, said New Delhi is working with other SCO member nations and partners to ensure strong condemnation of terrorism in the summit declara-

"The SCO was established with the primary goal of countering three evils of terrorism, separatism and extremism, which continue to remain a challenge," he said.

Lal said the security of the region remains a priority for the SCO members and recalled a joint statement on countering radicalisation, extremism and terrorism that was adopted during India's presidency of the grouping in 2023.

"In the past, there have been strong condemnations of terrorism, including cross-border terrorism, in the statements that have been finalised, including the joint statement that I referred to, which was finalised during our presidency of the summit," he said.

"As far as the declaration at this (upcoming) summit is concerned, that is under finalisation -- the text. We are working with other members and partners to see that there should be a reiteration of the strong condemnation of terrorism. including cross-border terrorism. But the text is under finalisation.' he said. Lal's comments came in response to a question on how the SCO will deal with the threat of terrorism.

India launched Operation Sindoor on May 7, targeting terrorist infrastructure in territories controlled by Pakistan in response to



strikes triggered four days of intense clashes that ended on May 10. Modi is expected to hold a bilateral meeting with Chinese President Xi Jinping on the margins of

Five killed, 14 injured in landslide on route to Vaishno Devi shrine

JAMMU, Aug 26: Relentless heavy rain led to a landslide on the route to the Mata Vaishno Devi shrine atop the Trikuta hill on Tuesday afternoon, killing at least five people and injuring 14, officials said. Several people were feared trapped.

The pilgrimage to the famed shrine in Jammu and Kashmir's Reasi district was suspended when the mountainside literally gave way and stones, boulders and rocks came hurtling down around 3 pm, catching people unawares.

Rescue operations are underway near the Inderprastha Bhojnalaya at Adhkwari, officials said. The landslide struck at a point about halfway along the winding 12-km trek from Katra to the hilltop

There are two routes up to the shrine -- while the yatra had been suspended on the Himkoti trek route since morning, it was going on on the old route till 1.30 pm when authorities decided to suspend it till further orders in view of the torrential rain.

"In an unfortunate incident of landslide at Adhkwari, 5 people have lost their lives and 14 others have been injured. Rescue operations underway," the Shri Mata Vaishno Devi Shrine Board said in a post on X. Kiran, from Mohali in Punjab, was among those caught in the hail of stones, trees and boulders. "I was coming down the hill after performing darshan when people started shouting. I saw stones falling down. I rushed to safety but was injured," Kiran told reporters from a hospital bed in Katra. "We were a group of five out of which three are injured," added another girl, traumatised by her narrow escape." (PTI)

Lancet study draws attention to rising C-section deliveries, calls for regulation in private healthcare

NEW DELHI, Aug 26: Seeing a rise in caesarean deliveries in India -- from 8.5 per cent in 2005 to 21.5 per cent in 2021 -- which is well above WHOrecommended levels, researchers are calling for policy measures, including more regulation in private healthcare, in an analysis published in The Lancet Regional Health Southeast Asia journal.

Delivering a baby via a caesarean section (C-section) involves making a surgical cut in the mother's abdomen and uterus.

The researchers, including those from the Institute of Public Health Bengaluru and Christian Medical College in Vellore, Tamil Nadu, said that while a medically indicated C-section is vital to preventing maternal and newborn mortality, rates of caesarean deliveries exceeding 10 per cent in the population are not linked with reduced mortality -- as noted by

the World Health Organization. An unjustified caesarean delivery is related to longer hospital stays and higher healthcare costs, with babies born through the procedure known to be at an increased risk of asthma, obesity, type 1 dia-

betes and allergies, among other health problems. The team reviewed 75 previously published studies -- mostly from India, followed by Bangladesh and Pakistan -- and examined factors in the countries' health systems contributing to caesarean pro-

cedures in the population. The authors said that an avoidable caesarean de-



livery can be financially stressful for families across South Asia, where a substantial fraction of deliveries

occur in the private sector. For example, out-of-pocket expenditures for a Csection in India will cost around Rs 43,000 in private hospitals, and around Rs 8,500 in public ones, suggesting that avoidable caesarean deliveries unnecessarily burden the healthcare system and families,

they said. Limited regulation and insurance coverage were among other factors associated with increased C-sec-

Decision-making at the healthcare provider's level was influenced by financial incentives, medico-legal concerns and scheduling convenience, the researchers said

Mother's education, socioeconomic status and age, and family preferences were found to be individual and community-level factors driving an upward trend in caesarean deliveries.

Caesarean deliveries in Bangladesh are estimated to have increased from 18 per cent in 2011 to 45 per cent in 2022, while those in Pakistan rose to 20 per cent in 2018 from about three per cent in 1990. Data from national surveys were analysed for arriving at the figures.

The authors said that caesarean deliveries are being resorted to at nearly double the rates since 2000, with one in every five births involving the sur-

C-section rates in Asia rose from 4.4 per cent in 1990 to 19.5 per cent in 2014, with south Asia reflecting similar upward trends seen across the continent, they said.

"The review highlights the need for coordinated policy responses across levels, including payment reforms, regulatory oversight, and improved antenatal counselling, to ensure (C-section) use aligns with clinical need rather than socio-economic or institutional pressures," the authors wrote. (PTI)

Report claiming 'Manipur strife orchestrated' serves to deepen divide, prolong mistrust: Ex-CM

IMPHAL, Aug 26: Former Manipur chief minister N Biren Singh alleged that a report of Delhi-based non-profit organisation PUCL claiming that the ethnic violence in the northeastern state was "orchestrated and not spontaneous" serves only to deepen the divide, prolong mistrust and may even promote misunderstanding.

Singh was the chief minister of Manipur when ethnic violence, which has claimed over 260 lives and rendered thousands homeless so far, erupted between Imphal Valley-based Meiteis and adjoining hills-based Kukis in May 2023.

BJP's Rajya Sabha MP Leishemba Sanajaoba said that "more than 3,000 FIRs" will be lodged against PUCL for its claim.

Their reactions came after Imphal-based human rights organisation Human Rights International Freedom (HRIF) threatened to take legal measures against the People's Union for Civil Liberties (PUCL)

3 militants arrested in Manipur, arms and ammunition seized

IMPHAL, Aug 26: Three militants belonging to three proscribed outfits have been arrested by security forces in Imphal East and West districts of Manipur, police said on Tuesday. An active cadre of the banned Kangleipak Communist Party (PWG) was arrested from Taothong Khunou area in Imphal West district on Sunday.

The insurgent, identified as Oinam Somenchandra Singh (41), was involved in extortion from shops and the general public. A pistol with a magazine was seized from his possession, a police statement said.

A militant belonging to the proscribed People's Liberation Army was arrested from Huikap Makha Leikai in Imphal East district on Sunday. He was identified as Phanjoubam Ramanada Singh (23), it said. An active cadre of KCP(MFL) was arrested from Takhel in Imphal East district on Monday.

Meanwhile, security forces seized a cache of arms and ammunition and explosives from Singtom village in Kakching district on Monday. The seized weapons include an INSAS rifle, a bolt-action rifle, two 51mm mortars, two country-made carbines, one .32 pistol. seven IEDs, 56 cartridges of various calibres, two tear smoke grenades and other items. (PTI)

Addressing a programme during which appointment letters were handed to newly-recruited medical officers, Saha said steps have also been taken to recruit specialist doctors

in government hospitals. We are in the process of adding 100 more MBBS seats in AGMC. We have received an indication to go ahead with the plan. We are also planning to introduce super speciality medical courses at AGMC. We are in touch with the National Medical Council (NMC) to materialise the plan," he said.

"We are receiving wishlists from MLAs to get specialist doctors in their areas, but there is a shortage of specialist doctors in the state. We sought to fill vacancies for 180 specialist doctors, but got only 45. The government will again recruit

specialist doctors with more doctors having cleared MD and MS courses by that time," he said.

At present, there are 100 seats in MBBS and 89 seats for post-graduate courses at the AGMC. Saha said the government has already taken steps

to recruit technical and paramedical personnel to boost the healthcare facilities in the state.

He also sought to put to rest the ongoing controversy over the recruitment of those candidates for General Duty Medical Officers (GDMOs) who scored 14, 18 and 21 in the examination conducted by the Tripura Public Service Commission (TPSC).

"These are grade marks, which have no value when it comes to judging the quality of a medical officer. A student who completed an MBBS course had to take a tough entrance test like NEET after ensuring a good performance in the class 12 board exams. The NMC has

already provided them with a degree. Therefore, the allegation of a very poor mark has nothing to do with medical practice," he said. (PTI)

Mizoram saw new investments worth ₹ 16,800 cr in last four fiscals: Report

GUWAHATI, Aug 26: Mizoram has witnessed investments of nearly ₹ 16,800 crore in various new projects during the last four fiscals, according to a latest report by MSME Export Promo-

tion Council. The report, titled 'Investment, Development & Growth in Progressive Mizoram', highlighted that the Northeastern state is registering robust economic growth and has seen notable expansion across its sectors.

"It has attracted an investment in the new projects between 2021-22 and 2024-25 of ₹ 16,720 crore," MSME Export Promotion Council (MSME EPC) said. In 2021-22, the state saw new investments of ₹ 2,587 crore, followed by ₹ 126 crore in 2022-23, ₹ 41 crore in 2023-24 and ₹ 1,397 crore in 2024-25, it

Apart from these, investments were made in various ongoing and completed projects, it added. "It is expected that these projects have generated direct employment opportunities for 30,000-35,000 people and 20,000 indirect jobs," MSME

While projects worth ₹ 1,918 crore were completed between 2021-22 and 2024-25, projects

50,000 people. The services sector has been a significant contributor to the extent of 45-46 per cent of the gross state value added (GSVA)," it said.

MSME EPC Chairman DS Rawat said the sector witnessed improvement and its GSVA share rose from 25 per cent to 34 per cent, while agriculture and aligned sectors declined from 25 per cent to about 20 per cent.

"The state's economy is growing consistently, ranging from 13 to 15 per cent. The MSME sector in the state is poised for a significant upward trajectory," he said.

The report said there is a huge untapped potential in the tourism sector in the state.

"To tap into its potential, the state should promote eco-adventure packages, wildlife safaris and trekking circuits, highlight festival tourism, accelerate village tourism, enhance infrastructure and explore cross-border tourism," it said. (PTI)

Meghalaya PSC reforms panel recommends tighter safeguards in recruitment process

SHILLONG, Aug 26: The Meghalaya Cabinet on Tuesday reviewed the report of the state PSC reforms committee, which recommended stronger safeguards in recruitment, including strict confidentiality of question papers and installation of CCTV cameras during interviews to ensure greater transparency. The report also proposed publication of candidateto-vacancy ratios and release of answer keys, Chief Minister Conrad K Sangma said. The report recommended short, medium and long-term reforms to make the Meghalaya Public Service Commission (MPSC) more efficient and accountable.

Short-term measures include formation of multiple interview boards, clear interview protocols, conflict-of-interest reviews, declaration of assets by the chairman and members, preparation of an annual calendar of activities, and public disclosure of interview marks and candidate scores.

It also proposed a grievance cell, maintaining unchanged roll numbers during recruitment and addressing corruption issues under the Meghalaya Lokayukta Act, 2014. Medium and long-term steps suggested are shifting to computer-based

tests, strengthening MPSC cells in Jowai and Tura towns, combining examinations with similar qualifications to avoid delays, and continuing the use of optional papers in major competitive exams. (PTI)

Govt school teachers launch agitation in Nagaland

KOHIMA, Aug 26: Academic activities in 133 government high schools across Nagaland were disrupted on Tuesday as the Nagaland RMSA Teachers Association (NRMSTA) 2016 batch launched its phase-wise indefinite agitation over long-pending service bene-

The agitation began with a pendown strike after the expiry of the teachers' ultimatum to the state government on August 13.

The association said the protest was necessitated by the government's "continued silence" despite court verdicts in its favour.

"Our members are attending the respective school but are not carrying out any pen and paper works,' NRMSATA-2016 president Imlitemien told PTI here. (PTI)

₹44.02 cr released as first installment of XV FC grants for rural local bodies in Mizoram, Tripura

AGARTALA, Aug 26: The Union Government has released the first installment of the Fifteenth Finance Commission (XV FC) Untied Grants for Rural Local Bodies (RLBs) in Mizoram and Tripura for the financial year 2025-26.

According to official reports, Mizoram has received ₹ 14.27 crore for 827 eligible Village Councils as part of the 2023-24

Meanwhile, Tripura has been allocated ₹ 29.75 crore covering 606 eligible Gram Panchayats, 35 Block Panchayats, 8 Zilla Parishads, 587 Village Committees, and 40 Block Advisory Committees under the first installment of the 2025-26 Untied

"Government of India, through the Ministry of Panchayati Raj and Ministry of Jal Shakti, recommends release of XV FC Grants to states for Rural Local Bodies (RLBs)/Panchayati Raj Institutions (PRIs). These grants are released in two installments every financial year," an official statement said.

The Untied Grants are to be utilized by



RLBs/PRIs to address location-specific developmental needs under the 29 subjects listed in the Eleventh Schedule of the Constitution, excluding salaries and establishment costs.

In contrast, the Tied Grants are earmarked for basic services, specifically maintenance of sanitation and ODF status, including household waste management, treatment of human excreta, and fecal sludge management.

Ensuring supply of drinking water, rainwater harvesting, and water recycling

This allocation is aimed at strengthening grassroots governance and ensuring sustainable development across rural areas of both states.

Coordinating committee on Manipur integrity

IMPHAL, Aug 26: The Coordinating Committee on Manipur Integrity (CO-COMI) has strongly rejected the recently released Independent People's Tribunal (IPT) report of the People's Union for Civil Liberties (PUCL), alleging that it is "biased, misleading and politically engineered" one to vilify the Meitei community while legitimising separatist agendas of Chin-Kuki armed groups. In a statement issued on Tuesday, CO-

COMI said the 694-page report, prepared under the chairmanship of former Supreme Court judge Justice Kurian Joseph, was "deliberately structured to appease separatist aspirations" and contained selective omissions and fabrica-

COCOMI alleged that the report misrepresented the Meitei Scheduled Tribe (ST) demand, spread false narratives on the outbreak of violence, and presented a one-sided portrayal of victims. It also accused the tribunal of ignoring the role of Kuki-Chin armed groups despite public admissions by their leaders, while repeatedly naming Meitei groups such as Arambai Tenggol and Meitei Leepun.

COCOMI further criticised the report for omitting key incidents, including the May 3 Torbung-Kangvai clashes "where



Meitei homes" were allegedly first torched, the "Jakuradhop massacre" in Jiribam, and cases of enforced disappearances. It said the tribunal endorsed separatist narratives," justified poppy cultivation, and made "false historical claims" that demonised the Meitei com-

Announcing its next steps, COCOMI said it will conduct a public review of the report to expose its "falsehoods and omissions" and pursue legal action against PUCL and tribunal members for "defamatory and unfounded statements."

It also vowed to mobilise civil society, intellectuals and legal experts to safeguard Manipur's unity and integrity.

"The PUCL-IPT report has no legitimacy and no credibility. It does not serve the cause of peace, justice or reconciliation. Instead, it emboldens narco-terrorist groups and weakens national security," the statement read.

COCOMI concluded that Manipur does not need "propaganda masquerading as human rights" but rather "truth, fairness and collective resolve to restore peace, integrity and unity." (NNN)

SOME FILMS WITHOUT NUANCE OR CRAFT TAKING

ADVANTAGE OF HYPER POLITICAL ENVIRONMENT,



NEW DELHI, Aug 26: We are living in a hyper political environment with religion conclusively dividing society and some films "without nuance or craft" are taking advantage of that to bring in the numbers, says a

tough talking John Abraham. Films can be patriotic in a restrained and responsible way without being jingoistic, adds the actor, who has done a series of geopolitical thrillers in recent years and was last seen in ZEE5's 'Tehran''

"There are films that are patriotic that make a lot of sense," Abraham told PTI, citing his film "The Diplomat", which saw the actor in the role of diplomat J P Singh who rescued an Indian woman from Pakistan.

"Not because I have done it, but The Diplomat is one of those films where you're not jingoistic, you're not beating your chest. But you are patriotic in a resilient, silent, and restrained way," the actor said. Beginning his journey in movies with the 2003 film Jism and working through comedies such as Garam Masala and Dostana, the actor

has moved on to films on politics and diplomacy with Madras Cafe, Parmanu, and The Diplomat.

"Please understand and words, I think we are living in a hyper political environment where religion is dividing us very conclusively, which is not the most

live in," he said.

"Some films are taking advantage of that and bringing in the numbers. That's really unfortunate to see because when you see certain films, you see there is no nuance or craft there, but you see that there are tropes. And it is a scary sight to see today," John told PTI in an interview.

According to John, propaganda films will continue to be made as moviemaking is a creative space where you are allowed to make the kind of films you want to.

He turned producer with Vicky Donor in 2012 and his recent releases have mostly focused on stories inspired by real incidents, be it Madras Cafe, set during the Sri Lankan civil war and Rajiv Gandhi's assassination, or Parmanu, a film about the 1998 nuclear bomb test explosions in Pokhran.

"My responsibility is making films that are very balanced... Our audiences will stay on for way longer than the films that just want to take advantage of a situation. That is important to know," he said.

As far as making money is concerned, one can do that through commercial and fun films like Pathaan, according to the actor who played the antagonist in the Shah Rukh Khan-starrer.

"They can make you money. You don't necessarily need to take advantage of a system to make money. That's a personal choice you have to make. I have made the choice that I would not take advantage of that though I am very equipped to do so. But I won't do that because that's not where I come from. That's not my fabric," he said.

"That's not the way I've been brought up. I've been brought up as a person who needs to be a responsible citizen of this country, who needs to say responsible things. Now, am I right all the time? Definitely not. I could make mistakes, but I would want to be more right than wrong," he added.

John said he loves playing the occasional bad guy whether in Dhoom or most recently in Pathaan. (PTI)

But that does not give anyone the right to film private residences and push those videos online. 2-time Wimbledon champion Petra Kvitova and Caroline Garcia head to retirement after US Open losses

NEW YORK, Aug 26: Petra Kvitova looked to her right as she sat down in the U.S. Open's main interview room for her final postmatch news conference as a professional tennis player, and the two-time Wimbledon champion saw what she was hoping for.

"Tissues are here. Very good," Kvitova said. "I'll try to be

While speaking to reporters following a 6-1, 6-0 loss to Diane Perry in the first round at Flushing Meadows, the last tournament for Kvitova before retirement, the 35-year-old left-hander was in a good mood, smiling or laughing at some of her own answers.

The tears she shed on court right after the 52-minute defeat were no longer flowing.

Kvitova, who said she came down with a case of COVID-19 a few weeks ago and considered pulling out of the U.S. Open, hadn't expected to be so emotional on



morning, I felt it. I felt it would be not good. I couldn't eat. I was really nervous. But in different way, I would say. I couldn't move. I couldn't swing, I couldn't do anything," she explained.

"It was really difficult. I never (had experienced) ... knowing I'm playing my last match, most

After it ended when she sent a backhand return wide, Kvitova began crying. She went over to the stands for a hug and a kiss from her husband, Jiri Vanek, who is also her coach. They became parents in July 2024, when their son, Petr, was born, and Kvitova returned to the tour this season after a 17-month break.

She announced earlier this year that she would stop playing after the U.S. Open. So had another tour veteran, 31-year-old Caroline Garcia of France, who also headed to retirement Monday

"Obviously you can always achieve more, and I was dreaming of achieving more," said Garcia, a 2022 semifinalist in New York. "But I'm very happy and (at) peace with my decision to move forward with my life and close the chapter of being a tennis

Kvitova won Grand Slam titles at Wimbledon in 2011, defeating Maria Sharapova in the final, and 2014, with a victory over Eugenie Bouchard. She also was the runner-up to Naomi Osaka at the 2019 Australian Open and was ranked as high as No. 2.

In December 2016, she was stabbed at her home by a knifewielding intruder. Kvitova needed hours of surgery to repair nerves and tendons in her racket-holding

Venus Williams' pain-free return to Grand Slam tennis means more to her than a US Open loss

Venus Williams lost her first Grand Slam match in two years — and what she says will be her last match of 2025 — didn't really matter.

Certainly not to the thousands of supportive spectators in the Arthur Ashe Stadium seats who roared for her best shots and, in a way, for everything her career means to them, before sending her off the court with a standing ovation after a 6-3, 2-6, 6-1 defeat against 11thseeded Karolina Muchova at the U.S. Open.

The result also sure seemed beside the point to Williams herself, at 45 the oldest singles player at Flushing Meadows since 1981. She smiled and laughed and joked through her postmatch news conference — until, that is, a reporter asked something that made her think back to all of the injury and illness issues she dealt with for years. "Oh, what did I prove to myself?" Williams began, repeating part of the question. "I think for me, getting back on the court was about giving myself a chance to play more healthy. When you play unhealthy, it's in your mind. It's not just how you feel. You get stuck in your mind too. So it was nice to be freer."

As she spoke those last few words, Williams bowed her head and closed her eyes, which welled with tears. After several seconds of silence, the tournament moderator ended the O-and-A session and Williams rose from her seat at the front of the room.

This was just the fourth singles match of a comeback that began in July after 16 months off the tennis tour, time marked by pain from uterine fibroids she had surgery for last year. "My team and I, we worked as hard and as fast as we could. We literally took no days off. I haven't gone to dinner. I haven't seen friends. I haven't done anything except train for three months as hard as I could," Williams said. "From each match that I didn't win, then I tried to go back and learn from that and then get better.'

U.S. Open in singles since 2019, when she got to the second round. Since then, Williams exited in the first round in 2020, 2022 and 2023, and missed the tournament in 2021

Being back in the arena meant so much to her — and to those watching. "I don't think I've ever had a crowd that much on my side," said Williams, who appreciated the backing and yells of "Let's go, Venus!" that came from the stands even as she dropped 11 of the night's first 13 points. "I knew going into this match that people in this stadium, people in the United States, people around the world, were really rooting for me, and that felt great.'

This event holds a special place in her career. Her first Grand Slam final came at the 1997 U.S. Open, when she was 17. She won two of her seven major championships there, in 2000 and 2001.

And it was at the U.S. Open more than a decade ago that Williams withdrew before she was supposed to play in the second round, revealing she had been diagnosed with Sjögren's syndrome, an energy-sapping auto-immune disease that can cause joint pain.

Some thought she might leave tennis because of that, but she remained a leading figure — on and off the court. "She's such a legend of our sport," 2023 French Open runner-up Muchova said, calling it an honor "to share a court with her."

Muchova, a 29-year-old from the Czech Republic, made it to the semifinals in New York in both 2023 — when she lost to eventual champion Coco Gauff in a match interrupted by a climate protest and 2024. So perhaps it wasn't surprising that Williams started slowly. But with her fiance, Andrea Preti, leaping out of his seat after many points, Williams got back into the match, smacking vintage serves at up to 114 mph and finishing with just one fewer winner than Mu-

Australian Open champion Madison Keys loses in US Open 1st round to Renata Zarazua

NEW YORK, Aug 26: Pretty much from the get-go at the U.S. the final at Melbourne Park — was ponents ranked in the top 10. over just as it began. The interval of the final at Melbourne Park — was ponents ranked in the top 10. Open, Madison Keys could tell she wasn't hitting the ball well or feeling very much at all like the self-confident player who claimed her first Grand Slam title at the Australian Open in January. After 89 unforced errors, including 14 double-faults, the No. 6-seeded Keys was gone from Flushing Meadows in the first round with a 6-7 (10), 7-6 (3), 7-5 loss to 82nd-ranked Renata Zarazua of Mexico. "For the first time in a while ... my nerves really got the better of me, and it kind of became a little bit paralyzing," said Keys, the runner-up in New York to good friend Sloane Stephens in 2017 and a semifinalist in 2018 and 2023, "I felt like I was just slow. I wasn't seeing things the way that I wanted to, which I feel like resulted in a lot of bad decisions and lazy footwork."

Her first U.S. Open with the status of major champion — thanks to defeating No. 1 Aryna Sabalenka in

"You always kind of feel firstround jitters and, as the day is getting closer, feeling a little bit more and more nervous," said Keys, who played with her left thigh heavily taped. "But I feel like, for whatever reason, today I just couldn't separate myself from ... feeling like winning matters just way too much." She made so many mistakes off

the spin-laden shots coming her way that Zarazua needed to produce just eight winners to earn the biggest victory of her career. Zarazua lost in the first or second round of all eight of her previous Slam appearances. Yet somehow, it was Zarazua who

managed to deal with any nervousness better, even though she was competing in cavernous Arthur Ashe Stadium for the first time and had only had a chance to hit there once a couple of days prior.

The 5-foot-3 Zarazua came into the day with a 0-6 record against op-

coming in here, it was like: Oh, my God. This is huge," Zarazua said about the largest stadium in tennis, which holds nearly 24,000 spectators. When the match ended with Keys missing a forehand, Zarazua smiled as wide as possible, held her racket atop her head, then placed a hand over her face.

This one certainly was memorable, in part because it did not come easily and lasted 3 hours, 10 minutes. Zarazua trailed by a set — after frittering away five chances to take the opener — and 3-0 in the second. Quite a daunting deficit. But she never went away. "Kudos to her for making me play a lot of balls today," Keys said. "I mean, she's a tricky

While Keys was one of 25 American players in the women's singles draw, the 27-year-old Zarazua is Mexico's lone entrant in the bracket.

"In Mexico, yeah, it's probably not the most famous sport," Zarazua said about tennis, which she picked up after starting out in gymnastics and diving. "I got into tennis," she explained, "just because my brother

was playing, and he was like, I think

Smells of weed, roars of airplanes, loud crowds: It's all part of the US Open's chaos

NEW YORK, Aug 26: There are even if it doesn't reach Medvedev some tennis players, such as Frances Tiafoe or Madison Keys or Ben Shelton, who can't wait for the U.S. Open to come around each year, with its boisterous crowds, its bold-faced names in the stands, its music at changeovers, its buzz. To them, the louder, the better. Start the show and bring the noise.

"I operate well in chaos," said Tiafoe, twice a semifinalist at Flushing Meadows.

Sometimes, it all can get out of control, as happened during a match that ended early Monday. There was a delay of more than five minutes while spectators booed and shouted — egged on by 2021 champion Daniil Medvedev, who was angered by chair umpire Greg Allensworth's ruling after a photographer interrupted play by going on court, of all things.

"They didn't want to stop," Medvedev said about the fans. "So,

levels. Not everyone is able to shrug off that sort of mayhem at a Grand Slam tournament famous some would say infamous - for the over-served fans, airplanes roaring overhead, the Manhattan-Queens commute and the odors of everything from marijuana to food being grilled.

"It's something you really can't train the brain to kind of deal with," 1991-92 champion Monica Seles said. "You just adjust to it."

I've visited most of the places in New York; I don't need to go to Central Park for the 1,003rd time," said Adrian Mannarino, 37, a Frenchman who began his 15th U.S. Open on Sunday by upsetting 29th-seeded Tallon Griekspoor.

"It used to be fun," Mannarino said about the tournament, "but sometimes I'm like, Gosh, I wish I could concentrate a little bit more." The types of scenes at the

US Open do not show up at Wimbledon. The hushes that envelope Wimbledon's Centre Court or the French Open's Court Philippe-Chatrier — which hold nearly 10,000 fewer spectators than 23,859-seat Arthur Ashe Stadium — are harder to come by in New

"Wimbledon, for example — it's proper, it's elegant, it's elevated. People are definitely more quiet and respectful, I guess you could say," said Emma Navarro, an American who reached the semifinals at Flushing Meadows last year. "U.S. Open, it feels a bit more casual. Casually rowdy, I guess I would call it." There is a constant hum at Ashe

and other arenas.

"If I was here for six weeks, eight weeks or 12 weeks, I could take that one week at a time, prepare myself mentally that way and just use the facility and stay in that moment and move in the right direction."

Recalling the time when he first understood the gravity of his injury, Suryakumar said it was a problem quite similar to the one he had experienced in the past. "It actually got diagnosed close to the

end of IPL. I felt it because I had the similar kind of injury last year as well and that's how I got to know. So a few checklists were there," said Suryakumar, who had an ankle surgery in 2023 and underwent another sports hernia procedure in early 2024.

"I tried those things and then I realised that it's time to go and do a small MRI. When I did it, it was very clear in that. I did it post IPL, went to Germany.

"It went really well how it went last year

and I knew how the recovery is going to be step by step. So I was prepared for everything. So we took one week at a time and we are here and I'm feeling good."

Talking about his structured rehabilitation and the support at CoE, Suryakumar said: "I think the most important thing for me is when you come here at COE or when I was here at NCA last year as well, they understood how my body reacts to certain situations.

"So all the strength and conditioning coach and the physios, they understood how my body works and accordingly they planned all the workouts. As soon as I used to hit the gym and I came here, they would plan the sessions and that's how we took one week at a time and slowly but steadily we are here." The India skipper also gave a big thumbs up to the facilities at the CoE.

"I think firstly it's very massive. The place is huge. Let me talk about the gym first. I think more than 30-35 people can train here together," he said.

"I actually used most of the equipment here. Some new equipment which are actually very useful from athletes point of view. Not only for a rehab but if someone, any contracted player or a targeted player wants to come here for few weeks, train, use the ground and everything.

"Unbelievable facility and it's the best which I've seen for a really long time."

It can be prevented by practising the 5 Keys to Food Safety

- Choose safe raw or cooked materials- like vegetables, fish, meat
- Keep your hands and utensils clean Always keep cooked and raw food separately
- Cook food thoroughly
- Keep food at safe temperature



- Use clean water for drinking and washing
- Keep your hands and utensils clean by washing properly
- Rinse properly and repeatedly the materials to be used for 'Prasad', 'Khichri', 'Bhog' etc. on religious occasion /community cooking with clean water
- Freezed/preserved food must be well covered and kept in the right temperature

- Do not choose food materials of inferior quality
- Do not eat half cooked or stale food
- Do not keep/ preserve cooked food which may have been in contact with uncooked food
- Do not use soaps, special detergents to remove dirt, contaminants from the surfaces of vegetables
