CM Himanta clears air on land acquisition near Guwahati airport

Third edition of state's flagship Orunodoi scheme — Orunodoi Plus — initiated

GUWAHATI, Aug 1: The Assam government has initiated the process of acquiring around 500 bighas (around 166 acres) near Guwahati airport to construct a stadium for concerts and a convention centre, but a section of media outlets is wrongfully claiming that the Adani group is acquiring it, Chief Minister Himanta Biswa Sarma said here.

The government aims to secure land from genuine investors who want to sell their land, and residents will not be evicted, Sarma assured at a press conference.

'This move has been initiated by the state government to safeguard the land for the people of Assam, and we plan to take up three specific projects in the area,' he said.

These include a state-of-the-art stadium to promote Assam's concert economy, a convention centre on the lines of the Bharat Mandapam and an entertainment zone or amusement park on the lines of Universal Studios, but not on such a big scale, he added.

'All these projects will be fully planned and implemented by the state government and not by any industrial house', he said.

DCs directed to conduct survey to ascertain encroachment on forest land: Sarma

GUWAHATI, Aug 1: Chief Minister Himanta Biswa Sarma on Friday said that he has directed all district commissioners to conduct surveys to ascertain the level of encroachment of forest lands in their respective areas. All districts will conduct the survey, and those living

in forest areas will be evicted, except those who are eligible for forest rights, the chief minister said at a press conference here. 'Tribal people can stay in forests provided they have been there before 2005. We are going to evict people

who are not covered under the Forest Rights Act," he Sarma said the level of encroachment is very high

and beyond imagination.

"Even if one eviction is carried out each month, it will take 10 years to clear the land,' the chief minister said. Sarma had earlier said that all unauthorised occupation of forest land, VGR (Village Grazing Reserve), PGR (Professional Grazing Reserve), Satras, Namghars, and other public areas would be cleared in

a phased manner. He had said 1,19,548 bighas (160 sq km) of land had been cleared of encroachment since his government took over in May 2021, affecting about 50,000 people. Of these, 84,743 bighas are forest land and 26,713

bighas are 'khas' or general government land, he said. Another 63 lakh bighas, including 29 lakh bighas of forest land, are still under encroachment in the state, though some of it is occupied by tribals who will be provided with ownership as per rules, Sarma had said.

Sarma on Thursday had asserted that the state government has cleared nearly 3,305.78 acres of encroached land in the ongoing eviction drive at Uriamghat in Golaghat district, the largest area to be freed from encroachers in the state.

Most of the people displaced due to the eviction drive are Bengali-speaking Muslim communities who claim that their ancestors had moved and settled in the areas where drives were carried out after their land in the 'Char' or riverine areas was washed away due to erosion by the River Brahmaputra.

Meanwhile, the eviction drive continued for the fourth consecutive day on Friday in six villages of Golaghat district, and there was no report of any untoward incident so far, officials said. The eviction drive, one of the largest so far to clear 1,500 (CONTD. ON PAGE-2)

of Ports, Shipping and Waterways (MoPSW) is setting up a state-ofthe-art Regional Centre of Excellence (RCoE) in Dibrugarh, Assam, with an outlay of ₹188 crore to provide advanced maritime training for the youth of the Northeast.

The initiative, announced by

Minister Sarbananda Union Sonowal in an official statement during the ongoing monsoon session of the Lok Sabha, is part of the Atmanirbhar Bharat mission and the Centre's long-term Maritime Amrit Kaal 2047 vision.

According to the statement, the Dibrugarh RCoE will offer training in smart navigation systems, marine engineering, IT, logistics, and certified courses in inland waterway operations and maritime safety.

The project is expected to be completed within 19 months. The new centre will work in tandem with the existing Maritime

Skill Development Centre (MSDC) in Guwahati, which currently provides training in areas such as inland vessel management, general purpose rating, hospitality, safety, and crew management.

Together, both institutions aim to serve aspiring maritime professionals, particularly from the eight northeastern states.

Speaking on the significance of the project, union minister Sarbananda Sonowal said, "Under the visionary leadership of Prime Minister Narendra Modi, the Northeast is no longer seen as a remote corner of the country, but as a gateway to growth and connectivity. This new Centre of Excellence in Dibrugarh will harness the potential of our vouth and equip them with worldclass maritime skills.'

Trump tariffs to hit less than half of India's exports; trade talks on; no compromise on agri, dairy

NEW DELHI, Aug 1: The US on Friday slapped a 25 per cent tariff on India, potentially impacting about half of the USD 86 billion Indian exports to America, while the other half, including pharmaceuticals, electronics, and petroleum products, continued to be exempted from the levy.

New Delhi continues to be engaged in talks with the US to work out a trade deal, but will make no compromise on agricultural, daily and genetically modified (GM) products, sources said on Friday.

For the sixth round of talks, the US team is coming to India on August 25.

The sectors, which would bear the brunt of 25 per cent duty include textiles/ clothing (10.3 billion), gems and jewellery (12 billion), shrimp (USD 2.24 billion), leather and footwear (USD 1.18 billion), animal products (USD 2 billion), chemicals (2.34 billion), and electrical and mechanical machinery (about USD 9 billion).

According to sources, about half of the goods exported from India to the US are in the exemption category (such as pharma and electronic goods). So, the impact will be only on the remaining half.

"More than half of India's exports to the US will not be impacted by the duty. Due to the Section 232 exemption of the US, only exports worth about USD 48 billion would be impacted with these tariffs," they said, adding that the remaining exports will have a little impact on a country with a GDP of about USD 4 trillion and a consumer base of 140 crore.

In 2024-25, the bilateral trade between India and the US stood at USD 131.8 billion (USD 86.5 billion exports and USD 45.3 billion imports).

According to think tank GTRI, the 25 per cent tariffs will not be applica-



ble on the exempted categories, including pharmaceutical; energy products such as crude oil, refined fuels, natural gas, coal, and electricity; critical minerals; and a wide range of electronics and semiconductors, like computers, tablets, smartphones, solidstate drives, flat panel displays, and integrated circuits.

US President Donald Trump unveiled sweeping new tariffs on dozens of countries, including 25 per cent duties for goods from India, marking a new era of American protectionism that triggered fresh tensions and concerns over a much wider disruption in

India for buying crude oil and military equipment from Russia.

'We are keeping our fingers crossed on the issue, as there is no mention of penalty in the order," sources added.

Sarma also announced a new initiative — Orunodoi Plus — which will be rolled out as a pilot project starting January 2026 for four months. Under this, eligible beneficiaries who purchase LPG cylinders will receive an additional ₹ 250 subsidy.

"A form for LPG connection will also be provided with the letter, and Indian Oil Corporation (IOC) will inform the state government when the beneficiary buys gas. The ₹250 will be directly credited to their bank account," he said. "We are launching the scheme initially for four months to test coordination among the agencies. If it works, we will scale it up," he added.

Sarma also announced the launch of the second edition of the 'Nijut Moina' scheme, providing financial support to eligible girl students for higher studies so that they do not drop out of school and become victims of child marriage. The forms will be distributed to eligible girl students from August 6, he said. Residents of Assam studying in central universities like Tezpur and Assam University will also be covered under the scheme. The vice president is the second highest constitutional office in the country. He/she serves for a five-year term, but can continue to be in office, irrespective of the expiry of the term, until the successor assumes office. (PTI)

The CM said he has directed the district commissioners to prepare a list of 50 people who had come into contact with Hazarika during his lifetime, and they will be invited to the function. Besides, 1,000 artistes will also be invited to present together parts of Hazarika's prominent songs, he said.

Sarma also launched a portal where people who want to attend the function can register till August 20. An invite will be sent to them by the state's Cultural Affairs Department. He said that at the function, the PM will also launch Hazarika's biography.

The state government will also organise year-long celebrations across the country, including Delhi, Mumbai, West Bengal and Arunachal Pradesh, to commemorate Hazarika's legacy. (PTI)

US slaps 25% tariff

billion). The sources said that about half of the goods exported from India to the US are in the exemption category (such as pharma and electronic goods), so, the impact will be only on the remaining half. In the Executive Order titled 'Further Modifying The Reciprocal Tariff Rates', Trump announced tariff rates for nearly 70 nations.

A 25 per cent "Reciprocal Tariff, Adjusted" has been imposed on India, according to the list released. The executive order however does not mention the "penalty" that Trump had said India will have to pay because of its purchases of Russian military equipment and energy. Besides the new tariff, Trump had also announced an additional "penalty" for New Delhi's purchases from Russia. While August 1 was the tariff deadline, the new levies will come into effect from August 7. In April, Trump had announced that India will face a 26 per cent "discounted reciprocal tariff", a per cent higher than the rate announced now.

Responding to the executive order, Senior Vice President of the Asia Society Policy Institute (ASPI) and former Deputy US Trade Representative Wendy Cutler said in a statement that India, a "promising candidate for an early agreement", was assigned a 25 per cent tariff. This "calls into question the fate of a bilateral trade agreement. The President's annoyance with India on a range of trade and broader matters rang through his Truth Social post," Cutler said.

Federation of Indian Export Organisations (FIEO) Director General Ajay Sahai said that the order provides relaxation for goods in transit and those loaded on ship for final sailing to the US by August 7. Goods cleared for consumption in the US by October 5 will also not be subject to reciprocal tariffs, thus providing some relief to exporters of goods already shipped or likely to be shipped this week.

According to Cutler, US customs officials will face challenges implementing the executive order, particularly with the different tariff rates now applied across the world.

In the executive order, Trump stated that some trading partners have agreed to, or are on the verge of agreeing to, meaningful trade and security commitments with the US, thus signalling their sincere intentions to permanently remedy trade barriers and align with Washington on economic and national security matters.

"Other trading partners, despite having engaged in negotiations, have offered terms that, in my judgment, do not sufficiently address imbalances in our trading relationship or have failed to align sufficiently with the United States on economic and national-security matters," he said.

The tariffs in the list range from 10 per cent to 40 per cent, with Japan being charged 15 per cent, Laos and Myanmar (40 per cent each), Pakistan (19 per cent), Sri Lanka (20 per cent) and the United Kingdom (10 per cent).

Declaring that the US has a massive trade deficit with India, Trump had said that while "India is our friend, we have, over the years, done relatively little business with them because their tariffs are far too high, among the highest in the world, and they have the most strenuous and obnoxious non-monetary Trade Barriers of any country.

'Also, they have always bought a vast majority of their military equipment from Russia, and are Russia's largest buyer of energy, along with China, at a time when everyone wants Russia to stop the killing in Ukraine — All things not good!" Trump said.

He said that India will therefore be paying a tariff of 25 per cent, plus a penalty for the above, starting on August 1. Trump also mounted a sharp attack on India and Russia for their close ties. "I don't care what India does with Russia. They can take their dead economies down together, for all I care," he said. "We have done very little business with India, their Tariffs are too high, among the highest in the World," he added.

In its reaction, India said it will take all necessary steps to safeguard and promote national interest and that the implications of the tariffs are being examined. (PTI)

Illegal Teak Timber seized in West Karbi Anglong

KHERONI, Aug 1: The Southern Range of the Forest Department, West Karbi Anglong, seized illegally procured teak timber during a raid at a furniture shop in Langmepi on Friday. The operation was led by Range Officer Bitupon Ronghang.

The timber, allegedly stored by smugglers, was recovered from the premises of M/s Mon Timber and Furniture, owned by Bhola Ronghang. The shop was sealed following the seizure. However, no arrests have been made so far, and there is no report of an FIR being lodged.

According to forest officials, it is an unusual instance where a commercial establishment was found being used as a timber dump by smugglers. The Southern Range typically deals with rampant smuggling of forest resources and illegal sand mining in the region.

Sources said timber smuggling operations often involve felling of trees in the already depleting forest areas of West Karbi Anglong, with the felled logs being transported into Meghalaya. Local involvement and cross-border logistical support are suspected, as evident from frequent seizures of equipment and vehicles used in such activities.

The porous and contested Assam-Meghalaya border continues to pose a major challenge in curbing illegal timber trade in the region.

Tipra Motha's 'Historic March to Delhi' reaches Kokrajhar

KOKRAJHAR, Aug 1: The "Historic March to Delhi" led by Tipra Motha leader David Murasing and his 12-member team reached Kokrajhar on July 30 as part of their 2,500-km foot-march from Agartala to New Delhi, aimed at highlighting the issue of infiltration in Tripura. The march, which began on July 5, resumed from Kokrajhar the following day after a warm reception was accorded to the team by Kokrajhar East MLA Lawrence Islary at his office.

Future of electric vehicle

here's a blind spot in India's electric vehicle ambitions, which sits deep inside the battery. Lithium, neodymium, dysprosium, praseodymium are rare earth elements. Laboratory processing of these rare earth materials yields permanent magnets, which have applications spanning dental, aerospace, defense, electronics, batteries, and automotive sectors. And India imports most of permanent magnets from a single source: China. In late 2024, China tightened its grip on permanent magnets exports, citing national security and environmental concerns. It was a sharp reminder of where power lies in the global clean-tech race. China controls more than 70% of global rare earth production and refining. India's \$240 billion auto industry just found itself exposed. Although Indian automobile manufacturers frontloaded magnet imports in March and April this year, up 20% and 87% year-on-year, respectively - those stockpiles are expected to run out soon. This is no time for wishful thinking. If India is serious about electrifying transport and building clean-tech self-reliance, it must first learn how others played this game.

Initially, United States improvised by importing through third country route when China pulled the plug.US companies quietly redirected supply chains through third countries, mostly Thailand and Mexico. Between December 2024 and April 2025, US imports of antimony oxide (a type of rare earth material) from the two nations reached approximately 3,834 metric tonnes, more than the previous three years combined. That's because it wasn't, at least on paper. In reality, the materials were shipped from China to these intermediaries. There, they were relabelled and re-exported to the U.S., often disguised as unrelated goods such as zinc, iron, or even art supplies. US regulations permit this kind of re-routing, so long as shipments are licensed. And Beijing has no easy way to stop it.

However, this strategy of rerouting through third countries did not remain effective for long. Chinese government tightened export controls, making it increasingly difficult for the U.S. to procure materials through transshipment channels. Starting May 2025, Chinese Ministry of Commerce (MOFCOM) launched a dedicated campaign against smuggling and illicit transshipment of these strategic items. Authorities intensified customs checks, investigations, and legal actions against domestic and overseas entities involved in re-routing goods to the U.S. If India wants to lead the global EV transition, it can't afford to be a bystander in the rare earth game. These materials may lie buried in foreign soil, but the strategy to secure them can be hammered out at home. Because no matter how sleek the car, it won't move an inch without the right

Citizenship, Identity, and the New Demographic Anxiety

The complexities surrounding citizenship, identity, and demographic shifts have long cast a shadow over Assam's sociopolitical fabric. In recent years, however, the anxiety surrounding these elements has intensified, producing volatile discourse and unsettling uncertainties. At the heart of Assam's current crisis lies the fear of cultural erasure and political displacement, fuelled by concerns over migration, the National Register of Citizens (NRC), and the implementation of the Citizenship Amendment Act (CAA). This interwoven matrix of history, politics, and demography continues to redefine what it means to be Assamese, creating fault lines between communities while challenging the foundational premises of Indian

Assam's experience with migration dates back to colonial times when the British administration encouraged the movement of labourers and peasants from other parts of India, especially Bengal, to cultivate its fertile land. Over decades, the demographic

composition of Assam began shifting, leading to anxieties among the indigenous communities

regarding the dilution of their cultural identity, language, and control over resources. This long-standing fear crystallized in the form of the six-year-long Assam Movement (1979–1985), demanding the identification and deportation of illegal immigrants, particularly those from Bangladesh. The movement culminated in the Assam Accord of 1985, which set 24 March 1971 as the cutoff date for detecting and deporting illegal migrants. Yet, this accord did not deliver the clarity or closure many hoped for; instead, it laid the groundwork for continuing ambiguities and disputes over citizenship.

The updating of the NRC, touted as a mechanism to address these concerns, brought both hope and chaos. The final list, published in 2019, excluded around 1.9 million people, including many Assamesespeaking Hindus and Muslims. While some anticipated that the NRC would validate the identity of indigenous citizens, its implementation exposed systemic flaws, legal loopholes, and bureaucratic hurdles. Instead of resolving the citizenship question, the NRC only deepened uncertainties and anxieties. The absence of clear guidelines for those excluded and the establishment of Foreigners Tribunals further complicated the fate of lakhs of people caught in administrative limbo. For a region already scarred by identity-based violence, these developments

The introduction of the CAA in 2019 further inflamed tensions. While the government claimed it was a humanitarian measure to offer refuge to persecuted minorities from neighbouring countries, in Assam, it was widely perceived as a betraval of the Assam Accord. By allowing citizenship to undocumented non-Muslim migrants from Bangladesh, Pakistan, and Afghanistan, the CAA potentially legitimizes the presence of communities that the Assamese people have long struggled to identify as outsiders. For many in Assam, the Act challenges the very definition of citizenship that the NRC was supposed to clarify. It fuels the fear that the cultural and linguistic uniqueness of the Assamese people is at risk of being subsumed under a homogenizing national identity that does not acknowledge regional aspirations or historical grievances.

This demographic anxiety is not limited to numbers but extends to the deeper question of identity. For the indigenous communities of Assam, identity is inseparable from land.

undermine these pillars creates a climate of cultural siege. This siege mentality, in turn, influences political rhetoric, electoral strategies, and policy formulations. Political parties across the spectrum have weaponized identity politics, often reinforcing divisions between indigenous and migrant communities, between Assamese speakers and Bengali speakers, and between Hindus and Muslims. In this fraught environment, citizenship becomes not just a legal status but a moral and emotional claim to belonging.

However, such essentialist narratives of identity risk erasing the complex reality of Assam's pluralism. The state is home to a mosaic of communities-Ahoms, Bodos, Karbis, Tea Tribes, Bengalis, and many others—each with distinct histories and cultural practices. The danger of reducing this diversity to binaries of insider versus outsider or indigenous versus migrant undermines the inclusive ethos that should ideally govern a democratic society. Moreover, the lived experiences of many so-called "outsiders" reveal decades of rootedness in Assam- generations who have contributed to its economy, culture, and society. Denying them recognition on the basis of perceived foreignness only perpetuates alienation and exclusion.

What complicates the situation further is the absence of robust mechanisms to reconcile legal definitions of citizenship with social perceptions of belonging. The NRC was

supposed to be such a mechanism, but its flawed execution eroded public trust. The CAA, instead of clarifying ambiguities, introduced new ones by privileging religious identity over territorial and historical continuity. This piecemeal approach to citizenship exacerbates the demographic anxiety it was meant to address. It neither satisfies the indigenous communities' demand for cultural preservation nor assures security to long-term residents fearing statelessness.

The new demographic anxiety in Assam is thus both a cause and a consequence of these unsettled debates over identity and citizenship. It is an anxiety that finds expression in protests, court battles, and everyday conversations. It is also a deeply political anxiety, shaped by electoral calculations and ideological agendas. In recent elections, political parties have sought to consolidate votes by invoking the fear of the "other"—a tactic that may yield short-term gains but erodes the social fabric in the long run. The rise of identity-based political parties and the polarization of public discourse further entrench these divides, making reconciliation increasingly difficult.

Yet, amidst this gloom, there is a growing recognition—especially among youth, civil society groups, and independent intellectuals—that Assam's future cannot be built on exclusion. There is an emerging discourse that calls for a more nuanced understanding of identity, one that acknowledges historical grievances without perpetuating them, and one that sees citizenship as an evolving relationship with the state rather than a static entitlement. This vision requires legal reforms, administrative transparency, and most importantly, empathy. It demands that citizenship processes be humane, inclusive, and sensitive to the lived realities of people.

The challenge before Assam today is to navigate this complex terrain without sacrificing justice at the altar of identity, or unity at the altar of numbers. While it is legitimate for communities to seek the preservation of their culture and language, this cannot come at the cost of marginalizing those who have shared space, labour, and aspirations for decades. The test of any democracy lies not just in how it protects majorities but in how it treats its minorities—especially those rendered invisible by politics and policy.

What Assam needs is a reimagining of citizenship that moves beyond mere documentation. It needs a framework that balances cultural autonomy with constitutional guarantees, regional sentiments with national commitments. This is not an easy task, but it is a necessary one if the state is to emerge from the shadows of its demographic anxieties and chart a path towards inclusive development. This reimagining also calls for education, dialogue, and the courage to confront difficult truths—about past policies, present prejudices, and future possibilities.

Assam's demographic anxiety is symptomatic of a larger national debate on citizenship and identity, one that questions who belongs, on what terms, and with what rights. The answers to these questions cannot be found in exclusionary laws or contested registers. They must emerge from a collective reckoning with history, a commitment to justice, and an unflinching belief in the plural foundations of the Indian republic. Only then can Assam truly lay to rest the ghosts of its past and embrace a future rooted in dignity and shared belonging.

Indian Police crackdown on muslim Bangla-speaking migrants

wo impoverished families have been working as scrap pickers for over two decades in the suburb of New Delhi. Both families were detained, transported in harsh conditions, and pushed into Bangladesh in the dark hours. Police in Delhi claimed hat they are Bangladeshi citizens and that their ancestors were from a village in the southern district of the country.

The ordeal of the two families surfaced after their families filed cases with the Delhi High Court and Kolkata High Court. The families complained that the Indian authorities do not know of their whereabouts in Bangladesh, and the families do not have any contact with them.

The petition said that last month. Sweety Bibi and her two sons, Korban Sheikh (16 years old) and Imam Sheikh (6 years old) and another family, Sonali Khatun, her husband, Danesh Sheikh and their son Sabbir Sheikh, were abducted, and police said they were deported to Bangladesh as they were Bangladesh citizens.

Later, the West Bengal police collected several documents to prove that the family's ancestors' history is from the state of West Bengal and that they are genuine Indian citizens.

A video shot inside Bangladesh, which went viral on social media, showed two women, one teenager and one male, who was seen in the footage. It could not be ascertained where in Bangladesh it was recorded. The woman, Sweety Bibi, described in the video how they were forcibly abducted by police and later pushed into a foreign country and were alleged to be émigrés from Bangladesh.

In the recent spate of crackdown against illegal immigrants, India, when persons speak Bangla (the official language of Bangladesh and also spoken in neighboring states of West Bengal and Tripura) and are Muslim, that person, in the eyes of the police, is a potential demographic threat to the country's security. The authorities jump to the conclusion that the suspects are

All over India, such suspects in thousands were hauled and taken to different concentration camps. The detained persons are enduring untold miseries, agony and sufferings. They are tortured by law enforcement agencies. The encampments have poor sanitation, no

Indian press, which habitually barks anti-Bangladesh rhetoric, hardly reported the incidents of the harassment and illegal confinement of Indian citizens, bracketed as "unauthorized immigrants" from Bangladesh. Most of them live in shanty slums and work as menial workers and have migrated from different places for a better future and finan-

According to international media and rights organizations, they have been critical of such government-induced crackdown against the working class in India. Most do not have proper documents to prove their identity. Even though they had valid citizenship documents, they had those confiscated and

Human Rights Watch (HRW), a New York-based organization, said India forcibly expelled more than 1,500 Muslim men, women, and children to Bangladesh between 7 May and 15 June, quoting Bangladeshi authorities. The police, while detaining the suspects, speak of harrowing tales of being robbed of their cash and valuables, the poor people possessed. For the detained Muslims, the sky seems to have fallen over their head.

India is one of the few South Asia countries where secularism, equality and rights of citizens are guaranteed in the state constitution, but the government and law enforcement authorities are flouting the law with impunity during the arbitrary crackdown on illegal immigrants.

The suspects are forcibly boarded on a train or trucks and brought near the India-Bangladesh border. They are pushed through porous borders into Bangladesh. Such "push-in" as it is popularly said on both sides of the border has become a regular phenomenon of the Indian Border Security Forces

Bangladesh is encircled by India on three sides by land, and has seen relations with New Delhi turn icy since a mass uprising in August last year toppled the autocratic government of Sheikh Hasina, an ally of India, who is living in exile somewhere in New

Bangladesh's Foreign Ministry has repeatedly communicated with the Indian Ministry of External Affairs (MEA) to abide by international laws for deporting illegal immigrants. The standard procedure would be to produce a list of names, photos, addresses in Bangladesh, and documents to prove they are from Bangladesh.

Bangladesh authorities would verify their citizenship and decide who could be sent back. Meanwhile, some Arab countries, Malaysia, South Korea, the United States and other countries have provided documents of those deported for illegally staying in their country and are undocumented. They are listed when their work permit and visas expired long ago, or they were involved in heinous crimes and given long-term prison sentences. The criminals are sent back to serve the rest of their imprisonment tenure in their home country.

"The Indian government is putting thousands of vulnerable people at risk in apparent pursuit of unauthorized immigrants, but their actions reflect broader discriminatory policies against Muslims." India has also been accused of forcibly deporting Muslim Rohingya refugees from Myanmar, with navy ships dropping them off the coast of the war-torn nation.

A City's reckoning with negligence and privilege

n the stillness of a humid July night in Guwahati, a life full of promise was shattered by a moment of reckless negligence. Twenty-one-year-old Samiul Haque, a final-year electrical engineering student at Nalbari Polytechnic and a newly appointed temporary worker at the Guwahati Municipal Corporation (GMC), was fatally injured in a hit-and-run incident in Kahilipara's career ended instead in silence—on a hospital bed, four days after the accident, as the city erupted in protest and stands Assamese actress Nandinee Kashvap, now arrested in connection with the case, and a justice system once again under public scrutiny.

The accident occurred on the night of July 25—ironically, the very day rary basis. He was diligently working on the installation of streetlights, part of a larger initiative to improve the city's infrastructure. Eyewitnesses claim a speeding vehicle struck him and fled the scene without a pause. That vehicle, later identified as belonging to Nandinee Kashyap, left behind a trail of horror: Samiul was critically injured. sustaining severe brain trauma and multiple fractures.

Initially rushed to Gauhati Medical College and Hospital (GMCH), Samiul was later transferred to Apollo Hospitals on July 28 as his condition deteriorated. Despite the efforts of doctors and one from the interim government ever the prayers of loved ones, he succumbed to his injuries on July 29. His death triggered a wave of outrage across Assam, with local residents, student bodies, and civil society demanding accountability, transparency, and swift justice.

> The immediate reaction to the incident was marked by confusion, frustration, and despair. Police officials claimed that the family had not named the accused in the FIR, yet the name of the vehicle owner, the location, and the circumstances were clear from the outset. The case, initially registered under bailable sections of the Bharativa Nyaya Sanhita (BNS)—namely Sections 115(2), 125(b), and 281—was criticized for being too lenient. Only later was a non-bailable charge under Section 105 added, raising further questions about the police's priorities and procedural integrity. The arrest of Nandinee Kashyap came a day after Samiul's death. She was intercepted near Mandakata while returning from a theatre rehearsal and detained by a Guwahati Police team. By the following day, she was formally arrested and brought to the All Women Police Station at Panbazar for interrogation. During this period, the vehicle involved in the incident—a car bearing registration number AS 01FM 9199—was seized by the authorities. Still, doubts lingered over whether Kashyap herself was behind the wheel at the time of the acci

dent. The police have yet to officially confirm this, despite eyewitness reports suggesting her involvement directly. The story does not end with the crash or the arrest. What followed in the days afterward speaks volumes about both personal conduct and systemic failure. According to Samiul's family and local residents, not only did Kashyap fail to stop after hitting the young man, but she also made no attempt to check on his condition or offer help in the days that followed. A relative claimed that she made a call on WhatsApp where she reportedly said she wo cited her political connections as a shield. When Samiul was eventually shifted to Apollo Hospital, it was not the actress, but her father who visited. "He came with a few people, looked at Samiul, said he would get better, and left," a relative recounted in anguish.

Facing growing criticism, Nandinee's mother later issued a public statement expressing sorrow over the incident. She claimed that the family had tried to offer financial assistance but were rebuffed by hostile youths. She also added that police had advised Nandinee against visiting the hospital for safety reasons. Regarding prior traffic violations linked to the car, her mother insisted those were the responsibility of the driver and not the actress herself. "We are open to helping in any way possible after the legal procedures conclude," she added.

However, the apology has done little to quiet the storm. Samiul's death has become a symbol of growing anger against unchecked privilege, legal loopholes, and the rising menace of hit-andrun cases in Guwahati. The All Assam Polytechnic Students' Union (AAPSU) filed a formal FIR at Dispur Police Station and held public demonstrations outside Apollo Hospital, demanding strict action. Samiul was not just a student but also a diligent young man working night shifts to support his family. His story has become a painful representation of countless young lives in Assam striving to rise against odds, only to be crushed under the wheels of negligence and impunity.

The Raidhani Theatre, where Kashyap was under a two-year contract, terminated its association with her, citing the need to protect its institutional reputation. Members of the Assamese film fraternity also expressed their sorrow. Actor Ravi Sarma, who had acted alongside her in the movie Rudra, posted a heartfelt note: "The tragic loss of Samiul Haque has deeply saddened me. My thoughts and prayers are with his family during this incredibly difficult time.

But grief alone cannot resolve the deeper issues at play. Guwahati has seen a sharp rise in hit-and-run cases over the past few years. According to city traffic data and local reports, incidents of vehicles striking pedestrians or two-wheelers and fleeing the scene have nearly doubled since 2019. The reasons are manifold: increasing vehicular density, inadequate pedestrian infrastructure, late-night overspeeding, distracted driving due to mobile use, and, significantly, the presence of unlicensed or underage drivers on the roads. Law enforcement, for its part, has repeatedly failed to keep up with these challenges. While Guwahati Police has launched surveillance projects, including CCTV installation and traffic monitoring squads, loopholes in investigation and weak initial charges often delay justice. In many cases, FIRs are delayed, eyewitness accounts are ignored, and powerful individuals escape nipulation. Even when vehicles are seized, the legal process is often diluted, as was seen in the initial bailable charges filed in Samiul's case.

To curb the rising tide of hit-and-run incidents in Guwahati, systemic reform is urgently required. Firstly, traffic enforcement needs a major overhaul. Speeding, driving under the influence, and reckless driving must be treated as serious criminal offenses from the outset—not as bailable infractions. Police must be equipped with better training and resources to handle accident scenes, gather forensic evidence swiftly, and protect the rights of victims and their families.

Secondly, public awareness campaigns must focus on responsible driving behavior, ethical responsibility during accidents, and the legal obligations of drivers. The general attitude that "powerful people can get away with anything" must be challenged both culturally and legally.


Thirdly, there is a need to improve road infrastructure. Poor lighting, lack of pedestrian crossings, and chaotic intersections make nighttime travel dangerous for both drivers and workers like Samiul. Municipal bodies and the state government must prioritize safe road engineering alongside urban development. Finally, a victim compensation and support mechanism should be instituted. Families of hit-and-run victims often struggle to afford medical care or legal support. A state-backed fund could offer immediate relief, legal aid, and rehabilitation assistance for those affected.

Samiul Haque's story is not just the tale of one life lost—it is an indictment of a city failing to protect its youth. It is about the growing disconnect between the privileged and the common citizen. about a legal system that drags its feet when speed is most needed, and about a culture that must evolve to place value on human life above status and influence. As protests continue and investigations unfold, Guwahati must reckon with a crucial question: how many more lives must be lost before the sys-

tem begins to care? The death of Samiul must not be allowed to fade into another unsolved file or a passing news cycle. It should serve as a wake-up call—one that jolts conscience, ignites reform, and builds a city where justice is not a privilege, but a right. Zelenskyy said that in July, Russia launched over 5,100 glide bombs, more than 3,800 Shahed drones, and nearly 260 missiles of various types, 128 of them ballistic, against Ukraine.

He repeated his appeal for countries to impose heavier economic sanctions on Russia to deter the Kremlin, as US-led peace efforts have failed to gain traction.

"No matter how much the Kremlin denies (sanctions') effectiveness, they are working and must be break through defences after some 18 months of fighting.

Zelenskyy said that Russian claims of capturing Chasiv Yar on Thursday were "disinformation."

US envoy visits distribution site in Gaza as humanitarian crisis worsens

STRIP), Aug 1: US President Donald Trump's special envoy Steve Witkoff visited southern Gaza on Friday during international outrage over starvation, shortages and deadly chaos near aid distribution sites.

Witkoff and US Ambassador to Israel Mike Huckabee toured one of Gaza Humanitarian Foundation's distribution sites in Rafah, Gaza's southernmost city, according to an official involved with the visit. The official requested anonymity because he was not authorised to brief the media.

All four of the group's distribution sites are in zones controlled by the Israeli military and throughout their months in operation have become flashpoints of desperation, where starving people scramble for scarce aid. Hundreds have been killed by either gunfire or trampling. The Israeli military says it has only fired warning shots at people who approach its forces, and GHF says its armed contractors have only used pepper spray or fired warning shots to prevent deadly crowding.

Witkoff's visit comes a week after US officials walked away from ceasefire talks in Qatar, blaming Hamas and pledging to seek other ways to rescue Israeli hostages and make Gaza safe.

White House press secretary Karoline Leavitt said Thursday that he was sent to craft a plan to boost

effort "to save lives and end this crisis," while Trump wrote on social media that the fastest way to end the crisis would be for Hamas to surrender and release hostages.

International organisations have said Gaza has been on the brink of famine for the past two years. The Integrated Food Security Phase Classification, the leading international authority on food crises, said recent developments, including a complete blockade on aid for 2 1/2 months, mean the "worst-case scenario of famine is currently playing out in Gaza."

Though the flow of aid has resumed, including via airdrops, the amount getting into Gaza remains far lower than what aid organisations say is needed. A security breakdown in the territory has made it nearly impossible to safely deliver food to starving Palestinians, much of the limited aid entering is horded and later sold at exorbitant prices.

In a report issued Friday, Human Rights Watch called it "a flawed, militarised aid distribution system that has turned aid distributions into regular bloodbaths.'

Israel's military and prime minister's office did not respond to request for comment on the report.

Trump has also expressed frustration with a trade deficit with Canada that largely reflects oil purchases by America. OTTAWA, Aug 1: Plans announced by France, the United Kingdom and Canada to recognise a Palestinian state won't bring one about anytime soon, though they could further isolate Israel and strengthen the Palestinians' negotiating position over the long term.

The problem for the Palestinians is that there may not be a long term.

Israeli Prime Minister Benjamin Netanyahu rejects Palestinian statehood and has vowed to maintain open-ended control over annexed east Jerusalem, the occupied West Bank and the war-ravaged Gaza Strip — territories Israel seized in the 1967 war that the Palestinians want

for their state. Israeli leaders favour the outright annexation of much of the West Bank, where Israel has already built well over 100 settlements housing over 500,000 Jewish settlers. Israel's offensive in Gaza has reduced most of it to a smoldering wasteland and is pushing it toward famine, and Israel says it is pressing ahead with plans to relocate much of its population of some 2 million to other countries.

The United States, the only country with any real leverage over Israel, has taken its side

Critics say these countries could do much more Palestinians have welcomed international support for their decades-long quest for statehood but say there are more urgent measures Western countries could take if they wanted to pressure Israel. "It's a bit odd that the response to daily

atrocities in Gaza, including what is by all accounts deliberate starvation, is to recognize a theoretical Palestinian state that may never actually come into being," said Khaled Elgindy, a visiting scholar at Georgetown University's Centre for Contemporary Arab Studies.

"It looks more like a way for these countries to appear to be doing something," he said.

Fathi Nimer, a policy fellow at Al-Shabaka, a Palestinian think tank, says they could have suspended trade agreements with Israel, imposed arms embargoes or other sanctions. "There is a wide tool set at the disposal of these countries, but there is no political will to use it," he said.

It's not a completely empty gesture Most countries in the world recognised Palestinian statehood decades ago, but Britain and France would be the third and fourth permanent members of the UN Security Council to do so, leaving the US as the only holdout.

"We're talking about major countries and major Israeli allies," said Alon Pinkas, an Israeli political analyst and former consul general in New York. "They're isolating the US and they're



leaving Israel dependent — not on the US, but on the whims and erratic behav-

ior of one person, Trump. Recognition could also strengthen moves to prevent annexation, said Hugh Lovatt, an expert on the conflict at the European Council on Foreign Relations. The challenge, he said, "is for those recognising countries to match their recognition with other steps, practical

It could also prove significant if Israel and the Palestinians ever resume the long-dormant peace process, which ground to a halt after Prime Minister Benjamin Netanyahu returned to office in

"If and when some kind of negotiations do resume, probably not in the immediate future, but at some point, it puts Palestine on much more equal footing," said Julie Norman, a professor of Middle East politics at University College London.

'It has statehood as a starting point for those negotiations, rather than a certainly-not-assured endpoint."

Israel's government and most of its political class were opposed to Palestinian statehood long before Hamas' Oct 7, 2023, attack triggered the war. Netanyahu says creating a Palestinian

state would reward Hamas and eventually lead to an even larger Hamas-run state on Israel's borders. Hamas leaders have at times suggested they would accept a state on the 1967 borders but the group remains formally committed to Israel's destruction.

Western countries envision a future Palestinian state that would be democratic but also led by political rivals of Hamas who accept Israel and help it suppress the militant group, which won parliamentary elections in 2006 and seized power in Gaza the following year.

Palestinian President Mahmoud Abbas, whose authority administers parts of the occupied West Bank, supports a two-state solution and cooperates with Israel on security matters. He has made a series of concessions in recent months, including announcing the end to the Palestinian Authority's practice of providing stipends to the families of prisoners held by Israel and slain militants.

Such measures, along with the security coordination, have made it deeply unpopular with Palestinians, and have yet to earn it any favours from Israel or the Trump administration. Israel says Abbas is not sincerely committed to peace and accuses him of tolerating incitement and militancy. Lovatt says there is much to criticise about the PA, but that "often the failings of the Palestinian leadership are exaggerated in a way to relieve Israel of its own obligations" The tide may be turning, but not fast

enough

If you had told Palestinians in September 2023 that major countries were on the verge of recognising a state, that the UN's highest court had ordered Israel to end the occupation, that the International Criminal Court had ordered Netanyahu's arrest, and that prominent voices from across the US political spectrum were furious with Israel, they might have thought their dream of statehood was at hand.

But those developments pale in comparison to the ongoing war in Gaza and smaller but similarly destructive military offensives in the West Bank. Israel's military victories over Iran and its allies have left it the dominant and nearly unchallenged military power in the region, and Trump is the strongest supporter it has ever had in the White House.

"This (Israeli) government is not going to change policy," Pinkas said. "The recognition issue, the ending of the war, humanitarian aid - that's all going to have to wait for another government." (AP)

Arunachal Pradesh alone accounts for 91 per cent of India's mithun count.

The animal is deeply integrated into the lives of tribal communities in Arunachal Pradesh, Nagaland, Manipur, Mizoram, and, more recently, parts of Assam.

It is not only a source of highquality meat and milk, but also plays a key role in the food security



Mithun is the state animal of both

Arunachal Pradesh and Nagaland. Patil noted that despite these factors, mithun remains outside the framework of the National Livestock Mission.

He pointed out that its inclusion would help drive focused research on breeding, feeding, health, and value addition, while also creating operating in challenging and remote geographies. He added that ICAR-NRCM is ready to provide the necessary documentation and support required for the animal's inclusion in the scheme.

Supporting this institutional appeal, the Jomlo Mongku Mithun Farmer Federation from Siang district in Arunachal Pradesh also raised the issue, calling for the intervention of Arunachal MPs Kiren Rijiju and Tapir Gao.

Federation chairman Tadang Tamut expressed concern that the mithun population is shrinking due to indiscriminate slaughter and unscientific farming practices.

Action over apathy: Youths restore hope in Arunachal's West Siang

ITANAGAR, Aug 1: In a powerful display of grassroots leadership, youths in Arunachal Pradesh's West Siang district have taken it upon themselves to revive incomplete infrastructure projects and address long-standing civic issues, without waiting for government support.

Across the state, young people are stepping up to drive change, tackling a wide range of challenges from drug awareness and waste management to infrastructure development. A notable instance of this spirit is unfolding in West Siang, where two youths have spearheaded the redevelopment of the long-pending Aalo Indoor Stadium, while another young entrepreneur has repaired a vital bridge connecting

The Aalo Indoor Stadium project, sanctioned under the 2014-15 Special Plan Assistance (SPA) with an estimated cost of ₹ 35.28 crore, was awarded to M/s TK Engineering Consortium Limited.

Construction began in June 2018 with a 36-month deadline, yet the project remains

In contrast, other stadiums sanctioned in the same period at Chimpu, Pasighat, Yupia, and Ziro have already been completed and are regularly hosting sports events. By 2024, the delay had tested the patience of local communities.

Multiple appeals from communitybased organisations, students, and senior citizens to expedite construction or have the firm vacate the site went unheard. Frustrated by the prolonged inaction,

two men in their early 40s, Nyatum Bagra and Kento Ete, decided to act.

On June 30, the West Siang District Olympic Association, under the leadership of its president Bagra, began redeveloping the abandoned ground to make it suitable for hosting football and volleyball tournaments, without any government funding or logistical support.

We were concerned by the lack of sports activities for almost a decade due to the construction of the stadium," said

"Young people, due to stadium construction and lack of other facilities, were left with no option and were going astray, indulging in alcohol and drugs," he



The legacy of sports in the district includes the Ramakrishna Mission School, Aalo, which reached the finals of the prestigious Subroto Mukherjee Cup in 1988 and 1990, and footballer-turned-coach Gumpe Rime, who hails from the district.

Kento Ete, general secretary of the West Siang District Football Association, echoed similar sentiments.

"A generation has lost the opportunity due to government apathy," Ete remarked, adding that the state government, district administration, and the sports department had failed the community.

With a group of volunteers, they began clearing the overgrown field, removing shrubs, debris, and discarded construction materials. However, the gallery, rostrum, and equipment left by the construction firm were left untouched. The initiative drew overwhelming public support, with contributions from the Football Players' Union, Tractors Union, senior citizens, and even manual labourers (mutias).

On July 16, the volunteers completed the ground redevelopment, drawing district-wide praise. The team now awaits rainfall to begin

planting carpet grass, a substitute for the astro-turf originally promised in the DPR. "The planting process is likely to cost us around ₹ 10-12 lakh," Bagra said, expressing hope to complete it soon.

District Sports Officer Tumto Loyi acknowledged that the ground should have been ready by 2019. "The project under SPA was delinked

due to litigations. As a citizen of Aalo, I feel the boys did a good job," Loyi said, though he maintained that the work should have followed technical protocols. While a renewed state fund had been allocated in 2022-23, construction once again slowed down due to unknown rea-

sons. In June 2024, the West Siang District Olympic Association staged a peaceful dharna to protest the ongoing delays. Following mounting pressure, several organisations in November last year issued a 48-hour ultimatum for the contractor to completion was set for December 31,

However, after months of inaction and the government's failure to blacklist the contractor, the WSDOA decided to move ahead on its own. In another inspiring act of community service, Gotum Gangkak, a 31-year-old entrepreneur and SRCC Delhi University B.Com graduate, took it upon himself to renovate a steel bridge over Himak River, which connects Darak circle with the rest of West Siang.

"I was moved by the dangers faced by the people of Darak to cross the bridge,' Gangkak said.

Despite being a vital lifeline for around 1,000 residents, the bridge had remained neglected for decades. With no help in sight, he hired JCB machines, fabrication equipment, a generator, and labourers, funding the entire operation himself.

He spent ₹ 5-6 lakh to procure materials from outside the state and completed the bridge repair.

Jumba Loyi, a health department worker

in Darak, praised the effort. "Now people can use the bridge without being worried," Loyi said, noting that previously, even trucks and dumpers engaged in construction in nearby Belo village

could not use the bridge safely. As both the stadium redevelopment and the bridge repair came to fruition, the residents of West Siang have expressed gratitude to the young change makers whose actions reflect the power of initiative and community spirit. Opposition protests rock Rajya Sabha; proceedings adjourned for the day

NEW DELHI, Aug 1: Rajya Sabha proceedings were washed out on Friday amid vociferous protests by Opposition members, who were demanding a discussion on Special Intensive Revision (SIR) of electoral rolls in Bihar and its rollback.

Some of the Opposition members tried to enter the well but were blocked by marshalls in the house, leading to strong objections by some leaders. They later alleged that it was a "paramilitary takeover" of the house.

When the House reassembled at 12 noon, some TMC and DMK MPs tried to enter the well, but were blocked by security personnel at the entry point. However, some MPs, including some women, sneaked into the well and raised slogans. They also protested against the blockade by security staff. Among some of the members who protested in the well were Nadimul Haque, Sagarika Ghosh, Derek O'Brien (all of TMC), Tiruchi Siva (DMK), and Sanjay Singh (AAP). The Rajya Sabha could not function on Friday, and both the Zero Hour and Question Hour became casualties. They raised slogans against SIR and demanded its withdrawal.

In the afternoon session, there was no let-up in the protests.

Ghanshyam Tiwari, who was in the chair, asked Vivek Tankha (Congress) to ask his supplementary question, urging protesting members to return to their seats and allow the question hour to

However, Tankha said he cannot speak as the House was not in order. Amid the din, the chair adjourned the Rajya Sabha for the day, as opposition members continued with their sloganeering inside the well and spoke into the microphones. The House will now meet again on Monday morning.

Leader of Opposition in Rajya Sabha Mallikarjun Kharge also wrote to Deputy Chairman Hari-

tices under Rule 267 for discussion on SIR, alleged discrimination against Bengali migrant workers in other states, impact of the US decision to impose a 25 per cent tariff on Indian imports, and mass layoffs in the Indian IT sector, among others. Harviansh said that since the notices do not conform to the detailed directions given by the Chair, they were declined. The Opposition member were

up on their feet, protesting the Chair's decision, and several of them raised slogans and stood in the aisle. The Chair allowed Manoj Kumar Jha (RJD) to speak, who urged the Chair to allow discussion on SIR. Harivansh said since the matter is sub judice, he cannot allow discussion on it.

"This is a sub judice matter and the rules of this House are very clear. I cannot allow (discussion)," he said, and urged the protesting members to return to their seats and called Ashok Kumar Mittal (AAP) to raise his Zero Hour mention.

However, the protests continued. The Chair's repeated efforts to ensure smooth functioning went in vain, and the proceedings were adjourned within 11 minutes. (PTI)

Replying to a question by Congress MP Pramod Tiwari in the Rajya Sabha on Friday, Union Minister of State for Environment Kirti Vardhan Singh said the study has cited its "own limitations of data availability".

The study, conducted by researchers from McGill University, alleged that 80 per cent of the total length of rivers in India could be posing environmental and health risks due to antibiotic pollution.

The media report, published on April 24, 2025, is based on a study titled "Antibiotics in the global river system arising from human consumption' conducted by researchers from McGill University, Canada, and its "findings are based on simulations and assumptions",

"This Article is our foundation. It protects our customs, our land, and our traditions. No other state in India has what we do. We must understand its value and use this privilege with purpose," Rio said, referring to Article 371(A), which grants Nagaland special autonomy over its religious, social, and customary practices, as well as land and resources.

The event was organised to highlight the outcomes of Chief Minister Neiphiu Rio's recent official visits to Russia and Japan from July 10 to 17 along with team of Naga artists and officials from Tourism and Industries department, where Nagaland was invited as one of six Indian states to participate in international cultural engagements facilitated by the Ministry of External Affairs.

Two women among five arrested, heroin seized

AIZAWL, Aug 1: Five people, including two women, have been arrested in connection with the seizure of heroin in three separate operations, police said.

Champhai Police intercepted an Aizawl-bound taxi at Khankawn check gate in Champhai and seized 364 gm of heroin worth ₹ 10.92 lakh on Thursday, police said.

The taxi driver, identified as C Zoramhluna (29), a resident of Biate village and presently residing in Aizawl's Chaltlang Lily Veng locality, and his passengers Lalnunzira (34) and Lalthanmawia (30), both from Chaltlang Lily Veng, were arrested in connection with the seizure, they said.

Zoramhluna revealed to the police that he had come to Champhai to receive the contraband for delivery to some persons in Aizawl, police said. Officials of the Excise and Narcotics Department also seized 60.27 gm of heroin from the possession of two women peddlers in two separate operations at Chhiahtlang village in Serchhip district

on Thursday, officials said. All five accused were booked under sections of the Narcotic Drugs and Psychotropic Substances Act 1985. (PTI)

CM Sangma urges Chhattisgarh to consider revoking charges against nuns held for 'conversion'

SHILLONG, Aug 1: Meghalaya Chief Minister Conrad K Sangma on Friday wrote to his Chhattisgarh counterpart, Vishnu Deo Sai, urging the latter's government to ensure a fair probe and consider revoking charges against two Catholic nuns from Kerala who were arrested last week over alleged human trafficking and forced religious conversion.

In a letter addressed to the Chhattisgarh CM, Sangma expressed concern over the arrest of Sister Vandana Francis and Sister Preethy Mary -- both affiliated with Fatima Hospital in Agra in Uttar Pradesh.

The two nuns, along with another person Sukhman Mandavi, were arrested by the Government Railway Police (GRP) at Durg railway station in Chhattisgarh on July 25 following a complaint by a local Bajrang Dal functionary, who accused them of forcibly converting three women from tribal-dominated Narayanpur district and trafficking them.

The nuns have been booked under Section 4 of the Chhattisgarh Freedom of Religion Act, 1968 (forced conversion) and Section 143 of the BNS (trafficking). Calling the allegations "false", and terming it a case

of "harassment," Sangma urged the Chhattisgarh government to uphold the rights of religious minorities



and ensure justice is served. He also requested that the charges be reviewed and revoked.

Sangma added that the Catholic Bishops' Conference of India (CBCI) has already written to Prime Minister Narendra Modi and Union Home Minister Amit Shah, seeking their intervention in the matter. Catholic Christians in Meghalaya have also submit-

ted petitions to the Chhattisgarh CM demanding justice for the detained nuns. Sangma said he hoped the issue would be resolved in a manner that respects constitutional values and re-

Street vendors protest outside Shillong



SHILLONG, Aug 1: Street vendors, mostly women, staged a protest outside the Shillong Municipal Board (SMB) office here on Friday, alleging arbitrary revocation of vending licences and biased allotment of stalls at the newly designated vending zone.

The protesters, under the banner of the Meghalaya and Greater Shillong Progressive Hawkers and Street Vendors Association (MGSPHSVA), demanded a review of the relocation process carried out by the SMB and the Urban Affairs department.

The vendors accused authorities of excluding several genuine local hawkers-particularly Khasi women-from the final list of beneficiaries, while stalls were allegedly allotted to non-local ven-

Protesters carried placards and submitted a memorandum seeking redressal of their grievance.

"Our names were there in the survey, and we even received vending certificates. But now our names are missing, and others

have taken our place," said one of

the protesting vendors. The protest follows a July 29 order of the Meghalaya High Court, which disposed of a PIL on vendor relocation, observing that the government had complied with the court's directive to shift certified vendors from Khyndailad to the vending zone at the MUDA Parking Complex by July

According to officials, 407 vendors were identified through a formal survey. Of them, 311 received Certificates of Vending (CoVs). and 282 stalls at the MUDA com-

plex have already been occupied. The relocation is part of the imlementation of the Meghalaya Street Vendors Scheme, 2023.

However, vendors at the protest alleged that the final list of beneficiaries was never published publicly, and many certified vendors were excluded without notice.

They demanded a halt to further evictions and a transparent reassessment of stall allotments. Angela Rngad, leader of the civil society group Thma U Rangli-Juki (TUR), speaking on behalf of MGSPHSVA, warned that the protest may intensify if the Town Vending Committee (PTVC) is not convened immediately to address the grievances of vendors whose CoVs were revoked despite being eligible.

She alleged that the Shillong Municipal Board had bypassed the PTVC and issued or revoked vending licences in an arbitrary manner, potentially favouring certain individuals. "This must go through the PTVC with proper documentation to prevent corruption or bias," she said.

Rngad said many legitimate vendors are still awaiting CoVs and questioned the lack of transparency in determining vendor eligibility

She also raised concerns about alleged irregularities in the construction and allocation of stalls at the vending zone.

The association has demanded a review of the vending zone plan and rationalisation of vendor spaces, especially for small-scale sellers such as betel nut or water

The hawkers have resolved to continue their sit-in protest until the SMB agrees to hold a PTVC

Under the relocation plan, each certified vendor is eligible for a ₹ 10,000 one-time assistance and a ₹ 2.000 monthly support for five months to help them re-establish their businesses at the new site.

The High Court has scheduled the next hearing on pending concerns, including licence revocations, on August 5. (PTI)

ceived a single dose of the measles vaccine, they added.

"A rapid survey of these areas revealed large gaps in immunisation," a district official said, urging people to get vaccinated. The district administration has

convened a multi-stakeholder meeting to develop a coordinated response to control the spread of infection and address the vaccine hesitancy, he said.

"Vaccine hesitancy has contributed significantly to the current situation," he said. (PTI)





Indian to become the head coach of the national football team in 13 years as he pipped Stephen Constantine and Stefan Tarkovic to grab the coveted post.

The last Indian to serve as the head coach of the national men's team was Savio Medeira, who held the position from 2011 to 2012. The 48-year-old Jamil had guided the unheralded Aizawl Football Club to a famous I-League title in 2017 and has a tough task at hand to turnaround the struggling Indian team's declining fortunes.

A former India international and currently in charge of Indian Super League side Jamshedpur FC, Jamil was selected by the All India Football Federation's (AIFF) executive committee.

Constantine was a former India head coach while Tarkovic has managed the Slovakia national team in the past.

The AIFF Technical Committee, led by legendary striker IM Vijayan, had shortlisted the three candidates for the executive committee's final decision.

An AFC Pro License Diploma holder, Jamil will succeed Spaniard Manolo Marquez, who parted ways with the AIFF last month following India's recent

been decided. We will do that after discussions with him and among ourselves. We also have to discuss with him his salary," AIFF President Kalyan Chaubey told PTI after the meeting.

"Jamil wanted a three-year tenure. Some ExCo members said it could be one year or two years. But it will be a long-term tenure, may be two or three years, and performance-based," Chaubey said. The AIFF president also made it clear that Jamil will be a full-time national team head coach and will not be associated with any other club. Jamil's predecessor Manolo had played a dual role during his one year tenure, taking charge of ISL side FC Goa when there was no national team



FROM RELUCTANCE TO PASSION

'Accidental coach' Khalid Jamil's journey to top of Indian football

NEW DELHI, Aug 1: Khalid Jamil's rise can't exactly be termed as meteoric but the last eight years has been nothing less than extraordinary for the 48year-old, who on Friday took over reins of the national men's football team.

If he decides to take a pause and look back to that summer of 2008, he might have a chuckle about his reluctance and anger after Mumbai FC management wanted him to coach the U-19s despite him being an active senior team player.

What if he would have rejected club's request outright? He didn't and thankfully on August 1, once an accidental coach is now at helm of country's national team.

From carrying Aizawl FC to an emotional I-League triumph which many felt was a shot in the arm for football in the north east

to facing immense pressure of expectations while coaching Kolkata giants East Bengal and Mohun Bagan with humongous fan base, Jamil has earned his stripes through the bump and grind of Indian football.

He is very much a product of the Indian football system having done his yards. This is a system he can play

around and vice-versa. No wonder he is one of rare Indian head coach of an ISL side --Jamshedpur FC and AIFF's choice to go for a 'Made In India' gaffer certainly won't raise eyeballs. Jamil, the youngest of the three contenders and without national team coaching experience at any level, became the first Indian in 13 years to occupy the coveted post. The last Indian who

was the national men's team head

coach was Savio Medeira from

2011 to 2012.

Jamil is, without question, the best Indian coach at the moment. He is the AIFF 'Coach of the Year' in the last two seasons, having made a name for himself for helping teams punch above their weight both in the I-League and the Indian Super League.

The unassuming Mumbaikar is a quintessential hard-worker known for meticulous planning before matches. His philosophy has been 'train hard and play

If one compares Jamil with coaches of yesteryears, closest comparison would be Syed Nayeemuddin, another firm believer in slogging hard at training and enjoying the fruits of labour during matches.

An AFC Pro License Diploma holder, Jamil has long been a trailblazer in Indian football.

Jamil was born in Kuwait but his family shifted to Mumbai after the Gulf War (1990-91). While studying at the famous Rizvi College in Mumbai, he made it to the university team. He later played for Mahindra United, Air India and Mumbai FC for major part of his club career.

"I always liked football from childhood, but when I started I didn't play the sport thinking of it as a profession. I kept on playing and it went like that," he had said. He is a deeply religious man,

who offers namaaz five times a day. Jamil made his national team debut in 1997 in a SAFF Cup match against Bangladesh in Kathmandu. A contemporary of the legendary Bhaichung Bhutia, Jamil played 15 matches for India till his retirement in 2006 due to

While playing for the Mumbai

FC senior team, he was asked to coach the junior side in 2008 and he reluctantly did that, and that changed his life.

"I was in the Mumbai FC senior team but one day I was asked to coach the U19 team. I had the hunger to play in senior team and did not want to coach. I was angry but agreed to coach the junior team," he had said.

"The U19 team did very well, won the league. Since David Booth has left the senior team, I was asked to take charge of the senior team (in 2009)." At just 33, he became the youngest coach in the I-League. He spent six seasons at Mumbai FC as head

The national team under Jamil may not be pleasing to watch, with less of 'tiki-taka' style short passing system. It will be a hardworking, well-organised, defen-

sively solid unit. His style is expected to be pragmatic football, according to match situation.

Jamil has spoken about keeping things simple, allowing his players the freedom to express themselves while maintaining defensive discipline. "My instructions (to players) are play defensively, man to man, be in shape, otherwise I give them a lot of freedom, to play their natural game depending on match situations," he had said.

"I don't give too many instructions especially to inexperienced Indian players. It should shouldn't be like my players are like robots and do exactly as I say. It's not very rigid.

BDFC nearly took the lead in first-half stoppage time when Robinson left a defender on the turf with a clever run but missed the target. Another teasing freekick from Pedro found Robinson again, but he failed to convert from close range as the half ended on 1-

The second half resumed with both teams trying to take control. Haokip (KAMSFC) and Pedro (BDFC) traded tame free kicks in the opening five minutes, both collected comfortably by the respective goalkeepers.

BFI elections scheduled for August 21 Good start by Diksha at AIG

NEW DELHI, Aug 1: The long-overdue Boxing Federation of India elections (BFI) will be held on August 21 in Delhi, the Interim Committee running the sport in the country has announced.

According to a circular issued on July 31 and signed by Interim Committee chief Ajay Singh, "the Annual General Meeting (AGM) of Boxing Federation of India will be held on 21.08.2025 at Delhi-NCR at 11:00 am.'

The agenda for the AGM are "confirmation of minutes of the previous meeting; election of various posts for the term 2025-2029 and any other item with the permission of the chair."

The tenure of the previous BFI officebearers ended on February 2. Elections were initially scheduled for March 28, but as stalled due to lega gling, including multiple appeals and counter-appeals. The BFI has been plagued by internal

strife and factionalism in the run-up to the elections. The Returning Officer, former Delhi High Court judge RK Gauba, also resigned from his post, alleging a smear campaign against him. In April, World Boxing, the sport's in-

ternational governing body, constituted the Interim Committee to manage the day-today affairs of Indian boxing. Last month, it set a deadline of August 31 to conduct the elections.

The entire electoral process will now restart, including the appointment of a new Returning Officer and the drafting of a fresh Electoral College.

The member associations have been asked "to send names of their two representatives as per the provisions of BFI's Constitution as approved by World Boxing to BFI's office email before 5 pm on 04.08.2025.

Singh, who has completed two fouryear terms as President, is set to contest for the third and last term as per the 2011 National Sports Development Code of

Former Sports Minister Anurag Thakur's had been nominated by Hi-



machal Pradesh Boxing as its representative in March but his name didn't figure in the Electoral College finalised by Singh and subsequently approved by the

Singh had said Thakur was "ineligible" to represent Himachal Pradesh, citing an official directive stating that only bonafide and duly elected members during the election AGM (duly notified to BFI) of the State Units affiliated with the BFI shall be authorised to represent their respective States/Union Territo-

Thakur's exclusion led his faction to initiate legal proceedings.

Interestingly, the revised BFI Constitution, which was approved by World Boxing on May 18, clearly defines a representative as "a person nominated by each Member to represent it at the General Council. Such person shall be an elected member of State/UT Association in Election AGM in presence of BFI Observer and shall not be a Government servant or holding a public office.'

It needs to be seen if HP Boxing nominate Thakur's name again. (PTI)

Don't think picking and choosing is a fair comment to Bumrah: India's assistant coach



LONDON, Aug 1: Jasprit Bumrah had made himself available for only three of the five Tests in England and the Indian team management felt it was right to honour the star pacer's call considering his workload, said assistant coach Ryan ten

Doeschate. With the series on the line, Indian captain Shubman Gill and head coach Gautam Gambhir waited till the last minute to take a call on Bumrah, who played the first Test at Headingley, skipped the second match at Edgbaston, and featured in

the games at Lord's and Old Trafford. Speaking to reporters after day one of the series-deciding fifth Test against England here, Doeschate said it is always a tough call leaving a player like Bumrah on the bench.

"It's quite a complex issue around Bumrah. We obviously want to wheel him in, but we also want to respect where his body's at, and on the basis of that, we just felt that it wasn't worth including him in the squad," he said on Thursday.

"He has bowled a large number of overs, I know it doesn't always seem like that because he's only played three Tests and he only bowled in one innings in Manchester.

"But if you look at the loads, he's bowled a lot of overs, and like he did say coming into the tour, he was going to be available for three games, and we just felt it was right to honour that call," Ten Doeschate added.

The Oval surface is the greenest of the series and Bumrah would have been lethal in the prevailing conditions. Is he picking and choosing games con-

sidering his injury prone past and back surgeries? "I don't think picking and choosing is

a fair comment to Bumrah. He did say he was going to play three games, he left it up to us which three he played. We've tried to manage the situation, it's not ideal, I guess giving those guys attention, the guys who aren't playing particularly when you're carrying 18 is important.

. Make them know that you're making all the decisions in good faith, in the best interest of the team, and just on that, all the guys who haven't played, they've been fantastic, they've trained the house down, they're disappointed when they get left out.

"They don't let it show when they're around the group and that's very important to creating a good culture for the guys who are playing to perform."

Doeschate added that it made sense to play Bumrah in Manchester than keeping him for the final Test. "Every time I've answered this ques-

tion I've spoken about like putting the

pieces of the puzzles together and guys were baffled when we didn't play him in the third Test," he said. "Our thinking was that the Oval, ves it's got bounce but it's normally a fairly good wicket for batting on, and we

thought we'd roll the dice and if we'd

won the toss we would have bowled. "In hindsight you would have loved to have him here, but you would also have said if we come here 3-1 down that we didn't use him there, so it's trying to not guess but trying to look into the future and then see how we can manage him, and maybe England have got it spot on leaving the best bowling wicket for the last Test after he's played three,

Doeschate said. (PTI)
