State govt to scrutinise applications for land transfer between persons of different faiths

State Cabinet clears new land transfer SOPs



GUWAHATI, Aug 27: The Assam Cabinet on Wednesday approved a Special Operating Procedure (SOP) to scrutinise applications for land transfer between persons of different religions for examining several angles, including national

security, before final permission is granted, Chief Minister Himanta Biswa Sarma said here. According to the SOP, the Special Branch of the Assam Police will examine whether the transfer of land involves any fraudulent or ille-

gal act, the source of funding of the buyers, impact on the social fabric of the locality where the land exists, and also the issue of national security, the CM said at a media briefing after the Cabinet meeting.

'If the proposal is received from buyers and sellers of the same religion, the SOP will not be applicable to them. But in the case of those from different religions, all these factors will be strictly examined,' Sarma said.

The same SOP will also be applicable to NGOs from outside planning to buy land in the state for setting up educational and healthcare institutions, he said.

'In a sensitive state like Assam, the issue of land transfer needs to be handled very carefully,' he said.

Some NGOs from Kerala have already bought land in Barpeta district, while some others are trying to buy huge tracts of land in Cachar and Sribhumi districts in Barak Valley, Sarmah claimed.

Communication channels open to resolve India-US tariff issue: Govt sources



NEW DELHI, Aug 27: Communication channels between India and the US are open to resolve the ongoing tariff issues, and the glitch in trade ties is only temporary, given the long-term relationship between the two nations, government sources said on Wednesday

The US's 50 per cent tariffs on Indian exports to America came into effect from August 27, barring

a few sectors. According to the sources, there is no need for panic for exporters as the impact of these high tariffs are unlikely to be as severe as

of Indian exports.
They added that India's exports to the US during the first four months of this fiscal year has risen 21.64 per cent to USD 33.53 bil-

Going by the trend, the exports may touch the last year's figure (USD 86.5 billion), one of the sources said.

"Communication channels are open between India and the US to resolve the ongoing tariff issues... it is a temporary phase in a longterm relationship," they said.

Meanwhile, in an interview with Fox Business, US Treasury Secretary Scott Bessent has described the India-US relationship as "very complicated" but hoped that "at the end of the day, we will come together".

HT Bureau GUWAHATI, Aug 27: In a significant push to boost private investment and generate employment in Assam, the State Cabinet chaired by chief minister Himanta Biswa Sarma at Lok Sewa Bhawan, Dispur, on Wednesday approved a set of key decisions, including major industrial and hospitality projects worth ₹ 969 crore.

According to the official statement, the Cabinet approved customised incentives under the Industrial and Investment Policy of Assam (IIPA) 2019 (as amended) to attract big-ticket investments in sectors ranging from gas manufacturing to healthcare, tourism and hospitality.

Among the projects cleared, Premier Cryogenics Limited will invest ₹ 125 crore in setting up a high-purity semiconductor-grade gas manufacturing plant at Jagiroad, which is expected to create employment for 200 people.

Operations Sindoor, Mahadev sent strong message to terror masterminds: Shah

NEW DELHI, Aug 27: Union Home Minister Amit Shah on Wednesday said that two major security operations, Operation Sindoor and Operation Mahadev. have sent an unmistakable message to the architects of terrorism that there will be consequences for targeting Indian citizens

Shah said that while Operation Sindoor "brought satisfaction among the people", Operation Mahadev transformed that satisfaction into "confidence".

The home minister said this while honouring 12 members of the Army, who successfully carried out Operation Mahadev and neutralised terrorists involved in the Pahalgam attack. Four personnel, two each from Jammu and Kashmir Police and CRPF, were also ho-

noured for being a part of the operation. The two operations were a direct response to a brutal attack on April 22 in Pahalgam, which claimed the lives of 26 people, mostly tourists.

"Whether from the ruling party or the Opposition, everyone felt joy and enthusiasm about operations Sindoor and Mahadev, and expressed gratitude to-

wards the security forces," Shah said.

This very trust in national security is the foundation of India's aspiration to achieve the highest position in the world in every field, he added.

On May 7, the armed forces launched Operation Sindoor, a large-scale military action targeting hideouts of banned Jaish-e-Mohammed and Lashkar-e-Taiba terror outfits in Pakistan and Pakistan-occupied

Operation Mahadev, launched immediately after the Pahalgam massacre, met with success on July 28 when the Army's elite para commandos neutralised mastermind, Sulieman alias Asif, and two of his associates, Jibran and Hamza Afghani.

The operation was launched after a technical signal detected the use of a satellite phone by the perpetrators. "Operation Sindoor and Operation Mahadev have sent a clear message to the masterminds of terror about the consequences of playing with the lives of Indian citizens," Shah said.

Secondary, tertiary effects of US tariffs on economy pose challenges: FinMin report

mediate impact of recent US tariffs on Indian exports may appear limited but their secondary and tertiary effects on the economy pose challenges that must be addressed, the finance ministry said in a report on Wednesday amid the US effecting a steep 50 per cent tariff on shipments from India.

Ongoing India-US trade negotiations are critical in addressing these issues including the secondary and tertiary effects of high tariff by the US on Indian goods, the monthly economic review released by the ministry said.

The steep 50 per cent tariff on Indian goods entering the US, which came into effect from August 27, would impact exports worth more than USD 48 billion. The sectors which would bear the brunt of the high import duties imposed by the Trump administration include textiles/ clothing, gems and jewellery, shrimp, leather and footwear, animal products, chemicals, and electrical and mechanical machinery.

"While the immediate impact of recent US tariffs on Indian exports may appear limited, their secondary and tertiary effects on the economy pose challenges that must be addressed. In this context, the ongoing India-US trade negotiations will be crucial," it said.

In line with the global shift towards diversification and strategic realignment, it said, India is actively pursuing a diversified trade strategy to sustain its resilient trade

The company is pursuing private equity investment for both Tropical Agrosystem and its subsidiary JE AgriScience rather than going public. "We are not going for an IPO. We are going for only private equity," Jhaver said, adding that discussions with potential investors have begun.

Export operations, currently in nascent stages, are expected to get a boost from next year as the company builds dedicated teams for biological and chemical products.

The company's key advantage against MNC rivals is competitive pricing, coupled with a dealer network of 22,000 partners pan-India. It also benefits from co-marketing arrangements with major players, particularly when their patents expire and generic manufacturing becomes available.

"When their products get offpatent, then everybody gets to manufacture these products. If you have the strength in the marketing team, then definitely selling will not be a problem," Jhaver noted.

On regulatory tailwinds, the chairman said the recent government ban on 30-40 year-old chemicals haven't impacted the company's operations. More importantly, regulatory approval timelines have improved dramatically -- from 5-7 years earlier, to just 1-1.5 years now. (PTI)

with the aim of ensuring more efficient processing and expeditious disposal of such proposals, he said. 'All applications for land transfer of this nature would be submitted to the government, which would exercise scrutiny over each case,' he said.

The district commissioner concerned would forward the proposal to the Revenue Department.

The designated nodal officer within that Department would then transmit it to the Special Branch of the Assam Police, where officials would examine the proposal to identify any elements of fraud, coercion, or illegality, to verify the source of funds used for the purchase, assess potential implications for social cohesion, and safeguard national security, he said.

Thereafter, the proposal would be returned to the government, with the district commissioner taking the final decision. The Cabinet also gave its nod to projects with private investment of ₹ 969 crore which would likely create 2,704 employment opportunities.

The projects include Ambuja Neotia Healthcare Venture Limited's hospital project with an investment of ₹ 302.65 crore, in addition to Ambuja Neotia Hotel Ventures Limited's ₹ 360 crore hospitality project.

The others include Premier Cryogenics Limited's investment of Rs 125 crore for setting up a high-purity semiconductor-grade gas manufacturing plant at Jagiroad, which is expected to generate employment for 200 people and Jonali Construction Private Limited's investment of ₹ 182.17 crore in tourism and hospitality services related to the Marriott Resort and SPA project, with the potential to create 204 jobs.

The Cabinet also approved the closure of the Assam Plantation Crops Development Corporation Ltd and corresponding financial sanction towards payment of VRS/one-time settlement and closure cost amounting to ₹ 600 lakh. (PTI)

"In the next 2-3 days, the ministry will meet stakeholders on the diversification of exports," an official said The steep 50 per cent tariff on Indian goods entering the US, which came into effect from August 27, will impact India's exports worth more than USD 48 billion to America.

The sectors, which would bear the brunt of high import duties imposed by the Trump administration include textiles/clothing, gems and jewellery, shrimp, leather and footwear, animal products, chemicals, and electrical and mechanical machinery. Sectors such as pharma, energy products and electronic goods are out of the ambit of these sweeping duties.

The US accounted for about 20 per cent of India's USD 437.42 billion worth of goods exports in 2024-25. The US has been the largest trading partner of India from 2021-22. In 2024-25, the bilateral trade in goods

stood at USD 131.8 billion (USD 86.5 billion exports and USD 45.3 billion imports). India is also planning dedicated outreach programmes in 40 countries, including the UK, Japan, and South

Together, these 40 countries represent more than USD 590 billion in textile and apparel imports, offering vast opportunities for India to enhance its market share, which stands at only 5-6 per cent, the official said. According to exporters, these high tariffs will have impact on their cost competitiveness in the US as their

competitor countries, including Bangladesh, Thailand, Vietnam, and Indonesia are being subjected to lower duties by America. Exporters said the imposition of a 25 per cent penalty on India over and above the 25 per cent tariffs move will disrupt the flow of Indian goods to its largest export market.

Mithileshwar Thakur, Secretary General, AEPC (Apparel Export Promotion Council), has said the textiles sector, with exports of USD 10.3 billion to the US, is one of the worst-impacted sectors.

Similarly, a leather exporter said some of the companies have orders in hand for 2-3 months, but the US firms are demanding about a 20 per cent discount to retain the orders.

Economic think tank GTRI said the US tariffs will hit 66 per cent of India's USD 86.5 billion exports to America. "The United States' new tariff regime marks one of the most severe trade shocks India has faced in recent years. With over two-thirds of India's USD 86.5 billion exports to the US now subject to prohibitive 25-50 per cent duties, critical labour-intensive sectors face sharp declines in competitiveness and employment," GTRI Founder Ajay Srivastava has said

He said India's exports to the US are set to fall steeply to about USD 49.6 billion in FY26 due to Washing-

Exporters have urged the government to announce steps to deal with these high tariffs. They have urged a moratorium on payment of principal and interest for loans up to a period of one year.

Besides, expanding PLI schemes, enhancing infrastructure, and investing in cold-chain/storage assets to strengthen competitiveness and aggressive market diversification through accelerated trade agreements (FTAs) with the EU, Oman, Chile, Peru, GCC, Africa, and other Latin American countries, with a provision for earlyharvest for labour-intensive sectors, should be prioritised, FIEO said.

It appeals for swift, coordinated action among exporters, industry bodies, and government agencies to protect livelihoods, reinforce global trade links, and navigate this turbulent phase. (PTI)

Assam LoP writes to human rights commission over infant's death in govt hospital

GUWAHATI, Aug 27: Leader of the Opposition in Assam Assembly, Debabrata Saikia, on Wednesday urged the state human rights commission to lodge a suo motu case and inquire into the death of a newborn in Gauhati Medical College and Hospital (GMCH). In a letter written to the chairperson of Assam Human Rights Commis-

sion (AHRC), Saikia sought to fix accountability in the death of the newborn at GMCH neonatal intensive care unit (NICU) on August 18, allegedly due to negligence.

'This incident, prima facie attributable to overcrowding, staff shortages, and abject failure in duty of care in the NICU, constitutes a blatant violation of fundamental human rights enshrined in the Constitution. "I urge the commission to take suo motu cognisance under Section

21(5) of the Protection of Human Rights Act, 1993 (PHRA)," he said. A four-day-old infant died after she was found hanging from the wires of a medical equipment in the NICU of GMCH on August 18. The infant, born in the same hospital on August 15, was admitted to the NICU for infection and jaundice.

Saikia demanded that a committee of independent experts be constituted to investigate the incident and submit a time-bound report on systemic failures in Assam's hospitals, including staffing and infrastructure deficiencies. "That liability be fixed on the chief minister of Assam, Himanta Biswa Sarma, and the Department of Health for irresponsible statements causing emotional distress, and for systemic lapses, recommending disciplinary action," he added.

Further, Saikia demanded that immediate interim compensation of Rs 10 lakh be paid to the parents under the Assam Victim Compensation Scheme, 2012, with final relief based on inquiry findings.

He said that state protection, including security and legal aid, should be provided to parents of the deceased infant under whistleblower laws for facing threats.

"The persistent recurrence of medical negligence in Assam's public healthcare facilities, coupled with the state's failure to effect meaningful reforms, necessitates immediate and robust intervention by the AHRC pursuant to the Protection of Human Rights Act, 1993," Saikia said in the letter. The commission's statutory authority to initiate suo motu inquiries, recommend prosecutions, and direct compensatory relief must be invoked to curb impunity and uphold fundamental rights, he said.

'The egregious circumstances surrounding the death of a newborn at GMCH on August 18, attributable to systemic lapses such as overcrowding and inadequate supervision, underscore the urgency of such action," the senior Congress leader added. (PTI)

District administration gears Teacher arrested in Dhubri for alleged links to jihadi outfits up for smooth conduct of

DHUBRI, Aug 27: In a significant development, a school teacher has been arrested in Golakgani. Assam, on suspicion of links with jihadi organizations. The accused, identified as Shah Alam Sarkar, a teacher at Lakhimari Middle School, was arrested by Dhubri police for alleged association with Jamaat-e-Islami, a political and religious group in Bangladesh.

According to police, Sarkar, a resident of Lakhimari village on the India-Bangladesh border, is currently under interrogation. Investigations are ongoing to determine the extent of his connections.

Lakhimari Middle School, where Sarkar worked, was originally established as Lakhimari Pre-ME Madrasa and later converted into a general school under SEBA by a government notification on 13th December 2023. Police are investigating whether the school's history played any role in facilitating these alleged links.

Meanwhile, another teacher from the same school, Hazrat Ali, is absconding. Authorities are actively searching for him as part of the probe.

A complicated situation

larification offered on August 21 by director general of Assam Rifles Lt-Gen Vikas Lakhera about Myanmarese nationals entering India under the Free Movement Regime (FMR) effective from last week of December 2024 has given an opportunity to the Kuki-Zo Council (KZC), a representative civil society organization in Manipur, to reiterate that their community people are not illegal immigrants nor have they entered India in recent times. Lt-Gen Lakhera's clarification followed a seminar Assam Rifles organized the previous day, that is, Wednesday, August 20 at the Manipur University premises as part of an academic collaboration between Assam Rifles and the university. FMR was the theme. The importance of the Assam Rifles initiative has to be gauged from the fact that this old, prominent security establishment is practically in charge of administering FMR along the 398 km Manipur-Myanmar border, which has been at the centre of controversy since February 2021 when a junta assumed control of Myanmar and the country witnessed the emergence of resistance forces opposed to the junta. Myanmarese people crossing over the to the Indian side has been an issue since then and former chief minister's regular refrain has been that a large number of illegal immigrants in Manipur are Kuki-Zos who have been engaging themselves in illegal activity, such as, smuggling and poppy cultivation.

What did Lt-Gen Lakhera say on August 21 in clarification? After the new FMR policy came into effect, the Myanmarese nationals entering India through crossing points are now being mapped. Since December [2024] 42,000 individuals have been mapped with the help of biometrics and various measures put in place by all involved government agencies, whom the data is being shared. These Myanmarese citizens stay temporarily in India's north-eastern states of Manipur, Nagaland, Mizoram and Arunachal Pradesh and "eventually revert to their country as per the provisions of the new FMR policy". Thus, the situation that has evolved after the Assam Rifles DG's clarification lends itself to two interpretations: first, Lt-Gen Lakhera's observation has been found comforting by KZC and secondly, KZC has utilized the occasion to target the immediate past Manipur chief minister, who is one of the tall Meitei leaders known for strong anti-Kuki-Zo bias.

It appears there is no formal order on scrapping FMR. As it is an international matter, India's external affairs ministry naturally should be in the picture. It looks like it is an in-principle decision, based on which directives on what has to be done have been given to officials. From published reports it is seen that an intention to scrap FMR was first announced by Union home minister Amit Shah in February 2024 taking into account the then raging ethnic conflict in Manipur and the complicated situation on the Manipur stretch of India-Myanmar border.

Assam's Aadhaar Dilemma: Identity, Migration, and the politics of citizenship

conomy and identity are often seen as the twin foundations upon which the destiny of ✓ nations rests. While the former dictates material survival, the latter defines belonging. Nowhere in India does this tension appear more visibly than in Assam, a land of immense natural beauty, abundant resources, and yet, an unending struggle with questions of citizenship, migration, and cultural preservation. At the heart of this struggle lies a paradoxical situation surrounding Aadhaar—the twelve-digit biometric identity number meant to be a universal marker of citizenship-like recognition in India. For most Indians, Aadhaar is an enabler, a facilitator of access to welfare, banking, mobile connectivity, and countless everyday functions. But in Assam, it has become the site of contradiction, exclusion, and contested legitimacy.

The debate over Aadhaar in Assam cannot be understood in isolation; it is inseparably linked to the history of migration, the Assam Accord of 1985, the prolonged exercise of the National Register of Citizens (NRC), and the fraught politics of identity. While the Union government has projected Aadhaar as a universal identity project, in Assam, Aadhaar's legitimacy has been undercut by the state's exceptional position within India's citizenship regime. As the state still grapples with the aftershocks of the NRC exercise that excluded nearly two million people, Aadhaar assumes an uncertain place—functional in parts, yet legally tenuous, accessible to many vet denied to others.

The crux of the Aadhaar dilemma lies in its uneasy coexistence with the NRC. The NRC, updated under the monitoring of the Supreme Court, was meant to be the definitive list of Indian citizens in Assam. Its publication in 2019 excluded 19,06,657 names, plunging these individuals into uncertainty about their legal status. Yet, many among these excluded have Aadhaar cards, which, by design, were never meant to confer citizenship but have nonetheless become a quasi-proof of legitimacy in practice. This disjuncture has created a peculiar situation where individuals can hold Aadhaar and enjoy its functional benefits—such as rations under the Public Distribution System (PDS) or banking services—while simultaneously being excluded from the NRC, thereby facing the threat of statelessness.

The contradictions multiply when one examines how Aadhaar enrolment has played out in Assam. Unlike other states, Aadhaar penetration here was deliberately delayed due to concerns over illegal migration from Bangladesh. While in Kerala or Maharashtra Aadhaar enrolment surpassed 95 percent early on, Assam's coverage lagged behind. creating a vacuum in welfare distribution and leaving millions in limbo. It was only after the Supreme Court's interventions and persistent central push that Aadhaar enrolment picked up. Yet, the spectre of migration politics continued to haunt the process, with allegations that Aadhaar could be misused by "illegal immigrants" to claim entitlements, further unsettling the indigenous As-

The lived consequences of this exceptionalism are stark. Farmers denied crop subsidies because they lack Aadhaar linkage, daily wage workers unable to receive government transfers, students barred from scholarships, pensioners cut off from benefits—all bear testimony to the precarious in-

tersection of welfare and identity. What was envisioned as a neutral, technocratic tool of inclusion has in Assam become a weapon of exclusion. Stories abound of families where the father has Aadhaar and is included in the NRC, the mother has Aadhaar but is excluded, and children are caught in bureaucratic uncertainty, deprived of state benefits despite being born in India. These human tragedies underscore the limitations of a purely technocratic approach to a deeply political issue.

At the heart of this debate lies the uneasy Assamese relationship with migration. The Assam Accord of 1985, signed after a six-year-long agitation, recognized March 24, 1971, as the cut-off date for identifying illegal immigrants. Anyone entering Assam after this date, regardless of origin, was to be declared a foreigner. This unique provision set Assam apart from the rest of India, embedding within its political consciousness a heightened sensitivity to migration. Aadhaar, with its universalist claims, seems to undercut this exceptionalism, raising fears that it dilutes the hardwon safeguards of the Accord. For Assamese nationalists, Aadhaar becomes more than a number—it is a perceived threat to identity, culture, and demography.

Yet, the Aadhaar-NRC conundrum is not merely a local story: it is emblematic of India's larger struggle to balance inclusion with exclusion, welfare with surveillance, and identity with citizenship. For the Union government, Aadhaar is indispensable in building a digital welfare state, plugging leakages, and accelerating direct benefit transfers. But in Assam, this logic collides with a state-specific history where identity politics precedes welfare priorities. This tension is further aggravated by the political economy of the region, where livelihoods are fragile and heavily dependent on state support. In such a context, denial of Aadhaar-linked benefits can quickly escalate into humanitarian crises.

The judiciary too has been drawn into this labyrinth. On one hand, the Supreme Court has ruled that Aadhaar is not proof of citizenship but merely of residence. On the other, the very act of excluding Aadhaar in Assam due to migration concerns implicitly treats it as a marker of citizenship. This contradiction not only confuses citizens but also paralyses administrators, forcing them into impossible choices between legality and compassion. The Foreigners' Tribunals, burdened with adjudicating claims of citizenship, often confront cases where Aadhaar exists but is deemed irrelevant. Meanwhile, those excluded from NRC but holding Aadhaar live in perpetual uncertainty legally suspect but practically dependent on the

Politics in Assam has weaponized this dilemma further. For the ruling Bharatiya Janata Party (BJP), the NRC and Aadhaar debates have provided fertile ground for electoral mobilization. By projecting itself as the guardian of Assamese identity while simultaneously championing welfare schemes tied to Aadhaar, the party has sought to straddle the contradictions. Opposition parties, meanwhile, accuse the government of doublespeak, arguing that the combination of NRC exclusion and Aadhaar-linked welfare reflects an incoherent policy that punishes the poor. Civil society, too, is divided—some groups see Aadhaar as an insidious attempt to erase Assamese exceptionalism, while others demand its universalization to ensure that no child goes hungry due to

The consequences of this stalemate extend beyond Assam, raising questions about India's larger democratic trajectory. At one level, Aadhaar symbolizes the promise of a modern digital state—efficient, transparent, and inclusive. At another, it exposes the fragility of citizenship in a democracy still wrestling with post-colonial anxieties of identity. Assam, with its fraught borders, history of migration, and contested nationalism, has become the testing ground for how India negotiates this tension. The world is watching, for the questions Assam confronts are not unique—many nations today face similar dilemmas of how to integrate migrants, secure borders, and vet remain inclusive. In this sense, Assam's Aadhaar dilemma is both a local tragedy and a global parable.

It is worth remembering that identity systems have historically been double-edged. From South Africa's pass laws under apartheid to America's Social Security number, state-issued identities have often oscillated between inclusion and exclusion, empowerment and surveillance. Aadhaar, though far removed from such histories, carries similar risks, especially in contexts like Assam where citizenship itself is contested. The challenge, therefore, is not to reject Aadhaar but to reconcile it with the state's unique history, ensuring that technology does not trample upon rights, and that the promise of inclusion does not degenerate into a new form of exclusion.

The way forward demands honesty and imagination. Legally, there must be clarity on the relationship between Aadhaar and citizenship—are they complementary, supplementary, or independent? Administratively, safeguards are needed to ensure that denial of Aadhaar does not mean denial of welfare.

Politically, leaders must resist the temptation to exploit identity for electoral gain and instead focus on building consensus around inclusive growth. Socially, there is a need to recognize that Assamese fears of cultural erosion are real, but they cannot be addressed through bureaucratic exclusion alone. Only a combination of legal safeguards, economic empowerment, and cultural ecognition can ease these anxieties.

The broader Indian story too is instructive. As the world's largest democracy, India's ability to harmonize diversity with unity, citizenship with rights, and welfare with identity will shape its global image. Assam, though a small state geographically, thus holds disproportionate importance in this national narrative. Its Aadhaar dilemma is not a marginal problem but a mirror reflecting the tensions of Indian democracy itself.

Assam today stands at a crossroads where technology, politics, and identity intersect in unsettling ways. Aadhaar, hailed as a universal enabler, has become in Assam a contested marker of belonging. The NRC, intended to provide clarity, has deepened uncertainty. Between them lies a humanitarian crisis where millions hover between recognition and exclusion, between security and statelessness. The challenge before India is not simply to resolve a technical glitch or a legal anomaly but to reaffirm the very principles of justice, equality, and inclusion upon which its democracy rests. For in the final analysis, identity is not just about numbers or documents—it is about dignity, belonging, and the promise of a future where no citizen feels alien in their own land. 100 years of RSS: A Saga of service

September 27, 1925, a small gathering of young men in Nagpur, India, marked the birth of an organization that would grow into one of the world's largest voluntary networks, profoundly shaping the nation's socio-political landscape. Founded by Dr. Keshav Baliram Hedgewar, a physician and freedom fighter disillusioned with the prevailing independence movement, the Rashtriya Swayamsevak Sangh, or RSS, emerged as a response to the perceived disunity among Hindus amid British colonial rule and communal tensions. Hedgewar, inspired by the writings of Vinayak Damodar Savarkar, the architect of Hindutva ideology, envisioned the RSS as a non-political body dedicated to character building, physical discipline, and fostering a sense of Hindu unity. That Vijayadashami day, with just 15 to 20 participants including early stalwarts like Bhauji Kawre, Anna Sohni, and Vishwanathrao Kelkar, the group hoisted the saffron flag, known as the Bhagwa Dhwaj, which would become the symbolic guru of the organization. This modest beginning laid the foundation for what would evolve into a vast ecosystem promoting Hindu cultural revival and national strength.

The early years of the RSS were marked by a deliberate focus on grassroots organization rather than overt political engagement. By May 28, 1926, the first daily shakha, or branch meeting, commenced at Mohitewada Ground in Nagpur, introducing routines of physical exercises, lathi training, and intellectual discussions. Commands like "Dakhsa" for attention and "Aaram" for rest echoed in Sanskrit, emphasizing discipline and cultural rootedness. Hedgewar insisted on starting and ending sessions with salutations to the Bhagwa Dhwaj and prayers in Hindi and Marathi, instilling a sense of devotion to the motherland. The inaugural route march, with 30 participants, symbolized the paramilitary-style drills that would characterize RSS activities, aimed at building valor and courage among Hindu youth. Hedgewar's philosophy was clear: train individuals physically, mentally, and intellectually to serve the nation selflessly, without formal mem-

bership or fees, making it accessible to all.
On April 17, 1926, a pivotal meeting at Hedgewar's residence finalized the organization's name from options like Jaripatka Mandal and Bharat Uddharak Mandal. Rashtriya Swayamsevak Sangh was chosen for its emphasis on national volunteers united in service. This naming reflected Hedgewar's rejection of his own deification; despite swayamsevaks' wishes to honor him as guru, he elevated the saffron flag to that status

a tradition upheld annually on Vyas Poornima. Under Hedgewar's leadership until his death in 1940, the RSS expanded cautiously, establishing shakhas across Maharashtra and beyond. It maintained neutrality toward the Indian National Congress's non-cooperation movement, prioritizing long-term Hindu consolidation over immediate anti-colonial agitation. Many early members, including Hedgewar himself, had Congress ties, but the RSS critiqued Gandhi's emphasis on Hindu-Muslim unity, viewing it as weakening Hindu resolve. By the late 1930s, the organization had grown to thousands of members, with Hedgewar organizing the first training camps to instill ideological depth.

Hedgewar's passing on June 21, 1940, was a turning point, as leadership passed to Madhav Sadashiv Golwalkar, known as Guruji, a bachelor ideologue who would steer the RSS for three decades. Golwalkar, influenced by Savarkar's Hindutva, articulated the vision of a Hindu Rashtra in his seminal 1939 book "We or Our Nationhood Defined," arguing that India's identity was inherently Hindu and that minorities must assimilate into this cultural framework. Under Golwalkar, the RSS formalized its hierarchical structure, with regional parents and full-time pracharaks dedicated to propagation. The organization distanced itself from direct politics, advising members to engage individually but not as RSS representatives. This period saw rapid expansion, with shakhas multiplying amid World War II and the Quit India Movement of 1942, where RSS swayamsevaks provided underground support without official involvement.

The partition of India in 1947 brought communal violence on an unprecedented scale, and RSS volunteers played a significant role in protecting Hindu refugees and organizing relief efforts. However, the assassination of Mahatma Gandhi on January 30, 1948, by Nathuram Godse, a former RSS member who had left the organization, cast a dark shadow. The government, led by Home Minister Sardar Vallabhbhai Patel, imposed a nationwide ban on the RSS on February 1948, accusing it of fostering hatred. Golwalkar and thousands of swayamsevaks were arrested, and the organization went underground. The ban highlighted early criticisms: the RSS's initial reluctance to adopt the tricolor flag, preferring the Bhagwa Dhwaj, and its critique of the Indian Constitution for not referencing Manusmriti laws. Publications like the RSS-inspired Organiser newspaper had editorialized against the tricolor, calling it unfit for Hindus. After 18 months of negotiations and assurances of non-violence, ditions like maintaining membership records and avoiding communal activities. This episode forced introspection, leading Golwalkar to emphasize the RSS's cultural rather than militant

The 1950s and 1960s under Golwalkar saw the RSS's ideological consolidation and expansion into the Sangh Parivar family of organizations. In 1951, the Bharatiya Jana Sangh was founded as its political arm, with RSS pracharaks like Deendayal Upadhyaya playing key roles. The Jana Sangh advocated for a Hindu-centric polity, contesting elections and winning seats, though it remained marginal. Golwalkar's tenure emphasized anti-communism and social reform, with swayamsevaks involved in cow protection movements and opposing linguistic divisions post-in-dependence. The 1962 Sino-Indian War was another defining moment; RSS volunteers offered relief and even joined the army, earning praise from Prime Minister Jawaharlal Nehru, who lifted lingering restrictions. This bolstered the organization's image as patriotic, despite ongoing Congress suspicions.

Golwalkar's death on June 5, 1973, led to the appointment of Madhukar Dattatray Deoras, or Balasaheb, as the third Sarsanghchalak. Deoras shifted focus toward social engagement, declaring in 1974 that "if untouchability is not wrong, nothing in the world is wrong," galvanizing anti-caste efforts. This era saw the RSS penetrate diverse sectors, from education via Vidya Bharati schools to labor through Bharatiya Mazdoor Sangh. The Emergency imposed by Indira Gandhi on June 25, 1975, tested the RSS's resilience. Banned again on July 4, 1975, for alleged anti-government activities, Golwalkar had already prepared swayamsevaks for underground operations. Over 100,000 members were imprisoned, yet the RSS coordinated with Jayaprakash Narayan's opposition, mobilizing protests that contributed to the Emergency's end in 1977. The ban's lifting of postelections marked a turning point, mainstreaming the RSS and leading to the Jana Sangh's merger into the Janata Party, which formed the first non-Congress government

The late 1970s and 1980s witnessed the RSS's deepening influence on politics. The Janata Party's internal conflicts led to the BJP's formation on April 6, 1980, under Atal Bihari Vajpayee, with RSS backing. Leaders like L.K. Advani and Murli Manohar Joshi, former swayamsevaks, steered it toward Hindutva. The Ram Janmabhoomi movement, launched in 1984 by the Vishwa Hindu Parishad (VHP), an RSS affiliate, became a mass mobilization effort. The 1989 palanquin procession of Ram's idols from Sita-

marhi to Ayodhya galvanized millions, culminating in the Babri Masjid's demolition on December 6, 1992, triggering nationwide riots and a third RSS ban until June 1993. Despite the controversy, the movement propelled the BJP to power in 1998, with Vajpayee as Prime Minister. The RSS's role in relief during the 1984 anti-Sikh riots and natural disasters like the 1979 Morbi dam failure underscored its service ethos.

The 1990s and 2000s under fourth Sarsanghchalak Rajendra Singh (K.S. Sudarshan, 2000-2009) saw the Sangh Parivar's diversification. Organizations like Seva Bharati focused on welfare, running schools for tribals and disaster relief. The 2001 Gujarat earthquake saw RSS volunteers providing aid to over 100,000 people. Controversies persisted, including the 2002 Gujarat riots, where RSS was accused of inciting violence, though it denied involvement and aided rehabilitation. In 2002, after activists forcibly hoisted the tricolor at RSS headquarters on Republic Day, protesting its absence, the organization finally adopted the national flag officially, marking symbolic integration. Sudarshan's tenure emphasized outreach, with initiatives like the Vishwa Mangal Gau Grama Yatra in 2009 collecting millions of signatures for cow protection.

The fifth Sarsanghchalak, Mohan Bhagwat, assumed leadership in 2009, ushering in a phase of strategic moderation and expansion. Under Bhagwat, the RSS grew to over 58,000 shakhas and 44,000 bastis by 2025, with swayamsevaks numbering in the millions. The organization supported the BJP's 2014 victory under Narendra Modi, a

lifelong RSS pracharak, influencing policies like the abrogation of Article 370 in 2019 and the Ram Temple foundation in 2020. Bhagwat's 2018 three-day conclave in Delhi outlined a 21st-century roadmap, emphasizing social harmony, environmentalism, and inclusive Hindutva, attracting diverse audiences through Q&A sessions. Service activities surged: during the 2013 Uttarakhand floods, RSS volunteers rescued thousands alongside the army; in 2006 Surat floods, they distributed essentials to affected families. The 2020 COVID-19 lockdown saw swayamsevaks deliver food, masks, and aid to millions, earning praise even from a Muslim woman in Kashmir who donated her Hajj savings to Seva Bharati.

The RSS's centenary in 2025 reflects a century of evolution from a small cadre to a global force with affiliates in over 100 countries via Hindu Swayamsevak Sangh. Key moments like the bans forged resilience, while movements like Ram Janmabhoomi unified Hindus across castes. Critiques of communalism persist, but the RSS maintains its cultural focus, with women's wings like Rashtra Sevika Samiti boasting 1.8 million members. Bhagwat's leadership has promoted interfaith dialogues and anti-conversion law support, balancing ideology with pragmatism. As India navigates global challenges, the RSS's emphasis on self-reliant Bharat, drawing from ancient values, positions it as an enduring pillar. From Hedgewar's vision to Bhagwat's roadmap, the journey underscores a commitment to national rejuvenation, proving that disciplined service can transform so-

Saplings under CM's 'Amrit Vriksh Andolan' and PM's 'Ek Ped Maa Ke Naam'

n 8 June 2023, Assam's Chief Minister Himanta Biswa Sarma launched a new green initiative called the "Amrit Vriksh Andolan." This became one of the largest plantation drives in Assam, under which 53 species of commercially valuable trees were chosen for plantation. On 17 September 2023, lakhs of people across the state—including women, teachers, party workers, and security forces—participated in the campaign.

The state forest department arranged free distribution of saplings for plantations. By 2024, more than 1.19 crore commercial saplings had been planted across the state, and reports indicate that over 80% of them are still surviving. Building on this achievement, the Chief Minister announced that under the 2023–24 financial year plan, a target of planting 5 crore saplings by 2025 has been set.

This campaign, based on a public participation model, received an overwhelming response. Over 48 lakh beneficiaries registered themselves through a mobile application. After planting saplings, people uploaded geo-tagged photos to the portal, verifying their contribution. Due to such mass participation and success, the "Amrit Vriksh Andolan 2023"

even set a Greeniz World Record.

Objectives of the Amrit

The main objectives of this movement are to increase tree cover outside forest areas, expand commercial plantations, nurture saplings through sustainable methods, and enhance Assam's green economy. It also aims to strengthen the agroforestry sector, provide raw ma-

terials for wood-based industries, attract investment in the sector, and create new employment opportunities for the people of

Assam.

Alongside this, Prime Minister Narendra Modi, on the occasion of World Environment Day (5 June 2024), launched the "Ek Ped Maa Ke Naam" campaign, urging citizens to plant a sapling in their mother's name as a tribute. Responding to this call, Chief Minister Dr. Himanta Biswa Sarma also encouraged the people of Assam to participate in this campaign.

Contribution of the Government Nursery at Chenga, Barneta

Among the nurseries that contributed significantly to both "Amrit Vriksh Andolan" and "Ek Ped Maa Ke Naam," the government nursery at Chenga in Barpeta under the Divisional Social Forestry Department has come into the limelight for distributing the

highest number of saplings.

Managed under the supervision of forest officer and Beat In-Charge Dhira Shri Das since 2024, this nursery has been making remarkable contributions. It produces a wide variety of valuable saplings such as mahogany, hilikha, amlakhi (Indian gooseberry), bhomora, bogijamu, sisoo, Manipuri urhi, kadam, shimlu, and arjun.

The nursery was initially established in 2024 on 5 hectares of land under the CAMPA Scheme. Later in 2025, another 3-hectare nursery was set up under the SOPD Scheme. The government's plan for 2024–25 includes planting 5 crore saplings across Assam, of which 12.15 lakh saplings are to be supplied from

these two Chenga nurseries to different parts of the state.


During the "Ek Ped Maa Ke Naam" campaign, this nursery distributed over 30,000 saplings, bringing special recognition to both the nursery and its in-charge Dhira Shri Das. Owing to this significant contribution, she was even invited as a special guest during the 79th Independence Day of India.

Challenges Faced in Establishing the Nursery

When the responsibility of establishing the Chenga nursery under the SOPD Scheme was entrusted to Dhira Shri Das, many considered it nearly impossible. However, through dedication and hard work, she successfully developed the nursery in a very

short period. The first major challenge was land preparation. The site was previously covered with dense forest, which had to be cleared to prepare land for the nursery. Another big challenge was water scarcity. The region receives very little rainfall, causing many saplings to wither. Initially, attempts were made to irrigate using borewells, but covering the vast 5-8 hectare area was nearly impossible. During the scorching heat of June–July, a large number of saplings dried up, forcing the SDRF (State Disaster Response Force) to assist in supplying water continuously for two to three days.

Despite such difficulties, Dhira Shri Das, along with the cooperation of Barpeta's forest division and other officials, played a vital role in successfully implementing both the Chief Minister's "Amrit Vriksh Andolan" and the Prime Minister's "Ek Ped Maa Ke Naam" campaign. Her dedication and contribution truly deserve high appreciation and recognition.

Trump again claims he stopped India-Pak war from 'going nuclear'

WASHINGTON, Aug 27: US President Donald Trump has once again claimed that he stopped the India and Pakistan war from "going nuclear" by threatening to impose tariffs and refusing to do any trade deals if they did not agree to a ceasefire.

Trump's latest comments came on Tuesday during a cabinet meeting at the White House, where he also claimed that he had spoken with Prime Minister Narendra

"I am talking to a very terrific man, Narendra Modi. I said, 'What's going on with you and Pakistan?' The hatred was tremendous. This has been going on for a hell of a long time, like, sometimes with different names for hundreds of years," the US president said.

"I said. I don't want to make a trade deal with you... You guys are going to end up in a nuclear war... I said, call me back tomorrow. But we're not going to do any deals with you, or we're going to put tariffs on you that are so high, your head's going to spin," he added.

"Within five hours, it was done. Maybe it starts again, but I will House on Monday, Trump had

Trump also claimed that "seven jets or maybe more than that" were shot down without elaborating which country's aircraft he was referring to.

DAMASCUS, Aug 27: Israeli drone strikes on a southern suburb of the Syrian capital Damascus killed six soldiers and wounded others, state media and a war monitor reported Wednesday

The latest drone strikes occurred Tuesday in the southern Damascus suburb of Kiswah and killed six soldiers, state-run Al-Ikhbariah reported, without giving further details.

The Israeli military did not immediately comment on the

Since the fall of Bashar Assad in December, Israel has carried out hundreds of airstrikes on different parts of the country, destroying Syrian army assets.

The Britain-based Syrian Observatory for Human Rights said the strikes hit a point that links Damascus with the southern province of Sweida that witnessed deadly clashes last month between pro-government gunmen and fighters from Syria's Druze minority

Israel intervened during the fighting last month on the side of the Druze, who form a substantial community in Israel, where they are seen as a loyal minority and often serve in the Israeli



BOGOTA, **Aug 27:** The father of Miguel Uribe, the Colombian presidential candidate fatally shot at a political rally earlier this year, launched a presidential campaign Tuesday in what he called an effort keep his son's legacy alive and build a safer and more prosperous

Miguel Uribe Londoño, 72, announced his candidacy with a speech outside the congressional building in the capital where his son became a well-known senator, and spoke behind a podium fitted with the campaign logo used by his

He gained new prominence during his son's nationally televised funeral, when he delivered a speech decrying what he called the country's descent into "madness" under the administration of leftwing President Gustavo Petro and urging Colombians to vote in next year's elections.

Uribe Londoño is one of five candidates that are running for the Democratic Center, the conservative party that Miguel Uribe belonged to. The party has said that later this year, it will use opinion polls to decide on its final candi-

Sergio Guzman, a political analyst in Bogota, said that Uribe Londoño's decision to enter the presidential race "reinvigorates" the Democratic Center, which has struggled to find a popular candidate while its leader, former Presi-"Together we can build a secure dent Alvaro Uribe, fights bian courts. The former president is no relation to Uribe Londoño

Guzman said that Uribe Londoño, whose wife was murdered in the 1990s, "symbolizes the pain of many victims, especially those who are conservatives."

Uribe Londoño's entry into the presidential race comes as Colombia faces a new wave of violence, caused largely by rebel groups and drug gangs that are trying to take over territory abandoned by the FARC, the guerrilla army that made peace with the government

The Fed hit the pause button heading into 2025 over concerns that higher tariffs imposed by Trump could reignite inflation. Lower interest rates make borrowing easier, helping to spur more investment and spending, but that could also potentially fuel inflation. However, concerns are deepening over the jobs market.

Friday will bring another update on inflation, the US personal consumption expenditures index. Economists expect it to show that inflation remained at about 2.6 per cent in July, compared with a year ago. Businesses have been warning investors and consumers about higher costs and prices because of tariffs.

Indians lead surge in sex crime convictions among foreigners in UK

LONDON, Aug 27: Indians have emerged as the nationality with the largest percentage increase in convictions for sexual offences in the UK amid a wider surge in foreigners being sentenced for such crimes over the past four years in the country, according to an analysis of British government data.

manufacturing especially hard.

Indian nationals logged a 72-case increase between 2021 and 2024, reflecting a 257 per cent hike amid an overall 62 per cent increase in foreign nationals being convicted of sexual offences during that period.

The figures are based on UK Ministry of Justice data drawn from the Police National Computer and then analysed by the anti-immigration think tank Centre for Migration Control (CMC).

"The number of foreign nationals convicted of sexual offences increased by 62 per cent between 2021 and 2024 - jumping from 687 to 1,114. The British convictions rate for these crimes increased by 39.31 per cent over the same time period," the CMC states in its analysis this week. According to the think tank's tally, Indians have remained at the top end of this chart since 2021, when 28 such offences were logged, followed by 53 in 2022, 67 in 2023 and 100 last year.

Nigerians with a 166 per cent increase in cases, Iraqis at 160 per cent, Sudanese at 117 per cent and Afghans at 115 per cent make up the top five nationalities in the sexual crime charts between 2021 and 2024. Other South Asian nationalities highlighted in the analysis include Bangladeshis, ranked sixth with a 100 per cent hike over the four-year period, and Pakistanis eleventh with a 47 per cent increase.

Among the non-summary or seri-

ous crime convictions, Indians ranked third with a 115 per cent increase and a 315-case hike for the 2021-24 period, with the highest number of cases (588) logged last year – more than double the 273 in 2021. "There were almost 75,000 non-summary convictions of foreign nationals between 2021 and 2024... showing a general pattern of increase," notes the CMC.

"There was a decrease in foreign nationals convictions for violent offences and fraud offences between 2021 and 2024," the CMC adds.

The analysis follows recent UK Home Office figures which indicated that Indian nationals in detention have almost doubled in the past year. The data also revealed Indians as the second-largest group to be granted study visas for the UK (98,014) and the largest for work

Imran Khan's party decides to boycott upcoming by-elections in Pakistan

ISLAMABAD, Aug 27: Jailed former prime minister Imran Khan's party has decided to boycott the upcoming by-elections for national and provincial assemblies. in line with the opinion of its founder.

Several seats of the national and provincial assemblies became vacant last month after the conviction of leaders of Khan's Pakistan Tehreek-e-Insaf (PTI) for their involvement in the May 9, 2023

The decision to boycott the byelections was taken by the party's political committee, which met to consider Khan's input following a meeting with his legal team at Adiala Jail on Tuesday, The Dawn newspaper reported.

Earlier in the day, Khan's message was relayed to the media by his sister, Aleema Khan, who also met the 72-year-old cricketerturned-politician in prison.

She was flanked by PTI secretary general Salman Akram Raia - whose resignation was reportedly turned down by Khan. Denying reports of a bitter ex-

change with Raja, she said the lawyer was "like family" to them. She said her brother had asked the party's political committee to

hold another meeting on the byelection issue based on his instruc-Later on Tuesday night, PTI

lawmaker Amir Dogar confirmed that the political committee had endorsed Khan's opinion on not contesting the by-elections, adding that party lawmakers would also start quitting parliamentary bodies

A day earlier, the party's political committee had voted 12-9 to take part in the by-elections. PTI's information secretary

Sheikh Waqqas Akram had even posted on social media that candidates would be given Sunni Ittehad Council (SIC) tickets to avoid the chances of their being declared 'independents'.

Talking to Dawn, former National Assembly speaker Asad Oaiser confirmed that in Khan's opinion, the party should not go into by-elections, and that its lawmakers should leave all parliamen-



tary standing committees, including the Public Accounts Commit-

"Parliament has already been made a rubber stamp, as the voice of the opposition members has been suppressed by not telecasting their remarks on the floor of the house," he said. "Khan was of the view that the

government will not let the PTI candidate win by-elections... [and] if [we] take part in the elections, it will legitimise the government's illegal action of de-seating PTI legislators," he added.

Political analyst Ahmed Bilal Mehboob said it was quite unfortunate that the decision taken by the party's political committee to contest by-elections was reversed

The PTI is more of a "one-man show" than any other political party, he said.

Last week. Pakistan's two major political parties in the current ruling dispensation — the Pakistan Muslim League-Nawaz (PML-N) and the Pakistan Peoples Party (PPP) — announced to jointly contest the upcoming by-elections.

As per the schedule issued by the Election Commission of Pakistan (ECP), the by-elections will be held on September 18 for the NA-66 Wazirabad, NA-129 Lahore-XIII, and PP-87 Mianwali-III constituencies.

It would be followed by elections in NA-143 Sahiwal-III, NA-185, DG Khan-ll, PP-203 Sahiwal-Vl. NA-96 Faisalabad-II. NA-104 Faisalabad-X, and PP-98 Faisalabad-I on October 5, the ECP

LAHORE, Aug 27: More than 100 people, mostly staff members, were stranded as floodwaters from the Ravi River inundated the Kartarpur Corridor, including Gurdwara Darbar Sahib, in Narowal district of Pakistan's Punjab province, officials said Wednesday.

"The entire Kartarpur Corridor complex, including Gurdwara Darbar Sahib, has been submerged by high floodwater," Saifullah Khokar, head of the Kartarpur Corridor Project Management Unit, told PTI.

He said the trapped people, mostly staff members of the Kartarpur Project Management Unit, were being rescued by boats and a helicopter.

Images and videos circulating on social media show the revered Sikh shrine surrounded by floodwaters.

The Pakistani government opened the Kartarpur Corridor in November 2019, which is around 4.1 kilometres from the Pakistan-India border.

The corridor links Pakistan's Gurdwara Darbar Sahib, where the founder of Sikhism, Guru Nanak Dev. lived and died at the start of the 16th century, to the Dera Baba Nanak in Punjab's Gurdaspur district. The 4 kmlong corridor provides visa-free access to In-



dian pilgrims to visit Gurdwara Darbar

Arunachal Congress slams Union min Rijiju over remarks against Rahul Gandhi

ITANAGAR, Aug 27: The Arunachal Pradesh unit of the Congress on Wednesday condemned Union Parliamentary Affairs Minister Kiren Rijiju for his recent remarks against Leader of Opposition in Lok Sabha, Rahul Gandhi, terming it an "indecent personal attack and character assassination".

In a statement issued here, Arunachal Pradesh Congress Committee (APCC) general secretary Chera Taya alleged that Rijiju's comments were an attempt to divert public attention from "his own failures as a leader and a Union minister".

"It is unfortunate and shameful to hear a Union minister stoop to such a low level of discourse, which only reflects the true nature, behaviour, and political culture of the BJP," Taya said, adding that Rijiju, once seen as a national figure, nad reduced himself to "using the language and tone of his rightwing brigade"

Rijiju, the Arunachal West MP, on August 23 hit out at Gandhi, saying that his own party MPs "get uncomfortable" when he speaks in Parliament and remain apprehensive that he will speak "anapshanap baatein" (baseless talk) and the party will have to bear the con-

The APCC accused the BJP-led



government of electoral malpractices, claiming that "vote theft, booth capturing, cash-for-vote practices, and inaction of election officers" marred the polls in Arunachal Pradesh

It further described Rijiju as the "Union Minister of Unparliamentary Affairs", alleging he had forgotten his role in governance and was still "manifesting his habitual role of opposition".

The opposition party also criticised the Centre and the state's BJP government on issues including border disputes with Assam, the construction of mega dams on the Siang River, and the "limited legislative powers" of the Arunachal Pradesh Assembly under Article

Taya urged Rijiju to focus on addressing unemployment, farmers' distress, and unfulfilled promises made by the Modi government instead of "parroting the hate-script

First yarn depot of NE inaugurated in Itanagar

ITANAGAR, Aug 27: In a significant initiative to support the weaving community, the first Yarn Depot of the Northeast was inaugurated on Wednesday at Khinam Fashion House in Vivek Vihar, Itanagar

The central government-sponsored facility is expected to serve as the sole source of yarn for weavers in Arunachal Pradesh while also promoting the government's "Vocal for Local" mission.

According to an official statement, the inaugural ceremony was attended by Arunachal Pradesh Khadi and Village Industries Board (KVIB) Chairman, Maling Gombo, as the chief guest, alongside a host of dignitaries, social workers, public leaders, and indigenous

The function was organised by Khinam Fashion House Director, Vishal P Nabam.

In his address, Chief Guest Gombo termed the occasion a "historic day for the weavers of Arunachal

He lauded the efforts of the Ministry of Development of North Eastern Region (DoNER) and the North East Handloom and Handicraft Development Corporation (NEHHDC), Guwahati, led by Managing Director Mara Kocho and his team, for establishing the Yarn Depot in the state.

With this facility in place, weavers across the state will now have access to quality yarn and raw materials directly from the depot, reducing their dependence on outside sources. This will not only inspire more individuals to take up weaving but also strengthen traditional practices while creating opportunities for self-employment," Gombo said.

He further informed that while the present Yarn Depot has been initiated by the Centre, the state government has also approved a similar project which will be established soon after completion of necessary for-

Highlighting future plans, Gombo noted that the

depot will not only ensure yarn availability but will also facilitate market linkages for handloom products in due

"We envision a system where local dresses and traditional products woven in Arunachal can be marketed across the state and beyond, providing economic upliftment to local artisans," he added.

Speaking on the occasion, NEHHDC Managing Director, Mara Kocho, said the launch of the Yarn Depot in Arunachal marks a "historic milestone" for the state's weaving sector.

He said there has been growing demand for authentic yarn to produce traditional dresses of various tribal

"Earlier, many weavers were cheated in the name of originality. This depot will ensure genuine yarn reaches them, and I appeal to all weavers to use only the original yarn being provided through this facility," Kocho stated.

He assured that similar depots would be opened in other northeastern states in the future and stressed the importance of entrepreneurship in the handloom and

"We want local entrepreneurs to emerge as role models so that weavers across the region become self-reliant and economically sustainable," he said

Kocho further added that NEHHDC is prepared to provide extensive skill development training for weavers and youth willing to engage in the sector.

JK: Death toll mounts to 41 after record rains in Jammu

Jhelum breaches flood alert mark in Srinagar, Anantnag

JAMMU/SRINAGAR, Aug 27: After record rains wreaked havoc in Jammu and Kashmir over the past two days, the death toll in related incidents rose to 41, most of them victims of the landslide on a Vaishno Devi pilgrimage route, while there was some let-up in the showers on Wednesday, allowing relief efforts to pick up pace.

The water level in the swollen rivers across Jammu showed signs of receding from 11 AM, but the flood alert mark was breached by the Jhelum in Anantnag and Srinagar and water entered several residential and commercial areas.

Massive damage has been reported to public infrastructure, including several key bridges, private houses and commercial establishments, due to overflowing of water bodies and flash floods across the Union Territory, officials said, adding more than 10,000 people have been evacuated from low-lying flooded areas.

As torrential rains disrupted normal life, Education Minister Sakina Itoo announced that all educational institutes will remain closed across Jammu and Kashmir on Thursday in view of the inclement weather.

The Northern Railways ordered the cancellation of 58 trains to and from Jammu and Katra stations, while 64 trains were short-terminated or short-originated at various stations in the division. Rail traffic. which was briefly restored on Wednesday morning with six trains departing from Jammu after a day-long suspension, has again been halted due to flash floods and heavy soil erosion in the Chakki river area, the officials said.

With the rain stopping in some areas, Chief Minister Omar Abdullah rushed to Jammu from Srinagar to personally review the situation in the region. Officials said that the phone and network services were restored across all networks on Wednesday, 24 hours after the damage to optical fibres caused outages in the Union territory

At least 20 people were injured in the landslide triggered by incessant heavy rain and are undergoing treatment in different hospitals, the officials said, adding the landslide struck near the Inderprastha Bhoj-

nalaya at Ardhkuwari, about halfway along the winding 12-km trek from Katra to the shrine, at around 3 PM on Tuesday. With more people feared

trapped, rescue teams are continuing to dig through the mounds of rubble to look for survivors. The pilgrimage to the shrine re-

mained suspended for the second day. While the yatra had been stopped on the Himkoti trek route since morning on Tuesday, it was going on on the old route till afternoon when authorities decided to suspend it as a precautionary measure. Jammu has recorded 380 mm of rainfall in the past 24 hours ending at 8.30 AM on Wednesday, which is the highest for a 24-hour period since 1910 when the observatory was set up in the winter capital.

Four people, including three women, lost their lives in Doda district on Tuesday, while two bodies were found on Tuesday, including that of a BSF jawan in Pragwal. The other body found in Akhnoor is yet to be identified. Body of an irrigation department employee was found in Lakhanpur along the border of Punjab.

Heavy rains were also experienced in the Kashmir valley overnight, where the main Jhelum river has crossed the flood alert mark at Sangam in Anantnag district and at Ram Munshi Bagh in Srinagar this morning.

In Srinagar, water entered the residential areas in Kursu, Ra-

jbagh, Bemina and Sekidafar, while most places in main Anantnag town also saw flood waters enter residential as well as commercial areas, leaving markets submerged, they said. The waters also entered the district court complex in Anantnag district in south Kashmir, following which the district judge and other staff had to be evacuated by the SDRF personnel using a boat, the officials said.

The district administrations and police in Anantnag, Kulgam and Srinagar had to evacuate people living in low-lying areas to safety.

The Jammu-Srinagar national highway remained closed for vehicular traffic, along with over a dozen other roads struck by landslides over the past couple of days. Prime Minister Narendra Modi said his prayers are for everyone's

safety and well-being.

"The loss of lives due to a landslide on the route to the Shri Mata Vaishno Devi Temple is saddening. My thoughts are with the bereaved families. May the injured recover at the earliest. The administration

is assisting all those affected," he said in a post on X.

Chief Minister Abdullah said he has briefed Prime Minister Modi on the situation arising from heavy rains and flooding in the Jammu region and expressed gratitude for his assurance of continued assistance to the people of Jammu and Kashmir. The chief minister said they were slightly relieved as the rain had stopped on Wednesday.

"As compared to yesterday, we have got slight relief today (Wednesday) with the fact that the rains have stopped. Water is slowly receding in low-lying areas," he said.Officials said said a flash flood washed away 10 residential houses and a bridge in the remote Margi area of Kishtwar district, but there was no immediate report of any casualties.

The rains continued non-stop in most parts of the Jammu region over the past 24 hours with almost all water bodies, including Tawi, Chenab, Ujh, Ravi and Basanter, flowing several feet above the danger mark, the officials said. (PTI)

Deletion of voters' names in Bihar worse than terrorism: Stalin

MUZAFFARPUR (BIHAR), Aug 27: Tamil Nadu Chief Minister M K Stalin on Wednesday asserted that the INDIA bloc will win the Bihar assembly polls "if the elections were free and fair", and described deletion of voters' names from electoral rolls as "worse than terrorism'

The DMK president flew down to the eastern state, along with sister and party MP Kanimozhi, where they joined Congress leaders Rahul Gandhi and Priyanka Gandhi Vadra, RJD's Tejashwi Yadav and CPI(ML) general secretary Dipankar Bhattacharya for the ongoing 'Voter Adhikar Yatra'.

Addressing a rally in Muzaffarpur, the largest town in north Bihar, Stalin delivered his speech in Tamil, which evoked applause from the crowds as it was translated into Hindi. "For the past one month, the entire nation has been looking keenly at Bihar... the Election Commission has become a remote-controlled puppet," alleged Stalin, who was impressed with the response to the yatra taken out in protest against the special intensive revision of electoral rolls.

"Is the deletion of names of 65 lakh people (from the draft electoral rolls) not worse than terrorism?" the Tamil Nadu CM asked.

When Rahul Gandhi raised doubts over the fairness of elections held in the past, he was challenged by Chief Election Commissioner Gyanesh Kumar to furnish an affidavit. Stalin said.

"But you cannot scare Rahul Gandhi," the DMK chief said, lauding his alliance partner.

"I have seen Rahul's camaraderie with Tejashwi, who ride motorcycles together. This friendship is deeper than a run-of-themill political partnership. And I am sure that if the elections are free and fair, the BJP-led NDA will be defeated," he asserted.

"I promise you that after the INDIA bloc wins the assembly polls, I will be back to attend the swearing-in ceremony," Stalin said. Bihar is the land where the foundation of this nationwide coalition (INDIA bloc) was laid, and this alliance succeeded in bringing down to 240 the tally of the BJP, which was boasting of winning more than 400 seats in the Lok Sabha polls last year, he said.

The Tamil Nadu CM began his speech by recalling the close friendship between his late father K Karunanidhi and RJD president Lalu Prasad, the father of Tejashwi Yadav, whom he hailed for "tirelessly championing social justice and never getting cowed down by the BJP". The DMK president's reverence for Prasad was also evident in a post on his X handle, immediately after he landed in Bihar.

'Touchdown #Bihar. The land of respected @laluprasadrjd greets me with fire in its eyes, the soil heavy with every stolen vote. Joined my brothers @Rahul-Gandhi, @yadavtejashwi and sister @priyankagandhi as the #voteadhikaryatra turns people's pain into unstoppable strength," he wrote.

Gandhi shared a selfie he took with Stalin and other prominent leaders and wrote, "Welcome to Bihar and the #VoterAdhikarYatra my brother Thiru @mkstalin. Your presence here strengthens our fight against Vote Chori in Bihar and the entire country.'

Back in Tamil Nadu, where the DMK's main rival AIADMK is a BJP ally, the saffron party sought to highlight the troubled equations of the chief minister's party with migrants from Bihar. (PTI)



Elaborating on rapid changes in the military domain, the defence minister said the present era will be defined by non-linear warfare. "The sheer number of soldiers or

the size of weapon stockpiles is no longer enough. Cyber warfare, artificial intelligence, unmanned aerial vehicles and satellite-based surveillance are shaping the wars that the Indian military must be of the future," he said.



"In the times ahead, the nation that masters the triangle of technology, strategy and adaptability will emerge as the true global power. To put it simply, this is the moment to learn from history and write a new one; this is the moment to anticipate the future and shape one," he said.

Singh argued that future wars will not merely be battles of weapons and they will be a combined play of technology, intelligence, economy and diplomacy.

He also noted that national security is no longer a matter of the military, but has become an issue of a "whole-of-nation approach". "We do not want anyone's land, but we are ready to go to any extent to protect our land," he said. The defence minister lauded the three services for Operation Sindoor and said it has emerged as a great example demonstrating the success of India's indigenous platforms, equipment and weapon systems. "Its achievements have once again underlined that in the times to come, self-reliance is an absolute necessity. We have indeed made significant progress on the path of self-reliance, but there is still a long way ahead," he said. (PTI)

Prolonging criminal case for unreasonable period a type of suffering: SC

NEW DELHI, Aug 27: The Supreme Court has said prolonging a criminal case for an unreasonable period was a type of suffering, amounting to mental incarceration for the person facing the proceedings.

Justices N V Anjaria and A S

Chandurkar made the observation while reducing a woman's sentence in a corruption case to the actual period undergone. While confirming her convic-

tion, the bench noted the incident occurred over 22 years ago and the woman was now 75.

It, however, increased the fine imposed on her by Rs 25,000 above the original fine. "The prolongation of a criminal

case for an unreasonable period is in itself a kind of suffering. It amounts to mental incarceration for the person facing such proceedings," the bench said on August 21.

The apex court verdict came on an appeal filed by the woman against the August 2010 verdict of the Madras High Court confirming the trial court order.

The trial court convicted the woman, who served as an inspector of Central Excise, under the provisions of the Prevention of Corruption Act, 1988, and sentenced her to undergo one year imprisonment

It was alleged by the prosecution that in September 2002, she demanded illegal gratification of Rs

The top court said a person, who has appealed against conviction and everyday awaits the fate of litigation, spends time in distress.

"In the present-day system of administration of justice, in which proceedings have often protracted unreasonably and therefore unbearably, the passage of long time itself makes the person suffer a

mental agony," the bench said. It said the process of sentencing by courts was guided by theories such as punitive, deterrent or reformative and noted each school of thought had its own object and purpose to explain sentencing and



"Amongst these theories, reformative approach has become increasingly acceptable to the modern jurisprudence. Reformation is something always considered progressive," it said.

The bench said when there were mitigating circumstances, the court would lean towards reducing of the sentence and the focus was on the crime and not on the criminal.

"The society and system would nurture the guilt with positivity, while selecting the sentence," it

The appellant in the top court gave up the challenge to the conviction and her lawyer requested the court for reduction of sentence.

The bench observed conviction and sentence had respective realms.

"While the conviction would be recorded on the basis of evidence adduced before the court which would establish the implication of the accused in the offence, the guilty person or the convicted when to be awarded a sentence, a host of factors would operate to govern," it said.

The bench noted the woman, a widow, underwent imprisonment for 31 days. "In the totality of the facts and

circumstances, the imprisonment already undergone by her is treated to be adequate sentence," it said. While increasing the fine

amount, the bench ordered it to be paid by September 10. Upon failure to pay the fine amount, the original order of sentence would kick in and operate, rendering her liable to surrender before the au-

Jarange leaves for Mumbai, govt Mamata, Abhishek express concern over delegation to meet him near Pune

CHHATRAPATI SAMBHAJI-NAGAR, Aug 27: Maratha quota movement leader Manoj Jarange left for Mumbai on Wednesday to launch a fresh hunger strike, but agreed to meet a government delegation near Pune on his way to the

state capital. While the 43-year-old activist has announced that he would sit on an indefinite fast at Azad Maidan in Mumbai from August 29, police granted him permission to stage his agitation there only for a day, with the number of protesters not exceeding 5,000.

Speaking to reporters at his village Antarwali Sarathi in Jalna district, over 400 km from the state capital, Jarange assured that his supporters would protest peacefully and not disrupt the Ganesh festival. Jarange has been demanding that all Marathas be recognised as Kunbis - an agrarian caste included in the OBC category which will make them eligible for reservation in government jobs and education

The activist told reporters that he received a call from state minister Radhakrishna Vikhe Patil. who heads a cabinet sub-committee on Maratha quota, informing him that a government team would reach Shivneri in Pune district for discussions.

"A delegation might come for discussion at Shivneri. I will not sit in any room, the discussion will take place in the open. No matter who comes for the talks, we will secure the Maratha quota this time," he said

Vikhe Patil said the cabinet subcommittee, which held its first meeting on Monday, had deliberated on Jarange's demands concerning extending reservation benefits to close relatives of the Maratha community. He added that the Justice Shinde committee on Maratha quota has been granted a six-month extension, as Jarange had demanded earlier.

The Jalna police allowed Jarange and his supporters to proceed with their march after imposing 40 conditions, directing them to avoid any law and order situations, not to cause disruptions to the movement of vehicles and desist from avoiding "objectionable" slogans

The BJP which heads the ruling coalition as well as Deputy Chief Minister Eknath Shinde had on Tuesday urged Jarange to postpone his agitation in view of the Ganeshotsav beginning on August 27. "There will be attempts to provoke us, but we will continue our agitation peacefully at Azad Maidan. No matter how long it takes this time, we will ensure reservation for the Maratha community," the activist told reporters before leaving Antarwali Sarathi in

the morning. Hundreds of supporters from Beed, Chhatrapati Sambhajinagar, Jalna and other districts in the Marathwada region reached the village in the morning.

Before leaving for Mumbai, Jarange addressed his supporters and attacked Chief Minister Devendra Fadnavis, accusing him of being "anti-Hindu and anti-Maratha". "The ball is now in the court of Fadnavis whether he gives us permission (for the protest) or not," he said.

"Eknath Shinde is not being allowed to speak (on the Maratha reservation) issue," he claimed.

In Mumbai, the senior inspector of Azad Maidan police station wrote a letter to the activist, granting him permission -- in response to an application -- to stage peaceful protests at Azad Maidan on August 29 between 9 am to 6 pm. At 6 pm, all protesters will have to leave the site, the letter said.

After entering Mumbai, from Wadi Bunder Junction only five vehicles of main protestors can head to Azad Maidan and the number of protestors there should not cross 5,000, it said.

The protest should not disrupt the Ganesh festival celebrations or cause traffic congestion, the letter instructed, while also warning the protesters not to incite communal hatred or hurt communal sentiments. (PTI)

Mizoram sticks to stand that its border with Assam is based on 1875 notification: Minister

Home Minister K Sapdanga on Wednesday reaffirmed the government's stand that its boundary with Assam is based on a notification issued in 1875.

The assertion came days after a fresh tension on the Mizoram-Assam border.

Addressing the assembly on the first day of the monsoon session, Sapdanga said that the Mizoram government approved the areas demarcated in the 'Inner Line on the Southern Frontier of the District of Cachar', which was notified on August 20, 1875, as the state's actual boundary with

Assam, however, asserts that the border defined by a map prepared by the Survey of India in 1933 is its constitutional boundary with Mizoram

According to the home minister, both Mizoram and Assam have held talks on more than 10 occasions since 1988 to amicably resolve the vexed border dispute.

The last official-level discussion between the two states on the boundary issue was held in Guwahati on April 25 to find an amicable solution to the long-standing dispute, he said.

Sapdanga said that the next round of official-level talks has



been proposed to be held in Mizoram, but the exact date of that is yet to be finalised.

Apart from ministerial-level and official-level talks, the two states are also taking steps to resolve the dispute by providing important border-related documents to each other, he said.

The home minister said that the Mizoram government formed a study team to task with collecting important documents to strengthen the state's claim.

Sapdanga also said that the state government has constructed and maintained border roads along the state border with Assam.

However, it has stopped maintaining or using some of those roads, as it can induce violation of tus quo on the disputed areas along the inter-state border.

Three Mizoram districts Aizawl, Kolasib and Mamit share a 164.6 km long border with Assam's Cachar, Sribhumi and Hailakandi districts.

The border dispute between the two northeastern states, which mainly stemmed from two conflicting colonial-era demarcations one from 1875 under the Bengal Eastern Frontier Regulation and another from 1933, is a long pending issue that has been unresolved till date.

The dispute escalated into violence on several occasions. A clash between police forces of both states near Mizoram's Vairengte village on July 26, 2021, resulted in the death of seven people, including six policemen from Assam. Since August 2021, the two Northeastern states have held four rounds of ministerial-level talks, besides negotiations and virtual meetings at official-level to resolve the decades-old border dispute.

In the last official-level talks held in Guwahati in April, both states agreed to maintain the status quo along the disputed areas and to expedite responses to claims

'Vote Chor, Gaddi Chhod': Nagaland Cong stages rally against alleged poll fraud



DIMAPUR, Aug 27: The Nagaland Pradesh Congress Committee (NPCC) on Wednesday held a rally in Dimapur under the slogan 'Vote Chor, Gaddi Chhod' (Vote thieves, vacate seat) to raise public awareness on alleged assaults on citizens' electoral rights.

Addressing the gathering, AICC in-charge Nagaland and MP Saptagiri Sankar Ulaka said all rights and privileges enshrined in the Constitution will be taken away by the BJP-led central government if citizens fail to protect it.

"They don't believe in the Constitution," he alleged.

Ulaka claimed that the Congress has "definite proof" of election manipulation in 70-80 Lok Sabha seats during the 2024 Lok Sabha elections, asserting that the BJP did not have the real mandate to gov-

'They didn't have the mandate, but due to the Election Commission and 'vote chori', the BJP managed to win some seats. Otherwise,

Modi would not have become the PM," Ulaka claimed.

Stating that the struggle is currently political but will eventually turn into a mass movement, he said, "During the first phase, we fought in Parliament, and now we are taking it to the streets. Our fight is not only on media, but also on the ground to ensure the Constitution is protected.

The Congress, he said, is staging the campaign to protect citizens' electoral rights and warned that if such practices are not stopped, "they will hit the streets in Nagaland and throughout the

country." Ulaka said, "The people of Nagaland will definitely support the Congress, stand up for truth, and help save the Constitution."

He added that the Congress is reorganising its party workers, announcing that Rahul Gandhi will visit the state soon.

AICC secretary in-charge of Nagaland, Christoper Tilak, also accused the BJP of consistently damaging the values of the Constitution by placing "RSS-trained people" in key institutions.

"They try to dilute constitutional values, and today people have started losing hope in these institutions," he said.

Tilak added that while talk of saving the Constitution was earlier taken lightly, particularly by youngsters, the present is "the right time to convert the abstract concept of the Constitution into a concrete reality that connects with the

NPCC president and Lok Sabha MP Supongmeren Jamir said the Constitution grants every citizen the right to vote, but this right itself is under threat under the present regime.

He asserted that the party is determined to fight and protect citizens' rights, declaring that it is 'the only party that safeguards the Constitution, culture, and tra-

AGARTALA, Aug 27: The Directorate of Enforcement (ED), Agartala Sub-Zonal Office, has seized cash worth ₹ 7 lakh and frozen bank accounts containing around ₹ 60 lakh during search operations conducted on August 26 under the Prevention of Money Laundering

Act (PMLA), 2002. The ED has carried out the search operation on August 26 in four locations of the Tripura including in the house of Utpal Kumar Chowdhury.

The searches were carried out at multiple locations in Tripura, Delhi, Haryana, and West Bengal in connection with an ongoing investigation against Utpal Kumar Chowdhury of Tripura.

According to ED, the probe began on the basis of several FIRs filed by West Bengal Police against Chowdhury. Investigations revealed that Chowdhury had floated a web of entities with names resembling reputed government departments and PSUs such as "Directorate of Higher Education, Tripura," "Bridge and Roof Company," and "Directorate of Bangladesh border, they said. (PTI) Apparel Council of India." By pos-



ing as a senior government official, he allegedly duped individuals and institutions by falsely promising government contracts, including mid-day meal tenders and student

Chowdhury also fraudulently took control of an NGO - M/s Chaltakhali Swamiji Seva Sangha, registered under the Foreign Contribution Regulation Act (FCRA) and used it to launder money. The ED's preliminary investigation found that over ₹200 crore was routed through this NGO to entities in Harvana, Kolkata, and Delhi under the guise of bogus rubber trade. The purported rubber transactions existed only on paper, with no evidence of actual trans-

During the searches, the ED seized incriminating digital and physical evidence, fake IDs of the Ministry of Home Affairs, stamps of various Tripura government departments and PSUs, and documents indicating investments in real estate and land across the state. The agency also found that Chowdhury enjoyed proximity to senior Tripura government officers, who allegedly introduced nim to businessmen as a high-ranking official. Some of these officers are suspected of having received large sums of

DIMAPUR, Aug 27: Kohima DC B Henok Buchem on Wednesday said National Highway 29 at Chainage KM 175.350, near the Old KMC dumping site, will remain temporarily closed for all forms of vehicular movement with immediate effect until further notice. The stretch of the road was damaged by landslides recently. In an order, Buchem said the condition of the affected portion of the highway was thoroughly assessed by the authorities and found to be unfit for vehicular traffic. As an alternative arrangement, he said, light motor vehicles will

be diverted through the Jotsoma Bypass Road. Heavy vehicles and other district-bound traffic, along with military and paramilitary vehicles, compact and mid-size pick-up trucks, and all types of heavy

and mid-size commercial passenger vehicles, will be diverted via the Peducha Bridge-Tsiesema (10 Mile Road). The DC said any violation of this order will be liable for prosecution. In a separate traffic advisory on Wednesday, Buchem said a landslide on National Highway 2 at Chainage KM 12.900, near Tsiesema Basa, resulted in the complete blockage of the highway. He said the road from High Court Junction, Meriema-Nagaland University Campus-Tsiesema Basa, near 5 Sector Assam Rifles/Koinonia Prayer Centre junction, has been designated as the alternative route for light motor vehicles. The advisory said due to the narrow passage along this alternative route, traffic for heavy vehicles, including those bound for Manipur and Dimapur, will be regulated by the traffic police after assessing the condition of the road.

AIZAWL, Aug 27: At least 351 people, including 46 women, have died in Mizoram in the last five years due to drug abuse, state Excise and Narcotics Minister Lalnghinghlova Hmar informed the assembly on Wednesday.

In a written reply to a question from opposition Mizo National Front (MNF) member K Laldawngliana, Hmar said that 78 people out of 351 died of heroin abuse, while 273 people died due to abuse of multiple drugs, during the period from 2020 to August 8 this year.

He said that the victims were in the age group of 19-57 years.

rested and booked under the Narcotic Drugs and Psychotropic Substances Act during the period, he said. On Tuesday, Home Minister K Sapdanga said that the state police, in coordi-

state's largest civil society organisation, Young Mizo Association (YMA), will launch a massive fight against drugs. He said that drug smugglers and addicts commit theft and other crimes, endangering society, which demands the need to

Opportunities to do diverse roles don't come that often: 'Gullak' actor Vaibhav Raj Gupta





"With this league, we aim to not only showcase top-tier talent from around the world but also highlight and celebrate India's rich archery heritage. The tournament will feature 36 Indian archers and 12 top global players divided into six franchises. The details regarding the franchises will be announced soon. (PTI)

Anish Bhanwala wins 25m rapid fire pistol silver at Asian C'ships

SHYMKENT KHSTAN), Aug 27: India's Anish Bhanwala once again showed why he is the best rapid fire pistol shooter in the country, clinching the silver medal in the ongoing Asian Shooting Championships here on Wednesday.

The 22-year-old Olympian finished with a total of 35, just one shy of gold winner Su Lianbofan of China. The bronze went to Korea's Lee Jaekyoon.

The Indian had a one-point lead after the first four series but fell behind after that.

Another Indian in the competition, Adarsh Singh, finished fifth.

Bhanwala, the 2018 Commonwealth Games gold medallist, was placed sixth with a score of 290 after the precision round of 30 shots on Tuesday, but in the rapid fire round on Wednesday, the Haryana marksman shot a superb 293 to jump to fourth place, aggregating 583 points. (PTI)

Chopra aims to end DL run with trophy in Final, eyes another 90m throw

ZURICH, Aug 27: Two-time Olympic medallist Neeraj Chopra seems primed to reclaim the Diamond League trophy with a repeat of the 90m show that has been the highlight of his season so far when the prestigious 14-leg series draws to a close here on

There were four Diamond League meetings which featured men's javelin throw, and Chopra competed in only two, qualifying for the Finals at fourth place with

He skipped the Silesia and Brussels legs on August 16 and August 22 respectively. He last won the DL trophy in 2022. The top six in the points table from the four meetings qualify for the Fi-

Since there are 32 events, both male and female, the DL Final is spread over two days.

Six events men's and women's pole vault, men's and women's shot put, men's long jump, and women's high jump -- are being held on Wednesday, all street events in the Swiss city's Sechselautenplatz.

The remaining 26 events will, however, be held inside the Letzigrund Stadium on Thursday.

The winner of each event at Diamond League Final will be named this year's champion and get a DL trophy as well as prize money ranging from USD 30,000



to USD50,000 and wild card entries to next month's World Championships in Tokyo.

A thrilling contest is on the cards in men's javelin with Tokyo Olympics gold medallist and Paris Games silver winner Chopra facing defending champion Anderson Peters of Grenada as well as Germany's Julian Weber in the seven-man final.

Kenya's 2015 world champion Julius Yego, Keshorn Walcott of Trinidad and Tobago, and Andrian Mardare of Moldova entered the field as athletes in the top-6 in the points table, while Simon Wieland of Switzerland was also added as the host coun-

Peters is also a two-time world champion though his form has not been the best in recent times. He has a season's best of 85.64m -while finishing third in Doha -- so far. Weber has the longest throw of this year at 91.06m which he produced to beat Chopra in Doha DL on May 16.

Chopra finally breached the

90m mark at Doha with a 90.23m though he finished second behind Weber. The 27-year-old Indian superstar then won the Paris leg on June 20 with a throw of 88.16m while Weber finished second with 87.88m.

The Indian star's 90.23m in Doha DL is the third longest throw of the season.

Luiz Mauricio Da Silva has the second longest of the season --91m -- but he has not qualified for the DL Final. Only three javelin throwers could breach the 90m mark so far this season.

Chopra's last event was the NC Classic in Bengaluru on July 5 which he hosted and won with a throw of 86.18m.

Chopra and the 30-year-old Weber have finished 1-2 alternately in the two DL clashes this season, and the contest for glory here is also expected to be between the two.

It has been an eventful year for Chopra. He first achieved the long-awaited 90m throw early in the season, then realised his dream of hosting and competing in a quality event in front of home fans at the NC Classic on July 5 in Bengaluru. On Thursday, he will attempt to regain the DL Trophy which he had won in 2022. He finished runner-up in 2023 and 2024 to Jakub Vadlejch of Czech Republic and Peterson re-

AIFF faces ban threat as FIFA, AFC set Oct 30 deadline for ratification of constitution

NEW DELHI, Aug 27: Indian football is staring at an international ban with world governing body FIFA and the Asian Football Confederation issuing a stern ultimatum to the embattled AIFF that it must adopt and ratify a new constitution by October 30 or risk suspension.

In a hard-hitting two-page letter on Tuesday, addressed to AIFF president Kalyan Chaubey, the two international bodies expressed "profound concern" at the federation's failure to finalise its constitution despite the matter being pending in the Supreme Court since 2017. The top court is scheduled to take up the matter on Thursday.

A suspension would mean national teams and clubs being barred from all international competitions, besides throwing into uncertainty, India's ambitious bid for the 2036 Olympic Games in Ahmedabad.

FIFA and AFC have directed the Chaubey-led AIFF to secure a "definitive order" from the Supreme Court approving the revised constitution, align it with the mandatory statutes of FIFA and AFC, and ratify it at the next General Body meeting before the October 30 deadline.

"Failure to meet this schedule will leave us with no alternative but to refer the matter to the relevant FIFA decision-making body for consideration and decision... including the possibility of suspension," the letter mentions without any am-

The missive is jointly signed by FIFA Chief Member Associations Officer Elkhan Mammadov and AFC Deputy General Secretary (Member Associations) Vahid Kar-

This is not the first time Indian football has faced such embarrass-

The world bodies expressed concern at the "continued failure to finalise and implement the revised Constitution of the All India Football Federation (AIFF), a matter that has remained under consideration since proceedings before the time. Hon'ble Supreme Court of India in 2017." "Despite repeated assurances, the absence of a clear and compliant governance framework has now created an untenable vacuum and legal uncertainties at the heart of Indian football," it stated.

that has "precipitated a governance and operational crisis," the letter said: "Clubs and players remain uncertain regarding the domestic competition calendar.

"Commercial partnerships beyond December 2025 remain unconfirmed; and essential functions relating to development, competitions, and marketing are increasingly compromised.

Lambasting the lack of financial stability and its "profoundly negative impact on India's football ecosystem", the two bodies said they are worried about the impact on footballers employed by clubs participating in the Indian Super League.

"We have received concerning reports from FIFPRO of the unilateral termination of players' employment contracts by various clubs, as a direct consequence of the current impasse, affecting the players' livelihoods and careers," the letter

Accordingly, the AIFF has been directed to take three immediate steps by the deadline.

'Secure a definitive order from the Supreme Court of India approving the revised AIFF Constitution. Ensure full alignment of the AIFF Constitution with the mandatory provisions of the FIFA and AFC Statutes and regulations.

"Obtain formal ratification of the AIFF Constitution at the next AIFF General Meeting."

Failure to adhere to this obligation may result in sanctions outlined in the FIFA and AFC Statutes, "including the possibility of suspen-

"A suspension of the AIFF would result in the loss of all of its rights as a FIFA and AFC member, as defined in the FIFA and AFC Statutes," it added.

The Supreme Court is set to hear the matter relating to the Master Rights Agreement between AIFF and its commercial partner Football Sports Development Limited on Thursday.

The agreement expires on December 8.

The FSDL last month put the upcoming season "on hold" citing uncertainty over MRA renewal.

Coco Gauff's 1st match with a new serve coach at the US Open is a struggle but also a win

NEW YORK, Aug 27: Coco Gauff's first match since enlisting someone to help with her shaky serving got off to a rocky start at the U.S. Open on Tuesday night. She double-faulted in the very first game — and a total of 10 times. She got broken in that game, too — and a total of six

The only numbers that truly counted in the end, of course, were the ones on the Arthur Ashe Stadium scoreboard, and those showed that the No. 3-seeded Gauff held on for a 6-4, 6-7 (2), 7-5 victory over Ajla Tomljanovic to reach the second round at Flushing Meadows.

"It wasn't the best," Gauff said. "but I'm happy to get through."

Nothing came easily. Gauff twice led by a break in the second set but couldn't end things. She went up 5-3 in the third and served for the victory at 5-4, but double-faulted twice in a row and missed a pair of forehands to make it 5-all.

That could have been too much to take. Instead, Gauff steadied herself, broke right back, then was able to serve it out on her second

chance to do so, nearly three full hours after the contest began.

"I had so many chances. ... I was just like, Eventually, one of these is going to go my way," she

Gauff, who won the first of her two Grand Slam titles at the 2023 U.S. Open as a teenager, added Gavin MacMillan to her coaching team shortly before the start of this tournament. MacMillan is a biomechanics expert who helped current No. 1 Aryna Sabalenka retool her serve a few years ago, and he was in the first row of Gauff's guest box, seated right in front of

After beating Tomljanovic, Gauff called her practices with MacMillan "really tough" and "mentally exhausting."

Venus Williams will compete in women's doubles at the US Open with 2021 finalist Leylah Fernandez

Williams will compete in women's doubles at the U.S. Open after receiving a wild-card entry with 2021 singles runner-up Leylah Fernandez on Tuesday.

The 45-year-old Williams is appearing at her first Grand Slam tournament in two years after making a comeback to pro tennis in July following 16 months away from the tour.

She competed in mixed doubles last week, then in singles on Monday night — both also via wild-card invitations from the U.S. Tennis Association.

Williams exited in the first round each time, but was thrilled to be back out on court after dealing with injuries and illness. She had surgery for uterine fibroids last year, and spoke Monday following her three-set exit in singles against 11th-seeded Karolina Muchova about being relieved to

be pain-free. "Oh, what did I prove to myself?" Williams said, repeating part of a reporter's question at her

postmatch news conference. "I think for me, getting back on the court was about giving myself a chance to play more healthy. When you play unhealthy, it's in your mind. It's not just how you feel. You get stuck in your mind, too. So it was nice to be freer."

She was the oldest person to play singles at the U.S. Open loved every moment of it, greeting her with camera phones held aloft, shouting "Let's go, Venus!" during the match and ushering her off the Arthur Ashe Stadium court with a standing ovation. In addition to her seven Grand

Slam singles trophies, Williams owns 14 major titles in women's doubles, all with her younger sister, Serena, as her partner. Two of those came in New York, in 1999 and 2009.

They last played together at the U.S. Open in 2022, the year Serena played her final singles match

Williams and Fernandez, a 22year-old from Canada, will face the sixth-seeded pair of Lyudmyla Kichenok of Ukraine and Ellen Perez of Australia in the first

Fernandez lost to Emma Raducanu in the U.S. Open singles final four years ago

The announcement came amid speculations earlier this month that were rife over Ashwin's future at Chennai Super Kings after an underwhelming IPL 2025 season, where he played only nine matches -- his second lowest in a season since he featured in just two games in his debut in 2009.

Amid talk of a possible trade involving Rajasthan Royals skipper Sanju Samson, the veteran off-spinner had admitted he had sought clarity from CSK on his role.

"Last year, I played only nine games; in all my years of playing in the IPL, that was the first year I played just nine games. I always used to play every game... so it was

my first experience like that.

I asked for clarity from my side, but I asked for it during the IPL season itself," Ashwin said on his YouTube channel in a podcast with

The 38-year-old acknowledged the buzz around a possible trade with Samson but stressed that much of it was outside the players' con-

"If Samson's trade is to happen, CSK will have to keep 18 crores free, and then you have to see who you can release to make that space," he said.

"If tomorrow I'm not in the CSK team, it might benefit them there's no doubt about that. But it can't all be about me. Right now, there is nothing in my hand. And all these rumours do not come from the player... there are a lot of layers to this.

Ashwin had retired from international cricket in December last year during the tour of Australia after a decorated career that saw him become India's second-highest wicket-taker (537) in Tests behind Anil Kumble (619).

Overall, he featured in 221 IPL matches, taking 187 wickets at an average of 30.22 with best figures of 4/34. With the bat, he scored 833 runs with a highest of 50 and an average of 13.02.

Ashwin was an integral member of CSK's successive title-winning campaigns in 2010 and 2011 and also turned out for the now defunct Rising Pune Supergiant, Punjab Kings, Delhi Capitals and Rajasthan Royals during his long career in the league.

Some of Ashwin's finest IPL moments came in his early years with CSK, especially bowling in the Powerplay against marauding batters like Chris Gayle and keeping them quiet.

It was in his first three seasons under MS Dhoni that Ashwin's carrom ball flourished, eventually propelling him into the Indian team.

In the later years, Ashwin switched franchises as there were captaincy ambitions and he even briefly captained Punjab Kings.

But as the league evolved, his attacking mindset and constant experimentation sometimes came at a cost with his stock falling in the later years.

With IPL batters adopting an attacking philosophy, franchises increasingly wicket-to-wicket left-arm orthodox spinners who could also chip in with the bat. It was an area where

Gill, Rohit continue to top ODI batting chart



DUBAI, Aug 27: Indian batting mainstays Shubman Gill and Rohit Sharma continued to remain at the top of the rankings for ODI batters with Virat Kohli at number four, even as Australian players made big gains after feasting on South Africa in the recent series finale in Mackay. Gill (784 rating points) and Rohit (756) held the number one and number two spot respectively with Pakistan's Babar Azam (739) rounding out

the top three. Kohli has got 736 points. The Indians have not featured in ODIs in recent months but Kuldeep

Yadav (650) and Ravindra Jadeja (616) still remained static at number three and number nine in the latest ODI rankings for bowlers. While Rohit and Kohli have retired from T20Is and Test cricket, both

remain active in the ODI format. Both Rohit and Kohli last played ODIs in February 2025 during the

ICC Champions Trophy in the UAE, where they played pivotal roles in India's title-winning campaign. Australia amassed an imposing 431/2 in the 50-over match at Mackay

with a trio of their batters in Travis Head (142), Mitch Marsh (100) and Cameron Green (118 not out) cashing in with a century.

All three made good ground on the rankings as a result, with Head gaining one place to move to equal 11th, Marsh jumping four rungs to move to 44th and Green rising a whopping 40 slots to be 78th. Australian teammate Josh Inglis also made ground on the list, with the

right-hander improving 23 spots to move to 64th as a result of his innings of 87 during the second match of the series against the Proteas.

The competition is tighter at the top of the rankings for ODI bowlers, with Sri Lanka spinner Maheesh Theekshana joining fellow tweaker Keshav Maharaj at the top on 671 rating points following the completion of the series between South Africa and Australia.

Maharaj lost ground after picking up figures of 1/57 in the series finale, with his rating dropping equal with Theekshana even as the Sri Lankan spinner didn't feature across the week.

The biggest mover on the ODI rankings for bowlers came via Lungi Ngidi, with the South Africa speedster gaining six places to move to 28th following his series-high seven scalps across the three games against Aus-

Australia duo Sean Abbott (up nine places to equal 48th) and Nathan Ellis (up 21 spots to 65th) also made ground on the list for following some decent showings during the series with the Proteas. (PTI)
