GUWAHATI, Aug 8: Ten illegal 'pushed back' by security forces to the neighbouring country from Assam's Sribhumi district on Friday, Chief Minister Himanta Biswa Sarma said.

'Stern action against illegal infiltration continues! In the wee hours today. @assampolice pushed back 10 illegal Bangladeshi infiltrators from the Sribhumi sector', the chief minister posted on X.

Sarma said that attempts to 'alter Assam's demography will not be tolerated. Borders secured, infiltrators repelled!

Assam police had pushed back 27 illegal infiltrators from Sribhumi, back to Bangladesh last

More than 387 alleged illegal infiltrators have been pushed back in recent months

Sarma claimed the state government was committed to an infiltration-free Assam.

The BSF has intensified its vigil along the 1,885 km-long India-Bangladesh border in the North East since the disturbances began in Bangladesh last year.

Assam Police is also maintaining a high alert along the India-Bangladesh border to ensure that no person can enter the state illegally and any person without any valid citizenship documents will be pushed back, an official said. (PTI)

### 10 Bangladeshi infiltrators sent 132 acres of forest land freed; drive to continue

#### 146 families evicted from Negheribil in Golaghat district

**GUWAHATI, Aug 8:** The Assam government on Friday evicted 146 families who had allegedly encroached on 132 acres (400 bighas) of forest land in Golaghat district, officials said.

The eviction drive was carried out at Negheribil in Merapani, located along the Assam-Nagaland border, as part of the ongoing drive to reclaim encroached land in the Doyang Reserve Forest, Special Chief Secretary MK Yadav said.

The drive led to the clearance of 146 households comprising numerous illegal structures, spread across more than 50 hectares of protected forest land, he said.

It was conducted by following due legal process with prior notices issued to the encroachers.

Yadav said the Nagaland government and police had extended active support and cooperation throughout the eviction process, which contributed significantly to the smooth conduct of the drive.

The remaining encroachments in Uriamghat and Negheribil will be removed from August 16, he said. The Gauhati High Court has di-



rected that those facing eviction from Doyang and South Nambar forests in Golaghat district to submit proof of land rights by August 14 or vacate the land.

A plantation drive will be launched in Uriamghat from Saturday with similar initiatives to follow in other recently cleared areas within the reserve forest, Yadav

This was the ninth eviction drive carried out in the state since June. The largest of these had cleared 1,500 hectares of forest land and

displaced around 1,500 families at Uriamghat in Golaghat district last week.

Chief Minister Himanta Biswa Sarma had claimed over 160 sq km of land has been cleared of encroachments since his government took over in May 2021, affecting affecting more than 50,000 people.

#### US rules out trade talks with India until tariff issue resolved

WASHINGTON/NEW DELHI, kicks in. Aug 8: After imposing a staggering 50 per cent duty on Indian goods, US President Donald Trump has also ruled out any trade talks between the two countries

until the tariff issue is resolved. "No, not until we get it resolved," Trump said in the Oval Office on Thursday in response to a question on whether he expects more trade negotiations with India after doubling the tariffs on Indian imports to 50 per cent.

A prominent American Congressman Representative Gregory Meeks, a Democrat, meanwhile, said Trump's latest 'tariff tantrum' risks years of careful work to build a stronger US-India partnership.

Over the last few months, India and the US have held several rounds of negotiations for a bilateral trade deal, but it could not be sealed in view of sharp divergences in certain critical areas, including agriculture and dairy.

The next round of bilateral talks for an initial trade agreement was scheduled to be held in August 25 in New Delhi, two days before the 25 per cent penalty on India, which is on top of a 25 per cent tariff, for continued purchase of Russian oil

As India explored various options to deal with Trump's action, Commerce and Industry Minister Piyush Goyal said the world today recognises the strengths of India and its demographic advantages.

"1.4 billion people bring aggregate demand, huge domestic market ...why else do you think everybody is vying up to do trade or have a better market access," he the Business Today India@100 event in Delhi on Fri-

Speaking at the same event, former G20 Sherpa Amitabh Kant said India should never lose its strategic autonomy and never yield to pressure while negotiating trade deals with the US, suggesting at the same time that the country should look at a long term perspective and behave in a calm and collected manner.

India should use trade-related uncertainties as an unique opportunity to carry out very vigorous reforms in our economy, he said.

"We still have 20 days for these (US) tariffs to kick in.We should never yield to pressure, but we should negotiate in a very rational manner, in a (CONTD. ON PAGE-2)

#### One killed, another injured in mob assault



GUWAHATI, Aug 8: One person vas killed and another injured on Friday after they were beaten up allegedly by local shopkeepers and others in Panbazar area here on suspicion of being thieves, a police officer said.

The culprits involved in the assault have been identified, and one of them has been arrested, the officer said.

Deputy Commissioner of Police (Central) Amitabh Basumatary said the Panbazar police station received information of the incident at around 9.30 am.

"On being informed, our team immediately rushed to the spot. A person was found lying in an injured condition, who was later identified as Atul Das, a rickshaw puller. He was rushed to the Gauhati Medical College and Hospital, but succumbed to his injuries," Basumatary said.

A second injured person was also spotted at the incident site, who was taken to the GMCH and is undergoing treatment, he added.

The DCP said an investigation has been launched and a team of the Criminal Investigation Department has visited the spot to collect evidence.

"The culprits have been identified. One of them has been arrested, and the rest will also be apprehended soon," he added.

Asked if local shopkeepers were involved in the thrashing, Basumatary did not rule it out, though he refused to share further details as the probe is still on.

### Rahul alleges problem with electoral process when BJP wins: Himanta

GUWAHATI, Aug 8: Chief Minister Himanta Biswa Sarma claimed on Friday that Congress leader Rahul Gandhi makes allegations of wrongdoing in the election process whenever the BJP emerges victorious.

He maintained that if the opposition leader was blaming EVMs for Congress' electoral defeats earlier, he is now pointing the finger at 'vote chori' (stealing of votes).

Sarma was responding to Gandhi's claims on Thursday of a 'huge criminal fraud' in polls through collusion between the BJP and the Election Commission, alleging that a 'vote chori model' was being used in many constituencies across the country.



"When Rahul Gandhi wins elections, everything is okay. When the BJP wins, he says there is some 'gondogol' (wrongdoing)," the chief

minister said, speaking to reporters on the sidelines of a programme in Udalguri.

"There is no 'vote chori' in Karnataka or Telangana (where Congress is in power). When we win, 'vote chori' happens," he said.

"Till now, they were saying it was the EVMs (behind BJP's wins), and now saying it is 'vote chori'," Sarma added.

Gandhi, the Leader of Opposition in Lok Sabha, said in a press conference in New Delhi on Thursday that over one lakh votes in the Mahadevapura assembly constituency in Karnataka were found to be fake, duplicate or bulk voters, with invalid addresses and new voters with misuse of Form 6. (PTI)

### Need of the hour to revise creamy layer income ceiling for OBCs: Parl panel

NEW DELHI, Aug 8: A parliamentary committee looking into the welfare of Other Backward Classes (OBCs) has said it was the "need of the hour" to revise the creamy layer income ceiling, saying the limit is excluding a large section of eligible OBC families from reservation benefits and government welfare schemes.

In its eighth report presented to Parliament on Friday, the panel noted that the last revision of the income threshold from ₹ 6.5 lakh to ₹ 8 lakh per annum was carried out in 2017. The Department of Personnel

and Training (DoPT) rules require the ceiling to be reviewed every

three years or sooner, if needed. "The present threshold is low, covering only a small segment of OBCs," the panel, chaired by BJP MP Ganesh Singh, said, adding in-



flation and rising incomes in even lower income groups had made an upward revision the "need of the

"The Committee is aware of the fact that the income limit for determining creamy layer for OBCs should be reviewed every three years or even before the stipulated period. However, the same has not been revised since 2017," it said.

"The Committee, therefore, in no uncertain words, reiterate their recommendation for reviewing and accordingly revising the present creamy layer threshold limit to cover more and more persons from the OBCs as this would eventually help in raising their socio-economic condition to a satisfactory

level," the panel said. The Ministry of Social Justice and Empowerment, however, told the committee that "there is no proposal under consideration" to revise the creamy layer limit.

Another unresolved issue flagged by the panel is the absence of equivalence between posts in autonomous bodies and government positions for determining creamy layer status.

The report said the lack of such equivalence has led to qualified OBC candidates, including those who cleared the UPSC Civil Serv-

### Assam govt recognises Wildlife Genetics Laboratory for wildlife crime investigations Assam Governor Laxman

**GUWAHATI, Aug 8:** The Assam government has recognised North East India's only Wildlife Genetics Laboratory (WGL) for the purpose of assisting wildlife crime investigations and control through forensic evidence gathering using DNA sampling methods.

Biodiversity organisation Aaranyak's Wildlife Genetics Laboratory has been recognised by the Assam government under Section 329 (4) of the Bharatiya Nagarik Suraksha (BNSS), 2023, WGL Director Udayan Borthakur said on Friday.

Section 329 of the Bharatiya Nagarik Suraksha Sanhita (BNSS), 2023, deals with the admissibility of reports from certain scientific experts, recognised by the government, as evidence in legal proceedings.

Prasad Acharya passed the order on August 4, following which the Special Chief Secretary of the Assam Environment, Forest and Climate Change Department issued the notification recognising both the laboratory and Borthakur under the relevant provision of the

"We regard the government's notification as a significant acknowledgement of our nearly two decades of work in this field and are grateful to the Assam government for entrusting us with this critical responsibility", Borthakur said. The notification will allow the lab and its biologist to function as scientific experts to support law enforcement agencies to gather evidence for forensic analysis in wildlife offences, that will facilitate increased conviction rates in the coming days.

Aaranyak Executive Director Bibhab Kumar Talukdar also thanked the state Forest department and other government authorities for bestowing faith and responsibilities to Wildlife Genetics facilities.

WGL, founded in 2008, is Northeast India's only conservation genetics and wildlife DNA forensics facility.

Over the past decade, the lab has provided genetic analysis and on-ground DNA sampling support to 135 wildlife crime investiga-

tions by government authorities. In addition to forensic work, the lab has conducted over two dozen conservation genetic research projects on threatened wildlife species in India and abroad. (PTI)

### Markets tank on tariff jitters, foreign fund exodus; Sensex dives below 80k

**MUMBAI, Aug 8:** Equity benchmark index Sensex tumbled nearly 1 per cent to slip below the 80,000 level on Friday as growing concerns over the impact of the additional US tariff and unabated foreign fund outflows unnerved investors.

Deep losses in market heavyweights Reliance Industries, HDFC Bank and Bharti Airtel also added pressure on equities, traders said.

The 30-share BSE Sensex tanked 765.47 points or 0.95 per cent to settle at 79,857.79. During the day, it tumbled 847.42 points or 1.05 per cent to 79,775.84.

As many as 2,507 stocks declined while 1,521 advanced and 145 remained unchanged on the BSE

50-share NSE Nifty dropped 232.85 points or 0.95 per cent to 24,363.30. Extending losing streak for the sixth consecutive week, the BSE benchmark dropped 742.12 points or 0.92 per cent, and the Nifty declined 202.05 points or 0.82 per cent.

"The Indian equity market exhibited downward movement, closing at a three-month low amid growing concerns over the impact of US tariffs on Indian exports.

"FIIs remained net sellers, intensifying the pressure on domestic indices. The pessimism was broadbased, with realty and metals bearing the biggest brunt," Vinod Nair,



ments Limited, said.

From the Sensex firms, Bharti Airtel, Tata Motors, Mahindra & Mahindra, Kotak Mahindra Bank, Axis Bank and Reliance Industries were among the laggards.

"Selling intensified, with the Sensex ending below the psychological 80k mark, as analysts believe that once the stiff tariff penalty on Indian goods by the Trump administration comes into effect, India's growth could be hit going ahead," Prashanth Tapse, Senior VP (Research), Mehta Equities Ltd, said.

However, NTPC, Titan, Trent, ITC and Bajaj Finserv managed to be in green territory.

The BSE midcap gauge tanked 1.56 per cent, and the smallcap index dropped 1.03 per cent.

All sectoral indices ended lower, realty dropped 2.09 per cent, telecommunication (1.83 per cent), metal (1.82 per cent), consumer durables (1.68 per cent), capital goods (1.62 per cent) and commodities (1.55 per cent).

Arunachal Pradesh Chief Minister highlighted that due to the high geographical spread and sparse population distribution in the state, there are a large number of villages that lack road connectivity. He suggested that the high-level task force may explore providing connectivity to these villages through PMGSY and other relevant central government schemes. He further stated that the air connectivity to the Hollongi Airport can be enhanced by increasing the frequency of flights.

Khandu also called for the need to reorient the North Eastern Council (NEC) to function as a think-tank, on the lines of NITI Aayog, for a holistic growth of the region. The Mizoram minister highlighted the issue of high logistics fare in NER, due to which the cost of local produce and commodities increases by more than 20 per cent, making these items less competitive. He also outlined the need for improving digital connectivity in the state. The Sikkim minister pointed out that an alternative road alignment to the existing NH-10 needs to be developed as the national highway gets affected every year by torrential rainfall and landslides.

He emphasised the need for developing climate-resilient infrastructure in NER to boost trade with Nepal. During the meeting, critical gaps were discussed in the sectors of roads, railways, waterways, logistics and digital connectivity, the statement said. To bridge these gaps, a comprehensive Infrastructure Master Plan must be formulated, it said. The plan will be developed in consultation with all eight northeastern states and central ministries, ensuring a collaborative approach to regional development. The key points of discussion during the meeting included identification of state-specific bottlenecks and challenges, critical connectivity gaps and prioritised infrastructure needs, integration of state budgets and national investments for capital formation, and an implementation roadmap for 'Viksit NER @ 2047'. Earlier this year, the Centre had formed eight high-level task forces, with each headed by one of the chief ministers of the NE region. (PTI)

"At this pivotal moment we should aggressively pursue the Free Trade Agreement with the European Union. That is very, very important. As one market seems to be kind of closing, we need to open wider another market... EU agreement needs to be done and then there are reforms that need to be done particularly with labour market and land market." Panagriya also dismissed Trump's "dead economy" jibe at India, saying the Indian economy is growing at 7 per cent and more than that in dollar terms. "May be, dead bodies do move."

You don't grow at 7 per cent plus (if the economy is dead), and actually in dollar terms we are growing at more than 7 per cent. I don't know what the definition (of dead economy) means. May be, dead bodies do move," he said when asked if India is a 'dead economy'. Mounting a sharp attack on India, Trump had remarked that India is a "dead economy". "I don't care what India does with Russia. They can take their dead economies down together, for all I care," Trump had said in a social media post on August 3.

US Representative Meeks said the US has "deep strategic, economic, and people-to-people ties" with India. "Trump's latest tariff tantrum risks years of careful work to build a stronger US-India partnership," he said in a post on X. "Concerns should be addressed in a mutually respectful way consistent with our democratic values." Kerala Finance Minister K N Balagopal said the 50 per cent tariff decision on Indian goods was a "bullying tactic" to control the country's economy.

The minister said the US was trying to bully India into accepting more imports from America as "our purchasing power has increased manifold". "Therefore, it is a time when all should stand united to safeguard India's interests and oppose such moves which can harm the Indian economy," he told reporters in Thiruvananthapuram. Moody's Ratings said India's GDP growth is likely to slow down by about 30 basis points to 6 per cent in the current fiscal if the US implements the total 50 per cent tariffs from August 27.

However, resilient domestic demand and the strength of the services sector will mitigate the strain on India, Moody's said, adding that India's response to high US tariffs will ultimately determine the effect on its growth,

While 10 of the panel's 12 recommendations from its earlier sixth report were accepted by the government, the two on creamy layer revision and post equivalence were reiterated.

Accepted proposals include reviewing parental income limits for scholarships, expanding the Pre-Matric Scholarship Scheme under PM-YASASVI to start from Class V, increasing slots for "Top Class" school and college education schemes for OBCs, Economically Backward Classes (EBCs) and Denotified Tribes (DNTs), and enhancing central grants for OBC welfare.

The panel also voiced concern over a sharp fall in scholarship beneficiaries. Under the pre-matric scheme, beneficiaries dropped from 58.6 lakh in 2021-22 to 20.29 lakh in 2023-24, while expenditure fell from ₹218.29 crore to ₹193.83 crore. Post-matric beneficiaries fell from 38.04 lakh to 27.51 lakh, with spending down from ₹1,320 crore to ₹ 988 crore in the same period.

States' incomplete or delayed proposals, slow fund utilisation, and transition issues to Aadhaar-based direct benefit transfer and online portals were cited as key reasons. On budget allocation, the committee said OBCs make up 52 per cent of India's population as per the Mandal Commission, yet their central grants are far lower compared to those for Scheduled Castes, who comprise about 16.6 per cent of the population.

While allocations for OBC schemes such as PM-YASASVI have risen from ₹ 1,581 crore in 2022-23 to ₹ 2,190 crore in 2025-26 the panel wants proportional increases to reflect the community's size and needs.

Unspent funds were another sticking point. The report pointed to unused amounts, including ₹86 lakh in prematric, ₹98 lakh in post-matric, and ₹15 lakh in hostel construction schemes as signs of "lack of supervision and foresightedness." It recommended stricter monitoring, more awareness campaigns in local languages, and better coordination with states to ensure timely utilisation of funds.

The committee warned that without timely policy updates and efficient execution, procedural delays and outdated eligibility norms could undermine the government's stated goal of uplifting backward classes through education, skills, and social welfare. (PTI)

### Treasury, forex gains help SBI post 10 pc growth in Q1 net profit

**MUMBAI, Aug 8:** State Bank of a NIM of 3 per cent for FY26 on India on Friday reported a 9.71 per cent increase in its consolidated net profit to ₹21,201 crore in the June 2025 quarter, helped by a handsome performance on the treasury and forex income.

On a standalone basis, the country's largest lender's net profit grew to ₹ 19,160 crore from ₹ 17,035 crore in the year-ago period.

Despite an 11.6 per cent jump in overall advances, the core net interest income declined by 0.13 per cent to Rs 41,072 crore, as net interest margins contracted by 0.33 per cent to 3.02 per cent, following the RBI's deep rate cuts and the time taken for deposit rate repricing impacted the spreads.

Its chairman CS Setty told reporters that the NIMs will follow a U-shaped trajectory in FY26, pointing out that there will be challenges on NIMs in the second quarter before the number inches up, and added that it aims to have

A 55 per cent jump in the overall non-interest income at ₹ 17,346 crore helped the bank deliver the profit growth for the quarter. This was led by a 352 per cent rise in forex income at ₹ 1,632 crore and the profit on sale of investments being 144 per cent higher at ₹ 6.326 crore.

Additionally, restricting the growth in operating expenses, which were up 7.88 per cent to ₹ 27,874 crore, also helped the bot-

From a loan growth perspective. Setty said the bank is maintaining its target of growing at 12 per cent for FY25. Corporate advances increased by 5.7 per cent, and the domestic retail segment rose 12.56 per cent, and overseas book was higher by 14 per cent year-on-year during the reporting quarter.

The chairman said the bank has a pipeline of Rs 7 lakh crore, including proposals and cleared loans yet to be disbursed, and added that the current uncertainties stemming from geopolitical issues are delaying disbursements.

The bank is hoping for an acceleration in the corporate loan disbursements in the remainder of the year and close FY26 with a 10 per cent loan growth in the segment,

Setty said companies are not investing because of the lack of clarity on the consumption demand front, and sectors like renewable power and data centres, which are seeing maximum credit demand at

Acknowledging that the bank has exposures to the 4-5 sectors directly impacted by the US move on tariffs, he said the banking sector will not be impacted by the measures unleashed by the Trump administration because its overall contribution is under 2 per cent to bank credit. (PTI)

MARGHERITA, Aug 8: Various organisations of Margherita Co-District have become active regarding the eviction of suspected citizens, as on Friday many illegal encroachers packed their belongings and left the Maulang area of Ledo under the 83rd Margherita Legislative Assembly Constituency in Tinsukia district.

Numerous suspected citizens, who had been occupying government land for years, have packed their bags and are preparing to leave Margherita and Upper Assam.

A few days ago, the Asom Jatiyotabadi Yuba Chatra Parishad (AJYCP) Margherita Regional Committee burnt tyres, staged a dharna and issued an ultimatum for suspected citizens residing in Margherita and nearby areas of Ledo to leave Upper Assam.

Additionally, former ULFA leader Jiten Dutta arrived in Margherita and issued a warning for suspected illegal encroachers to leave Upper Assam before August 15. Following this, suspected citizens have started leaving Margherita, with some already selling their livestock at low prices to prepare for departure.

It is reported that, due to panic, suspected citizens have sold milch cows valued from ₹ 30,000 to ₹ 40,000 for just ₹ 10,000 to ₹ 15,000.

In short, the roar of these organisations has left suspected citizens in Upper Assam disoriented.

Notably, former ULFA leader Jiten Dutta has commented that another eviction drive will be conducted after August 15.

#### **Future of Indian industries tense**

nnouncement by Tata Consultancy Service (TCS), India's largest private sector employer employing about 600,000, to lay off its 12,000 employees, has instilled a grave insecurity feeling not only among the workers, but has also raised serious concern in the entire IT sector. TATA is known for providing lifetime employment, and therefore, TCS shedding about 2 per cent of its workers is a serious matter. Deployment of Artificial Intelligence (AI) has been changing the IT sector faster than any other industry or sector across the world, and India is not an exception. Nevertheless, the CEO and managing director of TCS K Krithivasan has attributed the move not to AI adoption, but to "limited deployment opportunities and skill-mismatch". Taken on face value, it may be possible that AI may not be the factor for the current lay off in the TCS, but there is no reason to believe that "limited deployment opportunities and skill-mismatch" has nothing to do with the adoption of AI in the IT sector. Hence, the IT sector in generally sees the layoffs as a sign of broader and disruptive changes underway, only to be amplified by the growing influence of AI. Revenues of all major service provider Indian IT companies are either falling or almost stagnated, chiefly because of adverse economic, trade, and tariff conditions of US and European countries and AI automation.

All these show that the business model in the IT sector has been changing fast across the world along with deployment of new technology such as AI and unavailability of skilled workforce, that TCS called "limited deployment opportunities and skill-mismatch. It should be noted that TCS and many other Indian IT companies have traditionally been relying on India's vast pool of low-cost skilled labour. They were engaged by and large in providing software services. It is clear from the TCS layoffs that this service model is now lagging behind and is not able to compete with the changing ground realities. Their global clients are demanding services at competitive prices and technologically better. They have been rapidly deploying AI driven automation that has already automated many of their tasks, many of which were repetitive. Not only entry level routine jobs are being displaced, but also it is transforming the mid-level jobs. For many of the tasks, the global companies no longer require to higher services of the Indian IT companies.

This is the general condition of the IT sector, and it can't be ignored only on account of a few IT companies' announcements that they will be employing more people in near future. For example, Infosys has announced that they have hired 17,000 people in the first quarter of the current financial year and they plan to hire another 20,000 graduates this year itself. The CEO of Infosys has credited AI, cloud, and cost efficiency as key growth driver for such a growth.

### India's Tit for Trump's Tat

The trade winds between India and the United States are beginning to stir with tension once again. Former U.S. President Donald Trump's recent statements advocating a blanket 50% tariff on all imports, including those from long-standing trade partners like India, have sent a jolt through global markets and policy circles. While Trump's protectionist rhetoric isn't new, the scale and bluntness of this proposed tariff — if enacted in a future adminwould represent an unprecedented escalation in U.S. trade pol-

India, one of the largest trading partners of the United States, cannot afford to ignore such a move. With nearly \$118 billion in bilateral trade in goods and services in 2024 alone, the stakes are high. A 50% tariff would disproportionately affect key Indian sectors like textiles, pharmaceuticals, IT services, and steel - putting millions of Indian jobs at risk and shaking investor confidence.But India is not without leverage. With growing geopolitical clout, a rising economic profile, and strategic partnerships beyond Washington, New Delhi has both the tools and the resolve to respond. The question is not whether India should retaliate — it's how to retaliate smartly.

Why Trump's 50% Tariff matters is the burning debate today in the country. Congress and Trinamul Congress wanted answer from Prime Minister in the Parliament . They insisted why Trump's friend who even campaigned in Texas for his victory will have to reply. Parliament is facing turmoil everyday on this issue and sessions are adjourned many times.

Donald Trump's America First agenda has always viewed trade through a transactional lens. The proposed 50% tariff, if realized, would essentially act as a non-tariff barrier, pricing Indian goods out of the U.S. market. This threatens India's export competitiveness in key sectors:Pharmaceuticals is one of them. India is the world's largest supplier of generic medicines to the U.S.In the field of Textiles and Apparel we know India exports over \$8 billion worth of garments annually to the U.S.The other is IT Services and India's technology sector provides services worth billions through U.S.-based contracts.Beyond the economic blow, the tariff also signals a troubling shift: treating strategic partners like India on par with adversaries. This has broader implications for diplomatic trust and geopolitical collaboration — especially in an era where counterbalancing China remains a shared interest.

India's Options can be guessed. First it can be a measured retailiation. India indeed has a range of options — both hardline and diplomatic — that it can deploy in response. Each has its own trade-offs and strategic weight. Here's how India can respond with a calibrated "tit for tat."

1. Reciprocal Tariffs on Key U.S. Exports India could target American exports with mirror tariffs, leveraging its own large consumer base. Sectors that could feel the brunt of such a move include: Agricultural products like almonds, walnuts, and apples —

California's \$1.5 billion trade with India

could take a direct hit. Energy imports, including liquefied natural gas (LNG) and crude oil, which the U.S. has been increasingly selling to India. Luxury goods and high-end electronics, which are non-essential imports and easier to target without domestic backlash. This move sends a clear message: if Indian businesses are being hurt, U.S. exporters will feel the pain too.

#### 2. Diversify and De-Americanize Trade **Partnerships**

One of the best ways to retaliate without escalating is to reduce dependence on the

India can accelerate trade agreements with the EU, UK, and Australia. These markets offer comparable purchasing power and geopolitical alignment. India can strengthen its presence in ASEAN and African economies, where Indian pharmaceuticals, engineering goods, and education services are already well-regarded. Indian can play a bigger role in forums like BRICS

Global South Summits, and By: Dr. Ratan Bhattacharjee the Shanghai Cooperation Organisation (SCO) to build alternate coalitions. By diversifying its eco-

nomic footprint, India reduces vulnerability to U.S. tariffs and makes itself less susceptible to the whims of American domestic

#### 3. India is trying to boost Domestic Re-

In Atmanirbhar Bharat 2.0, Trump's protectionism could be the unexpected catalyst for a second wave of Atmanirbhar Bharat — the self-reliant India initiative. This involves i)Scaling up domestic manufacturing in electronics, textiles, and medical devices proach will help India maintain interna-

ii) Ncentivizing R&D and innovation in high-tech sectors like semiconductors and AI. India will be supporting MSMEs (Micro, Small & Medium Enterprises) to become export-ready and resilient to global shocks. The objective is not autarky, but rather strategic autonomy — ensuring that external disruptions do not derail India's growth trajectory.

Fourthly, India needs to challenge the Tariff Legally at the WTO. If implemented, a flat 50% tariff would almost certainly violate World Trade Organization (WTO) norms, especially most-favored nation (MFN) obligations. India could: India has to file a formal dispute at the WTO against the U.S., arguing that such a tariff is discriminatory and protectionist. India seeks support from other affected nations, including EU members, Japan, and South Korea creating a coalition of resistance.

India uses the legal process to create pressure for a negotiated rollback. Although the WTO's dispute settlement mechanism has weakened in recent years, a multilateral legal challenge still carries significant diplomatic and moral weight.

India uses Strategic Diplomacy — Not Just Trade Tools .India has proven its diplomatic dexterity time and again. Rather than a knee-jerk retaliation, New Delhi can:

India should engage with U.S. lawmakers, governors, and industry bodies — many of whom oppose such blanket tariffs of Trump. .In his own party there is a difference of opinion and Trump is being criticized for his steps against India, the imposition of highest tariff. Leverage lobbying power in sectors where U.S. companies rely on Indian talent and supply chains

- like tech and pharmaceuticals is to be sought.

India can make use of platforms like the Ouad, G20, and Indo-Pacific Economic Framework (IPEF) to frame the tariff as a threat to global stability and cooperation. By appealing to American self-interest — particularly in countering China — India can argue that penalizing friendly democracies weakens the broader strategic alignment. India's messaging must walk a fine line: assertive, not antagonistic. The public posture should be that India is committed to free and fair trade. India is opposed to unilateralism. India's proportionate retaliation only is a last resort. This ap-

tional credibility while unifying domestic stakeholders - from exporters and industrialists to policymakers and consumers.

At the same time we may take note of Economic and Political Implications for India. Trump's tariff rhetoric also has domestic implications. In the short term, Indian exporters may face order cancellations, higher costs, and market uncertainty. This could lead to: i) Job losses in key industries like garments and chemicals ii) Lower GDP growth due to reduced foreign exchange earnings iii) Pressures on the rupee due to trade imbalance iv) Politically, the government will face pressure to act decisively, especially with an increasingly nationalistic electorate. However, overreaction could alienate allies and trigger broader economic fallout. Therefore, the response must be strategic, not symbolic.

The bigger picture of India's role in a changing global order is emerging and Trump knows it. India has stopped buying war jets from the US and buys crude oil from Russia at a cheaper rate. Trump cannot poke his nose in the pretext of punishing for indirectly helping Russia against Ukraine. Trump's tariff proposal is not just an economic threat — it is a test of India's maturity as a global playen India's rise on the world stage comes with new responsibilities. Retaliation must be paired with visionary leadership — using this challenge to: i) Advance long-stalled economic reforms ii) Deepen global economic alliances iii) Project itself as a champion of multilateralism in an increasingly fragmented world

The real retaliation is not just in tariffs, but in showing that India can lead by example — firm, fair, and future-facing. India's calculated Strength and not any brash reaction will at this moment be the cry of the day. Trump's 50% tariff threat may be campaign posturing. Or it may become policy again. Either way, India cannot afford to wait and watch. The response must be grounded in economic logic, diplomatic tact, and strategic foresight. Whether through reciprocal tariffs, diversified trade, or global coalition-building, India must show that it is not a passive player in global trade. It is a sovereign nation with the strength and smarts to defend its interests without compromising its commitment to cooperation. In the end, retaliation is not

about mimicry — it's about strategy. India's "tit" must not just match Trump's "tat" —

#### Growing American terror on global economy and India

eing one of the largest economies of the world. America has been dominating global economic policies for a long time. This dominance has now taken the form of open bullying, especially when US President Donald Trump is trying to subjugate countries economically by imposing arbitrary tariffs. After imposing a 25 percent tariff on India, the announcement of an additional 25 percent tariff has made this bullying even more clear. That is, a total tariff of 50 percent - this will not only affect business competition, but will also affect the global trade balance.

Trump objects to India buying oil from Russia, while the irony is that China is also doing the same and America itself is buying uranium and fertilizers from Russia. That is, in theory and practice, American policy is full of double standards. The question is why should India work under American pressure by putting its interests at stake?

For the first time after Prime Minister Narendra Modi's announcement of tariff hike on India yesterday, the reaction at the MS Swaminathan Centenary International Conference has put forward India's firm stand even more strongly. India's firm attitude is reflected in it. Modi has clearly said that for us, the interest of our farmers is the top priority, no matter what price has to be paid for it. India will never compromise on the interests of farmers, fishermen and dairy farmers. This statement shows that India will no longer bow down to global pressures.

According to the data of the United States Trade Representative (USTR), the annual trade between India and America is Rs 11 lakh crore. India exports goods worth Rs 7.35 lakh crore to America, which includes medicines, telecommunication equipment, gems-and-jewellery, petroleum, electronics, engineering products and textiles. At the same time, India imports goods worth Rs 3.46 lakh crore from America, which includes crude oil, coal, diamonds, aircraft and spacecraft parts. But the worrying thing here is that America has not imposed such heavy duty on countries like China, Vietnam, Bangladesh and Indonesia, due to which their products will be cheaper in the American market than Indian products. Still, the attitude of the Modi government is firm. In the sixties, we were dependent on America even for wheat and milk, but it seems that Trump has read some book written in those days as if it were fresh. He is still seeing the old India, which he is thinking of bowing down. He should understand that India is no longer the same India as before. It is self-reliant and the fastest growing economy in the world. India's dominance is increasing all over

The industry is also seeing this pressure as an opportunity. Industrialist Harsh Goenka says that America can impose tariff on exports, but not on our sovereignty. Anand Mahindra even said that just as the foreign exchange crisis of 1991 opened the way for liberalization. similarly this tariff crisis can also give us momentum in the direction of self-reliance. Through a social media post, Lalit Modi has reminded Trump of the 2023 report, which was released by the US company Goldman Sachs. It is worth noting that Goldman Sachs had said in this report that India is on its way to becoming the world's second largest economy by 2075, which will leave behind not only Japan and Germany, but also the United States.

The report estimates that by 2075, India's GDP will be \$ 52.5 trillion, which will be less than China's \$ 57 trillion but more than America's \$ 51.5 trillion. Currently, India is the fourth largest economy in the world and is growing

America's economic bullying is nothing new. Since the First World War, it has been imposing its conditions in global economic policies, but now the situation is changing. China is already not coming under its pressure and now India is also giving clear indication that its priority is its national interests. Recently, India completely rejected America's attempt to take credit for stopping the Indo-Pak war during Operation Sindoor. The same attitude is now visible in the tariff dispute as well.

Leading with patience and restraint is India's strength. That episode of Ramcharitmanas comes to mind when Vibhishan told Shri Ram during the war that Rayana has everything, but you have nothing. Then Shri Ram replied that the biggest strength is patience, peace and tolerance. This policy is reflected in the leadership of India today. Where Trump is arrogant, India is moving ahead with determination and

History has proved that America has never been a permanent friend of India. Trump's policies are being opposed even within America. In such a situation, changing equations can open new opportunities for India. Trump may be adopting an arbitrary attitude, but he is also getting trapped. ### Quit India Movement: The turning point towards Independence

**T**he Quit India Movement of 1942 stands as one of the most decisive and defining moments in the history of India's long struggle for freedom, marking a shift from political negotiation to a final, resolute demand for independence. It was a movement born not out of gradual persuasion but from an unyielding assertion that the British must leave India immediately. By the early 1940s, the political climate in India was charged with frustration, disappointment, and a simmering discontent that spanned across classes and regions. The Second World War had further intensified this atmosphere. Britain had involved India in the war without consulting its leaders, and the growing economic strain, political suppression, and broken promises of constitutional reform deepened the sense of betraval. The failure of the Cripps Mission

in 1942 became the last straw. Sir Stafford Cripps, sent by the British government to secure Indian cooperation in the war effort, offered only a vague assurance of dominion status after the war, with no guarantee of immediate independence. For a country whose political awakening had been growing steadily since the late 19th century, such proposals were not only inadequate but insulting. It was against this back-

ground that Mahatma

Gandhi, at the All India Congress Committee meeting in Bombay's Gowalia Tank Maidan on 8 August 1942, gave his historic call for the British to "Ouit India," declaring "Do or Die" as the rallying cry for the nation.

The decision to launch the Quit India Movement was not one taken lightly. Gandhi himself had been committed to the principle of nonviolence, and he understood the risks of unleashing a mass movement at a time when the world was engulfed in war. Yet, he also recognised that the moment had arrived when nothing short of complete independence would satisfy the aspirations of the Indian people. The speech at Gowalia Tank was not merely a political declaration; it was a moral proclamation that the subjugation of India had to end, and it had to end now. The British reaction was swift and brutal. Within hours of the resolution being passed, the colonial government arrested Gandhi, Jawaharlal Nehru, Sardar Vallabhbhai Patel, Maulana Abul Kalam Azad, and almost the entire Congress leadership. The intention was clear: to decapitate the movement before it could gather momentum. But instead of crushing the spirit of resistance, the arrests sparked a spontaneous, decentralised uprising across the country.

**DEGREE OF THOUGHT** 

The leaderless nature of the movement became both its challenge and its unique strength. With the top leaders in prison, ordinary citizens, students, women, peasants, and workers took the lead in organising protests, strikes, and acts of defiance. The movement spread like wildfire, from urban centres to remote villages. In many places, government offices were attacked communication lines disrupted, and railways sabotaged to paralyse the colonial administration. While Gandhi had insisted on non-violence, the repression unleashed by the British provoked violent outbursts in several parts of the country. This was one of the rare moments in the nationalist struggle when civil disobedience and sabotage operated side by side, reflecting both the desperation and determination of the masses.

The Quit India Movement was remarkable for the breadth of its

participation. It was not confined to the educated elite or urban activists but drew in people from all walks of life. Students boycotted classes, factory workers went on strike, farmers refused to pay taxes, and women emerged as leaders in the absence of male political figures. Figures like Usha Mehta kept the movement alive through underground activities such as operating the Congress Radio, which broadcast uncensored news and messages of resistance. In Bengal, Matangini Hazra, an elderly woman in her seventies, led a procession carrying the national flag and was shot dead by the police, becoming a symbol of unflinching courage. In Bihar, Jayaprakash Narayan, Ram Manohar Lohia, and Aruna Asaf Ali emerged as key underground leaders, keeping the flame of resistance burning despite the intense crack-

The British responded with an iron hand. Censorship was tightened, public meetings banned, and thousands were jailed. The movement was met with mass shootings, lathi charges, and collective punishments, with entire villages being fined or destroyed for harbouring rebels. By the end of 1942, the movement had been physically suppressed, but its political impact was irreversible. For the first time, the British realised that governing India without the cooperation of its people was becoming impossible. The sheer scale of the uprising, cutting across regional, linguistic, and communal lines, sent a clear message that the demand for freedom was now an unstoppable force.

Movement also altered perceptions of the Indian struggle. The war had placed Britain in a precarious position, dependent on the goodwill and support of allies like the United States, which was increasingly uncomfortable with Britain's colonial policies. The contradiction of fighting a war for democracy while denying it to colonies like India did not go unnoticed. Although the movement did not lead to immediate independence, it significantly weakened Britain's moral authority and bargaining position in the postwar world. The polit-

ical landscape in India after 1942 was markedly different. The Quit India Movement had instilled in the masses a heightened political consciousness and a willingness to act independently of central leadership when necessary.

Perhaps the most enduring legacy of the Quit India Move-

ment lies in the way it shifted the balance of the freedom struggle. Earlier movements such as the Non-Cooperation Movement of the 1920s and the Civil Disobedience Movement of the 1930s had been powerful but ultimately reversible in their impact. The Ouit India Movement, however, created a point of no return. From this moment on, the question was not whether India would become free, but when and under what terms. The British, exhausted by the war. economically weakened, and politically isolated, could no longer hope to maintain their hold over India indefinitely. The repression of 1942 did not break the back of the nationalist movement; instead, it hardened its resolve.

The years between 1942 and 1947 were shaped by the political momentum generated by Quit India. The release of political prisoners in 1944, the naval mutiny in Bombay in 1946, and the mounting labour and peasant unrest all drew upon the spirit of defiance unleashed in 1942. Even as communal tensions and the eventual partition cast a shadow over independence, the Quit India Movement remained a reminder of the unity and collective will that had powered the struggle. Gandhi's vision of non-violent resistance, though challenged by the violence that erupted in parts of the country, still provided the moral backbone of the movement, demonstrating that moral courage could be as potent a weapon as physical

Looking back, the Quit India Movement occupies a unique place in India's history. It was not a carefully orchestrated campaign with a clear beginning and end; rather, it was a people's uprising that transcended organisational control. It represented the culmination of decades of political awakening, uniting millions under the shared conviction that the time for freedom had arrived. It also underscored the transformative power of mass participation in shaping political destiny. While it faced criticism for lacking concrete planning and for allowing violence to erupt, its significance cannot be measured solely by its immediate outcomes. It was a movement that shook the foundations of British rule, both materially and psychologically. When independence finally came

in August 1947, it was the result of multiple forces-political negotiations, global shifts in power, and the cumulative pressure of decades of struggle. But the Quit India Movement was the definitive moment that ensured there would be no turning back. It was the final assertion of a nation's will, a collective declaration that the people of India would no longer accept subjugation in any form. The slogan "Do or Die" was not merely rhetorical; it captured the essence of a people prepared to sacrifice everything for their freedom. The movement proved that the spirit of a united populace could withstand even the harshest repression and that the will to be free, once ignited, could not be extinguished.

Today, as India reflects on its journey from colonial rule to a sovereign republic, the Quit India Movement continues to inspire. It stands as a testament to the courage, resilience, and unity of ordinary Indians, who, in the absence of their leaders, rose to the occasion and carried the struggle forward. It is a reminder that history is shaped not only by leaders and negotiations but by the collective actions of those who refuse to accept injustice. In the annals of India's freedom struggle, 1942 will always be remembered as the year when the final chapter began—when a nation, weary of waiting, declared in one voice that the British must quit India, and when that declaration became the turning point towards the independence that followed five years later.

### Raksha Bandhan: A sacred thread beyond time and ties

n the grand mosaic of Indian festivals that spill color, devotion, and familial warmth across the subcontinent, Raksha Bandhan—or simply "Rakhi"—occupies a uniquely tender space. Celebrated each year on the full moon day of the Hindu lunar month of Shravana, typically in August, it is, at its surface, a charming occasion of sibling affection. A sister ties a decorative thread on her brother's wrist, prays for his well-being, and in return receives his pledge of protection, often accompanied by gifts. Yet beneath this simple exchange lies a vast reservoir of cultural philosophy, historical resonance, and spiritual symbolism. Far from being a mere domestic ritual, Raksha Bandhan has, over centuries, evolved into a civilizational narrative—one that intertwines myth and history, devotion and duty, emotional intimacy and societal ethics.

The very term is steeped in meaning: "Raksha" denotes protection, and "Bandhan" signifies a bond or tie. Together they convey more than familial loyalty; they speak of a sacred covenant rooted in the moral conscience of dharma. It is a promise that transcends personal affection, reaching into the realm of spiritual responsibility and social duty. To tie a rakhi is to acknowledge the sanctity of human relationships and to bind one-self to the ideal that strength should always shelter, never subdue.

The festival's roots reach deeply into the mythic soil of Hindu tradition. One of its earliest references lies in the Bhavishya Purana, where Indrani, the consort of Lord Indra, fashions a sacred thread and ties it around her husband's wrist before his battle with the asuras. Her mantras, woven into the thread, invoke divine protection. Indra's subsequent victory lends the rakhi a talismanic aura—a belief that a sanctified thread can summon cosmic strength. Though no sibling relationship is depicted here, the symbolism of a bond sanctified by prayer becomes the seed from which Raksha Bandhan would grow.

Equally enduring is the episode from the Mahabharata where Lord Krishna, upon wounding his finger, receives Draupadi's instant gesture of



and moral courage. Other legends add layers to the festival's ethos. In one, Yamuna ties a rakhi to Yama, the god of death, who grants her immortality and declares that any brother honored with a rakhi tied in sincerity will be blessed with longevity. In yet another tale from antiquity, the wife of Alexander the Great ties a rakhi to King Porus before battle, persuading him to spare Alexander's life.

History, too, records the rakhi as a token of moral duty beyond the family. In the sixteenth century, Rani Karnavati of Chittor, threatened by the forces of Bahadur Shah, sent a rakhi to the Mughal emperor Humayun, seeking protection. Rising above religious and political divides, Hu-

In South India, it aligns with Avani Avittam, a day when Brahmins renew their vows and sacred threads. The Skanda Purana and Bhagavat Purana connect it to the Vamana avatar of Vishnu, where humility and service triumph over pride. Across all these interpretations runs a common thread-literally and figuratively—of surrendering ego, upholding protection, and placing service above self-interest.

ndia is a country full of diversity, where every festival not only symbolizes religious faith, but also strengthens social and cultural relationships. One of these special festivals is Rakshabandhan, which symbolizes the sweetness, love and protection of the brother-sister relationship. ### China welcomes PM Modi's planned visit to attend SCO Summit

BEIJING, Aug 8: China on Friday welcomed Prime Minister Narendra Modi's planned visit to the Tianjin Summit of the Shanghai Cooperation Organisation (SCO) to be held later this month, expressing hope that the event will be a "gathering of solidarity, friendship and fruitful

PM Modi is expected to travel to China later this month, after a gap of over seven years, to attend the annual summit of the SCO, people familiar with the matter in Delhi said this week.

"China welcomes Prime Minister Modi to China for the SCO Tianjin Summit," Foreign Ministry Spokesperson Guo Jiakun said while responding to a question on reports about Modi's visit to China to attend the Tianjin summit to be held from August 31 to September 1.

'We believe that with the concerted effort of all parties, the Tianjin summit will be a gathering of solidarity, friendship and fruitful results, and the SCO will enter a new stage of highquality development featuring greater solidarcoordination. dynamism productiveness," Guo said.

Guo said that leaders of over 20 countries, including all member states of the SCO and heads of 10 international organisations, will attend relevant events. "The SCO Tianjin Summit will be the largest summit in scale since the establish-



ment of the SCO," the spokesperson added. Modi is expected to embark on a visit to Japan around August 29, and after concluding the trip, he will travel to the Chinese city of Tianjin for the SCO summit.

There is no official confirmation yet on Modi's two-nation visit to Japan and China. Modi last visited China in June 2018 to attend the SCO summit. Chinese President Xi Jin-

ping visited India in October 2019 for the second "informal summit" However, the relationship came under stress due to the eastern Ladakh border face-off.

The military standoff in eastern Ladakh began in May 2020 and the clashes at the Galwan Valley in June that year resulted in a severe strain in ties. The face-off effectively ended fol-

lowing completion of the disengagement process from the last two friction points of Demchok and Depsang under an agreement finalised on October 21 last year.

In the last few months, both sides revived the Special Representative dialogue on the boundary question and other dialogue mechanisms.

The decision to revive various dialogue mechanisms was taken at a meeting between Prime Minister Modi and President Xi at Kazan in Russia on October 23, 2024

The Modi-Xi meeting came two days after India and China firmed up a disengagement pact for Depsang and Demchok.

The two sides also took a number of initiatives to rebuild the ties, which included the resumption of Kailash Mansarovar Yatra and New Delhi restarting issuance of tourist visas to Chinese nationals. Both sides are also discussing modalities to resume direct flight services between the two countries.

Defence Minister Rajnath Singh, External Affairs Minister S Jaishankar and NSA Ajit Doval visited China in the last two months to attend the SCO meetings.

China is the current chair of the SCO. It is not immediately clear whether PM Modi and President Xi will hold a bilateral meeting on the sidelines of the SCO summit. (PTI)

### 17 killed, 33 missing in torrents, landslides in China

BEIJING, Aug 8: At least 17 people have died and 33 others are missing in torrents and landslides in China in the last 48 hours, official media here reported

President Xi Jinping has urged all-out search and rescue efforts, and flood prevention and disaster relief work after mountain torrents hit northwest Gansu province on Thursday, state-run Xinhua news agency reported on Friday. At least 10 people were killed and 33 others listed missing in mountain torrents in Gansu province, it said.

In another incident, seven people died and seven others injured following a rain-triggered landslide in Guangzhou, the capital of China's southern Guangdong province, on Wednesday, local officials said on Friday. The landslide occurred in Dayuan Village in Guangzhou's Baiyun District, trapping 14 people and damaging multiple houses, according to the district's emergency management bureau.

The injured were sent to the hospital.

On-site cleanup work is ongoing, along with geological hazard risk assessments in affected and surrounding areas. Safety inspections and evaluations of residential buildings will also be carried out to support follow-up work, Xinhua reported.

In Gansu, torrential rain pounded Yuzhong, which is under the jurisdiction of the provincial capital city of Lanzhou, and other areas of Lanzhou on Thursday evening, with the maximum precipitation reaching



220.2 mm by noon Friday. Several townships in Yuzhong have been seriously affected, the report said. Flood waters mixed with uprooted trees blocked the roads with mud deposits. The torrents also damaged several houses and vehicles.

More than 2,700 rescue personnel have been dispatched by provincial authorities, along with 980 vehicles and pieces of machinery and 8,530 sets of emergency supplies. Search and rescue efforts for the missing, infrastructure repairs, and the evacuation and resettlement of affected residents are underway.

Several provinces in China, including Beijing, are currently experiencing heavy rains and floods. Fortyfour people were killed and nine went missing in raintriggered floods in Beijing two weeks ago. The dead included 31 people from a nursing home in the Miyun district of Beijing. (PTI)

#### Trust in Zelenskyy is diminished even after reversal of law that fuelled anti-corruption protests

KYIV, Aug 8: Ukrainian President Volodymyr Zelenskyy quickly reversed course last month on a law that would have curbed the independence of the country's anti-corruption watchdogs after widespread protests that threatened the stability of his leadership for the first time since Russia's inva-

It's unlikely that the damage to the president's image can be changed as easily. Zelenskyy's reversal followed years of public discontent that simmered around his inner circle, some of whom have been accused of corruption. But Ukrainians have been largely deferential toward their president in wartime, trusting him to lead the fight against the Kremlin and even acquiescing in the suspension of some civil liberties. The protests showed the limits of that goodwill after the public concluded that Zelenskyy's fast-tracking of the law was a step too far.

"People will support Zelenskyy in whatever he does as it relates to the war. But the previous level of trust "that he will carry out everything correctly, without outside interests, has been damaged," said Tetiana Shevchuk, a board member of the Ukrainian nonprofit Anti-Corruption Action Centre, which fights graft. Zelenskyy "will need

to work hard to get it back." A Gallup poll released Thursday found that about two-thirds of Ukrainians approve of the way Zelenskyy is handling his job as president, down from 84 per cent in 2022. Another poll released Wednesday by the Kyiv International Institute of Sociology found a similar pattern, with trust in Zelenskyy down from just before the war started and a sharp decrease

since after the signing of the law. Both polls were conducted in July and excluded adults living in regions of the country that were not controlled by Ukraine or were under entrenched Russian control.

The initial decision to sign the proposal hurt Zelenskyy's standing among Ukrainians, loyal lawmakers and Western allies, including one foreign minister who told The Associated Press that his willingness to backtrack on the law would help restore "lost trust."

Zelenskyy says bill was designed to root out Russian influ-

Zelenskyy sparked the outcry when he signed measures to reduce the powers of the National Anti-Corruption Bureau, or NABU, and the Specialised Anti-Corruption Prosecutor's Office, or SAPO.

Zelenskyy said the initial bill was meant to root out Russian influence in those agencies, but he did not provide evidence to support the claim. The bill became a law so quickly that lawmakers said they barely had time to read it. For the Ukrainian people, patience

From the outset of Russia's fullscale invasion in 2022, the public tolerated restrictions such as martial law and postponed elections. But critics also argued that the consolidation of the president's authority undermined the country's democratic institutions, along with the checks and balances necessary for transparency. Members of Zelenskyy's inner circle and the corruption allegations fuelled public

The resulting anti-corruption protests in July in Kyiv and other cities were among the largest in years, drawing thousands of demonstrators and reflecting widespread public demand for transparency and accountability even during wartime.

"It's not one law that brought people to the streets, but a series of events and mostly an accumulation of feelings and wanting to show the government there are certain red lines," Shevchuk said.

Ukrainian leaders have been sensitive to public opinion ever since the Euromaidan protests of 2013 and 2014, which ignited extraordinary political changes, including the ousting of pro-Russia President Viktor Yanukovych. Those protests marked a decisive moment in Ukraine's history and galvanised public intolerance toward corruption and abuse of

Until recently, Zelenskyy's decisions and public statements aligned mostly with public opinion. He watches polls closely. For instance, he did not say that Ukraine would be unable to win back occupied territory militarily until polls showed that Ukrainians were willing to end the war for ter-

### Israel's Security Cabinet approves plan to take military control of Gaza

JERUSALEM, Aug 8: Israel's Security Cabinet has approved Prime Minister Benjamin Netanyahu's plan to take military control of Gaza City as part of a five-point aim primarily to 'disarm" Hamas, a decision that triggered fears of further escalation in the nearly two-year war in the enclave.

The controversial decision to take control of Gaza City came amid massive anti-government protests across Israel demanding an immediate end to the war and ensuring immediate return of over 50 hostages held captive by Hamas for the last 22 months.

"A decisive majority of Security Cabinet ministers believed that the alternative plan that had been submitted to the Security Cabinet would neither achieve the defeat of Hamas nor the return of the hostages," Netanyahu's office said. It is not immediately clear what the alternative plan was.

The plan cleared by the Security Cabinet featured five principles.

These are: disarming of Hamas, re-

sation of Gaza, Israeli security control in Gaza and establishment of a civil administration that is neither Hamas nor the Palestinian Authority

Netanyahu's office said the Israeli Defence Forces (IDF) will prepare for taking control of Gaza City while distributing humanitarian assistance to the civilian population outside the

Earlier, Israeli Armed Forces' Chief of Staff, Lt Gen Eyal Zamir, cautioned against full military conquest of Gaza City and said it would be a trap". Israel launched the war in Gaza after Hamas attacked Israeli cities on October 7, 2023 killing about 1,200 people. Hamas also took 251 people as hostages and over 50 of them are still in its captivity.

Israeli military operations have killed over 60,000 Palestinians since then, according to Gaza's Hamas-run health ministry.

Gaza has been reeling under a massive humanitarian crisis largely due to scarcity of food and medicines. The

World Health Organisation said last month that Gaza's malnutrition rates have reached "alarming levels".

Ahead of the Security Cabinet meeting, Netanyahu told a group of visiting Indian journalists that Israel doesn't want to annex or occupy Gaza and its sole aim is to destroy Hamas and hand over the strip to a transitional government. The prime minister also said that Israel wants to take control of Gaza's security.

Asked about the food crisis in Gaza, Netanyahu said over two million tonnes of food were sent to Israel, but the supplies were "interdicted".

"Our plan is not to occupy or annex Gaza. Our goal is to destroy Hamas and get our hostages back, and then handover Gaza to a transitory government," Netanyahu said.

The Israeli Security Cabinet's decision drew sharp reactions from families of the hostages as they feared that taking control of Gaza City would further delay the possibility of the release of the hostages. (PTI)

#### Israeli airstrike kills Palestinian official, bodyguard in east Lebanon

BEIRUT, Aug 8: An Israeli airstrike on eastern Lebanon killed a number of people, including a senior member of a Palestinian group and his bodyguard as they were on their way to Syria, news reports and his group said Friday.

The airstrike near the Lebanese border crossing of Masnaa on Thursday afternoon killed Mohammed Wishah, a member of the central committee of the Popular Front for the Liberation of Palestine, or PFLP, the group said in a statement. The Israeli army confirmed the airstrike, saying that Wishah was responsible for coordinating with other militant groups in the region and strengthening ties between the PFLP and Iran's socalled axis of resistance.

The military said that Wishah was advancing attacks against Israel and took his job as the PFLP's top security official in Syria after his predecessor was killed in an airstrike in Beirut in September. In a post on social media, senior

PFLP official Marwan Abdel-Al mourned the death of Wishah and his bodyguard, Mufid Hussein. "We have lost two of the most

loyal comrades who gave their precious souls to freedom," Abdel-Al wrote. Lebanon's state-run National News Agency, or NNA, said that the airstrike on east Lebanon killed six people and wounded 10 others, without identifying the victims.

began in October 2023, Israel has targeted Palestinian officials in Lebanon, including PFLP members. Three FPLP members were killed in an airstrike on a Beirut apartment in September.

A FPLP official said that Wishah had been in Lebanon to meet with other officials with the group and was on his way back to Syria when the airstrike happened. The official, who wasn't authorised to speak with the media, spoke on condition of anonymity. The PFLP statement said Wishah was born in the Gaza Strip in 1954 and spent five years in Israeli jails shortly after he joined the Palestinian group in 1973. #### Abbas' Fatah group. (AP) Imposition of additional duty on India 'national security issue': White House trade adviser

NEW YORK/WASHINGTON, Aug 8: The imposition of an additional 25 per cent duty on India is a "national security issue" associated with New Delhi's "abject refusal to stop buying Russian oil", White House Trade Adviser Peter Navarro has said.

Last week, US President Donald Trump had announced 25 per cent reciprocal tariffs on India that came into effect from August 7.

The US president on Wednesday also signed an executive order slapping an additional 25 per cent levy on India for New Delhi's purchases of Russian oil, bringing the total duties to 50 per cent, among the highest imposed by the US on any country in the world.

Navarro, while talking to reporters at the White House on Wednesday, said it is important to understand that the "rationale for the India tariffs is very different from the reciprocal tariffs".

'This was a pure national security issue associated with India's abject refusal to stop buying Russian oil," he said, and added that



"every American needs to understand the math of this because it is

related to the trade situation". 'You start with the fact that India is the 'maharaja' of tariffs, it's the highest tariffs in the world charging on American products and it's got a high non-tariff barrier so we can't get our products in," he

The US sends a lot of dollars overseas to India to buy their products in an "unfair trade environment", he claimed.

India," Navarro said.

"India then uses American dollars to buy Russian oil. Russia then uses those American dollars that come from India to finance its armaments, to kill Ukrainians, and American taxpayers are then called upon to pay for the weapons that have to defend Ukraine against Russian armaments paid for by American dollars that came from

He said that it has "got to stop".

'That math does not work. The president understands the connection between economic security and national security so that was the bottom line there," he added.

Navarro was asked why China, which buys more Russian oil than India does, has not been targeted the way Delhi has been with the doubling of its tariffs. "As the boss says, let's see what

happens. Keep in mind that we have over 50 per cent tariffs on China already...so we don't want to get to a point where we actually hurt ourselves," he said.

"The president certainly will be working with China on that issue,' he added.

Meanwhile, White House Homeland Security Adviser Stephen Miller said, "It probably surprised people to know that India is one of the largest purchasers in the world of Russian oil and they could easily access oil from many other markets around the world.'

"They are one of the largest funders of Russia's army for that reason," he claimed. (PTI)

### Arunachal Cabinet clears youth policy, welfare expansion, recruitment reforms

Approvals include disability pension relaxations, higher education boost, and updated service rules across key departments

ITANAGAR, Aug 8: The Arunachal Pradesh State Cabinet, chaired by Chief Minister Pema Khandu, has approved a series of far-reaching decisions aimed at empowering youth, expanding the social security net, strengthening education, and reforming recruitment procedures across various departments, according to an official statement.

A major highlight of the meeting was the approval of the Arunachal Pradesh State Youth Policy 2025, described as a pivotal step towards holistic youth de-

The policy sets out nine Youth Development Goals focusing on quality education, sustainable employment, entrepreneurship, innovation, skill enhancement, healthy lifestyles, youth leadership, civic engagement, arts, culture, sports, promotion of biodiversity, and building an inclusive and just soci-

The government said the policy

would follow a collaborative approach involving departments, NGOs, community-based organisations and youth bodies, with the goal of transforming Arunachal into a hub for sports, adventure activities, and cultural preservation.

In a significant welfare measure, the Cabinet approved relaxations in the Chief Minister Disability Pension eligibility criteria under the Chief Minister Social Security Scheme.

The age limit has been removed, making all persons with disabilities eligible regardless of age, compared to the earlier threshold of three years and above.

The required disability percentage has also been reduced from 70 per cent to 40 per cent, while other conditions remain unchanged

The government said the move is intended to provide broader coverage and support to the Divyangjan community in

For the education sector, the Cabinet cleared the creation of 18 new posts in



the science stream at Donyi Polo Government College, Kamki, including 10 assistant professors, four laboratory assistants and four multi-tasking staff.

It also approved the creation of five new principal posts for government colleges at Geku, Basar, Palin, Roing and Tawang, as part of efforts to strengthen higher education infrastructure Recruitment rules in several depart-

ments have also been updated. In the Animal Husbandry Department, the rules for the posts of stockman and laboratory assistant have been revised to include updated age criteria, reeducational qualifications, streamlined selection procedures and a reconstituted Departmental Promotion Committee.

In another change, the outdated 1999 recruitment rules for statistical inspectors and marketing inspectors have been replaced with the Agriculture Statistical Inspector Group-C Recruitment Rules, 2024, enabling direct recruitment of fresh statistical graduates.

The Department of Environment, Forest and Climate Change has also seen amendments in the Arunachal Pradesh Forest Service Rules, 2019 for Group-A gazetted officers and the Range Forest Officer Recruitment Rules, 2019 for Group-B gazetted officers.

The government said these changes reflect its commitment to effective governance and environmental protection. The Cabinet further approved the

Arunachal Pradesh Arun Parivar Patra Authority Rules 2025 to standardise procedures and ensure operational clarty for all stakeholders.

These rules are expected to improve enforcement of data protection and consent norms while maintaining public trust in the fairness and transparency of

During the meeting, the Cabinet was also briefed on the upcoming inauguration of the new Gauhati High Court, Itanagar Permanent Bench building on August 10, 2025.

The government described the new facility as a milestone in providing swift and seamless justice delivery to the people of the state.

According to the statement, these collective decisions reaffirm the state government's commitment to inclusive governance, youth empowerment, academic excellence, social welfare expansion, and transparent administrative

### Arunachal Pradesh opens patient guest house in Vellore

ITANAGAR, Aug 8: Chief Minister Pema Khandu on Friday virtually inaugurated the Arunachal Pradesh Patients' Guest House in Vellore, Tamil Nadu, to provide affordable accommodation for residents of the state seeking treatment at the Christian Medical College (CMC) Vellore, according to an official statement.

The facility has been developed to ease the accommodation challenges faced by patients and attendants who travel to Vellore for specialised medical care.

Official data shows that around 466 patients from Arunachal Pradesh visit CMC every month, with the annual number exceeding

### DU issues guidelines to curb defacement ahead of DUSU polls

**NEW DELHI, Aug 8:** The University of Delhi on Friday issued guidelines for the upcoming DUSU polls, mandating a bond of ₹ 1 lakh from candidates and banning the use of posters, wall writing, rallies, loudspeakers, and roadshows on the varsity campus.

The move comes nearly a year after the Delhi Court criticised the university over defacement of the campus during the students' union elections and stalled the results until defacement material, including posters, hoardings, and graffiti, was removed from public property.

The advisory was issued by DU Registrar Vikas Gupta, calling for strict compliance from students, colleges, and university departments. It is based on various legal provisions, court orders, and recommendations of the Lyngdoh Committee.

Speaking on the guideline, DUSU president Ronak Khatri said, "The guideline is not suitable for students, as someone from a lower-income background may not be able to afford the ₹ 1 lakh bond required for nomination, which could prevent them from participating despite their willingness."

To discourage defacement, the University has mandated that every contesting candidate submit a bond of ₹ 1 lakh while filing nominations. This amount will be liable for forfeiture if the candidate or their supporters are found violating defacement norms, it added.

In a bid to sensitise students early on, the University has proposed introducing an "anti-defacement affidavit," similar to the anti-ragging affidavit, to be submitted at the time of admission.

According to the guidelines, colleges and departments have been directed to conduct awareness programmes to encourage students to maintain decorum on campus during the election season.

Colleges should promote and organise debates for candidates contesting the student elections, which may be uploaded on the respective websites, the guidelines read.

Colleges have also been asked to increase the size of the "walls of democracy" at two locations dedicated to putting up poll-related material, it stated. Outside these designated areas, the use of posters, wall writing, rallies, loudspeakers, and roadshows has been strictly prohibited, it added.

As per the guidelines, candidates have also been instructed to immediately remove any unauthorised posters, especially those with misspelt names aimed at evading accountability, and report such instances to the nearest police station within 24 hours.

"Failing to do so may invite a fine of ₹ 25,000, suspension, rustication, or even disqualification from contesting elections," it

It further mentioned that a dedicated portal to report defacement and raise awareness on related issues will also be launched by the University and affiliated colleges.

Use of electronic media for campaigning is allowed, and colleges have been encouraged to host debates between candidates, which may be uploaded on official websites for wider viewing, the guidelines said. The University has made it clear that the use of dhols, loudspeakers, and similar equipment is hanned in and around campus premises, even after the elections are over. Additionally, entry of outsiders has been restricted, and colleges have been asked to consider installing biometric or facial recognition systems for access control.

"A committee at both college and university levels will be set up to monitor defacement and implement preventive steps. Details of these committees will be displayed on notice boards and websites," it

### 650 rescued in Uttarkashi, Army builds bridge over river to speed up evacuation

UTTARKASHI, Aug 8: Sniffer dogs nosed their way through high piles of rubble, drones circled overhead and rescue personnel searched for the missing through the sludge in disaster-hit Dharali on Friday, four days after raging tion with my friend President waters buried half the village and left scores missing.

Since Tuesday, 650 people have been rescued, 400 Thursday and 250 on Friday, Chief Minister Pushkar Singh Dhami said, adding the rest will also be evacuated

Communication lines were restored on Friday in the disaster-hit areas of Uttarkashi after remaining disrupted for three days with authorities hoping it will help in pacing up rescue operations.

"Internet connectivity has been restored. Airtel has begun to function in the affected area. It will speed up rescue operations," Dhami told reporters after returning from Dharali.

However, roads are still blocked or broken between Dharali, Harsil and Uttarkashi and power supply has been badly hit, he said.

He said a generator set has been brought to Uttarkashi to be flown to the affected area.

'The situation is of course difficult but we are trying to bring things back on track at the earliest," the chief minister, who camped here for the last three days to keep a close eye on the rescue operations, said.

Construction of a bailley bridge over Lincha Gad near Gangnani has also been started after the collapse of a bridge there, he said.

were killed in the flash floods. Two bodies were recovered on Wednesday. The Uttarakhand State Disaster

Management Authority (USDMA) said 16 people, including nine Army personnel and seven civilians, are missing.

According to residents of nearby villages, like Mukhba, who witnessed the disaster, the number of missing is likely to be higher as locals and labourers from Bihar and Nepal were working at underconstruction hotels and there were guests in about two dozen big hotels in Dharali when the disaster

Dharali is the main stopover on the way to Gangotri, from where



the Ganga originates, abounding in hotels, homestays, restaurants and guest houses.

The USDMA said more than 800 rescue personnel drawn from the Army, Indo-Tibetan Border Police (ITBP), National Disaster Response Force (NDRF) and State Disaster Response Force (SDRF) and police are engaged in the rescue operations on the ground.

Sniffer dogs and radars are being used to search for survivors and detect bodies buried under the huge mounds of debris.

The ITBP airlifted people stranded in Harsil, with some of the injured being carried into hel-

icopters on stretchers. To speed up rescue operations, the Army built a bridge over the

Bhagirathi river in the district. "Today we have established a bridge over the Bhagirathi river, using which the injured and stranded tourists are being evacu-

ated safely," an Army official said. To help people contact their family members, the Army activated its communication networks, including satellite and radio relay systems.

Many of those rescued made brief calls to their family members, letting them know they were

Lt Gen D G Mishra said efforts are on to get the stranded tourists out of Gangotri.

'With the aid of the civil administration, civil helicopters and the Indian Air Force, we have been able to pull out approximately 355 people from Harsil to Matli, south of Uttarkashi, from where the Uttarkhand government is sending them down to Dehradun," he said.

"Our present focus remains on ensuring that we have road connectivity between Uttarkashi, Harsil and Dharali. Secondly, we are also trying to get mobile connectivity and electricity to the villagers north of Harsil, which is an immediate necessity," he said. Lt Gen Mishra said the Army

has moved in medical supplies and deployed its resources. "All people who have been af-

fected by this incident are being provided medical assistance," he

Advanced equipment required to dredge through the debris in Dharali to search for the missing is being flown to the spot in heli-

Two Chinook helicopters, two Mi-17s of the Indian Air Force and eight choppers of the Uttarakhand Civil Aviation Development Authority have been deployed.

Rummaging through the debris is an uphill task as the rubble heaps are 50-60 feet high at several places.

With roads breached at various points, the thrust is on air support both for the evacuation of the stranded people and transporting food supplies and other essentials to the affected areas, an NDRF official said.

Dhami reached Dharali and interacted with locals and NDRF personnel in the village.

Earlier in the day, he met ITBP DG, NDRF DG, Uttarakhand Police DGP and other officials to take stock of relief and rescue operations. Necessary guidelines have been given to the officials on the restoration of roads, communication, electricity and food supply, Dhami said in a Face-

He also announced that he will contribute a month's salary towards disaster relief operations in Uttarkashi and appealed to public representatives, officials, voluntary organisations and common citizens to make their contributions to the ongoing relief work in the disaster-hit areas of the district. ### **GST** ignores Manipur's realities, says state **Congress chief Keisham Meghachandra**

IMPHAL, Aug 8: Manipur Conpresident Keisham Meghachandra on Friday said the Goods and Services Tax (GST) regime poses significant challenges for the state as its economic and infrastructural conditions differ vastly from the rest of the coun-

In a post on X, Keisham said, "GST — A One-Nation Tax That Overlooks Manipur's Unique Realities. Manipur is likely to face grave difficulties following the passage of the amendment to the State GST in Parliament yester-

day."
"The GST regime has posed significant challenges for states like Manipur, whose economic and infrastructural conditions differ vastly from mainland India," he

Keisham continued, "As we assess the impact eight years on, it is evident that the 'one-size-fits-all' approach of GST does not serve the interests of small, landlocked. and socio-economically fragile



Keisham explained that "GST stripped states of the power to levy independent taxes like VAT or entry tax. For a state like Manipur, this means a loss of financial flexibility at a time when local needs demand tailored economic policy."

The Wangjing constituency MLA further claimed that local industries, artisans, and farmers many of whom earlier benefited burdened by uniform GST slabs and items like handloom products, bamboo crafts, and small-scale goods now fall under taxable categories, raising prices and reducing

competitiveness Asserting that GST is an onlinebased system, Keisham argued that "many parts of Manipur still struggle with digital infrastructure and small traders, shopkeepers, and rural entrepreneurs are unable to comply due to poor internet connectivity and limited digital liter-

He urged the central government and the GST council to review and amend the GST framework with a region-sensitive lens, restore fiscal space for small states, ensure timely compensation payments, introduce simplified compliance mechanisms for small traders and create differential tax slabs for economically backward and geographically isolated states like

"It is time the voice of Manipur is heard in the GST debate," he added. (PTI)

### Union cabinet announces ₹250 crore special package for development of Tripura tribals: CM

AGARTALA, Aug 8: Tripura Chief Minister Manik Saha on Friday said the Union cabinet announced a Rs 250 crore special development package for tribals of Tripura following an agreement with two outlawed groups of the state.

Saha said that the funds will be used for improving the socio-economic condition of vulnerable and marginalised groups of people who have not benefited adequately from various existing government schemes.

'The Union Cabinet chaired by PM Narendra Modi Ji announced a new component under the existing central government scheme of special development package for Tripura", he wrote in a post on

Saha said, "Rs 250 crore for development of tribals of the state as per the MoS signed by the Centre and state government with the National Liberation Front of Twipra (NLFT) and All Tripura Tiger Force

The two outlawed groups - NLFT and ATTF - have signed a Memorandum of Settlement (MoS) with the Centre and the state government on September 4 last year for lasting peace in the northeastern state, which had witnessed bloodshed in the late 1990s.

As part of the MoS, as many as 584 insurgents and their followers surrendered before the CM at Jampaijala in Sepahijala district on September 24.

With the surrender of militants, the chief minister and the then DGP Amitabh Ranjan had declared the northeastern state as terrorist free.

"The special package will boost employment opportunities, provide health services, promote education and skilling and income through livelihood activities for youth and women," the chief minister

Saha added, "The outlay will increase inflow of tourists from other parts of the country, thereby creating additional employment and livelihood opportunities for the people of the northeastern region". (PTI)

### Exhibition in Kohima seeks to capture multifaceted history of education in NE

He also paid tribute to the early Christian missionaries, acknowledging their selfless service in bringing education to the Naga Hills when few dared to venture into the region.

Director general of the National Archives of India Samar Nanda said preserving culture is key to understanding and shaping the fu-

He explained that the current exhibition highlights the journey of education in Northeast India, particularly in Nagaland.

"There is no end to learning; we must continue to adapt to the evolving changes around us," he said. The exhibition, he added, offers a valuable glimpse into how education has transformed across India

#### Tripura CM sanctions over ₹ 87 cr for road construction, repair works ahead of Durga Puja

### Mizoram: Lunglei's maternal, child health initiative earns national recognition

AIZAWL, Aug 8: Mizoram's Lunglei district administration has earned national recognition for its flagship maternal and child health initiative, Project Bloom, officials said on Fri-

Under the theme "Transforming Health: Breakthrough Interventions", Lunglei Deputy Commissioner Navneet Mann presented 'Project Bloom (Better Living through Outreach, Optimal Maternal and Child Health)' as one of the 19 selected best practices at a programme in New Delhi on Thursday.

The 'Best Practices Seminar', organised by NITI Aayog, celebrated successful interventions from 329 aspirational districts and 500 aspirational blocks across the country, the officials

Launched on June 17 this year, the scheme addresses maternal and child health challenges in the Lungsen aspirational block in Lunglei, they said. The region, with its difficult terrain,

high logistical costs, limited internet



been struggling with low health indicators, they said.

The programme aims to close these gaps through a community-driven, convergence-based approach that integrates health, nutrition, transport and behaviour change, they said.

"Under this project, an on-call transport service, prioritising high-risk pregnancies and ensuring referrals to the district hospital, was undertaken, and 12 temporary homestays near de-

livery points, hosted by villagers, were set up to offer accommodation and support until delivery," an official said. House-to-house surveys were conducted to identify pregnant women

and malnourished children, he said. Incentives were given to promote early antenatal care (ANC) registration and institutional deliveries, including nutrition and hygiene kits, another official said.

Other key interventions of the project were immunisation drives with a focus on reaching villages, high-risk pregnancy tracking, capacity-building for accredited social health activists (ASHAs), Aanganwadi and health

According to the officials, the project has brought about a significant transformation in the maternal and child health sector in Lungsen block. They said that institutional deliver-

ies increased from 14.73 per cent in March 2023 to 43.14 per cent in March 2025, and surged to 72.2 per cent by

June-July 2025, crossing the 70 per cent mark for the first time. Early ANC registration improved

The actor-filmmaker spends hours in making sure he's up with the news. And not surprisingly, the filmography has undergone a dramatic change. So the list now includes films that marry commerce with stories about hot button issues and how they impact India, be it "Madras Cafe", "Parmanu", "The Diplomat" or his upcoming film "Tehran"

"It's important now to build a legacy around the kind of films I'm doing and to be known for them... Earlier, I didn't understand what the audience felt about me because we're insulated most of the times. But when I travel and meet people, they say, 'Oh, John we love The Diplomat. Oh, we love Madras Cafe.' That's when you realise you've slowly started creating a story for yourself," Abraham told PTI in an

The conversation is peppered with talk about Donald Trump, tariffs, Palestine, Israel and Russia-Ukraine.

He wants his audiences to associate him with sensible cinema, the kind that inspired him to get into movies. He remembers the moment it happened -when he watched Steven Spielberg's 1993 Holocaust drama "Schindler's

"I'm not lying, I was affected for days... And because that impacted me so much, I decided that when I become a producer, or when I get into films these are the kind of films I want to do," he said.

"It is challenging for us. But it's something that we need in today's time, like how a father-daughter, mother-daughter relationship should be. The love story is also different. There are ups and downs, and we see a relationship from a mature perspective," he said. brewing in his mind for a while. "Marriage is such a relevant and debatable subject today, and the values that we have carried for 25-30 years, it's all different today. "When I saw all this from their point of view, I felt that a story should be made on this. in which we can say something to society about what I've learned and experienced," he said.

# No Basanti or Radha, we just had two armymen and a dacoit in mind: Javed Akhtar on 'Sholay'

MUMBAI, Aug 8: There was no Basanti or Radha to begin with and Jai and Veeru started off as former army men sacked for indiscipline. And that's how the story of "Sholay" first took root in the minds of Salim Khan and Javed

At that point, the two ace screenwriters had only a dacoit in mind, Akhtar told PTI as he looked back at 50 years of the cult classic. "It was Salim sahab's idea that we should make a film about a retired major and two recruits from the army who have been removed because of indiscipline so the story was about them. But then we had limitations from the army and we couldn't take liberty, hence we changed the characters to a cop and (two) hoodlums," he said.

"At that point, we didn't think of Basanti or Radha, we just had a dacoit in mind. But gradually when the story got developed a lot of characters came into the picture and we felt it could be a great multi-starrer. We did not plan it as a multi-starrer, and a grand spectacle," he added ahead of the 50th anniversary of the film.

"Sholay", directed by Ramesh Sippy and featuring an ensemble cast includ-

ing Amitabh Bachchan, Dharmendra, Sanjeev Kumar, Amjad Khan, Jaya Bachchan and Hema Malini, released on August 15, 1975. It failed initially and picked up as the weeks went by.

Salim-Javed had no inkling they were making a "timeless" Hindi cinema classic, Akhtar said.

Be it dialogues, the friendship between Amitabh Bachchan's Jai and Dharmendra's Veeru, Sanjeev Kumar's vengeful turn as Thakur or Amjad Khan's portrayal of the dreaded dacoit Gabbar Singh who went on to redefine the Hindi film villain, "Sholay" has stayed at the top of the pop culture charts—for five decades and counting.

"I believe the canvas of the film was such that it just became timeless; it was not done intentionally. There was no deliberate attempt to do that (make it timeless)."

"It had a sargam of human emotions, whether it is vendetta, spoken or unspoken love, friendship, simplicity of the village, smartness of two urban hoodlums. It was a symphony of all human emotions." The film just happened, said Akhtar. There was no conscious effort.

"Any product of art which is relevant

in their own times and in the other times, and has timeless quality to it, irrespective of the changes in the industry over the years, that piece of art

remains relevant," the 80-year-old said. The year 1975 is often celebrated as a landmark period in Indian cinema, with "Sholay" along with other classics like "Deewar", also penned by Salim-Javed, and "Aandhi" redefining story-

telling in Hindi cinema. Akhtar said the year changed his and Salim Khan's lives, both personally and professionally.

"With the release of 'Deewar' and 'Sholay', we earned money, garnered recognition, and made a name for ourselves. So the year 1975 was an important year," he said.

The film's cast also includes Sachin Pilgaonkar as Ahmed, Asrani as Jailer, AK Hangal as Imam Saheb, Mac Mohan as Sambha, Jagdeep as Surma Bhopali and Viju Khote as Kalia

among others. If he were to rewrite "Sholay" today, is there anything he would do differently?

"I would not change anything in 'Sholay'. I would never rewrite 'Sholay'. We made it the way it is. I'm

glad so many people appreciated the film, and still talk about it with fondness," Akhtar said.

In June, a restored version of "Sholay" featuring six minutes of extra footage, including its original ending where Gabbar is killed by Thakur, was screened at an international film festival in Italy.

The restoration process was spearheaded by Film Heritage Foundation and Sippy Films Pvt Ltd and took more than three years.

In the original version of the movie, Sanjeev Kumar's Thakur extracts his revenge by killing Gabbar in the final moments. This was changed by the censor board during the Emergency. In the released version, Thakur walks away from an injured Gabbar as cops swoop in to arrest him.

"At that time, I was unhappy and disappointed that the ending was being changed but we had no choice but to do it," Akhtar said.

And what would Jai and Veeru be doing if they were in 2025?

'They would be in the corporate world. They are so badmaash. Where else would they go?" was Akhtar's prompt answer. (PTI)

### Ben Shelton rallies to beat Karen Khachanov in Toronto final

TORONTO, Aug 8: Ben Shelton won the National Bank Open for the third and biggest title of his young career, rallying to beat 11th -seeded Karen Khachanov of Russia 6-7 (5), 6-4, 7-6 (3).

The 22-year-old Shelton, seeded fourth, became the first American winner in the Masters 1000 hard-court event since Andy Roddick in 2003. Shelton also won on hard courts in Tokyo in 2023 and on clay in Houston last

"It's a surreal feeling," Shelton said. "It's been a long week, not an easy path to the final. My best tennis came out when it mattered most. I was clutch, I persevered, I was resilient. All the qualities I like to see in myself."

Shelton will move up a spot to a career-high sixth in the world. He beat Khachanov a night after topping second-seeded Taylor Fritz 6-4, 6-3 in an all-American semifinal match.

"I feel like it was a perfect storm for me this week," Shelton said. "A lot of tight matches and long matches. I played some of the best tennis that I've played this year.'

The winner had seven of his 16 aces in the third set, and ended the match by winning 14 consecutive points on serve. He held at love to force the final-set tiebreaker.

"He went for his shots, trusted the work that he's put in and he executed," said Bryan Shelton, his father and coach.

"Sometimes you do and sometimes you don't. But it's always nice when you can leave a tournament and hold a trophy up in your hands because it's rare.

The 29-year-old Khachanov has seven career victories — all on hard courts.

In the semifinals, he survived a match point in another third-set tiebreaker against top-seeded Alexander Zverev.

"It's a positive, a great tournament, a great run," Khachanov said. "I had some great battles and great wins against top guys."

He said, "I just felt really in rhythm. The course sets up well for my game, and once I made that eagle, everything clicked. I wasn't trying to chase anything — I just stuck to my process and got into a great zone.

Bhatia had seven birdies, one eagle, and one bogey and it was a personal best on the PGA Tour. It sets him up with a great chance to not only win his first playoff event, but also move into contention for the FedEx Cup. Indo-British Aaron Rai shot an even par 70 with two birdies and two bogeys. He was tied 39th. He is currently 55th and needs to be inside Top-50

to play the next event. Meanwhile, one shot behind Bhatia was Tommy Fleetwood, who shot a 7-under 63 that included a four-birdie run to close his round. The Englishman has been in great form this season, but he's still seeking his first PGA Tour
