ED raids premises of ex-IAS officer Sewali Sharma, others

₹105-cr SCERT 'fraud' case in Assam: Raids conducted under PMLA

GUWAHATI, Aug 5: The Enforcement Directorate (ED) on Tuesday carried out searches against retired IAS officer Sewali Devi Sharma and others in an alleged ₹ 105 crore scam in the Assam State Council of Educational Research and Training (SCERT).

At least eight premises connected with Sharma, a former executive chairman-cum-director of the SCERT, and some of her alleged associates were raided under the provisions of the Prevention of Money Laundering Act (PMLA), the sources said.

The money laundering case stems from a May 2023 FIR filed by the state police on the directions of the Assam CM's Special Vigilance Cell. She was arrested by the state police from Rajasthan a few days after filing of the complaint.

Sharma was subsequently chargesheeted by police for alleged possession of disproportionate assets worth ₹ 5.7 crore, according to

The 1992-batch Indian Administrative Service (IAS) officer hailed from the Rajasthan cadre and was on deputation to Assam when alleged irregularities worth ₹ 105 crore took place during her tenure in the SCERT between 2017 and

Sharma, the sources claimed, opened five bank accounts for the ODL Cell, where she was the "sole signatory" and this was in "violation" of government rules.

Of the ₹ 115 crore she received in fees from individuals, she allegedly spent more than ₹ 105 crore without obtaining financial sanction from the state government, the sources alleged.

The expenditure was incurred for supplies and execution of works without following the rules and procedures and payments were released without complete supply of materials, and no work was done, they claimed.

Guv Satyapal Flashflood havoc in Malik passes away U'khand post cloudburst



UTTARKASHI, Aug 5: Disaster swept through the Himalayan village of Dharali on way to Gangotri on Tuesday with a massive cloudburst leading to flashfloods that barrelled through homes, trees and cars, trapping 60-70 people and leaving at least four dead.

Dharali is the main stopover on way to Gangotri, the origin of the Ganges, and home to many hotels, restaurants and home stays.

At least half the village was buried under the fast flowing mudslide of slush, rubble and water, officials said as rescue personnel battled the elements in the ecologically fragile heights to contain the damage of the afternoon.

Contiguous buildings, including

like a pack of cards as the surging waters washed over them. The devastating flashflood came in the wake of a cloudburst somewhere in the catchment area of the Kheer Ganga river.

AK-47 recovered

BOKAJAN: An AK-47 assault rifle along with six rounds of ammunition was recovered by villagers from the roadside at Lahorijan Kania Tokbi village on August 4. The villagers immediately informed the police, who took possession of the weapon. The village, located near the Assam-Nagaland border adjacent to Dimapur, lies close to National Highway 39—an area known for frequent instances of drug trafficking and gun running. Narcotics such as heroin, brown sugar, methamphetamine, and morphine are often smuggled through this corridor, along with illegal arms and foreign goods. The same route is also reportedly used for transporting stolen motorcycles, commercial vehicles, earthmovers, dumper trucks, and luxury cars into Dimapur.

NEW DELHI, Aug 5: Parliament on Tuesday approved a statutory resolution to extend President's Rule in Manipur for another six months beyond August 13.

The resolution, which was passed by the Lok Sabha last week, was approved by the Rajya Sabha, amid ruckus over electoral rolls revision issue in Bihar.

Amid protests by Opposition

MPs. Chair Harivansh said it was a "constitutional obligation" to pass the resolution.

GUWAHATI, Aug 5: Chief Minister Himanta Biswa Sarma on Tuesday said that due to the BJP's efforts, peace has been firmly established in the Bodoland Territorial

Region (BTR).

The turnaround in the BTR from violence to peace has been 'our single biggest achievement', the chief minister, who is holding meetings for the forthcoming council polls in different parts of the region since Sunday, said.

India-UK trade deal: India eyes three-fold surge in seafood exports

AHMEDABAD, Aug 5: Seafood exports from India to the United Kingdom would witness a threefold jump in the coming years after the removal of duty on fisheries products under the India-UK free trade agreement, according to industry leaders.

Since Gujarat, having a coastline of nearly 2,300 kilometers, is one of the key states contributing to India's seafood exports, industry leaders believe that the increase in India's exports will also help Gujarat-based fishermen, exports and the entire ecosystem attached with this industry. Gujarat-based exporter Jagdish Fofandi said the relief in export duty would take India's seafood export to the UK from current levels of ₹1,000 crore to nearly ₹3,000 crore in three years

At present, the UK levies 8.9 per cent export duty on Indian seafood products such as fish and shrimp, said Fofandi, former national president of Seafood Exporters Association of India (SEAI). "Now, after the signing of the trade agreement, there will be zero duty on such products exported to the UK from India. The UK imports seafood worth USD 5.4 billion from across the world every year.

"However, India's share in this



comes to ₹ 1,000 crore at present," said Fofandi. With the reduction in the duty, Indian seafood items will be cheaper by nearly 8 to 9 per cent for the buyers in the UK, making Indian products more competitive in comparison to other countries, said Fofandi, former vice president of Marine Products Export Development Authority (MPEDA).

"We are assuming that in the next three years, there is a potential growth of 300 per cent. Thus, I am seeing that our export will go up from the current level of ₹ 1,000 crore to ₹3,000 crore. Since Gujarat is a major contributing state, this new market will certainly benefit our fishermen, exporters and

everyone associated with this business," said Fofandi. Shrimp constitutes 70 per cent of the total export basket of Indian seafood. However, it is facing stress from US and other

markets at present, said Fofandi.

"Opening up of the UK market due to this trade deal, it will absorb some of the shock which other markets are creating to Indian exporters. This will particularly help the shrimp farming industry of south Gujarat," said Fofandi. While south Gujarat is more into shrimp farming, the coastline of Saurashtra region contributes in exporting fish caught from the sea, said Fofandi, adding that some varieties of fish

Chinese settled in the UK.

According to Ketan Suyani, Gujarat-based regional president of SEAI, this trade agreement will eventually help fishermen in getting better prices for the catch.

At present, Gujarat's fisheries export is roughly around ₹ 5,000 crore. Of these, entire Europe accounts for nearly 40 per cent while the remaining 60 per cent goes to the Gulf, China and other Far-east countries, said Suyani.

"This trade agreement will eventually benefit Gujarat fishermen because the demand for Indian seafood products will increase after the duty reduction. Fishermen will get better prices with the increase in export quantity," he said.

In July, India and the United Kingdom signed the Comprehensive Economic and Trade Agreement (CETA), a bilateral free trade agreement. CETA provides an unprecedented duty-free access to 99 per cent of India's exports to the UK, covering nearly 100 per cent of the trade value. This includes labour-intensive sectors such as textiles, leather, marine products, gems and jewellery, and toys as well as high-growth sectors like engineering goods, chemicals, and

HDFC Bank warns against APK fraud; urges public to stay alert

GUWAHATI, Aug 5: HDFC Bank has issued an official advisory warning customers against APK (Android Package Kit) frauds, a growing cybercrime method where fraudsters gain remote access to victims' phones by tricking them into installing malicious files.

According to the bank, scammers often impersonate bank staff or government officials and send APK links under false pretexts like re-KYC, tax refunds, or traffic fine payments.

Once installed, the malware gives attackers full access to the victim's phone, allowing them to intercept calls and messages, and make unauthorised financial

The bank cited cases where fraudsters posed as RTO officials or bank employees, urging victims to download fake apps embedded with malware.

Victims are typically tricked into entering sensitive details like account numbers, card info, and OTPs, leading to immediate financial loss.

Customers have been advised not to click on suspicious links or install apps shared via SMS, email, or

HDFC Bank urged users to verify messages via official websites, use trusted antivirus software, and download apps only from secure platforms.

The advisory also highlighted rising scams like "digital arrest" frauds and fake investment platforms, where fraudsters use fear or greed to manipulate targets—a tactic the bank termed the "GTH method" (Greed, Threat, Help).

Victims should immediately report frauds to their bank, call the national helpline 1930, and file a complaint at www.cybercrime.gov.in, the bank added.

Indian services sector growth hits 11-month high in July on sharp rise in exports, overall sales

NEW DELHI, Aug 5: The Indian services sector growth touched an 11 month high in July, supported by a pickup in new exports orders and sharp rise in overall sales, a monthly survey said on Tuesday.

The seasonally adjusted HSBC India Services PMI Business Activity Index was at 60.5 in July, little-changed from 60.4 in June, and the rate of expansion was the best seen since August 2024.

In the Purchasing Managers' Index (PMI) parlance, a print above 50 means expansion, while a score below 50 denotes contrac-

"At 60.5, the services PMI indicated a strong growth momentum, led by a pick-up in new export orders," said Pranjul Bhandari, Chief India Economist at HSBC. Sustained increases in new busi-

ness intakes were the main aspect behind output growth, the survey said, adding that Indian service providers also welcomed a stronger improvement in international demand for their services. "They reportedly secured new work from Asia, Canada, Europe, the UAE and the US," it said.

Going ahead, service providers were on average optimistic about their expectations for output in the year ahead. Meanwhile, RBI Governor Sanjay Malhotra-headed rate-setting panel on Monday started the threeday deliberations to decide the next bi-monthly monetary policy amid expectations of a pause in the rate easing cycle.

Governor Malhotra-headed sixmember rate-setting panel -- the Monetary Policy Committee (MPC) -- is scheduled to announce the next bi-monthly policy rate on Wednesday (August 6).

Experts were of the opinion that the Reserve Bank may go in for a status quo this time and wait for more macro data after the announcement by the US to impose a 25 per cent tariff on Indian im-

ports beginning August 7. On the jobs front, Although the upturn added pressure on firms' capacity, hiring moderated. July's increase in employment was the

slowest in 15 months. "The rate of job creation was only slight, broadly converging to its long-run average. Fewer than 2 per cent of companies took on additional staff, with the vast majority indicating no change from June," the survey said.

Meanwhile, the HSBC India Composite PMI Output Index was up fractionally from 61.0 in June to 61.1 in July, indicating a sharp rate of expansion that was the quickest since April 2024.

Composite PMI indices are weighted averages of comparable manufacturing and services PMI indices. Weights reflect the relative size of the manufacturing and service sectors, according to official GDP data. The PMI results for July re-

vealed mixed signs regarding the performance of the Indian private

"New orders and output expanded at quicker rates, while job creation receded and business optimism faded. Meanwhile, inflationary pressures gathered pace,' the survey said.

The team of the National Disaster Response Force (NDRF) is yet to reach the area. (PTI)

State LoP Debabrata Saikia writes to Gauhati HC for suo motu cognisance

GUWAHATI, Aug 5: Leader of the Opposition in Assam Assembly, Debabrata Saikia, on Tuesday urged the Gauhati High Court Chief Justice to take suo motu cognisance over alleged violations of statutory laws related to the financial health of the state.

In a letter to the Chief Justice of Gauhati High Court, Justice Ashutosh Kumar, the Congress leader alleged violations of the Assam Fiscal Responsibility and Budget Management (AFRBM) Act, 2005 and related constitutional mandates by the state government, leading to an escalating state debt crisis.

"These violations, explicitly acknowledged in the state's own annual budget reports, have precipitated an unsustainable debt crisis, estimated at ₹ 1,84,463 crore as of July 2025, with a debt-to-Gross State Domestic Product (GSDP) ratio of 25.2 per cent," he added.

Saikia stated that the crisis threatens the economic stability, public welfare and constitutional rights of Assam's citizens, necessitating urgent judicial intervention to enforce fiscal discipline and protect public interest.

"The Government of Assam's annual budget reports for 2021-22 to 2024-25 admit deviations from AFRBM targets, including excessive fiscal deficits and failure to maintain a revenue surplus," the letter stressed.

These admissions, corroborated by adverse findings from the Comptroller and Auditor General (CAG), Reserve Bank of India (RBI) and PRS India, reveal a pattern of fiscal mismanagement, including understatement of deficits, misclassification of expenditures, underutilisation of funds and reliance on costly cash transfer schemes, it added.

Saikia also claimed that the CAG reports from 2021-22 and 2022-23 revealed systemic irregularities that violated the AFRBM Act and suggested potential fraud and corruption.

"These findings indicate cosmetic accounting practices such as inflated budget projections and misclassifications, which obscure financial realities and facilitate potential misappropriation. The noncertificates for ₹37,991.70 crore in 2022-23 further raises concerns about accountability," he added.

The LoP further said that the Assam government's cash transfer schemes exacerbate the fiscal crisis as these schemes, lacking transparent cost-benefit analyses, were declared without vote-on-account and are in violation of Article 203. 204, 205 and 266 of the Indian Constitution.

"Every time the Cabinet of Assam sits for a meeting, schemes in the form of cash handouts and freebies are declared by the Government of Assam to electorally induce the voters at the cost of the state exchequer.

"Further, taking financial decisions as cabinet decisions, beyond emergency provisions, violates the Constitution of India safeguarding the separation of powers of legislative and executive," he added.

Asserting that the judiciary's intervention is essential to uphold statutory and constitutional mandates to safeguard taxpayers' interests and prevent further fiscal deterioration, Saikia requested the High Court to issue an interim stay on the announcement and implementation of new freebie or cash transfer schemes not included in the annual budget. All eyes on Mint Street

s the Reserve Bank of India's Monetary Policy Committee (MPC) begins its three-day deliberation which will end on August 6, all eyes are on Mint Street. Will the central bank pull the trigger on another rate cut, or will it stick to a cautious pause? The stakes are unusually high this time—not merely for inflation or GDP numbers but for the credibility of India's monetary stance amid an increasingly unpredictable global and domestic landscape. There are no easy answers, but doing nothing may be the costliest option of all. India is witnessing its lowest inflation in over six years. Consumer Price Index (CPI) inflation fell to 2.1% in June 2025, marking the eighth consecutive month it undershot the 4% target and the fifth time it undershot even the lower threshold of 2%. Disinflation is not just a vegetable story; cereals, pulses, and proteins have also cooled off sharply. Further, the inflation outlook for the rest of FY26 is benign. Forecasts peg average CPI inflation at 2.7%-3.1%, significantly lower than the RBI's estimate of 3.7%. Even the FY27 projection, thanks to a revised CPI basket that may lower food weight and boost e-commerce weightage, suggests headline inflation staying below 4%.

This macro backdrop screams for accommodation. Yet, the RBI has maintained a conservative pause since April, despite frontloading 100 bps of rate cuts earlier in the year. The argument has been incomplete transmission, global volatility, and concern over the rupee amid a hawkish Fed. Steady, but softening India posted a robust 7.4% GDP growth in Q4 FY25, but the growth engine is visibly sputtering in Q1 FY26. High-frequency indicators point to deceleration in manufacturing, utilities, and mining. The output gap remains negative, nominal GDP is weakening due to low deflators, and rural income growth-though stable—isn't robust enough to carry the recovery alone. Urban consumption presents a mixed picture: credit card spending is up, but new card issuance and personal loan growth are the weakest in three years. Tractor sales are strong, yet passenger vehicle sales are down. Corporate investment remains government-led; private capex is hesitant. In this context, delaying rate cuts would mean letting growth slip further just as inflation provides space

Another pressing variable is the U.S.-India tariff dispute. With the Trump administration imposing a 25% reciprocal tariff on Indian exports, and uncertainty looming over additional penalties related to crude oil imports from Russia, the trade war could shave off 30-40 bps from

Shortly before the stroke of midnight on August 14, India's first prime minister, Jawaharlal Nehru, made a famous speech entitled "A Tryst with Destiny": India's independence from England was the result of many generations of resistance, culminating in a series of large-scale independence movements from 1919 to the early 1940s led by Mahatma Gandhi. In the 1600s, India was ruled by the Mughal empire, which had been in control for hundreds of years. India was made up of smaller citystates and had established trade routes and a long history of art and culture. However,

there were colonial powers like England,

Portugal and the Netherlands that were tak-

ing control of pockets of land. Companies ammunition with animal products, which is from those countries were using trade to gain power. One of the most prominent companies was the East India Company from Britain, which at one time controlled half of the world's trade. It recruited its own army and began seizing control of India region by region. Sometimes it took control through military force, such as through winning the Battle of Plassey in 1757. Other times it gained power through economic dominance. For a time, the British government allowed the East India Company a lot of leverage in taking over regions in India because England was benefiting financially. However, when decades of unrest and resistance by Indians against the East India Company eventually resulted in Sepoy Mutiny of 1857, the British government dissolved the East India Company but kept control of its land. This is how Britain took over large portions of what is now modern-

The Battle of Plassey

The Battle of Plassey in 1757, part of the larger Seven Years' War between Britain and France, was a turning point in the British conquest of India. The East India Company had increasingly solidified its position and was now regarded by native rulers as a serious threat. The nawab (ruler) of Bengal, Sirāj al-Dawlah, favoring an alliance with the French, had previously attacked company trading posts. With the help of some of the nawab's own generals, the British were able to defeat and depose the nawab at the Battle of Plassey and appointed their own administration in Bengal. This crucial victory marked the transformation of the British East India Company from a mere mercantile presence into a military

and political power in India. The company would go on to consolidate its power over the Indian subcontinent through a series of military campaigns. It established its dominance in Bengal and Bihar with the Battle of Buxar

(1764), in southern India with Tipu Sultan's defeat in the fourth Mysore War (1799), and in the Punjab following the second Sikh war (1848-49).The Sepoy Mutiny and the British Raj One of the first united actions that Indians

took against British control was the Sepoy Mutiny. Indians were angered by the increasing pressure to convert to Christianity by the British, and they were also growing concerned about attempts to Westernize their country. When Hindu and Muslim soldiers were seemingly forced to use guns and against both religions, a rebellion was sparked. The fighting spread through northern and central India over the course of several months, uniting groups of Indians in a common cause. There was a lot of violence and death on both sides, and the conflict stretched on for more than a year. The rebellion ended on June 19, 1858 when the British recaptured a town called Gwalior and fighting ended. This victory marked the beginning of the British Raj (meaning "rule") in India, but modern Indians note this mutiny was an early example of nationalistic action taken by Indians. Throughout the end of the 19th century and into the 20th, India generated large amounts of wealth for England, with people referring to it as "the jewel in the crown" because of its valuable natural resources and industry. Despite this, conditions for Indians under British rule grew worse and worse over the same time period. Poverty in India increased from about 23 percent to more than 50 percent from 1810 to the 1950s. The death rate increased, and the life expectancy of the average Indian was less than 22 vears. Resistance to British rule rose due to these conditions, and Indians advocated for more representation and control over the local government. A British man named Allan Octavian Hume brought together a group of Indians to serve on the Indian National Congress in 1885. Hume purposely chose Indians that were Western-educated because he hoped that they would be more agreeable to British rule, culture, and politics. Despite being supportive of British rule at the beginning, the Indian National Congress would slowly become a nationalist entity, and later members would be strong supporters of an independent India. One of these leaders was Mahatma Gandhi.

Formation of the Indian National Con-

On December 28, 1885, the Indian National Congress (Congress Party) was formed, marking the inception of the first major nationalist movement to emerge in the British Empire outside Britain. Led largely by Allan Octavian Hume, a retired British civil servant sympathetic to the cause of Indian freedom, the Congress Party was initially established as a platform for educated Indians to discuss political issues and advocate for a greater role in governance. The first meeting was held in Bombay (now Mumbai), drawing 72 delegates from across the Indian subcontinent. These initial delegates were largely Western-educated and from elite backgrounds and foright independence. By the early 20th century, the Indian National Congress began to shift from moderate to more "extremist" stances, under the influence of leaders such as Bal Gangadhar Tilak, Lala Lajpat Rai, Bipin Chandra Pal, and Annie Besant. The concept of swadeshi ("of our own country"), or prioritizing indigenous goods over British imports, gained prominence, symbolizing a growing spirit of economic selfsufficiency and resistance against imperial exploitation. By 1907 a clear delineation existed between the moderates, led by Gopal Krishna Gokhale, and the extremists.

Formation of the All-India Muslim

The All-India Muslim League, the first political party for Muslims in India, was founded in Dhaka (now the capital of Bangladesh) on December 30, 1906. This development was driven by the increasing dissatisfaction among Indian Muslims with the Indian National Congress, which many perceived as primarily representing Hindu interests. The party was heavily influenced by the visionary Indian Muslim leader Sir Sayyid Ahmad Khan, who had died in 1898, and was founded by leaders including Mian Muhammad Shafi, Nawab Waqar-ul-Mulk, Nawab Mohsin-ul-Mulk, Syed Ameer Ali, Mualana Mohammad Ali Jouhar, and Sir Sultan Mohammed Shah (the league's first president, also known as Aga Khan III). Sir Muhammad Iqbal would emerge as a key voice within a few years of the party's founding. The league aimed to safeguard the rights of Indian Muslims and initially espoused loyalty to the British raj as a means to achieve greater civil rights and counterbalance the dominance of the Congress Party. The Muslim League would eventually lay the groundwork for modern Pakistan. Mohammed Ali Jinnah, who joined the league in 1913, would later transform the political party into a mass movement for Muslim autonomy

Gandhi and the Modern Indian Inde-

pendence Movement Mahatma Gandhi was born in India and went to law school in England. He also worked as a lawyer in South Africa. He returned to India in 1915 as a strong supporter of Indian nationalism, and he joined the Indian National Congress to advocate for Indian self-rule. He used many forms of nonviolent resistance, also called passive resistance, to draw attention to the cause of self-rule and gain support. India opting for restraint and caution in dealing with Trump's 25 per cent tariffs

'ndia's hopes for reduced export tariffs to the United States were dashed on Wednesday when the Trump administration announced La 25% levy and an unspecified penalty for buying arms and crude oil from Russia. The Narendra Modi government is responding cautiously, as the full impact of these penalties remains unclear.

Concerns have been raised about the impact of India's exports on the economy and stock market. On July 30, Trump announced a 25% tariff on imports from India, stating, "While India is our friend, we have done little business with them because their tariffs are among the highest globally, and they have challenging non-tariff trade barriers." Experts warn that the 25% tariffs could reduce India's growth in

2025-26, potentially reducing it by up to 40 basis points. Additional penalties might further damage the economic outlook.

The statistics show that in 2025, India sold \$10.5 billion in pharmaceuticals and \$14.6 billion in smartphones to the United States. Trump did not include these critical sectors in the new tariffs starting on August 1. In that same year, India had a trade surplus of \$41 billion with the United States. This surplus was \$35.32 billion in 2023-24 and \$27.7 billion in 2023. Trump's surprise announcement has drawn strong reactions from opposition leaders. The Congress party stated on X, "The country is now bearing the costs of Modi's 'friendship'." Critics are questioning Trump's support for high tariffs despite calling Modi his friend.

The reasons were evident: the influence of Russia, trade with India, and India's firm stance during trade negotiations. This aggressive behaviour also comes from geopolitical frustration.

Media reports suggest that Trump is frustrated with the restrictions in Indian markets, which have influenced his decision. The US has long complained about high tariffs on American goods. Although Trump initially saw India as a key trade priority, slow progress has led to frustration in Washington. New Delhi's cautious approach has resulted in only limited concessions. This move aims to pressure New Delhi into meeting US demands, especially after the US secured favourable trade deals with major partners like Japan, the UK, and the EU, just two days before the timeline.

India's top exports include smartphones, pharmaceuticals, gems, textiles, industrial machinery, jewellery, and seafood—all of which are now under threat. In the 2024-25 fiscal year, the United States was India's largest trading partner, with bilateral trade reaching USD 186 billion. The US accounted for 18% of India's exports and 6.22% of its imports. Tariff changes could significantly affect both economies.

Trump commented on social media, "It's about India's relationship with Russia, stating, "They can drag their weak economies down together. We do very little business with India due to its high tariffs, and neither does the USA. Let's keep" it that way." New Delhi does not have many options. They are: deeper diplomatic engagement, look for new trade partners, and leveraging economy. The Modi government decided to source goods from various countries including Russia to protect national interests and stabilise Indian economy. Trump is open to negotiating with India but has imposed a trade penalty linked to its BRICS membership. Back-channel talks are underway, and experts believe solutions to open the agriculture and dairy sectors could

New Delhi is trying to manage the situation. Commerce and Industry Minister Piyush Goyal told Parliament that the government will take action to support farmers, workers, and small business owners. He is open to discussions about these issues. Not everything is black and white. Estimates from ICRA, Nomura, and ANZ suggest that the GDP impact will be modest, as India exports about \$87 billion in goods to the US annually, accounting for only 2 to 3% of its total GDP.

Trump commended reports that India might stop buying Russian oil as" a good step" amid US pressure. Indian officials clarified that Indian oil companies continue to import Russian oil due to pricing and logistics. Halting these imports could endanger India's energy security and lead to wider geopolitical consequences. New Delhi acknowledges changes in its relationship with Russia but remains confident that the partnership will continue to grow. Despite the challenges, there is some hope on the horizon as a US delegation is set to visit India on August 25 for the next round of negotiations regarding the proposed bilateral trade agreement between the two countries. Trump plan to end free elections in 2026 midterm and 2028 Presidential revealed

The Trump administration and its radical right foot-soldiers in the federal government and in the states are undertaking a comprehensive scheme to undermine future state and federal elections, in effect rigging the rolls to keep themselves in power no matter what the voters decide. So far, other than the report itself, by the Brennan Center for Law and Justice at New York University, there's been little-or little-noticed-re-

The comprehensive scheme is detailed in a combination of a Trump executive order on March 25 and the notorious SAVE Act, a GOP voter repression law that would disenfranchise at least 21 million people, most of them women—the voters most likely to oppose the Trump-

right-wing-corporate agenda. Detailed and footnoted protests were aired by the Citizens for Responsibility and Ethics in Washington (CREW) to the GOP-run House Administration Committee and by the Leadership Conference on Civil and Human Rights-whose members include the AFL-CIO—to the GOPrun Senate Rules and Administration Committee. And states have gone to court to try to block Trump, the Brennan Center

"A president has no right to rewrite the country's election rules or regulate federal elections on his own," the center's report says. "As a federal court recently put it, The Constitution yests none of these powers in the president.' In issuing the order, the president claimed extraordinary unilateral authority to regulate federal elections and usurp the powers of Congress, the states, and the (U.S.) Elections Administration Commission, an independent, bipartisan federal agency.'

Protecting U.S. elections, at all levels, from partisan manipulation, is now and has been for more than a century, important to workers, union, and non-union. One, as AFL-CIO President Liz Shuler often points out, is that the GOP Trump regime views organized labor as a key roadblock to its partisan and repressive agenda. And the best way to crush labor is to crush workers' right to vote.

And, second, and just as important, restricting who can vote, and who cannot, centralizes power in the hands not just of Γrump but of the corporate interests that back him and who turn a blind eye-or worse-to repression both at the workplace and at the ballot box.

After all, paraphrasing the late UAW President Walter Reuther, what is won at the bargaining table can be taken away by the stroke of a pen. The elements in the right wing's coordinated attempt to entrench itself in power go far beyond what Trump tried in the aftermath of the 2020 presidential election. Trump lost it to Democratic nominee Joe Biden, and knew it. But he tried to overturn the results in lawsuits and other intimidation in selected swing states—and went 0-for-62 in court cases.

When that failed, he turned to aiding and abetting the Jan. 6, 2021, Trumpite invasion, insurrection, and attempted coup d'etat at the U.S. Capitol.

But now the Trump right-wing playbook to undermine and rig coming elections is much more extensive and much more under the radar, the Brennan Center reports. It includes: Attempting to rewrite election rules to burden voters and usurp control of election systems. Targeting or threatening to target election officials and others who keep elections free and fair. Federal officials, at the Justice Department, had an important role in countering disinformation and combating racial discrimination.

This federal protection for fair elections may no longer exist. Supporting people who undermine election administration by putting them on state and local elections boards. Retreating from the federal role of protecting voters and the election process by defunding agencies Congress established to safeguard the vote and ensuring the Federal Elections Commission, already hobbled by a yearslong deadlock, remains toothless. Giving a "go" signal to future violence to overturn elections, by Trump's pardons of the January 6 insurrectionists

The Brennan report leaves out one tactic of Trump, the MAGAites and the right-wing: Stacking state and local elections boards. An attempt occurred in Nevada, a swing state in 2020 and 2024. And after the four-member, evenly split Wayne County, Mich. (Detroit) elections board voted 3-1 to certify Democratic presidential nominee Joe Biden's margin there in 2020. Michigan MAGAites forced the Republican commissioner who voted for certification out of office.

"Why do we conclude this represents a concerted strategy? Among other things, President Trump tried to do this before,' the Brennan Center points out. "He was the first president to try to overturn the results of a presidential election and used

federal power to do so. 'Institutions and key officials blocked him. These internal checks, however, are now gone, and many public officials will likely carry out the president's will. "This campaign to undermine elections runs afoul of the U.S. Constitution. Only Congress and the states can set election rules. The executive branch, especially the Department of Justice (DOJ), is charged with enforcing federal laws. But neither the president nor the DOJ has the authority to set rules governing elections or to super-

vise" state elections procedures. Yet Trump is trying just that. And, as CREW and the Brennan Center point out, the misnamed SAVE Act, a key goal of the House's ruling right-wing Republicans, would aid and abet that campaign. Other specifics include:

Attempting to impose a "Show Your Papers" requirement on voters. Trump, in a March 25 executive order, and the GOP congressional majority, in the SAVE Act, say doing so would prevent "voter fraud," which even Trump's last Attorney General in his first term, Bill Barr, called nonexistent. But "show your papers" mandates, using a citizenship document to even register to vote, "would undermine voting and disrupt election administration in multiple respects."



Estimates are that the mandate, the SAVE Act, or both, would disenfranchise at least 21 million voters nationwide. Most of them would be women, whose names on their initial voter registrations are different from the name they now use.

Force the states to re-certify all their voting machines, buy new ones, or both. That would cost billions of dollars. It's also one step removed from Trump's demand for hand counts of all elections. The certification would be done by federally approved firms and methods, and only one has been okayed by the federal Elections Administration Commission, on

There are also bans on unauthorized access to voting machines and equipment. The result of violating them is to toss the machines—and the votes they count out. Tina Peters, former county clerk in rural "red" Mesa County, Colo., is now serving a 9-year term in prison for allowing Trumpite election deniers access to her county's machines after the 2020 balloting. She was convicted last year.

There is a plan for retaliation against opponents of the right-wing's voter rigging. The targets include state and local elections officials, non-partisan groups such as the League of Women Voters, civic groups that mobilize voters "and other individuals and entities that protect elections and the rule of law," the Brennan Center reports.

That kind of retaliation could target both unions and their get-out-the-vote drives and groups such as the Poor People's Campaign, which registers and mobilizes poor and low-wealth people—the very voters least likely to participate, but also the most likely to oppose the Trumpite, right-wing and corporate hege-

The Brennan Center reports likely targets for "law enforcement" type retaliation would include individual voters, election officials, "perceived political adversaries, and journalists." The last two groups of targets have been GOP targets before: On Richard Nixon's enemies list. Labour leaders—AFSCME President Jerry Wurf and UAW President Leonard Woodcock—were on it, too.

Trump's FBI Director Kash Patel "stated 'We're going to come after the people in the media who lied about American citizens, who helped Joe Biden rig presidential elections-we're going to come after you," the Brennan Center

The Brennan Center reports three active task forces leading that retaliation: The Justice Department's "Weaponization Working Group, the New Jersey U.S. Attorney's Office Election Integrity Task Force, and the Washington, D.C., Attorney's Office Special Unit.

Letting DOGE—Trump's so-called Department of Government Efficiency-access sensitive private and personal voter registration files, just as it did with other agencies, including the Labour Department and the National Labour Relations Board. And the threat isn't only from DOGE's misuse of the files. The Brennan Center adds that when DOGE grabbed the NLRB's files, its security was so lax that foreign hackers immediately invaded

"The administration could abuse voter file access to claim fraud and erode public trust in elections," the Brennan Center warns. "It could also pressure state officials to target groups of voters and carry out unwarranted voter purges. Any disclosure of sensitive personal information puts individuals and groups at risk of being intimidated or doxed. And mishandling voter file data could expose U.S. elections to political and foreign interfer-

As regards intimidating election officials. after what happened in 2020 to the two African-American women in Georgia at the hands of Trump consigliere Rudy Giuliani—one a ballot counter, the other her mother—local elections officials are scared and defecting in droves.

"Criminal investigations and prosecutions would impose a severe personal and financial toll on election officials or nonprofit employees for simply doing their jobs to help keep elections free and fair. But beyond that, the harms that stem from targeting the officials and civil society groups that make our elections work are manifold," the Brennan Center report

"Even if the administration never charges any officials, the threat alone of criminal investigation or prosecution will likely exacerbate the exodus of election officials. In 2024 33% of local election officials knew at least one colleague who resigned in part due to fear for their safety, of increased threats, or of intimidation; 21% stated they were unlikely to continue serving in their role for the 2026 midterms. In 2025, 59% of officials reported fear of political interference in their ability to do their jobs. And 46% were very or somewhat concerned about potential politically motivated investigations of themselves and their families.'

The Brennan Center reports "federal and state law prohibit anyone, including federal officials, from intimidating voters and those, like election officials or civic engagement organizations, who assist or encourage them to vote. And though voters rarely do so, they are able to sue DOJ officials under anti-intimidation law in federal court."

"The Constitution establishes a system of checks and balances to ensure free and fair elections. The power to regulate elections lies in the hands of states and Congress. Courts and advocates complement this system to uphold the Constitution and federal law," the Brennan Center declares.

"U.S. election infrastructure leaves no room for the president to insert himself. Yet that is exactly what he purports to do." (IPA Service)

Rajkumari Amrit Kaur, India's first woman

patriot, eminent parliamentarian, firm believer in non-violence and selfless and dedicated worker for the cause of the emancipation of women and weaker sections of society, Rajkumari Amrit Kaur has left an indelible imprint on national life and polity.

Rajkumari Dame Bibiji Amrit Kaur (née Ahluwalia) was a freedom fighter and politician, and the first woman member of the Indian cabinet after independence. Following her long lasting association with the independence movement, she was appointed the first health minister of India in 1947 and remained in office until 1957. She also held the charge of the sports ministry and urban development ministry, and was instrumental in setting up the National Institute of Sports, Patiala. During her tenure, Kaur ushered in several healthcare reforms in India and is widely remembered for her contributions to the sector and her advocacy of women's rights. Kaur was also a member of the Constituent Assembly, the body that framed the Constitution of India.

Kaur, the only daughter among eight children of Raja Harnam Singh of the Kapurthala State of Punjab, was born in Lucknow on February 2, 1889. Her mother, Rani Harnam Singh, was the daughter of Golak Nath Chatterjee from Bengal. Although Kaur had inherited Christianity as her religion from her father, she had a deep reverence for all other faiths as well

Like any aristocratic children of that time, Kaur had her early schooling abroad in the Sherborne School, Dorsetshire, UK, where she was sent at quite an early age. Later, she was sent to Oxford for higher education, where she excelled. She also took a keen interest in sports, especially hockey, cricket and tennis, and won several champi-

She could speak Italian and French fluently and could play the piano and the violin proficiently. She was recognised as a connoisseur of things cultural and aesthetic. After completing her education in England, she returned to India in 1918 at the



cabinet minister, left a rich legacy

Gandhi's disciple

After her return to India from England, Kaur became interested in the Indian independence movement. She was drawn to the thoughts and vision of M.K. Gandhi, whom she met in Bombay in 1919. Soon Kaur became one of his closest disciples. She worked as Gandhi's secretary for 16 years, and their correspondence was subsequently published as a volume of letters titled Letters to Raikumari Amrit Kaur.

She was so impressed by the views, ideas and magnetic personality of Gandhi that she later remarked: "There was a quiet strength, an earnestness and deep humility about him that went straight to my young heart I feel I have owed allegiance to him and to his cause from that time

Gandhi too used to confide in her, as is evident from one of his letters in which he had written, "My special function from childhood has been to make woman realise her dignity. I was once a slave holder myself but Ba proved an unwilling slave and thus opened my eyes to my mission. Her

task was finished. Now I am in search of a woman who would realise her mission," and asked: "Are you that woman, will you be one?"

It was no wonder, therefore, that the Gandhian era produced so many women leaders of eminence. Kaur was among the privileged few who had, for many years, enjoyed and shared Gandhi's close confidence.

Having joined politics, she took an active part in the salt campaign and was arrested in Bombay. As a true patriot, she condemned the 'Communal Award' given by Ramsay Macdonald when he was premier in 1932, regarding the political rights of major and minor communities in India.

As a representative of the Indian National Congress, in 1937 she went on a mission of goodwill to Bannu, North-West Frontier Province (now in Pakistan). The British authorities charged her with sedition on July 16, 1937 and imprisoned her. During the 'Quit India' Movement in 1942, she led many processions and in one of them, was subjected to ruthless lathi charge in Simla. Subsequently, she was arrested and jailed. The hardships

of the jail, which she had to undergo, were, however, too much for her. She was therefore put under house arrest in Simla.

The British authorities appointed her as a member of the Advisory Board of Education, but she resigned from the position following her involvement with the Quit India Movement in 1942. She was imprisoned by the authorities for her actions during the time.

As a parliamentarian and minister


Kaur was a member of the Constituent Assembly of India (1946-50), the Provisional Parliament (1950-52), Lok Sabha (1952-57) and Rajya Sabha (1957-62). A dedicated parliamentarian, Kaur always showed a keen interest in the business of the House. For parliamentary debates and discussions, she used to come fully prepared. Her speeches in the parliament not only gave a new direction to the Indian polity and made it richer but also provided food for thought.

After India became independent, Prime Minister Jawaharlal Nehru invited her to become a member of his Council of Ministers. She thus acquired the distinction of being the first woman member of the Indian Cabinet after independence and held the portfolio of health from August 15, 1947 to April 17, 1957.

During her time health minister, the All India Institute of Medical Sciences (AIIMS) in New Delhi – one of the best in Asia – came into existence. While piloting the AIIMS Bill in Lok Sabha on February 18, 1956, she had observed:

"It has been one of my cherished dreams that for postgraduate study and for the maintenance of high standards of medical education in our country, we should have an Institute of this nature in India which would enable our young men and women to have their background with the necessary experience that we would like to have of work in villages and the impetus that we would like to give to them to do research in the various spheres of medical education This is a pure, honest attempt to bring to this country good standards of medical education and to make them available to all.'

She also took keen interest in a variety of issues



and legislative measures such as Sterilisation of the Unfit Bill, B.C.G. Vaccination Campaign, Report of Jaundice Enquiry Committee, Food situation, Countess of Dufferein's Fund Bill, 1957 and Annual Reports of Employees' State Insurance Corporation, and so on.

The suggestions made and solutions given by her on these issues were largely accepted by the

During this period, several important bills relating to her ministry such as The Indian Medical Council Bill, Indian Red Cross Society (Amendment) Bill, Government Premises (Eviction) Amendment Bill, Prevention of Food Adulteration Bill, 1954, Delhi (Control of Building Operation) Bill, 1955, Delhi Municipal Corporation Bill, 1957, Orphanages and Other Charitable Homes Bill, 1959_ Children Bill, 1959, Lady Harding Medical College and Hospital Bill, 1959, Geneva Convention Bill, 1960, Drugs (Amendment) Bill, 1961 etc., were discussed at length and later passed by parliament.

Kaur co-founded the All India Women's Conference in 1927. She was later appointed its secretary in 1930, and president in 1933.

Kaur died in New Delhi on 6 February 1964. Although she was, at the time of her death, a practising Christian, she was cremated according to family customs and her funeral was presided over by the SGPC. Kaur had never married, and had no children. (Courtesy:thewire)

here was a time when the relationship of husband and wife was a symbol of sacrifice, love and mutual dedication. Marriage was not just a social contract, but was considered a deep emotional and spiritual journey. bricks, worked as a daily wage labourer to educate his wife, filled her form, paid her fees, dropped her off at the examination centre, distributed sweets to her after she got selected when the same husband stands at the door, the wife says - "I don't need you anymore." This sentence is not just words, it is the death of the struggle in which relationships breathed This is the face of modernity, which shines but is hollow from within. If a wife rejects her husband without any reason, without any harassment, just because he has got a job, then this is neither empowerment nor freedom – this is a social crime. This is the murder of those values which are the foundation of Indian society. It is important to make it clear here that we are not talking about those women who are really harassed, exploited or who need protection. We are talking about those cases where a wife leaves her husband by misusing the law and rights only because she has become financially independent.

The protection that the law has given to women is necessary and should be there, but that protection is sacred only as long as it is used and not misused. Today, the number of such incidents is increasing in society where women have sent not only their husbands but also their families to jail by making false allegations, harassed them mentally and ruined them financially. Is this the family face of "New India"?

When a girl says, "Now I earn, I don't need anyone", it is not inde-

pendence, it is narcissism. Does selfreliance mean abandoning relationships? Does the value of love and sacrifice become zero as soon as one gets a job? Why is it not explained that a strong woman is one who keeps her nest safe even during her flight, and not burns it as soon as she

The purpose of education is not only to get a job but also to bring maturity in thinking. Unfortunately, today's education has not given this maturity but in many cases has given rise to self-centred thinking. If selfreliance turns into selfishness, then it becomes a threat to the society. If a woman runs away from her relationships after studies, then it raises a allows her to do this. Many times. when a wife leaves her husband, society remains silent. Women consider it their right, and men do not even have a say. If a husband says, "I educated her, raised her, made her career", he is told, "She did not do you any favour, she is independent now.' But when a woman moves forward by sacrificing her husband, does that sacrifice not have any value? Doesn't she have any emotional recognition?

This mindset has now reached the courts. There are thousands of cases pending in the courts where men are fighting for their marital rights, yearning to meet their children, and carrying the burden of a relationship that exists only on paper for years. They can neither get a divorce, nor start a new life, and neither does society understand their suffering.

In many cases, educated women have extramarital affairs, distance themselves from their husbands, and then hide behind legal protection. When someone questions such matters, he is called "anti-women", "narrow-minded" or "patriarchal". But does a society not have the right to listen to the voice of a man who protects relationships?

If this mindset continues, the institution of marriage will be hollowed out in the coming years. Men will fear marriage, families will break, and walls of mistrust will be erected in society. Women must understand that they are not only responsible for getting a job, but also for maintaining relationships. When a husband pays your fees, gets you coaching, encourages you, then he is not just a husband, but a guide, a helper, a mentor. And when you leave him after achieving success, you reject not just a person, but a trust. This society can no longer tolerate false cases, superficial freedom and relationships broken in the name of selfishness. Now the time has come to add moral values to education, bring balance in laws, and give the message to the society that empowerment does not mean running away from responsibil-

n July 20, 2025, the Indian Forest Service (IFS) Association made a historic decision by electing an all-female executive committee for the first time since its establishment. This news, prominently featured by The Pioneer on July 21, marks a significant milestone for gender representation within India's esteemed All India Services and underscores the pressing need for governance that is both responsive to climate issues and inclusive of gender perspectives. In an era where the world grapples with disasters stemming from climate change — such as flash floods, cloudbursts, extreme weather events, wildfires, rising sea levels, and prolonged droughts — the role of the Indian Forest Service is becoming increasingly vital.

Trump says he will raise tariffs on India 'very substantially' in next 24 hours

5: US President Donald Trump on Tuesday said India has not been a good trading partner and announced that he will raise the tariffs on New Delhi "very substantially" over the next 24 hours because it is buying Russian oil.

"With India, what people don't like to say about India, they're the highest tariff nation. They have the highest tariff of anybody. We do very, very little business with India because their tariffs are so high," Trump said in an interview with

CNBC Squawk Box. "India has not been a good trading partner, because they do a lot of business with us, but we don't do business with them. So we settled on 25% (tariff), but I think I'm going to raise that very substantially over the next 24 hours, because they're buying Russian oil. They're fuelling the war machine. And if they're going to do that, then I'm not going to be happy," he added. When asked about the trade deal with India that seemed imminent, Trump said the "sticking point" with India is that its tariffs are too high

"Now I will say this, India went from the highest tariffs ever, they will give us zero tariffs....But that's not good enough, because of what they're doing with oil."

A day earlier, Trump said he will "substantially" raise US tariffs on India, accusing the country of buy-



ing massive amounts of Russian

oil and selling it for big profits. Hours later, India mounted an unusually sharp counterattack on the US and the European Union for their "unjustified and unreasonable" targeting of New Delhi for its procurement of Russian crude oil.

Firmly rejecting the criticism, India pointed out the double standards in targeting it on the issue and said both the US and the EU are continuing their trade relations with Russia.

"Unlike our case, such trade is not even a vital national compulsion," the Ministry of External Affairs (MEA) said in a statement.

The Europe-Russia trade includes not just energy, but also ferproducts, mining tilisers, chemicals, iron and steel, and machinery and transport equipment, the MEA said. "Where the US is concerned, it continues to import

well as chemicals," it added. "In this background, the targeting of India is unjustified and unreasonable. Like any major economy, India will take all necessary measures to safeguard its national interests and economic security," the MEA said.

On Tuesday, Russia defended India's right to select trade partners, saying sovereign countries have the right to select their partners in trade and economic cooperation based on their interests.

"We believe that sovereign countries must have and do have the right to choose their trade partners, the partners in trade and ecoand independently determine those modes of trade and economic cooperation that suit the interests of a country in question," Kremlin Spokesman Dmitry Peskov told journalists, commenting on the

US' threats regarding India.

On Monday, Russian Foreign Ministry Spokesperson Maria Zakahrova accused the US administration of continuing a neocolonial policy against the nations of the Global South to maintain American hegemony. "Sanctions and restrictions are a regrettable reality of today's historical stage, which affects the entire world," Zakaharova said in a statement. "Washington cannot come to terms with the loss of hegemony in the emerging multipolar world order and continues to pursue a neocolonial policy in an attempt to maintain its position, using politicised levers of economic pressure against those who refuse to follow in its wake in the international arena," she added. On August 1, Trump signed an Executive Order titled 'Further Modifying The Reciprocal Tariff Rates', raising tariffs for over five dozen countries, including a steep 25 per cent for India.

The executive order, however, did not mention the "penalty" that Trump had said India will have to pay because of its purchases of Russian military equipment and

NATO to coordinate regular, largescale arm deliveries to Ukraine

BRUSSELS, Aug 5: NATO has started coordinating regular deliveries of large weapons packages to Ukraine after the Netherlands said it would provide air defence equipment, ammunition and other military aid worth 500 million euros (USD 578 million).

Sweden also announced Tuesday it would contribute USD 275 million to a joint effort along with its Nordic neighbours Denmark and Norway to provide USD 500 million worth of air defences, anti-tank weapons, ammunition and spare parts.

Two deliveries of equipment, most of it bought in the United States, are expected this month, although the Nordic package is expected to arrive in September. The equipment is supplied based on Ukraine's priority needs on the battlefield. NATO allies then locate the weapons and ammunition and send them on.

"Packages will be prepared rapidly and issued on a regular basis," NATO said Monday.

Air defence systems are in greatest need. The United Nations has said that Russia's relentless pounding of urban areas behind the front line has killed more than 12,000 Ukrainian civilians.

Russia's bigger army is also making slow but costly progress along the 1,000-kilometre front line. Currently, it is waging an operation to take the eastern city of Pokrovsk, a logistical hub whose fall could allow it to drive deeper into Ukraine.

European allies and Canada are buying most of the equipment they plan to send from the United States, which has greater stocks of ready military materiel, as well as more effective weapons. The Trump administration is not giving any arms to Ukraine.

The new deliveries will come on top of other pledges of military equipment. The Kiel Institute, which tracks support to Ukraine, estimates that as of June, European countries had provided 72 billion euros (USD 83 billion) worth of military aid since the start of Russia's full-scale invasion in February 2022, compared to USD 65 billion in US aid.

Dutch Defence Minister Ruben Brekelmans said that "American air defence systems and munitions, in



particular, are crucial for Ukraine to defend itself.' Announcing the deliveries Monday, he said Russia's attacks are "pure terror, intended to break Ukraine."

President Volodymyr Zelenskyy expressed his gratitude to the Netherlands, posting on social media that "Ukraine, and thus the whole of Europe, will be better protected from Russian terror."

He said the deliveries are coming "at a time when Russia is trying to scale up its strikes. This will definitely help protect the lives of our people!"

Germany said Friday it will deliver two more Patriot air defence systems to Ukraine in the coming days. It agreed to the move after securing assurances that the US will prioritise the delivery of new Patriots to Germany to backfill its stocks. These weapon systems are only made in the US.

As an organisation, NATO provides only non-lethal assistance to Ukraine like uniforms, tents, medical supplies and logistics support. The 32-nation military alliance has mostly sought to protect NATO territory from possible Russian attack and avoid being dragged into a war against a nuclear power.

But its support role has expanded since US President Donald Trump took office in January, even as his administration insists European allies must now take care of their own security and that of their war-ravaged neighbour. (AB)

Pak polls body disqualifies 9 lawmakers of Imran's party

ISLAMABAD, Aug 5: Pakistan's top election body on Tuesday disqualified nine lawmakers of jailed former prime minister Imran Khan's party, including leaders of the opposition in both chambers of the parliament, after their conviction in the May 9 riot case.

Supporters of the Pakistan Tehreek-e-Insaf (PTI) supremo Khan resorted to a spree of uncontrolled violence on May 9, 2023, vandalising military installations and state-owned buildings, after his arrest in Islamabad.

Cases were launched against several top leaders of the party, including Khan, and dozens of work-

ers, soon after the incident. In one of the cases, an anti-terrorism court in Faisalabad last week convicted over 100 leaders and workers to jail terms of up to 10 years. Those adjudged guilty included opposition leader in the National Assembly Omar Ayub Khan and opposition leader in the Senate

Shibli Faraz. Members of parliament Zartaj Gul, Hamid Raza, Sheikh Rashid Shafique, Kanwal Shauzab, Farah Agha, Rai Haider Kharal and Muhammad Ahmad Chattha were also found guilty.

All nine were sentenced to 10 years of rigorous imprisonment. As per the constitution, a convict cannot become a member of the

parliament under Article 63(1h). The Election Commission of Pakistan (ECP), acting on the court judgment, issued a notification to disqualify the members of parliament as well as members of the Punjab provincial assembly.

Earlier, the ECP had disqualified lawmakers Abdul Latif, Ejaz Chaudhry, Mohammad Ahmed Chatta and Ahmad Khan after their convictions by separate courts in Lahore and Sargodha. (PTI)

Thousands attend rally in B'desh to

DHAKA, Aug 5: Thousands of people in Bangladesh on Tuesday joined a rally in Dhaka, marking the first anniversary of last year's student-led protest movement, dubbed the "July Uprising", that toppled longtime

complex, saying the Uprising Day should serve as a reminder that the struggle for a better future continues.

"The people of Bangladesh express their desire that the student-people uprising of 2024 will get proper state and constitutional recognition and that the July declaration will feature in the schedule of the reformed constitution as framed by the government formed through the next national election," Yunus said, reading from the declaration.

The Yunus-led interim government wanted to give constitutional recognition to the student-led uprising. This recognition is known as the July Declaration. The over 1,000-word declaration described in detail the activities of the ousted "fascist" regime, adding that "therefore the people of Bangladesh express a strong desire" to bring the former rulers under trial for crimes of enforced disappearance and murder, individual and

"This document of declaration is written to reflect the aspirations of the people of Bangladesh at the event of the victory in the mass uprising of August 5, 2024," Yunus said.

Security forces enforced a strict vigil throughout the capital, with armoured vehicles patrolling the streets apparently to deter any attempt by Hasina's now-banned Awami League party to disrupt the day's events that included rallies, concerts, and prayer sessions.

However, apart from scattered political rallies, the streets of the capital

According to political analysts, the anniversary came as Hasina, now on self-exile in India, faces trial on charges like crimes against humanity while most of her colleagues in the cabinet and in her Awami League

But political analysts said Bangladesh is far from political stability, a year after the bloody uprising that claimed hundreds of lives.

Frequent disasters expose climate risks to infrastructure in South Asia

KATHMANDU, Aug 5: Floods that damaged hydropower dams in Nepal and destroyed the main bridge connecting the country to China show the vulnerability of infrastructure and need for smart rebuilding in a region bearing the brunt of a warming planet, experts say.

The flooding of the Bhotekoshi River on July 8 also killed nine people and damaged an inland container depot that was being built to support increasing trade between the two countries. The 10 damaged hydropower facilities, including three under construction, have a combined capacity that could power 600,000 South Asian homes.

Another smaller flood in the area on July 30 damaged roads and structures, but caused less overall destruction. Nepal's location in the Himalayan mountains makes it especially vulnerable to heavy rains, floods and landslides because the area is warming up faster than the rest of the world due to humancaused climate change. Climate experts say the increasing frequency of extreme weather has changed the playbook for assessing infrastructure risks while

also increasing the need for smart rebuilding plans. "The statistics of the past no longer apply for the future," said John Pomeroy, a hydrologist at the University of Saskatchewan in Canada. "The risk that goes into building a bridge or other infrastructure is generally based on historical observations of past risk, but this is no longer useful because future risk is different and often much higher.'

While damage estimates from the July floods in the Rasuwa region are still being calculated, past construction costs give a sense of the financial toll. The Sino-Nepal Friendship Bridge alone, for example, took USD 68 million to rebuild after it was destroyed by a 2015 earthquake that ravaged Nepal.

The latest disaster has also stoked fears of long-lasting economic damage in a region north of the capital city Kathmandu that spent years rebuilding after the 2015 quake. Nepali government officials estimate that USD 724 million worth of trade with China is conducted over the bridge each year, and that has come to a standstill.

"Thank God there was not much damage to local villages, but the container depot and bridges have been completely destroyed. This has severely affected workers, hotel operators, labourers and truck drivers who rely on cross-border trade for their livelihoods," said Kaami Tsering, a local government official, in a phone interview with The Associated Press.

Among those affected is Urken Tamang, a 50-yearold parking attendant at the depot who has been out work for several weeks. A small tea shop he runs nearby with his family has also suffered.

'We have been unlucky," said Tamang, a former farmer who sold his land and changed jobs when work on the depot began. He added: "The whole area was severely damaged by the 2015 earthquake, and just when life was slowly returning to normal, this devastating flood struck."(AP)

The initiative marks a key step toward digitising essential services across the state.

The new system enables residents to pay their water bills online, removing the need for physical visits to government offices and significantly cutting down wait times.

The pilot project is being implemented under the Public Health Engineering & Water Supply Department.

Police complaint filed over dilapidated highway in Arunachal



ITANAGAR, Aug 5: A youth organisation in Arunachal Pradesh has filed a police complaint against the National Highway and Infrastructure Development Corporation Ltd (NHIDCL), alleging misappropriation of funds and gross negligence in the construction of Likabali-Bam Road, which is a part of NH-13. The NH-13 connects Likabali in Lower Siang district to Mechukha in Shi-Yomi district.

In the complaint, filed at the Basar police station in Leparada district, the Galo Youth Organisation (GYO) said the road, which connects seven districts, was in an abysmal condition.

'This road is not only crucial for the daily lives of the people residing in these districts but also plays a vital role in defence and tourism," it said. "The construction fails to meet all-weather road standards for dou-

The GYO alleged that culverts, breast walls, bridges, retaining walls, drains and parapet walls constructed as a part of the road do not adhere to required quality standards and ratios.

It also accused the NHIDCL of not deploying men and machinery to clear the road promptly in the event of roadblocks due to landslides, thereby causing undue delays and hardships to travellers, including those seeking medical attention. It also wrote to the deputy commissioners of West Siang, Leparada and Lower Siang districts over the issue.

When contacted, PWD (Highways) Assistant Engineer Gemar Padu said the civil works of the viaduct of the highway are complete. We have been waiting for the last two months for a crane to put the

The youth organisation also filed an FIR at Likabali police station in Lower Siang district against "illegal earth cutting and environmental destruction" at Siji Village quarry. Lower Siang's Deputy Commissioner Rujjum Rakshap said the grievances of the organisation are genuine.

He said the district administration has been trying its best to provide a permanent solution. "The Lower Siang district administration recently convened a meeting with NHIDCL authorities to get an update on the

Rakshap said the preparation of the detailed project report (DPR) for the Siji block point is in its final stage, and the re-carpeting work of the Likabali-Bam Road will start soon. The NHIDCL could not be reached

Doctor bids adieu to public health service after 28 years His ability to coordinate response strategies.

NAHARLAGUN, Aug 5: After a distinguished career spanning nearly three decades, Dr Lobsang Jampa, the State Epidemiologist of Arunachal Pradesh, retired on July 31, leaving behind a legacy widely acknowledged as transformative for the state's public health infrastructure. A farewell ceremony in his honour was held at the Directorate of Health Services (DHS) in Naharlagun, where colleagues, dignitaries, and officials came together to celebrate his extraordinary service.

The ceremony was attended by Director of Health Services Dr Marbom Basar, Dr Komling Perme, and other senior officials of the Direc-

Recalling his contributions with deep admiration, speakers described Dr Jampa as a pioneer and referred to him as the "Father of Public Health" in Arunachal Pradesh—a title that reflects both his groundbreaking work and the en-

during impact he leaves behind. Dr Jampa's professional journey in the health sector stretched over 28 years and three months, marked by unwavering commitment and vision-

ary leadership Appointed as State Epidemiologist in 1999, he led the state's response to several major health crises, including the Avian Influenza outbreak of 2005, the Swine Flu episodes, and the COVID-19 pandemic.

manage containment protocols, and raise public awareness earned him wide appreciation across government and medical circles. His reputation for hands-on fieldwork was

well established during the early 2000s, when

he led disease surveillance and outbreak investigations in remote and inaccessible regions such as Parsiparlo, Sunpura, and Menchuka. His dedication to reaching the state's most underserved areas, often in the absence of proper road connectivity, stood as a testament

For his outstanding contributions, he was awarded the State Gold Medal on August 15, 2015. In addition to his role in emergency health response, Dr Jampa was instrumental in systemic reforms.

ademic and scientific research in the state. Under his leadership, multiple studies supported by the Indian Council of Medical Research (ICMR) were successfully conducted.



These included studies on Herpes Simplex and Hepatitis B screening in Anjaw district, the India Diabetes Study (2012 and its 2022–2023 follow-up), and research into Paragonimiasisa little-known lung fluke disease prevalent in the region.

A firm believer in building robust public health infrastructure, Dr Jampa facilitated land acquisition for critical projects, including space for patients in Vellore and for the National Centre for Disease Control (NCDC) at Hollongi.

He oversaw the construction of a boundary wall to protect the NCDC site and spearheaded the setting up of the Health Emergency Operation Centre (HEOC) at TRIHMS in conformity with International Health Regulations (IHR)

Among his most forward-thinking contributions was his work in laying the foundation for

the Public Health Cadre in Arunachal Pradesh. The proposed cadre represents a significant structural reform aimed at improving governance and operational efficiency in the health

Dr Jampa also played a critical role in imple-

menting flagship health initiatives. Under his guidance, 12 District Dialysis Units were established across the state under the Pradhan Mantri National Dialysis Programme (PMNDP), with three more units currently in

He was also responsible for rolling out the Chief Minister Organ Transplant Scheme (CMOTS) in 2018, under which over 200 successful kidney transplants have been conducted

the state.

In his tenure, he provided direct supervision and guidance to a wide array of national programmes including the National Programme for Prevention and Control of Non-Communicable Diseases (NP-NCD), Integrated Disease Surveillance Programme (IDSP), Health and Wellness Centres (HWC), National Programme on Climate Change and Human Health (NPC-CHH), National Rabies Control Programme (NRCP), and the National Viral Hepatitis Control Programme, among others.

Satyapal Malik's political journey: From loyalist to controversial critic

cian Satyapal Malik's five-decade-long political career spanned across multiple political parties and included several high-profile gubernatorial appointments before he transitioned into an outspoken critic of the very establishment he had served.

He served as the governor of four states -- Bihar (2017), Jammu and Kashmir (2018), Goa (2019), and Meghalaya (2020). But his most impactful assignment commenced in August 2018, when he was named the governor of Jammu and Kashmir.

The tenure saw two significant events -- the 2019 Pulwama attack in which 40 CRPF personnel lost their lives, and the August 5, 2019 revocation of Article 370 and the division of the erstwhile state into two Union Territorieswas the last governor of the state of Jammu and Kashmir.

Malik, 79, who had been hospitalised for some time, passed away in a Delhi hospital on Tuesday, which marks the sixth anniversary of Article 370 revoca-

Though he rose to prominence as a loyalist in the BJP, his recent years have been characterised by his vociferous condemnation of the central government's policies, reworking his public image from that of a seasoned administrator to that of a vocal dissident.

From J-K, he had been relocated to Goa, where his relationship with the state government soured as he was openly critical of its COVID-19 response and accused it of corruption. His term in Goa came to an abrupt halt and



he was posted to Meghalaya, his final publicly confronted the central govern-

On retirement from governorship, he

cluded a contention that the Pulwama attack was an outcome of governmental indifference, and vocally backed the farmers' protests against the three central laws, contending that the government had not listened to them.

During his last days of life, Malik was also named in the CBI chargesheets filed in May this year in connection with the alleged corruption in the Rs 2,200 crore Kiru Hydro power project. He strongly refuted the charges from his hospital bed, calling it "political vendetta".

Malik was born on July 24, 1946, in the Baghpat district of Uttar Pradesh.

His political journey started as a student leader with socialist ideology but his career was later characterised by party hopping as he switched from the Bharatiya Kranti Dal (BKD) to the Con-

gress, then the Janata Dal and finally the

The Jat leader was first elected to the Uttar Pradesh Assembly in 1974 on Charan Singh's BKD party.

Malik was elected twice to the Rajya Sabha -- from 1980 to 1986 and then from 1986 to 1989 -- before he decided to contest the Lok Sabha elections on the Janata Dal ticket. He won from the Aligarh parliamentary seat.

The then VP Singh government appointed him as the Union Minister of State for Parliamentary Affairs and

After the fall of the VP Singh government and the subsequent turmoil in the Janata Dal, Malik switched to the BJP, where he became a party vice-president and also acted as in-charge of its Kisan Morcha (farmers' cell). (PTI)

BJP leader Suvendu Adhikari's convoy attacked in Bengal's Cooch Behar



COOCH BEHAR (WB), Aug 5: The convoy of Leader of Opposition in the West Bengal Assembly, Suvendu Adhikari, allegedly came under attack from TMC workers during a protest programme in Cooch Behar on Tuesday, triggering tension in the Khagrabari area of the district.

Bulletproof glasses of the vehicle in which Adhikari and former Union minister Nisith Pramanik were seated were smashed. At least one police escort vehicle had its window panes shattered.

The TMC, however, dubbed the charges a "well-scripted drama". Armed with a Calcutta High

Court order, Adhikari travelled to the north Bengal district to lead a BJP rally and demonstration outside the office of the Cooch Behar Superintendent of Police, to protest alleged brutalities unleashed on BJP workers, and submit a memorandum.

Trinamool Congress workers had put up simultaneous pickets to protest the alleged "harassment of Bengalis in BJP-ruled states" and "attempts to implement NRC through backdoors in Bengal" in 19 locations of the districts, most of which were along the route through which Adhikari's convoy passed.

Adhikari faced 'go-back' and 'thief' slogans near the Ghoksadanga area, with black flags dotting the way to his destination at Cooch Behar town.

According to BJP leaders, a mob, holding TMC party flags and black flags, gathered at the Khagrabari crossing around 12.35 pm when Adhikari's convoy was passing through the area.

'The TMC assembled Rohingvas who infiltrated this region and made them carry out the at-

tack," Adhikari alleged. "They tried to smash the car in

sticks and, after they failed, shattered the bulletproof glasses with heavy stones," he claimed.

Stating that he was alive because of the bulletproof vehicle, the BJP leader said that he would go against the SP for the law and order breakdown with the full force of the law.

"I had taken necessary steps of informing the police and the administration before coming here, since this programme has the sanction of the high court, and because I had a hunch that something like this could happen. Now the SP will face the music," Adhikari said.

Former Union minister Nisith Pramanik alleged that the attack was led by Udayan Guha, minister of the North Bengal Development

"Guha was present at a local religious institution and instructed the mob to carry out the attack. It was an attempt on our lives," Pramanik claimed

"This is a clear indicator that the TMC is fast losing popular support in Cooch Behar. They manipulated votes to win the 2024 general elections here. But they will be whitewashed in the 2026 state polls," he added.

The TMC, however, claimed that no TMC workers were involved in the vandalism and the attack was a "result of the internal feud within the BJP"

"The TMC workers held spontaneous protests today against Adhikari. But no attack on the BJP leaders was carried out from our side." said Partha Pratim Ray, former MP and TMC's Cooch Behar district president.

"The BJP orchestrated this violence on their own to settle internal scores and grab media footage," he alleged.

It is yet to be confirmed whether anyone was injured in the incident.



BENGALURU, Aug 5: Employees of Karnataka's state-owned transport corporations began an indefinite strike on Tuesday morning, severely affecting public bus services across the state and leaving passengers in the

However, Bengaluru city is not affected by the strike, according to the transport department. The Bangalore Metropolitan Transport Corporation operates 99.8 per cent bus services, the department said. Details shared by the department showed

that the Kalyana Karnataka region, comprising Raichur, Ballari, Koppal, Yadgir, Kalaburagi and Bidar was worst hit with only 29.8 per cent government bus operations.

It shows that there was 59.4 per cent bus operations by the North West Karnataka Road Transport Corporation (NW-KRTC) and 43.9 per cent by the Karnataka State Road Transport Corporation (KSRTC). The unions went ahead with the strike despite a court stay, pressing demands including wage revision. Buses remained parked at depots and only a few were seen running, as some staff chose not to participate in the strike. Some buses in rural areas operated as a few drivers opted to work for the convenience of students to ferry them to their schools, said sources in the transport department.

Due to disruption in bus services, attendance in schools, colleges and offices was thin in many parts of the state.

The transport corporations are learned to have roped in trainee bus drivers to manage the situation. Also, the private buses were also

allowed to ply from the government bus terminals. Initially, bus services were affected in Bengaluru but gradually the services im-

proved in the city, Transport officials said. Bus stands in major cities like Chikkamagaluru, Raichur, Chitradurga, Hubballi, Dharwad, Belagavi, Mangaluru, Mysuru, Tumakuru, Hassan, Madikeri, Shivamogga, and Kalaburagi saw heavy passenger rush, with thousands stranded and struggling to find alternate ways to reach their destina-

Sikkim CS holds meeting on Census 2027

GANGTOK, Aug 5: A state-level meeting on the first phase of Census 2027 was held under the chairmanship of Sikkim Chief Secretary R Telang here on Tuesday, an official statement

The Sikkim government had constituted a high-level state census coordination committee under the chairmanship of chief secretary with senior officials to ensure effective inter-departmental coordination and successful execution of all phases of the census.

Director of Census Operations, Sikkim, Karma R Bonpo, presented a detailed overview of the upcoming census process in the meeting. He also highlighted the use of mobile applications for data collection, digital layout mapping, data security protocols, pre-test operations, and the drafting of the District Census Handbook

The chief secretary stressed the importance of meticulous planning and flawless execution of the census process. He underlined that the quality of data collected will directly influence the implementation and funding of future centrally sponsored schemes in the state. He urged all departments and officials involved to approach the task with seriousness and strive for accuracy at every stage, the statement said.

The meeting highlighted Sikkim's proactive stance in gearing up for Census 2027, which will be the first fully digital census and will also include a caste census—a significant shift in the data landscape of the country.

The meeting was attended by heads of departments, district collectors, representatives from all districts, senior officials from the Directorate of Census Operations, and officials from various departments of the state government, it said. (PTI)

Child marriage remains concern in Tripura, Sepahijala tops with 103 cases in 3 months

AGARTALA, Aug 5: Tripura's Sepahijala district has reported the highest number of child marriages in the state, with 103 cases recorded between April and June this year, an official said on Tuesday.

Amid rising concern over the issue, the district administration has also successfully foiled 101 attempted child marriages during the same period under its flagship 'Mission Sankalp' initiative, aimed at curbing the social menace.

South Tripura district ranked second with 43 child marriage cases. Dhalai, an aspirational district, reported 33 child marriages and thwarted 31 such attempts

Tripura ranks third in the country in terms of child marriage cases, as per the National Family Health Survey (NFHS) report.

Describing child marriage as one of the most serious social challenges in Tripura, Director of the Social Welfare and Social Education Department Tapan Kumar Das said the issue has taken a critical shape in the northeastern state.

"Economic backwardness is the root cause. Illiteracy, lack of social support, and influence of social media are also contributing factors," he said, citing departmental findings.

Das said that in many rural areas, girls are still considered a burden, and many parents are reluctant to educate their daughters.

"Poverty, inequality and elopement are other major drivers of child marriage in the state," he said.

In a bid to address the problem, the Social Welfare Department has taken multiple measures in coordination with district administra-

"One such initiative is 'Balika Manch', a school-level committee formed in most schools, involving both teachers and students. If a girl student remains absent for several days, her classmates are encouraged to report it to the committee. The matter is then looked into and, if necessary, referred to the panchayat," Das said.

Under the Centre's 'Beti Bachao Beti Padhao' scheme, substantial funds have been allocated to conduct awareness campaigns on the harmful effects of child marriage, he said.

"We release funds to districts to hold various programmes on child marriage and related issues. While coordinated efforts have led to improvements, a lot still remains to be done," he added.

Sepahijala's District Magistrate Siddharth Shiv Jaiswal, who has been at the forefront of anti-child marriage initiatives, said 'Mission Sankalp' is specifically designed to address child marriage, teenage pregnancy and substance abuse among youth. (PTI)

Meghalaya govt to spend ₹240 cr over 3 yrs to make state floriculture hub: CM

SHILLONG, Aug 5: Chief Minister Conrad K Sangma on Tuesday said his government will spend ₹ 240 crore over the next three years to transform Meghalaya into a floriculture hub.

Addressing a gathering during his visit to Mawkriah village in East Khasi Hills district, Sangma said the aim of the project is to make floriculture a high-value, climate-resilient and sustainable livelihood option for farmers in the state.

The 'Floriculture Mission 1.0' aims to benefit over 3,000 farmers, with each receiving ₹ 7 lakh subsidy for inputs, infrastructure and training. Nearly 500 farmers have already availed benefits of the

"This is the highest investment any government has made in floriculture in Meghalaya," Sangma said, adding that the government expects direct profit generation of ₹ 600 crore from the initiative in the coming years. The scheme will focus on cultivating high-value flowers such as orchids, dendrobium, cymbidium, vanda and phalaenopsis and oriental lilium, which are in demand in domestic and international markets.

"Region-specific flower clusters are being developed using scientific cultivation techniques," Sangma said.

"We are building on the state's natural strengths and innovating with improved



systems," he added.

The state has engaged two service providers, Darjeeling Gardens and North Bengal Floritech, to provide technical expertise, quality planting materials, infrastructure support and assured market linkage under a three-year buyback arrangement, officials said.

Meghalaya's unique agroclimatic conditions, with a blend of tropical and temperate elements, are ideally suited for growing exotic flowers, they said.

Sangma said the floriculture mission is part of a broader strategy by the state gov-

He cited the success of the Lakadong Turmeric Mission, as a part of which production increased from 1,000 ton to over 20,000 ton through SHG-led processing units, market linkages and targeted invest-

"Meghalaya's agriculture vision is rooted in identifying our core strengths and scaling them," he said.

"We aim to double farmers' incomes, diversify rural livelihoods and make agriculture a cornerstone of sustainable development," he added. (PTI)



n't get paid for it.

"You cannot bind someone saying, 'You work for eight hours only'. A police officer, a traffic cop or a doctor works for more than 16 to 18 hours. even pilots and our jawans work for long hours. So, till the time it is not being forced, and you're doing it because you've agreed to, then there's no harm in it. If someone forces you and even doesn't pay you, then it's wrong," he

Both Dilaik and Shukla are currently starring in Pati Patni Aur Panga. The reality show features famous couples and it premiered on August 2 on Colors TV and JioCinema.

Dilaik, who has also been a part of other reality shows like Bigg Boss, Khatron Ke Khiladi, Jhalak Dikhhla Jaa, and Laughter Chefs, said she has always been authentic in front of the camera.

"I don't have to create a facade or act differently, or think about what will be the impact if I say or do a certain thing; I don't do any of it, I'm authentic, and so is our relationship," she said.

GAMBHIR-AGARKAR EFFECT: BCCI UNLIKELY TO ALLOW STARS TO PICK AND CHOOSE GAMES GOING FORWARD

NEW DELHI, Aug 5: Gautam Gambhir has always been against the mega-star culture prevailing in Indian cricket but Mohammed Siraj's Herculean effort throughout the English summer has definitely given the Indian head coach a real shot in the arm.

The creditable 2-2 series draw in England will certainly empower Gambhir and chairman of selectors Ajit Agarkar to crack the whip and usher in a uniform team culture where certain individuals who would not be treated more than equals as it happened in recent years. It is understood that the selection committee, Gambhir and the decision makers in the Indian cricket board are all on the same page with regards to putting an end to players picking and choosing games and series in the pretext of workload management.

"There have been discussions and the message will be sent across to the centrally contracted players, especially those who are all format



regulars that this culture of picking and choosing games won't be entertained in near future," a senior BCCI official privy to current happenings told PTI on conditions of anonymity.

"It doesn't mean that workload management will be thrown out of the window but a more objective approach is expected in near future. Obviously, fast bowlers' workload needs to be managed but it can't be accepted that in the name of workload management, people will miss crucial matches.'

Siraj, who sent down 185.3 overs across five Tests, not to forget the hours of fielding and also overs bowled in the nets during the last six weeks is a shining example of what peak fitness looks like. More importantly, the performance of Siraj, Prasidh Krishna and Akash Deep has proved that even the biggest of stars are dispensable and no one is bigger than the team.

Even England skipper Ben despite multiple issues bowled marathon spells till the end of the fourth Test raising debates whether workload has become an "overrated concept" used for con-

Former India skipper Sunil Gavaskar ripped apart the over-usage of workload management.

When you are playing for your country, forget the aches and the pains. On the border, do you think that the jawans are complaining about cold? What did Rishabh Pant show you? He came out to bat with a fracture. That is what you expect from the players. Playing cricket for India is an honour," Gavaskar told 'India Today'. "You are representing 140 crore people and that is what we saw in Mohammed Siraj. I think Siraj bowled his heart out, and he debunked forever this business of workload. For five Test matches, non-stop he has bowled 7-8 over spells, because the captain wanted him and the country expected of him," added the former skipper.

Mboko reaches semifinals in **Montreal** and will face Rybakina



MONTREAL, Aug 5: Canadian teenager Victoria Mboko advanced to her first career WTA Tour semifinal with a 6-4. 6-2 win victory over Spain's Jessica Bouzas Maneiro on Monday night at the National Bank Open.

Two days after ousting No. 1 seed Coco Gauff in just 62 minutes, there was no letdown for the 18-year-old from Toronto.

After taking a back-and-forth — and error-filled — first set, Mboko was broken in a sluggish start to the second set but broke back in the fourth and sixth games to take a 4-2 advantage.

Mboko is the first Canadian to reach the WTA 1000 event's semifinals since Bianca Andreescu's title run in 2019. She's also the youngest woman to reach the semis since Belinda Bencic's 2015 win in Toronto.

Mboko will face Elena Rybakina, who led Marta Kostyuk 6-1, 2-1 when the Ukrainian was forced to stop playing because of an apparent arm injury.

Rybakina, the No. 9 seed from Kazakhstan, converted three of her 10 break-point chances in the quarterfinal matchup at IGA Stadium. The players shook hands at the 54minute mark before the 24thseeded Kostyuk exited the court in tears.

After the third game, Kostyu's trainers wrapped her forearm in medical tape.

In a breakthrough year, Mboko has surged from outside the top 300 to a career-high No. 85. That number is projected to climb to at least No. 55, according to WTA live rankings.

After two injury-plagued years, Mboko — who had shown promise as a junior opened the season with a 22match win streak and captured five titles on the lower-tier ITF

She then qualified for her first Grand Slam main draw at the French Open, reaching the third round, before stunning 25thseeded Magdalena Frech in the first round at Wimbledon.

And the upsets keep coming. In Montreal, Mboko has rattled off wins over 79th-ranked Kimberly Birrell, No. 23 seed Sofia Kenin, 39th-ranked Marie Bouzkova and Gauff, who is ranked No. 2.

Her latest victory boosted her record to 25-8 against higherranked players and 51-9 in all competitions.

In the other quarterfinals Tuesday, No. 6 seed Madison Keys — the highest-seeded player remaining — faces No. 16 Clara Tauson, and former No. 1-ranked Naomi Osaka

Olympic medal changed my life but I have already forgotten it: Aman Shehrawat

LUCKNOW, Aug 5: The Paris Olympics success took a lot of burden off Aman Sehrawat's shoulders but the young wrestler says he has already forgotten his bronze-medal feat, as sitting on past laurels won't let him chase bigger dreams.

Orphaned at a tender age, life has not been a bed of roses for the Birohar-born wrestler. His paternal uncle supported him wholeheartedly but family responsibilities did weigh on Aman's mind.

His bronze-winning show in Paris last year brought recognition and money that made his life easy, as Aman carried on the country's tradition of bringing home a medal in wrestling from every Olympic Games since 2008.

"The Olympic medal changed my life 90 per cent. No one knew me before. I would not be noticed anywhere, but after the Paris success, people began to know me, respect me. I felt I did something for the country and the hard work of 10-15 years has paid off," Aman

told PTI after winning the 57kg selection trials for the World Championships

"An Olympic medal is God's blessing. I was not even expected to win. Expectations were higher from the women wrestlers. Ye to prasad hi hai bhagwaan ka (This is God's gift).

"It motivated me as well. People are now expecting gold from me. I have already forgotten my bronze medals; I can't settle for that and say I have achieved enough. Now I am preparing for gold.'

Elaborating how success at the highest level had changed his life, the soft-spoken wrestler said, "I can buy whatever I want now."

"There was pressure that in future I need to get my younger sister educated and get her married. Now I can practice with a free mind; I don't need to worry about money."

"It's not that we were not taken care of. My uncle has always supported us, but you do think about the responsibility of being an elder



brother.'

As an individual, Aman hasn't changed much. Rather he is now more cautious about making decisions, being an Olympic medallist. He attributed his absence from

ner's purse of Rs 1 crore, will be competed for the first time over nine rounds in classical round robin format across Masters and Challengers segments. The tournament, which was played over seven rounds in the previous two editions, will see participation from 19 Grandmasters and will offer crucial FIDE Circuit points. The points will be vital for securing a spot in the 2026 Candidates Tournament, just like it helped eventual world champion D Gukesh to enter the Candidates.

Erigasi, who has broken into the elite 2800 FIDE rating club, will also face strong challenge from promising Nihal Sarin and Germany's 20-year-old Vincent Keymer, who was Gukesh's second during last year's World Championship. But his toughest competitor will be Giri, who brings a wealth of experience and a super-solid style that makes him one of the tournament favourites.

Apart from the established names, India's Pranav V and Karthikeyan Murali too are capable of effecting some stunning results.

As for the format, the latest edition marks a significant expansion, growing into a 20-player event split into two distinct 10-player sections: the Masters and the Challengers.

This new structure provides a direct pathway for rising stars to compete at the highest level, with the Challengers winner earning a guaranteed spot in the 2026 Masters.

Meanwhile, the Challengers section features some equally exciting talents in D Harika, who was a part of the gold winning women's team at the 45th Chess Olympiad last year. R Vaishali, Harshvardhan GB, Abhimanyu Puranik experienced Grandmaster Adhiban Baskaran. who is known for his aggressive style, will also be in contention.

An English Summer to Remember: Team in transition passes trial by fire

pected out of Shubman Gill and his team when they landed in England roughly two months ago. Five fiercely fought Tests later, the relatively inexperienced bunch not only exceeded expectations, it also gave a fine blueprint for the future.

In the words of two captains, Gill and his rival number Ben Stokes, 2-2 is probably a fair result after a 45-day slugfest. The two games that India lost, the seriesopener at Leeds and the third Test at Lord's, could have easily gone the other way around but those are the learnings that the players would take back home.

The times Gill and his men looked down and out, specifically Lord's, Old Trafford and The Oval, they refused to give up and on two occasions made a gladiatorial comeback that would aptly sum up the spirit of this team.

PTI looks back at the iconic moments of the series and the contributions of the players who came of age during the series or are returning home wiser.

Young leaders would dream of what Gill managed to achieve in his first series as Test captain. Having not done well in English conditions during past outings, there was a major question mark over his abilities as a batter, not to forget as cap-

Gill needed to earn the respect of the dressing room and he did that with a stel-

lar 147 in his first innings of the tour. Having made a few technical and mental adjustments, Gill took his game to the next level and what followed was a double hundred and a hundred in the emphatic win at Edgbaston.

Gill had his issues against the incoming ball but he found a way to deal with them. After the low returns at Lord's, Gill came up with his most significant knock of the tour -- a match saving 103 in Manchester. In the end, he aggregated a staggering 754 runs in 10 innings.

Gill came of age as a batter but as captain, he knows he remains a work in

On Monday, he was lauded for keeping the fielders in the deep with England nine down and 17 runs away from the target. He also kept it simple by not taking the new ball when the old one was aiding Mohammed Siraj and Prasidh Krishna.

Mohammed Siraj, the only fast bowler on either side to play in all five Tests, fittingly took the final wicket of the series at The Oval and ended up as the leading



wicket taker with 23 scalps. With the peerless Jasprit Bumrah not around for two Tests due to workload management, Siraj rose to the occasion. Like opposition captain Ben Stokes, he put his hand up when a few extra overs needed to be bowled to maintain pressure.

Questions over Bumrah's fitness will remain and his future in the longest format is unclear. But trust Siraj to be around to nurture the new crop of pacers.

In the words of bowling coach Morne Morkel, India need a batch of five to six fast bowlers to be ready for the physically punishing assignments of England and Australia.

Jadeja's exploits flew under the radar when the likes of Virat Kohli and Rohit Sharma were around. With the superstars now retired, Jadeja had to make up for the inexperience in the batting depart-

With 516 runs in the middle order including five fifties and a rearguard hundred at Old Trafford, the 36-year-old ended up having a series to remember.

In case of a collapse, Jadeja stood in the middle like a rock, averaging the

highest among the Indian batters with four not outs in the series.

The series will be remembered for its highly competitive nature. The first two Tests were played in a relatively incidentfree environment but with stakes getting higher, on-field tensions between the two team added to the spice.

The most significant of those moments was Jasprit Bumrah's final over at Lord's on day three.

Captain Shubman Gill asking Zak Crawley to grow some **** and the whole team sarcastically clapping at the England opener for delaying the proceedings will forever be talked about in the context of India-England rivalry.

On-field tensions became the norm after that incident including at Old Trafford where Stokes showed his frustration at India choosing to bat in the mandatory last 15 overs of the day despite draw being the only possible result.

What also lifted the profile of the series was the iconic acts of heroism from Rishabh Pant and Chris Woakes.

While Pant came out to bat with a fractured foot to add crucial runs in the first innings in Manchester, Woakes, already ruled out of the game due to a shoulder injury, came out to bat on day five of the final Test with the series on the line.

His left hand was tied with a sling and he was in no position to bat but he was still out there fighting for his team, summing up the intensely competitive environment of the series.

The most assured batter on either side of the dressing room was undoubtedly K L Rahul. In majority of his innings, he put up a masterclass of batting in English conditions. He played the ball late and close to his body, frustrating the bowlers with his water tight technique.

Besides Gill and Jadeja, he was the other Indian batter to tally more than 500 runs in the series including two hundreds.

In the lower-order, the poise of Washington Sundar stood out and he also made a telling contribution with his off-spin in Manchester. India remained firm on having batting till eight and Washington ensured the team did not have to move from its chosen path.

His gutsy hundred alongside Jadeja to save the game at Old Trafford sealed his place in the eleven for the foreseeable future and at The Oval, he showed he can seamlessly shift to attacking when re-

I hope workload management disappears from Indian cricket dictionary: Gavaskar after Siraj heroics

LONDON, Aug 5: Mohammed Siraj has "debunked forever this business of workload", said India batting great Sunil Gavaskar, questioning the concept by asserting that playing for the country should be enough to "forget the aches", something that soldiers guarding the nation are doing

LONDON, Aug 5: Mohammed Siraj's admiration for Jasprit Bumrah is well known, and the genial Hyderabadi said he sorely missed the pace spearhead's presence in his hour of glory following India's victory in the fifth Test against England here.

Siraj grabbed a five-wicket haul in the second innings of the fifth Test at The Oval as India defeated England by six runs in a thriller to draw the series 2-2 on Monday.

Siraj's nine-wicket haul in the game not only earned him the 'Man of the Match Award' but also brought him accolades from his legion of fans.

"Every batsman, every bowler (who played the Test), hat's off to him... and the way we came back, crazy man. I miss Jassi (Bumrah) bhai because had he been there, it would have been special. I believe in Jassi bhai and myself," said an emotional Siraj in a video posted

Bumrah did not play the final Test to manage his workload and was subsequently released from the Indian squad after playing the fourth game.

Siraj seemed determined on the final day after dropping a catch of Harry Brook on Sunday. Every ball he bowled in the morning session on Monday tormented the English

Test of skill and nerves: List of closely-fought series - From Gabba to Centurion to Mumbai



NEW DELHI, Aug 5: After 25 days of entrancing Test cricket, India and England shared the Anderson-Tendulkar Trophy 2-2, adding another glossy page to the long-

list of intensely-fought rubbers. But it wasn't the first time that things went right down to the wire in the game's oldest format and left fans asking for more even after a lengthy series that lasted well

over a month. PTI collates a few memorable showdowns in the last decade and half that had the quintessential crests and troughs of

Test cricket. Possibly, one of the best series in the history of the sport where India towered over several obstacles, including injuries to key players, to etch a 2-1 victory over Australia.

From the all-time low of 36/9 in Adelaide to the three-wicket Gabba heist. India, led by stand-in skipper Ajinkya Rahane, quietly pulled the rug from under the feet of unsuspecting Aussies in their own backyard.

This series, perhaps, marked the beginning of India's power run through Test cricket for the next decade under a new captain, Virat Kohli. Sri Lanka shocked India by 63 runs at Galle despite the latter

taking a substantial 192-run lead. But India imbibed Kohli's never-say-

die attitude in the next two games in Colombo (at the P Sara Oval and SSC), winning them by 278 and 117 runs respectively to bag the series 2-1.

It was the last Test series where the famed trio of Sachin Tendulkar, Rahul Dravid and VVS Laxman made a collective impact.

After an innings and 25-run drubbing at Centurion, India came back strongly to win the Durban Test by 85 runs where Laxman made a 96 against the rampaging duo of Dale Steyn and Morne Morkel, a performance that will stand the test of

In the final Test at Cape Town, India had a full Day 5 to survive and they did it through Gautam Gambhir (68 off 184 balls), Dravid (31, 112 balls), Tendulkar (14 not out off 91 balls) and Laxman (32 not out off 67 balls).

Proteas spinner Paul Harris conceded just 29 runs off 30 overs with 19 maidens. The four-match series appeared to be travelling on the familiar route once India hammered England by nine wickets at

Ahmedabad. But inspired by Kevin Pietersen's hundred that was touched by genius, England under Alistair Cook stunned India by 10 wickets at Mumbai before eking out a seven-wicket victory at the Eden Gardens.

On a Nagpur flatbed, England easily drew the fourth Test to win the series 2-1. leaving India shattered. Joe Root made his debut in that Test. It was a battle between new age pacers

Africa had Kagiso Rabada and Vernon Philander, while the Aussies showcased Mitchell Starc and Josh Hazlewood. The Proteas pacers had more fire in

from South Africa and Australia. South

them as they scythed through opposition for wins at Perth and Hobart before the home side pulled one back in the daynight Test in Adelaide.

It was Australia's first home series defeat after 2008.

Once New Zealand set foot in Abu Dhabi, predictions were on for a 3-0 whitewash against a spin-heavy Pakistan. But the Kiwis won the first Test by a slender margin of four runs, and Pakistan replied with an innings at 16-run victory at Dubai

But in Abu Dhabi, the Kiwis found an unlikely hero in off-spinner William Somerville, who had played just six Tests in his short career at that stage. His sevenwicket match haul powered the visitors to a 123-run win and sealed the series 2-1 in their favour.

The series was held behind closed doors during the COVID-19 pandemic but it was a classic where the two teams traded blows like two snarling boxers.

After a rather mundane draw at Nottingham, it came alive with India's 151run win at the Lord's, after which England retorted with an innings and 76-run drubbing at Leeds.

India won the fourth Test at the Oval by 157 runs before the tour was suspended in September 2021 due to members of the visiting team testing positive for COVID.

England panicked, they just needed one partnership: Vaughan

LONDON, Aug 5: Former captain Michael Vaughan feels England panicked on the final day of the fifth Test against India in the absence of inspirational skipper Ben Stokes, with only 35 runs needed to win and four wickets in hand. England eventually lost the match by six runs as India made a stunning comeback to draw the five-match series 2-2 on Monday.

"...Ben Stokes in that team, England would've won this Test match. He plays such a big role in this team, the mentality... England did panic (on the fifth morning).

"They just needed one partnership. They panicked in the way that they can with the way that they play, they play with a huge amount of aggressiveness. Yesterday (Sunday) afternoon, the Harry Brook dismissal did cause that collapse, but it's the way England play," Vaughan told BBC's Test Match

Stokes, who played a pivotal role for England with both bat and ball, missed the fifth Test due to a shoulder injury, while pacers Jofra Archer and Brydon Carse were rested. Vaughan said the thrilling series against India should be a perfect preparation for England for the this year's Ashes in Australia, starting in November. "It's been a tremendous five matches for England. You've got to be realistic, this week they were down to 10 men, lost one of their bowlers early, and not got Ben Stokes. You're looking at the team going to Australia and I think there's more pieces in place. "We'll arrive in Perth for that first Test and know the top seven. It's just a matter of the bowling attack and getting that right. Clearly Ben Stokes is going to have to get fit. With Ben Stokes in the England side they can beat anybody. Without him, they can lose to anybody," Vaughan said.

England looked on course for a historic win with Harry Brook and Joe Root taking the home team to 301 for three on the fourth day before Brook was caught by Mohammed Siraj off the bowling of Akash Deep. England then lost two more wickets, including Root before the end of the fourth day's play. "(Harry) Brook had that thought process that he wanted to hit 30 or 40 quick runs. What Harry needs to learn is in an Ashes series, in a similar situation, just win. I love the way he plays, his approach. At times, he's a genius. He plays the game in a fashion not many have ever played," Vaughan said. (PTI)
