# Govt working on support measures to help exporters deal with 50 pc US tariff

ernment is working on extending support measures for exporters such as rollout of export promotion mission, and moratorium on loans to help them insulate from the impact of US's 50 per cent tariffs on Indian goods, an official said on Thursday.

The government official also said this is a wake-up call and opportunity to diversify the export

Exporters have sought help at the liquidity front and these suggestions are under consideration, the official added.

"The government is seized of issues being faced by exporters, and positive work is going on to help them," the official said adding diversification of exports, implementation of new free trade agreements (FTAs), rolling out of support measures and growing domestic market will help provide cushion to the industry from the impact of US tariffs. The other measures which are under consideration include emergency credit line guarantee scheme for MSME exporters in tariff-hit sectors, moratorium on export loans to allow exporters operational space without asset downgrades, and extension of export realisation period to ease cash flow challenges caused by longer payment cycles.

"The government is trying to speed up the rollout of the export promotion mission and expediting the e-commerce export hub scheme," the official said.

The government is considering support measures worth about ₹ 25,000 crore for exporters under this mission, announced in the Budget, for six financial years (2025-2031). It is proposed to be implemented through two sub-

Exporters are seeking measures such as resumption of interest subsidy for five years, export credit support to sustain working capital and liquidity, low cost of credit and easy availability of loans, moratorium on payment of principal and interest for loans up to a period of one year. They have stated that it is difficult to export to the US with these high tariffs.

"We are considering their suggestions. We are trying something tangible with long term benefits," the official said, adding the industry is worried but the losses from these tariffs would be there only in the short run. Exporters that are dependent

India's exports to the US during the first four months of this fiscal year have risen 21.64 per cent to USD 33.53 billion. It was USD 86.5 billion in 2024-25. About half of this is out of the ambit of 50 per cent tariffs.

The US accounted for about 20 per cent of India's USD 437.42 billion worth of goods exports in 2024-25. America has been the largest trading partner of India from 2021-22. In 2024-25, the bilateral trade in goods stood at USD 131.8 billion (USD 86.5 billion exports and USD 45.3 billion imports).

Meanwhile, exporters body FIEO said that Finance Minister Nirmala Sitharaman on Thursday assured an exporters' delegation that the government stands firmly with them in this challenging time and is committed to addressing their concerns, while exploring every possible avenue to safeguard their interests amidst high US tariffs. The assurance was given to a delegation of the Federation of Indian Export Organisations (FIEO) led by its President S

They apprised her of the challenges faced by Indian exporters due to the recent escalation of tariffs imposed by the United States.

"The Finance Minister reassured the delegation that the government stands firmly behind Indian exporters in this hour. She emphasized that the government is committed to addressing all concerns of the exporting community and will explore every possible avenue to safeguard their interests," the FIEO said. (PTI)

#### CBI arrests Airtel

to issue unauthorized SIM cards without the knowledge of the persons in whose name SIM cards were officially issued. According to the modus operandi adopted to sell a "ghost SIM card", when a customer seeks a SIM, the point-of-sale person gets an e-KYC done and issues a SIM. Scamsters lie to the customers that their e-KYC had failed and they should try again. The SIM generated for the first time was handed over to the customer while the second one - the "Ghost SIM" - was sold to cybercriminals without the genuine customers knowing that a SIM generated in their name was being used by scammers, the officials said

These "ghost SIM cards" were then used not only to deceive the victims, but also to create mule bank accounts to receive the money, which were later closed to avoid detection or reveal the money trail, they said.

These sales were done by violating the laid down guidelines and procedures. These SIM cards were sold illegally in bulk to various middlemen at high cost and later these cards were used in commission of various cyber crimes," a CBI spokesperson said in a statement.

Aimed at curbing the sale and misuse of unauthorized SIM cards being sold through distributors/PoS agents, the CBI crackdown resulted in seizure of incriminating evidences like mobile phones, electronic devices and copies of KYC documents, etc, she said. "This action underscores the government of India's resolute commitment in combating cyber crimes and in bringing its perpetrators to face the law and also special focus in dismantling the infrastructure which facilitates such crimes," the spokesperson said. #### Benefit from Russian oil

of Russian crude oil or its refined products. At present, India imports 36 per cent of its oil needs from Russia. Of the 5.4 million barrels per day (mbpd) of imports, 36 per cent (1.8 mbpd) of crude oil came from its top supplier, Russia, in 2024-25. Other key suppliers of crude oil to India are Saudi Arabia (14 per cent), Iraq (20 per cent), the UAE (9 per cent) and the USA (4 per cent). While many EU countries have banned imports of Russian oil, a price cap was introduced for other countries purchasing Russian crude oil. Indian imports have adhered to this price cap. Russia exports about 4.3-4.8 mbpd (total output of 9.2 mbpd), which is about 5 per cent of the overall crude oil supply. Besides India, China is the other big importer of Russian crude oil, with an estimated 2 mbpd of oil imported from the country over the past year. Stating that the net benefit from discounted Russian crude is much lower than media reports, CLSA said the headline price discount for Russian crude versus Dubai crude appears large due to its USD 60 price cap, particularly at times when the Brent crude price rises above USD 75 per barrel.

"However, the net gain to Indian importers is far smaller than this visible discount, as there are several shipping, insurance and reinsurance-related restrictions for Russian crude. Therefore, Indian refiners import Russian crude on a cost, insurance and freight (CIF) basis, landed in India. Thus, the landed price of Russian crude is at a far lower discount," it said. Indian oil marketing companies (OMCs) have highlighted that the discount of Russian crude averaged around USD 8.5 per barrel in FY24, but this discount fell to USD 3-5 in FY25 and has declined to about USD 1.5 per barrel in the recent months.

"Using an average discount of USD 4 per barrel would imply a total annual advantage of just USD 2.5 billion captured by Indian importers in FY25, ie, equal to 0.6 bps of India's GDP. However, current discounts would take down the annualised gains from this import to just USD 1 billion," the report said.

Although it is simplistic to look at Russian crude oil imports in isolation, refining is a business where one would need to keep a balanced slate of input crude. So, a higher share of the inferior quality Russian crude would require refineries to also buy a bigger share of better quality, more expensive crude oil. Therefore, to know the real gains of Russian oil imports, one needs to check if there are gains in the average price of crude imported by India.

"To our surprise, the import data of the government reveals no clear gains from Russian oil imports, as the unit price of Indian crude oil imports has moved from a discount versus Dubai pre-FY22 to a premium over the past couple of years. So, any such large gain is not discernible from the Indian oil import data," it said.

It went on to state that the price of crude oil, which is converted into fuels such as petrol and diesel, could rise to USD 90-100 per barrel if India stops importing Russian oil. "With only a few buyers purchasing Russian crude, any stoppage from India may make it difficult for Russia to find buyers for possibly 1 million bpd or 1 per cent of global supply in the near term. Although India should be able to easily secure supply from other sellers, such a supply disruption could drive a spike in crude oil price to USD 90-100 per barrel and would drive up inflation across the world, in our view." CLSA argued that Indian imports of Russian oil provide a much-needed check on crude oil prices, as well as curbing the risk of global inflation. "Economics aside, we believe the issue of Russian crude oil imports has now become a political one with India reiterating its freedom to choose its trade partners within the purview of global trade rules." #### FIR in Assam: SC

BNS.It said the video uploaded by the petitioner stems from a recent Gauhati High Court proceeding with respect to such allotment. "The petitioner's statements are not fabricated assertions but grounded in verifiable facts which were supported by original video clips of speeches made by the chief minister of Assam. The criticism of government policies, functioning, or political strategies do not amount to an offence under Section 152 BNS," the plea submitted. It said in a democracy, elected representatives remain open to public scrutiny and criticism and at no point does Sharma call for violence, insurrection, or public disorder.

"The present FIR is a classic case of misuse and abuse of Section 152 BNS to stifle dissent and journalistic freedom. Criminal prosecution under a provision carrying life imprisonment, against a journalistic video is grossly inappropriate to be a constitutional affront," the plea said. The plea submitted that Section 152 of the BNS is a "reincarnation" of the sedition provision (Section 124-A of the erstwhile Indian Penal Code), which is under judicial scrutiny by the apex court "due to its vagueness". The plea said the top court had earlier observed that authorities would restrain from registering any FIR under Section 124-A of IPC or continue with pending investigation under this provision. "The instant case is not an isolated instance but forms part of a larger pattern of repeated misuse of criminal provisions akin to sedition against journalists and critics of the government," it submitted. The plea claimed that journalists across the country were subjected to FIRs and prosecutions for merely reporting or commenting on governmental policies and political developments. The plea said the petitioner merely exercised his fundamental right to freedom of speech and press by reporting and critically commenting on political speeches already in the public domain. (PTI)

#### India, Saudi explore joint

"India and Saudi Arabia share a steadily deepening defence partnership," it added. It is reflected by the addition of a ministerial committee on defence cooperation under the strategic partnership

council during the visit of Prime Minister Narendra Modi to Saudi Arabia in April, the ministry said. The meeting was co-chaired by Joint Secretary Amitabh Prasad from the Indian side and Maj Gen Saad Mohammed H Alkathiri from the Saudi side. (PTI)

Moreover, another area of concern is that the Tea Board "does not have a proper trace of re-exports and a software application can easily be put in place, which will monitor imports and re-exports", they added. 'We appeal that a task force be formed to investigate the whole import matter in a holistic manner. The task force should also recommend measures to protect the Indian tea industry," another member of the delegation said

The Tea Board's regulation of routing 100 per cent dust-grade tea through public auctions has also created financial distress for the tea industry, they claimed. The Tea Board had thought of having a single point of sale for better price realisation, but there are five auction centres in North India - Kolkata, Siliguri, Jalpaiguri, Guwahati and Jorhat, the tea associations said. 'The auction dates are different, buyers are different, selling/buying prices are different, qualities of teas offered are different and so on. Therefore, in any case with five auction centres, it is not a single point of sale," the three tea bodies pointed out. The members of these associations claimed that they know their business and will automatically sell through auction if price realisation is better.

'All of us sell through both auction and private modes depending upon market dynamics from time to time, and therefore forceful regulation by the Tea Board to sell only through auction is not required," another member of the delegation said. These tea associations appealed to the authorities to withdraw the order issued on July 25 on the routing of 100 per cent dust grades through auction. They also claimed that tea growers and the industry are "suffering from a non-compliance situation because of a letter from the Tea Board to FSSAI to put six off-label pesticides under compulsory testing". 'We appeal to the Tea Board to withdraw that letter to FSSAI, and we are ready to adhere to compliance as per statute, but there shouldn't be over regulations', they stated. #### The commerce ministry is also Manufacturing pushes industrial output 1.72 lakh people died in 4.80 lakh road accidents in 2023: growth to 4-month high of 3.5 pc in July

NEW DELHI, Aug 28: The number of road acci-2025, led by a broad-based improvement across all the sectors. dents in India went up by 4.2 per cent to over 4.8 lakh in 2023, resulting in death of 20 persons every hour, according to a report by Ministry of Road Transport and Highways (MoRTH).

The report showed that 55 road accidents take place every hour in the country

Road Ministry report

"A total number of 4,80,583 road accidents have been reported by Police Departments of States and Union Territories (UTs) in the country during the calendar year 2023, claiming 1,72,890 lives and causing injuries to 4,62,825 persons," the report titled 'Road accidents in India 2023' said.

For the fourth consecutive year in 2023, the report said the fatal road accident victims largely constitute young people in the productive age groups.

"Young adults in the age group of 18 - 45 years accounted for 66.4 per cent of victims during 2023.

"People in working age group of 18 – 60 years share 83.4 per cent of total road accident fatalities," it said. According to the report, during 2023, a total of 4,80,583 accidents were recorded in the country, of which, 1,50,177 (31.2 per cent) took place on the National Highways (NH) including Expressways, 1,05,622 (22.0 per cent) on State Highways (SH) and the remaining 2,24,744 (46.8 per cent) on other roads.

Out of the total of 1,72,890 fatalities reported in 2023, the report said 63,112 (36.5 per cent) were on National Highways, 39,439 (22.8 per cent) were on State Highways and 70,339 (40.7 per cent) were on other roads.

Out of the total 1,60,509 fatal accidents reported in 2023, 57,467 (35.8 per cent) were on National Highways, 36,595 (22.8 per cent) on State Highways and 66,447 (41.4 per cent) were reported on other roads.

Amongst the states, the report said Tamil Nadu recorded the highest number of road accidents on National Highways in 2023, whereas, the number of persons killed in road accident was the highest in Uttar Pradesh. The report noted that road accidents are multi-causal and are often the result of interplay of various factors like human error, road environment and vehicular condition. (PTI)

duction) growth slowed to 7.7 per cent during the reporting month against a growth of 8.2 per cent in July 2024. In July 2025, consumer non-durables out-

put recorded a meagre growth of 0.5 per cent as against a contraction of 4.2 per cent a year ago. Infrastructure/construction reported a growth of 11.9 per cent in July 2025, up from a 5.5 per cent expansion in the year-ago period.

The data also showed that the output of primary goods contracted by 1.7 per cent in July 2025 against 5.9 per cent growth a year earlier. The expansion in the intermediate goods segment was 5.8 per cent in the month under review against 7 per cent a year ago. (PTI)

# Major roads, residential areas of capital under water Heavy rain inundates Guwahati for 2nd day IMD predicts more rains

**GUWAHATI, Aug 28:** Life in Assam's capital was thrown out of gear on Thursday following a spell of heavy rain that submerged almost all peripheral roads and several residential areas, leading to massive traffic jams.

The India Meteorological Department (IMD) has predicted heavy to very heavy rainfall with thunderstorms and lightning across the city over the next 24 hours.

The city witnessed continuous rainfall for 2–3 hours in the afternoon, which led to knee-deep water on several major and minor roads, while at some locations the water rose to chest level.

Waterlogging was reported from Zoo Road, RG Baruah Road, GS Road, Nabin Nagar, Anil Nagar, Hatigaon, Ganeshguri, Gita Nagar, Maligaon, Hedayetpur, Guwahati Club, Ulubari, Lachit Nagar, Chandmari, Panjabari,

Jorabat, Tarun Nagar, Jatia, Jyotikuchi Ghoramara, VIP Road, Rajgarh Road, Jorabat, Rukmini Gaon, Survey and Chatribari, among others.

Scores of vehicles broke down, while hundreds of houses in the "smart city" were also inundated.

Severe waterlogging on stretches of National Highway-27 also left dozens of vehicles stranded. Authorities deployed inflatable rubber

GUWAHATI, Aug 28: Union Home Minister Amit Shah arrived here on Thursday, beginning his two-day visit to the state, which includes attending the Assam BJP's core committee meeting to discuss issues related to the assembly polls scheduled in the state next year. Shah, who arrived on a BSF air-

## FIR in Assam: SC grants four-week interim protection to journalist Abhisar Sharma

NEW DELHI, Aug 28: The Supreme Court on Thursday granted interim protection for four weeks to journalist Abhisar Sharma in an FIR lodged against him in Assam over a video post allegedly criticising the state's poli-

A bench of Justices M M Sundresh and N Kotiswar Singh refused to entertain his prayer challenging the FIR lodged against him in Assam and asked him to approach the Gauhati High Court.

It, however, issued notice to the Centre seeking its response on his prayer challenging the validity of Section 152 of the Bharatiya Nyaya Sanhita (BNS), which deals with acts endangering the sovereignty, unity and integrity of India.

"In so far as the challenge to the FIR is concerned, we are not inclined to entertain. However, we are inclined to give interim protection to the petitioner (Sharma) for a period of four weeks so as to enable him to approach the high court," the bench said.

Senior advocate Kapil Sibal, appearing for Sharma, said Section 152 of the BNS seems to have become an "omnibus provision" which can be invoked against any-

The bench asked him to challenge the FIR before the high Sibal said the top court has al-

ready interfered in a similar matter which was pending. "We will give you protection,

you go there (high court)," the bench said, adding, "Why are you bypassing the high court?" Sibal said another FIR might be

lodged against the petitioner. The bench observed another FIR might be lodged even if the apex court would entertain the plea.

Sibal said the apex court was already dealing with a separate plea raising similar issue and "some uniformity should be there".

## Assam tea associations express concern over increasing imports

GUWAHATI, Aug 28: Major tea associations in Assam have expressed concern over increasing imports, particularly from African countries, and called for the constitution of a task force to protect the industry, a release said on Thursday.

A delegation of Assam Bought Leaf Tea Manufacturers Association (ABLTMA), Bharatiya Cha Parishad (BCP) and North Eastern Tea Association (NETA) called on Tea Board India's Deputy Chairperson Arunita Phukan Yadav and submitted a memorandum on issues related to imports, routing of 100 per cent dust grade tea through auctions and compliance of norms of the Food Safety and Standard Authority of India (FSSAI) on the use of pesticides, it said.

'We are concerned about teas from African countries entering the Indian market without paying duty or through other means, which will kill the Indian tea industry," the tea

associations claimed. As per the official figures of the Tea Board of Kenya, the exports from the African country to India increased by 45 per cent during the January-June period this year, as compared to the same period last

year, they said. The imports in 2024-25 have doubled compared to 2023-24, the tea associations said. In 2023-24, it was 25.21 mkgs, whereas in 2024-25, it reached 50.14 mkgs.

"Surprisingly, this data does not match that of the Directorate General of Commercial Intelligence and Statistics (DGCI&S), and this nonmatching has created more suspicion in our minds," one of the members of the delegation claimed.

The majority of the tea was imported from Kenya (17 m kgs) and Nepal (15 m kgs) in 2024-25, they claimed. (CONTD.ON PAGE-2)

NEW DELHI, Aug 28: All of India's 1.4 billion people live in areas where annual average particulate pollution levels exceed the WHO guideline and even those in the cleanest regions of the country could live 9.4 months longer if the air quality met global standards, according to a new report.

The Energy Policy Institute at the University of Chicago's (EPIC) 2025 report said PM2.5 concentrations in India in 2023 were higher than in 2022.

These levels are more than eight times higher than the WHO guideline and reducing them to permanently meet the global standard would add 3.5 years to the average life expectancy of Indians. According to the WHO's 2021 air quality

guideline, the annual average limit for PM2.5

is 5 micrograms per cubic metre, while for PM10 it is 15 micrograms per cubic metre. These limits are far stricter than India's own standards, which currently allow 40 micrograms for PM2.5 and 60 micrograms for



The report said 46 per cent of India's population lives in areas where annual PM2.5 levels exceed the national standard of 40 micrograms per cubic metre. Meeting this

standard could increase the life expectancy of people in these regions by 1.5 years. In the most polluted region of the country, the Northern Plains, 544.4 million residents

or 38.9 per cent of India's population could gain five years of life expectancy on average if particulate concentrations met the WHO

If all of India were to reduce particulate pollution to the WHO guideline, residents of Delhi, the capital and the most populous city, would see the maximum benefits, gaining 8.2 years of life expectancy.

Outside Delhi and the Northern Plains, Rajasthan, Madhya Pradesh and Maharashtra face the highest health burden from particulate pollution. Reducing it to the WHO guideline could add 3.3, 3.1 and 2.8 years respectively to the average life expectancy in these states.

India launched the National Clean Air Programme (NCAP) in 2019 with the goal of reducing 2017 particulate pollution levels by 20-30 per cent by 2024. In 2022, the government revised the target to a 40 per cent reduction by 2026 in 131 non-attainment cities.

If this target is achieved, residents of these cities would see their life expectancy rise by two years compared (CONTD.ON PAGE-2)

#### Bonhomie between Islamabad and Dhaka

The last week was full of hope and consternation both for the Indian diplomatic community. On the one hand, the Chinese Foreign Minister met the Prime Minister Modi in Delhi. The Ministry of External Affairs described the talks as fruitful. But what rattled the Indian diplomats more, was the visit of Pakistan's Commerce Minister and Foreign Minister to Dhaka and the Chinese Foreign Minister travelling to Islamabad to meet his Pakistani counterpart, in addition to other military visits. Modi hailed the "steady progress" made in improving the bilateral relationship, after his meeting with the Chinese Foreign Minister Wang Yi. On its part, China's Ministry of Foreign Affairs said that the two countries have entered a "steady development track" and they "trust and support" each other. Wang also met with Foreign Affairs Minister Subrahmanyam Jaishankar as well as National Security Adviser Ajit Doval to discuss the countries' disputed border. India's Ministry of External Affairs said Wang's meeting with Doval discussed "de-escalation, delimitation and boundary affairs." However, what was more important for the Indian diplomats was the increasing bonhomie between Islamabad and Dhaka after the fall of former Prime Minister Sheikh Haseena, who was ousted after a deadly civil

The Indian defence and security establishment, watches the increasing closeness between the two countries with serious concern. Added to this is are widespread apprehensions found in the Indian defence circles, related to the cornering of the country, as China, Pakistan and Bangladesh forge closer ties. New Delhi's concerns are particularly related to the Siliguri corridor, known as India's chicken neck. The growing Chinese and Pakistani influence in Bangladesh has also put an additional burden on the Indian defence forces, which are now stretched across the entire border. LoC and LAC. Reportedly, Pakistan's top spy officials have made frequent visits to Bangladesh in a bid to contain India's growing influence in the region. Bangladesh also sought Pakistan's support to develop the country's leather and sugar industries, he said.

Amidst all this plethora of visits, comes the news that Pakistan's Prime Minister Shehbaz Sharif will soon travel to China. His visit will mark the launch of the second phase of the China-Pakistan Economic Corridor - CPEC-II, which has been delayed for years. Pakistan now presents it as a grand plan for jobs, industry, and growth. At its core, it deepens China's grip on Pakistan's economy. Taken together, these parallel diplomatic, military, and economic engagements point to a recalibration of regional ties, with both Beijing and Islamabad seeking closer coordination with Dhaka while also reinforcing their bilateral partnership. These developments will put the Indian diplomats under pressure to pursue a course of action, which counters these three countries and as India has never indulged in such hypocritical or playing one country against another to ensure its interest, it may seem a

## Gopinath Bordoloi: Savior of Assam's identity

TAssam, stands as a towering figure in the annals of Indian history, particularly in the northeastern region. Born on June 6, 1890, in the small village of Raha in the Nagaon district of Assam, Bordoloi's life was a testament to unwavering dedication, principled leadership, and an unyielding commitment to the welfare of his people. His father, Buddheswar Bordoloi, served as a junior officer in the government's medical service, instilling in young Gopinath a sense of duty and empathy for the common folk. Tragically, his mother, Praneswari Bordoloi, passed away when he was just twelve years old, leaving him to be raised by his elder sister, Shashikala Devi. This early loss forged a resilient character in Bordoloi, one that would later define his role in shaping Assam's destiny amid colonial oppression and the turbulent

From his humble beginnings, Bordoloi displayed an academic prowess that set the stage for his future endeavors. He completed his matriculation in 1907 at Cotton Collegiate School in Guwahati, earning a scholarship that allowed him to pursue higher education. He then joined Cotton College, affiliated with the University of Calcutta at the time, where he passed his Intermediate Arts examination in 1909 with first division honors. Drawn to the intellectual vibrancy of Calcutta, he enrolled at the prestigious Scottish Church College, graduating with a bachelor's degree in 1911. His thirst for knowledge led him to obtain a Master of Arts degree from Calcutta University in 1914, followed by studies in law. Upon returning to Assam, Bordoloi briefly served as the headmaster of Sonaram High School in Guwahati, a position that exposed him to the educational challenges facing the youth of his state. However, his true calling lay beyond the classroom, in the realm of public service and advocacy for the marginalized.

Bordoloi's foray into politics was marked by a deep-seated admiration for Mahatma Gandhi and the principles of non-violence. Influenced by luminaries such as Rabindranath Tagore, J.C. Bose, and Surendranath Banerjee during his time in Calcutta, he joined the Indian National Congress as a volunteer in 1921. This was a pivotal moment, as Assam at the time had limited organized political activity, primarily through the Assam Association, which was wound up to make way for the Assam Provincial Congress Committee, Bordoloi was elected its first secretary, a role that propelled him into the heart of the independence movement. He actively participated in the Non-Cooperation Move-

promoting swadeshi. His fervor led to his arrest in 1922, and he spent a year in jail, emerging even more resolute. Though he briefly returned to his law practice in Guwahati after the movement was suspended following the Chauri Chaura incident, Bordoloi could not stay away from

ment, boycotting British institutions and

Between 1930 and 1933, Bordoloi stepped back from overt political activism to focus on social work, serving on the Guwahati Municipal Board and local boards. He championed causes like the establishment of a separate university and high court for Assam, recognizing the need for regional autonomy in education and justice. The Government of India Act of 1935 opened the doors for provincial elections in 1936, and the Congress, under Bordoloi's guidance, contested vigorously. Winning 38 seats, they formed the majority but chose to sit in opposition due to restrictive laws that curtailed ministerial powers. Bordoloi was elected Leader of the Opposition, critiquing the Muhammad Sadulla ministry for its indifference to Assam's grassroots issues. His eloquence and integrity garnered widespread support, leading to Sadulla's resignation in

opinath Bordoloi, revered as the creator of modern September 1938. The Governor invited Bordoloi to form the government, and on September 21, 1938, he took oath as the Premier of undivided Assam, becoming the first Congress-led chief executive in the province.

As Premier, Bordoloi's administration was a beacon of progressive governance. He halted the imposition of land taxes that burdened peasants, protected indigenous land rights by curbing grants to migrant Muslims, and addressed the economic disparities plaguing Assam. His policies aimed at fostering self-reliance and social equity, reflecting Gandhian ideals. However, the outbreak of World War II in 1939 disrupted his tenure. At Gandhi's behest, all Congress ministries resigned in protest against Britain's unilateral involvement of India in the war, and Bordoloi's cabinet followed suit in 1940. Undeterred, he continued his activism, only to be arrested again in December 1940. Released prematurely due to deteriorating health before completing a year in prison, Bordoloi plunged into the Quit India Movement of 1942. The British declared the Congress illegal, and leaders like him were incarcerated once more. He remained in jail until 1944, enduring hardships that tested his resolve but never broke his spirit.

Bordoloi's most defining contributions came during the fraught years leading to India's independence. As the Cabinet Mission arrived in 1946 to negotiate the transfer of power, Assam faced existential threats. The Muslim League, led by figures from Bengal, pushed aggressively to incorporate Assam into East Pakistan, viewing the province's strategic location and resources as vital. The Cabinet Mission's grouping plan proposed placing Assam in Group B with Bengal and other Muslim-majority provinces, effectively ceding it to Pakistan. Bordoloi, re-elected as Premier in the 1946 elections, vehemently opposed this. He mobilized the Assam Congress Committee for mass agitation, organizing rallies and consultations with national leaders. When initial discussions with the Congress high command yielded no results, Bordoloi orchestrated a unanimous resolution in the Assam Legislative Assembly rejecting the grouping. Ten representatives from Assam were tasked with drafting a separate constitution, ensuring in-

tegration with the national framework without subordination. His persistence paid off when Lord Mountbatten, the new Viceroy, assumed office in 1947. Through separate meetings with the Muslim League, Congress, and Gandhi, Mountbatten opted for direct partition over grouping, averting Assam's absorption into East Pakistan. Bordoloi's role was DEGREE OF THOUGHT instrumental; he worked tirelessly alongside Sardar Vallabhbhai Patel to safeguard Assam's sover-By: Satyabrat Borah

eignty. Patel, India's Iron Man, hailed Bordoloi as the "Sher-e-Assam" or Lion of Assam for his courage. This victory not only preserved Assam's territorial integrity but also protected its Hindu-majority population from potential communal violence. Bordoloi also thwarted the insidious Coupland Plan, a subsidiary proposal by Oxford historian Reginald Coupland, which envisioned the northeastern tribal areas, including Garo Hills, Khasi-Jaintia Hills, Lushai Hills, Nagaland, and North Cachar Hills, as a self-governing Crown Colony under British protection. Alerting Gandhi to its implications, Bordoloi intensified non-violent protests, ensuring these regions remained

Post-independence, Bordoloi became the first Chief Minister of Assam on August 15, 1947, a position he held until his death. His vision extended beyond mere survival; he sought to build a modern, inclusive Assam. The partition brought waves of refugees fleeing communal riots in East Pakistan, and Bordoloi organized their rehabilitation with compassion and efficiency, resettling millions while maintaining communal harmony. He collaborated with Patel to fortify Assam's borders

against threats from East Pakistan and Communist China, laying the groundwork for regional security. Economically, he promoted agriculture, tea production, and resource utilization, recognizing Assam's potential in oil and minerals—the first oil in Asia was discovered there. Educationally, Bordoloi's legacy shines brightest. He spearheaded the establishment of Gauhati University in 1948, fulfilling a long-standing demand for a local institution of higher learning. The Gauhati High Court was inaugurated in the same year, decentralizing justice. He also founded the Assam Medical College, Assam Veterinary College, and the B. Borooah College, alongside the Kamrup Academy, to nurture talent and address healthcare and agricultural needs. The Gauhati Station of All India Radio was another milestone, connecting Assam to the nation

Bordoloi's approach to governance was holistic, emphasizing unity among Assam's diverse ethnic groups—Bodos, Nagas, Misings, Karbis, and others. As chairman of the North-East Frontier Tribal Areas and Assam Excluded and Partially Excluded Areas Sub-Committee in the Constituent Assembly. he advocated for tribal rights, proportional representation, and special financial considerations for Assam's unique challenges, such as migration and population shifts. In debates on August 5, 1949, he highlighted taxation issues, and on September 6, 1949, he detailed the tribal situation, ensuring their voices were heard in the framing of India's Constitution. His interventions on July 18, 1947, addressed demographic changes due to influxes, proposing safeguards for Assamese representation in

Despite his stature, Bordoloi remained a man of simplicity. A devout follower of the Bhagavad Gita, he wore khadi, lived austerely, and was known for his Vaishnava devotional singing. The Governor of Assam, Jayram Das Doulatram, bestowed upon him the title "Lokpriya," meaning "loved by all," in recognition of his selfless service. Bordoloi authored books like Annasaktiyog, Shreeramachandra, Hajrat Mohammad, and Buddhadeb, reflecting his philosophical depth. However, his health, weakened by years of imprisonment and relentless work, began to fail. On August 5, 1950, at the age of 60, he passed away in Guwahati, leaving behind a grieving state and nation.

Bordoloi's legacy endures as the architect of modern Assam His efforts ensured communal harmony, democratic stability, and progress, shielding the state from ideological invasions and external aggressions until the 1971 war. Posthumously awarded the Bharat Ratna in 1999 by Prime Minister Atal Bihari Vajpayee, he became the first and only recipient from the Northeast, a fitting tribute delayed by decades due to the region's peripheral status in national consciousness. In 2002, President A.P.J. Abdul Kalam unveiled a life-size statue of him in Parliament House. The Lokpriya Gopinath Bordoloi International Airport in Guwahati bears his name, and August 5 is observed as Lok Kalyan Divas in Assam to honor his death anniversary.

In the broader canvas of Indian history, Bordoloi's contributions transcend Assam. He opened the Northeast to the Congress, fostering national integration while preserving regional identity. His non-violent resistance against colonial designs and partition threats exemplified Gandhian ethos, inspiring generations. Today, as Assam grapples with issues like illegal migration,a concern Bordoloi foresaw and addressed, his vision remains relevant. He united diverse communities, promoted education and infrastructure, and laid the foundation for a progressive state. Gopinath Bordoloi was not just a politician; he was a guardian of Assam's soul, a builder of its future, and a symbol of integrity in public life. His life story reminds us that true leadership lies in selfless service, and his indelible mark on modern Assam ensures his place as an eternal icon of re-

s Assam observes the birth centenary of Golap Borbora, its first non-Congress Chief Minister, it is an opportune moment to reflect on the extraordinary journey of a man who embodied resistance, reform, and moral courage. Borbora's tenure at the helm of Assam's government may have lasted less than a year, but his imprint on the state's political imagination remains profound. His story is not simply that of a political leader but of an individual who lived and died with integrity, standing for principles when compromise would have been easier.

**Early Life and Education** 

Golap Borbora was born on August 29, 1925, at Purona Amalapatti in Golaghat, Assam, into a family that placed immense value on education and honesty despite financial limitations. His father, Komol Borbora, was an executive officer at the Digboi Oil Company, and his mother, Punivaprova Borbora, anchored the family through turbulent times. The family's fortunes changed when Komol resigned during a prolonged strike at the oil company, and hardship became a familiar companion. When young Golap was three years old, the family moved to Sripuria, Tinsukia, following his father's employment at Digboi, and it was there that he spent his formative years.

Even amid modest means, Borbora's family emphasized learning. He received his primary education in Sripuria before moving on to Senairam High School, Tinsukia. To support his higher studies, he worked briefly in the Labour Department of the Digboi Oil Company. His intellectual ability shone early: in 1944, he passed the entrance examination with a first division, and in 1947, he graduated with distinction in the ISC from Bangabasi College under the University of Calcutta. This period was not merely an academic journey but also a moral awakening. The final years of the freedom struggle were unfolding around him, and his political outlook was deeply influenced by Mahatma Gandhi's ideas and, more significantly, by socialist leaders like Ram Manohar Lohia and Jayaprakash Narayan.

The struggles he witnessed around him in the tea gardens, oil fields, and among daily wage earners shaped his sympathy for the working classes. Equally, his immersion in Assamese literature and culture instilled a lifelong commitment to preserving regional identity even while embracing progressive reform. These twin influences—socialist politics and Assamese culture—

became the bedrock of his later political career. **Entry into Politics** 

By the mid-1940s, Borbora had already stepped into the world of student activism and local political movements. After completing his ISC, he briefly taught at Tinsukia High School but soon resigned, deciding instead to dedicate his life to the Socialist Party and trade union movements. His ability to organize, to speak with clarity, and to place himself among the working masses made him stand out. The years following Independence were challenging for Assam, where issues of regional neglect and economic inequality deepened. For Borbora, politics was not an avenue of personal gain but

a moral responsibility to address these inequities. Throughout the 1950s, he became an active figure in trade unions, representing the struggles of workers, farmers, and marginalized communities. His leadership

was recognized early when he led an agitation demanding an oil refinery in Assam. For this, he was arrested in 1957, an experience that hardened his resolve to confront entrenched power structures. His arrest was emblematic of his larger approach: he did not shy away from confrontation if it meant advancing justice.

By the 1960s. Borbora had grown into a national figure within the Socialist Party. His commitment was rewarded in 1965 when he became the National General Secretary of the United Socialist Party, giving him a platform to voice Assam's concerns at the national stage. In 1968, he entered the Rajya Sabha, becoming the first opposition MP from Assam. His speeches earned him admiration across party lines for their clarity, integrity, and deep sense of justice.

The 1970s and the Road to Chief Ministership The 1970s were tumultuous years in Indian politics. Golap Borbora played a significant role in the Janata movement that rose in opposition to Indira Gandhi's increasingly authoritarian rule. During the 1974 railway strike, one of the largest industrial actions in India's history, Borbora was imprisoned. His unwavering opposition to authoritarianism reached a peak during the Emergency (1975–1977). Like many prominent opposition leaders, Borbora was jailed for 19 months in Tihar Jail. Yet, rather than weakening him, this incarceration

only sharpened his image as a leader of principle. After the lifting of the Emergency, the Janata Party emerged as a nationwide force, and in 1977, Borbora was appointed the Assam state unit president. Riding the wave of anti-Congress sentiment, he led the Janata Party to a historic victory in Assam, securing 53 seats in the assembly elections. For the first time since Independence, the Congress monopoly in Assam was broken. On March 12, 1978, Golap Borbora was unanimously elected as Chief Minister of Assam, making history as the state's first non-Congress Chief Minister.

Governance and Reforms

Although his tenure lasted only 11 months, from March 1978 to September 1979, Borbora's administration introduced reforms that were bold, people-centric, and reflective of his socialist ideals. His government exempted land revenue for farmers with holdings of up to 10 bighas, providing relief to tens of thousands of small cultivators. Land reform measures, including ceilings on holdings and redistribution to landless families, were introduced to reduce rural inequality.

Education was another priority. His government exempted fees for students up to HSLC level and extended free education to all girls up to high school. Hundreds of new schools were established, adult literacy campaigns were launched, and Assamese was strengthened as a medium of instruction. The focus on mother tongue education was in line with his philosophy that cultural preservation and progress must go hand in hand.

Healthcare reforms were equally transformative. Free medical treatment was introduced in government hospitals, making healthcare accessible to rural and marginalized communities for the first time. His government also allowed free movement of food grains within the state, eliminating barriers that had previously hurt ordinary citizens.

Administrative reforms became a hallmark of his leadership style. Determined to reduce corruption and bureaucratic hurdles, Borbora made the Chief Minister's office more accessible. Citizens could directly approach him with grievances, a practice that symbolized his commitment to participatory democracy. This philosophy of open-door governance set new standards in transparency and responsiveness.

Social welfare programs were expanded to cover workers, widows, and vulnerable groups. Pensions, relief aid, and health support were introduced to improve the conditions of marginalized communities. The government's initiatives produced measurable results: administrative delays were reduced by 75 percent, rural literacy increased by 60 percent, and agricultural productivity rose by 40 percent.

Challenges and the Fall of Government

Despite his achievements, Borbora's government faced formidable challenges. His attempts to curb the influx of illegal immigrants from neighboring countries stirred controversy, as the issue was deeply intertwined with Assam's socio-political fabric. At the same time, his move to dismantle the liquor monopoly in the tea garden belts threatened entrenched economic interests. These reformist measures, while progressive, cost him the support of powerful lobbies, contributing to the fall of his government in September 1979.

Yet, even after his government ended, Borbora was remembered as a leader who dared to confront systemic issues that others avoided. His 11 months in office remain etched in Assam's history as a period of principled governance rooted in social justice.

Later Years and Legacy

After leaving the Chief Minister's office, Borbora continued to serve the people, though he gradually withdrew from active politics. He devoted himself to social causes and educational initiatives, mentoring younger leaders and speaking on issues of democracy and justice. In his later years, he suffered from age-related ailments and passed away on March 19, 2006, at the age

His family has carried forward his legacy in different ways. His son, Pankaj Borbora, has been associated with the Bharatiya Janata Party, while his grandson, Abhinav P. Borbora, presides over the College Students Welfare Committee (CSWC), an NGO that commemorates his contributions. The CSWC Golap Borbora Scholarship Programme provides financial assistance to meritorious students, and the annual Golap Borbora Memorial Lecture continues to foster dialogue on democracy, governance, and social justice.

The Lasting Significance of His Leadership

Golap Borbora's life exemplifies the transformative power of principled politics. His reforms in land, education, healthcare, and welfare programs directly touched the lives of thousands. His insistence on transparency and open governance remains a benchmark in Assam's administrative history. More importantly, he demonstrated that leadership rooted in honesty, social justice, and empathy could challenge entrenched power and inspire people. His emphasis on cultural preservation alongside modern reform continues to guide Assamese identity politics, proving that progress does not have to come at the cost of tradition. In his words and actions, Borbora embodied a philosophy of participatory democracy, where citizens were not passive recipients of governance but active shapers of policy.

As Assam marks his centenary, Golap Borbora's legacy stands as a reminder that true political leadership is not measured by the length of tenure but by the depth of integrity and impact. His journey from the tea gardens and classrooms of Tinsukia to the Chief Minister's office in Dispur symbolizes the story of a man who never compromised with power but instead used it to serve. His centenary is therefore not just an occasion for remembrance but a call to renew faith in politics as a force for justice, dignity, and hope. ## Violence against journalists

iolence against journalists has emerged as one of the gravest threats to democracy and freedom of expression in the present world. The act of targeting those who dedicate their lives to uncovering truth and disseminating information is not merely an assault on individuals but a direct attack on the public's right to know. Journalism, by its very nature, seeks to question authority, investigate wrongdoing, and hold power accountable, but this function often puts journalists in direct confrontation with political establishments, corporate entities, criminal syndicates, and extremist groups. The result is a growing climate of intimidation, censorship, and violence, one that is undermining the very foundation of democratic societies and pushing journalism into a state of

The seriousness of the problem is evident from the rising numbers of attacks, killings, and unlawful detentions reported annually. International organizations such as Reporters Without Borders, the Committee to Protect Journalists, and UNESCO repeatedly highlight the worsening situation. Hundreds of journalists are killed every decade, often for exposing corruption, organized crime, environmental exploitation, or political abuse. The alarming aspect is not only the scale of the violence but also the impunity that follows. In most cases, attackers are never punished, creating a precedent where silencing journalists becomes a low-risk enterprise. The culture of impunity emboldens perpetrators, and the lack of accountability corrodes trust in justice systems, leaving the profession more vul-

The violence manifests in multiple forms, ranging from physical assaults, assassinations, and arbitrary arrests to online harassment, threats, and surveillance. In countries where democracy is fragile or authoritarianism is entrenched, journalists are often the first to be targeted. Governments justify repression in the name of national security, sovereignty, or public order, but in reality, such measures are designed to stifle criticism and control narratives. The weaponization of laws has become a subtle but powerful form of violence, where journalists are burdened with sedition charges, anti-terror laws, or defamation cases. This not only criminalizes reporting but also ensures prolonged harassment through the legal system, discouraging investigative journalism and forcing many to withdraw from sensitive reporting altogether.

India, often celebrated as the world's largest democracy, reflects the complexity of this issue. Journalists in metropolitan centers may still enjoy relative safety, but those working in rural and semi-urban areas face extreme vulnerability. Reporters covering local corruption, illegal resource extraction, insurgency, or caste and communal conflicts are frequently attacked or even killed. Many of these cases receive little national attention, leaving families of slain journalists without justice. The misuse of colonialera laws, arrests under vague charges, and police harassment have further shrunk the space for critical reporting. The dangers are not limited to physical violence alone but extend to psychological intimidation through trolling, hate campaigns, and targeted disinformation, particularly against women journalists.

The situation is equally concerning in other parts of the world. In Mexico and the Philippines, journalists investigating drug cartels, organized crime, or state collusion are regularly assassinated, making these nations among the most dangerous for the press. Russia and China showcase state-led suppression, where critical reporting is treated as an existential threat to authority. In conflict zones such as Syria, Afghanistan, and Yemen, journalists are deliberately targeted by both state and non-state ac-

pendent reporting, it has also become a breeding ground for harassment and intimidation. Coordinated trolling campaigns, doxxing, and threats of sexual violence against female journalists are widespread, creating an atmosphere of psychological terror. Online violence has the same silencing effect as physical attacks, pushing many to self-censor or retreat from public platforms. Moreover, digital surveillance by governments through spyware, hacking, and constant monitoring has made investigative journalism perilous. The absence of strict accountability mechanisms for technology companies exacerbates the issue, as online spaces become unregulated grounds for abuse.

The consequences of unchecked violence against journalists extend beyond individual tragedies. The silencing of journalists leads to the silencing of entire communities, particularly marginalized ones whose stories rarely find space in mainstream narratives. When journalists are intimidated or eliminated, corruption flourishes, human rights abuses remain hidden, and citizens are deprived of factual information and constant of the property of



liability. The killing of Jamal Khashoggi inside a Saudi consulate illustrated the extent to which even international borders and diplomatic norms are disregarded when silencing a critical voice becomes a political priority.

The rise of digital media has introduced a new dimension to violence against journalists. While the internet has democratized access to information and expanded the reach of indechilling effect created by violence ensures that even those who survive alter their reporting, avoiding subjects that could provoke retaliation. Over time, societies slide into a dangerous pattern where propaganda dominates, dissent diminishes, and the truth becomes obscured. The erosion of journalistic freedom is thus not just a professional hazard but a systemic threat to democracy itself.

Addressing this crisis requires strong political will and institutional reforms. States must recognize that protecting journalists is inseparable from upholding constitutional freedoms and democratic accountability. Legal systems must be strengthened to ensure that every act of violence against journalists is investigated impartially and prosecuted effectively. International conventions that safeguard press freedom, such as the International Covenant on Civil and Political Rights, must not remain symbolic but be enforced rigorously. Diplomatic pressure and sanctions on regimes that perpetrate or condone violence against journalists can act as deterrents.

Media organizations too must shoulder responsibility by investing in the safety and welfare of their staff. Journalists, particularly those working in high-risk areas, require safety training, legal support, and institutional backing. Unfortunately, many media houses prioritize profit and sensationalism over safety, leaving their frontline reporters exposed. Solidarity within the profession is equally critical. Independent journalists, unions, and press councils must build alliances to keep cases of violence alive in public consciousness until justice is delivered. International cooperation among media networks can help amplify local cases of violence, ensuring they are not buried under political or corporate influence.

Civil society has a vital role in resisting violence against journalists. Public support for independent media strengthens the position of journalists, signaling that truth-telling is valued by society. When citizens actively consume credible journalism, resist disinformation, and demand accountability for attacks on the press, they create an environment where violence loses legitimacy. Media literacy campaigns can further enhance societal resilience against propaganda and manipulation, ensuring that journalism continues to thrive as a pillar of democracy.

The long-term challenge lies in reconciling the demands of national security with the necessity of a free press. Governments often argue that journalism disrupts security or public order, but history repeatedly proves that suppressing the press ultimately weakens societies. True stability emerges from transparency, accountability, and the empowerment of citizens with accurate information. Protecting journalists is therefore not an optional democratic ideal but a practical necessity for building resilient societies.

The persistence of violence against journalists reflects the growing intolerance of power towards scrutiny. The murders of investigative reporters in Mexico, the imprisonment of journalists in Turkey and Belarus, the suppression of independent voices in Hong Kong, or the brutal killing of Khashoggi are not isolated incidents but symptoms of a global pattern of shrinking democratic space. If left unchallenged, this trend threatens to normalize violence as a tool to manage dissent, pushing societies into silence.

The defense of journalists must therefore be understood as the defense of democracy itself. Every attack on a journalist is an attack on the collective right of society to know the truth. The responsibility to reverse this trend lies not only with states and institutions but with citizens who must refuse to accept violence as the cost of truth. Unless decisive action is taken, the profession of journalism will increasingly be equated with danger, and the very principles of accountability, transparency, and justice will erode. Protecting journalists is not simply about safeguarding a profession but about preserving the voice of truth in society, without which democracy risks becoming an empty shell.

'Election campaign is on social media, then why not in the assembly?'

# Dignity of the House or the rights of the public-protection of dignity or distance from the public?

The greatest strength of democracy lies in its transparency and public participation. Parliament and Vidnan Sabhas represent the voice of the people and are the places where policies, laws and important issues related to public interest are decided. In such a situation, public access to the proceedings of the House can be called a basic need of any healthy democracy. The recent decision taken by the Haryana State Assembly Speaker that the proceedings of the Assembly will no longer be broadcast on Facebook, Instagram, YouTube, Twitter and web channels raises many important questions. Is this decision going to limit transparency or save the dignity of the House - this is the basic question of this editorial.

In the last decade, social media has brought a new revolution in Indian democracy. Earlier, where people used to depend on TV news channels or newspapers, now they get instant information from Facebook Live, YouTube streaming and Twitter updates. The proceedings of institutions like Vidhan Sabha or Parliament are no longer limited within the walls, but have started reaching directly on the mobile screens of the public.

This change was also positive. Common citizens, especially the youth, started getting involved in democratic discourse. They got an opportunity to understand how their elected representatives were debating their issues in the House. But at the same time, its negative aspects also came to the fore. Many times, small excerpts of serious debates in the House were taken out and made viral on social media, which were used for political propaganda, satire or to spread misunderstandings. As a result, the real purpose of the proceedings was left behind and controversies grabbed more headlines.

Haryana State Assembly Speaker Harivindra Kalyan says that the videomessages going viral on the internet media have hurt the dignity of the House. Many times, small parts of unparliamentary words, uproar and sarcasm are broadcast again and again, which only conveys a negative image to the public. He has issued an order clarifying that from now on only recognized TV channels will be able to broadcast the proceedings live, while there will be a strict ban on putting live or recording on any social media platform. He also argues that broadcasting the words and parts removed from the proceedings of the House on social media is a direct violation of the rules. Therefore, it is necessary to ban it. The order also states that action will be taken against the violators.

Although this argument seems correct on the surface, it also raises many questions from a democratic point of view. The assembly runs on public taxes, and every

If broadcasting the proceedings of the Vidhan Sabha on social media is prohibited, then leaders and parties should also not use social media for election campaigning. Today, to seek votes, large-scale campaigning is done on Facebook, YouTube, Instagram and Twitter along with rallies and TV. In such a situation, stopping only the proceedings of the House seems unfair. In a democracy, the rules should be the same for everyone, only then the public's trust in the system can be maintained.

activity there is directly related to the citizens. In such a situation, limiting access to information can be considered contrary to democratic values. Today's young generation does not watch TV. They are active on YouTube, Twitter and Instagram. If the proceedings are limited to TV channels only, a large population will be deprived of democratic debate. When only select mediums are allowed, it will send the message that information is being controlled. Transparency and accountability will be weakened in democracy.

More than 82 crore people use the internet in India. About 45 crore people are active on social media platforms (Facebook, YouTube, Instagram, Twitter etc.). The number of people watching TV is decreasing, while the number of people watching news on mobile is constantly increasing. Sansad TV and state assembly channels reach very few viewers, while a live stream on YouTube can gather millions of viewers. According to experts, digital transparency is the biggest means of maintaining public trust in democracy.

TV channels still reach only a limited section of society, whereas social media reaches every village and youth. In a country like India where there is talk of Digital India, limiting information only to TV channels does not match the demand of the time. Today's major discussions of politics and society take shape only in Twitter trends and YouTube debates.

It is true that it is not right to spread the proceedings of the House in an uncontextualized manner on social media. Many

times, parts are cut and made viral for fun or political attack. This gives an incomplete and wrong picture to the public. But the solution is not to impose a complete ban.

A better solution could be that the Vidhan Sabha itself creates an official YouTube channel, Twitter handle and Instagram account. The proceedings should be broadcast from there in full and without editing. Also, clear rules should be made that other people cannot use this official content by changing its context. In this way, decorum will be maintained and transparency will also be ensured.

In many democratic countries of the world, the proceedings of the Parliament and Assembly are made available to the public through live streaming. Countries like Britain, America, Canada and Australia have made the proceedings of their Parliament accessible online. There too, unparliamentary words or uproar take place, but still the public is given complete information so that faith in democracy remains intact. In a huge democracy like India, where the youth is moving towards political consciousness, banning social media is like taking a step backwards.

Technology in itself is neither good nor bad, it is its use that gives it meaning. Completely stopping the broadcast of assembly proceedings on social media is in a way denying the power of technology. It would be better if clear guidelines are made for this - live broadcast should be done only from official channels. Extracted parts from the proceedings should not be broadcast. Punitive action should be taken on videos made out of context. There should be a dialogue between the media and the public.

If a centralized digital platform is created by the Vidhan Sabha, the public will get direct and unedited access to the content. This will neither spread misunderstandings nor will it harm the dignity of the House. Apart from this, this step will also prove to be the simplest and most powerful medium to connect the youth with democratic discussions.

The success of democracy depends on public participation and transparency. The Vidhan Sabha is not just an institution of the MLAs, but also of the public. In such a situation, easy access of the public to its proceedings is essential for the health of democracy. This decision of the Vidhan Sabha Speaker is an attempt to save the dignity of the House, but it may cost transparency.

The right way is to strike a balance between dignity and transparency. Instead of banning social media, it should be streamlined so that not only the dignity of democracy is maintained, but citizens can also remain fully aware of the activities of their representatives. This will be the biggest identity of a healthy democracy.

# Building a Vishwaguru: Bhagwat's blueprint at RSS centenary

he centenary of the Rashtriya Swayamsevak Sangh (RSS) was marked in New Delhi at Vigyan Bhawan with its annual lecture New Kshitij series. This was not merely a celebratory event but a profound proclamation of India's soul and its future. In his keynote address, RSS Sarsanghchalak Mohan Bhagwat spoke with such clarity and seriousness that he not only dispelled long-standing misconceptions about the Sangh's ideology but also opened up a new horizon in India's journey to becoming a Vishwaguru—a teacher and guide to the world. The event was both a reflection on the Sangh's hundred years of dedicated service and a declaration of its vision for the next century. Bhagwat emphatically stated that the essence of the Sangh's work lies in the creation of a new human being. At first glance, this may sound simple, but its implications are deep and far-reaching. The roots of every societal and national problem lie within the individual. Therefore, the Sangh has resolved to unite all sections of society into one thread. Unless an individual's character, perspective, and conduct undergo transformation, no system or structure can permanently change. Through the patient and long-term pursuit of character-building, the Sangh seeks to transform society and the nation. The fruits of this work cannot be measured by the number of shakhas (branches) or programs but by the invisible yet tangible moral force that is gradually reshaping the course of society.

One of the most significant parts of Bhagwat's lecture was his explanation of Hindutva. He categorically clarified that Hindutva is not a narrow definition, nor is it a specific religion's ritual or sect. Rather, it is the Indian way of life—a vast cultural stream that integrates compassion. harmony, service, non-violence, truth, and self-realization. Hindutva unites; it excludes none. It is the very soul of India, and it is on this foundation that India earns the eligibility to become a Vishwaguru. This perspective firmly dispels the misconception that the Sangh's idea of Hindutva is merely a political tool or a ladder to power. Instead, it is a worldview meant to bind humanity into one, leaving no room for discrimination.

On the second day, Bhagwat delved deeper, introducing the concept of Panchakarma for society. Just as Ayurveda prescribes Panchakarma for the purification of the

human body, a similar fivefold process is necessary for the purification and reconstruction of society. He outlined five dimensions—character-building, organizational strengthening, social harmony, upliftment of the poor, and spiritual awakening. He argued that a nation does not become great through political reforms or economic growth alone. True greatness emerges only when individuals are morally upright, society is organized, harmony prevails, the weaker sections are uplifted, and life is enriched with higher spiritual values. Bhagwat's emphasis on the upliftment of the poor was particularly noteworthy. He asserted that India will be truly strong only when dignity and opportunity reach its last citizen. His words echoed Mahatma Gandhi's Antyodaya, Vinoba Bhave's Sarvodaya, and Deendayal Upadhyaya's Integral Humanism. The greatest challenge before modern India is the unequal distribution of development. The gulf between the rich and poor continues to widen. Unless this divide is bridged, the nation's progress will remain incomplete. For Bhagwat, the greatness of a nation is measured by whether its weakest citizen can live with dignity and respect.

Equally significant was his perspective on religious unity. India's history itself bears testimony to the coexistence of diverse faiths-Hindus, Muslims, Sikhs, Christians, Buddhists, and Jains—all of which flourished on this soil. At their core, all religions preach compassion, service, and humanity. Conflict arises only when religion is linked to the politics of power. Bhagwat stressed that if we focus on the essence of religions, there is no conflict. Love, truth, and service are the shared foundation. This shared foundation can enable India to build a society that becomes exemplary for the world.

While Bhagwat's ideas provide clarity and direction, one must also question how easily they can be translated into action. India's social complexities—caste tensions, religious divides, political interests, and economic inequalities—make the task of creating a "new human being" a long and arduous journey. Critics argue that although the Sangh has strong ideas, they have yet to deeply penetrate all sections of society. Suspicion among minority communities still exists. Therefore, trust cannot be earned by words alone but through transparent and concrete actions that demonstrate that the Sangh's Hindutva is genuinely inclusive. Similarly, while the call for uplifting the poor and uniting religions is commendable, the question remains whether the Sangh and its affiliated organizations can deliver measurable results. Critics further note that government initiatives have so far played a larger role in mainstream development than social organizations. Thus, if the Sangh is to prioritize these goals, it must move beyond moral appeals and design practical, actionable programs. Only then will its vision gain real effectiveness.

In the present global scenario, Bhagwat's message becomes even more relevant. The world is reeling under violence, terrorism, wars, and the blind race of consumerism. Environmental crises are worsening day by day. Mental stress and selfcentered lifestyles are hollowing out human life from within. In such circumstances, India is perhaps the only nation capable of offering an alternative philosophy of life. Alongside material growth, India possesses the heritage of spiritual abundance—a heritage that qualifies it to be a Vishwaguru. The RSS centenary lectures were therefore not just an internal exercise for swayamsevaks, but a message to the entire nation and the world: build a new man, uplift the poor, unite religions, establish harmony, and guide the world on the foundation of Hindutva's broad and inclusive vision.

For decades, the Sangh has faced criticism that its ideology is narrow, representing only the majority while excluding minorities. Bhagwat's address has clarified that the Sangh's vision is neither narrow nor exclusionary. Its Hindutva is inclusive, giving space to all faiths and beliefs. Its aim is not political power but moral and cultural reconstruction of society. The Sangh's centenary is therefore a historic opportunity. India today stands at a decisive crossroads: on one side lies economic growth, technological achievements, and growing global stature; on the other, internal challenges of inequality, caste tensions, religious discord, and valueless politics persist. The solution lies not in external reforms alone but in inner transformation. This, precisely, is the Sangh's approach and Bhagwat's central message. The centenary lecture series thus leaves us not merely with a conclusion but with a question: Do we wish to make India powerful only in material terms, or do we truly aspire to make it a Vishwaguru? If the answer is the latter, then Bhagwat's vision must be translated into action. We must cultivate a spirit of belonging to the world, not merely a transactional

## Man with links to radical outfit JMB held in Assam: CM

GUWAHATI, Aug 28: Assam Chief Minister Himanta Biswa Sarma said a person was arrested for allegedly sending phone numbers of several residents of Dhubri district to the fundamentalist outfit Jamatul-Mujahideen Bangladesh (JMB), which is trying to create disturbances in the state.

The arrested man, an Indian, was the main conduit who supplied phone numbers to the JMB, and its members would then dial those people with the intention to radicalise them, he said at a press conference on Wednesday.

The arrested person, Ali Hussain Bepari, had also been apprehended earlier but was out on bail, he said. The police are in the last stage of the investigation, and more details are likely to emerge soon, Sarma

A strict vigil is being kept in the districts of Dhubri and South Salmara that border Bangladesh, he said.

"South Salmara has been peaceful for the last five years, but there have been several activities in recent times in Dhubri. So, we have decided to continue with the shoot-at-sight orders at night during the Durga Puja as we are apprehensive about the law and order situation," he said.

Sarma said no FIR will be filed against former Planning Commission member Sayeeda Hamid "for saying that Bangladeshis can also live here"

"If I file an FIR, then she will collect contributions from different parts of the country to fight the case. She will be only enriched," he said.

If she, however, comes back to Assam, the state government will do what is required to be done according to the law, the CM said.



The chief minister said that since the Assam agitation around four decades ago, no Bangladeshi had been deported, but now "every week we are pushing back 70-100 people who are trying to enter the country". He said that it is a fact that Assam and the rest of the Northeast are used as a corridor by infiltrators.

Regarding the National Register of Citizens (NRC), Sarma alleged that the "people of Assam have been cheated as there are many anomalies in the list with many doubtful entries made".

The final NRC released on August 31, 2019, excluded 19,06,657 applicants. A total of 3,11,21,004 names were included out of 3,30,27,661 applicants. It has, however, not yet been notified.

"Our final aim is to ensure that the Centre, Supreme Court or the Assam government, within its powers, examine the legal angle and find a solution as the existing NRC cannot be accepted by us," he said. (PTI)

ITANAGAR, Aug 28: Arunachal Pradesh Deputy Chief Minister Chowna Mein on Thursday said the state will commemorate the birth centenary of Bharat Ratna awardee Dr Bhupen Hazarika with a state-level programme at Roing in Lower Dibang Valley district on September 26, as part of the nationwide celebrations of the legendary musician's legacy.

Mein, who attended the core committee meeting on the centenary celebrations in Guwahati chaired by Assam Chief Minister Himanta Biswa Sarma, informed that Prime Minister Narendra Modi will join the commemorative event in Assam on September 13.

'The Hon'ble Chief Minister reviewed the programme in detail and emphasised the need for collective efforts to make the event truly memorable," Mein said in a post on X.

"In this spirit, the Government of Arunachal Pradesh has also taken steps to honour the legacy of Dr Bhupen Hazarika. We will be commemorating his birth centenary at Roing on 26th September 2025," the deputy chief minister shared in his social media

Widely known as the 'Sudhakantha'. Hazarika was born on September 8, 1926, in Sadiya, Assam, and died on November 5, 2011, in Mumbai.

A singer, poet, composer, filmmaker and political thinker, Hazarika's works carried strong messages of humanity, communal harmony and social justice, earning him national and international acclaim.

He was conferred the Bharat Ratna, the country's highest civilian honour, posthumously in 2019.

Hazarika shared a deep connection with Arunachal Pradesh, where he spent part of his early career and composed soulful songs inspired by the Idu Mishmi community and the natural beauty of the Dibang Valley.

His compositions in Arunachali dialects helped bring the culture of the state to national prominence.

The state government said Roing, in Lower Dibang Valley, was chosen as the centenary venue in recognition of this enduring bond.

As part of the centenary celebrations, the Union finance ministry issued a notification announcing the release of a special ₹ 100 commemorative coin in Hazarika's honour.

The coin, made of 99.9 per cent pure silver, will be circular with a diameter of 44 millimetres and 200 serrations. The obverse side of the coin will feature the Lion Capital of Ashoka Pillar with the legend 'Satyameva Jayate' inscribed below, flanked by the word 'Bharat' in Devanagari script on the left and 'India' in English on the right, along with the rupee symbol and the denomination 100.

The reverse side will bear the image of Hazarika, with the inscription 'Dr. Bhupen Hazarika ki Janma Shatabdi' in Devanagari on the upper periphery and 'Birth Centenary of Dr. Bhupen Hazarika' in English on the lower periphery. The year '2025' will also be inscribed below the image.

Calling the government's decision 'a historic recognition by Prime Minister Narendra Modi', Mein said, "This is a fitting tribute to Sudhakantha, whose timeless contributions to music, literature, and social harmony continue to inspire us all." (PTI)

ITANAGAR, Aug 28: Arunachal Pradesh Civil Aviation minister Balo Raja on Thursday flagged off the first-ever outbound air cargo service from Donyi Polo Airport here, in a step aimed at boosting the state's agri-horticultural economy and linking local farmers to wider markets.

Raja said the initiative, themed 'Empowering Farmers, Connecting Markets', will create new opportunities for cultivators by ensuring their produce reaches national markets faster.

"Today, I had the privilege to flag off the first outbound air cargo from our state at Donyi Polo Airport. This initiative will open new horizons for our hardworking farmers," Raja said in a post on X.

Officials in the state civil aviation department said the cargo service is expected to primarily cater to perishable items such as fruits, vegetables, flowers and other local produce, which often suffer losses due to lack of quick transportation.

The facility, they said, would not only reduce wastage but also enable better price realisation for farmers in remote districts.

The minister also inspected the upcoming terminal building at the Donyi Polo Airport, which has been designed to handle over 400 passengers at a time.

The modern terminal, equipped with passenger amenities, will be formally dedicated to the people of the state on September 2.

"The new terminal is a symbol of Arunachal Pradesh's growing connectivity and aspirations. It will soon be inaugurated and will serve as a major gateway to the frontier state," the minister said in another social media post.

Donyi Polo Airport, inaugurated on November 19, 2022 by Prime Minister Narendra Modi, is the first greenfield airport of the northeastern state and has seen a steady rise in passenger footfall and flight op-

The new terminal and cargo facility, officials said, are part of the Centre's larger effort to improve air connectivity in the Northeast under the Ude Desh ka Aam Nagrik (UDAN) scheme. (PTI)

## BRO to complete strategically important road in Arunachal by March 2026: Chief Engineer

ITANAGAR, Aug 28: Border Roads Organisation (BRO) Project Brahmank Chief Engineer S C Looniya has said that the double-laning of the 32-km Pene-Tato stretch of the strategically important Aalo-Mechuka road in Arunachal Pradesh's Shi-Yomi district will be completed by March 2026. Admitting that the project has been delayed, Looniya attributed the delay to land acquisition on a stretch of the road.

He said, "We want to complete the formation-cutting immediately, to ensure that commuters don't face problems like road closure due to formation cutting and equipment movement. The stretch with all parameters will be completed, so that people get a safe, secure, satisfactory-level road connectivity."

Looniya said our aim is to at least provide all-weather connectivity from Kaying in Siang district to Tato soon.

"We are committed and are working vigorously to extend NH-13 to far-flung areas of Tato," he said.

The chief engineer, however, maintained that black-topping of the road will take

On the Tato-Mechuka stretch, Looniya said the 14 bridges along the Tato-



Mechuka stretch have been awarded to a contractor and work on these bridges are in

various stages. He said the work on the 12-km Yarlung-Trijunction road, including the 140 ft steel modular bridge has started and will be

completed within two years, while the 16km Yarlung-Lamang road has already been

The DPR for the 14-km Lamang-Lola Road is under preparation, he said. He said the roads under the National

Highway Single Lane (NHSL) will provide road connectivity to forces stationed in forward areas.

The chief engineer also said that the Migging-Tuting road will be completed soon. Only 15 km of formation cutting is

left, and the surfacing work is being planned this year, he said, adding that if weather permits, the work will be completed by March 2026.

The chief engineer also said that if the government allows, they are willing to take up the maintenance of the NH-13, Akajan-Likabali-Bam road.

It will be beneficial for movement of BRO personnel stationed in Daporijo (Upper Subansiri), Aalo (West Siang), Yingkiong (Upper Siang), Mechuka (Shi-

Yomi), he said The Akajan-Likabali-Bam-Aalo road was constructed by BRO in the 1960s before it was awarded to the National Highways & Infrastructure Development Corporation Ltd in June 2015 for double-

Several portions of the road are in pathetic condition and in many places, the road is not fit for traffic movement and has

## Won't let anyone take away people's voting right till I am alive: Mamata

CM apologises for delay in government recruitment drives, admission process in colleges

KOLKATA, Aug 28: West Bengal Chief Minister Mamata Banerjee on Thursday said she would not let anyone take away people's voting rights, alleging that the BJP was unleashing "linguistic terror" on Bengalis across the country.

Addressing a rally in Kolkata to mark the foundation day of the Trinamool Chatra Parishad, the party's students' wing, Banerjee claimed that the BJP has deployed over 500 teams from across the country in West Bengal to conduct surveys, aimed at deleting names of voters from the electoral rolls.

"Do not give your details if anyone comes to your house for surveys. They will use that data to delete your name from the voters' list. Instead, check directly with the polling centres and ensure your Aadhaar cards are ready, because the Centre has made it compulsory," she told her supporters at the

Alleging that the Election Commission was intimidating state government officers at the behest of the BJP, she said, "I respect the office of the EC, but you know, lollipops suit children. If adults start taking lollipops on behalf of one party, it does not look good."

Banerjee, the TMC chairperson, alleged that the BJP is insulting Bengalis by branding poor migrant workers from the state as "Bangladeshis"

"You torture poor people by calling them Bangladeshis. But to



me, poor people are my biggest strength. I don't believe in caste or creed, I believe in humanity," she

"Recently, a migrant worker from Habra was killed in Maharashtra, but these people (BJP) never raise their voice over such atrocities," she said.

Banerjee alleged that the BJP was trying to make people forget the role played by Bengalis during the freedom movement.

"If there is no Bengali language, then in which language were the national anthem and national song written? They want people to forget the historical role played by Bengalis. Now they are even funding movies to defame Bengal and insult our history," she alleged.

"Their predecessors were agents of the British who gave undertakings to get out of jails," she

With months left for the assem-

first half of 2026, Banerjee has been consistently hitting the road, alleging that Bengali-speaking migrant workers were being harassed in BJP-ruled states.

Taking on the Centre, the CM alleged that funds for key welfare schemes had been withheld out of 'political jealousy".

"For four to five consecutive years, Bengal was number one in providing 100 days' work, building houses for the poor and constructing rural roads. Out of jealousy, they have stopped our funds, and now they want to impose the NRC to take away people's voting rights. But as long as I am alive, nobody will be allowed to snatch away people's voting rights," she

Banerjee also alleged that cenagencies have been weaponised by the BJP to target opposition parties.

"Earlier, no government used

elections. But the BJP has made it a routine," she claimed.

She said 1.38 crore students have got bicycles under the 'Sabooj Sathi', 53 lakh students have got tablets and smartphones under the 'Taruner Swapna' scheme, and the 'Students' Credit Card' scheme has benefitted 92,000 youths.

## BJP alleges use of abusive language against PM during Rahul's yatra in Bihar



NEW DELHI/PATNA, Aug 28: The BJP on Thursday alleged that Congress leader Rahul Gandhi-led 'Voter Adhikar Yatra' in Bihar had crossed all "limits of insult, hate and tastelessness", claiming that abuses were directed at Prime Minister Narendra Modi's mother during the campaign.

The party, on its official X handle, refrained from posting the video of the incident, but clips shared online by a few accounts showed some unidentified people using a Hindi abuse for Modi from

a dais during the Yatra. The video, which has gone viral, is purportedly of Darbhanga district from where the Yatra had taken off on Wednesday morning, when Gandhi, his sister and Congress general secretary Priyanka Vadra and RJD leader Tejashwi Yadav left for Muzaffarpur on motorcycles.

PTI could not independently verify the authenticity of the video.

Several podiums had been erected along the route for local party workers who tried to mobilise public sentiments in favour of the INDIA bloc ahead of assembly elections due later this year.

The BJP said, "Tejashwi (Yadav) and Rahul are behind the use of such filthy language that it cannot be repeated from a public platform... Such lowliness was never seen before in politics. This Yatra has crossed all limits of in-

They have used a very vulgar language against the prime minister's late mother, it said.

The ruling party claimed that the choice of such abusive words for his mother shows the state of the opposition's desperation, as Gandhi and Yadav had earlier invited leaders like M K Stalin and Revanth Reddy, chief ministers of Tamil Nadu and Telangana, respectively, who are accused of "insulting" people of Bihar.

People of Bihar will not forgive Gandhi and Yadav, the main campaigners for the RJD, for such a mistake, even if they apologise a thousand times, the BJP said, calling the incident "extremely shame-

BJP's Darbhanga district chief Aditya Narayan Jha 'Manna' said, 'We are not going to take this insult lying down. We have burnt effigies of Rahul and Tejashwi and are going to lodge a police complaint, seeking a probe and action against those involved in hurling expletives".

A senior Congress leader requesting anonymity said, "We cannot say who the people are whose voice is there in the video. Workers of at least half-a-dozen parties are taking part in the yatra.

The INDIA bloc, which is known in Bihar as Mahagathbandhan or grand alliance, includes three Left parties and former state minister Mukesh Sahni's Vikassheel Insan Party. (PTI)

#### Rajasthan HC cancels 2021 police recruitment exam

JAIPUR, Aug 28: The Rajasthan High Court on Thursday cancelled the contentious 2021 police sub-inspector recruitment exam owing to allegations over paper leak and involvement of members of Rajasthan Public Service Commission (RPSC).

Justice Sameer Jain cancelled the exam, which was the bone of contention for both BJP and Congress governments in the state and gave a detailed verdict

'The Hindi idiom: 'ghar ka bhedi lanka dhaye' (insider does maximum damage), aptly encapsulates the egregious circumstances surrounding the Sub-Inspector Recruitment Examination 2021, wherein the very guardians entrusted with safeguarding the sanctity of the process, namely the members of the RPSC, were instrumental in its vitiation," the order said.

The verdict further called it a "travesty of monumental proportions" in which "six members of the RPSC. tasked with the sacrosanct duty of protecting the interests of the public and masses, chose to betray that trust".

Senior advocate Major R P Singh, who represented the petitioners, said the illegality and fraud on the system was so conspicuous and the verdict would hopefully act as a deterrent for the "gangs" playing with the future of

youths. Advocate Harendra Neel, who also represented petitioners, said, "Involvement of five members of RPSC has been found. Court has taken suo motu cognisance on matters related to RPSC. The court has said that the entire recruitment is polluted and if the recruitment is not cancelled then law and order of the state might get affected. It is a courageous and strict decision of the court.

## Two more bodies found, death toll in Palghar building collapse rises to 17

PALGHAR, Aug 28: The death toll in the collapse of an allegedly unauthorised building at Virar in Maharashtra's Palghar district has risen to 17 with the discovery of two more bodies, officials said on

Police have arrested the builder of the four-storey structure, Ramabai Apartment, after the Vasai Virar Municipal Corporation (VVMC) lodged a com-"Two more bodies have been located under the

debris. The teams from the National Disaster Response Force (NDRF) and other rescue units are extricating them," said Vivekanand Kadam, Chief of the Disaster Management Cell of Palghar District. Their identities will be ascertained subsequently, he

The building, housing nearly 50 flats, collapsed on an adjacent vacant tenement at Vijav Nagar in Virar area of Palghar, adjoining Mumbai, at 12.05 am on Wednesday, they said.

A one-year-old girl's birthday party was underway on the fourth floor when 12 flats in a wing of the building collapsed, trapping residents and guests under the debris, as per eyewitnesses.

Palghar District Collector Dr Indu Rani Jakhar on Thursday morning said that the death toll in the incident had gone up to 15 overnight. The girl, whose birthday was being celebrated

when the incident occurred, was among the deceased Six other persons, who were injured and rescued, were undergoing treatment in various hospitals, ac-

cording to an official from the Vasai-Virar Municipal Corporation (VVMC). Emergency teams, including the NDRF, local police and fire department, continue to sift through the

rubble to check if more victims are trapped. The work of clearing the debris will continue to ensure no other person is trapped under the rubble,

the collector told PTI. "The work is almost complete, but we want to be absolutely sure before concluding the operation,' she added.

Kadam said the teams are working around the clock. "The goal is not only to recover those trapped but also to ensure no lives are put at further risk,"

They have identified eight more victims as Govind Singh Ravat (28), Shubhangi Pawan Saheni (40), Kashish Pawan Saheni (35), Deepak Singh Behra (25), Sonali Rupesh Tejam (41), Harish Singh Bisht (34), Sachin Nevalkar (40) and Deepesh Soni

Eyewitnesses described the horrifying scene, where a moment of happiness turned to chaos in an

"People were dancing and celebrating (during the birthday party) when suddenly the entire structure collapsed like a pack of cards," said a survivor. The aftermath was marked by chaos and panic,

with people screaming and accusing the builder of negligence. Residents claimed that unlike previous incidents

of building collapses where cracks or structural weaknesses were visible beforehand, there were no such warning signs here. The sudden collapse has raised serious concerns

over building safety and unauthorised constructions in the area. Locals have alleged "lethargy and negligence" on

part of the builder and authorities, with many demanding a thorough investigation into how the unauthorised structure was allowed to house so many residents without proper safety measures. Police on Wednesday arrested the builder after the

VVMC lodged a complaint.

Luckily, the chawl or tenement on which the building collapsed was vacant, District Disaster Management Officer Vivekanand Kadam earlier

As a precautionary measure, all the chawls around the ill-fated building have been vacated and occupants shifted to safer places, he said.

Constructed in 2012, Ramabai Apartment has 50 flats, and the collapsed part had 12 apartments, said

A spokesperson of the VVMC had called the building "illegal".

The debris removal was delayed because officials initially struggled to bring heavy machinery to the crashed building located in a congested locality.

"All affected families have been temporarily housed at Chandansar Samajmandir. We are providing food, water, medical assistance, and other essential services," VVMC assistant commissioner Gilson Gonsalves said. (PTI)

Introducing the Mizoram Prohibition of Beggary Bill, 2025, on Wednesday, Social Welfare Minister Lalrinpuii said its objective is not only to prohibit begging, but also to assist and rehabilitate beggars by offering sustainable livelihood options.

She said there are concerns that begging is increasing in Mizoram, al-

though the state is very fortunate to have very few beggars due to its social structure, involvement of churches and NGOs and the welfare measures and schemes being implemented in the state. There is also an apprehension of an influx of beggars from outside the state with the arrival of the railhead at Sairang-Sihhmui, she said.

The railway line is scheduled to be inaugurated by Prime Minister Narendra Modi on September 13. The government is of the opinion that with proper regulatory frameworks in place, it can keep the state free from beggars, Lalrinpuii said. The minister said that the government will form a state-level 'relief board', which will set up receiving centres for temporary retention of

beggars. Beggars will be first kept at the receiving centre, and they will

be sent to their native homes or states within 24 hours, she added. The minister said there are more than 30 beggars, including non-locals, in state capital Aizawl, as per a survey conducted by the Social Welfare Department. Opposition members, including MNF leader Lalchhandama Ralte, stated that the Bill is detrimental to the Christian faith and will tarnish the state's reputation. They instead suggested a robust community involvement to stop begging. Chief Minister Lalduhoma said the main motive of the Bill is to help and rehabilitate beggars with the collective help of the government, NGOs and churches. (PTI)

# Mizoram govt procured ginger worth over ₹95 cr from farmers under flagship scheme: Minister

**AIZAWL, Aug 28:** The Mizoram government has procured over 3 lakh quintals of ginger worth over ₹ 95 crore from farmers under the state's flagship programme 'Bana Kaih' or handholding scheme, state Agriculture and Farmers' Welfare minister PC Vanlalruata informed the Assembly on Thurs-

He said the government received only ₹ 12.78 crore by selling the produce to companies.

Replying to questions from members during the monsoon session, Vanlalruata said the government has been making efforts to uplift farmers under the Bana Kaih programme.

"The government bought 3.45 lakh quintals of ginger from the farmers between January 20 and June 30 this year under the handholding scheme," he said.

The minister added that the government has so far spent or re-



leased ₹ 95.28 crore as support price for the purchase of raw ginger, while about ₹ 45 crore is still pending for release to farmers.

According to the minister, the government purchased ginger at ₹ 50 per kg at designated secondary collection centres and the procured stock was sold to companies through an auction system, with preference given to the highest bidders.

However, the government received only ₹ 12.78 crore in return from these sales

Vanlalruata said the government

faced challenges in procuring farmers, noting that some non-ginger farmers had allegedly bought ginger from Myanmar and sold it to the government to make some

He said assistance has been sought from the Centre under the Market Intervention Scheme (MIS), and assured that the pending payments would be released to farmers soon

Purchasing five key crops ginger, turmeric, chilli, broomsticks, and unhusked rice — was a major poll plank of the ruling Zoram People's Movement (ZPM).

These crops were brought under the Bana Kaih scheme, which was launched in September 2024.

For the 2025–26 fiscal year, the government has allocated ₹ 350 crore for the scheme — a 75 per cent increase from ₹ 200 crore in 2024–25. (PTI)

I'm so happy that Salman Bhai is with me, and today to make something relevant and fresh for him at his age is a bigger challenge," the filmmaker told PTI.

With a career spanning more than 30 years, Khan has built a reputation for blockbuster successes but his recent outings like "Sikandar", "Kisi Ka Bhai Kisi Ki Jaan", "Radhe", "Dabangg 3", and "Race 3" have not lived up to the expectations of his

loyal fan base. Barjatya, however, is optimistic about Khan's career and making a huge comeback.

"I think it happens in everyone's life... it is just that he is a celebrity, that's why he gets so much attention. But everyone should be allowed to make a mistake, to learn because that is

what his life is.

# Nila Madhab Panda-produced 'Spying Stars' to compete at Busan Film Festival

Vimukthi's deep reflection on the virus, nature, AI -- and his poetic connection with the metaphysical world -- makes 'Spying Stars' a powerful and timely film. "His use of psychological layers turns this story into more than a film—it becomes an experience. Spying Stars is a journey through fear, silence, and stillness. And above all, it's a film about finding inner

freedom," Panda said in a statemen

The film follows Anandi (Indira Tiwari), a biotechnician who arrives at Hanuman Island to perform her father's last rites but is quarantined in a remote hotel amid a pandemic in a machine-dominant world. When a mysterious star begins following her, she escapes and takes shelter with a mother and her transgender daughter.

"My film is a representation of how the tidy and socalled device-controlled world we were familiar with broke down and became an unknown and uncomfortable reality," Jayasundara said.

"It is a liberation film that is spiritual in nature. It asks one question: in a time of pervasive voyeurism and technological control, how do we retain our humanity?" The film's cast also includes Kaushakya Fernando and Samanalee Fonseka. The film is produced by Vincent Wang and co-produced by Arfi Laamba, Katharina Suckale and Michel Klein.

"Spying Stars" is the first project from Panda's new studio, Eleeanora Images. The banner's upcoming slate includes three narrative features and two documentaries, with Panda set to begin work on his next directorial, scheduled to go on floors in early 2026.



# 'The Monk and the Gun' is a celebration of innocence: Bhutanese filmmaker Pawo Choyning Dorji

**NEW DELHI, Aug 28:** Bhutanese filmmaker Pawo Choyning Dorji, who spent his formative years in India as the child of a diplomat, believes that looking at his country from a distance gave him a better perspective about its culture which he now wants to share with the world through his films.

through his films.

In his new film, "The Monk and the Gun", which was Bhutan's official entry to the Oscars in 2023, Dorji captures an important chapter in Bhutan's recent history. The movie, currently streaming on MUBI India, is set in 2006 when King Jigme Singye Wangchuck introduced democratic elections and held a mock exercise to train people.

"In Bhutan, we have a saying that you will never see your eyelashes because they are so close. But as a Bhutanese growing up outside, I could see the transformation of society as we were striving to become a modern country. I could see my eyelashes... And those scenes, observed as a little young boy, I've tried to capture in the film," Dorji told PTI in an interview.

"The Monk and the Gun" is set in the town of Ura where an old Lama instructs a young monk to procure a gun ahead of the mock elections between with parties

named after a colour. The young monk eventually crosses paths with an American gun collector, who is in the country in search of an antique rifle. Now why would a Lama need a gun? The film answers this question while introducing viewers to Bhutan's uniqueness.

"I tell people that this film is really about innocence. As I noticed my country and culture go through this phase of modernisation, that innocence was lost. If you have been to Bhutan, you will notice that we are a culture that celebrates this quality of innocence. "As we were becoming a modern country, we were told that sometimes innocence is ignorance. But with this film, I wanted to remind the audience that, 'Hey, sometimes it's okay to be inno-

cent and that's not ignorance."."

The idea of the film started taking shape when Dorji found himself stuck in his country during the global pandemic. "At that time, I went to the forest of central Bhutan and built a stupa. There were all these toy guns in the foundation of the stupa. So I asked the Lama, 'Why are we burying guns?' And he told me the story of why. I was like, 'I need to make this into a film."

Slowly, a script started to emerge about Bhutan's transformative phase.

The director said Bhutan is the only country in the world where democracy was introduced without a war or a revolution, which was different from the narrative he encountered as a young political science student in the US.

"I was kind of being fed this jargon that, 'Oh, you know, democracy is the gift given by the modern world to all these civilizations that don't have it'.

"And as a political science student, I found it to be a beautiful comedy that after all that, the people in Bhutan still voted for the Yellow party," he said, describing the result of the mock elections where people voted for the preservation of tradition and culture instead industrial development, represented by the Red Party.

The period in Dorji's film captures not just what people were thinking when the mock election was introduced but also how they were getting to know about the outside world through television. "I always tell the Americans, 'All of you remember where you were when the moon landing happened. For Bhutan, it was not the moon landing, it was our television being switched on for the first time'... I noticed that when the TV started coming, everyone started gathering around. And in villages, usually the people with the

biggest TVs became the most popular households. And every time, outside the house would be all these shoes lined up because everyone is glued to the TV."

Dorji spent many years in India -- in Delhi, Tamil Nadu and Himachal Pradesh. He is happy that the film can now reach the audiences in India.

"A lot of my formative years where I discovered who I wanted to be and what I wanted to do with my life were in India. I'm grateful that finally this film has a home in India. It has the most passionate audience," he said.

"The Monk and the Gun" won the Audience Choice Award at MAMI in Mumbai and his other film "Lunana: The Yak in The Classroom" is the only Oscar-nominated Bhutanese film.

Dorji said he is lucky that his films res-

onate beyond Bhutan.

"When my film 'Yak in the Classroom' was nominated at the Oscars, I met all these Hollywood people and I told them that you are watching a film that is unlike any other you've seen. It's about people in skirts and it's in a language you have never heard. But therein lies the beauty of art that even though it is so culturally diverse in humanity, there is so much that makes us all similar." (PTI)

Three-time champions India will look to put behind their dismal recent form and secure a World Cup berth by winning the men's Asia Cup hockey tournament starting with a tricky opening game against lower-ranked China here on Friday.

India and China are placed in Pool A with Japan and Kazakhstan. Pool B consists of titleholders and five-time champions South Korea, Malaysia, Bangladesh and Chinese Taipei.

Kazakhstan, set to play their first Asia Cup in over three decades, and Bangladesh replaced Pakistan and Oman, both of whom withdrew from the event.

Pakistan opted out citing security reasons in the backdrop of India's Operation Sindoor following the Pahalgam terror attack in April. Top two teams from each pool will qualify for the semifinals, with the final scheduled on September 7.

# Novak Djokovic is trying to solve riddles at the US Open but is back in the 3<sup>rd</sup> round

NEW YORK, Aug 28: For the second contest in a row at this U.S. Open, Novak Djokovic appeared a bit sluggish, a bit off, for a stretch. This time, he even dropped the opening set. And then, as always at Flushing Meadows, the 24-time Grand Slam champion progressed to the third round.

Djokovic improved to 36-0 across the first and second rounds in New York, a place he's won four championships, by coming back to beat 145th-ranked American qualifier Zachary Svajda 6-7 (5), 6-3, 6-3, 6-1 at Arthur Ashe Stadium on Wednesday.

"I really tried to soak it in and enjoy the moment, especially when I won the first set," said Svajda, a 22-year-old from San Diego. "It kind of shocked me. I was like, Wow!" Asked on court afterward how he felt in his first competition since losing to eventual champion Jannik Sinner in the Wimbledon semifinals on July 11 while hindered by a groin injury, Djokovic replied:

"Not that great, to be honest." Svaida noticed.

"He was missing a little bit," said Svajda, who got cramps in his legs and arms as the match wore on. "He was getting a little frustrated." At his news conference later, the 38-yearold Djokovic spoke a little more about his mood.

"It's not a motivation thing. It's just like me a bit frustrated with my game, and then I kind of go through stuff internally that — you don't want to know the details what I'm going through and telling myself," he explained after getting to the third round at a major for the 75th time, breaking a tie with Roger Federer for the most such appearances by a man. "I'm just trying to be locked in. Just trying to solve the riddle once I'm on the court," Djokovic continued. "It's not like I'm not finding joy on the court competing. I enjoy competing, but I don't enjoy not playing well. That's why I put extra pressure on myself and my team to be better the next day, the next



match." That will come against Cam Norrie, a British left-hander who reached the semifinals at Wimbledon in 2022 and is 0-6 against

Norrie got past Francisco Comesana of Argentina 7-6 (5), 6-3, 6-7 (0), 7-6 (4) in four hours and now it's his turn to face the task that Svajda did Wednesday against Djokovic. "He does everything so well, which is incredible," Svajda said. "I was talking to my team and coaches before, trying to figure it out. It's Novak Djokovic, so there's not a big weakness.

Winners included defending champion Aryna Sabalenka, both of last year's runners-up — Jessica Pegula and Taylor Fritz — along with Carlos Alcaraz, Ben Shelton, Frances Tiafoe, 2021 champion Emma Raducanu and Emma Navarro. No. 12 Casper Ruud, whose 0-3 record in Grand Slam finals includes a loss to Alcaraz at Flushing Meadows in 2022, was eliminated 6-4, 3-6, 3-6, 6-4, 7-5 by Raphael Collignon of Belgium. (AP)

With Maxime Vachier-Lagrave of France already the highest point scorer in the Grand Chess Tour. Levon Aronian also qualified for the GCT grand finale along with Caruana and Pragganandhaa.

# T20 tri-series: Rashid Khan's Afghanistan squad is the favorite in this Asia Cup tune-up

SHARJAH, Aug 28: It's time for Rashid Khan and his Afghanistan lineup to be favorites in a Twenty20 international cricket tournament.

Afghanistan has a formidable, spin-heavy squad for the tri-series that starts Friday and also features Pakistan and the host United Arab Emirates. It's a tune-up for next month's Asian Cup, which is also being staged in the UAE.

Last year Afghanistan reached the T20 World Cup semifinals before losing to South Africa, a run to the he last four that underlined its strength in the shortest format of international cricket.

Seven T20 games over the next 10 days at the Sharjah Cricket Stadium will involve the teams competing against each other twice before the top two qualify for the Sept. 7 final.

The slow pitches of Sharjah Cricket Stadium are unlikely to produce any big scores — the 200-run mark has been crossed only four times in 41 T20 internationals at the 16,000-capacity stadium.

The slow nature of the pitches has encouraged Afghanistan to pack its squad with five spinners, including the uncapped AM Ghazanfar. Rashid Khan and mystery spinner Mujeeb Ur Rahman have conceded fewer than six runs per over in a combined 23 T20s at Sharjah, while picking up 43 wickets.



Experienced allrounder Mohammad Nabi, who also bowls offspin, is rich with experience from playing in 25 T20s for Afghanistan at Sharjah, where he's taken 16 wickets at an impressive economy rate

Left-arm spinner Noor Ahmad had some impressive performances in IPL this season while representing Chennai Super Kings. The spin bowling attack is expected to pose some serious challenges to the rival batters.

Pakistan has its spin bases cov-

Ahmed and Sufiyan Muqeem are backed up by off-spinners Saim Ayub and captain Salman Ali Agha and left-armer Mohammad Nawaz. They're all capable of bowling a full quota of four overs in a T20 game, if the conditions favors slow

Pakistan's new limited-overs coach Mike Hesson has yet again ignored experienced veterans Babar Azam and Mohammad Rizwan as he searches for batters with better strike-rates upfront.

with better strike-rates upfront.

Babar and Rizwan haven't played an T20 international since

December. Pakistan has instead given consistent chances to Sahibzada Farhan, Mohammad Haris and Saim Ayub to look out for quick runs in the batting powerplay as it builds a team for next year's T20 World Cup.

Hesson wanted to see Babar not only improve his batting against spinners but also wanted him to score at a faster rate to regain his place in the T20 squad.

Pakistan has had mixed results over the last few months since Hesson was appointed coach. It started with Pakistan routing Bangladesh 3-0 at home before Bangladesh rallied to beat Pakistan 2-1 in the return series in Dhaka. Pakistan then won 2-1 against West Indies in Florida as Hesson experimented with batting and bowling combinations.

Uncapped left-handed batter Harshit Kaushik is among the four changes UAE has made after it lost to the hosts at the Pearl of Africa Cup in Uganda. Leg-spin allrounder Mohammad Farooq, who has nine wickets in 8 T20s, and fast bowlers Junaid Siddique and Mohammad Jawadullah are the others who've returned to the UAE squad

Coach Lalchand Rajput believes that after winning a T20 series against Bangladesh at home in May, the UAE team has the ability to beat any other test playing nation in the shortest format. (AP)

# Sindhu stuns world No 2; Dhruv-Tanisha pair ousts fifth seeds to reach World Championships quarters

**PARIS, Aug 28:** Two-time Olympic medallist P V Sindhu shocked world number 2 Wang Zhi Yi of China to storm into the quarterfinals of the World Championships, here on Thursday.

The 15th ranked Sindhu, who won the world title in Basel in 2019, took 48 minutes to prevail 21-19 21-15 in the pre-quarterfinals to lead head-to-head record against the Chinese 3-2.

The 30-year-old Indian will now face world number nine Putri Kusuma Wardani of Indonesia in the quarterfinals as the Indian is now just one victory away from securing a record-equalling sixth World Championships medal. The Indonesian had beaten Sindhu in straight games at the Sudirman Cup earlier this year, though the Indian had prevailed in their Asian Games round-two clash in 2022.

A five-time World Championships medallist, Sindhu made a bright start in the opening game, racing to an 11-6 lead at the mid-game interval with a flurry of sharp smashes and net winners.

Wang fought back strongly to level at 19-19, but the Indian held her nerves to pocket the game.

In the second game, Sindhu kept up the pressure, once again opening up a 11-6 cushion at the break.

A stunning 57-shot rally briefly tested her, but she regained control with decisive attacking play, closing out the match.

Sindhu thus extended her remarkable record against Chinese shuttlers at the Worlds, having previously beaten Wang Yihan (2013), Wang Shixian (2014), Li Xuerui (2015), Sun Yu (2017) and Chen Yufei (2017 and 2019) in earlier editions.

India's Dhruv Kapila and Tanisha Crasto also pulled off a big upset by stunning Hong Kong world number 5 pairing of Tang Chun Man and Tse Ying Suet 19-21 21-12 21-15 in a 63-minute battle to storm into the quarterfinals

The Indians, who had earlier cruised past Ireland's Joshua Magee and Moya Ryan 21-11 21-16 in 35 minutes, came from a game down to topple the reigning Asian champions with a determined fightback.

"We had a rough run a couple of months back. I think we are building together, step by step, slowly, slowly

we are getting there. Really happy with the way we played today," Tanisha said.

"We came prepared, prepared better this time. We didn't give up at any point in the match. Even after we lost the first set, we didn't let it get to us. We fought back even harder in the second and third. We kept pushing each other till the end, till the last shot. I think that was the real game changer today."

The Indian duo had endured a patchy start to the year, losing in the round of 16 at the Malaysia Open and India Open, before reaching the semifinals at the Ger-

man Open in February.

However, early exits at the Orleans Masters and All England Championships followed.

Dhruv spoke about the turnaround.
"We started really good in the beginning of the year, two tournaments didn't go well. There was no technical problem, but the main thing was we kept on supporting each other and came prepared well. Previously when we were losing the first game we were mentally down,

but today we stayed strong," he said.

Gupreet, Amanpreet secure 1-2 finish for India in 25m pistol

"Hardik is one player that I really admire. I like the way he plays and the calmness and composure that he offers to his team. He's a fighter; he has had his ups and downs. As an athlete, that's one quality that you have to possess just looking at the way

he goes about his cricket, it's just ad-

mirable," he said.

"I've looked up to Ben Stokes and Hardik Pandya for just the fighters that they've been and (all that) they offer," he added. With the T20I series win over Bangladesh in May, UAE have gained in confidence. Sharafu said nonethless it would be a challenge to ace the hot and humid conditions in Dubai and Abu Dhabi -- the two venues of the tournament.

Sharafu, whose unbeaten 68 helped UAE record only their second series win over an ICC Full Member this year, said the triumph over Bangladesh will hold his team in good stead in the eight-team competition

"It's great for our confidence as a team, knowing that we can go out there and beat some of these big teams that play Test cricket. Even in that series, we could have beaten them 3-0 but we missed out in the first game.

"The players are in a really good space knowing that on their day they can beat these big teams," he said. "I feel that it's going to be relatively dif-

ficult for spinners with how humid it has

been. We've seen in the last few practice games that we've played, spinners have been finding it difficult to grip the ball a little more because of how humid it's been; just sweat and moisture in the air," he added.

Sharafu, who averages over 30 in 50 T20Is with a strike rate of nearly 134, fin-

ished as the fourth-highest run-scorer in T20Is in 2024 with 770 runs. He is hoping to find his rhythm in one-day cricket as well.

"I've had a little more success and better

"I've had a little more success and better stats in T20s. I started off relatively young into international cricket, so initially in 50 overs, I batted in a lot of different numbers," he said. (PTI)
