'Eviction drives in Assam to continue to clear illegal encroachment'

Minority groups orchestrating land jihad: Himanta

GUWAHATI, Aug 4: Chief Minister Himanta Biswa Sarma on Monday accused certain minority groups of oppressing the state's indigenous communities through what he described as "Love Jihad" and "Land Jihad."

Talking to reporters, Sarma responded to a recent memorandum submitted by leaders of the All India United Democratic Front (AIUDF) to the Assam Police headquarters in Ulubari.

The AIUDF delegation had alleged ongoing discrimination and persecution of minority communities in the state.

Countering the allegations, Sarma said, "The so-called minorities are, in fact, the ones oppressing our indigenous people. They are involved in Love Jihad, Land Jihad, and are illegally occupying large swathes of land. Despite this, they are the ones raising complaints, while the real victims—our native communities-remain unheard."

The Chief Minister cited specific cases to back his claims, stating that in forested areas, minority groups have been planting betel nut trees and establishing fisheries.

"I have personally visited Uriamghat, where



300 to 400 bighas of land have been encroached upon. In contrast, in Baksa district, our indigenous people are still waiting for land allot-

ments," he added. Sarma further asserted that the narrative of

victimhood was being misrepresented. "If anyone should be submitting memorandums and expressing grievances, it should be us. Justice demands that the plight of our indigenous communities be (CONTD. ON PAGE-2)

BTC polls: BPF names 22 candidates

KOKRAJHAR, Aug 4: The opposition Bodoland People's Front (BPF) on Monday released the first list of 22 candidates for the upcoming Bodoland Territorial Council (BTC) elections, scheduled to be held in the last week of September.

The announcement marks the party's formal entry into the electoral contest, setting the tone for a high-stakes battle for control of the 40-member council.

According to an official statement issued by the party, BPF president and former BTC chief Hagrama Mohilary will contest from Debargaon constituency.

Sitting West Kokrajhar MLA Rabiram Narzary has been fielded from Kachugaon, while senior party leader and former minister Rihon Daimary will contest from Bhairabkunda.

The complete list of 22 candidates released so far includes: Moon Moon Brahma (Parbotjhora), Antaj Ali (Guma), Muk-Ahmed (Srirampur),

Mrityunjay Narzary (Soraibil), William Narzary (Jomduar), Prakash Basumatary (Dotma), Doneswar Goyary (Baukhungri), Derhasat Basumatary (Salakati), James Basumatary (Nichima), Paniram Brahma (Kajalgaon), Sukursingh Muchahary (Chirang), Dhiraj Borgoyary (Sobaijhar), Begum Akhtara Ahmed (Mathanguri), Augusta Tigga (Dihira), Emmanuel Mushahary (Darrangajuli), Maheswar Basumatary (Goreswar), Ganesh Kochary nated the BTC administration, is

Why FSL report on probe over alleged audio clips of ex-CM Biren Singh not filed, SC asks state



NEW DELHI, Aug 4: The Supreme Court on Monday questioned the state government for not placing on record a fresh forensic report on the authenticity of leaked audio clips alleging role of former Manipur chief minister N Biren Singh in the ethnic violence despite its direc-

A bench comprising Justices Sanjay Kumar and Satish Chandra Sharma referred to a previous order and asked the state, "What happened to the forensic report? That should have come at least. This order was passed in May 2025. Three months have passed. By now, the forensic report laboratory must have given you a report. At least tell us whether the report has come or it's still in the pipeline."

When the state's counsel said the FSL report had not come, the bench asked further, "How long does it take FSL to give a definite report on the analysis of the voice? We will pass it over. This can't go endlessly.

The matter could not reach the hearing again during the day. On May 5, a bench headed by former CJI Sanjiv Khanna ex-

amined a forensic report on au-

thenticity of leaked audio clips

alleging role of former Manipur CM and asked the state government to file a fresh report on the probe.

It opened the sealed cover report of the Central Forensic Sci-Laboratory (CFSL) submitted by Solicitor General Tushar Mehta and asked him to seek instructions from the state officers on the investigation.

"The FSL report has been filed. We need a month to probe it," the law officer said.

Mehta further said the Manipur High Court could hear the matter as "peace is prevailing now and the probe can go on".

After perusing the report, the CJI asked the law officer that he would have to speak to the officers about it.

The bench then posted the matter for a fresh report in the week of July 21.

Advocate Prashant Bhushan, appearing for petitioner Kuki Organisation for Human Rights Trust (KOHUR), said the probe related to the former chief minister and it should be fair, the CJI said, "Now we have the President Rule there... it should not be a problem".

Work for new Gauhati HC complex to start by year-end: CM

GUWAHATI, Aug 4: Despite strong opposition from the Gauhati High Court Bar Association over the proposed relocation of the high court complex, Assam Chief Minister Himanta Biswa Sarma on Monday said construction of the new premises will begin by the end of this year.

Speaking to reporters on the sidelines of an official function in North Guwahati, where the new building is proposed, Sarma said paying compensation to land owners has begun for acquiring their plots for the new Gauhati High Court complex.

"We will construct the new building of Gauhati High Court at Rangmahal. We have acquired 129 bighas (over 42.5 acres) for this. Today, we officially handed over the compensation to the land ownland," he added

After the first step in this process, the land for the judicial township has been made by the government and now the Public Works Department (PWD) will proceed to construct the high court, Sarma said.

"I believe the PWD will take control of the land soon and start the next process. Usually the tender process takes 2-3 months. We hope to start the construction by the end of this year." he added.

The Gauhati High Court Bar Association (GHCBA) has been vehemently opposing relocation of the high court complex to the northern banks of Brahmaputra from the existing place at the heart of the city.

Elaborating on the proposed new structure, the CM said, "We

along with the subordinate courts. We have planned a judicial township here. The architectural design is still under consideration of the HC, which may take another month to finalise it."

He said that the new complex is likely to be the biggest high court

"I feel there is no high court in India situated on such a large plot of land. It is going to be a big and beautiful project of Assam," Sarma said. Earlier, GHCBA had demanded an immediate halt to the project in the interest of all stakeholders and the public at large.

The HC is located in Uzan Bazar area of central Guwahati on the southern banks of Brahmaputra. It has a historical building, while a state-of-the-art multi-crore modern multi-storey structure was con-

IIT-G researchers develop sensor that can help people with voice disabilities communicate

GUWAHATI, Aug 4: Researchers at IIT-Guwahati have developed an underwater vibration sensor that enables automated and contactless voice recognition.

Developed in collaboration with researchers from Ohio State University in the US, the sensor offers a promising alternative communication method for individuals with voice disabilities who are unable to use conventional voice-based systems, the IIT-Guwahati said in a statement on Monday.

Voice recognition has become an integral part of modern life as it helps users in operating smart devices, including mobile phones and home appliances, through voice commands, it

However, for the people with voice disorders, this technological development remains inaccessible, it said.

To address this limitation, the research team has found a solution by focusing on the exhale air through the mouth while speaking, a basic physiological function, it added.

"In cases where individuals cannot produce sound, attempting to speak generates airflow from their lungs. When this air flows over a water surface, it produces subtle waves. The re-

search team has developed an underwater vibration sensor which can detect these water waves and interpret speech signals without depending on audible voice, thus creating a new pathway for voice recognition," the statement

The developed sensor is made from a conductive, chemically reactive porous sponge, it

When placed just below the air-water interface, it captures the tiny disturbances created by exhaled air and converts them into measurable electrical signals. The research team used Convolutional Neural Networks (CNN), a type of deep learning model, to accurately recognise these subtle signal patterns.

This setup allows users to communicate with devices from a distance, without the need to

The findings of the research have been published in the journal, Advanced Functional Ma-

Professor Uttam Manna, who was a part of the research team, said, "It is one of the rare designs of material allowing to recognise voice based on monitoring the water wave formed at the air/water interface (CONTD. ON PAGE-2)

JORHAT, Aug 4: A high-yielding pur ple rice variety 'Labanya', developed by Assam Agriculture University (AAU), has been registered under the Protection of Plant Varieties and Farmers' Rights Authority (PPVFRA), officials said on Monday.

'Labanya' integrates the rich nutritional profile of the traditional black rice, with the adaptability and convenience required for both daily consumption and commercial cultivation, the Public Relations Officer (PRO) of AAU, Ranjit Kumar Hout, said.

"AAU is pleased to announce that 'Labanya' has recently been registered under the Protection of Plant Varieties and Farmers' Rights Authority (PPVFRA). This is a big achievement for the scientists at AAU," he said.

According to an official directive from the office of the Chancellor of AAU, the variety was officially launched for commercialization before its formal registration and notification



leverage its commercial potential, the PRO said. "Accordingly, 'Labanya' was introduced on e-commerce platforms and exclusive commercial rights were granted to a local entrepreneur.

The variety has been sold across more than 18 states with over 30 per cent of buyers identified as repeat customers, reflecting strong market demand and consumer satisfaction," he said.



Bhushan termed the contents of the audio leaks a "very serious matter" and said Singh was purportedly heard saying that Meitei groups were allowed to loot arms and ammunition of the state government. On November 8 last year, a bench headed by former CJI D Y Chandrachud directed KOHUR to produce material to indicate the authenticity of some of the leaked audio clips.

Over 260 people were killed and thousands displaced since the ethnic violence broke out between the Imphal valley-based Meitei and neighbouring hills-based Kuki communities in May 2023.

The clashes began after a "Tribal Solidarity March" was organised in the hill districts to protest against an order of the Manipur High Court on the Meitei community's demand for scheduled tribe status. Bhushan alleged that the recorded conversation prima facie showed the complicity and involvement

of the state machinery in the violence against the Kuki Zo community.

He said the clips had "disturbing conversations" and Singh could be heard instigating the violence and protecting the attackers. KOHUR's plea alleged that Singh was instrumental in "inciting, organising and thereafter centrally orchestrating the large-scale murder, destruction and other forms of violence against the Kuki-dominated areas in Manipur". (PTI)

Starting from Kangkan Ground at Lakla, the rally — led by the All Assam Tribal Sangha (Margherita sub-division) and the Tirap Autonomous District Council Demand Committee, along with several students' and community organisations — culminated in Jagun town.

Participants from the Mising, Sonowal Kachari, Mech Kachari, Tangsa, Singpho, Tai Khamti, Tai Khamyang, Rabha, Tai Phakey, Hajong, Deori and Sema communities marched with banners and raised slogans, terming the decision a direct threat to the constitutional land rights, cultural identity and safeguards of Scheduled Tribes in the notified tribal belt.

Speakers at the rally stressed the historical role of the Tirap Tribal Belt and Block in protecting the rights and heritage of local tribes. They warned the government that diluting its status would set a dan-

gerous precedent for tribal areas across the state and country. Pallab Shyam Wailung, general secretary of the Tirap Autonomous District Council Demand Committee, said granting protected status and land rights to non-protected groups in the belt was a "gross viola-

Delhi new labour codes

elhi government has finally taken a step towards implementation of the controversial new labour codes by publishing its Draft Code on Social Security Rules, 2025. This is first to be framed by the Delhi Government under the Code on Social Security 2020 passed in the Parliament of India. The rules under other three codes - the Code on Wages 2019, Code on Industrial Relations 2020, and the Code on Occupational Safety, Health, and Working Conditions2020 - are in various states of finalization, which the state government expects to complete in near future. It is to be noted that Delhi government led by Aam Aadmi Party (AAP) had been opposing the new labour codes which the PM Narendra Modi government at the centre got passed in the parliament as part of biggest labour reform in the country since independence. These codes primarily aimed ease of doing business. PM Modi had said that it would benefit the workforce in the country, which the joint platform of the Central Trade Unions (CTUs) has been opposing these as anti-labour and pro-corporate, with numerous protest demonstrations and even all India strike actions the last being on July 9, 2025.

Nevertheless, the BJP led government at the Centre and in Delhi does not seem to be affected by the strike action of July 9, and they are going forward to implement those controversial labour codes. On July 24, the Union Minister of State for Labour and Employment Shobha Karandlaje has informed the Rajya Sabha in a written reply to a question that as a step towards implementation of the four labour codes, the Central Government has prepublished the draft Rules. Since labour is in the Concurrent List of the Constitution of India, state governments are also empowered to make labour rules. She informed the parliament that out of 36 states and UTs, 32 have prepublished their draft rules under the four labour codes. The states and UTs which have not pre-published their draft rules under any of the labour codes were West Bengal and Lakshadweep. Lakshadweep is a Union Territory while the West Bengal is ruled by Trinamool Congress led by Mamata Banerjee, who is dead against the new labour

As for Delhi is concerned, it had pre-published draft rules under the Code of Wages 2019 in November 2021, when the state ruled by AAP under chief ministership of its Supremo Arvind Kejriwal. It should be noted that prepublication of the rules allows the government for public consultation. Thereafter, Delhi has stopped framing of rules and their pre-publication. The work on labour codes progress only after BJP won the Delhi election held in February 2025, and came to power. BJP led government in Delhi has the started working on framing of rules under

Gopinath Bordoloi: The architect who shielded Assam from Islamisation

Assam, where political discord and so-Lcial fragmentation threaten the state's harmony, the memory of Gopinath Bordoloi, fondly known as "Lokpriya" or "loved by all," emerges as a beacon of unity and resilience. As the first Chief Minister of Assam in independent India, Bordoloi's indomitable spirit and farsighted leadership were instrumental in safeguarding Assam from being subsumed into an Islamic state during the critical juncture of India's independence in 1947. At a time when the British government's divisive policies sought to carve the subcontinent into Hindu and Muslim majority states, Bordoloi's resolute opposition to the Cabinet Mission Plan ensured Assam's distinct identity within the Indian Union. His legacy, rooted in principled leadership and unwavering commitment to his people, remains a clarion call for unity amidst the contemporary challenges facing Assam.

Born on June 6, 1890, in Raha, Assam, Gopinath Bordoloi's early life was marked by personal tragedy and academic excellence. The loss of his mother at the age of 12 did little to deter his intellectual pursuits. Excelling in his studies, he matriculated in

1907 and gained admission to Cotton College in Guwahati, then affiliated with the University of Calcutta. His academic journey contin-

ued at the prestigious Scottish Church College in Calcutta, where he earned his bachelor's degree in 1911, followed by a Master's degree from the University of Calcutta in 1914. Initially pursuing law, Bordoloi briefly served as Headmaster of Sonaram High School at the request of Tarun Ram Phukan before establishing a legal practice in Guwahati in 1917. This foundation of intellectual rigor and public engagement set the stage for his transformative political career.

Bordoloi's political awakening came in 1921 when he joined the Indian National Congress as a volunteer, immersing himself in the Non-Cooperation Movement. His arrest in 1922, resulting in a year of imprisonment, only deepened his commitment to India's freedom struggle. After the movement's suspension following the Chauri Chaura incident, Bordoloi resumed his legal practice but remained active in social work.

serving on the Guwahati Municipal Board align with the Muslim League's demands and Local Board from 1930 to 1933. His advocacy for a separate university and high court for Assam during this period reflected his vision for the state's development. By 1936, the Government of India Act paved the way for provincial elections, and Bordoloi emerged as the leader of the opposition in the Assam Legislative Assembly. showcasing his growing political stature.

In September 1938, following the resig-

nation of the Md. Sadulla Cabinet, Bordoloi was invited to form the government, becoming Assam's Premier. The outbreak of World War II in 1939 and Mahatma Gandhi's call for resistance led to the resignation of his Cabinet in 1940, followed by his arrest in December of that year. The year 1946 marked a defining moment in Bordoloi's career as the Congress secured victory in the Assam Assembly elections, and he was unanimously chosen as Chief Minister for the second time, a position he held until his death on August 5, 1950. The arrival of the British Cabinet Mission on March 23, 1946, tasked with drafting a future Constitution for India, posed an existential threat to Assam's autonomy. The Mission's plan arbitrarily divided British India into three groups: Group A, comprising six Hindu-majority provinces; Group B, including Punjab, Sindh, Baluchistan, and the North-West Frontier Provinces; and Group C, clubbing Assam with Bengal to create a predominantly Muslim zone in eastern India. This proposal, designed to for Pakistan, was a calculated move by the British Labour government to perpetuate division in the subcontinent.

On April 1, 1946, Bordoloi met with the Cabinet Mission and vehemently opposed the inclusion of Assam in Group C. He argued that Assam, a province formed on linguistic and cultural lines with provincial autonomy, deserved to remain a distinct entity in the future constitutional framework. Rejecting Mohammed Ali Jinnah's de-

> preposterous," Bordoloi also supported the separation of Sylhet district from Assam to preserve its cultural integrity. Despite his cogent arguments, the Mission persisted with its grouping scheme, announced on May 16, 1946. The proposal required Assam's representatives to the Constituent Assembly to sit with Bengal's rep-

mand for Pakistan as "absolutely

resentatives to determine both provincial and group constitutions by a simple majority, effectively subordinating Assam's interests to a Muslim-majority Bengal.

The announcement sparked widespread outrage in Assam. The Assam Provincial Congress Committee, meeting in Guwahati, lodged a strong protest with the Congress Working Committee, while the Asom Jatiya Mahasabha exposed the Muslim League's designs through secret documents. A fervent agitation swept the state, driven by fears that Assam would lose its identity in a "political whirlpool of Muslim India." On July 16, 1946, the Assam Legislative Assembly, led by Bordoloi, adopted a resolution expressing strong disapproval of the grouping plan. It directed Assam's ten representatives to the Constituent Assembly to refrain from sitting with any other province to devise Assam's constitution or settle related matters, a bold stand that underscored Bordoloi's determination to protect Assam's sovereignty.

Recognizing the gravity of the situation, Bordoloi sought the guidance of national leaders. Accompanied by Bijoy Chandra Bhagawati and Mahendra Mohan Choudhury, he met Mahatma Gandhi at Srirampur to present Assam's case. Strengthened by Gandhi's blessings, Bordoloi tirelessly lob-

bied the Congress Working Committee, which initially hesitated to take a firm stance. His persistence and strategic acumen ultimately prevailed, convincing Indian leaders to reject the Cabinet Mission's grouping scheme. This victory ensured that Assam could draft its own constitution independently, averting its inclusion in what would become East Pakistan (now Bangladesh). Had Bordoloi not acted with such foresight, Assam's history—and indeed India's northeastern frontier-might have been irrevocably altered.

Beyond this pivotal achievement, Bordoloi's post-independence contributions as Chief Minister were transformative. He spearheaded the establishment of Gauhati University, the High Court of Assam, Assam Medical College, and Assam Veterinary College, laying the foundation for the state's educational and judicial infrastructure. His efforts to rehabilitate millions of Hindu refugees fleeing violence in East Pakistan fostered communal harmony and stability. As chairman of the North-East Frontier Tribal and Excluded Areas Sub-Committee, Bordoloi shaped the Sixth Schedule of the Indian Constitution, ensuring autonomous governance for tribal areas in Assam, Meghalaya, Tripura, and Mizoram. His literary contributions, including works like Annasaktiyog and Shreeramachandra, penned during his imprisonments, reflected his intellectual depth and Gandhian values.

Bordoloi's untimely death in 1950 was a profound loss, yet his legacy endured. In 1999, he was posthumously awarded the Bharat Ratna by Prime Minister Atal Bihari Vajpayee, becoming the first Northeasterner to receive this honor. On October 1, 2002, a life-size statue of Bordoloi was unveiled in the Parliament House by President A.P.J. Abdul Kalam, cementing his place among India's national heroes. Revered as a disciplined Gandhian and a statesman of unparalleled stature, Gopinath Bordoloi's heroic leadership rescued Assam from a colonial conspiracy, ensuring its cultural and political integrity. As Assam grapples with contemporary challenges, Bordoloi's example of unity, integrity, and selfless service remains a powerful reminder of the leadership needed to navigate the state's future. The criminalization of Indian politics

olitics has become the last refuge of criminals Criminalization of politics is a major challenge for India, the world's largest democracy. Decriminalization of politics is essential for a healthy democracy. How dangerous it is for the democratic system to entrust the responsibility of legislation to lawbreakers. During every election, candidates are required to declare before the commission cases against them and a list of movable and immovable assets under affidavit. People can know Who owns how much property and who is involved in how many criminal cases.413 candidates in the first phase of the Lok Sabha elections have been revealed to have criminal cases against them. 18 candidates have criminal cases against women.

The next list will reveal the nature of more criminal candidates. The Association for Democratic Reforms (ADR) recently reported that the number of candidates with criminal cases in all major political parties in Karnataka has increased ahead of the 2023 Assembly elections This has raised the issue of criminalization of politics. The ADR has recommended permanent disqualification of candidates convicted of felony contesting

However, such disqualification has not yet been implemented. Political criminalization comes into play when criminals participate in politics to stay in government, ie contest elections and are elected to Parliament and State Assemblies. The growing threat has become a major problem for society. This has affected fundamental principles of democracy such as fairness in elections, rule of law and accountability etc. Since 2004, the number of candidates with criminal cases elected to Parliament in India has been increasing, ac-

cording to ADR data. In 2004, 24% of MPs had criminal cases pending, rising to 43% in 2019. A petition filed in February 2023 claimed that since 2009, the number of MPs with declared criminal cases had increased by 44%. In the 2019 Lok Sabha elections, 159 MPs declared under oath their serious criminal cases of rape, murder, attempted murder, kidnapping and crimes against women. One of the main reasons for the criminalization of politics is the vote

Some candidates and political parties often resort to vote buying and other illegal activities to



win elections. The close relationship between politicians and some of the most unscrupulous people in their constituencies creates an environment that encourages the misuse of power and resources for personal gain breeds corruption and criminal activity.

This culture of political crime is often given dimension by these connections. Corruption is another serious problem—most candidates contesting elections require large amounts of money, people, and donations. Where will this huge amount of money come from? So many have to resort to black money criminal mafia industrialists take unfair advantage after elections in exchange for helping people with money. Indirectly, they want to use politicians to suit their own

It is also the source of the massive corruption scam. Politicians make eloquent promises during elections to end corruption and muscle power but rarely deliver. The inefficient governance of the country also plays an important role in increasing the criminalization of politics. There is a lack of proper laws and regulations to govern the electoral process. There is only a model code of conduct, which is not enforced by any law. The main problem is that the lawbreakers become the law makers of the country in the guise of the people This adversely affects the effectiveness of the democratic process in delivering good governance. The Constitution of India does not specify the grounds on which a person can be disqualified from contesting elections to Parliament, Assem-

bly or any other legislative body.

The Representation of the

People Act, 1951 provides for the criteria for disqualifying a person from contesting Assembly elections. Section 8 of the Act provides for disqualification from contesting elections if convicted of certain offences. Accordingly, a person sentenced to more than two years cannot stand for election for six years after the end of the term of imprisonment.

However, the law does not

prevent persons who have criminal cases against them from contesting elections. The Vohra Committee on the Criminalization of Politics was established in 1983 with the objective of identifying the extent of political-criminal nexus and suggesting ways to effectively address the criminalization of politics. In 2017, the central government launched a one-year plan to set up 12 special courts to expedite criminal cases against MPs and MLAs. In 2002, the Supreme Court ruled that every candidate contesting elections must declare their criminal and financial records along with their educational qualifications. Voters should be more conscious and responsible when electing people's representatives so that no criminal mafia can take advantage of the voters' awareness to enter the floor of the holy parliament. Voters should also be aware of misuse of funds during elections.

The judiciary should play an active role by considering banning candidates with serious criminal charges from contesting elections. To increase criminalization in politics, the RPA of 1951 needs to be amended so that persons against whom cases of crimes of a serious nature are pending cannot contest elections.

he northeastern region of India, comprising eight states—Assam, Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Tripura, and Sikkim—has long been a vital yet overlooked part of the country. Despite its unique cultural mosaic, strategic geopolitical significance, and rich natural resources, this region continues to face persistent neglect by the Indian national media. The limited and often skewed media attention towards the Northeast not only marginalizes its people but also undermines the very fabric of India's unity and diversity. This ongoing sidelining is a complex problem rooted in geography, politics, cultural ignorance, and media economics, which together result in the Northeast being largely invisible on the national stage.

The roots of this media neglect trace back to the structure and priorities of India's mainstream press and electronic media. Major media houses are predominantly headquartered in metropolitan cities such as Delhi, Mumbai, and Bengaluru. These urban centres shape editorial agendas that focus heavily on their immediate regions or on areas with large, lucrative markets. The Northeast, with its comparatively smaller population and lesser economic clout, falls far outside these priorities. News coverage is often dictated by considerations of advertising revenue and audience interest, making stories from the Northeast appear commercially less attractive. As a result, important issues from the region rarely receive the sustained attention or prime placement they deserve.

The persistent invisibility of the Northeast in national media narratives leads to a disturbing pattern. News about the region mostly surfaces when crises erupt—be it ethnic violence, insurgency, floods, or natural disasters. Even then, coverage is often fleeting, superficial, or sensationalized, reinforcing stereotypes of the Northeast as a conflict-ridden and unstable frontier. Such portrayals ignore the everyday realities of vibrant communities, developmental efforts, cultural festivals, and political dialogues that shape life in the region. This episodic and crisis-driven coverage serves only to alienate the people of the Northeast further and distorts the perception of the region among the wider Indian public.

A significant consequence of this neglect is the erosion of empathy and understanding between



India. The region's complex history, marked by colonial legacies, ethnic diversity, and struggles for identity, requires nuanced and context-rich storytelling. However, the national media's tendency to simplify or homogenize the Northeast into a monolithic entity strips away these complexities. Each Northeastern state is unique, with distinct languages, customs, and challenges, yet this diversity is rarely reflected in mainstream discourse. This reductive approach not only diminishes the region's cultural richness but also prevents the emergence of informed national conversations on its developmental and political issues. Representation within newsrooms is another critical aspect contributing to the Northeast's marginalization. Journalistic leadership and reporting staff predominantly hail from India's Hindi-speaking belt or southern metro cities, often lacking lived experience or cultural understanding of the Northeast. Without a strong presence of Northeastern journalists in mainstream media, stories from the region risk being reported with bias, ignorance, or outright misrepresentation. Meaningful inclusion of Northeastern voices in media production is vital to bridge the empathy gap and foster more accurate and respectful

Language barriers further compound the problem. While regional news outlets in the Northeast thrive in local languages, their stories seldom reach national platforms due to lack of translation and crossmedia collaboration. English and Hindi dominate the national media landscape, limiting the dissemination of vernacular reports from the region. Strengthening partnerships between regional and national media, and investing in translation and content sharing, would greatly enhance the visibility of Northeast issues on the national agenda.

The rise of digital media has brought some positive change by

providing alternative platforms for Northeastern voices. Online portals, independent news websites, and social media channels based in the region have begun to highlight local stories that traditional media overlook. These digital outlets play a crucial role in grassroots reporting and community engagement. However, despite their growth, their reach and influence remain limited compared to legacy national media giants. Without integration into the larger media ecosystem, these alternative sources cannot fully counterbalance the main-

stream neglect. The ramifications of this persistent media neglect go beyond public perception: they influence policymaking and governance as well. Media attention often acts as a catalyst for political action and resource allocation. When Northeast India's concerns do not receive consistent national coverage, they fail to generate the political urgency required for comprehensive development and peacebuilding. Infrastructure deficits, ethnic tensions, environmental challenges, and social welfare issues in the region remain peripheral in the national policy discourse largely because they are invisible in the public domain. Media, as a democratic watchdog, must actively spotlight these concerns to ensure ac-

countability and progress. Strategic considerations further underscore the importance of inclusive media coverage of the Northeast. The region shares sensitive international borders with China, Myanmar, Bhutan, and Bangladesh, making it a critical zone for national security and foreign policy. Moreover, India's "Act East" policy seeks to enhance connectivity and economic integration with Southeast Asia through the Northeast. However, the lack of national media focus on these developments limits public understanding and support for initiatives vital to the country's strategic interests. Comprehensive coverage would not only inform citizens but also build national consensus on policies affecting the region. Addressing this persistent neg-

lect requires concerted efforts on multiple fronts. Media organisations must decentralize their operations by establishing robust bureaus in Northeastern states staffed with local journalists. Editorial priorities should treat stories from the region with equal seriousness and frequency as those from other parts of India. Journalism education and recruitpromote Northeastern representation at all levels, from reporters to editors. National media must also forge partnerships with regional news outlets to facilitate content exchange and wider dissemination of regional stories. Language inclusivity through translations and subtitling can help bridge communication gaps.

The role of media consumers is equally significant. Audiences must demand diverse and balanced news coverage that includes the Northeast as an integral part of India's national narrative. Civic activism, public discourse, and social media campaigns can pressure media houses to rectify biases and expand their geographical focus. Greater public curiosity and empathy towards the Northeast can drive editorial change and encourage more comprehensive reporting.

Persistent neglect of the Northeast by the Indian national media is not simply a journalistic oversight; it represents a democratic failure. In a pluralistic and federal nation, all regions and peoples must have a voice in the public sphere. The media's fundamental role as a bridge between the government, civil society, and the citizenry is compromised when vast areas of the country remain invisible. Genuine national integration and social cohesion depend on inclusive media that fairly represents the diversity of India's geography and culture.

Bringing the Northeast out of the shadows requires an acknowledgment of its importance and an unwavering commitment to balanced reporting. It demands recognition of the region's unique challenges and contributions, alongside a respect for its cultural and ethnic plurality. Only through sustained and empathetic media engagement can the Northeast become a visible, vibrant, and respected part of India's democratic and developmental journey. The persistent neglect of the Northeast must end, for the health of Indian democracy and the unity of its people depend on it.

How phones and WiFi hide our cosmic address

cientists have long turned to the mysteries of black holes to unlock secrets about our place in the vast expanse of the universe. These enigmatic cosmic entities, where gravity is so intense that not even light can escape, serve as crucial beacons for understanding the structure, expansion, and evolution of the cosmos. By studying the signals emitted from around black holes, particularly radio waves, astronomers can map out galaxies, trace the history of the universe back to the Big Bang, and pinpoint our exact location within this immense framework. It's like using distant lighthouses to navigate a foggy sea. However, in an ironic twist, the very technology that connects us in our daily lives like mobile phones and WiFi is increasingly obscuring this cosmic view, creating interference that hampers scientific

To appreciate the issue, we first need to delve into why black holes are so vital to astronomy. Black holes form from the collapse of massive stars, creating regions of spacetime so warped that they devour everything nearby. But it's not just their destructive power that fascinates scientists; it's the phenomena around them. For instance, as matter spirals into a black hole, it heats up and emits powerful radiation across the electromagnetic spectrum, including radio waves. These waves travel across billions of light-years to reach us, carrying information about the black hole's environment, the distribution of dark matter, and even the rate at which the universe is expanding. Projects like the Event Horizon Telescope, which captured the first image of a black hole in 2019, rely on synchronizing radio telescopes around the world to create a virtual Earth-sized observatory. This allows us to "see" these invisible giants and, by extension, orient ourselves in the cosmic landscape.

Our position in the universe isn't just a philosophical question. It's a scientific one with profound implications. By analyzing black holes in distant galaxies, astronomers can measure redshift, which tells us how fast objects are moving

away from us due to the universe's expansion. This helps refine the Hubble constant, a key parameter in cosmology. Moreover, supermassive black holes at the centers of galaxies act as anchors, influencing galactic formation and evolution. Understanding them helps us comprehend why our Milky Way looks the way it does and where Earth fits into this galactic neighborhood. Without clear observations, we're essentially flying blind in our quest to answer fundamental questions: How did the universe begin? Where is it headed? And what is our role in it?

Yet, this pursuit is being thwarted by an unlikely culprit: the radio frequency interference (RFI) from everyday devices. Mobile phones, WiFi routers, satellite communications, and even Bluetooth gadgets operate on frequencies that overlap with those used in radio astronomy. Radio telescopes are incredibly sensitive instruments designed to detect faint signals from the edge of the observable universe. When a telescope picks up these human-made signals, it drowns out the cosmic whispers, leading to noisy data that's hard to interpret. Imagine trying to listen to a faint whisper in a crowded stadium; that's the challenge astronomers face today.

The problem has escalated with the rollout of modern technologies. The advent of 5G networks, for example, uses higher frequency bands that encroach on the spectrum reserved for astronomical observations. WiFi 6 and beyond promise faster internet but at the cost of more pervasive RFI. Even low-Earth orbit satellites like those in Starlink constellations beam down signals that can blanket the sky, creating streaks of interference in telescope data. In remote observatories, where scientists once escaped urban noise, this satellite pollution is becoming unavoidable. A study published in Nature Astronomy in 2023 highlighted how satellite mega-constellations could increase RFI by up to 10 times, potentially blinding radio telescopes to certain frequencies.

This interference isn't just a minor annoyance; it has real consequences for science. Take the search for fast radio bursts (FRBs), mysterious



millisecond-long pulses often linked to black holes or neutron stars. Detecting these requires pristine radio data, but RFI can mimic or mask them, leading to false positives or missed discoveries. Similarly, efforts to study the cosmic microwave background rely on mapping subtle temperature variations, which RFI can distort. If we can't observe black holes accurately, our models of the universe become less reliable, stalling advancements in physics, from general relativity to quantum gravity theories.

The human element adds another layer to this dilemma. Our reliance on connectivity has exploded; billions of people use smartphones daily for work, social interaction, and entertainment. WiFi is ubiquitous in homes, offices, and public spaces, enabling everything from streaming videos to smart home devices. This technological

boom has lifted societies, bridging gaps and fostering innovation. But it comes at a price. As urban sprawl and digital infrastructure expand, even protected "radio quiet zones" like the National Radio Quiet Zone in West Virginia, USA, face encroachments from nearby developments.

Astronomers are fighting back with creative solutions. One approach is relocating telescopes to isolated spots with minimal human activity. The Atacama Desert in Chile hosts the Atacama Large Millimeter/submillimeter Array (ALMA), perched at high altitudes where the dry air and remoteness reduce interference. Similarly, the Square Kilometre Array (SKA), an ambitious project spanning Australia and South Africa, is being built in radioquiet regions to capture unprecedented details of black holes and early universe phenomena. These sites enforce strict controls: no cell phones, no

WiFi, and even restrictions on vehicle electronics. Technological fixes are also emerging. Advanced signal processing algorithms can filter out RFI, using machine learning to distinguish cosmic signals from terrestrial noise. For instance, software like RFI mitigation tools in the MeerKAT telescope in South Africa employs real-time excision of interfering signals. International regulations play a role too. The International Telecommunication Union (ITU) allocates spectrum bands for astronomy, designating "protected" frequencies where commercial use is limited. However, enforcement is tricky, as demand for bandwidth from telecom giants grows. Advocacy groups like the Committee on Radio Astronomy Frequencies (CRAF) lobby for better protections, urging governments to balance economic interests with scientific needs.

Collaboration between scientists and industry offers hope. Some companies are designing "astronomy-friendly" technologies, like satellites that dim their signals over observatories or WiFi systems that avoid sensitive bands. Public awareness is key; educating people about the invisible pollution of RFI could lead to supportive policies. Imagine apps that notify users when their devices might interfere with nearby telescopes, encouraging temporary shutdowns.

This conflict highlights a broader tension in human progress: the trade-off between immediate convenience and long-term knowledge. Black holes remind us of our smallness in the universe, yet our gadgets are inadvertently veiling that truth. To truly know where we are, we must quiet the digital clamor. By fostering dialogue between tech developers, policymakers, and astronomers, we can preserve the clarity needed to gaze into the abvss

Black holes aren't just distant curiosities. They're mirrors reflecting our cosmic address. If we let phones and WiFi block the view, we risk losing sight of our place in the grand scheme. But with mindful innovation, we can have our connectivity and our cosmos too. The universe is calling; we just need to clear the line.

India 2047: In search of a New Economic imagination

ecent developments detrimental to India's economic interests — such as China's restrictions on the export of rare earths and fertilisers, and the sudden exodus of Chinese engineers and technicians from Foxconn's iPhone facilities — underscore an urgent need for strategic recalibration. These are not isolated incidents. They reflect broader shifts in global trade architecture, the weaponisation of commerce, and a deepening asymmetry between India and China's economic heft. India's immediate responses will naturally aim to cushion disruptions in critical supply chains. But the more pressing imperative lies beyond crisis management — it is about engineering a fundamental transformation in the policy architecture that has governed India's growth story. The central question now is: Will this moment of geopolitical churn catalyse a new development bargain that places growth, prosperity, and upward mobility at the heart of India's future?

The Foundations: A Compact Built on Stability

The idea of a growth-oriented elite compact is not new. Historically, India's priorities have often tilted away from economic expansion and towards state consolidation. At the time of Independence, the trauma of Partition, the incorporation of princely states, and fears of national disintegration shaped a compact rooted in stability rather than growth. A strong Centre, enshrined in the Constitution, was seen as essential for holding the Union together. Political arrangements and economic policies alike were crafted within this overarching framework. Planning was centralised. Economic efficiency took a back seat.

In the early decades after Independence, the state's interventions in the economy were not necessarily designed to maximise output or innovation but to manage social and political coalitions. Even the liberalising shifts of the 1980s, as noted by economists Dani Rodrik and Arvind Subramanian, were less a response to economic logic and more an attempt to garner political support from dominant business lobbies. The result was a stunted economic landscape: Anaemic growth, widespread poverty, and a missed opportunity to build a dynamic industrial base. The system failed to deliver mass prosperity.

The 1991 Watershed: Building a Growth Con-

It took the 1991 balance of payments crisis to realign national priorities. What followed was the construction of a new compact — one that placed growth and development at its core. The liberalisation process triggered by the Narasimha Rao government, with Manmohan Singh as finance minister, represented a break from decades of economic conservatism. This was India's entry into a global order dominated by open markets, capital flows, and multilateral trade.

Economist Stefan Dercon calls such realignments "development bargains" — agreements among a nation's political and economic elites to prioritise prosperity and structure politics accordingly.

Interestingly, this new consensus emerged at a time of political decentralisation. The era of one-party dominance gave way to coalition politics, yet the elite bargain around growth held firm. The NDA government under Atal Bihari Vajpayee deepened the reform agenda, expanding infrastructure and opening up telecom and insurance sectors. The subsequent UPA governments continued the economic liberalisation journey, albeit with a sharper focus on inclusive development through schemes such as MGNREGA and the National Rural Health Mission. These welfare programmes were not detours from the growth compact, but rather its social stabilisers — mechanisms to preserve support for a market-oriented development path in a complex and unequal society.

The Age of Globalisation: Riding the Tides

This period coincided with the zenith of globalisation. As tariffs fell and capital flowed freely, India found a place in the global economy. Export-oriented sectors thrived, the IT industry exploded, and millions moved from agriculture into manufacturing and services. Urbanisation accelerated. Foreign direct investment surged. Poverty declined faster than in previous decades, and a new Indian middle class emerged — particularly from the southern and western states — propelled by the services sector and new aspirations.

Yet the high tide did not lift all boats equally. Regional disparities persisted. Infrastructure bottlenecks constrained growth. And while the private sector expanded, job creation lagged. Still, the broad elite consensus — that growth must be pursued as the primary national objective — endured. Even as growth slowed during the second UPA term, due in part to corruption scandals, policy drift, and global headwinds, there was no serious rupture in the underlying compact.

2014 and After: New Hopes, Emerging Fault Lines

The 2014 general elections were a turning point. The Bharatiya Janata Party, riding a wave of discontent over economic stagnation and corruption, came to power with a single-party majority — the first in three decades. This was widely interpreted as a moment of clarity: the end of fractious coalitions would allow decisive economic reforms. The promise of "Minimum Government, Maximum Governance" sought to reinvigorate the stalled growth story.

The Modi government's first term saw significant policy continuity. Initiatives like the Goods and Services Tax (GST), inflation targeting through a revamped RBI framework, and fiscal discipline carried forward the reform momentum. Foreign investors responded positively. Programmes like "Make in India," "Digital India," and the Jan Dhan Yojana hinted at new ambi-

tions. Yet, the actual outcomes on job creation and investment were mixed. The growth compact was in need of renewal, and by the time the pandemic struck, fault lines had already begun to show.

The Pandemic and the Populist Turn

The COVID-19 pandemic dealt a severe blow to India's economy, but it also exposed deeper weaknesses in the elite consensus. Economic inequalities widened. Urban employment collapsed. Upward mobility pathways, especially for the youth, shrank. In this climate, political incentives shifted. Across parties and states, a populist impulse took hold. Cash transfers, tax cuts, loan waivers, and free food schemes proliferated. While these measures provided short-term relief, they also diluted the focus on long-term productivity, innovation, and enterprise.

India's Production Linked Incentive (PLI) scheme, aimed at fostering manufacturing champions, was one of the few major policy innovations. But it remains a nascent effort with limited traction beyond a few sectors. Another noticeable development is the informal strategy of promoting select private conglomerates as national champions. While this may work in some strategic areas, it cannot substitute for a broad-based industrial policy or genuine entrepreneurship.

What is missing is a new, updated version of the 1991-style development bargain — one that reflects contemporary geopolitical and economic realities.

Global Headwinds and Structural Constraints
The international environment has changed dramatically. Trade is no longer the reliable engine of growth it once was. The Trump era marked a retreat from multilateralism, a trend that continues in various forms globally. India, too, has grown wary of trade deals—walking out of RCEP was one such sign. But in choosing to stay out of deeper integration with Asian supply chains, India risks isolating itself from the most dynamic nodes of global manufacturing.

Compounding this are new disruptions: the rise of artificial intelligence, which threatens the very IT jobs that created India's middle class; China's increasing economic coercion; and the reshuffling of global value chains. In this context, a mere continuation of past strategies — or a reliance on state-led populism — will not suffice.

The Tall Order of 2047

India has set itself an ambitious target: becoming a developed nation by 2047. This is aspirational, and rightly so. But it must be tempered by economic realism. Only a few nations have managed to climb from middle-income status to high-income prosperity within a few decades. If India continues to grow at the pace seen over the past ten years — a 5.7% annual increase in per capita income in dollar terms — average incomes by 2047 will hover just under \\$10,000. This would place India on the cusp of high middle-income status, but still well short of developed country benchmarks.

More importantly, sustaining such growth will require more than good intentions. It will require an explicit elite compact — a conscious agreement among the political and economic classes — to prioritise growth through innovation, investment, education, and global engagement. This will not happen automatically. It will demand tough reforms, a deeper fiscal state, and strong institutions.

Towards a New Growth Bargain

India needs to rediscover the political will to frame a new growth bargain. This bargain must go beyond slogans. It must re-imagine the roles of government and markets, empower cities and states, unleash entrepreneurial energies, and build resilient supply chains that are integrated with, not isolated from, global flows. It must invest massively in human capital, not just physical infrastructure.

At its core, this new compact must be built on the recognition that sustained growth — the kind that creates jobs, raises wages, and delivers dignity — is not a technocratic exercise. It is a political choice.

If India wants to be a developed nation by 2047, the road does not lie through populist giveaways or protectionist walls. It lies through a renewed commitment to economic dynamism, supported by a unified elite, and underwritten by the aspirations of its people. Only then can the promise of 1991 be fully realised. Every voice opposing education is actually a symbol of the fear that haunts the hypocrites – that if a child gets educated, he will raise questions on issues like casteism, discrimination, discrimination in temples, the status of women, exploitation and injustice. This fear keeps them away from books.

Even today, it is said in many places that "If you educate your daughters too much, it will become difficult for them to get married." An educated society is the foundation of a progressive nation. But when education itself is viewed with suspicion, the future of the country becomes dark. Considering schools inferior to places of worship, giving teachers a second place in society and giving priority to mantras instead of knowledge - all this is the result of the same mentality.

It is also worth noting that many times political power and religious hypocrisy come together. In the vote bank politics, so-called sadhus get a platform and they exploit the mentality of children by calling their education a delusion and a sin. Many times such preachers even get a government platform, security and facilities.

When children go to school, they don't just learn math, science, or language. They also learn freedom, equality, reason, and rights. This is what makes hypocrites uncomfortable.

They don't want any child to ask "If we are all children of God, then why

are there castes?"
"Why are women not allowed to enter

temples?"

"Why don't the poor get good schools?"
Only these questions can shake the roots
of hypocrisy, hence the first attack of such
people is always on education.

The sad thing is that even the education department sometimes succumbs to these tendencies. Teaching religious rituals in schools, giving holidays in the name of Babas, or holding bhajan competitions have now become common.

In such a situation, a child who should be given the freedom to think is taught the lesson of imitation.

The condition of girls is even more pathetic. Silencing them in the name of 'Kanyadaan', keeping them confined in the house in the name of 'purity', and depriving them of education in the name of 'culture' - all this is the true picture of a society that shines from outside but is rotten from within.

We often say that an educated mother educates the entire family. But when society forces that mother out of school, generations grow up in darkness.

We have to understand that education is not an optional means, it is a fundamental right. The sparkle in the eyes of children increases when they have books in their hands, when they have the freedom to ask questions and when the teacher is their guide, not some Baba.

If we want a society that is rational, just and egalitarian, then we must connect children with education. For this, not just plans but a change in mindset is required.

We have to ask this direct question to the babas and hypocrites -

"If education is a sin, then why do you educate your children?"

"If it is unfair for girls to go to school

"If it is unfair for girls to go to school, then why are the daughters of your house going to college?"

Asking questions is the first step in the fight against hypocrisy.

Teachers should not only teach the curriculum but also make children discerning. They should tell them the difference between faith and understanding. Schools should become centres where independent thoughts are respected and not just imitation is taught.

Governments should stop any kind of religious interference in the field of education. Constitutional citizens should not allow the rights of children to be violated in the name of religion. And above all, society should consider children's education as a 'duty' and not a 'religion'.

There can be no religion greater than the future of children. His school is more important than any sermon.

More important than any miracle is his courage to ask the question.

Only books can break down the walls of hypocrisy. And on the first page of that book it should be written - "I can think, therefore I am free."

Ultimately, it is our collective responsibility to raise our children in a society where they can live with conscience, think freely and shape their future above all kinds of hypocrisy.

US tariffs put 30,000 South African jobs at risk, officials say

reciprocal tariffs have put an estimated 30,000 jobs at risk, South African authorities said Monday, four days before a 30 per cent US tariff on most imports from South Africa kicks in.

South Africa was slapped with one of the highest tariff rates by its third-largest trading partner after China and the EU — creating uncertainty for the future of some export industries and catapulting a scramble for new markets outside the US Tariffs come into effect on August 8.

In an update on mitigation measures, a senior government official warned that an estimated 30,000 jobs were in jeopardy if the response to the higher tariffs was "mismanaged"

"We base this on the ongoing consultations that we have with all the sectors of the economy from automotive, agriculture and all the other sectors that are going to be impacted," said Simphiwe Hamilton, director-general of the Department of Trade, Industry and Competition.

South Africa is already grappling with stubbornly high unemployment rates. The official rate was 32,9 per cent in the first quar-

Cambodian, Thai officials meet in Malaysia to iron out ceasefire details

KUALA LUMPUR, Aug 4: Thai and Cambodian officials met in Malaysia on Monday for the first round of cross-border committee talks since a tense ceasefire was brokered last week after five days of deadly armed border clashes that killed dozens and displaced over 260,000 people.

The four-day General Border Committee meetings were initially due to be hosted by Cambodia, but both sides later agreed to a neutral venue in Malaysia, the annual chair of the Association of Southeast Asian Nations, which has mediated the halt in hostilities last month.

The July 28 ceasefire followed economic pressure from President Donald Trump, who had warned the two warring nations that the US would not conclude trade deals with them if the fighting persisted. Washington lowered tariffs on goods from the two countries from 36 per cent to 19 per cent on Aug 1 following the truce. Monday's talks focused on ironing out details to avoid further clashes. Discussions of the decades-long competing territorial claims over the pockets of land near the shared border are not on the agenda.

Thailand and Cambodia have been feuding neighbours for centuries, since both were mighty empires. In modern times, a 1962 ruling by the International Court of Justice awarding Cambodia the land on which the ancient Preah Vihear temple stands marked a new low point in relations, and other border territory remained claimed by both countries.

Fighting erupted in 2011 at Preah Vihaer, after which the International Court of Justice in 2013 reaffirmed its earlier ruling, rankling Thailand. Relations deteriorated again sharply in May this year, when a Cambodian soldier was shot dead in a brief fracas in one of the disputed border zones, setting off diplomatic and trade sanctions, one against the other.

Soon after two incidents last month in which Thai soldiers were wounded by land mines in disputed territory, for which Thailand blamed Cambodia, the two sides downgraded diplomatic relations and fighting broke out, each side blaming the other for starting the armed clashes. Thai Deputy Defence Minister Gen Natthaphon Nakpanit is leading a delegation that includes representatives of all branches of the military, in addition to the police force and the ministries of foreign affairs. (AP)

SEOUL, Aug 4: South Korea's military said Monday it had begun removing loudspeakers along its border with rival North Korea in a move aimed at reducing tensions.

The speakers had previously been used to blast anti-North Korean propaganda across the border, but the South's new liberal government halted the broadcasts in June in a conciliatory gesture as it looks to rebuild trust and revive dialogue with Pyongyang, which has largely cut off cooperation with the South in recent years. South Korea's Defence Ministry said the physical removal of the loudspeakers from the border was another "practical measure" aimed at easing tensions between the war-divided Koreas and that it does not affect the South's military readiness. Lee Kyung-ho, a spokesperson for the ministry, didn't share specific details on how the removed loudspeakers will be stored or whether they could be quickly redeployed to the border if tensions flare again between the Koreas. There were no discussions between the two militaries ahead of the South's decision to remove the speakers, Lee said during a briefing.

North Korea, which is extremely sensitive to any outside criticism of its authoritarian leadership and its third-generation ruler, Kim Jong Un, didn't immediately comment on the South Korean step. The South's previous conservative government resumed the daily loudspeaker broadcasts in June last year following a yearslong pause in retaliation for North Korea flying trash-laden balloons toward the South in a psychological warfare campaign.

The speakers blasted propaganda messages and K-pop songs, a playlist clearly designed to strike a nerve in Pyongyang, where Kim's government has been intensifying a campaign to eliminate the influence of South Korean pop culture and language among the population in a bid to strengthen his family's dynastic rule.

The Cold War-style psychological warfare campaigns further heightened tensions already inflamed by North Korea's advancing nuclear program and South Korean efforts to expand joint military exercises with the United States and their trilateral security cooperation with Japan. South Korean President Lee Jae Myung, a liberal who took office in June after winning an early election to replace ousted conservative Yoon Suk Yeol, has vowed to improve relations with Pyongyang, which reacted furiously to Yoon's hard-line policies and shunned dia-

WASHINGTON, Aug 4: US and Chinese officials may be able to settle many of their differences to reach a trade deal and avert punishing tariffs, but they remain far apart on one issue: the US demand that China stop pur-

chasing oil from Iran and Russia. "China will always ensure its energy supply in ways that serve our national interests," China's Foreign Ministry posted on X on Wednesday, following two days of trade negotiations in Stockholm, responding to the US threat of a 100 per cent tariff.

"Coercion and pressuring will not achieve anything. China will firmly defend its sovereignty, security and development interests," the ministry said.

The response is notable at a time when both Beijing and Washington are signalling optimism and goodwill about reaching a deal to keep commercial ties between the world's two largest economies stable -- after climbing down from sky-high tariffs and harsh trade restrictions. It underscores China's confidence in playing hardball

when dealing with the Trump administration, especially when trade is linked to its energy and foreign policies. US Treasury Secretary Scott Bessent,

Negotiating tactics aside, China may also suspect that the US will not follow through on its threat, questioning the importance Trump places on countering Russia, Tu said.

Boeing addresses more labour strike amid attempt to resuscitate its reputation

The strike that began just after midnight Monday involving more than 3,000 members of the International Association of Machinists and Aerospace Workers arrives as Boeing is attempting to resuscitate its reputation.

17 crore jobs created under Modi rule in 10 years: Mansukh Mandaviya to Parl

NEW DELHI, Aug 4: India generated 17 crore jobs in the 10 years of the Modi government, a big leap from 3 crore in the previous decade of UPA rule, Parliament was informed on Monday.

Answering an oral or starred question in Lok Sabha, Labour & Employment Minister Mansukh Mandaviya said, "About 10 crore employment generation is recorded in the last 10 years during the Modi government...If we work of ten years of UPA rule, then only 3 crore jobs were created. We don't say at our own as it is the data of RBI."

The minister said that the RBI has been releasing annual employment generation data since Independence. He also told the House that in the last 16 months, the Centre has made jobs available to 11 lakh youth in the country.


"Modi ji has not only created employment but

also has a work plant for next five year to create jobs...at the beginning of Modi 3.0, PM Viksit Bharat Rozgar Yojana is announced under the plan to create over 4 crore jobs with an outlay of ₹ 2 lakh crore. We are getting good results from this scheme," Mandaviva said

Employment-linked incentive scheme, PM Viksit Bharat Rozgar Yojana (PMVBRY), is rolled out from August 1, 2025.

The scheme, aimed at incentivising job creation in the country, was approved by the Union Cabinet chaired by Prime Minister Narendra Modi earlier. With an outlay of ₹ 99,446 crore, the PMVBRY aims to incentivise the creation of more than 3.5 crore jobs over two years. Of these, 1.92 crore will go to freshers.

The benefits of the scheme will apply to jobs



created between August 1, 2025, and July 31, 2027. The scheme, Mandaviya said, forms a crucial part of India's strategy to accelerate economic growth.

It consists of two parts, with Part A focused on first-timers and Part B focused on employers. Part-A will offer a one-month EPF wage up to ₹15,000 in two instalments. Employees with salaries up to ₹ 1 lakh will be eligible.

The first instalment will be payable after six months of service, and the second will be payable after 12 months and completion of a financial literacy programme by the employee.

A portion of the incentive will be kept in a savings instrument or deposit account for a fixed period and can be withdrawn by the employee at a later date. The Centre will incentivise employers, with up to ₹ 3,000 per month, for two years, for each additional employee with sustained employment for at least six months.

For the manufacturing sector, incentives will be extended to the third and fourth years as well. Establishments registered with EPFO will be required to hire at least two additional employees (for employers with less than 50 employees) or five additional employees (for employers with 50 or more employees), on a sustained basis for at least six months.

All payments to the first-time employees under Part A of the Scheme will be made through the DBT (Direct Benefit Transfer) mode using the Aadhar Bridge Payment System (ABPS). Payments to the Employers under Part B will be made directly into their PAN-linked Accounts. (PTI)

RANCHI/NEW DELHI, Aug 4: JMM founder Shibu Soren, the veteran tribal leader who played a key role in Jharkhand's creation, breathed his last on Monday.

He was 81. Shibu Soren was undergoing treatment at a private hospital in Delhi for over a month for kidneyrelated problems.

"Respected Dishom Guruji has left us all... I have become 'shunya' (zero) today," Hemant Soren posted on X.

The Jharkhand Assembly was adjourned sine die, while the state government declared a three-day state mourning following the former CM's demise.

Condolences came pouring in from across the country. The mortal remains of the for-

mer Jharkhand chief minister will be brought to Ranchi from Delhi around 5.30 pm on Monday, Jharkhand Mukti Morcha (JMM) said.

His body will be taken to his native village in Ramgarh district on Tuesday and his last rites will be performed there, the party said.

The Jharkhand Assembly was adjourned sine die as a mark of respect to the former chief minister. Adjourning the House sine die, Assembly Speaker Rabindra Nath Mahato said, "Dishom Guru Shibu Soren left for heavenly abode today... His demise is not only an irreparable loss to Jharkhand but to the nation... He was known for his fight for the poor..."

Statehood, sixth schedule top priority for Ladakh, says MP Mohmad Haneefa

NEW DELHI, Aug 4: A democratic set-up and constitutional safeguards under the sixth schedule remain the priority for people of Ladakh, said MP Mohmad Haneefa, as he rued the slow pace of talks with the Union home ministry.

In an interview with PTI as Ladakh marks six years as a Union Territory, the MP, who comes from the Kargil region of Ladakh, said the cultural diversity and fragile environment of the cold desert must be protected constitutionally.

Haneefa said that the formation of the Union Territory was welcomed by many at the time, but people soon realised it was not what they had wanted.

"When Jammu and Kashmir was divided into two parts and Ladakh was made a Union Territory, one section was welcoming it and the other section was against it," he said.

That Ladakh should become a Union Territory was the voice of the people in Leh, but those in Kargil were against it.

"In 2019, when they abrogated Article 370, divided Jammu and Kashmir, and Ladakh was made a separate UT, at that time, there was a wave of happiness among the people who were demanding this. They welcomed it and celebrated it. But as people came to know about

this setup, they also realised that this is not the UT people of Ladakh were demanding," Haneefa said. "The people who were demanding UT wanted one

that had democracy. They wanted a UT with a legislature. At the same time with the abrogation of Article 370 and 35A, all our safeguards were gone. Ladakh got neither safeguards nor any democratic set-up was provided, so people of Ladakh realised that our future is dark in this set-up," he said.

People in Ladakh, whether Buddhists or Muslims. are ready to sacrifice their lives for the country, the lawmaker asserted. "But Ladakh is culturally different. There are seven ethnic groups in Ladakh, and the culture changes across tribes and regions. The environment is fragile, and while the area is huge, it is the largest constituency in India, but the population is very small, around 3-4 lakh. If people from outside come and settle down in Ladakh, the demography would change," he said.

Haneefa said the Union government must look at

Ladakh from a different perspective. The Leh Apex Body and Kargil Democratic Alliance, the two groups representing social, religious interests, are in talks with the government on their four-point demand. (PTI)

Wildlife crime cases in India decline significantly from 2020 to 2024: Govt

NEW DELHI, Aug 4: India recorded over 2,700 wildlife crime cases from 2020 to 2024, with West Bengal, Uttar Pradesh, and Haryana reporting some of the highest numbers, according to government data.

Responding to a question in the Lok Sabha, Union Minister of State for Environment Kirti Vardhan Singh said the responsibility for conservation and protection of wildlife, including prevention of illegal trafficking, lies primarily with the state governments and Union Territories under the Wild Life (Protection) Act, 1972.

The Wild Life Crime Control Bureau (WCCB) collects and shares intelligence, coordinates enforcement and issues alerts to combat organised wildlife crime.

The data shows India recorded a total of 2,701 wildlife crime cases from 2020 to 2024. The country registered 820 cases in 2020; 632 in 2021; 546 in 2022; 349 in 2023 and 354 in 2024.Between 2020 and 2024, West Bengal recorded the highest number of cases at 349, followed by Uttar Pradesh with 297 and



Haryana with 243.

Tamil Nadu logged 200 such cases, Assam 178, Uttarakhand 15, Andhra Pradesh 153, Madhya Pradesh 145, Odisha 143, Karnataka 84, Maharashtra 77, Himachal Pradesh 76, Meghalaya 71, Telangana 51, and Punjab 49. Singh said the WCCB works with state agencies, customs, border forces and international organisations like INTERPOL and the UN Office on Drugs and Crime to tackle wildlife traf-

India is also a signatory to the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES), with its provisions incorporated into the Wild Life (Protection) Act through a 2022 amendment.

In the last five years, the WCCB conducted 806 training programmes for government officials and 128 awareness campaigns and community outreach initiatives to curb wildlife

trafficking. The bureau has also established regional and sub-regional offices, including one covering Andhra Pradesh under its southern jurisdiction. Singh said measures to strengthen surveil-

lance include joint operations, intelligence sharing and sensitisation of border guarding forces. He said the government remains committed to tackling organised wildlife crime to safeguard India's biodiversity. (PTI)

Two drug peddlers from Assam arrested in Meghalaya

JOWAI (MEGHALAYA), Aug 4: Two drug peddlers were arrested in Meghalaya's West Jaintia Hills district on Monday, and over 50 grams of heroin was seized from their possession, police said.

The two hailed from Darrang district in neighbouring Assam.

Acting on intelligence inputs, a joint team of the Anti-Narcotics Task Force (ANTF) Meghalaya and district police conducted a naka operation under the jurisdiction of Jowai Police Station in the early hours of Monday and apprehended the suspects.

They were travelling from Silchar in Assam to the Meghalaya capital Shillong in a bus which was stopped by the authorities around 4 am.

During a search, two soap cases containing heroin were recovered from one person, while three more such soap cases were found in possession of the other.

The contraband, concealed in undergarments and pockets, tested positive for heroin and weighed a total of 52.02 grams, the police officer said.

A case has been registered at Jowai Police Station under the NDPS Act.

Police said further investigation is on to trace the supply network and identify other operatives involved in the narcotic drug trade. (PTI)

Siraj stars with magic spell as India tie series against England with spirited comeback at Oval



LONDON, Aug 4: The perseverant Mohammed Siraj's warrior spirit steered India to a series-levelling six-run victory over England in the fifth and final Test here on Monday, bringing a fitting end to one of the most intensely-fought and drama-filled showdowns in recent times.

With four wickets in hand and 35 runs to get, England held the edge before start of play but the gladiator in Siraj made life hell for the opposition batters from ball

In the end, his effort, complemented quite well by Prasidh Krishna at the other end, left England short by the thinnest of margins and allowed India to sign off 2-2 in the high-pressure five-match rubber.

Siraj was deservedly adjudged player of the match for his nine-wicket match haul for the team that was missing its regular pace spearhead Jasprit Bumrah in this game due to his workload management.

"I woke up in the morning and checked google on my phone and took out a 'Believe' emoji wallpaper and told myself that I will do it for the country," the effervescent 31-year-old said in a post-match interaction, joy and relief both apparent on his face despite a tired body that delivered 185.3 overs in the series.

The decision to call off play on day four before cut-off time after a brief spell of rain was questioned by the likes of Stuart Broad and Michael Vaughan but it seemed fitting that the series-decider went to the final day with both teams fighting tooth and nail from start to finish.

The day started with bright sunshine but two hours before start of play, the clear skies made way for dark clouds, giving

more hope to India and their fans who ensured a sellout crowd at The Oval on day five. The 25 pounds non-refundable ticket helped fill the 27,500 capacity facility in

"For us as a team that wasn't given a chance in the series...for us to fight back and fight every game and get a result of 2-2...for us and for Indian Test cricket going into the future, this will rank right at the top and this is where the change begins and the team will win a lot more series outside of India," said batter K L Rahul, who had his own role in the triumph with two hundreds

The ground's chief curator Lee Fortis, who made headlines before the start of the game for his verbal spat with India head coach Gautam Gambhir, used the heavy roller for one last time which usually makes batting a tad easier in the first 30 minutes of play.

When proceedings finally began, the new ball was due in 22 balls but England expectedly went on the offensive in overcast conditions from the word go.

Prasidh Krishna, who had four balls left from his 23rd over overnight, bowled a short ball to start with and Jamie Overton did well to pull it away for a four. An inside edge the following ball meant back to back fours for England, reducing the target to 27 runs.

He added that it was heartening to learn about the two participating teams. One





"We have seen India lift the World Cup, I mean nothing compares to lifting the World Cup. But so many doubts, so many questions from everybody about whether Test cricket will stay or not. I think both the teams and the way we've played in this series, I think we've answered that question," Rahul said at the post-match press conference. "For us as a team, that wasn't given a

chance in this series. And for us to fight back and to fight in every game and to get a result which is 2-2 might seem like a drop. But for us and for Indian Test cricket going in the future, I think this will rank right at the top," he added.

He said the Indian Test team will go on to win a lot many series "outside of India and the whole team deserves it."

"For the start of the series, we had Virat Kohli retiring, Rohit Sharma retiring, we had Ashwin retiring. So three big names out of the roster in India's team," he pointed out. A senior player now, Rahul emerged as one of India's biggest performers with 532 runs across the five Tests and forged a fine partnership with the younger Yashasvi Jaiswal at the top.

"Yeah, I think it hit me when I joined the

team. I was here about two weeks earlier playing India A's and it didn't hit me back then. But once I joined the team and I looked around and I didn't have Rohit and Virat and Ashwin who I played all my cricket with..

"Just to look around and not see them felt a bit weird. But yeah, that's when it hit me that everyone else is looking at me, coming to me to ask about English conditions, what they need to do, how they need to prepare."

Rahul said he relied on his experience to do his bit in not just performing but also steering the younger lot.

"And that's when it hit me that, okay, I've stepped into a different role now and it's time for me to help the younger guys. Use all the experience I've had of playing Test cricket and international cricket over the years and really put my hand up and stand up for this team.

'This moment almost feels like this is a young team that's going to stay there for a long time. While new skipper Shubman Gill topped the scoring chart with over 700 runs, Rahul was not far behind and provided the team solidity at the top of the order with his calm and composed batting.

Rahul was full of praise for Gill. "Shubman's been phenomenal. I think

he's really led from the front. He's worked really hard on the boys behind the scenes as well. In forming connections which a lot of people don't see.

"He's been tactically really good. The changes he's made over the series has always got us the wickets somehow. And I think he will grow. He will grow on to be a really, really good Test captain.

"I can't speak too much about his individual performance because I think he's already shown the world what he can do in all three formats. And especially this series, the way he batted. (PTI)
