### **VP polls: Notification** issued, nomination process begins

**GUWAHATI, Aug 7:** The Election Commission of India has issued the official notification for the Vice-Presidential Election 2025, setting into motion the nomination process for one of the country's highest constitutional offices.

According to an official statement, the notification was released under sub-sections (4) and (1) of Section 4 of the Presidential and Vice-Presidential Elections Act, 1952, and published in the Gazette of India on August 7.

It is being republished in the respective State Gazettes in their official languages to ensure wider dissemination of the election schedule and guidelines.

The process has been initiated to fill the vacancy caused by the resignation of Vice President Jagdeep Dhankhar on July 21, who stepped down citing health reasons.

Though his term was due to end in August 2027, the mid-term nature of this election entitles the incoming Vice President to a full five-year term, as per constitutional provi-

In line with the Commission's directions, the Returning Officer for the election—Secretary General of the Rajya Sabha—has issued a public notice under Rule 3 of the Presidential and Vice-Presidential Elections Rules, 1974, in Form 1.

This notice has also been published in the Gazette of India and republished across State Gazettes.

The last date for filing nominations is August 21, and nominations are to be submitted to the Returning Officer or Assistant Returning Officer at Room No RS-28, First Floor, Parliament House, New Delhi, between 11 AM and 3 PM on any working day, excluding public hol-

The nomination must include a certified copy of the candidate's entry in the electoral roll of a Parliamentary constituency and the receipt of the ₹15,000 security deposit, which may be paid either in cash to the RO or through the Reserve Bank (CONTD. ON PAGE-2)

## HC directs those facing eviction from Golaghat forests to submit land rights proof 74 people claim possession of land since forefathers' time

High Court has directed those facing eviction from Doyang and South Nambar forests in Assam's Golaghat district to submit within

10 days proof of land rights or va-

cate the land. Chief Justice Ashutosh Kumar, hearing the petition of 74 people claiming they have been in possession of the land since the time of their forefathers, also directed the state advocate general to submit an affidavit by a forest officer stating that the appellants have been residing in the reserved forest area without any entitlement and are liable

to be evicted forthwith. The petitioners challenged the issuance of notices by the district authority asking them to vacate their land within seven days, alleging that such action of the respondents is in contravention of certain

them without any specific demarcation as to whether the land in question, said to be in illegal occupation of the appellants/writ petitioners, is a revenue or forest land.

The contention of the appellants in these appeals is that no procedure has been followed for their eviction from their houses, which had been allocated to them under some scheme of the government in the past. The court observed that no documentary evidence had been submitted to support these claims.

The state advocate general, however, contested the petitioners' submission and stated that the appellants are encroachers in the reserve forests, namely, Doyang and South Nambar reserve forests.

He submitted that after the notification converting the forests to reserved forests and its proclamation by the officer concerned, any

forests would be a criminal offence for which a penalty has been provided under the Assam Forest Regulation, 1891. He further submitted that ap-

proximately 29 lakh bighas (around 9.5 lakh acres) of land in the reserved forests in the entire state have been occupied by encroachers and with the drive undertaken by the government for removing such encroachers, more than one lakh bighas (around 33,000 acres) of land has been cleared of encroachment.

The advocate general contended that none of the appellants are flood-affected or landless, or forest dwellers, but are squatters and encroachers who, by their continuous illegal activities, have been damag-

ing the natural habitat of wildlife. The Doyang and Nambar reserve forests had (CONTD. ON PAGE-2)

## 114 families evicted from village grazing reserve land in Lakhimpur: Officials

**LAKHIMPUR, Aug 7:** The Assam government on Thursday evicted 114 families who had allegedly encroached on village grazing reserve (VGR) and cleared 78.21 acres (237 bighas) in Lakhimpur district, offi-

The eviction drive in Phukondoli village under Naoboicha revenue circle was conducted under heavy security cover.

cials said.

The families were served notices on July 31, and most of the people had cleared their belongings, with 25 per cent of them already leaving the village, a district official said.

The village was in a low-lying area, and the settlers had allegedly dug up ponds for carrying out fishery business with each family earning Rs 5 to 10 lakh annually, he

Some of the villagers claimed that they had land rights and had lived there for more than two decades, but the district authorities said the area was declared a VGR many decades ago.

The evicted families belonged to Bengali-speaking Muslim commu-

This was the eighth eviction drive carried out in the state since June by the state government. The largest of these took place last week at Uriamghat in Golaghat district, where 1,500 hectares of forest land were cleared, displacing around 1,500 families.

Chief Minister Himanta Biswa Sarma earlier claimed over 160 sq km of land had been cleared of encroachments since his government took over in May 2021, affecting around 50,000 people.

The CM had also said all unauthorised occupation of forest land, VGR, professional grazing reserve, satras, namghars, and other public areas would be cleared in a phased manner. Most of the people displaced due (CONTD. ON PAGE-2)

## No logic behind Trump's 50 pc tariff; talks continue with US: MEA official

logic or reason behind the Trump administration's "unilateral" move to impose 50 per cent tariffs on Indian exports to the US, a senior Indian diplomat said on Thursday.

Negotiations between the US and India continue even after the move, Secretary, Economic Relations, Ministry of External Affairs, Dammu Ravi told reporters hours after Washington doubled the tariffs on Indian goods.

'This is a unilateral decision. I don't think there is any logic or reason in the way it is done," Ravi told reporters on the sidelines of the LIDE Brazil India Forum here.

"Perhaps, this is a phase we have to overcome. The negotiations are still going on. So, we are confident that solutions will be found in the course of time in looking at mutually beneficial partnerships," he said while speaking on the sidelines of an event here.

US President Donald Trump on Wednesday slapped additional tariffs, apparently peeved at New Delhi's import of Russian oil. The move is likely to hit various sectors, like textiles, marine and leather exports.

In its first reaction to the move, India called it "unfair, unjustified and unreasonable"

Ravi said the Ministry of Commerce is leading the negotiation from the Indian side, and some solutions were in sight when Trump moved in with the executive order,



'We were very close to finding a solution, and I think that momentum has taken a temporary pause. but it will continue," he said.

It can be noted that, as per plans announced earlier, a team of US officials is slated to visit India later this month for talks on a trade agreement.

Ravi said India and the US have been strategic partners, having a complementary relationship for some time, and underlined that businesses and leaders on both sides are looking at trade opportunities. The high tariff will not have any detrimental impact on the Indian industry, Ravi said, stressing that it will not "pull back" or derail India Inc.

The Indian official said whenever any country faces tariff "walls", it looks for new markets where it can trade with, and the Middle East, Latin America, Africa and South Asia are among the regions India will target.

"If the US becomes difficult to export to, you will automatically look at other opportunities," he

Underlining that all countries are impacted by the tariff decisions being taken by US President Donald Trump, Ravi exuded confidence that solutions will evolve for the challenges.

"This is, in my view, a temporary aberration, a temporary problem that the country will face. In the course of time, we are confident that the world will find solutions to it. Like-minded countries will look for cooperation and economic engagement that will be mutually beneficial for all sides,"

been notified about 100 years ago and never in the past, the appellants had made any claim for settlement, or for their right for 'jhum' or shifting cultivation, or else it would have been decided by the forest authorities, he said. He also submitted that the forest area in question has been demarcated and only such persons, who are found to be residing in such demarcated areas, have been issued notices. The chief justice observed that, barring a statement by the petitioners that they have been residing in the houses constructed over the years, which do not fall in the reserved forest area, no documentary proof for such a statement has been given.

"However, in order to satisfy ourselves that the appellants are not forcefully and illegally evicted from their place of residence, we permit them to bring on record any document to establish the claim of their having been allocated land in the reserved forest area for the construction of houses," the chief justice observed.

The court extended the time given to them to clear the forest area or submit documentary evidence of their land rights by another 10 days, to be counted from August 5, the day the order was passed, and till then no coercive steps shall be taken against the appellants.

The court fixed the next date of hearing on August 14. The state government has carried out seven eviction drives since June this year, affecting more than 50,000 people and Chief Minister Himanta Biswa Sarma had earlier said that all unauthorised occupation of forest land, VGR (Village Grazing Reserve), PGR (Professional Grazing Reserve), Satras, Namghars, and other public areas would be cleared in a phased manner.

tioned Momin's stance, alleging inconsistency. "Sometimes he supports the Autonomous State, and at other times he appears to reject it. The people deserve clarity," he said.

Timung further accused Momin of promoting divisive politics by advocating a separate satellite regional council for other communities under Article 244(2).

"In 2018, he submitted a memorandum to the Governor seeking such a council. That move reflects a divide-and-rule strategy, which is unacceptable," he said. DSU president Shivraj Hasnu also expressed concern over the remarks. echoing calls for accountability.

KSA general secretary Barnabas Killing demanded a public apology from Momin, stating that a leader holding constitutional office should refrain from making comments that may hurt public sentiment.

The distressing visuals of the elephant's condition triggered immediate intervention

# The rising risk of memory loss due to Air Pollution

recent meta-study has revealed an alarming link between air pollution and deteriorating memory. Toxic particles in the air—especially fine dust and harmful gases such as nitrogen dioxide, primarily emitted from vehicles and industrial processes—are directly affecting our brains. This comprehensive research is based on 51 studies involving nearly 30 million individuals. The findings are particularly concerning for countries like India, where air pollution levels are among the highest in the world. If even wealthy and developed nations are struggling with the mental health impacts of pollution, India cannot afford complacency. Tackling air pollution must become our top priority.

The study warns that regular exposure to polluted air significantly increases the risk of dementia—a progressive condition that impairs memory and cognitive abilities. Globally, nearly 57.4 million people are already affected by dementia. Without urgent action to curb air pollution, this number could triple to 152.8 million by 2050. Notably, people exposed to polluted environments over long periods may experience a decline in brain function equivalent to aging by a decade. For example, a 50-year-old constantly breathing toxic air could show cognitive ability akin to that of a 60-year-old. Published in The Lancet Planetary Health journal, the study found that each 10-microgram per cubic meter increase in PM2.5 (fine particulate matter) raises the risk of memory-related diseases by 17%. Even a single microgram increase in black carbon—sourced from vehicle exhaust and burning wood—raises the risk by 13%. These microscopic particles can bypass our respiratory and circulatory systems, reaching the brain and triggering inflammation and oxidative stress, ultimately damaging neurons. The implications of this are far-reaching. Not only does polluted air affect lung and heart health, but it also impairs memory, concentration, learning, and emotional stability. Studies have shown that children living in high-pollution areas perform worse in school tests compared to those in cleaner environments. Adults exposed to polluted air often experience irritability, fatigue, and even depression. Their productivity and decision-making abilities may also suffer.

The impact of pollution-induced memory decline is not confined to individuals—it affects educational outcomes, workplace efficiency, and societal decision-making. Data indicates that people in high-PM areas score lower in verbal fluency, reasoning, learning, and memory tests—similar to losing an entire year of education. A recent study revealed how cognitive distraction in routine tasks, like grocery shopping, increases with pollution exposure. Older adults and less-educated individuals are particularly vulnerable, often losing the ability to perform everyday functions and becoming increasingly dependent on others.

Despite the rising threat, medical science currently offers no definitive cure for dementia. Existing treatments are limited and often ineffective, leaving patients to gradually lose their memory and independence. Dr. Kristian Bredal of Cambridge University, co-lead author of the study, emphasizes that dementia prevention is not solely a healthcare responsibility. Urban planning, transportation policies, and environmental regulations all play crucial roles in addressing this crisis. Air pollution not only harms individual health but also distorts collective thinking, lifestyle choices, and environmental decisions. On a larger scale, it contributes to reduced educational achievement, lower productivity, higher healthcare burdens, and deepening economic inequalities. A separate study from Washington involving 1.2 million individuals showed that exposure to wildfire smoke, which increases PM2.5 levels, raised dementia risk by 18-21%. Another extensive review by Cambridge University (29 million people across 51 studies) confirmed that PM2.5 exposure increases dementia risk by 13-17%. The science is clear: these fine particles penetrate deep into the respiratory system and brain, disrupting brain function and accelerating mental decline.

Recent Chinese research has also linked PM and NOx exposure to reduced cognitive ability in middle-aged and older populations, especially impairing working memory. If immediate and decisive actions are not taken, the situation will only worsen. Air pollution sets off harmful chemical reactions in the body that damage cells, proteins, and DNA—paving the way for neurological diseases like dementia. Encouragingly, the research suggests that reducing air pollution could offer long-term benefits across health, economic, social, and climate sectors. It would also ease the burden on patients, families, and caregivers. The question we must now ask ourselves is: how far are we willing to go to protect not just our lungs, but our minds?

# Trump's 50% tariff gives a big jolt to the India-US trade target of \$530 billion by 2030

India hits back but
major exports to
US market facing
bleak future due to
high prices

Indo-US trade tensions escalated to a flashpoint, on Wednesday as US President Donald Trump doubled down on a defiant India with 50% tariffs on Indian imports, raising it from 25%, citing its continued purchases of Russian oil as a blatant violation of Washington's sanctions. The increased rate will be effective after three weeks. Terming it a betrayal of strategic expectations, Trump's move is seen as the most serious rupture in bilateral trade relations since his return to the White House and casts fresh uncertainty over the long-stalled \$530 billion trade pact between the two countries by 2030.

The executive order signed late Tuesday accused the Indian government of "directly or indirectly importing Russian Federation oil," prompting an "additional rate of duty of 25%" on top of the 25% already set to take effect as part of Trump's sweeping global tariff regime. With this, India now joins a short list of countries—including Brazil, Myanmar, and Syria—that face U.S. tariffs of 40% or more. The effective 50% tariff on Indian goods is among the highest levied by the United States on any major trading partner.

Speaking to CNBC on Tuesday, Trump was blunt in his rationale: "India has not been a good trading partner... They're buying Russian oil. They're fuelling the war machine." The timing of the announcement was telling—just hours before a broader tariff hike across multiple U.S. trading partners was due to take effect. US and NATO countries have been complaining that China and India have been fuelling the Russian war machine against Ukraine by continued purchase of Russian crude, proceeds of which went to fund the war in Crimea.

Trump's fury stems from India's decision to continue purchasing discounted Russian crude despite repeated U.S. warnings. For New Delhi, the rationale has always been economic and strategic—low-cost oil from Russia during a time of inflationary pressure and geopolitical uncertainty. Indian officials maintain that the oil purchases were carried out transparently and with an understanding that it was not in violation of any formal sanctions. The Ministry of External Affairs in New Delhi responded forcefully to the latest development, stating, "These actions are unfair, unjustified and unreasonable. India will take all necessary actions to protect its national interests."

protect its national interests."

Until recently, India was poised to be



among the early beneficiaries of a Trumpera trade normalization strategy following the US withdrawal from the China-centric global supply chain. However, those hopes have been all but dashed by Trump's aggressive push to bring manufacturing—especially tech production—back to the US.

In a May post on Truth Social, Trump declared: "I have long ago informed Tim Cook of Apple that I expect their iPhones that will be sold in the United States of America will be manufactured and built in the United States, not India, or anyplace else." India had in fact benefited substantially from the US pivot away from China. According to Bloomberg and Canalys, India accounted for 44% of US smartphone imports in the last quarter, surpassing China.

Many of those phones—especially Apple iPhones—are now made in India, largely due to Apple's strategic shift in production.

Tim Cook, Apple's CEO, is expected to appear with Trump at the White House later today for a new investment announcement, even as Apple braces for a \$1.5 billion hit next quarter due to existing tariff head-

US Commerce Department data shows that India was the 10th largest source of goods imports to the US in 2024, with \$87 billion worth of shipment. Sectors likely to be most affected by the new tariffs include pharmaceuticals, textiles, auto components, and electronics—particularly smartphones.

At the heart of the dispute is India's refusal to fully align with US sanctions on Russia, particularly in the energy sector. New Delhi has consistently argued that its oil purchases from Moscow are in national interest and not in violation of international law. Furthermore, Indian refiners buy from Russia on a commercial basis, and not as part of any government-to-government deal.

Nevertheless, Trump's order frames the purchases as an affront to US policy. It has also sparked concern in European capitals and in OPEC countries, with whom India.

has deepened energy relationships in recent years. In fact, state-run oil companies in India have already begun diversifying their crude basket, increasing purchases from Saudi Arabia, the UAE, Iraq, and even the United States itself.

There are signs that New Delhi anticipated such punitive measures and has been gradually reducing its dependency on Russian crude. In June 2025, for instance, National Oil companies such as Indian Oil Corporation (IOC) and Bharat Petroleum signed multi-year contracts with suppliers in the Middle East to ensure uninterrupted supply amid the threat of sanctions.

According to the Petroleum Ministry, Russian oil now comprises less than 22% of India's total crude imports, down from 35% at its peak in 2023. Yet,

despite these adjustments, Washington's patience appears to have run out. What remains to

be seen is whether India will double down on diversification or scale back Russian imports even further to placate U.S. concerns.

India's trade strategists are now faced with a pivotal decision—resist or recalibrate. If India chooses to resist, it could look to deepen ties with alternative export markets like the EU, ASEAN, and the Gulf Cooperation Council (GCC), all of which have shown appetite for Indian products and services. New Delhi may also seek to expedite free trade talks with the UK and Australia to cushion the loss of U.S. market share. The EU is India's second-largest trading partner, accounting for trade in goods worth €120 billion in 2024, or 11.5% of India's total trade. India is the EU's 9th largest trading partner, accounting for 2.4% of the EU's total trade in goods in 2024, well behind the USA (17.3%), China (14.6%) or the UK (10.1%). Trade in goods between the EU and India has increased by almost 90% in the last decade.

The EU's imports from India comprise mainly of machinery and appliances, chemicals, base metals, mineral products, and matism. (IPA Service)

textiles. India's main exports to the EU consisted of machinery and appliances, transport equipment, and chemicals. Trade in services amounted to €59.7 billion in 2023 (with a deficit for the EU of €7.9 billion).

(with a deficit for the EU of €7.9 billion). The EU's share of foreign direct investment (FDI) stock in India reached €140.1 billion in 2023, up from €82.3 billion in 2019, making the EU a leading foreign investor in India. The stock of India's FDI in the EU was €10.2 billion. Some 6,000 European companies are present in India.

But falling in line with Washington's diktats could risk alienating Russia—a longtime defense and energy partner—and undermine India's carefully calibrated strategic autonomy. "There is no binary choice here," said former Indian foreign secretary Shyam Saran. "India must protect its strategic interests while also preserving access to global markets. It's a balancing act." Indian exporters, already battling currency fluctuations and global demand softness, now face an uphill climb. For sectors like generic pharmaceuticals-which depend heavily on the US for revenue—tariffs could be crippling. The Apparel Export Promotion Council (AEPC) has warned of job losses in textile hubs such as Tiruppur and Surat if orders shrink due to cost escala-

India's IT services, ironically, remain untouched by the current tariff regime, but fears persist that restrictions could soon expand to services, especially if immigration nd H-1B visa tensions resurface.

The Trump-Modi equation, once hailed as a cornerstone of the new Indo-Pacific architecture, is now on shaky ground. Modi was one of the first foreign leaders to visit Trump after his second inauguration, but the mood has clearly soured. A former US trade official commented anonymously: "Trump sees trade as leverage, not as partnership. He's willing to weaponize it—even against allies—if it suits his domestic narrative."

India, meanwhile, is unlikely to buckle easily. Its statement suggests retaliation may be on the cards, possibly through tariff hikes on American whiskey, Harley-Davidson bikes, or even the withdrawal of market access in sectors like fintech and digital payments where US firms have a growing footprint.

The doubling of tariffs by the United States marks a major inflection point in the Indo-US relationship, placing economic cooperation at odds with strategic alignment. As Washington prioritizes compliance over compromise, and New Delhi reaffirms its sovereignty over its energy choices, both countries risk drifting into a prolonged trade confrontation.

Whether this is a short-term disruption or the start of a longer-term decoupling depends on how both sides manage their immediate interests. For now, the world's two largest democracies find themselves staring at a hard choice between principle and pragmatism (IPA Service)

## CHILD ABUSE: A hidden social menace

**♦** hild abuse is not only a tragic individual crime but a national and global failure to safeguard the most vulnerable members of society. Beneath the surface of seemingly normal families, institutions, schools, and even online platforms. an insidious crisis unfolds—one that often goes unreported, unheard, and unresolved. Despite the illusion of social progress and the rhetoric surrounding children's rights, child abuse remains one of the most persistent and damaging social issues across the world, cutting across economic classes, cultures, and communities. The veil of silence surrounding abuse makes it a deeply entrenched menace, one that thrives on powerlessness, fear, and systemic neglect.

Child abuse is multifaceted, encompassing physical violence, emotional cruelty, sexual exploitation, neglect, and now increasingly, digital abuse. Its victims, being minors, rarely have the means, voice, or social power to speak out or seek redress. Often, the perpetrators are not strangers but people the child knows—family members, teachers, neighbours, caregivers—those entrusted with the responsibility of protection and nurturing. This betrayal of trust creates wounds far deeper than visible scars, and the damage reverberates through a child's mental, emotional, and psychological development for years to come. In many cases, the trauma of childhood abuse manifests later in life through depression, addiction, anxiety, suicidal thoughts, and social withdrawal. In the worst cases, it perpetuates cycles of violence, both personal and institutional.

The disturbing reality is that child abuse is far more prevalent than society acknowledges. Reports may suggest a few thousand cases per year, but experts widely agree that this is merely the tip of the iceberg. Underreporting remains a chronic issue, fueled by fear, stigma, lack of awareness, and institutional apathy. In India, according to the National Crime Records Bureau, a child is sexually abused every 15 minutes. The Protection of Children from Sexual Offences (POCSO) Act was enacted to address this crisis, yet convictions remain low and delays are rampant. A significant percentage of victims are under 12, and in many cases, victims are too afraid or unaware of how to report abuse. When they do, the process of justice is often so drawn-out, re-traumatizing, and opaque that many families abandon it altogether. Victims face victim-blaming, social ostracization, and even threats—especially in cases where the perpetrator is influ-

This problem is not limited to India. Globally, child abuse continues to expose systemic loopholes and cultural denials.

laws still grapple with institutional abuse and cover-ups. In the United States, the Catholic Church abuse scandal and the failures of child protection services highlight how institutions have often prioritized reputation over justice. In the United Kingdom, grooming gangs operated for years under the radar, with local authorities reluctant to act due to racial or political sensitivities. In Australia, revelations from Royal Commissions on Institutional Responses to Child Sexual Abuse showed how widespread the abuse was in religious and educational institutions. Even in Scandinavian nations known for progressive policies, cyber exploitation and grooming have emerged as new-age threats.

Technology has further complicated the fight against child abuse. While the internet has empowered many children with information and platforms for expression, it has also exposed them to unprecedented risks. The dark web, encrypted messaging apps, and anonymous social media platforms have become hubs for trafficking, grooming, and the sharing of child sexual abuse material. Online predators masquerade as peers or authority figures, manipulating children into harmful interactions. Despite efforts by law enforcement agencies, the sheer scale of digital abuse and the sophistication of technology used by perpetrators have made regulation and surveillance increasingly difficult. Cases of children being lured into trafficking rings, coerced into producing explicit content, or cyberbullied into self-harm are becoming alarmingly common.

The psychological toll of abuse, especially when unaddressed, is profound. Studies reveal that abused children are more likely to suffer from mental illnesses such as depression, post-traumatic stress disorder, borderline personality disorder, and anxiety disorders. They are also at greater risk of poor academic performance, substance abuse, homelessness, and involvement in criminal activities. Neuroscientific research confirms that abuse alters the brain's structure and stress response mechanisms, impairing emotional regulation and social development. The lack of early intervention and psychological support means that many survivors grow into adults still battling the demons of their childhood.

Addressing child abuse requires a multipronged approach rooted in prevention, protection, and rehabilitation. Legal frameworks must be strengthened, but more importantly, they must be effectively implemented. Laws without accountability and enforcement are meaningless. The judicial system must ensure that child abuse cases are handled swiftly, sensitively, and with absolute confidentiality. Specialized childfriendly courts and trained personnel are

Countries with advanced child protection laws still grapple with institutional abuse and cover-ups. Schools and educational institutions must play a central role in the protection of children. Schools are one of the few spaces where children can be observed regularly, making them critical for early detection of abuse. Comprehensive sex education and awareness programs can empower children to understand boundaries, recognize inappropriate behaviour, and report abuse. Yet in many societies, such programs are absent or resisted due to cultural taboos and moral policing. This resistance leaves children ignorant and vulnerable. Educating children about good touch and bad touch, providing safe reporting mechanisms, and ensuring psychological counselling services in schools are not optional—they are essential safeguards.

Parents and caregivers, too, must be part of the solution. Often, abuse happens because adults lack awareness or choose to ignore red flags due to fear of social embarrassment or loyalty to family members. Parenting programs that promote positive, non-violent discipline, emotional attunement, and open communication can go a long way in creating safe home environments. Religious and community leaders must also challenge cultural norms that enable silence or normalize abusive behaviour under the guise of tradition, obedience, or family honour.

The role of the media in combating child abuse cannot be understated. Responsible journalism can bring attention to hidden cases, expose systemic failures, and demand accountability. However, sensationalism or insensitive reporting can harm victims and deter others from coming forward. Media houses must adhere to ethical guidelines when reporting child abuse and focus on creating public awareness rather than exploiting trauma for ratings. Documentaries, films, and public service announcements can also serve as powerful tools in shifting public perception and breaking the stigma surrounding child abuse.

Non-governmental organizations have long filled the gaps left by the state. From rescue operations and legal aid to counselling and rehabilitation, NGOs have demonstrated both commitment and innovation in child protection. Initiatives like CHILDLINE (1098), Aarambh India, and the Bachpan Bachao Andolan have saved thousands of lives. But these organizations often operate with limited resources, facing bureaucratic hurdles and inconsistent fund-

port such initiatives, integrate their expertise into public policy, and scale up their best practices. One of the greatest barriers to eradicating child abuse remains the culture of silence. Fear, shame, and societal apathy combine to hush victims and their families into submission. Children are often told to remain quiet to protect family reputation, or worse, they are not believed when they report abuse. Breaking this silence requires creating safe, supportive, and non-judgmental environments where children feel heard and validated. It also requires adults to believe, support, and act decisively when abuse is suspected. Community-based child protection committees, helplines, and anonymous reporting tools can aid in encouraging disclosures without fear.

couraging disclosures without fear.

Furthermore, rehabilitation must extend beyond legal justice. Survivors need long-term psychological support, educational opportunities, and community reintegration programs. Simply rescuing a child from an abusive environment without follow-up care leaves them vulnerable to re-victimization or a lifetime of unresolved trauma. Trauma-informed care models must be adopted across institutions that deal with children. Policymakers should view child protection not just as a law and order issue but as a public health priority.

Finally, the battle against child abuse must be waged with the urgency it deserves. Too often, outrage erupts after a high-profile case only to subside in days. What is needed is a sustained, institutionalized commitment to child protection embedded in governance, education, health, and justice systems. Political leaders must speak openly about child abuse, allocate sufficient budgets for child welfare, and implement robust monitoring mechanisms to evaluate the effectiveness of existing programs. Technology must be used not just by predators but also by protectors-through surveillance of online platforms, use of AI for tracking CSAM, and development of child safety apps.

The measure of a society is how it treats its children. A nation that allows its children to suffer in silence, to be abused in homes, schools, or cyberspace, fails its moral and constitutional duty. Child abuse is not a family issue, a private matter, or a marginal concern—it is a national emergency. It damages lives, undermines development, and breeds generations of wounded individuals. But it is not inevitable. With the right policies, awareness, compassion, and action, it can be prevented, addressed, and eventually eradicated. The question is whether society has the will to see the invisible, hear the unheard, and protect the powerless.

To ignore child abuse is to be complicit in it. The time to act is now.

# Operation Sindoor has the key to why India and US ties are in doldrums

he special session of the parliament on Operation Sindoor exposed the limitation of India's foreign policy, driven as it is by the objective of projecting Prime Minister Narendra Modi as a strong leader, instead of furthering India's national interests. This objective suffered a setback after Operation Sindoor.

Before I go into the three key operational failings of Operation Sindoor, it should be understood that between nuclear armed India and Pakistan, the air war will determine the outcome of the campaign. While the firing of long-range missiles and drones by both sides will cause destruction of military and civilian infrastructure, apart from collateral damage, it will not determine the outcome of the war. Instead, it could raise the possibility of nuclear signalling by Pakistan since it has an elongated geography with numerous high value targets close to the border. The side which achieves limited, or total air superiority, will quickly help its army move fast to occupy enemy territory. For this reason, the air battle of May 6-7 night was important.

The first and biggest failing of Operation Sindoor was the timidity of military leaders, allowing the political leadership to determine operational matters. For example, Îndia's naval attaché in Indonesia, Captain Shiv Kumar disclosed that IAF was told to fire its missiles into Pakistan without first silencing Pakistan's air defences. At a time when the Pakistan Air Force had adequate warning of the impending attack, this was a shocking lapse. Then, India formally asking for an end to hostilities within half an hour of its operations not only showed a lack of political will to fight, but also that the political leadership was in operational control with the IAF leaders watching helplessly. These, and other issues which insiders know but are afraid to talk about, led to IAF fighter losses, whose numbers no one is willing to disclose.

The second operational shortcoming was that the Indian military was unaware that it would not be fighting the Pakistan military but a one-frontreinforced war. This meant the Pakistan military was fully supported by the PLA's non-kinetic capabilities and the combat support needed for a war surge. This was a big support for the Pakistan military considering neither the US nor Russia helped the Indian military with round-the-clock surveillance capabilities by their constellation of satellites namely, GPS (Global Positioning System) and GLONASS (Global Navigation Satellite System). After Sindoor, news came that to boost its real-time surveillance for military actions, the Indian military was in talks for commercial satellite imagery from a US-based company called Maxar Technologies, amongst others.

The third failing was of the IAF being unmindful of PAF's new war concept called Multi-Domain Operations (MDO). MDO are done by a digital ecosystem where space, air and ground as-



sets and fighters are integrated by data link allowing free information flow amongst them. This ecosystem is ideal for firing Beyond Visual Range (BVR) missiles. So, instead of PAF's J-10C doing a one-on-one engagement with IAF's Rafale, it used the MDO in what is called a 'system of systems' approach. The J-10C got the information feed from airborne assets and on getting the target coordinates through it, the fighter fired its PL-15 BVR missile while keeping its own radar off so as not to disclose its location. The PL-15 with a range of over 200km initially flew on a pre-programmed trajectory using its inertial navigation system with the mid-correction provided by an airborne asset. In the terminal phase, the PL-15's own AESA radar got activated and guided the missile to the target. Once the missile's AESA radar locked on the target, its seeker, highly resistant to the target's electronic countermeasures, ensured that it hit it with precision. The PL-15 is an advanced BVR.

Four issues regarding 'system of systems' warfighting are noteworthy. One, it requires great effort to put the hardware and software of the digital ecosystem in place. Two, it takes years of realistic combat training, patience and hard work for pilots to become proficient in using a digital ecosystem. Three, the PAF needed to have an advanced level of electronic warfare capabilities to ensure that the software data links connecting the ecosystem were not disrupted or damaged by the adversary. And four, unlike one-on-one engage-

ment which is a tactical approach, the MDO operates at the higher operational level involving multiple domains of land, air, space and electromagnetic spectrum with linked assets and capabilities from them. The MDO is necessary for BVRs engagement in modern aerial warfare.

The outcome of the air war was sensed by the US when shortly after asking Pakistan to end hostilities through the DGMO channel, Indian NSA Ajit Doval spoke with his US counterpart Marco Rubio. The latter on social media said the US was monitoring the India-Pakistan situation and President Trump was keen for an early ceasefire. Besides Doval other policy makers were also in touch with the Trump administration which in turn was interacting with Pakistanis for an early ceasefire. This was the basis of Trump's repeated claims made later that he brought about the ceasefire between India and Pakistan, thereby preventing a nuclear war.

Pakistan was quick to publicly thank Trump for the ceasefire through its foreign minister Ishaq Dar, something that India did not do. India stuck to the narrative that it was Pakistan which sought ceasefire with India on May 10 after its military's kinetic beating by the Indian military. Both Trump and Modi stuck to their positions for different reasons. Trump had entered his presidency as a peace time president who promised to end the Ukraine war in 24 hours. However, having failed to end wars in Ukraine and West Asia, Trump needed a

breakthrough by claiming to end a possible nuclear war between India and Pakistan to show to his voter base that he was serious about ending 'forever wars'. India denied him that opportunity since India's foreign policy is premised on Modi being a strong leader. To be sure, this incident did not go down well with an egoistic Trump.

Add to this was Trump's open call to India to withdraw from BRICS which he said was an anti-US group out to weaken the US dollar. Moreover, with Russia ignoring Trump's ultimatums to end the Ukraine war, he instructed India to stop buying Russian oil. This of course was not possible for India since (a) it would show Modi as a weak leader, (b) adversely impact India's economy, and (c) it would end the already strained ties with Russia, which besides so many other things, is India's guarantor of peace with China.

In short, India's projected foreign policy of multi-alignment (being in the QUAD and the BRICS at the same time) or being sought by all nations in the world, lies shattered. The reality of the present multipolar world with three great powers (the US, China and Russia) is that the Modi vernment's foreign policy is aligned with the US' Indo Pacific policy meant to contain China's rise. All US presidents since Obama's pivot to Asia had sought to contain China's rise with India becoming its military bulwark in the Indian Ocean Region (IOR). The US' role for India as a net security provider (including for combat) in the IOR suited the Modi government since it saw in this an opportunity of projecting its own strategic reach befitting a major power. So, the Modi government did two things. One, on the military front, it signed US military's four foundational agreements to become a part of the US Indo-Pacific command defence network. Two, on the policy front, external affairs minister, S. Jaishankar abandoned SAARC and focused on BIMSTEC which he said aligned well with Modi government's Act East policy which in turn was compatible with US' Indo Pacific policy with QUAD as its key component.

Moreover, as the founding member of Russia-India-China which was formed on the suggestion of Russian foreign minister Yevgeny Primakov in the Nineties and later became the basis of BRICS, India realised that with the rise of China, it had become a powerful grouping doing better than the G-7. Thus, until the arrival of the Trump administration, India could have its cake and eat it too since it was both in QUAD and BRICS. Given this, India's G-20 presidency in 2023 gave it the opportunity to showcase the four pillars of its foreign policy. These were:

(a) India's pivot to the US' foreign policy while being the foundational member of BRICS;

(b) Close ties with G-7 given India's strategic proximity to the US;

(c) Projecting itself as the bridge between Global South and Global North; and

(d) Piggybacking on the US foreign policy, it projected regional competition with China.

President Trump crushed India's foreign policy assumptions.

Trump was not interested in security competition with China in the IOR, hence the strategic role of India diminished, if not ended. Trump's foreign policy focus was on MAGA (Make America Great Again) through trade wars, to end forever wars, to maintain security competition with China in the eastern Pacific by hoping to keep it tied in the first island chain. While this was bad news for India, it quickly decided to hoist its strategic ties with the US on MAGA. This resulted in the February 13 joint statement between India and the US which promised Mission 500: to enhance the present US \$ 200 billion bilateral annual trade to US \$ 500 billion by 2030. India committed to buy Green Tech, Big Tech, energy, and defence equipment amongst other things from the US. Both sides were happy until Operation Sindoor happened.

While Trump was unhappy with Modi for denying him the credit for ending the war, he was astonished by his own intelligence briefing that five jets (belonging to the IAF) were lost in the opening round of the four days war. Trump publicly mentioned this number hoping that India would give its version of IAF fighter losses, which did not happen. This convinced Trump and much of the world that the Pakistan military was a peer competitor of the Indian military since India did not want an escalation after firing its opening kinetic salvo and was unwilling to talk on fighter losses in the air battle. This was the reason for Trump's strategic tilt from India to Pakistan. Since the US own foreign policy is predicated on military power, Pakistan's show of its military power was quickly noticed by Trump resulting in two areas of strategic convergence between the two nations: The US wants Pakistan to stabilise Afghanistan, and it wants Pakistan's help to get a foothold in the region to keep a watch on the Eurasian landmass.

As a consequence of Operation Sindoor, India and Pakistan were hyphenated as peer military competitors. And by denying Trump the credit of successfully ending a potential nuclear war, India's strategic ties with the US are in doldrums. Meanwhile, India cannot normalise ties with Beijing as its China policy of regional competition with it would unravel. Since normalisation of ties would imply mutual cooperation, China's deep pockets, superior infrastructure building capability, advancement in standards setting in Green and Big Tech, its exceptional ecosystem for global manufacturing and so on would end India's hope of projecting itself as China's regional competitor. Given its colonial mindset, dent to India's image of being the big brother in South Asia is unacceptable to New Delhi. Between a partnership with China and being a US vassal, India would prefer the latter, as it would come with the illusion of major power, even if by association. Thus, unless India changes its mindset, its rise will not happen.

## How the ICJ's advisory opinion transforms Global Legal Responsibility India speaks in many tongues,

In a defining moment for international climate justice, the International Court of Justice (ICJ) delivered a powerful advisory opinion on July 23, 2025, marking a pivotal legal and moral development in the global response to climate change. The Court unanimously affirmed that states have binding legal obligations to combat climate change and protect the Earth's climate systems, not merely as a political or ethical ideal, but as a duty rooted in international law. While advisory opinions are not enforceable verdicts, the legal gravitas and moral weight of the ICJ's pronouncement have the potential to reshape how nations, courts, and communities perceive climate responsibility.

The ruling explicitly stated that countries and territories are obligated to take actions — to the fullest extent of their capacities — to mitigate climate change. Human-induced greenhouse gas (GHG) emissions, the Court warned, are not just abstract pollutants but direct threats to biodiversity, public health, and human life. The advisory opinion reflects growing judicial recognition that climate change is not only an environmental issue but a legal and human rights concern, implicating states in potentially actionable breaches if they fail to act with due diligence.

The Legal Scope of an Advisory Opinion An ICJ advisory opinion is a formal interpretation of international law, typically requested by the United Nations General Assembly (UNGA) or its specialized agencies. Though non-binding in nature, these opinions carry considerable persuasive authority and serve as guiding principles for national and international courts. They do not impose direct legal consequences, but their role in setting legal norms and influencing policy decisions is profound. The United Nations itself affirms that such opinions carry both "legal weight and moral authority." The July 2025 opinion was delivered in response to a formal request by the UNGA on March 29, 2023. The General Assembly had asked the ICJ to clarify the obligations of states under international law in protecting the environment, particularly against GHG emissions, and to outline the legal consequences if those obligations were breached. What began as an initiative by a group of Pacific Island law students in 2019 had, over six years, evolved into a global campaign — led by Pacific Island Students Fighting Climate Change and joined by over 1,500 civil society organizations — and eventually culminated in a worldwide legal milestone. The campaign was formally embraced and championed by the island nation of Vanuatu, which has long stood at the frontlines

of climate vulnerability. **Key Findings of the Opinion** 

At the heart of the ICJ's opinion lies the assertion that the obligation to prevent environmental harm exists under customary international law. It is no longer sufficient for states to claim action; they must demonstrate meaningful and proportional efforts aligned with the scale of the crisis. The Court leaned heavily on scientific evidence from the Intergovernmental Panel on Climate Change (IPCC) and emphasized that states must adopt — and enforce — rigorous measures to cut emissions

and protect the climate system. Importantly, this due diligence requirement is not passive; it includes active oversight, administrative enforcement, and the prevention of harmful activities even by private actors.

In an important clarification, the Court noted that Nationally Determined Contributions (NDCs) — voluntary national climate goals submitted under the Paris Agreement — are not enough unless they represent each state's "highest possible ambition." The ICJ held that countries must not merely commit on paper but also act with seriousness and vigilance in implementing climate goals. This elevates NDCs from aspirational documents to potential benchmarks of legal compliance, subject to scrutiny under international law.

The Court made it clear that obligations relating to climate change are not derived from a single treaty but form an interconnected web of international legal instruments. It cited the UN Charter, the Kyoto Protocol, the UN Framework Convention on Climate Change (UN-FCCC), and the Paris Agreement, among others. These treaties, which are legally binding, collectively form the framework within which states must operate. Additionally, the Court referenced other relevant conventions such as the Convention on Biological Diversity and the UN Convention on the Law of the Sea (UNCLOS), thereby highlighting the broad legal ecosystem surrounding climate obligations. The ICJ also recognized the human right to a clean, healthy, and sustainable environment a significant affirmation that links environmental degradation with the erosion of human rights. This recognition aligns with recent trends in international jurisprudence that increasingly position environmental health as an intrinsic component of human dignity and intergenerational equity.

tergenerational equity.

While the Court refrained from assigning individual responsibility to specific states, it clarified that a failure to meet climate obligations could constitute a breach of international law. Such breaches, it said, may require reparations—including guarantees that the wrongful acts will not recur and compensation for affected states. This is a bold legal opening for climate-vulnerable nations seeking justice through litigation or diplomatic pressure.

Implications for Global Climate Politics

The ICJ's advisory opinion comes at a time of widespread disillusionment with international climate negotiations. For over three decades, the world's attempts to forge meaningful collective action on climate change have largely fallen short. Countries continue to miss emissions targets. Finance commitments from developed nations remain unfulfilled. Some major economies have even backtracked on their climate responsibilities — notably, the United States temporarily withdrew from the Paris Agreement without facing legal consequences. The ICJ opinion offers a counterpoint to this inertia. It reinforces the legal sanctity of environmental obligations and creates a new platform for courts and activists to pursue climate accountability. By asserting that legal consequences can follow inaction, the ICJ has raised the stakes for nations that have previously treated climate policy as negotiable or

As environmental lawyer Ritwick Dutta observes, the opinion may also help develop more

robust international environmental law, particularly in holding violators accountable. Most current conventions, while rich in principles, are weak on enforcement. The ICJ opinion might pave the way for more meaningful compliance mechanisms and could even pressure nations like the United States to ratify treaties such as the Convention on Biological Diversity and UNCLOS, which they have long resisted.

The Indian Context: Navigating Opportu-

For India, the ICJ's opinion presents both challenges and opportunities. India has historically contributed little to global GHG emissions, but as the third-largest current emitter, it is under growing pressure to accelerate its transition toward renewable energy. India remains heavily reliant on coal but has announced a commitment to reach net-zero emissions by 2070 — a timeline more conservative than that of many developed nations

The ICJ's opinion emphasizes the broader protection of climate systems — forests, rivers, grasslands, oceans — beyond the narrow metric of carbon emissions. This perspective could shift how climate action is interpreted in India's courts and policies. For example, the Indian Supreme Court's decision in the Great Indian Bustard case prioritized solar energy over biodiversity conservation — a dilemma that could be reassessed under the ICJ's holistic approach.

The opinion also reinforces the legal burden on both state and private entities to avoid environmental harm. This could result in increased litigation and judicial scrutiny of corporate polluters and regulatory failures. Already, the Indian government has acknowledged in an affidavit before the Supreme Court that continued coal dependence poses risks to both public health and the economy. This alignment with the ICJ's findings strengthens the legal basis for phasing out fossil fuels while investing in sustainable alternatives. Environmental activists like Harjeet Singh warn that the ICJ's nuanced view on differentiated responsibilities - which may re-evaluate static labels of "developed" and "developing" countries - could challenge India's long-held position in climate negotiations. However, Singh also emphasizes that the primary responsibility for the climate crisis remains with developed nations due to their disproportionate historical emissions. Any recalibration of responsibilities must be just and equitable, taking into account both capabilities and vulnerabilities.

A Legal Compass for the Climate Struggle Ahead
Ultimately, the ICJ's advisory opinion does
not offer immediate solutions to the climate crisis. It does not impose penalties or force nations
to act. But it does provide a comprehensive and
authoritative legal interpretation that climate
change is not just a political failure but a potential legal breach. It empowers national courts,
civil society groups, and vulnerable states to demand accountability and justice. It breathes new
life into international environmental law and
gives future generations a powerful legal framework to stand upon.

In an era marked by rising temperatures, biodiversity loss, and deepening inequality, the ICJ has delivered not merely an opinion, but a call to conscience — backed by law. Much controversy has been generated largely by the Opposition around the Three-Language Policy proposed under NEP. Let us be clear. This policy is not about imposing Hindi or any other language. It is about encouraging Indians to learn more Indian languages, just as English became popular because it was widely taught and available.

The three-language formula, first introduced in the post-1956 era after states were reorganised on linguistic lines, was meant for administrative convenience and national cohesion, not coercion. The Modi government is simply giving it a modern, inclusive interpretation. Encouraging linguistic diversity is not the same as enforcing uniformity. In fact, the policy provides the flexibility to choose languages based on regional preference and practical utility.

A Call for Unity, Not Uniformity

The Modi Government's language policy is rooted in a deep respect for India's cultural diversity and a firm belief in empowerment through inclusion. It rejects the old model of top-down imposition and embraces a bottom-up approach, one that strengthens regional identities while weaving them into the national fabric.

# Trump's reciprocal tariffs come into effect globally, including India

NEW YORK/WASHINGTON. **Aug 7:** The initial 25 per cent tariffs announced by the US on Indian imports came into effect Thursday, with President Donald Trump saying billions of dollars from countries that have taken advantage of America will now start flowing into the country.

"It's Midnight!!! Billions of Dollars In Tariffs Are Now Flowing Into The United States Of America!" Trump said in a post on Truth Social as the clock struck 12 midnight in the US, ushering in the August 7 date when the reciprocal tariffs announced on nations by Trump last week come into effect.

"Reciprocal tariffs take effect at midnight tonight! Billions of dollars, largely from countries that have taken advantage of the United States for many years, laughing all the way, will start flowing into the USA. The only thing that can stop America's greatness would be a radical left court that wants to see our country fail!" Trump said in announced that India will face tariffs of 25 per cent after Trump issued an executive order listing the various duties that Washington will impose on exports from countries around the world. In the Executive Order titled 'Further Modifying The Reciprocal Tariff Rates', Trump had announced tariff rates for nearly 70

The 25 per cent "Reciprocal Tariff, Adjusted" imposed on India came into effect on Thursday.

The tariffs in the list ranged from 10 per cent to 40 per cent, with Japan being charged 15 per cent, Laos and Myanmar (40 per cent each), Pakistan (19 per cent), Sri Lanka (20 per cent) and the United Kingdom (10 per cent).

In addition to the 25 per cent tariff announced last week, Trump on Wednesday imposed another 25 per cent levies on India for its purchases of Russian oil, bringing the total duties slapped on India to 50 per cent, among the highest imposed by the US on any country in the world.



The additional 25 per cent duty will come into effect after 21 days or August 27.

India, responding to the tariffs, said that the targeting of India is unjustified and unreasonable.

Bhutoria noted that Trump granted China a 90-day tariff pause while targeting India, a key democratic ally, for its energy needs.

"This double standard risks undermining the robust USD 186 billion US-India trade partnership and our shared goal of reaching USD 500 billion by 2030.

He underscored that the US and India share a strong, vibrant partnership built on mutual respect, economic ties, and shared values.

'We must work through these challenges together, not through divisive tariffs that hurt both nations. I urge both governments to prioritise dialogue and fair trade solutions that strengthen our alliance and keep costs affordable for our communities." (PTI)

Neither the Gaza Humanitarian Foundation nor the Israeli military, which helps secure the group's sites, immediately commented on the strikes or shootings. The Israeli military has accused Hamas of operating in densely populated civilian areas

**Opposition to expansion of the war** Demonstrations were planned across Israel on Thursday evening to protest the expected Cabinet decision. On Thursday morning, almost two dozen relatives of hostages being held in Gaza set sail from southern Israel towards the maritime border with Gaza, where they broadcast messages from loudspeakers on boats to their relatives in Gaza. The families denounced Netanyahu's plan to expand military operations. Yehuda Cohen, the father of Nimrod Cohen, an Israeli soldier held hostage in Gaza, said from the boat that Netanyahu is prolonging the war to satisfy extremists in his government and to prevent it

from collapsing. "Netanyahu is working only for himself," he said, pleading with the international community to put pressure on Netanyahu to stop the war and save his son.

#### Israel returns body of Palestinian activist for burial

Israeli authorities returned the body of a Palestinian activist allegedly killed by an Israeli settler last week, after female Bedouin relatives launched a hunger strike to

hold his body in custody. The hunger strike was a rare public call from Bedouin women who traditionally mourn in private. Witnesses said Awdah Al Hathaleen was shot and killed by a radical Israeli settler during a confrontation caught on video last month. Israeli authorities said they would only return the body if the family agrees to certain conditions that would "prevent public disorder.

Despite dropping some of their demands, family members said Israel set up checkpoints and prevented many mourners from outside the village from attending.

The plight of Palestinians in this area of the West Bank, known as Masafer Yatta, was featured in "No Other Land," an Oscar-winning documentary about settler violence and life under Israeli military rule.

Al Hathaleen, a political activist and an English teacher, was a contributor to the film and close friend of its Palestinian co-directors.

GHF did not immediately answer a request for comment. But it has said that its contractors have not shot anyone at its sites.

Hamas-led militants killed around 1,200 people, mostly civilians, and abducted 251 in the Oct. 7, 2023, attack that ignited the war. They still hold 50 hostages, around 20 of them believed to be alive, after most of the rest were released in ceasefires or other deals.

Israel's retaliatory military offensive has killed more than 61,000 Palestinians, according to Gaza's Health Ministry. The ministry doesn't distinguish between civilians and combatants in its count but says around half the dead have been women and children. The ministry is part of the Hamas government but is staffed by medical professionals. The UN and other independent experts view its figures as the most reliable casualty count.



Sudanese airstrike hits Darfur airport, kills 40 suspected mercenaries, officials say

State-run Sudan TV reported the aircraft had taken off from a military base in the Arab Gulf region, and that Sudanese fighter jets struck it when it landed at the Nyala airport. It described the strike as a "blatant message" and a "new equation of deterrence" against foreign interfer-

ence in Sudan's affairs. The Emirati Foreign Ministry didn't immediately respond to a request for comment. However, it has repeatedly denied involvement in the Sudan war by backing armed groups. There was also no comment from the RSF. Responding to the reports, Colombian President Gustavo Petro wrote on X overnight that he ordered an investigation into the mercenaries' killing.

The RSF seized Nyala, the capital city of South Darfur province, last year as part of the paramilitary group's push to control the entire region of Darfur. The Sudanese government has accused the RSF of turning the city's civilian airport into a military hub to receive weapons ship-

BANGKOK, Aug 7: President Donald Trump's new tariff rates on US imports from dozens of countries took effect Thursday, the latest chapter in the saga of Trump's reshaping of global trade. But many questions remain.

Trump has threatened tariffs of up to 200 per cent on imports of pharmaceuticals and has ordered a 100 per cent import tax on computer chips. Most US imports of copper, steel and aluminum are subject to a 50 per cent tar-

There's still no agreement on what tariffs might apply to products shipped from China. India has no deal yet and faces a potential 50 per cent tariff as Trump pressures it to stop buying oil from Russia. Recent data shows uncertainty is clouding

the outlook for exporters around the world as a rush to beat the tariffs during a pause for negotiation tapers off. Companies are reporting billions of dollars in higher costs or losses due to the higher import duties. Global financial markets took Thursday's

tariff adjustments in stride, with Asian shares and US futures mostly higher. Here's where things stand in what has proven to be a fast-changing policy landscape.

The tariffs taking effect this week The tariffs announced on August 1 apply to 66 countries, Taiwan and the Falkland Islands. They are a revised version of what Trump called "reciprocal tariffs," announced on April 2: import taxes of up to 50 per cent on goods from countries that have a trade surplus with the United States, along with 10 per cent "baseline' taxes on almost everyone else. That move triggered sell-offs in financial markets and Trump backtracked to allow time for



The president has bypassed Congress, which has authority over taxes, by invoking a 1977 law to declare the trade deficit a national emergency. That's being challenged in court, but the revised tariffs still took effect.

To keep their access to the huge American market, major trading partners have struck deals with Trump. The United Kingdom agreed to 10 per cent tariffs and the European Union, South Korea and Japan accepted US tariffs of 15 per cent.

Those are much higher than the low singledigit rates they paid last year, but down from the 30 per cent Trump had ordered for the EU and the 25 per cent he ordered for Japan.

Countries in Africa and Asia are mostly facing lower rates than the ones Trump decreed in April. Thailand, Pakistan, South Korea, Vietnam, Indonesia and the Philippines cut deals with Trump, settling for rates of around 20 per cent.

Indonesia views its 19 per cent tariff deal as a leg up against exporters in other countries that will have to pay slightly more, said Fithra Faisal Hastiadi, a spokesperson in the Indone-

"We were competing against Vietnam, India, Bangladesh, Sri Lanka and China ... and they are all subject to higher reciprocal tariffs," Hastiadi said. "We believe we will stav competitive."

The latest situation for China and India Trump has yet to announce whether he will extend an August 12 deadline for reaching a trade agreement with China that would fore-

stall earlier threats of tariffs of up to 245 per Treasury Secretary Scott Bessent said the president is deciding about another 90-day delay to allow time to work out details of an agreement setting tariffs on most products at 50 per cent, including extra import duties re-

lated to illicit trade in fentanyl. Higher import taxes on small parcels from China have hurt smaller factories and layoffs have accelerated, leaving some 200 million workers reliant on "flexible work" — the gig economy — for their livelihoods, the govern-

ment estimates. India also has no broad trade agreement with Trump. On Wednesday, Trump signed an executive order placing an extra 25 per cent tariff for its purchases of Russian oil, bringing combined US tariffs to 50 per cent.

India's Foreign Ministry has stood firm, saying it began importing oil from Russia because traditional supplies were diverted to Europe after the outbreak of the Ukraine conflict, a "necessity compelled by the global market situation.'

The hardest-hit countries Struggling, impoverished Laos and wartorn Myanmar and Syria face 40-41 per cent

Trump whacked Brazil with a 50 per cent import tax largely because he's unhappy with its treatment of former Brazilian President Jair Bolsonaro.

South Africa said the steep 30 per cent rate Trump has ordered on the exporter of precious gems and metals has put 30,000 jobs at risk and left the country scrambling to find new markets outside the United States.

Even wealthy Switzerland is under the gun. Swiss officials were visiting Washington this week to try to stave off a whopping 39 per cent tariff on US imports of its chocolate, watches and other products. The rate is over 2 1/2 times the 15 per cent rate on European Union goods exported to the United States.

Canada and Mexico have their own arrangements

Goods that comply with the 2020 United States-Mexico-Canada Agreement that Trump negotiated during his first term are excluded from the tariffs.

Even though US neighbour and allv Canada was hit by a 35 per cent tariff after it defied Trump, a staunch supporter of Israeli Prime Minister Benjamin Netanyahu, by saying it would recognise a Palestinian state, nearly all of its exports to the US remain duty

Canada's central bank says 100 per cent of energy exports and 95 per cent of other exports are compliant with the agreement since regional rules mean Canadian and Mexico companies can claim preferential treatment.

The slice of Mexican exports not covered by the USMCA is subject to a 25 per cent tariff, down from an earlier rate of 30 per cent, during a 90-day negotiating period that began last week. (AP)

He stressed that the challenges faced by independent India—poverty, inequality, ignorance, and corruption-are internal struggles that demand the same level of resolve and collective



## SASI urges Arunachal Govt to intensify ILP checks amid concerns over influx of illegal immigrants

ITANAGAR, Aug 7: The Save Arunachal Save Indigenous (SASI) forum has called upon the Government of Arunachal Pradesh to undertake strict and comprehensive checking of Inner Line Permits (ILPs) to curb the alleged influx of illegal immigrants into the state.

The forum submitted a four-point representation to the state's Home Minister on Thursday, urging the government to intensify ILP enforcement measures at all check gates across the state and address concerns about demographic changes. Addressing a press conference at the Arunachal Press Club, SASI Chairman Romjir Rakshap said that although the forum could not meet the Home Minister in person due to his engagements, the memorandum was formally submitted to his office.

According to an official statement issued by the forum, the representation highlights the perceived increase in illegal entry into Arunachal Pradesh and requests urgent action to preserve the demographic balance and security of the indigenous population.

Rakshap claimed that the recent eviction drives in neighbouring Assam, spearheaded by the Hemanta Biswa Sarma-led government targeting illegal encroachment on forest land, may have triggered a spillover of displaced settlers into Arunachal Pradesh. He warned that such movements could result in long-term socio-cultural disruptions within the state.

"There is a serious apprehension that a large number of illegal immigrants may have crossed over into Arunachal Pradesh through informal and illegal channels. This could lead to demographic imbalance and poses a threat to the safety and security of the indigenous population," Rakshap

He added that the issue of unchecked migration must be treated with urgency and seriousness, noting that current enforcement mechanisms might prove inadequate if not strengthened immediately.

# Arunachal Textile minister launches new Handloom and Handicrafts Policy 2025

ITANAGAR, Aug 7: Arunachal Pradesh Textile and Handicrafts minister Nyato Dukam on Thursday launched the state Handloom and Handicrafts Policy 2025 at Tezu in Lohit district.

### 70 rescued, over 50 missing in Uttarkashi flash floods: Army

**DEHRADUN, Aug 7:** As rescue operations in the flash floods-ravaged Uttarkashi entered the third day on Thursday, the Army said 70 people have been rescued so far and more than 50 are missing.

According to officials, at least four people have been killed in the disaster that struck the ecologically fragile area on Tuesday afternoon. Rescuers recovered two bodies on Wednesday, but it was not clear if these were among the four deaths reported the previous day. The district administration said 65 people who were stranded at different locations were airlifted to Matli town, 432

km from here, on Thursday. Efforts were also stepped up to airlift advanced equipment to the worst-hit Dharali village to speed up the search for those trapped under the rubble, officials said. The Indian Army said its troops reached Dharali within 15 minutes of the tragedy. It ramped up Humanitarian Assistance and Disaster Relief (HADR) operations in the Himalayan village and nearby Harsil. The region remains cut off due to multiple landslides and road breaches.

Seventy civilians have been rescued so far and more than 50 are missing, the Army said in an official release issued here. Nine Army personnel -- one junior commissioned officer and eight jawans -are also reported missing, it said.

Nine Army personnel and three civilians were evacuated to Dehradun by helicopter. Three critically injured civilians were shifted to AIIMS Rishikesh and eight were admitted to the Uttarkashi district hospital, it added

Road access is severely disrupted at multiple locations, including Bartwari, Linchigad, near Harsil, Gangnani and Dharali, Civilian and military teams are working round the clock to rescue stranded people, provide relief and restore connectivity, the Army said. The military helipad in Harsil and another in Nelong are operational and connected by road to Gangotri, enabling convenient movement of tourists. A civil helipad in Dharali remains non-functional due to a mudslide.

According to the Army, more than 225 troops, including engineers, medical teams, and rescue specialists, are on the ground. Search and rescue dogs have also been deployed.

One Reeco Radar team is in Tekla village and another Reeco Radar is being inducted for further deployment, the release said.

Chinook and Mi-17 helicopters are waiting at the Jollygrant airport in Dehradun and are likely to commence evacuation of civilians from Thursday if the weather improves, it said. Five civil helicopters from Sahastradhara have been operating between Matli, Bhatwari and Harsil for the rescue operations in coordination with the State Disaster Response Force (SDRF).

An ad hoc aviation base is being set up at the Matli helipad.

Approximately 180-200 tourists stranded in Gangotri are being provided food, shelter, and medical support by the Army and the Indo-Tibetan Border Police (ITBP), the release said. (PTI)

## Rahul claims 'proof of huge criminal fraud' in polls; alleges EC-BJP collusion

NEW DELHI, Aug 7: Congress leader Rahul Gandhi on Thursday cited an analysis of data from a Lok Sabha constituency in Karnataka from the 2024 elections to make explosive claims of "huge criminal fraud" in polls perpetrated by the BJP through the Election Commission, and asserted that this was a "crime" against the Consti-

The Leader of Opposition in the Lok Sabha also said that the judiciary needs to get involved in this because the democracy that "we love so much does not exist".

Gandhi said what his party had collected was "criminal evidence" and alleged that the Election Commission was busy destroying such proof across the country.

Addressing a press conference at the AICC's Indira Bhawan headquarters here. Gandhi also hit back at the Election Commission for demanding from him a signed declaration on his claims and said he had made the remarks publicly and they can "take it as an oath".

"I am a politician, what I say to the people is my word. I am saying it to the people publicly, take it as an oath. Interestingly, they haven't denied the information.

'They haven't said the voter lists (shown by me) are wrong, they are saying Rahul Gandhi should say it under oath... they know the truth. We know you (EC) have done this across the country.' the former Congress president

Talking to the media while taking them through an online presentation, Gandhi said they analysed the voter data of the Lok Sabha constituency of Bangalore Central and the Mahadevapura Assembly segment in it from the 2024 Lok

"Our internal polls indicated that we were expected to win 16 seats in Karnataka (in the 2024 Lok Sabha elections). However, we won nine. We then focused on the seven unexpected losses and chose the Mahadevapura Vidhan Sabha constituency. All the data we have here is from the 2024 elections, sourced from the Election Commission," he asserted.

Gandhi cited that in the 2024 Lok Sabha elections, the BJP secured 6.58,915 votes in the Bangalore Central seat, winning with a margin of 32,707.

"In the Mahadevapura assembly segment, the Congress received 1,15,586 votes, whereas the BJP garnered 2,29,632 votes.

"The Congress won all the Vidhan Sabhas except Mahadevapura, where the BJP swept and secured a victory margin of 1,14,046 votes. This seat significantly contributed to their election win, and the Lok Sabha result went in their favour

"This discrepancy is a huge im-

Gandhi alleged there was "vote chori" of 1,00,250 votes in the Mahadevapura segment, with 11,965 duplicate voters in the segment, 40,009 voters with fake and invalid addresses, 10,452 bulk voters or single address voters, 4,132 voters with invalid photos and 33,692 voters misusing Form 6 of new

Gandhi backed his claims of discrepancies with data displayed on the giant screen, citing examples of fake voters, duplicate voters and single address voters.

"This is EC data, and the EC is saying it is getting free and fair polls done. In one assembly segment, one lakh fake voters are there, we are telling the people of the country, this is your future. The whole system is being stolen. This evidence is 100 per cent in black and white," the Congress leader asserted.

"We see there is a pattern, we are absolutely convinced that this crime is being done on a huge scale across the country in state after state after state. CCTV footage and voter list are evidence in crime and the Election Commission is trying to destroy it," he alleged. "I want the nation to know that there is a huge criminal fraud being perpetrated on this country. It is being done by the Election Commission and the party in power and we have given you undoubtable proof," he said.

"If the Election Commission now does not give us electronic voter data of the last 10-15 years, and if it does not share the CCTV footage, they are partaking in the crime," he said.

Gandhi also batted for the judiciary to get involved in the issue. "I think the judiciary needs to get involved in this. We need to understand what is going on. Because, what we love so much -- our democracy, doesn't exist.

"What is the difference between us and other places, it is the truth of the country's democracy democracy, it's gone... if this is true," he said

In a warning to those involved in

Gandhi said there are going to be consequences for every single polling officer who is doing this.

"It doesn't matter how senior or iunior vou are. One day, the Opposition is going to come to power and then you see what we do to you; because you are attacking the foundation of what our forefathers who fought for India's freedom built and we are not going to allow you to do that, no matter who you are," he said.

Gandhi said his message to the Election Commission is that they are not in the business of destroying Indian democracy but in the business of protecting it.

"This is a crime that is being committed against the Indian Constitution, against the Indian flag. This is nothing less than that," he said, alleging poll rigging in various parts of the country.

Prime Minister Narendra Modi is the PM with a slender majority and needed to "steal" only 25 seats to stay in power, he said, adding the BJP won 25 seats in the Lok Sabha polls with less than 33,000 votes. He said the foundation of the Constitution is based on the fact that one person gets one vote. 'When we look at polls, the fundamental thing is how to secure 'one man, one vote' idea. Are the right people allowed to vote? Are fake people being added? Is the voter list true or not?" he said.

"For some time there has been suspicion among the public. Antiincumbency hits every single party, but the BJP is the only party that does not suffer anti-incumbency in a democratic framework," he said.

Exit polls go massively wrong and so do internal surveys, he said. Gandhi alleged that elections are 'choreographed" these days lasting months, when earlier, with minimal technology, the polls were conducted in the country together.

"The Election Commission is not giving us data because they are afraid that what we did in Mahadevapura, we will do in the remaining Lok Sabha seats, and then the will come out," he said.

The Election Commission is colluding with the BJP and helping them, he alleged. (PTI)

## Streak of global temperature records over for now, says European climate agency

A permanent breach of the 1.5-degrees Celsius limit refers to long-term warming over a 20 or 30-year period


**NEW DELHI, Aug 7:** The recent streak of record-breaking global temperatures is over for now, according to Europe's climate agency Copernicus, even as July 2025 ranked as the third-warmest

July on record worldwide. The agency also reported that the past 12 months (August 2024 to July 2025) were 1.53 degrees Celsius warmer than the pre-industrial average. The agency said July's global average surface air temperature of 16.68 degrees Celsius was 0.45 degrees Celsius above the 1991-2020 average for the month. It said July 2025 was 0.27 degree Celsius cooler than the record of July 2023 and 0.23 degree Celsius cooler than July 2024,

which was the second warmest. Scientists at Copernicus Climate Change Service (C3S) said July 2025 was 1.25 degrees Celsius

above the estimated 1850-1900 average used to define the pre-industrial level. "It was only the fourth month in the last 25 with a global temperature less than 1.5 degrees Celsius above the pre-industrial level," the European climate agency said in a statement. "Two years after the hottest July

on record, the recent streak of global temperature records is over - for now. But this does not mean climate change has stopped. We continued to witness the effects of a warming world in events such as extreme heat and catastrophic floods in July. Unless we rapidly stabilise greenhouse gas concentrations in the atmosphere, we should expect not only new temperature records but also a worsening of these impacts -- and we must prepare for that," C3S Director Carlo Buontempo said.



Human activities, especially the burning of fossil fuels, have pumped large amounts of heat-trapping greenhouse gases into the atmosphere. This has raised the planet's temperature, altered the climate and led to more frequent and severe floods, droughts, storms and

other extreme weather events. At the UN climate conference in Paris in 2015, countries pledged to limit the average global temperature rise to 1.5 degrees Celsius compared to pre-industrial levels to avoid the worst impacts of climate change. The year 2024 was the first calen-

dar year with a global average temperature 1.5 degrees Celsius above pre-industrial levels.

However, a permanent breach of the 1.5-degrees Celsius limit refers to long-term warming over a 20 or 30-year period. Scientists at Copernicus said the average sea surface temperature (SST) for July 2025 was 20.77 degrees Celsius, the third-highest value on record for the month, 0.12 degree Celsius below the July 2023 record.

Arctic sea ice extent was 10 per cent below average, ranking joint second-lowest for July in the 47-year satellite record, virtually tied with 2012 and 2021. Antarctic sea ice extent was 8 per cent below average, ranking third-lowest on record for the month, a less extreme anomaly than those seen in July 2023 (15 per cent below average) and 2024 (11 per cent below average). With 'Stop SIR' placards along with posters, alleging collusion between the EC and the government, in hand, the MPs of the opposition, including those of the Congress, DMK, TMC, and Left parties, among others, participated in the protest.

The opposition has been protesting in both Houses of Parliament against the SIR, alleging the EC's exercise was aimed at "disenfranchising voters" in Bihar ahead of the Assembly elections. They have been demanding a discussion on the issue in both Houses. There has been a logjam in Parliament over the SIR in Bihar. Barring discussions on Operation Sindoor in both Houses, Parliament has seen little business ever since the Monsoon session began on July 21 due to repeated adjournments, mostly over the SIR issue. # Five tribes committee slams cabinet's stand; plans joint meeting

KOHIMA, Aug 7: The five Tribes Committee on Review of Reservation Policy (CORRP) on Thursday strongly criticised the Nagaland Cabinet's decision on Backward Tribes (BT) reservation issue, calling it a repeat of its June 12 decision that failed to address their key demands

In a press statement, CORRP convener Tesinlo Semy and member secretary GK Zhimomi expressed disappointment that the state government has again ignored their core concerns and proceeded with the formation of a reservation review commission, including civil society organisations such as the Central Nagaland Tribes Council, Eastern Nagaland People's Organisation, and Tenyimi Union Nagaland.

CORRP's core demands are framing the terms of reference and the composition of an independent commission to review the decadesold reservation policy.

The committee alleged that the composition announced by the government lacks neutrality and reflects a partisan approach.

It also took strong exception to remarks made by government spokesperson and minister KG Kenye during a media briefing following the cabinet meeting held here on Wednesday.

Citing official data, Kenye said, "Five non-backward tribes currently occupy 64 per cent of government jobs, whereas the 10 backward tribes hold only 34 per

However, to address this imbalance, the government will constia reservation review commission, led by a retired senior government official, he added.

The commission has been tasked to submit its report within six months from the day it is formally appointed, but the implementation of the reforms may coincide with the caste-based census scheduled by the Centre in January 2026, the minister said.

Rejecting Kenye's justification, CORRP alleged, "The partisan attitude of the government spokesperson in justifying 48 years of indefinite reservation policy and throwing up wild imaginary figures in government employment as well as interlinking the reservation review commission outcome with the next census has only added insult to

our movement.' CORRP announced that it will hold a joint sitting with the five apex tribal bodies in Kohima on Saturday to decide the next course land's reservation policy intensified after the five tribal apex bodies under the banner of CoORRP submitted a joint memorandum to the state government re-

They argued that the policy, which has been in place since 1977, no longer reflects the current socio-economic and educational realities of the various communities in the state.

The committee held at least two phases of agitation - on May 29 and July 9 — in the form of protest rallies across multiple district headquarters (Dimapur, Kohima, Mokokchung, Wokha, Tseminyu, Zunheboto, Chümoukedima, Niu-

Initially, 25 per cent reservation was allocated for seven tribes in non-technical and non-gazetted posts for a period of 10 years. These tribes were designated as 'backward' based on educational and economic disadvantages, and limited representation in state services.

Over the years, the reservation increased to 37 per cent, comprising 25 per cent for seven Eastern Nagaland Backward Tribes and 12 per cent for four other backward tribes of the state. (PTI)

# Tripura HC orders probe into lower court's grant of bail to 6 murder accused



AGARTALA, Aug 7: The Tripura High Court has asked the Registrar Judicial to probe the grant of bail to six murder accused by the Additional District and Sessions Court, Belonia, despite rejection of their application by the high court, a senior lawyer said on

Justice Biswajit Palit of the high court also issued a notice to the six murder accused, asking them to explain why their bail should not be cancelled.

Badal Shil, a CPI (M) candidate of South Tripura Zilla Parishad elections, was brutally attacked by a group of people in Chottakhola area on July 12 last vear. He succumbed to his injuries while undergoing treatment at GBP Hospital in Agartala the following

Based on an FIR, police arrested seven persons for

candidate. After conducting the probe, the investigating officer submitted the charge-sheet before the additional district and sessions court, accusing the seven persons of the murder.

"Since the charge-sheet was filed, the seven accused moved bail petitions before the trial court. But considering the gravity of the case and evidence against the accused persons, the additional district and sessions court rejected the bail pleas," advocate Purushottam Roy Barman said.

Of the seven accused persons, six of them then approached the high court challenging the lower court's rejection of their bail pleas.

"After hearing the case, Justice Palit dismissed the bail petitions of the six accused in March this year, stating that bail cannot be granted at this stage because evidence against them appeared solid," he said.

Having failed to secure bail, the six accused again moved the additional district and sessions court, seeking bail as the trial had already begun.

"The lower court then granted bail to the six accused persons on July 25," he said.

"We took up the issue before a bench headed by Justice Palit on Wednesday and pointed out that the additional district and sessions court granted bail to six accused, violating the high court's ruling. The lower court's grant of bail to the persons facing serious charges is against the discipline in the judicial sys-

Roy Barman said Justice Palit, after hearing the arguments, asked the Registrar Judicial to probe the matter and also issued notices to the six accused persons asking them to reply why their bail should not be

### Tripura Human Rights body takes suo motu of assault on doctors, seeks probe reports

**AGARTALA, Aug 7:** The Tripura Human Rights Commission (THRC) has taken suo motu cognizance of the assault on two onduty doctors at GB Pant Hospital and has sought detailed inquiry reports from both the Director of Health Services and the Superintendent of Police, West Tripura.

In an official order issued by Chairperson Justice Arindam Lodh, the Commission stated that on August 4, two Medical Officers were reportedly assaulted by members of a patient party while carrying out their duties within the hospital premises.

Citing media reports, the Commission noted: "The manhandling of medical officers during the course of their duty within the hospital premises constitutes a serious violation of their human rights The authorities appear to have failed in ensuring their protection, despite the presence of security personnel at GB Hospital."

Justice Lodh emphasized that the incident warranted immediate attention and intervention from the Commission. As such, a notice has been issued to the Director of Health Services, seeking an explanation as to why adequate protection was not provided to the medical staff on duty. Simultaneously, the Superintendent of Police, West Tripura, has been asked to submit a report on the actions taken against the miscreants and the measures initiated to safeguard the hospital staff.

The Commission has directed both officials to submit their respective reports by August 21.

AGARTALA, Aug 7: Tripura Social Welfare Minister Tinku Roy on Thursday visited the parents of the driver who died after being trapped in a cementladen lorry earlier this week, and handed over a financial assistance of ₹ 6 lakh to

The driver, identified as Mihir Lal Debnath, was a resident of Dasda in North Tripura.

He was trapped inside the cabin of the lorry after the vehicle hit a tree in Khowai district's Chakmaghat in the early hours of Tuesday. He died as a prolonged rescue operation failed.

While the District Magistrate of Khowai has been served a show cause notice, the Sub-Divisional Magistrate of Teliamura has been suspended, and the officer in charge of Teliamura Fire Service station was show-caused for their alleged negligence in the incident.

"Following an instruction from Chief Minister Manik Saha, we arrived at Dasda to stand by the bereaved family in the hour of crisis. ₹ 6 lakh has been given to the family, and the government will also arrange social pension," Roy told reporters.

Terming the incident as tragic, the minister, who was accompanied by In-



dustries & Commerce Minister Santana Chakma and District Magistrate Chandi Chandran, said it would have been avoided had the local administration been more alert.

Meanwhile, the Left's workers under the banner of CITU and Tripura Motor Sramik Union (TMSU) on Thursday staged a rally protesting what they called "the insensitivity of the government" in handling the emergency situation.

## Lok Sabha passes Manipur Goods and Services Tax (Amendment) Bill

NEW DELHI, Aug 7: The Lok Sabha on Thursday passed The Manipur Goods and Services Tax (Amendment) Bill, 2025, to implement the decisions approved by the GST Council. The bill seeks to replace the Manipur Goods and Services Tax (Amendment) Ordinance, 2025. The Bill was passed by a voice vote amid din in the Lok

Moving the bill for discussion and passing, Finance Minister Nirmala Sitharaman said the amendment is a constitutional necessity which has to be taken up now.

"If it doesn't pass now, the state will have difficulty in implementing the amendments which has long been approved by the Council. Their revenue will get affected because they won't have the authority to charge (tax) on certain items," Sitharaman said.

Among other amendments, the bill seeks to make changes to Section 9 of Manipur GST Act, 2017, allowing the state to "levy State tax on un-denatured extra neutral alcohol or rectified spirit used for manufacture of alcoholic liquor for human consumption"

The GST council, chaired by the Union finance minister and comprising state ministers, had in its 52nd meeting in October 2023 recommended keeping Extra Neutral Alcohol (ENA) used for the manufacture of alcoholic liquor for human consumption outside GST. (PTI)

# Mizoram University researchers discover new snake species

AIZAWL, Aug 7: Researchers from the Zoology Department of Mizoram University have and neighbouring regions, he said. discovered a new species of snake --'Smithophis laptofasciatus'.

The new species was discovered after studying its scales, morphological features and DNA during herpetological expeditions, Professor H T Lalremsanga who heads the Zoology Department, said. The findings of the new research were published in the international scientific journal, 'Taproban-

ica' (The Journal of Asian Biodiversity) on August 5, he said. According to Lalremsanga, five Smithophis snake species have been discovered so far

They are mainly found in India's Northeast Of the five species, two species --Smithophis atemporalis and Smithophis mizo-

ramensis -- were discovered in Mizoram, he

Although the new finding was described as Smithophis bicolour, which was discovered in Meghalaya in 1855, a thorough study revealed that Smithophis laptofasciatus differs from the latter in

which confirmed it to be a new species, he said. Smithophis laptofasciatus is non-venomous and mainly feeds on worms, he said, adding it lives in dense forests. (PTI)

**MUMBAI**, **Aug 7:** Hollywood star George Clooney has praised Adam Sandler, his costar from the upcoming film "Jay Kelly", calling him "not just a great comedian" but also a "soulful actor." The two actors share the screen space for the first time in the drama movie from filmmaker Noah Baumbach. "I kept telling the cast, 'Don't call him Sand Man. Don't talk to him like he's iust some goofy comedian.' He's actually a really beautiful, wonderful actor," Clooney told news outlet Vanity Fair.

Clooney added, "Because of what his

paycheck is, which is doing big goofy comedies, when he does these other, beautiful, Uncut Gems kinds of movies, it reminds people of that. He's not just a good comedian." Clooney headlines "Jay Kelly" in the title role.

Written by Baumbach and Emily Mortimer, the film stars the Oscar winner as a world famous movie star in his 60s who faces a personal reckoning when he travels to an Italian film festival to receive a tribute award. Laura Dern stars as Jay's publicist, while Sandler plays his manager.

About the movie, the actor said, "This film, more than any film Adam has done, shows what a beautiful, heartfelt, soulful actor he is." With comedies such as "Just Go With It" and "Grown Ups" under his belt, Sandler has previously challenged himself with dramatic roles in "Punch Drunk Love" in 2002 and 2017's "The

# JAVED AKHTAR SAYS HE WANTED TO ASSIST LEGENDARY **GURU DUTT AND** BECOME A DIRECTOR



MUMBAI, Aug 7: Veteran poet-lyricistscreenwriter Javed Akhtar has revealed the late actor-filmmaker Guru Dutt had a profound influence on him, so much so that he harboured a dream of becoming a director and even assisting the "Pyaasa" maker.

At a special session organised to pay tribute to the Hindi cinema legend as part of his centenary celebrations in Mumbai on Wednesday night, Akhtar, 80, shared that his dream to work with Dutt remained unfulfilled.

"After my graduation, I thought I'll go to the film industry and join Guru Dutt for a couple of years and then I'll become a director. When you're 18-year-old things are simpler and easier, so that is what I had decided. It is so unfortunate that I came to Bombay (now Mumbai) in 1964, on October 4 and he passed away on October 10, so I could never ever see him," Akhtar said.

"I had really thought that I when I go (to Mumbai) somehow I'll manage (to work with Guru Dutt) because (poet-lyricist) Sahir (Ludhianvi) sahab was a good friend of Guru Dutt and he had written songs for 'Pyaasa', I thought this connection will work. I had thought I'll assist him for a while but it didn't work," he stated.

Akhtar, known for penning iconic films such as "Sholay", "Deewar", "Zanjeer", and "Don" along with Salim Khan, said he was impressed by the way Dutt would communicate complex

narratives through visuals. "I was highly impressed by Guru Dutt in my college days, that when I was 17 or 18-year-old I ed to see films of certain superstars because I believed they're bad actors. It means I had some choice. Guru Dutt had a deep impression

on me as a teenager. 'We had great directors like Mehboob (Khan), Bimal Roy, but Guru Dutt was the first person. who spoke through visuals. There were other directors who could give good performances, shoot at right locations, create right ambience in the film, and well-written films but talking through visuals is something that was taught to us by Guru Dutt," Akhtar noted.

The session was attended by filmmakers like Sudhir Mishra, Hansal Mehta, and R Balki, and film critic-author Bhawanaa Sommaya, each echoing Akhtar's sentiments of reverence for Dutt. The event concluded with a special screening of "Pyaasa", which was attended by Dutt's family including, his granddaughters Gouri and Karuna Dutt, late actor Johnny Walker's son Nasir, filmmaker Anubhav Sinha, actor Akshay Oberoi, and others.

Mishra recalled watching Dutt's film "Saheb Bibi Aur Ghulam" at least six times as a teenager, with his grandmother.

"Guru Dutt is an experience, one could see him again and again. At the age of 22, he would mean something else, and today he would mean something else. I keep revisiting him. There's nothing in my life that I've done that is not influenced by him, and I haven't measured up to to him, but I'm trying to.

"He taught us how to make films, how to see a scene, how to take a blueprint, which is a script, and he rewrite it in a film," the filmmaker said. Mehta revealed that during his FTII days in

Pune in the early 1990s, he created a music video which was a "plagiarised" song sequence from Dutt's iconic film, "Kaagaz Ke Phool".

He candidly described his work as a "vulgar replication", and added that he hopes to pay tribute to the late filmmaker someday by making a movie that talks about "heartbreak and love". "I grew up knowing about him through my closest friend, who was his nephew. I used to hear stories about his uncle. I discovered his (Dutt) film much later, 'Pyaasa' is the first film I saw and it left a lasting impression on me. More than the number of films I've made, I've had more heartbreaks, and love.

"Guru Dutt has taught me that pitying oneself can be beautiful, I began to think of self-sympathy as a virtue and that I should celebrate it, and that heartbreak is cinematic. I wish I can make a film that talks about heartbreak and love to pay tribute to the person who influenced me," Mehta noted. (PTI)

acters who are "funny" "One of the coolest things about being on set was that vou're surrounded by these really funny people, comedians, actors, who are sort of making you step your game up. That was really joyful and fun. I loved that," Beatriz said.

The series follows John Doe and Quiet as they strive to survive brutal battles, forge unlikely alliances, and chase a shot at redemption.

Asked about the fascination of storytellers with the concept of dystopia, Beatriz said humans have always been curious about disasters and how people might respond when everything falls

'You can go back to cave dwellings and see disaster, like 'what are we gonna do if this happens?' I think we, collectively, want to see how human beings would react in the worst possible scenario because we don't know what that will be like for us. That hasn't happened

People like to explore ex-

treme situations in stories because they reflect real emotions like "grief, fear, and anxiety", she added.

The actor said the show portrays themes like the divide between the rich and the poor, the desire for fairness, and the hope for change

"(It) is a big part of our show, the people inside the walls and the people outside the walls, and who decides who gets in and why certain people have to stay out and is there a way to create a society that is more equal and they're given that opportunity with the tournament.

"Because Calypso says anybody can enter this tournament. It's a fair game for anyone. And if you win, you get your greatest wish granted." Developed by Michael Jonathan Smith, 'Twisted Metal" season two also stars Joe Seanoa, Will Arnett, Thomas Haden Church, and Anthony Carrigan. (PTI)

# Canadian teen Mboko reaches Montreal final. beating Rybakina in 3<sup>rd</sup>-set tiebreaker

MONTREAL, Aug 7: Canadian teenager Victoria Mboko rallied to reach the National Bank Open final, beating ninth-seeded Elena Rybakina 1-6, 7-5, 7-6 (4) on Wednesday night.

The 18-year-old Mboko dropped to the court after Rybakina's shot sailed long on match point as the crowd — lined with "Allez Vicky" — erupted. Mboko saved a match point in the third set and broke Rybakina twice to force the tiebreaker.

"Incredible match, thank you to everyone for supporting me," Mboko told the crowd in French. "It was really difficult, but anything can happen.

On Thursday night, she'll face Japanese star Naomi Osaka, a 6-2, 7-6 (7) winner over 16th-seeded Clara Tauson of Denmark in the second semifinal.

Mboko, ranked 85th in the world, is seeking her first WTA Tour title and trying to join Faye Urban (1969) and Bianca Andreescu (2019) as the only Canadians to win the home event in the



crowd, obviously, has its advantages," Mboko said. "You always have everyone pumping you up as much as they can. It really pulls me through in the tough moments where I'm maybe not as positive. Really blessed to have that kind of support.'

Born in Charlotte, North Carolina, to Congolese parents, Mboko grew up in Toronto. She upset topseeded Coco Gauff 6-1, 6-4 on Saturday to reach the quarterfinals, then topped Jessica Bouzas Maneiro 6-4, 6-2 on Monday. At 2 hours, 46 minutes, the match Wednesday was the longest of Mboko's short tour career.

From Kazakhstan, Rybakina won at Wimbledon in 2022. She has nine career WTA Tour victories, winning in May on clay at Strasbourg. Rybakina beat Mboko 6-3, 7-5 last month in Washington.

"I knew that she was a tough opponent," Rybakina said. "She served really well in these important moments. It was a very close match, like a big fight. So it could

Mboko overcame 11 doublefaults and battled through a wrist injury after stumbling awkwardly to the ground in the second game of the third set. She'll will move up to at least 34th in the world after start-

ing the year outside the top 300. Mboko said her wrist felt "a lot better" after the match, but in the moment, the fall almost crushed her "She was playing really great

tennis on top of that, but I'm happy that I kept my composure," Mboko said. "I was patient in the right moments. I just feel really happy that I was able to bounce back after being down, even a match point, I think." Osaka, the four-time Grand Slam champion who reached No. 1 in the world, continued her best performance in a WTA 1000 tournament since reaching the Miami final in 2022. She stepped for 15 months toward the end of that season and had daughter Shai in July 2023. She's seeking her eighth title and her first since the 2021 Aus-

VANCOUVER, Aug 7: Former Bayern Munich forward Thomas Müller in joining the Vancouver Whitecaps in arguably the biggest signing in club history.

Müller, who won the World Cup with Germany in 2014, will join the Whitecaps for the remainder of the season in an open roster spot.

Terms of the deal were not released. It includes a Designated Player option for 2026.

"Whitecaps — let's make history." Müller said in a video he posted online Wednesday that showed him unboxing a Vancouver jersey. The 35-year-old Müller has spent the last 17 years with Bayern Munich in the German Bundesliga, helping the club win 13 league championships and 33 total titles during that span. He scored 250 goals in 756 appearances with Bayern across all competitions, but his contract was not renewed after last

At the 2014 World Cup in Brazil, Müller scored five goals. He also scored five goals at the 2010 World Cup in South Africa, winning the Golden Boot.

Müller's final match with Bayern came this summer at the Club World Cup, losing 2-0 in the quarterfinals to Paris Saint-Germain in Atlanta. He came into the match as a late substitute

Müller joined Bayern's academy as a 10-year-old in 2000. He made his senior debut under Jurgen Klinscame under Louis van Gaal the fol-

lowing season. The club announced in a joint statement in April that it would be his last season. In a post on social media, Müller said he understood Bayern's decision "even if this did not reflect my personal wishes."

"Thomas Müller is the definition of a Bavarian fairytale career; he grew in Bavaria and with Bayern," club president Herbert Hainer said. "Nobody has won more Bundesliga titles, and 33 trophies in total so far speak volumes. He ranks among the most outstanding personalities in FC Bayern history.

Müller retired from international soccer after last year's European Championship, having scored 45 goals in 131 appearances for Ger-

The Whitecaps obtained Müller's MLS discovery rights from FC Cincinnati in exchange for up to \$400,000 in General Allocation Money to complete the signing. He will occupy an international roster spot. "Thomas is a natural leader whose passion for the game is infectious. This is a statement signing by our club and our ownership — a transformative moment for our club and our city," Vancouver sporting director and CEO Axel Schuster said in statement.

Müller is set to arrive in Vancouver next week. His first practice and introductory news conference with the club are scheduled for Thursday.

"At this point in the year, that extra practice is maybe only going to be draining for me a little bit, and that's something that I've learned to manage as my career has gone on," Scheffler said Wednesday after his proam round in the FedEx St. Jude Championship.



# I never considered not going out to bat against India: Chris Woakes

LONDON, Aug 7: England allrounder Chris Woakes says not going out to bat due to a dislocated shoulder against India on the final day of the fifth Test was something he never considered, even as he wondered if his career was at risk when he suffered the

Woakes came out with his left hand wrapped in a sling and tucked inside his sweater at the fall of the penultimate wicket with the fifth Test — which India won narrowly — tantalisingly

Woakes said he felt it was his "duty to do it for everyone" and that he is still gutted that England lost the game.

"I don't know what it is. You just know you're part of something bigger. It's not just you that you're playing for out there," Woakes, awaiting further scans, told The Guardian.

"It's your team and your teammates, all the hard work and the sacrifices they put in, the people watching at home and in the ground. You just feel a duty to do it for everyone.

"I'm still gutted, devastated really, that we couldn't get the fairytale. But I never considered not going out there, even if it had been 100 runs still to win or whatever," he added.

Woakes said it felt nice to walk out to a standing ovation but does

not read much into his heroic act. "It was nice to have the ovation and some of the Indian players came over to show their respect. But any other player would have done the same. You couldn't just call it off at nine wickets down," he said.

Woakes revealed he began practising batting one-handed from the fourth day onwards with England assistant coach Marcus

"I defended one normally and, oh mate, it was agony," he said.

"We soon worked out that a left-hander's stance would shield the shoulder and at least allow me to sort of block with my top hand in control. I hit a few, only way to survive," he added. (PTI)

The senior England player also revealed the exchanges he had with India skipper Shubman Gill and his deputy Rishabh Pant, who himself put on a similar act of bravery in the fourth Test when he batted with a broken

"Shubman said something like: 'That was incredibly brave," he said.

"I told him: 'You've had an unbelievable series, well played, and credit to your team'. Both sets of players had been through the mill in the series and deserve credit for the show we put on. Both teams wanted the win, of course, but it does kind of feel fair that it was drawn.'

"I saw Rishabh (Pant) had put an image of me on Instagram with a salute emoji, so I replied thanking him: 'Appreciate the love and hope the foot is OK,'

Woakes added, "He then sent me a voice note saying: 'I hope all is OK, good luck with the recovery and I hope we meet again out there some day'. I obviously said sorry for the broken foot."

Woakes, who did not get to face a ball, said running between the wickets was the toughest.

'The first one was the worst All I had taken was codeine and it was just so sore. Instinct took over here – even with my arm strapped down I tried to run as you naturally do," he said.

"I genuinely worried my shoulder had popped back out again, hence you saw me throw my helmet off, rip the glove off with my teeth, and check it was

"It was bittersweet in the end. (A) part of me wondered what it might be like, to see if I could have defended the ball, seen out an over maybe, squeezed a run or carved a four.'

He continued, "But the other side of it was: 'Thank God I didn't face a 90mph bouncer, onehanded, facing the wrong way around'. I knew I was going to have to wear a few bouncers if I did get on strike." Woakes wondered if the injury was careerthreatening right after his slide on the first day of the Test.

"The outfield was wet from the rain, almost greasy, and my hand slipped as I landed and my full body weight went through my shoulder. I heard a pop and knew I was in trouble," he said.

"The pain came on pretty quickly and my arm was just hanging there. It was grim and my thoughts were racing. 'Is it game over? Is it career done missed a few, but it felt like the was a horrible place to be," he

# **New Zealand pace dismantles Zimbabwe top-order** as Taylor stands firm in comeback match

## Lovlina accuses BFI official of disrespectful behaviour, IOA inquiry panel to convene meeting soon

**NEW DELHI, Aug 7:** Tokyo Olympics bronze-winning boxer Lovlina Borgohain's allegations of "disrespectful and gender-discriminatory behaviour" against national federation's executive director Col Arun Malik are being investigated and a report would be submitted soon, a Sports Authority of India (SAI) official has said.

In a formal complaint addressed to Sports Minister Mansukh Mandaviya, Sports Authority of India (SAI) Director General, the TOPS (Target Olympic Podium Scheme) division, the Indian Olympic Association (IOA), and the Boxing Federation of India (BFI), Lovlina alleged that Malik humiliated her and undermined her achievements during a Zoom meeting on July 8, which was attended by SAI and TOPS officials.

On the call Lovlina requested that her per-

sonal coach, who was also present in the online meeting, be allowed in the national camp, something that goes against the BFI policy. She also wanted the coach to be allowed to travel with her to train in Europe.

According to Lovlina, Malik responded aggressively and spoke to her in a demean-

"He blatantly told me to 'shut up, lower your head and do as we say.' His words were not only disrespectful but also carried an alarming tone of gender-discriminatory and authoritarian dominance -something that no one, especially a woman who has brought honour to the nation, should be subjected to," Lovlina stated in her complaint.

"I was made to feel small, unheard, and powerless. It was not just a personal insult - - it was an attack on every woman athlete who dreams of standing tall, both in and outside the ring," Lovlina stated in her com-

She further asked for a "fair and swift inquiry" and also "necessary disciplinary action if these actions are found to be in violation of acceptable conduct." Malik, however, "categorically and un-

equivocally" denied the allegations, calling them "devoid of any merit." "Lovlina's requests were considered and

respectfully declined, as they are inconsistent with the policies of the Boxing Federa-

"As per BFI's Selection Policy published in January 2025, it is mandatory for all athletes to participate in the National Coaching Camp to be considered for evaluation and selection for international competitions," Malik said in his reply.

"BFI, in the interest of fairness and uniformity, does not permit personal coaches or support staff within the National Camp.'

Taking note of the complaint, the IOA formed a panel, comprising TOPS CEO N S Johal, IOA's athletes commission vice chairperson Sharath Kamal and a woman advo-

The entire interaction between Lovlina and Malik was recorded during the meeting and a member of the inquiry panel said a report would be submitted soon.

The committee was to give the report within two weeks of receiving the complaint but has been unable to convene a meeting due to "some prior commitments of its mem-

## High on confidence with improved fitness, Manpreet targets Asian Games 2026

NEW DELHI, Aug 7: Two Olympic medals, over 400 International caps and still going strong, Manpreet Singh, the second-most capped player in Indian hockey, has found a second wind by tweaking his lifestyle and diet. The former India captain, who led

India to a historic bronze at the Tokyo Olympics, realised after the Paris Games last year that staying relevant in the fastpaced world of modern hockey meant one thing: transforming his fitness. "After last year's Paris Olympics and

Asian Champions Trophy, I felt that if I

have to extend my career, I will have to work on my fitness," the 32-year-old told PTI Bhasha in an interview. "I am 30-plus and now I have to maintain my fitness at the level of the young players in the team to compete with them. Experience alone is not enough,'

added Manpreet all geared up for the

Asia Cup, a World Cup qualifier, to be

held in Bihar later this month. For the last one year, Manpreet who has played 402 matches for India -- second only to Dilip Tirkey's 412 -- in an illustrious career of 14 years, has now drastically altered his diet and training regimen.

He has cut down on sweets and junk food, shifted to a high-protein, low-carb diet, and incorporated specialised workouts focused on speed and core strength.

"I have almost stopped eating sweets and junk food. I eat that only once a week but in very small quantities. Apart from gym, I started working on core workouts, speed and lost seven kilos of weight,' added the veteran from Mithapur, Punjab who made his debut for India in 2011 at the age of 19.

"With less weight, the speed on the field improved. I also got very good results in Yoyo and speed tests. I am feeling very good about myself."

While there will be speculation whether he will aim for the 2028 Los An-



geles Olympics, Manpreet is not making long-term commitments just yet.

"My first target is the Asian Games 2026. I know that I can continue till then with my current fitness. After that I will assess and if I feel otherwise then I will make room for another player. I consider Cristiano Ronaldo as my idol who is so fit even at the age of 40," he said.

He also said the current Indian team is at par with heavyweights Australia, Netherlands and Germany on fitness, intensity and skills and the only difference is of execution.

"Even before the Tokyo Olympics, the team had the confidence to defeat big teams. In terms of fitness and skill, we are at par with them. The only difference is in the execution and we are focusing on that," he said.

Asked how he managed the workload in such a long career while playing fastpaced international hockey, he said, "We have a big pool of players and also have India A team. Young players also get opportunities and workload management is taken care of."

"If I talk about myself, I want to play every match, it is a matter of pride to play for the country and I do not want to lose

how much and what kind of recovery is needed after the tournament and I keep doing that," he added. Confident of World Cup berth via Asia

He is confident that India will qualify for next year's World Cup through the Asia Cup to be held in Rajgir, Bihar from August 29.

India have won only one World Cup so

far in 1975 and in the last tournament held in Bhubaneswar and Rourkela in 2023, the host team finished ninth. "Earlier it was said that we are not able to play well in the Olympics, but in Tokyo we won a medal after 41 years and

repeated it in Paris. We are sure that we

will perform well in the World Cup as

"It is very important to capitalise on the opportunities in the knockout stage of a big tournament. In the last World Cup, we made a mistake in the match against New Zealand which cost us dearly but

we have learned our lesson," he said. He does not underestimate any team in the Asia Cup and believes that India will have to play by focusing on its strengths.

"Every team is coming with the goal of World Cup qualification and anything is possible in modern hockey. South Africa had defeated Germany in the Olympics. We have to focus on our strength, not on which team is in front of

In the Europe leg of FIH Pro League this year, the scorelines of six consecutive losses suggest a tough fight by the Indians, but it also reflects a worrying trend of conceding last minute goals and defensive lapses under pressure.

"The European tour was not that bad and there were many close matches. We worked a lot on the defense after that, how not to give easy opportunities to opponents and convert our chances," he said. (PTI)
