NEW DELHI, Sept 9: NDA candidate C P Radhakrishnan was elected the next vice president of India on Tuesday as he bagged 452 votes against the opposition candidate B Sudershan Reddy's 300, winning the contest with a bigger than expected margin, indicating cross-voting from the rival

Announcing the result of the vice presidential election this evening, Rajya Sabha Secretary General and Returning Officer P C Mody said 767 MPs cast their votes out of the total valid electors of 781 in a turnout of 98.2 per cent.

He said 752 ballots were valid and 15 were invalid,

Hours before the result, senior Congress leader and Rajya Sabha MP Jairam Ramesh had claimed that the Opposition has stood united. "All of its 315 MPs have turned up for voting," he said. The final tally in favour of Reddy, a retired Supreme Court judge, was 300, decidedly less than expected by the opposition camp as some MPs unaligned to the two blocs had also announced their support to him.

BJP leaders were quick to claim that at least 15 opposi-

tion MPs voted in favour of Radhakrishnan. There were hints from the ruling alliance that some opposition MPs deliberately cast invalid votes.

"I declare C P Radhakrishnan elected to the post of Vice President of India and the results will be communicated to the Election Commission,' Mody said.

Assam goes tough on illegal immigration

State Cabinet approves relief, pay corrections, agricultural reforms on the table

GUWAHATI, Sept 9: The Assam Cabinet, chaired by Chief Minister Himanta Biswa Sarma at Lok Sewa Bhawan on Tuesday, approved several key decisions, with a particular focus on strengthening border management and tackling the growing challenge of illegal immigration, an official statement said.

Among the decisions, the Cabinet approved the framing of a Standard Operating Procedure under the Immigrants (Expulsion from Assam) Act, 1950, aimed at providing clear guidelines to District Commissioners and Senior Superintendents of Police on identifying and expelling illegal migrants.

The move comes amid growing concerns over unabated illegal immigration from neighboring countries, which the government says threatens the cultural and demographic fabric of the state.

Under the new procedure, if the District Commissioner receives information from the police or any other source that a person is suspected to be an illegal immigrant, the individual will be required to produce valid proof of citizenship within ten days.

If the submitted evidence is found unsatisfactory, the District Commissioner will issue a written opinion, identifying the individual as an illegal (CONTD. ON PAGE-2)

KATHMANDU, Sept 9: Nepal reeled under a serious political crisis on Tuesday as Prime Minister KP Sharma Oli resigned in the face of massive anti-government protests with the demonstrators attacking private residences of several highprofile leaders, headquarters of political parties and even vandalising the parliament, a day after 19 people died in police action against the agitators.

The students-led protests appeared to reflect the growing public anger with the Oli dispensation over a range of issues including a ban on social media and inaction against alleged corruption as the protesters, defying curfews and heavy deployment of security forces, resorted to arson and stormed various key buildings and establishments.

Hours before Oli's resignation, the protesters set on fire the Nepalese leader's private house in Balkot, and attacked properties of President Ramchandra Paudel, former prime minister Pushpa Kamal



Dahal, Communication minister Prithvi Subba Gurung, former home minister Ramesh Lekhak and former prime minister Sher Bahadur

The intensity of the protests that began on Monday against the government's ban on social media sites grew on Tuesday with demonstrators taking out anti-government marches in all leading cities and

Flight services at Tribhuvan International airport in Kathmandu have been partially suspended in view of the protests.

With the situation deteriorating

rapidly, the top brass of Nepali Army and other security agencies issued a joint appeal calling for restraint and resolution of the crisis through dialogue.

"As the prime minister's resignation has already been accepted by the president, we call upon all to restrain and not to allow more loss to life and property in this difficult situation," they said.

"A peaceful resolution through dialogue is the only way to restore order and stability," they said in a joint statement.

The statement was signed by Nepal Army chief Ashok Ra Sigdel, Chief Secretary Ek Narayan Aryal, Home Secretary Gokarna Dawadi, Chief of Armed Police Force (APF) Raju Aryal, Inspector General of Police Chandra Kuber Khapung and Chief of National Investigation Department Hutraj Thapa. BJP may emerge as winner in BTC polls: Himanta

GUWAHATI, Sept 9: Chief Minister Himanta Biswa Sarma on Tuesday said the Bharatiya Janata Party (BJP) has emerged as a serious contender in the upcoming Bodoland Territorial Council (BTC) elections and could spring a surprise in the region that has traditionally been dominated by local parties.

Speaking to reporters, Sarma noted that the United People's Party Liberal (UPPL) and the Bodoland People's Front (BPF) have so far remained the two strongest players in Bodoland pol-

'In my assessment LIPPL and BPF were the dominant parties for the BTC polls and they continue to be stronger compared to the BJP. But given the fact that the BJP has been preparing for the upcoming polls in Bodoland, it would not be surprising if we emerge as a winner," he said.

The Chief Minister emphasised that beyond electoral competition,

elections is to uphold and safeguard peace in the Bodoland re-

"The BTC polls are not just about power-sharing but also about protecting the peace that has been achieved after years of unrest," Sarma remarked. Bodoland, which falls under the

Bodoland Territorial Region (BTR), has a complex political landscape shaped by decades of movements for autonomy, armed insurgencies, and peace accords.

The BTC, an autonomous body under the Sixth Schedule of the Constitution, governs areas spread across four districts — Kokrajhar, Chirang, Baksa, and Udalguri.

The BPF led by Hagrama Mohilary held sway over the BTC for nearly 17 years until the 2020 elections, when the UPPL, supported by the BJP formed the council after a tough contest.

Sarma said that after talks with the Assam Tea Tribe Students' Association (ATTSA) and the All Adivasi Students' Association of Assam (AASAA), the government has reached an "amicable resolution" and will soon issue a formal tiveness of over 100 sub-groups

The announcement comes close on the heels of a major protest in Tinsukia district, where hundreds of AASAA members blocked NH-37 at Makum demanding recognition of specific Adivasi identities in caste certificates. The protesters argued that the current system which issues OBC certificates under four broad categories such as tea garden labourers, tea garden tribes, ex-tea garden labourers, and ex-tea garden tribes — undermines the historical and cultural distinc-

within the tea community. Community leaders have long expressed concern that the identities of groups such as Santhal, Oraon, Munda, Kharia, Bhumij, Teli, Tanti, Kurmi, Karmakar, Mahato, Nagbansi, Kanika, and Rajgarh are being erased by such generalised classification. They had also warned the BJP government of political repercussions if the issue was not addressed before the next Assembly elections.

Govt directs manufacturers to revise MRP on unsold stock as GST rates change

NEW DELHI, Sept 9: The government on Tuesday directed manufacturers and importers to declare revised maximum retail prices (MRP) on unsold stock to reflect changes in goods and services tax (GST) rates, with the deadline set for December 31 or until stocks are exhausted, whichever is earlier.

The directive comes as the government has reduced GST on various products and services, which will come into effect from September 22. "As per the new GST rates,

manufacturers, packers, and importers can revise the MRP on unsold stock until 31st December 2025 (or until stock lasts)," Union Food and Consumer Affairs Minister Pralhad Joshi said in a social media post on X. The minister emphasised that the revised prices must reflect GST changes only. "Any increase or decrease in price can only match the

tax change," Joshi said. According to the directive, the new MRP should be declared with a sticker, stamp or online print,

while ensuring the original MRP remains visible

The government has also mandated that manufacturers, packers or importers make at least two advertisements in one or more newspapers regarding the price revision.

Nepal in grip of

ouster for the death of at least 19 people in police action during the protests on Monday as well as for his alleged "inaction" against widespread corruption. In his resignation letter to President Ramchandra Paudel, the 73-yearold Communist Party of Nepal (Unified Marxist-Leninist) cited the "extraordinary circumstances" facing Nepal and said he is quitting to pave the way for a "constitutional and political" resolution of the current situation.

Oli, known to be close to China, had become the prime minister in July 2024 for the fourth time with the support from the Nepali Congress Party. He was scheduled to visit India this month. Though the Nepal government last night revoked its ban on social media websites following the protests led by 'Gen Z' youths, the agitators continued their demonstration against corruption and demanding accountability for deaths of 19 people.

The agitators under the banner of Gen Z, shouted slogans such as "KP Chor, Desh Chhod" (KP thief, leave the country) and "Take Action Against Corrupt Leaders". Protesters also torched the residence of former home minister Ramesh Lekhak at Naikap in Kathmandu, just a day after he resigned from his post, according to officials.

Demonstrations were reported from Kalanki, Kalimati, Tahachal, and Baneshwor in Kathmandu, as well as Chyasal, Chapagau, and Thecho areas of Lalitpur district. Protesters, mostly students, chanted slogans such as "Don't kill students", defying the restrictions on public gatherings. In Kalanki, demonstrators burnt tyres to block roads from the early hours of the morning, according to eyewitness accounts. The agitating youths also pelted stones at the residence of Communication Minister Prithvi Subba Gurung in

Sunakothi at Lalitpur district, eye witnesses said. Gurung had ordered a ban on the social media sites. They also vandalised former PM Sher Bahadur Deuba's house at Budhanilkantha in Kathmandu.

The Gen Z group, which has been campaigning against corruption for some time, has used social media platforms like Reddit and Instagram to expose what they called the "extravagant lifestyles of the children of ministers and other influential figures." They have posted videos and images, questioning the sources of wealth that fund such opulence, purportedly derived from corrupt practices.

The ban of social media sites was an attempt to suppress freedom of speech, the agitators said.

The Nepalese government had ordered the ban of 26 social media sites, including Facebook and 'X', over their egister with the government. However, in a late-night development on Monday, the go nounced the restoration of access to social media platforms, in an apparent bid to ease public anger.

Among the other demands of the protesters include guarantee for freedom of expression, and the introduction of a retirement age for those holding political office, according to Gen Z activists.

Nepal Army has also issued a separate statement expressing its commitment to protect the country's independence, sovereignty, territorial integrity, independence and national unity. "We are analysing the latest developments of the Gen Z movement being launched in Nepal in the recent period," it said. (PTI)

The electoral college for the vice presidential election comprises a total of 788 members - 245 from the Rajya Sabha and 543 from the Lok Sabha. The present strength of the electoral college is 781 as six seats are vacant in the Rajya Sabha and one in the Lok Sabha.

The BJP-led NDA had on paper 427 MPs in its alliance, with the YSR Congress also extending the support of its 11 MPs to its candidate. Some MPs representing smaller parties also backed Radhakrishnan.

The Congress congratulated the NDA nominee on his win, and said its ideological battle against the ruling alliance will continue "undiminished". (PTI)

Assam goes tough on

immigrant based on facts and reasons. The expulsion process will be swift and decisive.

The District Commissioner is empowered to pass an expulsion order under Section 2(a) of the Act, directing the migrant to leave Assam within 24 hours. Those already declared foreigners by the Foreign Tribunals will not require further identification, and expulsion orders will be issued immediately. Biometric and demographic details of identified individuals will be captured on the Foreigners Identification Portal to ensure tracking and enforcement. If the individual fails to comply, the District Commissioner, with assistance from law enforcement, may detain the person in a Holding Centre or hand them over to the nearest border guarding force under Section 4 of the Act.

In cases where illegal migrants are detected near the zero line or within 12 hours of entry, they will be pushed back immediately without undergoing further procedures. Chief minister Sarma underscored the government's commitment to safeguarding the indigenous population and strengthening Assam's security and administrative apparatus. Officials present at the meeting noted that the SOP would act as a comprehensive framework to curb illegal migration, ensure effective border enforcement, and maintain law and order in the state.

In addition to addressing the illegal migration issue, the Cabinet approved ex post facto financial assistance of ₹5 crore from the Chief Minister's Scheme for Public Emergency to the Chief Minister Relief Fund in Himachal Pradesh, aimed at providing relief from monsoon-related disasters

Japanese investment in India

apan committed investment in India worth Yen 10 trillion (US \$ 65 Billion) in the next decade. This is more than what Japan Invested in India till now. (US\$ 44 Billion). The moot point for enhanced investment is to make India hub for alternative supply chain. Hitherto, China was the promising destination for Japanese investment in Asia over one and half decade. Nonetheless, the trend underwent into a turnaround with the bursting of COVID pandemic and incentive from Japan to shift from China. India toppled China in 2023 and became the second biggest investment destination in Asia. The overturn in the investment direction was accelerated by the visit to Japan by the Prime Minister Narendra Modi on August 29 and 30 before attending SCO summit on August 31 apart from his bilateral meeting with the Chinese President Xi Jinping. The new investment will be encouraged in energy saving and new technology, besides automobile. In this regard, India- Japan Joint Credit Mechanism (JCM) pitches for cooperation between two countries to reduce greenhouse gas emission in India. Both sides aimed to launch sustainable fuel initiative and battery supply chain partnership., which will pose a new challenge to China

To this end, under TDSG plan (Time Division Switching Group), India launched its first lithium –ion battery manufacture for hybrid vehicle. Japanese companies are significantly increasing investment in India's battery sector, driven by joint strategic efforts. These include joint ventures between Toshiba Corporation, Denso and Suzuki of Japan in Gujarat. Besides, the visit initiated a new era for exchange of human resources between the two countries. Both sides agreed to exchange 5 lakh skilled workforces in different fields. Under this, 50.000 skilled Indians will be invited to Japan. Special ties between the two countries began with the first ever visit of Emperor Akhito and Empress Michiko to India in 2013. In the following year, India and Japan shared a "Special strategic and Global Partnership". These led India and Japan into a closer and strategic relation. The relation became further stronger by the visit of late Prime Minister of Japan Shinzo Abe, who became the first Japanese Prime Minster as Chief Guest to Republic Day celebra-

According to JBIC (Japan Bank for International Cooperation) survey 2024, India emerged the top investment destination in Asia. According to a survey by JETRO (Japan External Trade Organisation), India took lead in Japanese investor's expansion in Asia. In contrast, business expansion intension in China hit a record low. The trilateral relationship between India-Japan-China is indispensable to make India global hub for supply chain workshop.

'Nepal's online lockdown: A question mark on freedom'

The Nepal government has ordered 26 major social media and messaging platformsincluding Facebook, WhatsApp, Instagram, YouTube and X (formerly Twitter)—to be blocked in the country. The government argues that the companies have not set up local offices and have not created a complaint redressal system, leading to rumours and cybercrime. Critics see it as an attack on freedom of expression. The move will affect ordinary citizens, families, businessmen and content creators.

small democratic country like Nepal has recently taken such a big decision that shocked the whole world. The government ordered a sudden ban on 26 social media and messaging platforms. This includes the most popular platforms like Facebook, WhatsApp, Instagram, YouTube and X. As sudden as this decision was taken, it also started a deep debate whether this step was an attack on civil rights or was necessary for the digital security of the country.

The government says that social media companies were already warned to open their local offices in Nepal, appoint representatives and ensure a system for grievance redressal. But the companies did not follow it. According to the government, due to this, rumors, misleading news and cyber crime were increasing rapidly. This big step was taken to stop this.

But this decision is also being opposed rapidly. Journalist organizations, human rights groups and common citizens are considering it an attack on freedom of expression. They argue that social media is not just a means of entertainment, but it has now become the voice of citizens and the basis of democracy. When platforms are closed on such a large scale, it will have a profound impact on the public's freedom of communica-

tion and expression. There are millions of families in Nepal whose members are working abroad. For them, WhatsApp and Facebook are the easiest way to stay connected with their families. This ban will make their daily life difficult. Not only this, small traders and people doing online business also used to reach customers through social media. They used to sell their products by advertising on Instagram, YouTube and Facebook. Now all this will be affected.

Thousands of content creators and YouTubers, who were earning their livelihood from social media, are suddenly on the verge of unemployment. Disappointment and discontent is increasing among the

youth. This is not only an economic problem, but also a big blow to digital employment.

This decision can also be challenging for the Nepal government from a political point of view. The opposition is considering it a dictatorial step. They say that the government is afraid of criticism and questions, so it banned social media. The real strength of democracy lies in the voice of the people. When that voice is suppressed, democracy weakens.

Nepal's image will also be affected at the international level. Investors and digital companies will think that Nepal's digital environment is not stable and secure. This will affect investments and partnerships. Tourists may also be unhappy, because today a large part of travel, communication and information is based on social media.

The government's argument is not wrong at all. Rumours, fake news and cyber crime are spreading rapidly on social media. This can also trigger social tension and violence. The government has the right to ensure the safety of citizens and make companies responsible. But the solution to the problem should not be to directly

shut down the platforms. Many countries of the world have imposed rules on social media companies. India made new information technology rules in 2021, making it mandatory for companies to appoint grievance officers and take immediate action on content. The European Union also implemented the Digital Services Law. But no such complete ban has been imposed anywhere. Nepal's move therefore seems harsh and hasty.

The solution is for the government to negotiate with the companies, impose fines on them and force them to follow the rules. Completely suppressing the voice of the public is not the right way. This is not only against democratic values but will also increase distrust between the public and the

government. In the future, Nepal will have to choose the path of balance. It will have to understand that social media is no longer just a technical

tool, but has become an important part of people's lives. Shutting it down is an attack on both people's freedom and communication. It would be better if the government keeps the companies under strict rules, but the freedom of expression of citizens is also protected.

The real strength of democracy is the trust of the people. This trust is built only when the government communicates with the people and does not suppress their voice. Nepal should reconsider its decision and adopt a path that follows the law and also protects the freedom of citizens. This is the right democratic solution.

This incident in Nepal is a lesson for the whole world. It shows how important it is to maintain a balance between rules and freedom in the digital world. On one hand there is a need for security, control over rumors and crimes, while on the other hand it is equally important to respect the freedom of expression and communication of the public. If this balance is achieved, democracy will remain strong and everyone will benefit from the digital world.

Modi's Multi-Alignment: Designing India's strategic resolve and defining its ascendant Global role in 2025

The year 2025 finds India at an inflection point where history, geography, and destiny converge. At the heart of this convergence stands Narendra Modi, who, in his third term as Prime Minister, has sculpted a diplo matic doctrine best described as multi-alignment—a strategic architecture that refuses the binaries of Cold War thinking and embraces the multiplicity of an interdependent world. Where once nations were compelled to choose camps, India today has assumed the rare confidence to convene them, arbitrate their disputes, and shape the contours of tomorrow's global order. Syntax of Power

Unlike the rigid polarities of the 20th century, Modi's diplomacy has orchestrated a grammar of engagement where partnerships coexist without contradiction. India buys oil from Russia while deepening defence industrial cooperation with the United States. It signs climate compacts with Europe while championing energy security for the Global South. This is not strategic ambiguity; it is strategic maturity, born from an economy now surpassing \$4.6 trillion in nominal GDP in 2025, according to the IMF, and projected to overtake Japan by 2027. India's growing economic heft has liberated it from dependency, giving it leverage to craft terms rather than accept them.

Sindoor: Strategic Resolve

Few moments captured this new India better than Operation Sindoor, the evacuation of thousands of Indian and foreign nationals from conflict-torn West Asia earlier this year. Beyond humanitarian relief, the operation displayed India's logistical muscle, naval depth, and political will. It signalled a state that anticipates crises and delivers solutions. Operation Sindoor was less about evacuation than about strategic resolve: India asserting its role as a reliable stabiliser for both its citizens and partners. In a world of uncertain guarantors. India showed that it has moved from being protected to being

Modi's Diplomatic Journey

If diplomacy is theatre, Modi has mastered both script and stage. His 2025 itinerary illustrates the choreography of multi-alignment. In February, he was in France and the United States, reaffirming defence and technology ties, with the U.S. visit yielding a semiconductor investment worth \$12 billion. In March, his presence in Mauritius strengthened diaspora and maritime influence.

April showcased layered engagement: BIM-STEC and Sri Lanka cemented India's Bay of Bengal leadership, while his Riyadh summit with Saudi Arabia produced a long-term energy transition pact. August was a whirlwind: Cyprus, G7 in Italy, Argentina, BRICS in Johannesburg, Namibia, and Japan. Each stage reflected India's convening role, from lithium partnerships in Argentina to defence talks in Tokyo. Finally, the SCO Summit in Tianjin underlined India's ability to sit with adversaries without vielding autonomy. No other leader in 2025 can claim such a global calendar with tangible outcomes



Strategic Diplomatic Signals

What distinguishes India's diplomacy is not attendance but messaging. To Washington, it signals that multipolarity is necessity, not rebellion. To Beijing, it conveys coexistence without capitulation. To Riyadh, it affirms energy interdependence. To Africa, it offers partnership without conditionality. These gestures form a strategic mosaic, where each piece strengthens

India's Convening Power

India's greatest asset may be its convening power. The Voice of Global South Summit. which drew 125 nations this year, and Modi's ability to participate meaningfully in both BRICS and the G7, show a country that bridges divides. In a fragmented era, India positions itself as a platform builder rather than a fencesitter. The Munich Security Report 2025 notes India as a "balancing hinge" in global affairs, remarking that "no Indo-Pacific crisis can be addressed without New Delhi's participation.'

Strategic Economic Weight

The IMF projects 6.5% growth for India in 2025, the highest among major economies, with its middle class now exceeding 450 million consumers. India contributes nearly 15% of global growth, transforming it into an engine of financial governance. Its digital public infrastructure—UPI and Aadhaar—has become a model for inclusive modernization, now adopted in parts of Africa and Southeast Asia. Economic weight is no longer passive; India translates growth into strategic leverage, ensuring that its seat at the table is permanent.

Strategic Military Resolve

Prestige rests also on hard power. India's defence spending has risen to 2.1% of GDP, with emphasis on indigenisation under Atmanirbhar Bharat. The INS Vikrant carrier group and S-400 air defence systems have bolstered deterrence, while exercises with the U.S., France, and Japan highlight interoperability. At the same time, legacy ties with Russia remain intact. This duality ensures India is not trapped by dependence but empowered by diversification.

India Among Emerging Powers Unlike Brazil, which remains constrained by domestic turbulence, or Turkey, whose assertiveness lacks scale, India combines stability, economic depth, and demographic momentum.

Unlike Indonesia, which wields regional weight but limited global pull, India possesses both the numbers and the narrative to shape institutions. Its rise is therefore not an anomaly but a structural transformation in global order.

Multipolarity as Strategy

Unlike the unipolar 1990s or the bipolar Cold War, today's reality is multipolar. Modi has embraced complexity rather than fleeing from it. India does not seek to replace one hegemon with another; it pursues a concert of powers, where cooperation is fluid and competition managed. This vision is neither naive nor cynical—it is pragmatic pluralism for an era of dis-

The Road Ahead

India's outlook blends promise with challenge. Climate change demands balancing growth with sustainability. Border tensions with China endure, even as trade expands. Yet projections are emphatic: by 2030, India will be the third-largest economy, with a defence budget surpassing \$150 billion, and a demographic dividend still active. Its leadership in the International Solar Alliance, growing Arctic footprint, and activism in space diplomacy highlight ambitions beyond its neighbourhood.

India's Global Position 2025

The answer is both simple and profound: India in 2025 is everywhere and nowhere confined. It is not shackled to any alliance, yet it is indispensable to all. It is Washington's partner, Beijing's rival, Africa's friend, South Asia's anchor, and the Global South's voice. It mirrors the contradictions of the age—seeking peace while building deterrence, embracing modernity while rooted in civilisation.

The architecture of multi-alignment is not a transient tactic but India's blueprint for relevance in a fractured century. In the kaleidoscope of 2025's geopolitics, India is less a bystander and more an architect. Its message to the world is unmistakable: you may debate without India, but you cannot decide without it. That, perhaps, is the truest measure of New Delhi's place in the world order today—a nation that has shifted from the margins of decision-making to the very centre of the global stage. Role of Tribal Women in Assam Economy

ssam is home to a rich mosaic of Scheduled Tribes (STs)-including Bodo, Mising (Miris), Karbi, Dimasa, Rabha, Tiwa, Deori and others-who together constitute roughly 12.4% of the state's population (2011 Census). Within these communities, women sustain livelihoods through agriculture, weaving and sericulture, fisheries and wetland-based work. non-timber forest produce (NTFPs), and an expanding network of self-help groups (SHGs). Their labor is central both to household welfare and to state-level value chains such as handloom and silk. Yet, much of their contribution remains informal and undercounted.

Demographic and Sectoral Context: Assam's handloom economy is a standout example of women-led production. Official sources indicate over 12.83

lakh weavers and 12.46 lakh handlooms in the state, with women as the overwhelming majority of weavers; handloom is widely cited as the second-largest employer after agriculture in Assam.

National handloom data reinforces this

picture. The Fourth All India Handloom Census (2019-20) shows India's handloom sector engages 26.7 lakh weavers and 8.5 lakh allied workers, the vast majority female; Assam leads the country by number of weavers. Independent analysts estimate women's participation in Assam's handloom workforce at around 90%, underscoring a distinctly gendered craft economy. Beyond handloom, women's participation in MGNREGS (rural public works) has risen nationally; in Assam, the MIS dashboard reports women's person-days typically near or just below half in recent years—an important cash buffer for rural households. Female labour force participation (FLFP) in Assam has improved since 2021–22 (PLFS), now above the national average per an independent 2025 state factsheet-though the gains are uneven and a large share remains informal.

Core Economic Roles: 1) Agriculture and Allied Activities: Tribal women in both hill and plain districts carry significant responsibility across sowing, weeding, harvesting, seed conservation, and post-harvest processing. They manage mixed livelihoods paddy, horticulture, small livestock—and seasonal wage work including MGN-REGS, particularly during agricultural lean periods. Studies of rice-based systems and seed preservation practices highlight women as custodians of agrobiodiversity in tribal farming systems. Climate stress complicates this role.

Assam's recurring floods and riverbank erosion displace families and disrupt cropping calendars; women often become "left behind" managers of homes, fields, and children when men migrate for work. Local and state-wide studies document the gendered burden of climate shocks, especially in vulnerable districts like Dhemaji and riverine islands such as

2) Handloom & Sericulture (Muga, Eri, Pat): Weaving is both livelihood and cultural identity for many ST communities (e.g., Mising, Bodo, Karbi, Dimasa). Women are the primary weavers, producing textiles for home use and sale (mekhela sador, dokhona, shawls, gamocha, etc.). Assam's unique silks— Muga (GI-tagged), Eri, and Pat-anchor niche value chains in which women rear silkworms, reel yarn, dye, design, and weave. Government and academic sources recognize Muga as a Geographical Indication associated closely with Assam's heritage and women's skills.

As noted, the state leads India in number of handloom weavers, with women estimated to form the vast majority of the workforce. Yet the sector remains highly informal; many women juggle weaving with agriculture and care work, and face constraints in credit, quality raw material, design inputs, and stable market access.

3) Fisheries and Wetland Economies: Assam's rivers, beels (oxbow lakes), and floodplains support small-scale fisheries. While men often dominate capture fisheries, women's roles are significant in fish processing, vending, aquaculture support, and cooperative decision-making in certain community-managed wet-Case studies—including community fisheries management in floodplain wetlands—document women's participation and empowerment in decision-making spaces.

4) Non-Timber Forest Produce (NTFPs) and Bamboo/Cane: In forestfringe and hill communities, women collect and process NTFPs (wild edibles, medicinal plants, fibers) and engage in bamboo and cane crafts, a near-universal household skill across many tribal areas of Assam. Bamboo/cane value chains offer home-based, low-capital livelihoods with scope for design upgrades and cluster support. The national MSP for MFP mechanism acknowledges the centrality of NTFPs to tribal livelihoods, which typically involve high women's

5) Markets, Micro-Enterprises, and SHGs: The SHG movement has transformed women's access to microcredit. savings discipline, and enterprise. In Assam, ASRLM (NRLM) reports widespread SHG coverage with millions of women members, and state support for producer groups, bank linkages, and livelihood clusters. Studies from Assam show SHG participation raising women's income, mobility, and decision-making

Recent state initiatives-such as Mukhya Mantri MahilaUdyamita Abhiyan (MMUA) grants for SHG-linked micro-entrepreneurs and Sakhi Express mobility support for community cadres signal continued policy momentum to reduce mobility and financing barriers for rural women.

Nuanced Cases and Sector Linkages Tea and Plantation Work- A Clarification: Women are over 50% of the workforce in Assam's tea estates-largely concentrated in labour-intensive plucking-yet these communities (often called Tea Tribes/Adivasi) are not currently listed as Scheduled Tribes in Assam, though political debates about their ST status continue. Their situation intersects with tribal women's economic realities but requires a category distinction in official statistics and policy design.

Majuli and Riverine Communities: In Majuli, women (notably from the Mising community) have formed weaving cooperatives and community enterprises to offset the shocks of flood and erosion, linking cultural craft to climate resilience and local income.

Institutional and Policy Landscape

1. NRLM/ASRLM:State-wide SHG mobilization, credit linkage, enterprise promotion (producer groups, rural marts, bank sakhis/krishisakhis, etc.). State action plans highlight scaling of producer groups and linkages to markets and financial services.

2. Handloom & Sericulture Departments: Training centres, design inputs, procurement tie-ins (e.g., government purchases of handloom items), and GI/branding initiatives around Muga/Eri/ Pat. Legislative committee reports emphasize the sector's employment significance and institutional support networks.

Microfinance Ecosystem: NABARD's Status of Microfinance in India and sector reviews track SHG-bank linkage volumes and credit flows; Assam figures in the national uptick in SHG penetration and bank linkage, supplemented by NBFC-MFI outreach.

4. MGNREGS: Provides countercyclical employment and an income floor; women's participation has trended up nationally, while Assam's women's share hovers near the 50% mark per MIS.

5. FRA and NTFPs: Recognition of community rights under the Forest Rights Act, 2006 remains uneven in Assam, con-



straining women's collective access to forest commons and NTFPs that underpin cash incomes. Fact-finding reports recommend improving CFR (Community Forest Resource) implementation and micro-planning.

Key Constraints

Informality and Low Returns: Handloom and craft work is mostly homebased, part-time, and price-taker in nature. Women face thin margins due to raw material costs (yarn, dyes), limited design upgradation, and weak bargaining power with traders.

Credit & Market Linkages: Despite SHG progress, gaps remain in timely working capital, risk-sharing, and stable off-take contracts, especially for small, remote producers.

Mobility and Care Burdens: Distance to markets/banks and lack of childcare restrict enterprise growth. Recent mobility schemes (e.g., scooters for cadres) try to lower these barriers but are not yet uni-

Land and Commons: Incomplete tenure security and slow FRA realization can limit women's ability to invest in NTFPs or aquaculture-based livelihoods.

Climate Risk: Floods and erosion periodically wipe out looms, inventory, fish ponds, and stored grain—eroding assets and discouraging reinvestment.

Data Blind Spots: Official datasets often undercount unpaid and home-based work, masking women's actual contribution and hindering targeted support. (This is widely noted in gender and labour literature; the PLFS trend improvements still leave informality high.) What's Working: Positive Trends

and Illustrative Impacts Producer Groups and Federations: ASRLM-supported producer groups aggregating SHG women can improve bulk purchase of yarn, common facilities (dveing, reeling), and collective marketing, in-

cluding government procurement linkages. GI/Branding Pathways: Muga's GI and the state-wide recognition of handloom heritage create opportunities for premium pricing, authenticity labels, and tourism tie-ins, especially when women's coopera-

tives can meet design and quality standards. Market-Ready Skilling: Recent state schemes (e.g., MMUA) pair grants with basic business training—an essential complement to credit that improves repayment capacity and business survival.

Women in Community Fisheries: Participatory governance in wetlands has shown women can take on leadership roles in resource management and revenue allocation where institutions actively include them.

Recommendations

1. Strengthen Value Chains, Not Just Production: (a) Handloom/Sericulture: Invest in district-level common facility centres for yarn dyeing, design services, and quality testing; encourage government and corporate procurement of handloom uniforms/gifts with fair-price contracts to women's groups. (b) Bamboo/Cane: Support design labs and cluster-based branding tied to local motifs; build market linkages (urban craft stores, e-commerce) with logistics support from federations.

2. Finance that Fits Women's Cashflows: Use revolving working-capital funds at SHG federation level; expand credit guarantees to lower collateral barriers for micro-enterprises; and pilot invoice-discounting for orders from government buyers to producer groups. Sector reviews from NABARD and MFIN can guide bank partnerships.

3. Mobility, Care, and Safety as Enterprise Infrastructure: Scale last-mile mobility solutions (building on Sakhi Express) and community childcare near weaving clusters and weekly markets to free time for production and sales.

4. Climate-Resilient Livelihoods: Provide elevated weaving sheds, flood-resilient storage, micro-insurance, and seasonal cash grants after floods to protect inventories and restart production quickly in flood-prone districts (Majuli, Dhemaji, etc.).

5. Fisheries & Wetland Enterprises for Women: Expand community-based aquaculture with training on pond management, feed, and market channels; formalize women's roles in beel management committees with quotas and leadership training.

6. Secure Commons and Implement FRA Fairly: Accelerate Community Forest Resource (CFR) recognition and micro-planning in tribal villages; integrate NTFP value chains with MSP for MFP procurement, prioritizing women's groups as primary collectors/processors.

7. Data that Counts Women's Work: In PLFS/NSS-type surveys and state handloom databases, record home-based, parttime, and seasonal work more accurately; incorporate time-use modules to reflect unpaid care burdens that limit enterprise growth.

Conclusion

Tribal women in Assam are producers, entrepreneurs, knowledge keepers, and risk managers. They grow food, rear silkworms, weave worldrenowned textiles, steward bamboo and cane traditions, process fish, and keep markets alive—often while navigating floods, displacement, and thin margins. Progress in SHGs, state schemes (e.g., MMUA, Sakhi Express), and sector branding (Muga GI) has opened new doors. The next leap requires valuechain investments, gender-responsive finance and infrastructure, climate resilience, and secure rights to land and commons—so that the work tribal women already do can translate into stable incomes, asset building, and intergenerational opportunity.

upported by the colonial British-Indian administration, American Historian Katherine Mayo wrote her best-known work, Mother India in 1927. The book tried to fix India's image in a single damning frame. Mayo argued forcefully that Indians were not worthy of autonomy ecause of abominable treatment of women and best served by colonialism's civilising influence. It created a furore in Indian publics and they responded with prolific rebuttals in print, art and politics creating a long-standing debate on what Mother India is and is not.

Understandably, an important strand in this debate would seek to reimagine Mother India in a way which made her a moral figure, and Indians, worthy of freedom.

Being an intensely political writer, filmmaker, journalist and cultural commentator. Khwaja Ahmed Abbas must have been conscious of the contours of this debate when he wrote Bharat Mata ke Paanch Roop. It was first published in 1959 in a volume of short stories titled Diya Jale Saari Raat. In the story, Abbas may not be responding to Mayo's polemical Mother India directly but he replaced the singular, majoritarian, divine "Mother" with five ordinary-yet-exemplary women.

He uses description of their everyday courage to give content to the idea of India as an ethical collective, and thus, Indians as

deserving of autonomy. Kaun Hai Bharat Mata, a stage adaptation of the story by Mandala Theatre Group performed on September 2 tapped this alternative reimagination of patriotism of KA Abbas with verve and warmth. The production was supported by IPTA, Rajiv Gandhi Foundation and Khwaja Ahmed Abbas Me-

morial Trust. Staged at Delhi's Jawahar Bhawan auditorium – hardly a purpose-built theatre – the production could easily have been hamstrung by limitations of the space. But it wasn't. Despite heavy rain in the city the auditorium was full. Clean sightlines and unconventional entries of several actors from among the audience made the space work well.

The use of a digital screen on the stage was jarring in the beginning but turned out to be effective for a minimalist set. The projected visuals authenticated the context. A central screen provided a living archive: grainy archival newsreel, fragments from films and TV shows, artworks stitched together transitions and highlighted the subtext without too much moralising.

Each of the five sketches was delivered as a story narration but the actors infused it with the entire lifeworlds of the protagonists through lively speech rhythms and expansive stage work. The tone of each of the sketch was varied and the performances were notably polished. Moments of solo narration and quiet reflection were offset by imaginative transitions. The music, sometimes recorded played and live singing, was often carrying emotion across scene changes. It was consistently engaging but sometimes overpowered actor speeches.

Even in a hall not exactly designed for professional theatre performances, the cast's projection and timing kept the back rows involved. Applause punctuated key points in the play, and, at more than one point, the audience joined with the actors' slogans and songs. The theatre adaptation of Abbas's re-story by Lokesh Jain was creative yet faithful to Abbas's core spirit. The five women narrated by women and men actors produced a complex gendered field on the stage, which reflected the paradox and need of Indian feminism to distinguish itself from western feminism as an anti-colonial move at the time.

Gandhi figures prominently in Abbas' narrative and in the play through Masood Hussain's artworks in the play. But the play was fairly successful in depicting Gandhi as a value in the moral universe of these civic mothers and not as a cult of personality.

Mohammad Kazim's narration of a multilingual household in Madras was delightful and Pakhi Jain made the story of old Hakeemat weaving a khadi shroud radiate with her youthful perspective. Chhavi almost became the refugee Maaji from Rawalpindi.

The only character among the five who is not a Gandhian or pacifist is a Maharashtrian Brahmin whose will to provide cover to her grandson Inquilabi's friends involves breaking caste strictures. Rajesh Tiwari made valiant effort to infuse Nani's story with satirical humour.

Director Lokesh Jain became the voice of KA Abbas and narrates the story of his mother – a Muslim woman who was displaced from her beloved Panipat in the Partition violence but still refuses to move to

The vignettes foreground choices that make these women appear as a cut above and against the grain. In Abbas's telling these mothers are ordinary, but for their extraordinary response to exceptional circumstances. His civic mothers dethrone a divine icon, thus reimagining Mother India characterised by practicable set of ethics.

They are seen setting aside regional parochialism, ridding themselves of deeply ingrained caste prejudice, risking financial security, favouring the political over familial bonds - in order to inhabit a plural, capacious India. Their virtues involve tethering courage, self-discipline and labour to solidarity and fraternity. These biographies were able to remind the audience what citizenship means in the best possible sense, which was perhaps the intention of Abbas

when he penned them. History pulsates through the play. The Non-Co-operation and Khilafat movements are the moments in which political judgment is formed by the five mothers. The choices made by Lokesh Jain meant that the audience confront the Partition as a wound. But they are not left only hurting. The contemplation of the pain helped me understand that the Partition was also experienced by its survivors as a test of moral principles

in face of a violent political vision.

I saw the book Five Faces of Mother India with an introduction and translation by Sayeda Hameed published by Pratham at a book display and sale table outside the theatre only after the performance. As a result the intertextuality created by projection of the book illustrations by Nilofer Wadia elided me during the performance. But the

Many years ago I had seen artist Savi Savarkar's striking work critiquing caste imagination in the Manusmriti. Used in Inquilabi Nani's story it is a brilliant example of how art can disturb normative ways of understanding

The show was entertaining in the best sense. The music and video coordination by Akhil and Madhur was pacey, melodic and emotionally legible. Even when its entertainment slipped into sentimentality it still made the audience feel the loss of values and encourage to value anew like the use of quranic verses when Gandhian khadi weaver Hakku dies.

If a couple of sections felt overtly oratorical, the production earns them with careful build-up and a quick return to lived detail. The closing minutes of the sketches left the hall audibly moved.

This review would be incomplete without mentioning the ethical architecture the play seeks to bring into the spotlight. In the Gandhian tradition, nationalism is not primarily a question of whether the agents who colonise our lifeworld are foreign or native; it is a question of morality and autonomy. Satyagraha, is, in that frame, a method for reconstituting the self, the neighbourhood, and the polity by refusing domination and cultivating mutual aid. This necessarily means quiet courage for standing up for other's freedom too.

None of this can be achieved by jingoistic sloganeering, so steering clear of that would be a requirement too.

A professional cast in an under-equipped hall appeared before a parched audience ready to soak in stories of composite culture. That night Bharat Mata morphed from being an idol to be defended with aggression and came alive as civic mothers whose imagination was marked by faith in humanity. Five Faces of Mother India offers a calm grammar of belonging against the frenzied circulation of mythic nationhood that alienates.

Once or twice an individual in the audience broke into slogans that resonated with the feared jingoism too and many joined in with the person as if there was no option but to. But some were startled too, and others

reacted with now familiar, fatigued dismay. I hope I am not over estimating the atmosphere in the theatre, but the active spectatorship of the audience in Jawahar Bhawan could indicate a hunger for a civic, inclusive nationalism that many of us experienced not too long ago, and miss sorely. The play made one hopeful that perhaps others may not have forgotten it too because this civic feeling appeared familiar too. And perhaps has a more enduring appeal than we give it credit for.(Courtesy:Scroll.in)

very few months, the nation gets shaken by a horrifying report of a young woman's death in her marital home. Police investigations may cite accident, suicide, or homicide, with reasons ranging from dowry harassment to alleged infidelity. Social media erupts, families accuse. lawyers argue. Yet beneath all the noise, one fact refuses to go away: such incidents unsettle us because they feel very familiar. They are not rare exceptions. They reveal what many homes quietly hide: the reality of how relationships often play out.

The Ordinary Face of Violence

Contrary to the stereotype, most domestic violence cases do not originate in criminal settings. They emerge in households that otherwise appear respectable: middle-class families with jobs, education, and social standing. Violence is often hidden under the surface until it bursts into tragedy.

Why does this happen? The answer lies in the manner in which marriage usually takes place in our society. Often, marriage is pushed upon young people long before they are emotionally ready. By their twenties, marriage is treated like an ultimatum. Love, spoken of in lofty terms, remains unexplained and is usually reduced to attraction, duty, or calculation. Parents, with relief, often remark: "My daughter is married: one responsibility less.'

When marriage begins from such a place, it rarely becomes a union of two free individuals. It becomes an arrangement, a transaction between families. Transactions rarely generate trust; they sow seeds for obligations and resentment. What should have been a conscious partnership becomes a quiet marketplace of duties and demands, and that is a fragile foundation on which to build a lifetime together.

The Endless Shadow of Dowry

Dowry was outlawed more than six decades ago, but its grip remains. The National Crime Records Bureau reported 6.450 dowry deaths in 2022, around 18 women every single day. Uttar Pradesh, where the most recent incident occurred, also tops this list with 2,218 deaths. When greed becomes tradition, no law can restrain it. Behind these numbers lie homes where women face harassment and coercion. And what follows after an FIR is filed? More than 60,000 dowrydeath cases were pending in courts in 2022, and the conviction rate hovered around 33 per cent.

The tradition of dowry is one of the clearest signs of society's values falling apart. How can marriage, which is supposed to bring two lives together, be turned into a financial bargain? How can love or respect for each other grow when a relationship starts with money and demands? Dowry is not just greed; it is woven into families even before birth. Sons are celebrated as "investments," daughters treated as "liabilities," leading even to female foeticide. In such homes, violence is not an accident. It is the logical outcome of values sown generations earlier.

Violence Normalised as Silence

India flaunts its low divorce rates. But what hides beneath the pride? A culture where individuals endure humiliating, sometimes violent relationships. Women are told to put up with things "for the sake of the children." But a home where fear and violence are common can never provide a healthy environment. Children's well-being depends on dignity and safety, not appearances of unity. A broken home can still raise healthy children; a violent home never can. NFHS-5 (2019-21) found that 29 per cent of married women aged 18-49 have faced physical or sexual violence. Many of these injuries are explained away as "accidents." To endure in silence is not strength; it is slavery stretched over decades. Silence does not prevent violence; it feeds it.

The Practice of Courage

Courage cannot be conjured in a single moment. When smaller humiliations - taunts, restrictions, slaps - are tolerated for years, resistance withers. Real protection comes from everyday strength: refusing what demeans, and buildA Trap for Both Genders

Women, of course, continue to endure the harshest consequences of domestic abuse and dowry. But men, too, often face suffering. Sometimes, protection laws are exploited and misused, which can lead to false allegations that cause shame, financial ruin, and even self-harm. According to NCRB data of 2021, more than 70 per cent of suicide victims in India were male. The lesson here is not to set one gender against the other. Just as men have historically misused power, women, too, can misuse it if empowerment is given without wisdom. The solution is not a tug-of-war between sexes but the recognition that both men and women must be raised as conscious beings: neither trapped in the role of con-

troller, nor reduced to that of victim. **Beyond Tradition: Questioning Marriage Itself**

Some of the most pointed critiques strike at the root of tradition. Why must marriage mean that a woman leaves her parents' home? Why can't a husband live with his wife's family, or both maintain their own spaces? These customs were born in an age when men's physical labour sustained families. Today, when both genders can earn equally, why should old arrangements continue?

The tragedy is that society clings to these outdated structures. Girls grow up in ecosystems that see them as parayadhan-someone else's property. She bears the alienation of being raised as transferable, a possession to be handed over. By adulthood, marriage is presented not as a choice but as a cutoff point, like a hotel checkout time. Parents push daughters out by 22 or 24, as if their time has expired. If daughters are so loved, why are families in such haste to send them away?

The Wav Forward

What then can stop the next tragic headline? Laws and police action are vital, but they cannot reach the core of the problem. Real change has to start much earlier, within the individual. Education in dignity and courage: Children must not only pass exams but also learn to recognise society's illusions and stand up to injustice.

Economic independence: Without some measure of selfreliance, women and men alike remain vulnerable to dependence and exploitation.

Support systems: Counselling and safe spaces can assist, but they must guide individuals not just toward escape from pain, but toward self-understanding

Rethinking traditions: Customs like dowry or the expectation that a woman must leave her home after marriage are not sacred truths but relics of another age. They must be questioned and, where detrimental, rejected.

Inner empowerment: The deepest solution does not come from outside. Courage is cultivated, not as a one-day miracle, but as the fruit of inner clarity. This clarity grows as we see through conditioning, question fears and illusions, and live from a centre of self-knowledge. Without that, laws are

paper, and traditions only shift form. A Culture of Consciousness

Domestic violence, dowry, and oppressive marriages are symptoms of a deeper poverty: absence of inner clarity. They do not thrive because of a few 'bad families,' but because society at large runs on fear, desire, and unexamined habits. Outrage after each tragedy has become a ritual, but rituals cannot cure the blindness of the mind. That blindness can be dispelled only by clarity. When men and women see themselves not as roles or possessions but as conscious beings, the basis of exploitation dissolves. Empowerment without wisdom only changes who holds the whip; empowerment with wisdom ensures no whip is ever raised.

Liberation does not begin with outer reform but with seeing rightly. Without clarity, there can be no love; without love, greed is the default, and violence is inevitable. Dowry deaths are gross violence; mental trauma, wasted potential, and ill-raised children are subtle violence. With every new headline, let us be reminded that what shocks us has always been waiting beneath our silence. (Courtesy: The Pioneer)

Nepal internet crackdown part of global trend toward suppressing online freedom

A healthy 21st-century democracy cannot function without a trustworthy online environment

KATHMANDU, Sept 9: Nepal's crackdown on social media companies, which led to protests and police killing at least 19 people, is part of a yearslong decline of internet freedoms around the world as even democracies seek to curtail online speech.

The Himalayan country's government said last week it was blocking several social media platforms including Facebook, X and YouTube because the companies failed to comply with a requirement that they register with the government. The ban was lifted Tuesday a day after the deadly protests.

What's happening in Nepal mirrors "this broader pattern of controlling the narrative and controlling of stories emerging from the ground," said Aditya Vashistha, an assistant professor of information science at Cornell University.


This has happened several times in the neighbouring countries Pakistan and Bangladesh, he said.

"So this is nothing new - in fact, I would say this is taken from the playbook, which is now very established, of trying to control social media narratives," Vashistha

Like neighbouring countries, Nepal's government have been asking the companies to appoint a liaison in the country.

Officials are calling for laws to to monitor social media and ensure both the users and operators are responsible and accountable for what they share. But the move has been criticised as a tool for censorship and punishing opponents who voice their protests online.

"Governments absolutely have a valid interest in seeking to regulate



social media platforms. This is such a daily part of our lives and in our business. And it is certainly reasonable for authorities to sit down and say we want to develop rules for the road," said Kian Vesteinsson, senior research analyst for technology and democracy at the Washington-based nonprofit Freedom House.

"But what we see in Nepal is that wholesale blocks as a means of enforcing a set of rules for social media companies results in wildly disproportionate harms. These measures that were put in place in Nepal (cut) tens of millions of people off from platforms that they used to express themselves, to conduct daily business, to speak with their families, to go to school, to get healthcare information."

It's not just Nepal. Freedom House has found that global internet freedom has declined for the 14th consecutive year in 2024, as governments crack down on dissent and people face arrest for expressing political, social or religious views online.

While China consistently tops the list as the "world's worst environment" for internet freedom, last year Myanmar shared this designa-

tion as well. The organisation did not track Nepal.

In January, Pakistan's lower house of parliament passed a bill that gives the government sweeping controls on social media, including sending users to prison for spreading disinformation.

Calling internet freedom a "pillar of modern democracy," Freedom House said a healthy 21st-century democracy cannot function without a trustworthy online environment, where people can access information and express themselves freely.

Increasingly, though, governments are putting up roadblocks.
Often, regulations are in the name of child safety, cyber crime

name of child safety, cyber crime or fraud, Vesteinsson said, "but unfortunately, a lot of this regulation comes hand in hand with restrictive measures."

In the Nepali law, for instance, "the same provision of this law, directs social media platforms to restrict content relating to child trafficking and human trafficking and labour, a really important issue," he added. "Two bullet points above that, it orders platforms to restrict people from posting anonymously."

Russian glide bomb attack in eastern Ukraine kills at least 21 people

KYIV, Sept 9: A Russian glide bomb struck a village in eastern Ukraine as older people were lined up to receive their pensions on Tuesday, killing at least 21 and wounding nearly two dozen others, Ukrainian President Volodymyr Zelenskyy and a regional official acid

The bomb hit the village of Yarova in the Donetsk region, Zelenskyy said in a post on Telegram.

"Frankly brutal," he said of the attack, urging the international community to make Russia pay economically for its full-scale invasion through additional sanctions.

"The world should not remain silent," Zelenskyy wrote. "The world should not remain inactive. The United States needs a reaction. Europe needs a reaction. The G20



needs a reaction. Strong action is needed so that Russia stops bringing death."

With US-led peace efforts making no headway in recent months, Russia has escalated its aerial barrages of Ukraine. On Sunday, Russia hit the capital, Kyiv, with drones and missiles in the largest aerial attack since the war began on February 24, 2022.

The glide bombs are retrofitted Soviet weapons that have laid waste to eastern Ukraine for months. Some of them now weigh 3,000 pounds (1,360 kilograms), which is six times bigger than when they were first used in battle in 2022

Donetsk Governor Vadym Filashkin said that 21 people were killed and 21 others wounded in the attack, which struck a line of older people waiting to receive their pensions.

"This is not warfare. This is pure terrorism," he wrote on Telegram. Emergency responders were at the scene, he said.

Yarova is located less than 10 kilometres from the front line.

The territory was already occupied by Russia in 2022, but was then liberated by Ukraine's armed forces in a counteroffensive later the same year. (AP)

Thailand's political path shadowed by former Prime Minister Thaksin Shinawatra's dramas

BANGKOK, Sept 9: Thaksin Shinawatra, the billionaire former prime minister of Thailand, remains one of the country's most influential and controversial figures nearly two decades after being ousted in a 2006 military coup. His political journey, marked by unprecedented popularity, a dramatic fall from power, years in self-imposed exile and a high-profile return,

continues to shape Thailand's political landscape.

Thaksin's dramatic path took another turn Tuesday when the Supreme Court ruled that he must serve a one-year prison term for previous convictions on graft and abuse of power charges, after investigating whether officials had mishandled his return to Thailand in 2023 to begin serving the sentences.

Last month, he defied expectations when a court that has historically leaned against him and his political machine acquitted him of royal defamation, an offence that could have sent him to prison for up to 15

Despite powerful enemies in the Thai establishment and criminal convictions for corruption, he had avoided prison by going into exile after his ouster. His return had seemed to signal an accommodation with his opponents

He was insistent on maintaining a high public profile and was seen as the real power directing the government that was formed as he returned, especially when his daughter, Paetongtarn Shinawatra, became prime minister last year. It appeared to keep his old enmities alive and embroiled him in legal challenges

from those wishing to curb his influence. **Thaksin's beginnings**

The Shinawatra family is prominent in the northern city of Chiang Mai, where Thaksin was born to a mercantile family in 1949. After a career in public service as a police colonel, Thaksin became a business entrepreneur in the late 1970s. He built a telecommunications empire starting with Advanced Info Systems, an early mobile phone service provider and the primary source of his fortune.

He entered politics in 1994, holding Cabinet posts before establishing the Thai Rak Thai Party in 1998. Using his fortune to build a nationwide political machine, he promoted populist policies that resonated with lower-income citizens, especially in the country-

His platform promised to spread economic growth and bridge the wealth gap, with signature policies including universal healthcare and village development funds. This led to landslide victories for his party in 2001 and 2005, making him the first elected Thai prime minister to complete a four-year term and the country's longest-serving democratically elected

Powerful foes

toral support rocked Thailand's established political order. This earned him powerful enemies among conservative forces, including the army and the courts, which saw him as a threat to the monarchy, the bedrock of Thai identity, as well as to their own influence.

He also faced criticism for his imperious CEO-style governance, intolerance of criticism, especially from the media, and failure to distance his business interests from government policy. His administration was also blamed for setting off a persistent Muslim insurgency in Thailand's southern provinces and for what human rights advocates said were more than 2,000 extrajudicial killings during his war on drugs.

His second term was cut short by a military coup in 2006 while he was abroad. Opponents accused him of corruption, abuse of power, and disrespecting then-King Bhumibol Adulyadej, and hounded him with legal cases that he characterised as politically motivated. Thaksin's ouster triggered nearly two decades of deep political polarisation, pitting his supporters against opponents, including better-off urban dwellers, ardent royalists and the military. He briefly returned in 2008 to face charges but skipped bail and fled abroad again, commencing a self-imposed exile lasting over a decade.

Leading from overseas

Despite his physical absence, Thaksin remained a beloved and influential figure among his followers, whom he encouraged remotely. Parties formed from the ashes of his Thai Rak Thai Party and, still under his influence, consistently won elections but just as consistently were driven from office by legal challenges in courts hostile to him and destabilising street protests. His supporters, the "Red Shirts," engaged in militant street actions, countering "Yellow Shirt" royalists, with both sides responsible for street violence.

His sister, Yingluck Shinawatra, continued the family's legacy, leading the Pheu Thai Party to victory in 2011 and becoming Thailand's first female prime minister. Her government's proposed amnesty for Thaksin triggered protests, leading to another military coup in 2014, and driving Yingluck into exile as well. While in exile, Thaksin, who had his Thai passport revoked, obtained another from Montenegro through investment and spent significant time in Dubai. He also purchased and sold the Manchester City Football Club and invested in mining in Africa. Thaksin's return became possible after the progressive Move Forward Party's victory in 2023 rattled the establishment that had so abhorred him. This led to what many called a "selfserving deal" between Thaksin and his former conservative foes, a move that alienated many supporters even as it returned Pheu Thai to power while keeping Move Forward out of government. Activist group says drone hit Gaza aid boat in Tunisia

TUNIS (TUNISIA), Sept 9: An international activist group seeking to deliver aid to Gaza on a flotilla savs one of its boats was hit by what it believes was a drone while docked in Tunisia. Tunisian authorities denied a drone was involved, and said they are investigating a fire in a life jacket aboard the boat. The Global Sumud Flotilla said in a statement overnight that a vessel known as the "Family Boat" and travelling under a Portuguese flag was struck by a drone, but that no one aboard was hurt. Footage posted on the group's social media showed a flash of light landing on one of the boats and setting off what appears to be a fire. The group, whose flotilla was scheduled to leave Tunisia on Wednesday, is expected to give a news conference in Tunis later Tuesday about what happened. It said the incident would not derail its mission to de-

US, European officials meet to discuss new sanctions on Russia

WASHINGTON, Sept 9: US and European officials met at US Treasury Department on Monday evening to discuss various forms of economic pressure to exert on Russia, including new sanctions and tariffs on Russian oil purchases, a person familiar with the

meeting told The Associated Press.

The person, who spoke on the condition of anonymity to discuss the meeting, said US officials emphasised to their European counterparts that President Donald Trump is willing to exert significant actions to end the war but expects full cooperation from European partners in whatever actions are taken.

The meeting, which lasted less than two hours, highlighted tariff actions, the need for collective action on whatever is determined on sanctions, and how to manage Russian sovereign assets that are still immobilised largely in Europe, among other issues.

At least 60 people killed in eastern Congo

GOMA, Sept 9: At least 60 people have been killed in an overnight attack by Islamic-State-affiliated rebel group in eastern Congo, an official said.

The attack was reportedly carried by the Allied Democratic Force in Ntoyo, North Kivu, after residents gathered at a burial.

"The ADF attack caused around 60 deaths, but the final toll will be given later this evening because the territory has just deployed services to the area to count the number of beheaded people," Col Alain Kiwewa, local administrator of the Lubero territory where Ntoyo is located, told The Associated Press.

"There were about 10 of them. I saw machetes. They told people to gather in one place and started cutting them. I listened to people screaming and I fainted," a survivor who was present at the burial told the AP. She requested anonymity out of fear of reprisal. (AP)

BRICS nations hate each other, act like vampires in trade with US: Trump aide Navarro

TOKYO, Sept 9: Global shares traded mixed Tuesday as eyes turned to US data reports set for release later in the week that are likely to impact whether the Federal Reservecus interest rates at its next meeting.

France's CAC 40 rose 0.1% in early trading to 7,742.97, while the German DAX fell nearly 0.5% to 23,697.43. Britain's FTSE 100 gained 0.1% to 9,232.78. US shares were set to drift only moderately with Dow futures little changed at 45,593.00. S&P 500 futures rose 0.1% to 6,511.75.

In Asia, Japan's benchmark Nikkei 225 erased earlier gains to finish 0.4% lower at 43,459.29, as political uncertainty continued after Prime Minister Shigeru Ishiba said over the weekend that he planned to step down. Who will replace him is still uncertain and may take weeks to decide. The benchmark had momentarily surpassed the 44,000 mark.

Anticipation over one of the likely candidates, Sanae Takaichi, a hawkish legislator, sent defence issues higher in Tokyo trading.

Mitsubishi Heavy Industries rose 0.3%, IHI added 1.0% and Kawasaki Heavy 0.4%. Veteran ruling party legislator Toshimitsu Motegi has indicated he wants to run, and other expected contenders include Farm Minister Shinjiro Koizumi and Chief Cabinet Secretary Yoshimasa Hayashi.

All are members of the ruling Liberal Democratic Party, which will need coalition partners to stay in power.

Australia's S&P/ASX 200 declined 0.6% to 8,793.60. South Korea's Kospi climbed 1.3% to 3,260.05. Hong Kong's Hang Seng surged 1.2% to 25,938.13, while the Shanghai Composite fell 0.5% to 3,807.29. The mixed trading followed a stronger opening in Asia.

"Asian markets opened Tuesday with momentum, riding Wall Street's conviction that Fed cuts are no longer a question of if but how many. Nearly three reductions are now being priced before year-end. That expectation is washing through global markets like a spring tide," said Stephen Innes, managing partner at SPI Asset Management.

Updates are coming later this week on the US economy and inflation, which could alter expectations among traders, who at the moment are unanimously forecasting the Fed will cut its main interest rate for the first time this year at its meeting two Wednesdays from now.

The Fed has been more worried about the potential of inflation worsening because of President Donald Trump's tariffs than about the job market. But a slew of recent reports showing the US job market is slowing may be changing minds.

On Tuesday, the US government will release pre-

liminary revisions for job growth numbers reported through March, and it could show that hiring was weaker than earlier thought. Reports on inflation will follow on Wednesday and Thursday.

In energy trading, benchmark US crude gained 85

cents to \$63.11 a barrel. Brent crude, the international

standard, added 87 cents to \$66.89 a barrel.

In currency trading, the US dollar slipped to 146.68

Japanese yen from 147.51 yen. The euro cost \$1.1757, down from \$1.1765. Gold has been rising as a safe investment, surpassing the \$3,600 per ounce mark. Gold has been gaining on the back of a falling dollar and anticipation for the Fed's rate cut. (AP)



NEW YORK/WASHINGTON, Sept 9: The BRICS alliance will not last since the member nations "all hate each other", White House trade adviser Peter Navarro has said, likening their trade practices to "vampires" exploiting the United States.

BRICS, originally comprising Brazil, Russia, India, China, and South Africa, expanded in 2024 to include Egypt, Ethiopia, Iran, and the United Arab Emirates, with Indonesia joining in 2025.

"I don't see how the BRICS alliance stays to-

gether since historically they all hate each other and kill each other," Navarro said in an interview with the 'Real America's Voice' show on Monday. In a diatribe targeting the BRICS nations, he

and the "bottom line" is that none of the countries in the grouping can "survive if they don't sell to the United States. And when they sell to the United States, their exports, they're like vampires sucking our blood dry with their unfair trade practices".

Navarro, who has been ranting against India over its import of Russian oil and high tariffs, said the country has been at war with China for decades.

In a sarcastic remark, he said, "And I just remembered, yeah, it was China that gave Pakistan a nuclear bomb. You got ships flying around the Indian Ocean now with Chinese flags. (Prime Minister Narendra) Modi, see how you kind of work that out."

He also claimed that Russia is in "bed with Chino"

Navarro claimed Beijing has its sights on the Russian port of Vladivostok and is already "colonising Siberia, which is the biggest land mass of the Russian semi-empire" through "massive illegal immigration".

"So good luck with that, Putin," he said.

On Brazil, Navarro said the country's economy is "going down the tubes" because of President Luiz Inácio Lula da Silva's "socialist policies" while "they keep the real leader of that country in a cell", a reference to former president Jair Bolsonaro, who is currently under house arrest and is on trial for allegedly plotting a coup following his loss in the 2022 presidential election.

In July, President Donald Trump criticised Brazilian officials for their "persecution" of Bolsonaro and said the Brazilian government has "unjustly charged Bolsonaro with multiple crimes". For this, he imposed an additional 40 per cent levy on Brazil.

Earlier, in a post on X, Navarro said India has the largest population in the world and "all it can do is manage a few hundred thousand X propagandists to jerk around a poll? Too funny. America: look at how foreign interests use our social media to advance their agenda."

In the interview, Navarro warned that India "must come around" at some point on trade negotiations with the US, and if it doesn't, New Delhi is laying down with Russia and China and

that "won't end well" for India.

He said the Indian government has taken of-

fence to his describing India as the "Maharajah" of tariffs.

"But it's absolutely true. They have the highest tariffs in any major country in the world

against the United States. We got to deal with

that," Navarro said.

He claimed India never bought oil from Moscow before Russia invaded Ukraine, "except for like little tiny drops of it. And then they go into this mode of profiteering with Russian refiners coming on to Indian soil and profiteering," and American taxpayers end up having to

send more money for the conflict.

Listing the "great" trade deals that the US has inked with the European Union, Japan, South Korea, the Philippines and Indonesia, Navarro said "all these countries are working very closely with us" because they realise that they've been taking too much advantage of the US and also because they need American mar-

On additional sanctions on China, which is the largest purchaser of Russian oil, Navarro said Washington is walking a "fine line" and again urged India to stop importing Russian oil.

"I think that what's got to happen is India's got to stop buying Russian oil. That's going to be good for the whole peace; the road to peace partly runs through New Delhi. Europe certainly has to stop buying Russian oil... with China, we got over 50% tariffs on them, and we're doing the best we can in terms of negotiating to protect the American people without hurting the American people.

"And that's the art of diplomacy that we've got going on. And you just got to trust in Trump," he said. (PTI)

HRA demands removal of health minister after

ITANAGAR, Sept 9: The Human Rights of Arunachal (HRA) has urged the Chief Minister of Arunachal Pradesh to immediately remove Health Minister Biyuram Wahge and hold hospital authorities accountable following the death of 22-year-old Bengia Ama Gora at TRIHMS, Naharlagun, an official statement said.

In the letter addressed to the chief minister, Dr Kipa Kaha, Chairman of HRA, expressed concern that the patient's death was the result of grave negligence by the medical staff at TRIHMS.

The organisation has demanded the termination of the hospital's Director, Superintendent, and doctors responsible for the incident, in addition to calling for a time-

bound and transparent inquiry. HRA has also called for compensation of ₹1 crore to the deceased's family to ensure their livelihood and has emphasized the need for urgent reforms in healthcare infrastructure and patient

The statement further criticized the assurance given by the Health Minister to form an inquiry committee, calling it a delay tactic that undermines the demand for justice.

Highlighting systemic issues, the HRA noted that despite substantial funds allocated to the health sector under the leadership of chief minister Pema Khandu, citizens continue to face poor healthcare facilities and lack of accountability.

'Milestone for wildlife research brant pastoral traditions speaks ITANAGAR, Sept 9: Deep in

the high-altitude wilderness of Arunachal Pradesh, a landmark wildlife survey has thrown up rare treasures of nature -among them, the first-ever photographic proof of the mysterious and little-seen Pallas's cat. The survey, conducted by

WWF-India with the support of the state Forest Department and local communities, also recorded the presence of snow leopard, common leopard, clouded leopard, leopard cat, and marbled cat above 4,200 metre, indicating the landscape's unique wildcat diver-

"The discovery of the Pallas's cat in Arunachal Pradesh is a milestone for wildlife research in the eastern Hi-malayas," said the state's Principal Chief Conservator of Forest Nyilyang Tam.

A total of 136 camera traps were set up at 83 locations across 2,000 sq km of rugged high-altitude rangelands in the West Kameng and Tawang districts under the project funded by the UK government through the Darwin Initiative, WWF-India's director of Assam and Arunachal office, Archita Baruah Bhattacharyaa, said.

The survey documented the highest elevation records for several species, such as the common leopard at 4,600 metre, the clouded leopard at 4,650 metre, the marbled cat at 4.326 metre, the Himalayan wood owl at 4,194 metre, and the grey-headed flying squirrel at 4,506 metre, she said.

The elevation records were the highest in India to date and may exceed previously known global limits, she added.

The Pallas's cat was recorded slightly lower than the absolute global maximum of 5,050 metres. This coldadapted wild cat is one of the most elusive, rarely photographed and therefore remains one of the least studied feline species.

documentation Arunachal Pradesh significantly extends the known distribution of the species in the eastern Himalaya, adding to earlier confirmed records from Sikkim, Bhutan, and eastern

WWF-India's head for science and conservation of the Himalayas Programme, Rishi Kumar Sharma, said the discovery of Pallas's cat in Arunachal Pradesh at nearly 5,000 metres is a powerful reminder of how little is still known about life in the high Himalayas.

"That a landscape can support snow leopards, clouded leopards, marbled cats, and now Pallas's cat alongside vito its extraordinary richness and resilience. These findings highlight why community-led conservation, grounded in science and local knowledge, is indispensable for securing the future of our fragile rangelands," he said.

The survey involved meticulous planning and days of trekking through remote and high-altitude areas. The camera traps were kept active for over eight months, often in extreme weather and remote, difficultto-access terrain, he added.

In a rare behavioural observation, the camera traps also documented a snow leopard and a common leopard scentmarking at the same location. offering fresh insight into how these big cats share fragile alpine habitats.

The survey also captured images of the Brokpa herding community and their livestock. underscoring centuries-old pas toral traditions that have enabled coexistence between people and wildlife in these high-altitude rangelands.

Tam, the PCCF, said the active participation of herders and villagers in the survey demonstrates that conservation, traditional knowledge, and their livelihoods can go hand in hand in protecting the fragile mountain ecosystems. (PTI)

While leaving from Delhi for Himachal Pradesh and Punjab earlier in the day to review the situation in the wake of floods and landslides, PM Modi wrote on X, "The Government of India stands shoulder to shoulder with those affected in this tragic hour.'

Punjab is currently facing one of its worst flood disasters in decades. The floods are a result of swollen rivers the Sutlej, Beas, and Ravi along with seasonal rivulets caused by heavy rainfall in their catchment areas in Himachal Pradesh and Jammu & Kashmir. (PTI)

PM announces ₹ 1,500 cr immediate relief for disaster-hit Himachal

SHIMLA/DHARAMSHALA (HP), Sept 9: Prime Minister Narendra Modi on Tuesday announced an immediate relief of Rs 1,500 crore for rain-affected Himachal Pradesh.

Modi, who took stock of the flood and landslides situation in the state, also announced ₹ 2 lakh ex-gratia for the next of kin of the dead and ₹ 50,000 for the injured.

He first conducted an aerial survey of affected areas and then held a meeting in Kangra to review the relief and rehabilitation measures undertaken as well as assess the damage

In the meeting with Chief Minister Sukhvinder Singh Sukhu, Governor Shiv Pratap Shukla, BJP leaders, affected families and people engaged in rescue services in Kangra, Modi assured all help for restoration and rebuilding of infrastructure in the affected areas.

The financial assistance of ₹ 1,500 crore will be the advance release of the second instalment of SDRF and PM Kisan Samman

Modi asked for a multi-dimensional view to be taken to get the entire region and people back on its feet. These would be done through multiple ways, like rebuilding homes through PM Awas Yojana, restoration of national highways, rebuilding schools, provision of relief under PMNRF along with release of mini kits for livestock.

To ensure uninterrupted education, schools will be able to report and geotag damages, enabling timely assistance under the Samagra Shiksha Abhiyan.

Construction of recharge structures for water harvesting to help collect and store rainwater will be



done. These efforts will improve groundwater levels and support better water management.

The Centre has already sent inter-ministerial teams to Himachal Pradesh to assess the extent of damage, and based on their detailed report further assistance will be considered.

Modi also met families affected by the calamity. He expressed condolences and deep sorrow to those who lost their relatives. A photograph of the prime minister holding 11-month-old Neetika, the lone survivor in her family, has also gone viral on the internet.

Modi said that the Centre will work closely with the Himachal Pradesh government at this difficult time and extend all possible assistance.

Recognizing the critical need to support the agricultural community, additional assistance will be provided specifically targeted at farmers who currently lack power connections, he said and added that geotagging of damaged houses

will be done under the Under the PM Awas Yojana to assess the damage accurately and ensure faster delivery of aid.

He said all assistance under disaster management rules are being made including advance disbursements to the states. He appreciated the efforts of the personnel of NDRF, SDRF, Army, state administration and other service-oriented organisations in relief and response

The central government will further review the assessment based on the memorandum of the state as well as the report of the central teams, he said.

Modi acknowledged the gravity of the situation and assured that the Centre will make all efforts to address the situation. Earlier, he also watched a pres-

entation on the prevailing situation in Himachal Pradesh state after cloudbursts, flash floods and landslides triggered by heavy rains wreaked havoc in the state and was briefed about the same. (PTI)

2008 MALEGAON BLAST

Victims move HC against acquittal of Pragya Thakur, 6 others



MUMBAI, Sept 9: Six family members of people who died in the 2008 Malegaon bomb blast have moved the Bombay High Court, challenging a special court judgment acquitting the seven accused in the case, including former BJP MP Pragya Singh Thakur and Lt Col Prasad Purohit.

The appeal claimed faulty investigation or some defects in the probe cannot be the ground for acquitting the accused. It also contended that a conspiracy is hatched in secrecy and hence there cannot be a direct

The petitioners claimed the order passed by the special NIA court on July 31 acquitting the seven accused was wrong and bad in law and hence deserves to be

The appeal, filed on Monday by Nisar Ahmed Sayyed Bilal and five others through their advocate Mateen Shaikh, sought the HC to quash the special court judgment

As per the HC website, the appeal is likely to come up for hearing before a division bench headed by Jus-

tice A S Gadkari on September 15. An explosive device strapped to a motorcycle went off near a mosque in Malegaon town, located about 200 km from Mumbai in Maharashtra's Nashik district, on September 29, 2008, killing six persons and injuring 101 others.

The claim said the trial court judge should not act as a "postman or mute spectator" in a criminal trial. When the prosecution failed to elicit facts, the trial court can ask questions and/or summon witnesses, it

"The trial court has unfortunately acted as a mere post-office and allowed a deficient prosecution to benefit the accused," the appeal said.

It also pointed out that the previous special public prosecutor, Rohini Salian, had alleged pressure from the NIA to go slow in the case against the accused

after which a new prosecutor was appointed. The appeal also raised concerns over the manner in which the National Investigation Agency (NIA) conducted the probe and trial in the case and sought for

the accused to be convicted. The state Anti-Terrorism Squad (ATS), by arresting the seven persons, unearthed a large conspiracy and since then there has been no blast in areas populated by the minority community, the appeal said.

It claimed the NIA, after taking over the case, diluted the allegations against the accused persons.

The appeal further claimed the special court had erred in coming to the conclusion that the motorcycle used in the blast was not owned by Thakur and the RDX used was not procured by Purohit.

There was enough evidence to show the accused persons had hatched the conspiracy to carry out the blast and the special court had erred in holding that there was only strong suspicion against the accused but not sufficient evidence to convict them, it said.

The appeal said a conspiracy is hatched in secrecy and hence there cannot be any direct evidence of the

The special court had in its judgment said mere suspicion cannot replace real proof and there was no cogent or reliable evidence to warrant conviction.

Special judge A K Lahoti, presiding over the NIA court, had said there was no "reliable and cogent evidence" against the accused that proved the case bevond reasonable doubt.

The prosecution's case was that the blast was carried out by right wing extremists with an intention to terrorise the Muslim community in the communally sensitive Malegaon town.

The NIA court had in its judgment flagged several loopholes in the prosecution's case and the investigation carried out, and said the accused persons deserved the benefit of doubt

Besides Thakur and Purohit, the accused included Major Ramesh Upadhyay (retired), Ajay Rahirkar, Sudhakar Dwivedi, Sudhakar Chaturvedi and Sameer

Air India cancels four flights on Delhi-Kathmandu route

NEW DELHI, Sept 9: Air India on Tuesday cancelled four flights between Delhi and Kathmandu amid massive anti-government protests in the neighbouring nation.

IndiGo and Nepal Airlines also cancelled their flights from the national capital to Kathmandu on Tuesday as the Tribhuvan International Airport in the Nepal's capital has been temporarily closed.

A source said one of the flights of Air India returned to the national capital on Tuesday as smoke was noticed at the Kathmandu airport during final approach of the aircraft.

"In view of the current situation prevailing in Kathmandu, the following flights AI2231/2232, AI2219/2220, AI217/218 and AI211/212 operating on the Delhi-Kathmandu-Delhi route have been cancelled today. We are closely monitoring the situation and will share further updates," Air India said in a statement on Tuesday.

Air India operates six flights a day between Delhi and Kath-

The decisions assume significance with assembly polls due to be held in the state in a few

A meeting of the state cabinet, chaired by Chief Minister Nitish garding increasing the honorariums of 1.20 lakh anganwadi workers and helpers. With this hike, anganwadi work-

ers will get ₹ 9,000 per month, up from ₹ 7,000, and helpers will receive ₹ 4,000 instead of ₹ 4,500. The government will spend an

additional ₹ 345.19 crore for the hike, effective from September 1. The cabinet also approved the

Revenue and Land Reforms Department's proposal for the creation of 3,303 posts of 'revenue staffers' The decision to create the new

posts was taken keeping in view the increasing number of 'jamabandi' cases, relating to the record-Additional Chief of-right, Secretary (Cabinet Secretariat) Arvind Kumar Chaudhary said.

The cabinet also sanctioned ₹ 280.60 crore for the installation of CCTV cameras in 176 new police stations and maintenance of already installed CCTV cameras, he said. The cabinet gave its nod to spend ₹ 50 crore from the Bihar Contingency Fund for the construction of marriage halls in a phased manner in all 8,053 panchayats, he added. Approval was also given to the of stray cows. (PTI)

50 killed, crops on more than 5 lakh hectares damaged in Marathwada this monsoon

CHHATRAPATI SAMBHAJINAGAR, Sept 9: At least 50 people lost their lives and crops on more than five lakh hectares of land were damaged due to heavy rainfall in Marathwada this monsoon, with Nanded emerging as the worst-hit district, an official said on Tuesday.

As per a report shared by the divisional commissioner's office, the region comprising eight districts received 606.3 mm of rainfall since June , which is 8.7 per cent above the normal expected rainfall.

Marathwada consists of Chhatrapati Sambhaiinagar, Jalna, Beed, Latur, Nanded, Dharashiv, Hingoli and Parbhani. Nanded, which was hit by floods last month, received 21.2 per cent more than the average expected rainfall. The region reported 50 deaths, the highest 18 were recorded in Nanded, followed by 11 in Chhatrapati Sambhajinagar, six each in Beed and Hingoli, five in Parbhani and three in Jalna, the report stated.

At least 1,049 animals died due to heavy rainfall, while 3,388 houses suffered damage, it said.

According to the report, crops on more than 5.62 lakh hectares of land, belonging to 15.78 lakh farmers, were damaged due to rains in the last three months. Nanded district was the most affected, with crop losses on 2.62 lakh hectares, while in Hingoli, crops on 1.24 lakh hectares of land were affected.

The administration has completed 45 per cent of the crop loss survey, the report stated. (PTI)

ED questions BJP worker who filed petition in HC questioning Rahul Gandhi's citizenship

NEW DELHI, Sept 9: A Karnataka BJP worker, who had petitioned the Allahabad High Court claiming that Congress leader Rahul Gandhi is a British citizen, deposed before the Enforcement Directorate on Tuesday where his statement was recorded, official sources said.

S Vignesh Shishir told reporters before entering the office of the federal probe agency in central Delhi that he has been summoned under section 37 of the Foreign Exchange Management Act (FEMA) with regard to the said investiga-

Shishir was asked to submit certain documents and "evidence" he had claimed to have been possessing. He has been asked certain questions and his statement has been recorded under the FEMA, agency sources said.

Nagaland pre-service teachers raises alarm over recruitment irregularities, demands immediate action

vice teachers in Nagaland on Tuesday raised concerns over the alleged irregularities and lack of transparency in the recruitment of primary teachers in the state.

The All Nagaland Pre-Service Teachers Association (ANPSTA) alleged that over the past decade, more than 1,000 primary teacher posts remained unadvertised, though appointments

have continued through questionable practices. An Education Department official said that the matter is being examined as the pupilteacher ratio in the state is already 7:1, higher than the national ratio.

The issue will be looked into under the ongoing process of rationalisation of teachers, the official said.

In a press conference, the association's representatives presented findings claimed to have been obtained through multiple Right to Information (RTI) applications, which exposed discrepancies in the recruitment data.

According to the RTI responses, 401 primary teachers were appointed between 2016 and the present time. However, upon careful scrutiny, the association found that many names were repeated or missing, bringing the total down to 397 confirmed appointments, the ANPSTA claimed

Only two posts were advertised during this entire period - one in Mon district in 2020 and another in Wokha district in 2021 - leaving 395 posts apparently filled through backdoor appointments without any public notice or fair process, the association alleged.

The association also alleged that 65 of these appointed teachers lack the mandatory teacher qualifications. The ANPSTA criticised the education department for failing to provide proper justification or accurate data in response to RTI queries. They argued that this opaque system endangers the quality of education and constitutes a "time bomb" for the future generation.



Expressing frustration at the government's inaction despite repeated appeals, the association demanded an immediate open recruitment process for the 1,168 pending primary teacher

They referenced a Supreme Court directive from November 2023, stating that recruitment must be conducted exclusively for qualified Diploma in Elementary Education (D.El.Ed) candidates, rejecting ECCE or Montessori qualifications as valid.

Highlighting the larger impact, the association said this situation reflects not only a failure in public administration but also contributes significantly to rising unemployment among trained teaching professionals in Nagaland.

Many qualified candidates, especially DLA trainees, are now at risk of becoming overage or having their careers permanently derailed due to inaction.

A memorandum outlining these demands and evidence was officially submitted during the day to the Principal Director of School Education, the association said, adding that they would wait for three weeks and resort to a democratic course of action if the department does not positively respond. (PTI)

NSF wants stringent documentation for ILP

DIMAPUR, Sept 9: The inner line regulation commission (ILRC) of the Naga Students' Federation (NSF) on Tuesday stressed that the very essence of the inner line mechanism lies in maintaining stringent documentation for all non-indigenous individuals entering or residing in Nagaland.

It also reiterated that no waiver of ILP fee, whether long-term or short-term, should be granted under any circumstances.

"Even short-term visitors must obtain and carry a valid ILP document, without exception," the ILRC said in a release. The ILRC also reaffirmed its commitment to constructive collaboration with the state government and district authorities to ensure that the inner line system, strengthened by Article 371(A), is uniformly enforced.

"In doing so, we must preserve its original purpose of safeguardof the Naga people, while adapting resiliently to contemporary chal-

lenges," it stressed. Further, aligned with the very spirit of the Bengal Eastern Frontier Regulation (BEFR) 1873, where the executive phrase "inner line pass" was originally used, the ILRC urged all district administrators and government offices to revert to the original nomenclature "inner line pass", not "inner line

Chakma language words to be included in Google translation platform: Tripura minister

AGARTALA, **Sept 9:** The Tripura government on Tuesday decided to include words of the Chakma language in the Google translation platform so that the content in the tribal language can be converted into English, Hindi and Bengali, a state minister said.

Agriculture Minister Ratan Lal Nath said the government also decided to observe Chakma language and script day on August 7 from next year onwards in a bid to protect the culture of

the indigenous people in the state. He said an advisory committee for the development of the Chakma language took these de-

cisions in a meeting during the day. "The panel decided to include words of the Chakma language in the Google translation platform so that the content in the tribal language can be converted into English, Hindi and Bengali," the minister said.

For this purpose, the committee has already collected 50,000 words of the Chakma language, and 50,000 more will be identified shortly, he said.

Kokborok, the mother tongue of the Tripuri tribe, has already been introduced in the Google translation platform.

According to the 2011 census, the northeastern state has 79,000 people belonging to the Chakma community, one of the 19 tribes in the state, and the population of this group has now grown to around 1,20,000, he said.

The Chakma language is being taught in 123 government schools, in which over 4,000 students from classes I to VIII are studying, the minister said.

"A total of 172 Chakma-speaking teachers are engaged in these schools. The advisory committee also decided to constitute nine subcommittees for the overall development of the language," he said. He also emphasised the development of the languages of all the tribes living in the northeastern state. (PTI)

LeBron James uses basketball diplomacy to bridge US-China tensions

HONG KONG, Sept 9: At a time of tensions and tariffs, LeBron James is harnessing basketball diplomacy as a way of finding some common ground for people in the U.S. and China.

The NBA legend wrote a rare op-ed in Chinese state media, following his first visit to China since 2019, saying: "Basketball is not only a sport, but also a bridge that connects us.

The op-ed appeared in Monday's edition of the People's Daily newspaper and got the attention of the Hong Kong-based South China Morning Post, which reported: "It is rare for the mouthpiece of China's ruling Communist Party to run articles carrying the byline of foreign sports stars. It is more common for international sporting heroes to connect with fans in China via Chinese social media.

James was in China ahead of two NBA pre-season games next month in Macao between the Phoenix Suns and the Brooklyn Nets, part of the league's efforts to

rebuild the brand in greater China. The games on Oct. 10 and 12 will take place more than five years after the league was effectively banned for a while in China over NBA Commissioner Adam Silver's decision not to punish Daryl Morey in 2019 for tweeting support of anti-government protesters in Hong Kong.

The geopolitical rift started when Morey, then the general manager of the Houston Rockets and now GM of the Philadelphia 76ers, tweeted support for protesters while the Nets and Los Angeles Lakers were in China.

The tweet was deleted quickly, but the fallout lasted years. No NBA games were shown in China for a year, and broadcasts of games only started returning regularly in 2022. There's been a series of moves toward a return to normalcy between China and the league, including a visit by Golden State's Stephen Curry and Sacramento's De'Aaron Fox last year that drew enormous crowds. Curry returned for a visit last month. (AP)

Italy's 5-4 victory over Israel in a World Cup qualifier was, Gattuso acknowledged, "the craziest game I've been involved with as a

"But that's my fault and not down to the players," Gattuso added. "If we want to play in a certain way, we need to get better at this. We were crazy to systematically go on the attack. That's what Israel was waiting for. They hit us on the counter every time.

Italy helped Israel with two own goals for the opponent, and Monday's game wasn't decided until Sandro Tonali's curled winner in stoppage time.

Still, it was a victory and three more points after Italy also scored a handful of goals in Gattuso's debut in charge, a 5-0 win over Estonia on Friday.

Italy on course for another playoffThe results meant that Italy leapfrogged Israel into second place in their qualifying group. Sharath hopes to shape India's first TT Olympic medallist by 2036 with some help from German football

NEW DELHI, Sept 9: Recently-retired Indian table tennis great A Sharath Kamal has given himself 11 years to produce the country's first Olympic medallist in the racket sport and German football club Borussia Dortmund could end up being his unlikely ally in pursuit of this path-breaking dream.

In his decorated two decade old career, the 43-year-old won plenty of medals at the Commonwealth Games and helped India end their barren run at the Asian Games but despite five Olympic appearances, he and the rest of his teammates could not get near the coveted podium.

Having retired from the sport in March, Sharath remains a man with strong purpose and clear vision. He is setting up a High Performance Centre (HPC) close to his hometown Chennai, a world class facility backed by the Tamil



aim to produce an Olympic medallist.

"I'm looking at my main goal at this very moment is setting up the High Performance Centre, making it run and hopefully what I couldn't achieve in my career of you know the Olympic medal, I hope I can live the dream through

the young talents that are there here and I can support them in their career.

"Yeah. So we're looking at 2036 Olympic Games. Hopefully it happens in India. That would be the best. Even if it doesn't happen, still giving myself 11 years time," said Sharath in an interview to PTI on the sidelines of the changes on in terms of talent

National Ranking Table Tennis event here on Tuesday.

Sharath, who is busy with administrative roles at the International Table Tennis Federation (ITTF) and the Indian Olympic Association (IOA), will be the sporting director of the HPC while full-time coaches are being sought from Germany, and sport's powerhouses China and Japan.

Sharath also revealed that he is in talks with top German football club Borussia Dortmund to help his HPC in talent identification. The facility will be up and running by October.

"I need a lot of help from abroad also. So I have been talking to the German Table Tennis Federation where I have played for a long time and also to a couple of football clubs (including Borussia Dortmund) in Europe where we can have some exidentification. Because talent identification is something I feel we don't do very robustly.

"I haven't explored so much into the Indian cricket side, but European football I do know that they have a fantastic structure in terms of talent identification and getting them," said Sharath.

The HPC will be looking to work with the talent in the 11-15 age bracket so that they have enough time to ready for the 2036

Olympics. "So it's almost like two and a half Olympic cycles where we can identify talent between the age of 11 to 15 and grow with them and groom them at the same time. These days there's a lot of sports science advancement that's been available and which I feel

like we can make use of it." Sharath and his team is looking to groom the players in three phases. (PTI)


