### Prohibitory orders enforced in Kokrajhar ahead of BTC polls

GOSSAIGAON, Sept 8: Prohibitory orders have been enforced across Kokrajhar district by District Magistrate Masanda M Pertin in view of the forthcoming Bodoland Territorial Council (BTC) Election 2025.

The orders have been issued under Section 163 of the Bharatiya Nyaya Sanhita (BNSS), 2023 to ensure peace, security, and the smooth conduct of the elections.

As per the order, carrying licensed arms is banned throughout the district until the completion of the electoral process.

Exemptions are provided only to police personnel, army and paramilitary forces on election duty, and sportsmen affiliated with the National Rifle Association of India participating in recognised sporting events, subject to production of valid documents.

The District Magistrate's directive also prohibits unauthorised public meetings, rallies, and pro-

The use of vehicles for electioneering, human rallies without prior approval, organising fairs or melas without permission, use of loudspeakers without clearance, carrying weapons or explosives, and torchlight processions have also been restricted

The orders will remain in force until further notice. Executive Magistrates, police officials, and security (CONTD. ON PAGE-2)

#### CIL mulls setting up data centres in decommissioned mines to boost digital infra, sustainability KOLKATA, Sept 8: Coal India Limited (CIL) was tisation, artificial intelligence, IoT, 5G rollout and

evaluating the potential of establishing data centres in its decommissioned mines, leveraging existing infrastructure to meet the country's growing demand for digital capacity while advancing sustainable development. The state-owned miner had already taken steps for a comprehensive feasibility study by consultants, officials told PTI.

The exercise will include a conceptual study of setting up data centres in India with a special focus on their viability within decommissioned CIL mines.

The study will cover site assessments, preparation of a comparison matrix for evaluating identified locations, and a Preliminary Feasibility Report (PFR) for the most suitable site. Four sites across CIL subsidiaries — Umrer (WCL), Saraipali in Korba (SECL), Himgir Rampur near Jharsuguda (MCL), and Nigahi (NCL) — have been shortlisted.

The scope of work involved a detailed analysis of the data centre industry in India and globally, classification of models such as hyperscale, colocation and edge facilities, and key demand drivers including digicloud adoption," a source said.

It will also assess demand forecasts, sectoral and regional trends, competitive landscape, customer segments, policy environment, regulatory compliance, and entry barriers such as power, cooling and connectivity. The study will also map opportunities for repurposing brownfield sites like mines, integrating renewable energy use, and expanding into Tier-2 and Tier-3 cities. At the same time, it will evaluate challenges unique to mine-based data centres, including geotechnical constraints, connectivity gaps, environmental issues, operational safety and cost uncertainties. CIL noted that the initiative aims to align its diversification with India's Digital India and Make in India missions, while optimally utilising redundant mining assets for high-value infrastructure creation. The final report is expected within the third quarter of FY26.

The state owned miner was adopting multiple repurposing strategies including closed coal mines repurposed into eco-parks, mine tourism sites and recreation centres. (PTI)

Maharashtra, Reddy is a former Supreme Court judge who hails from Telangana and is known for key judgements, including the one declaring Salwa Judum, a group of trained tribal youth deployed as special police officers to take on Naxalites, as illegal and unconstitutional.

The issue of Reddy's Salwa Judum judgement spiced up the otherwise staid campaign for the vice presidential election with Home Minister Amit Shah claiming that the 2011 verdict was a setback to the efforts to fight Maoism in Chhattisgarh. The vice-presidential poll has been described by the opposition as an ideological battle, even as the numbers are stacked in favour of the ruling National Democratic Alliance (NDA).

The NDA is projecting Radhakrishnan as an untainted leader with rich political and administrative experience for the vice president's office and maintaining that these qualities would also prove to be useful as the chairman

Radhakrishnan (67) served as a two-term member of the Lok Sabha from Coimbatore during the tenure of Prime Minister Atal Bihari Vajpayee and later went on to lead the saffron party in Tamil Nadu.

Reddy (79), who retired from the apex court in July 2011, is a veteran jurist known for several landmark judgments criticising the then Union government for showing slackness in probing black-money cases.

As an apex court judge, Reddy ordered the formation of a special investigation team to take all steps for bringing back unaccounted monies unlawfully kept in bank accounts abroad. Retrieving black money deposited in foreign banks was a key electoral plank of the BJP ahead of the 2014 Lok Sabha election. In a fervent appeal to MPs ahead of the vice presidential polls, Reddy on Sunday exhorted them not to let party

loyalty guide their choice and asserted that by voting for him, they would be ensuring that the Rajya Sabha stands

as a true temple of democracy. In a video message, Reddy told the MPs that this is not just a vote to elect their Vice-President but is a vote for the spirit of India itself. Since the filing of nomination papers on August 20, Radhakrishnan has met MPs from all the states in groups

and sought their support in the election, while Reddy has toured different states and met leaders of opposition parties. Reddy's meeting with RJD founder Lalu Prasad came under attack from the BJP which questioned the opposition candidate for meeting a person convicted in a scam.

The Congress-led INDIA bloc is projecting Reddy as a consistent and courageous champion of social, economic and political justice. Reddy has had a long and eminent legal career, including as a judge of the Andhra Pradesh High Court, the chief justice of the Gauhati High Court and a judge of the Supreme Court. He also led the committee that undertook the caste survey in Telangana. (PTI)

Hazarika's life teaches us the power of empathy, of listening to people and of staying rooted, he said. "His music teaches us to be compassionate and courageous. It asks us to remember our rivers, our labourers, our tea workers, our Nari Shakti and our Yuva Shakti. It encourages us to believe in unity in diversity," Modi said. He added, "It is only fitting that one of India's most significant infrastructure projects, the bridge connecting Dhola and Sadiya, bears the name of Bhupen Hazarika. # Govt working on comprehensive package to support exporters hit by US tariffs: FM

government is working on a comprehensive package to support Indian exporters impacted by a steep 50 per cent tariff imposed by the US, Finance Minister Nirmala Sitharaman has said, asserting a multi-departmental engagement is underway to assess the impact on Indian shipments.

In an interview with PTI, Sitharaman said various industries are sharing the impact with the concerned departments or ministries as the second part (25 per cent) of the tariff kicked in from August 27. "So, we are getting their inputs...something is being worked out to do some handholding for those exporters who have been affected by the US tariff of 50 per cent," she

ports and USD 45.3 billion imports). Calling the landmark GST overhaul a 'people's reform', Sitharaman said that rationalisation of tax rates for a wide swath of products will benefit every family, boost consumption, and bolster the economy.

The finance minister said she will personally monitor passing on of goods and services tax (GST) rate cuts in the form of price reduction, even as some of the industries have already announced price moder-

Within days of the decision, from car makers to public sector insurance companies and shoe and apparel brands have already announced significant price cuts, and the rest are likely to follow suit by the time new GST rates are implemented, she said.

Nearly 400 products - from soaps to cars, shampoos to tractors and air conditioners will cost less when the rejig of the GST is effective from the first day of Navaratri on September 22. Premium paid on individual health and life insurance will be tax-free. A third slab of 40 per cent tax has been earmarked for a small list of sin goods and ultra-luxury items.

"This is a reform which touches the lives of all 140 crore people. There is no individual in this country who is untouched by GST. The poorest of the poor also have something small that they buy, touched by GST," she said. Starting September 22, the GST slab structure will change - 5 per cent for common use goods and 18 per cent for everything else. The existing slab of 12 per cent and 28 per cent rates has been done away with.

In the revamped GST structure, most daily food and grocery items will fall under the 5 per cent GST slab, with bread, milk and paneer attracting no tax at all.

Sitharaman said the reform - the single biggest since the 2017 roll-out of the onenation, one tax regime - has been carried out with a focus on the common man. Every tax on daily-use items has gone through a rigorous review, and in most cases, the rates have come down drastically. (PTI)

Rongphar has been vocal in demanding eviction drives in the Professional Grazing Reserve (PGR) and Village Grazing Reserve (VGR) areas in Kheroni, West Karbi Anglong, and other locations including Uttarborbil and Rongkut under Howraghat police station, as well as Horilal Basti and Matipung in Diphu town to check illegal settlers.

His group organised several protests and dharnas pressing for eviction drives in these areas.

The most recent demonstration was held last Saturday when Rongphar

and his group staged a sit-in in front of Don Bosco HS School at Rongkhelan, demanding immediate action.

Unconfirmed sources said that a group from Uttarborbil and

Howraghat filed an FIR against him, alleging that disturbances were created in their area in the name of checking illegal settlers.

Based on the FIR, a case was registered at Howraghat police station (Case No. 20/25 under Sections 61(2), 351(3), 113(5), 3(5) of the Bharatiya Nyaya Sanhita). This morning, Howraghat and Kheroni police

arrested Rongphar from his residence and brought him to Diphu police station before taking him to Diphu District Court.

In the afternoon, the district sessions court granted him bail after hearing oral submissions from his counsel.

According to his advocate, only two of the sections were relevant to the case. At Diphu police station before being taken to court, Rongphar said that he was arrested because he was advocating for the protection of indigenous land.

Giant hotels, haphazard roads, dams, mining, and rampant construction have destabilized the delicate mountain terrain. When forests are felled, rainwater no longer seeps into the soil but rushes down in torrents, triggering floods and landslides. The result is devastation—crops submerged, homes destroyed, lives lost, and economic losses spreading a shadow of despair across vast regions.

Today's floods and deluge are not just an overflow of water; they are a mirror reflecting our mistakes. They are nature's retaliation, a stern warning that if we do not wake up now, the future will be even more catastrophic. As Mahatma Gandhi once said, "Nature provides enough to satisfy every man's needs, but not every man's greed." This is the stark truth. If we fail to restore balance, such apocalyptic scenes will only grow more frequent. But if we see this warning as an opportunity, nature like a mother—will once again embrace and sustain us. Water, the giver of life, when it bursts its bounds, reveals its deadly face. This year's torrential monsoon rains and cloudbursts have once again proved this reality. Normally, water sustains life, but when it becomes unrestrained and violent, it sweeps away homes, fields, roads, bridges, temples, mosques, and human lives Uttarakhand, Himachal alike. Pradesh, Jammu & Kashmir, and the

under such fury. Sudden cloudbursts, collapsing glaciers, landslides, and rivers swollen beyond control are creating scenes of horror.

Deforestation has not only reduced the land's water absorption capacity but also disrupted local climatic cycles. Global warming has accelerated glacial melting in the Himalayas, bringing sudden and extreme rainfall. This explains why cloudbursts have multiplied several times over in recent years. Mountain settlements, once living in harmony with nature, are now paying the price of human intervention. The root problem lies in how we define development. We have equated it with concrete and machinery, ignoring ecological balance and environmental sensitivity. As a result, when disaster strikes, our warning systems fail, and administrative measures fall short. Even the Himachal Pradesh government has admitted before the Supreme Court that existing measures have been inadequate—an acknowledgment of how grave the crisis has become. India's rivers, once revered as the very source of life, have now turned into messengers of death.

The Ganga, Yamuna, Brahmaputra, Narmada, and Godavari once nurtured civilizations along their banks, but today they overflow in rage. The reasons are man-made: indiscriminate dams, encroachments, reduced to polluted drains, and settlements crowding their floodplains. Every year, on average, floods claim 1.600 lives in India. affect nearly 7.5 million people, destroy crops, kill livestock, and cause economic damage worth billions. In 2023 alone, floods in Uttarakhand, Himachal, and Delhi inflicted losses exceeding ₹60,000 crore.

Weather patterns have completely shifted over the past decades. The monsoon, once predictable from June to September, is now erratic. Sometimes, months' worth of rain falls within 24 hours; at other times, prolonged droughts prevail. The 2013 Kedarnath tragedy exposed the perils of reckless construction in fragile

In 2023, Delhi witnessed the Yamuna breach a 45-year record—showing how unprepared cities are in the face of climate change and unplanned urbanization. Every corner of the country tells a similar story. In Uttarakhand and Himachal, hills are collapsing and landslides are wiping out villages. In

Bihar and Assam, floods annually dis place millions. Even modern metropolises like Delhi and Mumbai come to a standstill with waterlogging. In Rajasthan, a desert state, torrential rains and floods are emerging as new threats. Roads turn into rivers, bridges are washed away, and farmlands disappear under water. This devastation is not just destruction—it is proof of our ignorance. Nature keeps signaling that balance is the key to life, yet we have crossed its boundaries. We have carved tunnels and roads deep into fragile mountains, cleared forests for concrete jungles, and forced rivers into artificial channels. When cloudbursts occur and rivers rage, it is not just a natural disaster—it is nature's revenge.

The question, then, is how to respond. Relief and compensation alone cannot be the answer. What is needed are long-term, decisive measures. We must preserve forests, restore rivers to their natural courses, prioritize greenery and drainage in urban planning, adopt restraint in mountain development, and most importantly, build public awareness so people understand that protecting the environment is synonymous with protecting life. We must stop treating disasters as merely "natural" and start recognizing them as 'man-made" and the outcome of flawed governance. This means solutions must go beyond temporary relief to encompass long-term strategy. Policies must integrate expert opinion, scientific research, and the lived wisdom of local communities—crafted with sensitivity to mountains and ecosys-

The rising frequency of natural calamities is a stark warning: unless we embrace sustainable development, the future will be far more terrifying. Strengthening early warning systems, enhancing coordination among Himalayan states, making disaster management swift and effective, and above all, safeguarding forests and natural resources—these are today's most urgent imperatives. Despite being the world's fourth-largest economy, India cannot afford the colossal human and economic losses inflicted by natural disasters. This year's floods and cloudbursts are not just tragedies—they are a clear message: the cost of disturbing nature's balance may be nothing less than human survival itself. Reimagining our development policies through the lens of ecology is the only path forward to avert this looming crisis.

# Pitru Paksha: Paying the debt of life to our ancestors BRS Supremo KCR IS presiding over

n the tapestry of Indian civilization, the relationship between the living and the de-Lparted has always been sacred, intimate, and enduring. Unlike many modern cultures that see death as a definitive severance, India has for millennia nurtured the belief that life continues across realms, that the living and the departed remain bound by invisible threads of duty. memory, reverence, and gratitude. This ancient ethos finds its most profound expression in the observance of Pitr Paksha, the fortnight dedicated to honoring our ancestors through Shraadh and Tarpan.

#### The Karma of Inheritance

It is often said that if we are comfortably placed in our present lives, we are not standing on our own merit alone but are reaping the unseen blessings of our ancestors' good karma. Our forebears sowed seeds of virtue, sacrifice, and toil, and the fruits ripen in our generation. Just as a banyan tree provides shade long after its planter is gone, the moral capital of those before us continues to shelter us. Indian thought has always stressed that the web of destiny is collective, and our prosperity is not just ours but a continuation of what our lineage has invested. To acknowledge this debt is the essence of Shraddha—the reverence we show when we

#### perform rites for our Pitrs. A Time Set Aside for Ancestors

Indian culture sets aside distinct periods for almost every significant act—festivals, fasts, harvests, pilgrimages. Just as Janmashtami, Diwali, and Navratri fall on fixed lunar dates, so too does the observance of gratitude to ancestors. The fortnight of Pitr Paksha in 2025 begins on Poornima, 7 September, with the first Shraadh falling on Pratipada, 8 September, This ritual calendar is no accident but the fruit of deep cosmological belief. The day of a person's passing in the lunar month determines the exact tithi on which their Shraadh can be observed by their progeny in perpetuity. In this way, the calendar preserves memory across generations, ensuring that no soul is forgotten.

#### The Rare Gift of Human Birth

Parents are our first gods, for they gift us the rare jewel of human birth. Hindu philosophy emphasizes that birth in the human form is an extraordinary privilege, for it alone allows us to accumulate merit and move toward liberation. Yet every child enters the world carrying the chain of past-life karma, visible only in destiny's unfolding. In this delicate balance between free will and inherited karma, prayers by one's progeny hold great significance. It is believed that when descendants perform Shraadh, their invocations can still guide the departed soul toward peace. Thus, Shraadh is more than ritual; it is continuity of compassion across

#### A Day in Pitr Lok

An evocative metaphor sustains this observance: one day in Pitr Lok, the realm of the ancestors, equals a full year on Earth. During this period, the Pitrs descend once in their daywhich means once in our year—to partake in the offerings of their descendants. The fortnight of Shraadh is thus a cosmic appointment. The designated days are when the departed are permitted to return, receive food, and bless their

lineage. To miss it is to leave them hungry in spirit; to observe it with reverence is to nourish bonds that death cannot sever.

#### The Simplicity of Tarpan

One does not need elaborate rituals to fulfill this duty. The simplest act of Shraadh Tarpan involves filling a pot of water with milk, black sesame seeds, barley, and rice, adding kusha grass and flowers, and offering it with devotion while facing south—the direction associated with Yama, the deity of death. The water, ideally poured at the roots of a Tulsi plant, a Peepal tree, or on the grass, must not be wasted. This simple act, when done with reverence and the name of the departed, becomes potent. For in spiritual matters, it is not grandeur but Shraddha—sincere faith—that sanctifies.

The observance is inclusive of all beings. During Shraadh, food is offered to cows, crows, and dogs, creatures considered messengers of the Pitrs. Even such symbolic acts acknowledge the interconnectedness of life, reminding us that nature, too, is part of the family of existence.

**Repaying the Debt of Life** Hindu philosophy teaches that every human being is born with three debts: to the gods (Deva-rinn), to the sages (Rishi-rinn), and to the ancestors (Pitri-rinn). The first we repay through worship, the second through pursuit of knowledge, and the third through Shraadh and moral living. No one can truly repay the immeasurable sacrifices of parents and forebears, yet Shraadh is prescribed for three generations upward—parents, grandparents, and great-

grandparents. For those who cannot observe individual tithis, the last day of Pitr Paksha, known as Sarva Pitri Amavasya, offers a universal opportunity. Falling on 21 September 2025, this day allows descendants to honor all ancestors, known and unknown. Tradition holds that souls who are forgotten, for whom no one performs rites, remain grieving in the cosmos. But if even one stranger prays for them, they are released to continue their journey. In this sense, Shraadh is not just personal but profoundly humanitarian, extending compassion to the forsaken dead.

Arpan and Tarpan The distinction between Arpan and Tarpan is both subtle and profound. What we offer to God is Arpan; what we offer to our ancestors is Tarpan. One signifies surrender to the divine, the other repayment of debt. Pitr Paksha reminds us that life flows both upwards to the divine and backwards to the lineage. This is why certain auspicious beginnings are avoided in this period. Weddings, new ventures, mundan ceremonies, and festive purchases are postponed, for this time belongs solely to memory,

#### gratitude, and continuity with the past. Respect in Life, Not Just After

Yet no ritual can compensate for neglect in life. Performing Shraadh for departed parents has little meaning if they were disrespected while alive. An incident narrated recently from an old age home in Chandigarh captures this poignantly. A man recognized an elderly lady from a prominent family and was shocked to see her abandoned there by her son, who publicly paraded as a philanthropist. Enraged, he urged her to expose him. But the mother, with infinite love, pleaded: "Don't tell anyone. If you do, my son's respect will be lost." Such is the

boundless heart of a mother—giving, forgiving, protective even in the face of betrayal. The question that lingers is sharp: how authentic can Shraadh be if Shraddha—reverence and empathy—were missing during the parents' lifetime?

#### Parent as Pay-Rent

Shri Sathya Sai Baba once gave a luminous interpretation of the word 'parent.' He said it means pay-rent. After parents pass away, we inproperty, jewels, and wealth. But what rent do we pay them in return? The rent, he explained, consists of Respect, Empathy, Niceness, and Time. This rent cannot be deferred until after death. It must be paid while they are alive. Moreover, siblings too are carriers of parental flesh and blood; maintaining harmony with them continues the lineage of love, pleasing the departed souls as surely as rituals

#### **Ecology in Ritual**

The genius of Indian tradition lies in how rituals often entwine ecological wisdom. Brahmins advise placing kheer under a Peepal or Banyan tree during Shraadh. Crows, eating the kheer along with the fruits of these trees, spread the seeds wherever they fly. Thus, Shraadh became a vehicle for ecological continuity. The Peepal, which releases oxygen even at night, and the Banyan, rich in medicinal properties, were propagated through an ingenious ritual economy. Here, gratitude to ancestors coincided with gratitude to nature, affirming the interconnectedness of lineage and ecology.

#### Shraddha Beyond Human Life

President Droupadi Murmu recently shared a childhood memory that illuminates the true spirit of Shraddha. She recalled watching her father bring dried wood from the forest to light their hearth. Before chopping it, he would bow, offer respect, and ask forgiveness from the dead wood. Puzzled, the young Murmu asked him why. He replied: "All their life, these trees gave us air, flowers, fruit, shade. Now they are old, and even as firewood they serve us. I seek forgiveness for burning them, because we have no other choice." In this simple gesture lay the essence of reverence—for parents, for trees, for all forms of life that sustain us. True Shraddha, then, is not confined to ritual alone; it is a posture of humility before all that nurtures us.

The Living Legacy Pitr Paksha teaches us that life is not linear but cyclical, that we are part of a continuum stretching backward into the past and forward into the unborn. The fortnight of Shraadh is less about mourning and more about remembrance, gratitude, and responsibility. It reminds us that paying rent to our parents and ancestors is not about property or possessions, but about living

with empathy, respect, and harmony. The ultimate question that emerges is not whether we have observed Shraadh with proper ritual, but whether we have lived Shraddhawith parents, siblings, nature, and all beings For in the end, the truest offering to the Pitrs is not water and sesame alone, but the conduct of their descendants—our compassion, our humility, and our reverence. # the decline of his party in Telangana

hy do political families believe they can hold onto power in 1 of the latest they can hold onto power indefinitely? This is comwhen in many one-man or one-woman parwhere leaders often engage in nepotism by appointing relatives to positions of authority. For example, the late Mulayam Singh Yadav, leader of the Samajwadi Party, had over 20 family members active in politics at one time. However, these families frequently face power struggles as the leader's influence

This is precisely what is unfolding in Telangana, where the Bharat Rashtra Samithi chief and former Telangana Chief Minister, K. Chandrashekara Rao, has suspended his daughter, K. Kavitha, for engaging in anti-party activities, though he had encouraged her earlier. Kavitha was also ambitious. A power tussle is looming large between KCR's daughter and son, K.T. Rama Rao.

By directly naming her cousins Harish Rao and Santosh Kumar, she has even challenged the party's contention that the indictments against KCR and Harish Rao by the Commission were politically motivated. Kavitha's allegations could help BRS's opponents and open the door for political shifts.

Soon after her suspension, Kavitha quit the party and her membership in the Legislative Assembly. She is considering launching her own political organisation. This move could significantly alter the state's political landscape, but only if she succeeds.

This story reflects key themes in the regional politics of South and North India. Succession issues have long troubled regional parties, with a traditional preference for sons over daughters as political heirs.

Political rivalries abound, including V.N. Janaki versus J. Jayalalithaa, N. Chandra Babu Naidu versus Lakshmi Parvathi, MK Stalin versus MK Alagiri, Uddhav versus Raj Thackeray, and now Kavitha versus. K.T. Rama Rao.

The family feud within the BRS has intensified into a political drama as KCR's health and influence decline. His charisma failed to sway voters in the 2023 elections, resulting in a loss of power for his party. In the 2004 Lok Sabha polls, BRS got zero. Kavitha, recently released on bail after being jailed

for a multi-crore liquor case, has now targeted her father's confidants. She has been struggling to remain relevant politically. KCR had a grand dream of becoming the Prime

Minister, making his daughter Kavitha a Central Minister, and his son K.T. Rama Rao the Chief Minister of Telangana. But they remained a dream because KCR was a minor player in the overall national poli-

The blow to BRS came when it lost power in 2023. As it happens to many regional parties, the BRS, which finished third in the 2023 polls, got demoralised. Following a total defeat in the 2024 Lok Sabha polls, KCR has withdrawn from public life, making occasional public appearances. Most of his time is now spent at his farmhouse. Thus came a gap which needs to be filled by a capable political heir. KCR himself had depended on his son KTR as his political

Kavitha has been openly critical of her party, writing a six-page letter to her father about KCR's recent lack of energy. She condemned his silver jubilee speech for neglecting important issues and lacking

JAKARTA(INDONESIA), Sept **8:** Indonesia's president announced a Cabinet reshuffle Monday, replacing key economic and security ministers after deadly protests erupted across the country over lawmakers' perks.

The Cabinet shake-up comes as public dissatisfaction rose with President Prabowo Subianto's administration and the parliament's perceived insensitivity over economic hardships. Five ministers lost their jobs, including Finance Minister Sri Mulyani Indrawati, a widely respected technocrat and former managing director of the World Bank, and Budi Gunawan, the coordinating minister for politics and security

Subianto chose Indonesian economist Purbaya Yudhi Sadewa, chairman of the Deposit Insurance Corporation, to replace Indrawati. Violent protests that left seven people dead had gripped Southeast Asia's largest economy, home to more than 280 million people, after reports that all 580 members of the House of Representatives receive a monthly housing allowance of 50 million rupiah (USD 3,075), in addition to their salaries. The allowance, which was introduced last year, is nearly 10 times the minimum wage in Jakarta.

Critics argue that the perk isn't only excessive, but also insensitive at a time when most people are grappling with a soaring cost of living, taxes and rising unemploy-

### Sri Lanka opposes international action on human rights

COLOMBO, Sept 8: Sri Lanka on Monday opposed international intervention on its human rights situation at the United Nations Human Rights Council (UNHRC) in Geneva, asserting that such actions undermine ongoing domestic efforts to ensure justice and reconciliation.

The 60th regular session of the UNHRC, session, which opened in Geneva on Monday, will review reports and oral updates on several countries, including Myanmar, Sri Lanka, Afghanistan, Sudan, Palestine, and Syria.

"Sri Lanka observes that external initiatives will only serve as hindrances to the ongoing national efforts and serve to polarise the population," the foreign ministry said in a statement here.

Foreign Minister Vijitha Herath is scheduled to respond to a report by the UN High Commissioner for Human Rights, published in Auchief Volker Turk's visit to Sri Lanka in late June.

Herath is expected to call on the Council to provide the "space required" to implement "transformative reforms" outlined in the OHCHR report, the ministry said.

In his report, the UN rights chief urged Sri Lanka to accede to the Rome Statute of the International Criminal Court, which establishes the ICC's jurisdiction over grave crimes of international concern, including genocide, crimes against humanity, and war crimes.

The report also urged the island nation to apply a moratorium on the use of the Prevention of Terrorism Act (PTA), repeal or amend laws that curtail freedom of expression, such as the Online Safety Act, issue public instructions to the security forces that all extrajudicial methods are banned, and order an end to surveillance of individuals, among

# China's export growth slows in August as US tariffs and trade tensions bite

President Donald Trump has imposed 30% in additional tariffs

BEIJING, Sept 8: China's exports grew last month but at a slower pace than in recent months, the country's customs agency said

Exports reached \$321.8 billion in August, a 4.4% increase compared to the same month last year. That was down from a 7.2% jump in July. Meanwhile, imports totalled \$219.5 billion, a 1.8% rise.

China's large trade surplus has become a contentious issue with major trading partners including the US and the European Union. Low-priced Chinese imports are a boon for consumers but can lead to job cuts in manufacturing.

In the first eight months of the vear, China's exported \$785.3 billion more in goods than it imported from other countries, the monthly customs data showed.

President Donald Trump has imposed 30% in additional tariffs on imports from China since taking office early this year. He backed



down from even higher tariffs after China retaliated with import taxes of its own. The two countries are in talks to try to reach a trade

Citing hospital reports, the Himalayan Times newspaper reported that 14 people were killed in the protest in Kathmandu. The deceased include six at Trauma Centre, three at Civil Hospital, three at Everest Hospital, one at Kathmandu Medical College (KMC), and one at Tribhuvan University Teaching Hospital, the paper said.

**HAWTHORNE(US), Sept 8:** Elon Musk's SpaceX has reached a deal worth about USD 17 billion with EchoStar for spectrum licenses that it will use to beef up its Starlink satellite network.

The deal for EchoStar's AWS-4 and H-block spectrum licenses includes up to USD 8.5 billion in cash and up to USD 8.5 billion in SpaceX stock. SpaceX will make approximately USD 2 billion in cash interest payments on EchoStar debt through November

SpaceX and EchoStar will enter into a long-term commercial agreement which will allow EchoStar's Boost Mobile subscribers to access SpaceX's next generation Starlink Direct to Cell service.

Last month AT&T said that it will spend USD 23 billion to acquire wireless spectrum licenses from EchoStar, a significant expansion of its low- and mid-

band coverage networks. EchoStar said that it anticipates that the AT&T deal and the SpaceX transaction will resolve recent inquiries from the Federal Communications Commis-

sion about the rollout of 5G technology in the US. EchoStar said Monday that it will use the transaction's proceeds partly to pay down debt. Current operations of Dish TV, Sling and Hughes will not be impacted by the deal, the company said. (AP)

# APBB team conducts extensive survey for State Biodiversity Park in capital complex

ITANAGAR, Sept 8: The Arunachal Pradesh State Biodiversity Board (APBB), under the leadership of Chairman Hawa Bagang, has undertaken an extensive preliminary survey and trekking exercise aimed at identifying potential sites for the establishment of a State Biodiversity Park within the capital complex.

The initiative is being seen as a significant step toward enhancing conservation efforts and promoting ecological

awareness in the state. According to an official statement issued by the Board, the survey team was composed of senior forest officers and experts from various fields, along with local community representatives.

The team included Chairman Hawa Bagang, Director of the State Forest Research Institute (SFRI) cum Member Secretary of APBB H B. Abo, IFS, Senior Scientist R K Taj, Forest Geneticist Dr G Murtem, Orchidologist Dr Ona Apang, Regional Officer Dr Bameng Yakang, and several other forest offi-

The survey also saw the participation of Panchayat leaders, including former Autonomous District Council Member (ASM), General Purpose Committee (GPC) members, General Purpose Member (GPM), and Gram Bura (GBs) from

The survey focused on the Bedi Bedha area near Batt village, where the terrain and ecological diversity make it a promising location for the proposed biodiversity park.

The team conducted biodiversity trekking to assess the flora and fauna, geographical conditions, and other environmental parameters that would support the development of the park.

The exercise was aimed at identifying the ecological potential of the site while ensuring minimal disruption to the local environment and community.

The statement further mentioned that the detailed survey, mapping, and environmental impact assessment will be carried out once a formal agreement is reached with Panchayat leaders, GBs,

and other senior members of the village The Board has emphasized that the project will be executed in close consultation with local stakeholders, ensuring that their views and concerns are taken into account throughout the planning and implementation process.

Since assuming office, Chairman Hawa Bagang has been actively involved in strengthening the state's conservation efforts. He has been touring various forest areas and biodiversity hotspots across Arunachal Pradesh, inspecting potential sites, and engaging with local communities and conservationists. The next phase of the project will include detailed surveys, consultations, and formal agreements, with the Board seeking active participation from local stakeholders at every step.

### Arunachal Cabinet approves Bill to streamline urban growth, clears key rules

ITANAGAR, Sept 8: The Arunachal Pradesh Cabinet on Monday approved a Bill that seeks to provide a legal framework for town planning schemes, marking a major step towards streamlining urban growth and development in the state, according to an official statement.

The decision comes in the backdrop of rapid urbanisation in the state, with 47 notified urban centres requiring structured planning interventions to curb haphazard growth.

The draft Arunachal Pradesh Urban and Country Planning (Amendment) Bill, to be tabled in the forthcoming Assembly session, will provide a legal framework for town planning schemes and land pooling, and enable the state to access Rs 100 crore in capital incentives during the current financial year under the scheme for special assistance to the states for capital investment 2025-26.

The Cabinet meeting held at Ziro in Lower Subansiri district, chaired by Chief Minister Pema Khandu, observed that the initiative aligns with the state government's longterm vision for sustainable urbanisation while addressing challenges posed by geography and accessibility, the statement said.

The proposed amendments will further facilitate organised urban growth by introducing new planning schemes, transferring development rights, and empowering local bodies to implement master plans in line with national and constitutional provisions, including the 74th Amendment Act.

Recognising urgent needs in public safety, the cabinet sanctioned four new fire stations at Mebo (East Siang), Kimin (Papum Pare), Deomali (Tirap) and Lungla (Tawang), along with the creation of 68 posts to provide adequate manpower.

The move aims to strengthen emergency response capacity across vulnerable regions.

In another significant decision, the Cabinet approved the Arunachal Pradesh Municipal Property Tax Management Rule, 2025.

The rule will be implemented in all municipal areas in the first phase, with the government underlining that property tax collection will boost the fiscal autonomy of urban local bodies (ULBs) and make them financially self-reliant, an initiative being promoted as "Atmanirbhar Municipality." (PTI)

This is hypocrisy in extreme, BJP leader Ravi Shankar Prasad told reporters, as he took a jibe at Reddy, a former Supreme Court judge, for seeking votes for saving the soul of India and making other "big talks".

Reddy talks of saving the soul of India and is meeting someone not only convicted in fodder scam but also facing more corruption charges, including offering jobs in the railways in lieu of bribe, Prasad said.

"What kind of a retired Supreme Court judge you are. Lalu Prasad Yadav is not even a voter in the election. Please do not talk of saving soul...This is hypocrisy in extreme. We condemn his conduct," he said.

The former law minister was also critical of several retired judges who had defended the opposition vice presidential candidate against Home Minister Amit Shah's criticism of Reddy for his judgement as a member of Supreme Court double bench which had disbanded Salwa Judum, a civil militia which worked with police in fighting

The BJP has been saying it showed his



sympathy with naxalites.

Prasad questioned their "silence", alleging that Reddy has acted below the dignity expected of a retired judge by meeting Yadav, whose party RJD has backed his candida-

In his press conference, the BJP leader also criticised Congress leader Rahul Gandhi as a casual politician for his reported personal trip abroad currently when he should have visited flood-hit states like Karnataka and Puniab

Prasad noted that Kharge told him that he himself had suffered damaged in his 40-acre asked, noting that the farmer wanted to convey his pain as the Congress is in power in Karnataka and the region was Kharge's former constituency.

Sources said the Opposition MPs were told to ensure their vote is not wasted, as some votes were declared invalid last time. The MPs also participated in a mock poll for Tuesday's election to enable MPs to experience the voting

Members of Parliament are not bound by party whips to vote in the vice presidential election, which takes place under a secret ballot

The MPs will be handed out ballot papers containing the names of the two contesting candidates and will have to mark their preference by writing the figure '1' opposite the name of the candidate of their

Among the leaders who attended the meeting in Samvidhan Sadan were Congress president Mallikarjun Kharge, Congress Parliamentary Party leader Sonia Gandhi, NCP (SP) leader Sharad Pawar and DMK leader T R Baalu.

Meanwhile, the NDA also held a meeting of their MPs to brief them on the election process. The members also participated in a mock poll.

Odisha's principal opposition party, Biju Janata Dal (BJD), announced that its MPs will abstain from voting in the vice presidential

The party, headed by former chief minister Naveen Patnaik, said it took the decision as part of its policy of "maintaining an equal distance" from both the BJP-led NDA and Congress-led INDIA bloc at the national level.

On Sunday, AIMIM decided to support the opposition candidate in the election.

Ruling NDA nominee C P Radhakrishnan and joint opposition candidate B Sudershan Reddy are pitted against each other in a direct contest for the vice-presidential

The BJP-led alliance has a clear edge in the poll necessitated by the sudden resignation of Jagdeep Dhankhar on July 21.

Members of both Houses of Parliament will cast their votes in the Parliament House between 10 AM and 5 PM on Tuesday. Counting of votes will begin at 6 PM, and the results will be announced late in

#### BJD to abstain from vice presidential polls

NEW DELHI, Sept 8: The Biju Janata Dal (BJD) on Monday said it will abstain from voting in the vice presidential polls, and asserted that the party remains "equidistant" from both the NDA and the INDIA bloc. BJD leader Sasmit Patra also said his party's priority is the "fourand-a-half crore people of Odisha".

"(Following) discussions by our honourable party president, Mr Naveen Patnaik with the party's senior leaders, Political Affairs Committee and MPs, the Biju Janata Dal has decided to abstain from the vice presidential elections tomorrow," Patra said.

"The BJD remains equidistant from both the NDA and INDIA alliances. We are focused on the development and welfare of Odisha and four-and-a-half crore people of Odisha," he said.

The vice presidential election, a direct contest between ruling NDA nominee C P Radhakrishnan and joint opposition candidate B Sudershan Reddy, will take place in Parliament House, where members of both Houses of Parliament will cast their votes between 10:00 am and 5:00 pm on Tuesday. (PTI)

"Instead, the project denotifies a significant part of the Shompen tribal reserve, destroys the forest ecosystems where the Shompen live, and will cause a large-scale influx of people and tourists on the island," she argued.

Ultimately, the Shompen will find themselves cut off from their ancestral lands and unable to sustain their social and economic existence, Gandhi said. Yet, the government is stub-

bornly adamant and shockingly insistent, she added.

Gandhi alleged that the constitutional and statutory bodies set up to preserve tribal rights have been sidestepped throughout this process.

"As in Article 338-A of the Constitution, the Government should have consulted the National Commission for Scheduled Tribes. It has failed to do so.

"The Government should have consulted the Tribal Council of Great Nicobar and Little Nicobar

Island. Instead, the Council Chairman's plea that the Nicobarese tribals be allowed to return to their ancestral villages has been neglected," she pointed out.

Gandhi further said that the letter of no objection was secured from the Council, but it has since been revoked, with the Council noting that the authorities had "rushed them" into signing the let-

"Due process and regulatory safeguards set up to protect local communities have been evaded. The Social Impact Assessment (SIA) conducted as per the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 should have considered the Nicobarese and Shompen as stakeholders of the process and evaluated the project's impact on them,"

Instead, it omits any reference to them altogether, Gandhi said.

"The Forest Rights Act (2006), which empowers the Shompen as the authority to protect, preserve, regulate and manage the forests, should have underpinned any policy action. Instead, the Shompen have not been consulted on this issue -- a fact which the Tribal Council has now confirmed," she said in the article

"The country's laws are being mocked wholesale. Unconscionably, one of the country's most vulnerable groups may have to pay the ultimate price for it," she

"Ecologically, this project is nothing short of an environmental and humanitarian catastrophe. The project will require the cutting down of trees on an estimated 15% of the island's land, decimating a nationally and globally unique rainforest ecosystem," she pointed

The Ministry of Environment, Forests, and Climate Change estimates that 8.5 lakh trees may be cut, Gandhi said.

"This is a depressing figure, but it may also be a gross underestimate - independent estimates have suggested that 32 lakh trees to 58 lakh trees may eventually be cut," she said

The government's solution to this indiscriminate tree felling is that of "compensatory afforestation", a rather poor substitute for the loss of natural, old-growth forests, she opined.

"Despite abundant evidence confirming the same, which includes a National Green Tribunal order, the Government has contrived ways to manipulate this truth through a high-powered committee (HPC). The report of this HPC and the ground-truthing exercise it conducted to reclassify the port site out of CRZ 1A has not been made public," she said.

Gandhi further argued that from a wildlife standpoint too, the project raises serious concerns.

"Primatologists have written to the Government expressing grave concerns about the project's impact on the Nicobar long-tailed macaque. These concerns have been ignored," she said.

The biodiversity assessments for the projects have come under questioning for critical methodological flaws. Gandhi said.

"The assessment of sea turtle nesting sites was conducted in the off-season for nesting. Drones were employed to gauge the project's impact on dugongs, but these drones have limited capacity and can only assess shallow areas," she said. (PTI)

# Tiger reserve: SC orders status quo in Goa's Mhadei-Kotigaon area

Tiger protects the forest and the forest guards the tiger: SC

NEW DELHI, Sept 8: The Supreme Court on Monday ordered status quo in Goa's Mhadei-Kotigaon area which was identified by National Tiger Conservation Authority (NTCA) as a reserve for the big cats.

A bench of Chief Justice of India B R Gavai and Justices K Vinod Chandran and Atul S Chandurkar asked a central empowered committee to hear stakeholders in the matter and decide the issue in six

The bench ordered no projects or development to be undertaken in the meantime

The top court had earlier agreed to hear a plea filed by the Goa government and others challenging the Bombay High Court order to the state to notify Mhadei Wildlife Sanctuary and its surrounding areas as a tiger reserve within three

It sought responses from the



NTCA and others on the petition. Spread over 208 square kilometer, the Mhadei Wildlife Sanctuary is located in the northeastern part

of the state, adjoining Karnataka. The high court's judgement came on a plea filed by NGO Goa Foundation which sought direction to the state government to notify tiger reserves of the state as requested by the NTCA.

Quoting "Mahabharata", the

high court said, "If there is no forest, then the tiger gets killed; if there is no tiger, then the forest gets destroyed. Hence, the tiger protects the forest and the forest guards the tiger!" The high court had directed the state government to take necessary steps to prepare a tiger conservation plan as contemplated by the Wildlife Protection Act, and to forward the same to the NTCA within three months

from notifying Mhadei Wildlife Sanctuary and other areas as a tiger reserve.

The NTCA was, as a result, directed to give full assistance to the state government for completing the process following which it would "expeditiously process" the state's tiger conservation plan.

The high court also directed the state government to set up antipoaching camps at strategic locations with forest guards, watchers, etc., in the wildlife sanctuary and national parks in the state.

"This exercise must be completed within six months," it

The high court also asked the state government and the forest denartment to take steps to ensure no encroachments took place in the protected forest areas such as wildlife sanctuaries and national parks pending notification of the tiger reserve and in future. (PTI)

## Bar body ends strike after Delhi top cop assurance

NEW DELHI, Sept 8: The Delhi district courts bar body on Monday called off its strike after receiving an assurance from the Delhi Police commissioner's office that police officials will appear physically in courts to present evidence

"Since a circular has been issued from the office of commissioner of police that in all criminal trials, all police officials/ personnel shall physically appear before courts for the purpose of deposition/ evidence, the coordination committee in its meeting held today has resolved that since our demand for direction of police officials to appear physically in courts has been met with, call for abstinence from work is being withdrawn," said a communication from Tarun Rana secretary of New Delhi Bar Association. On September 4, the committee was critical of a letter of the police commissioner's office to the principal district and sessions judges about the proposed means of police virtually presenting evidence in courts, and announced the indefinite and intensified lawyers' strike from Monday, saying it was contrary to the assurance given by authorities. (PTI)

#### Human skeletal remains found during spot inspection in Dharmasthala case

MANGALURU (KARNATAKA), Sept 8: The SIT probing the alleged case of multiple rapes, murders, and burials in Dharmasthala recovered human skeletal remains during a spot inspection at Bangale Gudde on September 6, police said on Monday.

The discovery was made in the presence of a relative of the victim, a 17-year-old college student, police added.

The student was allegedly raped and murdered on October 9, 2012 a case that remains unresolved more than a decade later. Despite a CBI probe and Supreme Court intervention, the real perpe-

trators have never been identified. Police sources said the relative exhumed a human skull from the site on instructions from activist Girish Mattannavar, who had earlier obtained

information from complainant C N Chinnaiah, based on whose complaint SIT was formed. The SIT later confirmed that at least two sets of skeletal remains were

recovered during the exercise. "During the spot mahazar (spot inspection) at Bangale Gudde, the SIT recovered skeletal remains of at least two individuals. This is a shocking development for the investigation team," a senior police source said. Officials suspect more remains may be buried at the desolate site.

The recovered bones have been sent to the Forensic Science Laboratory (FSL) for analysis. Investigators are probing why Chinnaiah, despite being aware of the site, did not disclose it earlier. Police added that the relative acted under Mattannavar's direction and

recorded the exhumation on video. He has not been taken into custody

but is likely to be questioned further. 'We will investigate how the person came to know of this location and

why it was kept hidden for so long," a police official said. "The FSL report will be crucial in establishing the identity of the deceased and the circumstances of their death." (PTI)


# Manipur Guv accused of partisanship

IMPHAL, Sept 8: Former Chief Minister of Manipur and Congress Legislature Party (CLP) leader Okram Ibobi has accused Manipur Governor Ajay Kumar Bhalla of reducing Raj Bhavan to a "partisan platform" by holding a meeting exclusively with BJP legislators.

'The Governor's selective meeting is a shocking display of partisanship. If the discussion was really about the violence, why were opposition MLAs left out? Raj Bhavan must remain above politics," Ibobi said at a press briefing today in Imphal.

The Leader of the Opposition warned that such exclusionary politics deepens the trust deficit at a time when Manipur is still reeling from over a year of bloodshed and displace-

Ibobi also hit out at the Centre and the state government for what he called their mishandling of the Suspension of Operation (SoO) agreement signed with Kuki militant groups. He claimed that successive BJP-led governments ignored repeated violations of the ground rules.



"Even after the former state government passed resolutions for abrogation of SoO for two militant groups, the Centre failed to act. That left

On Modi's much-anticipated September 13 visit, Ibobi was blunt. He said, "The Prime Minister seems to believe he can pacify Manipur with a cursory 2–3 hours' visit. But the people cannot tolerate gestures without action.'

He added that Manipur appears to be treated as an afterthought in the Prime Minister's itinerary, with more priority given to Mizoram and Assam. "This is not a mission, it looks like a tour," he remarked.

The press conference was attended by AICC CWC member Gaikhangam, MLAs Lokeshwar and Surjakumar, former MLA Loken, and other senior Congress leaders.

Concluding his remarks, Ibobi said the Governor's selective meeting and the Centre's failure on the SoO pact together have eroded public faith in institutions. "Ignoring elected representatives and failing to enforce agreements that protect our citizens undermines the credibility of both Raj Bhavan and the Central govern-

# Meghalaya govt to study reservation policy report before implementing it: Cabinet spokesperson

laya government on Monday said it would take a decision on the recommendations of the Expert Committee on the State Reservation Policy after thoroughly examining the voluminous report.

Cabinet Minister Paul Lyngdoh told reporters that the cabinet had taken cognisance of the committee's findings during its meeting.

"The cabinet took cognisance of the report and has decided to study it. It is a voluminous report running into several thousands of pages. After due diligence, we should be able to come up with a decision on the various recommendations," he said.

The committee was constituted by the state government in May 2023, following growing demands for a review of the reservation policy, which has been in place since

Several pressure groups, particularly from Khasi and Jaintia Hills, had argued that the current formula disproportionately benefits one

The committee was tasked with examining the policy, consulting stakeholders, and suggesting changes while keeping constitutional and legal frameworks in

The demand had intensified after Voice of the People Party (VPP) chief Ardent Basaiawmoit staged a fast-unto-death in May 2023, pressing for a review of the

asserted.

He called off his protest after a fast of over 200 hours on June 1, when the government assured it would set up the expert panel.

The report, submitted in June this year, contains a mix of proposals, some suggesting status quo and others introducing new aspects, including economic consid-

"We have just received the report. We will need some time before we come up with a decision," Lyngdoh said

He added that the government has the option to accept or reject the recommendations, but will ensure a balanced approach.

"We have always been balanced, and we will continue to be so. Recommendations are just suggestions, but the decision is finally that of the state government," he

The minister stressed that the government will not rush into any decision as the issues have "wideranging ramifications". (PTI)

AGARTALA, Sept 8: Tripura Chief Minister Manik Saha on Monday said his government has spent ₹ 834.45 crore on providing different social welfare pensions to 3.90 lakh persons in the 2024-25

"We have spent ₹ 834.45 crore to provide different social welfare pensions to 3.90 lakh people in 2024-25, at the rate of ₹ 2,000 per person," he added.

Saha said the BJP government has increased the social pensions from ₹ 1,000 to ₹ 2,000 per month.

He said that in line with PM Narendra Modi's dream of a developed nation, his government has formulated a roadmap for building a developed Tripura by 2047.

"Tripura is the fifth state in the country and the first in the Northeast to have such a roadmap," he said.

The CM said various initiatives have been taken for the welfare of children, women and weaker sections of people.

# Fashion icon Giorgio Armani's 'Baaghi 4', headlined by impact, legacy will be felt for decades to come

MONTREAL, Sept 8: Despite the hyperbolic and fleeting tendencies of the fashion industry, few designers have had the impact of Giorgio Armani, who has died in Milan at the age of 91.

The new look and attitude the designer offered 50 years ago is today largely taken for granted and, at first glance, seems rather unassuming. But from the outset, Armani's focus and determination were to provide his customers with an easier way of dressing that was at once practical, sophisticated and thoughtful, yet unpretentious, powerful and subtle.

His suits required little effort on the part of the wearer, whose individuality and identity were meant to shine rather than being overwhelmed by his clothes. His approach to tailoring coincided with the growing awareness of health and fitness in the 1970s and 1980s

Armani's body-conscious approach soon garnered attention in Hollywood, and he was asked to provide the wardrobe for Richard Gere in the now cult-classic 1980 film American Gigolo.

Born in 1934 in the small northern Italian town of Piacenza, Armani was originally destined to be a country family doctor. Before founding his own fashion

house in 1975, relatively late in life, at the age of 41, Armani began in the fashion industry as a window dresser for the Milanese department store La Rinascente.

In 1961, he was hired by stylist and businessman Nino Cerruti to work in the Cerruti family's textile factory. This new and fertile environment proved seminal to Armani's future in textile development and would determine his own aesthetic formula.

While working at Cerruti, designing for the firm's Hitman menswear collection, Armani proverbially and literally took the stuffing out of traditional Italian tailoring, offering men a modern attitude and a novel, less rigid way of moving and living in their jackets and suits. Quickly, and throughout his 50-year career, the now iconic multi-purpose Armani jacket provided men and women alike with armour as much as comfort and support for the body underneath. Encouraged by his romantic and business partner Sergio Galeotti, an architect who remained Armani's business partner until his untimely death in 1984, Armani officially founded his own fashion house in July 1975. # Not many scripts that bring together India and Papua New Guinea: Ritabhari Chakraborty on 'Papa Buka'

**NEW DELHI, Sept 8:** Bengali actor Ritabhari Chakraborty is elated to be part of "Papa Buka", which is Papua New Guinea's first ever submission to the Oscars in the best international feature film category.

Directed by "Trees Under the Sun" fame Bijukumar Damodaran, the film is co-produced by Pa Ranjith via Neelam Productions alongwith Noelene Taula Wunum, Akshay Kumar Parija and Prakash Bare.

"Papa Buka" is a Tok Pisin-language film which follows an aging war veteran as he guides two Indian historians as they research about Indian soldiers who served alongside British and Australian forces during World War II. Chakraborty plays the role of Romila Chatterjee, a historian whose quest for history has a personal connection. "There's not many scripts in the world that can bring India

and Papua New Guinea together. These two countries are geographically so apart yet united by their history which was formed due to the war (World War II) that shook the world," Chakraborty told PTI in an interview. "As an actor working on films for so many years, it is a dream come true. We all want our films to be seen by the Academy. I have been working predominantly in Bengali films for a while and I don't even remember the last Bengali film which made it to Oscars," the actor added.

Chakraborty, a former history student at Jadavpur University, said she was intrigued by her character.

"I have been a history student in Jadavpur University so I had some insight on what a historian is like and what their lives are like since I have read so many books written by them. My character in this film is called Romila and it is not a

coincidence because one of the most famous historians from our country is named Romila Thappar. We wanted to reference her, even though my character is not based on her," she said. She found it interesting that while the film focuses on themes of war and violence, it barely depicts the gruesome events on screen. Her character Romila travels to the island to find out the truth of what happened to her grandfather, who never returned after serving during the Second World War.

"The nuances of building a story around our origin is the work of a historian and that is something we incorporated while also making Romila her own person. Her grandfather never came from the war, her mother never got closure so she had her own history to explore. We find out what happened to her grandfather and her exploration of history ultimately becomes a personal journey,'

Chakraborty said.

The actor, who reunited with the threetime National Award-winning director after their 2018 film "Painting Life", said it was challenging to shoot in a foreign land due to language differences. "Most of the film is in Tok Bisin which is the local language, the crew was Malayali and I am Bengali. I had most of my dialogues in Hindi but working with a crew whose language I didn't know on a film whose language is foreign was challenging," she said. "She praised director Biju as someone who is well-informed about the issues he is tackling in his movies. He is always about the craft, he makes his own cinema, which is not to please anyone. He had his vision. All I could do was get on board with the cap-

tain and trust him. He has the kind of sensitivity one needs to have when making films like this one,' she said. (PTI)

# Carlos Alcaraz beats rival Jannik Sinner at the US Open for a 6<sup>th</sup> Slam title and the No 1 ranking

NEW YORK, Sept 8: So maybe the first U.S. Open final between young, elite rivals Carlos Alcaraz and Jannik Sinner wasn't as long, riveting and dramatic as their matchup to decide the championship at the French Open. Perhaps it wasn't as seemingly meaningful and plot-driven as their showdown for the Wimbledon trophy.

Still, what the No. 2-seeded Alcaraz's 6-2, 3-6, 6-1, 6-4 victory over No. 1 Sinner on Sunday did do was significant. Alcaraz reasserted his superiority over the defending champion, wrested away the top spot in the ATP rankings and left tennis fans eager for whenever their next clash will come.

They are the first two men in the sport's history to face each other in three consecutive Grand Slam finals within a single season. "I'm seeing you more than my family," Alcaraz joked during the trophy ceremony, eliciting a grin from Sinner. "It's great to share the court, to share the locker rooms, everything.



Alcaraz, a 22-year-old from Spain, leads over Sinner, a 24-year-old from Italy, of 10-5 in their head-tohead series, 6-4 in total Grand Slam trophies, and 2-1 in U.S. Open championships.

"I give lots of credit to him, because he handled the situation better than I did," said Sinner, who lamented that his own play was too predictable. "He raised his level when he had to.'

The match's start was delayed for about a half-hour while thousands of fans were stuck outside Arthur Ashe Stadium going through extra security because President Donald Trump sat in a sponsor's suite.

# Arshdeep's rhythm, Bumrah's continuity key for India at Asia Cup: Arun

**DUBAI, Sept 8:** Arshdeep Singh's ability to regain "match rhythm" quickly and Jasprit Bumrah's capacity to play continuously without rest will define India's Asia Cup campaign, feels former national bowling coach Bharat Arun.

Arun said Arshdeep, despite extensive bowling in England, is still short on competitive overs. He did play a Duleep Trophy game for North Zone though. India begin their Asia Cup campaign on Wednesday against the UAE.

"Arshdeep, we all know what he is capable of doing. He must have bowled a lot in England, but he is definitely short of match practice. The rhythm really comes from playing matches no matter how much you bowl in the net and practice sessions," Arun told PTI during an exclusive interview

"I think it is important to bowl in matches. It's a big challenge for Arshdeep. How quickly he gets back his match rhythm would be very, very important. It can be in a jiffy or it can take him a couple of matches to get into rhythm," added the coach, who had two fairly successful stints as India's bowling coach between 2014 and 2021.

On Bumrah, Arun was emphatic that six T20 matches across three weeks should not trouble him.

"I would love to see Jasprit play. But I think it is his call. I think he should be able to play all the matches. But the real call must be taken by Jasprit. I don't think he would need rest looking at the format of this tournament.

"So, if he is bowling, it is also a question of continuing the good rhythm that he gets throughout the tournament, which would augur very well for him," Arun said.

Arun, who has worked closely with Harshit Rana at Kolkata Knight Riders, vouched for the pacer's potential but stressed on consistency

"Harshit has been very impressive in T20 cricket. He is a very talented bowler in the sense that he can really bowl well-disguised slower balls. He has got a pretty good yorker and he can move the

"The challenge for him would be to stay very consistent and to get his execution right. His capabilities and his talent is exceptional," he noted.

Arun was confident that Kuldeep Yadav, who could not fit into the playing XI during the Test series in England, would make an impact in the Asia Cup.

"Kuldeep Yadav has grown immensely in stature as a bowler. He is bowling beautifully. And it was unfortunate that he couldn't play in England.

"But I am sure he must have had a lot of overs under his belt. And he is experienced enough. He has got pretty good experience in the T20 format," Arun said.

Arun felt Kuldeep must have also got his rhythm back thanks to a

Duleep Trophy stint recently. ...these 35 overs in the Duleep Trophy must have been great for him to get back his rhythm. But I wouldn't read too much into performance (no wickets). As a coach, would only like to look at Kuldeep's rhythm.

"I think 35 overs of match bowling is pretty good for him to get back his rhythm. And I am sure the conditions in Dubai would be conducive for Kuldeep. The grounds are big. The wickets also could be favourable. So, I see Kuldeep doing very well in the Asia Cup," he added.

India have three specialists --Kuldeep, Axar Patel and Varun Chakravarthy -- and Arun said it would be hard to leave any of them out. "Well, Varun has been an exceptional T20 bowler. He is kind of a match-winner. And so is Kuldeep Yadav. And Axar Patel brings in a lot with the bat.

"So, I think Axar would be used more as an all-rounder. And if the wickets are a little conducive, it will be a great idea to play all three spinners. Because each one has got a different variety. "They have experience. And they bring a lot to the table...But obviously, the condition of the pitch would matter a lot. Then if it does, then it will be a very, very difficult choice to pick just two of them. Very tempting to play all

### Curtain Raiser: Asia Cup is India's tournament to lose

DUBAI, Sept 8: Overwhelming favourites will be an understatement to define the Suryakumar Yadav-led India given the gulf between them and the seven other nations, including a mercurial Pakistan, when the battle for continental supremacy unfolds at the Asia Cup T20 tournament on Tuesday.

The action will begin with Afghanistan taking on Hong Kong in Abu Dhabi, but all eyes will be on Dubai, where a star-studded Indian team will be aiming to crush United Arab Emirates in its opener on Wednesday.

In a tournament that has often served as a dress rehearsal for the T20 World Cup, the Asia Cup this time comes with a sense of inevitability.

The weight of expectations is on the Indian team, not merely because of its pedigree but also because the balance of power has tilted decisively in its favour.

India, for all their internal debates and external expectations, look like the one side that has clarity of purpose. And clarity, in highpressure tournaments, often counts for more than raw talent.

If one takes into account leadership, and sheer depth of talent, then this is India's tournament to lose. Such has been the confidence that chairman of selectors Ajit Agarkar and head coach Gautam Gambhir didn't for once entertain the idea of picking a 17-member squad allowed by the Asian Cricket Council.

Instead, they picked 15 like they do for ICC events even if it meant keeping out players like Shreyas Iver and Yashasvi Jaiswal.

Winning the continental showpiece for the ninth time (seven in ODI format and one in T20 format in 2016) would neither earn Suryakumar or head coach Gautam Gambhir any extra credit.

But anything short of trophy would invite a deluge of criticism given that the T20 World Cup is set to be co-hosted by India and Sri Lanka in four and half months' time. Suryakumar and his colleagues have around 20 games (if they reach Asia Cup final) before the global event starts. Getting the core combination right would be a major goal for the side.

India is such a powerhouse that at this point BCCI has the ability to field three national T20 teams of

Suryakumar has been a phenomenal skipper so far with an astounding 80 per cent win record but now the leadership group will have vice-captain Shubman Gill, who is expected to take charge from the Mumbaikar in due course of time. How the T20 skipper and Test skipper align and sing from the same hymn sheet will certainly be watched with a lot of interest.

The manner in which Indian batters reinvented the grammar of T20 batting, largely due to IPL exposure, has been difficult to match for teams like Pakistan and Sri Lanka, who were on even keel till a decade and half back.

The broader storyline of the Asia Cup is therefore less about who can win it and more about who can stop India. Their depth dwarfs Pakistan's transitional experiment and Sri Lanka's rebuilt side. Salman Ali Agha's Pakistan team bears a young and fresh look.

The dropping of Babar Azam and Muhammad Rizwan is PCB's clearest admission yet that reputations cannot hold a team hostage. But their success will largely depend more on how Shaheen Shah Afridi, Haris Rauf, and Hasan Ali bowl against a flamboyant Indian batting line-up. (PTI)

# Sharath's retirement brought a lull but future of Indian TT looks bright: Dronacharya awardee coach

NEW DELHI, Sept 8: A rich talent pool of players promises a bright future for Indian table tennis despite the recent retirement of stalwart Sharath Kamal, said Dronacharya awardee coach Sandeep Gupta on Monday.

Gupta is currently busy with the conduct of the National Ranking Table Tennis Championship which has returned to Delhi after a long gap of 13 years.

The tournament attracting close to 3000 entries is an indicator of the growing interest in the sport across the length and breadth of India, said Gupta, who is also the childhood coach of star player Manika Batra.

"The future of table tennis is very bright. Earlier, the level set by Sharath Kamal was very high. After that, there was a gap in the talent pool.

"But now, our top players -Manush, Manay, Sathiyan, Harmeet, and Ankur Bhattacharya - are very prominent names in In-

dian table tennis," Gupta told PTI at the Thyagaraj Stadium, the venue for the national ranking

He feels it is a big deal for Delhi to host an event of this scale after a long hiatus.

'We are able to host the championship after a gap of 15 years. Our players used to participate outside of the national ranking tournaments, but this is the first time we are hosting it, because of this, close to 3000 players are participating.

"Spectators will get a chance to see their role models-national champions, Olympic participants, Asian Games medallists, and Commonwealth medallists. They will get an opportunity to understand their game, and in turn, improve their own. This is a big achievement in itself."

India regularly win medals at the Commonwealth Games and of late have also brought laurels at the Asian Games, competing with tra-



ditional table tennis powerhouses like China and Japan.

However, an Olympic medal in table tennis remans a work in

"As you can see, we have just defeated Japan. So, in the coming time, we were 2-0 up against China (Indian women in the world cham-

pionships). We hope our players will regularly defeat China and Japan in the near future. We just need to continue performing the way we are right now," said Gupta.

At the opening ceremony of the event, Delhi Chief Minister Rekha Gupta emphasized her government's commitment to sports, announcing the highest-ever cash rewards for international medal win-

Olympic medalists from Delhi will now receive ?7 crore for gold, ?5 crore for silver, and ?3 crore for bronze. For the Commonwealth Games, the rewards will be ?3 crore, ?2 crore, and ?1 crore respectively.

Gupta welcomed the announcement, noting the impact such incentives can have on athletes' motivation and future.

He also highlighted the achievements of Payas Jain, a rising star from Delhi who once held the world number one spot in the U-17 category, as an example of the capital's growing contribution to the national talent pool.

"The pool of players is strong. Our own Payas Jain, a player from Delhi, is performing very well. The depth of talent is impressive, and I am 100% hopeful that these players will bring medals to our country." (PTI)

Heading into the Asia Cup on the back of a woeful run, India put up a superlative display, defeating South Korea 4-1 in the final on Sunday, to not only end their barren run at the continental tournament but also seal the berth for next year's World Cup.

HANGZHOU (CHINA), Sept 8: Navneet Kaur and Mumtaz Khan dazzled with a hat-trick each as India stormed into the Super 4s with a commanding 12-0 victory over Singapore in the women's Asia Cup hockey tournament, here on Monday.

While Navneet (14', 20', 28') and Mumtaz (2', 32', 39') dominated the proceedings, a brace from Neha (11', 38') along with a goal each from Lalremsiami (13'), Udita (29'), Sharmila (45') and Rutuia Pisal (53') ensured another dominant victory for India.

The world No 10 India, who had earlier thrashed Thailand 11-0 in their tournament-opener, got off to a strong start when they broke the deadlock within the first two minutes. Mumtaz surged forward and unleashed a thunderous reverse stick shot from the top of the circle

to open the scoring. The early pressure kept Singapore on the back foot and although they managed to fend off India's first penalty corner in the eighth minute, Neha doubled the advantage, pouncing on a rebound in the 11th minute to slot it home with a deft touch.

### AIFF invites bids from consulting firms to manage process of awarding commercial rights

NEW DELHI, Sept 8: The All India Football Federation has invited bids from consulting firms to manage the process of awarding its commercial rights and among its major requirements are a minimum annual turnover of ₹ 100 crore in last five years and prior experience of executing at least five such deals.

The AIFF has issued a Request For Quotation (RFQ) in this regard and the last date of submission of bids is September 14.

The federation said the purpose of this RFQ is "to provide the bidder(s) with information that may assist them in the formulation of their propos-

The bidder must "be in existence and being in operation for at least five (5) years and having prior experience of man-

aging processes" for the award of commercial rights, the AIFF said in the RFO. "The Bidder should have an average annual turnover/receipt of a min-

imum of ₹ 100 Crores (Indian Rupees One Hundred Crores only) for the last five (5) Financial Years. "The Bidder must have

experience in executing at least five (5) similar assignments from at least three (3) distinct clients over the past five (5) years, which clients may be governments, sports federations and/or leagues in India," it said in the RFQ document under the subhead 'eligibility criteria'

The AIFF also made it clear it will not entertain bids from entities that are blacklisted/debarred by the central or state governments, or by any international or national sports federations.

"The selected bidder shall study the best practices of awarding rights like the commercial rights in football across the world and in consultation with AIFF, determine the optimal basket of rights that will constitute the commercial rights, and the strategy to award such rights to third parties, in a manner most beneficial to AIFF, from an operational and financial

Among other things, the work of the consulting firms will entail undertaking tasks such as "identifying and engaging with key stakeholders, preparing requisite documentation with detailed terms and conditions. and conducting background research and analysis for the preparation of the relevant documents, as and when required. During a hearing before the Supreme Court last month, the AIFF and

its current commercial partner FSDL (Football Sports Development Limited), which also organises the top-tier Indian Super League, submitted a consensual resolution to conduct an open, competitive and transparent tender (or equivalent process) for selection of a commercial partner to conduct the ISL in line with global best practices.

The AIFF and the FSDL agreed that the process will be concluded by October 15, 2025, thereby providing certainty to clubs, broadcasters, sponsors and other stakeholders.

Subject to the consent of the AFC, the ISL season can thereafter commence in December, they had told the court.

Crisis surfaced in Indian football after FSDL put the 2025-26 ISL season "on hold" on July 11 due to the uncertainty over the renewal of the Master Rights Agreement (MRA) with the national federation, prompting at least three clubs to either pause first-team operations or suspend player

#### Young pacer Callum Vidler ruled out of Australia A's tour of India

MELBOURNE, Sept 8: Queensland fast bowler Callum Vidler was on Monday ruled out of Australia A's upcoming whiteball tour of India due to a partial stress fracture, adding to the growing list of injured pacers from Down Under.

The 19-year-old joins Test captain Pat Cummins, Lance Morris and Brody Couch on the sidelines, further depleting Australia's fast-bowling stocks ahead of the tour. The series between the A teams of the two countries start on September 30.

Vidler's last appearance in professional cricket was in the Sheffield Shield 2024-25 final against South Australia in March when he picked up five wickets in a losing cause.

"Callum experienced some back pain during training and promptly reported it. Unfortunately, the scans came back confirming a stress fracture so he will spend some time recovering and then start a rehab plan, Queensland general manager of high performance Joe Dawes was quoted as saying in ESPNcricinfo. "He's naturally very disappointed but accepts that injuries are part of the game. We'll work closely with him to ensure he has the best recovery to get him ready for a return to cricket," Dawes added.

Prior to Vidler's withdrawal, Australia A had also lost Morris and Couch from the red-ball leg of the series against India, starting September 16, to injuries.

Couch had suffered a side strain but is expected to recover in time for the Shield season with Western Australia, while Morris is set to miss cricketing action for a vear. (PTI)

# Mohammed Siraj nominated for ICC's Player of the Month award for Oval heroics

DUBAI, Sept 8: India pacer Mohammed Siraj was on Monday nominated for ICC's Player of the Month Award for August for his heroics in the fifth and final Test of the England tour, along with New Zealand's Matt Henry and West Indies' Jayden Seales.

In a series marked by injuries to several players from both teams, Siraj stood tall and featured in all five Tests to play a decisive role with 23 wickets, the highest by any bowler in the rubber.

In the series starting in late June and culminating in early August, Siraj bowled 185.3 overs across the five Tests to help a young and inexperienced Indian team to force a 2-2 draw, without any drop in his

intensity. "Mohammed Siraj played just one match in August, but his brilliance in that outing was enough to earn him a nomination. The India right-armer was instrumental in the final Test of the Anderson-Tendulkar Trophy series against England at The Oval, where he claimed nine wickets at an average of 21.11," the ICC said on its website.

"With Jasprit Bumrah absent, Siraj led the attack with great determination, bowling more than 46 overs across two innings, after having featured in the previous four Tests in the series as well."

"He took four wickets in the first innings and followed it up with a stellar five-wicket haul in the second. His decisive spell in the final innings bowled India to victory and proved crucial in securing a 2-2 series draw. For his stellar effort, Siraj was named Player of the Match in the south London contest," the governing body added.

New Zealand's Henry was nominated for his stellar show in the



Kiwis' Test series victory in Zimbabwe, in which the right-arm

pacer claimed 16 wickets. Henry took 6/39 and 3/51 in the first Test and 5/40 and 2/16 in the second to help his side record a 2-

"Matt Henry was the standout performer in New Zealand's 2-0 Test series win over Zimbabwe, claiming 16 wickets across two matches at an astonishing average of 9.12," the ICC said.

Seales, meanwhile, was rewarded for playing a "pivotal role" in West Indies' first ODI series win over Pakistan in 34 years. Seales took 10 wickets in three matches including 6/18 in the final ODI in which Pakistan were shot out for a mere 92, chasing 295.

"He had a quiet start in the opening ODI, managing only one wicket while conceding 59 as Pakistan cruised to victory. However, Seales bounced back brilliantly in the second match, striking with three wickets in seven overs, including the prized scalps of Babar Azam and Saim Ayub," the ICC

"The third ODI saw Seales at his lethal best, dismantling Pakistan's batting with a career-best 6/18 the third-best figures by a West Indies bowler in ODI history — to seal the series in emphatic fash-

# From desk jobs to Asia Cup, Oman's cricket inspiring story

**NEW DELHI, Sept 4:** From long in 2011 got a proper turf ground. There days at office desks to late evenings on cement pitches, Oman's cricketers have fought a battle few noticed beyond their own dressing room.

That constant hustle now takes them to the Asia Cup, where captain Jatinder Singh and all-rounder Sufyan Mehmood carry not just their team's hopes but also the story of a nation determined to carve its place in world cricket.

"When we started, our primary job was to get a job; cricket was secondary for us," Jatinder told PTI Videos.

"Most boys worked in offices and then managed cricket on the side. But will say now that it's a dream come true to represent Oman in the Asia Cup. Our camp is really excited and looking forward to the tournament", he added.

Jatinder spoke more his early struggles of playing cricket in Oman.

"Initially, we never had turf grounds." We started on cement wickets, then moved to Astro Turfs in 2008, and only

were times I thought, why am I putting in so much without results? But the hunger and passion kept us going," said

That harsh reality meant many talented players walked away. But those who stayed on like Jatinder and Sufyan, carried the torch.

Jatinder, 36, has scored 1,704 runs in 36 ODIs with four centuries and a best of 118\*, alongside 1,120 T20I runs at a strike rate above 115. Sufyan, 34, has featured in eight ODIs, scoring 107 runs with a top score of 72 and taking six wickets at 24.50.

For Sufyan, the resistance came from

"When I joined the national team, my parents told me Oman cricket had no future and I should focus on studies and work. But the self-belief was always there. The hunger to play kept me going. When we made it to the 2016 World Cup, I felt all our hard work had paid off," he said.



In 2015, Oman gained T20I status by defeating Namibia in the World T20 Qualifier, paving the way for their maiden global appearance the following year. In the 2016 World T20, they

stunned Ireland in their opening match before rain spoiled their game against the Netherlands and a defeat to Bangladesh ended their run. That World Cup debut proved to be the

turning point.

"After our 2016 T20 World Cup campaign the journey truly started. Discipline, professionalism, coaching, everything changed. Players started enjoying the game more. Fast forward to 2025, now the team is hungrier than ever," Jatinder said.

Now the challenge is bigger than ever, with Oman drawn alongside India, Pakistan and UAE in group A. "We want to play fearless cricket. At

least we will know where we stand because we hardly get chances against top teams. It is a golden opportunity," Jatinder explained.

For Oman, the highlight of the Asia Cup will be standing across from world champions India. A chance to measure themselves against the very best.

When asked which Indian stars he looks up to, Jatinder was quick to name a few in "Shubman Gill, Surya paaji (Suryakumar Yadav), Abhishek paaji (Abhishek Sharma), Arshdeep (Singh), Tilak Varma

For Sufyan, the admiration was for none other than star all rounder Hardik Pandva.

"The way he handles both batting and bowling. But honestly, I'd like to learn from most of the Indian team — how they prepare, how they handle pressure. Every moment with them will be a learning.

Beyond the tournament, Oman cricket is focused on building a sustainable future. With deputy head coach Sulakshan Kulkarni spearheading structured programs in schools, efforts are underway to introduce cricket to a wider pool of young Omanis despite football's domi-

"Cricket takes time, effort and equipment to popularise, but the work is underway," Jatinder said.

"The academy coaches are visiting schools, teaching the basics, and nurturing talent from a young age. The goal is to create a pipeline of skilled players who can carry Oman cricket forward for years to come." (PTI)
