Zubeen's death: Two band members get 14-day police remand

GUWAHATI, Oct 3: A court in Assam on Friday sent Zubeen Garg's band members Shekharjyoti Goswami and Amritprabha Mahanta to 14 days of police remand in connection with the death of the singer-composer.

Munna Prasad Gupta, the Special DGP of the Criminal Investigation Department (CID), told PTI that the Chief Judicial Magistrate of Kamrup Metropolitan district accepted the plea for further interrogation and sent the duo to 14 days of police remand.

"The interrogation of all the four arrested accused is underway. I cannot share anything more at this moment," he said.

Drummer Goswami and co-singer Mahanta were arrested on Thursday after days of interrogation. The two were present on the yacht in Singapore when Garg died while swimming in the sea on September 19.

Police have already invoked murder charges against Garg's manager Siddharth Sharma and festival organiser Shyamkanu Mahanta, who were nabbed from Delhi on Wednesday. They are also in CID custody for 14 days.

Garg had gone to the Southeast Asian nation to attend the 4th edition of the NorthEast India Festival, organised by Shyamkanu Mahanta and his company.

More than 60 FIRs have been lodged across Assam against Mahanta and around 10 others, including Garg's manager.

Talking about the second post-mortem examination of Garg conducted in Guwahati, the Special DGP said they are awaiting the final report, as the viscera samples have been sent to Delhi.

"We had sent the viscera samples to the Central Forensic Laboratory (CFL) in Delhi for a detailed examination. Once that report is received, the post-mortem report by the Gauhati Medical College and Hospital will be ready and available to us," he said.



Gupta is heading a nine-member Special Investigation Team (SIT) to probe into the death of the singer in Singapore.

Asked about the investigation into an alleged financial scam involving Shyamkanu Mahanta, the senior police officer said: "Our probe is underway. We are analysing every detail, but I cannot share anything more."

The CID had earlier initiated a separate probe against event manager Mahanta for alleged financial crimes and acquiring benami properties through money laundering.

The agency had seized incriminating documents and items from his home during raids on September 25-26, including multiple PAN cards in the name of the same firm, nearly 30 stamp seals of different companies and government officials, and documents related to several benami properties.

Mahanta is the younger brother of former DGP Bhaskar Jyoti Mahanta, who is presently the chief information commissioner of the (CONTD. ON PAGE-2)

Judicial commission to probe Zubeen's death case: Himanta

Shyamkanu moves SC seeking protection, CBI or NIA probe in iconic singer's death case

GUWAHATI/NEW DELHI, Oct 3: Chief Minister Himanta Biswa Sarma on Friday said a judicial commission will be formed to probe the death of the state's cultural icon Zubeen Garg.

The commission will be headed by Justice Soumitra Saikia of the Gauhati High Court, he said in a Facebook live.

"We will form the commission tomorrow. Now, we request all the people who have any information or videos related to Zubeen Garg's death to come forward and depose in front of the commission," he added.

Garg died under mysterious circumstances in Singapore on September 19 while swimming in the sea. He had gone to the Southeast Asian nation to attend the 4th edition of the NorthEast India Festival.

The CID is currently probing the case of Garg's death after more than 60 FIRs were lodged across the state.

Meanwhile, a petition has been



filed in the Supreme Court by Shyamkanu Mahanta, chief organiser of the Northeast India Festival, seeking transfer of probe into the death of Assamese singer Zubeen Garg from the state police's SIT to a central agency such as the CBI or the NIA.

Police have invoked murder charges against Garg's manager, Siddharth Sharma and Mahanta, who were nabbed from Delhi on Wednesday. They are also in CID custody for 14 days.

According to the petition, the Singaporean authorities have initiated their own inquiry, but they have not found any element of foul play or culpability attributable to Mahanta.

Mahanta, in his petition, which was filed through advocate Raj

Kamal on September 30, has made the Centre, Assam government, the state's Director General of Police, the Central Bureau of India (CBI) and the National Investigation Agency (NIA) as respondents.

The plea alleged that Mahanta, who is the brother of Assam's Chief Information Commissioner Bhaskar Jyoti Mahanta, has been subjected to a "vicious media trial" and "scapegoating" in connection with Garg's sudden death.

It said that despite this, the Assam Police registered a case under the Bharatiya Nyaya Sanhita for criminal conspiracy, culpable homicide not amounting to murder, and causing death by negligence.

Over 54 FIRs have reportedly been filed against Mahanta across Assam and other northeastern states, it said.

Mahanta contended that he has been unfairly vilified by both the state machinery and the media.

The plea said he was busy organising the three-day cultural festival in (CONTD. ON PAGE-2)

Three NEIF team members summoned

GUWAHATI, Oct 3: The SIT, probing into the death of singer Zubeen Garg, on Friday interrogated three members of the organising team of North East India Festival (NEIF) with the Special Director General of Police Munna Prasad Gupta asserting that the case will reach 'its logical conclusion'.

The three who had accompanied Garg to Singapore to take part in the NEIF, where he died on September 19, have been remanded to 14 days' police custody. Gupta who heads the SIT told reporters here.

Four people who had gone to attend the NEIF have been arrested so far in the case - the singer's manager Siddhartha Sharma and his musician Shekhar Jyoti Goswami, the festival organiser Shyamkanu Mahanta and singer Amritprabha Mahanta.

The arrested people are being interrogated, Gupta said.

"We will ensure that there will be no lapse on our part during the investigation," the SDGP said.

The aim of the SIT is to ensure that the case 'reaches its logical conclusion,' he added.

Gupta had earlier said that the investigations were 'proceeding on fast track'.

Meanwhile, three members of the NEIF organising team - Pankaj Adhikari, Pritam Talukdat and Krishanu Das - were summoned by the SIT for interrogation.

They, however, did not respond to questions from journalists.

Sharma and Mahanta were arrested in Delhi on Wednesday morning in connection with the singer's death and were also remanded to 14 days' police custody.

TRAI releases recommendations for roll out of digital radio

NEW DELHI, Oct 3: The Telecom Regulatory Authority of India (TRAI) on Friday released the recommendations on the digital broadcast policy that allows analogue FM radio channels to add a digital layer along the same frequency.

The recommendations on 'Formulating a Digital Radio Broadcast Policy for Private Radio Broadcasters' also call for a single technology standard across the country and auction of new frequencies in 13 cities, a move that is considered the first step towards the digital shift of India's FM radio.

The Ministry of Information and Broadcasting (MIB) had written to TRAI in April last year, asking

for recommendations for formulating a digital radio broadcast policy.

The first phase of the rollout will cover four A Plus cities - Delhi, Mumbai, Kolkata and Chennai and nine A category cities - Hyderabad, Bengaluru, Ahmedabad, Surat, Pune, Jaipur, Lucknow, Kanpur and Nagpur.

TRAI has recommended the auction of two new spot frequencies in each of these 13 cities. The reserve prices have been fixed city-wise. Mumbai (₹ 194.08 crore), followed by Delhi at ₹ 177.63 crore, Chennai at ₹ 146.68 crore and Kolkata at ₹ 79.96 crore.

In the A category, Bengaluru has been fixed at ₹ 87.22 crore,

Hyderabad at ₹ 65.85 crore, Pune at ₹ 41.26 crore, Ahmedabad at ₹ 40.44 crore, Nagpur at ₹ 29.48 crore, Jaipur at ₹ 26.89 crore, Surat at ₹ 25.89 crore, Lucknow at ₹ 24.59 crore and Kanpur at ₹ 20.52 crore.

It has also recommended that India adopt a single digital radio technology standard in the VHF Band II, with the government selecting the standard either through consultations with stakeholders such as broadcasters and receiver manufacturers.

The recommendations state that digital radio services should be commenced in simulcast mode by new broadcasters. The existing analog FM Radio broadcasters should also (CONTD. ON PAGE-2)

ED, I-T likely to join CID in probing Shyamkanu's fiscal scam

GUWAHATI, Oct 3: The Enforcement Directorate (ED) and Income Tax (I-T) Department are likely to join the Assam Police in investigating alleged organised financial crimes and acquisition of benami properties by event manager Shyamkanu Mahanta, an accused in the death of Assam's cultural icon Zubeen Garg.

The Criminal Investigation Department (CID) of Assam Police has also unearthed more than 20-year-old financial irregularities allegedly committed by Mahanta during his earlier job at a non-banking financial company (NBFC).

Sources privy to the development told PTI that officials from ED and the I-T Department have

already visited the CID headquarters to look into the case.

Assam Police have initiated a separate probe against festival organiser Mahanta for "organised financial crimes" and "acquiring huge amounts of benami properties through money laundering".

"The ED and the I-T Department have visited the CID office and discussed the case with senior officials. They are likely to join the probe with CID, and a formal decision may come very soon," a source said.

The CID seized bundles of incriminating documents and items from Mahanta's home during raids on September 25 and 26, such as multiple PAN cards in the name of the same firm, nearly 30

stamp seals of different companies and government officials, and documents related to several benami properties.

The source, however, declined to share further details, saying that more information in the public domain at this moment may jeopardise the investigation.

To a query whether the ED and the I-T Department will join the probe against Mahanta's alleged fiscal irregularities, CID Special DGP Munna Prasad Gupta told PTI, "I cannot comment on their behalf. It is up to them to decide."

MOSCOW, Oct 3: Russian President Vladimir Putin has ordered to devise measures, including purchasing more agricultural products and medicines from India, to soften the trade imbalance with New Delhi, which is due to the heavy import of crude by the country.

Speaking at the Valdai plenary session on Thursday, Putin also said that he was looking forward to his trip to India in early December and meeting with "my friend and our reliable partner Prime Minister (Narendra) Modi."

Putin, who will travel to India in early December for an annual summit, lauded India's nationalist government led by PM Modi, calling him a "balanced, wise," and "nationally oriented" leader. Putin said

Pakistan lost 12-13 aircraft including F-16 during Operation Sindoor: Air Chief Marshal Singh

NEW DELHI, Oct 3: At least a dozen Pakistani military aircraft including F-16 jets were destroyed or damaged in Indian strikes during Operation Sindoor, Chief of Air Staff Air Chief Marshal A P Singh said on Friday while describing Islamabad's claim of India's losses as "fanciful stories" (Manohar Kahaniyan).

The Air Chief Marshal also said that the Indian action damaged a large number of military infrastructure in Pakistan that included hangars in three locations, radars in at least four places, command and control centres in two sites and runways in two air bases.

Air Chief Marshal Singh was addressing a press conference days ahead of the annual Air Force Day.

One dead, four injured in fire at Fancy Bazaar

GUWAHATI, Oct 3: At least one person was killed and four others were injured in a fire at a cloth market in Assam's Guwahati on Friday, officials said.

The blaze erupted at a commercial establishment in Fancy Bazaar area of central Guwahati. Fire and Emergency Services Director Surendra Kumar said.

"We received intimation at 4:21 am and immediately our team reached the spot. Altogether, 16 fire tenders were pressed into service," he told PTI.

Kumar said the fire has been contained.

"It was not an easy type of fire to control, as the cloth market had a variety of materials. Our personnel have entered the basement now and are clearing the area," he said.

India a 'stabilising force' in global economy, can withstand external shocks: Sitharaman

NEW DELHI, Oct 3: Finance Minister Nirmala Sitharaman on Friday said the world is facing "profound imbalances" in trade and energy security, and is undergoing a structural transformation, with India standing out as a 'stabilising force' that can withstand external shocks.

Sitharaman said geopolitical conflicts are intensifying, and sanctions and tariffs are reshaping global supply chains. India must continue to remain vigilant, and there is no room for complacency, she said, speaking at Kautilya Economic Conclave 2025 here.

"Wars and strategic rivalries are redrawing the boundaries of cooperation and conflict. Alliances that once appeared solid are being tested, and new coalitions are emerging. For India, these dynamics highlight both vulnerability and resilience. Our capacity to absorb shocks is strong, while our economic leverage is evolving," she said.

She said the world is facing an era of unprecedented global uncertainty and volatility, and the task before nations is not only to manage uncertainty but to confront trade, financial and energy imbalances.

"The task before us, therefore, is not simply to manage uncertainty but to confront imbalance. We must ask ourselves: how can we build a global order where trade is fair, finance serves productive ends, energy is both affordable and sustainable, and climate action aligns with de-



velopment imperatives?" the minister said, addressing a session on 'Seeking Prosperity in Turbulent Times'.

She said there is a need to work on ways for international institutions to reflect today's realities rather than yesterday's hierarchies, besides ensuring that the voices of developing nations are no longer marginalised in rule-making, and are instead amplified in shaping the future.

Further, Sitharaman said dislocations define this new global era wherein trade flows are being reshaped, alliances are being tested, investments are being rerouted along geopolitical lines, and shared commitments are being re-examined. "Thus, what we face is not a temporary disruption but a structural transformation," Sitharaman said.

She added that the foundations of the global order are shifting as the world that emerged after the end of the Cold War, which led to the

expansion of globalisation, open markets and the pursuit of multilateral cooperation, now appears to be a relic of the past.

For three decades, a contested equilibrium allowed nations to pursue prosperity through integration and interdependence. That equilibrium has inevitably been upended, and the rules of international engagement are being rewritten, she said.

The global economy is currently facing headwinds, from an increase in trade tensions, higher tariffs, heightened global policy uncertainty and the ongoing Russia-Ukraine conflict.

Sitharaman said the global economy is faced with low investment, high cost of capital, volatile energy prices, and the tension between growth, stability, and sustainability.

In this context, India's rise as a stabilising force is neither accidental nor transient; instead, it results from a powerful combination of factors, she said.

Over the past decade, Sitharaman said, the government has focused on fiscal consolidation, improving the quality of capital expenditure, and reining in inflationary pressures.

"With the steady share of consumption and investment in the overall GDP over the years, India's growth is firmly anchored in its domestic factors, which minimises the impact of external shocks on overall growth. As a result, the Indian economy is resilient and continues to grow sustainably," she said. (PTI)

GUWAHATI, Oct 3: LG Electronics India Limited (LGEIL), a wholly owned subsidiary of LG Electronics Inc., will launch its Initial Public Offering (IPO) on October 7.

The price band has been fixed at ₹1,080 to ₹1,140 per equity share, the company announced. The anchor investor bidding date is scheduled for October 6. The IPO will remain open for subscription from October 7 to October 9. Investors can bid for a minimum of 13 equity shares and in multiples thereafter. Eligible employees will be offered a discount of ₹108 per share in the employee reservation portion.

The IPO consists entirely of an offer for sale of up to 10.18 crore equity shares of face value ₹10 each by the promoter, LG Electronics Inc. The shares are proposed to be listed on the NSE and BSE.

Sensex, Nifty extend gains to 2nd day as metal shares sparkle

MUMBAI, Oct 3: Benchmark indices Sensex and Nifty advanced for the second straight session on Friday, powered by buying in metal and telecom stocks following a firm trend in global markets.

After swinging between gains and losses for most of the session, the 30-share BSE Sensex climbed 223.86 points, or 0.28 per cent, to settle at 81,207.17. During the day, the index touched a high of 81,251.99 and a low of 80,649.57, gyrating 602.42 points.

As many as 2,710 stocks advanced while 1,490 declined and 139 remained unchanged on the BSE.

The 50-share NSE Nifty edged higher by 57.95 points, or 0.23 per cent, to 24,894.25.

On the weekly front, the BSE benchmark climbed 780.71 points or 0.97 per cent, and the Nifty went up by 239.55 points or 0.97 per cent. "After a period of range-bound trading, the market closed on a positive note, supported by gains in metal and consumer durables stocks. Optimism over a potential Fed rate cut in October, a weakening dollar, and stable base metal prices drove the rally in metal indices.

"Consumption stocks are on a buzz led by reforms, a good monsoon and moderation in inflation, upsizing demand as disposable income increases," Vinod Nair, Head of Research, Geojit Investments Limited, said.

From the Sensex firms, Tata Steel climbed the most by 3.40 per cent, followed by Power Grid, Axis Bank, Kotak Mahindra Bank, Larsen & Toubro, Bharat Electronics and Bharti Airtel. In contrast, Tech Mahindra, Maruti, UltraTech Cement and Bajaj Finserv were among the major laggards.

"The market's move was largely driven by domestic factors. The RBI's recent monetary policy -- holding rates steady while upgrading the growth outlook and lowering inflation guidance -- continued to boost confidence in rate-sensitive sectors, particularly banking. Additionally, earnings updates ahead of the reporting season reinforced the positive undertone," Ajit Mishra - SVP, Research, Religare Broking Ltd, said.

The BSE smallcap gauge jumped 1.09 per cent, and the midcap index went up by 0.78 per cent.

The BSE metal index jumped 1.85 per cent, with companies, such as Lloyds Metals and Energy surging 6.18 per cent, National Aluminium Company (3.10 per cent), and Jindal Stainless (2.87 per cent).

Among other sectoral indices, industrials jumped 1.28 per cent, telecommunication (1.16 per cent), consumer durables (1.15 per cent), commodities (1.12 per cent), capital goods (1.02 per cent) and utilities (0.95 per cent).

"Capital goods sector remained under focus on the back of reiteration from the Finance Minister that the government's commitment to increase capital expenditure to support growth remains intact," Siddhartha Khemka - Head of Research, Wealth Management, Motilal Oswal Financial Services Ltd, said.

Realty and healthcare were the laggards. Foreign Institutional Investors (FIIs) offloaded equities worth ₹ 1,605.20 crore on Wednesday, while Domestic Institutional Investors (DIIs) bought stocks worth ₹2,916.14 crore, according to exchange data.

In Asian markets, Japan's Nikkei 225 index settled sharply higher, while Hong Kong's Hang Seng index ended lower. The stock market in China and South Korea's Kospi were closed for a public holiday.

Equity markets in Europe were trading higher in mid-session deals.

US markets ended in green on Thursday. Global oil benchmark Brent crude climbed 0.86 per cent to USD 64.61 a barrel.

"Brent crude prices fell for the third straight session to a 16-week low as concerns over a potential US government shutdown and expectations of higher OPEC+ supply weighed on the market. Lower crude prices ease concerns on India's import bill and inflation, which is positive for domestic equities," Khemka said.

Equity markets were closed on Thursday for Mahatma Gandhi Jayanti and Dussehra. (PTI)

Singapore scheduled for September 19-21 and was not present at the site of Garg's death.

It said Mahanta last met the singer on September 17, two days before the incident. The plea sought transfer of the probe from the Assam SIT to the CBI or the NIA, and that it be monitored by a retired Supreme Court judge. It sought a direction to the Assam Police to restrain itself from taking coercive measures against Mahanta, including arrest, detention, or harassment.

It also sought the suspension of the Look-Out Circular against Mahanta and to allow him to return and join the investigations.

Besides, the plea sought preservation of crucial evidence, including Garg's post-mortem report, Singapore investigation records, video footage of the incident, and medical history pointing to the singer's prior health conditions, such as epileptic fits.

It sought the de-sealing of his properties and freezing of bank accounts belonging to him and his family. It also sought a direction to the media and social media platforms to cease prejudicial coverage until investigations are complete.

"The petitioner is a victim of a well-calculated witch-hunt involving irresponsible media reportings, both print and electronic, which seek to create a false narrative with regard to the alleged involvement of the Petitioner in the sad and unfortunate demise of his very dear personal friend, Zubeen Garg," it said.

This is a classic case where the petitioner, who himself is grieving due to the passing away of his personal dear friend, has been made the target of public hate and has not been allowed to even pay his respects at the last rites of the late singer, it said. (PTI)

the chief organiser of the North East India Festival, where the singer had gone to perform, and almost 10 others, including the icon's manager Siddharth Sharma and band members Shekharjyoti Goswami and Amritprabha Mahanta.

Special DGP Gupta is heading a nine-member Special Investigation Team (SIT) to probe into the untimely death of Garg in Singapore. Already, four people have been arrested and sent to 14 days of police remand each.

Shyamkanu is the younger brother of former DGP Bhaskar Jyoti Mahanta, who is presently the Chief Information Commissioner of the Assam State Information Commission. Another elder brother of his is Nani Gopal Mahanta, who was the Education Advisor to CM Himanta Biswa Sarma before becoming the Vice Chancellor of Gauhati University.

Another source, on condition of anonymity, said that CID has unearthed more than 20-year-old financial irregularities allegedly committed by Shyamkanu Mahanta when he was working as the Assistant General Manager with the North Eastern Development Finance Corporation Ltd (NEDFi).

"During the course of the investigation, it was found that he, along with two GMS, had given over ₹ 14-crore loan to a company named DSS E-Connect Ltd for opening call centres in Assam. Out of the total amount, ₹ 8.42 crore was disbursed in 2001 and ₹ 6 crore in 2003," he added.

When no call centre was established and no EMI was paid to repay the loan till 2003, an internal probe was initiated by NEDFi in early part of 2004, but it was never completed, the source said.

Prior to the internal probe, the loan to DSS was declared Non-Performing Asset (NPA) on March 31, 2003, he added.

"Mahanta was the project manager of the entire work. In 2004 end, he resigned from NEDFi and joined the Infrastructure Leasing & Financial Services (IL&FS) as its Vice President. Later, he left that job too and started his own event management firm, Trend MMS," the source said.

Garg died under mysterious circumstances in Singapore on September 19 while swimming in the sea. He had gone to the Southeast Asian nation to attend the 4th edition of the North East India Festival, organised by Shyamkanu Mahanta and his company.

From the search operation at Mahanta's home last week, the sleuths of the CID seized two PAN cards in the name of his event organising company, 'Trend MMS'.

Further, 28 stamp seals were recovered from his office premises. These included seals in the name of various companies and many government officials.

Several documents were also recovered inside the residence and the office premises of Mahanta, pertaining to the construction of roads under the PMGSY scheme in various districts of Assam as well as in Arunachal Pradesh. (PTI)

nation," Putin added. He was referring to the additional 25 per cent tariff imposed by President Donald Trump on New Delhi as a penalty for its purchases of Russian oil, taking the total levies imposed on India by the US to 50 per cent.

Putin said Russia may buy more agricultural products and medicines from India to remove the trade imbalance. "More agricultural products may be purchased from India. Certain steps can be undertaken from our side for medicinal products, pharmaceuticals," Putin stated.

The president said he had instructed the Russian government to think of proposals to be made to "Indian friends and counterparts on the most promising areas of cooperation and how Russia can smoothen the imbalance in trade and other areas," according to state-run news agency TASS.

Putin noted the vast potential for economic cooperation between Russia and India but acknowledged the need to resolve specific issues to fully unlock these opportunities.

For comparison, he said, the trade turnover between Russia and India is about USD 63 billion, and USD 50 billion with Belarus. "At the same time, the population is 1.5 billion in India and 10 million in Belarus. It obviously does not correspond to our potential opportunities," Putin stressed. (PTI)

Pakistan lost 12-13

have signs of one C-130 class of aircraft, one AEW&C (Airborne Early Warning & Control) class of aircraft and at least four to five fighter aircraft, most likely F-16, were hit on the ground, he said.

Sharing details of strikes in the air, the Chief of Air Staff said the IAF has clear evidence of one long-range strike with more than 300 km range hitting an AEW&C or SigNit (Signals intelligence) aircraft, along with five high-tech fighters between F-16 and JF-17 class.

"This is what our system tells us," he said.

While there were reports of damages to Pakistan's F-16 jets in a hangar, it was the first time the IAF confirmed hitting the US-manufactured jet in the air. The JF-17 is a Chinese jet.

The details shared by the IAF Chief takes the total number of aircraft lost by Pakistan to 12 to 13. On Pakistan's claim of shooting down Indian aircraft, the IAF chief called that narrative as "Manohar Kahaniyan".

"Let them be happy, as they need to show something to their audience to protect their reputation. It doesn't matter to me," he said "If they think they shot down 15 of my jets, let them think about it. I hope they're convinced about it, and they'll cater for 15 less aircraft in my inventory when they come to fight again," he said.

The Chief of Air Staff declined to divulge details of India's losses during the May 7 to 10 hostilities. "I won't say anything on what happened, how much damage was done, how it happened, because let them find out," he said.

Air Chief Marshal Singh also questioned the veracity of Pakistan's claim on damages to India. "Have you seen a single picture where something fell on any of our airbases, something hit us, a hangar was destroyed, or anything like that? We showed so many pictures of their places," he said.

"However, they couldn't show us even a single picture. So, their narrative is 'Manohar Kahaniyan'. Let them be happy," he said. In response to the Pahalgam terror attack, India launched Operation Sindoor on May 7, targeting terrorist infrastructure in territories controlled by Pakistan.

The strikes triggered four days of intense clashes that ended with an understanding on stopping the military actions on May 10. To a question, the IAF chief said all three services have started working on the 'Sudarshan Chakra' air defence system. (PTI)

Assam Valley School employee battles for life

GUWAHATI, Oct 3: A heart-wrenching plea has emerged from a family in Tezpur as 56-year-old Girin Chandra Kalita, a senior employee at the Assam Valley School, Balipara (Sonitpur), battles for his life following a massive brain hemorrhage. Kalita, who is the sole breadwinner for his family of four, is currently in the Intensive Care Unit (ICU) at Dorika Hospital, Tezpur.

According to medical reports from TIMEs Hospital, Kalita suffered a 5.4 cm-sized sub acute hematoma in the right gangliocapsular region of his brain. His condition remains critical, with doctors warning of the high risk of another fatal stroke if immediate and prolonged treatment is not administered.

The family shared their desperation: "He is the only earning member in the family. The ICU costs are overwhelming—around ₹ 25,000 per day. We simply cannot keep up." The MRI scan reveals severe compression in vital brain areas, further complicating the situation. Kalita's daughter, Jinti Kalita, has taken to social media and public platforms seeking financial support for his ICU treatment and life-saving medicines.

"We are reaching out with folded hands, requesting support in this most difficult time," Jinti wrote. "Your donation no matter how small can save his life."

Nine Dimasa workers die in construction site

DIPHU, Oct 3: A tragic incident has claimed the lives of nine migrant labourers—four from Karbi Anglong and five from Hojai—who were working at the Ennore SEZ Supercritical Thermal Power Project construction site in Ooranambedu, Tiruvallur district near Chennai. The accident occurred on September 30 when a steel arch of an under-construction structure collapsed, killing all nine on the spot. One worker was seriously injured.

All the deceased belonged to the Dimasa community. The four from Karbi Anglong hailed from Dhanisri Misibailam (two workers), Hawaipur, and Uttar Borbil, while the remaining five were from the Kurnakata locality in Hojai district.

In a press statement, the All Dimasa Students Union (ADSU) identified the deceased as Munna Kemprai, Sorbojit Thaosen, Phaibit Phonglo, Bidayum Parbosa, Dimaraj Thaosen, Prayanta Sorong, Paban Sorong, Sumon Kharikapsa, and Dipak Rajiyung.

The ADSU expressed deep sorrow over the tragic loss and called for a thorough investigation into the incident, demanding proper safety protocols to be enforced at such construction sites to prevent future tragedies.

The Dimasa Students Union (DSU) also issued a statement, urging both the Assam and Tamil Nadu administrations to handle the matter with urgency, ensure timely repatriation of the bodies, and provide full support to the bereaved families.

Meanwhile, the Karbi Students Association (KSA), Diphu District Committee, voiced strong condemnation and grief over the incident. The KSA demanded a high-level inquiry and urged the authorities to provide a compensation of at least Rs 25 lakhs to each victim's family along with government jobs as part of rehabilitation measures.

The KSA further blamed the Karbi Anglong Autonomous Council (KAAC) and the NC Hills Autonomous Council (NCHAC) for the ongoing unemployment crisis that compels local youths to migrate for work. They accused elected leaders of nepotism, corruption, and failing to create job opportunities in the hill districts, warning that such leadership failures could lead to further crises among tribal communities.

Youth stabbed during Durga idol immersion

DIBRUGARH, Oct 3: Tension gripped Dibrugarh town on Thursday evening after a youth was stabbed during a Durga Puja idol immersion procession. The injured has been identified as Ashish Pandey, a resident of Graham Bazar.

Pandey, who sustained injuries in the stomach, was rushed to Assam Medical College and Hospital (AMCH) where he is undergoing treatment.

His condition is reported to be stable.

According to Pandey, he was attacked in the Phoolbagan area by one Sujit Shah during the immersion procession.

"He called me during the procession and spoke with me for a while. Suddenly, he stabbed me. A few minutes later, I realised blood was flowing from my stomach," Pandey told reporters from his hospital bed.

He further alleged that Shah was involved in selling narcotics in the locality.

"Sujit Shah sells ganja and other narcotic items near our area. We had objected to it earlier. Out of grudge, he attacked me," Pandey said.

Following the incident, an FIR was lodged at the Dibrugarh police station.

SIR opposed in Kerala

The Communist Party of India (Marxist) has hardened its stand on the Election Commission's decision to conduct a Special Intensive Revision (SIR) of electoral rolls in the State in the short run-up to the local bodies' elections later this year and the Assembly polls nearly next year. The CPI(M) State Secretariat said, in a strongly worded statement, that the exercise will disenfranchise as many as 50 lakh voters in Kerala. CPI(M) state secretary M. V. Govindan said the hasty decision is fundamentally flawed. In support of his argument, Govindan said that Kerala's population had increased, in the past 23 years, by 1.57 crore. Similarly, the number of polling booths has also risen by 10,000. Govindan accused the Election Commission of acting at the instance of the BJP. The move has made inclusion on the latest voters' list impossibly difficult for a large section of the population. For instance, the EC, he contended, does not accept Kerala's ration cards as a valid identity. Instead, it has asked the voters to produce a set of 12 difficult-to-get documents, including proof of parentage, nativity and domicile, to be enlisted as a voter. The EC has deliberately introduced extensive red tape, rendering the task of registration extremely difficult. It may be mentioned that, initially, it had refused to accept Aadhaar cards as proof of identity. It changed the stance only after being pulled up by the Supreme Court.

Even the State's Chief Election Commission's word of caution has been ignored by the EC. The exercise would stretch the State's resources thin as it moves into the election mode, he added. The NCR will prepare the ground for categorizing large sections of the people as illegals earmarked for deportation. Govindan also said that the NCR, a Sangh Parivar agenda, is loaded against the minorities, Dalits, tribals, backward classes, refugees, economically disadvantaged sections, and legal immigrants. It is also inextricably linked to the anti-Muslim Citizenship (Amendment) Act (CAA)," he claimed. The EC's SIR in Bihar, he argued, had disenfranchised an estimated 65 lakh voters majority of whom were Muslims and members of the marginalized and economically disadvantaged sections. The CPI(M) has also signalled its intent on holding a National Seminar on SIR in October, which will be attended by top politicians, jurists, writers, thinkers and intellectuals. The seminar will record its protest against the EC's politically partisan efforts to undermine democracy and destroy the credibility of the elections.

In response to the request of Kerala's political parties, State Chief Electoral Officer R. Kelkar had urged the Election Commission of India (EC) to postpone the SIR until after the local bodies polls in 2025 and include the ration card as a valid identification document.

Transparent administration and effective measures against corruption

This law enables the public to access information about government activities, enhancing administrative transparency and reducing the likelihood of corruption. In India, the Right to Information Act, 2005, empowers the public to monitor government activities. Through this law, citizens can access details about government project budgets, expenditure records, and other information. However, there are still shortcomings in its implementation, such as delays in providing information or incomplete disclosures. To address these issues, the enforcement process of the Right to Information Act must be strengthened.

Administrative reforms are crucial for ensuring accountability and combating corruption. Establishing a clear code of conduct for administrative officials, regular monitoring of their work, and a transparent recruitment process to appoint efficient and honest personnel are necessary steps. Additionally, reg-

ular training programs for administrative staff should be conducted to foster awareness of ethical values. Training programs focused on ethics and integrity enhance officials' sense of responsibility. Independent auditing institutions also play a vital role in increasing administrative transparency. Such institutions can monitor government activities and reduce the potential for corruption.

The use of technology is a critical step in reducing corruption in the modern era. E-governance enhances the transparency of administrative processes. Online portals for delivering government services reduce the role of intermediaries, thereby decreasing opportunities for corruption. Digital payment systems have increased the transparency of government transactions. Systems like electronic bidding have brought transparency to government contract processes. Additionally, online grievance redressal mechanisms provide citizens with an accessible means to file complaints. In India, the Aadhaar system has facilitated the accurate distribution of funds for welfare projects, reducing the role of intermediaries and ensuring direct benefits to the public. However, challenges remain in leveraging technology, such as inadequate digital infrastructure, cybersecurity vulnerabilities, and limited internet access in rural areas. Addressing these issues requires improving digital infrastructure, strengthening cybersecurity measures, and promoting digital literacy among the public.

Mahatma Gandhi- Apostle of truth, non-violence & peace

It is impossible to discuss the subject of non-violence today without referring to the thought and action of Mohandas Karamchand Gandhi (1869-1948), known to the world as Mahatma ("great soul"). The name of Mahatma Gandhi transcends the bounds of race, religion and nation-states, and has emerged as the prophetic voice of the twenty-first century. The world remembers Gandhi not just for his passionate adherence to the practice of non-violence and supreme humanism, but as the benchmark against which we test men and women in public life, political ideas and government policies, and the hopes and wishes of our shared planet.

When Mohandas Karamchand Gandhi went to England to study Law and thereafter started working in South Africa, he was an ordinary man, desirous of making a living for him and his family. But when he returned home, he was a changed man. He practised what he had determined to do in his heart. This made him a great man. What actually happened in between in his life? While working as a lawyer in South Africa, in 1904, Gandhi received a copy of Ruskin Bond's 'Unto This Last', during a train journey from Johannesburg to Durban. In his Autobiography, Gandhi says he could not put the book down till he had read it completely. He was so fascinated by its contents that he could not sleep at all. He writes: "I was determined to change my life in accordance with the ideals of the book." Gandhi summarises what he read in that book:

1. The good of the individual is contained in the good of all.
2. A lawyer's work has the same value as that of a barber in as much as all have the same right of earning their livelihood from their work.
3. The life of labourer – the tiller of the soil and the handicrafts-man, etc. – is also a life worth living."

The above three statements piercingly shed light on one word: 'Equality'. It actually stems from a Universal truth of Fatherhood of God and brotherhood of all human beings. Gandhi rightly understood that we all come from God (through our parents), hence have only one Eternal Father, the Heavenly Father, the Supreme Soul; and all human beings are His children and therefore brothers and sisters. Hence no one is superior or inferior, but all are equal and good in their essence, and should have the dignity they deserve. Such an idea will instantly strike to the one whose sanskar is satvik (ontological)! Gandhi had that sanskar though dormant! So he alludes to this fact, when he writes in his Autobiography that one would receive a Guru he deserves! The book refreshed his sanskar! He could not ignore the plight of his ill-privileged fellowmen and was determined to work for the "the uplift of all" and "the welfare of all". What followed is history. The British Empire came to its knees in front of Gandhi's determined fight for the downtrodden. He set the model of equality of all in his own Ashram so that it could spread to his country and to other nations of the world. He would often declare: "My life is my message."

From equality, follows non-violence, which has now internationally become synonymous

with Gandhi's name. Hence Gandhi Jayanti that is observed every year as a national holiday in our country to commemorate his birthday (October 2, 1869 – January 30, 1948) is also observed by the United Nations as the International Day of Non-violence, which aims to disseminate his philosophy, principle and belief in non-violence through proper education and public awareness. The UN General Assembly, in a resolution adopted on 5 June 2007, reaffirms the universal relevance of the principle of non-violence and the desire to secure a culture of peace, tolerance, understanding and non-violence.

The International Day of Non-Violence is marked on 2 October, the birthday of Mahatma Gandhi, leader of the Indian independence movement and pioneer of the philosophy and strategy of non-violence. The General Assembly, in a resolution adopted on 5 June 2007, established the commemoration, the International Day as an occasion to disseminate the message of non-violence, including through education and public awareness.

Gandhi & Non-Violence

Non-Violence and Truth were his time-tested weapons throughout his life and he had applied them meticulously even in the extreme situations. He lived on a simple vegetarian diet and fasts rigorously for long periods, for both self-purification and protest in support of his justified demands. By means of a hunger strike, Gandhi had helped bring about India's Independence from British Rule, inspiring colonial people to work for their own independence and ultimately dismantle the British Empire. Gandhi's principle of Satyagraha (truth force) has inspired generations of democratic and anti-racist activists including Martin Luther King Junior and Nelson Mandela. He had often stated that his values were simple, drawn from traditional belief – Satya (truth) and Ahimsa (non-violence). Gandhi's philosophies and his ideas of truth and non-violence had the influence of the Bhagavad Gita and the writings of Leo Tolstoy. He was also inspired by Henry David Thoreau's famous essay on Civil Disobedience.

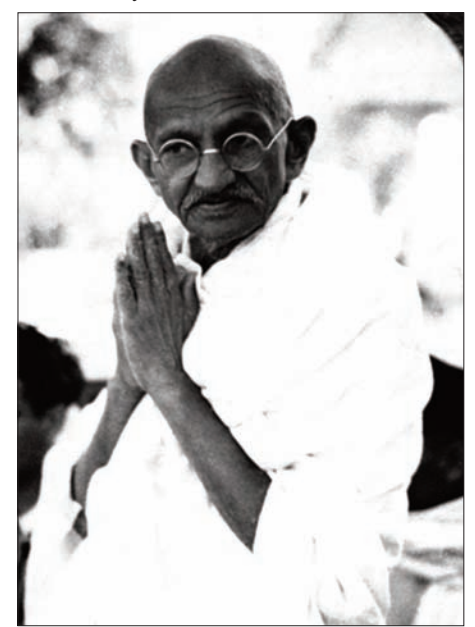
How much India and other countries have adopted his ideals is a different question. What is noteworthy about Gandhi is that he was open to new ideas. When he got the enlightening ideals from another human, his humility helped him to look at what is being said, not who said it. He enjoyed working for those ideals to the best of his ability which made him great to the point that the greatest genius of that time Albert Einstein commented: "Generations to come, it may well be, will scarce believe that such a man as this one ever in flesh and blood walked upon this Earth."

His greatness lies in that he is an example for everyone. Youngsters, in general, think that the problem is with others, and if others change, they will be happy. This is in sharp contrast to what Gandhi felt and did: "Be the change you want to see in the world." He is also an example even for couples. He had the experience of leading a normal and a celibate married life. Comparing the benefits of both, Gandhi says his celibate married life was "more peaceful, sweet and joyful!" He knew very well that lust is "the greatest enemy of the wise." – Gita 3:39 Gandhi was extremely successful because of his determination to practise the lofty ideals he got, and

the way in which he went ahead with that determination. He believed that one's greatest joy will be the awareness of how close one is with his Heavenly Father. No wonder he admits that, he could remember Shrimat Bhagwat Gita chapter 13 by-heart! Two concepts which he always kept close to his heart appear together in one verse in this chapter: "nonattachment, and even mindedness in desired and undesired events." (Gita 13:9). One's even-mindedness in all situations is what makes one a 'supreme devotee' of God, says Gita (18:54).

This chapter helped him to have a balanced approach towards everyone and in every situation in life, as he viewed himself as "a trustee," which means one having neither a sense of possession nor of doer-ship! Hence it was easy for him to declare: "Service is my religion." Gandhi accomplished great things, because he was operating from the realisation that he is a child of God, hence, he possessed infinite potential. His counter-part Nelson Mandela in South Africa, too understood the same fact when he said: "We are powerful beyond measure.... Your playing small does not serve the world." As we let our own lights shine, we unconsciously give other people permission to do the same. As we are liberated from our own fears, our presence automatically liberates others.... A series of career changes

Being a doctor and an engineer in one day was not just about choosing a profession, it was also about gaining social status. Just like being the founder of a tech startup these days, or in management at a big tech company. Current social status careers have new doctor, engineer and creative career status symbols associated with the tech world such as data scientists, AI experts. Being a great content creator in social media is also status. But the most popular careers come from sports, like cricket and badminton. But when it comes to the solid world of technology, green energy and healthcare sectors are areas where building a career is status symbol.

ICS, the glory of IAS

But all of these careers today weren't in the employment landscape until a decade ago, and even if they were, they didn't have special status. Different careers have been social status symbols in India over the decades since independence. If being a government official from the 1950s to 1960s, especially

ICS and IAS after independence was great not only in terms of career but also respect in society.

Doctor and Professor's reputation

Then in the 1960s, the professions that we could count as the highest in society became doctors and professors. Science, health and education were greatly emphasized in the Nehru era as well as these professions gained a lot of respect. In the seventies, it became much more important to have engineers and professionals in PSU. In fact, the 1970s were a time of heavy industry and public sector. During this period, Bhel, Cell and ONGC public enterprises emerged as four moon-laying enterprises in the country. Being an engineer in these institutions was a social pride, and that was the time when leaving IIT was like being a hero.

Bank manager and railway officer

In the 1980s, being an officer in banks and financial institutions became important. In fact, in the 1980s everyone was taking out loans from banks to fund their business or boost their fortunes. These days, the country has started to build houses on a large scale and also a series of home loans, which made the role

of banks important in society. Prior to 1980, the relationship with banks was hardly 20-25 per cent of Indians, after which 40-50 per cent started joining the bank in some form. Obviously, being a bank officer became important during this period. The demand of the bank manager was greatly increased during that period. Besides, it was great to be a manager in LICs, a senior officer in railways and an engineer in the telecom sector.

Bright career of IT and MBA

Then came the 1990s, when IT and MBA emerged as the most important social status-making careers. IT revolution in India for the first time since liberalization, finding jobs at companies like Infosys, TCS and Wipro became more important than IAS or IPS. Going from IIM to MBA and MNC became a status symbol. NRI has also become a part of the highest reputation in society, especially in America. Corporate management and global careers became the biggest social status symbol among urban, middle class

Start-ups, AI from the creative industry

But the world of startups and creative industries came to light in the 2000s, which led to start-



up founders like Flipkart, Paytm, Ola being known and discussed by everyone in society. Digital media, filmmaking and the fashion industry also became a sym-

bol of status. In addition to corporate lawyers, the profession of Chartered Accountant also became an important social status. While AI, robotics and data sci-

ence took the place of technology and social impact in the 2020s, social media influencers and content creators also began to take notice. In the meantime, Green

Energy and Climate Entrepreneurs' reputation grew. In addition to cricket, successful players were considered important careers during this period.

PM MODI TO UNVEIL INITIATIVES WORTH MORE THAN ₹ 62,000 CR FOR YOUTH, BIHAR IN FOCUS

'Bihar likely to develop as a centre for skilled manpower'

NEW DELHI, Oct 3: Prime Minister Narendra Modi will unveil various youth-focused initiatives worth more than Rs 62,000 crore on Saturday, his office said, billing the exercise as a landmark initiative for youth development which will give a decisive push to education, skilling and entrepreneurship.

The PMO said Modi will launch PM-SETU (Pradhan Mantri Skilling and Employability Transformation through Upgraded ITIs), a centrally sponsored scheme with an investment of Rs.60,000 crore.

The scheme envisages the upgradation of 1,000 government ITIs in a hub-and-spoke model comprising 200 hub ITIs and 800 spoke ITIs.



Each hub will be connected to four spokes on an average, creating clusters equipped with advanced infrastructure, modern trades, digital learning systems and incubation facilities.

Anchor industry partners will

manage these clusters, ensuring outcome-based skilling aligned with market demand, it said, adding that hubs will also house innovation centres, training-of-trainers facilities, production units and placement services, while spokes will focus on

expanding access. "Collectively, PM-SETU will redefine India's ITI ecosystem, making it government-owned but industry-managed, with global co-financing support from the World Bank and Asian Development Bank," it said.

In the first phase of the scheme implementation there will be special focus on ITIs in Patna and Darbhanga in Bihar, the statement added. He will also inaugurate 1,200 vocational skill labs established in 400 Navodaya Vidyalyayas and 200 Eklavya Model Residential Schools across 34 states and Union Territories. These labs will equip students, including those in remote and tribal areas, with hands-on training in 12 high-demand sectors such as IT, automotive, agriculture, electronics, logistics and tourism.

Aligned with the National Education Policy 2020 and CBSE curriculum, the project involves the training of 1,200 vocational teachers to deliver industry-relevant learning and

create an early foundation for employability.

A special emphasis of the programme will be on transformative projects in Bihar, reflecting the state's rich legacy and youthful demographic, the statement said.

Modi will launch Bihar's revamped "Mukhyamantri Nishchay Syam Sahayata Bhatta Yojana", under which nearly five lakh graduates every year will receive a monthly allowance of Rs 1,000 for two years, along with free skill training. He will also launch the redesigned Bihar Student Credit Card Scheme, which will provide interest-free education loans of up to Rs 4 lakh, significantly easing the financial burden of higher education.

More than 3.92 lakh students have already availed loans worth more than Rs 7,880 crore under the scheme. Further strengthening youth empowerment in the state, Bihar Yuva Ayog, a statutory commission for people between the ages of 18 and 45, will be formally inaugurated

by Modi to channelise and harness potential of the state's young population, it said.

The poll-bound Bihar has been at the focus of several development and welfare initiatives of the NDA governments at the Centre and the state. Other Bihar project that the prime minister will inaugurate is the Jan Nayak Karpoori Thakur Skill University, which has been envisioned to impart industry-oriented courses and vocational education to create a globally competitive workforce. Taking forward the National Education Policy 2020 with the vision to make higher education avenues better, he will lay the foundation stone for new academic and research facilities in four universities of Bihar namely Patna University, Bhubendra Narayan Mandal University in Madhepura, Jai Prakash Vishwavidyalaya in Chapra and Nalanda Open University in Patna, under the PM-USHA (Pradhan Mantri Uchchatar Shiksha Abhiyan). Financial condition of Karnataka worsened due to 'guarantee schemes': Ex-PM Deve Gowda

BENGALURU, Oct 3: Former Prime Minister H D Deve Gowda on Friday alleged that the financial condition of Karnataka has worsened due to the 'five guarantee' schemes being implemented by the Congress government.

He also claimed that there is no money to deal with the severe flood situation in six districts of north Karnataka, including Kalaburagi.

The JD(S) patriarch said he would visit Kalaburagi and neighbouring flood-hit regions within a week to assess the ground situation. Maharashtra's release of water from its dams has led to flooding in the Bhima and Krishna rivers. Kalaburagi, Vijayapura, Bidar and Yadgir are among the worst-affected districts.

Apart from crop loss, many houses have been damaged and there has been loss of human lives as well as livestock.

Gowda also said he would meet Prime Minister Narendra Modi to seek compensation for the flood-affected people.

"The financial condition of the state has worsened due to 'guarantees'. It's not me who is saying this, but the Congress MLAs," the former PM said at a press conference.

Pointing to disarray within the ruling party, the 92-year-old JD(S) supremo remarked, "They (Congress MLAs) say there is no money even to deal with such a severe flood situation".

The five pre-poll guarantees are Gruha Jyothi, offering 200 units of electricity free to every household; Gruha Lakshmi, providing Rs 2,000 to every woman head of a family; Anna Bhagya, assuring 10 kg rice to each member of a BPL family every month; Yuva Nidhi, promising Rs 3,000 to unemployed graduates and Rs 1,500 to unemployed diploma holders (aged 18-25) for two years; and Shakti, which allows women in Karnataka free travel on government-run non-luxury buses.

"More than 50 people have lost their lives, and there is a huge loss to livestock. Crops have been completely damaged. Roads, bridges and houses have been destroyed," Gowda said.

"I will visit Kalaburagi to see the ground reality. After visiting there, I will give my view about what the government has done," he said. Pointing out that Chief Minister Siddaramaiah had recently conducted an aerial survey of flood-affected areas and reviewed the crop damage, Gowda appealed to district in-charge ministers and officials to visit the spot and understand the woes of people.

On the BJP-JD(S) coalition, Gowda clarified that the alliance would continue. "There is no need to worry about the alliance. It will continue even for Panchayat and Assembly elections," he said.

Emphasising his cordial ties with Prime Minister Narendra Modi, Gowda said, "My relationship with Prime Minister Narendra Modi will never change. Show me one instance where I have spoken ill of him in the last 10 years".

The former prime minister also said he has set a target of winning at least 50 to 60 seats in the upcoming Bengaluru Municipal Corporation elections, and would soon hold a meeting in this regard. (PTI)

Army chief warns Pak, says India 'will not show restraint' next time



ANUPGARH/JAIPUR, Oct 3: In a stern warning to Pakistan, Army chief General Upendra Dwivedi said on Friday that the neighbouring country should stop sponsoring terrorism on its soil if it wants to retain its place on the world map.

The Chief of Army Staff (COAS) also said the restraint shown by New Delhi during Operation Sindoor would not be repeated in case of a future military conflict and urged Indian soldiers to remain poised for action.

"India, as a country, is fully prepared this time. And this time, it will not show the restraint that it showed during Operation Sindoor 1.0. This time we will take a step forward and act in a manner that will make Pakistan think whether it wants to remain on the world map or not," General Dwivedi said in a sternly worded address to soldiers at Anupgarh in Rajasthan's Sriganganagar district.

He asserted that if Pakistan wants to retain its place on the world map, it will have to stop state-sponsored terrorism.

The Army chief told the soldiers to stay prepared. "Keep yourselves fully prepared now, if god wants, the opportunity will come soon," he said.

Gen. Dwivedi said India has given evidence to the world of the presence of terrorist hideouts in Pakistan during Operation Sindoor. Had India not unearthed this evi-

dence, Pakistan would have hidden all of it, he said.

The Army chief said the entire world stood with India when it launched Operation Sindoor in the wake of the April 22 Pahalgam attack. He said the Indian military hit nine targets inside Pakistan during Operation Sindoor, of which seven were hit by the Army and two by the Air Force.

"We had identified the targets because we only wanted to harm the terrorists. We had aimed to strike their bases. We have no complaints against ordinary Pakistani citizens, so long as their country does not sponsor terrorists. Because terrorists were being sponsored, those terrorist targets were hit," Gen. Dwivedi said.

Replying to a question about his appeal to those living near the international border, he said, "We consider the border population not as ordinary civilians but as soldiers. That means they stand shoulder to shoulder with us in the battle. This is crucial because the coming struggle is the nation's struggle, not just the Army's."

The Army chief said history bears witness that during the 1965 and 1971 wars, ordinary citizens stood shoulder to shoulder with the soldiers. "We would want them to join us in the days ahead as well. I want to thank them -- their zeal boosts the morale of our soldiers," he said. (PTI)

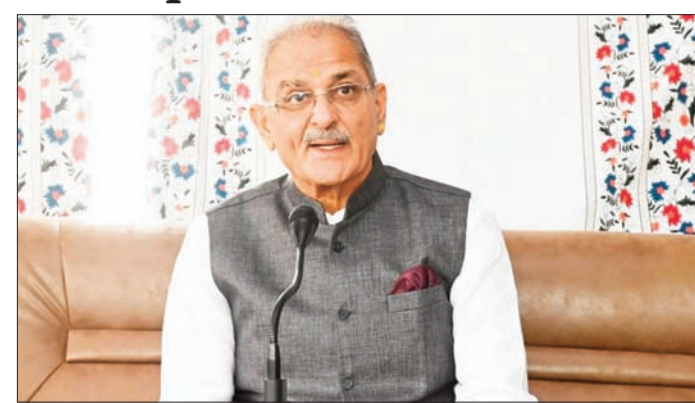
Ladakh cannot afford violence, people trying to vitiate atmosphere will not be spared: LG

JAMMU, Oct 3: Surrounded by Pakistan and China, Ladakh cannot afford violence but some people are trying to vitiate the atmosphere in the Union territory and they will not be spared, Lt Governor (LG) Kavinder Gupta said.

He said a magisterial probe has been launched into the September 24 violence that left four persons dead and scores injured in Leh. He also expressed satisfaction over the fast improving situation in the town, where the authorities eased the curfew for the whole day on Thursday following days of brief relaxations.

Talking to PTI videos here, Gupta said Section 163 of the Bharatiya Nagrik Suraksha Sanhita remains in force across Ladakh, prohibiting gatherings of people to avoid a repeat of the incidents of September 24.

"The situation is almost normal with all shops and business establishments open and offices working smoothly for the fourth day today (Friday). Schools up to class 8 also



opened (on Friday) and commercial vehicles are plying. The overall situation is normal with no untoward incident reported from anywhere," the LG said.

However, he said, some people are trying to vitiate the atmosphere, which is evident from the circulation of deepfake videos and appropriate action is being taken against them. "Many people, including those who provoked the mob violence through

elements and we cannot afford violence in Ladakh like what was witnessed on September 24. Our priority is to maintain the unity and integrity of the country and we know the people in Ladakh are peace-loving and nationalists," he said. On the growing demand for a judicial probe into the violence, Gupta said a magisterial probe has already been ordered and no injustice will be done to anyone.

"Had there been no timely action, they (mob) would have burnt everything. We are very sad about the loss of four persons who were also like our own children. My sympathies are with the bereaved families."

"The dead include an ex-serviceman, who was the son of a retired soldier and whose children are studying in army school. These are tragic happenings, whether they were involved (in violence) or not is a secondary question but the mob created such a situation where counter-terrace became imperative," he said. (PTI)

Gold-clad plates of Dwarapalaka at Sabarimala sparks political storm

THIRUVANANTHAPURAM, Oct 3: The controversy over the gold-clad plates of the Dwarapalaka idols at Sabarimala triggered a fresh political row on Friday, with allegations flying from both the ruling front and opposition parties.

Leader of Opposition in the Kerala Assembly, V D Satheshan, described the incident as "theft of Sabarimala properties" and called for heightened security for the Ayyappa idol. "In 2019, when the Dwarapalaka plates were removed for replating, they reached the Chennai factory 39 days later. What happened during those 39 days should be thoroughly investigated," he said.

Satheshan demanded a comprehensive probe into all temple inventories to determine what had been lost. "The current investigation focuses only on procedural lapses. We demand a full inquiry into the thefts at Sabarimala," he said.

He alleged that the Travancore Devaswom Board (TDB) and the

government violated rules by sending the plates for replating outside the temple, with sponsor Unnikrishnan Potty acting merely as a middleman. He called for the resignation of the TDB president and minister, saying, "For self-defence, they are seeking a probe starting from 1998. The TDB president should resign immediately."

All India Congress Committee (AICC) General Secretary K C Venugopal alleged the role of the state government, calling it a misappropriation of gold. "In other words, isn't it gold smuggling?" he asked.

He welcomed the Kerala High Court's intervention and expressed hope that the truth would emerge through the investigation under the court's supervision. Senior Congress leader Ramesh Chennithala termed the incident a major security lapse, highlighting devotees' concerns over temple property. He said two Devaswom Ministers, two TDB presidents, and the Thiruvabha-

ranam Commissioner should answer to the public. "Why has the chief minister not responded yet?" he asked. "People have no confidence in a TDB Vigilance investigation. A comprehensive probe should be conducted under the direct supervision of the Kerala High Court," Chennithala insisted. Taking a dig at the government and the TDB, senior BJP leader V Muraliedharan alleged that there was an attempt to sell the Sabarimala Sreekoil (the sanctum sanctorum). The former minister accused the Pinarayi government of supporting violations of tradition while gold was being looted from the shrine. "By handing over the sacred plates to an unknown person, the government has hurt the sentiments of crores of devotees across the world. Who gave permission to Potty to exhibit the plates outside after removing them from the temple?" he asked.

Muraliedharan said a vigilance probe alone was not enough and de-

manded a detailed investigation.

Devaswom Minister V N Vasavan said he could not comment further on the controversy at this stage. He pointed out that the Kerala High Court had already taken a strong stand by ordering a probe by the TDB Vigilance wing under the supervision of a retired High Court judge. "We will decide future steps based on the High Court's directions after the Vigilance files its report. We also want the people behind this incident to be exposed. How Potty became involved must also be investigated. Let there be a probe into how he handled the gold-clad plates and where he took them," Vasavan said. Meanwhile, CPI(M) senior leader E P Jayarajan warned that those responsible for fraud would be traced and strict action taken. "No one will be allowed to misuse Sabarimala. The recent developments reveal that Potty was used against the Global Ayyappa Sangamam," he said. (PTI)

Cong forgot about khadi after Independence, PM Modi resolved to revive it: Amit Shah

ROHTAK, Oct 3: Union Home and Cooperation Minister Amit Shah on Friday said khadi is not only a dress but also a feeling of 'swadeshi' and 'atmanirbharta', attacking the Congress and saying it forgot about khadi after Independence and did nothing for its promotion. This was the second event that Shah addressed here on Friday. Earlier, he inaugurated the newly constructed Sabar Dairy Plant facility in Rohtak.

Referring to the Congress ruling the country for many decades, Shah said the Congress forgot about khadi after Independence. "They did not pay attention to khadi and did nothing for its promotion," Shah said during the 'Khadi Karigar Mahotsav' event here. "I feel that what work has been done in the past 11 years, and had it been done continuously after Independence, our country would have never faced the problem of unemployment," said Shah in reference to the steps taken for

khadi's promotion by the Narendra Modi government.

Addressing the gathering at the khadi event, Shah said that 'Gandhi Jayanti' was observed on Thursday.

Shah said Mahatma Gandhi used khadi during the country's freedom movement to remove poverty, make the country self-reliant, give "swadeshi" thought to the nation and to make the nation gain Independence.

He said the beginning made by Mahatma Gandhi on khadi transformed the lives of lakhs of weavers in the country. The 'khadi mantra' given by Mahatma Gandhi gave momentum to the freedom movement, he said.

"But after this, the Congress forgot about khadi," he said.

Shah said when Modi was the Gujarat chief minister, he resolved to revive khadi.

Later, as Prime Minister, Narendra Modi, through his 'Mann Ki Baat' programme, gave the mes-



sage to the citizens to use khadi.

And see the result, Shah said, while adding Khadi and Village Industries Commission's (KVIC's) turnover increased to Rs 1.70 lakh crore now from Rs 33,000 crore in 2014-15, and this helps in giving employment to scores of weavers.

Even many companies in the

country do not have such a big turnover, he pointed out.

A good system of khadi's marketing and packaging was made and people were inspired, he said.

"When we wear khadi, it is not just a dress... we do not wear just a cloth, but we adopt and embrace the spirit of swadeshi and at-

manirbharta," he said.

Tool kits to over 2,200 artisans were given during the 'Khadi Karigar Mahotsav' at Maharshi Dayanand University, Rohtak. The event was organised by the KVIC under the Ministry of Micro, Small, Medium (MSME) and it was themed 'Swadeshi Se Swaavlamban'.

Modern machinery and tool kits were also distributed along with Rs 301 crore as margin money under the Prime Minister's Employment Generation Programme (PMEGP) in the event attended also by Haryana Chief Minister Nayab Singh Saini.

Addressing the gathering, Shah said the idea of 'swaraj' will be incomplete without 'swadeshi' and 'swabhasha' (own language). PM Modi has recently asked 140 crore people to use swadeshi items, he said. Many traders in the country have even resolved not to keep foreign products at their shops and showrooms, he said. (PTI)

Canadian envoy presents credentials to Murmu, year after diplomatic row

NEW DELHI, Oct 3: President Droupadi Murmu on Friday accepted credentials from Canadian High Commissioner Christopher Cooter, who has taken charge of the diplomatic post nearly a year after bilateral ties broke down over the allegations of Indian links in the killing of Khalistani separatist Hardeep Singh Nijjar.

In October last year, India recalled its high commissioner and five other diplomats after Ottawa attempted to link them to the Nijjar case. India had also expelled an equal number of Canadian diplomats.

Prime Minister Narendra Modi and his Canadian counterpart Mark Carney in June this year agreed to pursue "constructive" steps to restore stability in India-Canada ties, including the early return of envoys to each other's capitals.

Following this, both countries appointed envoys to each other's capitals in August, signalling their efforts to mend ties.

While India named seasoned diplomat Dinesh K Patnaik as the

next high commissioner to Ottawa, Canada appointed Cooter as its new envoy to New Delhi.

Patnaik presented his credentials to Canada's Governor General Mary Simon on September 25.

Cooter presented his credentials to President Murmu on Friday.

In a statement, the president's office said envoys of four nations, including Canada and Slovenia, presented their credentials to Murmu.

Those who presented their credentials were Ahmedou Sidi Mohamed, Ambassador of the Islamic Republic of Mauritania, Christian Biever, Ambassador of the Grand Duchy of Luxembourg, Christopher Cooter, High Commissioner of Canada and Tomaz Mencin, Ambassador of the Republic of Slovenia.

Cooter has 35 years of diplomatic experience, having served most recently as Canada's charge d'affaires to Israel and as Canada's high commissioner to South Africa, Namibia, Lesotho, Mauritius and Madagascar. (PTI)

'Indigenity of Nagas to its land cannot be eroded by any factor whatsoever'

Nagas are the only indigenous people of Nagaland: NSF

DIMAPUR, Oct 3: The Naga Students' Federation (NSF) asserted that, as far as it is concerned, only the Nagas are the indigenous people of Nagaland and other Naga-inhabited areas.

Reacting to the Rising People's Party's (RPP) statement expressing concern over non-inclusion of non-Naga indigenous tribes in the recruitment in the state police that was advertised on September 30, the inner line regulation commission (ILRC) of the NSF, in a release, said it was flabbergasted by the former's statement.

The ILRC sought to know from the RPP who are the "non-Naga indigenous tribes" in Nagaland.

Stating that it understands that other tribes and communities had also settled in various Naga areas, the NSF, however, said calling migrants indigenous to the land undermines the very sanctity of the peoples who have existed in those



lands since time immemorial.

It said the RPP must understand that the United Nations, as the world's apex organisation, has distinctively defined the term "indigenous" to preserve the distinct status of peoples who are indigenous to the lands they inhabit.

The NSF said the indigenity of the Nagas to their land cannot be eroded by any factor whatsoever. It added that indigenity to land inhabited by the Nagas is intrinsic to the Nagas and no one else.

Calling the Nagaland government's decision on the matter "ap-

propriate", the NSF said the RPP's characterisation of that decision as having "reflected poorly on the policy makers of the state" is devoid of logic.

Instead, it only reflects the utter ignorance of the RPP and amounts to an attempt to diminish the uniqueness of the Nagas in their ancestral homeland, the federation stated.

Acknowledging the existence of non-Nagas who came to Nagaland before December 1, 1963, the NSF urged the government to grant them suitable status so that their presence is recognised legally and officially.

It also appealed to those individuals, tribes, or communities who arrived in the state before December 1, 1963, not to be swayed by unfounded apprehensions, but to register their claims so that newcomers or self-interested individuals do not dilute their original status.

Khandu calls for urgent action against HIV, substance abuse

ITANAGAR, Oct 3: Arunachal Pradesh Chief Minister Pema Khandu on Friday expressed concern over the growing number of HIV-positive cases in the state, and stressed the need for urgent and effective steps to curb its spread, combat ignorance, and end social ostracism.

In a post on X, Khandu said the state's collective resolve was to "strengthen awareness, prevention, and care measures to protect every life and build a compassionate, informed society."

The chief minister chaired the 3rd State Council on AIDS (SCA) meeting of the Arunachal Pradesh State AIDS Control Society (APSACS) in the day, which was attended by cabinet colleagues, advisors, senior officers, NGOs and community-based organisations.

The rise of HIV cases and the need for integrated strategies linking HIV control with substance abuse prevention were discussed at the meeting, officials said.

According to the Arunachal Pradesh State AIDS Control Society, the number of cumulative HIV seropositive cases is 2,575 as on March 31 this year.

Khandu later chaired the 2nd meeting of the Arunachal Pradesh Psychoactive Substances Control

Authority (APPSCA), which focused on addressing the growing menace of drug addiction in the state.

"The meeting underlined that consumers are victims who need care and support, not punishment. The focus has now shifted towards suppliers and peddlers, the real drivers of this menace," the CM said in another social media post.

He said discussions also stressed strengthening rehabilitation and counselling facilities, intensifying the crackdown on the supply chain, and building a community-driven movement for a drug-free Arunachal.

Health and Family Welfare Minister Biyuram Wahge highlighted the latest data, revealing that HIV/AIDS transmission through infected needles accounted for 66.55 per cent of cases, while unprotected sex contributed 30.55 per cent.

"This underlines the urgent need to tackle drug abuse alongside HIV prevention," Wahge said in a social media post.

The minister said that the authorities resolved to strengthen awareness campaigns on HIV and substance abuse, intensify the Nasha Mukht Bharat Abhiyan, and build a united, multi-sectoral response to the crisis. (PTI)

Tripura to organise carnival of top Durga pujas today

AGARTALA, Oct 3: The Tripura government will on Saturday organise the fourth edition of 'Mayer Gamon carnival', a procession of Durga idols of top pujas in the state, an official said.

Chief Minister Manik Saha will inaugurate the event, which is likely to witness the participation of at least 40 community pujas.

Apart from trophies and citations, cash awards will be given to the three best pujas, he said.

"The CM will inaugurate the fourth edition of 'Mayer Gamon carnival', a procession by the puja organisers, on Saturday. His cabinet colleagues, MLAs, and elected representatives will remain present at the annual event," Information and Cultural Affairs (ICA) Director Bimbisar Bhattacharya said on Friday. (PTI)

Khandu inaugurates new ATI in Naharlagun, calls it key to grooming future administrators

ITANAGAR, Oct 3: Arunachal Pradesh Chief Minister Pema Khandu on Friday inaugurated the new Administrative Training Institute (ATI) building at Naharlagun, emphasising that the facility will play a crucial role in preparing administrators to meet the state's unique governance challenges.

The complex comprises a four-storied administrative and academic block, and a six-storied hostel block, each built at ₹20 crore, according to an official statement.

Recalling his first visit to ATI in 2017, Khandu noted that the old building's cramped classrooms and lecture halls had prompted the government to construct new towers for the institute, which trains government officers and employees, the "backbone" of governance.

Noting the complexities of governance due to the state's difficult terrain, dispersed habitations and diverse tribal cultures, he said Arunachal Pradesh requires administrators who are not only skilled but also empathetic, innovative, and committed to trans-

parency, accountability, and public service.

"Institutions like ATI are the crucibles where such officers are shaped," he said.

Khandu said 140 newly recruited Group-A and Group-B officers of the APPSCE 2024-2025 batch, who are scheduled to begin a four-month induction training on October 6, will benefit from the new infrastructure. He said the manpower requirements for ATI would be addressed soon, and four full-time faculty members have already been inducted.

The CM said a major exercise is underway to rationalise manpower across all government departments, directorates, and districts.

"The newly constituted State Commission for Reforms is undertaking a rigorous exercise in this regard, and it is expected to be completed within two years," he said.

The ATI is mandated to train ministerial staff and mid-level officers on office procedures, Arunachal Judicial Service officers, APCS and other administrative officers. (PTI)

The NPCC stated that a death threat issued openly against the leader of the Opposition, who represents millions of citizens and their voices, is nothing short of an attack on India's democracy itself.

It urged the central government to not only bring the offender to justice but also set a strong example against such barbaric and homicidal mindsets.

The NPCC further urged every citizen, irrespective of political affiliation, to condemn this dangerous act and uphold the sanctity of our democratic traditions.

Kuki outfit warns Manipur Police after raid in Chandel district

IMPHAL, Oct 3: A Kuki militant outfit on Friday warned Manipur Police that it will not remain a "mute spectator" after the force allegedly conducted a raid to arrest one of its leaders in Chandel district recently.

The United Kuki Liberation Front (UKLF), a group under the Suspension of Operations (SoO) agreement, condemned the late-night raid allegedly carried out by Chandel SP Dharmendra Kumar at the residence of one of its leaders in Sajik Tampak area on Wednesday. In a statement, the UKLF said the SP Chandel's act was serious and it would not remain a mute spectator if such action continues. The outfit claimed that after signing the SoO agreement, it had been abiding by the ground rules and working to achieve a "political solution" for the Kuki-Zo people.

Meanwhile, police claimed the operation was conducted to apprehend a suspected drug kingpin. "On Wednesday, acting on credible intelligence, Chandel District Police conducted an operation in T Kotlen village in Sajik Tampak area to apprehend a suspected drug kingpin. However, the person managed to escape," police said. Police claimed that while returning, they were attacked by a mob. The situation was peacefully resolved through dialogue with local leaders with support from the Assam Rifles and CAPF, allowing the team to return safely, police said. (PTI)

Security forces arrest 4 militants including self-styled chief of Kuki outfit in Manipur

IMPHAL, Oct 3: Security forces arrested four militants, including a self-styled chief of a banned Kuki outfit in Manipur, police said on Friday.

Security Forces arrested Paokhonen Guite, the self-styled 'commander-in-chief' of Chin Kuki Mizo Army (CKMA) from S Munuam in Churachandpur district on Wednesday, they said.

Guite was involved in trafficking of weapons and drugs across the India-Myanmar border and also in extortion activities. Two AK-47 rifles, 181 rounds of different types of ammunition, cash of ₹1,00,000 and a car were recovered from his possession.

Security forces arrested two cadres of the banned People's Liberation Army from different places in Imphal West district on Thursday. They were involved in extortion from brick field owners and the public in the valley area.

Police also arrested another member of the outfit from his residence at Yairipok in Thoubal district on Wednesday. He was involved in extortion and collection of money from quarry workers. Members of the PLA had, in September, carried out an ambush on an Assam Rifles convoy at Nambol Sabal Leikai in Bishnupur district, killing two personnel. (PTI)

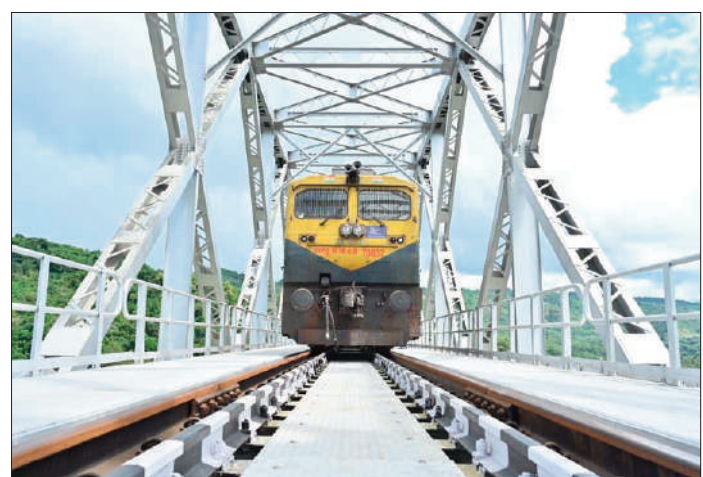
The training is expected to prepare them to become proficient professionals capable of contributing to complex SAP implementation projects across industries, according to a senior official of the society.

Rahul, Jurel and Jadeja's tons put India in complete command against West Indies in Ahmedabad Test

AHMEDABAD, Oct 3: KL Rahul's 11th hundred grounded the West Indies before Dhruv Jurel and Ravindra Jadeja followed the suit with stylish tons with India literally batting the visitors out of the opening Test with a huge lead of 286 runs at the end of second day's play. At stumps, India were 448 for 5 and with the West Indies spinners getting appreciable turn and bounce off the rough, the hosts will like to finish the game by the end of the third day itself and consolidate their position in the World Test Championship points table.

Rahul (100 off 197 balls), Jurel (125 off 210 balls) and Jadeja (104 batting off 178 balls) had their own distinct approach to Test match batting and even interesting ways of celebrations.

Rahul's was for his infant daughter while Jurel's gun salute was for the Indian Army while Jadeja's now familiar sword celebration is something people wait for.

The West Indies bowling was insipid and there was lack of energy on the field which also enabled India to actually increase their stranglehold on the opposition. India through 128 overs scored at 3.50 runs per over which is reminiscent of Test cricket from a bygone era but also hit 45 boundaries and eight sixes -- five of them by Jadeja, same shot in the same region.

While Rahul brought an end to his century drought at home by hitting his second century since December 2016, Jurel brought up his maiden Test century in only his sixth Test for India having made his debut last year.

Jadeja, whose purple patch saw



the venerable all-rounder notching up his seventh score in last six Tests in excess of 50 including two hundreds since the England tour, brought up his sixth century in the format. Jurel and Jadeja put on 206 runs for the fifth wicket for an imposing fifth-wicket stand, but they also narrowly missed breaking the record for highest fifth wicket partnership for India against West Indies, which belonged to VVS Laxman and Sachin Tendulkar who put on 214 runs at Kolkata's

Eden Gardens in October 2002.

The partnership ended when Jurel, who smacked 15 fours and three sixes got an inside edge off Khary Pierre late in the day to be caught behind for the West Indies debutant's maiden wicket in Tests.

On the second day, India opted for a traditional approach with the bat to pile up immense pressure on the West Indies, who, at the best, remained disciplined but could not put pressure back on the hosts. Gill and Rahul resumed India's

innings at 121 for 2 and by drinks in the first session, the deficit of 41 runs was erased with the two batters going about their jobs with ease.

In the 56th over off Pierre, Rahul reverse-swept a ball for a four which was enjoyed thoroughly by the Indian captain who tried to emulate his partner in the next. However, Roston Chase's (290) delivery, which pitched on off, took a leading edge and Justin Greaves in first slip was nimble to

move in direction of the ball to grab an easy catch.

Gill, who added 98 runs for the third wicket with Rahul, fell immediately after completing his half-century. His innings had five boundaries. But Rahul carried on to bring up only his second century at home in nine years and 11th overall. The right-handed batter had scored 199 in the Chennai Test against England in December 2016 and since then a triple-figure score had remained elusive. (PTI)

Weightlifting: Mirabai Chanu wins Silver at World Championships

FORDE (NORWAY), Oct 3: Star Indian weightlifter Mirabai Chanu (48kg) clinched a silver medal at the World Championships in the 48kg category here, extending her glittering record in the marquee event where she has been on the podium twice earlier.

The 2017 world champion and 2022 silver-medallist produced a total lift of 199kg (84kg in snatch + 115kg in clean and jerk) to be among the medal winners after moving down from the 49kg division.

Chanu struggled in snatch, failing twice at 87kg, but regained her rhythm in the clean and jerk, successfully executing all three attempts. A former world record holder in clean and jerk, Chanu completed lifts of 109kg, 112kg and 115kg with ease.

The last time she lifted 115kg was at the Tokyo Olympics in 2021 where she won a silver medal. "I'm happy to finish on the podium, it gives me great confidence for the year ahead, especially after my previous performance at the Commonwealth Weightlifting Championships in August," Chanu said.

"Every competition is part of my preparation towards the 2028 Los Angeles Olympics, and the upcoming Commonwealth Games and Asian Games will be crucial milestones on that journey. I'm focused on working hard, learning from each outing, and giving my best for the country."



Chief coach Vijay Sharma said Chanu's podium finish at the World Championships was a reflection of her consistency and commitment.

"This is just the start of a very important phase in her career, with Commonwealth Games and Asian Games next year serving as key tests before the LA Olympics."

The focus now is on fine-tuning her technique, building strength, and ensuring she peaks at the right time," he said. Sharma had earlier told PTI that the aim of these World Championships was to breach the 200kg mark and also to start lifting weights that Chanu had been heaving in the 49kg.

North Korea's Ri Song Gum won the gold with a commanding 213kg effort (91kg + 122kg), setting new world records in total as well as clean and jerk with her last two lifts of 120kg and 122kg.

Thailand's Thanayathorn Sukcharoen settled for bronze with a total of 198kg (88kg + 110kg). (PTI)

Women's World Cup: Sri Lanka face mighty Australia at home

COLOMBO, Oct 3: Sri Lanka will hope to make the most of home conditions and iron out their batting and fielding woes against a formidable Australia in their second match of the ICC Women's World Cup here on Saturday. The hosts bowled well in their opening game against India but paid the price for sloppy fielding and a string of soft dismissals. Despite nine batters reaching double digits, Sri Lanka failed to capitalise on the starts, eventually collapsing to 211 all out in 45.4 overs.

Skipper Chamari Athapaththu and her team will now face a stern challenge in the form of defending champions Australia, who opened their campaign with a dominant win over New Zealand.

Australia showcased their batting depth in the opener, recovering from 128 for 5 to post a mammoth 326 thanks to Ashleigh Gardner's counter-attacking 115 and a valuable lower-order contribution from Kim Garth at No. 9.

With the likes of Beth Mooney, Phoebe Litchfield and captain Alyssa Healy at the top, the Aussies boast an enviable batting line-up that allows them to play with freedom and aggression.

Their bowling unit, too, fired in unison, with pacer Annabel Sutherland claiming three wickets in a single over. Leg-spinner Alana King and left-arm spinner Sophie Molineux can apply pressure during the middle overs, while experienced names like Megan Schutt, Ellyse Perry, Tahlia McGrath and Darcie Brown remain constant threats.

For Sri Lanka, the challenge will be immense, and only a disciplined and consistent effort across all three departments will could them a chance against the seven-time champions.

Having missed out on qualification in the previous edition in 2022, Sri Lanka are eager to make their mark in this tournament, especially with their next four matches sched-



uled at home.

Athapaththu, the pillar of Sri Lanka's batting, will once again shoulder the bulk of the responsibility. The left-hander famously smashed an unbeaten 178 off 143 balls against Australia in the 2017 World Cup — still regarded as one of the greatest innings in women's cricket — and will hope to replicate that performance on Saturday.

The hosts have had a busy lead-up to the tournament, playing 31 matches, with young talents like

Harshitha Samarawickrama, Vishmi Gunaratne and Kavisha Dilhari showing promise. They will form the backbone of the batting unit, and much will depend on their performance against Australia.

Against India, the collapse after the openers departed exposed the middle order, something the team management would be keen to address. In the bowling department, Inoka Ranawera and Udeshika Prabodhani impressed with the ball but lacked support from the other end.

"We are calm. I still have faith in my youngsters because they have won more games for us. If they (Dilhari, Samarawickrama and Gunaratne) can perform, we definitely have a better chance," Athapaththu had said after the loss to India. Sri Lanka may consider bringing in 20-year-old all-rounder Dewmi Vihanga, who impressed in the Tri-Nation Series with 11 wickets, including a match-winning 5/43 against South Africa. (PTI)

Women's WC: Spinners call shots as England bundle out SA for 69

GUWAHATI, Oct 3: Left-arm spinner Linsey Smith led the show with an impressive three-wicket effort as England bowled out South Africa for a woeful 69, their second lowest total in the ICC Women's World Cup here on Friday.

On a pitch that offered a hint of grip to the bowlers, England, who chose to field, handed the ball to Smith (4-2-7-3) in the second over itself and the move fetched an immediate dividend.

Smith gave marching orders to SA skipper Laura Wolvaardt in the second ball of the second over through an easy return catch.

Smith returned in the fourth over to jettison Tazmin Brits with a delivery that came in with the angle, and in the sixth over she ousted the experienced Marizane Kapp. Kapp's tentative forward prod did not meet the ball as Smith's delivery crashed onto the stumps.

Pacer Lauren Bell accounted for Sune Luus as South Africa were tottering on 19 for four inside the first six overs, and they never recovered from that point. Once Kapp, Luuk and Brit, SA's most consistent batters, returned to the hut, the pressure was entirely on their middle-order batters to take their side to a respectable total.

But they failed to live up to the task, succumbing to a slightly sluggish track and relentless England bowlers. (PTI)

Asia Cup row may add pressure, but superior India will handle Pakistan clash calmly: Saba Karim

NEW DELHI, Oct 3: Former wicketkeeper Saba Karim believes the recent Asia Cup row will have a cascading effect on India's ICC Women's World Cup match against Pakistan in Colombo, but said Harmanpreet Kaur's side will not be overly concerned about "outside noise" as the gulf between the two sides is too vast.

India had refused to shake hands with Pakistan during the Asia Cup in the UAE, where the arch-rivals met thrice, including the final. After winning the title, the Indian team also declined to accept the trophy from Mohsin Naqvi, who is both the ACC President and Pakistan's federal interior minister.

Asked if the Indian players would be under pressure heading into Sunday's match, Karim said: "Yes, I think so... that is why India and Pakistan have become a big clash, even in the Women's World Cup. Otherwise, I don't think it would have mattered so much, because India has played against Pakistan before in the past," Karim told reporters during a JioStar programme.

Following the precedent set by the Indian men's cricket team during the Asia Cup, Harmanpreet and her side also will not engage in customary handshakes with Pakistan players in Colombo.

"Because of the so-called controversy that hangs over your



head... I'm sure that the Indian team management and the players would have worked on this kind of simulation so that they're able to perform even when something like this is on top of your mind."

"For India, the best solution would be to try and remove all these outside noises and focus on the game ahead. The kind of experience the Indian side has got, especially the support staff, they will put up a very good performance without really bothering about such controversy," he added.

Asked if the tension could escalate again, the 57-year-old said: "Not to that extent, not to that level. But I think the BCCI has made its stance very clear that the

Indian women's team will also have in the same manner as the Indian men's team did in the Asia Cup. "By which it means that I don't think the Indian women's team will also be shaking hands with the Pakistani cricketers. So that stance has been very clear. And I think India will stick to that."

"Once you are done away with all that controversy and then you concentrate on the game, then it becomes very easy. Initially, maybe a little bit here and there. But I think once you get on to the field, then I think everybody would love to focus on the game," he noted.

Assessing the quality of the two teams, Karim said: "India versus

Pakistan in women's cricket especially, we have seen a huge gulf in terms of quality. Indian women's team is far ahead in terms of resources, in terms of skill set, the kind of support that the Indian women's team receives from BCCI, all that matters in the end."

"I think this huge divide goes to show that India has moved ahead of a team like Pakistan. They are not a threat. But there are worthy opponents. Once you get on to the field, you possibly can't take any team lightly. I think India would be well advised to do their homework." Speaking about key Pakistani players, Karim said: "Sidra Amin is quite an exciting batter. She got back-to-back 100s against South Africa, which is quite an achievement. Then the young captain Fatima Sana has come up with some very good performances. So, India will prepare well against Pakistan." Reflecting on the broader challenges India may face in their World Cup campaign, Karim said: "One, it is a very long tournament, which means for India, the biggest challenge would be to sustain some good form."

"Whether it is from an individual perspective or from a team's perspective. So, for someone like Smriti Mandhana to maintain that kind of form for the entire duration of the tournament, that is going to be a huge challenge." (PTI)

Dhruv Jurel dedicates maiden Test hundred to Indian Army

AHMEDABAD, Oct 3: Wicketkeeper-batter Dhruv Jurel on Friday dedicated his maiden Test hundred against the West Indies to the Indian Army, saying he has always had "respect for what they do on the battlefield".

Jurel struck a neat 125 on the second day of the opening Test against West Indies, helping India reach a dominant 448 for five at stumps after senior colleagues KL Rahul and Ravindra Jadeja also helped themselves to hundreds.

Besides his excellent display with the bat, the 24-year-old Jurel's celebration, after reaching his hundred as well as the half-century, also caught everyone's attention.

The army salute was a tribute to the Indian army and his father, who is a Kargil war veter-

eran. "The salute (celebration) after reaching my fifty was for my father, but for the hundred, it was something that I had in my mind for a very long time because I have been so close to the Indian Army, I've seen my father since my childhood," Jurel said.

"What we do on the ground and what they do on the battlefield is very difficult and I cannot compare that. I will always have my respect and whatever I will do in the future will be for them."

"I will like to dedicate this to them (Indian Army) for what they do. I have seen them closely how it is like and I remain very fascinated in those things. I also used to keep asking my father. I will dedicate it to those who deserve," he said further. (PTI)
