**'Cong politicising Zubeen death issue to protect Miyas'**  
**Himanta confident of sweeping 2026 Assam polls**

GUWAHATI, Nov 19: Asserting that the BJP will sweep the assembly polls in Assam next year, Chief Minister Himanta Biswa Sarma took a dig at state Congress chief Gaurav Gogoi on Wednesday, stating that after losing, he can contest elections in Pakistan.

Speaking to reporters on the sidelines of a programme in Chamata in Nalbari district, Sarma alleged that the Congress was doing politics over the death of singer Zubeen Garg, in an attempt to protect the 'Miyas' who have encroached acres of land across the state.

Asked about Gogoi's statement that the situation in the Northeastern state was different from Bihar, where the BJP-led NDA registered a landslide victory in the recently concluded assembly polls, the CM claimed, "Assam is Assam and we will make a clean sweep in the assembly elections."

"He (Gogoi) will hundred per cent lose the polls in Assam, and



then he can contest the elections in Pakistan," Sarma added.

The CM has been attacking Gogoi over the last few months, alleging that he and his wife have a connection with the Pakistani intelligence agency ISI. He had also set up an SIT to probe the links, but is yet to make the findings public.

"The Congress is mainly concerned about 'Miyas', and the people of Assam will not vote for

"Have Muslims put up Zubeen's photograph in any mosque? But, Hindus have honoured him at Durga Puja pandals and other festivals, including the just-concluded Ras Mahotsav. People are now realising the truth. There is no point in fighting us on these issues, as we have the moral courage to tell the truth. We do not do politics with emotion but with hard work," Sarma said.

Garg's death in Singapore in September became a turning point in Assam's socio-political landscape, uniting people across communities and faiths in a common demand for justice.

Lakhs of people poured onto the streets to hold those in power accountable, as several high-profile names surfaced in connection with the icon's death.

The opposition has been claiming that the BJP government under Sarma, accused of pursuing divisive politics by specifically targeting 'Miyas' (CONTD. ON PAGE-2)

**Bhagwat urges youth not to form opinion on RSS based preconceived notions**

GUWAHATI, Nov 19: RSS chief Mohan Bhagwat on Wednesday appealed to the youth of Assam and the Northeast not to form opinions about the organisation based on preconceived notions or motivated propaganda.

Addressing the Youth Leadership Conclave on the final day of his three-day visit to the state, Bhagwat highlighted the principles, ideals, and functioning of the Rashtriya Swayamsevak Sangh (RSS), while addressing debates and discussions surrounding the organisation.

"RSS has now become a subject of public discussions but these discussions should be based on factual information," he asserted.

Claiming that over 50 per cent of information about the Sangh on international platforms and digital sources is either incorrect or incomplete, Bhagwat alleged a deliberate misinformation campaign against the RSS in various media outlets.

Referring to the vision of RSS founder Dr Keshav Baliram Hedgewar, Bhagwat said the primary aim



of the Sangh is to make India a 'Vishwaguru' (teacher to the world).

"The nation can rise only when society rises and only a united and quality-driven society can be created to lead a progressive nation", he said.

He urged youth to study the history of developed nations "where they will find that the first hundred years of their growth was focused on building unity and qualitative strength within their societies."

"Indian society also needs to evolve similarly and this idea is reflected in the five key principles of social transformation (Panch Parivartan) of the RSS, adopted on the occasion of its centenary year", he said.

Bhagwat said Bharat's greatness as a nation lies in its long-standing tradition of respecting and accepting linguistic, regional, and belief-oriented diversities. He also stressed (CONTD. ON PAGE-2)

**Five declared foreigners ordered to leave Assam within 24 hours**

TEZPUR, Nov 19: Five people including four women, who have been living in Assam for several years, were declared foreigners and the Sonitpur district administration on Wednesday issued notices directing them to leave the state within 24 hours, officials said.

Those five individuals -- Hanufa, Mariyam Nessa, Fatema, Monowara and Amjad Ali -- were Bangladeshi, according to the authorities.

They have been residing in Dhobokata village under Jamugurihat police station.

Sonitpur Foreigners Tribunal No. 2, in separate cases filed by the district's Superintendent of Police (Border) in 2006, termed them Declared Foreign Nationals (DFN).

A Foreigners Tribunal is a quasi-judicial body that determines if an individual is an illegal immigrant or a foreigner in Assam.

**Zubeen had not been a habitual drinker: CM**  
**'Chargesheet to detail how Zubeen was made to drink and exploited'**

 GUWAHATI, Nov 19: Chief Minister Himanta Biswa Sarma on Wednesday levelled serious allegations regarding the circumstances that contributed to the late singer Zubeen Garg's prolonged struggles before his death, asserting that the ongoing investigation has uncovered evidence showing he was deliberately intoxicated by people around him to siphon off his wealth.

Speaking to reporters in Nalbari, Sarma said that investigators had found "explosive details" indicating that certain individuals close to the singer routinely supplied him alcohol with the intention of manipulating him and misappropriating his earnings. "Zubeen Garg was made to drink alcohol in order to loot his wealth. Some people fed him alcohol and exploited him. Many explosive details have come to light in the investigation," the Chief Minister claimed.

Sarma further said that, contrary to the popular image of the singer, Zubeen had not been a habitual drinker by choice. Instead, he was allegedly pushed into intoxication during

events and performances by people who stood to benefit financially. Citing a specific incident, the Chief Minister said that during one Bihu programme, a committee paid Zubeen ₹ 5 lakh for his performance, but he was convinced—while in an intoxicated state—that he had received only ₹ 2.5 lakh. "He was intoxicated and believed the same, and that's how a certain group indulged him in alcohol and looted him," Sarma said.

He added that his personal interactions with the singer did not reflect the public perception that Zubeen regularly consumed alcohol. "The number of times Zubeen came to me in the morning, he was never drunk. The things he said in the evening were only because he was made to drink," Sarma noted, adding that the claim was supported by details emerging in the death investigation.

Urging the public not to link the singer's legacy with alcoholism, Sarma said the upcoming chargesheet would offer further clarity. "I request the public not to associate Zubeen with alcohol. In my life, I met Zubeen over 50 times; he (CONTD. ON PAGE-2)

**NFR's solar power capacity rises to 11.95 mw**

GUWAHATI, Nov 19: The North-east Frontier Railway (NFR) has installed a cumulative rooftop solar capacity of 11.95 mw, a statement said on Wednesday.

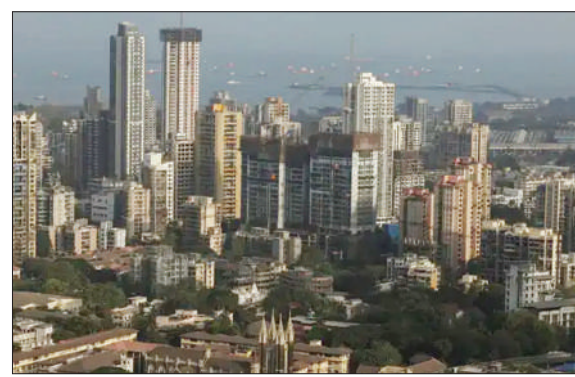

**'Success or failure of urbanisation in these key countries to shape global development outcomes'**  
**India among 7 countries expected to add over 500 million city residents between 2025 and 2050: UN**

UNITED NATIONS, Nov 19: India, along with six other countries, "will shape the future growth of the city population" of the world as they are expected to add more than 500 million city residents between 2025 and 2050, the UN said.

The 'World Urbanisation Prospects 2025: Summary of Results', released by the United Nations Department of Economic and Social Affairs (UN DESA), said that the world is becoming increasingly urban, with cities now home to 45 per cent of the global population of 8.2 billion.

The report said that the growth of the world's city population between now and 2050



will be concentrated in seven countries: India, Nigeria, Pakistan, Democratic Republic of the Congo, Egypt, Bangladesh and Ethiopia.

These seven countries,

global growth of city dwellers by 2050.

Taken together, these seven countries are expected to add more than 500 million city residents between 2025 and 2050, accounting for over half of the projected 986 million increase in the global number of city dwellers over that period.

Their ability to manage city growth sustainably will have profound implications not only for their populations but also for global progress toward the Sustainable Development Goals and climate (CONTD. # Stock markets rebound on buying in IT, banking shares; Sensex jumps over 513 points

MUMBAI, Nov 19: Benchmark indices Sensex and Nifty bounced back sharply on Wednesday, driven by a rally in IT and financial shares and sustained buying by domestic institutional investors amid growing hopes for an India-US trade deal.

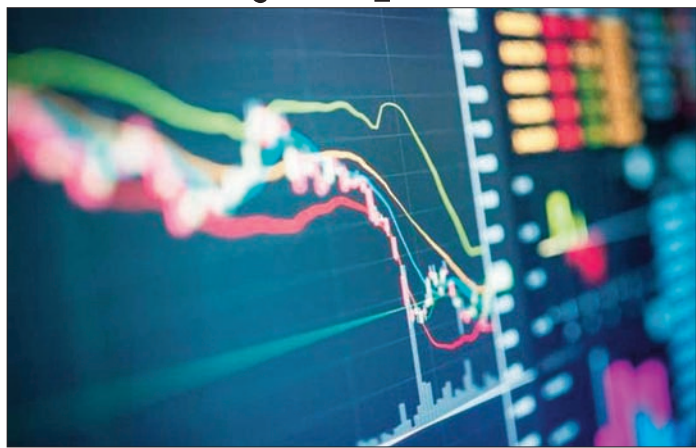
The 30-share BSE Sensex jumped 513.45 points, or 0.61 per cent, to settle at 85,186.47. During the day, the benchmark surged 563.75 points, or 0.66 per cent, to 85,236.77.

The 50-share NSE Nifty climbed 142.60 points, or 0.55 per cent, to close near the day's high at 26,052.65. The index hit a high of 26,074.65 in the day trade.

From the Sensex pack, HCL Tech, Infosys, Tata Consultancy Services, Hindustan Unilever, Sun Pharma and Titan were among the biggest gainers.

In contrast, Tata Motors Passenger Vehicles, Maruti, Adani Ports and Bajaj Finance were among the laggards.

Meanwhile, Commerce and Industry Minister Piyush Goyal on Tuesday said "you will hear good



news" on the proposed trade pact between India and the US once the deal is fair, equitable and balanced.

Equity benchmarks rebounded on Wednesday after Tuesday's pause, supported largely by strong buying in IT stocks, Gaurav Garg, Research Analyst, Lemonn Markets Desk, said.

"The rally was led by IT names such as Infosys and HCL Technologies, with sentiment improv-

ing after Infosys announced its ₹ 18,000-crore share buyback starting November 20. Expectations surrounding a potential India-US trade agreement also lifted sentiment, while a global shift away from AI-heavy bets steered more flows toward emerging markets like India," Garg added.

Vinod Nair, Head of Research, Geojit Investments Ltd, said that the IT sector rallied on revived hopes of a Fed rate cut, supported

by soft U.S. labour data and currency tailwinds, while PSU banks gained on merger-related news and improving fundamentals. Attention now turns to tomorrow's FOMC minutes for further policy signals. In Asian markets, South Korea's Kospi, Japan's Nikkei 225 index and Hong Kong's Hang Seng index settled lower. In contrast, Shanghai's SSE Composite index ended in the green.

Markets in Europe were trading mostly lower in mid-session deals. US markets ended in negative territory on Tuesday.

Foreign institutional investors (FIIs) offloaded equities worth ₹ 728.82 crore on Tuesday. However, domestic institutional investors (DIIs) bought stocks worth ₹ 6,156.83 crore, according to exchange data.

Brent crude, the global oil benchmark, dipped 0.39 per cent to USD 64.64 per barrel.

On Tuesday, the Sensex declined 277.93 points or 0.33 per cent to settle at 84,673.02. The Nifty dipped 103.40 points or 0.40 per cent to 25,910.05. (PTI)

## RBI updates 'alert list' of unauthorised forex trading platforms

MUMBAI, Nov 19: The Reserve Bank on Wednesday added 7 new names to its 'alert list' of unauthorised forex trading platforms, taking the total number to 95.

The alert list contains names of entities which are neither authorised to deal in forex under the Foreign Exchange Management Act, 1999 (FEMA) nor authorised to operate electronic trading platform (ETP) for forex transactions, the central bank said.

The new additions are: Starnet FX; CapPlace; Mirror; Fusion Markets; Trive; NXG Markets; and Nord FX. (PTI)

## TRAI sets firm deadlines for BFSI entities to adopt '1600' series for service, transactional calls

NEW DELHI, Nov 19: TRAI on Wednesday mandated clear deadlines for phase-wise adoption of dedicated '1600' numbering series to be used by regulated entities such as banks, NBFCs, mutual funds and others for making service and transactional calls, in a bid to curb impersonation-based financial frauds perpetrated through voice calls.

Mandating clear completion timelines, it said commercial banks, including public sector banks, private sector banks, and foreign banks, should onboard by January 1, 2026.

"TRAI today issued a direction mandating the last dates by which adoption of the '1600' numbering series should be completed by entities regulated by the Reserve Bank of India (RBI), Securities and Exchange Board of India (Sebi), and Pension Fund Regulatory and Development Authority (PFRDA)," TRAI said in a release.

Telecom Regulatory Authority of India (TRAI) further the 1600-series direction has been issued to enhance consumer trust, curbing spam, and preventing fraudulent activities perpetrated through voice calls.

It is pertinent to mention that '1600' numbering series has been assigned by the Department of Telecommunications (DoT) for allocation to entities in the banking, financial services and insurance

(BFSI) sector, and government organisations to clearly distinguish their service and transactional calls from other commercial communications.

The dedicated series will enable citizens to reliably identify legitimate calls originating from regulated financial institutions, TRAI said.

Adoption of '1600' numbering series for all mutual funds and asset management companies (AMCs) shall be completed by February 15, 2026, while commercial banks (including public sector banks, private sector banks, and foreign banks) shall onboard by January 1, 2026, as per TRAI.

Adoption of '1600' numbering series for all qualified stockbrokers (QSBs) has to be completed by March 15, 2026.

"For the time being, other Sebi-registered intermediaries may voluntarily migrate to the 1600-series after verification of their registration details," TRAI said.

Among RBI-regulated entities, large NBFCs, payments banks, and small finance banks have been asked to onboard by February 1, 2026, and remaining NBFCs, co-operative banks, regional rural banks, and smaller entities are required to onboard by March 1, 2026.

"Central recordkeeping agencies (CRAs) and pension fund managers

shall onboard by February 15, 2026," TRAI said.

Mandating the last date for adoption of '1600' series by the entities in the insurance sector is under discussion with IRDAI, and will be notified subsequently, the regulator added.

TRAI said it has regularly engaged with telecom operators and the BFSI sector regulators for adoption of '1600' series by BFSI entities.

"Consequent to these efforts, about 485 entities have already adopted 1600 series, subscribing to a total of over 2800 numbers. Based on TRAI's interactions with stakeholders, it was considered that time is now ripe to mandate timebound completion of the exercise so that entities continuing to use standard 10-digit numbers for service and transactional calls, also shift to 1600 series numbers to reduce the risk of fraudulent or misleading calls being made in the guise of trusted financial institutions," TRAI said.

The telecom regulator has taken inputs regarding timelines from the regulators of the BFSI sector, following deliberations held during the meetings of the Joint Committee of Regulators (JCoR).

"Based on the consultations held with them, a phase-wise implementation schedule has now been issued," according to TRAI. (PTI)

## Aliaxis calls India its 'most realistic growth market', steps up capex for eastern expansion

KOLKATA, Nov 19: Global plumbing and water management solutions major Aliaxis has identified India as its "most realistic growth market" worldwide and is stepping up investments to expand its footprint beyond its stronghold in South India, its Global Managing Director Thierry Vanlancker said on

Wednesday. With a global turnover of about 4 billion Euros, the privately held Belgium-based group counts India as its second-largest market after the US.

While the US contributes nearly 20 per cent of Aliaxis' global revenue, India accounts for about 15 per cent, underscoring the country's rising strategic importance in the company's global portfolio.

Aliaxis operates in India through its wholly owned Ashirvad brand, which holds what Vanlancker described as a "very, very strong number one position in the whole southern corner of India".

"The US market is probably 30 per cent bigger than India, but India is clearly the most realistic growth market for us globally," Vanlancker told PTI during an interaction.

Vanlancker, the entire Aliaxis Global Executive Committee, and Ashirvad Managing Director Partha Basu were in the city on Wednesday to inaugurate a series of infrastructure and distribution projects, in-

cluding the first Integrated Distribution Centre in Eastern India at Panchla in Howrah and an upgraded compounding facility at its existing Durgapur plant.

The company plans to expand aggressively across the East, where it currently ranks second, and has committed around ₹ 50 crore along with its partners in manufacturing and a third-party-managed distribution hub. "The East is the most attractive region to expand in," he said. The company aims to grow at "market plus", targeting expansion above the 5 per cent annual increase expected in the pipes and fittings segment. But Vanlancker stressed that the company will not chase market share at the cost of profitability. "What we do not want to do is buy market share," he said. "We rely on investments, innovation and quality products to maintain the bottom line as we are here with a long-term view."

A significant part of the capital budget is flowing into India for two large projects - the eastern expansion centred around the existing

manufacturing plant at Durgapur and the upcoming greenfield Hyderabad plant, expected to go live by mid-next year. On Durgapur, Vanlancker clarified that the current investment is aimed at self-sufficiency or backward integration rather than expanding output capacity.

"This expansion is not to expand capacity but to make it much more self-sufficient in inputs locally instead of shipping them from Bangalore," he said. A second phase, adding pipe extrusion lines, is expected in near future, paving the way for a "modest 10 per cent capacity increase over the next two to three years". The Howrah site will also house a new state-of-the-art distribution centre, the company's second after Ahmedabad. Aliaxis plans a network of five centralised warehouses. The company has three new such integrated distribution centres. On the Jal Jeevan Mission, which has seen delays, Ashirvad MD Partha Basu said funding constraints may persist into 2025 but the outlook improves thereafter. (PTI)

The ED recovered and seized ₹ 14.5 lakh in cash during the search operations and issued freezing orders for bank accounts having a balance of ₹ 13.68 lakh.

Further, two luxury cars, a deed of land sale agreement with a valuation of Rs 65 lakh suspected to be linked to proceeds of crime (PoC) and details of many other properties allegedly owned and controlled by the key accused along with various incriminating documents and digital evidences were recovered and seized, the ED said.

The ED claimed that during the investigation, it was found that Kaundinya, along with associates Jain and Das and others, have allegedly operated a "well-organised criminal conspiracy" involving fabrication of government documents like "fake supply orders, forged signatures, forged cheques and false payment" clearance notes purportedly issued by the autonomous council of Mising, Dima Hasao and others.

This was allegedly done with an "intention of inducement" of suppliers through high-value "fraudulent orders" for blankets, tarpaulins, dyed cotton yarn, solar equipment and large infrastructure projects.

The ED claimed that "fake orders" were issued against the supply of goods worth Rs 9.86 crore and a commission amounting to Rs 2.04 crore was "illegally received", tied to the respective "fake orders".

Further investigation is in progress for the identification of proceeds of crime, attachment of properties and restitution to rightful owners through due process, the ED said. (PTI)

objectives," the report said. The report said that the two most populous countries, India and China, will also have the largest populations residing in towns between now and 2050. As of 2025, the proportion of people living in towns has reached 44 per cent in India and 40 per cent in China. Together, India and China account for more than 1.2 billion town population, representing over 40 per cent of the population living in towns globally.

However, both countries also have substantial city populations, with a combined population of nearly 1.2 billion (627 million in China and 589 million in India in 2025).

Between 1950 and 1975, both countries experienced rapid growth in their city populations, but this pace slowed between 1975 and 2000 and in subsequent years, largely due to declining fertility rates and slower overall population growth.

Despite this deceleration, city population growth has outpaced town population growth, resulting in a decrease in the share of people living in towns. Each country still has more than 200 million people residing in rural areas, a figure that is expected to remain relatively stable through 2050, it said.

The report said that the number of megacities quadrupled from eight in 1975 to 33 in 2025, with 19 in Asia. Projections indicate that there will be 37 megacities globally by 2050, as the populations of Addis Ababa (Ethiopia), Dar es Salaam (United Republic of Tanzania), Hajipur (India) and Kuala Lumpur (Malaysia) grow to over 10 million.

Among the 33 megacities with 10 million inhabitants or more in 2025, 19 are in Asia. India alone has five megacities, and China has four.

Worldwide, more than 3,000 cities experienced population decline between 2015 and 2025.

"Most cities with shrinking populations have fewer than 250,000 inhabitants in 2025. More than one third are in China and another 17 per cent are in India," it said, adding that growth and decline can occur simultaneously within countries. Some cities' populations shrank even as their country's population grew. Conversely, some cities' populations grew despite shrinking national populations.

Despite the global shift towards city life, towns remain (in 2025) the most common settlement type in 71 countries. Countries in all regions and at diverse levels of economic development are found within this group, including Germany, India, Uganda and the United States of America.

Together, India and China host more than 1.2 billion town dwellers, representing over 40 per cent of the global population of towns. The towns of sub-Saharan Africa and of Central and Southern Asia are expected to continue to experience robust population growth between 2025 and 2050.

From 2000 to 2025, the global population living in cities increased by 1.25 billion, but over half of this growth came from only a few countries. India, China, Nigeria, Pakistan and the United States of America have collectively contributed over 500 million people to the global city population.

Additionally, five other countries - Indonesia, Egypt, Bangladesh, the Democratic Republic of the Congo and Brazil - added another 187 million city dwellers. In contrast, several countries in Eastern Europe, including Ukraine, Romania, Poland, the Republic of Moldova and Hungary, along with Japan in Eastern Asia, experienced a significant decline in their city populations.

"In the world's two most populous countries, India and China, towns currently accommodate nearly one seventh of the global population, a proportion expected to persist at least through the mid-century," it said.

United Nations Under-Secretary-General for Economic and Social Affairs Li Junhua said that as governments convene at COP30 to advance global climate commitments, the United Nations underscores the pivotal role of urbanisation in driving sustainable development and climate resilience across all settlement types.

"Urbanisation is a defining force of our time. When managed inclusively and strategically, it can unlock transformative pathways for climate action, economic growth, and social equity. To achieve balanced territorial development, countries must adopt integrated national policies that align housing, land use, mobility, and public services across urban and rural areas," he said. ## ICT verdict against Hasina

Bangladesh plunged into a fresh turbulence on Monday last after the International Crimes Tribunal (ICT) announced its verdict sentencing to death former Bangladesh Prime Minister Sheikh Hasina for "crimes against humanity" committed during last year's student led agitation that led to the fall of her Awami League Government on August 5, 2024. The ICT set up by the interim Government of Bangladesh headed by Chief Advisor Dr. Muhammad Yunus also indicted Sheikh Hasina on two other counts. The verdict was on expected lines. Sheikh Hasina who has been staying in India since August 5 afternoon last year, was in a challenging mood. She said that the Tribunal was rigged. She denied every single charge and castigated Tribunal for not giving the Awami League and herself a fair chance to defend themselves. In a belligerent mood, Sheikh Hasina said in her statement "the verdict revealed the brazen and murderous intent of extremist figures on an unelected government with no democratic mandate". Monday's development took place less than three months before the scheduled general elections in Bangladesh in February 2026. Though, the exact date will be announced by the Election Commission shortly, the interim Government chief announced on Thursday last both the general elections and the referendum on the July charter would take place on the same day in February. All the political parties excluding the banned Awami League are in the thick of the election battle as this verdict was announced on Monday.

The security situation was tense during the day as Awami League called for a lock down in Dhaka and the areas surrounding the Court. Army pickets were stationed in all important points of the nation's capital. There were sporadic explosions and bomb attacks. Hasina has been active in the last few weeks and as sources indicate that the Awami League supporters including the leaders who were earlier hiding, are coming out to participate in demonstrations and bands. It seems they have decided to show their strength in public. For Awami League, after this verdict, their members will be facing new attacks and they will have to meet the challenge.

As a result, the coming few weeks are going to be stormy though the major political parties like BNP, Jamaat e Islami, NCP and others will be busy in choosing their own candidates and participating in the election campaign. A recent opinion poll about the coming elections carried out by a private agency indicated that the Awami League, despite support has still support of more than 20 per cent just below the BNP. The other parties are ranking much below. This has given a boost to the morale of the Awami League supporters but at the same time, the divided anti-League political parties are getting frightened and trying to have common approach against any fresh move by the Awami League.

## Bihar's Verdict, Congress's blind spot

The Bihar election results came in like a quiet storm. Everyone who had predicted a tight race, a hung assembly, or even a slim edge for the Mahagathbandhan woke up to find Nitish Kumar and the NDA cruising past 190 seats. For the Congress, the morning after was brutal. The party ended up with just 19 seats, its worst performance in Bihar in decades. Rahul Gandhi's rallies, Priyanka Gandhi's roadshows, the endless promises of five guarantees and ten lakh jobs all melted away in the heat of a November that belonged to Nitish Kumar once again.

Yet within hours of the defeat, large sections of the Congress ecosystem pointed fingers at the Election Commission. The charge was simple and explosive: the ECI had gone soft on Nitish Kumar's government and allowed it to transfer money to women beneficiaries right through the election season. The same commission, they reminded everyone, had stopped a similar cash transfer scheme in Rajasthan last year when Ashok Gehlot was in power. Double standards, they cried. Institutional capture. The referee had fixed the match.

There is some truth in the anger, but only some. And the moment the Congress makes the Election Commission the main villain of its Bihar story, it falls into the trap of tunnel vision. It starts seeing only what it wants to see and stops looking at everything else that actually decided the election.

Let us first admit what really happened on the ground. Women turned out to vote in record numbers, higher than men in many districts. Many of them had received two thousand rupees in their bank accounts every month under the Mukhyamantri Mahila Samridhi Yojana. When the model code of conduct came into force, the Nitish government asked the Election Commission whether it could continue the transfers because the scheme was "ongoing". The ECI

said yes. In Rajasthan, the same commission had told Gehlot's government that a new cash dole announced just before the polls could not be disbursed until voting was over. The two situations were not identical, but they were close enough for people to smell bias.

That smell is real. The Election Commission should have either stopped both transfers or allowed both. Consistency matters more than legal hair-splitting when trust in institutions is already thin. By choosing the middle path of "it depends", the commission gave critics a stick to beat it with. The Congress is right to be upset about that one decision.

But to turn that one decision into the central explanation for a 170-seat disaster is to insult the intelligence of Bihar's voters. It is also an old Congress habit: when we lose badly, blame the umpire; when we win, celebrate the people's mandate. The truth is that the people of Bihar did not wake up, check their bank balances, and robotically vote for Nitish Kumar because two thousand rupees landed in their accounts. They voted for a government that has delivered electricity, roads, schools, and a sense of stability after the dark years of the nineties and early 2000s. They voted for a chief minister who, whatever his flip-flops, still enjoys personal credibility among extremely backward castes and women. They voted against an opposition that could not even decide who its chief ministerial face would be until the last week of campaigning.

The Congress fought this election with one hand tied behind its back because it spent half its energy fighting its own ally. Tejaswini Yadav wanted more seats; the Congress wanted to prove it was still the big brother. The result was a clumsy seat-sharing formula that left both sides sulking. Rahul Gandhi flew in for a few rallies, spoke in generalities



about caste census and saving the Constitution, and flew out. There was no local narrative, no sharp attack on Nitish Kumar's

record on jobs or crime, no clear alternative vision that could travel from Patna to Purnia. The party's state leaders were either invisible or busy settling personal scores. In short, the Congress campaigned like a guest at someone else's wedding.

Meanwhile, the NDA ran a textbook campaign. It stitched together a wider social coalition than in 2020 by bringing Mahadalits and sections of non-Yadav OBCs firmly into the fold. It reminded women voters, again and again, who brought bijli, sadak, and paisa into their lives. It used the prime minister's rallies to create a sense of occasion and the chief minister's roadshows to underline continuity. And yes, it made sure the money kept flowing legally, thanks to a helpful interpretation

from the Election Commission.

The Congress can shout about EVMs and the ECI from morning till night, but it will not win back a single voter that way. The voter in Kosi does not care about what happened in Rajasthan last year. She cares about whether her daughter can study under an electric bulb, whether the road to the block headquarters is motorable, whether someone listens when she calls the police helpline. On all these counts, she decided Nitish Kumar has done better than the alternative on offer.

This is the hard truth the Congress refuses to swallow. Every time it loses, it invents a grand conspiracy instead of looking in the mirror. After 2014 and 2019, it was EVMs. After Haryana and Maharashtra last year, it was again the Election Commission. Now in Bihar, it is cash transfers and a partisan ECI. There is always someone else to blame: the RSS, the media, the bureaucracy, now the referee. Never the batsman who keeps getting out playing the

same loose shot outside off stump.

If the Congress is serious about reviving itself in Bihar, it has to do three simple things. First, build a state unit that fights elections instead of fighting itself. Second, craft a local message that speaks to caste realities and economic anxieties without sounding like a Delhi lecture. Third, choose allies wisely and stick with them instead of treating every partnership as a temporary marriage of convenience.

Until it does these things, no amount of noise about the Election Commission will matter. The people of Bihar have given their verdict with open eyes. They saw the cash transfers, they saw the roads, they saw the rallies, and they saw the confusion in the opposition camp. Then they voted.

The Congress can keep staring at the one tree that bothers it and miss the entire forest. Or it can step back, take a deep breath, and finally start seeing the full picture. The choice is theirs. The voters have already made theirs.

## Pakistan: The making of a new military state

The political upheavals unfolding across South Asia today form a tableau of turbulence, uncertainty and profound structural transformation, yet nowhere is the convergence of crisis and consolidation more stark than in Pakistan. As Bangladesh grapples with its strained transition under the Yunus-led interim government and braces for the International Tribunal's November 17 verdict on the alleged abuses committed during Sheikh Hasina's tenure, the subcontinent stands on edge. The potential extradition of Hasina from India threatens to ignite passions, inflame social tensions and revive old anxieties that have long defined Dhaka's fraught political alignments. Yet even these dramatic developments pale in comparison to the ascent of Field Marshal Asim Munir, Pakistan's second-ever recipient of the title and a figure whose rise signals an epochal shift in the nature of the Pakistani state. His consolidation of power, enshrined through the 27th Constitutional Amendment, marks not merely a political transition but the birth of a new constitutional order—one that elevates the military above all other institutions, weakens judicial oversight, and redefines Pakistan's ideological direction.

Pakistan has never been free from the shadow of its military, but for much of its history this shadow ebbed and flowed with the tides of political crisis, economic failures and shifting regional pressures. Ayub Khan's takeover in 1958, justified in his autobiography as a stabilising intervention against political chaos, established the blueprint for military governance in Pakistan: a general steps in to "save" the nation, promises temporary stewardship, consolidates power, and leaves behind institutions weakened by authoritarian rule. Yahya Khan, Zia-ul-Haq and Pervez Musharraf followed variations of this script, each insisting that the armed forces' professional competence made them natural custodians of national integrity. The CIA's declassified assessments from the 1970s warned presciently that Pakistan's military was "inherently prone to internalising ideological and political objectives beyond its remit," a diagnosis that rings with alarming clarity today. Yet even these rulers, despite their authoritarian instincts, attempted at times to cloak their ambitions within the rhetoric of professional duty or national reform. Munir, by contrast, embodies a new paradigm: the military chief as ideological vanguard, a figure who not only commands the state but also seeks to reshape its moral compass.

Munir's transformation of Pakistan's military is neither rhetorical nor incidental. It is institutional, systematic and anchored in a worldview that merges national security with religious legitimacy. Under his leadership, the armed forces have adopted narratives such as Fitna al-Khawarij and Fitna al-Hindustan, framing insurgents in Khyber Pakhtunkhwa and Balochistan as heretical threats or Indian proxies. Domestic conflicts, long rooted in ethnic grievances, political neglect and economic deprivation, are now cast through a sacred lens. Munir's speeches emphasise the military's duty to defend the Muslim Ummah, presenting Pakistan as a besieged fortress confronted by internal apostasy and external hostility. This blending of ideological and strategic aims dangerously erodes the distinction between counter-insurgency and religious warfare. Pakistan's past experiments with ideology-driven militarisation—most notoriously under Zia-ul-Haq—demonstrated the enduring consequences of allowing faith to fuse with force: the proliferation of extremist organisations, the radicalisation of society, and the weakening of civic institutions. Analysts like Makhdoom Ali Khan warn that

what Zia may have envisioned, and what Musharraf failed to fully achieve, is now becoming an accomplished reality under Munir, whose Hafiz-e-Quaran status provides a doctrinal anchor to his political authority.

The 27th Constitutional Amendment is the legal cornerstone of this reconfigured state. Passed with overwhelming parliamentary support, the amendment creates the position of Chief of Defence Forces, abolishes the Chairman of the Joint Chiefs of Staff Committee, and grants Asim Munir a lifetime rank and immunity that places him beyond legal accountability. This structural elevation is unprecedented in Pakistan's history: even past dictators who seized power through coups lacked such constitutionally codified supremacy. The amendment narrows civilian authority to ceremonial functions and constructs a system in which the military hierarchy supersedes parliamentary and executive oversight. It also introduces a Federal Constitutional Court with primacy over constitutional matters, relegating the Supreme Court to a body handling ordinary civil and criminal appeals—a transformation that senior jurists have described as reducing it to a "Supreme District Court." Tariq Mehmood Khokhar's observation that the FCC is "empowered by disempowering the Supreme Court" captures the essence of the shift: judicial independence is curtailed not through abrupt intervention but through systemic restructuring. This judicial reordering is accompanied by increasing control over provincial autonomy. By undermining the devolved governance framework established under the 18th Amendment, Munir's centralisation threatens to inflame long-standing tensions in Sindh, Balochistan and Khyber Pakhtunkhwa. Provincial leaders fear a return to the dominance of Islamabad—long shorthand for the military establishment—while separatist groups may interpret this centralisation as confirmation of their grievances. Pakistan's federal fabric, already frayed by economic hardship and political fragmentation, risks tearing further under such pressures.

Economically, Pakistan remains caught in a cycle of structural weaknesses, external debt burdens and insufficient investment. Despite official claims of renewed investor confidence and resource-driven opportunities, the Financial Times reports that poverty remains above 25 per cent, capital formation remains weak, and foreign investors remain wary of the political unpredictability and institutional instability that have long characterised the Pakistani market. Finance Minister Muhammad Aurangzeb's admission that Pakistan faces the "existential issue" of growth barely matching population increase underlines the depth of economic vulnerability. The increasing involvement of the military in commercial ventures, combined with ideological militarisation, risks diverting resources away from meaningful reform and entrenching a model in which economic decision-making serves strategic or political ends rather than long-term stability.

Yet Pakistan's internal transformations cannot be fully understood without situating them within the region's intricate geopolitical landscape. Munir's diplomatic strategy reflects both assertiveness and insecurity. Islamabad's outreach to Dhaka under Bangladesh's interim government suggests an attempt to realign regional alliances in ways that counter Indian influence. At the same time, Pakistan's engagements with China, Saudi Arabia and the United States reveal a pragmatic pursuit of multipolar partnerships. The revival of discussions around mineral wealth and strategic ports such as Pansi positions Pakistan as a pivotal player seeking leverage through geography and resources. However, beneath this geopolitical ma-

neuvring lies the dangerous possibility that Pakistan may once again nurture extremist organisations for strategic advantage. History is unequivocal on this point: ideological militancy used as geopolitical currency inevitably turns inward, destabilising the state and imperilling regional peace. The risks of miscalculation are intensified by Pakistan's evolving foreign policy posture. The four-day conflict with India in May 2025 highlighted the volatility of a militarised approach to diplomacy. Munir's decision to publicly credit the ceasefire to Donald Trump, even nominating him for a Nobel Peace Prize, reflected a willingness to employ dramatic political gestures to shape narratives both domestically and internationally. Such behaviour illustrates the unpredictable consequences of merging ideological fervour with military decision-making. Under such conditions, regional actors must navigate a Pakistan where power is centralised not merely in the uniform but in a worldview that seeks to project ideological authority.

India's own behaviour complicates matters. New Delhi's assertive regional posture, its efforts to maintain influence in Bangladesh and Nepal, and its hardened stance toward Pakistan contribute to Islamabad's sense of encirclement. While India's policies often stem from legitimate security concerns, its assertiveness nonetheless fuels a strategic environment in which Pakistan feels compelled to project strength, consolidate internal authority and pursue ideological cohesion. Yet history repeatedly demonstrates that attempts to achieve strategic depth through militarisation or ideological alignment lead not to stability but to backlash, blowback and renewed cycles of conflict. The tribunal's impending verdict on Sheikh Hasina and the potential fallout from her extradition represent another layer of fragility. Bangladesh's internal fractures, its fraught relationship with India, and Pakistan's renewed diplomatic interest create a combustible environment in which political decisions reverberate across borders. If Hasina's supporters perceive international bias or Indian interference, public anger could spiral, empowering extremist elements or destabilising the Yunus-led interim government. In such a scenario, Pakistan's outreach may appear either opportunistic or strategically motivated, potentially reshaping Dhaka's alliances in unpredictable ways.

South Asia now stands at a threshold where old institutions weaken, new ideological forces rise, and regional rivalries deepen. Munir's ascent signals the emergence of a Pakistan in which the military is not merely dominant but constitutionally unassailable, ideologically motivated and geopolitically assertive. The combination of centralised military authority, judicial reengineering, ideological legitimisation and economic fragility creates a volatile national structure with implications that extend far beyond Pakistan's borders. While TS Eliot may have described certain transformations as occurring "not with a bang but with a whimper," Pakistan's current trajectory is marked by a quiet but decisive reshaping of its very foundations. The reverberations of this transformation—political, ideological and geopolitical—will echo across the subcontinent for decades, reshaping power structures, altering diplomatic alignments and challenging the fragile equilibrium of South Asia.

In this evolving landscape, the uniform has become not merely a symbol of authority but the architecture of the state itself. And as Pakistan marches deeper into this new era, the question is no longer whether the military rules, but what kind of state it seeks to build—and at what cost to the region's stability and future. ## A major blow to Naxalism: The dawn of a New Era

Naxalism is now in its final phase, and this significant achievement and transformation is neither accidental nor sudden. It is the result of the well-planned, firm, and comprehensive strategies implemented by Prime Minister Narendra Modi and Union Home Minister Amit Shah. The menace that had bled the heartland of India for decades, the ideology that held development, security, and human sensitivity hostage, now stands on the verge of complete extinction. The most recent and striking evidence of this is the elimination of the country's most dangerous, ruthless, and strategically powerful Maoist commander—Madvi Hidma. His very name had long instilled fear not only among security forces but also within the entire administrative system. Born in the Sukma region, Hidma was a member of the CPI (Maoist) Central Committee and the head of the Battalion-1 of the People's Liberation Guerrilla Army (PLGA). Such was his infamy that a reward of ₹50 lakh to ₹1 crore had been announced on his head.

On 18 November 2025, in a precisely executed and exceptionally brave operation by security forces, Hidma, his wife Raje, and six other Maoists were neutralised. The recovery of AK-47 rifles, pistols, and other weapons from the spot confirms that this operation was a decisive strike on the backbone of Naxalism. Hidma's end is not merely symbolic—it is a strategic turning point that has shaken the Naxal network at its core. Activities in what was once known as the "Red Corridor" have significantly shrunk, indicating that the dual strategy of security and development adopted by the central government has begun producing real results on the ground. Under the "Naxal-Mukt Bharat" campaign, 300 Naxalites were killed this year, while hundreds surrendered or were arrested. These figures clearly show that Naxalism has now lost its ideological and organisational strength. The recent mass surrenders in Chhattisgarh and Maharashtra within just two days reveal that Naxal groups are losing ground even in their traditional strongholds, while tribal communities are gradually moving toward the benefits of government development schemes. The elimination of Hidma has created an irreplaceable vacuum within the Maoist leadership.

Like terrorism, Naxalism has long been one of India's most complex internal security challenges. Just as cross-border terrorism threatens national peace and stability, Naxalism—born within—has consistently obstructed the nation-building process. For decades, it was not only a concern for a few states but for the entire country. Today, however, India stands at a turning point indicating that Naxalism is indeed nearing its end. The persistent successes of recent years—the elimination of top commanders, large-scale surrenders, and rapid development in affected areas—prove that the nation is moving toward a new dawn. It is a dawn that promises freedom from fear, violence, and backwardness, and paves the way for enduring peace and accelerated progress. The roots of Naxalism lay in the social and economic inequalities that emerged after independence—land disputes, exploitation, and the neglect of tribal regions. Development never reached several remote areas; government

schemes remained on paper, and local communities deeply distrusted the administration. This environment provided fertile ground for Naxal groups to propagate their ideology. They embraced the path of violence in the name of class struggle and armed revolution, using the forests as shields and drawing tribal youth into their fold. Over time, the movement drifted from ideology to a nexus of terror, extortion, exploitation, and bloodshed. Attacks on security forces, obstruction of development work, blowing up schools and bridges, using tribals as human shields, and their hunger for power—this became the true face of Naxalism.

Through the efforts of Modi and Shah, not only has the fight against Naxalism been intensified, but development projects in these regions have also been implemented on an unprecedented scale. Significant progress has been made in building roads, establishing electricity connections, and expanding mobile networks, weakening the hold of Naxal groups. According to government data, since 2014 more than 12,000 km of roads have been constructed in Naxal-affected areas, over a thousand new bank branches have been opened, and extensive work has been done in skill development. These coordinated efforts have uprooted Naxalism from its foundation. The killing of Madvi Hidma—a ruthless and strategically vital leader—is equivalent to breaking the spine of the Naxal movement. He was the chief brain behind their military strategies, and his image had long posed a psychological challenge to security forces. The diminishing of Naxalism is not only due to well-executed security operations but also because of strong political will. When the government declared its resolve to create a "Naxal-Free India," a multilayered strategy was adopted. On one hand, security forces were strengthened with modern technology, better training, and accurate intelligence; on the other, development was accelerated through roads, schools, hospitals, telecom connectivity, and livelihood programmes. The combined force of development and security proved decisive in weakening the roots of Naxalism.

The new dawn emerging before the nation signifies far more than the silencing of guns. It means that regions left behind for decades will now join the national mainstream. Investments will increase; education and healthcare will strengthen; tourism and local industries will flourish; and people will finally live without fear. The decline of Naxalism sends a powerful message: India's democratic system is stronger than any violent ideology. Attempts to seize power through weapons, terror, and intimidation are ultimately doomed to failure. The ongoing collapse of the Naxal movement makes this truth even clearer. However, the complete eradication of Naxalism cannot rely solely on military action. It is necessary that development efforts continue consistently, tribal communities are empowered, local culture and resources are respected, and the administrative system becomes transparent and sensitive. With such continuity, the resurgence of Naxalism becomes impossible. The near-end of Naxalism is not just a security triumph for India—it is a historic turning point. It marks the conclusion of a struggle in which thousands of soldiers sacrificed their lives, millions of citizens endured decades of fear, and the nation paused its development to prioritize security. Today, as Naxalism collapses, this is not merely a government victory—it is the collective victory of India. It is the dawn of a new nation—peaceful, secure, progressive, and self-confident. A dawn that will illuminate the future of generations to come.

# Rio urges Centre to review reimposition of PAP, cites impact on tourism

**KOHIMA, Nov 19:** Chief Minister Neiphiu Rio has urged Union Home Minister Amit Shah to urgently review the reimposition of the Protected Area Permit (PAP) in Nagaland, expressing fear that the move could "severely impact" tourism, cultural exchange, and economic revival of the state.

In a letter to the Home Minister on Tuesday, Rio noted that the Ministry of Home Affairs (MHA) reintroduced the PAP regime for Manipur, Mizoram, and Nagaland from December 17 last year, citing security concerns along India's border with Myanmar. The three states had been exempted from PAP restrictions since 2010, albeit with certain conditions.

Rio said that while the situation in Manipur and the influx of Myanmar refugees into Mizoram may justify the Centre's re-assessment, Nagaland's circumstances are "vastly different".

He claimed that Nagaland is experiencing "one of the most peaceful periods since statehood", with no major security concerns and no reports of refugee ingress across the India-Myanmar border.

He attributed the stability to the homogeneous ethnicity and close social ties among border communities.

The chief minister argued that the PAP's reinstatement in Nagaland "may not be warranted", and warned of its po-



tential to disrupt the state's growing tourism sector.

He recalled raising the matter at the North Eastern Council (NEC) plenary session on December 21, expressing concern that the restrictions could deter international visitors just as the state witnessed record tourist numbers during the 25th Hornbill Festival.

The Nagaland Cabinet discussed the matter on January 6 and March 27, after which the state government wrote to the MHA seeking a reconsideration.

Rio followed up with letters on July 17

and September 10, reiterating the request for a relaxation of PAP norms, subject to any safeguards the Centre deemed necessary. Highlighting the stakes, Rio said Nagaland has emerged as a global tourism destination, driven by the state's "Land of Festivals" policy.

Increased foreign tourist arrivals, he said, have boosted the economy, generated youth employment, and strengthened India's cultural image abroad.

"The imposition of the PAP regime has the potential to negatively impact all these gains," he warned.

Rio noted that Nagaland has historically struggled to attract private investment, making tourism one of its most important engines of economic recovery.

He cautioned that the PAP restrictions could significantly reduce foreign tourist inflow and reverse progress made after "decades of conflict".

The chief minister also pointed to the international presence of Naga artists and cultural ambassadors, stating that relaxed PAP norms would encourage cultural exchange and bolster India's global cultural engagement. With the Hornbill Festival 2025 set to begin on December 1, Rio said the matter has become "urgent" amid concerns that the PAP could keep away many international visitors.

The festival is a major global attraction for Nagaland, drawing thousands from India and abroad each year. Rio added that several organisations, from tourism and education stakeholders to civil society groups, have urged the state government to push for PAP relaxation.

In his appeal, the chief minister requested the Centre to review the PAP regime and issue new, more relaxed guidelines for Nagaland. The CM assured that the state would maintain stringent security protocols and screening systems to ensure that increased tourism does not compromise national security. (PTI)

# 24-hour strike against tourism festival affects normal life partially in Manipur valley districts



**IMPHAL, Nov 19:** A 24-hour bandh opposing a tourism festival in strife-torn Manipur partially affected normal life in Imphal valley districts on Wednesday.

Several markets, business establishments and educational institutes remained closed, and a handful of vehicles were seen plying on the roads in Imphal West, Imphal East, Thoubal, Kakching and Bishnupur districts, officials said.

Government offices also recorded low attendance, they said.

Though the bandh was called by the proscribed outfit Kangleipak Communist Party (MC Progressive) from 12 am on Wednesday to protest against organising the Sangai tourism festival without resolving the ethnic conflict in the state, internally displaced people (IDPs) and several civil society organisations boycotted the event.

They contended that this was not the right time to organise such an event when people are still bearing the brunt of the ethnic violence.

However, the government said the tourism festival is also important for economic acceleration in the state.

During the bandh, no untoward incident has been reported so far, the officials said.

Security measures have been

intensified across Imphal, particularly at the site of the festival venue, on account of the general strike and boycott call.

"There have been musical concerts and local entertainment programmes across the Imphal valley this year. Thousands from Imphal valley had gone to participate in the Shirui festival held in Ukhrul earlier this year. There was no boycott.

"Unfortunately, an important festival like Sangai, which seeks to promote tourism and revive economic growth through local entrepreneurs in the state, has been boycotted," an official said.

The Sangai festival, scheduled from November 21, will be held after a gap of two years, and the preparations are underway at Hapta Kangleibung, the main venue of the event.

The festival had been suspended since 2023 after ethnic violence broke out in the state.

Chief Secretary Puneet Kumar Goel had appealed to people to participate in the festival.

"While the relief and rehabilitation of IDPs (internally displaced persons) is the top priority for the state government, holding of Sangai festival is also important for economic acceleration and providing market linkages to local artisans, entrepreneurs, craftsmen and farmers, boosting trade and investment," Goel said. (PTI)

## Two Tripura institutions to become state universities

**AGARTALA, Nov 19:** The Tripura cabinet has decided to upgrade two educational institutions — Tripura Institute of Technology (TIT) and Tripura Women's College — into state universities, a senior minister said on Wednesday.

Currently, the northeastern state has one state government-run university, MBB University, while the Tripura University is managed by the Ministry of Human Resources. The National Forensic Science University is also functioning in the state.

"The council of ministers has approved a proposal for converting TIT as a full-fledged technical varsity to manage all the technical institutions," Transport Minister Sushanta Chowdhury said at a press conference.

He said the cabinet also cleared another proposal to elevate Tripura Women's College as a state government-run university.

"The move will certainly boost higher education ecosystem in the northeastern state which reflects the government's commitment," he said.

Chowdhury said the cabinet also approved the creation and filling up of 407 posts across various government departments.

"Altogether 97 auditors, investigators and statistical investigators will be recruited in the cooperation department and the written examination will be conducted by the Joint Recruitment Board of Tripura (JRBT)," he said adding 28 posts of ICDS supervisors will be recruited by the Tripura Civil Service Commission.

He said the cabinet also okayed a plan for setting up 119 new anganwadi centres to boost child care and education.

"To manage the proposed anganwadi centres, 119 anganwadi helpers and 119 anganwadi workers will be recruited. The government aims to extend proper care to children living in rural areas," he added. (PTI)

## Three militants arrested in Manipur

**IMPHAL, Nov 19:** Three militants belonging to various proscribed outfits were arrested from two districts in Manipur, police said on Wednesday.

A 53-year-old active cadre of the banned People's Liberation Army was apprehended from the Malom Makha Leikai area in Bishnupur district on Tuesday, and unaccounted cash of Rs 3.25 lakh was recovered from his possession, a senior officer said.

Another member of the outfit was also arrested from his residence at Keibul Awang Thana Leirak in the district, he said.

One cadre of the proscribed Kangleipak Communist Party (Nongdrenkhomba) was apprehended from a rented house at Langol Housing Complex in Imphal West district, the officer said.

Meanwhile, security forces on Tuesday recovered a cache of arms and ammunition from the Nachou Kha Mamang Patton area in Bishnupur district.

Security forces have been conducting search operations in Manipur since ethnic violence broke out two years ago.

More than 260 people have been killed and thousands rendered homeless in ethnic violence between Meiteis and Kuki-Zo groups since May 2023. (PTI)

## RSS chief Mohan Bhagwat to visit Manipur for first time since ethnic violence broke out in 2023

**IMPHAL, Nov 19:** RSS chief Mohan Bhagwat is scheduled to arrive in Manipur on November 20 for the first time since ethnic violence broke out two years ago, a functionary of the organisation said on Wednesday.

During his three-day stay, Bhagwat will interact with citizens, entrepreneurs, and representatives of the tribal community, RSS state general secretary Tarun Kumar Sharma told PTI.

"Our Sarsangchalak's visit to the state is in connection with the centenary celebrations of the RSS. He is arriving from Guwahati on November 20 and will leave on November 22," he said.

This will be Bhagwat's first visit since the violence broke out two years ago, another RSS functionary said, adding that he had last visited the state in 2022.

As part of his itinerary, separate interactive sessions

will be held with prominent citizens, Janajati (tribal) community representatives, and youth leaders, Sharma said.

"On the day of his arrival, he will be meeting with entrepreneurs and eminent individuals at a programme at Konjeng Leikai in Imphal. On November 21, Bhagwat will meet and interact with tribal leaders from the Manipur hills," he said.

Asked if the RSS chief will be visiting relief camps, where internally displaced people have been staying for the last two years, he said, "This is not in the schedule as of now. The visit is mostly an internal part of the organisation."

## BJP demands SIR in Sikkim under law protecting indigenous people's rights

**GANGTOK, Nov 19:** The BJP demanded a special intensive revision (SIR) of the electoral rolls in Sikkim under Article 371(F) of the Constitution, which protects the rights of the indigenous people, a party leader said.

A delegation of BJP functionaries met the district election officer (DEO) Gangtok, to press for updating of the electoral rolls through the SIR, the party's spokesperson Sangay Gyatso Bhutia said in a statement on Tuesday.

"The BJP is committed to protecting the unique identity and constitutional safeguards of the Sikkimese people. We have clearly articulated that the electoral rolls should be revised under Article 371(F), which lays down the historical and legal framework of Sikkim," the state BJP spokesperson said.

The SIR, as and when it takes place, should adhere to the Sikkim Citizenship Order Act, 1975 and the Representation of the Sikkim Subject Act, 1974, he said.

The BJP delegation also submitted a comprehensive application, which they had submitted to the Chief Electoral Officer (CEO) earlier, detailing the party's legal and constitutional arguments on the matter.

"Our party's stand has always been Sikkim and Sikkimese people first. We will never compromise on this sacred trust. The BJP is steadfastly committed to the welfare of the people of Sikkim and its future generations," Bhutia said.

The BJP leader also criticised other political parties for their alleged silence on the need for SIR in Sikkim.

"The silence maintained by other political parties of Sikkim on an issue of fundamental importance to our identity is deeply disappointing and frankly, alarming. Their silence triggers the suspicion that they only care about their narrow political interests," Bhutia alleged.

He urged the people of Sikkim to "acknowledge this duplicity of these political parties and see through their theatrics".

The BJP remains "vigilant" and will continue to monitor the steps over the SIR demand to ensure that the interests of the Sikkimese people are safeguarded at all costs", he said. (PTI)

10 to 13 Brix, is ideal for processing and canning industries," said the Minister.

The Minister in his speech also mentioned the scented lemon, locally known as Gandharaj.

"Tripura also produces the aromatic paddy, Kali Khasa variety, famous for its natural aroma and grain quality. Alongside it, our sticky rice, locally called the brown variety, and black rice, mainly Hangar, have gained recognition for their unique culinary properties and health benefits. Notably, black rice is rich in antioxidants and has a low glycemic index, making it a superfood suitable for the growing global demand for health-oriented products. Our organic cultivation further includes ginger, turmeric, Bird's Eye Chilli, sesame, and foxtail millet. These products have strong export potential, especially in Europe, the Middle East, and Southeast Asia, where demand for clean, tasty, and chemical-free food is growing exponentially.

# Jaishankar inaugurates two new Indian consulates in Russia

**MOSCOW, Nov 19:** External Affairs Minister S Jaishankar on Wednesday inaugurated two new Indian consulates in Russia, saying their establishment will boost trade, tourism, economic, scientific, technological, academic and cultural ties between the two countries.

Expanding its diplomatic footprint in Russia, India opened the new Consulates General in the cities of Yekaterinburg and Kazan.

Russia's Deputy Foreign Minister Andrey Rudenko and India's Ambassador to Russia Vinay Kumar were also present at the function held to mark the opening.

"This is a very important day in the diplomatic history of India in the Russian Federation," Jaishankar said. The top Indian diplomat alluded to the days when he had served in diplomatic assignments at the Indian embassy in Moscow.

"This is an important day for us, when we are adding two more Consulates General in this country... Over the last few months, consistent work has been underway to establish these consulates," he said and asserted that India recognises the support received from the Russian government. Jaishankar said Yekaterinburg is often called the "third capital of Russia" due to its industrial importance, and is a "gateway to Siberia".

It is known for its heavy engineering, gem cutting, defence manufacturing, metallurgy, nuclear fuel, chemicals and medical equipment, he said.

"The opening of the consulate will give impetus to enable and to strengthen technological, scientific, economic and trade collaborations between Indian and Russian industries," the external affairs minister said. Kazan, one of the most visited



cities of Russia, hosted the 2024 BRICS summit, which was also attended by Prime Minister Narendra Modi.

"I had the pleasure of going there myself, after Moscow and St Petersburg, and with good reasons," Jaishankar said.

The region is a multi-cultural and multi-ethnic hub and acts as a "bridge between Russia and the rest of Asia".

The consulate will help strengthen people-to-people ties by encouraging cross-cultural exchanges and ITEC (Indian

Technical and Economic Cooperation) participation, he said.

Kazan is well known for its oil production and refining, for fertilisers, automobiles, defence manufacturing, pharmaceuticals and electrical equipment, the minister said.

"I am confident that with the opening of the two new consulates, there will be a further strengthening of India-Russia ties and this will surely mark a new phase in our relationship," the EAM asserted.

He further said the opening of these consulates will "not only enhance our diplomatic presence" in Russia, but will act as a "catalyst" to further boost trade, encourage tourism, and bolster economic, scientific, technology, and even academic and cultural ties between the two countries.

"The consulates will contribute to our

joint efforts in increasing our bilateral trade to USD 100 billion by 2030 as envisaged by the leaders," Jaishankar said.

In July 2024, India and Russia set a target of USD 100 billion in annual trade volume by 2030 and vowed to develop a robust bilateral payment settlement mechanism using national currencies.

The two sides had also inked a total of nine agreements to further broaden cooperation in a range of areas, including in the economic domain, following summit talks between Prime Minister Modi and Russian President Vladimir Putin.

Modi had paid a two-day visit to Russia last year, his first to the country since the start of the war in Ukraine.

Jaishankar said that there is a sizeable and diverse Indian diaspora in Russia, which includes more than 30,000 Indian students today. (PTI)

## Russian barrage kills 16 in Ukraine city as Zelensky heads for talks with Turkish leader

**KYIV, Nov 19:** A large Russian drone and missile barrage pummeled a western Ukrainian city, killing 19 people, emergency services said Wednesday, as Ukrainian President Volodymyr Zelensky arrived in Turkey for top-level talks to try to muster diplomatic support against Russia's invasion of his country.

The nighttime attack hit two nine-story apartment blocks in Ternopil, located around 200 kilometres from the Polish border, according to Interior Minister Ihor Klymenko. Emergency crews were sifting through the rubble in daylight to find any survivors, he said. At least 66 people, including 16 children, were injured, authorities said.

Russia fired 476 strike and decoy drones, as well as 48 missiles of various types, at Ukrainian targets overnight, Ukraine's air force said. The bombardment included 47 cruise missiles, with air defences intercepting all but six of them, the air force said. Western-supplied F-16 and Mirage-2000 jets intercepted at least 10 cruise missiles, it said.

"Every brazen attack against ordinary life indicates that the pressure on Russia (to stop the war) is insufficient," Zelensky wrote on the messaging app Telegram.

The Ukrainian leader said he would meet with Turkey's President Recep Tayyip Erdogan later Wednesday as part of his efforts to



diplomatically isolate Russian President Vladimir Putin and bring more international pressure to bear on him.

Putin has so far resisted making compromises, despite US pressure. "Foremost, we will discuss maximum capabilities to ensure that Ukraine achieves a just peace," Zelensky said of his talks with Erdogan, adding that the leaders have "good relations."

Zelensky also said: "We see some positions and signals from the United States, well, let's see tomorrow."

He didn't elaborate but tough new American sanctions on Russia's oil industry, devised to push Putin in the negotiating table, are due to take effect on Friday.

A senior Turkish official initially said that US special envoy Steve Witkoff would join Zelensky in

Turkey, but backtracked later in the day and said Witkoff wouldn't be coming. The official spoke on the condition of anonymity Tuesday because he wasn't permitted to speak publicly about the arrangements.

Romania and Poland scramble fighter jets

The Ukrainian city of Ternopil sits in a part of relatively peaceful western Ukraine, where many people from the east and south moved to as they fled danger along the front line.

Almost 50 people were injured in Russian strikes on three other Ukrainian regions.

Russia's Defence Ministry said it attacked Ukrainian energy facilities and military-industrial targets, including long-range drone depots, in retaliation against strikes by Kyiv on Russian territory.

Two Eurofighter Typhoon jets and two F-16s were scrambled in Romania when a drone entered the NATO member's airspace during the Russian attacks, Romania's Ministry of National Defence said.

The Polish military said that Polish and allied aircraft were deployed in the middle of the night as a preventive measure. Poland's Rzeszów and Lublin airports were closed temporarily to prioritise military aviation, the Polish Air Navigation Services Agency said.

In northeastern Kharkiv, Ukraine's second-largest city, Russian drones injured 46 people, including two girls, the head of the regional military administration, Oleh Syniehubov, wrote on Telegram. Drones hit several city districts, at least 16 residential buildings, an ambulance station, school and other civilian infrastructure, he said.

Meanwhile, the Russian Defence Ministry said Wednesday that Ukraine fired four American-supplied ATACMS missiles at the Russian city of Voronezh on Tuesday. All four were shot down, the ministry said, but the debris damaged a private house, an orphanage and a gerontology centre. There were no casualties, the ministry said.

Ukraine's General Staff on Tuesday reported firing ATACMS missiles at Russia without offering details. (AP)

## Bangladesh's HC orders committee to review of security measures for courts, judges



**DHAKA, Nov 19:** Bangladesh High Court has ordered a review of security measures for courts and judges in view of sporadic, clandestine violence in the capital and elsewhere over the death penalty verdict against deposed prime minister Sheikh Hasina, a court official said Wednesday.

"The High Court asked the Supreme Court's registrar general to form a committee to assess existing security measures for the Supreme Court, subordinate courts and all judges across the country and submit a report in 90 days," a lawyer familiar with the development said.

Unlike the federal structures as in India, unitary Bangladesh's Supreme Court comprises two divisions --- the High Court and the Appellate Division, which is the apex

court.

The lawyer said the bench comprising Justice Sikder Mahmudur Razi and Justice Raziuddin Ahmed on Tuesday simultaneously issued a rule demanding an explanation about inaction by authorities concerned in ensuring overall security of judges, their courtrooms and residences, within the Supreme Court compound and all subordinate civil and criminal courts and tribunals across the country.

Hasina was on Monday sentenced to death in absentia by a special tribunal for "crimes against humanity" over her government's brutal crackdown on student-led protests last year. Even as Awami League has called for nationwide demonstrations to protest the death sentence handed down to its chief, security forces continued to main-

tain a strict vigil across major cities on Wednesday.

Lawyer Mehedi Hasan filed the writ while two fellow lawyers told the court that the authorities had failed to ensure adequate security for judges, their courtrooms and residences across subordinate civil and criminal courts and tribunals.

They referred to past incidents, including the killing of two judges in 2005 by Islamist militants, and the recent murder of Rajshahi Metropolitan Sessions Judge's son, as "ominous signs" for the judiciary.

Also, since the ouster of Hasina government on August 5, 2024, the security in court premises appears to be of major concern as several arrested Awami League leaders, party members and defending lawyers were assaulted during their court appearance.

The Dhaka Tribune on Wednesday headlined a report 'Security concerns grow at Dhaka's lower courts,' which drew attention to a November 11 letter by Dhaka's Chief Metropolitan Magistrate (CMM) Mohammad Mostafizur Rahman to Dhaka Metropolitan Police (DMP) seeking enhanced security at Dhaka's lower courts pointing out the growing panic among judges, lawyers, court staff and litigants.

The CMM noted that judges in particular often needed to work late hours, and they needed safe passage when returning home. (PTI)

## Israeli airstrike kills 1, wounds 11 including students in southern Lebanon

**SIDON (LEBANON), Nov 19:** An Israeli airstrike on a car in southern Lebanon on Wednesday killed one person and wounded 11 including students aboard a nearby bus, the Health Ministry and state media said.

The strike in the village of Tiri came hours after an Israeli drone attack on the Palestinian refugee camp of Ein el-Hilweh in southern Lebanon killed 13 people and wounded several others. The Tuesday night strike was the deadliest among scores of Israeli attacks since a ceasefire in the Israel-Hezbollah war a year ago.

State-run National News Agency said a school bus with students happened to be passing near the car that was hit Wednesday morning. The bus driver and several students were wounded, the report said. The identity of the person who died in the car wasn't immediately clear. The Israeli military did not comment Wednesday. In the Ein el-Hilweh refugee camp, just outside the port city of Sidon, life appeared normal Wednesday but Lebanese authorities prevented journalists from entering.

At the scene of the strike, paramedics searched for human remains around a wall that was stained with blood. Several cars were burnt and broken glass and debris littered the ground. (AP)

## Iran releases Marshall Islands-flagged tanker, crew

**DUBAI, Nov 19:** Iran on Wednesday released a Marshall Islands-flagged tanker with all its 21 crew members aboard days after Tehran seized the ship without explanation, the vessel's managers said.

Tehran had no immediate comment on the release of the Talar, which marked the first ship seizure by Iran in months. The Middle East remains tense after its 12-day war in June with Israel and as concerns remain over the Islamic Republic's nuclear programme. Cyprus-based Columbia Shipmanagement said the crew "are safe and in good spirits". "We have informed their families, and the vessel is now free to resume normal operations," the firm said. (AP)

## China's diesel trucks shifting to electric; this could change global LNG, diesel demand

**HANOI, Nov 19:** China is replacing its diesel trucks with electric models faster than expected, potentially reshaping global fuel demand and the future of heavy transport.

In 2020, nearly all new trucks in China ran on diesel. By the first half of 2025, battery-powered trucks accounted for 22% of new heavy truck sales, up from 9.2% in the same period in 2024, according to Commercial Vehicle World, a Beijing-based trucking data provider.

The British research firm BMI forecasts electric trucks will reach nearly 46% of new sales this year and 60% next year.

Heavy trucks carry the lifeblood of modern economies. They also contribute significantly to global emissions of carbon-dioxide: In 2019, road freight generated a third of all transport-related carbon emissions.

Trucking has been considered hard to decarbonise since electric trucks with heavy batteries can carry less cargo than those using energy-dense diesel. Proponents of liquefied natural gas have viewed it as a less polluting option while technology for electric heavy vehicles matures.

Liquefied natural gas (LNG) is

natural gas cooled to a liquid fuel for easy storage and transport.

China's trucking fleet, the world's second-largest after the US, still mainly runs on diesel, but the landscape is shifting.

Transport fuel demand is plateauing, according to the International Energy Agency and diesel use in China could decline faster than many expect, said Christopher Doleman, an analyst at the Institute for Energy Economics and Financial Analysis.

Electric trucks now outsell LNG models in China, so its demand for fossil fuels could fall, and "in other countries, it might never take off," he said.

The share of electric in new truck sales, from 8% in 2024 to 28% by August 2025, has more than tripled as prices have fallen. Electric trucks outsold LNG-powered vehicles in China for five consecutive months this year, according to Commercial Vehicle World.

While electric trucks are twice to three times more expensive than diesel ones and cost roughly 18% more than LNG trucks, their higher energy efficiency and lower costs can save owners an estimated 10%

to 26% over the vehicle's lifetime, according to research by Chinese scientists.

"When it comes to heavy trucks, the fleet owners in China are very bottom-line driven," Doleman said.

Early sales were buoyed by generous government incentives like a 2024 scheme for truck owners to trade in old vehicles. Owners can get up to about \$19,000 to replace older trucks with newer or electric models.

Investments in charging infrastructure are also boosting demand for electric trucks.

Major logistics hubs, including in the Yangtze River Delta, have added dedicated charging stations along key freight routes. Cities like Beijing and Shanghai have built heavy-duty charging hubs along highways that can charge trucks in minutes.

CATL, the world's largest maker of electric vehicle batteries, launched a time-saving battery-swapping system for heavy trucks in May and said it plans a nationwide network of swap stations covering 150,000 km out of China's 184,000 km of expressways.

The surge in sales of electric trucks is cutting diesel use and

could reshape future LNG demand, analysts say.

Diesel consumption in China, the second-largest consumer of the fuel after the US, fell to 3.9 million barrels per day in June 2024, down 11% year-on-year and the largest drop since mid-2021, partly reflecting the shift to LNG and electric trucks, according to the US Energy Information Administration.

"The rise of China's electric truck sector is one of the more under-reported stories in the global energy transition, especially given its potential impact on regional diesel trade flows," said Tim Daiss of APAC Energy Consultancy.

LNG truck sales peaked in Sept 2023 and March 2024 after China eased transport restrictions imposed during the COVID-19 pandemic, said Liuhanzi Yang of ICCT Beijing. By June 2025, sales had slipped 6% as electric trucks gained ground.

Shell's 2025 LNG Outlook projects that demand for imported LNG in China, the world's largest LNG importer, will continue to rise partly due to LNG trucks. It also suggests LNG trucking might expand to other markets, such as India. (AP)

## Africa hosts its first G20, urges rich world to do more against climate disasters

**JOHANNESBURG, Nov 19:** In South Africa's oldest township, volunteers in wetsuits jump into the thigh-deep water of the polluted Jukskei River to untangle a net that's designed to trap garbage but damaged by heavy rains. Without the nets, the shacks of low-lying Alexandra on the outskirts of Johannesburg could face disastrous flooding.

World leaders with the Group of 20 rich and developing nations will meet this weekend in Johannesburg for the bloc's first summit in Africa. Host South Africa wants to prioritise issues affecting poor countries, including responses to disasters made worse by climate change.

South Africa will urge rich countries and international financial institutions to help more — a plea also being made at global climate talks in Brazil.

Alexandra's over half a million residents live within steps of South Africa's richest financial district, Sandton. But flooding often submerges bridges, leaving the township's children unable to get to school. It is a "big hazard," said Semadi Manganye, a resident and co-founder of the volunteer group, the Alexandra Water



Warriors.

"The ravages of the climate are directly linked to the ravages of inequality," Binaifer Nowrojee, president of the Open Society Foundations, a non-governmental organisation promoting democracy and governance, told The Associated Press.

"Countries are facing the destructive choice between growing their economies and taking climate action."

The World Bank says the poorest countries were hit by nearly eight times as many natural disasters in the decade from 2010-2020 as they were from 1980-1990. Southern Africa has been struck by

strong tropical storms in the past decade, killing thousands of people and leaving nations with unbearable rebuilding costs. Cyclone Idai, which scientists say was made more powerful by climate change, ripped through Mozambique, Malawi and Zimbabwe in 2019, causing an estimated \$2 billion worth of damage, according to the World Bank. Malawi's gross domestic product is just \$12 billion.

Last year, the El Nino weather phenomenon caused one of the worst droughts in decades in the region, devastating small-scale agriculture and leaving people even poorer.

Climate financing has been a focus of sharp debate between rich and poor countries at major summits like the G20.

Rich countries agreed at last year's United Nations climate summit to pool at least \$300 billion a year by 2035 to help developing countries deal with the impacts of climate change and weather disasters. But independent experts said much more — an estimated \$1 trillion a year — was needed by 2030.

One of the world's largest polluters, the United States, won't even attend this

weekend's G20 summit as it boycotts over US President Donald Trump's widely rejected claims that South Africa is violently persecuting a white minority.

That makes action on climate, or even a meaningful declaration, from the G20 a tall order.

The Alexandra Water Warriors have considered themselves the guardians of their environment since they formed in 2021, planting native trees to reduce urban heat and collecting and recycling trash from the river.

They face the kind of challenges seen in other townships and poor settlements across South Africa, which is the continent's most developed economy but also has some of the world's most dramatic inequality.

An Amnesty International report released this month for the G20 summit said the South African government is failing as many as 5 million people who live in informal settlements without proper housing and services and are impacted by the climate crisis. It said they are often forced to live in vulnerable, low-lying areas close to rivers. (AP)

**ITANAGAR, Nov 19:** The Arunachal Pradesh Trade Union Federation (APTUF) began the first phase of its democratic movement recently with a sit-in dharna at the Tennis Court campus at IG Park, demanding the re-engagement of 75 employees discontinued under the EARAS scheme of the Agriculture Department.

APTUF Secretary General Kenkar Yomcha told the media that the protest reflects the employees' frustration and loss of faith after serving the department for years without job regularisation.

He said the 75 employees were appointed under the centrally sponsored EARAS scheme, and some had worked for more than a decade.

However, they were suddenly discontinued in April in the name of digitalisation and were informed only in July, leaving many unemployed and unpaid for months.

Yomcha said the federation has launched the phase-wise agitation from November 17 to press for re-engagement of the terminated employees.

He said the movement will intensify with hunger strikes and even a non-cooperation movement if the government fails to respond.

Expressing disappointment, he said the state government has not acted on earlier assurances that the issue would be resolved within two weeks.

Over a month has passed without any communication from either the government or the department concerned.

He accused some officials of diverting the issue by falsely claiming that the EARAS scheme has been closed by the Centre, adding that as many as 12 regular employees are still being paid under the scheme.

# Al Falah Group chairperson had reasons to flee India: ED

**NEW DELHI, Nov 19:** A Delhi court on Wednesday sent Al Falah group chairperson Jawad Ahmed Siddiqui to ED custody for 13 days even as the agency claimed that he had "incentives" to flee India as his close family members are settled in the Gulf.

The Enforcement Directorate (ED) arrested Siddiqui on Tuesday night after conducting day-long searches against the group, linked persons and the Faridabad-based Al Falah University, which is at the focus of investigation in the November 10 Delhi blast case that killed 15 persons and injured several others.

The federal probe agency also informed the court that Siddiqui received funds of at least ₹415 crore generated "dishonestly" from the students of educational institutes run by his trust.

He was produced before Additional Sessions

Judge Sheetal Chaudhary Pradhan at her residence close to midnight. The proceedings lasted till 1 am. The judge said, "After carefully considering the submission made, I am of the considered view that all the compliances under Section 19 of the PMLA (Prevention of Money Laundering Act) have been done." "Considering the gravity of the offence and that the investigation is at nascent stage, I deem it appropriate that the accused is granted ED custody remand for a period of 13 days (till December 1)," the judge ordered. The ED had sought a 14-day custody.

The university's role emerged during probe into a 'white-collar' terror module in which 10 people, including three doctors, have been arrested by the National Investigation Agency (NIA) and Jammu and Kashmir Police.

One of the doctors at the varsity-cum-hospital,



Dr Umar-un-Nabi, is alleged to have acted as a suicide bomber while driving an explosive-laden car on November 10 that blasted outside the Red Fort, killing 15 people. The ED took cognisance of two Delhi Police FIRs to register its case on November 14 under the anti-money laundering law against the Al Falah Group.

The agency informed the court that the university and its controlling trust, under the direction of Siddiqui, generated "proceeds of crime" of at least ₹ 415.10 crore by "dishonestly" inducing students and parents to part with money on the basis of false accreditation and recognition claims.

Siddiqui's lawyer told the court that his client was falsely implicated in the present matter and the two Delhi Police FIRs were "false and fabricated." The ED claimed that Siddiqui's arrest was necessary as there was an apprehension of his absconding and of non-cooperation.

"Accused has significant financial resources and influence and has a history of serious economic offences. His close family members are also settled in Gulf countries and he has incentives to flee India.

"Given the gravity of the present allegations

(with proceeds of crime quantified in hundreds of crores) and the potential consequences under PMLA, there is a reasonable apprehension that if not arrested he may abscond or remain unavailable for effective interrogation, relocate assets and himself beyond the jurisdiction, and continue to delay or obstruct the investigation," the ED told the court.

It said Siddiqui was the founder and managing trustee who was "controlling the mind" of Al Falah charitable trust and exercises de facto influence over Al Falah University and its institutions.

The ED alleged Siddiqui's custodial interrogation was necessary to unearth and quantify the full extent of the "proceeds of crime", including those not yet visible in the disclosed income tax return (ITR) figures and to enable the timely attachment and confiscation under the PMLA. (PTI)

## Sathya Sai Baba's teachings showing light to lakhs in 140 countries, says PM Modi

Asserting that the guru placed service at the heart of human life, he said Baba's life was a living embodiment of the ideal of "Vasud-



haiva Kutumbakam" (the world is one family), and "therefore, this birth centenary year has become a grand festival of universal love, peace, and service" Modi also said that the central value of Indian civilisation was Seva and Service. "All our diverse spiritual and philosophical traditions ultimately lead to this one idea, whether one walks the path of Bhakti, knowledge or karma," he added.

"Seva Parmo Dharmah" is the ethos that has sustained India through centuries of changes and challenges, giving our civilisation its inner strength, emphasised Modi, noting that many great saints and reformers have carried forward this timeless message in ways suited to their times.

He recalled Baba's words, "Love All, Serve All," and affirmed that for him, Seva was love

in action. The Prime Minister stated that Sai Baba's institutions in education, healthcare, rural development, and many other areas stand as living proof of this philosophy.

He further said that Baba did not impose any doctrine or ideology, but worked to help the poor and alleviate their suffering.

PM Modi recalled that after the Gujarat earthquake, Baba's Seva Dal stood at the forefront of relief efforts. His followers served with full dedication for several days, contributing significantly in reaching aid to affected families, providing essential supplies, and offering psychosocial support.

He said that Sri Sathya Sai Central Trust and its affiliated organisations are advancing service in an organised, institutional, and long-term manner.

He commended the work being done in areas such as water, housing, healthcare, nutrition, disaster support, and clean energy. (PTI)

## Mamata blames ECI for Jalpaiguri BLO's death

### BJP hits back, family cites rising workload

**KOLKATA, Nov 19:** West Bengal Chief Minister Mamata Banerjee on Wednesday tore into the Election Commission after a booth level officer in Jalpaiguri district was found hanging, alleging the "inhuman, unplanned" SIR workload is crushing field staff, even as the BLO's family flagged "unbearable pressure" and the BJP blamed state officials for the tragedy.

The deceased, 48-year-old Shantimuni Orai, an anganwadi worker serving as the BLO for booth number 20/101 under Rangamati gram panchayat, was found hanging from a tree near her home in the New Glencoe tea garden area early in the morning. Her scarf was tied around her neck, police said.

Her family alleged she died by suicide after weeks of mounting stress caused by the SIR drive.

Police from Mal police station have recovered the body and sent it to Jalpaiguri Sadar Hospital for post-mortem examination. "An in-

vestigation has begun," Superintendent of Police K U Ganpat said.

Banerjee, reacting strongly on X, said she was "deeply shocked and saddened" at yet another BLO death during the revision exercise.

"Today again, we lost a Booth Level Officer in Mal, Jalpaiguri, an anganwadi worker who took her own life under the unbearable pressure of the ongoing SIR work," she wrote. Claiming that 28 people have died since the SIR process began, she alleged that a task earlier spread over three years was being forced into two months "to please political masters", putting "inhuman pressure" on ground-level staff.

"Such precious lives are being lost because of the unplanned, relentless workload imposed by the so-called Election Commission of India. A process that earlier took three years is now being forced into two months on the eve of elections to please political masters,

putting inhuman pressure on BLOs," she said.

She urged the ECI to "act with conscience" and immediately suspend the drive. "I urge the ECI to act with conscience and immediately halt this unplanned drive before more lives are lost", she said.

TMC leaders have repeatedly accused the Election Commission of advancing deadlines and overburdening BLOs with extensive house-to-house verifications ahead of the 2026 Assembly elections. At Shantimuni's home, her husband, Sukh Ekka, described a daily routine that had become "mentally unbearable". After her regular anganwadi duties and household chores, she would go out at night to collect documents and fill up forms for the revision work, he said.

"The forms are all in Bengali, but most people here speak Hindi. Mistakes were bound to happen. Every evening, people would come to our house." (PTI)

"Hardik is recovering well from his quadriceps injury at the moment. He is at the Centre of Excellence doing his RTP (Return To Play) routines. As of now, returning from quadriceps injury, he needs to build up his workload and straightaway playing 50 overs will be risky. Till the T20 World Cup, the BCCI medical team and Hardik would focus on T20is," a BCCI source told PTI on conditions of anonymity. (PTI)

# South Africa A humble India A by 73 runs to avoid series whitewash

**RAJKOT, Nov 19:** Teen batting sensation Lhuan-dre Pretorius stole the show with a scintillating hundred as South Africa A came up with an all-round performance to earn a consolatory 73-run win over India A in the third unofficial ODI here on Wednesday.

The big victory helped the visitors avoid a series whitewash after India won the first two matches.

Besides Pretorius (123 off 98 balls), his opening partner Rivaldo Moonsamy also struck a fine century (107 off 130 balls) while sharing 241 runs to help South Africa post a formidable 325 for six in the allotted 50 overs.

In reply, India A were all out for 252 in 49.1 overs.

India A never got a partnership going and barring Ayush Badoni's run-a-ball 66 and Ishan Kishan's 67-ball 53, none of the home team batters could make a mark in the stiff chase of 326.

The duo of Badoni and Kishan joined forces with India A in a spot of bother at 82 for four in 17 overs. But after having added 88 runs, Kishan, seeking to make a



case for a return to India's white-ball teams, was sent back by Nqabayomzi Peter (4/48), who also dismissed Badoni to signal the end of India A's resistance.

India A lost three wickets in quick succession with Badoni and Rana falling to Peter on consecutive deliveries.

Earlier, 19-year-old Pretorius

and Moonsamy powered the visitors after India A captain Tilak Varma asked them to bat.

The South African team lost five wickets quickly after the openers' dismissals but Delano Potgieter and Dean Forrester played useful cameos to help the Proteas go past 320.

## Shardul Thakur says white-ball matches in between red-ball fixtures keep players mentally fresh

**MUMBAI, Nov 19:** India all-rounder and Mumbai captain Shardul Thakur on Wednesday said that playing a few white-ball matches between red-ball fixtures during the domestic season helps players stay mentally fresh.

Thakur also gave a thumbs up to the current scheduling of the Ranji Trophy, which is being held in two phases for the second consecutive season. He had earlier criticised the packed itinerary of the premier domestic competition, which offered only three-day gaps between matches.

"There would always be mixed views on it, but personally I am okay with it... to play ten games in a row is tough on the body," Thakur told the media after Mumbai crushed Pondicherry by an innings and 122 runs here at the Wankhede Stadium on Wednesday.

"We have also seen how the schedule is in the UK when the ECB plays. They have seven or eight first-class games in a row and then again they keep playing after break. They put some white-ball games in between, so that every-

one mentally fresh."

"Otherwise, you are just playing one format for three months and then suddenly, white-ball cricket and then red-ball cricket is lost. So, it's good that we are playing five games and we have a bit of a break. Then we play white-ball tournament, and then again move to red-ball cricket. So that way everyone stays in touch. They stay on top of both the games mentally..."

Thakur noted the break is welcoming especially for those players who are featuring in First-Class cricket regularly.

"Players who are playing First-Class cricket throughout the year, they would have had 14 First-Class games potentially with India A games, the Irani Trophy, the Duleep Trophy or even more. So a bit of break in between, switching in the formats is always good," he said.

Thakur reiterated that age cannot be a criteria for selection after Siddhesh Lad (33) and Akhil Herwadkar (31) scripted the win for Mumbai here. "There is no rule anywhere that only young-

sters can play cricket and once you are over 30, you can't play. There is nothing like that. If you are fit, if you are running, then you should definitely feature in the Playing XI," said Thakur, after leading Mumbai to a second consecutive victory by an innings in the Ranji Trophy.

"This sport is as much about fitness as it is about skills. At the end of the day, what matters is wickets and runs."

Thakur cited Shreyas Iyer's example, saying those youngsters who perform should be given adequate backing.

"It feels good to hear that we (Mumbai) have backed youngsters. But when do you back youngsters? When youngsters come here and make 100, 50, 150 and big runs," Thakur said.

"If you remember, when Shreyas Iyer came to the Mumbai team in 2013 or 2014, he failed in the first two matches. But then, he made 70, and a 150. So he never looked back. He kept making runs. And even today, whenever he comes, plays Ranji Trophy for Mumbai, he performs like a champion," he added. (PTI)

## Iraq scores late winner against UAE

**BASRA (IRAQ), Nov 19:** Iraq kept its 2026 World Cup hopes alive by beating the United Arab Emirates 3-2 on aggregate after a dramatic stoppage-time penalty in Asian qualifying. Amir Al-Ammari's penalty in the 17th minute of added time sealed the 2-1 victory Tuesday night to send Iraq to the intercontinental playoff round in March. The teams had drawn 1-1 in the first leg in Abu Dhabi.

In March, Iraq will be one of six teams from five confederations competing for two spots at next summer's World Cup. With the loss, the UAE was eliminated from qualifying. Caio Lucas put the UAE ahead seven minutes after halftime.

Mohamad Ali equalized midway through the second half, heading in from a free kick before Iraq pressed for a winner. The breakthrough came deep into stoppage time after a handball in the area. (AP)

## BRIEF REIGN AT TOP ENDS

Rohit drops down to 2<sup>nd</sup> among ODI batters

DUBAI, Nov 19: Indian star Rohit Sharma dropped down to second place after a brief reign at the top with New Zealander Daryl Mitchell dislodging him in the ICC ODI batters' rankings issued on Wednesday.

Mitchell became the second New Zealander to hold the No.1 spot for ODI batters on the back of an excellent century against the West Indies.

He scored his seventh ODI century during the opening game in the series against the Caribbean side, and that proved enough for the in-form right-hander to overtake Rohit at the top and claim the premier position for the first time in his career.

Mitchell currently has 782 rating points, one more than Rohit, whose reign at the top spot lasted around three weeks.

It means Mitchell is now just the second player from New Zealand to hold the top ranking for ODI batters, joining Kiwi great Glenn Turner who previously held the spot back in 1979.

Fellow New Zealanders Martin Crowe, Andrew Jones, Roger Twose, Nathan Astle, Kane Williamson, Martin Guptill, and Ross Taylor all spent time inside the top five of the ODI batter rankings during their illustrious careers, but only Turner and now Mitchell have ever held the No.1 spot.

Ibrahim Zadran of Afghanistan also dropped down one place to third while Shubman Gill (4th), Virat Kohli (5th) and Shreyas Iyer (8th) are in top-10.

## Curacao makes history as smallest nation by population to qualify for World Cup

KINGSTON (JAMAICA), Nov 19: Curacao salvaged a 0-0 draw with Jamaica to become the smallest nation by population to qualify for a World Cup and will be joined by CONCACAF sides Panama and Haiti which also booked their spots.

Curacao finished as the only undefeated nation in the tournament and finished atop of Group B with 12 points to advance to the World Cup for the first time in its history on Tuesday. Curacao got the historic result it needed despite not having his coach Dick Advocaat on the bench. The 78-year-old Advocaat missed the crucial match because he had to return to the Netherlands last weekend for family reasons.

Advocaat was at the helm of the Netherlands national team for three stints and managed South Korea, Belgium and Russia before taking the job with Curacao.

According to the Central Bureau of Statistics in Curacao, the country has a population of 156,115 persons as of last January. Iceland, with a population of just over 350,000 was the smallest country to reach the World Cup when it qualified for the tournament in Russia in 2018. (AP)

## Deaflympics: Abhinav, Pranjali win air pistol mixed team gold

TOKYO, Nov 19: Abhinav Deshwal and Pranjali Prashant Dhumal clinched the gold medal in the 10m Air Pistol event, while Kushagra Singh Rajawat won bronze in the 50m Rifle Prone competition as Indian shooters continued their fine run at the 25th Deaflympics here on Wednesday. The Indian shooters have won a total of 11 medals so far in the competition.

Abhinav and Pranjali notched up a dominating 16-6 win over Ya-Ju Kao and Ming-Jui Hsu of Chinese Taipei to finish on top.

In the second event of the day, Kushagra won the bronze with a final score of 224.3. Ukraine's Dmytro Petrenko won the gold by shooting 251.0, breaking the Deaf World and Olympic Records. Colin Mueller of Germany won the silver medal with a score of 245.4.

Abhinav and Pranjali maintained their commanding position from the start of the gold medal match and never gave their opponents any chance for a comeback.

The pair had earlier equalled their own Deaf World and



There were also big gains for a host of Pakistan players following their ODI series against Sri Lanka, with Mohammad Rizwan (up five places to equal 22nd) and Fakhar Zaman (up five rungs to equal 26th) making

eye-catching improvements on the list for ODI batters.

Pakistan registered an impressive 3-0 series sweep during the three-match rubber against their Asian rival, with spinner Abrar

Ahmed (up 11 places to ninth) and pacer Haris Rauf (up five spots to 23rd) being the big winners on the latest rankings for ODI bowlers that are still led by Afghanistan tweeker Rashid Khan.

Meanwhile, the completion of the opening Test between India and South Africa in Kolkata saw a host of players from both the sides climb the latest Test rankings for batters, with Proteas skipper Temba Bavuma moving to the top five for the first time in his career following his excellent hand of 55 not out in the second innings of the match.

India counterpart Shubman Gill rose two spots to 11th despite picking up an injury during the same match, while Bangladesh skipper Najmul Hossain Shanto moved up four places to equal 34th following his century in the first Test against Ireland in Sylhet.

India pacer Jasprit Bumrah held on to his spot as the No.1 Test bowler after six wickets during the first Test at Eden Gardens, with teammates Kuldeep Yadav (up two spots to a career-best 13th) and Ravindra Jadeja (up four places to 15th) among the players to make some inroads.

South Africa duo Marco Jansen (up one spot to 11th) and Simon Harmer (up 20 places to 24th) also rose in the list for Test bowlers following decent hauls against India.

Jansen also gained one place to move to fifth on the latest rankings for Test all-rounders. (PTI)

## Gill not exactly fit but desperate to play

GUWAHATI, Nov 19: Shubman Gill has travelled to Guwahati with the rest of the India squad for the second Test against South Africa, but the neck injury that is on the mend is unlikely to fully heal before the game begins here on Saturday.

However, it is understood that the skipper will try his best to prove his fitness during training sessions on Thursday and Friday. The squad has landed in the city.

If sources in the Indian team are to be believed, the 26-year-old Gill is far from being 100 per cent fit, with the pain in the nape of his neck still lingering although its intensity has reduced considerably.

"Shubman has been responding well to the medical treatment provided and will travel to Guwahati with the team on 19th November, 2025," read a statement from BCCI secretary Devajit Saikia.

"He will continue to be monitored by the BCCI medical team and a decision on his participation in the 2nd Test will be taken accordingly," he added, continuing the suspense on the batting star's availability.

While he might be clinically fit, the rigours of five-day cricket



could aggravate the issue and result in a longer lay-off.

With the series on line and off-spinner Simon Harmer posing a significant threat after the Kolkata Test, a competent right-hander who can take on spin is a necessity.

The current coaching staff and selection committee don't have a lot of faith in the likes of Sarfaraz Khan, Karun Nair or Abhimanyu Easwaran, even though all three handle spin well.

Their simple logic is: even though both Sai Sudharsan and Devdutt Padikkal are left-handers,

bringing in someone from outside would signal a massive lack of trust in the youngsters' ability to handle pressure.

However, Sudharsan has looked far from convincing, and there is a school of thought that Dhruv Jurel, with his tighter technique, might be a better fit at No. 3.

In this backdrop, Gill, known to train even on optional days, might just want to be fit enough to bat, as even a half-fit skipper is seen as more effective than Sudharsan, Easwaran or Sarfaraz.

Also, as a new captain still earning his stripes in the dressing

room, missing a Test at this nascent stage of his leadership is the last thing he would want.

## A tricky call

There is another aspect to the story. Gill probably needs at least 10 days to fully recover and then complete his rehabilitation to be match-ready. But if he plays the Test match, the logical step for selectors would be to rest him from the ODI series starting November 30 in Ranchi.

With little at stake in the series, he could easily take a break and return for the T20s against South Africa.

But with his ODI deputy Shreyas Iyer far from fit after his on-field injury, the last thing Gill wants is a third captaincy contender in KL Rahul or Axar Patel, even if it means only in a stop-gap role.

One thing is certain, Gill can't realistically play the second Test, three ODIs and five T20s in the next four weeks, along with all the air miles involved.

It could easily boomerang, and looking at the bigger picture, the emerging leader would need a break for his own and the team's greater good. (PTI)

## Iraq scores late winner against UAE to keep its World Cup hopes alive

BASRA (IRAQ), Nov 19: Iraq kept its 2026 World Cup hopes alive by beating the United Arab Emirates 3-2 on aggregate after a dramatic stoppage-time penalty in Asian qualifying.

Amir Al-Ammari's penalty in the 17th minute of added time sealed the 2-1 victory Tuesday night to send Iraq to the intercontinental playoff round in March. The teams had drawn 1-1 in the first leg in Abu Dhabi.

In March, Iraq will be one of six

teams from five confederations competing for two spots at next summer's World Cup.

With the loss, the UAE was eliminated from qualifying.

Caio Lucas put the UAE ahead seven minutes after half-time.

Mohamad Ali equalized midway through the second half, heading in from a free kick before Iraq pressed for a winner. The breakthrough came deep into stoppage time after a handball in the area. (AP)

## Mumbai, J&amp;K complete formalities to notch easy wins



MUMBAI, Nov 19: Mumbai needed just over half an hour to complete the formalities as they beat minnows Puducherry by an innings and 222 runs on the final day to top Group D in Ranji Trophy here on Wednesday.

Following on after conceding a mammoth 498-run first innings lead to their formidable opponents, Puducherry added just 45 runs in 8.3 overs for the loss of four wickets on the fourth morning to be all out for 276.

Puducherry were staring at a defeat after beginning the day on 231 for 6. Tushar Deshpande scalped two wickets while captain Shardul Thakur and Ayush Mhatre got one each as Mumbai got the job done in quick time.

Both Deshpande and Thakur ended the match with five wickets apiece while Siddhesh Lad and Akash Anand scored centuries in Mumbai's huge first innings total of 630 for 5 declared.

Mumbai collected seven points from their third win while Puducherry got none.

Mumbai topped Group D with 24 points ahead of Jammu and Kashmir (20 points) after playing five matches each.

## J&amp;K hammer Hyderabad

In Jammu, Abid Mushtaq spun J&K to an incredible win as Hyderabad were bowled out for 190 while chasing 472. It was Jammu & Kashmir's third win.

The wrecker-in-chief was the left-arm spinner Abid Mushtaq, who finished with figures of 7 for 68. It was his ninth five-wicket haul in first-class cricket.

This match also ended in quick time on the fourth morning with Hyderabad losing their remaining three second innings wickets in 5.2 overs while adding just 21 runs. They had resumed the day at 169 for 7.

Mushtaq picked all the three wickets to add to his earlier four in the Hyderabad second innings.

Jammu & Kashmir collected six points from the win while Hyderabad got none.

## Rajasthan take points for first-innings lead

At Rajsamand, hosts Rajasthan tried their best to eke out a result on the final day but a determined batting effort from Delhi forced their Group D clash into a draw.

Delhi reached 316 for seven in their second innings following on, having extended their lead to 42 runs overall after making 296 in the first innings.

Rajasthan had piled up a massive 570 for seven declared and with Delhi falling well short of the follow-on mark, the hosts also took away three points for taking a lead of 274 runs in the first innings.

For Delhi, skipper Yash Dhull waged a strong fight as he made a strokeful 189 from 242 balls with 27 fours and two sixes, aided well by Ayush Doseja (64 from 108 balls, 7x4s, 1x6s).

## Chhattisgarh play out a draw against Himachal

Chhattisgarh were 15 for no loss in their second innings against Himachal Pradesh when the two teams decided to call off their contest at the Amtar Cricket Ground in Nadaun.

With a total of 16 wickets falling across four days, Chhattisgarh, who made 585/6 declared in reply to HP's 425, walked away with three points for taking a lead of 160 runs in the first innings.

## Freeman scores twice as US routs Uruguay 5-1

TAMPA (USA), Nov 19: Alex Freeman scored twice and Sebastian Berhalter and Diego Luna had one goal each as the United States overwhelmed Uruguay with a four-goal first half in a 5-1 win to head into a World Cup year with a five-game unbeaten streak.

Tanner Tessmann added a 68th-minute goal for the U.S., which scored five times against a South American opponent and a top 30 team for the first time.

The 16th-ranked Americans continued their autumn turnaround after lackluster performances in the CONCACAF Nations League and Gold Cup.

They have just two more games, March friendlies likely against Belgium and Portugal, before coach Mauricio Pochettino selects his World Cup roster.

Freeman, Berhalter and Tessmann all scored their first international goals on Tuesday night as the U.S. got five goals against a team outside the CONCACAF region for the first time since beating Scotland 5-1 in 2012. The Americans have won four games, including three straight, during the five-game unbeaten streak against World Cup-bound teams.

Uruguay's Rodrigo Bentancur was sent off in the 64th minute for a high sliding tackle on Berhalter. La Celeste, ranked 15th and headed to its fifth straight World Cup, had entered the friendly with a six-game unbeaten streak.

Berhalter, a son of former coach Gregg Berhalter, put the U.S. ahead in the 17th minute off a free kick and Freeman headed in Berhalter's corner kick in the 20th. Freeman added a 31st-minute goal and Luna opened a four-goal lead in the 42nd.

Fielding a starting lineup of mostly backups, the U.S. scored four goals in a half for the first time against a South American team.

Uruguay's Giorgian de Arrascaeta scored on a 7-yard overhead kick in the first minute of first-half stoppage time, his 13th international goal, after goalkeeper Matt Freese and defenders Auston Trusty and Mark McKenzie converged and all failed to clear the ball.

Before the start and again at the final whistle, Pochettino hugged Uruguay's Marcelo Bielsa, the coach who signed him as a 13-year-old for Newell's Old Boys in Argentina. (AP)

## Soccer superstar Ronaldo joins Saudi crown prince during a White House visit

WASHINGTON, Nov 19: Soccer superstar Cristiano Ronaldo was at the White House as President Donald Trump hosted a glitzy dinner to honor Saudi Arabia's Crown Prince Mohammed bin Salman.

The soccer star was seated near the front of the East Room, not far from where the president and crown prince gave remarks to officials from both nations, along with major business leaders such as Apple CEO Tim Cook and Tesla founder Elon Musk on Tuesday.

Trump, in his speech, made a point of recognizing Ronaldo, whom he said he introduced to his teenage son.

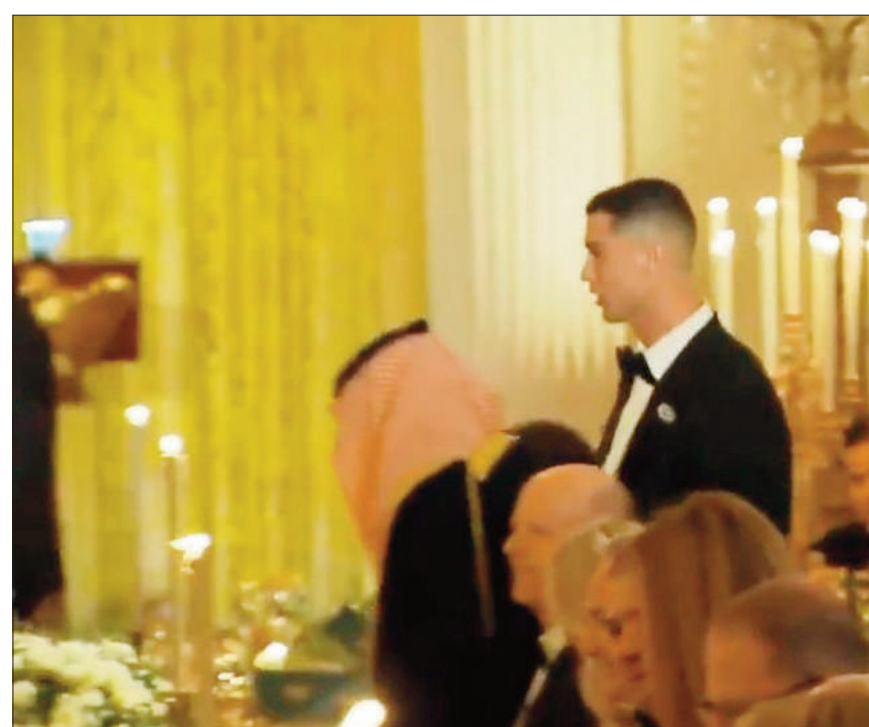
Ronaldo has been the face of the Saudi soccer league since joining Saudi club Al-Nassr at the end of 2022 on a reported \$200 million-a-year contract.

The 40-year-old Portuguese star signed a two-year extension in June with Al-Nassr, which is majority owned by the Saudi sovereign wealth fund that the crown prince chairs.

Trump thanked the athlete for attending. He said that his youngest son, Barron, is a "big fan" of Ronaldo and the 19-year-old was impressed that he got to meet the soccer player.

"Barron got to meet him. And I think he respects his father a little bit more, now, just the fact that I introduced you," Trump said.

Prince Mohammed was visiting the White House for the first time since a period of



diplomatic isolation began in 2018 after the killing of Washington Post journalist Jamal Khashoggi by Saudi agents in a consulate office in Istanbul. U.S. intelligence agencies determined that Prince Mohammed likely

directed the operation. He has denied involvement in the killing.

It was a rare U.S. visit for Ronaldo, who hasn't played in the country since 2014.

In 2017, German news magazine Der

Spiegel reported that Ronaldo had years earlier paid \$375,000 in hush money to a woman who accused him of raping her at a Las Vegas hotel in 2009. Ronaldo's lawyers maintained the sex was consensual and no criminal charges ever were filed.

## World Cup connection

Saudi Arabia will host the 2034 World Cup after FIFA and its president, Gianni Infantino, shaped a fast-track bidding process two years ago that helped ensure there was no rival bid.

Ronaldo promoted that bid, saying last December when the Saudi win was confirmed "after what I see, I'm more convinced that 2034 will be the best World Cup ever."

Ronaldo is set to play at a record sixth edition of the World Cup next year after Portugal qualified Sunday for the tournament co-hosted by the U.S., Canada and Mexico. However, he likely will be banned by FIFA for Portugal's first game next June after getting his first red card last week in 23 seasons playing for the national team.

Portugal will learn its World Cup opponents on Dec. 5 at the tournament draw, which Trump is set to attend at the Kennedy Center in Washington.

Trump has closely aligned himself with the 2026 World Cup. In the Oval Office he has a copy of the golden trophy loaned to him by FIFA President Gianni Infantino. (AP)
