# Organiser detained, probe ordered as Mamata apologises to fans Fans on rampage as Lionel Messi's Kolkata event turns 'messy'

**KOLKATA, Dec 13:** Chaos at the Salt Lake stadium here during a Lionel Messi event on Saturday escalated into a major law-and-order episode with police detaining the prime organiser for alleged mismanagement, even as West Bengal Chief Minister Mamata Banerjee ordered a high-level inquiry and apologised to fans who failed to see the football icon.

What was billed as a marquee sporting spectacle unravelled into disorder as thousands of spectators protested after being unable to get a clear glimpse of Messi, triggering vandalism inside the stadium and sharp political and administrative reactions later in the day.

Accompanied by long-time strike partner Luis Suárez and Argentine teammate Rodrigo De Paul, Messi, the World Cup-winning captain, arrived at the Vivekananda Yuba Bharati Krirangan around 11.30 am.

His vehicle was parked near the touchline and, as he stepped onto the field, he was quickly encircled by VIPs, organisers, celebrities and security personnel, leaving spectators in the galleries straining for a view.

Messi walked a short distance

on the pitch and waved briefly towards the stands amid chants of "Messi, Messi".

Fans, however, soon realised that he remained tightly cordoned off and barely visible from large sections of the stadium.

Several spectators complained that even the giant screens failed to provide a clear view.

Frustration mounted when it became evident that Messi would not complete the full lap of the stadium that was part of the original programme.

Instead, he turned back midway and was escorted out well before the scheduled end of his appearance.

As word spread that the football star had left prematurely, anger spilled over. Bottles and plastic chairs were hurled onto the pitch, sponsor banners and hoardings were torn down, fibreglass seats smashed, and sections of the crowd attempted to breach barricades to force their way onto the field.

Protesters raised slogans demanding the arrest of state Sports Minister Aroop Biswas and the event's chief organiser Satadru Datta, accusing them of gross mismanagement.

Eyewitnesses said the situation worsened after organisers, including Datta and his team, were no longer visible on the ground soon after Messi's exit.

Repeated announcements over the public address system asking unauthorised persons to vacate the field went largely unheeded as hundreds of spectators spilt onto the pitch, pulled down temporary tents and damaged equipment near the touchline.

Police personnel struggled to contain the surging crowd on the pitch, prompting the deployment of the Rapid Action Force inside the stadium. Some protesters were baton-charged to restore order, police sources said.

"This was complete mismanagement," said Ajay Shah, a football enthusiast who had come with his son. "People have spent a month's salary to see Messi. I paid ₹ 5,000 for a ticket. We came to watch Messi, not politicians."

Ticket prices for the event ranged between ₹ 4,500 and ₹10,000, with many fans arriving early in the morning in the hope of seeing the football legend up close.

The chaos forced an abrupt curtailment of the programme, with



several invited dignitaries, including Bollywood actor Shah Rukh Khan, former India cricket captain Sourav Ganguly and Chief Minister Mamata Banerjee, unable to participate as planned.

Police sources said the situation did not fully spiral out of control, only because Messi was taken out of the stadium earlier than scheduled and additional security forces

were rushed in.

Hours later, Banerjee expressed shock over the alleged mismanagement and announced the constitution of a high-level enquiry committee.

In a post on X, she apologised to Messi and sports lovers who had gathered at the stadium.

"I am deeply disturbed and shocked by the mismanagement

witnessed today at Salt Lake Stadium," she said, adding that thousands of fans had assembled at the venue hoping to catch a glimpse of the World Cup-winning star.

The inquiry committee will be chaired by retired Calcutta High Court judge Justice Ashim Kumar Ray, with the chief secretary and the additional chief secretary of the Home and Hill Affairs Department

as members.

The panel will fix responsibility and recommend measures to prevent such incidents in the future, Banerjee said.

Meanwhile, Director General of Police Rajeev Kumar said the prime organiser of the event had been detained in connection with the incident.

"The plan was that he would come, wave, meet certain people and leave. The government has already constituted a committee which will look into all aspects, including whether there was any mismanagement on the organiser's side," Kumar said.

He added that the organiser had given an assurance in writing that he would refund the ticket prices sold to spectators.

"The situation is now under control," the DGP said. TV channels, however, reported that the chief organiser has been arrested.

For a city that prides itself on its deep footballing culture, the scenes of broken chairs, ripped banners and angry fans stood in stark contrast to the promise of the day, as a much-anticipated Messi appearance ended in chaos at one of India's largest football arenas. (PTI)

## Centre of Excellence in aerospace, defence in Assam soon: CM

**GUWAHATI, Dec 13:** Specialised skilling in high-value sectors such as aerospace, defence and electric mobility will now be accessible in Assam, with Chief Minister Himanta Biswa Sarma announcing that a state-of-the-art Centre of Excellence (CoE) will soon come up at the Assam Engineering College (AEC) campus in Guwahati.

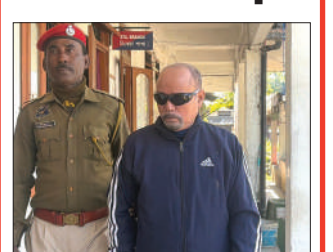
Taking to the X platform on Saturday, the Chief Minister said that earlier, students and professionals aspiring for advanced skilling in these sectors had to travel to metros and spend significant amounts on training. "Not anymore," he wrote, adding that the new facility will bring world-class training infrastructure to the doorstep of Assam's youth.

The upcoming Centre of Excellence—focused on Aerospace & Defence, Automotive and Electric Vehicle (EV) industries—is being developed with a total investment of ₹243.66 crore, of which ₹200 crore will be contributed by Dassault Systemes India. Spread over 5,000 sq ft, the centre is expected to train and upskill 10,000 candidates, including students, working professionals and employees from various industries.

A senior official asserted that the CoE will impart domain-specific skills, facilitate upskilling and reskilling, and provide crucial support to start-ups and MSMEs operating in emerging technology sectors. By integrating advanced simulation tools, digital manufacturing techniques and industry-driven modules, the facility aims to prepare a highly skilled workforce capable of meeting global industry standards.

The state government believes the initiative will significantly strengthen Assam's talent ecosystem while reducing dependency on larger cities for specialised training. The centre is also expected to enhance industry-academia collaboration, positioning Guwahati as a hub for high-end technological innovation (CONTD. ON PAGE-2)

## Zubeen case: Garima welcomes SIT chargesheet

**GUWAHATI, Dec 13:** Zubeen Garg's wife Garima has welcomed the chargesheet filed by the Special Investigation Team (SIT), which named four people in connection with the singer's murder.

"The investigation began on the basis of the FIR filed by us against the accused on behalf of our family. The probe proceeded on expected lines for which we are very grateful to the investigating agency," Garima told reporters.

She added that the probe's results were in accordance with public expectations and said, "Now everything depends on the judicial process, which we hope will move smoothly. We have faith in our nation's judiciary and want the guilty to be punished accordingly."



Garima said Chief Minister Himanta Biswa Sarma has indicated that the Chief Justice will be requested for a fast-track court, adding, "We also want the matter to be resolved at the earliest. Our

house has been shattered and people are very disturbed that a person like Zubeen Garg could be killed. The people of entire Assam want the guilty to be punished."

On participation in investigations by Singaporean authorities, she said the probe is based on the family's FIR, and they have full faith in the probe and judiciary.

The SIT, probing the death of Zubeen Garg, charged four accused, including the singer's secretary Siddhartha Sharma and festival organiser Shyamkanti Mahanta, with murder in the chargesheet filed in a court here on Friday.

Garg's band members, Shekhar Jyoti Goswami and Amritprava Mahanta, have also been charged with murder. (CONTD. ON PAGE-2)

## Making Assam flood free tops govt's priority list: Himanta

**GUWAHATI, Dec 13:** Chief Minister Himanta Biswa Sarma on Saturday asserted that building long-term flood resilience has emerged as one of the government's highest priorities, marking a decisive shift from what he described as decades of "temporary and fragile solutions" to a more durable and scientific approach.

Highlighting the transformation since 2016, Sarma said the era of weak earthen embankments is steadily coming to an end.

Taking a dig at previous Congress governments, Sarma said, "Before 2016, most embankments in Assam were earthen and had already crossed their lifespan. Flood protection was weak, temporary and highly vulnerable to breaches."

He also underlined how frequent embankment failures worsened annual floods and erosion across the Brahmaputra and Barak valleys.



According to Sarma, the government has since adopted a policy-driven shift towards long-life concrete embankments. He said that since 2022 alone, nearly 900 kilometres of new embankments have been constructed, with a target of completing 1,000 kilometres of concrete embankments in the

near future. This, he argued, reflects a clear political commitment to replace stop-gap arrangements with permanent infrastructure.

Drawing a contrast with the past, Sarma noted that earlier Assam witnessed between 17 to over 30 embankment breaches every year, severely impacting lives, agriculture and public infrastructure.

"This year, the number of breaches has been reduced sharply to just five," he claimed, adding that the impact of floods and erosion has been significantly curtailed in several vulnerable districts.

The Chief Minister said flood management was not merely an engineering challenge but a governance issue neglected by previous regimes. He maintained that his government's approach combines infrastructure creation with accountability, planning and sustained investment.

Sarma's remarks come at a time when flood control remains a politically sensitive issue in Assam, where seasonal floods have historically shaped public opinion and electoral narratives. By projecting tangible reductions in breaches and long-term infrastructure creation, the BJP-led (CONTD. ON PAGE-2)

## Cybersecurity of Power Grid Infrastructure Draws Policy Attention Amid Ongoing Parliament session

**NEW DELHI, Dec 13:** The increasing digitalisation of India's power sector has brought renewed focus on strengthening cybersecurity safeguards across the national transmission network. With modern grids relying heavily on connected systems, experts highlight the importance of advanced protection layers, real-time monitoring and international best practices to ensure uninterrupted power supply. The issue has also gained parliamentary attention. An unstarred question submitted in the Lok Sabha for reply on December 18 has sought updates from the Ministry of Power on various aspects of grid cybersecurity. These include the identification of substations requiring Next Generation Firewalls (NGFWs), priority locations for intervention, the status of cybersecurity audits undertaken over the past year, and ongoing collaboration with national agencies such as CERT-In for real-time monitoring and response coordination.

As part of the sector's modernisation efforts, utilities periodically revise procurement plans to align with emerging technical requirements. In this context, Power Grid Corporation of India Limited (PGCIL), through an official communication dated 22 August 2025, informed bidders that the earlier tender for Procurement of Firewall for Substation had been annulled. But the annulment of the tender raised serious question by various stakeholders as Power Grid corporation required immediate upgradation as far as cyber security is concerned.

Experts say that as cyber threats evolve globally,



critical infrastructure operators are increasingly integrating multi-layer security approaches. These include NGFW deployment, Security Information and Event Management (SIEM) systems, intrusion-prevention tools, and compliance with international frameworks such as NERC-CIP and ISO 27001. Strengthening institutional coordination between central utilities, state entities and national cybersecurity agencies is also seen as a key component of future readiness.

Stakeholders expect that ongoing discussions, combined with parliamentary queries and periodic upgrade cycles, will support the development of a more resilient digital ecosystem for the power sector. With India's grid expanding and adopting advanced technologies, cybersecurity preparedness is anticipated to remain a priority area in the sector's long-term planning. (PTI)

Assam minister Bimal Borah and Tinsukia MLA Sanjay Keshan were also present during the arrival of the bodies. "It is a tragic incident and we are doing the investigation. So far, the police have arrested the contractor and another person will be arrested soon. The police will investigate and bring justice to the family," said Tinsukia DC Swapneel Paul.

"Today, the team have retrieved 11 bodies from the site and the rescue operation was called off for today and tomorrow morning, again the rescue operation will start at 6 am. Yesterday, we have retrieved six bodies and handed them over to Tinsukia district administration," said Nang Chingni Choupoo, DDMO (In-charge) Anjaw district. Choupoo said, "It is one of the most dangerous rescue operation. The NDRF, BRO, Indian Army and official of Anjaw district administration were engaged in the Tinsukia operation. It is a very tough terrain and very risky operation."

A tragic vehicle accident involving a mini dumper occurred on December 8 last on the HMC (Hayuliang-Metengliang-Chaglagam) road, near Chaglagam Circle under Hayuliang Sub-Division, Anjaw district of Arunachal Pradesh, in which 22 persons including the driver were reported to be involved.

The incident site is approximately 60 km from Hayuliang towards Chaglagam in a deep gorge, making access and retrieval extremely challenging.

The incident came to light after the lone survivor Budheswor Deep informed the people about the accident.

## Ex-IAF personnel held for alleged

public outrage in the locality. The accused, Kulendra Sarma, a former Junior Warrant Officer who retired from the IAF in 2002, was apprehended following a secret operation carried out by Tezpur police based on confidential intelligence inputs. Sarma is a resident of Patiaachuburi under the Kachari Gaon police outpost.

Police sources said Sarma was detained during a discreet raid at his residence on Friday evening. Several electronic devices, including a mobile phone and a laptop, were seized during the operation. Forensic examination of the devices reportedly revealed objectionable material, leading to the registration of a case (Case No. 785/2025) under Sections 147, 148, 152, 238 and 62(2) of the Bharatiya Nyaya Sanhita (BNS). He was subsequently placed under arrest.

Investigators allege that Sarma used WhatsApp to share sensitive defence-related information with individuals linked to Pakistani spy agencies. Authorities are now attempting to retrieve deleted messages and data from his devices to determine the full extent of the alleged security breach.

After retiring from the Air Force, Sarma worked as a Technical Officer in the Department of Electronics at Tezpur University and retired from the post around two years ago. He has been residing in the area for nearly a decade. Notably, his only son is currently serving in the Indian Air Force. Sarma was produced before a local court on Saturday, which granted police custody for five days for further interrogation.

Meanwhile, the arrest sparked protests in the neighbourhood, with residents demanding strict punishment and raising slogans condemning the accused.

## Combine harvester catches fire in Sootea paddy field

## Jaggery farmers in KA face crisis as market sees no buyers

**KHERONI, Dec 13:** The biggest jaggery market in Assam, located in West Karbi Anglong, is witnessing a severe slowdown with no customers coming to buy jaggery. Traders who usually purchase jaggery for export to various parts of the state are reportedly absent, leaving local farmers in distress.

The situation was observed at the Kheroni weekly market, where farmers who cultivate sugarcane had brought jaggery for sale but found no buyers. Allegations have emerged that in recent days, police in Upper Assam have been conducting raids against jaggery traders, arresting them under the pretext of selling 'Lali Gur,' a type of low-grade or liquid jaggery.

As a result, the jaggery business has come to a standstill. Farmers are reportedly facing significant losses, unable to sell their produce. Meanwhile, some traders have alleged that Bokakhat police are collecting money from exporters who transport jaggery from Karbi Anglong to Upper Assam, further complicating the situation.

Under this society, she trained many local artisans in bamboo and wood crafts and weavers on handlooms. She is an expert in traditional Karbi tribal textiles and particularly skilled in Saphee Lanphee (hand embroidery) crafts. *Mobile theatre has been working as a powerful element in the propagation and expansion of the Assamese language. Though various dialects and spoken forms prevail in different parts of Assam, the mobile stage has always held up a model of standard Assamese before the audience, helping to establish linguistic unity. Yet in some plays nowadays, distorted use of language and application of obscene words in the name of character popularity or humour have become a matter of concern. As a result, there is a danger that the new generation, who learn or imitate language by watching mobile theatre plays, may receive wrong lessons*

Mobile theatre is not merely a theatrical genre or a medium of entertainment on the cultural map of Assam; rather, it is a throbbing pulse of Assamese national life and a symbol of pride that has profoundly influenced our social system over several decades. This unique art form, unseen anywhere else in the world, has achieved a marvellous fusion of art and commerce where thousands of people sit together in temporary auditoria to enjoy plays. Yet with the changing social order, the impact of globalisation, and the rapid onslaught of technology, this historic institution now faces certain new and complex challenges. Unless we engage in deep reflection and discussion right now, the possibility of a threat to its very existence in the future cannot be ruled out.

The future of mobile theatre does not depend only on producers or actors and actresses; it rests on the sense of responsibility of the audience—that is, the general public of Assam and its conscious citizens—because this institution has played the role of a powerful carrier in taking our language, literature, and culture to the grassroots level. Therefore, at this critical moment, determining the future course of mobile theatre and carrying forward its heritage intact while keeping pace with the new era has become a moral and social duty for all of us.

The economic foundation of mobile theatre and its social impact are extremely wide-ranging, and for their analysis we must not look only at the external glamour but comprehend the vast economic cycle that operates behind the scenes. In a state like Assam, industrially backward and grappling with burning unemployment, mobile theatre has taken the shape of a huge unorganised industry that arranges livelihood for thousands of families. A single theatre troupe does not involve only actors and actresses; numerous technicians, lighting artists, sound engineers, pandal-building workers, cooks, drivers, and their assistants are associated with it. When a troupe travels to a village or town, an economic vibrancy is created in that area for a few days, benefiting local traders, small shopkeepers, and people connected with transportation. Yet at present the running costs of this industry are rising rapidly, and competition is intensifying in parallel. In order to attract audiences, excessive dependence on costly glamour and publicity sometimes leads to compromise in the core standard of the play. This trend of commercialisation raises apprehension that it may adversely affect the distinctive character of mobile theatre. For this industry to survive in the future, it must not remain confined merely to earning money; it has to live on as a healthy cultural movement, where producers develop the mentality of spending a fixed percentage of profit on improving the standard of plays and on the welfare of workers. Our duty is to understand this economic struggle and, instead of thinking our responsibility ends with buying a ticket, to help create a favourable environment for the sustainability of this industry.

The sophisticated lighting and sound tech-

niques used on today's mobile theatre stages carry the audience into a magical world and make it possible to present cinematic visuals in living form on stage. Yet this technological advancement has a negative side: sometimes the dazzle of technology devours the emotion of acting and the essence of the story. When excessive emphasis is placed on eye-catching scenery and technical tricks, there is a danger that the main element of drama—the spontaneous expression of human feeling—will fade. The real strength of mobile theatre lies hidden in its story and dialogue, which can touch the heart of the audience. In the future mobile theatre, technology must be used as a complement to the story so that it helps take the audience deeper into the play rather than remaining limited to external pomp. We want our folk arts and traditional elements to be presented in new forms through technology, but vigilance is needed so that mechanisation never suppresses human values. For playwrights and directors it is a big challenge to maintain a beautiful balance between modern technology and classical acting style and to give the audience a complete aesthetic experience.

The crisis of subject matter or script in mobile theatre has become one of the most impor-

tant topics of discussion today, and it will play a major role in determining the future direction of this art. In the past, literature-based, history-centred, and deeply socially relevant plays dominated the mobile stage, which not only entertained the audience but also provided food for thought. Yet in recent times, citing so-called audience taste and in pursuit of cheap popularity, some troupes have been seen giving importance to overly dramatic, illogical stories that merely stir emotions. Blind imitation of foreign-language films or serials has weakened our own sphere of original thought, and as a result there is a possibility that the respect of the new generation towards mobile theatre may de-

crease to some extent. If future mobile theatre wishes to preserve its existence with pride, it must once again connect itself with original plays that smell of the soil, reflect the real problems of society, and are composed on the basis of our own culture. There is abundant scope to write powerful plays dealing with various events happening in our society, superstition, corruption, and the complexities of human relationships. Writers must have the courage to choose subjects that can shake the audience and force them to self-examine. Here too we have a responsibility: to welcome good stories and strong subject matter and, by rejecting low-taste plays, indirectly compel producers to prepare plays of better quality.

Mobile theatre has been working as a powerful element in the propagation and expansion of the Assamese language. Though various dialects and spoken forms prevail in different parts of Assam, the mobile stage has always held up a model of standard Assamese before the audience, helping to establish linguistic unity. Yet in some plays nowadays, distorted use of language and application of obscene words in the name of character popularity or humour have become a matter of concern. As a result, there is a danger that the new generation, who learn or imitate language by watching mobile theatre plays, may receive wrong lessons. The responsibility of the future of mobile theatre is to protect this purity and dignity of language. Playwrights and actors-actresses should keep in mind while uttering every dialogue that they are not only entertainers; they are teachers of the language, one by one. Moreover, the mobile stage can also take the lead in uniting the diverse ethnic cultures, songs, melodies, and traditions of Assam and propagating a message of harmony. We hope that in the days to come mobile theatre will be transformed into a sacred pilgrimage site of language and culture where audiences will come not only to watch plays but also to search for their own linguistic and cultural roots. To fulfil this sacred duty, it is desirable that every theatre troupe rises above its commercial interest and gives priority to national interest.

In today's digital age, the rapid change taking place in audience mentality and the concept of entertainment is a big test for mobile theatre to keep pace with it. With the best entertainment of the world now available in people's palms, human patience has decreased and interest in sitting in one place for a long time to watch a play has somewhat diminished. Especially attracting the youth, who spend more time in the world of internet and social media, has become difficult. In this context, bringing some change in the presentation style of mobile theatre has become a demand of the time. Only by reducing the length of plays, making the story move faster, applying modern cinematic style in visualisation, and presenting through plays the problems related to the lives of the young generation can new audiences be attracted. Yet this does not mean that we will completely abandon our heritage. Rather, a new stream must be created by blending the old and the new. Parents in our society also have a responsibility to familiarise their children with the environment of mobile theatre. When a family sits together to watch a play, a family bond and an atmosphere of cultural exchange are created. The responsibility



of making mobile theatre relevant for the contemporary young generation instead of considering it only entertainment of the old generation will depend on the creativity of playwrights and directors.

For the healthy development and sustainability of mobile theatre, a positive and cooperative attitude from the government and administration is also necessary, although this industry is mainly run by the private sector. Instead of treating this vast industry merely as a source of tax collection, the government should recognise it as a glorious cultural heritage of Assam and adopt policies for its preservation and development. The deplorable condition of the roads used by theatre troupes for travel, uncertainty of power supply, and problems in getting permission to set up pandals in various places often put the troupes in trouble. If the government solves these basic problems, the journey of mobile theatre will become smoother. Moreover, the absence of any kind of social security or insurance for the thousands of workers and artists associated with this industry is a sad matter. If the government adopts welfare schemes for these artists and workers, they will be able to work with greater enthusiasm. On the other hand, a system of government honour or financial grant to troupes that produce good and quality plays will create a healthy competitive environment in this field. Of course, we must remain aware that under the name of government assistance the creative freedom of the troupes is not curtailed or political interference does not occur. Mobile theatre must always remain the beloved of the common people and,

instead of becoming a propaganda machine for someone, it should remain a reflection of the joys and sorrows of the masses.

Moreover, whatever discussion takes place about mobile theatre in print media and social media usually remains confined to glamour, remuneration of star artists, or controversial comments, which diverts the audience from the real beauty of the play. In-depth analytical writing on the literary value of a play, directorial skill, subtle aspects of acting, or social relevance is very rarely seen. A section of our intellectual society is also sometimes seen despising mobile theatre by calling it "light art," which is not acceptable at all. Mobile theatre is the only medium that can directly connect with thousands of rural audiences at once. Therefore, the duty of critics is to point out mistakes as well as to praise good work and help shape audience taste. When playwrights and producers know that the intellectual circle is keeping an eye on their work, they will become more conscious and responsible. The media should highlight the positive aspects of mobile theatre before society not only from a commercial point of view but with a sense of cultural responsibility, so that this art form can recover its lost prestige.

Mobile theatre was not created merely for entertainment; it is an expression of the fighting spirit of the Assamese nation. The indomitable courage with which mobile theatre troupes perform plays going village to village every year even amidst floods, disasters, and economic problems is nothing but another name for the irrepresible desire of our nation to survive. Yet to keep this courage alive, we as audience cannot manage merely by clapping hands and floating in momentary excitement. We have to judge what we are watching and what is being shown to us. Audience indifference often patronises low-quality plays. We must consciously demand good plays. When audiences start rejecting illogical and cheap plays, producers will be forced to turn towards quality plays. Awakening this mass consciousness is the duty of every conscious citizen of ours. The mobile theatre pandal is not merely a place of commercial transaction; it must become an open school where people receive life lessons through entertainment. So that future mobile theatre does not remain busy only in building mountains of money but also extends a hand in building society, we must keep a constantly vigilant eye.

Finally, one thing is certain: no matter how much technology advances or how modern society becomes, the appeal of live acting by people of flesh and blood never ends. The future of mobile theatre is not dark, but it is facing challenges, and the ability to turn these challenges into opportunities lies in our own hands. Our duty is to carefully nurture this priceless asset and help remove the obstacles that come in the way of its evolution. We must dream of such a future where mobile theatre is not confined within the boundaries of Assam but becomes capable of representing Assamese culture in the world arena. For this, the honesty of producers, the dedication of artists, the far-sightedness of playwrights, and the conscious cooperation of audiences will be needed. If we all together build a healthy cultural environment, mobile theatre will continue to glitter age after age as the mirror of Assamese life. Come, let us all resolve that we will not only keep our mobile theatre alive but hand it over to future generations in a stronger, more humane, and more beautiful form, so that they too can proudly say that mobile theatre is our heritage and our cultural identity.

"Why?" Riya asked. "There are places where guests... hear things," Arjun laughed. "Everyone here talks like a storyteller!" But Riya felt something tighten in her chest. The next morning, they set off toward the forest shrine—Hari Eco Park Trail. Brown pine needles cushioned their steps. The air smelled of resin and morning light filtered through the tall trunks in delicate lines. Halfway down the trail, Riya suddenly felt someone watching them. "Arjun," she whispered, "did you hear that?"

"Hear what?" asked Arjun. "Someone whistled," said Riya with surprise in his eye. "It's birds, Ri," Arjun said. Riya protested, "No... it didn't sound like a bird." "Let's go back," Riya whispered. He nodded. They walked quickly, hand in hand, not speaking until they reached the homestay. Nil Xagoror Xankhadhwani by Sarmishtha Pritam unfolds as a tender, radiant love story between two contrasting lives—Arohi, whose world is anchored to a wheelchair, and Ribhu, a young man defined by movement, freedom, and youthful energy.

What begins as a simple connection slowly grows into a profound companionship where love flows in unexpected directions. At the centre of the narrative lies a striking interplay of opposites. Arohi's physical dependence on Ribhu is beautifully counterbalanced by Ribhu's quiet but unmistakable emotional dependence on her.

This becomes the story's emotional heartbeat—a powerful juxtaposition. Arohi's physical dependence on Ribhu contrasts beautifully with Ribhu's deep emotional dependence on her.

This inversion becomes the soul of the novel. Arohi relies on Ribhu for mobility, for physical ease, and for navigating a world that often overlooks or underestimates people with disabilities. Yet, Ribhu turns to Arohi for something far more essential—emotional grounding, understanding, stability, and unconditional acceptance.

Where he offers strength to her body, she offers strength to his heart. This delicate exchange creates a rare balance, where neither is weak nor strong alone. They complete one another.

Pritam portrays Arohi with quiet resilience and inner clarity.

Despite her physical limitations, she becomes Ribhu's safe space, the one person who listens without judgement, loves without expectation, and offers a refuge from the chaos of his own emotional world.

Her silence is not frailty, it is steadiness. Her stillness is not helplessness, it is rootedness. And in her presence, Ribhu discovers a sense of belonging he never knew he needed.

This narrative rises above stereotypes that often dominate stories about disabled protagonists.

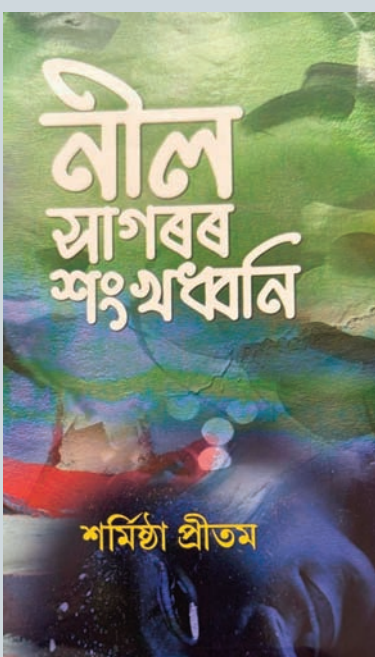
Instead of portraying Arohi as tragic or defeated, Pritam presents her as a woman fully capable of loving and being loved—deeply, passionately, and fearlessly.

The novel asserts an essential truth that physical disability does not diminish one's right to happiness, companionship, or a fulfilling life.

Arohi's journey challenges the conventional belief that a wheelchair-bound person must accept compromise or loneliness.

Here, she is cherished, valued, and chosen not out of pity, but out of genuine, transformative love.

In a society where narratives around disability often lean towards sorrow or sacrifice, Nil Xagoror Xankhadhwani stands apart. It celebrates a love that transcends physical constraints and societal expectations, leaving readers with a message of hope that emotional strength can reside in the most unexpected places, that love can balance two very different kinds of dependence, and that every individual regardless of physical ability, deserves the joy of companionship, a home of affection, and a life filled with dignity.

# Naxalism benefits nobody, only peace can pave way for development: Amit Shah

**RAIPUR, Dec 13:** Union Home Minister Amit Shah on Saturday said Naxalism does not benefit anyone - neither those who take up arms nor the security personnel, and asserted that only peace can pave the way for development.

Reiterating the Narendra Modi government's resolve to end Naxalism by March 31, 2026, he said the Centre has decided to transform Chhattisgarh's Bastar division, comprising seven districts, the most developed tribal region in the country in the next five years.

Addressing the closing ceremony of Bastar Olympic 2025 sport event at Indira Priyadarshini Stadium in Jagdalpur, the headquarters of state's Bastar district, Shah said Naxalism was like a "poisonous snake" that stalled the development in the region, and a "new chapter of development" will begin once the menace ends.

He appealed to those who are still associated with outlawed CPI (Maoists) to lay down arms and join the mainstream of society.

The government has decided to end "red terror" across the country before March 31, 2026, and the goal is now within reach, the Union minister said.

"I came here to participate in Bastar Olympic 2024, again in



2025, and I promise I will come in 2026 as well. When I arrive for the Bastar Olympic in 2026, Naxalism will have been wiped out from Chhattisgarh and the entire country," he said.

Shah said the seven districts of the Bastar division - Kanker, Kondagaon, Bastar, Sukma, Bijapur, Narayanpur and Dantewada - will be developed into the country's most advanced tribal districts by December 2030.

The BJP governments at the Centre and in the state are committed to

ensuring housing, electricity, toilets, tap water, LPG connections, five kg of free foodgrains and free medical treatment up to ₹ 5 lakh for every household in these districts, he said.

The Bastar division will be the most developed tribal region in the country, Shah said, adding that every village will be connected by roads, have electricity, banking facilities within a five-km radius and a strong network of primary and community health centres.

"Naxalism acted like a poisonous snake blocking development in this

region. With its end, a new chapter of development will begin," he said. "Naxalism will be eliminated by March 31, 2026, but I want to appeal to those still associated with it to lay down arms and join the mainstream for the welfare of their family and society.

"Naxalism benefits no one - not those who take up weapons, not tribals and not security personnel. Only peace can pave the way for development," he said, calling on misguided youth to take advantage of the rehabilitation policy and lead a dignified life.

Highlighting the changing face of Bastar, Shah said fear has been replaced by hope, schools bell now ring where gunfire once echoed, and roads, railways and highways are being built where development was once a distant dream.

Slogans of "Bharat Mata Ki Jai" have replaced slogans of 'Lal Salaam', marking a major transformation, he added.

"We are all committed to a developed Bastar. In this campaign that has been launched, the Chhattisgarh government and the Centre did not set the goal of merely engaging in encounters with armed cadres and killing them. More than 2,000 Naxalites have surrendered (in the last two years)," he said. (PTI)

# Congress govt in Himachal failed to utilise funds sent by Centre: Nadda

**SHIMLA, Dec 13:** BJP chief J P Nadda on Saturday alleged that the Congress government in Himachal Pradesh has failed to utilise the funds allocated by the Centre and therefore has no right to remain in power, accusing the state administration of functioning with a carefree mindset.

"Congress government in Himachal Pradesh is working with a mindset of 'Khao Piya Mauj karo, aage kisse dekha hai (indulge in merry making, who has seen the future)," he said and stressed that "double engine government is the only way to ensure development of the state".

Addressing an event here, Nadda accused the state government of corruption and misutilisation of funds given by the Centre under various heads, including building of houses, repair of roads and smart city.

Refuting the allegations of the Congress government that the Centre is not giving enough funds to the state, Nadda claimed, "₹ 3,789 crore were given for disaster relief, over ₹ 1,000 crore for Smart Cities besides funds for Vibrant Village development, medical colleges, AIIMS Bilaspur, a bulk drug park, four-lane highways and developed Baddi as a pharmaceutical hub in the state yet the Congress continues to spread falsehoods and mislead the innocent people of Himachal."

Targeting the Sukhu-led government for its incompetence, he claimed that the Centre has sent over ₹ 2,000 crore as special assistance and approved ₹ 1,442 crore under JICA funding, but the Congress government utilised only about 50 per cent of the funds in several schemes.

Taking a jibe at the Congress, Nadda said that Himachal's treasury is frequently shut, the entire administration runs on ad-hoc arrangements with the chief secretary and director general of police working on additional charge and there is no coordination between the chief minister and his ministers.

The Congress government has not brought even a single concrete project to the Centre, he said, and called upon BJP workers to take these facts and truths to every village and town, so that the "people of Himachal can free themselves from Congress misrule" and move decisively towards development and good governance.

"Victory of the NDA in recent Bihar Assembly polls has sent a clear message that people who want to run the country with the help of the intruders would not be accepted", said Nadda and asserted that the BJP would form government in West Bengal and Tamil Nadu.

Nadda alleged that "earlier the government used to come to power with the support of all but used to be limited to a particular caste, segment and religion, but 11 years back Prime Minister Narendra Modi changed the political scenario of the country by becoming the 'Pradhan Sevak' of the nation and moved from Rajpath to Kartavya Path." He recalled that during the previous state Assembly elections, he had warned the people against making the mistake of bringing the



Congress to power, asserting that Himachal Pradesh's development is possible only under a "double-engine government".

He said the "BJP government is a performance (report-card) based government, what it promised, it delivered and in contrast, the UPA politics revolved around casteism, appeasement and nepotism, while BJP politics is rooted in accountability and good governance."

Citing recent electoral outcomes, Nadda said in Haryana and Maharashtra, the Congress had already ordered sweets and prepared for celebrations, but people voted for a responsible government under the leadership of Modi.

Nadda said all political parties other than the BJP are immersed in the pursuit of power and suffer from ideological emptiness, while the BJP works with the motto of "Sabka Saath, Sabka Vikas, Sabka Vishwas".

The BJP president said that the Congress undermined Vande Mataram and the very spirit of India's freedom struggle, whereas the BJP practises politics aimed at taking the nation forward.

Highlighting India's transformation under Modi, Nadda said India has become the world's fourth-largest economy. Over 160 new airports have been built, and 'Made in India' now dominates mobile manufacturing and 'Ayushman Bharat' has benefited more than 62 crore people. Nadda also reiterated the achievements of the central government, including the abolition of 'Triple talaq', section 370 and the construction of the Ram temple at Ayodhya.

He said this gathering was not merely a political event, but an occasion to reaffirm the collective resolve for nation-building.

State BJP president Rajiv Bindal said that Congress was reduced to only six seats in Bihar, which is proof of its declining credibility and claimed that the same situation will prevail in the upcoming 2027 Himachal Pradesh assembly elections, where the Congress will not even reach double digits and will be reduced to only two seats.

Bindal said, "BJP workers and the people of the state have resolved to oust this anti-people Congress government and symbolically indicated that the bow and arrow have been handed over to Nadda and his aim is unerring." (PTI)

## LAND DEAL ROW

### Revenue officials should have refused faulty registrations: Pawar

**NAGPUR, Dec 13:** Maharashtra Deputy Chief Minister Ajit Pawar on Saturday said officials responsible for registering documents should have refused to process agreements that were not permissible under the law and clearly informed the parties concerned about such limitations.

His comments come against the backdrop of a notice issued by the deputy registrar to the firm of his son, Parth Pawar, seeking ₹ 21 crore in stamp duty and penalties in connection with a controversial land deal in Pune.

Hitting out at Pawar, Shiv Sena (UBT) leader Sanjay Raut said as the deputy CM wields so much of influence in the government, would any officer dare to question him.

"Does anyone have the courage in the revenue department (to defy) if Parth Pawar comes up with any proposal?" Raut asked.

Recently, the Bombay High Court raised sharp questions regarding the police probe into the land deal, suggesting authorities might be shielding Parth Pawar by failing to name him in the FIR.

Ajit Pawar sought to dispel perceptions stemming from a bill cleared by the legislative assembly on Friday, which empowers the revenue minister to hold hearings in contentious cases related to the Inspector General of Registration (IGR).

Pawar said those who registered such documents were at fault, and officials should have exercised due diligence at the time of registration.

"The officials who received the documents for registration of a deal should have refused to register it. They should have clearly informed the parties that such an agreement cannot be processed," the deputy chief minister told reporters in Nagpur.

When asked about allegations that the bill was moved to protect Parth, who holds a 99 per cent equity stake in Amadea Enterprises LLP, Pawar reiterated that the responsibility lay with the registering authorities.

"We are elected representatives in the House, and people have voted for us. We are free to take decisions or make amendments we find suitable," he said when asked about the intent behind the amendment.

Revenue Minister Chandrashekar Bavankule has said that under the earlier provision, complainants dissatisfied with decisions at the level of the IGR had to approach the high court. After the amendment, such complainants can now approach the revenue minister, who will be authorised to hold hearings in these matters.

He also stated that certain transactions have caused financial losses to the state exchequer, necessitating a more effective redressal mechanism.

The sale of 40 acres of land in Pune's upscale Mundhwa area for ₹ 300 crore to Amadea Enterprises LLP, in which Parth Pawar is a majority partner, came under scrutiny after it emerged that the plot belongs to the government and it could not be sold. The firm was also allegedly exempted from paying ₹ 21 crore in stamp duty.

A committee headed by the Joint Inspector General of Registration had indicted Digvijay Patil (Parth Pawar's business partner and cousin), Sheetal Tejwani (who held the power of attorney on behalf of the land sellers), and sub-registrar Ravindra Taru. They were named in an FIR registered at a police station in Pune.

Parth Pawar was not named as his name didn't appear on any document, a senior official had said. (PTI)

## Modi govt 'master' at renaming schemes: Congress

**NEW DELHI, Dec 13:** With the Cabinet approving a Bill to rename the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA), the Congress on Saturday said the Modi government is a "master" at renaming schemes and asked "what is wrong with the name Mahatma Gandhi" that it had to take this step. Reacting to the development, Congress general secretary in-charge communications Jairam Ramesh said the Modi government is a "master" at renaming schemes and laws.

"They renamed the Nirmal Bharat Abhiyan to Swachh Bharat Abhiyan, and the rural LPG distribution programme to Ujjwala. They are experts in re-packaging and branding," he told PTI.

"They hate Pandit Nehru but it seems they also hate Mahatma Gandhi. What's wrong with the name Mahatma Gandhi, why rename the Mahatma Gandhi National Rural Employment Guarantee Act to Pujya Babu Employment Guarantee Scheme?" Ramesh said.

The Union Cabinet on Friday approved a Bill to rename the MGNREGA and increase the number of work days, sources said. According to them, the scheme will now be renamed as 'Poojya Babu Grameen Rozgar Yojna', and the number of work days under it would be increased from 100 days at present to 125 days. Congress general secretary in-charge organisation K C Venugopal said the PM, who once called MGNREGA a "monument of failure", is now renaming it to claim credit for the revolutionary scheme.

"It's yet another way of erasing Mahatma Gandhi from our national psyche, especially from the villages, where, he said, India's soul resides," he alleged.

"This move is also nothing but a cosmetic change to paper over the deliberate neglect being meted out to this scheme," Venugopal said on X. MGNREGA workers have been demanding higher wages, but the Centre has been reducing allocated funds for the scheme year after year, he said.

"The arrears keep piling up, and it seems to be a carefully planned strategy to engineer a slow death for the scheme. In reality, this government has no intent of delivering welfare - and is merely putting up a pretence when it has run out of ideas," Venugopal alleged.

"But Mr Modi, rename it all you want, the people know it was Dr Manmohan Singh ji and Smt Sonia Gandhi ji who brought this transformative scheme to every village of India," he said.

The Mahatma Gandhi National Rural Employment Guarantee Scheme, better known as MGNREGA or NREGA, is a flagship scheme of the government aimed at enhancing livelihood security of households in the rural areas by providing at least 100 days of guaranteed wage employment in a financial year to every household whose adult members volunteer to do unskilled manual work. It was enacted in 2005. (PTI)

## Punjab rural polls: Mann slams Cong, SAD for 'high-handedness' charge

**CHANDIGARH, Dec 13:** Punjab Chief Minister Bhagwant Mann on Saturday slammed the Congress and Akali Dal over their "high-handedness" allegation against the AAP government in the zila parishad and panchayat samiti polls, saying they have accepted their defeat in the elections. Congress leader and former chief minister Charanjit Singh Channi alleged that the AAP government in the state had printed fake ballot papers for the December 14 Zila Parishad and Block Samiti elections.

Referring to Channi's statement, Mann took on the Congress and reminded it that the AAP supported the grand old party over the issue of "vote theft" whereas it was questioning the polling through ballot papers in Punjab.

Mann also highlighted the Congress' defeat in Bihar, Haryana, Madhya Pradesh and bypolls in Punjab and asserted that where they register victory in polls, then voting process is right and where they lose, they start "crying".

Addressing the media here, Mann lambasted Channi, saying he made an "irresponsible" statement and also spoke four colloquial Punjabi phrases including 'Hath na pahunche, thoo kori' (which means out of reach) to lash out at the Congress. These four idioms are suitable for Congress which lose because of their "misdeeds" and blame others, he said.

"Charanjit Singh Channi who was the chief minister for 111 days made an irresponsible statement that AAP printed 100 ballot papers each with AAP symbol printed on them at each polling booth. If you analyze it then it shows, actually they have accepted their defeat," said Mann.

"Both the Congress and Akali Dal have accepted their defeat in the rural polls but are ac-



curring the AAP government of high-handedness against opposition candidates," the chief minister claimed. Giving details of the zila parishad and panchayat samiti polls, Mann said out of 2,833 zones of block samitis, 340 AAP candidates, three Congress nominees and eight Independents have been elected unopposed.

"If the Congress and independent candidates were elected unopposed, then wasn't there any high-handedness in these seats?" Mann asked.

He said AAP's 2,771 candidates, Congress' 2,433, SAD's 1,814, BJP's 1,127, BSP's 195, SAD (Amritsar)'s three and 686 others are fighting the panchayat samiti polls. "How were the nomination papers of opposition candidates found to be correct?" he asked rhetorically.

Opposition parties had earlier targeted the ruling AAP, accusing it of misusing official machinery in preventing their candidates from filing their nomination papers and rejecting their candidature.

He said there are a total of 347 Zila Parishad zones. For these zones, Congress is fighting 331

## Avg age of school-going children picking up drugs, smoking habit in 10 Indian cities around 13 yrs: Study

**NEW DELHI, Dec 13:** School-going children are picking up drug and smoking habits and engaging in consumption of alcohol, with the average age of introduction to such harmful substances found to be around 13 years, suggesting a need for earlier interventions as early as primary school, a multi-city survey by AIIMS-Delhi said.

The findings also showed substance use increased in higher grades, with grade XI/XII students two times more likely to report use of substances when compared with grade VIII students. This emphasised the importance of continued prevention and intervention through middle and high school.

The study led by Dr Anju Dhawan of AIIMS's National Drug Dependence Treatment Centre, published in the National Medical Journal of India this month, looks at adolescent substance use across diverse regions.

The survey included 5,920 students from classes 8, 9, 11 and 12 in urban government, private and rural schools across 10 cities -- Bengaluru, Chandigarh, Delhi, Dibrugarh, Hyderabad, Imphal, Jammu, Lucknow, Mumbai, and Ranchi. The data were collected between May 2018 and June 2019.



The average age of initiation for any substance was 12.9 (2.8) years. It was lowest for inhalants (11.3 years) followed by heroin (12.3 years) and opioid pharmaceuticals (without prescription: 12.5 years).

Overall, 15.1 per cent of participants reported lifetime use, 10.3 per cent reported past year use, and 7.2 per cent reported use in the past month of any substance, the study found.

The most common substances used in the past year, after tobacco (4 per cent) and alcohol (3.8 per cent), were opioids (2.8 per cent), followed by cannabis (2 per cent) and inhalants (1.9 per cent). Use of non-prescribed pharmaceutical opioids was most common

among opioid users (90.2 per cent).

On being asked, 'Do you think this substance is easily available for a person of your age' separately for each substance category, nearly half the students (46.3 per cent) endorsed that tobacco products and more than one-third of the students (36.5 per cent) agreed that a person of their age can easily procure alcohol products.

Similarly, for Bhang (21.9 per cent), ganja/charas (16.1 per cent), inhalants (15.2 per cent), sedatives (13.7 per cent), opium and heroin (10 per cent each), the students endorsed that these can be easily procured.

About 95 per cent of the children, irrespective of their grade, agreed with the statement that 'drug use is harmful'.

The rates of substance use (any) among boys were significantly higher than those of girls for substance use (ever), use in the past year and use in the past 30 days. Compared to grade VIII students, grade IX students were more likely, and grade XI/XII students were twice as likely to have used any substance (ever).

The likelihood of past-year use of any substance

was also higher for grade IX students and for grade XI/XII students as compared to grade VIII students.

About 40 per cent of students mentioned that they had a family member who used tobacco or alcohol each. The use of cannabis (any product) and opioid (any product) by a family member was reported by 8.2 per cent and 3.9 per cent of students, respectively, while the use of other substances, such as inhalants/sedatives by family was 2-3 per cent, the study found.

A relatively smaller percentage of students reported use of tobacco or alcohol among peers as compared to among family members, while a higher percentage reported inhalants, sedatives, cannabis or opioid use among peers.

Children using substances (past year) compared to non-users reported significantly higher any substance use by their family members and peers.

There were 25.7 per cent students who replied 'yes' to the question 'conflicts/fights often occur in your family'. Most students also replied affirmatively to 'family members are aware of how their time is being spent' and 'family members are aware of with whom they spend their time'. (PTI)

## Suspected spy apprehended from trade fair in Aalo

A total of 5,037 BJP candidates for gram panchayat member seats have also been declared elected without contest.

Four BJP candidates were also elected unopposed for the Itanagar Municipal Corporation (IMC).

A total of 440 candidates will contest 186 Zilla Parishad seats, along with 39 candidates for 16 IMC wards and 21 candidates for eight PMC wards.

The SEC said that a total of 13 gram panchayat constituencies received no nominations, while all nominations in 14 gram panchayat constituencies were rejected during scrutiny. Polling in the Dumba Singpho gram panchayat constituency has been countermanded due to the death of a validly nominated candidate.

A total of 8,31,648 voters -- including 7,59,210 for rural polls and 72,438 for civic polls are eligible to cast their ballots across 2,171 polling stations for panchayat elections, 67 for IMC and 12 for PMC polling stations.

Electronic Voting Machines (EVMs) will be used for municipal polls, while ballot boxes will be deployed for panchayat elections. The counting of votes will be held on December 20. (With inputs from PTI)

## 3<sup>rd</sup> T20I: A three-match 'audition' starts for Gill to find his game back



**DHARAMSALA, Dec 13:** The countdown to save his place in the playing XI begins for a beleaguered Shubman Gill, who is likely to get three matches against South Africa to prove his worth before the Indian team management switches to a 'Plan B' ahead of the T20 World Cup, starting in six weeks.

As India gear up to play the third T20I against the Proteas on Sunday in sub-10-degree temperatures in the lap of the ice-clad Dhuladhara range, things are suddenly heating up in the Indian dressing room, with the prolonged poor form of skipper Suryakumar Yadav coming under the scanner.

Worse, his deputy Shubman Gill, who was pushed into the XI at the expense of a settled Sanju Samson, is not inspiring much confidence.

The South African pace attack featuring Anrich Nortje, Marco Jansen, Lungi Ngidi, Othniel Baartman and Lutho Sipamla — has shown how to bowl on Indian tracks, and the HPCA Stadium strip, offering extra bounce and some movement off the surface, will certainly keep them interested.

Among all T20 sides, South Africa, in terms of personnel, appears to have the requisite balance to win the trophy in the Indian subcontinent this time. Quinton de Kock's return, along with the likes of Aiden Markram, Dewald Brevis, Donovan Ferreira, David Miller and all-rounder Jansen, gives their batting an intimidating look.

With only eight games, starting from the third T20I, left before the start of the T20 World Cup title defence, India's under-fire head coach Gautam Gambhir won't be able to afford, two out-of-form top-order batters in the starting line-up.

Being the skipper of the side, Surya will certainly have immunity going into the T20 World Cup despite being completely out of form for the past one year but same can't be said about Gill, who wasn't the original choice as an opener.

Gill's entry into the T20 set-up was a classic case of trying to fix something that ain't broken and things haven't looked good so far.

In this backdrop, Gill would need to bat out of his skin to prove that Ajit Agarkar-led committee wasn't wrong in throwing Samson under the bus for one bad series against England.

The stylish Indian Test and ODI skipper will have to find his

T20 game and at least score in two of the three matches if he doesn't want Samson to get his rightful place back or for that matter, find Yashasvi Jaiswal, with a fabulous T20I strike-rate of 165, enter the fray during New Zealand series.

**Lack of clarity**  
While head coach Gambhir is too proud a person to admit but sending Axar Patel as a one drop batter during the sub-T20I was a "tactical brain fade" from the team's think-tank.

The kind misstep that was taken with Axar's promotion is unlikely to be repeated in the third game where skipper is expected to go back to No.3 where he has got a lot of success in his first few years at the international level.

Similarly, Shivam Dube being sent at number eight due to the shuffling of batting order was another poor call which would need course correction in the next game.

Is there a place for Kuldeep Yadav?

Kuldeep Yadav is one bowler who has consistently troubled the Proteas batter but in an Indian team where batting till No. 8 is non-negotiable, the left-arm wrist spinner often finds himself getting the rough end of the stick.

At Dharamsala too, he might have to sit out as Kuldeep and Varun Chakravarthy, two non-batters can't be clubbed in the same T20 playing eleven as that would lead to compromise in batting depth.

While Arshdeep hasn't had a good series so far, it will be interesting to find if team management can find a place for Kuldeep in the playing eleven with Hardik Pandya sharing the new ball with Jasprit Bumrah.

The five-match series is currently tied 1-1.

## Fans go on rampage as Messi's Kolkata tour turns 'Messy'

**KOLKATA, Dec 13:** Lionel Messi's much-hyped visit to the Salt Lake Stadium here on Saturday lasted 22 minutes, just enough to underline everything that is wrong in Indian football and the state administration's mismanagement.

What was billed as a historic celebration of the game's greatest icon degenerated into a spectacular breakdown of planning, policing and priorities, as angry fans ran riot at the venue after failing to get even a glimpse of their favourite superstar from Argentina.

The chaos was almost ironic. Messi's second visit to Kolkata -- part of a four-city India tour with Hyderabad, Mumbai and New Delhi to follow -- came against the backdrop of the Indian football team's alarming slide to 142nd in the latest FIFA rankings, its lowest since October 2016.

Arguably the greatest player of all time, Messi arrived just as the sport in the country hit rock bottom, with the domestic calendar in limbo and governance in disarray, and the events at the Salt Lake Stadium summed it up better than any ranking ever could.

What was meant to be a red-letter day for the City of Joy turned into a nightmare by noon.

About 50,000 spectators, many of whom had paid ₹ 4,000 to ₹ 12,000 -- and in some cases up to ₹ 20,000 in the black market -- watched helplessly as a swarm of politicians, VVIPs, security personnel, and assorted hangers more interested in selfies than crowd control surrounded Messi.

The build-up had been electrifying with fans spending sleepless nights to catch his midnight arrival and then making a beeline to the stadium from early morning. The gates were opened at 8am.

Over 50,000 fans packed the stadium, chanting 'Messi, Messi' as former foot-



ballers from Mohun Bagan and Diamond Harbour FC -- all sporting No.10 jerseys -- played a 35-minute exhibition match.

At 11.30am, the GOAT arrived dressed in black, and stepped out of a white Audi to a thunderous applause, and the stadium literally shook. Messi was flanked by longtime Barcelona teammate Luis Suarez and Argentina World Cup winner Rodrigo De Paul.

Then it all began to unravel. Within minutes, Messi was surrounded by a bevy of politicians, police officers, VVIPs and their aides, forming a human blockade that ensured the paying public saw everything except Messi.

Messi looked confused and bemused, gamely signing autographs for former players while attempting a slow circuit of the ground. The situation only worsened.

Promoter Satadru Dutta, his voice choking, repeatedly pleaded over the public address system: "Please leave him alone.

Please vacate the ground."

The appeals fell on deaf ears as dignitaries continued to pile on, and Messi was virtually camouflaged amid a swarm of bodyguards and officials.

Ironically, the easiest way to locate him was by first spotting state sports minister Arup Biswas -- clad in a white kurta-pyjama and Jawahar coat -- whose attire made him visible from afar.

As word spread that the 'Prince of Kolkata' Sourav Ganguly has arrived, tensions escalated further.

Bollywood superstar Shah Rukh Khan, waiting outside near the Vivekananda statue, eventually abandoned his plans altogether.

Chief minister Mamata Banerjee who had already started from her residence for the venue had to make a U-turn and change her plans.

Messi was finally escorted out well before his scheduled one-hour stay, leaving the sta-

dium after spending just 22 minutes, and all hell broke loose thereafter.

Angry fans started with hurling bottles -- banned items in an otherwise sporting venue. It was baffling how they were allowed to enter with these objects, which also included food packets. Chairs were then ripped out and thrown.

Fibreglass seats lay smashed across the pitch and the synthetic track.

Two canopies erected for Messi and the chief minister's enclosure were torn apart, with attempts even made to set parts of them on fire before police intervened.

Gates were battered, the players' tunnel roof was hammered, and posters torn down. Some spectators fled clutching broken chairs as trophies of disorder, resembling the political scenes of Bangladesh some months back. The mayhem continued for nearly 90 minutes.

To their credit, the police showed remarkable restraint, repeatedly pleading with the crowd and resorting only to mild charges in what could easily have spiralled into a stampede.

"This is a complete failure," said Ajay Saha, who came with his 12-year-old son. "Cold drinks cost ₹ 150-200, water was ₹ 200, and we didn't even see Messi. We spent a month's salary to watch football, not politicians taking selfies."

The scenes inevitably evoked Kolkata's darker sporting memories -- the 1996 cricket World Cup semifinal at Eden Gardens, abandoned amid fires and flying bottles, and the 1980 Kolkata Derby stampede, which claimed 16 lives.

Messi came and left. The GOAT's visit was meant to inspire. Instead, it served as a mirror reflecting a game, and an administration, in profound disarray. (PTI)

## Odisha Masters: Hooda, Isharani reach women's final



**CUTTACK, Dec 13:** Top seed Unnati Hooda and compatriot Isharani Baruah set up a women's singles final clash at the Odisha Masters Super 100 after registering contrasting semifinal victories here on Saturday.

The 18-year-old Hooda, a winner of the 2022 edition and 2023 Abu Dhabi Masters, was stretched by former junior world No. 1 Tasnim Mir before prevailing 18-21, 21-16, 21-16 in a hard-fought encounter that lasted an hour.

After conceding the opening game, Hooda raised her intensity, controlled the rallies better and showed superior temperament in the closing stages of the next two games to book her place in the final.

In the other semifinal, Assam's Isharani produced a strong comeback to defeat Tanvi Hemanth 18-21, 21-7, 21-7.

In the men's singles, second seed Kiran George and Rounak Chouhan, who were part of India's historic World Junior Championships medal-winning squad, will clash in the semifinal to decide the finalist.

In the mixed doubles semifinals, India's S. Kanapuram and R. Uthayasooriyar bowed out after going down 16-21, 19-21 to fifth seeds Dejan Ferdinansyah and B. Wardana of Indonesia.

The Indonesian pair kept their composure in both games, handling pressure situations better to seal a straight-game victory and progress to the final. (PTI)

## Lindsey Vonn places 2<sup>nd</sup> in a World Cup downhill a day after becoming oldest winner at age 41

**ST MORITZ (SWITZERLAND), Dec 13:** Lindsey Vonn nearly did it again. The 41-year-old American finished second in a World Cup downhill on Saturday, a day after becoming the oldest winner in the circuit's history.

After winning the season's opening downhill by nearly a full second on Friday, Vonn was beaten by only one racer this time: Emma Aicher of Germany was 0.24 seconds faster.

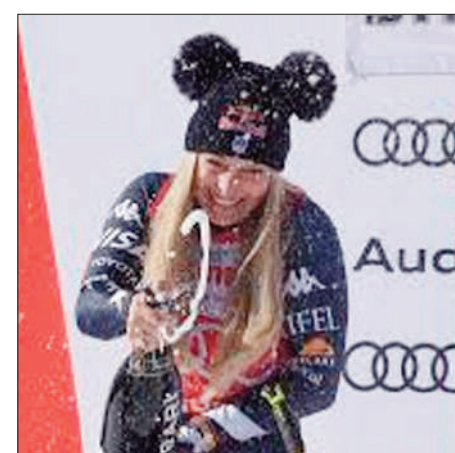
Vonn attributed a mistake landing a jump midway down her run for the gap, when she nearly lost her balance for an instant and leaned heavily on her left leg to raise herself back up.

"I'm a little bit tired from yesterday, there was a lot of emotion," Vonn told Swiss broadcaster RTS. "I thought I skied pretty well on top then I was just out of balance. I fell on my hip. Yeah, didn't ski the bottom the way I wanted to."

Sofia Goggia, the 2018 Olympic champion from Italy, finished third, 0.29 behind, and Breezy Johnson, the American world champion, was fourth, 0.40 back.

Vonn, who is preparing for the Milan Cortina Olympics, went into first position with her run down the sun-drenched Corviglia course. But the 22-year-old Aicher came down next and quickly pushed Vonn out of the leader's seat.

Vonn returned to skiing last season after nearly six years of retirement -- following a



partial replacement surgery on her right knee, which included inserting two pieces of titanium. Vonn's results are shaping up to make her a top medal contender at the Olympics -- and able to compete with skiers half her age. Women's Alpine skiing at the Feb. 6-22 Winter Games will be contested at Cortina d'Ampezzo, where Vonn holds the record of 12 World Cup wins.

Vonn registered the top speed of 102.45 kph (64 mph) on the top section; increased her speed to 110.02 kph (68 mph) on the bottom and flew

a massive 41 meters (yards) off a jump toward the end of her run

Vonn also clocked the fastest time in the final sector -- a sign of her increased fitness this season. She said earlier this week that she added 12 pounds (5.5 kilograms) of muscle during dry-land training over the summer and followed a rigid diet.

When Vonn crossed the finish line and saw that she was ahead of Goggia, Vonn celebrated thinking that she had won. She let out a scream, punched the air with one of her poles and then raised her arms over her head, shaking her head in apparent disbelief.

It was Vonn's 140th podium result and it came in a record-breaking 410th World Cup race. Former Austrian skier Renate Götschl held the previous record with 409 races.

It was Aicher's third World Cup victory and second in downhill. She's a rare all-around skier capable of being competitive in all four disciplines -- like Vonn at the height of her career. Aicher also finished on the podium in a slalom this season, placing third in Levi, Finland.

Vonn could aim for another victory in a super-G in St. Moritz on Sunday -- in a race that fellow American standout Mikaela Shiffrin is also expected to compete in.

Shiffrin has not been racing downhill. (AP)

"The All India Football Federation is deeply concerned by the events that transpired at the Vivekananda Yuba Bharati Krangan, where thousands of fans gathered to witness world football stars Lionel Messi, Luis Suarez, and Rodrigo de Paul.

"This was a private event organised by a PR agency. The AIFF was not involved in the organisation, planning, or execution of this event in any capacity," the AIFF said in a statement. Within minutes of his arrival at the venue, Messi was surrounded by a bevy of politicians, police officers, VVIPs and their aides, forming a human blockade that ensured the paying public saw everything except Messi.

The AIFF said it was not involved in the organisation, planning, or execution of the event in any capacity.

"This was a private event organised by a PR agency. Furthermore, the details of the event were neither communicated to the AIFF, nor was any clearance sought from the federation," the AIFF said.

"We urge all attendees to extend their full cooperation with the relevant authorities and to maintain order. The safety and security of all individuals involved must remain the paramount priority," the apex body said in the statement. (PTI)

## For Noah Lyles, all-or-nothing mentality is way forward

**PUNE, Dec 13:** For Olympics 100m gold medallist and multiple-time world champion American sprinter Noah Lyles, 2026 season and beyond will be about having an "all-or-nothing" mentality.

Lyles, who aims to beat the legendary Usain Bolt's records in 100m and 200m events, says his new approach would demand his body to produce something never happened before as he looks to make the most of the home Olympics -- LA28 Games.

"I would say I'm starting 2026 with a jump-off-the-cliff mentality. If I had to give a little more detail, it's all or nothing. There's no in-between," Lyles, a brand ambassador for the Bajaj Pune Marathon, told PTI in an exclusive interview here on Saturday.

"There's no one foot in, one foot out. It's all or nothing. That's the type of mentality that I'm coming into 2026 with."

Lyles said the new approach will push him to reach those limits in training and beyond which he never has been through.

"I'm still the same person. Of course, I'm going to keep growing and keep trying to be better," he said.

"But I'm going to have such an all-or-nothing mentality in my training that it's going to demand something from my body, that it has not had produced before."

The 28-year-old flamboyant sprinter said he has not yet confirmed his participation in the inaugural edition of the Ultimate Championship, a biennial track and field event to be held by World Athletics next September in Budapest.

"No, I haven't confirmed my participation as of now.



That's kind of just where it's standing until we have a better understanding and a better working concept with World Athletics," he said.

"I'm an all-or-nothing person, so if I'm showing up to an event, you're getting my all. I don't want to show up anywhere that I can't give my everything and my all and my showmanship and my excitement to."

"If you're limiting me in doing that, then I can't give myself nor the fans what I believe would be the best performance," he added.

Lyles, who became the first sprinter since Bolt to record a treble in 2023 World Championships (100m, 200m and 4x100m relay), said Los Angeles is a "perfect

place for great things to happen" when asked if breaking the Jamaican legend's record is on his list of goals.

"I would say that LA is a perfect place for great races to happen and I'm very blessed to be able to have the Olympics show up in my lifetime on home soil," he said.

"I'm not going to let that opportunity go by without taking advantage of it and yes, the all-or-nothing mentality is something that I plan to continuously push forward," Lyles added.

"Can we give the greatest events to be seen?" Lyles said his decision in finalising participation in Ultimate Championships will also be swayed with what he can offer as an athlete.

"I constantly think about, 'can we give everybody the greatest events they've ever seen? How do we constantly recreate that or create it in a new light? If it's something that's never been done before, let's do that,'" he said.

"If it's something that has (been done before), let's figure out how to go even further this time. That's my thought process when it comes to major champs, how to structure the season, and what I want to do," he added.

Lyles said he will look to remain flexible in terms of his preparation and participation in events but would want to follow the routines he did ahead of the Paris 2024 Olympics, where he won a gold in 100m and a bronze in 200m.

"... because everything is subject to change. We're in 2025, about to go into 2026, so that would technically be almost two years away (from LA28)," he said.
