Assembly session: Guv outlines new Assam govt's vision for next 5 years Oppn stages walkout raising slogans, showing placards

GUWAHATI, May 22: Governor Lakshman Prasad Acharya on Friday outlined the new government's vision for the state for the next five years in his first address in the 16th state Assembly amidst an opposition walkout, alleging failure of the dispensation to address core issues of the people.

Barely five minutes into the governor's speech on the second day of the session, Congress and Rajior Dal MLAs trooped into the Well of the House.

They demanded that the government address core issues like inflation rather than dwelling on achievements.

The Congress legislators also displayed placards and raised slogans before staging a walkout.

The two Rajior Dal MLAs, led by their leader Akhilesh Gogoi, remained in the House initially and continued to speak even as the governor delivered his speech.



After about 30 minutes, the two Rajior Dal MLAs also walked out, after submitting a paper with the points raised by them.

The governor, in his speech, said the return of the BJP-led NDA government for a third successive time was a testimony to people's support for the vision of the ruling dispensation, which secured an un-

precedented 102 out of 126 seats.

"This mandate reflects the people's endorsement of peace, economic stability and inclusive development pursued over the past ten years. The achievements in restoring peace have been substantial and historic," he said.

Mentioning of peace accords and settlement agreements signed

with different insurgent outfits over the last few years, he appealed to the ULFA(I), the only major group outside the peace process, to join the mainstream.

He appealed to the people to exercise restraint in discretionary spending and avoidable expenditure in line with the Prime Minister's appeal for austerity, and added, "Collective responsibility and prudent economic conduct will strengthen the nation during the challenging period."

Acharya welcomed the government's decision to introduce the proposed law regarding the Uniform Civil Code (UCC) during the current session, maintaining that it will strengthen social harmony, justice, gender equality and a modern progressive society.

He said the UCC will be enacted and implemented in a manner that "protects the traditional rights, customary (CONTD. ON PAGE 2)

Assam to become power surplus state soon: CM

GUWAHATI, May 22: Chief Minister Himanta Biswa Sarma on Friday said the state is steadily progressing towards becoming a power surplus state through large-scale investments in energy infrastructure and electricity generation capacity.

In a post on X, the Chief Minister said Assam has prepared an energy infrastructure vision worth ₹14,202 crore by 2035 and is currently implementing four major projects valued at ₹6,235 crore across the state.

"Assam is steadily moving towards becoming a power surplus state. With a ₹14,202 cr energy vision and ₹6,235 cr worth of projects already underway, we are strengthening our power infrastructure to support growth and ensure reliable supply for our people," Sarma stated.

According to officials, the state



government has been focusing on expanding electricity generation capacity, upgrading transmission networks and modernising distribution systems to meet rising power demand in both urban and rural areas.

The government is also placing emphasis on renewable energy ini-

tatives, including solar power projects, as part of its long-term strategy for energy security and sustainability.

Hydropower and thermal power projects are also being upgraded to improve efficiency and increase overall supply capacity. Officials said the (CONTD. ON PAGE 2)

EC announces Rajya Sabha polls for 26 seats on June 18

NEW DELHI, May 22: The NDA is likely to lose one Rajya Sabha seat in the biennial elections for 26 seats in 12 states across the country, while the Congress-led opposition is set to gain three.

The Election Commission on Friday announced elections for 26 Rajya Sabha seats on June 18 following the retirement of incumbents, including former prime minister HD Deve Gowda, Congress president Mallikarjun Kharge and party leader Digvijaya Singh, besides two Union ministers Ravneet Singh and George Kurian.

In a statement, the EC said the elections for the Rajya Sabha seats will be held in 10 states where 24 incumbents are retiring on different dates beginning June 21 to July 19. Of the total 26 seats where elections are being held, the NDA currently has 18 and the Congress four while one seat is with the JMM and three are with the YSRCP.

The NDA is likely to get 17 seats in these elections, while the Congress will get five, the JMM two and the TVK one. The NDA cur-

rently has 149 MPs in the upper house while the opposition has 78 and non-aligned regional parties have 17 MPs in the 244-member house.

The Rajya Sabha elections will be held in four seats each in Andhra Pradesh, Gujarat and Karnataka, three seats each in Madhya Pradesh and Rajasthan, two seats in Jharkhand and one seat each in Manipur, Meghalaya, Arunachal Pradesh and Mizoram. Besides, one seat each in Maharashtra and Tamil Nadu will also go to the polls on June 18.

The last date for filing of nominations is June 8, according to the EC.

In a separate notification, the EC also announced by-elections to fill the vacancies created by the NCP's Sunetra Pawar in Maharashtra and the AIADMK's C Ve Shanmugam in Tamil Nadu following their resignations after they were elected to the state assemblies.

While the NDA is set to bag Pawar's seat, going by its strength in the state assembly, the TVK is likely to (CONTD. ON PAGE 2)

India to create 'smart border' along Pak, B'Desh to stop infiltration, attempts of demographic change: Shah

NEW DELHI, May 22: Union Home Minister Amit Shah on Friday said the government will launch a tech-enabled "smart border" project by the next year to make the 6,000-km fronts with Pakistan and Bangladesh impenetrable and ensure that the "conspiracy" to change the demography of the country is defeated.

Delivering the annual Rustamji Memorial lecture hosted by the Border Security Force (BSF) here, the minister also reiterated that the government will find each and every infiltrator and send them out of India. K F Rustamji was the founding father and the first director general of the BSF, the world's largest border guarding force with about 2.70 lakh personnel tasked to guard Indian borders with Pakistan on the west and Bangladesh on the east. It was raised in 1965.

"The government of India has decided that not only will we stop infiltration but we will find each and every infiltrator and send them out of the country," Shah said.



He added his government will not allow "artificial change in our demography being attempted from the other side."

"I want to assure BSF troops that we will launch the smart border project within the 60th year of its raising and we will make the Bangladesh and Pakistan borders impenetrable through major technical assistance," Shah said.

The "smart border" will use technology, drones, radars and smart cameras to help create an impenetrable border, he told the gathering.

Calling these two borders "vulnerable" and a "cause of concern" for the country from the security point of view, Shah said these fronts

(about 1,289 km with Pakistan and 4,096 km with Bangladesh) cannot be guarded with "traditional" methods.

The concept of border security should not be seen in isolation but as a "territorial responsibility" involving all agencies and state governments, he said.

He said these borders currently face threats like illegal infiltration, smuggling of drugs, weapons and arms through drones apart from cattle, fake Indian currency notes and organised crime.

"It is most important to identify future dangers, and it is our responsibility to stop the artificial demographic change being attempted from the other side (of the border) through infiltration, and, for this, we have to remain alert and vigilant," he told the officers and jawans in attendance.

Shah said the Modi government brought a "radical" change to the security policy and border protection perspective since it took charge in 2014. (CONTD. ON PAGE 2)

Govt aims to make June 21 NEET-UG re-test 100 pc error-free: Pradhan

NEW DELHI, May 22: Union Education Minister Dharmendra Pradhan on Friday said the government had to take "tough decisions" after irregularities were detected in the conduct of the NEET-UG, asserting that authorities did not want even a single deserving student to lose their rightful seat because of the "examination mafia".

He also asserted that the government is committed to ensuring that the re-test scheduled to be held on June 21 remains "100 per cent error-free".

Addressing the Jagran Bharat Education Conclave 2026, Pradhan said around 22 lakh students have suffered "mental anguish" due to the controversy surrounding the medical-entrance exam and the government is committed to fixing the system.

"Twenty-two lakh children have gone through immense mental anguish. Understanding that anguish and taking responsibility, I am saying this today, we had to take some tough decisions," he said.

The National Eligibility-cum-Entrance Test (Undergraduate) for admissions in medical courses held on May 3 was cancelled by the National Testing Agency (NTA) recently amid allegations of paper leak. The matter is being probed by the Central Bureau of Investigation (CBI) and a re-test is scheduled to be held on June 21.

Pradhan said the government decided to cancel the examination after finding that "some assessments had been compromised".

"We did not want even a single student to be deprived of their rightful seat because of the conspiracy of those involved in irregularities in the education system and the examination mafia," he said.

The minister acknowledged the criticism over the handling of the issue but said the government is prepared to face the challenge.

"We are facing criticism and challenges, and I accept that. But it is our responsibility to set the system right. It is not our duty to shut our (CONTD. ON PAGE 2)

Decided to bring back to India some persons deported to Bangladesh: Centre to SC

NEW DELHI, May 22: The Centre on Friday told the Supreme Court that it has decided to bring back some people, who were earlier deported to Bangladesh, to India and would then verify their claim of Indian citizenship.

Solicitor General Tushar Mehta, appearing for the Centre, told a bench headed by Chief Justice Surya Kant that keeping in view the peculiar facts and circumstances of the case and by not treating it as a precedent to be followed in other matters, the government has decided to bring them back.

"The government would bring them back and thereafter examine their status. Depending upon the outcome, we will take steps accordingly," Mehta told the bench, which also comprised Justices Joymalya



Bagchi and Vipul M Pancholi.

The top law officer said that it may take 8-10 days to bring these persons back to India.

The bench posted the matter for hearing in July.

The top court was hearing a plea of the Centre challenging a September 26, 2025 order of the Calcutta High Court by which it had set aside the central government's decision to deport (CONTD. ON PAGE 2)

217 Indians joined Russian armed forces, 49 lost their lives in conflict: Centre to SC

NEW DELHI, May 22: The Centre on Friday told the Supreme Court that 217 Indian nationals had reportedly joined the Russian armed forces amid the ongoing Russia-Ukraine war, and 49 have lost their lives in the conflict.

In a status report filed before the apex court, the Centre said pursuant to sustained diplomatic engagement undertaken by the government of India with the Russian Federation, 139 Indian nationals have already been released from the contracts they signed to join the Russian Army.

"Further, 49 Indian nationals are reported to have lost their lives in the conflict. Additionally, 6 Indian nationals have been confirmed missing by the Russian side, whereas the status of 23 individuals remains unknown and continues to be under active follow-up by the Embassy of India in Moscow with the Russian authorities," the report said.

The status report was filed in a plea before the top court seeking directions to the Centre to take steps to facilitate the safe repatriation of 26 Indian citizens who have allegedly been detained in Russia and

forced to fight in the ongoing war with Ukraine.

"It is submitted that as per the latest information available with the Ministry of External Affairs, approximately 217 Indian nationals had reportedly joined the Russian armed forces," the status report said.

On Friday, the plea came up for hearing before a bench of Chief Justice Surya Kant and justices Joymalya Bagchi and Vipul M Pancholi.

Additional Solicitor General Aishwarya Bhati, appearing for the Centre, referred to the status report.

The report said in order to facilitate tracing of missing individuals and identification of mortal remains, DNA reports of the immediate family members of 21 individuals have been collected and transmitted to the Russian authorities with active facilitation by the government of India.

It said all such cases were being dealt with on utmost priority and were under continuous follow-up with the Russian authorities for resolution, while simultaneously keeping affected family informed about the developments. The report (CONTD. ON PAGE 2)

Union Health Ministry directs states, UTs to bolster surveillance amid Ebola outbreak

NEW DELHI, May 22: The Union Health Ministry has asked all states and Union territories to step up surveillance, hospital preparedness and screening of international travellers following the WHO's declaration of the Ebola outbreak in the Democratic Republic of Congo and Uganda as a public health emergency of international concern (PHEIC).

In a letter to chief secretaries and administrators of UTs on May 21, Union Health Secretary Punya Salila Srivastava said countries bordering DRC and Uganda, including South Sudan, have been assessed to be at high risk of disease transmission.

"While the current assessment indicates that the risk to countries outside the affected African region remains low, the substantial quantum of international trade and travel underscores the importance of maintaining adequate preparedness and response capacities at all levels of the health system," the letter said.

The ministry directed states to strengthen surveillance under the Integrated Disease Surveillance Programme (IDSP) for unusual clusters of cases showing symptoms suggestive of Ebola disease, particularly among people with recent travel history to affected areas.

The symptoms listed in the advisory include fever, weakness, muscle pain, headache, sore throat, vomiting, diarrhoea, stomach pain, rash and red eyes.

States have also been asked to identify designated isolation facilities and dedicated ambulances, ensure availability of trained healthcare personnel, personal protective equipment (PPE), logistics, laboratory support and critical care capacities.

The ministry said ICMR's National Institute of Virology (NIV), Pune, is fully equipped to test samples from suspected Ebola cases detected either at points of entry or in the community, and additional ICMR network laboratories would be strengthened depending on the evolving situation.

The advisory stressed coordination among airport and port health authorities, state and district surveillance units and other agencies for prompt information sharing and follow-up of travellers requiring public health monitoring.

According to the attached Standard Operating Procedure (SOP), passengers arriving from affected countries will undergo thermal screening and health monitoring, and those with symptoms suggestive of Ebola will be shifted to designated isolation facilities for testing and treatment.

The SOP also provides for 21-day monitoring of travellers from affected regions and lays down detailed protocols for quarantine, infection prevention, laboratory testing, contact tracing and clinical management. "States and UTs are (CONTD. ON PAGE 2)

West Asia fallout, Indo-Pacific situation top agenda India to host Quad meet

NEW DELHI, May 22: The foreign ministers of the Quad nations will deliberate on the fallout of the West Asia crisis and the prevailing situation in the Indo-Pacific at an India-hosted meeting on Tuesday.

The New Delhi meeting will be attended by US Secretary of State Marco Rubio, Australian Foreign Minister Penny Wong, and Japanese Foreign Minister Toshimitsu Motegi, the Ministry of External Affairs (MEA) said.

External Affairs Minister S Jaishankar will preside over the meeting.

Rubio, Wong and Motegi are also expected to call on Prime Minister Narendra Modi, besides holding separate bilateral meetings with Jaishankar.

"In keeping with the Quad vision for a Free and Open Indo-Pacific, the ministers will build on discussions held in Washington DC on July 1, 2025," the MEA said.



"They will exchange views on advancing Quad cooperation across priority areas, review progress on ongoing Quad initiatives, and reflect on recent developments in the Indo-Pacific region and other international issues of mutual concern," it said.

The Quad, comprising India, the US, Australia and Japan, has

emerged as a key grouping largely focusing on peace, security and stability in the Indo-Pacific region.

India is hosting the meeting in its capacity as the current chair of the coalition. There is no official word yet on the planned meeting.

People familiar with the preparations for the meeting said the Quad foreign ministers will deliberate on

the pressing global challenges, including the conflicts in Ukraine and the West Asia, and will take stock of cooperation in the Indo-Pacific, a region that has been witnessing increasing Chinese assertiveness.

In the last few years, the Quad has rolled out a number of initiatives addressing some of the most pressing needs and challenges of the Indo-Pacific region, including in areas of maritime security, infrastructure and connectivity.

In the last Quad summit held in Wilmington in the US in 2024, top leaders of the grouping unveiled major steps to expand maritime security cooperation in the Indo-Pacific.

The upcoming meeting is also likely to set the broad agenda of the Quad summit that is likely to take place in India later this year.

Century Ply Q4FY26 consolidated net up 49 pc to ₹ 79 cr

KOLKATA, May 22: Century Plyboards (India) Limited on Friday reported a 48.8 per cent rise in consolidated net profit to ₹ 79.4 crore for the quarter ended March of FY25-26, aided by strong growth across plywood, laminates and MDF segments.

The company had posted a consolidated net profit of ₹ 53.2 crore in the corresponding quarter of the previous financial year.

Consolidated revenue from operations during the January-March quarter grew 24.5 per cent to ₹ 1,492.2 crore, compared with ₹ 1,198.3 crore in the year-ago period.

For the full financial year 2025-26, consolidated net profit rose 44.2 per cent to ₹ 268.3 crore from ₹ 186.1 crore in FY25, while revenue from operations increased 19.2 per cent to ₹ 5,397.2 crore against ₹ 4,527.8 crore in the previous fiscal, the company informed bourses.

The plywood and allied products segment remained the largest contributor, with quarterly revenue rising to ₹ 791.1 crore from ₹ 670.7 crore a year ago.

The Medium-Density Fiberboard (MDF) segment revenue increased to ₹ 356.3 crore from ₹ 270.9 crore, while laminate and allied products revenue stood at ₹ 198.4 crore against ₹ 170.4 crore in the corresponding quarter last fiscal.

The laminate business turned profitable during the quarter, posting a segment profit of ₹ 17.4 crore against a loss of ₹ 4.9 crore a year ago, while MDF segment profit rose to ₹ 22.8 crore from ₹ 15.3 crore. The particle board segment, however, continued to remain under pressure.

The company said the group recognised an exceptional expense of ₹ 7.68 crore during FY26 on account of the implementation of the new labour codes.

It also reported sizeable foreign exchange fluctuation-related costs during the year. (PTI)

India's near-term outlook somewhat clouded by supply-side pressures: RBI Bulletin



MUMBAI, May 22: India's near-term outlook is somewhat clouded by supply-side pressures, and the spillover impact of the West Asia conflict on domestic inflation needs to be monitored, according to the RBI Bulletin.

While the global economy remained shadowed by uncertainties in West Asia, an article in the Bulletin said domestic economic activity exhibited resilience in April.

"The conflict in West Asia continued to exert pressure on commodity markets, global trade flows and supply chains, contributing to the volatility in financial markets. India has entered this phase from a position of macroeconomic strength," the article on the state of the economy said.

"Domestic demand continues to be the key driver of growth. However, the near-term outlook is somewhat clouded by supply-side

pressures.

"Although headline inflation remains firmly within the tolerance band, the pass-through to domestic prices needs to be monitored," it said. Retail inflation rose to 3.5 per cent in April, driven mainly by food inflation, while core inflation remained steady.

Against the backdrop of the Iran war, the article said constricted shipping routes and trade flows increased supply chain pressures to their highest levels since 2022.

Prices of commodities for which the Strait of Hormuz is a critical transit route remained elevated in April and early May.

The base metal prices, including aluminium, zinc and nickel, rose due to supply disruptions and higher fuel costs.

"The financial conditions, crude oil prices and capital flows continue to pose challenges to the ex-

ternal sector outlook," it said.

The merchandise trade deficit widened in April 2026 over March 2026 primarily on account of crude oil and gold imports.

Nevertheless, robust services exports, positive net FDI flows, foreign exchange reserve buffers and a number of proactive policy measures undertaken by the government and the Reserve Bank are likely to cushion the Indian economy against external headwinds, it said.

India is witnessing a trade re-configuration amidst the emerging geopolitical situation. Its trade through the Strait of Hormuz, which had declined sequentially in March, went up in April 2026.

The article further said that economic activity showed a mixed trend in April, as evidenced by several high-frequency indicators such as fuel consumption, trade, and logistics. E-way bills continued to achieve double-digit growth backed by GST rate rationalisation.

While petrol and diesel consumption continued to grow, overall petroleum consumption declined in April due to a sharp fall in the consumption of naphtha, liquefied petroleum gas (LPG) and other petroleum products, it said and added higher temperatures led to a sharp increase in electricity demand.

RBI announces record ₹ 2.87 lakh cr dividend to govt amid West Asia conflict



MUMBAI, May 22: The Reserve Bank on Friday announced a record dividend of ₹ 2.87 lakh crore to the government for the year-ended March 2026, providing a financial boost for the exchequer amid rising import bills and supply chain disruptions due to the West Asia conflict.

The dividend is 6.7 per cent higher than ₹ 2.69 lakh crore for the 2024-25 fiscal year.

In a statement, the RBI said its net income, before risk provision and transfer to statutory funds, aggregated ₹ 3.96 lakh crore in FY26 as against ₹ 3.13 lakh crore in FY25.

"The balance sheet of the Bank expanded by 20.61 per cent to ₹ 91,97,121.08 crore as on March 31, 2026," the Reserve Bank of India (RBI) said.

The RBI's Central Board of Directors, at its meeting, reviewed the global and domestic economic scenario, including risks to the outlook, and also approved the dividend.

According to the statement, the revised Economic Capital Framework (ECF) provides flexibility to maintain the Contingent Risk Buffer (CRB) between the range of 4.5 per cent and 7.5 per cent of the size of the balance sheet.

"Taking into consideration the current macroeconomic factors, financial performance of the Bank and maintenance of appropriate

risk buffers, the Central Board decided to transfer ₹ 1,09,379.64 crore towards the CRB for FY 2025-26 as against ₹ 44,861.70 crore in the previous year," it said.

The CRB at 6.5 per cent of the size of the RBI balance sheet, compared to 7.5 per cent for 2024-25.

"The Central Board approved the transfer of surplus of ₹ 2,86,588.46 crore to the Central Government for the accounting year 2025-26," the RBI said.

The 623rd meeting of the central board was held under the Chairmanship of Governor Sanjay Malhotra.

Deputy governors Swaminathan J, Poonam Gupta, Shirish Chandra Murmu, and Rohit Jain attended the meeting.

Other directors of the Central Board, including Nagaraju Maddirala, Secretary, Department of Financial Services; Satish Kashinath Marathe, Revathy Iyer, Sachin Chaturvedi, Anand Gopal Mahindra, Venu Srinivasan and Pankaj Rambhai Patel, too attended the meeting.

Amid the West Asia crisis, energy prices as well as those of fertilisers and other commodities have shot up, posing financial challenges. The rupee has also depreciated steeply, a scenario that makes imports costlier.

India meets about 88 per cent of its crude oil requirements through imports. (PTI)

Gold drops to ₹ 1.64 lakh/10g as Iran talks temper market anxiety

NEW DELHI, May 22: Gold prices retreated by ₹ 600 to ₹ 1.64 lakh per 10 grams in the national capital on Friday as tentative progress in US-Iran negotiations reduced precious metals buying, though unresolved tensions around the Strait of Hormuz kept traders cautious.

Snapping a three-day winning streak, the yellow metal of 99.9 per cent purity depreciated by ₹ 600 to ₹ 1,64,900 per 10 grams (inclusive of all taxes), according to local marketmen.

Gold prices witnessed a slight decline on Friday. The recent fluctuations in the bullion market are largely influenced by ongoing geopolitical tensions, particularly concerning US-Iran relations, alongside the volatility of the Indian rupee and movements in crude oil prices, Gaurav Garg, Research Analyst at Lemonn Markets Desk, said.

However, silver prices remained flat at ₹ 2,71,000 per kilogram in the bullion market.

In the international markets, spot gold fell marginally lower to USD 4,522.32 per ounce, while silver slipped 1 per cent to USD 75.87 per ounce.

"Spot gold trading lower to USD 4522 per ounce on Friday as despite narrowing differences between Iran and the US, nuclear and Hormuz control remain contentious issues," Praveen Singh, Head of Commodities at Mirae Asset ShareKhan, said.

Meanwhile, Washington has warned that shipping through the Strait of Hormuz should remain toll-free, keeping investors cautious despite signs of diplomatic progress between the US and Iran.

Bullion prices pared some losses after US Secretary of State Marco Rubio described the negotiations as showing tentative progress, though he flagged Hormuz control as a major sticking point. (PTI)

"Protection of tribal belts and blocks, preservation of community land rights and constitutional safeguards for indigenous communities will remain priority areas," he added.

The state's GSDP has grown by an annual compounded growth rate of nearly 16 per cent, and Assam was steadily progressing towards becoming a ₹ 10 lakh crore economy by 2028-29. Per capita income at current prices has more than doubled over the last few years, and capital expenditure has increased from Rs 13,502 crore in 2021-22 to ₹ 26,531 crore in 2025-26.

Despite this substantial increase in investment, the state has maintained its debt-to-GSDP ratio below 25 per cent, well within the permissible limit of 32 per cent, Acharya added.

The governor also mentioned of the government's commitment to create two lakh employment opportunities, make the state a power-surplus one for the first time, effectively tackle the annual floods, build a resilient agricultural economy, and further improve healthcare, education, tourism and other sectors. In Andhra Pradesh, the TDP will win all the four states for the Council of States and the BJP will bag all four seats in Gujarat. In Madhya Pradesh and Rajasthan, the Congress will get one seat each while the BJP will win two seats in each of the states, going by their current numbers.

In Karnataka, the Congress will win three seats and the BJP will get only one seat.

Among those who are retiring from the Rajya Sabha are Gowda, Congress president Kharge (both from Karnataka), Union ministers Ravneet Singh (Rajasthan) and George Kurian (Madhya Pradesh), former chief minister Digvijay Singh, and Congress leader Shaktisinh Gohil. Besides Ravneet Singh, the members whose tenure is ending in Rajasthan are Neeraj Dangi of the Congress and Rajendra Gehlot of the BJP.

Rajasthan has a total of 10 Rajya Sabha seats. The BJP and the Congress currently have five members each. Given the present strength of parties in the 200-member Rajasthan Assembly, the BJP is expected to win two of the three seats, while the Congress is likely to secure one.

The BJP has 118 MLAs in the Assembly, while the Congress has 67 members. The BSP has two MLAs, the Bharat Adivasi Party four, the Rashtriya Lok Dal one, and Independents eight. (PTI)

He could not become Prime Minister because the people of the country do not want him in that position," Borah said. The BJP MLA asserted that Narendra Modi's return to power for a third consecutive term reflected the confidence and faith people have placed in his leadership and governance.

Sunali Khatun and others to Bangladesh and termed it as "illegal".

On December 3 last year, the top court allowed on "humanitarian grounds" the entry of Khatun and her eight-year-old child into India, months after they were pushed into Bangladesh.

It had asked the West Bengal government to take care of the minor and directed the chief medical officer of Birbhum district to provide all possible medical assistance to pregnant Khatun, including free of cost delivery.

On April 24, the apex court granted last opportunity to the Centre and asked its counsel to take instruction and get back to it on the issue.

Senior advocates Kapil Sibal and Sanjay Hegde, appearing for Khatun's father Bhodu Sekh, had said it was a "bit unfair" on the part of the Centre which has not apprised the court about its views in the matter. Earlier, the top court had noted the submission of Mehta that the competent authority had agreed to allow the woman and her child into the country purely on humanitarian grounds without prejudice to rights and contentions, and they would be kept under surveillance.

Sekh alleged that the families, working as daily wage earners in Sector 26 of the Rohini area in Delhi for over two decades, were picked up by police on June 18, last year on suspicion of being Bangladeshis and subsequently pushed across the border on June 27. (PTI)

Demand for immediate government intervention on price of food items, fuel, LPG cylinders, medicines AASU holds protest rally against price hike of essential commodities

DIPHU, May 22: In tandem with the statewide agitation launched by the All Assam Students' Union (AASU) Central Committee, a massive protest demonstration was staged in Diphu town on Friday against the price rise of essential commodities.

Led by AASU Central Committee vice president Shorjun Hanse, Central Executive Member Arnabiyoti Kakoty, Karbi Anglong District Committee President Subhas Bora and General Secretary Arindam Mahata, protesters gathered outside the main entrance gate of the Diphu Club, raising slogans against the government's economic policies.

Addressing the protesters, AASU Central vice president Shorjun Hanse launched a scathing attack on the ruling dispensation, alleging that the BJP government moved to increase the prices of everyday essential goods immediately after forming the new government.

"The BJP government introduces various welfare schemes for the public on one hand, but it has completely failed to create sustainable income-generating opportunities for poor rural people to make them self-reliant," Hanse stated. "This government works for corporates and the rich, not for



the common citizen. Just days after the elections, prices of essential goods and medicines are being hiked, making life-saving drugs unaffordable for the poor."

Hanse vehemently dismissed the government's justification linking the fuel and commodity price hikes to the ongoing geopolitical conflict in West Asia.

"If the West Asia war is the real reason behind the oil crisis and the subsequent rise in petrol and diesel rates, why didn't the government increase the prices before the elections?" Hanse questioned. "They delib-

erately held back out of fear of losing the assembly elections and rolled out the hikes as soon as the voting concluded."

The student body has strongly demanded that both the Central and State governments take immediate corrective steps to roll back prices and alleviate the financial burden on the public. Hanse warned that if the administration fails to rein in inflation, AASU will launch an intense, multi-phased democratic agitation across the state to compel government action.

Our Jorhat Correspondent adds: In re-

sponse to a call given by the State leadership of the All Assam Students' Union (AASU), the Jorhat district unit on Friday took out a rally here to protest against the steep increase in prices of essential commodities like food items, fuel, LPG cylinders and medicines.

Holding banners and the organisation's flags, the protesters took out a rally from the Jorhat Stadium complex and moved across the town.

Shouting slogans against the government's failure to check the sharp hike in prices of essential commodities, they said that common people were hit hard by surging prices.

Demanding that the government take immediate steps to bring down the prices of essentials, they stated that students living in hostels and PGs, as well as small-time food outlets and restaurants, were severely affected by the huge hike in commercial LPG cylinders.

The protesters also criticised the BJP-led Central Government for increasing fuel prices just after the elections were held in five states.

NFR completes major curve realignment in Simaluguri-Moranhat section

GUWAHATI, May 22: Northeast Frontier Railway (NFR) has successfully completed a major curve realignment work in the Simaluguri-Moranhat section under Tinsukia Division in connection with the permanent removal of a Permanent Speed Restriction (PSR). The significant infrastructure improvement involved the conversion of an existing 3-degree curve into a smoother 2-degree curve through cut-and-connection of track along with shifting of Overhead Equipment (OHE) masts and wires. The work was executed successfully with close coordination among the Engineering, Operating and Traction Distribution (TRD) departments during the traffic block period, reflecting the strong teamwork and operational efficiency of the division.

During the execution of the block, the existing 3-degree curve was seamlessly connected with a newly aligned 2-degree curve laid on a fresh formation of approximately 500 metres in length. The project involved a maximum track slew of 7.7 metres and was completed with utmost precision and safety. To ensure smooth and safe train operations, machine tamping using a Duomatic machine was also carried out before the passage of the first train.

With the successful completion of this important infrastructure work, the existing Permanent Speed Restriction (PSR) of 95 kmph over a stretch of 500 metres has been permanently removed and the section is now fit for a Maximum Permissible Speed (MPS) of 110 kmph. This development will significantly enhance train mobility, improve punctuality and provide smoother and more efficient train operations in the section. Northeast Frontier Railway remains committed to continuous infrastructure modernisation, strengthening safety measures and enhancing operational efficiency to provide safer, faster and more reliable rail services across its network.

Dr Sharan also pointed out the increasing incidence of human papillomavirus (HPV)-related throat cancers among younger individuals and stressed the importance of recognising early symptoms such as non-healing mouth ulcers, persistent throat pain, voice changes, difficulty swallowing, unexplained neck

swelling and bleeding from the mouth. Speaking about advancements in cancer treatment, the doctors shared how robotic surgery and minimally invasive procedures are transforming patient care by offering greater precision, reduced pain, minimal blood loss, lower risk of infection, faster recovery, shorter hospital stays and smaller scars compared to conventional open surgeries.

Apollo Multispecialty Hospitals, Kolkata, continues to strengthen its position as a leading centre for advanced head and neck cancer care with the routine availability of comprehensive modern treatment modalities, including transoral robotic surgery (TORS) for pharyngeal and oropharyngeal cancers, robotic scarless thyroid and neck surgery, complex ablative head and neck cancer surgery and free microvascular flap reconstruction for restoration of speech, swallowing, function and appearance. TN CM's tribute to LTTE founder

History has again put the Congress in the politically very sensitive and emotionally complicated terrain. After the election result in Tamil Nadu, the Congress decided to support the Tamilaga Vettri Kazhagam (TVK) led by Vijay. As chief minister of the state, Vijay on May 18, paid tribute to Liberation Tigers of Tamil Eelam's (LTTE's) founder, Velupillai Prabhakaran, who was the chief accused in the former prime minister Rajiv Gandhi's assassination in 1991. The BJP's media cell chief Amit Malviya attacked Rahul Gandhi, "Tamil Nadu's new Chief Minister has paid homage to LTTE chief Velupillai Prabhakaran, whose outfit assassinated former Prime Minister Rajiv Gandhi. Of course, Rahul Gandhi would have no problem with it, as long as the Congress gets a slice of power. After all, the DMK too was an LTTE apologist, yet Congress remained perfectly comfortable in alliance with it." The attack is below the belt and devoid of all human sensitivity.

History is in no one's control, though some may imagine they have been controlling, as Leo Tolstoy demonstrates in his monumental work "War and Peace". Today, the history of Tamil Nadu is in the process of churning. DMK has just been defeated out of power, though TVK won only 108 seats, now has only 107 seats after Vijay's quitting from one of the two seats he had won. Congress has won 5 seats, and 8 seats are won by TVK's other allies VCK, CPI, CPI(M) and IUML. The majority mark is 118, and the ruling alliance has 120 seats. Congress, or anyone had not idea, in which way the politics will move. Though an AIADMK group of 25 is ready to join the TVK, they are kept at abeyance by Vijay because of CPI(M)'s objection. Vijay wants to keep the present alliance, which has been asserted by TVK leader Aadhav Arjuna on May 20. Congress has 5 seats, and Vijay is not so unwise that it should willingly hurt the Congress leadership or rank and file.

Nevertheless, the political compulsion for Vijay was to make its own ideological base other than the Dravidian politics of the DMK and AIADMK. Vijay wants to create neo-Dravidian ideological base by adding Tamil Nationalism to it. It is in this effort he referred to 'Mullivaikkal' where Prabhakaran was shot dead by the Sri Lankan army on May 18, 2009.

China-Russia joint declaration from Beijing Summit puts more pressure on Trump

The joint declaration made by Chinese President Xi Jinping and the visiting Russian President Vladimir Putin after their summit in Beijing on May 20 has major ramifications on the global geopolitics in the context of the present unilateral actions of the U.S. President Donald Trump including the launching of war against Iran which still is m not over.

The main thrust is the decision of Russia and China to set up a joint front against the USA blaming the Trump regime for global return to the law of the jungle. Significantly, this declaration was made by China and Russia after five days of the Xi-Trump summit held in Beijing on May 15. Though there was no joint declaration, both sides expressed happiness at the continuing improvement in the bilateral relations between China and the USA. Though the breakthrough took place only in business and economic discussions, there were much discussions on Iran war and Taiwan also. However, officially, Chinese side gave no details about the outcome.

In May 20 summit, however, President Xi came out more openly on Iran war and said that in Iran, further conflict was inadvisable and a ceasefire was necessary. President Xi said that a comprehensive ceasefire is of utmost urgency, resuming hostilities is even more inadvisable and maintaining negotiations is particularly important. What was more significant that in the joint statement, China and Russia took aim at Trump's plans for a US\$ 175 billion Golden Dome defence system which would create a new missile field in the middle east. Both the leaders also criticized the expiry of the last US-Russia arms control treaty fell to the wayside in February 2026 when the U.S. President did not respond to Moscow's proposal for extension.

The joint declaration of Russia and China is going to have its impact on the present peace making efforts on Iran war. Trump discussed the issue with President Xi on May 15 but it was not fruitful. On May 20, President Xi made his position on Iran war more clearer by saying that negotiations and not war have to be the instrument for ending Iran war. So whatever claims, Trump is now making that he is ready for fiercer attack against Iran if Tehran does not agree immediately to a deal, his options are not working.

Trump also knows that he has to agree to a solution on the basis of three draft proposals, Trump's own peace plan, Tehran's peace plan and China's four point formula. Both Trump and Tehran have to agree to a compromise solution to end the war. The joint declaration of China and Russia is a strong reminder to Trump that he has to resort to negotiations only for ending the Iran war. Among the chief topics of discussion was the energy sector, which Putin called the "driving force of economic cooperation" in Russian-Chinese relations. China asserted itself as a major buyer of Russian oil and trading partner after Western countries largely cut economic ties with Moscow in response to Russia's full-scale invasion of Ukraine.

According to Al Zazeera correspondent in Beijing, while the two leaders planned to sign some 40 agreements covering everything from the economy and tourism to education, energy security remained Putin's priority. "Since the war in Ukraine, any gas sales that were previously heading to Europe, that is all dried up, and Russia is in desperate need of revenue to replace that," she said. The talks did not lead to a new consensus on a long-discussed gas pipeline known as Power of Siberia.

However, Kremlin spokesperson Dmitry Peskov told Russian media that the two sides had reached a "basic understanding" on the pipeline, including its route, but that there was no "clear timeline" for a rollout. All indications suggest that despite keen Russian interest in this gas pipeline, Putin failed to persuade President Xi to agree the implementation of the project on a priority basis. Russia needs it now as its West European customers have dried up, but China has its own considerations, therefore is the delay and no finalization of the much expected deal.

China analysts have observed that President Xi treated President Trump as equal and gave him gala reception as the head of the country with largest economic power. China had lot of expectations from Trump from the summit. But in Putin's case, Russia is a lesser power now compared to Soviet days and also Putin is under economic stress. (IPA Service)

The chronicles of Pobitora and the evolution of Assamese ecological consciousness

The historical trajectory of environmental literature in Assam finds a profound and structured manifestation in the annual indices of Pobitora, a seminal publication dedicated to ecological discourse, wildlife conservation, and regional environmental challenges. Spanning nearly a decade of intellectual contributions from 2012 to 2018, these tables of contents delineate a critical transition in how regional scholars, scientists, and literary figures conceptualized the fragile ecosystems of Northeast India. Initially emerging as a localized platform to discuss the immediate surroundings of the Pobitora Wildlife Sanctuary, famed for its dense population of the Indian one-horned rhinoceros, the publication quickly matured into a comprehensive compendium addressing global anxieties such as climate change, anthropogenic degradation, and biodiversity loss through a distinctly indigenous lens. By analyzing the thematic distribution of these writings, one can discern the shifting priorities of the Assamese intelligentsia as they grappled with the dual pressures of infrastructural development and ecological preservation.

The foundational discourse captured in the 2012 edition establishes an essential baseline, focusing heavily on the immediate geography of Pobitora and the broader mandate of habitat protection. Early contributions by prominent figures such as Dipanka Hazarika and the legendary cultural icon Dr. Bhupen Hazarika underscore the deep intertwining of Assamese identity with its natural heritage, particularly the symbolic resonance of the rhinoceros and the riverine ecosystems of the Brahmaputra valley. This period of literature was characterized by foundational calls for afforestation, pioneered by national figures like Sunderlal Bahuguna, alongside granular examinations of local wetlands like Deepor Beel and the adjacent areas of Pobitora. The early writings effectively laid the groundwork for a more systemic critique of environmental policy by documenting the rich biodiversity of Assam while simultaneously introducing community responsibilities and



legal frameworks, such as the Indian Forest Act of 1927, to a general readership eager for structured conservation paradigms.

As the publication progressed into 2013 and 2014, the editorial scope expanded significantly beyond localized conservation to incorporate rigorous scientific assessments of global environmental phenomena and their regional ramifications. The discourse during these years began to feature critical appraisals of global warming, climate-induced hydrological shifts, and the specific vulnerabilities of the Brahmaputra's wetlands, often described metaphorically as the kidneys of the landscape by scholars like Banikanta Goswami. This era also witnessed an intellectual bridging between traditional folklore and scientific inquiry, particularly through explorations of Mayong, the traditional land of magic adjacent to Pobitora, where the historical coexistence of human communities and dense forests was analyzed for sustainable insights. Authors like Dr. Pradip Sharma and Dr. Buljit Buragohain contributed pieces that elevated the publication from a celebratory nature magazine to a serious forum for environmental advocacy, dissecting the impact of plastic pollution, the

necessity of energy sustainability, and the critical role of environmental education in mitigating civilian apathy.

The mid-decade volumes of 2015 and 2016 reflect a heightened urgency, marked by an increasing focus on specific ecological crises such as the alarming rise in rhino poaching, habitat fragmentation in the Amchang Wildlife Sanctuary, and the vulnerability of avian populations across the state. The prose in these editions grew more analytical and urgent, with contributors like Mubina Akhtar and Dr. Dinesh Chandra Goswami examining the profound systemic failures that allow wildlife trafficking to persist despite stringent legal protections. It was during this phase that the publication diversified its linguistic and stylistic presentation, incorporating formal English essays alongside Assamese commentaries to reach a broader academic audience. This period also highlighted the global interconnectedness of local conservation efforts, referencing international frameworks like United Nations declarations, the themes of World Environment Day, and the interventions of global bodies like UNESCO, thereby positioning the conservation of Assam's floodplains within the larger matrix of international biosphere preserva-

tion.

By 2017 and 2018, the compilation exhibited a highly sophisticated understanding of socio-ecological systems, directly confronting the complexities of modern development, urban expansion in Guwahati, and the degradation of rural commons. The articles from these final years, written by an array of specialists including Dr. Sabda Kanto Sarma and Dr. Hrishikesh Baruah, moved past mere problem identification to offer systemic critiques of groundwater depletion, river pollution, and the eco-centric philosophies required for genuine sustainable development. The threat of plastic became a dominant theme during this twilight period of the reviewed collection, with multiple essays exploring the biochemical threats of microplastics and celebrating innovative community-led movements toward a clean neighborhood paradigm. The literature evolved to recognize that wildlife protection cannot occur in isolation from human welfare, thus advocating for sustainable eco-tourism as a tool for economic empowerment and environmental stewardship, while warning against the commercial exploitation of fragile habitats like the Barail range.

Ultimately, the chronological evolution of the Pobitora indices serves as a mirror to the broader environmental movement within Assam, illustrating a transition from romanticized nature appreciation to an adversarial, data-driven critique of ecological neglect. The wealth of data contained within these documents reveals a community of writers, scientists, and citizens who refused to view nature as a passive backdrop to human progress, choosing instead to document its rhythms, its wounds, and its resilience. Through decades of changing climates and shifting political landscapes, these records remain invaluable archives of regional environmental history, demonstrating that the salvation of unique species like the great Indian rhinoceros is irrevocably linked to the preservation of the smallest wetland, the education of the youngest citizen, and the continuous cultivation of a rigorous, ecologically informed public discourse. What millennials and gen Z professionals need to know about developing a meaningful career

What is a "meaningful career"? It can be doing purpose-driven work that aligns with your values. It may mean finding a working arrangement that balances the different parts of your life. Or it could be a career that gives you the opportunity to be your authentic self, while contributing to the world or improving others' lives. The answer is different for everyone, and can change over time.

Defining a meaningful career can be difficult enough – but then you need to get there. This is a deeply personal journey that involves identifying your values, passions and interests, and finding environments where you can thrive.

A new survey in the US has found that a sense of purpose at work or in school is the most important driver for gen Zers' happiness. I recently interviewed 28 millennial and generation Z graduates in the UK about what a meaningful career means to them. All of the participants entered the labour market either during the 2008 financial crisis or the COVID pandemic,

making them feel uncertain about their immediate future.

One millennial graduate observed how people in their cohort "took whatever job they could get, then looked around for something else as the market recovered". A gen Z graduate noted: "The graduate market was so poor due to COVID-19 that it was just a case of taking any job that was offered."

In other words, the economic environment they found themselves in meant they didn't always have the flexibility to prioritise meaning in their job search.

Millennials and gen Zers both spoke of valuing a collaborative and inclusive work environment. They wanted employers to prioritise their wellbeing by managing workloads and giving them autonomy to do their work. Access to training and development, a competitive salary package and career progression opportunities all featured prominently in the interviews. Both groups also spoke of the need to feel that their work contributed value to the organisation or broader society.

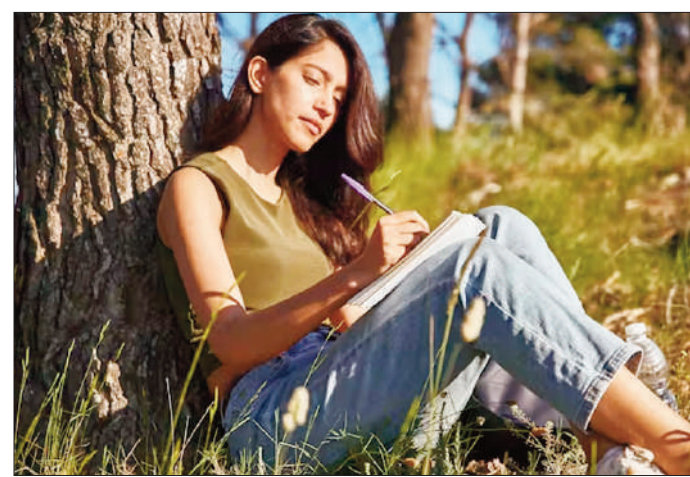

I also uncovered differences between millennials and gen Zers about what they want from a meaningful career. However, these had more to do with life stages than generational labels.

Gen Zers felt that because of the pandemic, "there was so much uncertainty" – so they wanted "somewhere that had a bit more job security and stability". They also felt a well-known employer with a good reputation "was safer in terms of job security during the pandemic".

Millennials, now having children and "settling down", placed greater emphasis on wanting a shorter commute and reducing the amount of physical travel for work. They were more likely to call for "family-friendly policies", although women from both age groups discussed this more than men.

People prioritise different things in work depending on their life



stages, and as things like caregiving responsibilities enter the picture. Your definition of a "meaningful" career might change over your lifespan.

Finding a meaningful career

Once you've determined what a meaningful career would look like for you, there are steps you can take to plan for and develop it. Remember, it is an ongoing process to align your career with your values, passions and interests, and it

is perfectly normal for these to evolve over time.

1. Consider your environment
Think about how the physical space of work can help you thrive. For example, I'm a disabled and housebound millennial, so hybrid or in-person simply does not work for me. To do meaningful work, it has to happen at home. In contrast, if you live on your own or in a house-share with no space to work, you may find meaning from in-

person interactions and seek out a role where you can be around other people.
2. Keep learning
Education does not have to begin or end with formal schooling. Commit to lifelong learning by embracing personal development throughout your career. Consider upskilling or reskilling opportunities, and alternative career paths.

I used to work in technology as a project manager. While I learned a lot, the work did not fulfil a sense of purpose and meaning for me. I retrained and pivoted into recruitment – helping graduates find internships and job opportunities gave me meaning, as I could see the outcome it had on people's lives.

3. Build your network
You may not find or build a meaningful career all on your own. Developing an expansive network of contacts can give you insight into other industries, organisations or roles, and may help you access new opportunities in the future. You may want to meet with a career counsellor or find a mentor.

Qualified career counsellors can be a wealth of information and support – as can friends, family and colleagues.

4. Be authentic and flexible
Because meaningful work is so personal, you have to have a strong sense of your own values – and stay true to them. Research shows there are many mental and physical benefits to having a purpose. If you know your values and purpose, you can align your work with your authentic self.

If you are trying to figure out what your values are or are stuck in a role that doesn't align with them, do not panic. It's never too late to make a change. As my own and my participants' experiences show, not every job you take will be perfectly matched with your values. That's OK. You can still learn skills and use this time to refine what a meaningful career means to you.

And if the reality of a situation does not meet your expectations, do not be afraid to try something new, or look for meaning outside of work. (Courtesy-The Conversation)

BJP's Bengal win can reshape India's economic direction: Pradeep Gupta

NEW DELHI, May 22: Pollster Pradeep Gupta has argued that the BJP's victory in the West Bengal Assembly election has the potential to reshape not just the state's future but also the economic direction of the entire country, citing eastern India's vast natural resources, ports and untapped trade potential.

The founder-chairman of Axis My India said states, such as Bihar, Odisha, Assam and West Bengal, collectively possess enormous economic and strategic importance.

"It is not just about Bengal. A victory there can change the direction and condition of the entire country," Gupta told PTI in an interview on Wednesday, while discussing the broader implications of the Bharatiya Janata Party's (BJP) poll triumph in West Bengal, dislodging the Trinamool Congress (TMC) from power after 15 years.

According to Gupta, eastern India's importance stems from its natural resources, maritime access and connectivity to the northeast and the Andaman and Nicobar Islands. Referring to West Bengal's geographical position, he said access to the Andaman Islands effectively passes through the state,



underlining its strategic significance.

He noted that Bengali and Tamil-speaking communities form a substantial part of the population in the islands because eastern India historically served as an important resource and migration base.

Gupta pointed out that regions with a strong port infrastructure and trade networks historically became centres of prosperity.

"It is often said that countries with the highest number of ports become the most prosperous because trade and business move through them. Without the movement of goods and commerce,

prosperity cannot come," he said.

Lamenting what he described as the economic decline of eastern India, Gupta questioned the developmental trajectory of Bihar and Odisha despite their mineral wealth and natural resources. He also said Assam and much of the northeast had long remained geographically and economically isolated.

"Look at the condition of Bihar. If you separate Odisha's mines and natural resources for a moment, what remains of its economy? Assam and the northeast were virtually cut off for years," he said.

On West Bengal, Gupta said the

state once served as one of India's foremost industrial and commercial centres, housing several major corporate headquarters during the colonial and early post-independence years.

He referred to the migration of businesses and business communities out of Kolkata over the decades, saying many firms shifted operations to cities, such as Mumbai and Bengaluru, while several business families later moved abroad. He also cited the collapse of the Tata Motors' Nano project in Singur as an example of how industrial opportunities were lost in West Bengal.

"Those who tried to harness Bengal's potential, like the Nano factory project, were driven away," he said. Gupta further claimed that migrant voters from eastern India appeared unusually determined to travel back home to cast their votes this time, suggesting a strong undercurrent of political change.

Recalling conversations with people travelling from cities such as Mumbai, Gupta said many voters were eager to participate despite logistical difficulties and fears around electoral participation. (PTI)

'Need innovators, not interpreters': Pradhan bats for Indian languages in education system

NEW DELHI, May 22: Union Education Minister Dharmendra Pradhan on Friday defended the emphasis on Indian languages in the education system, saying India needs "innovators, not interpreters", while asserting that foreign languages should not become a burden for students. Addressing the Jagran Bharat Education Conclave 2026, Pradhan expressed his support for teaching foreign languages, noting that students involved in global trade should learn multiple foreign languages.

"I am in favour of teaching foreign languages. Those who will handle Indian trade and commerce in global markets should learn even five foreign languages," the minister said. However, he stressed that students should study in the language in which they understand concepts best.

"When a child needs clarity, they should not remain burdened with foreign languages. They should study in the language in which they understand concepts clearly," he said.

Pradhan cited a review by the Central Board of Secondary Education (CBSE), which found that only one per cent of the board's total student population is studying foreign languages.

"We conducted a review through CBSE and found that foreign language students constitute only one per cent of the total student population," he said.

Responding to criticism over the emphasis on Indian languages, the minister said that India's rapid growth in innovation, research and manufacturing requires creators and innovators rather than translators.

"Indian languages should be studied because India has rapidly advanced in innovation over the past 10 years. Our production, research and national requirements have grown. India now has a population of 140 crore, and the Global South is increasingly connected with India. The expectations of the Global South rest on India's research,

innovation and low-cost production value chain," he said.

He emphasised that to strengthen India's innovation and low-cost production ecosystem, the nation needs more innovators than interpreters. "A few interpreters will always be needed, but society must decide whether it wants innovators or interpreters," he added.

"Our education policy is moving towards creating innovators," the minister said.

Pradhan welcomed criticism in a democracy as long as it is logical and relevant. "Criticism is essential in a democracy. But criticism should be logical and relevant — it should help take the debate forward," he added.

On Friday, the Supreme Court said it will hear a plea next week challenging the new CBSE policy, which has made the study of three languages, including at least two native Indian languages, compulsory for Class 9 students beginning July 1.

Senior advocate Mukul Rohatgi mentioned the matter before a bench of Chief Justice Surya Kant and Justices Joymalya Bagchi and Vipul M Pancholi.

"This is an urgent PIL. The petitioners are students, teachers and parents. They are challenging the new policy of the CBSE by which, in the 9th standard, two more languages have been made compulsory," Rohatgi said.

Urging the top court to list the matter for hearing on Monday, Rohatgi said, "It will create chaos."

The CJJ said next week will be a miscellaneous week, and the matter would be listed.

According to a recent circular issued by the CBSE, the board has made the study of three languages, including at least two native Indian languages, compulsory for Class 9 students beginning July 1.

The move is part of the CBSE's alignment of its Scheme of Studies with the National Education Policy (NEP) 2020 and the National Curriculum Framework for School Education 2023. (PTI)

India, Cyprus upgrade ties to a strategic partnership

NEW DELHI, May 22: India and Cyprus on Friday elevated their ties to a strategic partnership and set up a joint task force to facilitate deeper cooperation in sectors such as infrastructure and shipping as Prime Minister Narendra Modi hosted Cyprus President Nikos Christodoulides for wide-ranging talks.

The two leaders also deliberated on the West Asia crisis as well as the Ukraine conflict, with PM Modi saying New Delhi supports all efforts for an early end to the hostilities.

"Over the past decade, investment from Cyprus to India has nearly doubled. Trust between the two countries has increased, and with the India-European Union Free Trade Agreement, numerous new possibilities have emerged," Modi said in his media statement.

Taking advantage of this, we are targeting to double this investment again in the next five years, he said.

"And to realise this resolve, today we are elevating our trusted

relationship to a strategic partnership," he added.

The prime minister also noted that the friendship between India and Cyprus is both "strong and futuristic" as he elaborated on various aspects of his talks with Christodoulides.

"We also discussed global issues. Whether it is Ukraine or West Asia, we will continue to support efforts for the early end of the conflict and for peace," Modi said.

"We are also unanimous on the view that reform of global institutions is urgent and important for resolving the growing global challenges," he said.

The prime minister said the two countries also decided to expand cooperation in areas of maritime security and counter-terrorism.

In his remarks, Christodoulides said India and Cyprus decided to set up a joint task force for cooperation in key sectors such as infrastructure and shipping. Christodoulides kicked-started his three-day visit to India on Wednesday. (PTI)

SC grants bail to accused in UAPA case over recruitment of 'hybrid' terrorists



NEW DELHI, May 22: The Supreme Court on Friday granted bail to Suhail Ahmad Thokar, who was arrested in a UAPA case for allegedly conspiring with proscribed terrorist groups to recruit "hybrid" terrorists, radicalise youth and execute acts of terrorism following the repeal of Article 370 of the Constitution.

The Centre had on August 5, 2019 abrogated the provisions of Article 370 of the Constitution, which bestowed a special status on the erstwhile state of Jammu and Kashmir.

A bench of Chief Justice Surya Kant and Justices Joymalya Bagchi and Vipul M Pancholi passed the order while hearing Thokar's plea challenging a September 2023 order of the Delhi High Court which had denied him bail in the case probed by the National Investigation Agency (NIA).

He was arrested in the case on October 20, 2021.

The top court granted him bail while considering the

period already spent by him in custody and also that conclusion of trial in the matter would take some time.

It directed that Thokar be enlarged on bail subject to furnishing the bail bond to the satisfaction of the special NIA court at Delhi. Thokar had earlier moved the high court challenging a January 2023 order of the trial court denying him bail in the case lodged under various provisions of the erstwhile Indian Penal Code and the Unlawful Activities (Prevention) Act, 1967.

The prosecution had alleged that an FIR was registered subsequent upon the receipt of intelligence regarding the incubation of a larger conspiracy in the Kashmir valley and the conspiracy was orchestrated by proscribed terrorist groups, including Lashkar-e-Taiba, and Hizb-ul-Mujahideen. It was alleged that these terror groups, in collaboration with their facilitators and leaders based in Pakistan, were involved in influencing and radicalising susceptible local youth.

The prosecution had alleged that Thokar played an active role in providing refuge to the members of the terrorist organisations and their associates.

During the arguments before the high court, his counsel had argued that there existed a conspicuous absence of material evidence implicating him in any criminal conspiracy with the alleged terrorist outfits and nothing incriminating was recovered from his possession.

Opposing his submissions, the NIA's counsel had argued in the high court that the prosecution was clearly able to establish that Thokar played an active role in arranging logistical support for terrorists in the Kashmir valley. (PTI)

Madhya Pradesh HC allows second postmortem of Twisha Sharma

JABALPUR, May 22: The Madhya Pradesh High Court on Friday permitted a second postmortem of Twisha Sharma, the Noida woman who was allegedly harassed for dowry and died last week, her family members said.

The HC has allowed the petition filed by Twisha's father Navnidhi Sharma, their lawyer Ankur Pandey told PTI.

He said the high court has directed the state government to make arrangements for a team of doctors from the All India Institute of Medical Sciences (AIIMS), Delhi, to be flown to Bhopal.

The family approached the high court two days after a lower court turned down their plea for a second autopsy.

Twisha was found hanging at her marital home in Bhopal's Katara Hills area on May 12. The family of the 33-year-old model turned actor accused her in-laws of pushing their daughter to death. Her in-laws claim she was addicted to drugs.

While her postmortem was done at AIIMS Bhopal, her family had

sought a second autopsy, citing discrepancies.

Two days ago, Judicial Magistrate First Class Anudita Gupta in Bhopal rejected the family's plea, stating that the conscience of the court must be satisfied to order a re-postmortem. Minor infractions of procedure will not impel the court to order a second autopsy, the magistrate had noted.

The lower court also observed that the body was currently kept in the AIIMS Bhopal mortuary at -4 degrees Celsius, but required -80 degrees for longer preservation, a facility unavailable anywhere in the city.

Following Twisha's death, police registered an FIR under Sections 80(2), 85, and 3(5) of the Bharatiya Nyaya Sanhita along with relevant sections of the Dowry Prohibition Act, naming her husband Samarth Singh and mother-in-law and former judge Giribala Singh.

Police have also announced a cash reward of ₹ 30,000 for information leading to Samarth Singh's arrest and approached the court for revocation of his passport. (PTI)

Bihar Police says attacks on personnel increased amid intensified crackdown on criminals

PATNA, May 22: Bihar Police on Friday claimed that attacks on its personnel have increased amidst an intensified crackdown on criminals, forcing officers to open fire in self-defence in some cases.

Rejecting allegations that police encounters were being carried out on the basis of caste, newly appointed additional director general of police (law and order) Sudhanshu Kumar asserted that law enforcement agencies do not differentiate on caste lines.

"Police have no caste, and neither do criminals. For criminals who attack police personnel, we will not ask their caste before taking action against them to save our lives," Kumar told reporters at the police headquarters here.

He said sustained action by police, including arrests, speedy trials and seizure of properties acquired through crime, had led to desperation among criminal elements.

"In the wake of arrests, speedy trials and seizure of property acquired through crime, it is natural that some desperate elements will take such steps as attacking police, but we are ready for that," he said.

The ADGP said Bihar Police identified 1,433 criminals under provisions related to seizure of illegally acquired properties between January and May 15, and proposals against 428 people were sent to courts during the period.

Proceedings for seizure of property are underway against 103 accused, while attachment orders have

been issued against four others, he added. Kumar said 33,126 accused were arrested between January and May 15 in serious criminal cases, including murder (2,023), dacoity (311), loot (573) and atrocities against Scheduled Castes and Scheduled Tribes (1,572).

Furthermore, courts across the state convicted 70,624 people in 52,567 cases between January and April, of whom two persons were awarded death sentence, 453 were sentenced to life imprisonment and 253 received jail terms of more than 10 years, he added.

The ADGP said preventive action under relevant provisions of the Bharatiya Nagarik Suraksha Sanhita (BNSS) was taken against 4,13,118 people between January and May 15, while bond proceedings were initiated against 1,34,358 people during the same period.

He also said 1,146 accused were arrested in cases related to communal violence (57), attacks on police personnel (1,065), mob violence (04) and celebratory firing (20) in the same period.

According to a statement issued by the PHQ, police arrested 1,34,225 accused people and seized 1,466 illegal firearms, 7,073 cartridges, 12 bombs and 259 detonators between January and April.

Police also busted 35 illegal mini gun factories and seized narcotics, including 3,644 grams of heroin and over 16,408 kg of ganja, besides confiscating 7,709 vehicles during the period. (PTI)

Tribals embracing Christianity, other faith must be delisted from ST list: Vanvasi Kalyan Ashram

NEW DELHI, May 22: Religious conversion is a major threat to the country and has deeply affected tribal regions, leading to "serious social conflicts and divisions", Akhil Bharatiya Vanvasi Kalyan Ashram president Satyendra Singh has said, while calling for a constitutional amendment to check this menace.

In an exclusive interview with PTI Videos, Singh said the solution to "many problems related to conversion" lies in amending Article 342 of the Constitution to deny benefits under the Scheduled Tribe (ST) category to those who convert from Hinduism to Christianity or Islam on the lines of Article 341, which has such provisions for the members of the Scheduled Castes (SCs) embracing other religions.

Singh said while the Vanvasi Kalyan Ashram, an RSS-affiliate, mainly works in areas such as education, healthcare, self-reliance and cultural awareness, it set up the Janjati Suraksha Manch in Raipur in 2006 to further pursue

the issue of "delisting" the members of the ST communities who have converted to Islam, Christianity or any other non-Hindu religion.

He claimed that a large section of the tribal community has undergone religious conversion, adding that wherever conversions took place, a strong sense of "alienation" emerged.

"Our own people gradually became disconnected from each other. Conflicts and divisions started within the society itself. One brother became Christian, another remained Hindu, and this created divisions within families and communities," he said.

Referring to Vanvasi Kalyan Ashram founder Balasaheb Deshpande, Singh said, "He had said in his final days that while we are engaged in the service of people, the coming times would also be a period of struggle. Therefore, we would also need to prepare workers from that perspective."

Singh also acknowledged that

social discrimination and caste divisions within the Hindu society have contributed to religious conversions.

"There can be many reasons behind religious conversions. Some shortcomings also existed within our own society. People should have received more affection and inclusion," he said.

He alleged that missionary activities expanded during the British rule under the pretext of education, healthcare and welfare work, and claimed that "inducements" provided by Christian missionaries also played a role in conversions.

"The Hindu society also had caste divisions and feelings of superiority and inferiority. Missionaries offered affection as well as inducements, and that contributed to conversions," Singh said.

According to Singh, religious conversions took place most significantly in the northeast, Jharkhand, Chhattisgarh, Andhra Pradesh, Telangana and Kerala. (PTI)

Severe heatwave conditions likely to prevail over parts of India: IMD

NEW DELHI, May 22: Heatwave to severe heatwave conditions are likely to persist over the plains of northwest India, Central and East India, and parts of Peninsular India during the next six to seven days, the India Meteorological Department (IMD) said on Friday.

The IMD stated that heatwave conditions are likely in isolated areas of Uttar Pradesh and Madhya Pradesh from May 22 to May 28.

"Severe heatwave conditions over East Uttar Pradesh and East Madhya Pradesh are expected during the same period," the IMD said.

It added that heatwave conditions are very likely in isolated/some pockets over Punjab and Haryana, Chandigarh, and Delhi from May 22 to May 28.

Severe heatwave conditions are predicted in some areas of these re-

gions between May 24 and May 27.

"Heatwave conditions are very likely in isolated/some pockets over Rajasthan during May 22-28, with severe heatwave conditions likely in isolated/some pockets over West Rajasthan during May 24-28," the IMD said.

Parts of Vidharbha, Coastal Andhra, Yanam, Chhattisgarh, Jharkhand, Odisha, Telangana, Jammu-Kashmir, Himachal Pradesh, and Uttarakhand are likely to witness heat wave or severe heat wave conditions on different dates between May 22 and May 28.

Furthermore, warm night conditions are expected in isolated pockets of Uttar Pradesh and Vidharbha from May 22 to May 24, in Odisha from May 22 to May 26, and in Telangana on May 22 and May 23. (PTI)

Shutdowns and blockades mainly affect daily wage earners and disrupt state economy



IMPHAL, May 22: Manipur Chief Minister Y. Khemchand Singh on Friday appealed to the people of the state to come forward for talks and not to resort to bandhs or blockades.

Singh was speaking at the inauguration of a bridge at Akham Makha Leikai in Imphal West district.

Tripura BJP's chief demands four-day work week for govt staffers

"Following the prime minister's appeal amidst the West Asia conflict, the state government has ordered 50 per cent of Group C and D employees to work from home while the remaining workforce is attending offices (from May 14) as part of austerity measures," Roy said in a press conference.

She said the people must adhere to the prime minister's call for saving fuel because nobody knows when the conflict will end.

"Chief Minister Manik Saha, his cabinet colleagues and MLAs have already reduced their escorts and vehicles following the PM's

appeal. I urge the people to adopt austerity measures by using public transport, e-rickshaws or bicycles for short distances," she said.

Roy said the government has already introduced an e-office system from the civil secretariat to the gram panchayat level but support from Group C and D is required to keep the system going.

"Therefore, I appealed to the government to introduce a four-day work week for the employees by increasing working hours in offices from the existing eight hours to nine hours or so," she said. (PTI)

Chaubey assures full-fledged ISL next edition after dramatic 2025-26 season finish

KOLKATA, May 22: Marred by controversy in the build-up, the curtailed Indian Super League made a dramatic end with East Bengal claiming the title, and the All India Football Federation (AIFF) President Kalyan Chaubey assured that the tournament would return in a full-fledged format next season.

Twenty-two years after their last national league triumph, East Bengal finally ended their long wait for glory by defeating Inter Kashi 2-1 in a thrilling ISL 2025-26 finale at the Kishore Bharati Krirangan here Thursday night.

"Of course we will see a full-fledged ISL next season," Chaubey told reporters after the match.

Mohammed Rashid emerged the unlikely hero with a decisive 72nd minute strike after league top-scorer Youssef Ezzejjari had cancelled out Alfred Planas' early goal soon after the break.

The win helped East Bengal finish on top with 26 points from 13 matches, edging Mohun Bagan Super Giant on superior goal difference after both Kolkata giants ended level on points.

Hailing the rivalry between Mohun Bagan and East Bengal, Chaubey said: "Whenever there is competition, it is always healthy for football. The Kolkata derby between Mohun Bagan and East Bengal is among the biggest rivalries in world football."

"East Bengal had been lagging behind over the last few years, but the way they have come back this season will immensely benefit Bengal football."

"As long as the Mohun Bagan-East Bengal rivalry stays alive, Bengal football and Indian football will stay alive."

The 2025-26 ISL season kicked off on February 14, a delay of five months due to financial and governance deadlock after the expiry of the Master Rights Agreement between the AIFF and FSDL.

Each team got to play only a maximum of 13 matches, as opposed to 24 last season.

"I never said football would stop in India," Chaubey said. "This season we organised 21 tournaments and close to 2,100 matches. Never before in Indian football history have so many matches been played in a single season."

"Yes, there were crises and some controversies too. Sometimes controversies are even created because they keep people interested. But I strongly believe Indian football is moving forward and will continue to progress this way."

ISL's future is still uncertain



amid a fresh deadlock between clubs and the AIFF over commercial and broadcast structures. Several franchises have pushed for a club-led operational and commercial model, while uncertainty over the roadmap has stalled player contracts and renewals across teams.

At East Bengal too, head coach Oscar Bruzon had earlier publicly announced that he may not continue if clarity over the ISL's future does not emerge soon.

Chaubey said Indian football had already endured enough turbulence this season after the league remained suspended for seven months.

"Anyone who follows Indian football knows the sport came to a standstill for seven months after the expiry of the 15-year agreement between AIFF and FSDL."

"For the last eight years there was a system in place and suddenly there was uncertainty. At one stage, it even looked like the league would not happen."

"The Super Cup started late, players lacked match fitness because there were not enough games. So as an organiser, I feel satisfied that AIFF managed to bring everybody together and successfully conduct the tournament."

He said the competitiveness of the league despite the truncated format was the biggest positive.

"The bigger achievement is the way the tournament became so competitive. The way Mohun Bagan and East Bengal kept fighting for the title till the very last day, I don't think we have ever witnessed such an intense ISL season before."

"We made it possible through God's grace and through everyone's hard work."

There was much drama before the final round matches with five teams -- East Bengal, Mohun Bagan, Mumbai City FC, Punjab FC and Jamshedpur FC -- in the title race heading into the final round of simultaneous matches on Thursday.

With teams playing only 13 matches this season, compared to 24 last year, the title race remained wide open till the very end. (PTI)

PBKS seek dramatic turnaround to keep playoff hopes alive against struggling LSG

LUCKNOW, May 22: Punjab Kings will need something spectacular to arrest a disastrous slide and keep their fading playoff hopes alive when they take on already-eliminated Lucknow Super Giants, in their IPL clash, here on Saturday.

Punjab's campaign has unravelled dramatically since their record 265-run chase against Delhi Capitals on April 25.

From remaining unbeaten till the midway stage and looking like genuine title contenders with six wins in seven matches, the last season's runners-up have crashed to six successive defeats, leaving their playoff hopes hanging by a thread.

Now placed fifth, Punjab not only need to beat LSG in their final league game here on Saturday but also depend on Sunday's double headers (MI vs RR and KKR vs DC) to earn a place in the playoff.

The Shreyas Iyer-led side would hope both Mumbai Indians and Kolkata Knight Riders lose their respective matches.

A Rajasthan Royals win over Mumbai would officially end Punjab's hopes, while a KKR victory over Delhi Capitals could bring net run rate into play. At present, PBKS hold a slight edge in NRR over KKR.

But before permutations come into the picture, Punjab first need to rediscover their form after a prolonged slump that has exposed flaws across departments.

Their aggressive top order of Priyansh Arya, Prabhshimran Singh and Cooper Connolly has failed to provide the explosive starts that defined the first half of their season.

Priyansh has managed just one fifty in his



last seven innings and was dismissed for a duck in the previous game, while Prabhshimran too has struggled for consistency with only one fifty in his last five innings.

Connolly has shown glimpses but has not converted starts into substantial scores.

Having remained among the leaders in run-getters' tally, captain Iyer's returns too have dipped sharply during the losing streak, crossing fifty only once in the six defeats.

The middle order, which scripted the memorable chase against Delhi, has also lost momentum, while their bowling unit has leaked runs regularly at both ends of the innings.

Fielding has further hurt their campaign, with dropped catches proving costly in crucial

moments. LSG, meanwhile, have endured a forgettable season and are out of playoff contention after managing just two wins in their last 10 matches.

They suffered a seven-wicket defeat to Rajasthan Royals in Jaipur in their previous outing, a game dominated by teenage sensation Vaibhav Sooryavanshi.

Yet, the home side would take confidence from their recent performances at the Ekana Stadium, where both they secured both their last two wins -- against Royal Challengers Bengaluru and Chennai Super Kings.

The biggest positive for LSG has been the form of Australian duo Mitchell Marsh and Josh Inglis at the top.

The pair added 109 in only 8.2 overs in the last match and will once again be crucial if LSG are to finish their campaign on a positive note in front of the home crowd.

Nicholas Pooran too would look to rediscover his touch after managing just 87 runs in his last four innings.

Skipper Rishabh Pant, who has endured a disappointing season with only one fifty so far, will also hope to end on a high. In the bowling department, it remains to be seen whether veteran pacer Mohammed Shami returns after missing the previous game.

We'll make decision in best interest of team: Simons on Dhoni

AHMEDABAD, May 22: Chennai Super Kings bowling coach Eric Simons said Mahendra Singh Dhoni alone will decide on his comeback, stressing that the veteran wicketkeeper-batter would only return if he feels fully fit and ready to contribute to the team.

Dhoni, 44, couldn't play a single game in this edition due to a leg injury but Simons said he impressed in the nets with his clean striking.

"Are you seriously asking me that question? We always are," Simons said when asked if CSK are hopeful of Dhoni's availability next year.

"I mean, honestly, he has hit the ball so well. He obviously had a leg injury, which made it very difficult for him to run, so that's why he couldn't play."

"But in terms of hitting the ball in the nets, he's hitting it as well as I've ever seen him hit it. But I keep saying this, only MS will know, and MS will make the decision about when he's ready and when he's right."

The former South Africa all-rounder said Dhoni would always prioritise the team's interest over personal milestones.

"And I tell you what, if he knows he's not, he won't play. But if he is right, he will. He'll make the decision in the best interest of the team and not for himself as an individual. (PTI)

Rashid says GT thriving by not dwelling on imperfections

AHMEDABAD, May 22: Aware of the scrutiny around Gujarat Titans' middle order, star spinner Rashid Khan said the side has succeeded this season by not dwelling on imperfections but trusting players to deliver in different situations, and adapting quickly to conditions.

GT registered a massive 89-run win over Chennai Super Kings in their last league match on Thursday to take the top two positions in the points table.

"I think every team has those little bit areas to improve and have some areas very strong. You can't be a complete 100% perfect team. Doesn't matter how good a player you will have ... throughout the tournament there has been lots of discussion about our middle order and things like that but I feel everyone is stepping up," he said.

"Everyone is taking the responsibility and I feel like that's so important. If you keep thinking about those 10% or 15% you are not accurate, it's going to affect the rest of 70-75 or 80%."

"For us the thing is that we just keep the thing simple. Whoever the opposition is, how are we going to be more impactful whoever gets the opportunity in the middle. Either you bat, bowl or field. So don't much think about where we weak, where we strong. Think about what is in front of me and how I can do better for the team."



Rashid heaped praise on the bowlers for their consistent effort this season.

"The wicket didn't change. I think the bowling attack we have, especially the fast bowling unit we have, we have done a really great job throughout the tournament," Rashid said.

"And I feel like on this wicket, if you hit the right area consistently with a good pace, there is something for the bowler. While putting score on the board, you just don't go with the flow, you just see the condition first and then you try to play accordingly."

The Afghanistan leg-spinner said Gujarat's biggest strength has been their ability to read conditions faster than the opposition.

"I think that's the kind of main strength which remains for us throughout the competition, that we adjust ourselves with the condition very quickly as a bowling unit and also as a batting unit."

"So I feel like we adjusted ourselves with the condition and the wicket quicker than them and I think that's the reason behind we

won again," he said.

Reflecting on the challenges of bowling in high-scoring games, Rashid said modern-day T20 cricket demands aggressive thinking from bowlers even under pressure.

"In this game, when you're defending 230, you will go for runs. It's not something like you're going to be still bowling 18 to 20 dot balls," he said.

"But I feel like for you as a bowler, one thing remains, how I'm going to make it super hard and tough for him to hit that ball for a boundary," he added.

Rashid also spoke about dealing with difficult phases in his career, including a forgettable outing in 2019 when he conceded over 100 runs in a first-class innings.

"Well, I think in life you have good days and bad days and you have to know how to manage yourself in bad days as well," he said.

"And if you keep doing well and don't have any bad day, I don't think you're going to learn a lot," he added.

The 27-year-old said he focuses more on execution and consistency than match results, revealing that he regularly studies his pitching maps after games to assess his performance.

"Every game I play, I ask the video analyst to send me the pitching map and I see where I pitched maximum deliveries and what I can do better," Rashid said. (PTI)

PCB removes long-serving physio Cliffe Deacon

LAHORE, May 22: The Pakistan Cricket Board (PCB) has parted ways with long-serving team physiotherapist Cliffe Deacon, appointing Iftikhar in his place for the upcoming home ODI series against Australia.

Deacon, a South African who had been with the national side since 2017, apparently did not return with the Test squad from Bangladesh.

On Friday, the PCB named Iftikhar (one name given by PCB) as the physiotherapist for the Australia series, though it did not officially state the reasons behind Deacon's exit.

Sources claim his tenure came to a close over recurring injury issues among players.

The source said PCB was not happy with some players pulling out late from matches and series due to injuries. The board was also concerned that some players had managed to conceal fitness issues.

"Dr Javed Mughal who is now an important member of the PCB's medical and sports medicine team also gave a detailed brief to the board on the national team's support staff performance and requirements," the source said.

Deacon, a former first class player in South Africa, joined the national team's support staff back in 2017. (PTI)

Net bowlers: The unseen architects of IPL batting fireworks

NEW DELHI, May 22: The towering sixes, audacious scoops and last-over carnage that define the Indian Premier League are often rehearsed far from the television glare, shaped by an invisible workforce that rarely gets acknowledged -- the net bowlers.

While franchise superstars command crowds and dominate headlines, an army of largely anonymous young pacers and spinners spend weeks hurling deliveries in practice nets and serving as crucial sparring partners in one of cricket's most lucrative leagues.

For many, it is cricket's most unusual apprenticeship: bowling relentlessly to the biggest names in the game, often being asked to imitate Jasprit Bumrah's yorkers, Sunil Narine's mystery spin, or Mitchell Starc's left-arm thunderbolts -- all for daily allowances that are modest by IPL standards but invaluable as a career. Their only dream is wearing a franchise jersey instead of carrying drinks and spare balls.

IPL franchises usually keep around three to five specialist net bowlers with them, apart from the local bowlers arranged by host state associations and clubs at different venues. Their earnings are modest by IPL standards -- generally about ₹ 5,000 to 7,000 per day spent at the nets -- but the exposure is priceless.

"For me, bowling in the nets has never been about money. It is the rare opportunity to bowl to such great batsmen and to gain experience. That is the biggest incentive, and that is what matters," says pacer J.V. Karthik, a net bowler from Karnataka.

For many of them, the real payment lies elsewhere: a conversation with a senior India player, a technical tip from a renowned bowling coach, or simply the opportunity to test themselves against elite batters.

And in the IPL, fortunes can change all of a sudden. The lanky Gurnoor Brar, who was recently included in India's team for the one-off Test against Afghanistan, stands out as a classic example.

First summoned at Punjab Kings nets and



later signed by the franchise once Shikhar Dhawan, the then skipper, got impressed with bounce he generated from that 6 feet 5 inch frame. He played one game for PBKS but word spread and for the next year he became a regular Team India net bowler. Harshit Rana, another India pacer, started as a net bowler before forcing his way to the national team.

Chetan Sakariya also has a similar back story.

Before becoming an India international, the left-arm pacer spent time as a net bowler with franchises such as Mumbai Indians and Rajasthan Royals, quietly trying to catch the attention of coaches and scouts.

"I was trained at nets of both MI and RR. But it was an amazing moment for me when Royals picked me up in the auction," Sakariya recalled about the 2021 IPL auction where Rajasthan signed him for ₹ 1.2 crore.

"I never expected that. I was a bit nervous too because the Royals is a big team with a lot of big stars. I was in awe to see the likes of Kumar Sangakkara, Sanju Samson, Ben Stokes, Jos Buttler, and David Miller," he said.

"The happiest moment was when they handed me the debut cap in their first match of the season against Punjab Kings and for-

tunately I performed well," Sakariya said, recalling his memorable debut spell of 3/31.

Sakariya's journey is now part of IPL folklore, but he is hardly the only one.

Umran Malik first impressed at the nets of Sunrisers Hyderabad during the 2021 season in Dubai before joining the squad as a Covid-19 replacement for injured India pacer T Natarajan.

Left-arm spinner Kumar Kartikeya was initially a net bowler for Mumbai Indians before earning a mid-season contract in 2022 as a replacement for injured player Arshad Khan. Akash Madhwal was another net bowler at both RCB and MI and later got a Mumbai Indians contract.

Most net bowlers do not travel regularly with teams through the season. Franchises typically rely on local bowlers arranged by state associations whenever the tournament moves cities. Only in exceptional situations -- especially when injury concerns emerge in the main squad -- do net bowlers sometimes travel with the team and find themselves closer to a possible breakthrough.

Selection into these roles is hardly accidental. Performances in BCCI domestic tournaments such as the Syed Mushtaq Ali Trophy, impressive outings in state leagues and rec-

ommendations from scouts often determine who gets a chance.

Biju George, KKR Head Scout and renowned fielding coach, explained the selection process for net bowlers.

"We track players during various state premier leagues, and we have around 19 state leagues running in the country. Once we find a bowler who has good pace, variations and temperament, we pass the information to the team's coaching staff. They will be then invited for trials," he said.

"In the trials, we put them in match situations to further assess their skills. If the management thinks a particular player suits their needs then the team will acquire him in the auction. But a couple of others will stay with the team as net bowlers for the rest of the season," he added.

And in the IPL ecosystem, one opportunity can change everything overnight.

For Karnataka pacer JV Karthik, a single net session with Mumbai Indians in 2023 remains among the defining experiences of his cricketing life.

"Back in 2023, I had a chance to bowl to Mumbai Indians team at nets. It was the first time I bowled to players like Rohit Sharma, Suryakumar Yadav, Tim David and some others," Karthik said. What struck Karthik most was not merely the quality of the batters, but their professionalism and humility.

"They were all very special batsmen, and we understood why they play international cricket for such a long time. I think I bowled for about 20-30 minutes and later after the nets they were happy to pose for some photos for us and I got signs of Rohit and Suryakumar on the ball that I bowled to them."

Such moments become treasured possessions for these young bowlers -- reminders that the distance between obscurity and recognition may not be as vast as it seems.

And even when the cameras ignore them, they continue to observe closely -- how international stars train, recover, analyse conditions and prepare mentally. (PTI)

Batting with Kohli made a big difference in my growth, says Devdutt Padikkal

BENGALURU, May 22: Royal Challengers Bengaluru batter Devdutt Padikkal says opening alongside Virat Kohli in his debut IPL season helped him understand the art of constructing an innings, a lesson that continues to shape his approach in T20 cricket.

Padikkal, who burst onto the scene with Royal Challengers Bengaluru in the 2020 IPL, said watching Kohli operate from close quarters gave him invaluable insight early in his career.

"When I made my IPL debut with RCB in the 2020 season, I felt ready. I had a solid run of scores in domestic cricket behind me," Padikkal said during an interaction on JioStar.

"And batting with Virat Kohli, one of the greatest in the game, was a huge help. At that age, watching him build an innings gave me so much clarity and understanding of how to construct a knock. That made a big difference in my growth," he added.

The Karnataka batter said his subsequent stints with Rajasthan Royals and Lucknow Super Giants, where he batted in multiple positions, broadened his understanding of the game.

"Moving from being a dedicated opener to batting in different positions lower down the order was challenging, especially at a young age. But those experiences with Rajasthan Royals and Lucknow Super Giants shaped me into the player I am today," he said.

"Batting at different numbers taught me how to read situations, construct innings under pressure, and adapt my game."

Padikkal admitted the 2024 IPL season tested him mentally, but said the difficult phase eventually became a turning point in his career.

"The 2024 IPL season was a tough one. Bouncing back from a difficult season is never easy. During that season, a lot was going on in my head," he said.

"You must go through the phase, accept it, and figure out how to come out better. Once the season ended, I knew exactly what I had to work on."

The left-hander credited RCB mentor Dinesh Karthik and head coach Andy Flower for helping him tweak both his technique and mindset after his return to RCB.

"I made several changes to my batting technique with the help of Dinesh Karthik and Andy Flower. I needed to adjust a few things to shift from red-ball to white-ball cricket," he said.

"Mentally, I had to bring more intent into my game. I needed to go out with the mindset of looking to score off every ball. Once I did that, the results started showing."

Padikkal said RCB's batting depth has allowed top-order players to attack more freely in an evolving T20 landscape.

"Having a powerful and deep batting lineup at RCB is a luxury. When you know the batting order is strong all the way down, it gives you extra confidence to play freely at the top," he said. (PTI)
