Unlocking Northeast: EU eyes long-term economic partnership

EU delegation to visit Assam for 2 days from today

GUWAHATI, June 7: A high-level delegation of the European Union will be on a two-day visit to Assam from Monday to explore collaboration opportunities between Europe and the North Eastern states of India, officials said.

The tour of the EU delegation will be in line with the priorities set in the joint Comprehensive Strategic Agenda agreed between the EU and India at their summit last January, the European External Action Service (EEAS) said in a statement.

The team will comprise ambassadors and senior representatives from EU member states, including Herve Delphin, Ambassador of the European Union to India and Bhutan, alongside business representatives, the officials said.

"The visit will focus on value chains across sectors where Europe and the state of Assam and the region as a whole share strong synergies, including renewable and



green energy, sustainable urban infrastructure, healthcare and pharmaceuticals, semiconductors and electronics manufacturing, tea and agri-food processing, flavours and fragrances, and AYUSH," the statement added.

Welcoming the delegation, Assam Chief Minister Himanta Biswa Sarma, in a post on X, said

that the visit of the EU delegation to the state marks an important chapter for a stronger Indo-EU relation, deeper trade ties and shared progress.

"With Assam's growing strength in agriculture, tea, technology, energy, manufacturing and innovation, this engagement will open new doors for investment, jobs and

cross-border collaboration," he said.

The visit will also see the launch of Assam's first 'Blue Valley Cluster', a new industrial hub focused on fragrances, flavours, AYUSH and food processing, the EEAS said.

"This 4P (public-private-people-partnership) cluster will seek to connect Europe, Northeast India and Bhutan, promoting innovation, research, sustainable manufacturing and business collaborations. This pilot project, led by the Assam government, is aligned with the Blue Valleys initiative which was introduced at the 2026 EU-India Summit," it added.

During the visit, the 'Team Europe Ambassadors' will engage in a bilateral meeting with Assam Chief Minister Himanta Biswa Sarma, while a delegation led by the Federation of European Businesses in India (FEBI) will hold discussions (CONTD. ON PAGE 2)

154 mobile towers sanctioned under DBN Scheme for Karbi Anglong

DIPHU, June 7: In a major boost to digital connectivity in Karbi Anglong, 154 new mobile tower sites have been sanctioned under the Government of India's Digital Bharat Nidhi (DBN) 4G Saturation Scheme to provide reliable mobile network coverage in remote and underserved areas of the district.

Sharing the information, Chief Executive Member (CEM) of the Karbi Anglong Autonomous Council (KAAC), Tuliram Ronghang, described the development as a significant milestone in addressing one of the long-standing demands of people living in remote villages.

Ronghang said that during his visits to rural and interior areas, the lack of dependable mobile connectivity remained one of the most common concerns raised by residents. The absence of communication



infrastructure has posed challenges for students, farmers, patients, entrepreneurs and the general public in accessing essential services and opportunities.

The sanctioned towers are part of the Centre's Digital Bharat Nidhi 4G Saturation Scheme, aimed at extending mobile connectivity to villages and habitations where telecom service

providers have found it commercially unviable to establish networks.

The programme is being implemented by the Department of Telecommunications.

Meghalaya village protests India-Bangladesh border fence alignment, fears isolation

PNYURSULA (MEGHALAYA), June 7: Residents of a village along the India-Bangladesh border in Meghalaya held a demonstration on Sunday demanding that the fencing be done along the zero line, else they would get isolated from the rest of the country.

Located virtually on the zero line in Meghalaya's East Khasi Hills district, Lyngkhong is one of the few villages where homes stand just metres from a settlement in Bangladesh. According to international convention, fencing has to be at least 150 yards from the zero line.

Locals say the village had been separated from Bangladesh largely by a bamboo fence erected by villagers during the COVID-19 pandemic, and nothing has changed much.

On Sunday, they staged a protest and submitted a memorandum to the sub-divisional officer (SDO) of Pynursula, seeking an immediate halt to the ongoing fencing work.

"We are not against border fencing, but we want the fence to be



erected at the zero line so that our village remains inside India and within the fenced area," village head Ramu told PTI.

He said the proposed alignment would leave Lyngkhong outside the security barrier, raising concerns about access, security and the future of the settlement.

Echoing similar concerns, Rima Khongdir, a local, said, "If the fence comes up in its present alignment, our village will be left out-

side. We are worried about our future and want the state government to listen to our concerns and take them up with the Government of India."

Officials said construction of the border fence is continuing as part of efforts to secure the India-Bangladesh frontier.

Meghalaya has a 444 km border with Bangladesh, less than 80 km of which remains unfenced due to local (CONTD. ON PAGE 2)

Shah to launch advanced Land Port Management System for smart borders

NEW DELHI, June 7: Union Home Minister Amit Shah will launch the Land Port Management System (LPMS) on Tuesday, a digital platform designed to integrate operations across Land Ports into a unified system.

Shah will also inaugurate newly developed stakeholder accommodation facilities at the Dawki (Meghalaya) and Srimantapur (Tripura) Land Ports, a government statement said.

The LPMS will facilitate seamless coordination among various stakeholders, including government agencies and private operators, thereby reducing delays and enhancing operational efficiency, it said.

The system will provide secure end-to-end digital workflows for cargo and passenger processing, including slot booking, payments, tracking, and single-window clearances.

"Fully integrated with key national platforms such as ICE-GATE, ULIP, and the motor vehicle ecosystem, LPMS will en-

able interoperable, efficient, and transparent border management," a statement from the Home Ministry said.

The platform enables secure, real-time exchange of logistics and regulatory information, bringing land ports to the same standard as digital systems operational at airports and seaports, the statement said.

"This initiative underscores the Narendra Modi government's commitment to smart border management, enhancing efficiency, transparency, and security in cross-border trade and passenger movement through technology-driven solutions," the ministry said.

"The system is a state-of-the-art digital platform designed to integrate operations across Land Ports into a unified system," it said.

The system will be a modern, technology-enabled smart border management system, reflecting the nation's strategic focus on strengthening trade facilitation, connectivity, and national security and Viksit Bharat, it said. (PTI)

Two Nagaon women declared foreigners, shifted to transit camp in Goalpara

NAGAON, June 7: Two women from Assam's Nagaon district have been declared foreigners and sent to a detention centre, now called a transit camp, in Goalpara district, officials said on Sunday.

The two women -- Jahanara Begum of Bagarigori village and Mamta Begum of Dagaon -- have claimed Indian citizenship, but were unable to produce documents such as educational and birth certificates as legacy documents, instead of village headmen's testimonials, despite having valid documents of their parents, officials said.

Advocate Zahidul Hoque, appearing for Jahanara, told PTI that the two were first declared foreigners by the Juria Foreigners Tribunal (FT) (CONTD. ON PAGE 2)

Nepal backs bilateral path with India to resolve border row

NEW DELHI, June 7: Nepal wants to resolve its border dispute with India through existing bilateral mechanisms as "no problem is too large and complex" when both sides meet with an open heart, rational mind and mutual respect, Nepalese Foreign Minister Shishir Khanal said on Sunday, effectively endorsing New Delhi's rejection of any third-party involvement.

Khanal said Kathmandu refuses to see New Delhi through the "distorted, hyper-sensitive lens" of 21st-century geopolitics and instead aims to look at India with "clear eyes and a single transparent agenda of economic transformation of Nepal".

The Nepalese foreign minister was speaking to the media a day after holding wide-ranging talks with his Indian counterpart S Jais-

hankar that focused on ways to further expand ties in diverse sectors, including trade, critical technology, connectivity and energy.

His three-day trip to New Delhi from Friday came against the backdrop of a raging controversy triggered by Nepalese Prime Minister Balendra Shah's recent remarks on the boundary row between the two sides. Shah had also suggested the involvement of China and the UK to resolve the issue.

The Nepalese foreign minister, acknowledging India's transformation into a rapidly growing global economic and technological powerhouse, expressed Nepal's desire to engage with this "dynamic neighbour" by contributing its own aspiring energy to the partnership.

"Our primary responsibility is to

close the gap between bold promises made on paper and the physical reality delivered on the ground, transitioning away from abstract political statements to deliver measurable, life-changing results," he said.

Khanal added: "Let us build a partnership that is not constrained by the anxieties of the past, but one that is fuelled by the high hopes and promising prospects of our shared future."

The Nepalese foreign minister, referring to the border issue, said "true interdependence" means shared borders act as "highly efficient bridges, not frustrating barriers".

'Push-in' issue to feature in upcoming BGB-BSF talks: Bangladesh

DHAKA, June 7: Bangladesh said on Sunday that the issues of alleged "push-ins" by India and border killings will be discussed at an upcoming meeting between the heads of the two countries' border guarding forces.

The 57th edition of the bi-annual Director General-level border coordination conference between the Border Security Force (BSF) and Border Guard Bangladesh (BGB) will be held in New Delhi between June 8 and 11.

"The situation on the frontier, bilateral cooperation and particularly the issue of illegal push-ins will be placed with importance (by BGB)," Home Minister Salahuddin Ahmed told reporters at his office.

India maintains that "only illegal intruders" are pushed into Bangladesh following due procedures.

New Delhi says its policy is that "all illegal foreign nationals staying in India must be repatriated as per our laws, procedure and established bilateral arrangements."

Last month, responding to a remark by a Bangladeshi minister on the issue of "push-ins", Min-

istry of External Affairs spokesperson Randhir Jaiswal said, "We expect Bangladesh to expedite nationality verification so that repatriation of illegal immigrants can take place in a smooth manner."

At the four-day conference starting Monday, the Bangladeshi delegation will be led by BGB chief Major General Mohammad Ashrafuzzaman Siddiqui while the Indian team will be headed by BSF DG Praveen Kumar.

The conference comes as BGB intensified vigil along its frontiers with India to halt what it calls "illegal push-in" attempts in recent weeks.

"Our BGB men remain on high alert along the frontier. Any attempt of illegal push-ins or unlawful border crossings will be firmly resisted," the state-run BSS news agency quoted Ahmed as saying.

The term "push-in" is typically used to describe the action of people, believed to be illegal migrants, being forcefully sent across borders. Countries that send them back often use the term "pushback".

Park aims to reverse loss of over 60 per cent of its grasslands as conservation programme seeks to rebuild a thriving wild pygmy hog population by 2040

Manas launches Assam's first grass nursery, releases 15 pygmy hogs into restored habitat

GUWAHATI/KOKRAJHAR, June 7: In a major step towards restoring Assam's endangered grassland ecosystems, Manas National Park and Tiger Reserve (MNPTTR) on Sunday inaugurated the state's first dedicated grass nursery and released 15 captive-bred pygmy hogs into the Kuribeel grasslands under the Pygmy Hog Conservation Programme (PHCP).

The twin initiatives mark significant milestones in conservation efforts at Manas, which has lost more than 60 per cent of its historical grassland cover over the past 35 years.

According to park authorities, grasslands that covered around 384 sq km, or 45 per cent of the landscape in 1990, have declined to approximately 155 sq km, accounting for just 18 per cent of the area today.

The grass nursery, developed over 7.5 bigha (around one hectare) at the Bansbari Range with financial assistance from CAMPA, will serve as a long-term source

of native grass species for restoration projects across Manas and other protected areas of Assam.

Officials said 16 species of indigenous grasses collected from different habitats within Manas have been raised in specially prepared nursery beds since November 2025.

The facility is expected to play a key role in habitat restoration, invasive species management and recovery of wildlife habitats.

"These grasslands are the ecological backbone of Manas and support globally threatened species such as the pygmy hog, Bengal florican, hispid hare, one-horned rhinoceros, wild water buffalo, swamp deer, Asian elephant and tiger," park authorities said.

Principal Chief Conservator of Forests (Wildlife) and Chief Wildlife Warden of Assam, Dr Vinay Gupta, described grassland restoration as one of the highest conservation priorities for Manas.

"The newly established grass nursery



will ensure a sustainable supply of native grass species required for habitat restoration, invasive species management and recovery of critical wildlife habitats," he said.

The occasion also witnessed the release of 15 captive-bred pygmy hogs, including nine females and six males, into the Kuribeel grasslands.

The pygmy hog (*Porcula salvania*), the

world's smallest and rarest wild pig, remains one of the most endangered mammals globally.

The release is particularly significant as Kuribeel is the same site from where six pygmy hogs were taken into captivity in 1996 to establish a breeding population against extinction.

With no confirmed signs of pygmy hogs in the area for the last nine years, conservationists described the reintroduction as a major step in restoring the species to its historical habitat.

"This release marks a true homecoming for the pygmy hog," officials said.

Dr Gupta termed the reintroduction a remarkable conservation achievement and expressed hope that Manas would eventually support a stable and self-sustaining pygmy hog population.

Additional PCCF and Chief of Habitat Development, BTC, Suman Mohapatra, said the return of the pygmy hog reflected the success of habitat restoration and collaborative conservation efforts undertaken

in the landscape.

This is the sixth release of pygmy hogs into Manas since 2020, taking the total number released in the park to 78.

Over the next five years, the PHCP plans to release around 80 more pygmy hogs with the goal of rebuilding a thriving wild population of approximately 300 animals by 2040.

The PHCP, a collaborative initiative involving the Assam Forest Department, Durrell Wildlife Conservation Trust, the IUCN SSC Wild Pig Specialist Group, Ecosystems-India and Aaranyak, has played a crucial role in rescuing the species from the brink of extinction after it was feared extinct during the 1970s.

Since its inception, the programme has successfully bred and reintroduced 194 pygmy hogs in Assam. Conservationists estimate that the reintroduced population may now exceed the species' current global wild population for the first time since the programme began. Highlighting the ecological (CONTD. LPG PRICE HIKE

Govt says rates in India among world's lowest despite 46 pc jump in global benchmark

NEW DELHI, June 7: Indian households continue to pay among the lowest prices for cooking gas globally despite a sharp rise in international LPG prices triggered by disruptions in West Asia, the government said on Sunday, a day after increasing domestic LPG prices by ₹ 29 per cylinder.

The price of a 14.2-kg domestic LPG cylinder in Delhi was raised to ₹ 942 from ₹ 913, while beneficiaries of the Pradhan Mantri Ujjwala Yojana (PMUY) will continue to pay an effective ₹ 642 per cylinder after receiving a subsidy of ₹ 300 per refill on the first four refills annually, down from 9 refills announced last year.

The increase follows a ₹ 60-per-cylinder hike on March 7, taking the cumulative hike to ₹ 89 per 14.2-kg cylinder. State-run oil marketing companies were estimated to be losing about ₹ 703 on every LPG cylinder sold before the latest revision.

In a statement, the government said the cost of supplying a domestic LPG cylinder has risen to more than ₹ 1,600 following a surge in international prices that followed the outbreak of war in West Asia at the end of February. India's LPG import costs are linked to the Saudi Contract Price (CP), the global benchmark for the fuel. The benchmark has risen after 46 per cent since February after disruptions linked to the Strait of Hormuz tightened supplies from the Gulf region, according to the statement.

Despite the increase, domestic LPG prices remain below those prevailing in neighbouring countries such as Pakistan, Nepal, Bangladesh, and Sri Lanka, and significantly lower than prices in advanced economies, including the United States, Australia, and Canada, the government said.

The government also said India was among the few countries able to maintain uninterrupted energy shipments through the Strait of Hormuz during the crisis, ensuring there was no shortage of LPG or other petroleum products in the country. Domestic LPG production was increased and supplies diversified through alternative sourcing



arrangements to safeguard availability, it added.

According to the statement, cumulative under-recoveries on domestic LPG sales rose to about ₹ 60,000 crore by the end of the previous financial year, compared with ₹ 41,338 crore a year earlier. The Union Cabinet has approved ₹ 30,000 crore in compensation to state-run oil marketing companies to partly offset these losses.

The government said the latest revision balances the need to shield households from volatile global energy prices while ensuring continued availability of cooking fuel across the country.

"The prices of petroleum products in India are linked to the corresponding prices in the international market. The government, however, continues to modulate the effective price to the consumer for domestic LPG. Any household can buy as many cylinders as it needs at ₹ 942," the statement said.

"A PMUY beneficiary will additionally receive the direct benefit transfer of ₹ 300 a cylinder on the first four refills each year -- broadly the average annual consumption of a typical Ujjwala household, about four refills a year -- and so pays an effective ₹ 642 on those refills; this support is unchanged."

Even a non-PMUY household would pay about ₹ 700 below the market-linked cost of the cylinder.

Retail prices differ marginally across locations on account of distribution costs.

"What the household does not

bear the brunt of is the several hundred rupees a cylinder which the government is bearing. Through a period of sharp international cost increases, that burden has been absorbed upstream rather than passed to the consumer," it said.

While the commercial cylinder used by hotels and businesses is revised automatically every month because its price is a direct pass-through of the international benchmark, the domestic cooking cylinder is not.

"India used to import 60 per cent of its LPG requirements, and the landed cost of that import tracks the Saudi Contract Price (CP) that Saudi Aramco sets at the start of each month. This is an external price over which the Indian consumer has no control," the government said.

Through the West Asia disruption the benchmark moved sharply higher. "Expressed as the 50:50 propane-butane blend used for India's LPG, the Saudi CP for LPG stood at about USD 543 a tonne in February, before the disruption. Following the closure of the Strait of Hormuz in late February, the April contract price -- the first set after the disruption tightened Mideast Gulf exports -- rose to USD 775 a tonne, with propane at USD 750 and butane at USD 800, and has since edged up further to USD 790 a tonne in June."

The blended LPG benchmark has thus risen by about 46 per cent since the pre-crisis February level, the statement said.

"The scale of this is visible in the fully market-priced commercial cylinder: the 19 kg cylinder used by hotels and restaurants sells in Delhi at ₹ 3,113.50, about ₹ 164 a kg, after five increases during the West Asia crisis. The domestic household, by contrast, pays about ₹ 66 a kg after the revision," it said.

"Commercial gas carries a higher rate of tax and larger margins, so it sits above the household's cost-reflective level; even so, the import-linked cost of a domestic cylinder works out to over ₹ 1,600."

The government said it maintained uninterrupted supplies of LPG and other petroleum products despite disruptions in the Strait of Hormuz, a key shipping route through which 54 per cent of India's LPG imports are transported. Domestic LPG production was increased by more than 60 per cent -- from about 32,000 tonnes a day to about 52,000 tonnes -- imports were diversified to suppliers, including the United States, Canada and Algeria, and ensured continued movement of LPG cargoes to Indian ports, preventing shortages in the domestic market.

To conserve supplies, consumers were encouraged to switch to piped natural gas where available, while enforcement against diversion of subsidised LPG cylinders to commercial use was stepped up through wider use of OTP-based delivery verification. The government said these measures helped sustain household supplies during a period of heightened geopolitical tensions and supply-chain disruptions.

"The under-recovery is separate from the subsidy: the gap between the international cost and the regulated retail price -- an estimated amount rising towards ₹ 60,000 crore on domestic LPG in the last full year, up from ₹ 41,338 crore the year before -- is borne by the public sector marketing companies and the exchequer, against which the Union Cabinet has approved ₹ 30,000 crore in compensation; over and above this, Ujjwala consumers receive an additional ₹ 300 per cylinder credited directly to their bank account, reaching more than 10.58 crore connections," the statement added. with state officials to identify trade and investment opportunities. Commenting on the visit, Delphin said, "Northeast India and Assam at its core has enormous potential -- its resources, its skilled workforce and is already one of the fastest growing regions of India by GDP."

While the general contours to strengthen the EU-India ties have been finalised at the EU-India summit, it will have to take roots at the state level, he added. "The EU has a long-standing engagement with Assam, and we are encouraged by the advancements we're seeing through initiatives like the Blue Valley," Delphin said.

Assam presently stands at a pivotal moment in history, and the state's strategic location as a gateway to South East Asia makes it well placed to attract EU's support in green growth, sustainable industries, skill development and technology-led transformation, the CM said. This visit will also help Assam connect more deeply with European expertise in renewable energy, semiconductors, food processing, education, healthcare and advanced manufacturing, he said. "The outcomes of this visit, I am certain, will aid local enterprises, spur opportunities for youth and enhance Assam's role in India's Act East Policy and global outreach," he added.

In addition to meetings and the Blue Valley event, the delegation will visit Tata Electronics' new semiconductor plant, showcasing Assam's growing role in high-tech manufacturing.

"This visit also highlights the importance of EU-India digital partnership under the EU-India Trade and Technology Council (TTC) and will give European investors a closer look at Assam's business environment, infrastructure and industry potential," the EEAS said. The delegation's programmes in Assam signal a new chapter in EU-India collaboration, with a shared vision to unlock the Northeast's economic potential through innovation, sustainability and inclusive growth, it added. in 2019. "After that, separate petitions were filed in the Gauhati High Court challenging the FT verdict. The HC, in its order on April 24, sent the cases back to the Juria FT for review," he said.

Later, the FT declared them foreigners despite having valid documents of their families, as they could not provide linkage documents, Hoque said. "They were then sent to the transit camp by the authorities last week. We are now evaluating all legal options," he added.

The case against Jahanara was registered in 2016 by the FT, while that of Mamta was filed in 2015.

"The cause of their rejection is non-furnishing of valid documents instead of the village headmen's certificates. They have no birth certificates, and due to illiteracy, they also have no educational certificates, too," Hoque said. The FT declared the duo foreigners after rejecting their village headmen's certificates, he added.

Meanwhile, the Sadao Asom Gramin Shramik Santha (SAGSS) and Ganatantra Suraksha Mancha (GSM) have alleged that the FT sent both the "Indian citizens" to the transit camp after "ignoring the Gauhati High Court's ruling". The HC, in its order, had said the FT judgment of 2019 was given without proper discussion of the evidence in the documents, Hoque said. "Therefore, the judgment was quashed, and the matter was sent back to Juria FT for reconsideration. The petitioners were also directed to appear before the designated Juria FT with a certified copy of the HC order and submit necessary documents," he added.

He further alleged that the Tribunal did not conduct a detailed hearing before passing the fresh order declaring the two women foreigners and directing them to be sent to the transit camp in Goalpara. (PTI)

Nepal backs bilateral

consistently maintained that the territories are part of Uttarakhand. Late last month, Nepalese Prime Minister Shah sought involvement of China and the United Kingdom to address the long-standing border dispute between India and Nepal. Days later, New Delhi categorically rejected any role for third parties to resolve the row.

The Nepalese foreign minister said the involvement of the UK was meant in the context of availing documents and historical details from British libraries and museums. "We want to solve our disputes through diplomatic processes. We just want to see if we can access some of the documents that might be in libraries or museums in the UK. Our position was not that we were asking for mediation," he said.

"Rather than engaging in hyper-nationalistic grandstanding, we are pursuing calm, data-driven and evidence-based discussions to resolve challenges in good faith," the Nepalese foreign minister said.

Khanal said the year 2026 has provided the "most conducive, highly aligned window" for the two countries in decades to completely "elevate and transform" their relations. "No problem is too large, and no boundary too complex, when we sit down with an open heart, a rational mind and mutual respect," he said.

Asked about Nepal's objection to the Kailash Mansarovar Yatra through the Lipulekh region, Khanal said Kathmandu's concerns stemmed from the understanding between India and China to use the route for the pilgrimage without consulting Nepal, claiming that the area belongs to his country. "Our concerns are with the renewal of the agreement between India and China over the Kalapani and Lipulekh area, where we have said for a very long time that the land belongs to us, and without Nepal's consent, the two countries by themselves cannot make those agreements," he said. "And we've made that very clearly known through our communication, including diplomatic notes to both countries," he said. At the same time, the Nepalese foreign minister asserted that Nepal seeks resolution of the issue with India through existing bilateral mechanisms. Khanal said the new government in Nepal has a strong desire to deepen ties with India. "When we look across the border, we see a rising India -- an India that has fundamentally and beautifully redefined itself on the global stage as a dynamic, fast-growing tech and economic powerhouse," he said. "We want to engage with this India of intense aspiration, cutting-edge technology, and relentless execution. In turn, we bring the energy of an aspiring Nepal," he said. Khanal also elaborated on historical India-Nepal ties, saying the people of the two nations are the children of the same rivers, the same mountains, and the same ancient wisdom. "Every time on the journey from Kathmandu to New Delhi, looking down at the majestic Himalayas yielding to the vast, fertile plains of the Gangetic basin, I am reminded of a profound truth," he said. "We are not merely neighbours joined by political lines drawn on a map; we are the children of the same rivers, the same mountains, and the same ancient wisdom," he said.

The Nepalese foreign minister refused to give a direct reply when asked about the youth-led "Gen Z" protests in Nepal in September 2025 and the Cockerroach Janta Party's protest in New Delhi on Saturday.

"There was a movement back in September and the political transition that took place brought us to power. I would not want to comment on what's happening in India," he said. Asked about the report of the Eminent Persons Group (EPG), Khanal said it was commissioned under an understanding of the prime ministers of the two countries. "The (EPG) report can only be submitted to the two prime ministers. I have no authority to make that public, accept or do anything," he said. Formed in January 2016, the EPG was tasked with reviewing the agreements and treaties between the two sides, including the Nepal-India Friendship Treaty of 1950. (PTI)

Flipkart launches EV assist to accelerate electric mobility adoption among delivery partners

GUWAHATI, June 7: Flipkart has launched EV Assist, a digital marketplace aimed at simplifying access to electric vehicles (EVs) for its delivery executives, known as Wishmasters.

The platform is currently available for Flipkart Minutes riders across more than 20 cities and forms part of the company's broader commitment to electrifying its last-mile delivery fleet under the EV100 initiative.

The launch comes as Flipkart's EV fleet continues to expand rapidly, having crossed 20,000 vehicles during the 2025 festive season.

Through EV Assist, the company seeks to address key barriers to EV adoption, including affordability, vehicle ownership and access to reliable rental services.

The platform brings together verified EV fleet and rental providers, allowing delivery partners to browse electric two-wheeler options based on their city and budget. Wishmasters can compare rental plans, register their interest with minimal documentation and connect directly with mobility providers for vehicle allocation and onboarding.

According to Flipkart, the initiative has already generated strong interest among delivery partners, with Delhi NCR, Patna and Bengaluru emerging as leading markets. A recent Flipkart study involving more than 6,000 delivery partners found that nearly 46 per cent are willing to switch to electric mobility, although challenges related to financing, charging infrastructure and confidence in the EV ecosystem continue to hinder adoption.

The study also revealed that around 90 per cent of de-

livery partners spend between ₹2,000 and ₹5,000 per month on petrol.

Industry estimates indicate that electric two-wheelers can reduce fuel and energy expenses by up to 70-80 per cent, while lower maintenance costs can improve delivery partners' earnings by 15-20 per cent.

To improve accessibility, EV Assist is available in multiple languages, including English, Hindi, Bengali and Kannada. Mobility partners associated with the platform also provide vehicle servicing, maintenance and operational support.

The EVs come equipped with features such as GPS tracking, IoT-enabled monitoring and geofencing technology to enhance operational efficiency and security.

Commenting on the initiative, Rajneesh Kumar, Chief Corporate Affairs Officer of Flipkart Group, said making EV adoption simple and affordable is critical to India's transition towards sustainable mobility. He added that the company is focused on building systems that enable delivery partners to adopt electric vehicles in a practical and cost-effective manner.

Beyond EV Assist, Flipkart is also working with infrastructure partners to expand charging facilities across key delivery hubs and high-density routes.

The company has additionally piloted electric trucks on mid-mile logistics routes, including NCR-Jaipur and NCR-Agra, as part of efforts to reduce emissions across its broader supply chain.

The initiative reflects Flipkart's ongoing efforts to promote sustainable logistics and support India's transition towards cleaner transportation solutions.

Bengal: Dark spots on Himsagar mangoes cast shadow on export shipment

KOLKATA, June 7: Dark spots caused by a weather-induced disease have made the shipping of Bengal's famed Himsagar mangoes overseas uncertain, exporters said.

Spotting on the surface of mangoes is caused by continuous rain during bagging and subsequent high temperatures. These spots are early signs of infection. Bagging involves covering each fruit with protective bags while still on the tree. This technique is widely used to improve the appearance of mangoes and reduce damage caused by pests and diseases.

A major fruit exporter from West Bengal's Malda said efforts to address the problem of dark spots on bagged Himsagar mangoes have failed, rendering many of the fruits unsuitable for exports or for sale through organised retail chains.

"We were supposed to send the first consignment of mangoes to the US this week. We feared dark spots on the fruits, and it has come true. Had we exported the consignment, it would have been rejected by the importer as fruits have to be free of spots, which are an early sign of disease," co-founder of Shrishti Food Products, Prasun Chitlangia, told

PTI. He attributed the problem to adverse weather conditions during the growing season.

"Continuous rain during the bagging period followed by high temperatures led to the problem. The situation is bad, we have a large number of export orders," he said.

The exporter had earlier planned to send a one-tonne consignment of Himsagar mangoes to the US as the first overseas shipment of the season from Malda. The setback comes at a time when exporters and officials had been targeting a sharp rise in mango and litchi exports from the district to more than 300 metric tonnes (MT) this season, supported by the expansion of export-oriented cultivation practices and a larger number of farmers adopting fruit bagging techniques.

Despite the dark spot problem affecting shipping prospects, Malda Mango Merchants Association president Ujjal Saha remained optimistic about the export outlook.

"There have been reports of disease in around 15 per cent of the bagged fruits. But nearly three lakh more bagged mangoes are still available and can be exported. Orders for

Himsagar mangoes continue to remain strong," Saha said.

Exporters had earlier estimated that mango exports from the district could reach 300-500 metric tonnes this season, compared to around 15 metric tonnes exported to five countries last year.

The state horticulture department and exporters have been promoting export-oriented cultivation through fruit bagging, good agricultural practices (GAP), scientific harvesting and post-harvest handling measures to improve fruit quality and meet international standards. Officials had distributed around 2.5 lakh fruit bags among growers and were monitoring 50-60 orchards following export-compliant cultivation practices.

The export basket this season was expected to include premium mango varieties such as Himsagar, Langra, Lakshman Bhog and Amrapali, besides litchis from Malda and neighbouring Murshidabad district.

Despite the disease-related setback, exporters said overseas demand for premium Malda mangoes remains robust, and efforts are continuing to identify export-worthy fruits from unaffected orchards. (PTI)

Foreign liquor retailers urge Bengal govt to revise trade margin structure

KOLKATA, June 7: Foreign liquor retailers in West Bengal have urged the state government to increase the trade margin on alcohol sales to 10 per cent of MRP, withdraw special-purpose fees imposed during the COVID-19 period and review the state's liquor distribution mechanism.

The demands were raised by the Society for the Welfare of West Bengal Foreign Liquor Licences, an association representing more than 1,000 licensed foreign liquor (FL) shops across the state, which said rising operational and compliance costs had made the current business model unsustainable.

"We demand a margin of 10 per cent. It has come down to 3.5-4 per cent, which is not sustainable," the society's secretary, Bijon Patra, told reporters here.

According to a representation submitted to the excise commissioner, the association has sought rationalisation of trade margins in view of increasing business costs. It has also demanded the removal of special-purpose fees introduced during the pandemic and a shift to a system in which the state government directly manages liquor distribution instead of the existing distributor-led arrangement. Patra said the industry body was seeking reforms that would improve the business environment for licensed FL shops and ensure their long-term sustainability. The association also called for stronger action against illicit liquor, decentralisation of licensing and administrative processes, simplification of regulatory procedures and greater transparency in the implementation of excise policies.

"Licensed foreign liquor trade is an important stakeholder in West Bengal's economy and revenue ecosystem. We believe there is significant scope for policy reforms that can benefit consumers, strengthen compliance, improve business sustainability and enhance government revenues," Patra said.

Problems in the sector began after the erstwhile TMC government allegedly replaced the traditional distributor-led model with a state-controlled distribution system.

Patra, however, declined to comment on whether the new system was prone to corruption.

The association said it was willing to work with the state government and the excise department to develop practical solutions that support both regulatory objectives and business growth. (PTI)

Dibrugarh launches eviction drive against illegal encroachments

DIBRUGARH, June 7: In a major crackdown against illegal roadside encroachments, the Dibrugarh Municipal Corporation (DMC) has launched an extensive eviction drive across various parts of the town, removing unauthorised roadside vendors and structures operating outside designated vending zones.

Among the structures demolished was a roadside stall at Graham Bazar near Tinkunia, which had recently come under public scrutiny after a raid reportedly led to the recovery of 85.240 grams of suspected cannabis (ganja) from the premises.

The stall was removed during the civic body's enforcement operation as authorities intensified efforts to reclaim public spaces and restore order on busy roads and footpaths.

The eviction drive was carried out following the expiry of a seven-day notice period issued jointly by the district administration and the Dibrugarh Municipal

Corporation, directing vendors occupying roadsides, footpaths and other public areas to shift to officially designated vending zones. Despite repeated warnings, several vendors allegedly failed to comply, prompting the authorities to initiate strict enforcement measures.

Speaking during the operation, DMC Commissioner Novas Das, ACS, said the corporation has adopted a zero-tolerance approach towards illegal encroachments that obstruct traffic movement and compromise public safety.

"Public roads, footpaths and highways are meant for commuters and pedestrians. Unauthorised occupation of these spaces creates serious inconvenience and safety hazards. The corporation is committed to ensuring that public infrastructure is used for its intended purpose," Das stated.

Municipal teams, supported by officials and law enforcement personnel, conducted the drive in multiple locations across Dibrugarh, dismantling illegal stalls and clearing encroachments that had nar-

rowed roads and obstructed pedestrian movement.

Officials said the operation is part of a broader initiative to improve urban management, ease traffic congestion, enhance pedestrian safety and maintain civic discipline within the town. Authorities also warned that similar drives will continue in the coming days and that stringent action will be taken against individuals attempting to reoccupy cleared public spaces.

The removal of the Graham Bazar stall, particularly in the wake of the recent alleged ganja recovery has drawn significant public attention and is being viewed as a strong message from the administration against both illegal encroachment and unlawful activities operating from public land.

Residents and commuters welcomed the move, expressing hope that sustained enforcement will help create a cleaner, safer and more organised urban environment in Dibrugarh.

Festival focus on value addition and global market expansion of Tezpur litchi

TEZPUR, June 7: The second day of the "Tezpur Litchi Festival 2026" drew an overwhelming crowd from the early hours of the Sunday morning, with tourists from Bengaluru, Chennai, West Bengal and Kerala joining locals from across the state to savour the celebrated fruit at the exhibition and sales venue.

The day's proceedings gained further momentum when MLA Prithiraj Rabha, District Commissioner Ananda Kumar Das, APEDA officials, District Agriculture Officer Pradeep Talukdar and Sub-Divisional Agriculture Officer Dr Zakir Hussain jointly flagged off the export of one tonne of GI-tagged Tezpur litchi to Dubai — a milestone that organisers described as a significant boost to the region's agricultural export credentials.

Authorities announced that the export process would continue for the next three days, with Singapore and Thailand among the countries slated to receive consignments in the days ahead.

In a key academic session held in collaboration with the Food Engineering Department of Tezpur University, professors Dr Poonam Mishra, Dr Swami Ranjan Purohit and Dr Rahul Kumar delivered an important workshop titled "Food Technology and Litchi." The experts underscored the considerable potential for producing litchi-based processed food items on a

sustained basis, urging local entrepreneurs to step forward and convert this seasonal fruit into a commercially viable industry. ICAI Guwahati conducts seminar on GSTAT appeal filing

GUWAHATI, June 7: The Guwahati Branch of the Institute of Chartered Accountants of India (ICAI) organized a seminar on "GSTAT Appeal Filing" on June 6, 2026, at ICAI Bhawan, Manik Nagar, Guwahati. The programme was organized in view of the operationalization of the Goods and Services Tax Appellate Tribunal (GSTAT) after a wait of more than eight years since the introduction of GST and the approaching deadline of June 30, 2026, for filing eligible pending appeals before the Tribunal.

The seminar commenced with the inaugural address by Shri Somnath Ganguli, Hon'ble Vice President and Judicial Member, GSTAT, Guwahati Bench, who shared valuable insights into GST law and the functioning of the GST Appellate Tribunal. Addressing the gathering, he elaborated on the role of GSTAT in the GST dispute resolution mechanism and highlighted important aspects of appellate proceedings for professionals. His address provided participants with a deeper understanding of the procedures and expectations of the appellate authorities, particularly in an e-filing environment.

Speaking on the occasion, CA Anjani Kumar Mundhra, Chairman of the Guwahati Branch, stated that the seminar had been organized at a crucial juncture, as the due date for filing eligible pending GST appeals before GSTAT is June 30, 2026. He mentioned that the objective of the programme was to provide both legal and practical guidance on GSTAT appeals and to facilitate a smooth transition into the GST appellate regime, even if there were procedural issues or minor defects. 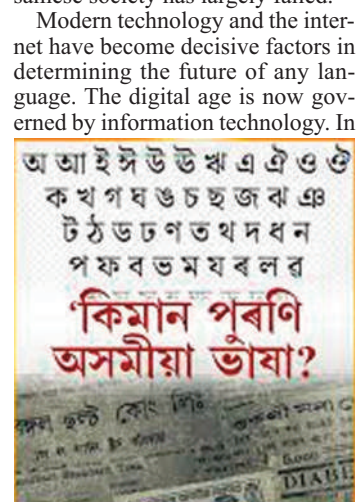

Assessing India's social determinants of health approach using NFHS-6 Data

The Ministry of Health and Family Welfare released the latest National Family Health Survey (NFHS-6 (2023-24)) fact sheets on 29 May 2026, covering nearly 6.79 lakh households across 715 districts. Compared with NFHS-5 (2019-21), the latest survey points to broad-based gains across maternal health, child immunisation, and nutrition. Institutional deliveries reached 90.6 percent (up from 88.6 percent), antenatal care coverage rose to 95.9 percent (from 92.6 percent), and skilled birth attendance improved to 91.3 percent. Full immunisation coverage among children aged 12-23 months reached 87.1 percent, with rotavirus vaccination more than doubling from 36.4 percent to 85.4 percent.

On adult nutrition, both ends of the BMI distribution worsened simultaneously (Figure 1)—the share of overweight or obese women rose from 24.0 percent to 30.7 percent, and that of men from 22.9 percent to 27.3 percent, while underweight prevalence also increased among both sexes—a textbook double burden of malnutrition.

Contrasted against these impressive gains, several indicators moved in the wrong direction. Exclusive breastfeeding among infants under six months fell from 63.7 percent to 55.8 percent. The share of institutional births occurring in public facilities declined from 61.9 percent to 58.6 percent, pointing to a quiet shift towards private delivery care—possibly financed by large publicly funded insurance schemes—even as overall institutional delivery rates rose. The caesarean section rate climbed from 21.5 percent to 27.2 percent, with increases recorded in both public and private facilities. Modern contraceptive use slipped from

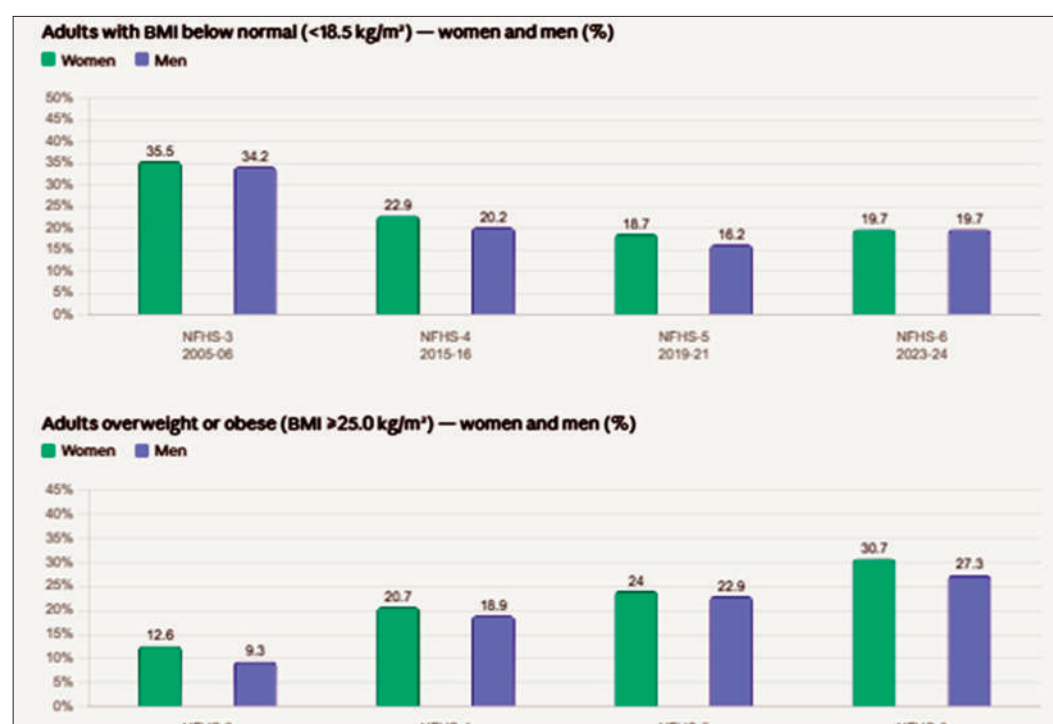

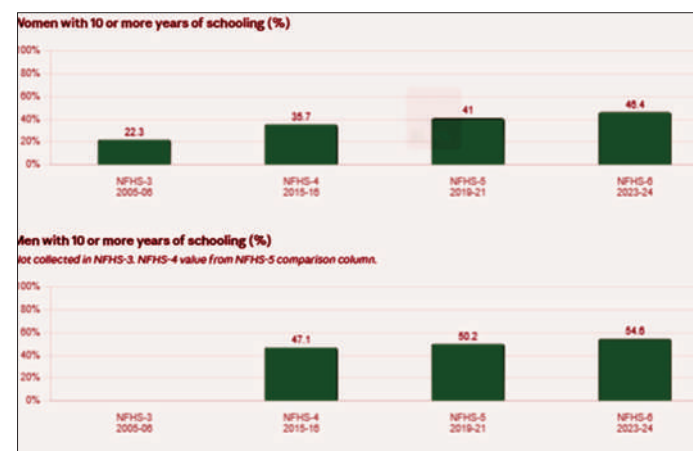

Educational attainment among adults has improved steadily across all four survey rounds covering 2005-06 to 2023-24. The share of women aged 15-49 with ten or more years of schooling rose from 22.3 percent in 2005-06 to 46.4 percent in 2023-24, more than doubling over two decades (Figure 2). The corresponding figure for men, available from NFHS-4 onwards, increased from 47.1 percent to

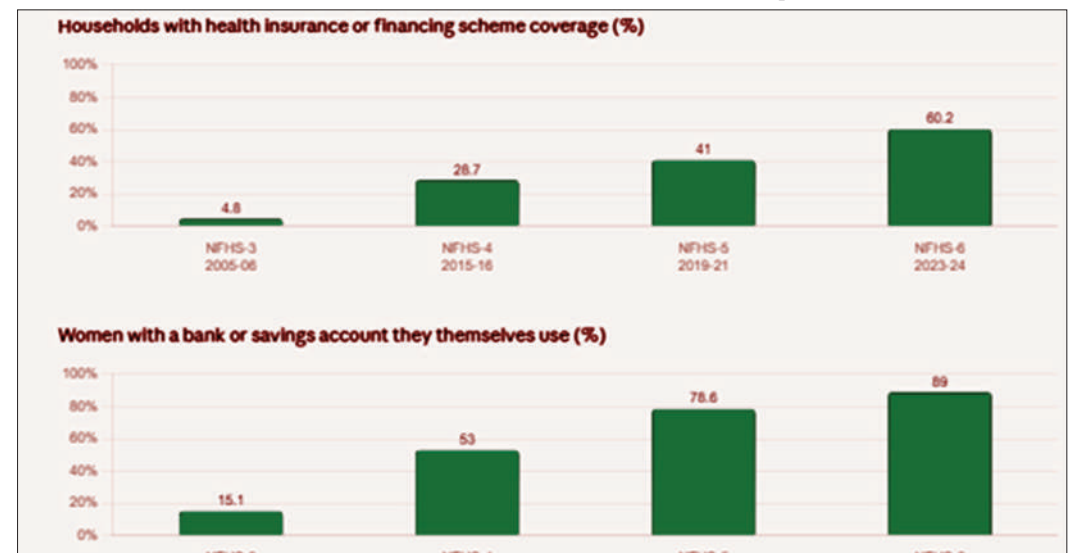


54.6 percent. The gender gap in schooling, while narrowing, remains substantial, and further improvements and convergence are likely to yield additional health benefits across the country.

Child undernutrition has improved, albeit often slowly, across all three anthropometric measures (Figure 3), with stunting falling from 48.0 percent to 29.3 percent between 2005-06 and 2023-24, a reduction of nearly 20 percentage points that reflects cumulative gains in maternal nutrition, sanitation, and child feeding practices. Wasting has remained stubbornly high at 19.0 percent, while the prevalence of

Living conditions have shown steady improvement over the last two decades. Access to electricity, drinking water, and sanitation has expanded substantially, as tracked using NFHS and other official sources (Figure 4). Household electricity access rose from 67.9 percent to 98.3 percent, and improved drinking water coverage increased from 87.6 percent to 96.5 percent. Clean cooking fuel use, at 63.4 percent in 2022-23, continues to lag considerably behind, with rural coverage remaining below 50 percent, representing a significant and ongoing source of indoor air



underweight children stands at 31.8 percent, indicating that progress in child nutrition remains incomplete and requires additional effort. Cervical cancer prevention: Why linking HPV awareness matters

On the Menstrual Hygiene Day (May 28), Delhi CM Rekha Gupta raised a very powerful voice by promising No more silence on Menstruation. While many political leaders and public figures treat menstrual hygiene as a welfare issue and focus on just the distribution of sanitary pads, she is trying to institutionalise the apparatus and position menstrual health as a public health matter.

In her article, the Delhi CM also linked menstrual hygiene to cervical cancer awareness. "This (menstrual hygiene) will be directly linked to awareness of HPV and cervical cancer. Cervical cancer remains one of the most common cancers among Indian women, and it is also one of the most preventable. By connecting menstrual health to HPV awareness, we treat a girl's reproductive health holistically," she argued.

India needs to treat health as a continuous journey instead of just focusing on building cure infrastructure. While all the new hospitals, the increase in the number of medical seats, colleges, and Jan Aushadhi Kendras are essential to ensure that no one loses lifespan or healthspan due to unfortunate incidents, the focus should be on minimising the need for the same in the first place. A good parallel would be the city transport infrastructure - the European

cities initially focused on improving the road and metro infrastructure for city commute, but could never keep up with the growing population and its needs - later they realised that the solution lies in eliminating/minimising vehicle commute altogether and redesigned the city for pedestrian and cycle traffic. And the result of this is that European cities are cleaner, the population is healthier, and the quality of life is much better. Similarly, we need to minimise the need for healthcare infrastructure by focusing on preventive healthcare.

According to the WHO, cervical cancer is the 2nd most common cancer after breast cancer among women in India. Cervical Cancer is primarily driven by Human Papillomavirus (HPV), and our country accounts for roughly 20% of the global cervical cancer burden against 18% of the global population. Cervical cancer is preventable through vaccination administered between the ages of 9 and 14 before any exposure to the virus.

Adolescence represents a narrow, vital developmental window. Treating menstruation, reproductive education, and cancer prevention as completely separate may make sense from a curative point of view, but from a preventive lens, all of this could be dealt with a holistic strategy. When a young girl learns about her reproductive system in early teens, this is the right time

to introduce her to the preventive vaccination framework, also. Many authoritative studies have pointed out that schools are the basis for preventive healthcare interventions. Sensitisation about HPV and the vaccination to prevent the same will end the pandemic and will make our coming generations healthy and productive.

For too long, India has focused on curative healthcare despite being a low-per-capita-income country. While we see the 'prevention is better than cure' slogan in almost every other clinic and hospital, preventive healthcare has not been the focus of the community or the policymakers. India has one of the highest out-of-pocket healthcare expenditures (OOPHE) in the world at 43%. It was even higher, 64 percent a decade ago, but thanks to the Modi government's focus on healthcare infrastructure and improved spending, the ratio has decreased significantly. However, in a lower-middle-income country, people cannot afford to pay 43% OOPHE, which means the majority of India's population is one medical bill away from being pushed below the poverty line.

The people of the United States, with a per capita income of around 90,000 dollars (30 times that of India), can afford to pay OOPHE, and most of Europe has fully public healthcare, but given India's stage of development, both of these models are unsustainable for us. Thus, we have to focus on preventive healthcare in a big way if we want to have a healthy country that can reap the benefits of the demographic dividend by participating in the economy. Various studies have shown that health is directly linked to productivity, and as the cases of obesity, diabetes, breast and cervical cancer increase, the productivity of our young population will go down. If this demographic window is lost, India risks becoming old before becoming rich, and unless the country focuses on preventive healthcare to improve the healthspan and lifespan of the population, this risk will linger on. 23 parties have confirmed participation: Congress 'INDIA janbandhan united'

NEW DELHI, June 7: Twenty-three political parties have confirmed their participation in the "INDIA janbandhan" meeting at the Constitution Club here on Monday, the Congress said and asserted that the opposition bloc continues to stand united through its diversity.

Congress leader Jairam Ramesh said there are some parties that have expressed their inability to attend this particular meeting for their own reasons.

In a post on X, he said, "23 political parties have confirmed participation in the INDIA janbandhan meeting at Constitution Club, New Delhi, on Monday, June 8, 2026, at 12 noon."

Tagging Ramesh's post, TMC MP Derek O'Brien said, "Meeting with a common purpose and clear intent. INDIA united. Many parties look forward to meeting in the spirit of camaraderie."

"There are some parties who have expressed their inability to attend this particular meeting for their own reasons, even though they have conveyed their strong opposition to the Modi government's policies and actions that are snatching away the right to vote for millions of Indians, as-



saulting the Constitution daily, attacking Opposition leaders through investigative agencies, seriously damaging the livelihoods of crores of Indians, breaking household budgets through relentless price rise, betraying the hopes and aspirations of lakhs of youth, dampening investment climate, and compromising the national interest by its foreign policy," said the Congress general secretary in-charge communications Jairam Ramesh.

Like India, the "INDIA janbandhan" continues to stand

over the allegation by top Congress leaders that the Left had colluded with the BJP in Kerala.

According to sources, CPI(M) general secretary M A Baby has recently written to Congress president Mallikarjun Kharge seeking clarification on remarks by senior Congress leaders that suggested a political understanding between the CPI(M) and the BJP in Kerala.

The meeting also comes in the backdrop of the recent assembly elections in which TMC and DMK were ousted from power in West Bengal and Tamil Nadu.

The gathering is being seen as an effort to deepen coordination among opposition parties, particularly after the recent round of assembly elections and amid evolving political equations in several states.

The AAP has publicly distanced itself from the bloc, while the DMK this week announced its decision to boycott the meeting.

In the past, the INDIA bloc leadership has also got together formally for consultations ahead of Parliament sessions, when opposition parties discussed floor coordination and issues to be jointly raised against the central government. (PTI)

Our agitation will continue until Union minister Pradhan resigns: CJP founder Dipke

CHHATRAPATI SAMBHAJINAGAR, June 7: Cockroach Janta Party (CJP) founder Abhijeet Dipke said on Sunday his agitation over alleged irregularities in examinations and recruitment tests will not stop until Union Education Minister Dharmendra Pradhan resigns.

Dipke also said their protest at Jantar Mantar in New Delhi on Saturday was largely successful, with around 7,000 people participating in it, and added that the movement would now expand nationwide. The CJP founder reached his residence in the MIDC Waluj area in Maharashtra's Chhatrapati Sambhajnagar district on Sunday morning and was welcomed by his family members.

Later, speaking to reporters, Dipke said the agitation undertaken by the Cockroach Janata Party will not stop until Union Education Minister Dharmendra Pradhan resigns.

"The protest we staged (at Jantar Mantar) was successful, as 6,000 to 7,000 people attended it. This agitation will go nationwide. We won't step back till Dharmendra Pradhan resigns," he asserted.

"We will roll out a further action plan to take this agitation nationwide," Dipke added.



Hundreds of protesters gathered at Delhi's Jantar Mantar on Saturday under the banner of the CJP, demanding Pradhan's resignation over alleged irregularities in examinations and recruitment tests, with Dipke delivering the message not to be "scared".

At a press conference later in the national capital, CJP spokespersons announced that they will wait for a week either for the Centre to sack Pradhan or his voluntary resignation, after which they would launch a countrywide protest.

Dipke, who called for the protest, arrived in Delhi from the United States on Saturday morn-

ing, walking out of the airport carrying a copy of B R Ambedkar's autobiography. After receiving permission from the Delhi Police, he reached Jantar Mantar.

Protesters, armed with posters demanding Pradhan's resignation, were seen wearing cockroach masks, which were being distributed at the venue. Besides demanding the education minister's resignation, the protesters also raised slogans demanding that the ruling Bharatiya Janata Party (BJP) stop indulging in "Hindu-Muslim" politics, and hailed the motherland with "Bharat Mata ki Jai" slogans. (PTI)

Ram temple donation funds missing, claims Akhilesh

LUCKNOW, June 7: Samajwadi Party president Akhilesh Yadav on Sunday said that reports have emerged claiming that crores of rupees from donations offered at the Ram Temple were missing and urged the court to take cognisance of the matter.

There was no immediate response from the temple trust or the Uttar Pradesh government on Yadav's remarks.

In a post on X, Yadav said the issue was "extremely sensitive" for devotees of Lord Ram across the world and described the situation as "highly embarrassing" for the temple trust.

"It is very sensitive news for devotees of Lord Ram across the world that crores of rupees from donations made to the Ram Temple have been found missing," Yadav's post read in Hindi.

The Samajwadi Party chief also questioned the "silence" of the temple trust and the government over the issue. "The government's silence is suspicious," Yadav said.

Calling the alleged discrepancy a matter of public concern, the former Uttar Pradesh chief minister said, "This is an extremely shameful situation for the temple trust. No one is willing to come forward and offer an explanation."

Yadav urged the court to intervene in the matter, saying it was linked to the deep faith of the global Sanatani community in Lord Ram.

The court should take "suo motu cognisance because the issue is directly related to the profound faith that the Sanatani community across the world places in Lord Ram," he said. (PTI)

Indicators 'missing' in NFHS factsheet being monitored via national surveys, databases: Govt sources

NEW DELHI, June 7: Union health ministry sources said the indicators claimed to be "missing" in the National Family Health Survey (NFHS)-6 Fact Sheets are being monitored through dedicated national surveys and administrative databases, and therefore were not duplicated in the preliminary release.

Responding to "commentary in sections of the media regarding the absence of certain indicators", official sources emphasised that the factsheets represent only the first stage of dissemination and cover 101 major indicators intended to provide a concise snapshot of India's most critical health and demographic trends.

"The factsheets are the first stage of dissemination. The detailed national report will provide a much broader picture," they said. It will be released subsequently with a much wider range of indicators, detailed analyses and methodological documentation, they added. "The objective is to ensure that each indicator is reported through the most appropriate and authoritative source, reducing duplication and improving overall data coherence," one of the sources said.

Official sources noted that several indicators cited as "missing" from the factsheets are already being monitored through dedicated national systems.

Sanitation and clean cooking fuel coverage, for instance, are tracked through specialised surveys and administrative platforms such as Swachh Survekshan Grameen and the Ministry of Statistics and Programme Implementation's surveys, making duplication within the factsheets unnecessary, they said.

Similarly, key statistics relating to mortality, birth registration and population characteristics continue to be generated through established systems such as the Sample Registration System (SRS), Civil Registration System (CRS) and Census framework, which remain the country's designated sources for these indicators, the sources said. On the absence of anaemia estimates in the factsheets, they explained that haemoglobin testing was not undertaken in NFHS-6 due to concerns surrounding the capillary blood sampling methodology used in previous rounds.

Instead, anaemia prevalence estimates will be derived from the Indian Council of Medical Research's Diet and Biomarkers Survey, which employs gold-standard venous blood sampling methods to improve accu-

LPG price hikes: Govt will pay 'political price', says Sharad Pawar; Cong's Wadettiwar slams BJP

KOLHAPUR, June 7: NCP (SP) chief Sharad Pawar on Sunday criticised the Centre over rising prices, claiming the government would pay a "political price" as frequent hikes in essential commodities were burdening the common man.

People across the country were facing hardship due to inflation, the former Union minister claimed and questioned the government's stand that price rise was under control.

"The hike may have started with just two rupees, but over time the increases have kept piling up, and today we can see how far the prices have risen. All of this has a direct impact on the finances and daily lives of ordinary people," Pawar said.

Prime Minister Narendra Modi had initially claimed his government would keep inflation under control, the NCP (SP) supremo said.

However, it now appears that their (Centre's) idea of "control" is to deliver these price shocks step by step, he added. "Those responsible will have to pay a political price," he said in response to media queries on the LPG price hike.

Maharashtra Congress leader Vijay Wadettiwar accused the BJP of abandoning its earlier stand on price rise, and said the ruling party was no longer showing the same concern for issues affecting ordinary people as it had done while in the opposition.

In a statement, Wadettiwar said BJP leaders used to stage protests whenever cooking gas prices were increased during the UPA regime, but remained silent despite repeated hikes in fuel and LPG prices since coming to power.

"Commercial LPG cylinder prices have risen sharply over the past few months and petrol, diesel and CNG prices have also witnessed multiple revisions in recent years. Inflation was severely affecting household budgets and placing an additional burden on middle-class and economically weaker families," the Congress leader claimed.

Domestic cooking gas LPG price has been raised by Rs 29 per cylinder, marking the second increase in three months as state-owned fuel retailers continue to grapple with elevated global energy costs.

The increase follows a Rs 60-per-cylinder hike on March 7 after the conflict in West Asia disrupted global energy supplies and drove up international fuel prices.

Meanwhile, the Union government on Sunday said Indian households continue to pay among the lowest prices for cooking gas globally despite a sharp rise in international PG prices triggered by disruptions due to the West Asia crisis that began on February 28 following a joint attack by the US-Israel on Iran.

In a statement, the government said the cost of supplying a domestic LPG cylinder has risen to more than Rs 1,600 following a surge in international prices that followed the outbreak of war in West Asia.

India's LPG import costs are linked to the Saudi Contract Price (CP), the global benchmark for the fuel. The benchmark has risen about 46 per cent since February after disruptions linked to the Strait of Hormuz tightened supplies from the Gulf region, according to the statement. (PTI)

'PM wants youth to keep making reels, fry pakodas': Rahul Gandhi hits out at PM Modi on CBSE OSM row

NEW DELHI, June 7: Congress leader Rahul Gandhi on Sunday hailed whistleblower student Sarthak Sidhant and his associate Nisarga Adhikary for exposing the "collusion" between the CBSE and COEMPT and said Prime Minister Narendra Modi wants the youth to keep "making reels and fry 'pakodas'" but these two youngsters asked questions and found answers too.

Gandhi shared on X a video of his meeting last week with Sarthak Sidhant, an 18-year-old student affected by the CBSE's on-screen marking system (OSM) who has pointed out alleged irregularities in the tendering process to select a vendor for the OSM exercise in Class-12 board exams.

In his post in Hindi accompanying the video, Gandhi said, "Sarthak is 18 years old, yet, in terms of mindset, courage, and principles, he is second to none."

"He and his associate, Nisarga, accomplished what the country's major media houses and investigative journalists could not: they exposed the collusion between CBSE



and COEMPT to the nation."

An 18-year-old from the country proved faster and sharper than the CBI; this victory for the youth is, in the true sense, a defeat for the government, Gandhi said.

"Modi ji wants our youth to keep making reels and frying pakodas, without asking questions or opening their eyes. But these young men did ask questions, and they found the answers, too," the Leader of Opposition in the Lok Sabha said.

"This is India's true youth power -- inquisitive, aware and informed. And remember, the country's future will not be led astray," he said.

While the government has shunted out two top CBSE officials following the on-screen marking system row, the opposition Congress has dismissed it as an eyewash and a cover-up, with Rahul Gandhi demanding that Education Minister Dharmendra Pradhan be sacked and an independent judicial inquiry be ordered

Rajeev Chandrasekhar calls Kerala's political culture 'strange' after first Assembly session

THIRUVANANTHAPURAM, June 7: Kerala BJP president Rajeev Chandrasekhar on Sunday said several aspects of the state's political discourse appeared "strange" to him during his first Assembly session, alleging that political parties were creating "unnecessary controversies" instead of focusing on issues affecting the public.

In a Facebook post, Chandrasekhar, a former Union minister and three-time MP, said he entered the Kerala Assembly for the first time as an MLA on June 1 after spending 18 years in Parliament.

"I thought I had seen almost everything in politics and parliamentary functioning during my 18 years in Parliament. But now I realise I had seen nothing," the Nemon MLA remarked sarcastically.

The BJP leader said the recent Assembly session was notable for several reasons, but what stood out to him was what he described as a

"political culture disconnected from the real concerns of society."

"The strangest thing for me was the politics of some people. It is a strange kind of politics that has no connection with the real issues facing society," he said.

Chandrasekhar said the country was living in an era of rapid technological transformation, with artificial intelligence opening up new opportunities for young people while businesses face emerging global challenges.

However, he alleged that sections of the political leadership were preoccupied with ideological debates and political controversies rather than discussions on development, investment and employment generation. Referring to the debate over the state's economic white paper, Chandrasekhar criticised CPI(M) leaders for opposing it and alleged that political rivals were more interested in blaming one another for the BJP's electoral success than ad-

ressing public concerns.

He claimed that despite rising prices, a lack of fresh investments and concerns over employment opportunities, "none of the real issues affecting people are becoming subjects of discussion".

"The economy of Kerala has collapsed not because of anything else, but because of the disastrous politics of the Congress and the CPI(M)," he alleged.

Describing the situation as "painful, pathetic and completely irresponsible", Chandrasekhar said the BJP's objective was to bring about a change in the state's political culture.

"Our goal is to replace this culture of trivial political debates and manufactured controversies with a politics of performance," he said.

Chandrasekhar also said the party would continue to advocate its vision of a "developed Kerala" and raise development-oriented issues in the Assembly. (PTI)

Gandhi also hails him for doing the job of investigative journalists. After meeting Sidhant and his family last Tuesday, Gandhi had posted pictures from the meeting and said, "Sarthak, stay firm on your principles."

Sidhant also made a presentation before a parliamentary panel on Tuesday on the alleged irregularities in the OSM tendering process.

The Central Board of Secondary Education (CBSE) replaced the traditional method of checking papers with digital evaluation for Class 12 through the on-screen marking system.

However, a controversy erupted after some Class 12 students alleged that the scanned copies of their answer sheets uploaded by the board did not match their handwriting, raising concerns over possible answer-sheet mismatch in the OSM system. (PTI)

Four workers die after inhaling toxic fumes at septic tank in Surat

SURAT, June 7: Four workers died after inhaling toxic fumes while cleaning a septic tank at a jewellery manufacturing unit in Gujarat's Surat city on Sunday morning, police said. While asphyxiation is likely the primary cause of their death, the exact cause will be confirmed by the post-mortem report, Deputy Commissioner of Police, Zone-1, Alok Kumar said. The incident occurred at the septic tank, which collects waste from the jewellery cleaning process, in the Ashwini Kumar area, he said.

The facility's septic tank undergoes cleaning and maintenance every two months. This morning, four individuals - a supervisor and three labourers - entered the tank. They collapsed due to the effects of poisonous gas and all of them died, the official said. "We are examining whose negligence led to the incident, as preliminary investigations indicate that safety protocols were not followed. Nevertheless, we will conduct a detailed investigation into the matter," he said. (PTI)

CSI Medak Diocese appeals for peace, release of abducted persons in Manipur

IMPHAL, June 7: The Church of South India (CSI) Medak Diocese, Hyderabad has appealed for justice, peace and the safe release of abducted pastors and civilians in Manipur.

"We, the members of the Church of South India (CSI) Medak Diocese, Hyderabad, TG, express our deep anguish and concern over the continuing incidents of violence, abduction and loss of innocent lives in Manipur," said the appeal letter of the church body. It added, "In this difficult and painful moment, we make a humble, earnest and prayerful appeal to all concerned communities, civil society organisations and community leaders to work collectively towards peace, justice, reconciliation and the protection of innocent civilians."

It also respectfully appealed to the United Naga Council (UNC) and the Kuki Inpi Manipur (KIM) to extend their humanitarian intervention and moral leadership in facilitating the safe and immediate release of the hostages.

In its appeal letter, the South India church body mentioned Rev Dr Manu Thiumai of Leimakhong Baptist Church, Pastor Kenpibou Chawang of Juna Baptist Church, Phenrongwibou Thiumai, Dilip Thiumai, Phenrilung Chawang and



Kaliwangbou Abonmai from Kongsakul (Konsaram), a Naga village, who were reportedly abducted at Leilon Vaiphei Kuki village in Kangpokpi district on May 13, 2026.

At the same time, the church body also earnestly appealed for the safe and unconditional release of the fourteen Kuki civilians re-

portedly abducted in Senapati district by Nagas in the aftermath of the recent tensions.

It said the suffering of innocent civilians, irrespective of community, denomination or identity, deeply wounds the social fabric of Manipur and prolongs fear, mistrust and collective trauma.

The church body then mourned

and strongly condemned the tragic killings of Rev Vumthang Sithou, Rev Kaigoulun Lhouvum and Pastor Paogoulun Sithou of the Thadou Baptist Association India (TBAI) and United Baptist Council (UBC), as well as the killing of Wilson Thanga of the Chiru community.

"We are equally saddened by the

abduction of two Catholic (Salesian) trainee priests, Panmei Aching Albert and Poji Kuvise Peter (Nagas) from Sapormeina in Kangpokpi district, Manipur on May 13, although they were released on May 15, 2026, after civil society organisations and the church intervened," it said, adding, "Such acts of violence against religious leaders and innocent civilians undermine the moral foundations of humanity, coexistence, justice and peace."

The Church of South India (CSI) Medak Diocese, Hyderabad, then urged the Government of Manipur and the Government of India to ensure impartial, transparent and humane investigations into all incidents of abduction and killings, without bias.

It said justice, dialogue and reconciliation are essential for restoring trust and rebuilding peace among communities.

As people of a faith that believes in forgiveness, the church body said it believes that lasting peace cannot emerge through vengeance, hatred or violence, but through compassion, mutual respect, justice and collective healing. "We continue to pray for the safe return of all abducted persons and for justice, peace and harmony to prevail in Manipur," it added. (NNN)

Liquor permit on medical grounds requires stringent verification in dry Mizoram: Official



AIZAWL, June 7: A stringent multi-tier verification process is required to secure 'Red Card', a special permit system to possess and consume liquor on medical grounds in dry Mizoram, an official said on Sunday.

Mizoram's Excise and Narcotics department had last week announced the rollout of the 'Red Card' permit and invited applications from people whose health conditions require consumption of liquor.

The department has so far not received applications seeking such permission, the official said.

To qualify for the permit, an applicant must submit a doctor's prescription certifying the need for alcohol consumption as part of medical treatment, he said. Such a prescription will be thoroughly scrutinised by the district medical superintendent concerned before granting final clearance, he said.

The 'Red Card' permit will be issued only to those who clear this

verification process, the official said.

The excise department emphasised that the scheme is intended for genuine medical cases and not as a means to bypass Mizoram's liquor regulations.

Under the proposed system, a 'Red Card' permit will be valid for one year and will cost ₹ 5,000 annually.

Cardholders will be permitted to purchase liquor only in quantities prescribed by their doctors, the official said.

The 'Red Card' provision forms part of the state's regulated approach to liquor control, allowing limited access to alcohol for individuals whose medical conditions may warrant its use, he said.

The excise department has opened a store in its Aizawl office, where liquor that has been seized by enforcement agencies and subsequently cleared for disposal by the courts will be sold to cardholders at ₹ 75 per cent lower than the prevailing market price. (PTI)

Nagaland overhauls civil services exam pattern

DIMAPUR, June 7: The Nagaland government has effected a major overhaul of the examination pattern and syllabus for Nagaland Civil Service (NCS), Nagaland Police Service (NPS), Nagaland Secretariat Service (NSS) and Allied Services examinations by amending the Nagaland Public Service Commission (State Civil & Other Services) Recruitment Rules, 2008. The revised rules broadly align the state's examination structure with the UPSC Civil Services Examination while incorporating Nagaland-specific components.

The amendments titled the Nagaland Public Service Commission (State Civil & Other Services) Recruitment (11th Amendment) Rules, 2026, will come into force prospectively from the next recruitment cycle or advertisement, according to a state personnel & administrative reforms department (Personnel B Branch) notification, dated June 4.

The notification said the Preliminary Examination, under the amended Rule 14(1) will consist of a single objective-type paper carrying 200 marks with 100 multiple-choice questions.

As per the new rules, negative marking has been introduced, with one-third of the marks allotted to a question deducted for every incorrect answer. The examination will be of two hours' duration.

The preliminary examination syllabus covers general science, history of India and Nagaland, geography, Indian polity and economy, the Indian national movement, general mental ability and current events.

The Main Examination has been restructured into six papers carrying a total of 1,200 marks. A new paper, General Studies-Nagaland has also been introduced, focusing on the state's history, culture, geography, economy, polity and governance, society and current affairs.

"Village authorities and civil society organisations were approached for their essential support and were assured of the presence of security forces in the area to ward off any threats", it said. (PTI)

NFR unloads 1,034 freight rakes in May

GUWAHATI, June 7: Northeast Frontier Railway (NFR) continued its strong freight performance in May 2026, recording a notable mark in unloading activity. During the month, 1,034 freight rakes were unloaded across the zone, marking a steady start for the zone in FY 2026-27.

Throughout the month, NFR ensured the smooth transportation of essential and industrial commodities, including food grains, food-grade items, fertilisers, sugar, SNTP coal, salt, tank consignments and other goods. These consignments were efficiently handled at various goods sheds across its jurisdiction, ensuring timely supply and operational reliability.

A significant share of the freight traffic was dedicated to meeting the requirements of the Northeastern states. Assam accounted for the highest unloading with 557 rakes, comprising 271 rakes of essential commodities and 286 rakes of non-essential commodities, underscoring the vital role of

Railways in supporting public distribution systems, industrial activities and daily consumer needs. During the same period, 74 rakes were unloaded in Tripura, 34 rakes in Nagaland, 20 rakes in Manipur, 10 rakes in Arunachal Pradesh, 8 rakes in Mizoram and 1 rake in Meghalaya.

In addition, West Bengal recorded the unloading of 196 rakes, while Bihar accounted for 134 rakes comprising both essential and non-essential commodities, further strengthening regional supply chains, trade connectivity and economic activities across the region.

Suthar brilliant on debut as India take control against Afghanistan

MULLANPUR, June 7: Debutant Manav Suthar's classical left-arm spin bowling was a beacon of hope for a bright future as his three wickets gave India complete control on the second day of their one-off Test against Afghanistan here on Sunday.

With mercury soaring, India declared their first innings at 564 for 8 once Washington Sundar scored a pressure-free half-century while adding 54 useful runs with Suthar (28 off 41 balls).

At stumps, Afghanistan were tottering at 113 for 5 with Suthar recording figures of 3 for 21 in 15.5 overs.

Prasidh Krishna (2/27 in 7 overs) was the other wicket-taker. Hosts, now, are ahead by 451 runs.

Having warmed up nicely with a short yet sweet maiden Test knock, Suthar got into the act straightaway after being summoned to bowl the last over before tea.

He removed opener Abdul Malik, who wanted to sweep his way out of trouble after looking clueless facing first three deliveries.

A classical action and the old school diagonal run-up of bowling to right-handers while cutting between the umpire and stumps, the 23-year-old from Rajasthan's Sri Ganganagar was a delight to watch.

In times when spin bowling is



increasingly starting to become more of a restrictive weapon, thanks to the mushrooming T20 leagues, Suthar brought a lot of freshness while sticking to basics -- flight and turn.

Suthar has a high release point and his main attributes included putting multiple revs (revolutions) on the ball. He could hang the ball for an extra second in the air and also get some drift before it turns away from the right-hand batters.

The 23-year-old has a repetitive action and the pitch map on TV showed that he could land the ball on the same spot and make it do three different things.

A few would turn more, a few would go straight with extra bounce forcing batters to go on

back-foot, and a few others were classic arm balls that come in with the angle.

The wicket of the Afghanistan opener was one which he bowled straight and the ball bounced a tad extra making Malik's sweep look like an ugly hook.

In the case of Rahmanullah Gurbaz, a former KKR opening batter, he simply didn't allow him to come on the front-foot.

He bowled a few that went straight and Gurbaz defended. Then from the same spot, he bowled one that dipped late and then turned away kissing the edge of Gurbaz's willow into Sai Sudharsan's hands in the second slip.

Suthar's third and final wicket of the day came when the ball

stopped and bounced with Afsar Zazai closing the face of the bat and the loopy leading edge resulted in an easy return catch.

Skipper Shubman Gill, very rightly allowed him to bowl unchanged for 13 overs from one end while shuffling between Mohammed Siraj, Prasidh and Kuldeep Yadav at the other end.

If Suthar's impressive initiation into Test arena is any indication, Indian selectors can hope for a smooth transition as and when Ravindra Jadeja is phased out from red ball format.

Earlier, Rishabh Pant answered his critics in the best possible manner with a stroke-filled 81 while Afghanistan pacer Mohammad Saleem enjoyed the fruits of labour in punishing weather with figures of 6 for 140.

In-front of a sparse Sunday crowd, Pant did play his signature strokes but also curbed his natural instinct to go after each delivery, treating each ball on its merit during his 121-ball knock that had six boundaries and three sixes.

He should have completed his century but off-spinner Hashmatullah Shahidi slowed the pace considerably.

Pant charged down the track but couldn't fully reach to the pitch of the delivery as the lofted hit ballooned up for a simple catch for Azmatullah Omarzai.

For Afghanistan, their IPL star Omarzai was distinctly unlucky.

He was impressive with the second new ball, beating the bat on a number of occasions without much luck.

In fact, Pant, like KL Rahul did on Day 1, also edged one but no one from the Afghanistan team appealed for caught behind. The replays, though, showed a snick.

In the first hour of the second morning, Gill (126 off 177 balls) was dismissed by Saleem (4/109 in 20 overs), who bowled a beauty to get rid of the Indian skipper.

It was pitched on fuller length on off-stump channel drawing Gill forward and then there was a hint of outward movement, as the ball took the edge of his bat to end a 169-run stand.

Dhruv Jurel (19 off 20 balls) played a few beautiful square of the wicket shots but Saleem got one to reverse as Jurel decided to leave the ball on length only to find his off-stump pegged back.

However, one dismissal that left the crowd high and dry was Pant's as they were expecting some more fireworks from him once the spinners came into operation.

Washington and Suthar added 54 for the seventh wicket to take the team past the 500 run mark.

With the bowlers tiring, Washington calmly rotated the strike and hit the occasional six. Just after he completed his half-century, Gill signalled for declaration. (PTI)

Pragg is more dangerous than Carlsen: Pravin Thipsay



NEW DELHI, June 7: First Indian to win the prestigious Norway Chess title, Rameshbabu Pragganandhaa is a more dangerous player than even World No. 1 Magnus Carlsen and the most improved chess player in the world, according to Arjuna awardee Grandmaster Pravin Thipsay.

Pragganandhaa's historic triumph at Norway Chess 2026 has reinforced his status among the game's elite, with Thipsay rating him as India's strongest player at present, ahead of reigning world champion D. Gukesh and Arjun Erigaisi.

"Pragganandhaa is the best Indian chess player right now. On current form, he can be considered one of the most dangerous opponents in the world, even more dangerous than Carlsen," Thipsay told PTI in an interview.

He pointed to Pragganandhaa's impressive record against the Norwegian legend, noting that few players have enjoyed such success against Carlsen in recent years.

Thipsay described the Norway Chess victory as one of the finest achievements by an Indian player in recent years.

He particularly praised Pragganandhaa's finish to the tournament, where he won his final four rounds against opponents rated above 2750, including Carlsen and Gukesh.

"What a great comeback. After a somewhat disappointing 2025, he has produced something truly extraordinary. Indian chess needed a performance like this," he said.

According to Thipsay, the 20-year-old's biggest achievement has been the transformation of his playing style.

Once known primarily as a sharp attacking player who relied heavily on opening preparation, Pragganandhaa has developed into a far more versatile competitor capable of excelling in a variety of positions.

"Three or four years ago, he was feared for his attacking chess. But opponents gradually

learned how to neutralise those strengths. Over the last few months, he has added new dimensions to his game, including improved defence, positional understanding and tactical accuracy," Thipsay explained.

He compared the evolution of Pragganandhaa's style to that of former world champion Anatoly Karpov and Carlsen, players who focus less on gaining opening advantages and more on gradually outplaying opponents through superior understanding and consistency.

Thipsay believes India currently possesses three genuine world-title contenders in Pragganandhaa, Gukesh and Arjun Erigaisi.

While all three are capable of becoming world champion, he feels Pragganandhaa holds a slight edge at present because of his recent form and ability to consistently defeat players of equal or greater strength.

"It's very important to maintain form for a long period. Like Kasparov was the strongest, highest rated player in the world for 18 years. If our youngsters gain that sort of consistency than singular performance, then it would really be great."

Former Grandmaster Dibyendu Barua also praised Pragganandhaa's achievement, calling the Norway Chess title a remarkable milestone.

He said the victory would provide additional confidence and motivation for future tournaments.

Barua, however, stressed that Pragganandhaa, Gukesh and Arjun are all performing at a similar level and represent the future of Indian chess. He noted that their rivalry is pushing each player to improve and helping India maintain its position among the world's leading chess nations.

"The competition between them is bringing out the best in all three. Sometimes Arjun will win, sometimes Pragganandhaa, sometimes Gukesh. We are witnessing a golden era for Indian chess," Barua said. (PTI)

IGU names six-member team for Asian Games in Japan



NEW DELHI, June 7: Yuvraj Sandhu and Aditi Ashok were among a six-member Indian golf team named on Sunday for the Asian Games in Aichi-Nagoya, Japan, later this year.

A LPGA Tour regular, Aditi won an individual silver medal in the 2022 Asian Games in Hangzhou, China.

Sandhu (World No. 451), Veer Ahlawat (World No. 558) and Saptak Talwar (World No. 576) are the three male members while Aditi (World No. 135), Diksha Dagar (World No. 221) and Pranavi Urs (World No. 270) are the three female players named by Indian Golf Union (IGU).

The golf events for both men and women are scheduled from September 30 to October 3 at the Kasugai Country Club East Course.

The IGU, led by Brijinder Singh, said the entries were decided as per its selection policy for Asian Games.

"We have got a supremely talented and efficient squad which has someone like Yuvraj Sandhu, who won seven times

on the PGTI circuit last year. Then there are the likes of Aditi Ashok and Diksha Dagar who have won multiple times on the Ladies European Tour (LET). The entries were decided purely through World Rankings. I am confident that the Indian team will finish on the podium this time," Singh said in a release. India has had an illustrious history in golf at the Asian Games, clinching three gold and three silver medals so far.

The Indian quartet of Lakshman Singh, Rishi Narain, Amit Luthra and Rajeev Mohta won the team gold back in 1982 Asian Games in New Delhi. Lakshman Singh also bagged an individual gold medal.

Shiv Kapur won the individual gold at the 2002 Busan Asian Games. At the 2006 Doha Asian Games, the Indian team comprising Anirban Lahiri, Gaganjeet Bhullar and Joseph Chakola clinched silver.

In the 2010 Guangzhou Asian Games, the Indian team of Rashid Khan, Rahul Bajaj, Abhinav Lohan and Abhijit Singh Chadha won the silver medal. (PTI)

I don't have to change my personality for responsibility as a captain: Shreyas Iyer

MUMBAI, June 7: India's T20I skipper Shreyas Iyer on Sunday said he has always loved facing challenges growing up and the new responsibility of leading the country in the shortest format doesn't mean he has to change his personality.

The 31-year-old Iyer was on Saturday named the captain of the Indian T20I side, replacing Suryakumar Yadav who had led the national team to the T20 World Cup title in March.

Iyer said he would want to remain the same person who grew up in a challenging cricket environment in Mumbai.

"I don't have to change my personality. I have to be the same person how I was before, and not try to be someone else or be under someone's shadow," Iyer said at an event here.

"I obviously loved challenges growing up, especially being from Mumbai, where the cricket is pretty big, competition is high. Every other kid on the street, they want to represent Mumbai."

He said his mindset was always about winning, against everyone that he challenged.

"My mindset was always about winning, against everyone that I challenged so whether it's about learning or winning that is secondary, but more fun you have growing up, the more competitive nature you have, especially while you play cricket or any other sport in general," said Iyer.

"I think that takes you to another level and you want



to take that sort of responsibility (and) even when I've got this job right now, or a responsibility as a captain, it's a great challenge at the same time," he said.

Meanwhile, former India captain and BCCI president Sourav Ganguly said Iyer has earned the role of national team captaincy.

Iyer, who is set to lead India in Ireland for two T20Is as his first assignment as skipper, had played the last of his 51 T20Is in December 2023 before losing his spot.

The right-handed batter comes into the side and the middle-order as a like-for-like replacement of former skipper Suryakumar Yadav, who was also dropped from the Indian squad.

"Shreyas has done well, he has earned it. I would not say that the removal of Suryakumar Yadav is unfair. The selectors have made a decision," Ganguly said. (PTI)

Veer Ahlawat struggles in third round of Swiss Challenge

LUCERNE (SWITZERLAND), June 7: After setting a course record in the second round, Veer Ahlawat could not sustain the momentum, dropping 12 positions to tied 13th after the third round at the Swiss Challenge at Golf Semphach here.

Ahlawat carded 3-over 74 to be 9-under par after three rounds.

He was six shots behind the leader, George Bloor (67), who was heading into the final round with a total score of 15-under par.

Ahlawat began his third round with early birdies on the first and fourth holes before dropping a shot on the fifth.

He would pick up the stroke on the sixth before dropping two shots on the seventh with his

first double bogey of the day. He followed it with his second bogey on the eighth hole.

On the back nine Ahlawat dropped a second double on the 15th before picking up one shot on the 17th hole only to give it back with a bogey on the 18th.

Ahlawat, who has yet to win a title on the Hotel Planner Tour will need to find the magic from his second round once more if he hopes to challenge for the title this week.

Bloor carded a round of 4-under 67 to become the sole leader heading into the final round.

Bloor is one stroke clear of Hamish Brown and Matthew Southgate. The third round by Bloor included five birdies and one bogey. (PTI)

We were superstitious, hence didn't come to watch second day's play: Suthar's father Jagdish

MULLANPUR, June 7: Jagdish Suthar, a retired Physical Education teacher from Rajasthan's Sri Ganganagar district, had travelled all the way to Mullanpur with his family to watch his elder child Manav make his Test debut but left for home without watching his son's on-field exploits on second day of the match against Afghanistan on Sunday.

Suthar made a brilliant debut as he had the Afghanistan batters tied in knots with figures of 3 for 21 in 15.5 overs.

"Yes, me, my wife and my daughter Mansi (Manav's younger sister) had come to watch his debut. I can't describe how it felt seeing him get the Test Cap yesterday. However today we had come back home as we were all nervous and a bit superstitious watching him live in action from the stadium," the soft-spoken Jagdish Suthar told PTI during an exclusive interaction on the second day of the Test.

A man of few words, Jagdish was very reluctant to take any credit for his son's success on the cricket field which has now culminated into donning the national colours.



"It is completely Manav's hard work and the hours that he has put into practice. He would leave home for training in the morning and return late in the evening. It is his

credit and his childhood coach Dheeraj Sharma to whom we are all indebted. Manav learnt all his cricket under him," Suthar senior said.

Asked when did he actually found that his son has talent, the father said that it wasn't like one fine day that he realised it.

"Like every other child, he was also passionate about cricket. He would play with tennis and rubber ball when he was around six to seven years old. Since I was a PT teacher, I always encouraged my son to play the sport and enjoy. When he was around 10 to 11 years old, I had enrolled him in Dheeraj sir's academy. After that I just told him, "Tujhe jo achha lage, tu kar, mera support humesha tere saath rahega (Whatever you feel like pursuing, do it and I will give you my full support)," Jagdish added.

Asked if he was concerned about his son's studies, he replied in the negative.

"Cricket was his focus but he has also completed his graduation," he informed. According to the father, the son is a very reticent and seldom speaks about cricket when he is at home. "When he is at home, we hardly have conversations on cricket. He doesn't speak much. Yes, we know that he is a big fan of Ravichandran Ashwin and the way he had dominated world cricket during his time," he concluded. (PTI)
